# **ON SPLIT REGULAR HOM-LIE SUPERALGEBRAS**

ABSTRACT. We introduce the class of split regular Hom-Lie superalgebras as the natural extension of the one of split Hom-Lie algebras and Lie superalgebras, and study its structure by showing that an arbitrary split regular Hom-Lie superalgebra  $\mathfrak{L}$  is of the form  $\mathfrak{L} = U + \sum_j I_j$  with U a linear subspace of a maximal abelian graded subalgebra H and any  $I_j$  a well described (split) ideal of  $\mathfrak{L}$  satisfying  $[I_j, I_k] = 0$  if  $j \neq k$ . Under certain conditions, the simplicity of  $\mathfrak{L}$  is characterized and it is shown that  $\mathfrak{L}$  is the direct sum of the family of its simple ideals.

#### 1. INTRODUCTION AND FIRST DEFINITIONS

The motivation to study Hom-Lie structures are related to physics and to deformations of Lie algebras (see for instance [1, 3, 13, 14, 19, 21, 22]). A Hom-Lie superalgebra is a  $\mathbb{Z}_2$ -graded space with a bracket for which the super Jacobi identity is twisted by a homomorphism. This class was introduced by Ammar and Makhlouf in [1], where they have shown that the supercommutator bracket defined using the multiplication in a Homassociative superalgebra leads naturally to a Hom-Lie superalgebra. Hom-Lie superalgebras are generalizations of Lie superalgebras, Lie algebras as well as Hom-Lie algebras, and also they are a particular case of  $\Gamma$ -graded quasi-Lie algebras introduced by Larsson and Silvestrov in [15], who also have shown its relation with discrete and deformed vector fields and differential calculus. We also note that an analogous notion has been considered in other categories like Hom-associative algebras, Hom-alternative algebras, Hom-Leibniz algebras, etc. (see [1, 12, 16, 17, 18, 20, 23]).

In the present paper we introduce the class of split regular Hom-Lie superalgebras as the natural extension of the one of split regular Hom-Lie algebras (see [2]) and study its structure presenting them as a direct sum of adequate ideals. We also characterize a simple split regular split Hom-Lie superalgebra which together a relation of equivalence defined in its root system allow us to obtain a final expression as direct sum of simple ideals. Here it is interesting to mention the recent references [9, 10, 11, 24] where different classes of split Hom-algebras are also studied from the viewpoint of their inner structures.

We briefly describe the content of this paper. In Section 2 we develop connection of roots techniques which becomes the main tool in our study. In Section 3 we apply all of the machinary introduced in the previous section to show that a split regular Hom-Lie

superalgebra  $\mathfrak{L}$  is of the form  $\mathfrak{L} = U + \sum_j I_j$  with U a linear subspace of a maximal abelian graded subalgebra H and any  $I_j$  a well described ideal of  $\mathfrak{L}$  satisfying  $[I_j, I_k] = 0$  if  $j \neq k$ . In the final section, under certain conditions, the simplicity of  $\mathfrak{L}$  is characterized and it is shown that  $\mathfrak{L}$  is the direct sum of the family of its simple ideals.

**Definition 1.1.** A *Hom-Lie superalgebra*  $\mathfrak{L}$  is a  $\mathbb{Z}_2$ -graded algebra  $\mathfrak{L} = \mathfrak{L}_{\overline{0}} \oplus \mathfrak{L}_{\overline{1}}$  over a base field  $\mathbb{K}$  endowed with a bilinear product

$$[\cdot, \cdot] : \mathfrak{L} \times \mathfrak{L} \to \mathfrak{L}$$

and an even superspace homomorphism  $\phi : \mathfrak{L} \to \mathfrak{L}$ , satisfying

$$[x, y] = -(-1)^{ij}[y, x]$$
(1)

$$(-1)^{ik}[[x,y],\phi(z)] + (-1)^{ij}[[y,z],\phi(x)] + (-1)^{jk}[[z,x],\phi(y)] = 0,$$

for all homogeneous elements  $x \in \mathfrak{L}_{\overline{i}}, y \in \mathfrak{L}_{\overline{j}}, z \in \mathfrak{L}_{\overline{k}}$ , with  $\overline{i}, \overline{j}, \overline{k} \in \mathbb{Z}_2$ , called *skew-supersymmetry* and *super Hom-Jacobi identity*, respectively. Furthermore, if  $\phi$  is an super-algebra automorphism  $\mathfrak{L}$  is called a *regular Hom-Lie superalgebra*.

Note that  $\mathfrak{L}_{\overline{0}}$  is a Hom-Lie algebra called the even or bosonic part of  $\mathfrak{L}$  while  $\mathfrak{L}_{\overline{1}}$  is called the odd or fermonic part of  $\mathfrak{L}$ . The usual regularity concepts will be understood in the graded sense. A graded subalgebra A of  $\mathfrak{L}$  is a graded subspace  $A = A_{\overline{0}} \oplus A_{\overline{1}}$  of  $\mathfrak{L}$  such that  $[A, A] \subset A$  and  $\phi(A) = A$ . An *ideal* I of  $\mathfrak{L}$  is a graded subalgebra  $I = I_{\overline{0}} \oplus I_{\overline{1}}$  of  $\mathfrak{L}$  satisfying  $[I, \mathfrak{L}] \subset I$ . A Hom-Lie superalgebra  $\mathfrak{L}$  is called *simple* if  $[\mathfrak{L}, \mathfrak{L}] \neq 0$  and its only (graded) ideals are  $\{0\}$  and  $\mathfrak{L}$ . Throughout this paper we consider regular Hom-Lie superalgebras and denote by  $\mathbb{N}_0$  the set of all non-negative integers and by  $\mathbb{Z}$  the set of all integers. Finally, we emphasize that the regular Hom-Lie superalgebras  $\mathfrak{L}$  are considered of arbitrary dimension and over an arbitrary base field  $\mathbb{K}$ . Let us introduce the class of split algebras in the framework of regular Hom-Lie superalgebras in a similar way to the cases of Hom-Lie algebras, Lie algebras and Lie superalgebras, among other classes of algebras. We begin by considering a maximal abelian graded subalgebra  $H = H_{\overline{0}} \oplus H_{\overline{1}}$  among the abelian graded subalgebras of  $\mathfrak{L}$ .

**Definition 1.2.** Let  $\mathfrak{L}$  be a regular Hom-Lie superalgebra and denote by  $H = H_{\bar{0}} \oplus H_{\bar{1}}$  a maximal abelian graded subalgebra (MAGSA) of  $\mathfrak{L}$ . For a linear functional  $\alpha : H_{\bar{0}} \to \mathbb{K}$ , we define the *root space* of  $\mathfrak{L}$  (with respect to H) associated to  $\alpha$  as the subspace

$$\mathfrak{L}_{\alpha} := \left\{ v_{\alpha} \in \mathfrak{L} : [h_{\bar{0}}, v_{\alpha}] = \alpha(h_{\bar{0}})\phi(v_{\alpha}) \text{ for any } h_{\bar{0}} \in H_{\bar{0}} \right\}.$$

The elements  $\alpha \in (H_{\bar{0}})^*$  satisfying  $\mathfrak{L}_{\alpha} \neq 0$  are called *roots* of  $\mathfrak{L}$  (with respect to H) and we denote  $\Lambda := \{\alpha \in (H_{\bar{0}})^* \setminus \{0\} : \mathfrak{L}_{\alpha} \neq 0\}$  the *root system* of  $\mathfrak{L}$ . We say that  $\mathfrak{L}$  is a *split regular Hom-Lie superalgebra* (with respect to H) if

$$\mathfrak{L} = H \oplus \left(\bigoplus_{\alpha \in \Lambda} \mathfrak{L}_{\alpha}\right).$$

Split regular Hom-Lie algebras, split Lie superalgebras and split Lie algebras are examples of split regular Hom-Lie superalgebras. Hence, the present paper extends the results in [2, 4, 8]. Let us now show a proper example.

**Example 1.1.** Consider the real  $\mathbb{Z}_2$ -graded vector space  $\mathfrak{L} = \mathfrak{L}_{\bar{0}} \oplus \mathfrak{L}_{\bar{1}}$ , with basis

$$\{e_1, e_2\} \cup \{h_n, x_n, y_n : n \in \mathbb{N}, n \ge 2\}$$

of  $\mathfrak{L}_{\bar{0}}$  and

of  $\mathfrak{L}_{\bar{1}}$ ; and where the nonzero products on these elements are induced by the relations:

$$[e_2, e_1] = e_1, \quad [h_n, x_n] = 2n^2 x_n, \quad [h_n, y_n] = -\frac{2}{n^2} y_n,$$
$$[x_n, y_n] = h_n, \quad [y_n, g_n] = \frac{1}{n} f_n, \quad [x_n, f_n] = ng_n,$$
$$[h_n, f_n] = -\frac{1}{n} f_n, \quad [h_n, g_n] = ng_n, \quad [g_n, f_n] = h_n, \quad [g_n, g_n] = -2n^2 x_n,$$
$$[f_n, f_n] = \frac{2}{n^2} y_n.$$

Then by considering the superspace homomorphism

 $\phi:\mathfrak{L}\to\mathfrak{L}$ 

defined by

$$\phi(e_i) = e_i, i \in \{1, 2, 3\} and$$
  
$$\phi(h_n) = h_n, \phi(x_n) = n^2 x_n, \phi(y_n) = \frac{1}{n^2} y_n, \phi(f_n) = \frac{1}{n} f_n, \phi(g_n) = ng_n$$

for any  $n \ge 2$ , we have that  $\mathfrak{L} = \mathfrak{L}_{\overline{0}} \oplus \mathfrak{L}_{\overline{1}}$  becomes a, (non-Hom-Lie algebra and non-Lie superalgebra), split regular Hom-Lie superalgebra

$$\mathfrak{L} = H \oplus \mathfrak{L}_{\alpha} \oplus \big(\bigoplus_{n \in \mathbb{N}, n \ge 2} \mathfrak{L}_{\beta_n}\big) \oplus \big(\bigoplus_{n \in \mathbb{N}, n \ge 2} \mathfrak{L}_{-\beta_n}\big) \oplus \big(\bigoplus_{n \in \mathbb{N}, n \ge 2} \mathfrak{L}_{\gamma_n}\big) \oplus \big(\bigoplus_{n \in \mathbb{N}, n \ge 2} \mathfrak{L}_{-\gamma_n}\big)$$
(3)

where

$$H = \langle e_2, h_2, h_3, ..., h_n, ... \rangle \oplus \langle e_3 \rangle,$$
  
$$\mathfrak{L}_{\alpha} = \langle e_1 \rangle, \mathfrak{L}_{\beta_n} = \langle x_n \rangle, \mathfrak{L}_{-\beta_n} = \langle y_n \rangle, \mathfrak{L}_{\gamma_n} = \langle f_n \rangle \text{ and } \mathfrak{L}_{-\gamma_n} = \langle g_n \rangle,$$

being

$$\alpha, \beta_n, \gamma_n : H \to \mathbb{R},$$

 $n \in \mathbb{N}, n \geq 2$ , defined by

$$\alpha(e_2) = 1, \text{ and } \alpha(e_3) = \alpha(h_n) = 0, \text{ for any } n \ge 2,$$
  
 $\beta_n(e_2) = \beta_n(e_3) = 0, \beta_n(h_n) = 2, \text{ and } \beta_n(h_m) = 0 \text{ when } n \ne m,$   
 $\gamma_n(e_2) = \gamma_n(e_3) = 0, \gamma_n(h_n) = -1, \text{ and } \gamma_n(h_m) = 0 \text{ when } n \ne m.$ 

It is clear that the root space associated to the zero root satisfies  $H \subset \mathfrak{L}_0$ . Conversely, given any  $v_0 \in \mathfrak{L}_0$  we can write  $v_0 = h + \sum_{i=1}^n v_{\alpha_i}$  with  $h \in H$  and  $v_{\alpha_i} \in \mathfrak{L}_{\alpha_i}$  for  $i \in \{1, \ldots, n\}$ , being  $\alpha_i \in \Lambda$  with  $\alpha_i \neq \alpha_j$  if  $i \neq j$ . Hence  $0 = [h_{\bar{0}}, h + \sum_{i=1}^n v_{\alpha_i}] = \sum_{i=1}^n \alpha_i (h_{\bar{0}}) \phi(v_{\alpha_i})$  for any  $h_{\bar{0}} \in H_{\bar{0}}$ . So, taking into account the direct character of the sum, that  $\alpha_i \neq 0$  and  $\phi$  is an automorphism, we have that any  $v_{\alpha_i} = 0$  and then  $v_0 \in H$ . Consequently

$$H = \mathfrak{L}_0.$$

By the grading of  $\mathfrak{L}$ , any  $v_{\alpha} \in \mathfrak{L}_{\alpha}, \alpha \in \Lambda \cup \{0\}$  may be expressed in the form  $v_{\alpha} = v_{\alpha,\bar{0}} + v_{\alpha,\bar{1}}$  with  $v_{\alpha,\bar{i}} \in \mathfrak{L}_{\bar{i}}, \bar{i} \in \mathbb{Z}_2$ , then

$$[h_{\bar{0}}, v_{\alpha, \bar{i}}] = \alpha(h_{\bar{0}})\phi(v_{\alpha, \bar{i}})$$

for any  $h_{\bar{0}} \in H_{\bar{0}}$ . From here,  $\mathfrak{L}_{\alpha} = (\mathfrak{L}_{\alpha} \cap \mathfrak{L}_{\bar{0}}) \oplus (\mathfrak{L}_{\alpha} \cap \mathfrak{L}_{\bar{1}})$ . Hence, by denoting  $\mathfrak{L}_{\alpha,\overline{i}} := \mathfrak{L}_{\alpha} \cap \mathfrak{L}_{\overline{i}}$ , for  $\overline{i} \in \mathbb{Z}_2$ , we can write

$$\mathfrak{L}_{\alpha} = \mathfrak{L}_{\alpha,\bar{0}} \oplus \mathfrak{L}_{\alpha,\bar{1}} \tag{4}$$

for any  $\alpha \in \Lambda \cup \{0\}$ . From the above,

$$H_{ar{0}} = \mathfrak{L}_{0,ar{0}}$$
 and  $H_{ar{1}} = \mathfrak{L}_{0,ar{1}},$ 

and also

$$\mathfrak{L}_{ar{0}} = H_{ar{0}} \oplus (igoplus_{lpha \in \Lambda} \mathfrak{L}_{lpha, ar{0}}) \quad ext{and} \quad \mathfrak{L}_{ar{1}} = H_{ar{1}} \oplus (igoplus_{lpha \in \Lambda} \mathfrak{L}_{lpha, ar{1}}).$$

Taking into account this expression of  $\mathfrak{L}_{\bar{0}}$ , the direct character of the sum and the fact that  $\alpha \neq 0$  for any  $\alpha \in \Lambda$ , we have that  $H_{\bar{0}}$  is a MASA of the Hom-Lie algebra  $\mathfrak{L}_{\bar{0}}$ . Hence  $\mathfrak{L}_{\bar{0}}$  is a split regular Hom-Lie algebra (with respect to  $H_{\bar{0}}$ ) (cf. [2]) and  $\mathfrak{L}_{\bar{1}}$  is (in a sense) a split anti-Lie triple system (with respect to  $H_{\bar{0}}$ ) (cf. [5]). For an easier notation, the mappings  $\phi|_{H_{\bar{0}}}, \phi|_{H_{\bar{0}}}^{-1}: H_{\bar{0}} \to H_{\bar{0}}$  will be denoted by  $\phi$  and  $\phi^{-1}$ , respectively, when there is not possible confusion. The below lemma in an immediate consequence of super Hom-Jacobi identity.

**Lemma 1.1.** For any  $\alpha, \beta \in \Lambda \cup \{0\}$  the following assertions hold.

- 1. If  $\phi(\mathfrak{L}_{\alpha}) \neq 0$  then  $\alpha \phi^{-1} \in \Lambda \cup \{0\}$  and  $\phi(\mathfrak{L}_{\alpha}) = \mathfrak{L}_{\alpha \phi^{-1}}$ . In a similar way, if  $\phi^{-1}(\mathfrak{L}_{\alpha}) \neq 0$  then  $\alpha \phi \in \Lambda \cup \{0\}$  and  $\phi^{-1}(\mathfrak{L}_{\alpha}) = \mathfrak{L}_{\alpha \phi}$ . 2. If  $[\mathfrak{L}_{\alpha}, \mathfrak{L}_{\beta}] \neq 0$  then  $\alpha \phi^{-1} + \beta \phi^{-1} \in \Lambda \cup \{0\}$  and  $[\mathfrak{L}_{\alpha}, \mathfrak{L}_{\beta}] \subset \mathfrak{L}_{\alpha \phi^{-1} + \beta \phi^{-1}}$ .

*Proof.* 1. For any  $h_{\bar{0}} \in H_{\bar{0}}$  and  $0 \neq v_{\alpha} \in \mathfrak{L}_{\alpha}$ , since  $[h_{\bar{0}}, v_{\alpha}] = \alpha(h_{\bar{0}})\phi(v_{\alpha})$ , by writing  $h' := \phi(h_{\bar{0}})$  we have

$$[h', \phi(v_{\alpha})] = \phi([h_{\bar{0}}, v_{\alpha}]) = \alpha(h_{\bar{0}})\phi^{2}(v_{\alpha}) = \alpha\phi^{-1}(h')\phi(\phi(v_{\alpha})).$$

That is,  $0 \neq \phi(v_{\alpha}) \in \mathfrak{L}_{\alpha\phi^{-1}}, \alpha\phi^{-1} \in \Lambda \cup \{0\}$  and also

$$\phi(\mathfrak{L}_{\alpha}) \subset \mathfrak{L}_{\alpha\phi^{-1}}.$$
(5)

Now, for any  $h_{\bar{0}} \in H_{\bar{0}}$  and  $0 \neq v_{\alpha} \in \mathfrak{L}_{\alpha}$ , as in the previous inclusion, for  $h' := \phi^{-1}(h_{\bar{0}})$ we get

$$[h', \phi^{-1}(v_{\alpha})] = \phi^{-1}([h_{\bar{0}}, v_{\alpha}]) = \alpha(h_{\bar{0}})\phi^{-1}(\phi(v_{\alpha})) = \alpha\phi(h')\phi(\phi^{-1}(v_{\alpha})).$$

That is,  $0 \neq \phi^{-1}(v_{\alpha}) \in \mathfrak{L}_{\alpha\phi}, \alpha\phi \in \Lambda \cup \{0\}$  and conclude

$$\phi^{-1}(\mathfrak{L}_{\alpha}) \subset \mathfrak{L}_{\alpha\phi}.$$
 (6)

Now for any  $x \in \mathfrak{L}_{\alpha\phi^{-1}}$ , we can write  $x = \phi(\phi^{-1}(x))$  and since  $\alpha\phi^{-1} \in \Lambda \cup \{0\}$  by Equation (6) we have  $\phi^{-1}(x) \in \mathfrak{L}_{\alpha}$ , and we conclude  $\mathfrak{L}_{\alpha\phi^{-1}} \subset \phi(\mathfrak{L}_{\alpha})$ . This fact together with Equation (5) show  $\phi(\mathfrak{L}_{\alpha}) = \mathfrak{L}_{\alpha\phi^{-1}}$ . In a similar way we also prove  $\phi^{-1}(\mathfrak{L}_{\alpha}) = \mathfrak{L}_{\alpha\phi}$ .

2. For any  $h_{\bar{0}} \in H_{\bar{0}}, v_{\alpha} \in \mathfrak{L}_{\alpha}$  and  $v_{\beta} \in \mathfrak{L}_{\beta}$  such that  $[v_{\alpha}, v_{\beta}] \neq 0$ , by denoting  $h' := \phi(h_{\bar{0}})$ , we get

$$[h', [v_{\alpha}, v_{\beta}]] = -[[h_{\bar{0}}, v_{\beta}], \phi(v_{\alpha})] + [[h_{\bar{0}}, v_{\alpha}], \phi(v_{\beta})]$$
$$= (\alpha + \beta)(h_{\bar{0}})\phi([v_{\alpha}, v_{\beta}])$$
$$= (\alpha + \beta)\phi^{-1}(h')\phi([v_{\alpha}, v_{\beta}]).$$

That is,  $0 \neq [v_{\alpha}, v_{\beta}] \in \mathfrak{L}_{\alpha \phi^{-1} + \beta \phi^{-1}}$  and  $\alpha \phi^{-1} + \beta \phi^{-1} \in \Lambda \cup \{0\}$ . 

**Remark 1.1.** From Lemma 1.1 and Equation (4) we can assert that for any  $\alpha, \beta \in \Lambda \cup \{0\}$ and  $i, j \in \mathbb{Z}_2$ :

1. If  $\phi(\mathfrak{L}_{\alpha \overline{i}}) \neq 0$  then  $\alpha \phi^{-1} \in \Lambda \cup \{0\}$  and  $\phi(\mathfrak{L}_{\alpha \overline{i}}) = \mathfrak{L}_{\alpha \phi^{-1} \overline{i}}$ ,

2. If 
$$\phi^{-1}(\mathfrak{L}_{\alpha,\overline{i}}) \neq 0$$
 then  $\alpha \phi \in \Lambda \cup \{0\}$  and  $\phi^{-1}(\mathfrak{L}_{\alpha,\overline{i}}) = \mathfrak{L}_{\alpha\phi,\overline{i}}$ ,  
3. If  $[\mathfrak{L}_{\alpha,\overline{i}}, \mathfrak{L}_{\beta,\overline{j}}] \neq 0$  then  $\alpha \phi^{-1} + \beta \phi^{-1} \in \Lambda \cup \{0\}$  and  $[\mathfrak{L}_{\alpha,\overline{i}}, \mathfrak{L}_{\beta,\overline{j}}] \subset \mathfrak{L}_{\alpha\phi^{-1} + \beta\phi^{-1},\overline{i}+\overline{j}}$ ,

**Lemma 1.2.** If  $\alpha \in \Lambda$  then  $\alpha \phi^z \in \Lambda$  for any  $z \in \mathbb{Z}$ .

Proof. Consequence of Lemma 1.1-1.

**Remark 1.2.** From Lemma 1.2, Remark 1.1 and Equation (4) we can assert if  $\mathfrak{L}_{\alpha,\bar{i}} \neq 0$ , with  $\bar{i} \in \mathbb{Z}_2$ , then  $\mathfrak{L}_{\alpha\phi z,\bar{i}} \neq 0$  for any  $z \in \mathbb{Z}$ .

# 2. CONNECTIONS OF ROOTS TECHNIQUES

In the following, £ denotes a split regular Hom-Lie superalgebra and

$$\mathfrak{L} = \mathfrak{L}_0 \oplus \left( \bigoplus_{lpha \in \Lambda} \mathfrak{L}_lpha 
ight)$$

the corresponding root spaces decomposition. Given a linear functional  $\alpha : H_{\bar{0}} \to \mathbb{K}$ , we denote by  $-\alpha : H_{\bar{0}} \to \mathbb{K}$  the element in  $(H_{\bar{0}})^*$  defined by  $(-\alpha)(h_{\bar{0}}) := -\alpha(h_{\bar{0}})$  for all  $h_{\bar{0}} \in H_{\bar{0}}$ . We also denote by  $-\Lambda := \{-\alpha : \alpha \in \Lambda\}$  and

$$\pm\Lambda:=\Lambda\cup-\Lambda.$$

**Definition 2.1.** Let  $\alpha$  and  $\beta$  be two elements in  $\Lambda$ . We shall say that  $\alpha$  is *connected* to  $\beta$  if there exists  $\{\alpha_1, \alpha_2, \ldots, \alpha_k\} \subset \pm \Lambda$  such that:

$$\begin{split} &\text{If } k = 1, \\ &1. \ \alpha_1 \in \{\alpha \phi^{-n} : n \in \mathbb{N}_0\} \cap \{\pm \beta \phi^{-m} : m \in \mathbb{N}_0\}. \\ &\text{If } k \geq 2, \\ &1. \ \alpha_1 \in \{\alpha \phi^{-n} : n \in \mathbb{N}_0\}. \\ &2. \ \alpha_1 \phi^{-1} + \alpha_2 \phi^{-1} \in \pm \Lambda, \\ &\alpha_1 \phi^{-2} + \alpha_2 \phi^{-2} + \alpha_3 \phi^{-1} \in \pm \Lambda, \\ &\alpha_1 \phi^{-3} + \alpha_2 \phi^{-3} + \alpha_3 \phi^{-2} + \alpha_4 \phi^{-1} \in \pm \Lambda, \\ &\vdots \\ &\alpha_1 \phi^{-i} + \alpha_2 \phi^{-i} + \alpha_3 \phi^{-i+1} + \dots + \alpha_{i+1} \phi^{-1} \in \pm \Lambda, \\ &\vdots \\ &\alpha_1 \phi^{-k+2} + \alpha_2 \phi^{-k+2} + \alpha_3 \phi^{-k+3} + \dots + \alpha_i \phi^{-k+i} + \dots + \alpha_{k-1} \phi^{-1} \in \pm \Lambda. \\ &3. \ \alpha_1 \phi^{-k+1} + \alpha_2 \phi^{-k+1} + \alpha_3 \phi^{-k+2} + \dots + \alpha_i \phi^{-k+i-1} + \dots + \alpha_k \phi^{-1} \in \\ &\{\pm \beta \phi^{-m} : m \in \mathbb{N}_0\}. \end{split}$$

We shall also say that  $\{\alpha_1, \ldots, \alpha_k\}$  is a *connection* from  $\alpha$  to  $\beta$ .

Observe that the above concept of connection of nonzero roots from  $\alpha$  to  $\beta$ , given in Definition 2.1, for the case k = 1 is equivalent to the fact  $\beta = \epsilon \alpha \phi^z$  for some  $z \in \mathbb{Z}$  and  $\epsilon \in \{1, -1\}$ . Our next goal is to show that the connection relation is of equivalence. We begin with a couple of previous lemmas being their proof analogous to the ones of Lemma 2.1 and Lemma 2.2 in [2].

**Lemma 2.1.** For any  $\alpha \in \Lambda$ ,  $\alpha \phi^{z_1}$  is connected to  $\alpha \phi^{z_2}$  for any  $z_1, z_2 \in \mathbb{Z}$ , and also to  $-\alpha \phi^{z_2}$  in case  $-\alpha \in \Lambda$ .

**Lemma 2.2.** Let  $\{\alpha_1, \ldots, \alpha_k\}$  be a connection from  $\alpha$  to  $\beta$ . The following assertions hold.

1. If  $\alpha_1 = \alpha \phi^{-n}, n \in \mathbb{N}_0$ , then for any  $r \in \mathbb{N}_0$  such that  $r \ge n$ , there exists a connection  $\{\bar{\alpha}_1, \ldots, \bar{\alpha}_k\}$  from  $\alpha$  to  $\beta$  such that  $\bar{\alpha}_1 = \alpha \phi^{-r}$ .

2. If 
$$\alpha_1 = \epsilon \beta \phi^{-m}$$
 in case  $k = 1$  or

 $\alpha_1 \phi^{-k+1} + \alpha_2 \phi^{-k+1} + \alpha_3 \phi^{-k+2} + \dots + \alpha_k \phi^{-1} = \epsilon \beta \phi^{-m}$ 

in case  $k \geq 2$ , with  $m \in \mathbb{N}_0$  and  $\epsilon \in \{1, -1\}$ , then for any  $r \in \mathbb{N}_0$  such that  $r \geq m$ , there exists a connection  $\{\bar{\alpha}_1, \ldots, \bar{\alpha}_k\}$  from  $\alpha$  to  $\beta$  such that  $\bar{\alpha}_1 = \epsilon \beta \phi^{-r}$  in case k = 1 or

$$\bar{\alpha}_1 \phi^{-k+1} + \bar{\alpha}_2 \phi^{-k+1} + \bar{\alpha}_3 \phi^{-k+2} + \dots + \bar{\alpha}_k \phi^{-1} = \epsilon \beta \phi^{-r}$$

in case  $k \geq 2$ .

The proof of the next result follows the ideas of [2] for split Hom-Lie algebras. For the sake of completeness we add an sketch of the same.

**Proposition 2.1.** The relation  $\sim$  in  $\Lambda$  defined by  $\alpha \sim \beta$  if and only if  $\alpha$  is connected to  $\beta$  is an equivalence relation.

*Proof.* By Lemma 2.1 the relation  $\sim$  is reflexive. The symmetric character of  $\sim$  is consequence of consider  $\alpha \sim \beta$  with a connection  $\{\alpha_1, \alpha_2, \alpha_3, \ldots, \alpha_{k-1}, \alpha_k\} \subset \pm \Lambda$  from  $\alpha$  to  $\beta$ . If k = 1 we get  $\beta \sim \alpha$  with the connection  $\{\epsilon \alpha_1\}$ . If  $k \geq 2$ , we conclude  $\beta \sim \alpha$  taking the connection

$$\{\beta\phi^{-m}, -\alpha_k\phi^{-1}, -\alpha_{k-1}\phi^{-3}, -\alpha_{k-2}\phi^{-5}, \dots, -\alpha_{k-i}\phi^{-2i-1}, \dots, -\alpha_2\phi^{-2k+3}\} \subset \pm \Lambda$$
  
in case  $\alpha_1\phi^{-k+1} + \alpha_2\phi^{-k+1} + \alpha_3\phi^{-k+2} + \dots + \alpha_{k-i+1}\phi^{-i} + \dots + \alpha_k\phi^{-1} = \beta\phi^{-m}$ , and the connection

$$\{\beta\phi^{-m}, \alpha_k\phi^{-1}, \alpha_{k-1}\phi^{-3}, \alpha_{k-2}\phi^{-5}, \dots, \alpha_{k-i}\phi^{-2i-1}, \dots, \alpha_2\phi^{-2k+3}\} \pm \Lambda$$

in case  $\alpha_1 \phi^{-k+1} + \alpha_2 \phi^{-k+1} + \alpha_3 \phi^{-k+2} + \dots + \alpha_{k-i+1} \phi^{-i} + \dots + \alpha_k \phi^{-1} = -\beta \phi^{-m}$ , for some  $m \in \mathbb{N}_0$ .

Finally, to verify that ~ is transitive we suppose  $\alpha \sim \beta$  with connection  $\{\alpha_1, \ldots, \alpha_k\}$  such that

$$\alpha_1 = \epsilon \beta \phi^{-m} \text{ if } k = 1 \tag{7}$$

for some  $m \in \mathbb{N}_0$ ,  $\epsilon \in \{1, -1\}$ , or

$$\alpha_1 \phi^{-k+1} + \alpha_2 \phi^{-k+1} + \alpha_3 \phi^{-k+2} + \dots + \alpha_k \phi^{-1} = \epsilon \beta \phi^{-m} \text{ if } k \ge 2, \tag{8}$$

for some  $r \in \mathbb{N}_0$ , and suppose  $\beta \sim \gamma$  with connection  $\{h_1, \ldots, h_p\}$ . If  $p = 1, \{\alpha_1, \ldots, \alpha_k\}$  is also a connection from  $\alpha$  to  $\gamma$ . If  $p \ge 2, \{\alpha_1, \ldots, \alpha_k, h_2, \ldots, h_p\}$  is a connection from  $\alpha$  to  $\gamma$  if  $\epsilon = 1$  in Equations (7) or (8), and  $\{\alpha_1, \ldots, \alpha_k, -h_2, \ldots, -h_p\}$  is the referred connection if  $\epsilon = -1$  in Equations (7) or (8). Summarizing, the connection relation is also transitive and so it is an equivalence relation.

### 3. DECOMPOSITIONS

By Proposition 2.1 the connection relation is an equivalence relation in  $\Lambda$  and so we can consider the quotient set

$$\Lambda/\sim:=\{[\alpha]:\alpha\in\Lambda\},\$$

becoming  $[\alpha]$  the set of nonzero roots  $\mathfrak{L}$  which are connected to  $\alpha$ . Our next goal in this section is to associate an (adequate) ideal  $I_{[\alpha]}$  of the split regular Hom-Lie superalgebra  $\mathfrak{L}$  to any  $[\alpha]$  of  $\Lambda/\sim$ . For  $[\alpha]$ , with  $\alpha \in \Lambda$ , we define

$$H_{[\alpha]} := span_{\mathbb{K}} \{ [\mathfrak{L}_{\beta}, \mathfrak{L}_{\delta}] : \beta, \delta \in [\alpha] \} \cap \mathfrak{L}_{0}.$$

Applying Lemma 1.1-2 we obtain

$$H_{[\alpha]} := span_{\mathbb{K}} \{ [\mathfrak{L}_{\beta}, \mathfrak{L}_{-\beta}] : \beta \in [\alpha] \} =$$

6

$$\Big(\sum_{\beta \in [\alpha]} \left( [\mathfrak{L}_{\beta,\bar{0}},\mathfrak{L}_{-\beta,\bar{0}}] + [\mathfrak{L}_{\beta,\bar{1}},\mathfrak{L}_{-\beta,\bar{1}}] \right) \Big) \oplus \Big( \sum_{\beta \in [\alpha]} \left( [\mathfrak{L}_{\beta,\bar{0}},\mathfrak{L}_{-\beta,\bar{1}}] + [\mathfrak{L}_{\beta,\bar{1}},\mathfrak{L}_{-\beta,\bar{0}}] \right) \Big) \subset H_{\bar{0}} \oplus H_{\bar{1}} \oplus H_{\bar{1$$

last equality being consequence of Equation (4), and we also define

$$V_{[\alpha]} := \bigoplus_{\beta \in [\alpha]} \mathfrak{L}_{\beta} = (\bigoplus_{\beta \in [\alpha]} \mathfrak{L}_{\beta,\bar{0}}) \oplus (\bigoplus_{\beta \in [\alpha]} \mathfrak{L}_{\beta,\bar{1}}).$$

We denote by  $\mathfrak{L}_{[\alpha]}$  the following (graded) subspace of  $\mathfrak{L}$ ,

$$\mathfrak{L}_{[\alpha]} := H_{[\alpha]} \oplus V_{[\alpha]}.$$

**Proposition 3.1.** For any  $[\alpha] \in \Lambda / \sim$ , the linear subspace  $\mathfrak{L}_{[\alpha]}$  is a graded subalgebra of £.

*Proof.* First, we have to check that  $\mathfrak{L}_{[\alpha]}$  satisfies  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\alpha]}] \subset \mathfrak{L}_{[\alpha]}$ . Since  $H_{[\alpha]} \subset \mathfrak{L}_0 = \mathbb{C}$ H, then  $[H_{\alpha}], H_{\alpha}] = 0$  and we have

$$\left[H_{[\alpha]} \oplus V_{[\alpha]}, H_{[\alpha]} \oplus V_{[\alpha]}\right] \subset \left[H_{[\alpha]}, V_{[\alpha]}\right] + \left[V_{[\alpha]}, V_{[\alpha]}\right]. \tag{9}$$

Let us consider the first summand in Equation (9). Given  $\beta \in [\alpha]$  we have  $[H_{[\alpha]}, \mathfrak{L}_{\beta}] \subset$  $\mathfrak{L}_{\beta\phi^{-1}}$ , being  $\beta\phi^{-1} \in [\alpha]$  by Lemma 2.1. Hence

$$[H_{[\alpha]}, \mathfrak{L}_{\beta}] \subset V_{[\alpha]}. \tag{10}$$

Consider now the second summand in Equation (9), that is,  $[V_{[\alpha]}, V_{[\alpha]}]$ . Given  $\beta, \gamma \in [\alpha]$ such that  $[\mathfrak{L}_{\beta},\mathfrak{L}_{\gamma}] \neq 0$ , if  $\gamma = -\beta$  then clearly  $[\mathfrak{L}_{\beta},\mathfrak{L}_{\gamma}] = [\mathfrak{L}_{\beta},\mathfrak{L}_{-\beta}] \subset H_{[\alpha]}$ . Suppose  $\gamma \neq -\beta$ . Taking into account that the fact  $[\mathfrak{L}_{\beta}, \mathfrak{L}_{\gamma}] \neq 0$  together with Lemma 1.1-2 ensure  $\beta \phi^{-1} + \gamma \phi^{-1} \in \Lambda$ , we have that  $\{\beta, \gamma\}$  is a connection from  $\beta$  to  $\beta \phi^{-1} + \gamma \phi^{-1}$ . The transitivity of ~ gives now that  $\beta \phi^{-1} + \gamma \phi^{-1} \in [\alpha]$  and so  $[\mathfrak{L}_{\beta}, \mathfrak{L}_{\gamma}] \subset \mathfrak{L}_{\beta \phi^{-1} + \gamma \phi^{-1}} \subset V_{[\alpha]}$ . Hence  $[\bigoplus \mathfrak{L}_{\beta}, \bigoplus \mathfrak{L}_{\beta}] \subset H_{[\alpha]} \oplus V_{[\alpha]}$ . That is,

$$\beta \in [\alpha]$$
  $\beta \in [\alpha]$ 

$$[V_{[\alpha]}, V_{[\alpha]}] \subset \mathfrak{L}_{[\alpha]}. \tag{11}$$

From Equations (9)-(11) we get  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\alpha]}] = [H_{[\alpha]} \oplus V_{[\alpha]}, H_{[\alpha]} \oplus V_{[\alpha]}] \subset \mathfrak{L}_{[\alpha]}$ . Second, we have to verify that  $\phi(\mathfrak{L}_{[\alpha]}) = \mathfrak{L}_{[\alpha]}$ . But this is a direct consequence of Lemma 1.1-1 and Lemma 2.1. 

**Proposition 3.2.** If  $[\alpha] \neq [\gamma]$  then  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\gamma]}] = 0$ .

Proof. We have

$$\left[H_{[\alpha]} \oplus V_{[\alpha]}, H_{[\gamma]} \oplus V_{[\gamma]}\right] \subset \left[H_{[\alpha]}, V_{[\gamma]}\right] + \left[V_{[\alpha]}, H_{[\gamma]}\right] + \left[V_{[\alpha]}, V_{[\gamma]}\right].$$
(12)

Consider the above third summand  $[V_{[\alpha]}, V_{[\gamma]}]$  and suppose there exist  $\alpha_1 \in [\alpha]$  and  $\gamma_1 \in [\gamma]$  such that  $[\mathfrak{L}_{\alpha_1}, \mathfrak{L}_{\gamma_1}] \neq 0$ . As necessarily  $\alpha_1 \neq -\gamma_1$ , then  $\alpha_1 \phi^{-1} + \gamma_1 \phi^{-1} \in \Lambda$ . So  $\{\alpha_1, \gamma_1, -\alpha_1 \phi^{-1}\}$  is a connection between  $\alpha_1$  and  $\gamma_1$ . By the transitivity of the connection relation we have  $\alpha \in [\gamma]$ , a contradiction. Hence  $[\mathfrak{L}_{\alpha_1}, \mathfrak{L}_{\gamma_1}] = 0$  and so

$$[V_{[\alpha]}, V_{[\gamma]}] = 0. (13)$$

Consider now the first summand  $[H_{[\alpha]}, V_{[\gamma]}]$  in Equation (12) and suppose there exist  $\alpha_1 \in [\alpha]$  and  $\gamma_1 \in [\gamma]$  such that  $[[\mathfrak{L}_{\alpha_1}, \mathfrak{L}_{-\alpha_1}], \mathfrak{L}_{\gamma_1}] \neq 0$ . By Lemma 1.1-1 we have  $\mathfrak{L}_{\gamma_1} = \phi(\mathfrak{L}_{\gamma_1\phi})$ , so we obtain  $[[\mathfrak{L}_{\alpha_1}, \mathfrak{L}_{-\alpha_1}], \phi(\mathfrak{L}_{\gamma_1\phi})] \neq 0$ . Using the grading of  $\mathfrak{L}_{\alpha_1}$  we get

$$\left[ \left[ \mathfrak{L}_{\alpha_1,\bar{0}}, \mathfrak{L}_{-\alpha_1} \right], \phi(\mathfrak{L}_{\gamma_1 \phi}) \right] + \left[ \left[ \mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1} \right], \phi(\mathfrak{L}_{\gamma_1 \phi}) \right] \neq 0.$$

Therefore  $\left[ [\mathfrak{L}_{\alpha_1,\bar{0}}, \mathfrak{L}_{-\alpha_1}], \phi(\mathfrak{L}_{\gamma_1\phi}) \right] \neq 0$  or  $\left[ [\mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1}], \phi(\mathfrak{L}_{\gamma_1\phi}) \right] \neq 0$ . In the first case, by super Hom-Jacobi identity we get either  $[\mathfrak{L}_{-\alpha_1},\mathfrak{L}_{\gamma_1\phi}] \neq 0$  or  $[\mathfrak{L}_{\gamma_1\phi},\mathfrak{L}_{\alpha_1,\overline{0}}] \neq 0$ .

From here  $[V_{[\alpha]}, V_{[\gamma]}] \neq 0$  in any case, what contradicts Equation (13). In the second case we have  $0[[\mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1,\bar{0}}], \mathfrak{L}_{\gamma_1\phi}] + [[\mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1,\bar{1}}], \mathfrak{L}_{\gamma_1\phi}] \neq 0$  and so either  $[[\mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1,\bar{0}}], \mathfrak{L}_{\gamma_1\phi}] \neq 0$  or  $[[\mathfrak{L}_{\alpha_1,\bar{1}}, \mathfrak{L}_{-\alpha_1,\bar{1}}], \mathfrak{L}_{\gamma_1\phi}] \neq 0$ . By applying super Hom-Jacobi identity to any of these summands we have as above that necessarily  $[V_{[\alpha]}, V_{[\gamma]}] \neq 0$  what contradicts again Equation (13). From here  $[H_{[\alpha]}, V_{[\gamma]}] = 0$ .

In a similar way we get  $[V_{[\alpha]}, H_{[\gamma]}] = 0$  and we conclude, together with Equations (12) and (13) that  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\beta]}] = 0$ .

**Theorem 3.1.** Let  $\mathfrak{L}$  be a split regular Hom-Lie superalgebra. The following assertions *hold:* 

1. For any  $[\alpha] \in \Lambda / \sim$ , the (graded) subalgebra

$$\mathfrak{L}_{[\alpha]} = H_{[\alpha]} \oplus V_{[\alpha]}$$

of  $\mathfrak{L}$  associated to  $[\alpha]$  is an ideal of  $\mathfrak{L}$ .

2. If  $\mathfrak{L}$  is simple then there exists a connection from  $\alpha$  to  $\beta$  for any  $\alpha, \beta \in \Lambda$  and  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}].$ 

*Proof.* 1. Since  $[\mathfrak{L}_{[\alpha]}, H] \subset \mathfrak{L}_{[\alpha]}$  we have by Proposition 3.1 and Proposition 3.2 that

$$[\mathfrak{L}_{[\alpha]},\mathfrak{L}] = [\mathfrak{L}_{[\alpha]}, H \oplus (\bigoplus_{\beta \in [\alpha]} \mathfrak{L}_{\beta}) \oplus (\bigoplus_{\gamma \notin [\alpha]} \mathfrak{L}_{\gamma})] \subset \mathfrak{L}_{[\alpha]}.$$

We also have by Proposition 3.1 that  $\phi(\mathfrak{L}_{[\alpha]}) = \mathfrak{L}_{[\alpha]}$ , we conclude  $\mathfrak{L}_{[\alpha]}$  is an ideal of  $\mathfrak{L}$ .

2. The simplicity of  $\mathfrak{L}$  implies  $\mathfrak{L}_{[\alpha]} = \mathfrak{L}$ . From here, it is clear that  $[\alpha] = \Lambda$  and  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}]$ .

**Theorem 3.2.** A split regular Hom-Lie superalgebra  $\mathfrak{L}$  can be represented as

$$\mathfrak{L} = U + \sum_{[\alpha] \in \Lambda/\sim} \mathfrak{L}_{[\alpha]},$$

where U is a linear complement in H of  $span_{\mathbb{K}}\{[\mathfrak{L}_{\alpha},\mathfrak{L}_{-\alpha}]: \alpha \in \Lambda\}$  and any  $\mathfrak{L}_{[\alpha]}$  is one of the ideals of  $\mathfrak{L}$  described in Theorem 3.1-1, satisfying  $[\mathfrak{L}_{[\alpha]},\mathfrak{L}_{[\gamma]}] = 0$  if  $[\alpha] \neq [\gamma]$ .

*Proof.* We have  $\mathfrak{L}_{[\alpha]}$  is well defined and, by Theorem 3.1-1, an ideal of  $\mathfrak{L}$ , being clear that

$$\mathfrak{L} = H \oplus \left(\bigoplus_{\alpha \in \Lambda} \mathfrak{L}_{\alpha}\right) = U + \sum_{[\alpha] \in \Lambda/\sim} \mathfrak{L}_{[\alpha]}$$

Finally from Proposition 3.2 we obtain  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\gamma]}] = 0$  if  $[\alpha] \neq [\gamma]$ .

Let us denote by  $\mathcal{Z}(\mathfrak{L}) := \{ v \in \mathfrak{L} : [v, \mathfrak{L}] = 0 \}$  the *center* of  $\mathfrak{L}$ .

**Corollary 3.1.** If  $\mathcal{Z}(\mathfrak{L}) = 0$  and  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}]$  then  $\mathfrak{L}$  is the direct sum of the ideals given in Theorem 3.1,

$$\mathfrak{L} = igoplus_{[lpha] \in \Lambda/\sim} \mathfrak{L}_{[lpha]},$$

being  $[\mathfrak{L}_{[\alpha]},\mathfrak{L}_{[\gamma]}] = 0$  if  $[\alpha] \neq [\gamma]$ .

*Proof.* Since  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}]$  we get  $\mathfrak{L} = \sum_{[\alpha] \in \Lambda/\sim} \mathfrak{L}_{[\alpha]}$ . Finally, the direct character of the sum can be followed from the facts  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\gamma]}] = 0$ , if  $[\alpha] \neq [\gamma]$ , and  $\mathcal{Z}(\mathfrak{L}) = 0$ .

**Example 3.1.** Let us consider the split Hom-Lie superalgebra  $\mathfrak{L}$  in Example 1.1. We have that

$$\Lambda = \{\alpha\} \cup \{\pm \beta_n, \pm \gamma_n; n \in \mathbb{N}, n \ge 2\}.$$

It is straightforward to verify that

$$\Lambda / \sim = \{ [\alpha] \} \cup \{ [\beta_n] : n \in \mathbb{N}, n \ge 2 \},$$

where  $[\alpha] = \{\alpha\}$  and any  $[\beta_n] = \{\pm \beta_n, \pm \gamma_n\}$ . Indeed, for checking for instance  $\beta_n \sim \gamma_n$ , observe that the fact  $\beta_n \phi^{-1} + \gamma_n \phi^{-1} = -\gamma_n$  gives us that the set  $\{\beta_n, \gamma_n\}$  is a connection from  $\beta_n$  to  $\gamma_n$ .

From here, the results in this section allow us to consider the family of ideals

$$\mathfrak{L}_{[\alpha]} := \mathfrak{L}_{\alpha}, and$$

$$\mathfrak{L}_{[\beta_n]} := \langle h_n \rangle \oplus \mathfrak{L}_{\beta_n} \oplus \mathfrak{L}_{-\beta_n} \oplus \mathfrak{L}_{\gamma_n} \oplus \mathfrak{L}_{-\gamma_n}$$
, for  $n \ge 2$ ;

and the decomposition of  $\mathfrak{L}$  as the sum of the ideals

$$\mathfrak{L} = \langle e_2, e_3 \rangle \oplus \mathfrak{L}_{[\alpha]} \oplus (\bigoplus_{n \in \mathbb{N}, n \ge 2} \mathfrak{L}_{[\beta_n]}).$$
(14)

### 4. The simple components

In this section we are interested in studying under which conditions  $\mathfrak{L}$  decomposes as the direct sum of the family of its simple ideals. We recall that a roots system  $\Lambda$  of a split regular Hom-Lie superalgebra  $\mathfrak{L}$  is called *symmetric* if it satisfies that  $\alpha \in \Lambda$  implies  $-\alpha \in \Lambda$ . From now on we will suppose  $\Lambda$  is symmetric.

**Lemma 4.1.** If I is an ideal of  $\mathfrak{L}$  such that  $I \subset H$ , then  $I \subset \mathcal{Z}(\mathfrak{L})$ .

*Proof.* Consequence of  $[I, H] \subset [H, H] = 0$  and  $[I, \bigoplus_{\alpha \in \Lambda} \mathfrak{L}_{\alpha}] \subset (\bigoplus_{\alpha \in \Lambda} \mathfrak{L}_{\alpha}) \cap H = 0.$   $\Box$ 

Observe that the grading of I and Equation (4) let us write

$$I = I_{\bar{0}} \oplus I_{\bar{1}} = \left( \left( I_{\bar{0}} \cap H_{\bar{0}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda} (I_{\bar{0}} \cap \mathfrak{L}_{\alpha,\bar{0}}) \right) \right) \oplus \left( \left( I_{\bar{1}} \cap H_{\bar{1}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda} (I_{\bar{1}} \cap \mathfrak{L}_{\alpha,\bar{1}}) \right) \right).$$
(15)

Next lemmas have a proof similar to the ones of Lemma 4.2 and Lemma 4.3 in [2].

**Lemma 4.2.** For any  $\alpha, \beta \in \Lambda$  with  $\alpha \neq \beta$  there exists  $h_0 \in H_{\overline{0}}$  such that  $\alpha(h_0) \neq 0$  and  $\alpha(h_0) \neq \beta(h_0)$ .

**Lemma 4.3.** If I is an ideal of  $\mathfrak{L}$  and  $x = h + \sum_{j=1}^{n} v_{\alpha_j} \in I$ , with  $h \in H$ ,  $v_{\alpha_j} \in \mathfrak{L}_{\alpha_j}$ and  $\alpha_j \neq \alpha_k$  if  $j \neq k$ . Then any  $v_{\alpha_j} \in I$ .

Let us introduce the concepts of root-multiplicativity and maximal length in the framework of split Hom-Lie superalgebras in a similar way to the ones for split Hom-Lie algebras, split Lie algebras, split color algebras, split Leibniz algebras and split Lie superalgebras (see [2, 4, 6, 7, 8] for these notions and examples). We denote by  $\Lambda_{\bar{0}} := \{\alpha \in \Lambda : \mathfrak{L}_{\alpha,\bar{0}} \neq 0\}$ and by  $\Lambda_{\bar{1}} := \{\alpha \in \Lambda : \mathfrak{L}_{\alpha,\bar{1}} \neq 0\}$  (see Equation (4)). So  $\Lambda = \Lambda_{\bar{0}} \cup \Lambda_{\bar{1}}$ , being a non necessarily disjoint union.

**Definition 4.1.** We say that a split regular Hom-Lie superalgebra  $\mathfrak{L}$  is root-multiplicative if given  $\alpha \in \Lambda_{\overline{i}}, \beta \in \Lambda_{\overline{j}}, \text{for } \overline{i}, \overline{j} \in \mathbb{Z}_2$ , such that  $\alpha \phi^{-1} + \beta \phi^{-1} \in \Lambda_{\overline{i}+\overline{j}}$ , then  $[\mathfrak{L}_{\alpha,\overline{i}}, \mathfrak{L}_{\beta,\overline{j}}] \neq 0$ .

**Definition 4.2.** It is said that a split regular Hom-Lie superalgebra  $\mathfrak{L}$  is of maximal length if dim  $\mathfrak{L}_{\alpha,\overline{i}} \in \{0,1\}$  for any  $\alpha \in \Lambda$  with  $\overline{i} \in \mathbb{Z}_2$ .

Observe that if  $\mathfrak{L}$  is of maximal length, then the grading of I and Equation (4) allow us to assert that given any nonzero ideal I of  $\mathfrak{L}$  then

$$I = \left( \left( I_{\bar{0}} \cap H_{\bar{0}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda_{\bar{0}}^{I}} \mathfrak{L}_{\alpha,\bar{0}} \right) \right) \oplus \left( \left( I_{\bar{1}} \cap H_{\bar{1}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda_{\bar{1}}^{I}} \mathfrak{L}_{\alpha,\bar{1}} \right) \right)$$
(16)

where  $\Lambda_{\overline{i}}^{I} := \{ \alpha \in \Lambda_{\overline{i}} : I_{\overline{i}} \cap \mathfrak{L}_{\alpha,\overline{i}} \neq 0 \}$ , for  $\overline{i} \in \mathbb{Z}_{2}$ .

**Theorem 4.1.** Let  $\mathfrak{L}$  be a split regular Hom-Lie superalgebra of maximal length, root multiplicative and with  $\mathcal{Z}(\mathfrak{L}) = 0$ . It holds that  $\mathfrak{L}$  is simple if and only if it has all its nonzero roots connected and  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}].$ 

*Proof.* The necessary implication is Theorem 3.1-2. To prove the converse, consider I a nonzero ideal of  $\mathfrak{L}$ . By Lemmas 4.2, 4.3 and Equation (16) we can write

$$I = \left( \left( I_{\bar{0}} \cap H_{\bar{0}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda_{\bar{0}}^{I}} \mathfrak{L}_{\alpha,\bar{0}} \right) \right) \oplus \left( \left( I_{\bar{1}} \cap H_{\bar{1}} \right) \oplus \left( \bigoplus_{\alpha \in \Lambda_{\bar{1}}^{I}} \mathfrak{L}_{\alpha,\bar{1}} \right) \right)$$

with  $\Lambda_{\overline{i}}^{I} \subset \Lambda_{\overline{i}}$ , for  $\overline{i} \in \mathbb{Z}_{2}$  and some  $\Lambda_{\overline{i}}^{I} \neq \emptyset$  by Lemma 4.1. Hence, we can take  $\alpha_{0} \in \Lambda_{\overline{i}}^{I}$  being so

$$0 \neq \mathfrak{L}_{\alpha_0, \overline{i}} \subset I, \tag{17}$$

thus

$$\{\mathfrak{L}_{\alpha_0\phi^z,\bar{i}}: z \in \mathbb{Z}\} \subset I \tag{18}$$

because  $\phi(I) = I$  together with Lemma 1.1 and Remark 1.1 allow us to assert that

if 
$$\alpha \in \Lambda^{I}_{\overline{i}}$$
 then  $\{\alpha \phi^{z} : z \in \mathbb{Z}\} \subset \Lambda^{I}_{\overline{i}}.$  (19)

Now, let us take any  $\beta \in \Lambda \setminus \{\alpha_0 \phi^z, -\alpha_0 \phi^z : z \in \mathbb{Z}\}$ . Since  $\alpha_0$  and  $\beta$  are connected we have a connection  $\{\alpha_1, \alpha_2, \dots, \alpha_k\} \subset \Lambda, k \geq 2$ , from  $\alpha_0$  to  $\beta$  satisfying:

1. 
$$\alpha_{1} = \alpha_{0}\phi^{-n}$$
 for some  $n \in \mathbb{N}_{0}$ .  
2.  $\alpha_{1}\phi^{-1} + \alpha_{2}\phi^{-1} \in \Lambda$   
 $\alpha_{1}\phi^{-2} + \alpha_{2}\phi^{-2} + \alpha_{3}\phi^{-1} \in \Lambda$   
 $\vdots$   
 $\alpha_{1}\phi^{-i} + \alpha_{2}\phi^{-i} + \alpha_{3}\phi^{-i+1} + \dots + \alpha_{i+1}\phi^{-1} \in \Lambda$   
 $\vdots$   
 $\alpha_{1}\phi^{-k+2} + \alpha_{2}\phi^{-k+2} + \alpha_{3}\phi^{-k+3} + \dots + \alpha_{i}\phi^{-k+i} + \dots + \alpha_{k-1}\phi^{-1} \in \Lambda$   
3.  $\alpha_{1}\phi^{-k+1} + \alpha_{2}\phi^{-k+1} + \alpha_{3}\phi^{-k+2} + \dots + \alpha_{i}\phi^{-k+i-1} + \dots + \alpha_{k}\phi^{-1} = \epsilon\beta\phi^{-m}$   
for some  $m \in \mathbb{N}_{0}$  and  $\epsilon \in \{1, -1\}$ .

Consider  $\alpha_1 = \alpha_0 \in \Lambda_{\bar{i}}$ . Since  $\alpha_2 \in \Lambda$  it follows  $\mathfrak{L}_{\alpha_2,\bar{j}} \neq 0$ , for some  $\bar{j} \in \mathbb{Z}_2$ , and so  $\alpha_2 \in \Lambda_{\bar{j}}$ . We have  $\alpha_1 \in \Lambda_{\bar{i}}$  and  $\alpha_2 \in \Lambda_{\bar{j}}$  such that  $\alpha_1 \phi^{-1} + \alpha_2 \phi^{-1} \in \Lambda_{\bar{i}+\bar{j}}$  by Remark 1.1. The root-multiplicativity and maximal length of  $\mathfrak{L}$  allow us to assert  $0 \neq [\mathfrak{L}_{\alpha_1,\bar{i}}, \mathfrak{L}_{\alpha_2,\bar{j}}] = \mathfrak{L}_{\alpha_1\phi^{-1}+\alpha_2\phi^{-1},\bar{i}+\bar{j}}$ . As consequence of Equation (17) we get

$$0 \neq \mathfrak{L}_{\alpha_1 \phi^{-1} + \alpha_2 \phi^{-1}, \overline{i} + \overline{j}} \subset I.$$

A similar argument applied to  $\alpha_1 \phi^{-1} + \alpha_2 \phi^{-1}, \alpha_3$  and

$$(\alpha_1\phi^{-1} + \alpha_2\phi^{-1})\phi^{-1} + \alpha_3\phi^{-1} = \alpha_1\phi^{-2} + \alpha_2\phi^{-2} + \alpha_3\phi^{-1}$$

gives us  $0 \neq \mathfrak{L}_{\alpha_1 \phi^{-2} + \alpha_2 \phi^{-2} + \alpha_3 \phi^{-1}, \overline{l}} \subset I$ , for certain  $\overline{l} \in \mathbb{Z}_2$ . We can follow this process with the connection  $\{\alpha_1, \alpha_2, \ldots, \alpha_k\}$  to get

$$0 \neq \mathfrak{L}_{\alpha_1 \phi^{-k+1} + \alpha_2 \phi^{-k+1} + \alpha_3 \phi^{-k+2} + \dots + \alpha_i \phi^{-k+i-1} + \dots + \alpha_k \phi^{-1}, \bar{h} \subset I,$$

for some  $\bar{h} \in \mathbb{Z}_2$ , and then

$$0 \neq \mathfrak{L}_{\epsilon\beta\phi^{-m},\bar{h}} \subset I, \text{ for certain } \epsilon \in \{1,-1\}$$

$$(20)$$

for any  $\beta \in \Lambda \setminus \{\alpha_0 \phi^z, -\alpha_0 \phi^z : z \in \mathbb{Z}\}$  and some  $m \in \mathbb{N}_0$ . In general, from Equations (18) and (20) we get for any  $\alpha \in \Lambda$ 

either 
$$\{\mathfrak{L}_{\alpha\phi^z,\overline{i}}: z \in \mathbb{Z}\} \subset I$$
 or  $\{\mathfrak{L}_{-\alpha\phi^z,\overline{i}}: z \in \mathbb{Z}\} \subset I$ , for a fixed  $\overline{i} \in \mathbb{Z}_2$ .

which can be reformulated by given any  $\alpha \in \Lambda$ :

either  $\{\alpha\phi^z : z \in \mathbb{Z}\}$  or  $\{-\alpha\phi^z : z \in \mathbb{Z}\}$  is contained in  $\Lambda^I_{\overline{i}}$ , for some  $\overline{i} \in \mathbb{Z}_2$ . (21)

From here, if we have

$$\Lambda_{\bar{0}} \cap \Lambda_{\bar{1}} = \emptyset,$$

Equation (21) shows that for any  $\alpha \in \Lambda$  we have

$$a_{\alpha} \subset I$$
 (22)

for some  $\epsilon \in \{1, -1\}$ . Since the expression of H we get

$$H \subset I. \tag{23}$$

Now, for  $-\epsilon \alpha \in \Lambda$ , the facts  $-\epsilon \alpha \neq 0, H \subset I$  and the maximal length of  $\mathfrak{L}$  show

 $\mathfrak{L}_{\epsilon}$ 

$$H_{\bar{0}}, \mathfrak{L}_{-\epsilon\alpha}] = \mathfrak{L}_{-\epsilon\alpha} \subset I.$$
(24)

From Equations (22)-(24) we conclude  $I = \mathfrak{L}$ .

Therefore, it just remains to study the case in which there exists  $\alpha \in \Lambda$  such that

$$\alpha \in \Lambda_{\bar{0}} \cap \Lambda_{\bar{1}}$$

We begin with the following observation.

If there exists some 
$$\alpha \in \Lambda_{\bar{0}} \cap \Lambda_{\bar{1}}$$
 satisfying  $\mathfrak{L}_{\alpha,\bar{0}} \oplus \mathfrak{L}_{\alpha,\bar{1}} \subset I$  then  $I = \mathfrak{L}$ . (25)

Indeed, by arguing as above with the fact that  $\mathfrak{L}$  has all its nonzero roots connected from  $\mathfrak{L}_{\alpha,\bar{0}}$ , we get that for any  $\beta \in \Lambda \setminus \{\alpha, -\alpha\}, 0 \neq \mathfrak{L}_{\epsilon\beta,\bar{h}} \subset I$  for some  $\epsilon \in \{1, -1\}$  and some  $\bar{h} \in \mathbb{Z}_2$ . If we argue similarly from  $\mathfrak{L}_{\alpha,\bar{1}}$  we obtain  $0 \neq \mathfrak{L}_{\epsilon\beta,\bar{h}+\bar{1}} \subset I$ . So  $\mathfrak{L}_{\epsilon\beta} \subset I$ . From here, as  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}]$  we have

$$H \subset I. \tag{26}$$

Given now any  $\gamma \in \Lambda$ , the facts  $\gamma \neq 0$ ,  $H \subset I$  and the maximal length of  $\mathfrak{L}$  show

$$[H_{\bar{0}}, \mathfrak{L}_{\gamma, \bar{i}}] = \mathfrak{L}_{\gamma, \bar{i}} \subset I$$

for any  $\overline{i} \in \mathbb{Z}_2$ . Therefore

$$[H_{\bar{0}}, \mathfrak{L}_{\gamma}] = \mathfrak{L}_{\gamma} \subset I.$$
<sup>(27)</sup>

From Equations (26) and (27) we conclude  $I = \mathfrak{L}$ .

Let us return to our  $\alpha \in \Lambda$  such that  $\alpha \in \Lambda_{\bar{0}} \cap \Lambda_{\bar{1}}$ . Taking into account Equation (21)  $\epsilon \alpha \phi^{-m} \in \Lambda$ , for certain  $\epsilon \in \{1, -1\}$  and some  $m \in \mathbb{N}_0$ , then  $[H_{\bar{0}}, \mathfrak{L}_{\epsilon \alpha \phi^{-m}, \bar{h}}] \neq 0$  for fixed  $\bar{h} \in \mathbb{Z}_2$ . Since  $H_{\bar{0}} = \sum_{\gamma \in \Lambda} ([\mathfrak{L}_{\gamma, \bar{0}}, \mathfrak{L}_{-\gamma, \bar{0}}] + [\mathfrak{L}_{\gamma, \bar{1}}, \mathfrak{L}_{-\gamma, \bar{1}}])$ , there exists  $\gamma \in \Lambda$  such that either

 $[[\mathfrak{L}_{\gamma,\bar{0}},\mathfrak{L}_{-\gamma,\bar{0}}],\mathfrak{L}_{\epsilon\alpha\phi^{-m},\bar{h}}] \neq 0 \text{ or } [[\mathfrak{L}_{\gamma,\bar{1}},\mathfrak{L}_{-\gamma,\bar{1}}],\mathfrak{L}_{\epsilon\alpha\phi^{-m},\bar{h}}] \neq 0. \text{ That is, by Lemma 1.1} \text{ and Remark 1.2 is } \phi(\mathfrak{L}_{\epsilon\beta\phi^{-m+1},\bar{h}}) = \mathfrak{L}_{\epsilon\alpha\phi^{-m},\bar{h}}, \text{ and so}$ 

$$\left[\left[\mathfrak{L}_{\gamma,\bar{n}},\mathfrak{L}_{-\gamma,\bar{n}}\right],\phi(\mathfrak{L}_{\epsilon\alpha\phi^{-m+1},\bar{h}})\right]\neq0\tag{28}$$

for some  $\bar{n} \in \mathbb{Z}_2$  and fixed  $\bar{h} \in \mathbb{Z}_2, m \in \mathbb{N}_0$ . By super Hom-Jacobi identity

either 
$$[\mathfrak{L}_{\epsilon\alpha\phi^{-m+1},\bar{h}},\mathfrak{L}_{\gamma,\bar{n}}]\neq 0$$
 or  $[\mathfrak{L}_{-\gamma,\bar{n}},\mathfrak{L}_{\epsilon\alpha\phi^{-m+1},\bar{h}}]\neq 0$ 

and so  $\mathfrak{L}_{\gamma+\epsilon\alpha\phi^{-m+1},\bar{n}+\bar{h}}\neq 0$  or  $\mathfrak{L}_{-\gamma+\epsilon\alpha\phi^{-m+1},\bar{n}+\bar{h}}\neq 0$ . That is, by Equation (20),

$$0 \neq \mathfrak{L}_{\kappa\gamma + \epsilon\alpha\phi^{-m+1}, \bar{n} + \bar{h}} \subset I \tag{29}$$

for some  $\kappa \in \{1, -1\}$ .

Let us distinguish two possibilities, if  $\mathfrak{L}_{-\kappa\gamma,\bar{n}+\bar{1}} \neq 0$ , we get by the root-multiplicativity and maximal length of  $\mathfrak{L}$  that

$$0 \neq [\mathfrak{L}_{\kappa\gamma+\epsilon\alpha\phi^{-m+1},\bar{n}+\bar{h}},\mathfrak{L}_{-\kappa\gamma,\bar{n}+\bar{1}}] = \mathfrak{L}_{\epsilon\alpha\phi^{-m+1},\bar{h}+\bar{1}} \subset I.$$

From here, Equations (21) and (25) give us  $I = \mathfrak{L}$ .

If  $\mathfrak{L}_{-\kappa\gamma,\bar{n}+\bar{1}} = 0$ , as by symmetry of  $\Lambda$  is  $-\epsilon\alpha\phi^{-m} \in \Lambda$ , and by Lemma 1.2 we also obtain  $-\epsilon\alpha\phi^{-m+1} \in \Lambda$ , so  $\mathfrak{L}_{-\epsilon\alpha\phi^{-m+1},\bar{m}} \neq 0$  for some  $\bar{m} \in \mathbb{Z}_2$ . By Equation (29) and the root-multiplicativity and maximal length of  $\mathfrak{L}$  we obtain

$$0 \neq [\mathfrak{L}_{\kappa\gamma + \epsilon\alpha\phi^{-m+1},\bar{n}+\bar{h}}, \mathfrak{L}_{-\epsilon\alpha\phi^{-m+1},\bar{m}}] = \mathfrak{L}_{\kappa\gamma,\bar{n}+\bar{h}+\bar{m}} \subset I.$$
(30)

If  $\bar{h} + \bar{m} = \bar{0}$ , taking into account that Equation (28) gives us  $[[\mathfrak{L}_{\gamma,\bar{n}}, \mathfrak{L}_{-\gamma,\bar{n}}], \mathfrak{L}_{\epsilon\alpha\phi^{-m},\bar{h}}] \neq 0$ , that is,

$$\alpha([\mathfrak{L}_{\gamma,\bar{n}},\mathfrak{L}_{-\gamma,\bar{n}}])\neq 0,$$

Equation (30) and the fact  $\alpha \in \Lambda_{\bar{0}} \cap \Lambda_{\bar{1}}$  let us assert  $0 \neq [[\mathfrak{L}_{\gamma,\bar{n}}, \mathfrak{L}_{-\gamma,\bar{n}}], \mathfrak{L}_{\alpha,\bar{p}}] = \mathfrak{L}_{\alpha,\bar{p}} \subset I$  for any  $\bar{p} \in \mathbb{Z}_2$ . From here, Equation (25) gives us  $I = \mathfrak{L}$ .

If  $\bar{h} + \bar{m} = \bar{1}$  we have by Equation (30) and the root-multiplicativity and maximal length of  $\mathfrak{L}$  that  $0 \neq [\mathfrak{L}_{\kappa\gamma,\bar{n}+\bar{1}}, \mathfrak{L}_{\epsilon\alpha\phi^{-m+1},\bar{h}}] = \mathfrak{L}_{\kappa\gamma+\epsilon\alpha\phi^{-m+1},\bar{n}+\bar{h}+\bar{1}} \subset I$ . From here, Equations (29) and (25) give us  $I = \mathfrak{L}$ . Consequently  $\mathfrak{L}$  is simple.

**Theorem 4.2.** Let  $\mathfrak{L}$  be a split regular Hom-Lie superalgebra of maximal length, root multiplicative satisfying  $\mathcal{Z}(\mathfrak{L}) = 0$  and  $H = \sum_{\alpha \in \Lambda} [\mathfrak{L}_{\alpha}, \mathfrak{L}_{-\alpha}]$ . Then  $\mathfrak{L}$  is the direct sum of the family of its minimal ideals, each one being a simple split regular Hom-Lie superalgebra having all its nonzero roots connected.

*Proof.* By Corollary 3.1,  $\mathfrak{L} = \bigoplus_{[\alpha] \in \Lambda/\sim} \mathfrak{L}_{[\alpha]}$  is the direct sum of the ideals

$$\mathfrak{L}_{[\alpha]} = H_{[\alpha]} \oplus V_{[\alpha]} = \Bigl(\sum_{\beta \in [\alpha]} [\mathfrak{L}_{\beta}, \mathfrak{L}_{-\beta}] \Bigr) \oplus \Bigl(\bigoplus_{\beta \in [\alpha]} \mathfrak{L}_{\beta} \Bigr)$$

having any  $\mathfrak{L}_{[\alpha]}$  its root system  $[\alpha]$  with all of its roots connected. Taking into account the facts  $[\alpha] = -[\alpha]$  and  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\alpha]}] \subset \mathfrak{L}_{[\alpha]}$  (see Proposition 3.1-1) we easily deduce that  $[\alpha]$  has all of its roots connected through roots in  $[\alpha]$ . We also have that any of the  $\mathfrak{L}_{[\alpha]}$  is root-multiplicative as consequence of the root-multiplicativity of  $\mathfrak{L}$  and trivially is regular. Finally, is clear that  $\mathfrak{L}_{[\alpha]}$  is of maximal length and  $\mathcal{Z}_{\mathfrak{L}_{[\alpha]}}(\mathfrak{L}_{[\alpha]}) = 0$  (where  $\mathcal{Z}_{\mathfrak{L}_{[\alpha]}}(\mathfrak{L}_{[\alpha]})$  denotes de center of  $\mathfrak{L}_{[\alpha]}$  in  $\mathfrak{L}_{[\alpha]}$ ) as consequence of  $[\mathfrak{L}_{[\alpha]}, \mathfrak{L}_{[\gamma]}] = 0$  if  $[\alpha] \neq [\gamma]$  (Theorem 3.2) and  $\mathcal{Z}(\mathfrak{L}) = 0$ . We can apply Theorem 4.1 to any  $\mathfrak{L}_{[\alpha]}$  so as to conclude  $\mathfrak{L}_{[\alpha]}$  is simple. It is clear that the decomposition  $\mathfrak{L} = \bigoplus_{[\alpha] \in \Lambda/\sim} \mathfrak{L}_{[\alpha]}$  satisfies the assertions of the theorem.

**Remark 4.1.** We finally note that the results in the present paper also hold for non regular Hom-Lie superalgebras  $\mathfrak{L}$  if we introduce the class of split non regular Hom-Lie superalgebras by asking for H not only the condition of being a maximal abelian subalgebra of  $\mathfrak{L}$ but also the one of satisfying that  $\phi|_H$  is a linear bijection from H onto H. **Example 4.1.** Let us consider the real  $\mathbb{Z}_2$ -graded vector space  $\mathfrak{L} = \mathfrak{L}_{\bar{0}} \oplus \mathfrak{L}_{\bar{1}}$ , with basis

$$\{e_1, e_2\} \cup \{h_n, x_n, y_n : n \in \mathbb{N}, n \ge 2\}$$

of  $\mathfrak{L}_{\bar{0}}$  and

$$\{e_3\} \cup \{f_n, g_n : n \in \mathbb{N}, n \ge 2\}$$

of  $\mathfrak{L}_1$  given in Example 1.1. Here the nonzero products on these elements were induced by the relations:

$$[e_2, e_1] = e_1, \quad [h_n, x_n] = 2n^2 x_n, \quad [h_n, y_n] = -\frac{2}{n^2} y_n,$$
$$[x_n, y_n] = h_n, \quad [y_n, g_n] = \frac{1}{n} f_n, \quad [x_n, f_n] = ng_n,$$
$$[h_n, f_n] = -\frac{1}{n} f_n, \quad [h_n, g_n] = ng_n, \quad [g_n, f_n] = h_n, \quad [g_n, g_n] = -2n^2 x_n$$
$$[f_n, f_n] = \frac{2}{n^2} y_n.$$

If we now consider the superspace homomorphism

$$\phi': \mathfrak{L} \to \mathfrak{L}$$

defined by

$$\phi'(e_1) = e_1, \ \phi'(e_2) = e_2, \ \phi'(e_3) = 0 \ and$$
  
$$\phi'(h_n) = h_n, \ \phi'(x_n) = n^2 x_n, \ \phi'(y_n) = \frac{1}{n^2} y_n, \ \phi'(f_n) = \frac{1}{n} f_n, \ \phi'(g_n) = ng_n$$

for any  $n \ge 2$ , we have that  $\mathfrak{L} = \mathfrak{L}_{\overline{0}} \oplus \mathfrak{L}_{\overline{1}}$  also becomes a split Hom-Lie superalgebra, with a root spaces decomposition as in Equation (3), which is not regular since  $\phi'$  is not an automorphism of  $(\mathfrak{L}, [\cdot, \cdot])$ . However,  $\phi'|_H$  is a linear bijection from H onto H. From here, Remark 4.1 allows us to assert that  $\mathfrak{L}$  admits an analogous decomposition as sum of ideals as the one given in Equation (14).
