## THE $L_p$ POLAR BODIES OF SHADOW SYSTEM AND RELATED INEQUALITIES

ABSTRACT. The  $L_p$  versions of the support function and polar body are introduced by Berndtsson, Mastrantonis and Rubinstein in [7] recently. In this paper, we prove that the  $L_p$ -support function of the shadow system  $K_t$  introduced by Rogers and Shephard in [27,30] is convex and the volume of the section of  $L_p$  polar bodies of  $K_t$  is  $\frac{1}{n}$ -concave with respect to parameter t, and obtain some related inequalities. Finally, we present the reverse Rogers-Shephard type inequality for  $L_p$ -polar bodies.

#### 1. INTRODUCTION

A convex body is a subset  $K \subset \mathbb{R}^n$  which is convex, compact, and has non-empty interior. The support function  $h_K$  of a convex body K is defined by

$$h_K(x) = \max\{\langle x, y \rangle : y \in K\}, \quad x \in \mathbb{R}^n$$

where  $\langle \cdot, \cdot \rangle$  denotes the standard inner product. By int(K) we denote the interior of K. If K is a convex body in  $\mathbb{R}^n$  and  $z \in int(K)$ , the polar body  $K^z$  of K with the center of polarity z is defined by

$$K^{z} = \{ y \in \mathbb{R}^{n} : \langle y - z, x - z \rangle \le 1 \quad \text{for all} \ x \in K \}.$$

$$(1.1)$$

If the center of polarity is taken to be the origin, we denote by  $K^o$  the polarity of K, thus  $K^z = (K-z)^o + z$ . For  $z \in int(K)$ ,  $(K^z)^z = K$  (see [20] or [29, Theorem 1.6.1]). In [7], Berndtsson, Mastrantonis and Rubinstein introduced  $L_p$  versions of the support function  $h_K$  and polar body  $K^o$  of K as follows.

**Definition 1.1.** For  $p \in (0, +\infty]$  and  $K \subset \mathbb{R}^n$ , the  $L_p$  support function  $h_{p,K}$  of K is defined by

$$h_{p,K}(y) := \log\left(\int_{K} e^{p\langle x, y \rangle} \frac{dx}{|K|}\right)^{\frac{1}{p}}, \quad y \in \mathbb{R}^{n}.$$
 (1.2)

where |K| is the volume of K and the  $L_p$  polar body  $K^{o,p}$  of K is defined by

$$K^{o,p} := \{ y \in \mathbb{R}^n : \|y\|_{K^{o,p}} \le 1 \},$$
(1.3)

where

$$\|y\|_{K^{o,p}} := \left(\frac{1}{(n-1)!} \int_0^\infty r^{n-1} e^{-h_{p,K}(ry)} dr\right)^{-\frac{1}{n}}.$$
 (1.4)

From (1.4) and the formula in [29, P276, Remark 5.1.2], the volume of  $K^{o,p}$  can be represented in the form

$$|K^{o,p}| = \frac{1}{n} \int_{S^{n-1}} \|u\|_{K^{o,p}}^{-n} du = \frac{1}{n!} \int_{\mathbb{R}^n} e^{-h_{p,K}(x)} dx,$$
(1.5)

where in the first integral the integration is with respect to Lebesgue measure on the unit sphere  $S^{n-1}$  and in the second integral the integration is with respect to Lebesgue measure on  $\mathbb{R}^n$ . It is obvious that  $h_K$  and  $K^o$  are  $L_\infty$ versions of  $h_{p,K}$  and  $K^{o,p}$ , i.e.,

$$h_K = h_{\infty,K}$$
 and  $K^o = K^{o,\infty}$ .

Berndtsson et al also introduced  $L_p$  Mahler volumes  $\mathcal{M}_p(K)$  of a convex body K in [7],

$$\mathcal{M}_p(K) := |K| \int_{\mathbb{R}^n} e^{-h_{p,K}(x)} dx, \qquad (1.6)$$

and the authors also introduced  $L_p$  Mahler conjectures and established many important and interesting results. One of their main results is the following  $L_p$  Blaschke-Santaló's inequality.

**Theorem A.** [7] Let  $p \in (0, +\infty]$ . For a symmetric convex body  $K \subset \mathbb{R}^n$ ,

$$\mathcal{M}_p(K) \le \mathcal{M}_p(B_2^n),$$

where  $B_2^n = \{x \in \mathbb{R}^n : |x_1|^2 + \dots + |x_n|^2 \le 1\}.$ 

By taking  $p \to +\infty$ , one recovers the classical Blaschke-Santaló's inequality:

$$\mathcal{M}(K) \le \mathcal{M}(B_2^n).$$

For more reference of Blaschke-Santaló's inequality, we refer to [16–20] and references therein. The idea used in the proof of Theorem A is standard: for  $u \in S^{n-1}$ , the Steiner symmetrization  $S_u K$  of K with respect to a hyperplane  $u^{\perp} := \{x \in \mathbb{R}^n : \langle x, u \rangle = 0\}$  increases the volume of the  $L_p$  polar body, i.e.,

$$|(S_u K)^{o,p}| \ge |K^{o,p}|.$$

The notion of shadow system was introduced by Rogers and Shephard [27] and Shephard [30]. A shadow system along the direction  $v \in S^{n-1}$  is a family of convex sets  $K_t \subset \mathbb{R}^n$ ,

$$K_t = conv\{x + \alpha(x)tv : x \in K \subset \mathbb{R}^n\},\tag{1.7}$$

where *conv* denotes convex hull, K is an arbitrary bounded set of points,  $\alpha(x)$  is bounded function on K and  $t \in \mathbb{R}$ . The function  $\alpha(x)$  is called the

speed function of the shadow system. A parallel chord movement along the direction  $v \in S^{n-1}$  is a particular type of shadow system defined by

$$K_t = \{ x + \beta(x|v^{\perp})tv : x \in K \},$$
(1.8)

where  $K \subset \mathbb{R}^n$  is a convex body and  $\beta(\cdot)$  is a continuous real function on the projection  $K|v^{\perp}$  of K onto  $v^{\perp}$ . The speed function  $\beta(\cdot)$  has to be given in such a way that at time t the union  $K_t$  of moving chords is convex. For the use of special shadow system, we refer to Bianchini and Colesanti [8], Campi and Gronchi [10–13], Fradelizi, Meyer and Zvavitch [15] and Meyer and Reiser [21,22] and references therein.

For any  $v \in S^{n-1}$  and  $s \in \mathbb{R}$ , the projection of  $K \cap (v^{\perp} + sv)$  of a convex body  $K \subset \mathbb{R}^n$  onto  $v^{\perp}$  is denoted by K(s), i.e.,

$$K(s) = \{x' : x' + sv \in K\}.$$

In this paper, we will prove that the  $L_p$ -support function of the shadow system  $K_t$  is convex and the slice volume of  $L_p$  polar body  $K_t^{o,p}$  of a parallel chord movement  $K_t$  is  $\frac{1}{n}$ -concave with respect to parameter t.

**Theorem 1.1.** Let  $p \in (0, \infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel movement of a convex body  $K \subset \mathbb{R}^n$  along the direction v. Then the function  $t \mapsto h_{p,K_t}$  is convex.

**Theorem 1.2.** Let  $p \in (0, +\infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel chord movement of a convex body K along the direction v. Then for all  $s, t_i \in \mathbb{R}$ , i = 1, 2

$$|K_{\frac{t_1+t_2}{2}}^{o,p}(s)|^{\frac{1}{n-1}} \ge \frac{1}{2}|K_{t_1}^{o,p}(s)|^{\frac{1}{n-1}} + \frac{1}{2}|K_{t_2}^{o,p}(s)|^{\frac{1}{n-1}}.$$
(1.9)

Let K be a convex body. For any  $v \in S^{n-1}$ , we have

$$K = \{x' + sv : x' \in K | v^{\perp}, g_v(x') \le s \le f_v(x')\},$$
(1.10)

where  $g_v(x')$  and  $-f_v(x')$  are convex functions on  $K|v^{\perp}$ . If we take  $\beta(\cdot) = -(g_v(\cdot) + f_v(\cdot))$ , then  $K_0 = K$ ,  $K_1 = K^v$  is the reflection of K in the hyperplane  $v^{\perp}$ , and  $K_{\frac{1}{2}} = S_v K$  is the Steiner symmetrization of K with respect to  $v^{\perp}$ . Taking  $t_1 = 0$ ,  $t_2 = 1$  and  $\beta(\cdot) = -(g_v(\cdot) + f_v(\cdot))$  in Theorem 1.2, we have the following corollary.

**Corollary 1.3.** Let K be a symmetric convex body. Then for any  $v \in S^{n-1}$ ,  $|(S_vK)^{o,p}| \ge |K^{o,p}|.$ 

The Minkowski sum of two convex bodies  $K,L\subset \mathbb{R}^n$  is the convex body defined by

$$K + L := \{ x + y \in \mathbb{R}^n : x \in K, y \in L \}$$
(1.11)

and K - L := K + (-L). It was proved in [2] (see also [4]) that for any two convex bodies  $K, L \subseteq \mathbb{R}^n$  with  $o \in intK \cap intL$ 

$$|(K \cap L)^{o}||(K - L)^{o}| \le |K^{o}||L^{o}|, \qquad (1.12)$$

and in [2] Alonso at all also point out that (1.12) only converges to equality when we consider sequences of sets  $\{(K_n^o)_n\}$  and  $\{(L_n^o)_n\}$  converging to simplices with o in one of the vertices and the same outer normal vectors at the facets that pass through the origin.

A reverse inequality was proved by Alonso in [3] as follows: Let  $K, L \subseteq \mathbb{R}^n$  be convex bodies such that  $K^o$  and  $L^o$  have opposite barycenters.

$$|(K \cap L)^{o}||(K - L)^{o}| \ge \frac{(n!)^{2}}{(2n)!}|K^{o}||L^{o}|$$
(1.13)

For more references on Rogers-Shephard inequalities and its reverse, we refer to [1-4,24-26] and reference therein. In Section 3, we prove the following volumes inequality which is a reverse Rogers-Shephard type inequality about  $L_p$  polar bodies.

**Theorem 1.4.** Let  $p \in (0, +\infty]$  and  $K, L \subset \mathbb{R}^n$  be convex bodies with  $o \in intK \cap intL$  such that  $K^{o,p}$  and  $L^{o,p}$  have opposite barycenters. Then

$$C_{2n}^{n} \left| conv \left( K^{o,p} \cup L^{o,p} \right) \right| \cdot \left| \left[ (K^{o,p})^{o} - (L^{o,p})^{o} \right]^{o} \right| \ge |K^{o,p}| |L^{o,p}|.$$

where  $C_{2n}^n = \frac{(2n)!}{(n!)^2}$  is the combination number formula.

The ideas and techniques of Berndtsson, Mastrantonis and Rubinstein [7], Meyer and Werner [23], Meyer and Pajor [20] and Alonso at al [1–3] play a critical role throughout this paper. It would be impossible to overstate our reliance on their work.

#### 2. P POLAR BODY OF SHAWDOW SYSTEM

For quick reference, we list some notations and definitions that will be useful in all the paper. See [29] for additional detail. The origin, unit sphere, and closed unit ball in *n*-dimensional Euclidean space  $\mathbb{R}^n$  are denoted by  $o, S^{n-1}$  and  $B_2^n$ . If  $u \in S^{n-1}$ , then  $u^{\perp}$  is the hyperplane containing oand orthogonal u. For any convex body  $K \subset \mathbb{R}^n$ , we will denote by  $I_K^{\infty}$ the convex characteristic function of K which is the function defined by  $I_K^{\infty}(x) = 0$  if  $x \in K$  and  $I_K^{\infty}(x) = +\infty$  if  $x \notin K$ .

In addition to its denoting absolute value, we shall use  $|\cdot|$  to denote the standard Euclidean norm on  $\mathbb{R}^n$  and to denote k-dimensional volume in  $\mathbb{R}^n$ ,  $k \leq n$ .

In this section we will prove the following theorems.

**Theorem 2.1.** Let  $p \in (0, \infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel movement of a convex body  $K \subset \mathbb{R}^n$  along the direction v. Then the function  $t \mapsto h_{p,K_t}$  is convex, i.e., for any  $x' \in v^{\perp}$ ,  $s, t_i \in \mathbb{R}$ , i = 1, 2, we have

$$\frac{1}{2}h_{p,K_{t_1}}(x'+sv) + \frac{1}{2}h_{p,K_{t_2}}(x'+sv) \ge h_{p,K_{\frac{t_1+t_2}{2}}}(x'+sv).$$

**Theorem 2.2.** Let  $p \in (0, +\infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel chord movement of a convex body K along the direction v. Then for all  $s, t_i \in \mathbb{R}$ , i = 1, 2

$$|K_{\frac{t_1+t_2}{2}}^{o,p}(s)|^{\frac{1}{n-1}} \ge \frac{1}{2}|K_{t_1}^{o,p}(s)|^{\frac{1}{n-1}} + \frac{1}{2}|K_{t_2}^{o,p}(s)|^{\frac{1}{n-1}}.$$
(2.1)

**Lemma 2.3.** [7, Corollary 5.16] Let  $p \in (0, +\infty]$ ,  $v \in S^{n-1}$  and K be an origin symmetric convex body. Then for all  $s \in \mathbb{R}$ , then

$$K^{o,p}(s) = K^{o,p}(-s).$$

**Lemma 2.4.** Let  $p \in (0, +\infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel chord movement of a convex body K with speed function

$$\beta(\cdot) := -\Big(f_v(\cdot) + g_v(\cdot)\Big)$$

along the direction v. Then for all  $s \in \mathbb{R}$ ,

$$K^{o,p}(s) = K_1^{o,p}(s).$$

*Proof.* Since for any  $v \in S^{n-1}$ ,

$$K = \{x' + sv | g_v(x') \le s \le f_v(x'), x' \in K | v^{\perp} \},\$$

and from the definition of parallel movement (1.8), we have

$$K_1 = \{x' + sv| - f_v(x') \le s \le -g_v(x'), x' \in K | v^{\perp} \}.$$

Hence, for any  $x' \in v^{\perp}$  and  $s \in \mathbb{R}$ ,

$$h_{p,K_{1}}(x'+sv) = \frac{1}{p} \log \int_{K_{1}} e^{p\langle z'+z_{n}v,x'+sv\rangle} \frac{dz'dz_{n}}{|K_{1}|}$$

$$= \frac{1}{p} \log \int_{K|v^{\perp}} \int_{-f_{v}(x')}^{-g_{v}(x')} e^{p\langle z',x'\rangle} e^{psz_{n}} \frac{dz'dz_{n}}{|K|}$$

$$= \frac{1}{p} \log \int_{K|v^{\perp}} e^{p\langle z',x'\rangle} \frac{1}{ps} [e^{ps(-g_{v}(z'))} - e^{ps(-f_{v}(z'))}] \frac{dz'}{|K|}$$

$$= \frac{1}{p} \log \int_{K} e^{p\langle z'+z_{n}v,x'-sv\rangle} \frac{dz'dz_{n}}{|K|}$$

$$= h_{p,K}(x'-sv). \qquad (2.2)$$

From (1.4) and (2.2), we get

$$\begin{aligned} \|x' + sv\|_{K_1^{o,p}} &= \left(\frac{1}{(n-1)!} \int_0^\infty r^{n-1} e^{-h_{p,K_1}(r(x'+sv))} dr\right)^{-\frac{1}{n}} \\ &= \left(\frac{1}{(n-1)!} \int_0^\infty r^{n-1} e^{-h_{p,K}(r(x'-sv))} dr\right)^{-\frac{1}{n}} \\ &= \|x' - sv\|_{K^{o,p}}. \end{aligned}$$

Therefore,  $x'+sv\in K_1^{o,p}$  if and only if  $x'-sv\in K^{o,p}$  , which means that  $K^{o,p}(-s)=K_1^{o,p}(s).$ 

**Lemma 2.5.** Let  $p \in (0, \infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel movement of a convex body  $K \subset \mathbb{R}^n$  along the direction v. Then for any  $x', y' \in v^{\perp}, s \in \mathbb{R}$  and a, b, c > 0 with  $\frac{2}{a} = \frac{1}{b} + \frac{1}{c}$ , we have

$$\frac{c}{b+c}h_{p,K_{t_1}}(bx'+bsv) + \frac{b}{b+c}h_{p,K_{t_2}}(cy'+csv) \ge h_{p,K_{\frac{t_1+t_2}{2}}}(a\frac{x'+y'}{2}+asv)$$

*Proof.* For any  $v \in S^{n-1}$ , there are convex functions  $g_v(\cdot), -f_v(\cdot): K|v^{\perp} \to \mathbb{R}$ , such that

$$K = \{ z' + rv : g_v(z') \le r \le f_v(z'), z' \in K | v^{\perp} \}.$$

Let  $m_i := \frac{1}{2}(g_v + f_v) + \beta t_i, i = 1, 2$ , where  $\beta$  is the speed function of  $K_t$ and  $f_v := f_v(z'), g_v := g_v(z')$ .

From (1.2), Fubini's Theorem and (1.8), we have

$$h_{p,K_{t_{1}}}(bx'+bsv)$$

$$=\frac{1}{p}\log\int_{K_{t_{1}}}e^{p\langle z,bx'+bsv\rangle}\frac{dz}{|K_{t_{1}}|}$$

$$=\frac{1}{p}\log\int_{K|v^{\perp}}\int_{g_{v}+\beta t_{1}}^{f_{v}+\beta t_{1}}e^{pb\langle z',x'\rangle}e^{pbsr}\frac{drdz'}{|K|}$$

$$=\frac{1}{p}\log\int_{K|v^{\perp}}e^{pb\langle z',x'\rangle}\frac{1}{pbs}\left(e^{pbs\frac{f_{v}-g_{v}}{2}}-e^{-pbs\frac{f_{v}-g_{v}}{2}}\right)\cdot e^{pbsm_{1}}dz'$$

$$=\frac{1}{p}\log\int_{K|v^{\perp}}e^{pb\langle z',x'\rangle}\cdot J(z',b)\cdot e^{pbsm_{1}(z')}dz'$$
(2.3)

where

$$J(z',b) = \frac{1}{pbs} (e^{pbs\frac{f_v - g_v}{2}} - e^{-pbs\frac{f_v - g_v}{2}}).$$

In the similar way we have

$$h_{p,K_{t_2}}(cy' + csv) = \frac{1}{p} \log \int_{K|v^{\perp}} e^{pc\langle z', y' \rangle} \cdot J(z', c) \cdot e^{pbsm_2(z')} dz', \quad (2.4)$$

and

$$h_{p,K_{\frac{t_1+t_2}{2}}}(a\frac{x'+y'}{2}+asv) = \frac{1}{p}\log\int_{K|v^{\perp}}e^{p\frac{a}{2}\langle z',x'+y'\rangle} \cdot J(z',a) \cdot e^{pas\frac{m_1+m_2}{2}}dz'.$$
 (2.5)

From (2.3) and (2.4), Minkowski inequality and the fact that  $\frac{2}{a} = \frac{1}{b} + \frac{1}{c}$ , we have

$$\frac{c}{b+c}h_{p,K_{t_{1}}}(bx'+bsv) + \frac{b}{b+c}h_{p,K_{t_{2}}}(cy'+csv) \\
= \frac{1}{p}\log\left[\left(\int_{K|v^{\perp}} e^{pb\langle z',x'\rangle} \cdot J(z',b)e^{pbsm_{1}}dz'\right)^{\frac{c}{b+c}} \\
\cdot \left(\int_{K|v^{\perp}} e^{pc\langle z',y'\rangle} \cdot J(z',c) \cdot e^{pbsm_{2}}dz'\right)^{\frac{b}{b+c}}\right] \\
\geq \frac{1}{p}\log\int_{K|v^{\perp}} e^{p\frac{bc}{b+c}\langle z',x'\rangle} \cdot J(z',b)^{\frac{c}{b+c}} \cdot e^{\frac{pbcsm_{1}}{b+c}} \cdot e^{p\frac{bc}{b+c}\langle z',y'\rangle} \cdot J(z',c)^{\frac{b}{b+c}} dz' \\
= \frac{1}{p}\log\int_{K|v^{\perp}} e^{p\frac{a}{2}\langle z',x'+y'\rangle} \cdot J(z',b)^{\frac{c}{b+c}} \cdot J(z',c)^{\frac{b}{b+c}} \cdot e^{pas\frac{m_{1}+m_{2}}{2}(z')}dz'. \quad (2.6)$$

Since  $J(z',t) = \frac{2}{pst}\sinh(\frac{f_v - g_v}{2}pst)$  is log-convex in t, i.e.

$$J(z',b)^{\frac{c}{b+c}} \cdot J(z',c)^{\frac{b}{b+c}} \ge J(z',a),$$

from (2.5) and (2.6), we have

$$\begin{aligned} &\frac{c}{b+c}h_{p,K_{t_1}}(bx'+bsv) + \frac{b}{b+c}h_{p,K_{t_2}}(cy'+csv) \\ &\geq \frac{1}{p}\log \int_{K|v^{\perp}} e^{pa\langle z',\frac{x'+y'}{2}\rangle} \cdot J(z',a) \cdot e^{pas\frac{m_1+m_2}{2}}dz' \\ &= h_{p,K_{\frac{t_1+t_2}{2}}}(a\frac{x'+y'}{2}+asv) \end{aligned}$$

 -	-	-	

Proof of Theorem 2.1. The direct conclusion of the Lemma 2.5 is that the  $L_p$ -support function of the shadow system  $K_t$  is convex with respect to parameter t.  $\Box$ 

The following well known consequence of Keith Ball will be needed.

**Lemma 2.6.** [5, Theorem 5] Let  $F, G, H : (0, +\infty) \to [0, +\infty)$  be measurable functions, not almost everywhere 0, with

$$H(r) \ge F(t)^{\frac{s}{t+s}} \cdot G(s)^{\frac{t}{t+s}}, \quad \frac{2}{r} = \frac{1}{s} + \frac{1}{t}.$$

Then, for  $q \geq 1$ ,

$$2\Big(\int_0^\infty r^{q-1}H(r)dr\Big)^{-\frac{1}{q}} \le \Big(\int_0^\infty t^{q-1}F(t)dt\Big)^{-\frac{1}{q}} + \Big(\int_0^\infty s^{q-1}G(s)ds\Big)^{-\frac{1}{q}}.$$

**Lemma 2.7.** Let  $p \in (0, \infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel chord movement of a convex body K along the direction v. Then for any  $s, t_i \in \mathbb{R}$ , i = 1, 2.

$$\frac{1}{2}K^{o,p}_{t_1}(s) + \frac{1}{2}K^{o,p}_{t_2}(s) \subset K^{o,p}_{\frac{t_1+t_2}{2}}(s).$$

*Proof.* For any  $x' + sv \in K_{t_1}^{o,p}, y' + sv \in K_{t_2}^{o,p}$ , and  $a, b, c \in \mathbb{R}$  with  $\frac{2}{a} = \frac{1}{b} + \frac{1}{c}$ , from Lemma 2.5, we have

$$e^{-h_{p,K_{\frac{t_1+t_2}{2}}}(a\frac{x'+y'}{2}+asv)} \ge \left(e^{-h_{p,K_{t_1}}(bx'+bsv)}\right)^{\frac{c}{b+c}} \cdot \left(e^{-h_{p,K_{t_2}}(cy'+csv)}\right)^{\frac{b}{b+c}}.$$
(2.7)

From (1.4), (2.7) and Lemma 2.6, we get

$$\begin{split} \|\frac{x'+y'}{2} + sv\|_{K_{\frac{t_1+t_2}{2}}^{o,p}} \\ &= \left(\frac{1}{(n-1)!} \int_0^\infty a^{n-1} e^{-h_{p,K_{\frac{t_1+t_2}{2}}}(a\frac{x'+y'}{2} + asv)} da\right)^{-\frac{1}{n}} \\ &\leq \frac{1}{2} \left(\frac{1}{(n-1)!} \int_0^\infty b^{n-1} e^{-h_{p,K_{t_1}}(bx'+bsv)} db\right)^{-\frac{1}{n}} \\ &\quad + \frac{1}{2} \left(\frac{1}{(n-1)!} \int_0^\infty c^{n-1} e^{-h_{p,K_{t_2}}(cy'+csv)} dc\right)^{-\frac{1}{n}} \\ &= \frac{1}{2} \|x'+sv\|_{K_{t_1}^{o,p}} + \frac{1}{2} \|y'+sv\|_{K_{t_2}^{o,p}} \leq 1. \end{split}$$

Hence

$$\frac{x'+y'}{2} + sv \in K^{o,p}_{\frac{t_1+t_2}{2}},$$

which means that

$$\frac{1}{2}K_{t_1}^{o,p}(s) + \frac{1}{2}K_{t_2}^{o,p}(s) \subset K_{\frac{t_1+t_2}{2}}^{o,p}(s).$$

*Proof of Theorem 2.2.* It is obvious that the inequality (2.1) follows from the Brunn-Minkowski inequality and Lemma 2.7.  $\Box$ 

**Corollary 2.8.** Let  $p \in (0, +\infty]$ ,  $v \in S^{n-1}$  and  $K_t$  be a parallel chord movement of a convex body K with speed function  $\beta(\cdot) = -(g_v(\cdot) + f_v(\cdot))$ along the direction v. Then for all  $s \in \mathbb{R}$ ,

$$\frac{1}{2}K^{o,p}(s) + \frac{1}{2}K^{o,p}_{1}(s) \subset K^{o,p}_{\frac{1}{2}}(s) = (S_vK)^{o,p}(s).$$
(2.8)

In particular, for K = -K,

$$|(S_v K)^{o,p}| \ge |K^{o,p}|. \tag{2.9}$$

*Proof.* Taking  $t_1 = 0$  and  $t_2 = 1$  in Lemma 2.7 and Theorem 2.2, it is easily to obtain (2.8) and (2.9) follows from (2.8), Lemma 2.4 and Lemma 2.3.

*Remark* 2.1. We should point out that the above inequality (2.9) has been proven in [7].

The following  $L_p$  Blaschke-Santaló inequality follows from (2.9), (1.5), (1.6) and the fact that repeated Steiner symmetrizations converge to a dilated Euclidean standard ball. THE  $L_p$  POLAR BODIES OF SHADOW SYSTEM AND RELATED INEQUALITIES 9

**Corollary 2.9.** [7] Let  $p \in (0, +\infty]$ . For a symmetric convex body  $K \subset \mathbb{R}^n$ ,

$$\mathcal{M}_p(K) \le \mathcal{M}_p(B_2^n),\tag{2.10}$$

where  $B_2^n = \{x \in \mathbb{R}^n : |x_1|^2 + \dots + |x_n|^2 \le 1\}.$ 

Remark 2.2. We want to point out that the above inequality (2.10) in [7] is stated for symmetric bodies and we can get a different upper bound for  $\mathcal{M}_p(K)$  of convex body K, which may not be symmetric.

We need the following Lemma which is classical and can be found in [23, Lemma 3] or in [14, Lemma 2.5].

**Lemma 2.10.** Let  $K \subset \mathbb{R}^n$  be a convex body with  $o, z \in intK$ . Then

$$|(K-z)^o| = \int_{K^o} \frac{dx}{(1-\langle z, x \rangle)^{n+1}}$$

**Lemma 2.11.** [7, Remark 3.14] Let  $p \in (0, \infty]$  and  $K \subset \mathbb{R}^n$  be a convex body with bar(K) = o. Then

$$K^o \subset K^{o,p} \subset \frac{(1+p)^{1+\frac{1}{p}}}{p} K^o.$$

**Proposition 2.12.** Let  $p \in (0,\infty]$  and  $K \subset \mathbb{R}^n$  be a convex body with bar(K) = o. Then

$$\mathcal{M}_p(K) \le n! \left(\frac{(1+p)^{1+\frac{1}{p}}}{p}\right)^n |B_2^n|^2.$$

*Proof.* Let  $z \in int K^{o,p}$ . From Lemma 2.10, Lemma 2.11 and applying Jensen's inequality to the convex function  $\varphi(x) = (1 - \langle z, x \rangle)^{-(n+1)}$  on K, we get

$$|(K^{o,p} - z)^{o}| = \int_{(K^{o,p})^{o}} \frac{dx}{(1 - \langle z, x \rangle)^{n+1}} \\ \ge \int_{\frac{p}{(1+p)^{1+\frac{1}{p}}K}} \frac{dx}{(1 - \langle z, x \rangle)^{n+1}} \\ \ge \left(\frac{p}{(1+p)^{1+\frac{1}{p}}}\right)^{n} |K| \varphi \left(\int_{\frac{p}{(1+p)^{1+\frac{1}{p}}K}} x \frac{dx}{|\frac{p}{(1+p)^{1+\frac{1}{p}}K}|}\right) \\ = \left(\frac{p}{(1+p)^{1+\frac{1}{p}}}\right)^{n} |K|, \qquad (2.11)$$

where the barycenter of  $\left(\frac{p}{(1+p)^{1+\frac{1}{p}}}K\right)$  is *o*.

Let  $z = San(K^{o,p})$  be the Santaló point  $K^{o,p}$ . Using (2.11) and the classical Blaschke Santaló inequality, we can obtain

$$|K||K^{o,p}| \le \left(\frac{(1+p)^{1+\frac{1}{p}}}{p}\right)^n |\left(K^{o,p} - San(K^{o,p})\right)^o||K^{o,p}| \le \left(\frac{(1+p)^{1+\frac{1}{p}}}{p}\right)^n |B_2^n|^2,$$

which shows that

$$\mathcal{M}_p(K) \le n! \left(\frac{(1+p)^{1+\frac{1}{p}}}{p}\right)^n |B_2^n|^2.$$

# 3. The reverse Rogers-Shephard type inequality for P polar bodies

In this section we will discuss reverse Rogers-Shephard type inequality for  $L^p$ -polar bodies. We will need the following useful Lemmas.

# **Lemma 3.1.** [7, Lemma 3.1] Let $p \in (0, \infty]$ and K be a convex body. Then $o \in intK$ if and only if $o \in intK^{o,p}$ .

**Lemma 3.2.** [29, Theorem 1.6.3] Let  $K, L \subset \mathbb{R}^n$  be convex bodies with  $o \in int(K \cap L)$ . Then

$$(K^o \cap L^o)^o = conv(K \cup L).$$

**Lemma 3.3.** Let  $p \in (0, +\infty]$  and  $K, L \subset \mathbb{R}^n$  be convex bodies with  $o \in int(K \cap L)$ . Then, for any  $z \in \mathbb{R}^n$ ,

$$\inf_{z=x+y} (\|x\|_{K^{o,p}} + \|y\|_{K^{o,p}}) = \|z\|_{conv(K^{o,p} \cup L^{o,p})}.$$

*Proof.* For any convex function f on  $\mathbb{R}^n$ , its *Legendre transform*  $\mathcal{L}f$  is defined by

$$\mathcal{L}f(x) = \sup_{y \in \mathbb{R}^n} \{ \langle x, y \rangle - f(y) \}.$$

In fact, for any convex body  $K, L \subset \mathbb{R}^n$  with  $o \in int(K \cap L)$ , we have

$$\mathcal{L}\Big(\inf_{\cdot=x+y}(\|x\|_{K}+\|y\|_{L})\Big)(z)$$

$$=\sup_{w\in\mathbb{R}^{n}}\Big(\langle w,z\rangle - \inf_{w=x+y}(\|x\|_{K}+\|y\|_{L})\Big)$$

$$=\sup_{w\in\mathbb{R}^{n}}\Big(\langle w,z\rangle - \inf_{w=x+y}(h_{K^{o}}(x)+h_{L^{o}}(y))\Big)$$

$$=\sup_{w\in\mathbb{R}^{n}}\sup_{w=x+y}\Big(\langle x,z\rangle - h_{K^{o}}(x)+\langle y,z\rangle - h_{L^{o}}(y)\Big)$$

$$=I_{K^{o}}^{\infty}(z)+I_{L^{o}}^{\infty}(z).$$
(3.1)

10

Hence, from Lemma 3.2,

$$\inf_{z=x+y} (\|x\|_{K} + \|y\|_{L})$$

$$= \mathcal{L} \Big( I_{K^{o}}^{\infty}(\cdot) + I_{L^{o}}^{\infty}(\cdot) \Big)(z)$$

$$= \sup_{w \in \mathbb{R}^{n}} \Big( \langle w, z \rangle - I_{K^{o}}^{\infty}(w) - I_{L^{o}}^{\infty}(w) \Big)$$

$$= h_{K^{o} \cap L^{o}}(z) = \|z\|_{(K^{o} \cap L^{o})^{o}}$$

$$= \|z\|_{conv(K \cup L)}.$$
(3.2)

The conclusion follows from Lemma 3.1 and (3.2).

**Lemma 3.4.** [24] Let  $\mu$  be a probability measure on  $\mathbb{R}^n$  and let  $\phi : \mathbb{R}^n \to \mathbb{R}$  be a non-negative log-concave function with finite, positive integral. Then

$$\int_{\mathbb{R}^n} \phi(x) d\mu(x) \le \Big( \int_{\mathbb{R}^n} x \frac{\phi(x)}{\int_{\mathbb{R}^n} \phi(y) d\mu(y)} d\mu(x) \Big).$$

**Lemma 3.5.** Let  $K, L \subset \mathbb{R}^n$  be convex bodies. Then, for any  $x, y \in \mathbb{R}^n$ ,

$$\max\{\|x\|_{K}, \|y\|_{L}\} = \|(x, y)\|_{K \times L}.$$

In fact, from the definition of norm, we have

$$\|(x,y)\|_{K\times L} = \inf\{\lambda : (x,y) \in \lambda(K\times L)\}$$
$$= \max\{\inf\{\lambda : x \in \lambda K\}, \inf\{\lambda : y \in \lambda L\}\}$$
$$= \max\{\|x\|_{K}, \|y\|_{L}\}.$$

Let  $K, L \subset \mathbb{R}^n$  be convex bodies with  $o \in int(K \cap L)$ . For simplification, we introduce the following notations.

$$f(x) = e^{-\|x\|_{K^{o,p}}}$$
 and  $g(y) = e^{-\|y\|_{L^{o,p}}}$ . (3.3)

$$C_t = \{(x, y) \in \mathbb{R}^{2n} : f(x)g(-y) \ge t\}$$
(3.4)

$$\tilde{C}_t = \{(u, v) \in \mathbb{R}^{2n} : f(\frac{u+v}{\sqrt{2}})g(-\frac{u-v}{\sqrt{2}}) \ge t\}.$$
(3.5)

Let  $M_t$  be the projection of  $\tilde{C}_t$  onto the subspace

$$H = span\{e_{n+1}, \cdots, e_{2n}\} = \mathbb{R}^n,$$

thus

$$M_t = \{(o, v) \in \mathbb{R}^{2n} : \max_{u \in \mathbb{R}^n} f(\frac{u+v}{\sqrt{2}})g(-\frac{u-v}{\sqrt{2}}) \ge t\}.$$
 (3.6)

**Theorem 3.6.** Let  $p \in (0, +\infty]$  and  $K, L \subset \mathbb{R}^n$  be convex bodies with  $o \in intK \cap intL$  such that  $K^{o,p}$  and  $L^{o,p}$  have opposite barycenters. Then

$$C_{2n}^{n} \left| conv \left( K^{o,p} \cup L^{o,p} \right) \right| \cdot \left| \left( (K^{o,p})^{o} - (L^{o,p})^{o} \right)^{o} \right| \ge |K^{o,p}| |L^{o,p}|,$$

where  $C_{2n}^n = \frac{(2n)!}{(n!)^2}$  is the combination number formula.

*Proof.* From the definitions (3.5) and (3.6), the volume of  $\tilde{C}_t$  can be expressed as an integral,

$$|\tilde{C}_t| = \int_{M_t} \int_{\tilde{C}_t \cap \left((0,v) + H^{\perp}\right)} du dv = \int_{M_t} \phi_t(v) dv, \qquad (3.7)$$

where  $\phi_t(v) = |\tilde{C}_t \cap ((o, v) + H^{\perp})|$  is the volume of the section  $\tilde{C}_t \cap ((o, v) + H^{\perp})$ .

Since  $\phi_t(v)$  is a log-concave function and has support on  $M_t$ , from (3.7) Lemma 3.4, we have

$$\widetilde{C}_{t}| = |M_{t}| \int_{M_{t}} \phi_{t}(v) \frac{dv}{|M_{t}|} \leq |M_{t}| \phi_{t} \left( \frac{\int_{M_{t}} v \phi_{t}(v) \frac{dv}{|M_{t}|}}{\int_{M_{t}} \phi_{t}(v) \frac{dv}{|M_{t}|}} \right)$$

$$= |M_{t}| \phi_{t} \left( \frac{1}{|\widetilde{C}_{t}|} \int_{M_{t}} \int_{\widetilde{C}_{t} \cap \left((0,v) + H^{\perp}\right)} v du dv \right)$$

$$= |M_{t}| \phi_{t} \left( \frac{1}{|\widetilde{C}_{t}|} \int_{\widetilde{C}_{t}} v du dv \right).$$
(3.8)

By using variable substitution  $u = \frac{x+y}{\sqrt{2}}$ ,  $v = \frac{x-y}{\sqrt{2}}$ , we have

$$\int_{\tilde{C}_t} v du dv = \frac{1}{\sqrt{2}} \int_{\{(x,y):f(x)g(-y) \ge t\}} x - y dx dy$$
$$= \frac{1}{\sqrt{2}} \Big( \int_{C_t} x dx dy - \int_{C_t} y dx dy \Big).$$
(3.9)

Since  $||f||_{\infty} = ||g||_{\infty} = 1$ , we have

$$\begin{split} \int_{C_t} x dx dy &= \int_{\{(x,y):f(x)g(-y) \ge t\}} x dy dx \\ &= \int_{\{x:f(x) \ge t\}} \int_{\{y:g(-y) \ge \frac{t}{f(x)}\}} x dy dx \\ &= \int_{\{x:\|x\|_{K^{o,p}} \le -\log t\}} \int_{\{y:\|-y\|_{L^{o,p}} \le -\log t - \|x\|_{K^{o,p}}\}} x dy dx \\ &= |-L^{o,p}| \int_{(-\log t)K^{o,p}} x(-\log t - \|x\|_{K^{o,p}})^n dx \\ &= |L^{o,p}|(-\log t)^{2n+1} \int_{K^{o,p}} z(1 - \|z\|_{K^{o,p}})^n dz \\ &= (-\log t)^{2n+1} |L^{o,p}| \int_{K^{o,p}} z \int_{\|z\|_{K^{o,p}}}^1 n(1-s)^n ds dz \\ &= (-\log t)^{2n+1} |L^{o,p}| n \int_0^1 (1-s)^n \int_{sK^{o,p}} z dz ds \end{split}$$

$$= (-\log t)^{2n+1} |K^{o,p}| |L^{o,p}| n \int_0^1 (1-s)^n s^{n+1} ds \int_{K^{o,p}} z \frac{dz}{|K^{o,p}|}$$
$$= n(-\log t)^{2n+1} \beta(n,n+2) |K^{o,p}| |L^{o,p}| \cdot bar(K^{o,p}), \qquad (3.10)$$

where  $\beta(n, n+2)$  is Euler integral. In the similar way, we have

$$\int_{C_t} y dx dy = n(-\log t)^{2n+1} \beta(n, n+2) |K^{o,p}| |L^{o,p}| \cdot bar(L^{o,p}).$$
(3.11)

From (3.8), (3.9), (3.10), (3.11) and the fact that  $bar(K^{o,p}) = -bar(L^{o,p})$ , we get

$$|\tilde{C}_t| \le |M_t|\phi_t(o) = |M_t| \cdot |\tilde{C}_t \cap H^{\perp}|.$$
(3.12)

On the one hand,

$$\int_{0}^{1} \tilde{C}_{t} dt = \int_{0}^{1} \int_{\{(u,v) \in \mathbb{R}^{2n} : f(\frac{u+v}{\sqrt{2}})g(-\frac{u-v}{\sqrt{2}}) \ge t\}} du dv dt$$

$$= \int_{\mathbb{R}^{2n}} f(\frac{u+v}{\sqrt{2}})g(-\frac{u-v}{\sqrt{2}}) du dv$$

$$= \int_{\mathbb{R}^{2n}} f(x)g(-y) dx dy$$

$$= \int_{\mathbb{R}^{2n}} e^{-\|x\|_{K^{o,p}}} e^{-\|y\|_{L^{o,p}}} dx dy$$

$$= (n!)^{2} |K^{o,p}| |L^{o,p}|.$$
(3.13)

On the other hand, from (3.12), Lemma 3.3 and Lemma 3.5, we have

$$\begin{split} &\int_{0}^{1} \tilde{C}_{t} dt \leq \int_{0}^{1} |M_{t}| \cdot |\tilde{C}_{t} \cap H^{\perp}| dt \\ &= \int_{0}^{1} |\{(o,v) \in \mathbb{R}^{2n} : \max_{\tilde{u} \in \mathbb{R}^{n}} f(\frac{\bar{u}+v}{\sqrt{2}})g(-\frac{\bar{u}-v}{\sqrt{2}}) \geq t\}| \\ &\cdot |\{u \in \mathbb{R}^{n} : f(\frac{u}{\sqrt{2}})g(-\frac{u}{\sqrt{2}}) \geq t\}| dt \\ &= \int_{\mathbb{R}^{2n}} \int_{0}^{\min\left\{\max_{\tilde{u} \in \mathbb{R}^{n}} f(\frac{\bar{u}+v}{\sqrt{2}})g(-\frac{\bar{u}-v}{\sqrt{2}}), f(\frac{u}{\sqrt{2}})g(-\frac{u}{\sqrt{2}})\right\}} dt du dv \\ &= \int_{\mathbb{R}^{2n}} \min\left\{\max_{\tilde{u} \in \mathbb{R}^{n}} e^{-\|\frac{\tilde{u}+v}{\sqrt{2}}\|_{K^{o,p}} - \|\frac{v-\tilde{u}}{\sqrt{2}}\|_{L^{o,p}}}, e^{-\|\frac{u}{\sqrt{2}}\|_{K^{o,p}} - \|\frac{-u}{\sqrt{2}}\|_{L^{o,p}}}\right\} du dv \\ &= \int_{\mathbb{R}^{2n}} \min\left\{e^{-\|\sqrt{2}v\|_{conv(K^{o,p} \cup L^{o,p})}, e^{-h(K^{o,p})o_{-}(L^{o,p})o(\frac{u}{\sqrt{2}})} du dv \\ &= \int_{\mathbb{R}^{2n}} e^{-\max\left\{\|v\|_{conv(K^{o,p} \cup L^{o,p})}, \|u\||((K^{o,p})o_{-}(L^{o,p})o)^{o}\right\}} du dv \\ &= \int_{\mathbb{R}^{2n}} e^{-\|(v,u)\|_{conv(K^{o,p} \cup L^{o,p}) \times ((K^{o,p})o_{-}(L^{o,p})o)^{o}} du dv \end{split}$$

$$=(2n)!|conv(K^{o,p} \cup L^{o,p}) \times ((K^{o,p})^o - (L^{o,p})^o)^o|$$
  
=(2n)!|conv(K^{o,p} \cup L^{o,p})| \cdot |((K^{o,p})^o - (L^{o,p})^o)^o|. (3.14)

The conclusion follows from (3.13) and (3.14).

*Remark* 3.1. Using the following inequality due to Rogers and Shephard [26, P273, Theorem 1] instead of (3.12),

$$|\tilde{C}_t| \ge \frac{(n!)^2}{(2n)!} |M_t| \cdot |\tilde{C}_t \cap H^{\perp}|,$$

we can obtain the reverse of Theorem 3.6 as follows,

$$\left| conv \left( K^{o,p} \cup L^{o,p} \right) \right| \cdot \left| \left( (K^{o,p})^o - (L^{o,p})^o \right)^o \right| \le |K^{o,p}| |L^{o,p}|.$$
