ASYMPTOTIC FORMULA FOR THE SUM OF A PRIME AND A SQUARE-FULL NUMBER IN SHORT INTERVALS

ABSTRACT. Let $R_{m, \text{sq-full}}(N)$ be a representation function for the sum of a prime and a square-full number. In this article, we prove an asymptotic formula for the sum of $R_{m, \text{sq-full}}(N)$ over positive integers N in a short interval (X, X + H) of length H slightly bigger than $X^{\frac{1}{2}}$.

1. INTRODUCTION

As one of the well-known Hardy–Littlewood conjectures, it is conjectured that every sufficiently large positive number N is a square or it can be expressed as the sum of a prime and a square. In other words,

$$N = n^2$$
 or $p + n^2$,

where p denotes a prime number and n denotes a positive integer.

To this conjecture, an effective approach to count N expressible as $p + n^2$ is to use the following function

(1)
$$R_{p, \operatorname{sq}}(N) = \sum_{p+n^2=N} \log p$$

or

(2)
$$R_{m, \operatorname{sq}}(N) = \sum_{m+n^2=N} \Lambda(m),$$

where $\Lambda(m)$ is the von Mangoldt function given by

$$\Lambda(m) = \begin{cases} \log p & \text{if } m = p^k \text{ for some prime } p \text{ and some integer } k \ge 1, \\ 0 & \text{otherwise.} \end{cases}$$

We call the functions such as (1) and (2) the representation functions.

In [3], Hardy and Littlewood obtained a hypothetical asymptotic formula for N not being a square,

(3)
$$R_{m, sq}(N) = \mathfrak{S}\sqrt{N} + (\text{error}),$$

X

where

$$\mathfrak{S} = \mathfrak{S}(N) = \prod_{p>2} \left(1 - \frac{(N/p)}{p-1} \right)$$

with (N/p) being the Legendre symbol. It is difficult to obtain (3) itself, but it may be possible to consider the short interval average of the representation functions:

$$\sum_{\langle N \leq X+H} R_{m,\,\mathrm{sq}}(N)$$

for X, H being real numbers with $4 \le H \le X$.

In 2017, A. Languasco and A. Zaccagnini showed that

Theorem 1.1. (Languasco–Zaccagnini[6]). For real numbers X, H with $4 \le H \le X$ and any real number $\varepsilon > 0$, there exists a constant C > 0 such that

(4)
$$\sum_{X < N \le X+H} R_{m, \, \text{sq}}(N) = HX^{\frac{1}{2}} + O\left(HX^{\frac{1}{2}}\exp\left(-C\left(\frac{\log X}{\log\log X}\right)^{\frac{1}{3}}\right)\right)$$

provided

$$X^{\frac{1}{2}} \exp\left(-C\left(\frac{\log X}{\log\log X}\right)^{\frac{1}{3}}\right) \le H \le X^{1-\varepsilon}.$$

In 2023, Y. Suzuki improved the above theorem:

Theorem 1.2. (Suzuki[7]). For $X^{\frac{32-4\sqrt{15}}{49}+\varepsilon} \leq H \leq X^{1-\varepsilon}$, the asymptotic formula (4) holds.

In this article, we study a variant of the above problem, where we replace squares with square-full numbers. Recall that a positive integer n is square-full if a prime p divides n, then p^2 also divides n.

Let us mention some known results about square-full numbers. Let Q(x) be a counting function of square-full numbers less than or equal to x. Then we have following the two theorems.

Theorem 1.3. (Bateman–Grosswald[1]). For a real number $x \ge 1$, we have

$$Q(x) = \frac{\zeta(\frac{3}{2})}{\zeta(3)}x^{\frac{1}{2}} + \frac{\zeta(\frac{2}{3})}{\zeta(3)}x^{\frac{1}{3}} + O(x^{\frac{1}{6}}).$$

Theorem 1.4. (Filaseta–Trifonov[2]). Under $x^{\frac{1}{2}+\frac{5}{39}+\varepsilon} \leq H \leq x$, we have

$$Q(x+H) - Q(x) \sim \frac{\zeta(\frac{3}{2})}{2\zeta(3)} H x^{-\frac{1}{2}}.$$

In 2002, O. Trifonov improved the exponent of x in Theorem 1.4 from $\frac{5}{39}$ to $\frac{19}{154}$ ([8]).

It follows easily that

(5)
$$R_{p, sq}(N) = \sum_{m+n^2=N} \Lambda(m) \le \sum_{\substack{m+f=N\\f: \text{square-full}}} \Lambda(m)$$

since squares are square-full numbers. In this article, we consider the evaluation of the most-right-hand side of (5):

$$R_{m, \text{sq-full}}(N) := \sum_{\substack{m+f=N\\f \in \mathcal{Q}}} \Lambda(m),$$

where $\mathcal{Q} := \{n \in \mathbb{N} \mid n \text{ is square-full}\}$. Especially, we consider the short interval average of the $R_{m, \text{sq-full}}(N)$. An easy calculation shows

(6)
$$\sum_{X < N \le X+H} R_{m, \operatorname{sq-full}}(N) = \sum_{\substack{X < m+f \le X+H \\ f \in \mathcal{D}}} \Lambda(m) = \sum_{\substack{m \le X+H \\ X-m < f \le X-m+H}} \Lambda(m) \sum_{\substack{X-m < f \le X-m+H \\ f \in \mathcal{D}}} 1.$$

By using Theorem 1.4, for $x^{\frac{1}{2}+\theta+\varepsilon} \leq H \leq x$ $(\theta = \frac{5}{39}, \frac{19}{154})$, (6) roughly becomes

(7)
$$\sum_{X < N \le X+H} R_{m, \text{ sq-full}}(N) \sim \sum_{m \le X+H} \Lambda(m) \left(\frac{\zeta(\frac{3}{2})}{2\zeta(3)} H X^{-\frac{1}{2}}\right) \sim \frac{\zeta(\frac{3}{2})}{\zeta(3)} H X^{\frac{1}{2}} \quad (X \to \infty).$$

Our main theorem is the following, that is we improve the range of H in (7) to $\theta = 0$:

Theorem 1.5. For $X^{\frac{1}{2}+\varepsilon} \leq H \leq X^{1-\varepsilon}$, we have

$$\sum_{X < N \le X + H} R_{m, \text{ sq-full}}(N) = \frac{\zeta(\frac{3}{2})}{\zeta(3)} H X^{\frac{1}{2}} \left(1 + O\left((\log X)^{-1}\right) \right).$$

2. Proof of the main theorem

Let $\mathbb{1}_P$ be a characteristic function for some condition P.

Lemma 2.1. For a positive number f, we have

$$\mathbb{1}_{f\in\mathscr{Q}}=\sum_{a^2b^3=f}\mu(b)^2,$$

where $\mu(b)$ is the Möbius function.

Proof. This is well-known. It suffices to prove that any square-full number f can be written uniquely as $f = a^2 b^3$ with a positive integer a and a square-free number b. For positive numbers n and d, we write

$$d \mid\mid n \text{ if } d \mid n \text{ and } \left(d, \frac{n}{d}\right) = 1.$$

Then, we have

$$f = \prod_{p^v \mid | f} p^v = \prod_{\substack{p^v \mid | f \\ v: \text{even}}} p^v \prod_{\substack{p^v \mid | f \\ v: \text{odd}}} p^v.$$

If v is odd in $p^v || f$, we have $v \ge 3$ because f is square-full. This gives,

$$f = \prod_{\substack{p^v \mid | f \\ v: \text{even}}} p^v \prod_{\substack{p^v \mid | f \\ v: \text{odd}}} p^{v-3} \left(\prod_{\substack{p^v \mid | f \\ v: \text{odd}}} p\right)^3.$$

Then $\prod_{\substack{p^v \mid | f \\ v: \text{even}}} p^v \prod_{\substack{p^v \mid | f \\ v: \text{odd}}} p^{v-3}$ is square because v-3 is even when v is odd and $\prod_{\substack{p^v \mid | f \\ v: \text{odd}}} p$ is

square-free because the exponent of each prime factor p is 1.

For a real number $B \geq 2$, we define

(8)
$$R_B(N) := \sum_{\substack{m+a^2b^3=N\\b\leq B}} \Lambda(m)\mu(b)^2.$$

Lemma 2.2. For a positive number N and a real number $B \ge 1$, we have

$$R_{m, \text{sq-full}}(N) = R_B(N) + O((N^{\frac{1}{2}} \log N) B^{-\frac{1}{2}}).$$

Proof. Using Lemma 2.1, we have

$$R_{m, \text{ sq-full}}(N) = \sum_{\substack{m+f=N\\f\in\mathscr{Q}}} \Lambda(m) = \sum_{\substack{m+a^2b^3=N}} \Lambda(m)\mu(b)^2.$$

The difference between $R_{m, \text{sq-full}}(N)$ and $R_B(N)$ can be estimated as

$$R_{m, \, \text{sq-full}}(N) - R_B(N) = \sum_{\substack{m+a^2b^3 = N \\ b > B}} \Lambda(m)\mu(b)^2$$

$$\leq \log N \sum_{\substack{m+a^2b^3 = N \\ b > B}} 1$$

$$= \log N \sum_{\substack{a^2b^3 \leq N \\ b > B}} 1$$

$$= \log N \sum_{\substack{B < b \leq N^{\frac{1}{3}} \text{ and } \frac{2}{b^3}} \sum_{\substack{n=1 \\ B < b \\ n = 1}} 1$$

$$\leq N^{\frac{1}{2}} \log N \sum_{\substack{B < b \\ B < b \\ n = 1}} b^{-\frac{3}{2}}$$

$$\ll (N^{\frac{1}{2}} \log N)B^{-\frac{1}{2}}.$$

This completes the proof.

By Lemma 2.2, we have

$$\sum_{X < N \le X+H} R_{m, \, \text{sq-full}}(N) = \sum_{X \le N \le X+H} R_B(N) + O\left(\sum_{X < N \le X+H} (N^{\frac{1}{2}} \log N) B^{-\frac{1}{2}}\right).$$

If $B = (\log X)^4$, we have

$$\sum_{X < N \le X + H} R_{m, \text{ sq-full}}(N) = \sum_{X \le N \le X + H} R_B(N) + O(HX^{\frac{1}{2}}(\log X)^{-1})$$

The following lemma is well-known.

Lemma 2.3. For a real number x such that $x \ge 2$, we have

$$\sum_{m \le x} \Lambda(m) = \sum_{p \le x} \log p + O(x^{\frac{1}{2}} (\log x)^2).$$

Let $\mathscr{Q}_B := \{n \in \mathbb{N} \mid n = a^2 b^3, b \leq B \text{ and } b \text{ is square-free} \}$. Then from (8)

$$\sum_{X < N \le X+H} R_B(N) = \sum_{\substack{X < m+a^2b^3 \le X+H\\b \le B}} \Lambda(m)\mu(b)^2 = \sum_{\substack{X < m+f \le X+H\\f \in \mathscr{Q}_B}} \Lambda(m).$$

Using Lemma 2.3, we have

$$\sum_{X < N \le X+H} R_B(N) = \sum_{\substack{f \le X+H \ X-f < p \le X+H-f}} \sum_{\substack{\log p + O\left(\sum_{\substack{f \le X+H \ f \in \mathcal{Q}_B}} X^{\frac{1}{2}} (\log X)^2\right)} \\ = \sum_{\substack{f \le X+H \ X-f < p \le X+H-f}} \sum_{\substack{\log p + O(X(\log X)^2)} \\ = \sum_{\substack{f \le X-2H \ X-f < p \le X+H-f}} \sum_{\substack{\log p \\ f \in \mathcal{Q}_B}} \sum_{\substack{f \le X-2H \ X-f < p \le X+H-f}} \\ + \sum_{\substack{X-2H < f \le X+H \ X-f < p \le X+H-f} \\ f \in \mathcal{Q}_B} \sum_{\substack{f \le X+H \ X-f < p \le X+H-f}} \\ \log p + O(X(\log X)^2).$$

For the second sum on the most-right-hand side can be bounded as

$$\sum_{\substack{X-2H < f \le X+H}{f \in \mathcal{Q}_B}} \sum_{X-f < p \le X+H-f} \log p \ll H \sum_{\substack{X-2H < f \le X+H\\f \in \mathcal{Q}_B}} 1$$
$$\ll H \sum_{b \le B} \sum_{\substack{X-2H < a^2b^3 \le X+H}} 1$$
$$\ll H \sum_{b \le B} \left(\frac{H}{b^3}\right)^{\frac{1}{2}} \ll H^{\frac{3}{2}}.$$

Therefore, we get

(9)
$$\sum_{\substack{X < N \le X + H \\ f \le \mathcal{Q}_B}} R_B(N) \\ = \sum_{\substack{f \le X - 2H \\ f \in \mathcal{Q}_B}} \sum_{X - f < p \le X + H - f} \log p + O(H^{\frac{3}{2}}B + X(\log X)^2) \\ = \sum_{\substack{m^2 \le X - 2H \\ f \le X - 2H \\ f \le \mathcal{Q}_B}} \sum_{X - f < p \le X + H - f} \sum_{\substack{n^2 \le X - 2H \\ f \le \mathcal{Q}_B}} \log p + O(H^{\frac{3}{2}} + X(\log X)^2).$$

Lemma 2.4. For a positive integer m and a square-full number f with $m^2 \leq f < (m+1)^2$, we have

$$\sum_{X-f$$

Proof. When $u \in [m, f^{\frac{1}{2}}]$, we have

$$X - f < X - u^2$$
 and $X + H - f < X + H - u^2$.

By recalling $f < (m+1)^2$, we have

$$\begin{split} & \left| \sum_{X-f$$

Similarly, if $u \in [f^{\frac{1}{2}}, m+1]$, we have

$$X - u^2 < X - f$$
 and $X + H - u^2 < X + H - f$

and so

$$\left| \sum_{X-f$$

In any case, we thus have

$$\sum_{X - f$$

for $m \le u \le m+1$. By integrating this formula over $m \le u \le m+1$, we give the lemma.

Substituting Lemma 2.4 into (9) then, we have

$$\sum_{X < N \le X+H} R_B(N)$$

$$= \sum_{\substack{m^2 \le X-2H \\ f \le X-2H \\ f \in \mathcal{D}_B}} \sum_{\substack{M=0 \\ K-2H \\ f \in \mathcal{D}_B}} \left(\int_m^{m+1} \sum_{\substack{X-u^2
$$+ O(H^{\frac{3}{2}} + X(\log X)^2).$$$$

By estimating the contribution of $O(m \log X)$ as

$$\sum_{\substack{m^2 \leq X - 2H \\ f \leq X - 2H \\ f \in \mathcal{Q}_B}} \sum_{\substack{m \log X \ll X^{\frac{1}{2}} \log X \\ f \in \mathcal{Q}_B}} X \otimes X \log X \otimes X^{\frac{1}{2}} \log X \sum_{\substack{f \leq X - 2H \\ f \in \mathcal{Q}_B}} 1 \ll X \log X$$

6

We obtain

(10)
$$\sum_{X < N \le X+H} R_B(N) = \sum_{\substack{m^2 \le X-2H \ m^2 \le f < (m+1)^2 \\ f \le \mathcal{Q}_B}} \sum_{\substack{m^2 \le X-2H \ f \in \mathcal{Q}_B}} \int_m^{m+1} \left(\sum_{\substack{X-u^2 < p \le X+H-u^2 \\ F \in \mathcal{Q}_B}} \log p - H\right) du + \sum_{\substack{m^2 \le X-2H \ m^2 \le f < (m+1)^2 \\ f \le \mathcal{Q}_B}} \sum_{\substack{H+O\left(H^{\frac{3}{2}} + X(\log X)^5\right) \\ f \le \mathcal{Q}_B}} H + O\left(H^{\frac{3}{2}} + X(\log X)^5\right)$$

Put the first term to be Σ_1 and the second term to be Σ_2 .

First, we consider Σ_1 . Before evaluating Σ_1 , we first introduce following the lemma and the theorem.

Lemma 2.5. For $m^2 \leq X - 2H$, we have

$$\sum_{\substack{m^2 \leq f < (m+1)^2 \\ f \leq X - 2H \\ f \in \mathcal{Q}_B}} 1 \ll B$$

Proof. From the definition of \mathcal{Q}_B , we have

$$\sum_{\substack{m^2 \le f < (m+1)^2 \\ f \le X - 2H \\ f \in \mathcal{D}_B}} 1 = \sum_{\substack{m^2 \le a^2 b^3 < (m+1)^2 \\ b < B}} \mu(b)^2$$
$$= \sum_{\substack{b \le B}} \sum_{\substack{\frac{m^2}{b^3} \le a^2 < \frac{(m+1)^2}{b^3}}} 1$$
$$= \sum_{\substack{b \le B}} \left(\left[\frac{m+1}{b^{\frac{3}{2}}} \right] + \left[\frac{m}{b^{\frac{3}{2}}} \right] \right)$$
$$= \sum_{\substack{b \le B}} \left(b^{-\frac{3}{2}} + O(1) \right)$$
$$\ll \sum_{\substack{b \le B}} 1 = B.$$

Theorem 2.6. ([4]). Let A be any real positive number. For $X^{\frac{1}{6}+\varepsilon} \leq H \leq X$, we have

$$\int_{X}^{2X} \bigg| \sum_{u$$

where the implicit constant depends on A and ε .

Proof. This follows by a standard argument using Perron's formula and the zero-density estimate of Ingham [5] and Huxley [4]. \Box

We now evaluate Σ_1 . Lemma 2.5 gives

$$\begin{split} \Sigma_1 &= \sum_{\substack{m^2 \le X - 2H \\ f \le X - 2H \\ f \in \mathcal{Q}_B}} \sum_{\substack{m^2 \le f < (m+1)^2 \\ f \le X - 2H \\ f \in \mathcal{Q}_B}} \int_m^{m+1} \left(\sum_{\substack{X - u^2 < p \le X + H - u^2 \\ X - u^2 < p \le X + H - u^2}} \log p - H \right) du \\ &\ll B \int_1^{[\sqrt{X - 2H}] + 1} \left| \sum_{\substack{X - u^2 < p \le X + H - u^2 \\ X - u^2 < p \le X + H - u^2}} \log p - H \right| du \\ &\ll B \int_{X - ([\sqrt{X - 2H}] + 1)^2}^{X - 1} \left| \sum_{t < p \le t + H} \log p - H \right| \left(\frac{1}{2\sqrt{X - t}} \right) dt. \end{split}$$

When $X^{\frac{1}{2}+\varepsilon} \leq H$, we have $X - (\left[\sqrt{X-2H}\right] + 1)^2 \geq H$ and

$$\Sigma_1 \ll B \int_H^{X-1} \bigg| \sum_{t$$

From Cauchy-Schwarz inequality,

$$\Sigma_{1} \ll B\left(\left(\int_{H}^{X-1} \left(\sum_{t$$

Let K be a positive number such that $2^{K}H \leq X - 1 < 2^{K+1}H$. Then,

$$\Sigma_1 \ll B\left(\left(\int_H^{2^{K+1}H} \left(\sum_{t
$$\ll B\left(\sum_{k=0}^K \left(\int_{2^kH}^{2^{k+1}H} \left(\sum_{t$$$$

Since $H \ge X^{\frac{1}{2}} + \varepsilon$ and $2^k H \le X$ in the last integrals, we may use Theorem 2.6, to get

$$\Sigma_1 \ll B \left(\sum_{k=0}^{K} \left(2^k H^3 (\log X)^{-A} \right) \right)^{\frac{1}{2}} (\log X)^{\frac{1}{2}}$$
$$\ll B \left(2^K K H^3 (\log X)^{-A} \right)^{\frac{1}{2}} (\log X)^{\frac{1}{2}}$$
$$\ll H X^{\frac{1}{2}} (\log X)^{-A},$$

where we replaced the value of A appropriately at the last line.

Next, we consider Σ_2 . We first rewrite the sum as

(11)
$$\Sigma_2 = \sum_{\substack{m^2 \le X - 2H \\ f \le X - 2H \\ f \in \mathcal{Q}_B}} \sum_{\substack{H = \sum_{\substack{f \le X - 2H \\ f \in \mathcal{Q}_B}} H = \sum_{\substack{f \le X - 2H \\ f \in \mathcal{Q}_B}} H = \sum_{\substack{f \le X - 2H \\ f \in \mathcal{Q}}} H - \sum_{\substack{f \le X - 2H \\ f \in \mathcal{Q} \setminus \mathcal{Q}_B}} H.$$

By using Theorem 1.3, the first term in (11) is

$$\begin{split} \sum_{\substack{f \leq X-2H \\ f \in \mathscr{Q}}} H &= \frac{\zeta(\frac{3}{2})}{\zeta(3)} H(X-2H)^{\frac{1}{2}} + O(HX^{\frac{1}{2}}(\log X)^{-1}) \\ &= \frac{\zeta(\frac{3}{2})}{\zeta(3)} HX^{\frac{1}{2}} + \frac{\zeta(\frac{3}{2})}{\zeta(3)} H\Big((X-2H)^{\frac{1}{2}} - X^{\frac{1}{2}}\Big) + O(HX^{\frac{1}{2}}(\log X)^{-1}) \\ &= \frac{\zeta(\frac{3}{2})}{\zeta(3)} HX^{\frac{1}{2}} + O\Big(H^2X^{-\frac{1}{2}} + HX^{\frac{1}{2}}(\log X)^{-1}\Big). \end{split}$$

The second term in (11) is

$$\sum_{\substack{f \leq X-2H\\f \in \mathcal{Q} \setminus \mathcal{Q}_B}} H \ll \sum_{\substack{a^2 b^3 \leq X\\B < b}} \mu(b)^2 H$$
$$\ll \sum_{\substack{B < b \leq X}} \sum_{\substack{1 = a^2 \leq \frac{X}{b^3}}} H$$
$$\ll \sum_{\substack{B < b}} H X^{\frac{1}{2}} b^{-\frac{3}{2}}$$
$$\ll H X^{\frac{1}{2}} B^{-\frac{1}{2}}$$
$$\ll H X^{\frac{1}{2}} (\log X)^{-2}.$$

These results give

$$\Sigma_2 = \frac{\zeta(\frac{3}{2})}{\zeta(3)} HX^{\frac{1}{2}} + O\Big(H^2 X^{-\frac{1}{2}} + HX^{\frac{1}{2}} (\log X)^{-1}\Big).$$

Then, (10) becomes

$$\begin{split} &\sum_{X < N \le X + H} R_B(N) \\ = & \Sigma_1 + \Sigma_2 + O\left(H^{\frac{3}{2}}B + H^2 X^{-\frac{1}{2}} (\log X)^5 + X (\log X)^5\right) \\ = & \frac{\zeta(\frac{3}{2})}{\zeta(3)} H X^{\frac{1}{2}} \\ &+ O\left(H X^{\frac{1}{2}} (\log X)^{-1} + H^{\frac{3}{2}}B + H^2 X^{-\frac{1}{2}} (\log X)^5 + X (\log X)^5\right). \end{split}$$

Taking $X^{\frac{1}{2}+\varepsilon} \leq H \leq X^{1-\varepsilon}$ gives

$$\sum_{X < N \le X+H} R_B(N) = \frac{\zeta(\frac{3}{2})}{\zeta(3)} H X^{\frac{1}{2}} \left(1 + O((\log X)^{-1}) \right),$$

which leads to Theorem 1.5.
