

# Maximum of the Characteristic Polynomial of I.I.D. Matrices

**Abstract:** We compute the leading order asymptotic of the maximum of the characteristic polynomial for i.i.d. matrices with real or complex entries. In particular, this result is new even for real Ginibre matrices, which was left as an open problem in [69]; the complex Ginibre case was covered in [67]. These are the first universality results for the non-Hermitian analog of the first order term of the Fyodorov–Hiary–Keating conjecture. Our methods are based on constructing a coupling to the branching random walk via Dyson Brownian motion. In particular, we find a new connection between real i.i.d. matrices and inhomogeneous branching random walk.

## 1 Introduction

Let  $X$  be an  $n \times n$  matrix of i.i.d. centered real or complex random variables, scaled so that  $\mathbb{E}|X_{ij}|^2 = \frac{1}{n}$ . It is natural to investigate the size of the fluctuations of the characteristic polynomial,

$$P_n(z) := \log |\det(X - z)|, \tag{1.1}$$

where the logarithmic scaling turns out to best capture the interesting behavior of  $P_n(z)$ . A remarkable property of the field  $\{P_n(z)\}_z$  is that it is expected to asymptotically exhibit Gaussian fluctuations with covariance structure,<sup>1</sup>

$$\text{Cov}(P_n(z), P_n(w)) \approx -\frac{1}{4} \log(|z - w|^2 + n^{-1}). \tag{1.2}$$

The field  $\{P_n(z)\}_z$  is ill-behaved as a function of  $z$ , as indicated by the fact that variance is diverging when  $z = w$ . In the case that  $X$  is drawn from the complex Ginibre ensemble (in which the entries of  $X$  are standard complex Gaussians), Rider and Virag showed that  $\{P_n(z)\}_z$  converges in distribution to a generalized function known as the Gaussian free field [84]. This was extended to more general classes of normal matrices in [4, 5] and i.i.d. matrices in [35, 37], as well as to certain space–time correlations [23].

In fact, the covariance structure (1.2) indicates that  $P_n(z)$  is an example of a *logarithmically correlated field*, objects which are ubiquitous in probability theory and statistical mechanics. They emerge from any model where randomness contributes equally at all length scales. Two of the most prominent examples are the two-dimensional Gaussian free field and branching random walk.

The central quantity of interest in our work will be the *maximum* of the field  $\{P_n(z)\}_z$  in the argument  $z$  (after a re-centering of  $P_n(z)$  by its large  $n$  limit). The study of the extreme values of logarithmically correlated fields has received significant attention in recent years, especially within the context of random matrix theory. Of course, the extrema of stochastic processes is a classical subject in probability theory dating to the early twentieth century. On the other hand, the classical theory does not apply to stochastic processes exhibiting strong correlations, and logarithmically correlated fields are a natural candidate for the development of a new extreme value theory.

Investigation of the extreme values of random matrix characteristic polynomials is motivated in part by the seminal work of Fyodorov, Hiary and Keating who conjectured that the extremal statistics of the Riemann zeta function are well modeled by random matrix eigenvalues [58]. There has since been tremendous progress on both the number theoretic and random matrix sides of the problem. The breakthrough works of Arguin, Bourgade and Radziwiłł verified the conjectured asymptotics for the local max of the Riemann zeta function (at a random point high on its critical axis), by showing that the maximum is tight after accounting for leading and subleading deterministic contributions [9, 10]. Studies on the random matrix side have focused on the Circular Unitary Ensemble and its generalization, the Circular  $\beta$ -Ensemble ( $C\beta E$ ), with the work of Paquette and Zeitouni [80] proving convergence in distribution of the centered maximum of the log-characteristic polynomial. Prior contributions in this direction include [7, 79, 29]. These developments and related literature will be discussed in greater detail in Section 1.1 below.

However, in the context of general i.i.d. matrices, progress has so far been sparse. In particular, the eigenvalues of the  $C\beta E$  are one-dimensional, being distributed on the unit circle, whereas the eigenvalues of i.i.d. matrices asymptotically fill the unit disc. The work [67] of Lambert finds the first-order asymptotics for the maximum of the log-characteristic polynomial of the complex Ginibre ensemble. The other paper on 2-d random matrix models is that of Lambert, Leblé and Zeitouni [69] which extends this result to the 2-d Gaussian  $\beta$ -ensemble, an explicit measure on  $\mathbb{C}^n$  (see (1.7) below) generalizing the complex Ginibre ensemble to other inverse temperatures (and extended to more general 2-d  $\beta$ -ensembles in the recent work of Peilen [81]). Other than the complex Ginibre ensemble, these models are unrelated to the general non-invariant ensembles that we consider, whose eigenvalue distributions do not have explicit forms. Significantly, the only work on the maximum of the characteristic polynomial of non-invariant random matrices is that of Bourgade-Lopatto-Zeitouni which studies general Hermitian random matrices (the Wigner ensembles) [25] (see Section 1.1 for further detailed discussion). Wigner matrices are ultimately a simpler object than the ensembles we consider here, owing to the well developed universality theory available in the Hermitian case.

The methods developed in these works, while powerful, nonetheless do not apply to the general, non-invariant and non-Hermitian random matrix ensembles that we study, and so new approaches are required. Our work provides the first treatment of the characteristic polynomial for general

i.i.d. matrices by proving that for any real or complex i.i.d. matrix and any  $0 < r < 1$ ,

$$\max_{|z| \leq r} [P_n(z) - E_n(z)] = \frac{\log n}{\sqrt{2}}(1 + o(1)) \quad (1.3)$$

with probability tending to 1 as  $n \rightarrow \infty$ . Here,  $n^{-1}E_n(z)$  is the a.s. limit of  $n^{-1}P_n(z)$ .

Of particular interest is that we can also handle real i.i.d. matrices; indeed, before our work, the result (1.3) was not available even for the real Ginibre ensemble, despite the fact that this ensemble also enjoys explicit formulas for its eigenvalue density. This is partly due to the fact that the real i.i.d. case exhibits a much richer structure than the complex case. In fact, for real i.i.d. matrices (1.2) is not exactly correct. There is a second term on the RHS of the form  $\frac{1}{4} \log(|z - \bar{w}|^2 + n^{-1})$  reflecting the symmetry of the eigenvalues about the real axis. Of course, away from the real axis this term is subleading and so one expects the same behavior as in the complex case; however, if  $z$  approaches the real axis as  $n \rightarrow \infty$ , say  $\text{Im}[z] = n^{-\alpha}$ , then this term matters. Moreover,  $E_n(z)$  in the real case has an additional correction of order  $\log n$ , the same order as the maximum. Due to this, it is not a priori clear what occurs near the real axis - whether the maximum is the same or not. In order to explain what occurs, we briefly discuss our methods.

Many tools have been developed to study the extremal values of logarithmically correlated fields, such as the second moment method, barriers, and convergence to Gaussian Multiplicative chaos; see, e.g., [6, 19] for reviews. Works [67, 69] rely on computations of joint Laplace transforms of  $P_n(z)$  in order to carry out union bounds, as well as prove convergence to the Gaussian multiplicative chaos. However, such computations are not available in the general models we consider here.

Instead, we use Dyson Brownian motion (DBM) to exhibit a coupling of the characteristic polynomial of our random matrix models to the branching random walk, one of the central objects of the universality class of logarithmically correlated fields. This relies on recent advances in the understanding of multi-resolvent local laws [32, 38] in order to compute the joint distribution of the evolution of the characteristic polynomial at different  $z$  under the DBM.

The salient feature in the real i.i.d. case close to the real axis is that the branching random walk (BRW) is *inhomogeneous*. That is, the effective rate of branching as well as the step size changes abruptly at a macroscopic time part of the way through the walk. To our knowledge, this is the first appearance of an inhomogeneous branching random walk in random matrix theory. Apart from the change in the branching structure this is almost precisely the BRW considered in [55] (this aspect of our methods is discussed in further detail in Section 1.2.1 below).

In the case of homogeneous branching random walk, the leading order of the, say,  $n$  final values is the same as if the  $n$  walkers were independent and there was no correlation structure. The logarithmic correlation only shows up at subleading order. However, in the case of inhomogeneous branching random walk, there is a distinction, as discovered in [55]. If the initial step size is smaller, then the leading order does coincide with the independent case. However, if the initial step size is larger, then the leading order is different and is strictly smaller.

Remarkably, our inhomogeneous branching random walk is an example of the latter; the initial step size is larger and so the leading order does not coincide with the ansatz of the random variables being independent. In fact, if one tries to do a naive union bound for  $\text{Im}[z] \approx n^{-\alpha}$ , modelling it as the maximum of  $n^{1-\alpha}$  Gaussians with variance  $\frac{1+2\alpha}{4} \log n$  (i.e., one Gaussian per radius  $n^{-1/2}$  disc, the scale on which (1.2) decorrelates), then one will arrive at the incorrect answer for (1.3).<sup>2</sup>

By implementing our strategy of coupling the real i.i.d. case to an inhomogeneous branching

random walk, we will in fact prove the stronger result,

$$\max_{\text{Im}[z] \approx n^{-\alpha}} [P_n(z) - E_n(z)] = \frac{\log n}{\sqrt{2}}(1 + o(1)), \quad (1.4)$$

with probability tending to 1 as  $n \rightarrow \infty$  and any  $0 < \alpha < \frac{1}{2}$ . It appears to be a coincidence that the parameters in our inhomogeneous BRW are set up so that the RHS above is independent of  $\alpha$ . On the contrary, the  $\log n$  correction to  $E_n(z)$  in the real case depends on  $\alpha$  (see (2.5) below). Moreover, (1.4) distinguishes the real i.i.d. case from the complex one; in the latter, the above max would be smaller than the max over the entire unit disc (it would be  $\sqrt{\frac{1-\alpha}{2}} \log n$ ), whereas in the real case they are the same.

We turn now to a more detailed discussion of the literature and our methods before stating our main results in Section 2.

### 1.1 Logarithmic correlated fields in random matrices

We now review in greater detail the literature on logarithmically correlated fields. Aside from the two-dimensional GFF and the BRW, the celebrated work [58] of Fyodorov, Hiary and Keating (FHK) uncovered yet another instance in which logarithmically correlated fields naturally appear. They conjectured that the extremal statistics of characteristic polynomials of Hermitian random matrices and of the Riemann zeta function on the critical line are identical, and coincide with those of logarithmically correlated fields. More precisely, let  $U_n$  be an  $n \times n$  Haar-distributed unitary matrix, then the FHK conjecture states

$$\max_{|z|=1} \log |\det(z - U_n)| = \log n - \frac{3}{4} \log \log n + X_n, \quad (1.5)$$

with  $X_n$  being an order one random variable that converges, as  $n \rightarrow \infty$ , to the sum of two independent Gumbel random variables.

The last decade has seen enormous progress towards the proof of (1.5), both for the Riemann zeta function and for unitary random matrices. Initial progress on the number theoretic side appeared in [8, 60, 76]. The contribution of the works of Arguin, Bourgade, and Radziwill [9, 10] is to show that (1.5) holds for the Riemann zeta function up to tightness, i.e., that  $X_n$  is a tight random variable when the LHS is replaced by the local max near a random point high up on the critical axis of the Riemann zeta function. Remarkably, they were also able to compute the (lower and upper) tail behavior of the random variable  $X_n$ , finding estimates in agreement with the predictions of [58]. For further references we refer the interested reader to the survey [61] (see also [13]). On the random matrix side, there have been a series of works proving (1.5) term by term. The leading and second order terms were computed in [7] and [79], respectively. Then, (1.5) was proven up to tightness in [29], even for the more general class of circular  $\beta$ -ensembles ( $C\beta E$ ). In this case (1.5) holds after rescaling its left-hand side by  $\sqrt{\beta/2}$  (the Haar unitary case corresponds to  $\beta = 2$ ). Very recently, this progression of works culminated in the work of Paquette and Zeitouni [80], where they proved the convergence in distribution of  $X_n$ .

Progress for Hermitian random matrix ensembles has occurred only recently (see [59] for various predictions). In [25] Bourgade, Lopatto, and Zeitouni study a similar question to (1.5), but for Wigner matrices and  $\beta$ -ensembles instead of  $C\beta E$ . More precisely, let  $\lambda_i$  denote the eigenvalues of a Wigner matrix or the particles of a  $\beta$ -ensemble, then [25] for any  $\beta > 0$  shows

$$\max_{E \in \text{bulk}} \left( \log \left| \prod_{i=1}^n (\lambda_i - E) \right| - \mathbb{E} \left[ \log \left| \prod_{i=1}^n (\lambda_i - E) \right| \right] \right) = \sqrt{\frac{2}{\beta}} \log n (1 + o(1)). \quad (1.6)$$

The case  $\beta = 2$  of (1.6) was already proven in [42, 70]. Additionally, [25] proves that for some Wigner matrices there is universality of the left-hand side of (1.6) up to tightness. This means that if the analog of (1.5) is proven for the GUE/GOE ensembles up to tightness, then [25] implies the same result for some more general classes of Wigner matrices (i.e. with entries not necessarily Gaussian). We also mention that in [25] the authors prove optimal rigidity estimates (with Gaussian tail) for the eigenvalues of such matrices.

Much less is known in the two dimensional case. The exact distribution of the maximum  $X_n$  in (1.5) was first conjectured in [58], and then identified as the sum of two independent Gumbel random variables in [66]. However, at the moment, there is no conjecture about the analog of  $X_n$  for any 2-d ensemble. The only known results are the leading order asymptotic for two dimensional Coulomb gases. These gases are comprised of  $n$  interacting particles  $\mathbf{x}_n = (x_1, \dots, x_n) \in (\mathbb{R}^2)^n$  distributed according to the Gibbs measure

$$d\mathbb{P}_{n,\beta} = \frac{1}{Z_{n,\beta}} e^{-\beta H_n(\mathbf{x}_n)} d\mathbf{x}_n. \quad (1.7)$$

Here  $Z_{n,\beta}$  is a normalization constant, and

$$H_n(\mathbf{x}_n) := -\frac{1}{2} \sum_{1 \leq i \neq j \leq n} \log |x_i - x_j| + n \sum_{i=1}^n V(x_i), \quad (1.8)$$

for some potential  $V$  growing sufficiently fast at infinity. For these models it is known that for any  $\beta > 0$  that

$$\max_{z \in D_r} \left( \log \left| \prod_{i=1}^n (x_i - z) \right| - \mathbb{E} \left[ \log \left| \prod_{i=1}^n (x_i - z) \right| \right] \right) = \frac{1}{\sqrt{\beta}} \log n (1 + o(1)), \quad (1.9)$$

with  $D_r$  being a disk of radius  $r$  contained in the bulk of the limiting empirical measure of  $\mathbb{P}_{n,\beta}$ . The Gaussian case  $V(x) = |x|^2/2$  was proven in [69], and this result was recently extended to a more general class of potentials in [81]. Prior to these two results, only the case  $\beta = 2$  and  $V(x) = |x|^2/2$  was known [67], as a consequence of the fact that the Gibbs measure (1.7) coincides with the eigenvalue density of the complex Ginibre ensemble. Unlike in the one dimensional case, the case  $\beta = 1$  in (1.7) does not correspond to the real Ginibre ensemble; in fact, the spectrum of real Ginibre matrices is symmetric with respect to the real axis, unlike (1.7). Hence, (1.3) for real Ginibre matrices does not follow from the case  $\beta = 1$  of (1.9).

We now comment on the relation between (1.9) and our result (1.3). Similarly to the one dimensional case (1.6), for two dimensional Coulomb gases, (1.9) depends on the values of  $\beta$ . In contrast, quite surprisingly, the leading order asymptotic of (1.3) is exactly the same for both real and complex matrices  $X$ . At first, one may think that this is a consequence of the fact that the local statistics of the eigenvalues of real Ginibre away from the real axis are (asymptotically) the same as those of the complex Ginibre. However, as indicated above, the underlying reason for the same asymptotics is more subtle. In fact, in (1.4) (and in Theorem 2.3 below) we clearly see the difference between the log-correlation structure in the complex and the real Ginibre ensemble: the maximum over any mesoscopic band  $\text{Im } z \asymp n^{-\alpha}$ , with  $\alpha \in (0, 1/2)$ , of the left-hand side of (1.3) is given by  $\log n$  in the real case, while it depends on  $\alpha$  in the complex case. This shows that even though the local statistics of the eigenvalues of real and complex  $X$  are the same for  $|\text{Im } z| \gg n^{-1/2}$ , their contribution to the extremal values of this log-correlated field is different, showing the cumulative effect of the randomness at each scale.

We conclude this section by mentioning that recently there has been great interest and progress in studying many other aspects of the connection between extremal value theory and spectral statistics of random matrices. See, e.g., [40] for a recent example not falling in the log-correlated universality class.

### 1.1.1 Emergence of log-correlated fields in other models

Asymptotics of the form (1.5) are very well understood for Gaussian logarithmically correlated fields. In fact, in this case it is known that the fluctuation of  $X_N$  is always given by the sum of two independent random variables, one which is universally Gumbel distributed and one which depends on the long-range behavior of the covariance (i.e., it is model dependent). We refer the interested reader to [19, 20, 47, 91], and references therein. Extending this theory beyond the Gaussian case has been a major challenge, which has recently attracted lots of activity. Beyond the models discussed in Section 1.1, we will now briefly mention other models that fall in the universality class of logarithmically correlated fields. Some examples are: the sine-Gordon model [14] (which can be coupled directly with the GFF), the cover time for planar random walks [15, 16, 46] (where tightness is known), the maximum of Ginzburg-Landau fields where very recently tightness was proven [85] (see also [17] for a previous result about the leading order asymptotics). We also mention the maximum of permutation matrices [43] (where only the leading order is known), and the model of two dimensional polymers [28, 44, 45] (where not even the leading order asymptotic is known).

## 1.2 Methods

Girko's Hermitization formula is one of the most important backbones in the study of non-Hermitian spectral statistics. In particular, it enables one to express statistics of non-Hermitian eigenvalues in terms of joint statistics of a certain family of Hermitian matrices. More precisely, for  $z \in \mathbb{C}$  we define the family of Hermitian matrices

$$H^z := \begin{pmatrix} 0 & X - z \\ (X - z)^* & 0 \end{pmatrix}. \quad (1.10)$$

The  $2n \times 2n$  matrix  $H^z$  is called the *Hermitization* of  $X - z$ . The spectrum of  $H^z$  is symmetric with respect to zero, and its positive eigenvalues  $\{\lambda_i^z\}_{i=1}^n$  coincide with the singular values of  $X - z$ . Then, Girko's formula states

$$\log |\det(X - z)| = \frac{1}{2} \log |\det H^z|. \quad (1.11)$$

After reducing the study of non-Hermitian characteristic polynomials to the Hermitized ones (1.11), the proof of (1.3) consists of two main parts, an upper bound and a lower bound. In both cases we first show that the maximum over  $|z| < 1$  can be expressed as the maximum over a mesh  $\mathcal{P}$  of  $\asymp n^{-1}$  equidistant points on the unit disk. This follows by the Lipschitz continuity of the logarithm of the characteristic polynomial, which is a consequence of recent *multi-resolvent* local laws from [32]. The key observation in [32] is that the fluctuations of the resolvent of  $H^z$  are much smaller when tested against certain observable matrices, an effect first observed in the context of Wigner matrices in [34].

A common difficulty in the analysis of the maximum of (1.11) is that this quantity can be very singular if  $H^z$  has eigenvalues close to zero. We thus regularize

$$\log |\det H^z| = \sum_{i=1}^n \log \lambda_i^z \approx \frac{1}{2} \sum_{i=1}^n \log [(\lambda_i^z)^2 + \eta^2], \quad \eta \asymp n^{-1}. \quad (1.12)$$

While this regularization can easily be achieved in the proof of the upper bound (due to simple monotonicity), for the lower bound we need to ensure that for each  $z \in \mathcal{P}$  the corresponding smallest singular value  $\lambda_1^z$  is not too small; this is a well known difficult problem in the analysis of the spectrum of non-Hermitian matrices, even for a single fixed  $z$ . We achieve this using the smallest singular value estimate [33] (see also [39, 49, 86]) together with the asymptotic independence result from [37, Section 7] for  $\lambda_1^{z_1}, \lambda_1^{z_2}$ , as long as  $|z_1 - z_2| \gg n^{-1/2}$ . Essentially, the asymptotic independence allows us to find a sufficiently large (random) collection of points  $\{w_i\}_i$  where  $\lambda_1^{w_i}$  is not too small; this allows us to achieve some amount of regularization and then in turn apply the Lipschitz continuity mentioned above to return to a *deterministic* collection of points to which we will apply the second moment method.

We now explain the main differences and the common features of the proofs of the upper and lower bounds in (1.3). Our main tool, used in both parts of the proof, is a new branching random walk representation for  $\log |\det(X - z)|$  which we discuss in Section 1.2.1 below. One of the main advantages of this representation is that, to prove universality of (1.3), we do not need to compare  $\log |\det(X - z)|$  with its Ginibre counterpart, but we can instead estimate it directly even for general i.i.d. matrices. This also allows us to prove (1.3) in the real case; here, a direct comparison to the real Ginibre ensemble would not work, as (1.3) was not known for the real Ginibre ensemble prior to our work (partly as a consequence of the very complicated  $k$ -point correlation functions [21, 57]). Our methods are likely to be useful in further studies of the extremal statistics of the log-characteristic polynomial, such as determining lower order terms. Investigating subleading terms in the real case would be of particular interest, as they have a different character in the inhomogeneous and homogenous BRW; see [55].

### 1.2.1 Branching random walk structure and lower bound

In this section we explain our coupling to the BRW and our proof of the lower bound. Traditionally, proving a lower bound for the leading order asymptotic of characteristic polynomials is closely related to proving the convergence of powers of the characteristic polynomials to the Gaussian Multiplicative Chaos (GMC) measure (see e.g. [25, 42, 67, 69]). We refer the reader to [24, 68, 77, 89, 82] for other works concerning the emergence of the GMC measure from spectral statistics of random matrix ensembles. Instead, we take a completely different route, and extract the underlying branching structure using *Dyson Brownian motion (DBM)*. The branching structure of  $\log |\det(X - z)|$  is different in the complex and in the real case. In fact, one can think of  $\log |\det(X - z)|$  as a Gaussian field on the disk with correlation kernel (here we omit a  $1/n$  regularization)

$$K(z_1, z_2) = \begin{cases} -\frac{1}{4} \log |z_1 - z_2|^2 & \text{if } X \in \mathbb{C}^{n \times n}, \\ -\frac{1}{4} \log |z_1 - z_2|^2 - \frac{1}{4} \log |z_1 - \bar{z}_2|^2 & \text{if } X \in \mathbb{R}^{n \times n}. \end{cases} \quad (1.13)$$

This shows that heuristically in the real case  $\log |\det(X - z)|$  can be thought as the cumulative effect of two different fields: one that has the same singularity as in the complex case, and one that is smoother on the disc. The fact that  $\log |\det(X - z)|$  has a different behavior in the real and complex cases naturally emerges by the following branching random walk representation using DBM.

We embed  $X$  in a flow

$$dX_t = -\frac{1}{2} X_t dt + \frac{dB_t}{\sqrt{N}}, \quad X_0 = X, \quad (1.14)$$

which will asymptotically not affect the distribution of the maximum, due to moment matching arguments based on [71]. Here  $B_t$  is a matrix valued standard i.i.d. Brownian motion.

Fix a final time  $T = o(1)$ . Associated with this flow are *characteristics*  $\eta_t \approx n^{-1} + (T - t)$ . Eigenvalue statistics such as  $\log |\det(X_t - z)|$ , evaluated along characteristics obey particularly nice equations under the stochastic dynamics (1.14) and so we may approximate,

$$\log |\det(X_T - z)| \approx \frac{1}{2} \log \det [|X_T - z|^2 + \eta_T^2] \approx \frac{1}{2} \int_0^T d (\log \det [|X_t - z|^2 + \eta_t^2]) \quad (1.15)$$

with the integral in the Itô sense. The last approximation on the RHS is our BRW representation for the log-characteristic polynomial (we omit the other endpoint of the integral at  $t = 0$  for brevity as it plays a less important role). We want to think of the RHS of (1.15) as the different branches of a BRW for different  $z$ . Indeed, this can be seen as a BRW due to the fact that the increments  $d (\log \det [|X_T - z|^2 + \eta_T^2])$  are almost perfectly correlated for  $|z_1 - z_2|^2 \ll \eta_t$  and decorrelated for  $|z_1 - z_2|^2 \gg \eta_t$ . Moreover, the fact that the BRW is inhomogeneous in the real case is immediate: in the real case the quadratic variation process of  $d [\log \det (|X_t - z|^2 + \eta_t^2)]$  is roughly

$$\frac{\sigma_1}{\eta_t} \mathbf{1}_{\{\eta_t > \text{Im}[z]^2\}} + \frac{\sigma_2}{\eta_t} \mathbf{1}_{\{\eta_t < \text{Im}[z]^2\}}, \quad (1.16)$$

for some  $\sigma_1 > \sigma_2$  (note that the logarithmic behavior comes from  $\int_0^T \eta_t^{-1} dt \approx \log n$  up to appropriate constants). In particular, the step size of our random walk decreases abruptly at the time  $t$  such that  $\eta_t = \text{Im}[z]^2$ . After an exponential time change, this corresponds roughly to the model of an inhomogeneous BRW considered by Fang and Zeitouni in [55], where the step size changes at a macroscopic time part of the way along the walk.

Beyond the work of [55] which partially inspires our analysis, there has been significant recent attention given to inhomogeneous BRWs. A sampling of these works includes [11, 12, 18, 26, 56, 75, 78]. In particular, many of these works study the 2d discrete GFF with scale-dependent variance, and the work [11] finds an inhomogeneous structure in a randomized model of the Riemann zeta function. An attractive feature of our paper is then showing that real i.i.d. matrices are another setting in which inhomogeneous models arise naturally. In particular, this is the first instance of an inhomogeneous BRW emerging in the context of random matrix theory.

The analysis of the covariation process of the Martingale increments on the RHS of (1.15) (which then leads to the important decorrelation/correlation dichotomy depending on the distance  $|z_1 - z_2|$  as well as the inhomogeneous structure (1.16)) is based on state-of-the-art multi-resolvent local laws for i.i.d. matrices [38]. More precisely, we use that the size of the product of the resolvents of  $H^{z_1}$  and  $H^{z_2}$  gets smaller as  $|z_1 - z_2|$  becomes larger, an effect first observed in [37]. For matrices with complex entries this is proven in [38, Theorem 3.3] using the method of characteristics. Here, following the lines of [38], we extend this result to matrices with real entries (with a large Gaussian component) as well as to certain matrices of mixed symmetry (see Appendix B for more details). Furthermore, we point out that in Corollary B.4 we also show that the  $|z_1 - z_2|$ -gain persists below the typical fluctuation scale of the eigenvalues of  $H^{z_1}, H^{z_2}$ .

The characteristic method has been used previously in [22, 63]. A similar idea was used earlier in the context of edge universality for Hermitian matrices [74]. Since these results, the characteristic flow has been very widely used in the context of single resolvent observables [1, 2, 72, 73, 27] as well as to prove multi-resolvent local laws [24, 30, 38, 40, 31, 83, 87] for various models.

Finally, given (1.15), we use a (modified) *second moment method* to obtain the desired lower bound. Here, we follow the presentation of [6] of Kistler's multiscale refinement of the second moment method [65]. As a consequence of (1.13), the second moment method needs to be performed differently in the real and complex cases.

### 1.2.2 Upper bound

In the complex case, the correlation structure (1.13) suggests that, to leading order, the maximum of  $\log |\det(X - z)|$  can be modelled by the maximum of  $n$  independent Gaussians with variance  $\frac{1}{4} \log n$ . This ansatz motivates the proof of the upper bound in the complex case. Indeed, the Lipschitz continuity mentioned above implies that we can consider the maximum over  $n$  points, after which the upper bound essentially follows from the fact that  $\log |\det(X - z)|$  is approximately Gaussian and a union bound. We point out that this argument actually applies to establish the upper bound of the leading order asymptotic of logarithm of characteristic polynomials in all models discussed in Section 1.1. In our case, after the regularization (1.12), the Gaussianity of  $\log |\det(X - z)|$  is proven using again the representation (1.15), obtained using DBM.

The situation in the real case is more complicated. If  $\text{Im}[z] \asymp n^{-\alpha}$  with  $\alpha \in [0, 1/2]$ , then the asymptotic variance of  $\log |\det(X - z)|$  implied by (1.13) is  $\frac{1+2\alpha}{4} \log n$ . In each mesoscopic slice  $\text{Im}[z] \asymp n^{-\alpha}$ , there are fewer points if  $\alpha$  is larger, but the fluctuation itself grows.

At first, one may hope that in order to obtain (1.3), one could compute the maximum over each of these slices using a union bound (as in the complex case), and then maximize in  $\alpha$ . However, this does not give the correct answer (see (1.4) and the discussion below it). Instead, to obtain (1.13), we need to use again the representation (1.15) as an inhomogeneous BRW. This allows us to decompose  $\log |\det(X - z)|$  as the sum of two independent Gaussian fields according to the covariance structure (1.13). For one of these two fields we can estimate its maximum using a union bound, and then, given this information as an input, we compute the maximum of the sum. This is partly inspired by [55].

### Notations and conventions

For integers  $k \in \mathbb{N}$  we use the notation  $[k] := \{1, 2, \dots, k\}$ . We write  $\mathbb{D} \subset \mathbb{C}$  to denote the open unit disc, and for any  $\sigma \in \mathbb{C}$  we use the notation  $d^2\sigma := 2^{-1}i(d\sigma \wedge d\bar{\sigma})$  to denote the two dimensional volume form on  $\mathbb{C}$ . For positive quantities  $f, g$  we write  $f \lesssim g$  and  $f \asymp g$  if  $f \leq Cg$  or  $cg \leq f \leq Cg$ , respectively, for some constants  $c, C > 0$  which depend only on the constants appearing in (2.1). We denote vectors by bold-faced lower case Roman letters  $\mathbf{x}, \mathbf{y} \in \mathbb{C}^d$ , for some  $d \in \mathbb{N}$ , and their scalar product by

$$\langle \mathbf{x}, \mathbf{y} \rangle := \sum_{i=1}^d \overline{x_i} y_i.$$

For any  $d \times d$  matrix  $A$  we use the notation  $\langle A \rangle := d^{-1} \text{Tr}[A]$  to denote the normalized trace of  $A$ , and  $A^\dagger$  denotes the transpose of  $A$ . We denote the  $d$ -dimensional identity matrix by  $I = I_d$ . Furthermore, we define the  $2 \times 2$  block matrices

$$E_1 := \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}, \quad E_2 := \begin{pmatrix} 0 & 0 \\ 0 & 1 \end{pmatrix}. \quad (1.17)$$

We also use the notation

$$\tilde{\sum}_{ij} := \sum_{(i,j) \in \{(1,2), (2,1)\}},$$

to denote sums over matrices  $E_1, E_2$ .

We will use the concept of “with overwhelming probability” meaning that for any fixed  $D > 0$  the probability of the event is bigger than  $1 - n^{-D}$  if  $n \geq n_0(D)$ . Moreover, we use the convention that  $\xi > 0$  denotes an arbitrary small constant which is independent of  $n$ .

For real-valued martingales  $M_t, N_t$ , we denote the covariation process by  $d[M_t, N_t]$ . For complex valued martingales  $M_t = X_t + iY_t, N_t = P_t + iQ_t$  the covariation process is defined by,  $d[M_t, N_t] := d[X_t, P_t] - d[Y_t, Q_t] + i(d[Y_t, P_t] + d[X_t, Q_t])$ . The total variation process of a real-valued martingale is denoted by  $[M_t] := d[M_t, M_t]$ .

## 2 Main result

We consider the following model of i.i.d. matrices:

**Definition 2.1.** *An i.i.d. matrix is an  $n \times n$  matrix  $X$  whose entries are all independent, identically distributed (i.i.d.) random variables,  $X_{ab} \stackrel{d}{=} n^{-1/2}\chi$ . We always assume that  $\mathbb{E}[\chi] = 0$  and  $\mathbb{E}[|\chi|^2] = 1$ . We will consider two classes of i.i.d. matrices, real i.i.d. matrices and complex i.i.d. matrices. In the real case  $\chi \in \mathbb{R}$  and in the complex case  $\chi \in \mathbb{C}$  and we further assume that  $\mathbb{E}[\chi^2] = 0$ . We will always assume that for all  $p \in \mathbb{N}$  there exists a  $C_p > 0$  so that,*

$$\mathbb{E}|\chi|^p \leq C_p. \quad (2.1)$$

Throughout, we will use the parameter  $\beta$  to unify formulas that hold in the real and complex cases. Specifically, in the real case  $\beta = 1$  and in the complex case  $\beta = 2$ .

We will also say that  $X$  has a Gaussian component of size  $a > 0$  if  $\chi = (1-a)^{1/2}\chi' + a^{1/2}g$  where  $g$  is a standard real or complex Gaussian (matching the symmetry of  $X$ ) and  $\chi'$  is independent of  $g$  and also obeys (2.1). Throughout the paper, we will also use the abbreviation GDE to denote the Gaussian divisible ensemble, i.e. i.i.d. matrices having a nonzero Gaussian component.

Our main observable of interest is the logarithm of the characteristic polynomial of  $X$ ,

$$P_n(z) := \log |\det(X - z)|. \quad (2.2)$$

The leading order asymptotics of the characteristic polynomial are given by,

$$\varphi(z) := \int_{\mathbb{D}} \log |z - \sigma| d^2\sigma = (\log |z|)_+ - \frac{(1 - |z|^2)_+}{2}. \quad (2.3)$$

Note that for  $|z| < 1$  we have  $\varphi(z) = (|z|^2 - 1)/2$ .

Our main result for complex i.i.d. matrices is the following.

**Theorem 2.2.** *Let  $X$  be a complex i.i.d. matrix as in Definition 2.1. Then for any  $\varepsilon > 0$  and  $0 < r < 1$  we have that*

$$\lim_{n \rightarrow \infty} \mathbb{P} \left( \left( \frac{1}{\sqrt{2}} - \varepsilon \right) \log n \leq \max_{|z| \leq r} [P_n(z) - n\varphi(z)] \leq \left( \frac{1}{\sqrt{2}} + \varepsilon \right) \log n \right) = 1. \quad (2.4)$$

We remark that by inspecting the proof one finds that the probability of the event in (2.4) is bounded below by  $1 - n^{-c_\varepsilon}$  for some  $c_\varepsilon > 0$  depending on  $\varepsilon > 0$ .

In the real case, there is an additional subleading deterministic contribution to the log characteristic polynomial. That is, if  $X$  is a real i.i.d. matrix, one expects that for  $|z| < 1$  the random variable,

$$\frac{P_n(z) - E_n(z)}{\sqrt{\frac{1}{4} \log n + \frac{1}{4} |\log(|z - \bar{z}|^2 + n^{-1})|}}, \quad E_n(z) := n\varphi(z) - \frac{1}{4} \log(|z - \bar{z}|^2 + n^{-1}) \quad (2.5)$$

converges to a standard normal random variable, even if  $\text{Im}[z] \rightarrow 0$  as  $n \rightarrow \infty$ . This would not be hard to show with our techniques, but given the length of the current paper we leave this to future work [41].

**Theorem 2.3.** *Let  $X$  be a real i.i.d. matrix. Then for any  $\varepsilon > 0$  and  $0 < r < 1$  we have that,*

$$\lim_{n \rightarrow \infty} \mathbb{P} \left[ \left( \frac{1}{\sqrt{2}} - \varepsilon \right) \log n \leq \max_{|z| \leq r} [P_n(z) - E_n(z)] \leq \left( \frac{1}{\sqrt{2}} + \varepsilon \right) \log n \right] = 1. \quad (2.6)$$

In addition, for any  $0 < \alpha < \frac{1}{2}$  and  $0 < r < 1$  we have that

$$\lim_{n \rightarrow \infty} \mathbb{P} \left[ \left( \frac{1}{\sqrt{2}} - \varepsilon \right) \log n \leq \max_{\substack{|z| \leq r \\ n^{-\alpha} \leq \text{Im}[z] \leq 2n^{-\alpha}}} [P_n(z) - E_n(z)] \leq \left( \frac{1}{\sqrt{2}} + \varepsilon \right) \log n \right] = 1. \quad (2.7)$$

**Remark.** [Maximum over the real axis] *We point out that using techniques similar to the proof of Theorems 2.2–2.3 we can also prove*

$$\mathbb{P} \left( \max_{x \in [-1+r, 1-r]} \left[ P_n(x) - n\varphi(x) + \frac{\log n}{4} \right] = \frac{\log n}{\sqrt{2}} (1 + \mathcal{O}(\varepsilon)) \right) = 1, \quad (2.8)$$

for any small  $r > 0$ . We do not present its proof here for brevity.

**Remark.** *In Theorems 2.2–2.3 and (2.8) we gave a leading order asymptotic for the maximum of the characteristic polynomial over the domain  $|z| \leq r$ , for some  $0 < r < 1$ . We expect that the same proof works for the maximum over  $|z| \leq 1$  (giving the same answer), but this would require significant rewriting of technical inputs to our work and so we omit this for brevity.*

We now present some technical results that will be used throughout the paper.

## 2.1 Preliminaries

Given  $z \in \mathbb{C}$  and a matrix  $X \in \mathbb{C}^{n \times n}$ , the *Hermitization* of  $X - z$  is

$$H^z(X) = H^z := \begin{pmatrix} 0 & X - z \\ (X - z)^* & 0 \end{pmatrix}. \quad (2.9)$$

Notice that  $H^z \in \mathbb{C}^{2n \times 2n}$  has a  $2 \times 2$  block structure, i.e. it consists of four  $n \times n$  blocks. This structure (known as *chiral symmetry*) induces a spectrum symmetric around zero, i.e., denoting the eigenvalues of  $H^z$  by  $\{\lambda_{\pm i}^z\}_{i \in [n]}$ , we have  $\lambda_{-i}^z = -\lambda_i^z$ , for  $i \in [n]$ . Furthermore, we point out that that  $\{\lambda_i^z\}_{i \in [n]}$  are exactly the singular values of  $X - z$ .

In this context, Girko's Hermitization formula is the identity,

$$\log |\det(X - z)| = \frac{1}{2} \log |\det H^z|. \quad (2.10)$$

This relation reduces the analysis of the non-Hermitian eigenvalues to study the eigenvalues of the Hermitian matrix  $H^z$ . In particular, we can write

$$P_n(z) - n\varphi(z) = \frac{1}{2} \left( \sum_{i=-n}^n \log |\lambda_i^z| - 2n \int_{\mathbb{R}} \log |x| \rho^z(x) dx \right) \quad (2.11)$$

Here  $\rho^z(x)$ , denoting the limiting eigenvalues distribution of  $H^z$ , is defined by

$$\rho^z(x) := \lim_{\eta \rightarrow 0^+} \frac{1}{\pi} \operatorname{Im} m^z(i\eta), \quad (2.12)$$

with  $m^z(w)$ , for  $w \in \mathbb{C} \setminus \mathbb{R}$ , being the unique solution of the cubic equation (see e.g. [3])

$$-\frac{1}{m^z(w)} = w + m^z(w) - \frac{|z|^2}{w + m^z(w)}, \quad \operatorname{Im}[w] \operatorname{Im}[m^z(w)] > 0. \quad (2.13)$$

In particular, the identity  $\varphi(z) = \int_{\mathbb{R}} \log |x| \rho^z(x) dx$  follows from either the fact that they must both be the a.s.-limits of  $n^{-1} \log |\det X|$  or, when  $|z| \leq 1$ , a direct calculation using (5.5) below (with initial data being a delta function).

We define the  $n$ -quantiles  $\gamma_i^z$  of  $\rho^z$  implicitly by

$$\int_0^{\gamma_i^z} \rho^z(x) dx = \frac{i}{2n}, \quad \text{for } i \in [n], \quad (2.14)$$

and  $\gamma_{-i}^z = -\gamma_i^z$  for  $i \in [n]$ . For  $w \in \mathbb{C} \setminus \mathbb{R}$ , we denote the resolvent by  $G^z(w) := (H^z - w)^{-1}$ . The local law (see Theorem 2.4 below) states that in the large  $n$ -limit the resolvent  $G^z$  becomes approximately deterministic, i.e. that  $G^z \approx M^z$  with

$$M^z = M^z(w) := \begin{pmatrix} m^z(w) & -zu^z(w) \\ -\bar{z}u^z(w) & m^z(w) \end{pmatrix}, \quad u^z(w) := \frac{m^z(w)}{w + m^z(w)}. \quad (2.15)$$

Here  $m^z(w)$  is the unique solution of (2.13). Additionally, this implies that  $M^z(w)$  is the unique solution of

$$-\frac{1}{M^z(w)} = w + Z + \langle M^z(w) \rangle, \quad Z := \begin{pmatrix} 0 & z \\ \bar{z} & 0 \end{pmatrix}, \quad (2.16)$$

satisfying  $\operatorname{Im}[w] \operatorname{Im}[M^z(w)] > 0$ .

The following local laws and rigidity estimates may be found in [35, Theorem 3.1].

**Theorem 2.4.** *Fix  $0 < r < 1$ ,  $C > 0$ , and any small  $\xi > 0$ . Uniformly in  $\operatorname{Im}[w] \geq n^{-1}$ ,  $|w| \leq C$ ,  $|z| \leq r$ , matrices  $A \in \mathbb{C}^{2n \times 2n}$  and vectors  $\mathbf{x}, \mathbf{y} \in \mathbb{C}^{2n}$ , we have with overwhelming probability,*

$$|\langle \mathbf{x}, (G^z(w) - M^z(w)) \mathbf{y} \rangle| \leq \|\mathbf{x}\| \|\mathbf{y}\| \frac{n^\xi}{\sqrt{n \operatorname{Im}[w]}} \quad (2.17)$$

and

$$|\langle A(G^z(w) - M^z(w)) \rangle| \leq \frac{n^\xi \|A\|}{n \operatorname{Im}[w]}. \quad (2.18)$$

Additionally, we have with overwhelming probability that,

$$|\lambda_i^z - \gamma_i^z| \leq \frac{n^\xi}{n^{2/3} (1 + n - |i|)^{1/3}} \quad (2.19)$$

Due to the importance of the quantity on the RHS of (2.11) we will denote,

$$\Psi_n(z) := \sum_{i=-n}^n \log |\lambda_i^z| - 2n \int \log |x| \rho^z(x) dx + \mathbf{1}_{\{\beta=1\}} \frac{1}{2} \log \left( |z - \bar{z}|^2 + 2n^{-1} \sqrt{1 - |z|^2} \right). \quad (2.20)$$

Note that, in the complex case,  $\Psi_n(z)$  differs from  $P_n(z) - n\varphi(z)$  only by a factor of 2, while in the real case there is an additional subleading order correction. We will need to consider a more general quantity. Throughout our work the matrix  $X$  will be allowed to depend on time  $t$ , and we will denote the eigenvalues of the Hermitization of  $X_t - z$  (as in (2.9)) by  $\lambda_i(t)^z$ . Furthermore, for any  $\eta > 0$  we denote,

$$\begin{aligned} \Psi_n(z, t, \eta) &:= \operatorname{Re} \left( \sum_{i=-n}^n \log(\lambda_i^z(t) - i\eta) - 2n \int_{\mathbb{R}} \log(x - i\eta) \rho_t^z(x) dx \right) \\ &\quad + \mathbf{1}_{\{\beta=1\}} \frac{1}{2} \log \left( |z - \bar{z}|^2 + (n^{-1} \vee \eta) \right) \\ &= \frac{1}{2} \left( \sum_{i=-n}^n \log(\lambda_i^z(t)^2 + \eta^2) - 2n \int_{\mathbb{R}} \log(x^2 + \eta^2) \rho_t^z(x) dx \right) \\ &\quad + \mathbf{1}_{\{\beta=1\}} \frac{1}{2} \log \left( |z - \bar{z}|^2 + (n^{-1} \vee \eta) \right). \end{aligned} \quad (2.21)$$

In the case that  $X$  does not depend on time we will denote the above observable by  $\Psi_n(z, \eta)$ . Above,  $\rho_t^z$  will be a possibly time-dependent limiting spectral distribution of  $X_t$ ; whenever we introduce a time-dependent models of  $X_t$ , we will also introduce  $\rho_t^z$  at the same time. Due to taking the real part, the choice of branch cut of the logarithm is immaterial, but for definiteness we will take the branch cut along the positive imaginary axis. Note that in principle, the additional term present in the real case should also have some time dependence, but since we will always have  $t \leq n^{-c}$ , for some possibly very small fixed  $c > 0$ , this will turn out to be lower order.

The following is a consequence of [32, Theorems 4.4–4.5], and we provide the proof in Appendix D.1.

**Proposition 2.5.** *Let  $0 < r < 1$ , and fix any small  $\xi > 0$ . For  $X$  a real or complex i.i.d. matrix we have*

$$|\Psi_n(z_1, \eta) - \Psi_n(z_2, \eta)| \leq \frac{n^\xi |z_1 - z_2|}{\sqrt{\eta}} \quad (2.22)$$

with overwhelming probability uniformly in  $z_1, z_2$  satisfying  $|z_i| < r$  and  $1/n \leq \eta \leq 1$

### 3 Fine rigidity estimates for the Hermitization of $X - z$

In this section we will derive a very precise bound on the eigenvalues  $\lambda_i^z$  for small  $i$ . That is, we will show that  $|\lambda_i^z - \gamma_i^z| \ll \log n/n$  for small  $i$ . The first step towards this estimate is the following improvement on the averaged local laws of Theorem 2.4, which replaces the  $n^\xi$  error term with a correction sub-logarithmic in  $n$  (observe that the results hold only for small  $\operatorname{Im} w \ll 1$ ).

**Definition 3.1.** *For  $|z| \leq r < 1$  and  $\kappa > 0$  we define the bulk interval  $I_z(\kappa)$  by*

$$I_z(\kappa) := \{E : \rho^z(E) > \kappa\} \quad (3.1)$$

*Note that  $I_z(\kappa)$  consists of a single interval for all  $\kappa > 0$  sufficiently small.*

**Proposition 3.2.** *Let  $X$  be a real or complex i.i.d. matrix. Then, for any sufficiently small  $\delta > 0$  and  $\kappa > 0$  it holds*

$$|\langle G^z(w) - M^z(w) \rangle| \lesssim \frac{(\log n)^{1/2+\delta}}{n |\operatorname{Im} w|}, \quad (3.2)$$

*with overwhelming probability uniformly in  $n^{-\delta} \geq |\operatorname{Im} w| \geq (\log n)^{1/2+10\delta}/n$  and  $\operatorname{Re} w \in I_z(\kappa)$ .*

**Remark.** *In Proposition 3.2 we prove an averaged local law for sub-logarithmic scales. We expect that the same proof should give a similar bound for the isotropic law without any additional effort. This means that for any deterministic unit vectors  $\mathbf{x}, \mathbf{y}$ , with overwhelming probability, we have*

$$|\langle \mathbf{x}, (G^z(w) - M^z(w)) \mathbf{y} \rangle| \lesssim \frac{(\log n)^{1/2+\delta}}{\sqrt{n} |\operatorname{Im} w|}. \quad (3.3)$$

*We do not present its proof here for brevity. We also expect to be possible to choose  $\delta = 0$  in (3.2)–(3.3), giving an optimal bound in terms of  $n$ . This would also give an optimal delocalization bound on the eigenvectors of  $H^z$ .*

The proof of Proposition 3.2 is deferred to Section 3.1. The estimate (3.2) implies the following rigidity estimate via the Helffer-Sjöstrand formula. The proof is standard and deferred to Section D.2.

**Corollary 3.3.** *Let  $X$  be a real or complex i.i.d. matrix and fix  $|z| \leq r < 1$ . Then for any large  $C > 0$  and small  $\delta > 0$  we have that*

$$|\lambda_i^z - \gamma_i^z| \leq \frac{\log n^{1/2+\delta}}{n}, \quad (3.4)$$

*for  $|i| \leq (\log n)^C$  with overwhelming probability. Furthermore, for any  $\delta, \varepsilon > 0$  we have that,*

$$|\lambda_i^z - \gamma_i^z| \leq \frac{(\log n)^{3/2+\delta}}{n} \quad (3.5)$$

*for  $|i| < n^{1-\varepsilon}$  with overwhelming probability.*

### 3.1 Proof of Proposition 3.2

We prove this local law dynamically. That is, we will first prove (3.2) for matrices with a fairly large Gaussian component, using Dyson Brownian motion and then remove this Gaussian component by a standard Green's function comparison (GFT) argument.

First, note that the local law (2.18) with  $A = I$  implies that,

$$|\langle G^z(w) - M^z(w) \rangle| \leq \frac{n^\xi}{n |\operatorname{Im} w|}, \quad (3.6)$$

with overwhelming probability for any small  $\xi > 0$ , uniformly in  $|\operatorname{Im} w| \geq n^{-1+\xi}$ . We will show that along the flow (3.7) below we can improve this bound in two directions. First, that the  $n^\xi$  in the RHS of (3.6) can be replaced by  $(\log n)^{1/2+\delta_1}$ , for some small fixed  $\delta_1 > 0$ ; and then second, that this bound will hold uniformly in  $|\operatorname{Im} w| \geq n^{-1}(\log n)^{1/2+10\delta_1}$ .

Consider the Ornstein-Uhlenbeck flow

$$dX_t = -\frac{1}{2}X_t dt + \frac{dB_t}{\sqrt{n}}, \quad X_0 = X, \quad (3.7)$$

where we consider two cases. First, if  $X$  is a complex i.i.d. matrix, then  $B_t$  is a matrix of i.i.d. standard complex Brownian motions. If  $X$  is a real i.i.d. matrix, then  $B_t$  is a matrix of i.i.d. standard real Brownian motions. As indicated in Definition 2.1, we will use the parameter  $\beta = 1, 2$  to denote the real and complex cases, respectively.

Let  $H_t^z = H^z(X_t)$  be the Hermitization of  $X_t - z$  defined as in (2.9) with  $X$  replaced by  $X_t$ , and define its resolvent by  $G_t^z(w) := (H_t^z - w)^{-1}$ , with  $w \in \mathbb{C} \setminus \mathbb{R}$ . In particular, along (3.7) the first two moments of  $H_t^z$  are preserved and so  $\rho^z(x)$  will continue to be a good approximation to its empirical eigenvalue distribution for any  $t \geq 0$ .

Recall the definition of  $E_1, E_2$  in (1.17) as well as  $\tilde{\sum}_{ij}$  directly below that equation. Then, using Itô's formula we obtain (recall that  $A^t$  denotes the transpose of  $A$ )

$$\begin{aligned} d\langle G_t^z(w) \rangle &= dN_t^z(w) + \frac{1}{2}\langle G_t^z(w) \rangle dt + \frac{1}{2}\langle (Z + w)G_t^z(w)^2 \rangle dt + 2\sum_{ij}^{\tilde{\sum}} \langle G_t^z(w)E_i \rangle \langle G_t^z(w)^2 E_j \rangle dt \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij}^{\tilde{\sum}} \langle G_t^z(w)^2 E_i G_t^z(w)^t E_j \rangle dt \end{aligned} \quad (3.8)$$

where

$$dN_t^z(w) := -\frac{1}{n^{1/2}} \langle (G_t^z)^2 d\mathfrak{B}_t \rangle, \quad \mathfrak{B}_t = \begin{pmatrix} 0 & B_t \\ B_t^* & 0 \end{pmatrix}. \quad (3.9)$$

Associated with (3.8) are the characteristics,

$$\partial_t w_t = -m^{zt}(w_t) - \frac{w_t}{2}, \quad \partial_t z_t = -\frac{z_t}{2}, \quad (3.10)$$

with initial conditions  $\eta_0 = n^{-\xi}$  and  $|z_0| \leq r < 1$ . By implicitly differentiating (2.16) with respect to  $t$  one finds that,

$$\frac{d}{dt} M^{zt}(w_t) = \frac{1}{2} M^{zt}(w_t). \quad (3.11)$$

Computing the flow (3.8) along the characteristics (3.10), using (3.11), we find that,

$$\begin{aligned} d\langle G_t^{zt}(w_t) - M^{zt}(w_t) \rangle &= dN_t^{zt}(w_t) + \left( \frac{1}{2} + \langle G_t^{zt}(w_t)^2 \rangle \right) \langle G_t^{zt}(w_t) - M^{zt}(w_t) \rangle dt \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij}^{\tilde{\sum}} \langle G_t^{zt}(w_t)^2 E_i G_t^{zt}(w_t)^t E_j \rangle dt \end{aligned} \quad (3.12)$$

where we used that  $2\langle G_t^{zt}(w)E_i \rangle = \langle G_t^{zt}(w) \rangle$  and  $2\langle G_t^{zt}(w)^2 E_i \rangle = 2\partial_w \langle G_t^{zt}(w)E_i \rangle = \partial_w \langle G_t^{zt}(w) \rangle = \langle G_t^{zt}(w)^2 \rangle$ . For notational simplicity we will drop the superscript and denote  $G_t = G_t^{zt}(w_t)$  and  $N_t = N_t^{zt}$ . We remark also that if either  $\text{Re}[w_t] \in I_{z_t}(\kappa)$  or  $\text{Re}[w_0] \in I_{z_0}(\kappa)$  for some  $\kappa > 0$ , then, if  $t$  is sufficiently small, we have that  $\text{Re}[w_s] \in I_{z_s}(\frac{1}{2}\kappa)$  for all  $0 \leq s \leq t$ .

In the remainder of the section we will denote  $\eta_s := \text{Im}[w_s]$ . In several places we will use the fact that if  $\text{Re}[w_s] \in I_{z_s}(\kappa)$  then  $-\partial_s \eta_s \asymp 1$ .

**Lemma 3.4.** *Let  $\xi, \kappa > 0$  and  $\delta > 0$ . Let  $(z_s, w_s)$  denote a characteristic with  $\text{Re}[w_0] \in I_{z_0}(\kappa)$ ,  $\text{Im}[w_0] = n^{-\xi}$  and  $n^{-5\xi} \geq \text{Im}[w_t] \geq n^{-1+10\xi}/n$ . Then with overwhelming probability,*

$$|\langle G_t^{zt}(w_t) - M^{zt}(w_t) \rangle| \leq \frac{(\log n)^{1/2+\delta}}{n \text{Im}[w_t]}. \quad (3.13)$$

**Proof.** First note that (2.18) with  $A = I$  implies that with overwhelming probability we have

$$|\langle G_s(w) - M^{z_s}(w) \rangle| \leq \frac{n^\xi}{n \operatorname{Im}[w]}, \quad |\langle \partial_w(G_s(w) - M^{z_s}(w)) \rangle| \leq \frac{n^\xi}{n \operatorname{Im}[w]^2}, \quad (3.14)$$

uniformly in  $0 \leq s \leq t$  and  $\operatorname{Im}[w] \geq n^{-1+\xi}$  (with the second inequality following from the Cauchy integral formula).

Integrating (3.12) in time, using (3.14) and  $|\langle \partial_w M^z(w) \rangle| \lesssim 1$  for  $\operatorname{Re}[w] \in I_z(\kappa)$ , we conclude (recall  $\eta_0 = n^{-\xi}$ )

$$\begin{aligned} \langle G_t(w_t) - M^{z_t}(w_t) \rangle &= \int_0^t dN_s + \int_0^t \left( \frac{1}{2} + \langle \partial_{w_s} M^{z_s}(w_s) \rangle \right) \langle G_s(w_s) - M^{z_s}(w_s) \rangle ds \\ &+ \mathcal{O} \left( \frac{n^{2\xi}}{n} + \frac{n^{2\xi}}{(n\eta_t)^2} + \frac{\mathbf{1}_{\{\beta=1\}}}{n\eta_t} \right) \\ &= \int_0^t dN_s + \mathcal{O} \left( \frac{n^{2\xi}}{n} + \frac{n^{2\xi}}{(n\eta_t)^2} + \frac{\mathbf{1}_{\{\beta=1\}}}{n\eta_t} \right) \end{aligned} \quad (3.15)$$

In order to estimate the term on the second line of (3.12) we used,

$$\frac{1}{n} |\langle G_t(w_t)^2 E_i G_t(w_t)^t E_j \rangle| \lesssim \frac{1}{n} \langle |G_t(w_t)|^4 \rangle^{1/2} \langle |G_t(w_t)|^2 \rangle^{1/2} \lesssim \frac{1}{n\eta_t^2} \langle \operatorname{Im}[G_t(w_t)] \rangle \lesssim \frac{1}{n\eta_t^2} \quad (3.16)$$

with overwhelming probability. We are thus left only with the estimate of the martingale term. Let  $\tau > 0$  be the stopping time,

$$\tau := \inf\{0 < s < t : \langle |G_s(w_s) - M^{z_s}(w_s) \rangle| > 1\} \quad (3.17)$$

Note that  $\tau = t$  with overwhelming probability. For  $t < \tau$  we have for the quadratic variation of  $N_s$  (by direct computation),

$$d[N_s, \bar{N}_s] = \sum_{ij} \left( \frac{1}{n^2} \langle G_s(w_s)^2 E_i G_s(\bar{w}_s)^2 E_j \rangle + \frac{\mathbf{1}_{\{\beta=1\}}}{n^2} \langle G_s(w_s)^2 E_i [G_s(\bar{w}_s)^2]^t E_j \rangle \right) ds \leq \frac{C}{n^2 \eta_s^3} ds. \quad (3.18)$$

The inequality follows by Cauchy-Schwarz and the fact that

$$\langle E_i G_s(w_s)^2 (G_s(w_s)^*)^2 \rangle \leq C \eta_s^{-3} \langle \operatorname{Im}[G_t(w_t)] \rangle \leq C \eta_s^{-3}. \quad (3.19)$$

By the martingale representation theorem, the real and imaginary parts of the stopped process  $N_s^\tau$  are each equal in distribution to processes  $X_s, Y_s$  that satisfy  $X_s = \tilde{b}_{[X_s]}$ ,  $Y_s = \tilde{b}_{[Y_s]}$ , where  $\tilde{b}$  is a standard Brownian motion. Since the total variation processes of the real and imaginary parts of  $N_s^\tau$  are bounded above by  $[N_s^\tau, \bar{N}_s^\tau]$  and by definition of  $\tau$ ,  $[N_s^\tau, \bar{N}_s^\tau] \lesssim (n\eta_s)^{-2}$ , we obtain

$$\mathbb{P} \left( \sup_{0 \leq s \leq t} |N_s^\tau| > \frac{u}{n\eta_t} \right) \lesssim \mathbb{P} \left( (n\eta_t) \sup_{0 \leq s \leq C/(n\eta_t)^2} |b_s| > u \right) \lesssim e^{-cu^2}, \quad (3.20)$$

for some small constant  $c > 0$ . This implies that

$$\mathbb{P} \left( \exists s \in [0, t] : |N_s| \geq \frac{(\log n)^{1/2+\delta}}{n\eta_t} \right) \lesssim n^{-D}, \quad (3.21)$$

for any  $D > 0$ , which together with (3.15) completes the proof (here we use the fact that  $n^{2\xi-1} + n^{2\xi}/(n\eta_t)^2 \leq n^{-\xi}/(n\eta_t)$  by our assumptions on  $\eta_t$ ).  $\square$

We now propagate the above estimate to shorter scales.

**Lemma 3.5.** *Let  $\xi, \kappa, \delta > 0$  be sufficiently small. Let  $(z_s, w_s)$  denote a characteristic with  $\text{Re}[w_0] \in I_{z_0}(\kappa)$ ,  $\text{Im}[w_0] = n^{-\xi}$  and  $\text{Im}[w_t] \geq (\log n)^{1/2+10\delta}/n$ . Assume that with overwhelming probability,*

$$|\langle G_0^{z_0}(w_0) - M^{z_0}(w_0) \rangle| \leq \frac{(\log n)^{1/2+\delta}}{n \text{Im}[w_0]}, \quad |\langle \partial_w(G_0^{z_0}(w_0) - M^{z_0}(w_0)) \rangle| \leq \frac{(\log n)^{1/2+\delta}}{n \text{Im}[w_0]^2}. \quad (3.22)$$

Then with overwhelming probability we have that

$$|\langle G_t^{z_t}(w_t) - M^{z_t}(w_t) \rangle| \leq \frac{(\log n)^{1/2+2\delta}}{n \text{Im}[w_t]}. \quad (3.23)$$

**Proof.** Note that the term  $\langle G_t(w_t)^2 \rangle$  appears in the flow (3.12). For this purpose we study the evolution of this term along the characteristics (see e.g. [38, Eq. (5.7)] for  $A = B = I$ ):

$$\begin{aligned} d\langle G_s(w_s)^2 - \partial_w M^{z_s}(w_s) \rangle &= d\widehat{N}_s + (1 + 2\langle \partial_w M^{z_s}(w_s) \rangle) \langle G_s(w_s)^2 - \partial_w M^{z_s}(w_s) \rangle \\ &\quad + \langle G_s(w_s)^2 - \partial_w M^{z_s}(w_s) \rangle^2 \\ &\quad + 2\langle G_s(w_s) - M^{z_s}(w_s) \rangle \langle G_s(w_s)^3 \rangle \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij} \widetilde{\langle \langle G_t(w_t)^3 E_i G_t(w_t)^t E_j \rangle + \langle G_t(w_t)^2 E_i [G_t(w_t)^2]^t E_j \rangle \rangle} dt \end{aligned} \quad (3.24)$$

with (recall the definition of  $\mathfrak{B}_t$  from (3.9))

$$d\widehat{N}_s := -\frac{1}{n^{1/2}} \langle (G_s^{z_s})^3 d\mathfrak{B}_s \rangle. \quad (3.25)$$

We remark that in (3.24) we used [38, Lemma 5.5] in the form

$$\partial_s \langle \partial_w M^{z_s}(w_s) \rangle = \langle \partial_w M^{z_s}(w_s) \rangle + \langle \partial_w M^{z_s}(w_s) \rangle^2, \quad (3.26)$$

and that  $\langle G_s(w_s)^2 (E_1 - E_2) \rangle = \langle \partial_w M^{z_s}(w_s) (E_1 - E_2) \rangle = 0$  by spectral symmetry.

Define

$$X_s := \langle G_s(w_s) - M^{z_s}(w_s) \rangle, \quad Y_s := \langle G_s(w_s)^2 - \partial_w M^{z_s}(w_s) \rangle, \quad (3.27)$$

and the stopping time,

$$\tau := \inf \left\{ s \geq 0 : |X_s| = \frac{(\log n)^{1/2+2\delta}}{n\eta_s}, \quad |Y_s| = \frac{(\log n)^{1/2+3\delta}}{n\eta_s^2} \right\} \wedge t, \quad (3.28)$$

where  $t$  is as in the statement of the lemma and  $\eta_t \geq (\log n)^{1/2+10\delta}/n$ . Necessarily,  $t \asymp \text{Im}[w_0]$ . Note that by our assumptions on the initial conditions we have that  $\tau > 0$  with overwhelming probability. Then, by (3.12) and (3.24), we have with overwhelming probability, for any  $0 < s < \tau$ ,

$$X_s = \int_0^s dN_u + \int_0^s \left( \frac{1}{2} + \langle \partial_w M^{z_u}(w_u) \rangle \right) X_u du + \mathcal{O} \left( \frac{(\log n)^{1/2+\delta}}{n\eta_0} + \frac{(\log n)^{1+5\delta}}{(n\eta_s)^2} \right), \quad (3.29)$$

and

$$Y_s = \int_0^s d\widehat{N}_u + \int_0^t (1 + 2\langle \partial_w M^{z_u}(w_u) \rangle) Y_u du + \mathcal{O} \left( \frac{(\log n)^{1/2+\delta}}{n\eta_0^2} + \frac{(\log n)^{1+6\delta}}{(n\eta_s)n\eta_s^2} + \frac{(\log n)^{1/2+2\delta}}{n\eta_s^2} \right). \quad (3.30)$$

We point out that to estimate the error in (3.30) we used

$$|\langle G_t(w_t)^3 \rangle| \leq \frac{\langle \text{Im} G_t(w_t) \rangle}{\eta_t^2} \lesssim \frac{1}{\eta_t^2}, \quad (3.31)$$

where in the last inequality we used the definition of  $\tau$  in (3.28) and the fact that  $(\log n)^{1/2+\delta}/(n\eta_s) \lesssim 1$ . For the terms when  $\beta = 1$  on the last line of (3.24) we used,

$$\begin{aligned} & |\langle G_t(w_t)^3 E_i G_t(w_t)^t E_j \rangle + \langle G_t(w_t)^2 E_i [G_t(w_t)^2]^t E_j \rangle| \\ & \lesssim \langle |G_t(w_t)|^6 \rangle^{1/2} \langle |G_t(w_t)|^2 \rangle^{1/2} + \langle |G_t(w_t)|^4 \rangle \lesssim \frac{1}{\eta_t^3} \end{aligned} \quad (3.32)$$

for  $t < \tau$ . For the martingale terms, for  $s < \tau$ , we have

$$\begin{aligned} d[N_s, \bar{N}_s] &= \frac{1}{n^2} \sum_{ij} \tilde{\langle G_t(w_t)^2 E_i G_t(\bar{w}_t)^2 E_j \rangle} + \mathbf{1}_{\{\beta=1\}} \langle G_t(w_t)^2 E_i [G_t(\bar{w}_t)^2]^t E_j \rangle \\ &\lesssim n^{-2} \langle |G_s(z_s)|^4 \rangle \lesssim n^{-2} \eta_s^{-3} \langle \text{Im}[G_s(z_s)] \rangle \lesssim \frac{1}{n^2 \eta_s^3}, \end{aligned} \quad (3.33)$$

and

$$\begin{aligned} d[\hat{N}_s, \hat{\bar{N}}_s] &= \frac{1}{n^2} \sum_{ij} \tilde{\langle G_t(w_t)^3 E_i G_t(\bar{w}_t)^3 E_j \rangle} + \mathbf{1}_{\{\beta=1\}} \langle G_t(w_t)^3 E_i [G_t(\bar{w}_t)^3]^t E_j \rangle \\ &\lesssim n^{-2} \langle |G_s(z_s)|^6 \rangle \lesssim \frac{1}{n^2 \eta_s^5}. \end{aligned} \quad (3.34)$$

Therefore, by the same argument that uses the martingale representation theorem in the proof of Lemma 3.4, for any  $0 < s < t$ , we have

$$\mathbb{P} \left[ \sup_{0 < u < s} |N_{u \wedge \tau}| > \frac{(\log n)^{1/2+\delta/2}}{n\eta_s} \right] + \mathbb{P} \left[ \sup_{0 < u < s} |\hat{N}_{u \wedge \tau}| > \frac{(\log n)^{1/2+\delta/2}}{n\eta_s^2} \right] \leq n^{-D} \quad (3.35)$$

for any  $D > 0$ . We now claim that in fact the stronger estimate,

$$\mathbb{P} \left[ \sup_{0 < s < t} \eta_s n |N_{s \wedge \tau}| > (\log n)^{1/2+\delta} \right] + \mathbb{P} \left[ \sup_{0 < s < t} \eta_s^2 n |\hat{N}_{s \wedge \tau}| > (\log n)^{1/2+\delta} \right] \leq n^{-D}. \quad (3.36)$$

holds. To prove this, take a sequence of times  $s_i$  such that  $\eta_{s_i} = \frac{1}{2}\eta_{s_{i-1}}$ , with  $s_0 = 0$ . There are at most  $\mathcal{O}(\log n)$  such times until  $\eta_{s_i} < \eta_t$ . For  $s \in [s_{i-1}, s_i]$  we have that  $\eta_s \asymp \eta_{s_i}$ . Therefore, (3.35) implies

$$\mathbb{P} \left[ \sup_{u \in [s_{i-1}, s_i]} |(n\eta_u) N_{u \wedge \tau}| > (\log n)^{1/2+\delta} \right] + \mathbb{P} \left[ \sup_{u \in [s_{i-1}, s_i]} |n\eta_u^2 \hat{N}_{u \wedge \tau}| > (\log n)^{1/2+\delta} \right] \leq n^{-D} \quad (3.37)$$

From a union bound we therefore conclude (3.36).

Therefore, with overwhelming probability we have for all  $0 < s < \tau$  that,

$$X_s = \int_0^s \left( \frac{1}{2} + \langle \partial_{w_u} M^{z_u}(w_u) \rangle \right) X_u du + \mathcal{O} \left( \frac{(\log n)^{1/2+\delta}}{n\eta_s} \right) \quad (3.38)$$

and

$$Y_s = \int_0^s (1 + 2\langle \partial_{w_u} M^{z_u}(w_u) \rangle) Y_u du + \mathcal{O} \left( \frac{(\log n)^{1/2+2\delta}}{n\eta_s^2} \right). \quad (3.39)$$

Note that in order to simplify the errors in (3.29) and in (3.30) we used the fact that  $n\eta_s \geq (\log n)^{1/2+10\delta}$  by assumption. From the integral form of Gronwall inequality, using  $|\langle \partial_{w_u} M(w_u) \rangle| \leq C$ , we then see that with overwhelming probability for any  $0 < s < \tau$  we have that,

$$|X_s| \leq C \frac{(\log n)^{1/2+\delta}}{n\eta_s}, \quad |Y_s| \leq C \frac{(\log n)^{1/2+2\delta}}{n\eta_s^2}. \quad (3.40)$$

Since  $X_s$  and  $Y_s$  are continuous, we cannot have that  $\tau < t$ , and so the claim follows.  $\square$

The above two lemmas easily imply the following. In particular, the assumption (3.22) of Lemma 3.5 is satisfied as a consequence of (3.13) and Cauchy integral formula.

**Proposition 3.6.** *Let  $\xi, \kappa$  and  $\delta > 0$ . Let  $X$  be a real or complex i.i.d. matrix with Gaussian component of size at least  $n^{-\xi/10}$ . Then with overwhelming probability we have for all  $w$  satisfying  $(\log n)^{1/2+\delta} \leq \text{Im}[w] \leq n^{-\xi}$  and  $\text{Re}[w] \in I_z(\kappa)$  that*

$$|\langle G^z(w) - M^z(w) \rangle| \leq \frac{(\log n)^{1/2+\delta}}{n \text{Im}[w]}. \quad (3.41)$$

$\square$

Strictly speaking, our methods do not require us to prove the above estimates for matrices with no Gaussian component, as this local law is only used to analyze the dynamics. However, for notational simplicity, and because the results may be of use in other problems, in the next section we use a Green's function comparison argument to extend the local law to all matrices.

### 3.1.1 Removal of Gaussian divisible component

In this section we extend Proposition 3.6 to general i.i.d. matrices. We just present the proof in the complex i.i.d. case, the other case being analogous. Let  $Z(X)$  be the function on the space of  $n \times n$  matrices given by,

$$Z(X) := n \text{Im}[w] |\langle G^z(w) - M^z(w) \rangle|. \quad (3.42)$$

Let  $X$  and  $Y$  be two  $n \times n$  matrices such that

$$\mathbb{E}[X_{ij}^a \bar{X}_{ij}^b] = \mathbb{E}[Y_{ij}^a \bar{Y}_{ij}^b] \quad (3.43)$$

for  $0 \leq a + b \leq 3$  and

$$\left| \mathbb{E}[X_{ij}^a \bar{X}_{ij}^b] - \mathbb{E}[Y_{ij}^a \bar{Y}_{ij}^b] \right| \leq T n^{-2} \quad (3.44)$$

for  $a + b = 4$ . Here  $T = n^{-\varepsilon}$  for some  $\varepsilon > 0$ . Let  $W^{(ab)}$  be the matrix obtained by replacing all the entries  $(i, j)$  of  $X$  with  $i \leq a$  or  $j \leq b$  with those of  $Y$ . Define now,

$$p(k) := \sup_{0 \leq a, b \leq n} \mathbb{P} \left[ Z(W^{(ab)}) > k(\log n)^{1/2+\delta} \right]. \quad (3.45)$$

Then we have the following which is proven in Appendix F.1.

**Proposition 3.7.** *Assume that  $\text{Re}[w] \in I_z(\kappa)$  and that  $n^{-1} \leq \text{Im}[w] \leq 1$ . Then, there is a constant  $C > 0$  so that for  $k \geq 2$  we have,*

$$p(k) \leq C \mathbb{P} \left[ Z(Y) \geq (\log n)^{1/2+\delta} \right] + CT^{1/2} p(k-1) + n^{-D}. \quad (3.46)$$

**Proof of Proposition 3.2.** For any fixed  $\xi > 0$ , Proposition 3.6 implies that Proposition 3.2 holds for matrices with Gaussian component of size at least  $T := n^{-\xi/10}$ . For any given ensemble  $X$  we may find another ensemble  $Y$  so that the first three moments of  $Y$  match those of  $X$  and the fourth moments differ by  $\mathcal{O}(Tn^{-2})$  and  $Y$  has Gaussian component of size least  $T$  (see, e.g., Lemma 3.4 of [54]). Therefore, iterating the estimate of Proposition 3.7  $k$  times, we get

$$p(k) \leq Cn^{-D} + CT^{k/2}. \quad (3.47)$$

Taking  $k$  sufficiently large, depending on  $\xi > 0$  yields the claim.  $\square$

### 3.2 Local laws for matrices of mixed symmetry

In this section we introduce matrices which have a mixed symmetry class. More precisely, they consist of the sum of two independent matrices, one being a real i.i.d. matrix and one being a (small) complex Ginibre matrix. This class of matrices will appear at a certain point in the proof of the lower bound for real matrices (see Lemma 10.4 below) for purely technical reasons.

**Definition 3.8.** *We say that  $X$  is a matrix of type  $M$  if it can be written in the form  $X = (1-t)^{1/2}Y + \sqrt{t}G$  where  $Y$  is a real i.i.d. matrix,  $G$  is a complex Ginibre matrix, and  $t \leq n^{-\varepsilon}$  for some  $\varepsilon > 0$ .*

We now claim that the local law and rigidity estimates from Proposition 3.2 and Corollary 3.3 still hold for this class of matrices. The proof of this lemma is postponed to Appendix C.

**Lemma 3.9.** *If  $X$  is a matrix of type  $M$ , then the local law and rigidity (2.18)–(2.19), the estimate (3.2), and the results of Corollary 3.3 hold. For other eigenvalues, for any  $c > 0$  and all  $1 \leq i \leq (1-c)n$ , we have*

$$|\lambda_i^z - \gamma_i^z| \leq \frac{n^\xi}{n} \quad (3.48)$$

and that  $|\lambda_n^z - \gamma_n^z| \leq n^\xi \sqrt{t}$  with overwhelming probability for any small  $\xi > 0$ .

## 4 Maximum on almost-global scales

In this section we present a bound for the regularized characteristic polynomial  $\Psi_n(z, \eta)$  (recall the definition (2.21)) when  $\eta = n^{-\gamma}$  for small  $\gamma > 0$ . This will be used to truncate various large scale contributions throughout our proofs.

**Proposition 4.1.** *Let  $0 < r < 1$ . There is a  $C_1 > 0$  so that the following holds. Let  $\gamma > 0$ ,  $C > 0$ , and define  $\eta_* := n^{-\gamma}$ . Then, for any real or complex i.i.d. matrix we have,*

$$\mathbb{P} \left[ \max_{|z| \leq r, (\log n)^{-C} \eta_* \leq \eta \leq (\log n)^C \eta_*} |\Psi_n(z, \eta)| > C_1 \gamma \log n \right] \leq n^{-3\gamma} \quad (4.1)$$

for all sufficiently small  $\gamma > 0$ .

The main ingredient to prove Proposition 4.1 is the following estimate of the characteristic function of a linear statistic, whose proof is postponed to Appendix E.

**Proposition 4.2.** Fix any sufficiently small  $\gamma > 0$ , and let  $f : \mathbb{R} \rightarrow \mathbb{R}$  be in  $C_0^\infty([-5, 5])$  and such that  $\|f\|_{C^k} \lesssim n^{k\gamma}$  for all sufficiently large  $k$ . Then for  $\lambda \in \mathbb{R}$  satisfying  $|\lambda| \leq n^{1/100}$  we have

$$\mathbb{E} \left[ \exp \left( i\lambda (\text{Tr}f(H^z) - \mathbb{E}\text{Tr}f(H^z)) \right) \right] = \exp \left( -\frac{\lambda^2}{2} V(f) \right) + \mathcal{O} \left( \frac{n^{200\gamma}}{n^{1/4}} \right), \quad (4.2)$$

for some explicit  $V(f) \geq -n^{-1/5}$ . Additionally, if  $f(x) = \text{Re} \log(x - i\eta)$ , with  $\eta = n^{-\gamma}$ , then

$$\begin{aligned} \mathbb{E}\text{Tr}f(H^z) &= n \int \log(x^2 + \eta^2) \rho^z(x) dx + \frac{\mathbf{1}_{\{\beta=1\}}}{2} \log [|z - \bar{z}|^2 + \eta] + \mathcal{O}(1), \\ V(f) &= -\log \eta - \mathbf{1}_{\{\beta=1\}} \log [|z - \bar{z}|^2 + \eta] + \mathcal{O}((\log n)^{1/2}). \end{aligned} \quad (4.3)$$

The above is readily seen to imply the following via Fourier duality.

**Lemma 4.3.** There is a  $C_1 > 0$  so that the following holds. Let  $f = \text{Re} \log(x - i\eta)$  with  $\eta = n^{-\gamma}$ , for  $\gamma > 0$  sufficiently small. Then,

$$\mathbb{P} \left[ \left| \text{Tr}f(H^z) - 2n \int \text{Re} \log(x - i\eta) \rho^z(x) dx \right| > C_1 \gamma \log n \right] \leq n^{-5\gamma}. \quad (4.4)$$

**Proof.** Let  $0 \leq F(x) \leq 1$  be a smooth function with bounded derivatives such that  $F(x) = 1$  for  $|x| \leq C_1 \gamma \log n$  and  $F(x) = 0$  for  $|x| > C_1 \gamma \log n + 1$ . Let  $\hat{F}(\lambda)$  denote its Fourier transform. Then,

$$|\hat{F}(\lambda)| \leq \frac{(\log n)^2}{1 + |\lambda|^M} \quad (4.5)$$

for any  $M > 0$  and  $n$  large enough. Let  $Y := \text{Tr}f(H^z) - \mathbb{E}[\text{Tr}f(H^z)]$ . We know that  $\mathbb{E}[\text{Tr}f(H^z)] = 2n \int \text{Re} \log(x - i\eta) \rho^z(x) dx + \mathcal{O}(\gamma \log n)$  by (4.3), and so it suffices to prove the estimate for  $Y$ . For  $Y$ , we have

$$\begin{aligned} \mathbb{E}[F(Y)] &= \int_{\mathbb{R}} \hat{F}(\lambda) \mathbb{E} e^{i\lambda Y} d\lambda = \int_{|\lambda| \leq n^{1/100}} \hat{F}(\lambda) \mathbb{E} e^{i\lambda Y} d\lambda + \mathcal{O}(n^{-2}) \\ &= \int_{|\lambda| \leq n^{1/100}} \hat{F}(\lambda) e^{-\frac{\lambda^2}{2} V(f)} d\lambda + \mathcal{O}(n^{-1/5}) \\ &= \int_{\mathbb{R}} \hat{F}(\lambda) e^{-\frac{\lambda^2}{2} V(f)} d\lambda + \mathcal{O}(n^{-1/5}). \end{aligned} \quad (4.6)$$

The first and third lines use (4.5) as this estimate implies,

$$\int_{|\lambda| > n^{1/100}} |\hat{F}(\lambda)| \left( \left| \mathbb{E}[e^{i\lambda Y}] \right| + e^{-\frac{\lambda^2}{2} V(f)} \right) d\lambda \leq n^{-2}, \quad (4.7)$$

where we used the fact that  $V(f) \geq 0$  by (4.3). The second line of (4.6) is a direct application of (4.2) using that  $\gamma$  is so small that  $n^{200\gamma-1/4} \leq n^{-1/5}$ . The integral in the last line of (4.6) equals  $\mathbb{E}[F(Z)]$  for a centered Gaussian random variable with variance  $V(f) \asymp \gamma \log n$ . In particular,

$$\mathbb{P}[|Y| > C_1 \gamma \log n + 1] \leq \mathbb{E}[(1 - F)(Y)] = \mathbb{E}[(1 - F)(Z)] + \mathcal{O}(n^{-1/5}). \quad (4.8)$$

On the other hand,

$$|\mathbb{E}[(1 - F)(Z)]| \leq \mathbb{P}[|Z| > C_1 \gamma \log n] \leq n^{-10\gamma} \quad (4.9)$$

if  $C_1$  is taken sufficiently large. Above, the first inequality follows because  $F(x) = 1$  for  $|x| \leq C_1 \gamma \log n$ . This yields the claim.  $\square$

**Lemma 4.4.** *Let  $\delta > 0, \varepsilon > 0$  and  $C_* > 0$ . Let  $\eta_1 \leq \eta_2$  satisfy  $\frac{\log(n)^{1/2+\delta}}{n} \leq \eta_1 \leq n^{-\varepsilon}$  and  $\eta_2 \leq (\log n)^{C_*} \eta_1$ . We have with overwhelming probability that,*

$$\sup_{\eta \in [\eta_1, \eta_2]} |\Psi_n(z, \eta) - \Psi_n(z, \eta_2)| \leq (\log n)^{1/2+\delta}. \quad (4.10)$$

**Proof.** In the complex i.i.d. case we have,

$$\Psi_n(z, \eta) - \Psi_n(z, \eta_2) = 2n \int_{\eta}^{\eta_2} \text{Im}(G^z(iu) - M^z(iu)) du. \quad (4.11)$$

By Lemma 3.2, the integral on the RHS is  $\mathcal{O}((\log n)^{1/2+\delta/2})$  with overwhelming probability.

In the real  $\beta = 1$  case, there is an additional term in (2.21) that is bounded by,

$$|\log(|z - \bar{z}|^2 + \eta) - \log(|z - \bar{z}|^2 + \eta_2)| \leq C \int_{\eta_1}^{\eta_2} \frac{1}{u} du \leq C \log \log n. \quad (4.12)$$

The claim now follows.  $\square$

**Proof of Proposition 4.1.** Recall  $\eta_* = n^{-\gamma}$ . By Lemma 4.4 it suffices to bound the max over  $z$  with  $\eta = \eta_*$  fixed. For an  $\varepsilon_1 > 0$  we fix a set  $P_1$  of  $n^{\gamma+\varepsilon_1}$ -well spaced points of the disc  $\{z : |z| < r\}$ . From Proposition 2.5 we have that

$$\max_{|z| < r} \Psi_n(z, \eta_*) = \max_{z \in P_1} \Psi_n(z, \eta_*) + \mathcal{O}(n^{-\varepsilon_1/2}) \quad (4.13)$$

with overwhelming probability. The claim now follows from a union bound, Lemma 4.3 and taking  $\varepsilon_1 > 0$  sufficiently small in terms of  $\gamma$ .  $\square$

## 5 Upper bound of $\Psi_n(z)$ for complex i.i.d. matrices with Gaussian component

In this section we will prove the upper bound for complex i.i.d. matrices with a Gaussian component. The degree of precision in our upper bound will depend on the size of the Gaussian component.

**Proposition 5.1.** *Let  $0 < r < 1$ . There are constants  $c_1, C_1 > 0$  so that the following holds. Let  $\varepsilon > 0$ , and let  $X$  be a complex i.i.d. matrix with Gaussian component of size  $T = n^{-\varepsilon}$ . Then, for  $n$  sufficiently large, we have*

$$\mathbb{P} \left[ \max_{|z| < r} \Psi_n(z, n^{-1}) \geq (\sqrt{2} + C_1 \varepsilon) \log n \right] \leq n^{-c_1 \varepsilon}. \quad (5.1)$$

The proof of the above appears below in Section 5.2. We realize the matrix  $X$  as the solution at time  $T$  of the flow,

$$dX_t = \frac{dB_t}{\sqrt{n}}, \quad X_0 = (1 - T)^{1/2} Y \quad (5.2)$$

with  $B_t$  being a matrix of i.i.d. standard complex Brownian motions, and  $Y$  being a complex i.i.d matrix as in Definition 2.1. With this scaling the entries of  $X_T$  have variance  $1/n$ .

Let  $H_t^z = H^z(X_t)$  be the Hermitization of  $X_t - z$  defined as in (2.9) with  $X$  replaced with  $X_t$ , and define its resolvent by  $G_t^z(w) := (H_t^z - w)^{-1}$ , with  $w \in \mathbb{C} \setminus \mathbb{R}$ . By simple second order

perturbation theory and the Itô lemma (see e.g. [51, Eq. (5.8)], [37, Appendix B]), one can see that the eigenvalues of  $H_t^z$ , denoted by  $\lambda_i^z = \lambda_i^z(t)$ , are the solution of

$$d\lambda_i^z = \frac{db_i^z}{\sqrt{2n}} + \frac{1}{2n} \sum_{j \neq i} \frac{1}{\lambda_i^z - \lambda_j^z} dt, \quad (5.3)$$

with  $b_{-i}^z = -b_i^z$  and  $\lambda_{-i}^z = -\lambda_i^z$  as a consequence of the chiral symmetry of  $H_t^z$ . Here,  $b_i^z = b_i^z(t)$ , with  $i \in [n]$ , is a family of independent standard Brownian motions. Let  $c_*(t) := \sqrt{1 + (t - T)}$ . Since  $X_t$  is a rescaling of an i.i.d. matrix, the limiting Stieltjes transform for  $H_t^z$ , denoted by  $m_t^z$ , is found by rescaling the function in (2.13) as,

$$m_t^z(w) := \frac{1}{c_*(t)} m^{z/c_*(t)}(w/c_*(t)). \quad (5.4)$$

We denote  $\rho_t^z$  to be the measure associated to  $m_t^z(w)$ . With this definition we see that,

$$\partial_t m_t^z(w) = m_t^z(w) \partial_w m_t^z(w). \quad (5.5)$$

We now consider the evolution of  $\sum_i \log(\lambda_i - w_t)$  along the characteristics of the above equation,

$$\partial_t w_t = -m_t^{z_t}(w_t), \quad z_t = z_0, \quad (5.6)$$

i.e., unlike in Section 3.1, we now move only  $w_t$  and not  $z_t$ . We point out that, by standard ODE theory, if we fix  $w \in \mathbb{C}, T > 0$ , then there exists  $w_0$  such that  $|\operatorname{Im} w_0| \asymp T$  and the solution  $w_t$  of (5.6), with initial condition  $w_0$ , is such that  $w_T = w$ . In this section we will only consider characteristics of the form  $w_s = i\eta_s$ , and we use this notation extensively. Note that  $-\partial_s \eta_s \asymp 1$ .

**Lemma 5.2.** *Let  $\lambda_i^z(t)$  be the eigenvalues of  $H_t^z$ . Let  $\xi > 0$  and let  $T = n^{-\xi}$ . Consider a characteristic  $w_s = i\eta_s$  such that  $\eta_T = (\log n)^{C_*}/n$ , for some  $C_* \geq 10$ . We have with overwhelming probability that,*

$$\begin{aligned} & \sum_i \log(\lambda_i^z(T) - w_T) - 2n \int_{\mathbb{R}} \log(x - w_T) \rho_T^z(x) \\ &= \sum_i \log(\lambda_i^z(0) - w_0) - 2n \int_{\mathbb{R}} \log(x - w_0) \rho_0^z(x) dx + \xi_{n,T} + \mathcal{O}\left(\frac{(\log n)^5}{n|\eta_T|}\right), \end{aligned} \quad (5.7)$$

for a complex Gaussian random variable  $\xi_{n,T}$ . Furthermore, we have,

$$\operatorname{Var}(\operatorname{Re} \xi_{n,T}) = \log |\eta_0/\eta_T| + \mathcal{O}\left(T + \frac{\log n}{n|\eta_T|}\right). \quad (5.8)$$

The proof of the above lemma appears below in Section 5.1. Recall now our three-parameter version of  $\Psi_n(z, t, \eta)$  given by (2.21). The above quickly implies the following.

**Proposition 5.3.** *Let  $\{X_t\}_{0 \leq t \leq T}$  be as in (5.2), let  $\eta_1 = (\log n)^{C_*}/n$ , and let  $T = \eta_2 = n^{-\gamma}$  for some  $\gamma < 1/10$ . There is a  $c > 0$  so that the following holds. Let  $0 < r < 1$  and  $\varepsilon > 0$ . Then,*

$$\max_{|z| \leq r} \Psi_n(z, T, \eta_1) \leq \max_{|z| \leq r, (\log n)^{-1} \eta_2 \leq \eta \leq \eta_2 \log n} \Psi_n(z, 0, \eta) + \left(\sqrt{2} + \varepsilon\right) \log n. \quad (5.9)$$

with probability at least  $1 - n^{-c\varepsilon}$ , for all  $n$  sufficiently large.

**Proof.** Let  $P_1$  be a grid of  $n^{1+\varepsilon}$  well-spaced points of  $\{z : |z| < r\}$ . By Proposition 2.5 we have that,

$$\max_{|z|<r} \Psi_n(z, T, \eta_1) = \max_{z \in P_1} \Psi_n(z, T, \eta_1) + \mathcal{O}(n^{-\varepsilon/2}) \quad (5.10)$$

with overwhelming probability. For any  $z \in P_1$  we consider the characteristic  $w_t = i\eta_t$  with  $\eta_T = \eta_1$ . Then  $\eta_0 \asymp T$ . Let  $Y_z = \text{Re}[\xi_{n,T}]$  where  $\xi_{n,T}$  is the Gaussian random variable from Lemma 5.2. We therefore have,

$$\max_{z \in P_1} \Psi(z, \eta_1, T) \leq \max_{|z|<r, (\log n)^{-1}\eta_2 \leq \eta \leq \eta_2 \log n} \Psi_n(z, \eta, 0) + \max_{z \in P_1} Y_z + \mathcal{O}(1) \quad (5.11)$$

with overwhelming probability. But since the variance of each  $Y_z$  is bounded by  $\log n + C$  we see that by a union bound,

$$\mathbb{P} \left[ \max_{z \in P_1} Y_z > \left( \sqrt{2} + 10\varepsilon \right) \log n \right] \leq n^{-\varepsilon}. \quad (5.12)$$

for all  $n$  sufficiently large. The claim now follows.  $\square$

## 5.1 Proof of Lemma 5.2

Let  $w_t = i\eta_t$  be as in the statement of the lemma. We compute,

$$d \sum_i \log(\lambda_i^z - w) = \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z - w} + \frac{1}{2n} \sum_{j \neq i} \frac{1}{(\lambda_i^z - w)(\lambda_i^z - \lambda_j^z)} dt - \frac{1}{4n} \sum_i \frac{1}{(\lambda_i^z - w)^2} dt. \quad (5.13)$$

Symmetrizing the  $i, j$ -summation, we get

$$d \sum_i \log(\lambda_i^z - w) = \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z - w} - \frac{1}{4n} \left( \sum_i \frac{1}{\lambda_i^z - w} \right)^2 dt. \quad (5.14)$$

Note that along the characteristics (5.6) we have  $\partial_t m_t(w_t) = 0$ . We thus obtain

$$d \sum_i \log(\lambda_i^z - w_t) = \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z - w_t} - \sum_i \frac{1}{\lambda_i^z - w_t} \left( \frac{1}{4n} \sum_i \frac{1}{\lambda_i^z - w_t} - m_t^z(w_t) \right) dt. \quad (5.15)$$

Then, subtracting the deterministic approximation in the LHS of (5.15), we get

$$\begin{aligned} d \left[ \sum_i \log(\lambda_i^z - w_t) - 2n \int_{\mathbb{R}} \log(x - w_t) \rho_t^z(x) dx \right] &= \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z - w_t} - n [\langle G_t^z(w_t) \rangle - m_t^z(w_t)]^2 dt \\ &\quad - 2n \int_{\mathbb{R}} \log(x - w_t) \partial_t \rho_t^z(x) dx - n m_t(w_t)^2. \end{aligned} \quad (5.16)$$

We now show that the last line of (5.16) is equal to zero. By (5.5) we have that  $\pi \partial_t \rho_t(x) = \partial_x \text{Im}[m_t(x)^2]/2$ . Then, using integration by parts, we have

$$\begin{aligned} -2 \int_{\mathbb{R}} \log(x - w_t) \partial_t \rho_t^z(x) dx &= \frac{1}{\pi} \int_{\mathbb{R}} \frac{\text{Im}[m_t(x)^2]}{x - w_t} dx \\ &= \frac{1}{2\pi i} \int_{\mathbb{R}} \left[ \frac{m_t(x)^2}{x - w_t} - \frac{\overline{m_t(x)^2}}{x - w_t} \right] dx = m_t(w_t)^2, \end{aligned} \quad (5.17)$$

where in the last equality we used residue theorem together with  $\text{Im } w_t > 0$  (which makes the integral with  $\overline{m}_t(x)$  equal to zero). This shows that the last line in (5.16) is equal to zero and so,

$$d \left[ \sum_i \log(\lambda_i^z - w_t) - 2n \int_{\mathbb{R}} \log(x - w_t) \rho_t^z(x) dx \right] = \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z - w_t} - n [\langle G_t^z(w_t) \rangle - m_t^z(w_t)]^2 dt. \quad (5.18)$$

We rewrite the martingale term in (5.18) as

$$\frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z(t) - w_t} = \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\gamma_i^z(t) - w_t} + \left( \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\lambda_i^z(t) - w_t} - \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z}{\gamma_i^z(t) - w_t} \right) \quad (5.19)$$

Here,  $\gamma_i^z(t)$  are the  $n$ -quantiles of the measure  $\rho_t^z$  (see e.g. the definition in (2.14)). We now bound the quadratic variation of the second term. With  $c = (100)^{-1}$ , using the rigidity estimates in (3.5) for  $|i| \leq n^{1-c}$  and the estimates (2.19) for the other terms, we have,

$$\begin{aligned} \int_0^T \frac{1}{n} \sum_i \left| \frac{1}{\lambda_i^z(t) - w_t} - \frac{1}{\gamma_i^z(t) - w_t} \right|^2 dt &\leq C \int_0^T \frac{1}{n} \sum_{|i| < n^{1-c}} \frac{|\lambda_i^z(t) - \gamma_i^z(t)|^2}{|\gamma_i^z(t) - w_t|^4} dt + n^{-3/2} \\ &\leq C \int_0^T \frac{(\log n)^4}{n^3} \sum_{|i| < n^{1-c}} \frac{1}{|\gamma_i^z(t) - w_t|^4} dt + n^{-3/2} \quad (5.20) \\ &\leq C \int_0^T \frac{(\log n)^4}{n^2 \eta_t^3} dt + n^{-3/2} \leq C \frac{(\log n)^4}{(n \eta_T)^2} \end{aligned}$$

with overwhelming probability. Therefore, by the Burkholder-Davis-Gundy (BDG) inequality,

$$\sup_{0 \leq t \leq T} \left| \int_0^t \left[ \frac{1}{\sqrt{2n}} \sum_i \frac{db_i(t)}{\lambda_i - w} - \frac{1}{\sqrt{2n}} \sum_i \frac{db_i(t)}{\gamma_i - w} \right] \right| \lesssim \frac{(\log n)^5}{n \eta_T} \quad (5.21)$$

with overwhelming probability.

Applying the local law (3.2) to the second term in (5.16) we have,

$$n \int_0^T [\langle G^z(w_s) \rangle - m^z(w_s)]^2 ds = \mathcal{O} \left( \frac{(\log n)^4}{n \eta_T} \right) \quad (5.22)$$

with overwhelming probability. Therefore, we conclude,

$$\Psi_n(z, T, \eta_T) - \Psi_n(z, 0, \eta_0) = \frac{1}{\sqrt{2n}} \int_0^T \sum_i \frac{db_i(t)}{\gamma_i^z(t) - w_t} + \mathcal{O} \left( \frac{(\log n)^5}{n \eta_T} \right), \quad (5.23)$$

with overwhelming probability. This proves (5.7), after defining,

$$\xi_n := \frac{1}{\sqrt{2n}} \int_0^T \sum_i \frac{db_i(t)}{\gamma_i - w_t}. \quad (5.24)$$

We now compute the variance of the real part of  $\xi_n$ ,

$$\begin{aligned} \text{Var}(\text{Re } \xi_n) &= \frac{1}{n} \int_0^T \sum_i \frac{(\gamma_i^z(t))^2}{|\gamma_i^z(t) - i\eta_t|^4} dt = \frac{1}{2n} \int_0^T \sum_i \frac{1}{|\gamma_i^z(t) - i\eta_t|^2} dt + \text{Re} \frac{1}{2n} \int_0^T \sum_i \frac{1}{(\gamma_i^z(t) - i\eta_t)^2} dt \\ &= \int_0^T \frac{\text{Im } m_t^z(i\eta_t)}{\eta_t} dt + \mathcal{O} \left( T + \frac{\log n}{n \eta_T} \right) = - \int_0^T \frac{1}{\eta_t} d\eta_t + \mathcal{O} \left( T + \frac{\log n}{n \eta_T} \right) \\ &= \log \left( \frac{\eta_0}{\eta_T} \right) + \mathcal{O} \left( T + \frac{\log n}{n \eta_T} \right) \end{aligned} \quad (5.25)$$

In the third equality we replaced the sum over the quantiles with an integral against  $\rho^z(x)$ , at the price of a negligible error, and used the fact that  $\partial_w m_t^z(w)$  is bounded near the imaginary axis. This completes the proof.  $\square$

## 5.2 Proof of Proposition 5.1

Before proving Proposition 5.1 we first prove the following preliminary lemma.

**Lemma 5.4.** *For both real or complex i.i.d. matrices the following holds. For any  $C_* \geq 1$  and any  $\delta > 0$  it holds that with overwhelming probability,*

$$\Psi_n(z, n^{-1}) \leq \Psi_n(z, (\log n)^{C_*} n^{-1}) + (\log n)^{1/2+\delta}. \quad (5.26)$$

**Proof.** We first consider the complex  $\beta = 2$  case. For any  $\eta_1 < \eta_2$  we have that,

$$|\Psi_n(z, \eta_2) - \Psi_n(z, \eta_1)| \leq \int_{\eta_1}^{\eta_2} n |\operatorname{Im}\langle G^z(i\eta) - M^z(i\eta) \rangle| d\eta. \quad (5.27)$$

We first apply this with  $\eta_1 = n^{-1}$  and  $\eta_2 = (\log n)^{1/2+\delta} n^{-1}$ . Since  $y \rightarrow y \operatorname{Im}\langle G(iy) \rangle$  is an increasing function, we see that, by applying (3.2) at  $\eta = \eta_2$ , we have with overwhelming probability,

$$\int_{n^{-1}}^{(\log n)^{1/2+\delta} n^{-1}} n |\operatorname{Im}\langle G^z(i\eta) - M^z(i\eta) \rangle| d\eta \leq (\log n)^{1/2+\delta} \int_{n^{-1}}^{(\log n)^{1/2+\delta} n^{-1}} C \eta^{-1} d\eta \leq C (\log n)^{1/2+2\delta}. \quad (5.28)$$

Then, applying (5.27) with  $\eta_1 = (\log n)^{1/2+\delta} n^{-1}$  and  $\eta_2 = (\log n)^{C_*} n^{-1}$  and using (3.2) we have,

$$\int_{(\log n)^{1/2+\delta} n^{-1}}^{n^{-1} (\log n)^{C_*}} n |\operatorname{Im}\langle G^z(i\eta) - M^z(i\eta) \rangle| d\eta \leq (\log n)^{1/2+\delta} \int_{(\log n)^{1/2+\delta} n^{-1}}^{n^{-1} (\log n)^{C_*}} \eta^{-1} d\eta \leq (\log n)^{1/2+2\delta} \quad (5.29)$$

and the claim follows in the complex case. In the real case, there is an additional deterministic term which is bounded by  $C \log \log n$  using the exact same argument as in (4.12).  $\square$

**Proof of Proposition 5.1.** Lemma 5.4 reduces this to proving the upper bound at  $\eta = (\log n)^{C_*} / n$ . The upper bound for this quantity is then an immediate consequence of Proposition 5.3, with  $\gamma = \varepsilon$ , and Proposition 4.1.  $\square$

## 6 Upper bound in the GDE real case

In this section we prove the upper bounds of Theorem 2.3 for real i.i.d. matrices having an almost order one Gaussian component. The following is the analog of Proposition 5.1.

**Proposition 6.1.** *Let  $0 < r < 1$ . There are constants  $C_1, c_1 > 0$  so that the following holds. Let  $\varepsilon > 0$  and let  $X_T$  be a real i.i.d. GDE matrix with Gaussian component of size at least  $T = n^{-\varepsilon}$ . Then,*

$$\mathbb{P} \left[ \max_{|z| \leq r} \Psi_n(z, n^{-1}) \geq \left( \sqrt{2} + C_1 \varepsilon \right) \log n \right] \leq n^{-c_1 \varepsilon} \quad (6.1)$$

for  $n$  sufficiently large.

We let  $X_t$  solve (5.2), but now  $B_t$  is a matrix of i.i.d. standard real Brownian motions, and  $X = (1 - T)^{1/2}Y$  for a real i.i.d. matrix  $Y$ . We continue to denote  $H_t^z$  the Hermitization of  $X_t - z$ , and use the notation  $m_t^z(w)$ , etc., as defined at the beginning of Section 5. We also recall our three parameter function  $\Psi_n(z, t, \eta)$  as in (2.21), which now has the additional deterministic term compared to the complex case.

The first step in Section 5 for the complex case was to write the log-determinant on small scales as the one on (almost) global scales plus a Gaussian term using the characteristics method (see Lemma 5.2). We now replace this step with the following lemma. Notice that compared to (5.7) we now write (6.2) for all intermediate mesoscopic scales; this will be useful in the analysis of Section 6.4 below.

**Lemma 6.2.** *Let  $\lambda_i^z(t)$  be the eigenvalues of  $H_t^z$ . Let  $\xi, \varepsilon_1, \varepsilon_2 > 0$  be sufficiently small. Let  $T = n^{-\varepsilon_1}$ . Consider a characteristic  $w_s = i\eta_s$  such that  $\eta_T \geq n^{\varepsilon_2 - 1}$ . Let  $S_1, S_2$  satisfy  $0 \leq S_1 < S_2 \leq T$ . Then, uniformly in  $S_1, S_2$  we have, with overwhelming probability,*

$$\begin{aligned} & \sum_i \log(\lambda_i^z(S_2) - w_{S_2}) - 2n \int_{\mathbb{R}} \log(x - w_{S_2}) \rho_{S_2}^z(x) - E_n(S_1, S_2) \\ &= \sum_i \log(\lambda_i^z(S_1) - w_{S_1}) - 2n \int_{\mathbb{R}} \log(x - w_{S_1}) \rho_{S_1}^z(x) + \xi_n(S_1, S_2) + \mathcal{O}\left(\frac{n^\xi}{n\eta_{S_2}}\right) \end{aligned} \quad (6.2)$$

where for fixed  $S_1$ , the process  $\{\xi_n(S_1, S_2)\}_{S_2 \in [S_1, T]}$  is a complex martingale, and

$$E_n(S_1, S_2) = \frac{1}{2} \log \left( \frac{|z - \bar{z}|^2 + 2\eta_{S_1} \sqrt{1 - |z|^2}}{|z - \bar{z}|^2 + 2\eta_{S_2} \sqrt{1 - |z|^2}} \right) + \mathcal{O}(S_2 \log n). \quad (6.3)$$

Furthermore, there exists a coupling such that with overwhelming probability we have for all  $s$  satisfying  $S_1 \leq s \leq T$  that

$$\operatorname{Re}[\xi_n(S_1, s)] = \int_{S_1}^s V_u^{1/2} d\tilde{b}_u + \mathcal{O}\left(\frac{n^\xi}{\sqrt{n\eta_s}}\right), \quad (6.4)$$

for a standard Brownian motion  $\tilde{b}_u$  and some explicit deterministic  $V_u$  such that

$$\int_{S_1}^s V_u du = \log\left(\frac{\eta_s}{\eta_{S_1}}\right) + \log\left(\frac{|z - \bar{z}|^2 + 2\eta_{S_1} \sqrt{1 - |z|^2}}{|z - \bar{z}|^2 + 2\eta_s \sqrt{1 - |z|^2}}\right) + \mathcal{O}\left(S_2 \log n + \frac{\log n}{n\eta_s}\right). \quad (6.5)$$

**Proof.** Some parts of this proof are similar to the proof of Lemma 5.2, and for this reason we focus on the main differences.

By Proposition 7.6 and Appendix B of [35] the eigenvalues  $\lambda_i^z(t)$  of  $H_t^z$  are the unique strong solution of

$$d\lambda_i^z(t) = \frac{db_i^z(t)}{\sqrt{2n}} + \frac{1}{2n} \sum_{j \neq i} \frac{1 + \Lambda_{ij}^z(t)}{\lambda_j^z(t) - \lambda_i^z(t)} dt. \quad (6.6)$$

The driving martingales  $b_i^z(t)$  have the following covariation process

$$d[b_i^z(t), b_j^z(t)] = [\delta_{ij} - \delta_{i,-j} + \Lambda_{ij}^z(t)] dt, \quad \Lambda_{ij}^z(t) := 4 \operatorname{Re} [\langle \mathbf{w}_i^z(t), E_1 \mathbf{w}_j^{\bar{z}}(t) \rangle \langle \mathbf{w}_j^{\bar{z}}(t), E_2 \mathbf{w}_i^z(t) \rangle]. \quad (6.7)$$

Here  $\{\mathbf{w}_i^z(t)\}_i$  denote the eigenvectors of the Hermitization of  $X_t - z$ . Note that  $\Lambda_{ij}^z(t) = \Lambda_{ji}^{\bar{z}}(t)$ . We also point out that if  $z \in \mathbb{R}$ , then  $\Lambda_{i,j}^z(t) = 0$ , for  $j \neq \pm i$ , and  $\Lambda_{i,\pm i}^z(t) = \pm 1$ , i.e. for  $z \in \mathbb{R}$  there is no repulsion from zero in (6.6).

Proceeding similarly to (5.13)–(5.23), using (6.6) instead of (5.3), for any  $0 \leq S_1 < S_2 \leq T$ , we obtain

$$\begin{aligned} & \int_{S_1}^{S_2} d \left[ \sum_i \log(\lambda_i^z - w_t) - 2n \int_{\mathbb{R}} \log(x - w_t) \rho_t^z(x) dx \right] \\ &= \frac{1}{\sqrt{2n}} \int_{S_1}^{S_2} \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t} + \tilde{\sum}_{ij} \int_{S_1}^{S_2} \langle G_t^z(w_t) E_i G_t^{\bar{z}}(w_t) E_j \rangle dt + \mathcal{O} \left( \frac{\log n}{n\eta_{S_2}} \right). \end{aligned} \quad (6.8)$$

Here  $\tilde{\sum}_{ij}$  is defined below (1.17), and we recall that it denotes a summation over  $(i, j) \in \{(1, 2), (2, 1)\}$ . Next, we use that by rescaling Corollary B.4 (i.e. the entries have variance  $c_*(t)/n$  instead of  $1/n$ ) we have

$$|\langle (G_t^z(i\eta_t) E_i G_t^{\bar{z}}(i\eta_t) - M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t)) E_j \rangle| \lesssim \frac{n^\xi}{n\eta_t^2}. \quad (6.9)$$

Here for any  $z_1, z_2 \in \mathbb{C}$  and any matrix  $A \in \mathbb{C}^{2n \times 2n}$ , we defined

$$M_t^{z_1, z_2}(i\eta_1, A, i\eta_2) := (1 - c_*(t)^2 M_t^{z_1}(i\eta_1) \mathcal{S}[\cdot] M_t^{z_2}(i\eta_2))^{-1} [M_t^{z_1}(i\eta_1) A_1 M_t^{z_2}(i\eta_2)] \quad (6.10)$$

with the *covariance operator*  $\mathcal{S} : \mathbb{C}^{2n \times 2n} \times \mathbb{C}^{2n \times 2n}$  defined by

$$\mathcal{S}[\cdot] := 2\langle \cdot, E_1 \rangle E_2 + 2\langle \cdot, E_2 \rangle E_1.$$

The constant  $c_*(t)$  is defined below (5.3), and

$$M_t^z(w) := \begin{pmatrix} m_t^z(w) & -zu_t^z(w) \\ -\bar{z}u_t^z(w) & m_t^z(w) \end{pmatrix}, \quad u_t^z(w) := \frac{m_t^z(w)}{w + c_*(t)^2 m_t(w)}. \quad (6.11)$$

By (6.9), we thus get

$$\begin{aligned} & \int_{S_1}^{S_2} d \left[ \sum_i \log(\lambda_i^z - w_t) - 2n \int_{\mathbb{R}} \log(x - w_t) \rho_t^z(x) dx \right] \\ &= \frac{1}{\sqrt{2n}} \int_{S_1}^{S_2} \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t} + \tilde{\sum}_{ij} \int_{S_1}^{S_2} \langle M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t) E_j \rangle dt + \mathcal{O} \left( \frac{n^\xi}{n\eta_{S_2}} \right). \end{aligned} \quad (6.12)$$

To conclude the proof, we need to compute the leading order approximation of the deterministic term in the RHS of (6.12) and write the martingale term (at leading order) as an integral of a rescaled Brownian motion using the martingale representation theorem.

We start with the computation of the deterministic term. By (5.5)–(5.6) it follows that  $m_t^z(w_t)$  and  $u_t^z(w_t)$  are constant in time. Define the short-hand notations  $c_t := c_*(t)^2 = 1 + (t - T)$ ,  $m := m_0(i\eta_0) = m_t(i\eta_t)$ , and  $u := u_0^z(i\eta_0) = u_t^z(i\eta_t)$ . By an explicit computation we obtain

$$\tilde{\sum}_{ij} \int_{S_1}^{S_2} \langle M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t) E_j \rangle dt = \int_{S_1}^{S_2} \frac{c_t u^2 \operatorname{Re}[z^2] - c_t^2 |z|^4 u^4 + c_t^2 m^4}{1 + c_t^2 |z|^4 u^4 - c_t^2 m^4 - 2c_t u^2 \operatorname{Re}[z^2]} dt \quad (6.13)$$

Then, a straightforward but somewhat tedious computation shows that,

$$1 + c_t^2 |z|^4 u^4 - c_t^2 m^4 - 2c_t u^2 \operatorname{Re}[z^2] = (1 + \mathcal{O}(\eta_t)) |z - \bar{z}|^2 + 2\eta_t (1 + \mathcal{O}(\eta_t)) \sqrt{1 - |z|^2} \quad (6.14)$$

using

$$u = 1 - \frac{\eta_T}{\sqrt{1 - |z|^2}} + \mathcal{O}(\eta_T^2), \quad m = i\sqrt{1 - |z|^2} + i\frac{\eta_T(2|z|^2 - 1)}{2(1 - |z|^2)} + \mathcal{O}(\eta_T^2), \quad (6.15)$$

and that  $\eta_t = \eta_T + (T - t) \operatorname{Im} m$ , for any  $0 \leq t \leq T$ . With this, we then have that,

$$\begin{aligned}
& \sum_{ij}^{\sim} \int_{S_1}^{S_2} \langle M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t) E_j \rangle dt \\
&= \int_{S_1}^{S_2} \frac{c_t u^2 \operatorname{Re}[z^2] - c_t^2 |z|^4 u^4 + c_t^2 m^4}{1 + c_t^2 |z|^4 u^4 - c_t^2 m^4 - 2c_t u^2 \operatorname{Re}[z^2]} dt \\
&= -\frac{1}{2} \int_{S_1}^{S_2} \partial_t \log [1 + c_t^2 |z|^4 u^4 - c_t^2 m^4 - 2c_t u^2 \operatorname{Re}[z^2]] dt + \mathcal{O}(S_2 \log n) \\
&= -\frac{1}{2} \log \left[ \frac{1 + c_{S_2}^2 |z|^4 u^4 - c_{S_2}^2 m^4 - 2c_{S_2} u^2 \operatorname{Re}[z^2]}{1 + c_{S_1}^2 |z|^4 u^4 - c_{S_1}^2 m^4 - 2c_{S_1} u^2 \operatorname{Re}[z^2]} \right] + \mathcal{O}(S_2 \log n) \\
&= \frac{1}{2} \log \left( \frac{[1 + \mathcal{O}(\eta_{S_1})] \cdot |z - \bar{z}|^2 + 2\eta_{S_1} \cdot [1 + \mathcal{O}(\eta_{S_1})] \sqrt{1 - |z|^2}}{[1 + \mathcal{O}(\eta_{S_2})] \cdot |z - \bar{z}|^2 + 2\eta_{S_2} \cdot [1 + \mathcal{O}(\eta_{S_2})] \sqrt{1 - |z|^2}} \right) + \mathcal{O}(S_2 \log n) \\
&= \frac{1}{2} \log \left( \frac{|z - \bar{z}|^2 + 2\eta_{S_1} \sqrt{1 - |z|^2}}{|z - \bar{z}|^2 + 2\eta_{S_2} \sqrt{1 - |z|^2}} \right) + \mathcal{O}(S_2 \log n),
\end{aligned} \tag{6.16}$$

This concludes the computation of  $E_n(S_1, S_2)$  in (6.3).

Next, we consider the martingale term in the RHS of (6.12). The martingale  $\xi_n(S_1, s)$  is defined by,

$$\xi_n(S_1, s) := \frac{1}{\sqrt{2n}} \int_{S_1}^s \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t}.$$

We now compute the quadratic variation process of  $\operatorname{Re}[\xi_n(S_1, s)]$ :

$$\begin{aligned}
& d \left[ \operatorname{Re} \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t}, \operatorname{Re} \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t} \right] \\
&= \left[ \frac{1}{n} \sum_i \frac{(\lambda_i^z)^2}{|\lambda_i^z - i\eta_t|^4} + 2 \sum_{ij}^{\sim} \langle \operatorname{Re} G_t^z(i\eta_t) E_i \operatorname{Re} G_t^{\bar{z}}(i\eta_t) E_j \rangle \right] dt \\
&= \left[ \frac{1}{n} \sum_i \frac{(\lambda_i^z)^2}{|\lambda_i^z - i\eta_t|^4} + 2 \sum_{ij}^{\sim} \langle G_t^z(i\eta_t) E_i G_t^{\bar{z}}(i\eta_t) E_j \rangle \right] dt \\
&= \left[ \frac{1}{n} \sum_i \frac{(\gamma_i^z)^2}{|\gamma_i^z - i\eta_t|^4} + 2 \sum_{ij}^{\sim} \langle M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t) E_j \rangle \right] dt + \mathcal{O} \left( \frac{n^\xi}{n\eta_t^2} \right) dt,
\end{aligned} \tag{6.17}$$

where to go from the first to the second line we used that, by the symmetry of the spectrum of  $H^z$ ,  $\operatorname{Im} G^z$  is diagonal,  $\operatorname{Re} G^z$  is off-diagonal, and  $E_i \operatorname{Im} G^z E_j = 0$  for  $i \neq j$ . Additionally, in the last equality we used similar estimates to (5.20) to compute the deterministic approximation of the first term and (6.9) to compute the deterministic approximation of the second term.

Denote

$$V_t := \frac{1}{n} \sum_i \frac{(\gamma_i^z)^2}{|\gamma_i^z - i\eta_t|^4} + 2 \sum_{ij}^{\sim} \langle M_t^{z, \bar{z}}(i\eta_t, E_i, i\eta_t) E_j \rangle \asymp \frac{1}{\eta_t}. \tag{6.18}$$

Here, the estimate follows in a straightforward manner from the computations in (5.25), (6.13) and (6.14). Then, by the martingale representation theorem together with (6.17), we write (after passing to possibly a larger probability space),

$$\operatorname{Re} \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t} = \left[ V_t + \mathcal{O} \left( \frac{n^\xi}{n\eta_t^2} \right) \right]^{1/2} d\tilde{b}_t, \tag{6.19}$$

with  $\tilde{b}_t$  being a standard real Brownian motion. We now define

$$d\mathcal{X}_t := V_t^{1/2} d\tilde{b}_t. \quad (6.20)$$

By the BDG inequality we then have with overwhelming probability,

$$\operatorname{Re} \xi_n(S_1, s) = \operatorname{Re} \frac{1}{\sqrt{2n}} \int_{S_1}^s \sum_i \frac{db_i^z(t)}{\lambda_i^z(t) - w_t} = \int_{S_1}^s d\mathcal{X}_t + \mathcal{O}\left(\frac{n^\xi}{\sqrt{n\eta_s}}\right), \quad (6.21)$$

which shows (6.4) for  $V_t$  being defined as in (6.18). Finally, we conclude the proof noticing that by (5.25) and (6.16) we compute the leading order approximation of the first and second term in the definition of  $V_t$ , respectively, and obtain (6.5).  $\square$

Notice that, unlike in the complex case (cf. Lemma 5.2), the variance of the martingale term in Lemma 6.2 (see (6.4)–(6.5)) depends on the size of  $|z - \bar{z}| = 2|\operatorname{Im} z|$ . For this reason, in the remainder of this section we divided the analysis of  $\Psi_n(z)$  into three regimes according to the size of  $|\operatorname{Im} z|$ . We will first record an estimate that will be useful both here and later in the paper.

## 6.1 Short time increment bound

The following is a sub-optimal estimate controlling the process  $\Psi_n(z, t, \eta_t)$  over short time intervals. It will be mostly used for passing from  $(\log n)^C/n$  scales to  $n^\varepsilon/n$  scales. In the following, we let  $X_s$  solve  $dX_s = dB_s/\sqrt{n}$  where  $B_s$  is a matrix of either complex or real standard Brownian motions, with  $X_0 = (1 - T)^{1/2}Y$  for  $Y$  an i.i.d. matrix, and  $T \leq n^{-c}$  for some  $c > 0$ . If  $B_s$  is complex, we will allow  $Y$  to be either a real or complex i.i.d. matrix. If  $B_s$  is real then we will assume that  $Y$  is real. We let  $\Psi_n(z, s, \eta)$  be as in (2.21) where  $\beta = 1, 2$  corresponds to the real or complex dynamics driving by  $B_s$ , respectively.

**Proposition 6.3.** *There is a  $c_1 > 0$  so that the following holds. Fix  $T$  and  $X_s$  as above, and let  $0 \leq t \leq T$ . Let  $\varepsilon_1 > 0$  be sufficiently small. Let  $\eta_s > 0$  be a characteristic such that  $(\log n)^{10}/n \leq \eta_t \leq n^{-\varepsilon_1}$  and,*

$$\log(\eta_0/\eta_t) \leq \varepsilon_1 \log n. \quad (6.22)$$

Then,

$$\mathbb{P}\left[|\Psi_n(z, t, \eta_t) - \Psi_n(z, 0, \eta_0)| > \varepsilon_1^{1/3} \log n\right] \leq e^{-c_1 \varepsilon_1^{-1/3} \log n} + n^{-100} \quad (6.23)$$

for all  $n$  large enough and  $\varepsilon_1 > 0$  sufficiently small.

**Proof.** We first consider the case of complex dynamics. Integrating (5.18) in time, and applying (3.2) or Proposition 3.9 (for  $Y$  complex or real, respectively) we see that,

$$\Psi_n(z, t, \eta_t) - \Psi_n(z, 0, \eta_0) = \operatorname{Re} \left[ \frac{1}{\sqrt{2n}} \int_0^t \frac{db_i^z(s)}{\lambda_i^z(s) - i\eta_s} \right] + \mathcal{O}((\log n)^{-9}) \quad (6.24)$$

with overwhelming probability. The quadratic variation process of the martingale term is bounded by,

$$\sum_{i=-n}^n \frac{1}{|\lambda_i^z(s) - i\eta_s|^2} ds \leq \frac{\operatorname{Im}\langle G_s(i\eta_s) \rangle}{\eta_s} ds \leq \frac{C}{\eta_s} ds \quad (6.25)$$

again by (3.2) or Lemma 3.9 (in the case of complex or real initial data respectively) with overwhelming probability. Therefore, by the martingale representation theorem (as in (3.20)), we have that

$$\mathbb{P} \left[ \left| \frac{1}{\sqrt{2n}} \int_0^t \frac{db_i^z(s)}{\lambda_i^z(s) - w_s} \right| > (\varepsilon_1)^{1/3} \log n \right] \leq C e^{-c\varepsilon_1^{-1/3} \log n} + n^{-1000} \quad (6.26)$$

with overwhelming probability; this completes the proof in the case of complex dynamics.

In the real case, we first note that the proof of Lemma 6.2 up to and including the estimate (6.8) holds even if we only assume that  $\eta_t \geq (\log n)^{10}/n$ . Then, integrating (6.8), and applying an estimate similar to (4.12) for the deterministic contribution to  $\Psi_n(z, s, \eta_s)$ , we find that,

$$\Psi_n(z, t, \eta_t) - \Psi_n(z, 0, \eta_0) = \operatorname{Re} \left[ \frac{1}{\sqrt{2n}} \int_0^t \frac{db_i^z(s)}{\lambda_i^z(s) - w_s} + \sum_{ij} \int_0^t \langle G_s^z(w_s) E_i G_s^{\bar{z}}(w_s) E_j \rangle ds \right] + \mathcal{O}(\varepsilon_1 \log n), \quad (6.27)$$

with overwhelming probability. By Cauchy-Schwarz and (3.2) we have with overwhelming probability,

$$\left| \int_0^t \langle G_s^z(w_s) E_i G_s^{\bar{z}}(w_s) E_j \rangle ds \right| \leq C \int_0^t \eta_s^{-1} \langle \operatorname{Im}[G_s^z(w_s)] \rangle ds \leq C \varepsilon_1 \log n \quad (6.28)$$

because  $\log(\eta_0/\eta_t) \leq \varepsilon_1 \log n$  by assumption. Similarly, using (3.2) and the computations around (6.17) we see that the quadratic variation process of the Martingale term in (6.27) is bounded by  $C/\eta_s$  with overwhelming probability. The proof is then completed in the same fashion as in the case of complex dynamics above.  $\square$

We now divide the remainder of this section into three parts. In Section 6.2 we prove an upper bound for the (regularized) maximum of the log-characteristic polynomial in the regime  $\operatorname{Im} z > n^{-\varepsilon}$ , for some small fixed  $\varepsilon > 0$ . Then, in Section 6.3 we consider the regime  $\operatorname{Im} z \leq n^{-1/2-\varepsilon}$  and, finally, in Section 6.4 we consider the regime  $\operatorname{Im} z \asymp n^{-\alpha}$  for some intermediate  $\alpha \in (0, 1/2)$ .

## 6.2 Real case: upper bound for $\operatorname{Im}[z] \geq n^{-\varepsilon}$ .

We first prove the upper bound for points  $z$  that have relatively large imaginary part. This proof is almost the same as in the complex i.i.d. case.

**Proposition 6.4.** *There is a  $C_1 > 0$  so that for all sufficiently small  $\varepsilon > 0$  the following holds. Let  $X$  be a real i.i.d. matrix with Gaussian component of size at least  $n^{-\varepsilon}$ . Let  $0 < r < 1$ . Then*

$$\mathbb{P} \left[ \max_{|z| \leq r, \operatorname{Im}[z] \geq n^{-\varepsilon}} \Psi_n(z, n^{-1}) \geq (\sqrt{2} + C_1 \varepsilon) \log n \right] \leq n^{-c\varepsilon} \quad (6.29)$$

**Proof.** The proof of this statement is similar to Proposition 5.1. First, by using Lemma 5.4 and Proposition 2.5, it suffices to bound the maximum over a set of  $n^{1+\varepsilon}$  well-spaced points  $P_1$  of

$$\max_{z \in P_1} \Psi_n(z, T, (\log n)^{C_*}/n) \quad (6.30)$$

for any sufficiently large  $C_* > 0$ , with all  $z \in P_1$  satisfying  $\operatorname{Im}[z] \geq n^{-\varepsilon}$  and  $|z| \leq r$ . For each  $z$  we let  $\eta(s, z)$  be a characteristic ending at  $(\log n)^{C_*}/n$  at time  $s = T$ . Next, letting  $S_2 = T - n^{\varepsilon^3-1}$  we have by Proposition 6.3 that with probability at least  $1 - n^{-10}$  that,

$$\max_{z \in P_1} \Psi_n(z, T, (\log n)^{C_*}/n) \leq \max_{z \in P_1} \Psi_n(z, S_2, \eta(S_2, z)) + C\varepsilon \log n, \quad (6.31)$$

for some constant  $C > 0$ . At this point we can directly apply Lemma 6.2, with  $T = n^{-\varepsilon}$ , in an analogous fashion to the proof of Proposition 5.3 (which uses Lemma 5.2) using (6.4) in place of (5.8). Observe also that the term  $E_n(S_1, S_2)$  in (6.2) equals the deterministic correction in (2.21) up to  $\mathcal{O}(1)$ . We have by estimates (6.2) and (6.4) of Lemma 6.2 that,

$$\begin{aligned} & \mathbb{P} \left[ |\Psi_n(z, S_2, \eta(S_2, z)) - \Psi_n(z, 0, \eta(0, z))| > (\sqrt{2} + C_1\varepsilon) \log n \right] \\ & \leq \mathbb{P} \left[ \left| \int_0^{S_2} (V_u)^{1/2} d\tilde{b}_u \right| > (\sqrt{2} + (C_1 - 1)\varepsilon) \log n \right] + n^{-10} \leq n^{-1-10\varepsilon} \end{aligned} \quad (6.32)$$

if  $C_1 > 0$  is sufficiently large. In the last inequality we used the fact that

$$\int_0^{S_2} V_u du \leq \log n + C\varepsilon \log n \quad (6.33)$$

by our assumption that  $\text{Im}[z] \geq n^{-\varepsilon}$  from (6.5). Therefore, by a union bound over  $P_1$ ,

$$\max_{z \in P_1} \Psi_n(z, S_2, \eta(S_2, z)) \leq \max_{z \in P_1} \Psi_n(z, 0, \eta(0, z)) + (\sqrt{2} + C\varepsilon) \log n \quad (6.34)$$

with probability at least  $1 - n^{-\varepsilon/2}$ , for some sufficiently large  $C > 0$ . Now, the first quantity on the RHS of the above estimate is bounded by Proposition 4.1. This finishes the proof.  $\square$

### 6.3 Real case: upper bound for $\text{Im}[z] \leq n^{-1/2+\varepsilon}$ .

**Proposition 6.5.** *Let  $0 < r < 1$ . There is a  $C_1 > 0$  so that for all sufficiently small  $\varepsilon > 0$ , the following holds. Let  $X$  be a real i.i.d. matrix with Gaussian component of size at least  $n^{-\varepsilon}$ . Then,*

$$\mathbb{P} \left[ \max_{|z| \leq r, \text{Im}[z] \leq n^{\varepsilon-1/2}} \Psi_n(z, n^{-1}) \geq (\sqrt{2} + C_1\varepsilon) \log n \right] \leq n^{-c\varepsilon} \quad (6.35)$$

**Proof.** This proof follows identically to Proposition 6.4 except for the fact that one chooses a grid  $P_1$  of  $n^{1/2+2\varepsilon}$  well-spaced points. Furthermore, the intermediate inequality (6.34) still holds, but this is due to the fact that Gaussian random variable on the RHS of (6.4) has variance of no more than  $(2 + C\varepsilon) \log n$  which is compensated by the fact that we are taking a union bound over only  $n^{1/2+2\varepsilon}$  points.  $\square$

### 6.4 Real case: upper bound for $\text{Im}[z] \approx n^{-\alpha}$ .

The main result of this section is the following:

**Proposition 6.6.** *There is are  $C_1, c_1, c_* > 0$  so that the following holds. Fix  $0 < \alpha < \frac{1}{2}$  and  $\varepsilon > 0$  satisfying  $\varepsilon < c_* \min\{\alpha, 1/2 - \alpha\}$ . Let  $X$  be a real GDE with Gaussian component of size at least  $n^{-\varepsilon}$ . Then,*

$$\mathbb{P} \left[ \max_{|z| < r, n^{-\alpha-\varepsilon} < \text{Im}[z] < n^{-\alpha+\varepsilon}} \Psi_n(z, n^{-1}) > (\sqrt{2} + C_1\varepsilon) \log n \right] \leq n^{-c_1\varepsilon}. \quad (6.36)$$

The proof of this proposition will require a few intermediate results. Let  $T = n^{-\varepsilon}$ , and consider  $X_s$  as above. We consider the characteristic  $\eta(s, z)$  that end at  $\eta(T, z) = (\log n)^{10}/n$ . Fix

$$t_1 := T - n^{-2\alpha}, \quad t_2 := T - n^{-\varepsilon^3-1} \quad (6.37)$$

and decompose

$$\begin{aligned}\Psi_n(z, \eta(T, z), T) &= [\Psi_n(z, \eta(T, z), T) - \Psi_n(z, \eta(t_2, z), t_2)] + [\Psi_n(z, \eta(t_2, z), t_2) - \Psi_n(z, \eta(t_1, z), t_1)] \\ &\quad + [\Psi_n(z, \eta(t_1, z), t_1) - \Psi_n(z, \eta(0, z), 0)] + \Psi_n(z, \eta(0, z), 0) \\ &=: F(z) + X_2(z) + X_1(z) + Y(z)\end{aligned}\tag{6.38}$$

First,  $Y(z)$  is an initial step that is very small and so can be neglected by Proposition 4.1, using the fact that  $\eta(0, z) \asymp t_f$ . Similarly,  $F(z)$  is a short time increment and can be neglected by Proposition 6.3. The component  $X_1(z)$  is then the part of the random walk bringing us down to the intermediate scale  $\eta \approx n^{-2\alpha}$ , and then  $X_2(z)$  goes down to the microscopic scales. As will be seen below, the equation (6.5) implies that the quadratic variation process of the main Gaussian contributions to  $X_1(z)$  and  $X_2(z)$  behave differently.

We now control the maximum of  $X_1(z)$  by a union bound, and then use this a priori information as an input to give an upper bound on  $X_1(z) + X_2(z)$ . This part of the argument is inspired by [55].

**Lemma 6.7.** *There exists  $C_1, c_1 > 0$  so that for all  $\varepsilon > 0$  sufficiently small,*

$$\mathbb{P} \left[ \max_{|z| \leq r, n^{-\varepsilon-\alpha} \leq \text{Im}[z] \leq n^{\varepsilon-\alpha}} |X_1(z)| > (2\sqrt{2}\alpha + C_1\varepsilon) \log n \right] \leq n^{-c_1\varepsilon}\tag{6.39}$$

**Proof.** The proof will be by a union bound. First we have by definition,  $\eta(t_1, z) \asymp n^{-2\alpha}$  and that  $\eta(t_1, z) \leq \eta(0, z) \leq n^{-\varepsilon}$ . Therefore by Lemma 4.4 and Proposition 2.5, the max of  $X_1(z)$  over the set  $\mathcal{E} := \{z : |z| < r, n^{-\alpha-\varepsilon} < \text{Im}[z] < n^{-\alpha+\varepsilon}\}$  is approximated by the max over a subset of  $\mathcal{E}$  points of cardinality at most  $n^{\alpha+3\varepsilon}$ , up to an error of size  $\mathcal{O}((\log n)^{3/4})$ , with overwhelming probability. We denote this subset of points by  $P_1$ .

For each  $z \in P_1$  the estimates of Lemma 6.2 imply that

$$\mathbb{P} \left[ |X_1(z)| > (2\sqrt{2}\alpha + C_1\varepsilon) \log n \right] \leq \mathbb{P} \left[ |Z_1(z)| > (2\sqrt{2}\alpha + (C_1 - 1)\varepsilon) \log n \right] + n^{-10}\tag{6.40}$$

where  $Z_1(z)$  is a centered Gaussian random variable with variance bounded by  $(4\alpha + C\varepsilon) \log n$ . Then for  $C_1$  sufficiently large we have,

$$\mathbb{P} \left[ |Z_1(z)| > (2\sqrt{2}\alpha + (C_1 - 1)\varepsilon) \log n \right] \leq n^{-\alpha-10\varepsilon}\tag{6.41}$$

for all  $\varepsilon > 0$  sufficiently small. This yields the claim.  $\square$

Using Lemma 6.7, we now obtain the desired bound on  $X_1(z) + X_2(z)$ :

**Lemma 6.8.** *There exists  $C_2, c_2, c_* > 0$  so that the following holds. Let  $P$  be a set of  $n^{1-\alpha+2\varepsilon}$  well-spaced points of the strip  $\{z : n^{-\varepsilon-\alpha} < \text{Im}[z] < n^{\varepsilon-\alpha}, |z| \leq r\}$ . For all  $\varepsilon > 0$  satisfying  $\varepsilon < c_* \min\{\alpha, (1 - 2\alpha)\}$  we have that for  $n$  sufficiently large,*

$$\mathbb{P} \left[ \exists z \in P : X_1(z) + X_2(z) > (\sqrt{2} + C_2\varepsilon) \log n \right] \leq n^{-c_2\varepsilon}\tag{6.42}$$

**Proof.** We have by (6.39) and a union bound that,

$$\begin{aligned}&\mathbb{P} \left[ \exists z \in P : X_1(z) + X_2(z) > (\sqrt{2} + C_2\varepsilon) \log n \right] \\ &\leq \mathbb{P} \left[ \left\{ \exists z \in P : X_1(z) + X_2(z) > (\sqrt{2} + C_2\varepsilon) \log n \right\} \cap \left\{ \max_{z \in P} |X_1(z)| \leq (2\sqrt{2}\alpha + C_1\varepsilon) \log n \right\} \right] + n^{-c_1\varepsilon}\end{aligned}$$

$$\leq \sum_{z \in P} \mathbb{P} \left[ \{X_1(z) + X_2(z) > (\sqrt{2} + C_2\varepsilon) \log n\} \cap \{|X_1(z)| \leq (2\sqrt{2}\alpha + C_1\varepsilon) \log n\} \right] + n^{-c_1\varepsilon}. \quad (6.43)$$

Note that we can take  $C_1 > 0$  larger if necessary and the above estimate still holds. By applying Lemma 6.2 twice, once to  $X_1(z)$  and once to  $X_1(z) + X_2(z)$  we see that with overwhelming probability,

$$X_1(z) = Z_1(z) + \mathcal{O}(1), \quad X_2(z) = Z_2(z) + \mathcal{O}(1) \quad (6.44)$$

where  $Z_1(z)$  and  $Z_2(z)$  are centered independent Gaussian random variables, by passing to possibly a larger probability space. As long as  $\varepsilon > 0$  is sufficiently small depending on  $\alpha > 0$  we see that,

$$4\alpha \log n \asymp \text{Var}(Z_1(z)) \leq (4\alpha + C_*\varepsilon) \log n, \quad (1 - 2\alpha) \log n \asymp \text{Var}(Z_2(z)) \leq (1 - 2\alpha + C_*\varepsilon) \log n \quad (6.45)$$

for some  $C_* > 0$  that will be fixed until the end of the proof. Assuming that  $C_2 \geq C_1$ , we have that the probability in the sum on the last line of (6.43) is bounded by (in the second line we write  $Z_i = Z_i(z)$ )

$$\begin{aligned} & \mathbb{P} \left[ \{Z_1(z) + Z_2(z) > (\sqrt{2} + C_2\varepsilon) \log n\} \cap \{|Z_1(z)| \leq (2\sqrt{2}\alpha + C_1\varepsilon) \log n\} \right] \\ &= \int_0^\infty \mathbb{P} \left[ Z_2 > x + (\sqrt{2}(1 - 2\alpha) + (C_2 - C_1)\varepsilon) \log n \right] \mathbb{P} \left[ Z_1 = (2\sqrt{2}\alpha + C_1\varepsilon) \log n - x \right] dx \\ &\leq n^\varepsilon \int_0^\infty \exp \left( -\frac{(x + (\sqrt{2}(1 - 2\alpha) + (C_2 - C_1)\varepsilon) \log n)^2}{(2(1 - 2\alpha) + C_*\varepsilon) \log n} - \frac{((2\sqrt{2}\alpha + C_1\varepsilon) \log n - x)^2}{(8\alpha + C_*\varepsilon) \log n} \right) dx \\ &\leq n^\varepsilon \exp \left( -\log n \left( \frac{2(1 - 2\alpha)^2 + (1 - 2\alpha)(C_2 - C_1)\varepsilon}{2(1 - 2\alpha) + C_*\varepsilon} + \frac{8\alpha^2 + C_1\alpha\varepsilon}{8\alpha + C_*\varepsilon} \right) \right) \\ &\quad \times \int_0^\infty \exp \left( -x \left( \frac{2^{3/2}(1 - 2\alpha)}{2(1 - 2\alpha) + C_*\varepsilon} - \frac{4\sqrt{2}\alpha}{8\alpha + C_*\varepsilon} - \frac{2C_1\varepsilon}{8\alpha + C_*\varepsilon} \right) \right) dx \end{aligned} \quad (6.46)$$

As long as  $\varepsilon > 0$  satisfies  $\varepsilon < (C_*)^{-1} \min\{1 - 2\alpha, \alpha\}$  we see that

$$\frac{2(1 - 2\alpha)^2 + (1 - 2\alpha)(C_2 - C_1)\varepsilon}{2(1 - 2\alpha) + C_*\varepsilon} + \frac{8\alpha^2 + C_1\alpha\varepsilon}{8\alpha + C_*\varepsilon} \geq 1 - \alpha + \frac{C_2 - C_1}{10}\varepsilon \geq 1 - \alpha + 100\varepsilon \quad (6.47)$$

as long as  $C_1 \geq C_*$  and  $C_2 \geq C_1 + C_* + 10^3$ . Fix  $C_1, C_2 > 0$  until the end of the proof.

Assuming further that  $\varepsilon < 10^{-6}(C_*)^{-1} \min\{\alpha, 1 - 2\alpha\}$  and also  $\varepsilon < C_1\alpha 10^{-6}$  we see that,

$$\frac{2^{3/2}(1 - 2\alpha)}{2(1 - 2\alpha) + C_*\varepsilon} - \frac{4\sqrt{2}\alpha}{8\alpha + C_*\varepsilon} - \frac{2C_1\varepsilon}{8\alpha + C_*\varepsilon} \geq \sqrt{2} - 2^{1/2} - \frac{1}{100} \geq \frac{1}{100}. \quad (6.48)$$

Therefore the integral on the last line of (6.46) converges, and is bounded by a constant. The claim now follows.  $\square$

We are now ready to conclude the estimate of the maximum of  $\Psi_n(z, n^{-1})$  for  $\text{Im } z \asymp n^{-\alpha}$ .

**Proof of Proposition 6.6.** By Lemma 5.4 and Proposition 2.5 it suffices to bound

$$\max_{z \in P_1} \Psi_n(z, (\log n)^{10}/n) \quad (6.49)$$

for  $P_1$  being a set of  $n^{1-\alpha+2\varepsilon}$  points in the set  $\{z : |z| < r, n^{-\varepsilon-\alpha} \leq \text{Im}[z] \leq n^{\varepsilon-\alpha}\}$ . For each such  $z$  we use the decomposition in (6.38). By Proposition 4.1 and Proposition 6.3 we have that

$$\mathbb{P} \left[ \max_{z \in P_1} |Y(z)| > C\varepsilon \log n \right] \leq n^{-\varepsilon}, \quad \mathbb{P} \left[ \max_{z \in P_1} |F(z)| > C\varepsilon \log n \right] \leq n^{-10} \quad (6.50)$$

for some sufficiently large  $C > 0$  and all  $\varepsilon > 0$  sufficiently small. The estimate for  $X_1(z) + X_2(z)$  follows from Lemma 6.8.  $\square$

## 6.5 Proof of Proposition 6.1

The upper bound now follows in a straightforward manner from Propositions 6.4, 6.5, and 6.6. Fixing an  $\varepsilon_1 > 0$ , we apply Proposition 6.4 and 6.5 to control the maximum for  $z$  s.t.  $\text{Im}[z] \leq n^{-1/2+\varepsilon_1}$  or  $\text{Im}[z] \geq n^{-\varepsilon_1}$ . Proposition 6.6 then applies for all  $\alpha \in (\varepsilon_1/2, 1/2 - \varepsilon_1/2)$ , with the  $\varepsilon$  in the statement of Proposition 6.6 equalling  $\varepsilon_2 := c_*\varepsilon_1$  for the  $c_* > 0$  coming from that Proposition. We then apply Proposition 6.6 finitely many times (where finitely many depends on  $\varepsilon_1$  and  $c_*$ ) to conclude that,

$$\mathbb{P} \left[ \max_{z:|z|\leq r} \Psi(z, n^{-1}) \geq (\sqrt{2} + C\varepsilon_1) \log n \right] \leq n^{-c\varepsilon_1} \quad (6.51)$$

for all matrices with Gaussian component of size at least  $n^{-c\varepsilon_1}$ , for some small  $c, C > 0$ . This yields the claim, after defining  $\varepsilon > 0$  in terms of  $\varepsilon_1 > 0$  appropriately.  $\square$

## 7 Upper bound for general ensembles; comparison

### 7.1 Comparison

In this section we will state a general comparison result for a certain regularization of the maximum of the characteristic polynomial. We fix  $0 < r < 1$  and a parameter  $\delta > 0$ . Let  $P$  be a set of points of the disc  $\{z : |z| \leq r\}$  s.t.  $|P| \leq n^2$ . With this data, consider the function on the space of iid matrices given by,

$$Z_\delta(X) := \frac{1}{n^\delta} \log \left( \sum_{z \in P_\delta} e^{n^\delta \frac{1}{2} \Psi_n(z, n^{-1})} \right) \quad (7.1)$$

Let  $X$  and  $Y$  be two i.i.d. matrices that match moments to order 3 and their fourth moments differ by  $\mathcal{O}(Tn^{-2})$ . The proof of the following lemma is deferred to Appendix F.2.

**Lemma 7.1.** *In the above set up, we have*

$$|\mathbb{E}[F(Z_\delta(X))] - \mathbb{E}[F(Z_\delta(Y))]| \leq \|F\|_{C^5} (Tn^{10\delta} + n^{-1/4}) \quad (7.2)$$

### 7.2 Proof of upper bounds of Theorems 2.2 and 2.3

It suffices to prove the upper bounds of (2.4) and (2.6), as the upper bound of (2.7) is a consequence of (2.6).

In the set-up of the previous section, we choose  $P = P_\delta$ , a set of  $n^{1+\delta}$  well-spaced points of the disc of radius  $r$ . It is easy to see that, almost surely,

$$\left| \max_{z \in P_\delta} \frac{1}{2} \Psi_n(z, n^{-1}) - Z_\delta(X) \right| \leq \frac{2 \log n}{n^\delta}. \quad (7.3)$$

Moreover, from Proposition 2.5 we have that

$$\left| \max_{|z|<r} \Psi_n(z, n^{-1}) - \max_{z \in P_\delta} \Psi_n(z, n^{-1}) \right| \leq n^{-\delta/2} \quad (7.4)$$

with overwhelming probability.

Note that,

$$\sum_i \log((\lambda_i^z)^2) \leq \sum_i \log((\lambda_i^z)^2 + \eta^2) \quad (7.5)$$

and that

$$\left| \partial_\eta \int \log(x^2 + \eta^2) \rho_z(x) dx \right| = 2 \operatorname{Im}[m^z(i\eta)] \asymp 1 \quad (7.6)$$

and so almost surely we have

$$\Psi_n(z) \leq \Psi_n(z, n^{-1}) + C. \quad (7.7)$$

It therefore suffices to prove the estimates for the regularized  $\Psi_n(z, n^{-1})$ . Let  $X$  be an i.i.d. matrix and  $\varepsilon > 0$ . Let  $Y$  match  $X$  to three moments and the fourth to  $\mathcal{O}(Tn^{-2})$  with  $T = n^{-\varepsilon}$ , with  $Y$  a GDE with component of size  $T$ . We let  $\delta = \varepsilon/20$ . From the discussion above it suffices to bound  $Z_\delta(X)$ . We see by Lemma 7.1 that

$$\mathbb{P} \left[ Z_\delta(X) \geq \left( \frac{1}{\sqrt{2}} + C_1 \varepsilon \right) \log(n) \right] \leq \mathbb{P} \left[ Z_\delta(Y) \geq \left( \frac{1}{\sqrt{2}} + C_1 \varepsilon \right) \log(n) + 1 \right] + n^{-c\varepsilon}. \quad (7.8)$$

On the other hand, the probability on the RHS is easily bounded by relating  $Z_\delta(Y)$  back to the max of  $\Psi_n(z, n^{-1}, Y)$  using (7.3) and then applying Proposition 5.1 and Proposition 6.1 in the complex and real cases, respectively.  $\square$

## 8 Second moment method; lower bound on mesoscopic scales via DBM in the complex case

In this section we will find a lower bound for the log-characteristic polynomial on mesoscopic scales. We will apply a dynamical version of the second moment method; our treatment of the second moment method follows roughly that outlined in the expository notes [6]. Our dynamical set-up will be similar to Section 5. Fix two exponents  $\mathbf{a}, \mathbf{b} > 0$ , and define

$$\mathbf{c} := \min\{\mathbf{a}, \mathbf{b}\}. \quad (8.1)$$

We assume  $\mathbf{c} < 10^{-3}$ . Let  $t_{\mathbf{b}} = n^{-\mathbf{b}}$  and set  $dX_t = dB_t/\sqrt{n}$  where  $B_t$  is a matrix whose entries are i.i.d. standard real or complex Brownian motions. Here,  $X_0$  is a matrix of the form  $X_0 = (1 - t_{\mathbf{b}})^{1/2} Y$  where  $Y$  is an real or complex i.i.d. matrix as in Definition 2.1. The limiting Stieltjes transform of the Hermitization of  $X_t - z$  is given by  $m_t^z(w)$  as in (5.4), with  $c_*(t) = \sqrt{1 + (t - t_{\mathbf{b}})}$ , and it satisfies (5.5) with characteristics given by (5.6).

In this section we will only consider the  $\beta = 1$  case in Proposition 8.2 below (for later use in Section 9); in all other statements in this section we will assume  $\beta = 2$ .

With this definition of  $X_t$  we introduce the field,

$$\Phi(z) := \Psi_n(z, t_{\mathbf{b}}, \eta_{\mathbf{a}}(z, t_{\mathbf{b}})) - \Psi_n(z, 0, \eta_{\mathbf{a}}(z, 0)) \quad (8.2)$$

where  $\eta_{\mathbf{a}}(z, s)$  is a characteristic s.t.  $\eta_{\mathbf{a}}(z, t_{\mathbf{b}}) = n^{\mathbf{a}-1}$ . The main result of this section, proven by the second moment method, is the following:

**Theorem 8.1.** *Let  $P$  be a grid of  $n^{1-\mathbf{a}}$  well-spaced points of the disc  $\{|z - \frac{1}{2}i| < \frac{1}{4}\}$ . There is a  $c > 0$  so that the following holds. For all sufficiently small  $\varepsilon_1 > 0$  we have that*

$$\max_{z \in P} \Phi(z) \geq \sqrt{2}(\sqrt{1 - \mathbf{a} - \mathbf{b}}\sqrt{1 - \mathbf{b} - \varepsilon_1}) \log n \quad (8.3)$$

with probability at least  $1 - n^{-c\varepsilon_1}$ .

Note that due to the proof of Lemma 5.2 we have the decomposition,

$$\Phi(z) = \operatorname{Re} \left[ \frac{1}{\sqrt{2n}} \int_0^{t_b} \sum_i \frac{db_i^z(s)}{\lambda_i^z(s) - i\eta_a(z, s)} \right] + \mathcal{O}(n^{-a/2}) \quad (8.4)$$

with overwhelming probability. Specifically, this follows from (5.18) and (5.22). Fix now an integer  $K \geq 1$  and define,

$$\delta_K := \frac{1 - a - b}{K}. \quad (8.5)$$

Define now  $t_K = t_b = n^{-b}$  and  $t_0 = 0$ . For  $1 \leq i \leq K - 1$  we define,

$$t_i := t_b - \frac{n^{a+(K-i)\delta_K}}{n} \quad (8.6)$$

Then  $t_0 < t_1 < \dots < t_K$  and

$$\log(\eta_a(z, t_i)/\eta_a(z, t_{i+1})) = \delta_K \log n + \mathcal{O}(1) \quad (8.7)$$

for  $0 \leq i < K$ , and

$$\eta_a(z, t_K) = \frac{n^a}{n}, \quad \eta_a(z, t_i) \asymp \frac{n^{a+(K-i)\delta_K}}{n}, \quad 0 \leq i < K. \quad (8.8)$$

Define,

$$Y_i(z) := \operatorname{Re} \left[ \frac{1}{\sqrt{2n}} \int_{t_{i-1}}^{t_i} \sum_i \frac{db_i^z(s)}{\lambda_i^z(s) - i\eta_a(z, s)} \right] \quad (8.9)$$

We now compute the covariation process of the  $Y_i(z)$ . Fix  $z_1, z_2 \in \mathbb{C}$ , for any  $A \in \mathbb{C}^{2n \times 2n}$ , we recall that the deterministic approximation of  $G_t^{z_1}(i\eta)AG_t^{z_2}(i\eta_2)$  is given by (see (6.10))

$$M_t^{z_1, z_2}(i\eta_1, A, i\eta_2) = (1 - c_*(t)^2 M_t^{z_1}(i\eta_1) \mathcal{S}[\cdot] M_t^{z_2}(i\eta_2))^{-1} [M_t^{z_1}(i\eta_1) A_1 M_t^{z_2}(i\eta_2)]. \quad (8.10)$$

Then, for the covariation process we have the following:

**Proposition 8.2.** *Denoting  $\eta_{i,t} = \eta_a(z_i, t)$ , with overwhelming probability, for any small  $\xi > 0$  we have*

$$\left[ \operatorname{Re} \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^{z_1}(t)}{\lambda_i^{z_1}(t) - i\eta_a(z_1, t)}, \operatorname{Re} \frac{1}{\sqrt{2n}} \sum_i \frac{db_i^{z_2}(t)}{\lambda_i^{z_2}(t) - i\eta_a(z_2, t)} \right] \quad (8.11)$$

$$= \left[ 2 \sum_{ij} \tilde{\langle} M_t^{z_1, z_2}(i\eta_{1,t}, E_i, i\eta_{2,t}) E_j \rangle + \mathcal{O} \left( \frac{n^\xi}{n\eta_*(t)^2} \right) \right] dt \quad (8.12)$$

$$+ \mathbf{1}_{\{\beta=1\}} \left[ 2 \sum_{ij} \tilde{\langle} M_t^{z_1, \bar{z}_2}(i\eta_{1,t}, E_i, i\eta_{2,t}) E_j \rangle \right] dt \quad (8.13)$$

where  $\eta_{*,t} = \min\{\eta_{1,t}, \eta_{2,t}\}$  and  $M_t^{z_1, z_2}$  is defined as in (8.10).

**Proof.** We first consider the complex case. Then the covariation process is, by direct calculation,

$$\begin{aligned}
& \frac{1}{2n} \sum_{i,j} \frac{\lambda_i^{z_1} \lambda_j^{z_2} d[b_i^{z_1}, b_j^{z_2}]}{|\lambda_i^{z_1} - i\eta_{1,t}|^2 |\lambda_j^{z_2} - i\eta_{2,t}|^2} dt \\
&= \frac{1}{2n} \sum_{i,j} \frac{4\lambda_i^{z_1} \lambda_j^{z_2} \operatorname{Re}[\langle \mathbf{w}_i^{z_1}, E_1 \mathbf{w}_j^{z_2} \rangle \langle \mathbf{w}_j^{z_2}, E_2 \mathbf{w}_i^{z_1} \rangle]}{|\lambda_i^{z_1} - i\eta_{1,t}|^2 |\lambda_j^{z_2} - i\eta_{2,t}|^2} dt \\
&= 2 \sum_{i,j} \langle \operatorname{Re} G_t^{z_1}(i\eta_{1,t}) E_i \operatorname{Re} G_t^{z_2}(i\eta_{2,t}) E_j \rangle dt \\
&= 2 \sum_{i,j} \langle G_t^{z_1}(i\eta_{1,t}) E_i G_t^{z_2}(i\eta_{2,t}) E_j \rangle dt \\
&= \left[ 2 \sum_{i,j} \langle M_t^{z_1, z_2}(i\eta_{1,t}, E_i, i\eta_{2,t}) E_j \rangle + \mathcal{O}\left(\frac{n^\xi}{n\eta_*(t)^2}\right) \right] dt.
\end{aligned} \tag{8.14}$$

We point out that to go from the third to the fourth line we used that  $\operatorname{Im} G_t^{z_i}(i\eta)$  is diagonal and that  $\operatorname{Re} G_t^{z_i}(i\eta)$  is off-diagonal as a consequence of the symmetry of the spectrum of  $H_t^z$ ; in particular this implies that  $E_1 \operatorname{Im} G_t^{z_i}(i\eta) E_2 = E_2 \operatorname{Im} G_t^{z_i}(i\eta) E_1 = 0$ . Additionally, in the last line we used the following estimate, which is a consequence of rescaling the entries of the matrix considered in [38, Theorem 3.3] (i.e. we now have entries with variance  $c_*(t)^2/n$  instead of  $1/n$  as in [38]),

$$\left| \langle (G_t^{z_1}(i\eta_1) A_1 G_t^{z_2}(i\eta_2) - M_t^{z_1, z_2}(i\eta_1, A_1, i\eta_2)) A_2 \rangle \right| \lesssim \|A_1\| \|A_2\| \frac{n^\xi}{n\eta_*^2}, \tag{8.15}$$

with  $\eta_* := |\eta_1| \wedge |\eta_2|$ , with overwhelming probability, for any  $\xi > 0$  and for any deterministic  $A_1, A_2 \in \mathbb{C}^{2n \times 2n}$ . In the real i.i.d. case, the third line of (8.14) has an additional term

$$2 \sum_{i,j} \langle \operatorname{Re} G_t^{z_1}(i\eta_{1,t}) E_i \operatorname{Re} G_t^{z_2}(i\eta_{2,t}) E_j \rangle dt, \tag{8.16}$$

whose deterministic approximation can be computed as in (8.14), again using (8.15) but with  $z_2$  replaced with  $\bar{z}_2$ . This concludes the proof.  $\square$

**Lemma 8.3.** *For the deterministic process*

$$M(z_1, z_2, t) := 2 \sum_{i,j} \langle M_t^{z_1, z_2}(i\eta_{1,t}, E_i, i\eta_{2,t}) E_j \rangle, \tag{8.17}$$

denoting  $\eta_{i,t} = \eta_a(z_i, t)$ , we have the following estimates. First,

$$M(z, z, t) = \frac{\operatorname{Im}[m_t^z(\eta_a(z, t))]}{\eta_a(z, t)} + \mathcal{O}(1). \tag{8.18}$$

Additionally, if there is a  $\sigma > 0$  so that  $|z_1 - z_2|^2 \geq n^\sigma \eta_a(z_1, t)$  then,

$$|M(z_1, z_2, t)| \lesssim \frac{1}{n^\sigma \eta_a(z_1, t)}, \tag{8.19}$$

where we note that  $\eta_a(z_1, t) \asymp \eta_a(z_2, t)$ . Finally, if  $\eta_a(z, t)$  is such that  $\eta_a(z, t) \geq n^\sigma \operatorname{Im}[z]^2$  then,

$$M(z, \bar{z}, t) = \frac{\operatorname{Im}[m_t^z(\eta_a(z, t))]}{\eta_a(z, t)} (1 + \mathcal{O}(n^{-\sigma/10})) + \mathcal{O}(1) \tag{8.20}$$

**Proof.** By [37, Lemma 6.1], we have

$$\|M^{z_1, z_2}(i\eta_1, A, i\eta_2)\| \lesssim \frac{1}{|z_1 - z_2|^2 + |\eta_1| + |\eta_2|}, \quad (8.21)$$

for any  $\eta_i \neq 0$  and  $\|A\| \leq 1$ , which readily implies (8.19).

We now prove (8.18) and (8.20). We recall that by an explicit computation (see (6.13) and the shorthand notation defined directly before it) we have

$$M(z, \bar{z}, t) = 2 \frac{c_t u^2 \operatorname{Re}[z^2] - c_t^2 |z|^4 u^4 + c_t^2 m^4}{1 + c_t^2 |z|^4 u^4 - c_t^2 m^4 - 2c_t u^2 \operatorname{Re}[z^2]}. \quad (8.22)$$

Then, using (6.14), and that

$$c_t u^2 \operatorname{Re}[z^2] - c_t^2 |z|^4 u^4 + c_t^2 m^4 = 1 - |z|^2 + \mathcal{O}(|z - \bar{z}|^2 + \eta_a(z, t))$$

by (6.15), we conclude (8.20). We point out that here we also used that

$$c_t = 1 + (t - t_b) = 1 - \frac{\eta_a(z, t) - \eta_a(z, t_b)}{\operatorname{Im} m} = 1 + \mathcal{O}(\eta_a(z, t)).$$

The proof of (8.18) is completely analogous (in fact simpler) and so omitted. □

We now define

$$V_j(z_1, z_2) = \int_{t_{j-1}}^{t_j} M(z_1, z_2, s) ds \quad (8.23)$$

to be the leading order deterministic approximation to the covariance of the  $Y_k$ 's. We note that by (8.18) we have that

$$V_j(z, z) = \delta_K \log n + \mathcal{O}(1) \quad (8.24)$$

**Proposition 8.4.** *Let  $\sigma > 0$  be sufficiently small. Fix  $0 \leq k_0 \leq K$  an integer. Let  $z_1, z_2$  be two points such that (recall that  $\eta_a(z_1, t_k) \asymp \eta_a(z_2, t_k)$ )*

$$|z_1 - z_2|^2 \geq n^\sigma \eta_a(z_1, t_{k_0}). \quad (8.25)$$

*Then there is a coupling between the random variables  $\{Y_j(z_1)\}_{j=1}^K, \{Y_j(z_2)\}_{j=k_0+1}^K$  and a vector of independent Gaussian random variables  $\{Z_j(z_1)\}_{j=1}^K, \{Z_j(z_2)\}_{j=k_0+1}^K$  such that with overwhelming probability we have that,*

$$Y_j(z_1) = Z_j(z_1) + \mathcal{O}(n^{-\sigma/10} + n^{-a/10}), \quad Y_l(z_2) = Z_l(z_2) + \mathcal{O}(n^{-\sigma/10} + n^{-a/10}) \quad (8.26)$$

for  $1 \leq j \leq K$  and  $k_0 + 1 \leq l \leq K$ . The variance of the  $Z_j(u)$  are given by

$$\operatorname{Var}(Z_j(u)) = V_j(u, u) = \int_{t_{j-1}}^{t_j} M(u, u, s) ds = \delta_K \log n + \mathcal{O}(1), \quad (8.27)$$

for  $(u, j) \in \{(z_1, i) : 1 \leq i \leq K\} \cup \{(z_2, i) : k_0 + 1 \leq i \leq K\}$ . Note that if  $k_0 = K$  then we are only producing a coupling for the process  $\{Y_j(z_1)\}_{j=1}^K$ , and the estimates (8.26) holds without the  $n^{-\sigma/10}$  error.

**Proof.** Let  $d[Y_j(z), Y_k(w)] = \mathcal{C}_{jk}(z, w, t)dt$  be the covariation process of the  $Y_k$ 's. Note that this is non-zero for  $j \neq k$  and for  $j \leq k_0$  we are only considering the single process  $dY_j(z_1)$ . For each time  $t$ , the covariation process of  $\{Y_j(z_1)\}_{j=1}^K, \{Y_j(z_2)\}_{j=k_0+1}^K$  is a  $(K + (K - k_0)) \times (K + (K - k_0))$  dimensional matrix which we will denote by  $\mathcal{C}(t)$ . Construct now a deterministic diagonal matrix  $\mathcal{M}(t)$  of the same dimension as follows. For every possible choice of  $z_i$  and  $j$  s.t.  $Y_j(z_i)$  is one of the elements of our process, if the  $(k_1, k_1)$ -th entry of  $\mathcal{C}(t)$  corresponds to the variation process of this  $Y_j(z_i)$  then set

$$\mathcal{M}_{k_1, k_1}(t) := M(z_i, z_i, t) \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}}. \quad (8.28)$$

Set all other entries of  $\mathcal{M}$  to be 0. Then, with overwhelming probability by Proposition 8.2 and (8.19) we have that

$$\max_{i,j} |\mathcal{C}_{ij}(t) - \mathcal{M}_{ij}(t)| \leq C \left( \frac{1}{n^\sigma \eta_a(z_1, t)} + \frac{n^\xi}{n \eta_a(z_1, t)} \right) \quad (8.29)$$

for any  $\xi > 0$ . By the martingale representation theorem, there is a probability space and a sequence of  $K + (K - k_0)$  standard Brownian motions  $\tilde{b}_t$  s.t.

$$dY_t = \sqrt{\mathcal{C}(t)} d\tilde{b}_t \quad (8.30)$$

where by an abuse of notation we let  $Y_t$  to denote the  $K + (K - k_0)$ -dimensional vector of the processes  $\{Y_j(z_1)\}_{j=1}^K, \{Y_j(z_2)\}_{j=k_0+1}^K$ . We can define now  $Z$  by  $dZ_t = \sqrt{\mathcal{M}(t)} d\tilde{b}_t$ . Clearly  $Z$  has the desired distribution (recall that  $\mathcal{M}(t)$  is diagonal and deterministic). To estimate the difference we compute the quadratic variation of  $Y_j(u) - Z_j(u)$ , for  $u$  and  $j$  as in the proposition statement. This is bounded by,

$$\begin{aligned} [d(Y_j - Z_j), d(Y_j - Z_j)](t) &= \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}} \sum_{\alpha} (\sqrt{\mathcal{C}} - \sqrt{\mathcal{M}})_{j,\alpha}^2 dt \\ &= \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}} ((\sqrt{\mathcal{C}} - \sqrt{\mathcal{M}})_{jj}^2) \\ &\leq \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}} \text{Tr} \left[ ((\sqrt{\mathcal{C}} - \sqrt{\mathcal{M}})^2) \right] \\ &\leq \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}} \text{Tr} |\mathcal{C} - \mathcal{M}| \\ &\lesssim \mathbf{1}_{\{t \in (t_{j-1}, t_j)\}} \left( \frac{1}{n^\sigma \eta_a(z_1, t)} + \frac{n^\xi}{n \eta_a(z_1, t)} \right) \end{aligned} \quad (8.31)$$

The last inequality uses (8.29) and the fact that  $\text{Tr}|T| \leq \sum_{ij} |T_{ij}|$ , and the second last inequality uses the Powers-Størmer inequality. By integrating the final inequality we then obtain

$$\int_{t_{j-1}}^{t_j} [d(Y_j - Z_j), d(Y_j - Z_j)] \leq C(n^{-\sigma/2} + n^{-a/2}), \quad (8.32)$$

with overwhelming probability. The claim now follows from the BDG inequality.  $\square$

We now state the following asymptotic for Gaussian random variables (see e.g. [48, Theorem 1.2.3]), which will be useful in the following. If  $Z$  is a centered Gaussian with variance  $\sigma^2$  we have,

$$\frac{1}{\sqrt{2\pi}} \left( \frac{\sigma}{x} - \frac{\sigma^3}{x^3} \right) e^{-\frac{x^2}{2\sigma^2}} \leq \mathbb{P}[Z > x] \leq \frac{1}{\sqrt{2\pi}} \frac{\sigma}{x} e^{-\frac{x^2}{2\sigma^2}}. \quad (8.33)$$

Let us now define,

$$\mathcal{E}_m(z) := \left\{ Y_m(z) > \frac{\sqrt{2}}{K}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n \right\} \quad (8.34)$$

as well as,

$$\mathcal{F}_m(z) := \left\{ \mathcal{Z}_m(z) > \frac{\sqrt{2}}{K}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n \right\} \quad (8.35)$$

where  $\{\mathcal{Z}_m(w)\}_{m,w}$  is a family of independent Gaussian random variables with variance  $V_m(w, w)$ . Define the functions

$$p_m(z, x) := \mathbb{P}[\mathcal{Z}_m(z) > x], \quad \hat{p}_m(z) := \mathbb{P}\left[\mathcal{Z}_m(z) > \frac{\sqrt{2}}{K}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n\right], \quad (8.36)$$

and the point

$$\hat{x} := \frac{\sqrt{2}}{K}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n. \quad (8.37)$$

**Lemma 8.5.** *For all  $n$  sufficiently large we have that,*

$$\mathbb{P}\left[\bigcap_{m=1}^K \mathcal{E}_m(z)\right] = \left(\prod_{m=1}^K \hat{p}_m(z)\right) (1 + \mathcal{O}(n^{-a/100})) \asymp (\log n)^{-K/2} n^{-(1-a)+\varepsilon_1[2(1-a)^{1/2}(1-a-b)^{-1/2}-\varepsilon_1/(1-a-b)]} \quad (8.38)$$

and so,

$$\mathbb{E}\left[\sum_{z \in P} \prod_{m=1}^K 1_{\{\mathcal{E}_m(z)\}}\right] \asymp (\log n)^{-K/2} n^{\varepsilon_1[2(1-a)^{1/2}(1-a-b)^{-1/2}-\varepsilon_1/(1-a-b)]} \quad (8.39)$$

**Proof.** By (8.33) and (8.24) we have that,

$$\begin{aligned} \hat{p}_m(z) &= \frac{1}{\sqrt{2\pi}} \frac{K\sqrt{V_m(z, z)}}{\sqrt{2}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n} \exp\left(-\frac{(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1)^2 (\log n)^2}{K^2 V_m(z, z)}\right) (1 + \mathcal{O}((\log n)^{-1})) \\ &\asymp \frac{K^{1/2}}{(\log n)^{1/2}} n^{-(1-a)/K} n^{\frac{\varepsilon_1}{K}[2(1-a)^{1/2}(1-a-b)^{-1/2}-\varepsilon_1/(1-a-b)]} \end{aligned} \quad (8.40)$$

By Proposition 8.4 (applied to the case of just a single  $z_1$  or  $k_0 = K$ ), with  $\hat{x}$  as in (8.37), we have that

$$\prod_{m=1}^K p_m(z, \hat{x} + n^{-a/10}) - n^{-1000} \leq \mathbb{P}\left[\bigcap_{m=1}^K \mathcal{E}_m(z)\right] \leq \prod_{m=1}^K p_m(z, \hat{x} - n^{-a/10}) + n^{-1000}. \quad (8.41)$$

It is straightforward to check, using (8.33) and the explicit form of the Gaussian density that for  $|s| \leq 1$  we have

$$p_m(z, \hat{x} + s) = p_m(z, \hat{x})(1 + \mathcal{O}(|s|)) \quad (8.42)$$

This now completes the proof.  $\square$

**Proposition 8.6.** *Suppose that  $|z - w|^2 > n^{-b/10}$ . Then,*

$$\mathbb{P}\left[\bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w)\right] = \left(\prod_{m=1}^K \hat{p}_m(z)\hat{p}_m(w)\right) (1 + \mathcal{O}(n^{-c/200})). \quad (8.43)$$

**Proof.** We just prove the upper bound, the lower bound being very similar. We first have by Proposition 8.4 with  $\sigma = \mathfrak{b}/2$  (recall that  $\eta_{\mathfrak{a}}(z, 0) \asymp n^{-\mathfrak{b}}$  by definition) that

$$\mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \leq \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{G}_m(z, \hat{x} - n^{-c/100}) \cap \mathcal{G}_m(w, \hat{x} - n^{-c/100}) \right] + n^{-100}, \quad (8.44)$$

where

$$\mathcal{G}_m(z, x) := \{\mathcal{Z}_m(z) > x\}. \quad (8.45)$$

Now, by the independence of the  $\mathcal{Z}_m$ 's we have,

$$\mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{G}_m(z, \hat{x} - n^{-c/100}) \cap \mathcal{G}_m(w, \hat{x} - n^{-c/100}) \right] = \prod_{m=1}^K \mathbb{P} \left[ \mathcal{G}_m(w, \hat{x} - n^{-c/100}) \right] \mathbb{P} \left[ \mathcal{G}_m(z, \hat{x} - n^{-c/100}) \right] \quad (8.46)$$

The claim now follows from (8.42).  $\square$

**Proposition 8.7.** *Suppose that for some  $\sigma > 0$  and  $0 \leq k \leq K$  we have,*

$$|z - w|^2 \geq n^\sigma \frac{n^{\mathfrak{a} + (K-k)\delta_K}}{n}. \quad (8.47)$$

Then,

$$\mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \leq \left( \prod_{m=k+1}^K \hat{p}_m(z) \right) \left( \prod_{m=1}^K \hat{p}_m(w) \right) (1 + \mathcal{O}(n^{-\mathfrak{a}/20} + n^{-\sigma/10})) \quad (8.48)$$

**Proof.** The proof is analogous to the proof of Proposition 8.6, and so omitted.  $\square$

**Proposition 8.8.** *We have for  $K > 10/\varepsilon_1$  and  $K > 10^6/c$  that,*

$$\mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{m=1}^K 1_{\{\mathcal{E}_m(z_i)\}} \right)^2 \right] \leq \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{m=1}^K 1_{\{\mathcal{E}_m(z_i)\}} \right) \right]^2 (1 + \mathcal{O}(n^{-c/200} + n^{-\varepsilon_1/10})) \quad (8.49)$$

**Proof.** Fixing  $\frac{\mathfrak{b}}{100} > \sigma > 0$  we have, (all of the sums below are over  $(z, w) \in P \times P$ )

$$\begin{aligned} \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{m=1}^K 1_{\{\mathcal{E}_m(z_i)\}} \right)^2 \right] &= \sum_{|z-w|^2 > n^{-\mathfrak{b}/10}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \\ &+ \sum_{n^\sigma n^{-\mathfrak{b}} < |z-w|^2 < n^{-\mathfrak{b}/10}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \\ &+ \sum_{k=1}^K \sum_{n^\sigma n^{-\mathfrak{b}-k\delta_K} < |z-w|^2 < n^\sigma n^{-\mathfrak{b}-(k-1)\delta_K}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \\ &+ \sum_{|z-w|^2 < n^\sigma n^{\mathfrak{a}-1}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \end{aligned} \quad (8.50)$$

By Proposition 8.6 and Lemma 8.5 we see that,

$$\sum_{|z-w|^2 > n^{-b/10}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \leq \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{i=1}^m 1_{\{\mathcal{E}_m(z_i)\}} \right) \right]^2 (1 + \mathcal{O}(n^{-c/200})) \quad (8.51)$$

By Proposition 8.7 with  $k = 0$  we see that

$$\begin{aligned} & \sum_{n^\sigma n^{-b} < |z-w|^2 < n^{-b/10}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \lesssim \sum_{n^\sigma n^{-b} < |z-w|^2 < n^{-b/10}} \left( \prod_{m=1}^K \hat{p}_m(z) \right) \left( \prod_{m=1}^K \hat{p}_m(w) \right) \\ & \lesssim n^{-b/10} (n^{1-a})^2 (\log n)^{-K} \left( n^{-(1-a) + \varepsilon_1 [2(1-a)^{1/2} (1-a-b)^{-1/2} - \varepsilon_1 / (1-a-b)]} \right)^2 \\ & \lesssim n^{-b/10} \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{i=1}^m 1_{\{\mathcal{E}_m(z_i)\}} \right) \right]^2 \end{aligned} \quad (8.52)$$

where we used the fact that there are at most  $\mathcal{O}((n^{1-a})^2 n^{-b/10})$  pairs of points s.t.  $|z-w|^2 < n^{-b/10}$ . The last inequality uses the second part of (8.38). For  $1 \leq k \leq K$  we have by Proposition 8.7 that

$$\begin{aligned} & \sum_{n^\sigma n^{-b-k\delta_K} < |z-w|^2 < n^\sigma n^{-b-(k-1)\delta_K}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \\ & \leq C n^\sigma n^{-b-(k-1)\delta_K} (n^{1-a})^2 \left( (\log n)^{-K/2} n^{-(1-a) + \varepsilon_1 [2(1-a)^{1/2} (1-a-b)^{-1/2} - \varepsilon_1 / (1-a-b)]} \right)^{2 - \frac{k}{K}} \quad (8.53) \\ & \leq C n^{2\sigma} n^{-b-(k-1)\delta_K + k(1-a)/K - \hat{c}\varepsilon_1 k/K} \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{i=1}^m 1_{\{\mathcal{E}_m(z_i)\}} \right) \right]^2 \end{aligned}$$

where we denoted  $\hat{c} := 2(1-a)^{1/2}(1-a-b)^{-1/2} - \varepsilon_1/(1-a-b) \geq 1$  for simplicity, assuming  $\varepsilon_1 < 10^{-3}$ . The exponent of  $n$  in the last line equals,

$$2\sigma - \mathfrak{b}(1 + K^{-1}) + \frac{1-a}{K} + \frac{k}{K}(\mathfrak{b} - \hat{c}\varepsilon_1) \leq \max\left\{2\sigma + \frac{1-a-b}{K} - \hat{c}\varepsilon_1, 2\sigma - \mathfrak{b} + \frac{1-a}{K} - \frac{\hat{c}}{K}\varepsilon_1\right\} \quad (8.54)$$

Since  $\hat{c} \geq 1$ , we can take  $\sigma < \varepsilon_1/10$  and  $K > 10/\varepsilon_1 + 10/\mathfrak{b}$  and  $\sigma < \mathfrak{b}/10$  to show that the RHS is less than  $-\min\{\mathfrak{b}/2, \varepsilon_1/2\}$ . Finally,

$$\sum_{|z-w|^2 < n^\sigma n^{a-1}} \mathbb{P} \left[ \bigcap_{m=1}^K \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \leq n^\sigma \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{i=1}^m 1_{\{\mathcal{E}_m(z_i)\}} \right) \right] \leq n^{-\varepsilon_1/2} \mathbb{E} \left[ \left( \sum_{z_i \in P} \prod_{i=1}^m 1_{\{\mathcal{E}_m(z_i)\}} \right) \right]^2 \quad (8.55)$$

if  $\sigma < \varepsilon_1/10$ , as the RHS of (8.39) is at least  $n^{9\varepsilon_1/10}$  if  $\hat{c} \geq 1$ . The claim follows.  $\square$

## 8.1 Proof of Theorem 8.1

Define the random variable,

$$\Xi := \sum_{z \in P} \prod_{m=1}^K 1_{\mathcal{E}_m(z)}. \quad (8.56)$$

If  $\Xi > 0$  then there is a  $z \in P$  such that

$$\Phi(z) = \sum_{i=1}^K Y_i(z) + \mathcal{O}(n^{-a/2}) \geq \sqrt{2}(\sqrt{1-a-b}\sqrt{1-a} - \varepsilon_1) \log n - n^{-a/2}. \quad (8.57)$$

where the second equality holds with overwhelming probability. The Paley-Zygmund inequality states that,

$$\mathbb{P}[\Xi > \theta \mathbb{E}[\Xi]] \geq (1-\theta)^2 \frac{\mathbb{E}[\Xi]^2}{\mathbb{E}[\Xi^2]}. \quad (8.58)$$

The claim now follows from Proposition 8.8 and the choice of  $\theta = n^{-c\varepsilon_1}$  for some small  $c > 0$ , and the fact that  $\mathbb{E}[\Xi] \geq n^{\varepsilon_1/2}$  by Lemma 8.5.  $\square$

## 9 Second moment method for real i.i.d. matrices

In this section we carry out the second moment method in the real i.i.d. case. Some parts will be similar to the complex case considered in Section 8.

We fix here three exponents  $\mathbf{a}, \mathbf{b}, \mathbf{c} > 0$ , let  $\varepsilon := \min\{\mathbf{a}, \mathbf{b}\}$ . Fix  $\alpha > 0$  and assume  $\varepsilon + \mathbf{c} < \frac{\alpha}{100}$ . We consider the set  $\mathfrak{P} := \{z \in \mathbb{C} : n^{-\alpha} \leq \text{Im}[z] \leq 2n^{-\alpha}, |\text{Re}[z]| \leq \frac{1}{2}\}$ . We let  $P_1$  be a set of  $n^{1-\alpha-\mathbf{a}}$  well-spaced points of  $\mathfrak{P}$ , and set  $t_{\mathbf{b}} = n^{-\mathbf{b}}$ .

The matrix  $X_t$  we will consider is the following satisfies  $dX_t = dB_t/\sqrt{n}$  where  $B_t$  is a matrix whose entries are i.i.d. standard real Brownian motions. The initial data is  $X_0 = \sqrt{1-t_{\mathbf{b}}}Y$  where  $Y$  is a real i.i.d. matrix.

For every  $z \in \mathfrak{P}$  we let  $\eta_{\mathbf{a}}(z, t)$  be a characteristic such that  $\eta_{\mathbf{a}}(z, t_{\mathbf{b}}) = n^{\mathbf{a}-1}$  where  $t_{\mathbf{b}} = n^{-\mathbf{b}}$ . Fix a large integer  $K > 0$ . We let,

$$\delta_K^{(1)} := \frac{2\alpha - \mathbf{b} - \mathbf{c}}{K}, \quad \delta_K^{(2)} := \frac{1 - \mathbf{a} - \mathbf{c} - 2\alpha}{K} \quad (9.1)$$

We let  $t_K^{(2)} = t_{\mathbf{b}}$  and, for  $0 \leq i \leq K-1$ , let

$$t_i^{(2)} = t_{\mathbf{b}} - \frac{n^{\mathbf{a}+(K-i)\delta_K^{(2)}}}{n} \quad (9.2)$$

Similarly, for  $0 \leq i \leq K$  let,

$$t_i^{(1)} = t_{\mathbf{b}} - n^{-2\alpha+\mathbf{c}+(K-i)\delta_K^{(1)}}. \quad (9.3)$$

Then  $0 =: t_0^{(1)} < t_1^{(1)} \dots < t_K^{(1)} < t_0^{(2)} < \dots < t_K^{(2)} := t_{\mathbf{b}}$ . Moreover, for  $0 \leq j \leq K$ ,

$$\eta_{\mathbf{a}}(z, t_j^{(2)}) \asymp \frac{n^{\mathbf{a}+(K-j)\delta_K^{(2)}}}{n} = n^{-\mathbf{c}-2\alpha-j\delta_K^{(2)}}, \quad \eta_{\mathbf{a}}(z, t_j^{(1)}) \asymp n^{-2\alpha+\mathbf{c}+(K-j)\delta_K^{(1)}} = n^{-\mathbf{b}-j\delta_K^{(1)}}. \quad (9.4)$$

For each  $z$  we then define  $2K$  random variables as follows:

$$Y_j(z) := \text{Re} \left[ \frac{1}{\sqrt{2n}} \int_{t_{j-1}^{(1)}}^{t_j^{(1)}} \sum_i \frac{db_i^z(s)}{\lambda_i^z(s) - i\eta_{\mathbf{a}}(z, s)} \right], \quad Y_{K+j}(z) := \text{Re} \left[ \frac{1}{\sqrt{2n}} \int_{t_{j-1}^{(2)}}^{t_j^{(2)}} \sum_i \frac{db_i^z(s)}{\lambda_i^z(s) - i\eta_{\mathbf{a}}(z, s)} \right] \quad (9.5)$$

for  $1 \leq j \leq K$ . Note that  $Y_K$  involves an integral over  $[t_{K-1}^{(1)}, t_K^{(1)}]$  and  $Y_{K+1}$  over  $[t_0^{(2)}, t_1^{(2)}]$  and  $t_K^{(1)} < t_0^{(2)}$ . I.e., we are throwing away a small increment where  $\eta_{\mathbf{a}}(z, t) \approx n^{-2\alpha}$  in order to make

calculations simpler. Let  $t_{aK+j} = t_j^{(1+a)}$  for  $a = 0, 1$  and  $0 \leq j \leq K-1$ , and let  $t_{2K} = t_b$ . We point out that, unlike in the complex case, we introduced two different families of random variables in (9.5) to reflect the fact that in the real case the characteristic polynomial consists of the sum of two different fields living on different scales (see e.g. (1.13) and (6.4)–(6.5)).

**Proposition 9.1.** *Let  $1 \leq k_0 \leq 2K$  and assume that  $|z - w|^2 \geq n^\sigma \eta_a(z, t_{k_0})$ . Then there is a coupling between the random variables  $\{Y_i(z)\}_{i=1}^{2K}$ ,  $\{Y_i(w)\}_{i=k_0+1}^{2K}$  and a vector of independent Gaussians  $\{Z_i(z)\}_{i=1}^{2K}$ ,  $\{Z_i(w)\}_{i=k_0+1}^{2K}$  such that*

$$Y_j(z) = Z_j(z) + \mathcal{O}(n^{-\sigma/10} + n^{-\epsilon/10}), \quad Y_l(w) = Z_l(w) + \mathcal{O}(n^{-\sigma/10} + n^{-\epsilon/10}) \quad (9.6)$$

for  $1 \leq j \leq 2K$  and  $k_0 + 1 \leq l \leq 2K$  with overwhelming probability. The variance of the  $Z_j(u)$  are given by,

$$\text{Var}(Z_{aK+j}(u)) = \int_{t_j^{(1+a)}}^{t_j^{(1+a)}} [M(u, u, s) + M(u, \bar{u}, s)] ds = (2-a)\delta_K^{(1+a)} \log n + \mathcal{O}(1) \quad (9.7)$$

for  $a = 0, 1$  and  $1 \leq j \leq K$ , and  $u = z$  or  $w$  as appropriate. Here  $M(z, w, s)$  is defined in (8.17).

**Proof.** The proof is almost identical to Proposition 8.4, as the main inputs, Proposition 8.2 and (8.19), apply also in the real case. The only difference is then the computation of the variance of the Gaussian random variables. For  $1 \leq j \leq K$ , one uses (8.18) and (8.20). For  $j > K$  one uses (8.19) instead of (8.20).  $\square$

Define,

$$\hat{x} := \frac{\sqrt{2}}{K} (2\alpha - \mathbf{b} - \mathbf{c}) \log n, \quad \hat{y} := \frac{\sqrt{2}}{K} (1 - \mathbf{a} - \mathbf{c} - 2\alpha) \log n. \quad (9.8)$$

Then for  $a = 0, 1$  and  $1 \leq m \leq K$ , we define the events

$$\mathcal{E}_{aK+m}(z) := \{Y_{aK+m}(z) > \mathbf{1}_{\{a=0\}} \hat{x} + \mathbf{1}_{\{a=1\}} \hat{y}\} \quad (9.9)$$

and

$$\mathcal{F}_{aK+m}(z) := \{\mathcal{Z}_{aK+m}(z) > \mathbf{1}_{\{a=0\}} \hat{x} + \mathbf{1}_{\{a=1\}} \hat{y}\}, \quad (9.10)$$

where  $\mathcal{Z}_m$  are a family of independent Gaussians having variance as in (9.7). For  $1 \leq m \leq K$ , we use the notation

$$\hat{p}_m(z) = \mathbb{P}[\mathcal{F}_m(z)], \quad \hat{q}_m(z) = \mathbb{P}[\mathcal{F}_{K+m}(z)]. \quad (9.11)$$

By (8.33), we have

$$\hat{p}_m(z) \asymp (\log n)^{-1/2} n^{-\delta_K^{(1)}/2} =: p, \quad \hat{q}_m(z) \asymp (\log n)^{-1/2} n^{-\delta_K^{(2)}} =: q. \quad (9.12)$$

Finally, we define,

$$\Xi := \sum_{z \in P_1} \prod_{m=1}^{2K} \mathbf{1}_{\mathcal{E}_m(z)}. \quad (9.13)$$

**Proposition 9.2.** *Let  $\sigma > 0$ . For any  $z, w$  s.t.  $|z - w|^2 \geq n^{\sigma-b}$  we have*

$$\mathbb{P} \left[ \bigcap_{m=1}^{2K} \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] = \left( \prod_{m=1}^K \hat{p}_m(z) \hat{p}_m(w) \hat{q}_m(z) \hat{q}_m(w) \right) (1 + \mathcal{O}(n^{-\epsilon/10} + n^{-\sigma/10})). \quad (9.14)$$

Further we have that,

$$\mathbb{P} \left[ \bigcap_{m=1}^{2K} \mathcal{E}_m(z) \right] = \left( \prod_{m=1}^K \hat{p}_m(z) \hat{q}_m(z) \right) (1 + \mathcal{O}(n^{-\epsilon/10})). \quad (9.15)$$

and so  $\mathbb{E}[\Xi] \asymp n^{1-a-\alpha} (pq)^K$

**Proof.** The second estimate is proven similarly to (8.38). The first is similar to Proposition 8.6. For concreteness, we prove the upper bound of (9.14). By Proposition 9.1 and the independence of the Gaussians we have,

$$\begin{aligned} \mathbb{P} \left[ \bigcap_{m=1}^{2K} \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] &\leq \prod_{a=0,1} \prod_{m=1}^K \left\{ \mathbb{P} \left[ \mathcal{Z}_{aK+m}(z) \geq \mathbf{1}_{\{a=0\}} \hat{x} + \mathbf{1}_{\{a=1\}} \hat{y} - n^{-\sigma/10} - n^{-\epsilon/10} \right] \right. \\ &\quad \left. \times \mathbb{P} \left[ \mathcal{Z}_{aK+m}(w) \geq \mathbf{1}_{\{a=0\}} \hat{x} + \mathbf{1}_{\{a=1\}} \hat{y} - n^{-\sigma/10} - n^{-\epsilon/10} \right] \right\} + n^{-1000}. \end{aligned} \quad (9.16)$$

We conclude the upper bound using an estimate similar to (8.42). The lower bound is similar.  $\square$

Similarly to the proof of Proposition 9.2 we obtain the following bounds. We omit the proof for brevity.

**Proposition 9.3.** For  $|z - w|^2 > n^\sigma n^{-b-j\delta_K^{(1)}}$  and  $1 \leq j \leq K$  we have,

$$\mathbb{P} \left[ \bigcap_{m=1}^{2K} \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \lesssim (pq)^{2K} p^{-j}. \quad (9.17)$$

For  $|z - w|^2 > n^\sigma n^{-c-2\alpha-j\delta_K^{(2)}}$  and  $0 \leq j \leq K$  we have,

$$\mathbb{P} \left[ \bigcap_{m=1}^{2K} \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right] \lesssim (pq)^{2K} p^{-K} q^{-j}. \quad (9.18)$$

The bound for  $j = K$  holds for any choice of  $z, w$ .

We are now ready to state and prove the main result of this section:

**Proposition 9.4.** There exists a small  $c > 0$  such that

$$\mathbb{E}[\Xi^2] \leq \mathbb{E}[\Xi]^2 (1 + n^{-a/100} + n^{-b/100}). \quad (9.19)$$

**Proof.** Fix a small  $\sigma > 0$ . Write  $f(z, w) := \mathbb{P} \left[ \prod_{m=1}^{2K} \mathcal{E}_m(z) \cap \mathcal{E}_m(w) \right]$  and write,

$$\mathbb{E}[\Xi^2] = \sum_{|z-w|^2 > n^\sigma n^{-b}} f(z, w) + \sum_{j=1}^{2K} \sum_{\eta_j \leq n^{-\sigma} |z-w|^2 < \eta_{j-1}} f(z, w) + \sum_{|z-w|^2 < n^\sigma \eta_{2K}} f(z, w) \quad (9.20)$$

where  $\eta_j = n^{-b-j\delta_K^{(1)}}$  for  $0 \leq j \leq K-1$  and  $\eta_{i+K} = n^{-c-2\alpha-i\delta_K^{(2)}}$  for  $0 \leq i \leq K$ . By (9.14) we have,

$$\sum_{|z-w|^2 > n^\sigma n^{-b}} f(z, w) \leq (\mathbb{E}[\Xi])^2 (1 + n^{-\sigma/10} + n^{-\epsilon/10}). \quad (9.21)$$

For  $1 \leq j \leq K$  the number of pairs of points  $z, w$  such that  $|z - w|^2 < n^\sigma \eta_{j-1}$  is of order,

$$n^{\sigma/2} (n^{1-a})^2 n^{-2\alpha} \sqrt{\eta_{j-1}} = n^{\sigma/2} (n^{1-a-\alpha})^2 n^{-b/2-(j-1)\delta_K^{(1)}/2}. \quad (9.22)$$

Therefore, for  $1 \leq j \leq K$  we have, by (9.17),

$$\sum_{\eta_j \leq n^{-\sigma} |z-w|^2 < \eta_{j-1}} f(z, w) \lesssim n^{\sigma/2} (n^{1-a-\alpha} (pq)^K)^2 n^{-b/2} n^{\delta_K^{(1)}/2} (p^{-1} n^{-\delta_K^{(1)}/2})^j \lesssim n^{-b/20} \mathbb{E}[\Xi]^2 \quad (9.23)$$

as long as  $\sigma < \mathfrak{b}/10$  and  $K > 100/\mathfrak{b}$ . For  $1 \leq j \leq K$  the number of pairs points  $z, w$  such that  $|z - w|^2 < n^\sigma \eta_{K+j-1}$  is bounded by,

$$n^\sigma (n^{1-a})^2 n^{-\alpha} \eta_{K+j-1} = n^\sigma (n^{1-a-\alpha})^2 n^{-c-\alpha} n^{-(j-1)\delta_K^{(2)}}. \quad (9.24)$$

Therefore, using (9.18), we have the bound

$$\begin{aligned} \sum_{\eta_{j+K} \leq n^{-\sigma} |z-w|^2 < \eta_{j+K-1}} f(z, w) &\lesssim n^\sigma ((pq)^K n^{1-a-\alpha})^2 p^{-K} q^{-j} n^{-c-\alpha} n^{-(j-1)\delta_K^{(2)}} \\ &\leq n^\sigma (\mathbb{E}[\Xi])^2 (\log n)^{K/2} n^{-b/2-3\mathfrak{c}/2} n^{\delta_K^{(2)}} (q^{-1} n^{-\delta_K^{(2)}})^j \leq n^{-b/20} (\mathbb{E}[\Xi])^2. \end{aligned} \quad (9.25)$$

In the second estimate we used that  $p^K \gtrsim (\log n)^{-K/2} n^{-(2\alpha-b-c)/2}$  and in the last estimate that  $q \geq n^{-\delta_K^{(2)}} (\log n)^{-1/2}$ . The last term of (9.20) is also bounded above by the RHS of (9.25) when  $j = K$ . This completes the proof, after choosing  $\sigma = \mathfrak{e}/10$ .  $\square$

**Theorem 9.5.** *There are constants,  $c, C > 0$  so that the following holds. For a real i.i.d. matrix,  $P_1$  as above and*

$$\Phi(z) := \Psi_n(z, t_{\mathfrak{b}}, \eta_{\mathfrak{a}}(z, t_{\mathfrak{b}})) - \Psi_n(z, 0, \eta_{\mathfrak{a}}(z, 0)) \quad (9.26)$$

we have that,

$$\mathbb{P} \left[ \max_{z \in P_1} \Phi(z) \geq \sqrt{2} \left( 1 - \mathfrak{b} - 2\mathfrak{c} - \mathfrak{a} - C\mathfrak{c}^{1/3} \right) \log n \right] \geq 1 - n^{-c \min\{\mathfrak{a}, \mathfrak{b}\}}, \quad (9.27)$$

as long as  $\mathfrak{c}, \mathfrak{a}, \mathfrak{b} > 0$  are sufficiently small and  $\mathfrak{d} < \frac{\mathfrak{b}}{20}$ .

**Proof.** By definition, we have

$$\Phi(z) = \sum_{m=1}^{2K} Y_m(z) + \left( \Psi_n(z, \eta_{\mathfrak{a}}(t_0^{(2)}), t_0^{(2)}) - \Psi_n(z, \eta_{\mathfrak{a}}(t_K^{(1)}), t_K^{(1)}) \right), \quad (9.28)$$

and

$$\left| \log \left[ \eta_{\mathfrak{a}}(z, t_0^{(2)}) / \eta_{\mathfrak{a}}(z, t_K^{(1)}) \right] \right| \leq C\mathfrak{c} \log n. \quad (9.29)$$

Proposition 6.3 thus implies

$$\mathbb{P} \left[ \left| \Psi_n(z, \eta_{\mathfrak{a}}(t_0^{(2)}), t_0^{(2)}) - \Psi_n(z, \eta_{\mathfrak{a}}(t_K^{(1)}), t_K^{(1)}) \right| > C\mathfrak{c}^{1/3} \log n \right] \leq n^{-10} \quad (9.30)$$

for  $\mathfrak{c} > 0$  sufficiently small. The claim now follows from Proposition 9.4 and the Paley-Zygmund inequality.  $\square$

## 10 Technical lower bound for GDE

In this section we work towards Theorems 10.6 and 10.7 below. They are stronger versions of the lower bounds of Theorems 2.2 and 2.3 in that they bound below the maximum of the characteristic polynomial over points  $z$  where  $\lambda_1^z$  is not too small, for i.i.d. ensembles with an  $n^{-\varepsilon}$  Gaussian component. The reason for this is that it is hard to apply the four moment method directly to the maximum of the characteristic polynomial with no regularization, i.e.,  $\Psi_n(z, \eta = 0)$ . One could compare the maximum at  $\eta \approx n^{-1}$ , but then this is hard to relate back to the characteristic polynomial with no regularization. Keeping around the condition that  $\lambda_1^z$  is not too small allows us to do so; see Lemma 11.5 in the next section.

### 10.1 Regularization

We need the following notion of regular sets of points.

**Definition 10.1.** *We say that a set of point  $\mathcal{P}$  in  $\mathbb{C}$  is  $\varepsilon_1$ -regular if  $\mathcal{P}$  can be written as a disjoint union  $\mathcal{P} = \bigsqcup \mathcal{P}_i$  where  $\log n \leq |\mathcal{P}_i| \leq 10 \log n$  and for all  $i$  and all  $w, z \in \mathcal{P}_i$  with  $w \neq z$  we have*

$$\frac{n^{\varepsilon_1}}{n^{1/2}} \leq |z - w| \leq \frac{n^{2\varepsilon_1}}{n^{1/2}} \quad (10.1)$$

Furthermore,  $\mathcal{P} \subseteq \{z : |z| < 0.99\}$  and  $|\mathcal{P}| \leq N^2$ .

In this section we will consider  $X_t$  to satisfy  $dX_t = dB_t/\sqrt{n}$  where  $B_t$  is a matrix of i.i.d. complex Brownian motions. We will consider a final time  $T_c$  and initial data  $X_0 = (1 - T_c)^{1/2}Y$ , where  $Y_0$  is either a complex or real i.i.d. matrix. Note that in both cases, the dynamics will be complex. Furthermore, in the real case we will assume that  $Y_0$  has a Gaussian component; its size will be specified in the assumptions below.

In this section we will ignore the additional deterministic correction to (2.21). To avoid confusion, we introduce

$$\hat{\Psi}_n(z, t, \eta) = \operatorname{Re} \left( \sum_{i=-n}^n \log(\lambda_i^z(t) - i\eta) - 2n \int_{\mathbb{R}} \log(x - i\eta) \rho_t^z(x) dx \right). \quad (10.2)$$

Here,  $\rho_t^z$  is as in (5.4) and  $\lambda_i^z$  are the eigenvalues of  $H^z(X_t)$  in (2.9) as usual.

The first main technical step of this section is the following proposition connecting the maximum of  $\hat{\Psi}_n$  over points where  $\lambda_1^z$  is not too small to the maximum of  $\hat{\Psi}_n$  regularized on a scale  $\eta \gg 1/n$ , which can then be estimated using the results from Sections 8–9, in the real and complex case respectively. The proof of this proposition is presented in Section 10.1.1.

**Proposition 10.2.** *There is  $C_1 > 0$  so that the following holds, with  $X_t$  as above. Let  $\varepsilon_1, \varepsilon_3$  be sufficiently small and satisfy  $\varepsilon_1 < \varepsilon_3/10$ . Let  $\mathcal{P}$  be an  $\varepsilon_1$ -regular set of points. Assume that  $Y_0$  is either a complex i.i.d. matrix, or a real i.i.d. matrix with Gaussian component of size at least  $n^{-\varepsilon_1/2000}$ . Then, for all  $\varepsilon_3 > 0$  sufficiently small, and  $n$  large enough,*

$$\mathbb{P} \left[ \max_{z \in \mathcal{P}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \hat{\Psi}_n(z, T_c, (\log n)^{-100} n^{-1}) \geq \max_{z \in \mathcal{P}} \hat{\Psi}_n(z, 0, \hat{\eta}) - C_1(\varepsilon_3)^{1/3} \log n \right] \geq 1 - n^{-50} \quad (10.3)$$

for  $T_c = n^{\varepsilon_3}/n$  and  $\hat{\eta} = n^{\varepsilon_3}/n$ .

We first require the following.

**Proposition 10.3.** Fix any small  $\delta > 0$ . Fix any small  $c_* > 0$ , let  $C_1, C_2 > 0$  and  $c_* \leq a \leq 1$ , and let  $(\log n)^{-C_1} n^{-a} \leq \eta_1 \leq \eta_2 \leq (\log n)^{C_2} n^{-a}$ . Then we have,

$$|\hat{\Psi}(z, t, \eta_1) - \hat{\Psi}(z, t, \eta_2)| \leq (\log n)^{1/2+\delta} \quad (10.4)$$

with overwhelming probability.

**Proof.** By (3.2) when  $X_0$  is complex and Proposition 3.9 when  $X_0$  is real, for any  $\delta > 0$  we have

$$|\langle G_t^z(i\eta) - M_t^z(i\eta) \rangle| \leq \frac{(\log n)^{1/2+\delta}}{n\eta} \quad (10.5)$$

for all  $n^{-c_*} \geq \eta \geq (\log n)^{1/2+\delta}/n$ . Let  $\eta_c := (\log n)^{1/2+\delta}/n \vee \eta_1$ . We first consider the case  $\eta_c > \eta_1$ . It is easy to see that the deterministic part of  $\Psi(z, t, \eta_1) - \Psi(z, t, \eta_c)$  contributes only  $(\log n)^{1/2+\delta}$ . For the random part we have,

$$\begin{aligned} 0 &\leq \sum_{i=1}^n \log((\lambda_i^z(t))^2 + \eta_c^2) - \log((\lambda_i^z(t))^2 + \eta_1^2) = n \int_{\eta_1}^{\eta_c} \text{Im} \langle G_t^z(i\eta) \rangle d\eta \\ &\leq n\eta_c \int_{\eta_1}^{\eta_c} \eta^{-1} \text{Im} \langle G_t^z(i\eta_c) \rangle d\eta \\ &= (n\eta_c) \int_{\eta_1}^{\eta_c} \eta^{-1} \text{Im} \langle G_t^z(i\eta_c) - M^z(i\eta_c) \rangle d\eta + \mathcal{O}((\log n)^{1/2+\delta} \log \log n) \\ &\leq C \log \log n (\log n)^{1/2+\delta} \end{aligned} \quad (10.6)$$

where in the last step we used (10.5) with  $\eta = \eta_c$ . Finally, we estimate

$$|\hat{\Psi}(z, \eta_c) - \hat{\Psi}(z, \eta_2)| \leq n \int_{\eta_c}^{\eta_2} |\langle G_t^z(i\eta) - M^z(i\eta) \rangle| d\eta \leq C(\log n)^{1/2+\delta} \log \log n, \quad (10.7)$$

where we used again (10.5) to estimate the integral. This completes the proof in the case  $\eta_c > \eta_1$ . If  $\eta_c = \eta_1$ , then the estimate follows from (10.7).  $\square$

We now show that the small singular values of  $X - z$  are asymptotically independent for  $z$ 's sufficiently away from each other. This follows in a straightforward manner from [37, Section 7] (see the proof in Appendix A).

**Lemma 10.4.** Fix  $r < 1$  and a small  $\varepsilon > 0$ , and let  $J$  be a set of at most  $\mathcal{O}(\log n)$  points, with  $|z| \leq r$ , which are all at least  $n^{-1/2+\varepsilon}$  from each other. Let  $H_t^z$  be the Hermitization of  $X_t - z$ , with  $X_t$  as above, with  $Y_0$  either a complex i.i.d. matrix or a real i.i.d. matrix with size  $n^{-\varepsilon/2000}$  Gaussian component.

Then for any  $\frac{1}{2} > \varepsilon_2 > 0$ , let  $\lambda_i^z(t)$  be the positive eigenvalues of  $H_t^z$ , with  $t = n^{-1+\varepsilon_2}$ . For any  $C > 0$  and for all  $(\log n)^{-C} \leq s \leq 1$  it holds

$$\mathbb{P} \left[ \bigcap_{z \in J} \{ \lambda_1^z(t) \leq sn^{-1} \} \right] \lesssim \prod_{z \in J} \mathbb{P} [\mu_1^z \leq 2sn^{-1}] + n^{-100}. \quad (10.8)$$

where the  $\mu_1^z$  are the singular values of the shifted complex Ginibre ensemble.

And immediate corollary of the above is the following.

**Proposition 10.5.** *Let  $0 < r < 1$  and  $\varepsilon_1, \varepsilon_3 > 0$  such that  $\varepsilon_1 < \varepsilon_3/10$ . Let  $\mathcal{P} = \bigsqcup_{i=1}^K P_i$  be  $\varepsilon_1$ -regular. Let  $T_c = n^{\varepsilon_3-1}$ , and  $X_t$  as above. Then if  $Y_0$  is either a complex i.i.d. matrix or a real i.i.d. matrix with Gaussian component of size at least  $n^{-\varepsilon_1/2000}$ , then we have*

$$\mathbb{P} \left[ \bigcap_{i=1}^K \{ \exists z \in P_i : \lambda_1^z(T_c) \geq (\log n)^{-10} n^{-1} \} \right] \geq 1 - n^{-90}. \quad (10.9)$$

**Proof.** For  $1 \geq s \geq (\log n)^{-C}$  we have the estimate, for  $\mu_i^z$  being the singular values of the shifted complex Ginibre ensemble,

$$\mathbb{P} [\mu_1^z \leq 2sn^{-1}] \leq Cs, \quad (10.10)$$

by [33, Eq. (4a)]. Therefore, by Lemma 10.4 we have that

$$\mathbb{P} \left[ \bigcap_{z_i \in P_i} \{ \lambda_1^{z_i}(T_c) < (\log n)^{-10} n^{-1} \} \right] \leq n^{-100} + (C/\log n)^{\log n}, \quad (10.11)$$

and so the claim follows.  $\square$

### 10.1.1 Proof of Proposition 10.2

First, we see from Proposition 10.5 that for each  $P_i$  there exists a  $w_i \in P_i$  so that  $|\lambda_1^{w_i}| \geq (\log n)^{-10} n^{-1}$ , with probability at least  $1 - n^{-90}$ . So we bound

$$\max_{z \in \mathcal{P}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \hat{\Psi}_n(z, T_c, (\log n)^{-100} n^{-1}) \geq \max_{\{w_i\}_i} \hat{\Psi}_n(w_i, T_c, (\log n)^{-100} n^{-1}) \quad (10.12)$$

with probability at least  $1 - n^{-90}$ . Letting now  $\eta_2 = (\log n)^{C_2}/n$  for some large  $C_2 > 0$  we see from Proposition 10.3 that,

$$\max_{\{w_i\}_i} |\hat{\Psi}_n(w_i, T_c, (\log n)^{-100} n^{-1}) - \hat{\Psi}_n(w_i, T_c, \eta_2)| \leq (\log n)^{3/4} \quad (10.13)$$

with overwhelming probability. Taking  $C_2 = 100$ , we now see, from Proposition 6.3 and choosing characteristics  $\eta_s^{(i)} = \eta(s, w_i)$  ending at  $\eta_t^{(i)} = \eta_2$  for each  $w_i$ , that we have

$$\max_{\{w_i\}_i} |\Psi_n(w_i, t, \eta_2) - \Psi_n(w_i, 0, \eta_0^{(i)})| \leq (\varepsilon_3)^{1/3} \log n, \quad (10.14)$$

with probability at least  $1 - n^{-100}$ , if  $\varepsilon_3 > 0$  is sufficiently small. Letting now  $\hat{\eta} = n^{\varepsilon_3}/n$ , using  $\eta_0^{(i)} \asymp t$ , by Proposition 10.3, we have that

$$\max_{\{w_i\}_i} |\Psi_n(w_i, 0, \hat{\eta}) - \Psi_n(w_i, 0, \eta_0^{(i)})| \leq (\log n)^{3/4}, \quad (10.15)$$

with probability at least  $1 - n^{-100}$ . Now for any fixed  $P_i$  we have for all  $z, w \in P_i$  by Proposition 2.5 that with overwhelming probability,

$$|\Psi_n(w, 0, \eta_3) - \Psi_n(z, 0, \eta_3)| \leq \frac{n^{4\varepsilon_1}}{n^{\varepsilon_3/2}} \leq n^{-\varepsilon_3/10} \quad (10.16)$$

and so the desired estimate follows.  $\square$

## 10.2 Technical lower bound for GDE

In this section we will develop technical lower bounds for the log characteristic polynomial of Gaussian divisible ensembles. We first deal with the complex i.i.d. case. Fix now  $\varepsilon_1 > 0$  and  $\varepsilon_3 > 0$  with  $\varepsilon_1 = \frac{\varepsilon_3}{10}$ . We construct a specific  $\varepsilon_1$ -regular set  $\hat{\mathcal{P}}$  as follows. First, let  $\mathcal{P}_1$  be a well-spaced set of  $n^{1-\varepsilon_3}$  points of the disc  $\{|z - \frac{1}{2}i| < \frac{1}{4}\}$ . In particular for all distinct  $z, w \in \mathcal{P}_1$  we have  $|z - w|^2 \geq cn^{\varepsilon_3-1}$ . Then, around each  $z \in \mathcal{P}_1$  we add a set of  $P_i$  points of size  $|P_i| = \log n$ , such that for all distinct  $z_1, z_2 \in \mathcal{P}_1 \cup \{z\}$  we have  $n^{\varepsilon_1-1/2} \leq |z_1 - z_2| \leq n^{2\varepsilon_1-1/2}$ . We let  $\hat{\mathcal{P}}$  be the union of all of the  $P_i$  and  $\mathcal{P}_1$ .

**Theorem 10.6.** *There are  $c, C > 0$  so that the following holds. Let  $X$  be a matrix of the form  $X = (1 - T)^{-1/2}Y + T^{1/2}G$  where  $T = n^{-b} + n^{\varepsilon_3-1}$ ,  $G$  is a complex Ginibre matrix and  $Y$  is a complex i.i.d. matrix. Then, we have*

$$\mathbb{P} \left[ \max_{z \in \hat{\mathcal{P}}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \Psi_n(z, (\log n)^{-100} n^{-1}) \leq \sqrt{2}(1 - C(b + (\varepsilon_3)^{1/3})) \log n \right] \leq n^{-cb} + n^{-c\varepsilon_3}. \quad (10.17)$$

**Proof.** Let  $T_3 = n^{\varepsilon_3}/n$ . We can consider  $X$  as the solution at time  $T_3$  of  $dX_s = dB_s/\sqrt{n}$  with  $B_s$  a matrix of i.i.d. complex Brownian motions and  $X_0 = (1 - T_3)^{1/2}Y_0$  with  $Y_0$  an i.i.d. matrix with Gaussian component of size  $n^{-b}$ . Let  $\hat{\Psi}_n(z, s, \eta)$  denote the characteristic polynomial of  $X_s$ , as in (2.21). Then the observable  $\Psi_n$  in the probability in (10.17) is given by  $\hat{\Psi}_n(z, T_3, (\log n)^{-100} n^{-1})$ . By Proposition 10.2 we have that,

$$\max_{z \in \hat{\mathcal{P}}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \hat{\Psi}_n(z, T_3, (\log n)^{-100} n^{-1}) \geq \max_{z \in \hat{\mathcal{P}}} \hat{\Psi}_n(z, 0, n^{\varepsilon_3}/n) - C_1 \varepsilon_3^{1/3} \log n, \quad (10.18)$$

with probability at least  $1 - n^{-50}$ . We then lower bound,

$$\max_{z \in \hat{\mathcal{P}}} \hat{\Psi}_n(z, 0, n^{\varepsilon_3}/n) \geq \max_{z \in \mathcal{P}_1} \hat{\Psi}_n(z, 0, n^{\varepsilon_3}/n) \quad (10.19)$$

We want to apply Theorem 8.1 to the quantity on the RHS of (10.19). However, it is the log characteristic polynomial of an i.i.d. matrix with variance  $(1 - T_3)n^{-1}$  which is not exactly  $n^{-1}$ . Nonetheless, for any  $a > 0$  and matrix  $M$ , we have that,

$$\log \left| \det \begin{pmatrix} -i\eta & aM - z \\ aM^* - z & -i\eta \end{pmatrix} \right| = 2na + \log \left| \det \begin{pmatrix} -i\eta a^{-1} & M - za^{-1} \\ M^* - za^{-1} & -i\eta a^{-1} \end{pmatrix} \right| \quad (10.20)$$

and by the definition of  $\rho_t^z(x)$  in (5.4), with  $c_* = \sqrt{1 - T_3}$ ,

$$n \int \log(x^2 + \eta^2) \rho_0^z(x) dx = 2n \log c_* + \int \log(x^2 + (\eta/c_*)^2) \rho^{z/c_*}(x) dx \quad (10.21)$$

after a rescaling. Therefore, if  $\tilde{\Psi}_n(z, \eta)$  is the log-characteristic polynomial of the matrix  $Y_0$  we have that  $\hat{\Psi}_n(z, 0, \eta) = \tilde{\Psi}_n(z/c_*, \eta/c_*)$ . Note that after the rescaling by  $c_* \asymp 1$ , the set  $\mathcal{P}_1$  remains a well-spaced subset of the unit disc. We denote this set by  $\tilde{\mathcal{P}}_1$ . We let now  $T_b = n^{-b}$  and assume that  $Y_0$  is equal to  $\tilde{X}_{T_b}$  where  $d\tilde{X}_s = \frac{d\tilde{B}_s}{\sqrt{n}}$  where  $\tilde{B}_s$  is a matrix of complex i.i.d. Brownian motions, and  $\tilde{X}_0 = (1 - T_b)^{1/2}\tilde{Y}_0$ , where  $\tilde{Y}_0$  is an i.i.d. complex matrix. Denote the characteristic polynomial of  $\tilde{X}_s$  by  $\tilde{\Psi}_n(z, s, \eta)$ . We write now,

$$\tilde{\Psi}_n(z, T_b, n^{\varepsilon_3}/n) = \left( \tilde{\Psi}_n(z, T_b, n^{\varepsilon_3}/n) - \tilde{\Psi}_n(z, 0, \eta_z) \right) + \tilde{\Psi}_n(z, 0, \eta_z) \quad (10.22)$$

where  $\eta_z$  is a characteristic that ends at  $n^{\varepsilon_3}/n$  at time  $T_{\mathbf{b}}$ . We have that  $\eta_z \asymp n^{-\mathbf{b}}$ . From Proposition 4.1 we see that

$$\max_{z \in \hat{\mathcal{P}}_1} |\tilde{\Psi}_n(z, 0, \eta_z)| \leq C \mathbf{b} \log n, \quad (10.23)$$

with probability at least  $1 - n^{-c\mathbf{b}}$  if  $\mathbf{b} > 0$  is sufficiently small. Therefore on this event,

$$\max_{z \in \hat{\mathcal{P}}_1} \tilde{\Psi}_n(z, t_1, n^{\varepsilon_3}/n) \geq \max_{z \in \hat{\mathcal{P}}_1} \left( \tilde{\Psi}_n(z, t_1, n^{\varepsilon_3}/n) - \tilde{\Psi}_n(z, 0, \eta_z) \right) - C \mathbf{b} \log n. \quad (10.24)$$

On the other hand, Theorem 8.1 then applies to the max on the right-hand-side. We see that for any sufficiently small  $\varepsilon_2 > 0$  we have

$$\max_{z \in \hat{\mathcal{P}}_1} \left( \tilde{\Psi}_n(z, t_1, n^{\varepsilon_3}/n) - \tilde{\Psi}_n(z, 0, \eta_z) \right) \geq \sqrt{2}(1 - C(\varepsilon_2 + \varepsilon_3 + \mathbf{b})) \log n, \quad (10.25)$$

with probability at least  $1 - n^{-c\varepsilon_2}$ . The claim follows.  $\square$

We now deal with the real i.i.d. case. We will develop a lower bound for points in the rectangle consisting of  $z$  s.t.  $\text{Im}[z] \asymp n^{-\alpha}$ . Again, fix  $\varepsilon_1, \varepsilon_3 > 0$  with  $\varepsilon_1 = \frac{\varepsilon_3}{10}$ . Assume also that  $\varepsilon_3 < \frac{\alpha}{1000}$ . Let  $\mathcal{P}_1$  be a set of  $n^{1-\alpha-\varepsilon_3}$  well-spaced points of the rectangle  $\{z : |\text{Re}(z)| \leq \frac{1}{2}, n^{-\alpha} \leq \text{Im}[z] \leq 2n^{-\alpha}\}$ . Note for distinct  $z, w \in \mathcal{P}_1$  we have that  $|z - w|^2 \geq cn^{\varepsilon_3-1}$ . For each  $z \in \mathcal{P}_1$  we add a set of  $P_i$  of size  $|P_i| = \log n$  s.t. for distinct  $z_1, z_2 \in P_1 \cup \{z\}$  we have  $n^{\varepsilon_1-1/2} \leq |z_1 - z_2| \leq n^{2\varepsilon_2-1/2}$ . We define  $\hat{P}$  to be the union of all of the  $P_i$  as well as  $\mathcal{P}_1$ .

**Theorem 10.7.** *There are  $c, C > 0$  so that the following holds. Let  $T_{\mathbf{b}} = n^{-\mathbf{b}}$  and  $T_3 = n^{\varepsilon_3-1}$  with  $\mathbf{b} > 0$  sufficiently small, satisfying  $\mathbf{b} < 10^{-6}\varepsilon_3$ . Let  $X = (1 - T_{\mathbf{b}} - T_3)^{1/2}Y + \sqrt{T_{\mathbf{b}}}G_r + \sqrt{T_3}G_c$  where  $Y$  is a real i.i.d. matrix, and  $G_r$  and  $G_c$  are from the real and complex Ginibre ensembles, respectively. Then,*

$$\mathbb{P} \left[ \max_{z \in \hat{P}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \Psi_n(z, (\log n)^{-100} n^{-1}) \leq \sqrt{2}(1 - C\varepsilon_3^{1/3}) \log n \right] \leq n^{-c\mathbf{b}}. \quad (10.26)$$

Above,  $\Psi_n(z, \eta)$  is as in (2.21) with  $\beta = 1$ .

**Proof.** The proof is similar to Theorem 10.6 and so we focus on the differences. We first consider  $X$  as the solution at time  $T_3$  of  $dX_s = dB_s/\sqrt{n}$  with  $B_s$  a matrix of i.i.d. complex Brownian motions and  $X_0 = (1 - T_3)^{1/2}Y_0$  with  $Y_0$  a real i.i.d. matrix with a real Gaussian component of size of order  $T_{\mathbf{b}}$ .

Denote by  $\hat{\Psi}_n(z, t, \eta)$  the log characteristic polynomial of  $X_t$  as in (10.2) without the additional  $\beta = 1$  deterministic correction that appears in (2.21). Arguing as in the proof of Theorem 10.6 we have by Proposition 10.2 that,

$$\max_{z \in \hat{P}: |\lambda_1^z| \geq (\log n)^{-10} n^{-1}} \Psi_n(z, (\log n)^{-100} n^{-1}) \geq \max_{z \in \hat{\mathcal{P}}_1} \left( \hat{\Psi}_n(z, 0, n^{\varepsilon_3}/n) + \alpha \log n \right) - C_1(\varepsilon_3)^{1/3} \log n. \quad (10.27)$$

Let now  $Y_0$  be  $\tilde{X}_{T_{\mathbf{b}}}$  where  $d\tilde{X}_s = \frac{d\tilde{B}_s}{\sqrt{n}}$  where  $\tilde{B}$  is a matrix of i.i.d. real Brownian motions, with  $\tilde{X}_0 = (1 - T_{\mathbf{b}})^{1/2}\tilde{Y}$  with  $\tilde{Y}$  a real i.i.d. matrix. Denote by  $\tilde{\Psi}_n(z, s, \eta)$  its log characteristic polynomial as in (2.21), including the  $\beta = 1$  correction term. By a rescaling (similar to in the proof of Theorem 10.6) we have,

$$\max_{z \in \hat{\mathcal{P}}_1} \left( \hat{\Psi}_n(z, 0, n^{\varepsilon_3}/n) + \alpha \log n \right) = \max_{z \in \tilde{\mathcal{P}}_1} \left( \tilde{\Psi}_n(z, T_{\mathbf{b}}, c_*^{-1} n^{\varepsilon_3}/n) \right) + \mathcal{O}(1) \quad (10.28)$$

where  $c_* \asymp 1$  is a constant and  $\tilde{\mathcal{P}}_1$  is a set of  $n^{1-\alpha-\varepsilon_3}$  well spaced points lying in the rectangle  $\{z : |\text{Re}(z)| \leq \frac{3}{4}, n^{-\alpha} \leq 2 \text{Im}[z] \leq 5n^{-\alpha}\}$ . We conclude the proof similarly to Theorem 10.6, using now Theorem 9.5 (taking the  $\mathbf{c} > 0$  in that theorem to be  $\mathbf{c} = \mathbf{b}^3$ ).  $\square$

## 11 Lower bound for $\Psi_n(z)$

We now remove the Gaussian component in the lower bound in Theorem 10.6. For this purpose we use a comparison argument (see, e.g., Proposition 11.3 below). The following deterministic lemma is a straightforward consequence of writing  $\langle G^z(i\eta) \rangle$  in terms of eigenvalues and so the proof is omitted.

**Lemma 11.1.** *The following holds deterministically for any matrix of the form  $\begin{pmatrix} 0 & M - z \\ M^* - \bar{z} & 0 \end{pmatrix}$  with resolvent  $G^z(i\eta)$  and eigenvalues  $\lambda_i^z$ . First, for any  $\eta > 0$ , we have*

$$n\eta \operatorname{Im}[\langle G^z(i\eta) \rangle] < \frac{1}{10} \implies \lambda_1(z) > \eta \quad (11.1)$$

Second, assume that the bound,

$$N\tilde{\eta} \operatorname{Im}[\langle G^z(i\tilde{\eta}) \rangle] \leq (\log n)^4, \quad (11.2)$$

holds for  $\tilde{\eta} = (\log n)^2/n$ . Then if  $\lambda_1(z) > n^{-1}(\log n)^{-10}$  we have that,

$$n\eta_1 \operatorname{Im}[\langle G^z(i\eta_1) \rangle] \leq (\log n)^{-1}, \quad (11.3)$$

if  $\eta_1 = (\log n)^{-20}/n$ .

For this section we will denote by  $Q$  be a smooth function which is equal to 1 for  $|x| < 1/20$  and equal to 0 for  $|x| > 1/10$ . Let now,

$$\eta_1 := \frac{1}{n(\log n)^{20}}. \quad (11.4)$$

For any i.i.d. ensemble we know that  $N\eta_2 \operatorname{Im}[\langle G^z(i\eta_2) \rangle] \leq (\log n)^4$  with overwhelming probability with  $\eta_2 = (\log n)^2/n$  by (3.2). Therefore, by Lemma 11.1, with overwhelming probability on the event  $\lambda_1^z \geq (\log n)^{-10}n^{-1}$ , we have

$$Q(n\eta_1 \operatorname{Im}\langle G^z(i\eta_1) \rangle) = 1. \quad (11.5)$$

Let now  $\hat{\eta} := (\log n)^{-100}n^{-1}$ . We have the following.

**Lemma 11.2.** *Let  $X$  be an i.i.d. matrix and  $\hat{P}$  a set of points. Let  $\mathfrak{b} > 0$  and  $\varepsilon_3 > 0$  be sufficiently small. There are constants  $c, C > 0$  so that,*

$$\mathbb{P} \left[ \max_{z \in \hat{P}} Q(n\eta_1 \operatorname{Im}\langle G^z(i\eta_1) \rangle) \left( \Psi_n(z, X, \hat{\eta}) - \Psi_n(z, X, n^{-\mathfrak{b}}) \right) \leq \sqrt{2} \left( 1 - C\varepsilon_3^{1/3} \right) \log n \right] \leq n^{-c\mathfrak{b}} \quad (11.6)$$

in the case that:

1.  $X$  is a complex i.i.d. matrix with Gaussian component of size at least  $n^{-\mathfrak{b}}$  and  $\hat{P}$  is a certain set of at most  $n$  points of the unit disc; in this case  $\varepsilon_3 = \mathfrak{b}$ .
2.  $X = (1 - n^{\varepsilon_3 - 1} - n^{-\mathfrak{b}})^{1/2} Y + n^{\varepsilon_3/2 - 1/2} G_c + n^{-\mathfrak{b}/2} G_r$  where  $G_r, G_c$  are real and complex Ginibre matrices and  $Y$  is a real i.i.d. matrix, and  $\hat{P}$  is a certain set of at most  $n$  points of the strip  $\{z : n^{-\alpha} \leq 2 \operatorname{Im}[z] \leq 5n^{-\alpha}, |\operatorname{Re}[z]| \leq \frac{3}{4}\}$ , with  $\alpha \in (0, 1/2)$ , and  $\mathfrak{b} < 10^{-6}\varepsilon_3$ . In this case,  $\Psi_n(z, X, \eta_3)$  is as in (2.21) with the  $\beta = 1$  deterministic correction.

**Remark.** *The second case holds also for a set of points in the region  $\text{Im}[z] \geq c$ ,  $|z| \leq 1 - c$  for and small  $c > 0$ , as can be seen from the proof. However, we will not need this as we will only prove our lower bounds near the real axis.*

**Proof.** [Proof of Lemma 11.2] By the discussion immediately preceding this lemma and Theorems 10.6–10.7 we see that the lemma holds if the term  $\Psi_n(z, X, n^{-b})$  is not present in (11.6). So we need only to show that this term contributes  $\mathcal{O}(\varepsilon_3^{1/3} \log n)$  to the max. For the complex case, this follows from Proposition 4.1 (recall that in that case  $\varepsilon_3 = b$ ). For the real case, we first use Proposition 6.3 to remove the complex Ginibre contribution at the cost of  $\mathcal{O}(\varepsilon_3^{1/3} \log n)$ , leaving us to control the max of the log characteristic polynomial of a real i.i.d. matrix at scale  $\eta \asymp n^{-b}$ . This follows also from Proposition 4.1.  $\square$

We are now ready to state our comparison argument for the quantity on the LHS of (11.6); the proof of this result is presented in Appendix F.2. We denote by  $\Xi(X)$  the function in the probability on the LHS of (11.6), considered as a function on the space of matrices to  $\mathbb{R}$ ,

$$\Xi(X) := \max_{z \in \hat{P}} Q(n\eta_1 \text{Im}\langle G^z(i\eta_1) \rangle) \left( \Psi_n(z, X, \eta_3) - \Psi_n(z, X, n^{-b}) \right) \quad (11.7)$$

We have the following moment matching result for  $\Xi$ . The proof is presented in Appendix F.2.

**Proposition 11.3.** *Let  $F$  be a Schwarz function. Let  $X_1$  and  $X_2$  be two either real or complex i.i.d. matrices matching the moments up to third order and matching the fourth moment up to  $n^{-2}t$ . That is,*

$$\left| \mathbb{E} \left[ (X_1)_{ij}^a (\bar{X}_1)_{ij}^b \right] - \mathbb{E} \left[ (X_2)_{ij}^a (\bar{X}_2)_{ij}^b \right] \right| \leq \mathbf{1}_{a+b=4} t n^{-2} \quad (11.8)$$

for all  $0 \leq a + b \leq 4$  and  $i, j$ . Then for all  $\varepsilon > 0$  we have

$$\left| \mathbb{E}[F(\Xi(X_1))] - \mathbb{E}[F(\Xi(X_2))] \right| \leq \|F\|_{C^5} (n^{-\varepsilon} + n^{10\varepsilon}t). \quad (11.9)$$

In the real i.i.d. case we first need to remove the small complex Gaussian component. For this we use the following set up. We let  $X_0$  be a real i.i.d. matrix with a size  $n^{-\varepsilon}$  Gaussian component, and let  $dX_s = \frac{dB_s}{\sqrt{n}} - \frac{X_s}{2} dt$  where  $B_s$  is a matrix of complex Brownian motions. The proof is presented in Appendix B. We point out that a proof similar in spirit to this one was performed in [90] in a different setting.

**Proposition 11.4.** *Let  $X_t$  and  $\Xi$  be as above, and let  $F$  be a Schwarz function. Assume that the points  $\hat{P}$  satisfy  $\text{Im}[z] \geq n^{c_1-1/2}$  for some  $c_1 > 0$  and all  $z \in \hat{P}$ . As long as  $\varepsilon > 0$  satisfies  $\varepsilon < \frac{c_1}{2000}$  we have,*

$$\left| \mathbb{E}[F(\Xi(X_t))] - \mathbb{E}[F(\Xi(X_0))] \right| \leq C \|F\|_{C^4} \left( (1 + nt) n^{-c_1/100} + n^{3/4}t \right). \quad (11.10)$$

Finally, we rely on the following lemma to remove the last bit of regularization in  $\Xi$ .

**Lemma 11.5.** *Let  $X$  be a real or complex i.i.d. matrix, and let  $\Psi_n(z, \eta)$  denote its log characteristic polynomial in (2.21). For any  $D > 0$  and any  $C_2 > 50$  we have*

$$\mathbb{P} \left[ \lambda_1^z \geq (\log n)^{-20} n^{-1}, |\Psi_n(z, n^{-1}(\log n)^{-C_2}) - \Psi_n(z, 0)| > (\log n)^{-10} \right] \leq n^{-D} \quad (11.11)$$

for  $n$  large enough and all  $|z| < r$ .

**Proof.** Let  $\eta_2 := (\log n)^{-C_2} n^{-1}$  for notational simplicity. We have that,

$$\partial_\eta \int \log(x^2 + \eta^2) \rho^w(x) dx = \text{Im}[m^w(i\eta)] \leq C, \quad (11.12)$$

so the deterministic contribution to  $\Psi_n(z, 0) - \Psi(z, \eta_2)$  is less than  $CN\eta_2 \leq C(\log n)^{-50}$ . Using the notation  $\lambda_i = \lambda_i^z$ , we have

$$\sum_i |\log(\lambda_i^2 + \eta_2^2) - \log(\lambda_i^2)| \leq C\eta_2^2 \sum_i \frac{1}{\lambda_i^2}. \quad (11.13)$$

When  $\lambda_1 \geq (\log n)^{-20} n^{-1}$  we can bound

$$\sum_{|i| < (\log n)^{10}} \frac{\eta_2^2}{\lambda_i^2} \leq (\log n)^{-50}. \quad (11.14)$$

For  $i < n^{1-1/100}$  we have that  $|\lambda_i - \gamma_i| \leq \frac{(\log n)^2}{n}$  with overwhelming probability, and since  $\gamma_i \asymp i/n$  we have,

$$\sum_{(\log n)^{10} < i < n/2} \frac{\eta_2^2}{\lambda_i^2} \leq \frac{C}{(\log n)^{100}} \sum_{i>1} \frac{1}{i} \leq C(\log n)^{-98}. \quad (11.15)$$

Finally, if  $i > n^{1-1/100}$  then  $\lambda_i \geq c(i/n)$  so  $\sum_{i>n/2} \frac{\eta_2^2}{\lambda_i^2} \leq n^{-1/2}$ . The claim now follows.  $\square$

## 11.1 Proof of lower bounds of Theorem 2.2 and 2.3

We begin with the lower bound of Theorem 2.3. The lower bound of (2.6) follows from that of (2.7), so we only prove the latter. Let  $0 < \alpha < \frac{1}{2}$ . We will first prove that the lower bound holds for real i.i.d. matrices with sufficiently large Gaussian component. I.e., we will remove the complex Gaussian component from Lemma 11.2 by applying Proposition 11.4.

Fix  $\varepsilon_3 > 0$  and  $\mathfrak{b} > 0$  with  $\mathfrak{b} = 10^{-7}\varepsilon_3$ . Let  $X_0$  be a real i.i.d. matrix with Gaussian component of size at least  $n^{-\mathfrak{b}}$ . Let  $X_t = (1 - e^{-t})^{1/2} X_0 + e^{-t/2} G_c$  where  $G_c$  is complex Ginibre matrix, and  $t = n^{\varepsilon_3 - 1}$ . By Lemma 11.2 it holds that,

$$\max_{z \in \hat{P}} Q(n\eta_1 \text{Im}\langle G(i\eta_1) \rangle) \left( \Psi_n(z, X_t, \hat{\eta}) - \Psi_n(z, X_t, n^{-\mathfrak{b}}) \right) \geq \sqrt{2}(1 - C\varepsilon_3^{1/3}) \log n \quad (11.16)$$

with probability at least  $1 - n^{-c\varepsilon_3}$ . As long as  $\varepsilon_3 < 10^{-3}(\frac{1}{2} - \alpha)$  (recalling  $\mathfrak{b} = 10^{-7}\varepsilon_3$ ), we see that the above holds for  $X_0$  as well, by applying Proposition 11.4 (with  $F$  being some appropriate smoothed indicator function). Hence, (11.16) holds for any real i.i.d. ensemble with a sufficiently large Gaussian component, of size  $n^{-c_*\varepsilon_3}$ . Now, given any real i.i.d. ensemble  $Y$ , we may find a Gaussian divisible  $X$  whose first three moments match with  $Y$  and the fourth moment matches up to order  $n^{-2-c_*\varepsilon_3}$ . Hence, by Proposition 11.3, we have that (11.16) holds also for the matrix  $Y$ , with probability at least  $1 - n^{-c_*\varepsilon_3/2}$ .

Now, by applying Proposition 4.1, we see that for the matrix  $Y$ ,

$$\max_{z \in \hat{P}} Q(n\eta_1 \text{Im}\langle G^z(i\eta_1) \rangle) \Psi_n(z, Y, \hat{\eta}) \geq \sqrt{2}(1 - C\varepsilon_3^{1/3}) \log n \quad (11.17)$$

with probability at least  $1 - n^{-c\varepsilon_3}$  after possibly adjusting the constants  $C, c > 0$ . We may assume that  $C(\varepsilon_3)^{1/3} < \frac{1}{2}$ , so the RHS is positive.

To conclude the proof we are thus left only with removing the  $\hat{\eta}$ -regularization above, which we now turn to. Since the RHS of (11.17) is positive, some points on the LHS must be non-zero. Any point on the LHS which is non-zero must have that  $\Psi_n(z, \hat{\eta}) > 0$  and that  $n\eta_1 \text{Im}\langle G^z(i\eta_1) \rangle < \frac{1}{10}$ . Then by (11.1) we have that  $\lambda_1^z > \eta_1$  for such  $z$ 's. Then by Lemma 11.5, with overwhelming probability, for all such  $z$ 's such that  $Q\Psi$  is non-zero we have

$$|\Psi_n(z, \hat{\eta}) - \Psi_n(z, 0)| \leq \frac{1}{\log n}. \quad (11.18)$$

Hence, if  $z \in \hat{P}$  is a maximizing point in (11.17) we have

$$Q(n\eta_1 \text{Im}\langle G^z(i\eta_1) \rangle)\Psi_n(z, \hat{\eta}) \leq Q(n\eta_1 \text{Im}\langle G^z(i\eta_1) \rangle)\Psi_n(z, 0) + (\log n)^{-1} \leq \Psi_n(z, 0) + (\log n)^{-1}, \quad (11.19)$$

using that  $0 \leq Q \leq 1$ . We thus conclude the lower bound in (2.7).

The proof of the lower bound of Theorem 2.2 is similar but easier. We start from the first part of Lemma 11.2 and proceed as in the above proof, except that we do not need the intermediate Proposition 11.4. Instead, we conclude directly that (11.17) holds for any complex i.i.d. matrix using directly Proposition 11.3. The rest is the same.  $\square$

## A Proof of Lemma 10.4

The proof of this lemma follows closely the proof of [37, Section 7], with a few very minor modifications. For this reason we only present a sketch of the proof and highlight the differences. The arguments in [37, Section 7] considered the flow (A.1) with initial condition being the eigenvalues of a complex i.i.d. matrix. In the current case we will also consider the case when the initial data are given by eigenvalues of a matrix of type  $M$  (see Definition 3.8), where the real part has a large (almost order one) Gaussian component.

The proof in this case is analogous to [37, Section 7] once the a priori estimate (A.3) is proven. While in the complex case (A.3) follows by directly [37, Lemma 7.9] and [38, Theorem 3.1], we need to prove this bound, in Corollary B.5 below, when the initial data is real or of type  $M$ . The second difference is that [37, Section 7] considered (A.1), and performed a coupling, only for finitely many different  $z$ 's; instead for the proof of Lemma 10.4 we need to couple the flows (A.1) and (A.2) for a slightly diverging number of different  $z$ 's, in fact  $\log n$  of them will suffice. With these changes in mind we now present the main steps of the proof.

In the argument below, we will couple the eigenvalue flows to some auxiliary processes and then derive the estimate (10.8) after a short time  $t = n^{\varepsilon'}/n$ , for  $\varepsilon' > 0$  being sufficiently small, where “sufficiently small” will depend on the  $\varepsilon > 0$  in the hypotheses of Lemma 10.4. However, the statement of the lemma is for  $t = n^{\varepsilon_2-1}$  for possibly larger  $\varepsilon_2 > 0$ . This case can be reduced to the one we derived below, simply by starting the coupling argument later in the flow of the eigenvalues  $\lambda_i^z(s)$ , (i.e., from  $t_0 = n^{\varepsilon_2-1} - n^{\varepsilon'-1}$ ) starting from a different i.i.d. ensemble of type  $M$ . For notational simplicity we ignore this distinction in the proof below.

Recall that the eigenvalues of the Hermitization  $H_t^z$  of  $X_t - z$  are the solution of

$$d\lambda_i^z(t) = \frac{db_i^z(t)}{\sqrt{2n}} + \frac{1}{2n} \sum_{j \neq i} \frac{1}{\lambda_j^z(t) - \lambda_i^z(t)} dt. \quad (A.1)$$

Here  $\{b_i^z(t)\}_{i \in [n]}$  is a family of standard i.i.d. real Brownian motions, and  $b_{-i}^z(t) = -b_i^z(t)$ ; in particular, this ensures that  $\lambda_{-i}^z(t) = -\lambda_i^z(t)$  for  $i \in [n]$  and any  $t \geq 0$ . The rigidity of these eigenvalues close to zero follows by (2.19) in the complex case and by Lemma 3.9 in the real case.

We now consider the joint evolution of  $\lambda_i^{z_l}(t)$  for all  $z_l \in J$ . In order to prove their asymptotical independence, we couple their flows with the following fully independent flows (see e.g. [37, Section 7]):

$$d\mu_i^{(l)}(t) = \frac{d\beta_i^{(l)}(t)}{\sqrt{2n}} + \frac{1}{2n} \sum_{j \neq i} \frac{1}{\mu_j^{(l)}(t) - \mu_i^{(l)}(t)} dt, \quad (\text{A.2})$$

with initial data  $\{\mu_i^{(l)}(0)\}_{i \in [n]}$  being the singular values of  $\log n$  independent complex Ginibre matrices  $X^{(l)}$ , and  $\mu_{-i}^{(l)}(0) = -\mu_i^{(l)}(0)$ . Here  $\{\beta_i^{(l)}\}_{i \in [n], l \in [\log n]}$  is a family of standard real i.i.d. Brownian motions, which are then defined also for negative indices by symmetry. To make sure that the coupling argument in [37] can be applied we need the overlap bound (see [37, Lemma 7.9], which is needed to ensure [37, Assumption 7.11 (c)]):

$$|\langle \mathbf{u}_i^{z_1}(t), \mathbf{u}_j^{z_2}(t) \rangle| + |\langle \mathbf{v}_i^{z_1}(t), \mathbf{v}_j^{z_2}(t) \rangle| \leq n^{-\omega_E}, \quad 1 \leq i, j \leq n^{\omega_B}, \quad (\text{A.3})$$

for some constants  $\omega_E, \omega_B > 0$ , uniformly in  $t \leq n^{100\epsilon}/n$ . Here  $\mathbf{w}_i^z(t) = (\mathbf{w}_i^z(t), \pm \mathbf{v}_i^z(t))$  are the eigenvectors of  $H_t^z$ . This follows by [37, Lemma 7.9] if the initial condition of  $X_t$  is a complex i.i.d. matrix and it is proven in Corollary B.5 if the initial condition of  $X_t$  is a type  $M$  matrix.

Then, by the coupling argument in [37, Section 7.2.1], it follows that there exists a small  $\omega > 0$  such that

$$|\lambda_1^{z_l}(t) - \mu_1^{(l)}(t)| \leq \frac{1}{n^{1+\omega}}, \quad (\text{A.4})$$

with overwhelming probability in the joint probability space of all the  $\{\lambda_1^{z_l}(t)\}_{z_l \in J}$  (recall that  $J$  consists of  $\log n$  points). We point out that the coupling in [37, Section 7.2.1] was performed only for finitely many  $z$ 's, however, inspecting the proof, it is clear that it is actually possible to couple the flow for up to  $n^c$  different  $z$ 's for some sufficiently small fixed  $c > 0$ .

Then, we compute

$$\begin{aligned} \mathbb{P} \left[ \bigcap_{l=1}^{\log n} \{\lambda_1^{z_l}(t) \leq sn^{-1}\} \right] &\leq \mathbb{P} \left[ \bigcap_{l=1}^{\log n} \left\{ \mu_1^{(l)}(t) \leq sn^{-1} + |\mu_1^{(l)}(t) - \lambda_1^{z_l}(t)| \right\} \right] \\ &\leq \mathbb{P} \left[ \bigcap_{l=1}^{\log n} \left\{ \mu_1^{(l)}(t) \leq sn^{-1} + n^{-1-\omega} \right\} \right] + n^{-100} \\ &= \prod_{l=1}^{\log n} \mathbb{P} \left[ \left\{ \mu_1^{(l)}(t) \leq sn^{-1} + n^{-1-\omega} \right\} \right] + n^{-100} \\ &\leq \prod_{l=1}^{\log n} \mathbb{P} \left[ \left\{ \lambda_1^{z_l}(t) \leq sn^{-1} + n^{-1-\omega} + |\mu_1^{(l)}(t) - \lambda_1^{z_l}(t)| \right\} \right] + n^{-100} \\ &\leq \prod_{l=1}^{\log n} \mathbb{P} \left[ \left\{ \lambda_1^{z_l}(t) \leq sn^{-1} + 2n^{-1-\omega} \right\} \right] + n^{-100}. \end{aligned} \quad (\text{A.5})$$

Noticing that  $s \geq (\log n)^{-C}$ , and so that  $sn^{-1} + 2n^{-1-\omega} \leq 2sn^{-1}$ , this concludes the proof.  $\square$

## B Removal of a small complex Gaussian divisible ensemble from a real GDE

The purpose of this section is to prove Proposition 11.4. Recall that our set-up is that  $X_t$  satisfies  $dX_t = \frac{dB_t}{\sqrt{n}} - \frac{X_t}{2}dt$  where  $B_t$  is an i.i.d. matrix of complex Brownian motions and  $X_0$  is a real i.i.d. matrix. Moreover, we are considering the observable,

$$\Xi(X) := \max_{z \in \hat{P}} Q(n\eta_1 \operatorname{Im}\langle G^z(i\eta_1) \rangle) \left( \Psi_n(z, X, \eta_3) - \Psi_n(z, X, n^{-b}) \right). \quad (\text{B.1})$$

For  $z_i \in \hat{P}$  let us denote

$$\mathcal{X}_i = Q(n\eta_1 \operatorname{Im}\langle G^{z_i}(i\eta_1) \rangle) Y_i \quad (\text{B.2})$$

$$Y_i = \Psi_n(z, X, \eta_3) - \Psi_n(z, X, n^{-b}) = \int_{\eta_3}^{n^{-b}} n \operatorname{Im}[\langle G^{z_i}(i\eta) - M^{z_i}(i\eta) \rangle] d\eta - c_i \quad (\text{B.3})$$

for some  $n$ -dependent constant  $c_i$  that is  $\mathcal{O}(\log n)$ . Fixing a small  $\mathfrak{a} > 0$  we see that,

$$|\Xi(X) - Z_{\mathfrak{a}}(X)| := \left| \Xi(X) - \frac{1}{n^{\mathfrak{a}}} \log \left( \sum_{i \in \hat{P}} e^{n^{\mathfrak{a}} \mathcal{X}_i} \right) \right| \leq \frac{\log n}{n^{\mathfrak{a}}}. \quad (\text{B.4})$$

(with the  $Z_{\mathfrak{a}}(X)$  defined implicitly in the obvious way). It suffices to prove the estimate for  $Z_{\mathfrak{a}}(X)$ , after taking  $\mathfrak{a} > 0$  sufficiently small. Define now,

$$F_1(X) = F(Z_{\mathfrak{a}}(X)). \quad (\text{B.5})$$

In (B.6) below, the derivatives  $\partial_{ab}$  are with respect to the  $(a, b)$  entries of the Hermitization of  $X$ , as  $F_1$  depends on  $X$  only through its Hermitization. Moreover, we recall the definition of  $\sum_{ab}$  in (E.22).

**Lemma B.1.** *Let  $F_1$  be as above. Then,*

$$\frac{d}{dt} \mathbb{E}[F_1(X_t)] = -\frac{e^{-t}}{2n} \mathbb{E} \left[ \sum_{ab} \partial_{ab}^2 F_1(X_t) \right] + \mathcal{O}(n^{1/2+\varepsilon+3\mathfrak{a}}). \quad (\text{B.6})$$

for any  $\varepsilon > 0$ .

**Proof.** Let,

$$\frac{a_t}{n} := \mathbb{E}[\operatorname{Re}[X_{ab}(t)]^2] = \frac{1}{n} - \mathbb{E}[(\operatorname{Im}[X_{ab}](t))^2] = \frac{1 + e^{-t}}{2n} \quad (\text{B.7})$$

Then, by Itô's lemma, we have

$$\frac{d}{dt} \mathbb{E}[F_1(X_t)] = \sum_{a,b=1}^N \mathbb{E} \left[ \frac{1}{4n} (\partial_{\operatorname{Re}[X_{ab}]}^2 + \partial_{\operatorname{Im}[X_{ab}]}^2) F_1(X_t) - \frac{\operatorname{Re}[X_{ab}]}{2} \partial_{\operatorname{Re}[X_{ab}]} F_1 - \frac{\operatorname{Im}[X_{ab}]}{2} \partial_{\operatorname{Im}[X_{ab}]} F_1 \right]. \quad (\text{B.8})$$

Due to a cumulant expansion, similar to e.g., (E.23), we have

$$\mathbb{E} \left[ \frac{\operatorname{Re}[X_{ab}]}{2} \partial_{\operatorname{Re}[X_{ab}]} F_1 + \frac{\operatorname{Im}[X_{ab}]}{2} \partial_{\operatorname{Im}[X_{ab}]} F_1 \right] = \mathbb{E} \left[ \frac{a_t}{2n} \partial_{\operatorname{Re}[X_{ab}]}^2 F_1 + \frac{1 - a_t}{2n} \partial_{\operatorname{Im}[X_{ab}]}^2 F_1 \right] + \mathcal{O}(n^{\varepsilon-3/2}) \quad (\text{B.9})$$

Here, the error in the cumulant expansion can be controlled by Lemma F.1, the derivatives of  $F_1$  with respect to matrix elements are bounded above by some small powers of the derivatives of the  $\mathcal{X}_i$ . However, by direct calculation,

$$\left| \partial_{ij}^k \mathcal{X}_i \right| \leq C_k \sup_{\eta_1 \wedge \eta_3 \leq \eta \leq 1} |G_{ab}(i\eta)|^{2k+4} \leq n^\varepsilon \quad (\text{B.10})$$

for any  $\varepsilon > 0$  with overwhelming probability. Moreover, the derivatives are deterministically bounded by  $n^{3k}$ . The claim now follows once we note that we have shown,

$$\begin{aligned} \frac{d}{dt} \mathbb{E}[F_1(X_t)] &= \frac{1-2a_t}{4n} \sum_{a,b=1}^n \mathbb{E} \left[ (\partial_{\text{Re}[X_{ab}]}^2 - \partial_{\text{Im}[X_{ab}]}^2) F_1(X_t) \right] + \mathcal{O}(n^{\varepsilon-3/2}) \\ &= \frac{1-2a_t}{2n} \sum_{a,b=1}^n \mathbb{E} \left[ (\partial_{X_{ab}}^2 + \partial_{\bar{X}_{ab}}^2) F_1(X_t) \right] + \mathcal{O}(n^{\varepsilon-3/2}) \\ &= \frac{1-2a_t}{2n} \sum_{ab} \mathbb{E} \left[ \partial_{ab}^2 F_1(X_t) \right] + \mathcal{O}(n^{\varepsilon-3/2}) \end{aligned} \quad (\text{B.11})$$

where  $2\partial_{X_{ab}} = \partial_{\text{Re}[X_{ab}]} - i\partial_{\text{Im}[X_{ab}]}$  is the usual Wirtinger derivative.  $\square$

**Proof.** [Proof of Proposition 11.4] By direct calculation, the derivative  $\sum_{ab} \partial_{ab}^2 F_1(X)$  can be bounded above by a constant times  $n^{2a}$  times the maximum of the absolute value of the following five terms:

$$\mathcal{E}_1 := n\eta_1 \sum_{a,b} \partial_{ab}^2 \langle \text{Im} G^{zi}(i\eta_1) \rangle, \quad \mathcal{E}_2 := (n\eta_1)^2 \sum_{a,b} (\partial_{ab} \langle \text{Im}[G^{zi}(i\eta_1)] \rangle) (\partial_{ab} \langle \text{Im}[G^{zj}(i\eta_1)] \rangle) \quad (\text{B.12})$$

$$\mathcal{E}_3 := \sum_{ab} \partial_{ab}^2 \int_{\eta_2}^{n^{-c_2}} n \text{Im} \langle G^{zi}(iu) - M^{zi}(iu) \rangle du, \quad (\text{B.13})$$

$$\mathcal{E}_4 := \sum_{ab} \left( \partial_{ab} \int_{\eta_2}^{n^{-c_2}} n \text{Im} \langle G^{zi}(iu) - M^{zi}(iu) \rangle du \right) \left( \partial_{ab} \int_{\eta_2}^{n^{-c_2}} n \text{Im} \langle G^{zj}(iu) - M^{zj}(iu) \rangle du \right) \quad (\text{B.14})$$

$$\mathcal{E}_5 := n\eta_1 \sum_{ab} (\partial_{ab} \langle \text{Im}[G^{zi}(i\eta_1)] \rangle) \left( \partial_{ab} \int_{\eta_2}^{n^{-c_2}} n \text{Im} \langle G^{zj}(iu) - M^{zj}(iu) \rangle du \right). \quad (\text{B.15})$$

Therefore, Proposition 11.4 follows immediately from the estimates (B.4) and (B.6) and the following, since we are assuming that  $\text{Im}[z_i] \geq n^{c_1-1/2}$  for all  $z_i \in \hat{P}$  (we choose, e.g.,  $\mathbf{a} = \frac{c_1}{100}$ ). The proof of this lemma is presented below, after Corollary B.6.

**Lemma B.2.** *Fix any small  $\varepsilon > 0$ . If  $X$  is a matrix of type  $M$ , having real Gaussian component of size  $n^{-\varepsilon/100}$ , then each of the terms in (B.12)–(B.15) is bounded in absolute value, with overwhelming probability, by*

$$n^2 \log n \left( \frac{n^{7\varepsilon/3}}{n \min_i |\text{Im} z_i|^2} + n^{-\varepsilon/3} \right). \quad (\text{B.16})$$

$\square$

## B.1 Proof of the local law to estimate (B.6)

The main result of this section is the following local law for real matrices with a large Gaussian component. The proof of this proposition is presented at the end of this section.

**Proposition B.3.** *Fix any small  $\xi, \omega > 0$ , and fix  $|z_1 - z_2| \leq n^{-\omega}$ . Let  $X$  be a real i.i.d matrix having a Gaussian component of size  $n^{-\xi}$ . Then, with overwhelming probability, we have*

$$|\langle (G^{z_1}(i\eta_1)A_1G^{z_2}(i\eta_2) - M^{z_1, z_2}(i\eta_1, A_1, i\eta_2))A_2 \rangle| \lesssim n^{10\xi} \left( \frac{1}{n\eta_*^{3/2}(|z_1 - z_2|^2 + |\eta_1| + |\eta_2|)^{1/2}} + \frac{1}{n^{3/2}\eta_*^{5/2}} \right), \quad (\text{B.17})$$

with  $\eta_* := |\eta_1| \wedge |\eta_2|$ , uniformly in  $\eta_* \geq n^{-1+100\xi}$ , and matrices  $\|A_i\| \lesssim 1$ .

Furthermore, (B.17) holds if  $X$  is replaced with a matrix of type  $M$ , as defined in Definition 3.8, such that its real component has a Gaussian component of size  $n^{-\xi}$ . In this case, we also have

$$|\langle (G^{z_1}(i\eta_1)A_1(G^{z_2}(i\eta_2))^t - M_t^{z_1, \bar{z}_2}(i\eta_1, A_1, i\eta_2))A_2 \rangle| \lesssim n^{10\xi} \left( \frac{1}{n\eta_*^{3/2}(|z_1 - \bar{z}_2|^2 + |\eta_1| + |\eta_2|)^{1/2}} + \frac{1}{n^{3/2}\eta_*^{5/2}} \right), \quad (\text{B.18})$$

with  $M_t^{z_1, \bar{z}_2}$  defined as in (6.10) with  $c_*(t)^2 = 1 - e^{-t}$ . Here  $t$  denotes the size of the Gaussian component in Definition 3.8.

Additionally, we have the following slightly weaker local law for general real i.i.d. matrices.

**Corollary B.4.** *Let  $X$  be a real i.i.d. matrix. Then, with overwhelming probability for any  $\xi > 0$ , we have*

$$|\langle (G^{z_1}(i\eta_1)A_1G^{z_2}(i\eta_2) - M^{z_1, z_2}(i\eta_1, A_1, i\eta_2))A_2 \rangle| \lesssim \frac{n^\xi}{n\eta_*^2}, \quad (\text{B.19})$$

with  $\eta_* := |\eta_1| \wedge |\eta_2|$ , uniformly in  $\eta_* \geq n^{-1+10\xi}$ , and matrices  $\|A_i\| \lesssim 1$ .

**Proof.** For real matrices with a Gaussian component of size  $n^{-\xi/10}$  (B.19) follows by (B.17). Then, by a standard comparison argument (e.g. similar to the proof of Proposition 3.2 in Section 3.1.1) we can remove this Gaussian component at a price of a negligible error  $n^{-\xi/10}/(n\eta_*^2)$ . This concludes the proof.  $\square$

As an immediate corollary of Proposition B.3 we have the following bound for eigenvector overlaps.

**Corollary B.5.** *Fix any small  $\omega_d \geq 100\xi > 0$ , and let  $X$  be a matrix of type  $M$  as defined in Definition 3.8, such that its real component has a Gaussian component of size  $n^{-\xi}$ . Pick  $z_1, z_2$  such that  $|z_1 - z_2| \geq n^{-1/2+\omega_d}$ , and let  $H^{z_l}$ ,  $l = 1, 2$ , be the Hermitization of  $X - z_l$ . Let  $\mathbf{w}_i^{z_l} = (\mathbf{u}_i^{z_l}, \pm \mathbf{v}_i^{z_l})$  denote the eigenvectors of  $H^{z_l}$ . Then there exist  $\omega_E \geq \omega_d/2$ ,  $\omega_B > 0$  such that, with overwhelming probability, we have*

$$|\langle \mathbf{u}_i^{z_1}, \mathbf{u}_j^{z_2} \rangle| + |\langle \mathbf{v}_i^{z_1}, \mathbf{v}_j^{z_2} \rangle| \leq n^{5\xi - \omega_E}, \quad 1 \leq i, j \leq n^{\omega_B}. \quad (\text{B.20})$$

**Proof.** Let  $\omega > 0$  from Proposition B.3. In the regime  $|z_1 - z_2| \leq n^{-\omega}$ , given (B.17), the proof of this corollary is completely analogous to the proof of [37, Lemma 7.9]. In the complementary regime  $|z_1 - z_2| > n^{-\omega}$  the bound (B.20) was already proven in [37, Lemma 7.9].  $\square$

To prove Lemma B.2, we need a bound on  $\langle G^{z_1}(i\eta_1)G^{z_2}(i\eta_2) \rangle$  also for  $\eta_i$  below  $1/n$ :

**Corollary B.6.** *Fix any small  $\epsilon > 0$ . Let  $X$  be a matrix with real Gaussian component of size  $n^{-\epsilon/100}$  such that its Hermitization satisfies (B.18), then for any large  $C > 0$ , for  $l_1, l_2 \geq 1$ , we have*

$$|\langle G^{z_1}(i\eta_1)^{l_1} A_1 (G^{z_2}(i\eta_2)^{l_2})^t A_2 \rangle| \lesssim \frac{1}{|\eta_1|^{l_1-1} |\eta_2|^{l_2-1}} \left( \frac{n^{7\epsilon/3}}{|z_1 - \bar{z}_2|^2} + n^{1-\epsilon/3} \right), \quad (\text{B.21})$$

with overwhelming probability uniformly in  $|\eta_i| \geq n^{-1}(\log n)^{-C}$ , and matrices  $\|A_i\| \lesssim 1$ . Similarly, if  $X$  satisfies (B.17) then (B.21) holds with  $(G^{z_2}(i\eta_2)^{l_2})^t$  replaced with  $G^{z_2}(i\eta_2)^{l_2}$ , and  $\bar{z}_2$  in the RHS replaced with  $z_2$ .

**Proof.** [Proof of Lemma B.2] We now show that all the terms in (B.12)–(B.15) are of a form so that the bound (B.21) can be applied. To keep the presentation short we neglect the fact that all the terms in (B.12)–(B.15) contain the imaginary part of the resolvent, as we can write

$$2i \operatorname{Im} G(i\eta) = G(i\eta) - G^*(i\eta) = G(i\eta) - G(-i\eta),$$

and the estimate (B.21) is not sensitive to  $\eta_i$  being positive or negative. We thus write

$$\begin{aligned} \mathcal{E}_1 &= 2n\eta_1 \sum_{ij}^{\sim} \langle (G^{z_1}(i\eta_1))^t E_i (G^{z_2}(i\eta_1))^2 E_j \rangle \\ \mathcal{E}_2 &= \frac{n\eta_1^2}{2} \sum_{ij}^{\sim} \langle [(G^{z_1}(i\eta_1))^2]^t E_i (G^{z_2}(i\eta_1))^2 E_j \rangle \\ \mathcal{E}_3 &= 2n \sum_{ij}^{\sim} \int_{\eta_2}^{\sim} \int_{\eta_2}^{n^{-c_2}} \langle (G^{z_1}(iu))^t E_i (G^{z_2}(iu))^2 E_j \rangle du \\ \mathcal{E}_4 &= \frac{n}{2} \sum_{ij}^{\sim} \int \int_{\eta_2}^{n^{-c_2}} \langle [(G^{z_1}(iu))^2]^t E_i (G^{z_2}(iv))^2 E_j \rangle dudv \\ \mathcal{E}_5 &= \frac{n\eta_1}{2} \sum_{ij}^{\sim} \int_{\eta_2}^{\sim} \int_{\eta_2}^{n^{-c_2}} \langle [(G^{z_1}(i\eta_1))^2]^t E_i (G^{z_2}(iu))^2 E_j \rangle du. \end{aligned} \quad (\text{B.22})$$

Using (B.21), we immediately get (B.16). □

**Proof.** [Proof of Corollary B.6] To keep the presentation simple we only present the proof that the estimate (B.17) implies (B.21) but with  $(G^{z_2}(i\eta_2)^{l_2})^t$  on the LHS replaced with  $G^{z_2}(i\eta_2)^{l_2}$ , and with  $\bar{z}_2$  replaced by  $z_2$  on the RHS. The proof of the fact that (B.18) implies (B.21) is completely analogous and so omitted. We also assume that  $\eta_1, \eta_2 > 0$ , the other cases being identical.

First, we show that if (B.17) holds then the same local law holds if one of the  $G$ 's is replaced by  $|G|$ 's, after possibly multiplying the RHS of (B.17) by  $\log n$ . For this purpose we use the integral representation [36, Eq. (5.4)]

$$|G^z(i\eta)| = \frac{2}{\pi} \int_0^\infty \operatorname{Im} G^z(i\sqrt{\eta^2 + v^2}) \frac{dv}{\sqrt{\eta^2 + v^2}}. \quad (\text{B.23})$$

Defining  $\eta_v := \sqrt{\eta_1^2 + v^2}$ , by [36, Eq. (5.6)], we write the deterministic approximation  $\widetilde{M}(i\eta_1, A, \eta_2)$  of  $|G^{z_1}(i\eta_1)| A G^{z_2}(i\eta_2)$  as

$$\widetilde{M}(i\eta_1, A, \eta_2) := \frac{1}{\pi i} \int_0^\infty \frac{\widehat{M}^{z_1, z_2}(i\eta_v, A, i\eta_2)}{\eta_v} dv,$$

with

$$2i\widehat{M}^{z_1, z_2}(i\eta_v, A, i\eta_2) := M^{z_1, z_2}(i\eta_v, A, i\eta_2) - M^{z_1, z_2}(-i\eta_v, A, i\eta_2).$$

Note that by (8.21), we have (neglecting  $\log n$ -factors)

$$\left\| \widetilde{M}(i\eta_1, A, \eta_2) \right\| \lesssim \frac{\|A\|}{|z_1 - z_2|^2 + \eta_1 + \eta_2} \quad (\text{B.24})$$

We thus have

$$\begin{aligned} & \langle (|G^{z_1}(i\eta_1)|A_1 G^{z_2}(i\eta_2) - \widetilde{M}^{z_1, z_2}(i\eta_1, A_1, i\eta_2))A_2 \rangle \\ &= \int_0^\infty \langle (\text{Im } G^{z_1}(i\eta_v)A_1 G^{z_2}(i\eta_2) - \widehat{M}^{z_1, z_2}(i\eta_v, A_1, i\eta_2))A_2 \rangle \frac{dv}{\eta_v} \\ &= \int_0^{n^{100}} \langle (\text{Im } G^{z_1}(i\eta_v)A_1 G^{z_2}(i\eta_2) - \widehat{M}^{z_1, z_2}(i\eta_v, A_1, i\eta_2))A_2 \rangle \frac{dv}{\eta_v} + \mathcal{O}(n^{-10}). \quad (\text{B.25}) \\ &= \mathcal{O} \left[ (\log n)n^{\varepsilon/10} \left( \frac{1}{n\eta_*^{3/2}(|z_1 - z_2|^2 + \eta_1 + \eta_2)} + \frac{1}{n^{3/2}\eta_*^{5/2}} \right) \right] \end{aligned}$$

We point out that to remove the regime  $\eta_v \geq n^{100}$  in (B.25) we used the norm bound  $\|G\| \leq 1/\eta$  for the resolvents, and (8.21) for the deterministic term. In the last inequality we used (B.17) for the integrand in the third line of (B.25) and that  $\int dv/\eta_v \lesssim \log n$ .

We now show that given (B.25) for  $\eta_1, \eta_2 \gg 1/n$ , we can extend it below  $1/n$ . We will achieve this in two steps: we first prove that a bound of the form (B.21) holds when one  $\eta_i \gg 1/n$  and the other one is smaller than  $1/n$ , and then, using this new bound as an input, that (B.21) holds when both  $\eta_1$  and  $\eta_2$  are smaller than  $1/n$ . We first prove this when  $A_1 = A$ ,  $A_2 = A^*$ , and then we show that this easily implies the general case.

We now may assume that (B.17) and (B.25) hold for  $\eta_* \geq n^{-1+\varepsilon}$ . Assume that  $(\log n)^{-C}n^{-1} \leq \eta_1 \leq n^{-1+\varepsilon} =: \hat{\eta}$  and that  $\eta_2 \geq \hat{\eta}$ . We have the general estimate,

$$\begin{aligned} |\langle G^{z_1}(i\tau)^{l_1+1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle| &= \left| \frac{1}{2n} \sum_{i,j} \frac{|\langle \mathbf{w}_i^{z_1}, A \mathbf{w}_j^{z_2} \rangle|^2}{(\lambda_i^{z_1} - i\tau)^{l_1+1} (\lambda_j^{z_2} - i\eta_2)^{l_2}} \right| \\ &\lesssim \frac{1}{2n\tau^{l_1-1}\eta_2^{l_2-1}} \sum_{i,j} \frac{|\langle \mathbf{w}_i^{z_1}, A \mathbf{w}_j^{z_2} \rangle|^2}{|\lambda_i^{z_1} - i\eta_1|^2 |\lambda_j^{z_2} - i\eta_2|} \quad (\text{B.26}) \\ &= \frac{1}{\tau^{l_1}\eta_2^{l_2-1}} \langle \text{Im } G^{z_1}(i\tau)A | G^{z_2}(i\eta_2) | A^* \rangle. \end{aligned}$$

Applying this with  $\eta_1 \leq \tau \leq \hat{\eta}$  to the integral on the RHS of the first line below we have,

$$\begin{aligned} & |\langle G^{z_1}(i\eta_1)^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle - \langle G^{z_1}(i\hat{\eta})^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle| = \left| \int_{\eta_1}^{\hat{\eta}} \langle G^{z_1}(i\tau)^{l_1+1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle d\tau \right| \\ &\lesssim \frac{1}{\eta_2^{l_2-1}} \int_{\eta_1}^{\hat{\eta}} \frac{1}{\tau^{l_1}} \langle \text{Im } G^{z_1}(i\tau)A | G^{z_2}(i\eta_2) | A^* \rangle d\tau \\ &\lesssim n^\varepsilon (\log n)^{C+1} \frac{1}{\eta_1^{l_1-1}\eta_2^{l_2-1}} \langle \text{Im } G^{z_1}(i\hat{\eta})A | G^{z_2}(i\eta_2) | A^* \rangle \\ &\lesssim \frac{n^\varepsilon (\log n)^{C+1} n^{\varepsilon/10}}{\eta_1^{l_1-1}\eta_2^{l_2-1}} \left( \frac{1}{|z_1 - z_2|^2} + \frac{n^{1/2-3\varepsilon/2}}{|z_1 - z_2|} + n^{1-5\varepsilon/2} \right) \end{aligned}$$

$$\lesssim \frac{n^\varepsilon (\log n)^{C+1} n^{\varepsilon/10}}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \left( \frac{1}{|z_1 - z_2|^2} + n^{1-5\varepsilon/2} \right), \quad (\text{B.27})$$

where in the last line we used a Schwarz inequality. Here, in the first inequality we used (B.26), in the second inequality we used that  $\tau \mapsto \tau \operatorname{Im} G(i\tau)$  is increasing as an operator, and in the third inequality we used (B.24) and (B.25). Now, note that the second term in the LHS of (B.27) can be incorporated into the RHS by (B.25), (B.26), and (B.24). We therefore conclude that

$$\left| \langle G^{z_1}(i\eta_1)^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle \right| \lesssim \frac{n^\varepsilon (\log n)^{C+1} n^{\varepsilon/10}}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \left( \frac{1}{|z_1 - z_2|^2} + n^{1-5\varepsilon/2} \right) \quad (\text{B.28})$$

holds when only  $\eta_1$  is below the scale  $\hat{\eta}$  but  $\eta_2 \geq \hat{\eta}$ .

We now consider the case when both  $\eta_1, \eta_2$  are below the scale  $\hat{\eta}$ . Proceeding as in (B.27), we find that

$$\left| \langle G^{z_1}(i\eta_1)^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle - \langle G^{z_1}(i\hat{\eta})^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle \right| \lesssim n^\varepsilon (\log n)^{C+1} \frac{1}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \langle \operatorname{Im} G^{z_1}(i\hat{\eta}) A | G^{z_2}(i\eta_2) | A^* \rangle, \quad (\text{B.29})$$

where we used again the monotonicity of  $\tau \mapsto \tau \operatorname{Im} G(i\tau)$  as an operator. Note that in the RHS of (B.29) only  $\eta_2$  is below the scale. Therefore, by applying (B.23) we can use the estimate (B.28) to estimate the RHS of (B.29), finding,

$$\begin{aligned} \left| \langle G^{z_1}(i\eta_1)^{l_1} A G^{z_2}(i\eta_2)^{l_2} A^* \rangle \right| &\lesssim \frac{[n^\varepsilon (\log n)^{C+1}]^2 n^{\varepsilon/10}}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \left( \frac{1}{|z_1 - z_2|^2} + n^{1-5\varepsilon/2} \right) \\ &\leq \frac{1}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \left( \frac{n^{2\varepsilon+\varepsilon/9}}{|z_1 - z_2|^2} + n^{1-\varepsilon/2+\varepsilon/9} \right). \end{aligned} \quad (\text{B.30})$$

where we also used (B.28) to estimate the second term on the LHS of (B.29). We re-iterate that the conclusion of all of the above argument is that (B.30) holds for  $|\eta_i| \geq n^{-1}(\log n)^{-C}$ .

We now turn to the final part of the proof, concluding that (B.21) holds for general  $A_1, A_2$ . First, note that by applying (B.23) twice, we see that the estimate (B.30) holds also in the case that  $l_1 = l_2 = 1$  and  $G^{z_i}(i\eta_i)$  are both replaced by  $|G^{z_i}(i\eta_i)|$  on the LHS. Applying this in the second inequality below, we find,

$$\begin{aligned} \left| \langle G^{z_1}(i\eta_1)^{l_1} A_1 G^{z_2}(i\eta_2)^{l_2} A_2 \rangle \right| &\leq \frac{\prod_{i=1}^2 \langle |G^{z_i}(i\eta_i)| A_i | G^{z_2}(i\eta_2) | A_i^* \rangle^{1/2}}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \\ &\lesssim \frac{(\log n)^2}{\eta_1^{l_1-1} \eta_2^{l_2-1}} \left( \frac{n^{2\varepsilon+\varepsilon/9}}{|z_1 - z_2|^2} + n^{1-\varepsilon/2+\varepsilon/9} \right). \end{aligned}$$

The first inequality followed from an argument similar to (B.26). This concludes the proof.  $\square$

**Proof.** [Proof of Proposition B.3] We first prove (B.17) for real i.i.d. matrices and then at the end of the proof we describe the very minor differences to obtain the same result for matrices of type  $M$ . The proof of this proposition follows very closely [38, Section 5]; in fact the only difference is that in [38, Section 5] it was considered the evolution of a certain initial matrix along complex Brownian dynamics, instead in the current case we will consider real Brownian dynamics. First of all we notice that if  $1 \gtrsim |\eta_i| \geq n^{-\xi}$ , then (B.17) holds by [37, Theorem 5.2]. If instead  $|\eta_i| \gtrsim 1$

this follows from computations analogous to [36, Appendix B]. For this reason, to prove (B.17), in the remainder of the proof we use a dynamical argument to show that this bound can in fact be propagated down to  $\eta_* \geq n^{-1+100\xi}$  (see [38, Proposition 5.3] for the complex case).

Consider the Ornstein–Uhlenbeck flow

$$dX_t = -\frac{1}{2}X_t dt + \frac{dB_t}{\sqrt{n}}, \quad X_0 = X,$$

with characteristics

$$\partial_t \eta_t = -\operatorname{Im} m^{z_t}(i\eta_t) - \frac{\eta_t}{2}, \quad \partial_t z_t = -\frac{z_t}{2}. \quad (\text{B.31})$$

Here  $(B_t)_{ij}$  are i.i.d. real Brownian motions and  $X$  is an i.i.d. matrix (see Definition 2.1). Define the resolvents  $G_{i,t} := (H^{z_{i,t}} - i\eta_{i,t})^{-1}$ , and let  $\mathfrak{B}_t$  be the Hermitization of  $B_t$  defined in (3.9). Then, by Itô's formula, we have

$$\begin{aligned} d\langle G_{1,t}AG_{2,t}B \rangle &= \sum_{a,b=1}^{2n} \partial_{ab} \langle G_{1,t}AG_{2,t}B \rangle \frac{d(\mathfrak{B}_t)_{ab}}{\sqrt{n}} + \langle G_{1,t}AG_{2,t}B \rangle dt \\ &\quad + 2\langle G_{1,t}AG_{2,t}E_1 \rangle \langle G_{2,t}BG_{1,t}E_2 \rangle dt + 2\langle G_{1,t}AG_{2,t}E_2 \rangle \langle G_{2,t}BG_{1,t}E_1 \rangle dt \\ &\quad + \langle G_{1,t} - M_{1,t} \rangle \langle G_{1,t}AG_{2,t}BG_{1,t} \rangle dt + \langle G_{2,t} - M_{2,t} \rangle \langle G_{2,t}BG_{1,t}AG_{2,t} \rangle dt \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij}^{\sim} \langle G_{1,t}^t E_i G_{1,t}AG_{2,t}BG_{1,t}E_j \rangle dt + \frac{2\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij}^{\sim} \langle [G_{1,t}AG_{2,t}]^t E_i G_{2,t}BG_{1,t}E_j \rangle dt \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ij}^{\sim} \langle G_{2,t}^t E_i G_{2,t}BG_{1,t}AG_{2,t}E_j \rangle dt. \end{aligned} \quad (\text{B.32})$$

Here  $\sum_{ij}^{\sim}$  is defined below (1.17), and we recall that it denotes the sum over  $(i, j) \in \{(1, 2), (2, 1)\}$ . We also point out that  $M_{i,t} = M^{z_{i,t}}(i\eta_{i,t})$  depends on time only through the characteristics (B.31). In the following we use the short-hand notation  $\sum_{ab}^{2n} := \sum_{a,b=1}^{2n}$ .

Note that the only difference compared to [38, Eq. (5.7)] are the three new terms in the last two lines of (B.32). For this reason we only explain how to estimate these terms and show that they do not change the proof of [38, Proposition 5.3] as they can be incorporated in the error terms that are already present in the proof of [38, Proposition 5.3]. In fact, even if the quadratic variation of the stochastic term in the RHS of (B.32) is slightly different compared to [38, Eq. (5.14)], this does not imply any change in its estimate. The quadratic variation of the stochastic term is now given by

$$\frac{1}{n} \sum_{ab} |\partial_{ab} \langle G_{1,t}AG_{2,t}B \rangle|^2 + \frac{\mathbf{1}_{\{\beta=1\}}}{n} \sum_{ab} (\partial_{ab} \langle G_{1,t}AG_{2,t}B \rangle)^2.$$

However, it is easy to see that the second term above is estimated in terms of the first one, which is equal to [38, Eq. (5.14)]; hence, no new estimate is needed for the stochastic term in (B.32).

The proof of [38, Proposition 5.3] is divided into two parts: in Part 1 it is proven a weaker local law with error  $1/(n\eta_*\sqrt{\eta_1\eta_2})$ , then in Part 2 this bound is improved to (B.17). For the purpose of Part 1 we estimate the three new terms in (B.32) by (we write only two for brevity)

$$\frac{1}{n} |\langle G_{1,t}^t E_i G_{1,t}AG_{2,t}BG_{1,t}E_j \rangle| + \frac{1}{n} |\langle [G_{1,t}AG_{2,t}]^t E_i G_{2,t}BG_{1,t}E_j \rangle| \lesssim \frac{1}{n\eta_*\sqrt{\eta_1\eta_2}}, \quad (\text{B.33})$$

with overwhelming probability. This bound follows by a simple Schwarz to separate the resolvents with their transposes followed by Ward identity. In Part 1 of [38, Proposition 5.3] it was considered

only the special case  $A = L'_-, B = L_-$ , with  $L_-, L'_-$  being the left eigenvectors corresponding to the smallest eigenvalue of the operator  $1 - M_{1,t}\mathcal{S}[\cdot]M_{2,t}$  and the one with  $1 \rightarrow 2$  exchanged, respectively. This is a consequence of the fact that for any matrix orthogonal to this eigenvectors the desired result immediately follows from [38, Lemma 5.4]. In particular, defining

$$Y_t := \left| \langle (G_{1,t}L_-G_{2,t} - M^{z_{1,t},z_{2,t}}(i\eta_{1,t}, L'_-, i\eta_{2,t}))L_- \rangle \right|,$$

and combining (B.33) with [38, Eq. (5.29)] we obtain

$$Y_t = Y_0 + 2 \int_0^t \langle M^{z_{1,s},z_{2,s}}(i\eta_{1,s}, I, i\eta_{2,s}) \rangle Y_s ds + \mathcal{O} \left( \frac{n^\xi}{n\eta_{*,t}\sqrt{|\eta_{1,t}\eta_{2,t}|}} \right). \quad (\text{B.34})$$

Finally, by the integral Gronwall inequality, using

$$\exp \left( \int_s^t 2 |\langle M^{z_{1,s},z_{2,s}}(i\eta_{1,s}, I, i\eta_{2,s}) \rangle| ds \right) \lesssim \frac{\eta_{*,s}\sqrt{\eta_{1,s}\eta_{2,s}}}{\eta_{*,t}\sqrt{\eta_{1,t}\eta_{2,t}}},$$

which is [38, Eq. (5.34)], we obtain the desired bound for  $Y_t$ .

For Part 2 we want to gain from  $|z_1 - z_2|$  being large, for this reason we do not want to separate  $G_{1,t}G_{2,t}$  when they come close to each other. For this reason, defining

$$\begin{aligned} Y_t := & \sup_{C_1, C_2 \in \{A, B, E_1, E_2\}} \left| \langle (G_{1,t}(i\eta_{1,t})C_1G_{2,t}(i\eta_{2,t}) - M^{z_{1,t},z_{2,t}}(i\eta_{1,t}, C_1, i\eta_{2,t}))C_2 \rangle \right| \\ & + \sup_{C_1, C_2 \in \{A, B, E_1, E_2\}} \left| \langle (G_{1,t}(i\eta_{1,t})C_1G_{2,t}(-i\eta_{2,t}) - M^{z_{1,t},z_{2,t}}(i\eta_{1,t}, C_1, -i\eta_{2,t}))C_2 \rangle \right|, \end{aligned}$$

we estimate

$$\begin{aligned} \frac{1}{n} \left| \langle G_{1,t}^t E_i G_{1,t} A G_{2,t} B G_{1,t} E_j \rangle \right| & \lesssim \langle G_{1,t}^t E_i G_{1,t} A (G_{1,t}^t E_i G_{1,t} A)^* \rangle^{1/2} \langle (G_{2,t} B G_{1,t} E_j)^* G_{2,t} B G_{1,t} E_j \rangle^{1/2} \\ & \lesssim \frac{\langle \text{Im } G_{1,t} \text{Im } G_{2,t} \rangle^{1/2}}{\eta_{*,t}\sqrt{\eta_{1,t}\eta_{2,t}}} \lesssim \frac{Y_t^{1/2}}{\eta_{*,t}\sqrt{\eta_{1,t}\eta_{2,t}}}, \end{aligned} \quad (\text{B.35})$$

with overwhelming probability. Similarly, we estimate

$$\left| \langle [G_{1,t} A G_{2,t}]^t E_i G_{2,t} B G_{1,t} E_j \rangle \right| \lesssim \frac{Y_t}{\eta_{1,t}\eta_{2,t}}, \quad (\text{B.36})$$

with overwhelming probability. Combining this with [38, Eq. (5.39)], and the display below it, we obtain

$$\begin{aligned} Y_t \leq & Y_0 + C \int_0^t \left( \frac{1}{|z_{1,s} - z_{2,s}|^2} + \frac{n^\xi}{\sqrt{n}\eta_{*,s}^{3/2}} \right) Y_s ds + \frac{n^\xi}{N\sqrt{\eta_{*,t}|\eta_{1,t}\eta_{2,t}|(|z_{1,t} - z_{2,t}|^2 + \eta_t^*)}} \\ & + \frac{1}{\sqrt{n}\eta_{*,t}} \cdot \frac{n^{2\xi}}{n\eta_{*,t}\sqrt{|\eta_{1,t}\eta_{2,t}|}}, \end{aligned} \quad (\text{B.37})$$

which, by the integral Gronwall inequality, gives (B.17).

To conclude the proof, we only need to show that (B.17) holds for matrices of type  $M$ , and that the same bound holds if one of the resolvents is replaced by its transpose. As an input we rely on the following single resolvent local laws for matrices of type  $M$ , whose proof is postponed to Appendix C.

**Lemma B.7.** *For matrices of type  $M$  as in Definition 3.8, we have that*

$$|\langle G^z(i\eta) - M^z(i\eta) \rangle| \leq \frac{n^\xi}{n\eta}, \quad |\langle \mathbf{x}, G^z(i\eta) - M^z(i\eta) \mathbf{y} \rangle| \leq \frac{n^\xi}{\sqrt{n\eta}} \quad (\text{B.38})$$

with overwhelming probability, for any  $\xi > 0$  and any unit vectors  $\mathbf{x}, \mathbf{y}$ .

We now consider the Ornstein–Uhlenbeck flow

$$d\widehat{X}_t = -\frac{1}{2}\widehat{X}_t dt + \frac{d\widehat{B}_t}{\sqrt{n}}, \quad \widehat{X}_0 = \widehat{X},$$

with  $\widehat{X}$  being a real i.i.d matrix such that its Hermitization  $\widehat{H}^{zi}$  satisfies (B.17). Then, it is easy to see that the resolvents  $\widehat{G}_{i,t} := (\widehat{H}^{zi,t} - i\eta_{i,t})^{-1}$  satisfy (B.32) with  $\beta = 2$ . The proof of (B.17) in this case is then immediate by [38, Proposition 5.3] together with (B.17) for real i.i.d. matrices to estimate the initial condition, as [38, Theorem 3.3 and Proposition 5.3] used the matrix to be complex only to bound the initial condition. We are thus left only with the case when one of the resolvents is replaced by its transposes. By Itô's formula we obtain (cf. (B.32))

$$\begin{aligned} d\langle G_{1,t} A G_{2,t}^t B \rangle &= \sum_{ab} \partial_{ab} \langle G_{1,t} A G_{2,t}^t B \rangle \frac{d\widehat{B}_{ab,t}}{\sqrt{n}} + \langle G_{1,t} A G_{2,t}^t B \rangle dt \\ &+ \frac{1}{n} \sum_{ij} \widetilde{\langle G_{1,t}^t E_i G_{1,t} A G_{2,t} B G_{1,t} E_j \rangle} dt + \frac{2}{n} \sum_{ij} \widetilde{\langle [G_{1,t} A G_{2,t}]^t E_i G_{2,t} B G_{1,t} E_j \rangle} dt \\ &+ \frac{1}{n} \sum_{ij} \widetilde{\langle G_{2,t}^t E_i G_{2,t} B G_{1,t} A G_{2,t} E_j \rangle} dt. \end{aligned} \quad (\text{B.39})$$

Here  $\widehat{B}_t$  is the Hermitization of  $\widehat{B}_t$ . Note that this evolution is analogous to (B.32) with the second and third lines removed. For this reason, the estimate of the RHS of (B.39) is completely analogous to (B.32)–(B.37), and so omitted. This concludes the proof.  $\square$

## C Local laws for matrices of mixed symmetry

In this section we present the proof of the necessary averaged and isotropic single resolvent local laws for matrices of type  $M$ .

**Proof.** [Proof of Lemma 3.9] We first prove that (2.18) holds, then we use this as an input to prove (3.2) hold. We can consider  $X$  to be the solution of (3.7) with initial data being a real i.i.d. matrix and  $B_t$  being a matrix of complex Brownian motions.

First, the proof of Lemma 3.5 is easily modified to show that for all  $\varepsilon, \kappa > 0$  we have that,

$$|\langle G_t^z(w) - M_t^z(w) \rangle| \leq \frac{n^\varepsilon}{n \operatorname{Im}[w]} \quad (\text{C.1})$$

for all  $n^{\varepsilon-1} \leq \operatorname{Im}[w] \leq 10$  and  $\operatorname{Re}[w]$  such that  $\rho^z(\operatorname{Re}[w]) > \kappa$ . With this as input, all of the arguments in Section 3.1 apply line-by-line, yielding the estimate (3.2). Corollary 3.3 and (2.19) are a direct consequence of these local laws.

Next, (3.48) is a consequence of (C.1) and the estimate for  $\lambda_n^z$  follows from comparing the eigenvalues of the Hermitization of  $(1-t)^{1/2}Y + t^{1/2}G$  to those of  $Y$  using the Weyl bound  $|\lambda_i(A) - \lambda_i(B)| \leq \|A - B\|$ .

□

**Proof.** [Proof of Lemma B.7] The averaged law follows by Lemma 3.9. We now use the averaged law to prove the isotropic law. We only present a sketch of the proof for brevity, as it is very similar (actually simpler) to the proof of Lemma 3.5.

By Itô formula, it is easy to see that along the characteristics (3.10) we have (we use the notations  $G_t := (H_t^{zt} - i\eta_t)^{-1}$ ,  $M_t := M^{zt}(i\eta_t)$ )

$$d(G_t - M_t)_{\mathbf{x}\mathbf{y}} = \frac{1}{\sqrt{n}} \sum_{ab=1}^{2n} \partial_{ab}(G_t)_{\mathbf{x}\mathbf{y}} d(\mathfrak{B}_t)_{ab} + \frac{1}{2}(G_t - M_t)_{\mathbf{x}\mathbf{y}} dt + \langle G_t - M_t \rangle (G_t^2)_{\mathbf{x}\mathbf{y}} dt, \quad (\text{C.2})$$

where we used the short-hand notation  $(G_t)_{\mathbf{x}\mathbf{y}} := \langle \mathbf{x}, G_t \mathbf{y} \rangle$ . Here  $\mathfrak{B}_t$  is the Hermitization of  $B_t$  defined in (3.9); in particular,  $(\mathfrak{B}_t)_{ab} = 0$  for  $a, b \leq n$  and  $a, b \geq n + 1$ . Notice that the second term in the RHS of (C.2) can be removed by looking at the evolution of  $e^{-t/2}(G_t - M_t)_{\mathbf{x}\mathbf{y}}$ ; we thus neglect this term. Define the stopping time

$$\tau := \inf \left\{ t : \sup_{\mathbf{u}, \mathbf{y} \in \{\mathbf{x}, \mathbf{y}\}} |(G_t - M_t)_{\mathbf{u}\mathbf{v}}| = \frac{n^{2\xi}}{\sqrt{n\eta_t}} \right\}.$$

Then, we estimate

$$\left| \int_0^{t \wedge \tau} \langle G_s - M_s \rangle (G_s^2)_{\mathbf{x}\mathbf{y}} ds \right| \leq \frac{n^\xi}{\sqrt{n\eta_{t \wedge \tau}}}.$$

Finally, the quadratic variation process of the stochastic term in the RHS of (C.2) can be estimated by

$$\frac{1}{n\eta_t^2} (\text{Im } G_t)_{\mathbf{x}\mathbf{x}} (\text{Im } G_t)_{\mathbf{y}\mathbf{y}} \lesssim \frac{1}{n\eta_{t \wedge \tau}^2}.$$

Then, using the BDG inequality we see that the stochastic term is also bounded by  $n^\xi / \sqrt{n\eta_{t \wedge \tau}}$ . This concludes the proof. □

## D Miscellaneous results

### D.1 Proof of Proposition 2.5

**Lemma D.1.** *Let  $z_s := z + sw$ , with  $|z_s| < 1$  for some interval of  $|s| < r$ . Then,*

$$\frac{d}{ds} \text{Re} \int \log(x - i\eta) \rho^{z_s}(x) dx = \text{Re}[\dot{z}_s \bar{z}_s] (u^{z_s}(i\eta)), \quad (\text{D.1})$$

where  $\dot{F}$  means  $\frac{d}{ds}F$ .

**Proof.** We can write,

$$\text{Re} \int \log(x - i\eta) \rho^{z_s}(x) dx = -i \int_0^\eta m^{z_s}(iu) du + \frac{-1 + |z_s|^2}{2} \quad (\text{D.2})$$

using  $m^z(iu) = i \text{Im}[m^z(iu)]$ . Here we used the fact that

$$\text{Re} \int \log(x) \rho^z(x) dx = \frac{1}{\pi} \int_{|u| < 1} \log|u - z| du d\bar{u} = \frac{1}{2} = \frac{|z|^2 - 1}{2} \quad (\text{D.3})$$

for  $|z| < 1$ . The first equality may be deduced from the fact that both sides are the almost sure limit of  $\log \det |X - z|$ . Differentiating (2.13) wrt  $s$  and re-arranging yields,

$$\dot{m}^{z_s}(w) = \frac{2 \operatorname{Re}[\dot{z}_s \bar{z}_s](m^{z_s}(w))^2}{2(m^{z_s}(w))^2(w + m^{z_s}(w)) - w}. \quad (\text{D.4})$$

Similarly, differentiating (2.13) wrt  $w$  and re-arranging yields,

$$\partial_w m^{z_s}(w) = -m^{z_s}(w) \frac{2(w + m^{z_s}(w))m^{z_s}(w) + 1}{2(m^{z_s}(w))^2(w + m^{z_s}(w)) - w}. \quad (\text{D.5})$$

Therefore,

$$\partial_w u^{z_s}(w) = \partial_w \left( \frac{m^{z_s}(w)}{m^{z_s}(w) + w} \right) = \frac{(\partial_w m^{z_s}(w))w - m^{z_s}(w)}{(m^{z_s}(w) + w)^2} \quad (\text{D.6})$$

$$= -\frac{2(m^{z_s}(w))^2}{2(m^{z_s}(w))^2(w + m^{z_s}(w)) - w} \quad (\text{D.7})$$

with the last line following by direct substitution. Therefore,  $\dot{m}^{z_s}(w) = -\operatorname{Re}[\dot{z}_s \bar{z}_s] \partial_w u^{z_s}(w)$ , and so

$$-i \int_0^\eta \dot{m}^{z_s}(iu) = \operatorname{Re}[\dot{z}_s \bar{z}_s] \int_0^\eta \partial_w u^{z_s}(iu) i du = \operatorname{Re}[\dot{z}_s \bar{z}_s] (u^{z_s}(i\eta) - 1) \quad (\text{D.8})$$

The claim follows.  $\square$

**Lemma D.2.** *Let  $z_s := z + sw$ , with  $|z_s| < 1$  for some interval of  $|s| < r$ . Let  $\varepsilon > 0$ . Then with overwhelming probability we have,*

$$\frac{d}{ds} \operatorname{Re} \log \det(H^{z_s} - i\eta) = n 2 \operatorname{Re}[\dot{z}_s \bar{z}_s] u^{z_s}(i\eta) + \mathcal{O}(n^\varepsilon \eta^{-1/2}) \quad (\text{D.9})$$

for  $n^\varepsilon/n \leq \eta \leq \delta$  for some  $\delta > 0$ .

**Proof.** We have that,

$$\frac{d}{ds} \log \det(H^{z_s} - i\eta) = \operatorname{Tr} \left( \frac{1}{H^{z_s} - i\eta} (-\dot{z}_s F - \dot{z}_s F^*) \right) \quad (\text{D.10})$$

where  $F = \begin{pmatrix} 0 & 1 \\ 0 & 0 \end{pmatrix}$ . But by [32, Theorem 4.5] we have

$$\operatorname{Tr}(G(i\eta)F) = -n \bar{z}_s u^{z_s}(i\eta) + \mathcal{O}(\eta^{-1/2} n^\varepsilon), \quad (\text{D.11})$$

and a similar estimate for  $F^*$ . Here we used the fact  $F$  is regular in the sense of [32, Definition 4.2]; see also the discussion in the proof of Theorem 2.4 near Eq. (3.22) of [32].  $\square$

**Lemma D.3.** *Let  $0 < r < 1$  and fix any small  $\xi > 0$ . Uniformly in  $\eta_1, \eta_2$  and  $z$  satisfying  $n^{-\varepsilon/10}/n \leq \eta_1 \leq \eta_2 \leq 1$  and  $|z| \leq r$  we have with overwhelming probability,*

$$|\langle G^z(i\eta_1)F \rangle - \langle G^z(i\eta_2)F \rangle| \leq (\eta_2 - \eta_1) n^{1/2+\xi} \quad (\text{D.12})$$

**Proof.** By the spectral theorem we have,

$$\mathrm{Tr}G^z(i\eta)F = \sum_i \frac{1}{\lambda_i^z - i\eta} u_i^* v_i \quad (\text{D.13})$$

where  $u_i, v_i$  are the normalized eigenvectors of  $X^*X$  and  $XX^*$ , respectively. By [32, Eq. (2.8c)] we see that,

$$|u_i^* v_i| \leq n^\xi \left( \frac{1}{\sqrt{n}} + \frac{|i|}{n} \right) \quad (\text{D.14})$$

for  $|i| \leq cn$  for some  $c > 0$ , with overwhelming probability. Therefore,

$$\left| \sum_{|i| < cn} u_i^* v_i \left( \frac{1}{\lambda_i^z - i\eta_1} - \frac{1}{\lambda_i^z - i\eta_2} \right) \right| \leq n^{3\xi}(\eta_2 - \eta_1) \sum_{|i| < cn} \frac{n^2}{i^2} \left( \frac{1}{n^{1/2}} + \frac{|i|}{n} \right) \leq n^{4\xi}(\eta_2 - \eta_1)n^{3/2} \quad (\text{D.15})$$

Using  $|u_i^* v_i| \leq 1$  for all  $i > 0$  we easily see that

$$\left| \sum_{|i| < cn} u_i^* v_i \left( \frac{1}{\lambda_i^z - i\eta_1} - \frac{1}{\lambda_i^z - i\eta_2} \right) \right| \leq Cn(\eta_2 - \eta_1), \quad (\text{D.16})$$

and the claim follows.  $\square$

**Proof of Proposition 2.5.** We treat first the complex case  $\beta = 2$ . The claim for  $\eta \geq n^\varepsilon/n$  follows immediately from differentiation and Lemmas D.1 and D.2. For  $1/n \leq \eta \leq n^\varepsilon/n$  we apply Lemma D.3 with  $\eta_1 = \eta$  and  $\eta_2 = n^\varepsilon/n$  to approximate  $\langle G(i\eta_1)F \rangle = \langle G(i\eta_2)F \rangle + \mathcal{O}(n^\varepsilon n^{-1/2})$ . The claim then follows because  $u^z(i\eta_1) = u^z(i\eta_2) + \mathcal{O}(n^{-1+\varepsilon})$ . In the real case we need only to check that the additional deterministic term present in (2.21) also obeys the same estimate. But this is clear because for  $\eta \geq n^{-1}$  the difference between these terms is,

$$\left| \log(4 \operatorname{Re}[z_1]^2 + 2\eta\sqrt{1 - |z_1|^2}) - \log(4 \operatorname{Re}[z_2]^2 + 2\eta\sqrt{1 - |z_2|^2}) \right| \leq C \frac{|z_1 - z_2|}{\sqrt{\eta}} \quad (\text{D.17})$$

under the assumption  $|z_1 - z_2| \leq \sqrt{\eta}$ . If this does not hold, then the deterministic term can be absorbed into the error on the RHS of (2.22).  $\square$

## D.2 Proof of Corollary 3.3

The proof will follow by the estimate (3.2) together with an application of the well known Helffer-Sjöstrand formula (see (D.19) below). Let  $f : \mathbb{R} \rightarrow \mathbb{R}$  be a smooth function, and define its almost analytic extension by

$$\tilde{f}(x + iy) := [f(x) + i\partial_x f(x)] \chi_{\mathfrak{a}}(y). \quad (\text{D.18})$$

Here  $\chi_{\mathfrak{a}}(y)$  is a smooth cut-off function such that  $\chi_{\mathfrak{a}}(y) = 1$  for  $|y| \leq \mathfrak{a}$  and  $\chi_{\mathfrak{a}}(y) = 0$  for  $|y| \geq 2\mathfrak{a}$ , for some  $n$ -dependent  $\mathfrak{a}$  satisfying  $n^{-\delta} \geq \mathfrak{a} \geq (\log n)^{1/2+10\delta}$ , which we will choose later in the proof. We may also assume that  $|\chi'_{\mathfrak{a}}(y)| \leq C/\mathfrak{a}$  and that  $\chi_{\mathfrak{a}}(y)$  is even. Then, by the Helffer-Sjöstrand formula, we have

$$f(\lambda) = \frac{1}{\pi} \int_{\mathbb{C}} \frac{\partial_{\bar{w}} \tilde{f}(w)}{\lambda - w} d^2 w = \frac{1}{\pi} \int_{\mathbb{R}} \int_{\mathbb{R}} \frac{\partial_{\bar{w}} \tilde{f}(w)}{\lambda - w} dx dy. \quad (\text{D.19})$$

We now choose  $f(x)$  to be a smooth function such that  $f(x) = 1$  for  $|x| \leq B$  and  $f(x) = 0$  for  $|x| \geq A + B$ , for some  $n$ -dependent  $A, B$ , which we will choose shortly. We point out that this  $f$

is a smooth version of the eigenvalue counting function as a consequence of the symmetry of the spectrum of  $H^z$  around zero. Using (D.19), we have

$$\langle f(H^z) \rangle - \int_{\mathbb{R}} f(x) \rho^z(x) dx = \frac{1}{\pi} \int_{\mathbb{C}} \partial_{\bar{w}} \tilde{f}(w) \langle G^z(w) - M^z(w) \rangle d^2w. \quad (\text{D.20})$$

Notice that by (D.18) we have

$$\partial_{\bar{w}} \tilde{f}(x + iy) = iy f''(x) \chi_{\mathbf{a}}(y) + [f(x) + i \partial_x f(x)] \chi'_{\mathbf{a}}(y). \quad (\text{D.21})$$

We now estimate the two terms in the RHS of this equality one by one. Using Lemma 3.2, we have, using that  $\chi'_{\mathbf{a}}(y) \neq 0$  only for  $\mathbf{a} \leq y \leq 2\mathbf{a}$ ,

$$\left| \frac{1}{\pi} \int_{\mathbb{R}^2} \chi'_{\mathbf{a}}(y) [f(x) + iy f'(x)] \langle G^z(x + iy) - M^z(x + iy) \rangle dx dy \right| \lesssim \frac{(\log n)^{1/2+\delta}}{n} \left( 1 + \frac{B+A}{\mathbf{a}} \right), \quad (\text{D.22})$$

We now estimate the first term in the RHS of (D.21). Let  $y_0 := (\log n)^{1/2+10\delta}$ . Since  $y \rightarrow \text{Im} \langle G(iy) \rangle$  is monotonically increasing, and since  $\langle M(iy) \rangle$  is a bounded function, for  $y < y_0$ ,

$$\langle \text{Im} [G^z(iy)] \rangle \leq C \frac{y_0}{y}, \quad \langle \text{Im} [M^z(iy)] \rangle \leq C \leq C \frac{y_0}{y} \quad (\text{D.23})$$

with overwhelming probability. By (D.23), we thus estimate

$$\left| \int_{|y| < y_0} \chi_{\mathbf{a}}(y) y f''(x) \langle G^z(x + iy) - M^z(x + iy) \rangle dx dy \right| \quad (\text{D.24})$$

$$= 2 \left| \int_{0 < y < y_0} \chi_{\mathbf{a}}(y) y f''(x) \langle \text{Im} [G^z(x + iy) - M^z(x + iy)] \rangle dx dy \right| \leq \frac{y_0^2}{A} = \frac{(\log n)^{1/2+10\delta}}{n}, \quad (\text{D.25})$$

with overwhelming probability, where in the last equality we chose  $A = y_0$ . The first inequality follows because we assumed that  $\chi_{\mathbf{a}}(y)$  is even.

Before turning to the portion of the integral with  $y \geq y_0$ , we first remark that from (3.2) and the Cauchy Integral formula we obtain that

$$|\partial_w \langle G(w) - M^z(w) \rangle| \lesssim \frac{(\log n)^{1/2+\delta}}{n |\text{Im } w|^2}, \quad (\text{D.26})$$

with overwhelming probability, uniformly in  $n^{-\delta} \geq |\text{Im } w| \geq (\log n)^{1/2+\delta}/n$  and  $\text{Re}(w) \in I_z(\kappa)$ .

Now for  $y \geq y_0$ , we estimate

$$\begin{aligned} & \left| \frac{1}{\pi} \int_{|y| \geq y_0} \chi_{\mathbf{a}}(y) y f''(x) \langle G^z(x + iy) - M^z(x + iy) \rangle dx dy \right| \\ &= \left| \frac{1}{\pi} \int_{|y| \geq y_0} \chi_{\mathbf{a}}(y) y f'(x) \partial_w \langle G^z(x + iy) - M^z(x + iy) \rangle dx dy \right| \\ &\lesssim \frac{(\log n)^{1/2+\delta}}{n} \int_{\mathbf{a} \geq |y| \geq y_0} \frac{1}{|y|} dy \\ &\lesssim \frac{(\log n)^{1/2+\delta}}{n} (1 + \log(\mathbf{a}/y_0)), \end{aligned} \quad (\text{D.27})$$

where in the first equality we used integration by parts and used that  $\partial_x F(w) = \partial_w F(w)$  for holomorphic  $F$  by the Cauchy-Riemann equations. In the first inequality we used (D.26). Now as long as  $\mathbf{a}$  satisfies  $(\log n)^{10\delta}/n \leq \mathbf{a} \leq (\log n)^{C_1}/n$  for any fixed  $C_1 > 0$  we see that,

$$\left| \frac{1}{\pi} \int_{\mathbb{R}^2} \chi_{\mathbf{a}}(y) y f''(x) \langle G^z(x + iy) - M^z(x + iy) \rangle dx dy \right| \lesssim \frac{(\log n)^{1/2+10\delta}}{n}. \quad (\text{D.28})$$

For any  $B \leq \mathbf{a}$ , we therefore conclude that with overwhelming probability,

$$\left| \langle f(H^z) \rangle - \int_{\mathbb{R}} f(x) \rho^z(x) dx \right| \lesssim \frac{(\log n)^{1/2+10\delta}}{n}. \quad (\text{D.29})$$

By choosing  $B$  to be the location of the quantiles  $\gamma_i^z$  for  $0 < i < (\log n)^{C_1}$ , for some fixed  $C_1 > 0$ , and  $\mathbf{a} = B \vee ((\log n)^{10\delta}/n)$ , and using the symmetry  $\lambda_i^z = \lambda_{-i}^z$ , one therefore finds the estimate,

$$|\{j : 0 \leq \lambda_j^z \leq \gamma_i^z\} - i| \leq C(\log n)^{1/2+10\delta} \quad (\text{D.30})$$

with overwhelming probability. From this, the estimate (3.4) follows immediately. For (3.5), one can repeat the above argument, instead choosing  $\mathbf{a} = n^{-\varepsilon}$  for some  $\varepsilon > 0$ . Then one finds that with overwhelming probability, for all  $i < n^{1-\varepsilon}$ , we have

$$|\{j : 0 \leq \lambda_j^z \leq \gamma_i^z\} - i| \leq (\log n)^{3/2+20\delta}, \quad (\text{D.31})$$

which implies (3.5). □

## E Proof of Proposition 4.2

The proof of this proposition is divided into two part: using Stein's method (see (E.10) and Lemma E.1 below), we first show (4.2) for general smooth test functions  $f$ , and then we specialize to  $f(x) = \text{Re} \log(x - i\eta)$  for which we explicitly compute the expectation and the variance  $V(f)$  in (4.3).

**Proof.** [Proof of (4.2)] The proof of (4.2) is based on [73, Section 10]. The main difference is that [73] considers Wigner (Hermitian) matrices, while now we consider the technically more complicated Hermitization  $H^z$  of an i.i.d. matrix  $X - z$  defined as in (2.9). On the other hand [73] needed a higher precision in the estimate of the error term.

Let  $f$  be a smooth function supported on  $[-5, 5]$ , and for any  $k \in \mathbb{N}$  we denote its almost analytic extension by

$$\tilde{f}(x + iy) = \tilde{f}_k(x + iy) := \chi(y) \sum_{l=0}^k (iy)^l f^{(l)}(x),$$

with  $\chi$  a smooth cut-off function which is equal to one for  $|y| \leq 1$  and equal to zero for  $|y| \geq 2$ . Here  $f^{(l)}$  denotes the  $l$ -th derivative of  $f$ . In particular, it is easy to see that

$$|\partial_{\bar{w}} \tilde{f}(w)| \lesssim |\text{Im } w|^{k-1} \|f\|_{C^k} \lesssim |\text{Im } w|^{k-1} n^{\gamma k}. \quad (\text{E.1})$$

The precise value of  $k$  will be chosen shortly. We recall that by Helffer-Sjöstrand formula we can write

$$\langle f(H^z) \rangle = \frac{1}{\pi} \int_{\mathbb{C}} \partial_{\bar{w}} \tilde{f}(w) \langle G^z(w) \rangle d^2 w.$$

We thus define the characteristic function:

$$e(\lambda) := \exp \left[ i\lambda \left( \frac{2n}{\pi} \int_{\mathbb{C}} \partial_{\bar{w}} \tilde{f}(w) (\langle G^z(w) \rangle - \mathbb{E} \langle G^z(w) \rangle) d^2w \right) \right], \quad (\text{E.2})$$

and its approximation

$$e_{\mathbf{a}}(\lambda) := \exp \left[ i\lambda \left( \frac{2n}{\pi} \int_{\Omega_{\mathbf{a}}} \partial_{\bar{w}} \tilde{f}(w) (\langle G^z(w) \rangle - \mathbb{E} \langle G^z(w) \rangle) d^2w \right) \right]. \quad (\text{E.3})$$

where

$$\Omega_{\mathbf{a}} := \{(x, y) \in \mathbb{R}^2 : |y| \geq n^{-\mathbf{a}}\}, \quad (\text{E.4})$$

for some  $\mathbf{a} > 0$  which we will choose shortly.

The goal of this section is to use Stein's method to compute  $\psi_{\mathbf{a}}(\lambda) := \mathbb{E}e_{\mathbf{a}}(\lambda)$ , and thus  $\psi(\lambda) := \mathbb{E}e(\lambda)$ . In particular, we use that  $\psi_{\mathbf{a}}(\lambda)$  is a very good approximation of  $\psi(\lambda)$  as a consequence of

$$\left| \frac{2n}{\pi} \int_{\mathbb{C} \setminus \Omega_{\mathbf{a}}} \partial_{\bar{w}} \tilde{f}(w) (\langle G^z(w) \rangle - \mathbb{E} \langle G^z(w) \rangle) d^2w \right| \lesssim n^{-(\gamma-\mathbf{a})k} \lesssim n^{-1/2}, \quad (\text{E.5})$$

choosing  $\mathbf{a} = 1/100$  and  $k$  large enough (in terms of  $\mathbf{a}$ ) in the last inequality, say  $k = 60$ . This follows from the local law (3.2) and the bound (E.1). Using (E.5), we then immediately conclude

$$|\psi_{\mathbf{a}}(\lambda) - \psi(\lambda)| \lesssim n^{-1/2+1/100}, \quad (\text{E.6})$$

for  $|\lambda| \leq n^{1/100}$ .

Given (E.5), the main ingredient to prove (4.2) is to compute  $\mathbb{E}[e_{\mathbf{a}}(\lambda) \langle G^z(w) - \mathbb{E}G^z(w) \rangle]$  as in the following lemma. We present its proof after the conclusion of the proof of (4.2).

**Lemma E.1.** *Fix any sufficiently small  $\gamma > 0$  as in Proposition 4.2, then we have*

$$\begin{aligned} & 2n\mathbb{E}[e_{\mathbf{a}}(\lambda) \langle G^z(w) - \mathbb{E}G^z(w) \rangle] \\ &= \frac{i\lambda\psi_{\mathbf{a}}(\lambda)}{2\pi} \sum_{ij} \int_{\Omega_{\mathbf{a}}} \partial_{\bar{w}_1} \tilde{f}(w_1) \langle M^{z,z,z}(w_1, I, w_1, E_i, w) A(w) E_j \rangle d^2w_1 \\ &+ \frac{i\mathbf{1}_{\{\beta=1\}}\lambda\psi_{\mathbf{a}}(\lambda)}{2\pi} \sum_{ij} \int_{\Omega_{\mathbf{a}}} \partial_{\bar{w}_1} \tilde{f}(w_1) \langle M^{z,z,\bar{z}}(w_1, I, w_1, E_i A(w)^{\dagger}, w) E_j \rangle d^2w_1 \\ &+ \frac{i\lambda\kappa_4\psi_{\mathbf{a}}(\lambda)}{2\pi} \int_{\Omega_{\mathbf{a}}} \partial_{\bar{w}_1} \tilde{f}(w_1) (m^z(w_1)^2)' (m^z(w)^2)' d^2w_1 + \mathcal{O}\left(\frac{n^{200\gamma+5\mathbf{a}}}{n^{1/2}}\right) \\ &=: -i \int_{\Omega_{\mathbf{a}}} \partial_{\bar{w}_1} \tilde{f}(w_1) R(w_1, w) dw_1^2 + \mathcal{O}\left(\frac{n^{200\gamma+5\mathbf{a}}}{n^{1/2}}\right). \end{aligned} \quad (\text{E.7})$$

Here we used the definitions  $\kappa_4 := n^2\mathbb{E}|X_{ab}|^4 - (2 + \mathbf{1}_{\{\beta=1\}})$  for the fourth cumulant,

$$A(w) := \frac{M^z(w)}{1 - \langle (M^z(w))^2 \rangle}, \quad (\text{E.8})$$

and for  $z_i \in \mathbb{C}$ ,  $B_i \in \mathbb{C}^{2n \times 2n}$ ,

$$\begin{aligned} M^{z_1, z_2}(w_1, B_1, w_2) &:= [1 - M^z(w_1) \mathcal{S}[\cdot] M^{z_2}(w_2)]^{-1} [M^{z_1}(w_1) B_1 M^{z_2}(w_2)] \\ M^{z_1, z_2, z_3}(w_1, B_1, w_2, B_2, w_3) &:= [1 - M^{z_1}(w_1) \mathcal{S}[\cdot] M^{z_3}(w_3)]^{-1} \left[ M^{z_1}(w_1) B_1 M^{z_2, z_3}(w_2, B_2, w_3) \right. \\ &\quad \left. + M^{z_1}(w_1) \mathcal{S}[M^{z_1, z_2}(w_1, B_1, w_2)] M^{z_2, z_3}(w_2, B_2, w_3) \right]. \end{aligned} \quad (\text{E.9})$$

Using Lemma E.1, we then compute

$$\frac{d}{d\lambda}\psi_a(\lambda) = \frac{2in}{\pi} \int_{\Omega_a} \partial_{\bar{w}}\tilde{f}(w)\mathbb{E}[e_a(\lambda)\langle G^z(w)\rangle - \mathbb{E}\langle G^z(w)\rangle] d^2w = -\lambda V_a(f)\psi_a(\lambda) + \mathcal{O}\left(\frac{n^{200\gamma+5a}}{n^{1/2}}\right), \quad (\text{E.10})$$

where we defined

$$V(f) = V_a(f) := \frac{1}{\pi^2} \int_{\Omega_a} \int_{\Omega_a} \partial_{\bar{w}_1}\tilde{f}(w_1)\partial_{\bar{w}}\tilde{f}(w)R(w_1, w) dw_1^2 d^2w. \quad (\text{E.11})$$

We now claim the lower bound (the proof is presented after the end of the proof of (4.2))

$$V(f) \geq -n^{-1/5}. \quad (\text{E.12})$$

This ensures that  $\exp(-\lambda^2 V(f)) \lesssim 1$  for  $|\lambda| \leq n^{1/100}$ . From (E.10) we thus conclude

$$\psi_a(\lambda) = \exp(-\lambda^2 V(f)/2) + \mathcal{O}(n^{-1/2+200\gamma+5a}), \quad (\text{E.13})$$

for all  $|\lambda| \leq n^{1/100}$ . Combining (E.13) with (E.6) we conclude (4.2).  $\square$

We now present the proof of a few technical results that we used within the proof of (4.2).

**Proof.** [Proof of (E.12)] Define

$$Z := \frac{2n}{\pi} \int_{\Omega_a} \partial_{\bar{w}}\tilde{f}(w)(\langle G^z(w)\rangle - \mathbb{E}\langle G^z(w)\rangle) d^2w, \quad (\text{E.14})$$

then by the local law (3.2) and the bound (E.1) we have  $|Z| \leq n^{200\gamma}$ . Choose  $\lambda = n^{-1/4}$ , then, proceeding similarly to the proof of [72, Lemma 5.10], using  $|Z| \leq n^{200\gamma}$ , we obtain

$$\mathbb{E}[iZe^{i\lambda Z}] = -\lambda \text{Var}(Z) + \mathcal{O}(|\lambda|^2 n^{200\gamma}) = -\lambda \text{Var}(Z)\mathbb{E}[e^{i\lambda Z}] + \mathcal{O}(|\lambda|^2 n^{200\gamma}), \quad (\text{E.15})$$

where in the second equality we used  $\mathbb{E}[e^{i\lambda Z}] = 1 + \mathcal{O}(|\lambda|n^{200\gamma})$ . On the other hand, by (E.10), we have

$$\frac{d}{d\lambda}\mathbb{E}[iZe^{i\lambda Z}] = \frac{d}{d\lambda}\mathbb{E}[e^{i\lambda Z}] = -\lambda V_a(f)\mathbb{E}[e^{i\lambda Z}] + \mathcal{O}(n^{-1/2+200\gamma}). \quad (\text{E.16})$$

Subtracting (E.16) to (E.15) and dividing by  $\lambda$ , we conclude

$$V(f) = \text{Var}(Z) + \mathcal{O}(n^{-1/4+200\gamma}), \quad (\text{E.17})$$

which implies the desired lower bound on  $V(f)$ , for  $\gamma$  sufficiently small.  $\square$

**Proof.** [Proof of Lemma E.1] The proof of this lemma is similar to the proof of [73, Proposition 10.1]; for this reason we only present the main differences and omit some of the technical details which can be readily seen to adapt to the current case in an immediate way.

Within this proof we may often omit the  $z, w$ -dependence of the resolvent  $G = G^z(w)$  and of its deterministic approximation  $M = M^z(w)$ , to keep the notation simpler. Let  $W$  be the Hermitization of  $X$  defined as in (2.9) with  $X - z$  replaced with  $X$ . Then we have

$$\mathcal{B}[G - M] = -M\underline{W}G + M\langle G - M\rangle(G - M), \quad \mathcal{B}[\cdot] := 1 - M\mathcal{S}[\cdot]M, \quad (\text{E.18})$$

with

$$\underline{W}G := WG + \langle G\rangle G. \quad (\text{E.19})$$

We point out that the definition of the underline term in (E.19) is so that  $\mathbb{E}\langle \underline{WGA} \rangle \approx 0$ . Using (E.18), for the (normalized) trace of  $G - \mathbb{E}G$  we get

$$\langle G - \mathbb{E}G \rangle = -\langle \underline{WGA} \rangle + \mathbb{E}\langle \underline{WGA} \rangle + \langle G - M \rangle \langle (G - M)A \rangle - \mathbb{E}\langle G - M \rangle \langle (G - M)A \rangle, \quad (\text{E.20})$$

with

$$A = A(w) := ((\mathcal{B}^{-1})^*[1])^* M(w).$$

We point out that using

$$((\mathcal{B}^{-1})^*[B^*])^* = B + \frac{\langle (M^z(w))^2 B \rangle}{1 - \langle (M^z(w))^2 \rangle}, \quad (\text{E.21})$$

for any  $B \in \mathbb{C}^{2n \times 2n}$ , we obtain that  $A(w)$  can be written as in (E.8).

To reflect the block structure of  $W$ , throughout this section we use the short-hand notation:

$$\sum_{ab} := \sum_{\substack{1 \leq a \leq n, \\ n+1 \leq b \leq 2n}} + \sum_{\substack{n+1 \leq a \leq 2n, \\ 1 \leq b \leq n}}. \quad (\text{E.22})$$

Next, using that (recall  $|\text{Im } w| \geq n^{-a}$ )

$$n \langle G - M \rangle \langle (G - M)A \rangle \lesssim \frac{n^\xi}{n |\text{Im } w|^2} \leq \frac{n^{\xi+2a}}{n}$$

with overwhelming probability by (2.18), and performing cumulant expansion (which was first used in the random matrix context in [64] and then revived in [62, 74]; see these references for more details), we have

$$\begin{aligned} 2n \mathbb{E}[e_a \langle G - \mathbb{E}G \rangle] &= 2 \sum_{ab} \mathbb{E}[\partial_{ba} e_a \langle \Delta^{ab} GA \rangle] + 2 \mathbf{1}_{\{\beta=1\}} \sum_{ab} \mathbb{E}[\partial_{ab} e_a \langle \Delta^{ab} GA \rangle] \\ &\quad + 2n \sum_{k=2}^R \sum_{ab} \sum_{\alpha \in \{ab, ba\}^k} \frac{\kappa(ba, \alpha)}{k!} (\mathbb{E} \partial_\alpha [e_a \langle \Delta^{ba} GA \rangle] - \psi_a(\xi) \mathbb{E} \partial_\alpha [\langle \Delta^{ba} GA \rangle]) \\ &\quad + \Omega_R + \mathcal{O}\left(\frac{n^{\xi+2a}}{n}\right). \end{aligned} \quad (\text{E.23})$$

Notice that in the second line of (E.23) we truncated the cumulant expansion at  $k = R$ . In fact, it is easy to see that  $\Omega_R = \mathcal{O}(N^{-2})$  for  $R = 12$  (see e.g. [50, Proposition 3.2]). Here  $\partial_{ab} := \partial_{W_{ab}}$  denotes the directional derivative in the direction  $W_{ab}$ ,  $\partial_\alpha := \partial_{\alpha_1} \dots \partial_{\alpha_k}$ , with  $\alpha_i \in \{ab, ba\}$ , and  $\kappa(ba, \alpha)$  denotes the  $k + 1$ -th cumulant of the random variables  $W_{ab}, W_{\alpha_1}, \dots, W_{\alpha_k}$ , with  $\alpha := (\alpha_1, \dots, \alpha_k)$ . We point out that in (E.23) we also used that the term  $\langle G \rangle \langle GA \rangle$  from (E.19) cancels after cumulant expansion as a consequence of  $\partial_{ba} \langle \Delta^{ab} GA \rangle = -\langle G \rangle \langle GA \rangle$ . By analogous computations to [73, Section 10.1] one can see that the only order one terms are the ones in the first line of (E.23) and a certain term which comes from  $k = 3$  in the second line of (E.23). We thus compute precisely these three terms and neglect the estimates of the other terms as their estimate is completely analogous to [73].

We thus compute

$$\begin{aligned}
& 2 \sum_{ab} \mathbb{E}[\partial_{ba} e_a \langle \Delta^{ab} GA \rangle] \\
&= \frac{2i\lambda}{\pi} \sum_{ij} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) \mathbb{E}[e_a \langle G^z(w_1)^2 E_i G^z(w) A(w) E_j \rangle] d^2 w_1 \\
&= \frac{2i\lambda \psi_a(\lambda)}{\pi} \sum_{ij} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) \langle M^{z, z, z}(w_1, I, w_1, E_i, w) A(w) E_j \rangle d^2 w_1 \\
&\quad + \frac{2i\lambda}{\pi} \sum_{ij} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) \mathbb{E}[e_a \langle (G^z(w_1)^2 E_i G^z(w) - M^{z, z, z}(w_1, I, w_1, E_i, w) A(w) E_j) A(w) E_j \rangle] d^2 w_1.
\end{aligned} \tag{E.24}$$

Here  $\sum_{ij}$  is defined below (1.17). The last line in (E.24) can be easily seen to be lower order using the (almost) global law (recall the definition of  $M^{z_1, z_2, z_3}$  from (E.9), cf. [32, Proposition 4.1])

$$\mathbb{E} \left| \langle (G^{z_1}(w_1) B_1 G^{z_2}(w_2) B_2 G^{z_3}(w_3) - M^{z_1, z_2, z_3}(w_1, B_1, w_2, B_2, w_3)) B_3 \rangle \right|^2 \lesssim \frac{n^{5a}}{n} \tag{E.25}$$

for deterministic  $\|B_i\| \lesssim 1$ . Note that we need (E.25) only in second moment sense. The proof of (E.25) is presented after the conclusion of the proof of this lemma. This concludes the computation of the first term in the RHS of (E.7). Next, we compute

$$2 \sum_{ab} \mathbb{E}[\partial_{ab} e_a \langle \Delta^{ab} GA \rangle] = \frac{2i\lambda}{\pi} \sum_{ij} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) \mathbb{E}[e_a \langle G^z(w_1)^2 E_i A(w)^t G^{\bar{z}}(w) E_j \rangle] d^2 w_1.$$

Proceeding as in (E.24) and using again (E.25), we obtain the second term in the RHS of (E.7).

Finally, we conclude the proof of this lemma by computing the order one term coming from  $k = 3$ . In the second line of (E.23), we notice that for  $k = 3$  the only order one term is given by (all the other terms a lower order)

$$\begin{aligned}
& \frac{\kappa_4}{n^2} \sum_{ab} \mathbb{E}[(\partial_{ab} \partial_{ba} e_a) G_{aa} (GA)_{bb}] \\
&= \frac{i\kappa_4 \lambda}{n^3 \pi} \sum_{ab} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) \mathbb{E}[e_a (G^z(w_1))_{aa} (G^z(w_1)^2)_{bb} (G^z(w))_{aa} (G^z(w) A(w))_{bb}] d^2 w_1 \tag{E.26} \\
&= \frac{2i\lambda \kappa_4 \psi_a(\lambda)}{\pi} \int_{\Omega_a} \partial_{\bar{w}_1} \tilde{f}(w_1) m^z(w_1) (m^z(w_1))' m^z(w) (m^z(w))' d^2 w_1 + \mathcal{O}(n^{-1/2+\xi+k\gamma}).
\end{aligned}$$

We also point out that in the last equality we used

$$(M^z(w) A(w))_{bb} = \langle M^z(w) A(w) \rangle = \langle \mathcal{B}^{-1} [M^z(w) M^z(w)] \rangle = \langle \partial_w M^z(w) \rangle = (m^z(w))'.$$

□

**Proof.** [Proof of (E.25)] By [37, Theorem 5.2] we have

$$\left| \langle (G^{z_1}(w_1) B_1 G^{z_2}(w_2)) - M^{z_1, z_2}(w_1, B_1, w_2) B_2 \rangle \right| \lesssim \frac{n^{3a}}{n} \|B_1\| \|B_2\|, \tag{E.27}$$

with overwhelming probability, with  $M^{z_1, z_2}$  being defined as in (E.9). We now show that, using (3.2) and (E.27) as an input, we can easily conclude (E.25). Note that there is no assumption on the sign of  $\text{Im } w_1 \text{Im } w_2$  in (E.27).

In the reminder of the proof we use the short-hand notations  $M_i := M^{z_i}(w_i)$ ,  $G_i := G^{z_i}(w_i)$ ,  $M_{ij}^B := M^{z_i, z_j}(w_i, B, w_j)$ , and  $\mathcal{B}_{ij}[\cdot] := 1 - M_i \mathcal{S}[\cdot] M_j$ . Using (E.18) for  $G_1$ , we have

$$\begin{aligned} \mathcal{B}_{13}[G_1 B_1 G_2 B_2 G_3] &= M_1 B_1 M_{23}^{B_2} + M_1 \mathcal{S}[M_{12}^{B_1}] M_{23}^{B_2} - M_1 \underline{W G_1 B_1 G_2 B_2 G_3} + M_1 B_1 (G_2 B_2 G_3 - M_{23}^{B_2}) \\ &\quad + M_1 \mathcal{S}[G_1 B_1 G_2 - M_{12}^{B_1}] (M_{23}^{B_2} + G_2 B_2 G_3 - M_{23}^{B_2}) + M_1 \mathcal{S}[M_{12}^{B_1}] (G_2 B_2 G_3 - M_{23}^{B_2}) \\ &\quad + M_1 \mathcal{S}[G_1 B_1 G_2 B_2 G_3] (G_3 - M_3) + \langle G_1 - M_1 \rangle M_1 G_1 B_1 G_2 B_2 G_3, \end{aligned} \quad (\text{E.28})$$

where we defined

$$\underline{W G_1 B_1 G_2 B_2 G_3} := \underline{W G_1} B_1 G_2 B_2 G_3 + \mathcal{S}[G_1 B_1 G_2] G_2 B_2 G_3 + \mathcal{S}[G_1 B_1 G_2 B_2 G_3] G_3. \quad (\text{E.29})$$

From now on we assume that  $\|B_i\| \lesssim 1$ . Note that all the random terms in the RHS of (E.28), except for the underline term, can be estimated relying on the single resolvent local law (2.18) or on the two-resolvent local law (E.27). We now present the estimate of two representative terms, all other terms can be estimated analogously. We notice that for any matrices  $R_1, R_2$  we have

$$\langle \mathcal{B}_{13}^{-1}[R_1] R_2 \rangle = \langle R_1 ((\mathcal{B}_{13}^{-1})^* [R_2^*])^* \rangle.$$

Denote

$$C := [(\mathcal{B}_{13}^{-1})^* [B_3^*]]^*;$$

and notice that by  $\|\mathcal{B}_{13}^{-1}\| + \|(\mathcal{B}_{13}^{-1})^*\| \lesssim \min_i 1/|\text{Im } w_i| \leq n^\alpha$  it follows  $\|C\| \lesssim n^\alpha$ . Then, using (2.18) together with a Schwarz inequality, we estimate

$$|\langle G_1 - M_1 \rangle \langle M_1 G_1 B_1 G_2 B_2 G_3 C \rangle| \lesssim \frac{n^\xi \|C\|}{n |\text{Im } w_1 \text{Im } w_2 \text{Im } w_3|} \leq \frac{n^{5\alpha}}{n}. \quad (\text{E.30})$$

Additionally, using (E.27) and (8.21), we estimate

$$|\langle M_1 \mathcal{S}[M_{12}^{B_1}] (G_2 B_2 G_3 - M_{23}^{B_2}) C \rangle| = 2 \left| \sum_{ij} \langle M_{12}^{B_1} E_i \rangle \langle M_1 E_j (G_2 B_2 G_3 - M_{23}^{B_2}) C \rangle \right| \lesssim \frac{n^{5\alpha}}{n}. \quad (\text{E.31})$$

Putting these estimates together, we thus conclude

$$\begin{aligned} \langle G_1 B_1 G_2 B_2 G_3 B_3 \rangle &= \left\langle \mathcal{B}_{13}^{-1} [M_1 B_1 M_{23}^{B_2} + M_1 \mathcal{S}[M_{12}^{B_1}] M_{23}^{B_2}] B_3 \right\rangle \\ &\quad - \langle M_1 \underline{W G_1 B_1 G_2 B_2 G_3} C \rangle + \mathcal{O}\left(\frac{n^{6\alpha}}{n}\right), \end{aligned} \quad (\text{E.32})$$

with overwhelming probability.

Finally, using cumulant expansion, proceeding similarly to [37, Eq. (6.32)] (recall that  $|\text{Im } w_i| \geq n^{-\alpha}$ ), we estimate

$$\mathbb{E} |\langle M_1 \underline{W G_1 B_1 G_2 B_2 G_3} C \rangle|^2 \lesssim \frac{n^{4\alpha}}{n},$$

where we used that  $\|C\| \lesssim n^\alpha$ . Recalling the definition (E.9), this concludes the proof.  $\square$

**Proof.** [Proof of (4.3)] We start with the computation for the variance  $V(f)$ . Recall the definition of  $Z$  from (E.14). By (E.17), to prove (4.3), it is enough to compute  $\text{Var}(Z)$  when  $f(x) = \text{Re } \log(x - i\eta)$ , with  $\eta = n^{-\gamma}$ .

Using (E.1) and the local law (3.2), it is easy to see that

$$Z = \text{Tr}f(H^z) - \mathbb{E}\text{Tr}f(H^z) + \mathcal{O}(n^{-1/2}) = \frac{1}{2} \sum_i \log [(\lambda_i^z)^2 + \eta^2] - \mathbb{E}(\dots) + \mathcal{O}(n^{-1/2}). \quad (\text{E.33})$$

We now write  $Z = Z_1 + Z_2$  (neglecting the negligible error term  $n^{-1/2}$ ), with

$$\begin{aligned} Z_1 &:= - \int_{\eta}^1 \text{Tr}[\text{Im} G^z(i\tau) - \mathbb{E} \text{Im} G^z(i\tau)] d\tau \\ Z_2 &:= \frac{1}{2} \sum_i \log [(\lambda_i^z)^2 + 1] - \mathbb{E} \frac{1}{2} \sum_i \log [(\lambda_i^z)^2 + 1]. \end{aligned} \quad (\text{E.34})$$

We use the following lemma (whose proof is presented at the end of this section) to estimate  $\text{Var}(Z_2)$ :

**Lemma E.2.** *There exists  $C > 0$  such that*

$$\text{Var}(Z_2) \leq C. \quad (\text{E.35})$$

Then, using (E.35), we have

$$V(f) = \text{Var}(Z_1) + \mathcal{O}\left(\text{Var}(Z_1)^{1/2} + n^{-1/5}\right). \quad (\text{E.36})$$

We are thus left only with the computation of  $\text{Var}(Z_1)$ . Using [37, Proposition 3.3], [35, Proposition 3.3] for the complex and real case, respectively, we get

$$\text{Var}(Z_1) = 4 \int_{\eta}^1 \int_{\eta}^1 [\widehat{V}(z, \tau_1, \tau_2) + \kappa_4 U(z, \tau_1)U(z, \tau_2)] d\tau_1 d\tau_2 + \mathcal{O}\left(\frac{n^{6\alpha}}{\sqrt{n}}\right). \quad (\text{E.37})$$

Here, using the notations  $m_i := m^{z_i}(i\tau_i)$ ,  $u_i := u^{z_i}(i\tau_i)$ , we defined  $U(z_i, \tau_i) := i\partial_{\tau_i} m_i / \sqrt{2}$ , and  $\widehat{V}(z, \tau_1, \tau_2) = V(z, z, \tau_1, \tau_2) + \mathbf{1}_{\{\beta=1\}} V(z, \bar{z}, \tau_1, \tau_2)$ , with

$$V(z_1, z_2, \tau_1, \tau_2) := -\frac{1}{2} \partial_{\tau_1} \partial_{\tau_2} \log [1 + |z_1 z_2|^2 u_1^2 u_2^2 - m_1^2 m_2^2 - 2u_1 u_2 \text{Re}[z_1 \bar{z}_2]]. \quad (\text{E.38})$$

We point out that in [37, Proposition 3.3] and [35, Proposition 3.3] it was assumed that  $z_1 \neq z_2$ ,  $z_1 \neq \bar{z}_2$ , however, inspecting the proof of these propositions it is clear that this assumption is not needed for  $\eta_i \geq n^{-\alpha}$  (see also [37, Remark 3.4]).

Then, using that both  $U$  and  $\widehat{V}$  are complete derivatives, we then compute (for simplicity we only consider the case  $\beta = 2$ )

$$\begin{aligned} \text{Var}(Z_1) &= -\log [1 + |z|^4 (u^z(i\eta))^4 - (m^z(i\eta))^4 - 2(u^z(i\eta))^2 |z|^2] \\ &\quad + 2 \log [1 + |z|^4 (u^z(i\eta))^2 (u^z(i))^2 - (m^z(i\eta))^2 (m^z(i))^2 - 2u^z(i\eta) u^z(i) |z|^2] + \mathcal{O}(1). \end{aligned} \quad (\text{E.39})$$

Finally, using the analog of (6.15) for  $m^z(i\eta)$ ,  $u^z(i\eta)$ , we conclude

$$\text{Var}(Z_1) = -\log \eta + \mathcal{O}(1). \quad (\text{E.40})$$

Similarly, in the real case we get

$$\text{Var}(Z_1) = -\log \eta - \log[|z - \bar{z}|^2 + \eta] + \mathcal{O}(1)$$

Combining this with (E.36) we conclude the computation of  $V(f)$ .

We now turn to the computation of  $\mathbb{E}\text{Tr}f(H^z)$ . We write (recall that  $\eta = n^{-\gamma}$ )

$$\begin{aligned}\mathbb{E}\text{Tr}f(H^z) &= \frac{1}{2}\mathbb{E}\sum_i \log [(\lambda_i^z)^2 + \eta^2] \\ &= \frac{1}{2}\mathbb{E}\sum_i \log [(\lambda_i^z)^2 + 1] - \int_\eta^1 \mathbb{E}\text{Tr}[\text{Im} G^z(i\tau)] d\tau.\end{aligned}\tag{E.41}$$

Denote  $m := m^z(i\tau)$  and  $u := u^z(i\tau)$ . In order to compute the expectation of the second term in the RHS of (E.41) we rely on [37, Eqs. (3.11)–(3.12)]:

$$\mathbb{E}\text{Tr}[\text{Im} G(i\eta)] = -2im - \frac{\kappa_4}{2}\partial_\tau m^4 + \frac{\mathbf{1}_{\{\beta=1\}}}{2}\partial_\tau \log(1 - u^2 + 2u^3|z|^2 - u^2(z^2 + \bar{z}^2)) + \mathcal{O}\left(\frac{n^{2\gamma}}{\sqrt{n}}\right).\tag{E.42}$$

We point out that in [37, Eqs. (3.11)–(3.12)] the error term deteriorates with  $|\text{Im} z|^2$ ; however, inspecting its proof, it is clear that every instance of  $1/|\text{Im} z|^2$  can be replaced by  $1/\eta$ , giving (E.42).

We now use

$$\frac{1}{2}\mathbb{E}\sum_i \log [(\lambda_i^z)^2 + 1] = n \int \log(x^2 + 1)\rho^z(x) dx + \mathcal{O}(1).\tag{E.43}$$

This easily follows by an application of Helffer–Sjöstrand formula together with (E.42) for  $\gamma = 0$  (see the proof of Lemma E.2 for similar computations). Plugging (E.43) into (E.41) and using (E.42), we obtain

$$\begin{aligned}\mathbb{E}\text{Tr}f(H^z) &= n \int \log(x^2 + 1)\rho^z(x) dx - 2in \int_\eta^1 m^z(i\tau) d\tau \\ &\quad + \frac{\mathbf{1}_{\{\beta=1\}}}{2} \log(1 - u^z(i\eta)^2 + 2u^z(i\eta)^3|z|^2 - u^z(i\eta)^2(z^2 + \bar{z}^2)) + \mathcal{O}(1).\end{aligned}\tag{E.44}$$

Finally, using that

$$\partial_\tau \int \log(x^2 + \tau^2)\rho^z = -2im^z(i\tau),$$

and the analog of (6.15) for  $m^z(i\eta), u^z(i\eta)$  in (E.42), (E.44) concludes the computation of the expectation of  $f(H^z)$ . □

**Proof.** [Proof of Lemma E.2] Consider  $f(x) := \log(x^2 + 1)$ , then, using (E.11) and (E.17) (applied to this function), we write

$$\text{Var}(Z_2) = V(f) = \frac{1}{\pi^2} \int_{\Omega_a} \int_{\Omega_a} \partial_{\bar{z}} \tilde{f}(z) \partial_{\bar{w}} \tilde{f}(w) R(z, w) dz^2 d^2w + \mathcal{O}(n^{-1/4+200\gamma}),\tag{E.45}$$

with  $a > 0$  arbitrary small,  $\Omega_a$  from (E.4), and  $R(z, w)$  being defined in (E.7). Next, by (E.1) for  $\gamma = 0$ , we have

$$|\partial_{\bar{z}} \tilde{f}(z)| \lesssim |\text{Im} z|^{k-1},\tag{E.46}$$

for any  $k \in \mathbb{N}$ . Additionally, by the definition of  $R(z, w)$  in (E.7) (see also (E.8)–(E.9)) together with (8.21) for  $z_1 = z_2 = z$ , we also have

$$|R(z, w)| \lesssim \frac{1}{(|\text{Im} z| + |\text{Im} w|)^3}.\tag{E.47}$$

Plugging (E.46)–(E.47) into (E.45) we conclude the desired bound. □

## F Green's function comparison

### F.1 Proof of Proposition 3.7

The proof given here is similar in spirit to [52, Section 2.3]. Suppose first that  $X$  and  $Y$  differ only in one matrix entry, say the  $(1, 1)$ -th. Let  $W(\theta)$  be the matrix with this entry set to  $\theta$  so that  $X = W(X_{11})$  and  $Y = W(Y_{11})$ . Let  $F : \mathbb{C} \rightarrow \mathbb{R}$  be a smooth function so that

$$F(z) = 1, \quad |z| > (k + 3/4)(\log n)^{1/2+\delta}, \quad F(z) = 0, \quad |z| < (k + 1/2)(\log n)^{1/2+\delta} \quad (\text{F.1})$$

Using the local law of Theorem 2.4 and a resolvent expansion it is not hard to check that for any  $\frac{1}{10} > \varepsilon > 0$  we have, with overwhelming probability

$$\left| \sup_{|\theta| \leq n^{\varepsilon/2-1/2}} \partial_{\theta}^a \partial_{\theta}^b Z(W(\theta)) \right| \leq n^{\varepsilon}. \quad (\text{F.2})$$

for all  $0 \leq a + b \leq 5$ ,  $a, b \geq 0$ . Specifically, the derivatives appearing above will involve products of resolvent entries of  $W$ . If  $\theta$  were a random variable, the bounds for these entries would follow from (2.17). To deal with the sup over  $\theta$ , one can apply a resolvent expansion similar to (16.8) of [53].

By Taylor expansion to fifth order we then see that,

$$|\mathbb{E}[F(X)] - \mathbb{E}[F(Y)]| \leq (Tn^{-2} + n^{-5/2+\varepsilon}) \mathbb{E} \left[ \sup_{|\theta| \leq n^{\varepsilon/2-1/2}, 1 \leq a+b \leq 5} \partial_{\theta}^a \partial_{\theta}^b F(Z(W(\theta))) \right] + n^{-D}. \quad (\text{F.3})$$

The derivatives of  $F(z)$  are non-zero only if  $|z| > (k + 1/2)(\log n)^{1/2+\delta}$ . Moreover, one can check by resolvent expansion that

$$\sup_{|\theta| \leq n^{\varepsilon-1/2}} |Z(W(\theta)) - Z(W(X_{11}))| \leq n^{-1/4} \quad (\text{F.4})$$

with overwhelming probability. Therefore,

$$|\mathbb{E}[F(X)] - \mathbb{E}[F(Y)]| \leq (Tn^{-2} + n^{-5/2+\varepsilon}) n^{\varepsilon} p(k) + n^{-D}. \quad (\text{F.5})$$

In the general case where  $X$  and  $Y$  differ in all entries but the moments match, we follow the Lindeberg replacement strategy by replacing the matrix elements of  $X$  by those of  $Y$  one at a time; the above illustrates one step of the procedure (see e.g. the fourth moment method of Tao–Vu [88] or [53, Chapter 16] for a pedagogical introduction). At each of the  $n^2$  steps we apply the above inequality to conclude that

$$|\mathbb{E}[F(X)] - \mathbb{E}[F(Y)]| \leq T^{1/2} p(k) + n^{-D}. \quad (\text{F.6})$$

We may also apply the above estimate with  $X = W^{(ab)}$ , i.e., at one of the intermediate steps. The claim now follows.  $\square$

### F.2 Proof of Lemma 7.1 and Proposition 11.3

We prove only Proposition 11.3, as the proof of Lemma 7.1 is easier. The proof of this proposition will go through the standard Lindeberg replacement strategy of replacing the matrix elements of one matrix by another one by one and estimating the difference at each step (see above). First, we

will need to regularize the max, using a similar strategy to [71]. We notice that for any  $B > 0$  we have

$$\max_{z \in \mathcal{P}_2} Q(z) \mathcal{X}_n(z) \leq \frac{1}{B} \log \left( \sum_{z \in \mathcal{P}_2} e^{BQ(z) \mathcal{X}_n(z)} \right) \leq \max_{z \in \mathcal{P}_2} Q(z) \mathcal{X}_n(z) + \frac{\log |\mathcal{P}_2|}{B}, \quad (\text{F.7})$$

where we abbreviated  $Q(z) \mathcal{X}_n(z) := Q(n\eta_4 \text{Im}\langle G^z(i\eta_4) \rangle) (\Psi_n(z, \eta_3) - \Psi_n(z, n^{-b}))$ . We take  $B = n^\alpha$  for some fixed  $\alpha > 0$ . Let

$$\hat{\Xi} := \frac{1}{B} \log \left( \sum_{z \in \mathcal{P}_2} e^{B\beta Q(z) \mathcal{X}_n(z)} \right), \quad (\text{F.8})$$

so that

$$|\mathbb{E}[F(\Xi)] - \mathbb{E}[F(\hat{\Xi})]| \leq C \|F\|_{C^1} n^{-\alpha} \log n \quad (\text{F.9})$$

Let  $\partial_{ij}$  be directional derivatives with respect to the matrix elements. Let  $W(\theta)$  be a real or complex i.i.d. matrix with the  $(a, b)$ -th entry set to  $\theta$ . It is not hard to check that for any sufficiently small  $\varepsilon, \xi > 0$

$$\sup_{i,j, |\theta| \leq n^{1/2+\varepsilon}, (\log n)^{-C} n^{-1} \leq \eta} \left| (H_\theta^z - i\eta)_{ij}^{-1} \right| \leq n^\xi \quad (\text{F.10})$$

with overwhelming probability. Here,  $H_\theta^z$  is the Hermitization of  $W(\theta)$ . Define,

$$M_\theta := \max_{z \in \mathcal{P}_2, 0 \leq a+b \leq 5} \left| \partial_{ij}^a \partial_{ji}^b (n^\alpha Q(z) \mathcal{X}_n(z)) \right| \Big|_{W(\theta)} \quad (\text{F.11})$$

The derivatives of the above quantity can be written in terms of the resolvent entries of  $W(\theta)$ . Therefore, using (F.10) one finds that

$$\sup_{|\theta| \leq n^{-1/2+\varepsilon}} |M_\theta| \leq n^{\xi+\alpha} \quad (\text{F.12})$$

with overwhelming probability and that  $|M| \leq n^{10}$  almost surely. By direct calculation (see Lemma F.1 below), we find that

$$|\partial_{ij}^a \partial_{ij}^b \hat{\Xi}| \leq C_k M_\theta^k \quad (\text{F.13})$$

for  $a + b \leq k$ . With this as input, the proof of the proposition follows from applying the standard Lindeberg replacement strategy as indicated above, after taking  $\alpha > 0$  sufficiently small. Again, we refer the reader to [53] for a pedagogical introduction.  $\square$

**Lemma F.1.** *Let  $Z = B^{-1} \log \left( \sum_z e^{B\mathcal{X}_z} \right)$  where  $\mathcal{X}_z$  are some real valued functions on the space of matrices. Then for any  $k$  there is a constant  $C_k > 0$  so that,*

$$\left| \partial_{ij}^k Z(X) \right| \leq C_k B^{k-1} \max_{z, 0 \leq a \leq k} |\partial_{ij}^a \mathcal{X}_z|^k \quad (\text{F.14})$$

**Proof.** This follows by a straightforward and direct calculation, which is outlined in, e.g., the proof of Lemma 3.4 of [71]. For reader convenience, we present the proof for the first derivative, as the general case is not much harder:

$$|\partial_{ij} Z| = B \left| \frac{\sum_z e^{B\mathcal{X}_z} \partial_{ij} \mathcal{X}_z}{\sum_z e^{B\mathcal{X}_z}} \right| \leq \sup_z |\partial_{ij} \mathcal{X}_z| \quad (\text{F.15})$$

where we used that  $\mathcal{X}_z$  is real-valued so that  $e^{B\mathcal{X}_z}$  is positive.  $\square$
