# MODULARITY OF CERTAIN PRODUCTS OF THE ROGERS-RAMANUJAN CONTINUED FRACTION

#### Abstract

We study the modularity of the functions of the form $r(\tau)^{a} r(2 \tau)^{b}$, where $a$ and $b$ are integers with $(a, b) \neq(0,0)$ and $r(\tau)$ is the Rogers-Ramanujan continued fraction, which may be considered as companions to the Ramanujan's function $k(\tau)=r(\tau) r(2 \tau)^{2}$. In particular, we show that under some condition on $a$ and $b$, there are finitely many such functions generating the field of all modular functions on the congruence subgroup $\Gamma_{1}(10)$. Furthermore, we establish certain arithmetic properties of the function $l(\tau)=r(2 \tau) / r(\tau)^{2}$, which can be used to evaluate these products. We employ the methods of Lee and Park, and some properties of $\eta$-quotients and generalized $\eta$-quotients to prove our results.


## 1. Introduction

For an element $\tau$ in the complex upper half-plane $\mathbb{H}$ and $q:=e^{2 \pi i \tau}$, the RogersRamanujan continued fraction is defined by

$$
r(\tau)=\frac{q^{1 / 5}}{1+\frac{q}{1+\frac{q^{2}}{1+\frac{q^{3}}{1+\cdots}}}}=q^{1 / 5} \prod_{n=1}^{\infty} \frac{\left(1-q^{5 n-1}\right)\left(1-q^{5 n-4}\right)}{\left(1-q^{5 n-2}\right)\left(1-q^{5 n-3}\right)} .
$$

In his first correspondence [2, pp. 21-30] to Hardy in 1913, Ramanujan asserted that

$$
r(i)=\sqrt{\frac{5+\sqrt{5}}{2}}-\frac{\sqrt{5}+1}{2}
$$

He later claimed in his second letter [2, pp. 53-62] to Hardy that the values of $r\left(\frac{\sqrt{-n}}{2}\right)$ "can be exactly found" for any positive rational number $n$. Ramanujan's observations were settled by Gee and Honsbeek [10], who treated $r(\tau)$ as a modular function, and used Watson's formulas [18] to show that $r(\tau)$ generates the field of all modular functions on the congruence subgroup $\Gamma(5)$. Consequently, they determined the exact values of $r(\tau)$ at some imaginary quadratic points $\tau \in \mathbb{H}$ as nested radicals.

Recently, Lee and Park [12] proved that the Ramanujan's function $k(\tau):=r(\tau) r(2 \tau)^{2}$ generates the field of all modular functions on the congruence subgroup $\Gamma_{1}(10)$. They also proved that if $K$ is an imaginary quadratic field with ring of integers $\mathbb{Z}[\tau]$ and $\tau \in K \cap \mathbb{H}$, then $k(\tau)$ generates the ray class field $K_{(10)}$ modulo 10 over $K$. As a result, they computed the exact values of $r(\tau)$ at some imaginary quadratic points $\tau \in \mathbb{H}$. We refer the reader to $[1,6,19,22]$ for other arithmetic properties of $k(\tau)$.

In this paper, we partially extend Lee and Park's result by exploring the functions $r(\tau)^{a} r(2 \tau)^{b}$ for integers $a$ and $b$ with $(a, b) \neq(0,0)$, which may be considered as companions of $k(\tau)$. More precisely, we show that under some condition on $a$ and $b$, there

[^0]are finitely many such functions generating the field of all modular functions on $\Gamma_{1}(10)$. We also show that under the same condition, the above functions can be expressed in terms of $l(\tau):=r(2 \tau) / r(\tau)^{2}$. We further establish certain arithmetic properties of $l(\tau)$, which will be useful in computing exactly the values of $r(\tau)^{a} r(2 \tau)^{b}$ at imaginary quadratic points $\tau \in \mathbb{H}$. We apply the methods of Lee and Park [12], as well as some properties of $\eta$-quotients and generalized $\eta$-quotients defined by Yang [20], to prove our results.

We organize the paper as follows. In Section 2, we give a brief background about modular functions, particularly $\eta$-quotients and generalized $\eta$-quotients, on some congruence subgroups of $\mathrm{SL}_{2}(\mathbb{Z})$. In Section 3, we discuss the modularity of the functions $r(\tau)^{a} r(2 \tau)^{b}$ on $\Gamma_{1}(10)$, where $a$ and $b$ are integers with $(a, b) \neq(0,0)$ and $5 \mid a-3 b$. We show that these functions can be expressed as a rational function of $l(\tau)$. In Section 4, we prove that modular equations for $l(\tau)$ of any level always exist, and derive such equations for $l(\tau)$ of levels two and five. We prove in Section 5 that if $K$ is an imaginary quadratic field with ring of integers $\mathbb{Z}[\tau]$ for some $\tau \in K \cap \mathbb{H}$, then $l(\tau)$ generates $K_{(10)}$. We also prove that $l(\tau)$ and the functions $r(\tau)^{a} r(2 \tau)^{b}$ are algebraic units for $\tau \in K \cap \mathbb{H}$. Finally, we give an example of finding the class polynomial for $K_{(10)}$ when the discriminant of $K$ is divisible by 4 using Shimura reciprocity law due to Cho and Koo [4] and Gee [9] to evaluate $r(\tau)^{a} r(2 \tau)^{b}$. We perform most of our calculations via Mathematica.

## 2. Preliminaries

In this section, we recall some facts about modular functions on some congruence subgroups, which are subgroups of $\mathrm{SL}_{2}(\mathbb{Z})$ containing

$$
\Gamma(N):=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \mathrm{SL}_{2}(\mathbb{Z}): a-1 \equiv b \equiv c \equiv d-1 \equiv 0 \quad(\bmod N)\right\}
$$

for some integer $N \geq 1$. Examples of congruence subgroups we focus on in this paper are

$$
\begin{aligned}
& \Gamma_{1}(N):=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \operatorname{SL}_{2}(\mathbb{Z}): a-1 \equiv c \equiv d-1 \equiv 0 \quad(\bmod N)\right\} \\
& \Gamma_{0}(N):=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \operatorname{SL}_{2}(\mathbb{Z}): c \equiv 0 \quad(\bmod N)\right\}
\end{aligned}
$$

Any element of a given congruence subgroup $\Gamma$ acts on the extended upper half-plane $\mathbb{H}^{*}:=\mathbb{H} \cup \mathbb{Q} \cup\{\infty\}$ by a linear fractional transformation. We define the cusps of $\Gamma$ as the equivalence classes of $\mathbb{Q} \cup\{\infty\}$ under this action, and it is known that there are finitely many inequivalent cusps of $\Gamma$. We define the modular function on $\Gamma$ by a function $f(\tau): \mathbb{H} \rightarrow \mathbb{C}$ such that

- $f(\tau)$ is meromorphic on $\mathbb{H}$,
- $f(\gamma \tau)=f(\tau)$ for all $\gamma \in \Gamma$, and
- $f(\tau)$ is meromorphic at all cusps of $\Gamma$.

The last condition implies that for every cusp $r$ of $\Gamma$ and an element $\gamma \in \operatorname{SL}_{2}(\mathbb{Z})$ with $\gamma(\infty)=r$, the $q$-expansion of $f \circ \gamma$ given by $f(\gamma \tau)=\sum_{n \geq n_{0}} a_{n} q^{n / h}$, for some integers $h$ and $n_{0}$ with $a_{n_{0}} \neq 0$, has finitely many negative exponents. We call the least such $n_{0}$ the order of $f(\tau)$ at $r$, denoted by $\operatorname{ord}_{r} f(\tau)$, and we say that $f(\tau)$ has a zero (resp., a pole) at $r$ if $\operatorname{ord}_{r} f(\tau)$ is positive (resp., negative). We also call $h$ the width of $r$, which is the smallest positive integer $k$ such that $\gamma\left[\begin{array}{ll}1 & k \\ 0 & 1\end{array}\right] \gamma^{-1} \in \pm \Gamma$. We note that $h$ is independent on the choice of $\gamma$.

Let $A_{0}(\Gamma)$ be the field of all modular functions on $\Gamma$ and let $A_{0}(\Gamma)_{\mathbb{Q}}$ be its subfield consisting of all modular functions on $\Gamma$ with rational $q$-expansion. We identify $A_{0}(\Gamma)$ with the field of all meromorphic functions on the modular curve $X(\Gamma):=\Gamma \backslash \mathbb{H}^{*}$. If
$f(\tau) \in A_{0}(\Gamma)$ has no zeros nor poles on $\mathbb{H}$, then the degree $\left[A_{0}(\Gamma): \mathbb{C}(f(\tau))\right]$ is the total degree of poles of $f(\tau)$ given by $-\sum_{r} \operatorname{ord}_{r} f(\tau)$, where the sum ranges over the inequivalent cusps $r$ of $\Gamma$ for which $f(\tau)$ has a pole at $r$ (see [17, Prop. 2.11]).

We describe a systematic way of getting the set of inequivalent cusps of the congruence subgroup $\Gamma:=\Gamma_{1}(N) \cap \Gamma_{0}(m N)$ for positive integers $m$ and $N$, following Cho, Koo, and Park [5]. Let $\Gamma(1)_{\infty}$ be the stabilizer of $\infty$ in $\mathrm{SL}_{2}(\mathbb{Z})$ and let $\Gamma \gamma_{i} \Gamma(1)_{\infty}, i=1, \ldots, g$, be the representatives for the double coset $\Gamma \backslash \mathrm{SL}_{2}(\mathbb{Z}) / \Gamma(1)_{\infty}$. Then the set $\left\{\gamma_{i}(\infty): i=1, \ldots, g\right\}$ is the set of all inequivalent cusps of $\Gamma$. Consider the set

$$
M=\left\{(c, d) \in(\mathbb{Z} / m N \mathbb{Z})^{2}: \operatorname{gcd}(c, d, m N)=1\right\}
$$

and the subgroup $\Delta$ of $(\mathbb{Z} / m N \mathbb{Z})^{\times}$given by

$$
\Delta=\left\{ \pm(1+N k) \in(\mathbb{Z} / m N \mathbb{Z})^{\times}: k=0, \ldots, m-1\right\} .
$$

We define a relation $\sim$ on $M$ as follows: if $\left(c_{1}, d_{1}\right),\left(c_{2}, d_{2}\right) \in M$, then $\left(c_{1}, d_{1}\right) \sim\left(c_{2}, d_{2}\right)$ if $\left(c_{2}, d_{2}\right) \equiv\left(s c_{1}, s d_{1}+n c_{1}\right)(\bmod m N)$ for some $s \in \Delta$ and $n \in \mathbb{Z} / m N \mathbb{Z}$. This is an equivalence relation, and the map $\phi: \Gamma \backslash \mathrm{SL}_{2}(\mathbb{Z}) / \Gamma(1)_{\infty} \rightarrow M / \sim \operatorname{sending} \Gamma\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \Gamma(1)_{\infty}$ to the equivalence class of $(c, d)$ is well-defined and bijective (see [8, Prop. 3.8.5]).

Lemma 2.1 ([5]). Suppose $a, c, a^{\prime}, c^{\prime} \in \mathbb{Z}$ such that $\operatorname{gcd}(a, c)=\operatorname{gcd}\left(a^{\prime}, c^{\prime}\right)=1$. We denote $\infty:= \pm 1 / 0$. Then $a / c$ and $a^{\prime} / c^{\prime}$ are equivalent under $\Gamma_{1}(N) \cap \Gamma_{0}(m N)$ if and only if there exist $s \in \Delta$ and $n \in \mathbb{Z}$ such that $\left[\begin{array}{c}a^{\prime} \\ c^{\prime}\end{array}\right] \equiv\left[\begin{array}{c}s_{s c}^{-1} a+n c\end{array}\right](\bmod m N)$.

We now consider the surjective canonical projection $\pi_{x}:(\mathbb{Z} / m N \mathbb{Z})^{\times} \rightarrow(\mathbb{Z} / x \mathbb{Z})^{\times}$for a positive divisor $x$ of $m N$. For each positive divisor $c$ of $m N$, let $s_{c, i}^{\prime}, i=1, \ldots, n_{c}$, be the distinct coset representatives of $\pi_{m N / c}(\Delta)$ in $\left(\mathbb{Z} / \frac{m N}{c} \mathbb{Z}\right)^{\times}$with $n_{c}=\varphi\left(\frac{m N}{c}\right) /\left|\pi_{m N / c}(\Delta)\right|$ (here, $\varphi$ is the Euler's totient function). We then choose $s_{c, i} \in(\mathbb{Z} / m N \mathbb{Z})^{\times}$such that $\pi_{m N / c}\left(s_{c, i}\right)=s_{c, i}^{\prime}$ for each $i$ and define $S_{c}=\left\{s_{c, i} \in(\mathbb{Z} / m N \mathbb{Z})^{\times}: i=1, \ldots, n_{c}\right\}$. We next let $a_{c, j}^{\prime}, j=1, \ldots, m_{c}$, be the distinct coset representatives of $\pi_{c}\left(\Delta \cap \operatorname{ker} \pi_{m N / c}\right)$ in $(\mathbb{Z} / c \mathbb{Z})^{\times}$with

$$
m_{c}=\frac{\varphi(c)}{\left|\pi_{c}\left(\Delta \cap \operatorname{ker} \pi_{m N / c}\right)\right|}=\frac{\varphi(c)\left|\pi_{m N / c}(\Delta)\right|}{\left|\pi_{m N / \operatorname{gcd}(c, m N / c)}(\Delta)\right|} .
$$

We then choose a positive integer $a_{c, j}$ less than $m N$ and coprime to $m N$ such that $\pi_{c}\left(a_{c, j}\right)=a_{c, j}^{\prime}$ for each $j$ and define $A_{c}=\left\{a_{c, j}: j=1, \ldots, m_{c}\right\}$.

Lemma 2.2 ([5]). With the notations as above, let

$$
S=\left\{\left(c s_{c, i}, a_{c, j}\right) \in(\mathbb{Z} / m N \mathbb{Z})^{2}: 0<c \mid m N, s_{c, i} \in S_{c}, a_{c, j} \in A_{c}, \operatorname{gcd}\left(c s_{c, i}, a_{c, j}, m N\right)=1\right\} .
$$

For a given $\left(c s_{c, i}, a_{c, j}\right) \in S$, choose coprime integers $x$ and $y$ such that $x \equiv c s_{c, i}$ $(\bmod m N)$ and $y \equiv a_{c, j}(\bmod m N)$. Then the set of $y / x$ for such $x$ and $y$ is the set of all inequivalent cusps of $\Gamma_{1}(N) \cap \Gamma_{0}(m N)$ and the number of such cusps is

$$
|S|=\sum_{0<c \mid m N} n_{c} m_{c}=\sum_{0<c \mid m N} \frac{\varphi(c) \varphi(m N / c)}{\left|\pi_{m N / \operatorname{gcd}(c, m N / c)}(\Delta)\right|}
$$

We now obtain the width of a cusp of $\Gamma_{1}(N) \cap \Gamma_{0}(m N)$ as the following result shows.
Lemma 2.3 ([5]). The width $h$ of a cusp $a / c$ of $\Gamma_{1}(N) \cap \Gamma_{0}(m N)$, where $a$ and $c$ are coprime integers, is

$$
h= \begin{cases}\frac{m}{\operatorname{gcd}\left(c^{2} / 4, m\right)} m N & \text { if } N=4, \operatorname{gcd}(m, 2)=1, \operatorname{gcd}(c, 4)=2, \\ \frac{m c d}{\operatorname{gcc}(c, N) \operatorname{gcd}\left(m, c^{2} / \operatorname{gcd}(c, N)\right)} & \text { otherwise. }\end{cases}
$$

For the congruence subgroups $\Gamma_{0}(N)$ and $\Gamma_{1}(N)$, we obtain a nice description for their respective sets of inequivalent cusps.

Corollary 2.4 ([5]). Suppose $a, c, a^{\prime}, c^{\prime} \in \mathbb{Z}$ such that $\operatorname{gcd}(a, c)=\operatorname{gcd}\left(a^{\prime}, c^{\prime}\right)=1$. We denote $\infty:= \pm 1 / 0$. Let $S_{\Gamma}$ be the set of all inequivalent cusps of a congruence subgroup $\Gamma$.
(1) The cusps $a / c$ and $a^{\prime} / c^{\prime}$ are equivalent under $\Gamma_{0}(m)$ if and only if there exist $s \in(\mathbb{Z} / m \mathbb{Z})^{\times}$and $n \in \mathbb{Z}$ such that $\left[\begin{array}{c}a^{\prime} \\ c^{\prime}\end{array}\right] \equiv\left[\begin{array}{c}s_{s c}^{-1} a+n c\end{array}\right](\bmod m)$. Moreover, we have

$$
\begin{gathered}
S_{\Gamma_{0}(m)}=\left\{a_{c, j} / c \in \mathbb{Q}: 0<c \mid m, 0<a_{c, j} \leq m, \operatorname{gcd}\left(a_{c, j}, m\right)=1\right. \\
\left.a_{c, j}=a_{c, j^{\prime}} \Longleftrightarrow a_{c, j} \equiv a_{c, j^{\prime}}(\bmod \operatorname{gcd}(c, m / c))\right\}
\end{gathered}
$$

and the width of the cusp $a / c$ in $\Gamma_{0}(m)$ is $m / \operatorname{gcd}\left(c^{2}, m\right)$.
(2) The cusps $a / c$ and $a^{\prime} / c^{\prime}$ are equivalent under $\Gamma_{1}(N)$ if and only if there exists $n \in \mathbb{Z}$ such that $\left[\begin{array}{c}a^{\prime} \\ c^{\prime}\end{array}\right] \equiv \pm\left[\begin{array}{c}a+n c \\ c\end{array}\right](\bmod N)$. Moreover, we have

$$
\begin{aligned}
S_{\Gamma_{1}(N)}= & \left\{y_{c, j} / x_{c, i} \in \mathbb{Q}: 0<c \mid N, 0<s_{c, i}, a_{c, j} \leq N,\right. \\
& \operatorname{gcd}\left(s_{c, i}, N\right)=\operatorname{gcd}\left(a_{c, j}, N\right)=1, \\
& s_{c, i}=s_{c, i^{\prime}} \Longleftrightarrow s_{c, i} \equiv \pm s_{c, i^{\prime}}(\bmod N / c), \\
& a_{c, j}=a_{c, j^{\prime}} \Longleftrightarrow a_{c, j} \equiv \begin{cases} \pm a_{c, j^{\prime}}(\bmod c) \quad & \text { if } c \in\{N / 2, N\} \\
a_{c, j^{\prime}}(\bmod c) & \text { otherwise, },\end{cases} \\
& \left(x_{c, i}, y_{c, j}\right) \in \mathbb{Z}^{2}, \operatorname{gcd}\left(x_{c, i}, y_{c, j}\right)=1, \\
& \left.x_{c, i} \equiv c s_{c, i}(\bmod N), y_{c, j} \equiv a_{c, j}(\bmod N)\right\}
\end{aligned}
$$

and the width of the cusp $a / c$ in $\Gamma_{1}(N)$ is 1 if $N=4$ and $\operatorname{gcd}(c, 4)=2$ and $N / \operatorname{gcd}(c, N)$ otherwise.
We now introduce an $\eta$-quotient, which is a function of the form

$$
f(\tau)=\prod_{\delta \mid N} \eta(\delta \tau)^{r_{\delta}}
$$

for some indexed set $\left\{r_{\delta} \in \mathbb{Z}: \delta \mid N\right\}$, where $\eta(\tau)=q^{1 / 24} \prod_{n=1}^{\infty}\left(1-q^{n}\right)$ is the Dedekind eta function. The next two lemmas provide necessary conditions on the modularity and the behavior at the cusps of an $\eta$-quotient on $\Gamma_{0}(N)$.

Lemma $2.5([14,15,16])$. Let $f(\tau)=\prod_{\delta \mid N} \eta(\delta \tau)^{r_{\delta}}$ be an $\eta$-quotient with $k=\frac{1}{2} \sum_{\delta \mid N} r_{\delta} \in$ $\mathbb{Z}$ such that

$$
\sum_{\delta \mid N} \delta r_{\delta} \equiv 0 \quad(\bmod 24) \quad \text { and } \quad \sum_{\delta \mid N} \frac{N}{\delta} r_{\delta} \equiv 0 \quad(\bmod 24)
$$

Then for all $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in \Gamma_{0}(N)$,

$$
f\left(\frac{a \tau+b}{c \tau+d}\right)=\left(\frac{(-1)^{k} \prod_{\delta \mid N} \delta^{r_{\delta}}}{d}\right)(c \tau+d)^{k} f(\tau)
$$

Lemma 2.6 ([13, 16]). Let $c, d$ and $N$ be positive integers with $d \mid N$ and $\operatorname{gcd}(c, d)=1$ and let $f(\tau)=\prod_{\delta \mid N} \eta(\delta \tau)^{r_{\delta}}$ be an $\eta$-quotient satisfying the conditions of Lemma 2.5. Then the order of vanishing of $f(\tau)$ at the cusp $c / d$ is

$$
\frac{N}{24 d \operatorname{gcd}\left(d, \frac{N}{d}\right)} \sum_{\delta \mid N} \operatorname{gcd}(d, \delta)^{2} \cdot \frac{r_{\delta}}{\delta} .
$$

We next define, following Yang [20], generalized $\eta$-quotients with analogous properties on $\Gamma_{1}(N)$. These are functions of the form

$$
f(\tau)=\prod_{1 \leq g \leq\lfloor N / 2\rfloor} \eta_{N, g}(\tau)^{r_{g}}
$$

for some indexed set $\left\{r_{g} \in \mathbb{Z}: 1 \leq g \leq\lfloor N / 2\rfloor\right\}$ of integers, where

$$
\eta_{N, g}(\tau)=q^{N B(g / N) / 2} \prod_{m=1}^{\infty}\left(1-q^{N(m-1)+g}\right)\left(1-q^{N m-g}\right)
$$

is the generalized Dedekind eta function with $B(t):=t^{2}-t+\frac{1}{6}$. The following results give the transformation formula of $\eta_{N, g}$ on $\Gamma_{0}(N)$ and conditions for the modularity of a generalized $\eta$-quotient on $\Gamma_{1}(N)$.
Lemma 2.7 ([20]). The function $\eta_{N, g}(\tau)$ satisfies $\eta_{N, g+N}(\tau)=\eta_{N,-g}(\tau)=-\eta_{N, g}(\tau)$. Moreover, let $\gamma=\left[\begin{array}{cc}a & b \\ c N & d\end{array}\right] \in \Gamma_{0}(N)$ with $c \neq 0$. Then we have

$$
\eta_{N, g}(\gamma \tau)=\varepsilon(a, b N, c, d) e^{\pi i\left(g^{2} a b / N-g b\right)} \eta_{N, a g}(\tau),
$$

where

$$
\varepsilon(a, b, c, d)=\left\{\begin{array}{lll}
e^{\pi i\left(b d\left(1-c^{2}\right)+c(a+d-3)\right) / 6}, & \text { if } c \equiv 1 & (\bmod 2), \\
-i e^{\pi i\left(a c\left(1-d^{2}\right)+d(b-c+3)\right) / 6}, & \text { if } c \equiv 0 & (\bmod 2) .
\end{array}\right.
$$

Lemma 2.8 ([20]). Suppose $f(\tau)=\prod_{1 \leq g \leq\lfloor N / 2\rfloor} \eta_{N, g}(\tau)^{r_{g}}$ is a generalized $\eta$-quotient such that

$$
\sum_{1 \leq g \leq\lfloor N / 2\rfloor} r_{g} \equiv 0 \quad(\bmod 12) \quad \text { and } \quad \sum_{1 \leq g \leq\lfloor N / 2\rfloor} g r_{g} \equiv 0 \quad(\bmod 2) .
$$

Then $f(\tau)$ is a modular function on $\Gamma(N)$. Moreover, if in addition, $f(\tau)$ satisfies

$$
\sum_{1 \leq g \leq\lfloor N / 2\rfloor} g^{2} r_{g} \equiv 0 \quad(\bmod 2 N)
$$

then $f(\tau)$ is a modular function on $\Gamma_{1}(N)$.
Lemma 2.9 ([20]). Let $N$ be a positive integer and $\gamma=\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in S L_{2}(\mathbb{Z})$. Then the first term of the $q$-expansion of $\eta_{N, g}(\gamma \tau)$ is $\varepsilon q^{\delta}$, where $|\varepsilon|=1$ and

$$
\delta=\frac{\operatorname{gcd}(c, N)^{2}}{2 N} P_{2}\left(\frac{a g}{\operatorname{gcd}(c, N)}\right)
$$

with $P_{2}(t):=B(\{t\})$ and $\{t\}$ is the fractional part of $t$.
Using Lemma 2.3, Corollary 2.4, and Lemma 2.9, we can compute the order of a generalized $\eta$-quotient at a cusp of $\Gamma_{1}(N) \cap \Gamma_{0}(m N)$.
3. Modularity of $r(\tau)^{a} r(2 \tau)^{b}$

In this section, we show that under a congruence condition on integers $a$ and $b$ with $(a, b) \neq(0,0)$, there are finitely many functions of the form $r(\tau)^{a} r(2 \tau)^{b}$ generating the field $A_{0}\left(\Gamma_{1}(10)\right)$ of all modular functions on $\Gamma_{1}(10)$, partially extending the result of Lee and Park [12] that $k(\tau)$ is one such function. To prove this, we use the fact that $r(\tau)=\eta_{5,1}(\tau) / \eta_{5,2}(\tau)$.
Theorem 3.1. Let $a$ and $b$ be integers with $(a, b) \neq(0,0)$ such that $5 \mid a-3 b$. Then the function $r(\tau)^{a} r(2 \tau)^{b}$ is modular on $\Gamma_{1}(10)$. In addition, if $r(\tau)^{a} r(2 \tau)^{b}$ generates $A_{0}\left(\Gamma_{1}(10)\right)$, then there are two such functions up to taking reciprocals, namely $k(\tau)$ and $l(\tau)$.

Proof. We write $F(\tau):=r(\tau)^{a} r(2 \tau)^{b}$ as a generalized $\eta$-quotient given by

$$
F(\tau)=\eta_{10,1}(\tau)^{a} \eta_{10,2}(\tau)^{b-a} \eta_{10,3}(\tau)^{-a} \eta_{10,4}(\tau)^{a-b} .
$$

By Lemma 2.8 and the given divisibility condition, we see that $F(\tau)$ is modular on $\Gamma_{1}(10)$. Using Corollary 2.4(2), we choose the set of inequivalent cusps of $\Gamma_{1}(10)$ to be $S_{\Gamma_{1}(10)}=\{\infty, 0,1 / 2,1 / 3,1 / 5,1 / 6,3 / 5,3 / 10\}$. We then calculate using Lemma 2.9 the order of $F(\tau)$ at each element of $S_{\Gamma_{1}(10)}$, as shown in Table 1.

| cusp $r$ | $\infty$ | $1 / 5$ | $3 / 5$ | $3 / 10$ | $0,1 / 2,1 / 3,1 / 6$ |
| :---: | :---: | :---: | :---: | :---: | :---: |
| $\operatorname{ord}_{r} F(\tau)$ | $\frac{1}{5}(a+2 b)$ | $\frac{1}{5}(2 a-b)$ | $\frac{1}{5}(-2 a+b)$ | $\frac{1}{5}(-a-2 b)$ | 0 |

Table 1. The orders of $F(\tau)$ at the cusps of $\Gamma_{1}(10)$

Observe that the orders of $F(\tau)$ at the cusps $\infty, 1 / 5,3 / 5$ and $3 / 10$ are integers, and that $\operatorname{ord}_{3 / 5} F(\tau)=-\operatorname{ord}_{1 / 5} F(\tau)$ and $\operatorname{ord}_{3 / 10} F(\tau)=-\operatorname{ord}_{\infty} F(\tau)$. Since $F(\tau)$ generates $A_{0}\left(\Gamma_{1}(10)\right)$, exactly one of $\operatorname{ord}_{1 / 5} F(\tau)$ and $\operatorname{ord}_{\infty} F(\tau)$ is zero and the other is $\pm 1$ (otherwise, the total degree of poles of $F(\tau)$ would have been at least 2 ). We now proceed by doing casework:

- If $0=\operatorname{ord}_{1 / 5} F(\tau)=\frac{1}{5}(2 a-b)$ and $\pm 1=\operatorname{ord}_{\infty} F(\tau)=\frac{1}{5}(a+2 b)$, then $(a, b) \in$ $\{(1,2),(-1,-2)\}$.
- If $0=\operatorname{ord}_{\infty} F(\tau)=\frac{1}{5}(a+2 b)$ and $\pm 1=\operatorname{ord}_{1 / 5} F(\tau)=\frac{1}{5}(2 a-b)$, then $(a, b) \in$ $\{(-2,1),(2,-1)\}$.
Thus, we get four possible ordered pairs ( $a, b$ ), corresponding to the functions $k(\tau), k(\tau)^{-1}, l(\tau)$ and $l(\tau)^{-1}$. The desired conclusion now follows.

As a consequence of Theorem 3.1, we prove that the field $A_{0}\left(\Gamma_{0}(10)\right)$ of all modular functions on $\Gamma_{0}(10)$ can be generated by a rational function of $l(\tau)$. We use the fact that $\Gamma_{0}(10)$ is generated by $\Gamma_{1}(10)$ and the matrix $\gamma:=\left[\begin{array}{cc}3 & -1 \\ 10 & -3\end{array}\right]$.
Theorem 3.2. The function $l(\tau)-1 / l(\tau)$ generates $A_{0}\left(\Gamma_{0}(10)\right)$.
Proof. Since $l(\gamma \tau)=-1 / l(\tau)$ by Lemma 2.7, $l(\tau)-1 / l(\tau) \in A_{0}\left(\Gamma_{0}(10)\right)$. We take $S_{\Gamma_{0}(10)}=\{\infty, 0,1 / 2,1 / 5\}$ as the set of inequivalent cusps of $\Gamma_{0}(10)$ by Corollary 2.4(1). Using Lemma 2.9, we compute $\operatorname{ord}_{1 / 5} l(\tau)=-1$ and $\operatorname{ord}_{r} l(\tau)=0$ for any $r \in S_{\Gamma_{0}(10)}$ with $r \neq 1 / 5$. We see that

$$
\operatorname{ord}_{1 / 5}(l(\tau)-1 / l(\tau))=\min \left\{\operatorname{ord}_{1 / 5} l(\tau), \operatorname{ord}_{1 / 5} 1 / l(\tau)\right\}=-1
$$

and

$$
\operatorname{ord}_{r}(l(\tau)-1 / l(\tau)) \geq \min \left\{\operatorname{ord}_{r} l(\tau), \operatorname{ord}_{r} 1 / l(\tau)\right\}=0
$$

for any $r \in S_{\Gamma_{0}(10)}$ with $r \neq 1 / 5$. Thus, we obtain that $l(\tau)-1 / l(\tau)$ has a simple pole only at $1 / 5$ and holomorphic elsewhere, which yields the desired conclusion.

We now consider modular functions on $\Gamma_{0}(10)$ involving $r(\tau)^{a} r(2 \tau)^{b}$ for integers $a$ and $b$ with $(a, b) \neq(0,0)$. The following results, which extend Theorem 3.2, imply that under the condition of Theorem 3.1, the functions $r(\tau)^{a} r(2 \tau)^{b}$ can be expressed explicitly in terms of $l(\tau)$.
Theorem 3.3. Let $a$ and $b$ be integers with $(a, b) \neq(0,0)$ such that $5 \mid a-3 b$. Then the function $f_{a, b}(\tau):=r(\tau)^{a} r(2 \tau)^{b}+(-1)^{b-a} /\left(r(\tau)^{a} r(2 \tau)^{b}\right)$ is modular on $\Gamma_{0}(10)$. In addition, the function $(l(\tau)-1 / l(\tau))^{|a+2 b| / 5} f_{a, b}(\tau)$ is a polynomial in $l(\tau)-1 / l(\tau)$ with rational coefficients.

Proof. We know from Theorem 3.1 that $F(\tau):=r(\tau)^{a} r(2 \tau)^{b}$ is a modular function on $\Gamma_{1}(10)$. Since $F(\gamma \tau)=(-1)^{b-a} / F(\tau)$ by Lemma 2.7, we see that $f_{a, b}(\tau)=F(\tau)+F(\gamma \tau)$ is a modular function on $\Gamma_{0}(10)$. We again choose $S_{\Gamma_{0}(10)}=\{\infty, 0,1 / 2,1 / 5\}$ as the set of inequivalent cusps of $\Gamma_{0}(10)$ by Corollary 2.4(1). By Lemma 2.9, we find that $\operatorname{ord}_{\infty} F(\tau)=(a+2 b) / 5, \operatorname{ord}_{1 / 5} F(\tau)=(2 a-b) / 5$ and $\operatorname{ord}_{r} F(\tau)=0$ for $r \in\{0,1 / 2\}$. Thus, we get

$$
\begin{aligned}
\operatorname{ord}_{\infty} f_{a, b}(\tau) & =\min \left\{\operatorname{ord}_{\infty} F(\tau), \operatorname{ord}_{\infty} 1 / F(\tau)\right\}=-|a+2 b| / 5 \\
\operatorname{ord}_{1 / 5} f_{a, b}(\tau) & =\min \left\{\operatorname{ord}_{1 / 5} F(\tau), \operatorname{ord}_{1 / 5} 1 / F(\tau)\right\}=-|2 a-b| / 5,
\end{aligned}
$$

and

$$
\operatorname{ord}_{r} f_{a, b}(\tau) \geq \min \left\{\operatorname{ord}_{r} F(\tau), \operatorname{ord}_{r} 1 / F(\tau)\right\}=0
$$

for $r \in\{0,1 / 2\}$. We now claim that $l(\tau)-1 / l(\tau)$ has a zero at $\infty$. Indeed, we have the $q$-expansion of $l(\tau)$ given by

$$
\begin{equation*}
l(\tau)=1+2 q-4 q^{3}-2 q^{4}+6 q^{5}+8 q^{6}-4 q^{7}+O\left(q^{8}\right) \tag{1}
\end{equation*}
$$

Observe that when $\tau=\infty, q=0$ and $l(\tau)=1$, which proves our claim. Consequently, we see that $\operatorname{ord}_{\infty}(l(\tau)-1 / l(\tau)) \geq 1$. We deduce from Theorem 3.2 that the nonconstant function $(l(\tau)-1 / l(\tau))^{|a+2 b| / 5} f_{a, b}(\tau)$ has a pole of order $d:=(|a+2 b|+|2 a-b|) / 5$ only at $1 / 5$ and holomorphic elsewhere. Thus, by [21, Lem. 2], we obtain that $(l(\tau)-$ $1 / l(\tau))^{|a+2 b| / 5} f_{a, b}(\tau)$ is a polynomial in $l(\tau)-1 / l(\tau)$ of degree $d$. Moreover, this polynomial has rational coefficients since the $q$-expansions of $r(\tau)$ and $l(\tau)$ are rational.

Corollary 3.4. We have the identities

$$
r(\tau)^{5}=l^{-2}\left(\frac{l-1}{l+1}\right), \quad r(2 \tau)^{5}=l\left(\frac{l-1}{l+1}\right)^{2}
$$

where $l:=l(\tau)$. Consequently, under the conditions of Theorem 3.3, we have

$$
r(\tau)^{a} r(2 \tau)^{b}=l^{(b-2 a) / 5}\left(\frac{l-1}{l+1}\right)^{(a+2 b) / 5}
$$

Proof. Using the notations of Theorem 3.3 and following its proof, we know that ( $l-$ $1 / l) f_{5,0}(\tau)$ is a third-degree polynomial in $l-1 / l$. Writing

$$
(l-1 / l) f_{5,0}(\tau)=\sum_{i=0}^{3} a_{i}(l-1 / l)^{i}
$$

for some constants $a_{0}, a_{1}, a_{2}$ and $a_{3}$, and applying the $q$-expansions

$$
r(\tau)^{5}=q-5 q^{2}+15 q^{3}-30 q^{4}+40 q^{5}-26 q^{6}+O\left(q^{7}\right)
$$

and (1), we get $\left(a_{0}, a_{1}, a_{2}, a_{3}\right)=(-4,-4,-2,-1)$ and

$$
f_{5,0}(\tau)=r(\tau)^{5}-\frac{1}{r(\tau)^{5}}=-\frac{\left(1-l+l^{2}+l^{3}\right)\left(-1+l+l^{2}+l^{3}\right)}{l^{2}(-1+l)(1+l)} .
$$

Solving the above equation for $r(\tau)^{5}$ and applying again the $q$-expansions of $r(\tau)^{5}$ and $l(\tau)$ yield the first identity. The identities involving $r(2 \tau)^{5}$ and $r(\tau)^{a} r(2 \tau)^{b}$ now follow from the first identity and the definition of $l(\tau)$.

## 4. Modular equations for $l(\tau)$

We infer from Theorem 3.1 that $l(\tau)$ generates $A_{0}\left(\Gamma_{1}(10)\right)$. The following shows that we can define an affine model for the modular curve $X\left(\Gamma_{1}(10) \cap \Gamma_{0}(10 n)\right)$ over $\mathbb{Q}$ using $l(\tau)$. This affine model gives rise to the modular equation for $l(\tau)$ of suitable level. We omit the proof as it is similar to that of [12, Lem. 3.2].
Lemma 4.1. We have $A_{0}\left(\Gamma_{1}(10) \cap \Gamma_{0}(10 n)\right)_{\mathbb{Q}}=\mathbb{Q}(l(\tau), l(n \tau))$ for all positive integers $n$.
According to Table $1, l(\tau)$ has a simple pole at $1 / 5$ and a simple zero at $3 / 5$. We use this to describe the behavior of $l(\tau)$ at the cusps.
Lemma 4.2. Let $a, c, a^{\prime}, c^{\prime}$ and $n$ be integers with $n$ positive. Then:
(1) The modular function $l(\tau)$ has a pole at $a / c \in \mathbb{Q} \cup\{\infty\}$ if and only if $\operatorname{gcd}(a, c)=$ $1, a \equiv \pm 1(\bmod 5)$ and $c \equiv 5(\bmod 10)$.
(2) The modular function $l(n \tau)$ has a pole at $a^{\prime} / c^{\prime} \in \mathbb{Q} \cup\{\infty\}$ if and only if there exist integers $a$ and $c$ such that $a / c=n a^{\prime} / c^{\prime}, \operatorname{gcd}(a, c)=1, a \equiv \pm 1(\bmod 5)$ and $c \equiv 5(\bmod 10)$.
(3) The modular function $l(\tau)$ has a zero at $a / c \in \mathbb{Q} \cup\{\infty\}$ if and only if $\operatorname{gcd}(a, c)=$ $1, a \equiv \pm 3(\bmod 5)$ and $c \equiv 5(\bmod 10)$.
(4) The modular function $l(n \tau)$ has a zero at $a^{\prime} / c^{\prime} \in \mathbb{Q} \cup\{\infty\}$ if and only if there exist integers $a$ and $c$ such that $a / c=n a^{\prime} / c^{\prime}, \operatorname{gcd}(a, c)=1, a \equiv \pm 3(\bmod 5)$ and $c \equiv 5(\bmod 10)$.
Proof. Note that $l(\tau)$ has a pole (resp., zero) at $a / c \in \mathbb{Q} \cup\{\infty\}$ which is equivalent to $1 / 5$ (resp., 3/5) on $\Gamma_{1}(10)$. By Corollary 2.4(2), $a / c$ is equivalent to $1 / 5$ on $\Gamma_{1}(10)$ if and only if $\left[\begin{array}{c}a \\ c\end{array}\right] \equiv \pm\left[\begin{array}{c}1+5 m \\ 5\end{array}\right](\bmod 10)$ for some integer $m$. Thus, we get $\operatorname{gcd}(a, c)=1, a \equiv \pm 1$ $(\bmod 5)$ and $c \equiv 5(\bmod 10)$, proving $(1)$. On the other hand, $a / c$ is equivalent to $3 / 5$ on $\Gamma_{1}(10)$ if and only if $\left[\begin{array}{c}a \\ c\end{array}\right] \equiv \pm\left[\begin{array}{c}3+5 m \\ 5\end{array}\right](\bmod 10)$ for some integer $m$. This yields $\operatorname{gcd}(a, c)=1, a \equiv \pm 3(\bmod 5)$ and $c \equiv 5(\bmod 10)$, proving (3). Statement (2) (resp. (4)) now follows from (1) (resp. (3)).

To obtain explicitly modular equations for $l(\tau)$ of any level, we present the following result by Ishida and Ishii [11], which gives information on the coefficients of the modular equation between two functions $f_{1}(\tau)$ and $f_{2}(\tau)$ that generate the field $A_{0}\left(\Gamma^{\prime}\right)$ for some congruence subgroup $\Gamma^{\prime}$ of $\mathrm{SL}_{2}(\mathbb{Z})$.
Proposition 4.3 ([3, 11]). Let $\Gamma^{\prime}$ be a congruence subgroup of $S L_{2}(\mathbb{Z})$, and $f_{1}(\tau)$ and $f_{2}(\tau)$ be nonconstant functions such that $A_{0}\left(\Gamma^{\prime}\right)=\mathbb{C}\left(f_{1}(\tau), f_{2}(\tau)\right)$. For $k \in\{1,2\}$, let $d_{k}$ be the total degree of poles of $f_{k}(\tau)$. Let

$$
F(X, Y)=\sum_{\substack{0 \leq i \leq d_{2} \\ 0 \leq j \leq d_{1}}} C_{i, j} X^{i} Y^{j} \in \mathbb{C}[X, Y]
$$

satisfy $F\left(f_{1}(\tau), f_{2}(\tau)\right)=0$. Let $S_{\Gamma^{\prime}}$ be the set of all the inequivalent cusps of $\Gamma^{\prime}$, and for $k \in\{1,2\}$, define

$$
\begin{aligned}
S_{k, 0} & =\left\{r \in S_{\Gamma^{\prime}}: f_{k}(\tau) \text { has a zero at } r\right\}, \\
S_{k, \infty} & =\left\{r \in S_{\Gamma^{\prime}}: f_{k}(\tau) \text { has a pole at } r\right\} .
\end{aligned}
$$

Further let

$$
a=-\sum_{r \in S_{1, \infty} \cap S_{2,0}} \text { ord }_{r} f_{1}(\tau) \quad \text { and } \quad b=\sum_{r \in S_{1,0} \cap S_{2,0}} \text { ord }_{r} f_{1}(\tau)
$$

with the convention that $a=0$ (resp. $b=0$ ) whenever $S_{1, \infty} \cap S_{2,0}$ (resp. $S_{1,0} \cap S_{2,0}$ ) is empty. Then
(1) $C_{d_{2}, a} \neq 0$ and if, in addition, $S_{1, \infty} \subseteq S_{2, \infty} \cup S_{2,0}$, then $C_{d_{2, j}}=0$ for all $j \neq a$;
(2) $C_{0, b} \neq 0$ and if, in addition, $S_{1,0} \subseteq S_{2, \infty} \cup S_{2,0}$, then $C_{0, j}=0$ for all $j \neq b$.

By interchanging the roles of $f_{1}(\tau)$ and $f_{2}(\tau)$, one may obtain properties analogous to (1) - (2).

We apply Lemma 4.2 and Proposition 4.3 to deduce the following result, which asserts that modular equations for $l(\tau)$ of any level always exist, which serve as affine models for $X\left(\Gamma_{1}(10) \cap \Gamma_{0}(10 n)\right)$.
Theorem 4.4. One can explicitly obtain modular equation for $l(\tau)$ of level $n$ for all positive integers $n$.
Proof. The proof is similar to that of [12, Thm. 1.1](1), so we omit the details. We instead note that if $L_{n}(l(\tau), l(n \tau))=0$ is the modular equation for $l(\tau)$ of level $n$ for some polynomial $L_{n}(X, Y) \in \mathbb{C}[X, Y]$, then $L_{n}(X, Y)$ is irreducible as a polynomial of $X$ (resp. $Y$ ) over $\mathbb{C}(Y)$ (resp. $\mathbb{C}(X)$ ), in view of [3, Lem. 3.1].
We now use Theorem 4.4 to derive the modular equations for $l(\tau)$ of levels two and five, and find which coefficients of the modular equations for $l(\tau)$ of odd prime level $p \neq 5$ are nonzero.

Theorem 4.5 (modular equation of level 2). We have

$$
1+l(\tau)-2 l(\tau) l(2 \tau)-l(\tau) l(2 \tau)^{2}+l(\tau)^{2} l(2 \tau)^{2}=0
$$

Proof. In view of Lemmata 2.2 and 4.2, we work on the congruence subgroup $\Gamma_{1}(10) \cap$ $\Gamma_{0}(20)$ and the following cusps: $1 / 5,3 / 5,1 / 10$ and $3 / 10$. Recall that

$$
l(\tau)=\frac{\eta_{10,2}(\tau)^{3} \eta_{10,3}(\tau)^{2}}{\eta_{10,1}(\tau)^{2} \eta_{10,4}(\tau)^{3}}
$$

is a generalized $\eta$-quotient. Using Lemmata 2.3 and 2.9 , we know that $l(\tau)$ has a double pole at $1 / 5$ and a double zero at $3 / 5$. We now compute the order of $l(2 \tau)$ at $3 / 10$ (which is a zero) as follows. Since

$$
l\left(2\left[\begin{array}{cc}
3 & -1 \\
10 & -3
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
6 & -2 \\
10 & -3
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{ll}
3 & -2 \\
5 & -3
\end{array}\right](2 \tau)\right)
$$

by Lemma 2.9, the first term of the $q$-expansion of $l\left(2\left[\begin{array}{cc}3 & -1 \\ 10 & -3\end{array}\right] \tau\right)$ is $\varepsilon q^{\delta}$, where $|\varepsilon|=1$ and

$$
\delta=2 \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{3}{5}\right)+3 P_{2}\left(\frac{6}{5}\right)+2 P_{2}\left(\frac{9}{5}\right)-3 P_{2}\left(\frac{12}{5}\right)\right]=1 .
$$

As the width of the cusp $3 / 10$ is 1 by Lemma 2.3, we see that $\operatorname{ord}_{3 / 10} l(2 \tau)=1 \cdot 1=1$, so $l(2 \tau)$ has a simple zero at $3 / 10$. Similarly, $l(2 \tau)$ has another simple zero at $1 / 5$, and two simple poles at $1 / 10$ and $3 / 5$. We deduce that the total degree of poles of both $l(\tau)$ and $l(2 \tau)$ are 2 , so by Proposition 4.3, there is a polynomial

$$
L_{2}(X, Y)=\sum_{0 \leq i, j \leq 2} C_{i, j} X^{i} Y^{j} \in \mathbb{C}[X, Y]
$$

such that $L_{2}(l(\tau), l(2 \tau))=0$. In addition, we get that $C_{2,2} \neq 0, C_{0,0} \neq 0$ and $C_{2,0}=$ $C_{2,1}=C_{0,1}=C_{0,2}=0$. Using the $q$-expansion (1) of $l(\tau)$, we may take $C_{2,2}=1$. Hence, we arrive at $L_{2}(X, Y)=1+X-2 X Y-X Y^{2}+X^{2} Y^{2}$ and the desired identity follows.
Theorem 4.6 (modular equation of level 5). We have

$$
\left(l(\tau)^{5}-l(5 \tau)\right)\left(l(5 \tau)^{2}-l(5 \tau)-1\right)^{2}=-5 l(\tau) l(5 \tau) P(l(\tau), l(5 \tau)),
$$

where $P(X, Y):=\left(Y^{2}-Y-1\right) Y X^{3}+\left(3 Y^{2}+2 Y-3\right) X^{2}-\left(3 Y^{2}+2 Y-3\right) Y X+Y^{2}-Y-1$.

Proof. Appealing to Lemmata 2.2 and 4.2, we focus on the congruence subgroup $\Gamma_{1}(10) \cap$ $\Gamma_{0}(50)$ and the following cusps:

$$
1 / 5,2 / 5,3 / 5,4 / 5,1 / 15,2 / 15,4 / 15,8 / 15,1 / 25,3 / 25
$$

Applying Lemmata 2.3 and 2.9, we see that $l(\tau)$ has five simple poles at $1 / 5,4 / 5,1 / 15,4 / 15$ and $1 / 25$, and five simple zeros at $2 / 5,3 / 5,2 / 15,8 / 15$ and $3 / 25$. We now compute the order of $l(5 \tau)$ at the cusp $1 / 25$ (which is a pole) as follows. Observe that

$$
l\left(5\left[\begin{array}{cc}
1 & 0 \\
25 & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
5 & 0 \\
25 & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{ll}
1 & 0 \\
5 & 1
\end{array}\right](5 \tau)\right)
$$

so by Lemma 2.9, the $q$-expansion of $l\left(5\left[\begin{array}{ll}1 & 0 \\ 25 & 1\end{array}\right] \tau\right)$ starts with $\varepsilon q^{\delta}$ with $|\varepsilon|=1$ and

$$
\delta=5 \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{1}{5}\right)+3 P_{2}\left(\frac{2}{5}\right)+2 P_{2}\left(\frac{3}{5}\right)-3 P_{2}\left(\frac{4}{5}\right)\right]=-\frac{5}{2} .
$$

Since the width of the cusp $1 / 25$ is 2 by Lemma 2.3, we see that $\operatorname{ord}_{1 / 25} l(5 \tau)=2 \cdot-5 / 2=$ -5 . Similarly, we get that $\operatorname{ord}_{3 / 25} l(5 \tau)=5$, so the total degree of poles of both $l(\tau)$ and $l(5 \tau)$ are 5. Thus, by Proposition 4.3, there is a polynomial

$$
L_{5}(X, Y)=\sum_{0 \leq i, j \leq 5} C_{i, j} X^{i} Y^{j} \in \mathbb{C}[X, Y]
$$

such that $L_{5}(l(\tau), l(5 \tau))=0$. In addition, we get that $C_{5,0} \neq 0$ and $C_{0,1} \neq 0$. Switching the roles of $l(\tau)$ and $l(5 \tau)$ yields $C_{0,5} \neq 0, C_{j, 5}=0$ for $j \in\{1,2,3,4,5\}$ and $C_{k, 0}=0$ for $k \in\{0,1,2,3,4\}$. Using the $q$-expansion (1) of $l(\tau)$ leads us to

$$
L_{5}(X, Y)=\left(X^{5}-Y\right)\left(Y^{2}-Y-1\right)^{2}+5 X Y P(X, Y)
$$

and the desired identity follows.
Theorem 4.7. Let $0=L_{p}(X, Y)=\sum_{0 \leq i, j \leq p+1} C_{i, j} X^{i} Y^{j} \in \mathbb{Q}[X, Y]$ be the modular equation for $l(\tau)$ of odd prime level $p \neq 5$.
(1) If $p \equiv \pm 1(\bmod 10)$, then $C_{p+1,0} \neq 0, C_{0, p+1} \neq 0$, and $C_{i, p+1}=C_{p+1, i}=0$ for $i \in\{1, \ldots, p+1\}$ and $C_{0, j}=C_{j, 0}=0$ for $j \in\{0, \ldots, p\}$.
(2) If $p \equiv \pm 3(\bmod 10)$, then $C_{p+1, p} \neq 0, C_{0,1} \neq 0, C_{1, p+1} \neq 0, C_{p, 0} \neq 0$, and $C_{p+1, i}=$ $C_{i, 0}=0$ for $i \in\{0, \ldots, p-1, p+1\}$ and $C_{0, j}=C_{j, p+1}=0$ for $j \in\{0,2, \ldots, p+1\}$.

Proof. We adapt the notations of Lemma 2.2, and in view of Lemma 4.2, we need to determine the sets $S_{c}$ and $A_{c}$ for $c \in\{5,5 p\}$. We set $I:=\{0,1, \ldots, p-1\}$ and choose a unique integer $k_{0} \in I$ such that $p \mid 1+10 k_{0}$. Then

$$
\Delta=\left\{ \pm(1+10 k) \in(\mathbb{Z} / 10 p \mathbb{Z})^{\times}: k \in I \backslash\left\{k_{0}\right\}\right\}
$$

For each $a \in I \backslash\left\{k_{0}\right\}$, choose $b \in I \backslash\left\{k_{0}\right\}$ such that $p \mid 1+5(a+b)$. Then $\pi_{2 p}(1+10 a)=$ $\pi_{2 p}(-1-10 b)$, so $\pi_{2 p}(\Delta)$ has exactly $p-1$ distinct elements modulo $2 p$. We see that $\pi_{2 p}(\Delta)=(\mathbb{Z} / 2 p \mathbb{Z})^{\times}$and thus, $S_{5}=\{1\}$. On the other hand, we choose $d \in I \backslash\left\{k_{0}\right\}$ such that $p \mid 1+5 d$. Then $\pi_{2 p}(-1-10 d)=1$, so $\Delta \cap \operatorname{ker} \pi_{2 p}=\{1,-1-10 d\}$ and $\pi_{5}\left(\Delta \cap \operatorname{ker} \pi_{2 p}\right)=\{ \pm 1\}$. Thus, we take $A_{5}=\{1,2\}$. We next observe that $\pi_{2}(\Delta)=$ $\{1\}=(\mathbb{Z} / 2 \mathbb{Z})^{\times}$, so we have $S_{5 p}=\{1\}$ and $\pi_{5 p}\left(\Delta \cap \operatorname{ker} \pi_{2}\right)=\pi_{5 p}(\Delta) \subset(\mathbb{Z} / 5 p \mathbb{Z})^{\times}$. We claim that $\pi_{5 p}(\Delta)$ has $2(p-1)$ distinct elements modulo $5 p$; otherwise, we would have $1+10 r \equiv \pm(1+10 s)(\bmod 5 p)$ for some distinct $r, s \in I \backslash\left\{k_{0}\right\}$, and all cases lead to a contradiction. As $(\mathbb{Z} / 5 p \mathbb{Z})^{\times}$has $4(p-1)$ elements, we take $A_{5 p}=\{1,2\}$.

We see that $l(\tau)$ and $l(p \tau)$ has poles and zeros at the following cusps of $\Gamma_{1}(10) \cap \Gamma_{0}(10 p)$ : $1 / 5,2 / 5,1 / 5 p$ and 2/5p. Applying Lemma 2.9, we get $\operatorname{ord}_{1 / 5} l(\tau)=-p=-\operatorname{ord}_{2 / 5} l(\tau)$ and
$\operatorname{ord}_{1 / 5 p} l(\tau)=-1=-\operatorname{ord}_{2 / 5 p} l(\tau)$. We next compute $\operatorname{ord}_{1 / 5 p} l(p \tau)$ and $\operatorname{ord}_{2 / 5 p} l(p \tau)$. We note that

$$
l\left(p\left[\begin{array}{cc}
1 & 0 \\
5 p & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
p & 0 \\
5 p & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{ll}
1 & 0 \\
5 & 1
\end{array}\right](p \tau)\right)
$$

so by Lemma 2.9, the first term of the $q$-expansion of $l\left(p\left[\begin{array}{ll}1 & 0 \\ 5 p & 1\end{array}\right] \tau\right)$ is $\varepsilon q^{\delta}$ with $|\varepsilon|=1$ and

$$
\delta=p \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{1}{5}\right)+3 P_{2}\left(\frac{2}{5}\right)+2 P_{2}\left(\frac{3}{5}\right)-3 P_{2}\left(\frac{4}{5}\right)\right]=-\frac{p}{2} .
$$

Since the width of the cusp $1 / 5 p$ is 2 by Lemma 2.3, we get $\operatorname{ord}_{1 / 5 p} l(p \tau)=2 \cdot-p / 2=-p$. On the other hand, we choose integers $u$ and $v$ such that $2 v-5 p u=1$. We have

$$
l\left(p\left[\begin{array}{cc}
2 & u \\
5 p & v
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
2 p & u p \\
5 p & v
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
2 & u p \\
5 & v
\end{array}\right](p \tau)\right)
$$

so Lemma 2.9 shows that the $q$-expansion of $l\left(p\left[\begin{array}{cc}2 & { }_{5 p}^{u} \\ v\end{array}\right] \tau\right)$ starts with $\varepsilon q^{\delta}$ with $|\varepsilon|=1$ and

$$
\delta=p \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{2}{5}\right)+3 P_{2}\left(\frac{4}{5}\right)+2 P_{2}\left(\frac{6}{5}\right)-3 P_{2}\left(\frac{8}{5}\right)\right]=\frac{p}{2} .
$$

As the cusp 2/5p has width 2 by Lemma 2.3, we obtain $\operatorname{ord}_{2 / 5 p} l(p \tau)=2 \cdot p / 2=p$.
We now compute $\operatorname{ord}_{1 / 5} l(p \tau)$ and $\operatorname{ord}_{2 / 5} l(p \tau)$. We choose an integer $g$ with $p g \equiv 1$ $(\bmod 5)$, so that

$$
l\left(p\left[\begin{array}{ll}
1 & 0 \\
5 & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{ll}
p & 0 \\
5 & 1
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
p & (p g-1) / 5 \\
5 & g
\end{array}\right] \frac{\tau+(1-p g) / 5}{p}\right)
$$

By Lemma 2.9, we deduce that the $q$-expansion of $l\left(p\left[\begin{array}{ll}1 & 0 \\ 5 & 1\end{array}\right] \tau\right)$ starts with $\varepsilon q^{\delta_{p}}$ with $|\varepsilon|=1$ and

$$
\delta_{p}:=\frac{1}{p} \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{p}{5}\right)+3 P_{2}\left(\frac{2 p}{5}\right)+2 P_{2}\left(\frac{3 p}{5}\right)-3 P_{2}\left(\frac{4 p}{5}\right)\right] .
$$

Since the width of $1 / 5$ is $2 p$ by Lemma 2.3, we see that

$$
\operatorname{ord}_{1 / 5} l(p \tau)=2 p \cdot \delta_{p}=\left\{\begin{array}{lll}
-1 & \text { if } p \equiv \pm 1 & (\bmod 10) \\
1 & \text { if } p \equiv \pm 3 & (\bmod 10)
\end{array}\right.
$$

We next take an integer $h$ with $2 p h \equiv 1(\bmod 5)$, so that

$$
l\left(p\left[\begin{array}{ll}
2 & 1 \\
5 & 3
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
2 p & p \\
5 & 3
\end{array}\right] \tau\right)=l\left(\left[\begin{array}{cc}
2 p & (2 p h-1) / 5 \\
5 & h
\end{array}\right] \frac{\tau+(3-p h) / 5}{p}\right) .
$$

Using Lemma 2.9, the first term of the $q$-expansion of $\left.l\left(\begin{array}{ccc}2 & 3 \\ 5 & 1\end{array}\right] \tau\right)$ is $\varepsilon q^{\delta_{p}}$ with $|\varepsilon|=1$ and

$$
\delta_{p}:=\frac{1}{p} \cdot \frac{25}{20}\left[-2 P_{2}\left(\frac{2 p}{5}\right)+3 P_{2}\left(\frac{4 p}{5}\right)+2 P_{2}\left(\frac{6 p}{5}\right)-3 P_{2}\left(\frac{8 p}{5}\right)\right] .
$$

Since the width of $2 / 5$ is $2 p$ by Lemma 2.3 , we arrive at

$$
\operatorname{ord}_{2 / 5} l(p \tau)=2 p \cdot \delta_{p}= \begin{cases}1 & \text { if } p \equiv \pm 1 \quad(\bmod 10) \\ -1 & \text { if } p \equiv \pm 3 \quad(\bmod 10)\end{cases}
$$

Using the notations of Proposition 4.3 with $f_{1}(\tau)=l(\tau)$ and $f_{2}(\tau)=l(p \tau)$, we obtain $S_{1, \infty}=\{1 / 5,1 / 5 p\}, S_{1,0}=\{2 / 5,2 / 5 p\}$ and

$$
\begin{aligned}
S_{2, \infty} & =\left\{\begin{array}{lll}
\{1 / 5,1 / 5 p\} & \text { if } p \equiv \pm 1 & (\bmod 10), \\
\{2 / 5,1 / 5 p\} & \text { if } p \equiv \pm 3 & (\bmod 10),
\end{array}\right. \\
S_{2,0} & =\left\{\begin{array}{lll}
\{2 / 5,2 / 5 p\} & \text { if } p \equiv \pm 1 & (\bmod 10), \\
\{1 / 5,2 / 5 p\} & \text { if } p \equiv \pm 3 & (\bmod 10),
\end{array}\right.
\end{aligned}
$$

so that $S_{1, \infty} \cup S_{1,0}=S_{2, \infty} \cup S_{2,0}$. In addition, we deduce that the total number of poles of both $l(\tau)$ and $l(p \tau)$ is $p+1$, so there is a polynomial

$$
L_{p}(X, Y)=\sum_{0 \leq i, j \leq p+1} C_{i, j} X^{i} Y^{j} \in \mathbb{Q}[X, Y]
$$

with $L_{p}(l(\tau), l(p \tau))=0$. We find that if $p \equiv \pm 1(\bmod 10)$, then $C_{p+1,0} \neq 0$ and $C_{0, p+1} \neq$ 0 , so that $C_{p+1, i}=0$ for $i \in\{1, \ldots, p+1\}$ and $C_{0, j}=0$ for $j \in\{0, \ldots, p\}$. Switching the roles of $l(\tau)$ and $l(p \tau)$ yields $C_{i, p+1}=0$ for $i \in\{1, \ldots, p+1\}$ and $C_{j, 0}=0$ for $j \in\{0, \ldots, p\}$. On the other hand, if $p \equiv \pm 3(\bmod 10)$, then $C_{p+1, p} \neq 0$ and $C_{0,1} \neq 0$, implying that $C_{p+1, i}=0$ for $i \in\{0, \ldots, p-1, p+1\}$ and $C_{0, j}=0$ for $j \in\{0,2, \ldots, p+1\}$. Swapping the roles of $l(\tau)$ and $l(p \tau)$ gives $C_{1, p+1} \neq 0, C_{p, 0} \neq 0, C_{i, 0}=0$ for $i \in\{0, \ldots, p-1, p+1\}$ and $C_{j, p+1}=0$ for $j \in\{0,2, \ldots, p+1\}$.

We give the modular equations $L_{n}(X, Y)$ for $l(\tau)$ of level $n$ with $n \in\{2,4,5,6,13\}$ as shown in Table 2. On the other hand, we verify via Mathematica that the modular equations for $l(\tau)$ of prime levels $p \in\{3,7,11,19\}$ are the same as those for $k(\tau)$, which appeared as a supplementary material (Appendix A) to [12], so we will not present them here and instead remark that they satisfy the Kronecker congruence depending on the values of $p$ modulo 10 .
We now consider modular equations for $l(\tau)$ of levels $n$ coprime to 10 . For any integer $a$ coprime to 10 , we choose a matrix $\sigma_{a} \in \mathrm{SL}_{2}(\mathbb{Z})$ such that $\sigma_{a} \equiv\left[\begin{array}{cc}a_{0}^{-1} & 0 \\ 0 & a\end{array}\right](\bmod 10)$. We take

$$
\sigma_{ \pm 1}= \pm\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right] \quad \text { and } \quad \sigma_{ \pm 3}= \pm\left[\begin{array}{cc}
-3 & -10 \\
10 & 33
\end{array}\right] .
$$

We know that $l\left(\sigma_{ \pm 1} \tau\right)=l(\tau)$ and $l\left(\sigma_{ \pm 3} \tau\right)=-1 / l(\tau)$ by Lemma 2.7. Moreover, by [17, Prop. 3.36], we have the disjoint union

$$
\Gamma_{1}(10)\left[\begin{array}{ll}
1 & 0 \\
0 & n
\end{array}\right] \Gamma_{1}(10)=\bigsqcup_{0<a \mid n} \bigsqcup_{\substack{0 \leq b<n / a \\
\operatorname{gcd}(a, b, n / a)=1}} \Gamma_{1}(10) \sigma_{a}\left[\begin{array}{ll}
a & b \\
0 & \frac{n}{a}
\end{array}\right]
$$

and $\Gamma_{1}(10) \backslash \Gamma_{1}(10)\left[\begin{array}{ll}1 & 0 \\ 0 & n\end{array}\right] \Gamma_{1}(10)$ has $\psi(n):=n \prod_{p \mid n}(1+1 / p)$ elements. We now define the polynomial

$$
\Phi_{n}(X, \tau):=\prod_{0<a \mid n} \prod_{\substack{0 \leq b<n / a \\ \operatorname{gcd}(a, b, n / a)=1}}\left(X-\left(l \circ \alpha_{a, b}\right)(\tau)\right)
$$

where $\alpha_{a, b}:=\sigma_{a}\left[\begin{array}{cc}a & b \\ 0 & n / a\end{array}\right]$. Then the coefficients of $\Phi_{n}(X, \tau)$ are elementary symmetric functions of $l \circ \alpha_{a, b}$, so these are invariant under the action of $\Gamma_{1}(10)$ and thus are in $A_{0}\left(\Gamma_{1}(10)\right)=\mathbb{C}(l(\tau))$. Thus, we may write $\Phi_{n}(X, \tau)$ as $\Phi_{n}(X, l(\tau)) \in \mathbb{C}(l(\tau))[X]$.

TABLE 2. Modular equations $L_{n}(X, Y)=0$ for $l(\tau)$ of level $n \in\{2,4,5,6,13\}$

Let $S_{n, \infty}$ (resp. $S_{n, 0}$ ) be the set of inequivalent cusps of $\Gamma_{1}(10) \cap \Gamma_{0}(10 n)$ for which $l(n \tau)$ has a pole (resp. a zero). We define

$$
r_{n}:=-\sum_{r \in S_{1, \infty} \cap S_{n, 0}} \operatorname{ord}_{r} l(\tau),
$$

with the convention that $r_{n}=0$ if $S_{1, \infty} \cap S_{n, 0}$ is empty, and set

$$
L_{n}(X, l(\tau))=l(\tau)^{r_{n}} \Phi_{n}(X, l(\tau))
$$

The following result gives the properties of the polynomial $L_{n}(X, l(\tau))$ when $\operatorname{gcd}(n, 10)=$ 1. We omit the proof as it is similar to that of [12, Thm. 1.1]. We note that $L_{n}\left(l\left(\frac{\tau}{n}\right), l(\tau)\right)=$ 0 , which can be seen as the modular equation for $l(\tau)$ of level $n$.

Theorem 4.8. Let $n$ be a positive integer coprime to 10 and let $L_{n}(X, Y)$ be the polynomial as above. Then
(1) $L_{n}(X, Y) \in \mathbb{Z}[X, Y]$ and $\operatorname{deg}_{X} L_{n}(X, Y)=\psi(n)$.
(2) $L_{n}(X, Y)$ is irreducible both as a polynomial in $X$ over $\mathbb{C}(Y)$ and as a polynomial in $Y$ over $\mathbb{C}(X)$.
(3) We have

$$
L_{n}(X, Y)= \begin{cases}L_{n}(Y, X) & \text { if } n \equiv \pm 1 \quad(\bmod 10) \\ Y^{\psi(n)} L_{n}\left(-Y^{-1}, X\right) & \text { if } n \equiv \pm 3 \quad(\bmod 10)\end{cases}
$$

(4) (Kronecker congruence) If $p \neq 5$ is an odd prime, then

$$
L_{p}(X, Y) \equiv\left\{\begin{array}{lll}
\left(X^{p}-Y\right)\left(X-Y^{p}\right) & (\bmod p \mathbb{Z}[X, Y]) & \text { if } p \equiv \pm 1 \\
\left(X^{p}-Y\right)\left(X Y^{p}+1\right) & (\bmod p \mathbb{Z}[X, Y]) & \text { if } p \equiv \pm 3 \\
(\bmod 10)
\end{array}\right.
$$

## 5. Arithmetic of $l(\tau)$ and evaluation of $r(\tau)^{a} r(2 \tau)^{b}$

We study in this section some arithmetic properties of $l(\tau)$ at imaginary quadratic points $\tau \in \mathbb{H}$, which will be useful in evaluating the functions of the form $r(\tau)^{a} r(2 \tau)^{b}$ satisfying the conditions of Theorem 3.1. We first state the following result of Cho and Koo [4] about generating ray class fields by a singular value of a modular function on some congruence subgroup between $\Gamma(N)$ and $\Gamma_{1}(N)$.

Lemma 5.1 ([4]). Let $K$ be an imaginary quadratic field with discriminant $d_{K}$ and $\tau \in K \cap \mathbb{H}$ be a root of a primitive equation $a X^{2}+b X+c=0$ such that $b^{2}-4 a c=d_{K}$ and $a, b, c \in \mathbb{Z}$. Let $\Gamma^{\prime}$ be a congruence subgroup such that $\Gamma(N) \subset \Gamma^{\prime} \subset \Gamma_{1}(N)$. Suppose that $\operatorname{gcd}(a, N)=1$. Then the field generated over $K$ by all values of $h(\tau)$, where $h \in A_{0}\left(\Gamma^{\prime}\right)_{\mathbb{Q}}$ is defined and finite at $\tau$, is the ray class field $K_{(N)}$ modulo $N$ over $K$.

We now apply Lemma 5.1 to prove the following.
Theorem 5.2. Let $K$ be an imaginary quadratic field with discriminant $d_{K}$ and $\tau \in K \cap \mathbb{H}$ be a root of the primitive polynomial $a X^{2}+b X+c \in \mathbb{Z}[X]$ such that $b^{2}-4 a c=d_{K}$ and $\operatorname{gcd}(a, 10)=1$. Then $K(l(\tau))$ is the ray class field modulo 10 over $K$.

Proof. In view of Theorem 3.1, we have that $A_{0}\left(\Gamma_{1}(10)\right)_{\mathbb{Q}}=\mathbb{Q}(l(\tau))$ since $l(\tau)$ has a rational $q$-expansion. Suppose $\tau \in K \cap \mathbb{H}$ is a root of the primitive polynomial $a X^{2}+$ $b X+c \in \mathbb{Z}[X]$ such that $b^{2}-4 a c=d_{K}$ and $\operatorname{gcd}(a, 10)=1$. Then $l(\tau)$ is well-defined and finite, so the desired conclusion follows from Lemma 5.1.

The following result shows that the modular $j$-invariant defined by

$$
j(\tau)=\eta^{-24}(\tau)\left(1+240 \sum_{n=1}^{\infty} \frac{n^{3} q^{n}}{1-q^{n}}\right)^{3}
$$

can be written as a rational function of $l(\tau)$, which implies that $l(\tau)$ is an algebraic unit for imaginary quadratic points $\tau \in \mathbb{H}$. In general, we infer from [10, Prop. 3] that the functions $r(\tau)^{a} r(2 \tau)^{b}$ are algebraic units for all integers $a$ and $b$ and for such points $\tau \in \mathbb{H}$.
Theorem 5.3. Let $K$ be an imaginary quadratic field and $\tau \in K \cap \mathbb{H}$. Then

$$
j(\tau)=\frac{P(l)^{3}}{l^{2}\left(l^{2}-1\right)\left(l^{2}+4 l-1\right)^{5}\left(l^{2}-l-1\right)^{10}},
$$

where $l:=l(\tau)$ and

$$
\begin{aligned}
P(X):=1 & -4 X+234 X^{2}-460 X^{3}+495 X^{4}+456 X^{5}-1444 X^{6} \\
& -456 X^{7}+495 X^{8}+460 X^{9}+234 X^{10}+4 X^{11}+X^{12}
\end{aligned}
$$

Proof. We first remark that the function $f(\tau):=\eta^{6}(\tau) \eta^{-6}(5 \tau)$ generates the field of all modular functions on $\Gamma_{0}(5)$ by Lemmata 2.5 and 2.6, and satisfies the identity [7, Thm. 5.26]

$$
\begin{equation*}
j(\tau)=\frac{\left(f^{2}(\tau)+250 f(\tau)+3125\right)^{3}}{f^{5}(\tau)} \tag{2}
\end{equation*}
$$

As a modular function on $\Gamma_{0}(10)$, we deduce from Lemma 2.6 that $f(\tau)$ has a double pole at $1 / 5$ and a simple pole at $\infty$. Since $A_{0}\left(\Gamma_{0}(10)\right)=\mathbb{C}(f(\tau), l(\tau)-1 / l(\tau))$ by Theorem 3.2, we infer from Proposition 4.3 that there is a polynomial

$$
F(X, Y)=\sum_{\substack{0 \leq i \leq 1 \\ 0 \leq j \leq 3}} C_{i, j} X^{i} Y^{j} \in \mathbb{C}[X, Y]
$$

such that $F(f(\tau), l(\tau)-1 / l(\tau))=0$. Using (1) and the $q$-expansion of $f(\tau)$ leads to $F(X, Y)=4-7 Y-X Y+2 Y^{2}+Y^{3}$ and

$$
\begin{equation*}
f(\tau)=\frac{\left(l^{2}-l-1\right)^{2}\left(l^{2}+4 l-1\right)}{l^{2}\left(l^{2}-1\right)} \tag{3}
\end{equation*}
$$

where $l:=l(\tau)$. Combining (2) and (3) gives the desired identity.
The next result concerns about the singular values of $l(r \tau)$ for positive rational numbers $r$, which can be written as radicals using the values of $l(\tau)$. We omit the proof as it is analogous to that of [12, Thm. 1.4].
Theorem 5.4. For any positive $r \in \mathbb{Q}$, if $l(\tau)$ can be expressed in terms of radicals, then $l(r \tau)$ can also be expressed in terms of radicals.

We now discuss a method of evaluating singular values of $l(\theta)$, where $\theta \in K \cap \mathbb{H}$ is a generator for the ring of integers $\mathcal{O}_{K}$ of an imaginary quadratic field $K$ with discriminant $d_{K} \equiv 0(\bmod 4)$, by finding its minimal polynomial over $K$, which is the class polynomial of the ray class field $K_{(10)}$ modulo 10 over $K$, using Shimura reciprocity law. For more details, we refer the reader to $[4,9]$.

We denote by $\mathcal{F}_{N}$ the field modular functions of level $N$ whose coefficients in their $q$ expansions lie in the cyclotomic field $\mathbb{Q}\left(\zeta_{N}\right)$. Then $\mathcal{F}_{N}$ is a Galois extension of $\mathcal{F}_{1}=\mathbb{Q}(j)$ with Galois group $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm 1\}$. We recall the action of this Galois group on $\mathcal{F}_{N}$ as follows. Given $h \in \mathcal{F}_{N}$ and $A_{N} \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we take a lift $A \in \mathrm{SL}_{2}(\mathbb{Z})$ of $A_{N}$ and define the action $h^{A_{N}}=h \circ A$, which induces the isomorphism $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm 1\} \simeq$
$\operatorname{Gal}\left(\mathcal{F}_{N} / \mathbb{Q}\left(\zeta_{N}\right)(j)\right)$. We next define the action of an element $d \in(\mathbb{Z} / N \mathbb{Z})^{\times}$on $h$ by applying the $\mathbb{Q}\left(\zeta_{N}\right)$-automorphism $\zeta_{N} \mapsto \zeta_{N}^{d}$ on the $q$-expansion of $h$, which yields the isomorphism $(\mathbb{Z} / N \mathbb{Z})^{\times} \simeq \operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{N}\right)(j) / \mathbb{Q}(j)\right)$. Combining these isomorphisms induces the exact sequence

$$
\begin{equation*}
1 \longrightarrow\{ \pm 1\} \longrightarrow \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z}) \longrightarrow \operatorname{Gal}\left(\mathcal{F}_{N} / \mathcal{F}_{1}\right) \longrightarrow 1 \tag{4}
\end{equation*}
$$

We know from the main theorem of complex multiplication that if $h \in \mathcal{F}_{N}$ is a modular function with $h(\theta)$ finite, then $h(\theta)$ generates the ray class field $K_{(N)}$ over $K$. Consequently, class field theory gives the exact sequence

$$
\begin{equation*}
1 \longrightarrow \mathcal{O}_{K}^{\times} \longrightarrow\left(\mathcal{O}_{K} / N \mathcal{O}_{K}\right)^{\times} \xrightarrow{\bar{\Theta}} \operatorname{Gal}\left(K_{(N)} / K(j(\theta))\right) \longrightarrow 1, \tag{5}
\end{equation*}
$$

where $K(j(\theta))$ is the Hilbert class field of $K$, and $\bar{\Theta}$ is the reduction modulo $N$ of the restriction of the Artin map to the profinite completion of $\mathcal{O}_{K}$. The Shimura reciprocity law relates (4) with (5) via the map $g_{\theta}:\left(\mathcal{O}_{K} / N \mathcal{O}_{K}\right)^{\times} \rightarrow \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ defined by

$$
g_{\theta}(s \theta+t)=\left[\begin{array}{cc}
t-B s & -C s \\
s & t
\end{array}\right] \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})
$$

where $s \theta+t \in\left(\mathcal{O}_{K} / N \mathcal{O}_{K}\right)^{\times}$and $X^{2}+B X+C \in \mathbb{Z}[X]$ is the minimal polynomial of $\theta$. We denote by $W_{N, \theta}$ the image of $\left(\mathcal{O}_{K} / N \mathcal{O}_{K}\right)^{\times}$under $g_{\theta}$. We see that there is a surjective homomorphism from $W_{N, \theta}$ to $\operatorname{Gal}\left(K_{(N)} / K(j(\theta))\right)$ that sends $\alpha$ to the map $h(\theta) \mapsto h^{\alpha^{-1}}(\theta)$, whose kernel $T$ is the image $g_{\theta}\left(\mathcal{O}_{K}^{\times}\right)$given by

$$
T= \begin{cases}\left\{ \pm\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right], \pm\left[\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right]\right\} & \text { if } K=\mathbb{Q}(\sqrt{-1}) \\
\left. \pm\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right], \pm\left[\begin{array}{cc}
-1 & -1 \\
1 & 0
\end{array}\right], \pm\left[\begin{array}{cc}
0 & -1 \\
1 & 1
\end{array}\right]\right\} & \text { if } K=\mathbb{Q}(\sqrt{-3}) \\
\left. \pm \pm\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right]\right\} & \text { otherwise }\end{cases}
$$

To get the conjugates of $h(\theta) \in K_{(N)}$ over $K$, we now exploit the action of the form class group $C\left(d_{K}\right)$ on $h(\theta)$ as follows. Suppose $x:=[a, b, c] \in C\left(d_{K}\right)$ is a reduced primitive binary quadratic form and $\tau_{x}:=\left(-b+\sqrt{d_{K}}\right) /(2 a) \in \mathbb{H}$. We choose a matrix $u_{x} \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ such that
for each prime power $p^{r_{p}}$ dividing $N$. We have the action $h(\theta)^{x^{-1}}=h^{u_{x}}\left(\tau_{x}\right)$, and note that if $f$ is a modular function such that $f(\theta) \in K(j(\theta))$, then there is an isomorphism from $C\left(d_{K}\right)$ to $\operatorname{Gal}(K(j(\theta)) / K)$ that sends the class $x^{-1}$ to the map $f(\theta) \mapsto f^{u_{x}}\left(\tau_{x}\right)$. In view of the isomorphism

$$
\operatorname{Gal}\left(K_{(N)} / K\right) / \operatorname{Gal}\left(K_{(N)} / K(j(\theta))\right) \simeq \operatorname{Gal}(K(j(\theta)) / K)
$$

we obtain the following.

Proposition 5.5 ([4]). Using the above notations, the set of all conjugates of $h(\theta) \in K_{(N)}$ over $K$ is given by

$$
\left\{h^{\alpha \cdot u_{x}}\left(\tau_{x}\right): \alpha \in W_{N, \theta} / T, x \in C\left(d_{K}\right)\right\} .
$$

After obtaining all conjugates of $h(\theta)$, we can now define the class polynomial of $K_{(N)}$ given by

$$
\begin{equation*}
F_{N}(X):=\prod_{\substack{\alpha \in W_{N, \theta} / T \\ x \in C\left(d_{K}\right)}}\left(X-h^{\alpha \cdot u_{x}}\left(\tau_{x}\right)\right) \in K[X] . \tag{6}
\end{equation*}
$$

We now let $\theta:=\frac{\sqrt{d_{K}}}{2}$; then $l(\theta)$ is a real number since $e^{2 \pi i \sqrt{d_{K}} / 2} \in \mathbb{R}$. Thus,

$$
0=F_{10}(l(\theta))=\overline{F_{10}(l(\theta))}=\overline{F_{10}}(\overline{l(\theta)})=\overline{F_{10}}(l(\theta)),
$$

so that $F_{10}(X) \in(K \cap \mathbb{R})[X]=\mathbb{Q}[X]$. We see from Theorem 5.3 that $l(\theta)$ is an algebraic integer, which shows that $F_{10}(X) \in \mathbb{Z}[X]$. In this case, we can numerically obtain $F_{10}(X)$ using an accurate approximation of $l(\theta)$ via (1). We illustrate an example of finding $F_{10}(X)$, which can be used to evaluate $l(\theta)$ and the functions $r(\theta)^{a} r(2 \theta)^{b}$ using Corollary 3.4.

Example 5.6. Consider the field $K=\mathbb{Q}(i)$ with $d_{K}=-4$ and $\mathcal{O}_{K}=\mathbb{Z}[i]$, where $i=\sqrt{-1}$. We wish to find the class polynomial $F_{10}(X)$ with $F_{10}(l(i))=0$. We choose $(B, C)=(0,1)$ since $X^{2}+1$ is the minimal polynomial of $i$. Since $x:=[1,0,1]$ is the only reduced primitive binary quadratic form of discriminant -4 , we have $\tau_{x}=i$ and $u_{x}=\left[\begin{array}{cc}1 & 0 \\ 0 & 1\end{array}\right] \in \mathrm{GL}_{2}(\mathbb{Z} / 10 \mathbb{Z})$. We compute

$$
\begin{aligned}
W_{10, \theta} / T= & \left\{\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right],\left[\begin{array}{ll}
3 & 0 \\
0 & 3
\end{array}\right],\left[\begin{array}{cc}
-1 & -4 \\
4 & -1
\end{array}\right],\left[\begin{array}{cc}
2 & -3 \\
3 & 2
\end{array}\right],\right. \\
& {\left.\left[\begin{array}{cc}
5 & 2 \\
-2 & 5
\end{array}\right],\left[\begin{array}{cc}
-4 & -5 \\
5 & -4
\end{array}\right],\left[\begin{array}{cc}
-3 & 2 \\
-2 & -3
\end{array}\right],\left[\begin{array}{cc}
4 & 1 \\
-1 & 4
\end{array}\right]\right\} . }
\end{aligned}
$$

Using the $q$-expansion (1) of $l(\tau)$, we get

$$
\begin{aligned}
& \left.\left.F_{10}(X)=(X-l(i))\left(X-l^{\left[\begin{array}{ll}
3 & -10 \\
-33
\end{array}\right]}(i)\right)\left(X-l^{[-1} 2_{7}^{-4}\right](i)\right)\left(X-l^{\left[\begin{array}{l}
2 \\
1
\end{array}\right]}{ }^{7}\right](i)\right) \\
& \left.\times\left(X-l^{[5}{ }_{2}^{5}{ }_{5}^{12}\right](i)\left(X-l^{\left[\begin{array}{l}
5 \\
5
\end{array}-4\right]}(i)\right)\left(X-l^{\left[\begin{array}{l}
7 \\
-4 \\
-2
\end{array}{ }_{-1}\right]}(i)\right)\left(X-l^{\left[\frac{4}{7}\right.} \frac{1}{2}\right](i)\right) \\
& \approx X^{8}+26 X^{7}+62 X^{6}+458 X^{5}-130 X^{4}-458 X^{3}+62 X^{2}-26 X+1 .
\end{aligned}
$$

As $l(i) \approx 1.00373486$, we deduce that

$$
l(i)=\frac{1}{4}(-13-5 \sqrt{5}+(15-\sqrt{5}) \alpha+2 \sqrt{5} \sqrt{25+13 \sqrt{5}-(15+5 \sqrt{5}) \alpha})
$$

where $\alpha:=\sqrt{2+\sqrt{5}}$. In view of Corollary 3.4 and the approximations $r(2 i)^{3} / r(i) \approx$ 0.00187091 and $r(2 i) / r(i)^{7} \approx 542.52907744$, we arrive at the exact values of $r(2 i)^{3} / r(i)$ and $r(2 i) / r(i)^{7}$ respectfully given by

$$
\begin{aligned}
& \frac{1}{4}(251+115 \sqrt{5}-(115+59 \sqrt{5}) \alpha+2 \sqrt{5} \sqrt{15725+7033 \sqrt{5}-(7645+3415 \sqrt{5}) \alpha}) \\
& \frac{1}{4}(-6259-2815 \sqrt{5}+(3145+1557 \sqrt{5}) \alpha+26 \sqrt{5} \sqrt{50825+22733 \sqrt{5}-(24615+11005 \sqrt{5}) \alpha}) .
\end{aligned}
$$

On the other hand, using the modular equation for $l(\tau)$ of level two from Theorem 4.5 and $l(i / 2) \approx 1.08609902$, we obtain the exact value of $l(i / 2)$ :

$$
\frac{1}{2}(-134-60 \sqrt{5}-(65+29 \sqrt{5}) \alpha+\sqrt{10} \sqrt{7225+3231 \sqrt{5}+(3510+1570 \sqrt{5}) \alpha}) .
$$

We can then obtain the exact values of $r(i)^{3} / r(i / 2)$ and $r(i) / r(i / 2)^{7}$ using Corollary 3.4 and the value of $l(i / 2)$.
