# SUMS OF HURWITZ CLASS NUMBERS, CM MODULAR FORMS, AND PRIMES OF THE FORM $x^{2}+n y^{2}$

#### Abstract

We consider sums of Hurwitz class numbers of the type $\sum_{t \equiv m(\bmod M)} H\left(4 p-t^{2}\right)$, where $M$ is composite. For $M=6$ and 8 , we show that these sums can be expressed in terms of coefficients of CM cusp forms. This leads to explicit formulas which depend on the expression of $p$ in the form $x^{2}+n y^{2}$.


## 1. Introduction

Modular forms found many applications in and outside of number theory. Given an arithmetic function $a(n)$ for $n \in \mathbb{Z}_{\geq 0}$, let $f(\tau):=\sum_{n=0}^{\infty} a(n) q^{n}$ be its generating function, where $q=e^{2 \pi i \tau}$. Provided that the series converges for $\tau$ in the upper half-plane $\mathbb{H}$, we may hope that $f$ is a modular form, or that it at least satisfies a weight $\kappa$ modularity for some $\kappa \in \frac{1}{2} \mathbb{Z}$.

The example relevant for this paper is the generating function

$$
\mathcal{H}(\tau):=\sum_{n=0}^{\infty} H(n) q^{n}
$$

where $H(n)$ is the $n$th Hurwitz class number (defined in Section (2). It turns out that $\mathcal{H}$ is not a modular form but a weight $\frac{3}{2}$ mock modular form. Mock modular forms have been the subject of an ongoing research interest, see for example [5, 6, 7, 21.

One motivation for studying Hurwitz class numbers comes from their connection to elliptic curves. If $p$ is a prime, $r \in \mathbb{Z}_{\geq 1}$, and $E$ is an elliptic curve over the finite field $\mathbb{F}_{p^{r}}$, then its trace of Frobenius is defined by

$$
\operatorname{tr}(E):=p^{r}+1-\# E\left(\mathbb{F}_{p^{r}}\right)
$$

By the Hasse bound, $|\operatorname{tr}(E)| \leq 2 \sqrt{p^{r}}$. When counting elliptic curves, it is quite natural to weight $E$ by 1 over the size of its automorphism group. Thus, for $t \in \mathbb{Z}$ we let

$$
N_{A}\left(p^{r} ; t\right):=\sum_{\substack{E / \mathbb{F}_{p^{r}} \\ \operatorname{tr}(E)=t}} \frac{1}{\# \operatorname{Aut}_{\mathbb{F}_{p^{r}}}(E)},
$$

where the sum is taken over all elliptic curves over $\mathbb{F}_{p^{r}}$ with trace of Frobenius equal to $t$. If $p \geq 3,|t| \leq 2 \sqrt{p^{r}}$ and $p \nmid t$, then by [12, Theorem 3],

$$
2 N_{A}\left(p^{r} ; t\right)=H\left(4 p^{r}-t^{2}\right)
$$

The last equality can be used to show the identity

$$
\sum_{t \in \mathbb{Z}} H\left(4 p-t^{2}\right)=2 p
$$

for a prime $p$ [9, p. 154].
More generally, one can consider the sums

$$
H_{m, M}(n):=\sum_{\substack{t \in \mathbb{Z} \\ t \equiv m \\(\bmod M)}} H\left(4 n-t^{2}\right),
$$

where $m \in \mathbb{Z}$ and $M \in \mathbb{Z}_{\geq 1}$. In [1], Brown et al. proved explicit formulas for $H_{m, M}(p)$ when $p$ is a prime and $M \in\{2,3,4\}$. They also conjectured a formula for $M=5$ and gave an incomplete formula for $M=7$. For example, if $M=5$ and $m=0$, then

$$
H_{0,5}(p)= \begin{cases}\frac{p+1}{2} & \text { if } p \equiv 1 \quad(\bmod 5) \\ \frac{p+1}{3} & \text { if } p \equiv 2,3 \quad(\bmod 5), \\ \frac{p-3}{2} & \text { if } p \equiv 4 \quad(\bmod 5)\end{cases}
$$

[^0]Bringmann and Kane [2] developed a unified approach to these sums for $M$ prime, proved the conjecture for $M=5$ and a complete formula for $M=7$. Their technique was further simplified by Mertens [16] as an application of his development of the theory of Rankin-Cohen brackets of weight $\frac{3}{2}$ mock modular forms and weight $\frac{1}{2}$ modular forms.

Besides sums of Hurwitz class numbers, one can also consider higher moments. For $\kappa \in \mathbb{Z}_{\geq 0}, m \in \mathbb{Z}$, $M \in \mathbb{Z}_{\geq 1}$, and $n \in \mathbb{Z}_{\geq 0}$, let

$$
H_{\kappa, m, M}(n):=\sum_{\substack{t \in \mathbb{Z} \\ t \equiv m \\(\bmod M)}} H\left(4 n-t^{2}\right) t^{\kappa}
$$

Kane and Pujahari gave an asymptotic formula for the even moments $H_{2 k, m, M}(n)$ expressed in terms of the zeroth moment [11, Theorem 1.1], which they subsequently applied to elliptic curves, namely the weighted even moments with respect to the trace of Frobenius [11, Theorem 1.2]. Odd moments were similarly treated in [4, Theorem 1.4].

In this paper, we find explicit formulas for $H_{m, M}(p)$ for the composite moduli $M=6$ and $M=8$. Let us state our results for $m=0$. The following is a famous fact from elementary number theory [8, p. 7]: If $p$ is a prime, then

$$
\begin{aligned}
& p=x^{2}+y^{2}, \quad x, y \in \mathbb{Z} \quad \Longleftrightarrow \quad p=2 \text { or } p \equiv 1 \quad(\bmod 4), \\
& p=x^{2}+2 y^{2}, \quad x, y \in \mathbb{Z} \quad \Longleftrightarrow \quad p=2 \text { or } p \equiv 1,3 \quad(\bmod 8), \\
& p=x^{2}+3 y^{2}, \quad x, y \in \mathbb{Z} \quad \Longleftrightarrow \quad p=3 \text { or } p \equiv 1 \quad(\bmod 3) .
\end{aligned}
$$

If $p$ is an odd prime such that $p=x_{0}^{2}+y_{0}^{2}$ with $x_{0}, y_{0} \in \mathbb{Z}$, then exactly one of $x_{0}, y_{0}$ is odd, hence $p$ is also of the form $x^{2}+4 y^{2}$. If we require $x, y \in \mathbb{Z}_{\geq 0}$, then this expression is unique. More generally, if $n \in \mathbb{Z}_{\geq 2}$ and $p$ is an odd prime of the form $x^{2}+n y^{2}$, then there exists a unique solution to the equation $p=x^{2}+n y^{2}$ with $x, y \in \mathbb{Z}_{\geq 0}$ [8, Exercise 3.23].

Theorem 1.1. Let $p \geq 5$ be a prime. For $p \equiv 1(\bmod 3)$, let $p=x^{2}+3 y^{2}$, where $x, y \in \mathbb{Z}$. If $\chi-3$ denotes the non-principal character modulo 3, then

$$
H_{0,6}(p)= \begin{cases}\frac{p+1}{3}+\frac{1}{3} \chi_{-3}(x) x & \text { if } p \equiv 1 \quad(\bmod 3), \\ \frac{2 p-4}{3} & \text { if } p \equiv 2 \quad(\bmod 3)\end{cases}
$$

Proof. This is a special case of Theorem 4.4
Theorem 1.2. Let $p \geq 3$ be a prime. For $p \equiv 1(\bmod 4)$, let $p=x^{2}+4 y^{2}$, where $x, y \in \mathbb{Z}$. If $\chi_{-4}$ denotes the non-principal character modulo 4 , then

$$
H_{0,8}(p)= \begin{cases}\frac{p+1}{4}+\frac{1}{2} \chi_{-4}(x) x & \text { if } p \equiv 1 \quad(\bmod 4), \\ \frac{p+1}{3} & \text { if } p \equiv 3 \quad(\bmod 8), \\ \frac{p-3}{2} & \text { if } p \equiv 7 \quad(\bmod 8) .\end{cases}
$$

Proof. This is a special case of Theorem 4.6.
We prove formulas of this type for all other $m$. It is interesting to note that for $M \leq 5$, the formulas are linear in $p$, while in our theorems we have the "error terms" $\frac{1}{3} \chi_{-3}(x) x$ and $\frac{1}{2} \chi_{-4}(x) x$ of size $O(\sqrt{p})$. As will become clear from the proof, they appear as coefficients of CM cusp forms. For example, $\frac{1}{3} \chi_{-3}(x) x$ comes from $\frac{1}{6} \Psi_{3}\left(\chi_{-3}, \tau\right)$, where

$$
\Psi_{3}\left(\chi_{-3}, \tau\right):=\frac{1}{2} \sum_{n=1}^{\infty}\left(\sum_{x^{2}+3 y^{2}=n} \chi_{-3}(x) x\right) q^{n}=q-4 q^{7}+2 q^{13}+8 q^{19}+O\left(q^{20}\right)
$$

(the inner sum runs over all $x, y \in \mathbb{Z}$ such that $x^{2}+3 y^{2}=n$ ). This is a newform in the space $S_{2}\left(\Gamma_{0}(36)\right)$ with complex multiplication by $\mathbb{Q}(\sqrt{-3})$, as we show in Lemma 4.1. A similar situation occurs for $M=7$ : the sum $H_{0,7}(p)$ depends on the coefficient of a newform in $S_{2}\left(\Gamma_{0}(49)\right)$ with complex multiplication by $\mathbb{Q}(\sqrt{-7})$ [2, Corollary 4.5].

The rest of the paper is organized as follows. In Section 2, we review the preliminaries about Hurwitz class numbers, modular forms, and CM forms. Section 3 contains auxiliary lemmas. The explicit formulas for $H_{m, M}(p)$ are proved in Section 4 .

## 2. Preliminaries

We begin by defining Hurwitz class numbers. Let $\mathcal{Q}_{D}$ be the set of binary integral quadratic forms of discriminant $D$. For $Q \in \mathcal{Q}_{D}$, let $\Gamma_{Q}$ be the stabilizer group of $Q$ in $\mathrm{SL}_{2}(\mathbb{Z})$.

Definition 2.1. Let $D \in \mathbb{Z}_{<0}, D \equiv 0,1(\bmod 4)$. The $|D|$-th Hurwitz class number is defined by

$$
H(|D|)=\sum_{Q \in \mathcal{Q}_{D} / \mathrm{SL}_{2}(\mathbb{Z})} \frac{1}{\omega_{Q}},
$$

where

$$
\omega_{Q}:=\frac{\left|\Gamma_{Q}\right|}{2}= \begin{cases}2 & \text { if } Q=a\left(x^{2}+y^{2}\right) \\ 3 & \text { if } Q=a\left(x^{2}+x y+y^{2}\right) \\ 1 & \text { otherwise }\end{cases}
$$

We also set $H(0):=-\frac{1}{12}$ and $H(n):=0$ if $n \in \mathbb{Z}_{<0}$ or $n \equiv 1,2(\bmod 4)$.
We briefly summarize some basic facts about modular forms; for details, see 13,17 . Let $F: \mathbb{H} \rightarrow \mathbb{C}$ denote a function on the upper half-plane. The weight $\kappa$ slash operator is defined as follows: if $\kappa \in \mathbb{Z}$, then

$$
\left(\left.F\right|_{\kappa} \gamma\right)(\tau):=(c \tau+d)^{-\kappa} F(\gamma \tau)
$$

where $\gamma=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{SL}_{2}(\mathbb{Z})$, and if $\kappa \in \frac{1}{2}+\mathbb{Z}$, then

$$
\left(\left.F\right|_{\kappa} \gamma\right)(\tau):=\left(\frac{c}{d}\right)^{2 \kappa} \varepsilon_{d}^{2 \kappa}(c \tau+d)^{-\kappa} F(\gamma \tau)
$$

where $\gamma=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \Gamma_{0}(4),(\vdots)$ is the extended Legendre symbol, and

$$
\varepsilon_{d}=\left\{\begin{array}{lll}
1 & \text { if } d \equiv 1 \quad(\bmod 4) \\
i & \text { if } d \equiv 3 & (\bmod 4)
\end{array}\right.
$$

Let $\Gamma$ be a congruence subgroup containing $T:=\left(\begin{array}{ll}1 & 1 \\ 0 & 1\end{array}\right)$ and such that $\Gamma \subset \Gamma_{0}(4)$ if $\kappa \in \frac{1}{2}+\mathbb{Z}$. We say that $F$ satisfies modularity of weight $\kappa$ on $\Gamma$ with Nebentypus character $\chi$ if

$$
\left.F\right|_{\kappa}=\chi(d) F .
$$

Moreover, if $F$ is holomorphic on $\mathbb{H}$ and $F(\tau)$ grows at most polynomially in $v$ as $\tau:=u+i v \rightarrow \mathbb{Q} \cup\{i \infty\}$, then $F$ is called a (holomorphic) modular form. If $F$ vanishes at the cusps of $\Gamma$, then it is called a cusp form. The modular (resp. cusp) forms of weight $\kappa$ on $\Gamma$ with character $\chi$ form a $\mathbb{C}$-vector space which will be denoted by $M_{\kappa}(\Gamma, \chi)\left(\operatorname{resp} . S_{\kappa}(\Gamma, \chi)\right)$.

If $F$ satisfies weight $\kappa$ modularity and there exist holomorphic functions $F_{j}$ for $0 \leq j \leq \ell$ such that $F(\tau)=\sum_{j=0}^{\ell} F_{j}(\tau) v^{-j}$, then $F$ is called an almost holomorphic modular form and the function $F_{0}$ is called a quasimodular form.

The $U$-operator is defined for $M \in \mathbb{Z}_{\geq 1}$ and $F(\tau)=\sum_{n=0}^{\infty} a(n) q^{n}$ by

$$
\left(F \mid U_{M}\right)(\tau):=\sum_{n=0}^{\infty} a(M n) q^{n}
$$

and the $V$-operator is defined for $M \in \mathbb{Z}_{\geq 1}$ and $F: \mathbb{H} \rightarrow \mathbb{C}$ by

$$
\left(F \mid V_{M}\right)(\tau):=F(M \tau)
$$

Suppose that $F$ satisfies weight $\kappa$ modularity on $\Gamma_{0}\left(N_{1}\right) \cap \Gamma_{1}\left(N_{2}\right)$ with character $\chi$, where $N_{2} \mid N_{1}$ and where we assume $4 \mid N_{1}$ if $\kappa \in \frac{1}{2}+\mathbb{Z}$. Then $F \mid U_{M}$ satisfies weight $\kappa$ modularity on $\Gamma_{0}\left(\operatorname{lcm}\left(N_{1}, M\right)\right) \cap \Gamma_{1}\left(N_{2}\right)$ with character $\chi \cdot\left(\frac{M}{-}\right)^{2 \kappa}$, and $F \mid V_{M}$ satisfies weight $\kappa$ modularity on $\Gamma_{0}\left(N_{1} M\right) \cap \Gamma_{1}\left(N_{2}\right)$ with character $\chi \cdot\left(\frac{M}{.}\right)^{2 \kappa}$.

For a Dirichlet character $\psi$ with modulus $M$, the $\psi$-twist of $F=\sum_{n=0}^{\infty} a(n) q^{n}$ is defined by

$$
(F \otimes \psi)(\tau):=\sum_{n=0}^{\infty} \psi(n) a(n) q^{n}
$$

If $F \in M_{\kappa}\left(\Gamma_{0}(N), \chi\right)$, then $F \otimes \psi \in M_{\kappa}\left(\Gamma_{0}\left(N M^{2}\right), \chi \psi^{2}\right)$.
For $M \in \mathbb{Z}_{\geq 1}$ and $m \in \mathbb{Z}$, the sieving operator $S_{M, m}$ is defined by

$$
\left(F \mid S_{M, m}\right)(\tau)=\sum_{n \in \mathbb{Z}} a(M n+m) q^{M n+m} .
$$

We will show how this operator acts on spaces of modular forms in Lemma 3.5

To check whether two modular forms in the same space are equal, we use the Sturm bound, which is a consequence of the valence formula.
Theorem 2.2 (Sturm bound, [20, Corollary 9.20]). Let $\kappa \in \mathbb{Z}_{\geq 2}, \Gamma \subset \mathrm{SL}_{2}(\mathbb{Z})$ be a congruence subgroup, and $\chi$ be a character. If $f=\sum_{n=0}^{\infty} a(n) q^{n}$ and $g=\sum_{n=0}^{\infty} b(n) q^{n}$ are two modular forms in $M_{\kappa}(\Gamma, \chi)$ such that

$$
a(n)=b(n) \text { for } 0 \leq n \leq\left\lfloor\frac{\kappa m}{12}\right\rfloor
$$

where $m=\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma\right]$, then $f=g$.
In the situations where we apply Theorem 2.2, we use the following simple lemma to compute the index of the group $\Gamma$.

Lemma 2.3 ([3, Lemma 2.2]). If $N_{1}, N_{2} \in \mathbb{Z}_{\geq 1}$ with $N_{2} \mid N_{1}$, then

$$
\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{0}\left(N_{1}\right) \cap \Gamma_{1}\left(N_{2}\right)\right]=N_{1} \prod_{p \mid N_{1}}\left(1+\frac{1}{p}\right) \varphi\left(N_{2}\right)
$$

where the product runs over all primes dividing $N_{1}$. In particular,

$$
\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{0}\left(N_{1}\right)\right]=N_{1} \prod_{p \mid N_{1}}\left(1+\frac{1}{p}\right)
$$

Next, we recall the definition of CM modular form.
Definition 2.4 ([18, p. 34]). Let $\kappa \in \mathbb{Z}_{\geq 2}, N \in \mathbb{Z}_{\geq 1}$, and $\chi$ be a Dirichlet character. Let $f(\tau)=\sum_{n=0}^{\infty} c(n) q^{n}$ in $S_{\kappa}\left(\Gamma_{0}(N), \chi\right)$, and assume that $f$ is a newform. Let $\varphi$ be a Dirichlet character modulo $M$ for some $M \in \mathbb{Z}_{\geq 2}$. The form $f$ has complex multiplication by $\varphi$ if

$$
\varphi(p) a(p)=a(p)
$$

for all primes $p$ in a set of primes of density 1 .
If $D \in \mathbb{Z}_{<0}, D \equiv 0,1(\bmod 4), K=\mathbb{Q}(\sqrt{D})$ is a quadratic field, and $\varphi=\left(\frac{D}{\cdot}\right)$ is the quadratic character of $K$, then we say that $f$ has complex multiplication by $K$.

The following theorem due to Hirzebruch and Zagier states that one can complete the generating function $\mathcal{H}$ for the Hurwitz class numbers to obtain a harmonic weak Maass form. Since we will not use this theorem directly, we do not define harmonic weak Maass forms and instead refer to, e.g., [15, Definition 3.1].

Theorem 2.5 ([10, Theorem 2]). The function

$$
\widehat{\mathcal{H}}(\tau):=\mathcal{H}(\tau)+\frac{1}{8 \pi \sqrt{v}}+\frac{1}{4 \sqrt{\pi}} \sum_{n=1}^{\infty} n \Gamma\left(-\frac{1}{2}, 4 \pi n^{2} v\right) q^{-n^{2}}
$$

where $\Gamma(\cdot, \cdot)$ denotes the incomplete Gamma function, is a harmonic Maass form of weight $\frac{3}{2}$ on $\Gamma_{0}(4)$.
If we let

$$
\theta_{m, M}(\tau):=\sum_{\substack{n \in \mathbb{Z} \\ n \equiv m \\(\bmod M)}} q^{n^{2}}
$$

then the generating function

$$
\mathcal{H}_{m, M}(\tau):=\sum_{n=0}^{\infty} H_{m, M}(n) q^{n}
$$

satisfies

$$
\mathcal{H}_{m, M}=\left(\mathcal{H} \theta_{m, M}\right) \mid U_{4}
$$

Definition 2.6 ([11, p. 5]). For $F_{1}, F_{2}$ transforming like modular forms of weight $\kappa_{1}, \kappa_{2} \in \frac{1}{2} \mathbb{Z}$, respectively, define for $k \in \mathbb{Z}_{\geq 0}$ the $k$-th Rankin-Cohen bracket

$$
\left[F_{1}, F_{2}\right]_{k}:=\frac{1}{(2 \pi i)^{k}} \sum_{j=0}^{k}(-1)^{j}\binom{\kappa_{1}+k-1}{k-j}\binom{\kappa_{2}+k-1}{j} F_{1}^{(j)} F_{2}^{(k-j)}
$$

with $\binom{\alpha}{j}:=\frac{\Gamma(\alpha+1)}{j!\Gamma(\alpha-j+1)}$. Then $\left[F_{1}, F_{2}\right]_{k}$ transforms like a modular form of weight $\kappa_{1}+\kappa_{2}+2 k$.
Note that for $k=0$, the Rankin-Cohen bracket $\left[F_{1}, F_{2}\right]_{0}$ is simply the product $F_{1} F_{2}$. Let

$$
\Lambda_{\ell, m, M}(\tau):=\sum_{n=1}^{\infty} \lambda_{\ell, m, M}(n) q^{n}, \quad \text { where } \quad \lambda_{\ell, m, M}(n):=\sum_{ \pm} \sum_{\substack{t>s \geq 0 \\ t^{2}-s^{2}=n \\ t \equiv \pm m(\bmod M)}}^{*}(t-s)^{\ell}
$$

The * next to the sum means that terms for $s=0$ are taken with weight $\frac{1}{2}$.

Lemma 2.7 ([11, Lemma 3.3]). For $k \in \mathbb{Z}_{\geq 0}, m \in \mathbb{Z}$, and $M \in \mathbb{Z}_{\geq 1}$, the function

$$
\left.\left(\left[\mathcal{H}, \theta_{m, M}\right]_{k}+2^{-1-2 k}\binom{2 k}{k} \Lambda_{2 k+1, m, M}\right) \right\rvert\, U_{4}
$$

is a holomorphic cusp form of weight $2+2 k$ on $\Gamma_{0}\left(4 M^{2}\right) \cap \Gamma_{1}(M)\left(r e s p . \Gamma_{0}\left(4 M^{2}\right)\right.$ ) if $M \nmid m$ (resp. $M \mid m$ ) if $k>0$ and quasimodular on that group if $k=0$.

This result was originally stated by Mertens [16, p. 379] in the special case when $M=p$ is prime. Kane and Pujahari [11] pointed out that it remains valid for $M$ composite and corrected the constant appearing in front of $\Lambda_{2 k+1, m, M}$.

## 3. Auxiliary lemmas

Lemma 2.7 for $k=0$ is the main ingredient in our proof of explicit formulas like the one in Theorem 1.1. In this section, we find a different expression for $\Lambda_{\ell, m, M}$ which is more suitable for calculations. Similar formulas were given by Mertens in the case when $M=p$ is a prime, see [16, Proposition 7.2] and also [15, Proposition V.4.3]. It would be sufficient to evaluate $\Lambda_{\ell, m, M}$ only for $\ell=1$. However, finding the evaluation for general $\ell$ presents very little additional difficulty.

For $\ell \in \mathbb{Z}_{\geq 0}, a, b \in \mathbb{Z}$, and $M, n \in \mathbb{Z}_{\geq 1}$, let

$$
\mu_{\ell, a, b, M}(n):=\sum_{\substack{t>s \geq 1 \\ t^{2}-s^{2}=4 n \\ t \equiv a \quad(\bmod M) \\ s \equiv b \quad(\bmod M)}}(t-s)^{\ell}
$$

Lemma 3.1. Let $\ell \in \mathbb{Z}_{\geq 0}$, $a, b \in \mathbb{Z}$, and $M=2^{e} M_{1}$, where $e \in \mathbb{Z}_{\geq 1}$ and $M_{1} \in \mathbb{Z}_{\geq 1}$ is odd. Let $f=0$ if $e=1$ and $f=e$ if $e \geq 2$. Let $n \in \mathbb{Z}_{\geq 1}$ be such that $\operatorname{gcd}(n, M)=1$.
(1) If $a$ or $b$ is odd, then $\mu_{\ell, a, b, M}(n)=0$.
(2) If $a=2 a_{1}$ and $b=2 b_{1}$, then

$$

Next, we prove (2). First, suppose $e=1$, hence $M=2 M_{1}$ for $M_{1}$ odd. If $\mu_{\ell, a, b, M}(n)$ is non-zero, then there exist $t>s \geq 1, t \equiv 2 a_{1}(\bmod M), s \equiv 2 b_{1}(\bmod M)$ such that $t^{2}-s^{2}=4 n$, hence

To prove the explicit formulas for $H_{m, M}(p)$ in Section 4 we twist the quasimodular form in Lemma 2.7 by the principal character $\chi_{M, 0}$. It is necessary to know to which space the resulting function belongs. The answer is provided by the next lemma. An analogous result for weight $\kappa \in \frac{1}{2}+\mathbb{Z}$ is [3, Lemma 2.3 (2)].

\left.\left.\left(f \mid S_{M, m}\right)\right|_{\kappa} \gamma=\left.\chi(d) \frac{1}{M} \sum_{\ell^{\prime}}(\bmod M) \quad e^{\frac{-2 \pi i m a^{2} \ell}{M}} f\right|_{\kappa}\left(\begin{array}{cc}
1 & \frac{\ell^{\prime}}{M} \\
0 & 1
\end{array}\right)=\chi(d) f \right\rvert\, S_{M, m a^{2}}
$$

If we additionally assume $\gamma \in \Gamma_{1}(M)$, then $a \equiv 1(\bmod M)$, hence

$$
\left.\left(f \mid S_{M, m}\right)\right|_{\kappa} \gamma=\chi(d) f \mid S_{M, m}
$$

and $f \mid S_{M, m}$ satisfies weight $\kappa$ modularity on $\Gamma$. To prove the "moreover" part, we note that if $M \mid 24$, then $a^{2} \equiv 1(\bmod M)$ for every $a$ such that $(a, M)=1$, hence $f\left|S_{M, m a^{2}}=f\right| S_{M, m}$.

## 4. Explicit formulas modulo 6 and 8

In this section, we prove the explicit formulas for $H_{m, M}(p)$, where $M \in\{6,8\}$ and $p$ is a prime. We begin by proving that certain functions are CM cusp forms and identify the spaces to which they belong.

For $k \in \mathbb{Z}_{\geq 2}$ and an odd Dirichlet character $\chi$, let

$$
\psi_{k}(\chi, n):=\sum_{x^{2}+k y^{2}=n} \chi(x) x,
$$

where the sum runs over all $x, y \in \mathbb{Z}$ such that $x^{2}+k y^{2}=n$, and

$$
\Psi_{k}(\chi, \tau):=\frac{1}{2} \sum_{n=1}^{\infty} \psi_{k}(\chi, n) q^{n} .
$$

The $\frac{1}{2}$ in front of the sum normalizes it in such a way that the coefficient of $q$ equals 1 . If we set

$$
\theta_{0}(\tau):=\sum_{y \in \mathbb{Z}} q^{y^{2}}
$$

and

$$
\theta(\chi, 1, \tau):=\frac{1}{2} \sum_{x \in \mathbb{Z}} \chi(x) x q^{x^{2}}
$$

then we see that

$$
\Psi_{k}(\chi, \tau)=\theta(\chi, 1, \tau) \cdot\left(\theta_{0} \mid V_{k}\right)(\tau)
$$

Lemma 4.1. Let $\chi_{-3}$ and $\chi_{-4}$ denote the non-principal characters modulo 3 and 4 , respectively. The functions $\Psi_{k}(\chi, \tau)$ satisfy the following:
(1) $\Psi_{3}\left(\chi_{-3}, \tau\right)$ is a newform in $S_{2}\left(\Gamma_{0}(36)\right)$ and has complex multiplication by $\mathbb{Q}(\sqrt{-3})$ (LMFDB label 36.2.a.a).
(2) $\Psi_{4}\left(\chi_{-4}, \tau\right)$ is a newform in $S_{2}\left(\Gamma_{0}(64)\right)$ and has complex multiplication by $\mathbb{Q}(i)$ (LMFDB label 64.2.a.a).
(3) $\Psi_{2}\left(\chi_{-4}, \tau\right) \in S_{2}\left(\Gamma_{0}(64),\left(\frac{2}{-}\right)\right)$. It satisfies

$$
\Psi_{2}\left(\chi_{-4}, \tau\right)=\frac{f(\tau)+\bar{f}(\tau)}{2}+\frac{f(\tau)-\bar{f}(\tau)}{2 i}
$$

where $f(\tau)=\sum_{n=1}^{\infty} a(n) q^{n}$ is the newform with LMFDB label 64.2.b.a and $\bar{f}(\tau)=\sum_{n=1}^{\infty} \overline{a(n)} q^{n}$. The form $f$ has complex multiplication by $\mathbb{Q}(\sqrt{-2})$.

Proof. If $\chi$ is an odd character of conductor $N_{\chi}$, then by [17, Theorem 1.44], $\theta(\chi, 1, \tau) \in S_{\frac{3}{2}}\left(\Gamma_{0}\left(4 N_{\chi}^{2}\right), \chi \chi-4\right)$. By [17, Proposition 1.41], $\theta_{0}(\tau) \in M_{\frac{1}{2}}\left(\Gamma_{0}(4)\right)$, hence $\left(\theta_{0} \mid V_{k}\right)(\tau) \in M_{\frac{1}{2}}\left(\Gamma_{0}(4 k),\left(\frac{k}{4}\right)\right)$.

Thus, if $k=3$ and $\chi=\chi_{-3}$, then $\theta\left(\chi_{-3}, 1, \tau\right) \in S_{\frac{3}{2}}\left(\Gamma_{0}(36),\left(\frac{12}{4}\right)\right)$ and $\left(\theta_{0} \mid V_{3}\right)(\tau) \in M_{\frac{1}{2}}\left(\Gamma_{0}(12),\left(\frac{3}{4}\right)\right)$, hence $\Psi_{3}\left(\chi_{-3}, \tau\right) \in S_{2}\left(\Gamma_{0}(36)\right)$.

If $\chi=\chi_{-4}$, then $\theta\left(\chi_{-4}, 1, \tau\right) \in S_{\frac{3}{2}}\left(\Gamma_{0}(64), \chi_{-4}^{2}\right)=S_{\frac{3}{2}}\left(\Gamma_{0}(64)\right)$. For $k=4$, we get $\left(\theta_{0} \mid V_{4}\right)(\tau) \in M_{\frac{1}{2}}\left(\Gamma_{0}(16)\right)$, hence $\Psi_{4}\left(\chi_{-4}, \tau\right) \in S_{2}\left(\Gamma_{0}(64)\right)$.

For $k=2$, we get $\left(\theta_{0} \mid V_{2}\right)(\tau) \in M_{\frac{1}{2}}\left(\Gamma_{0}(8),(\underline{2})\right)$, hence $\Psi_{2}\left(\chi_{-4}, \tau\right) \in S_{2}\left(\Gamma_{0}(64),(\underline{2})\right)$.
Next, we identify these forms with forms in the LMFDB [14. We have $\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{0}(36)\right]=72$ and $\left[\mathrm{SL}_{2}(\mathbb{Z})\right.$ : $\left.\Gamma_{0}(64)\right]=96$ by Lemma 2.3. To show that two forms on $\Gamma_{0}(36)$ (respectively $\Gamma_{0}(64)$ ) are equal by Theorem 2.2, we must check the first $\frac{72}{6}=12$ (respectively $\frac{96}{6}=16$ ) coefficients. Since

$$
\begin{aligned}
& \Psi_{3}\left(\chi_{-3}, \tau\right)=q-4 q^{7}+O\left(q^{12}\right), \\
& \Psi_{4}\left(\chi_{-4}, \tau\right)=q+2 q^{5}-3 q^{9}-6 q^{13}+O\left(q^{16}\right), \\
& \Psi_{2}\left(\chi_{-4}, \tau\right)=q+2 q^{3}-q^{9}-6 q^{11}+O\left(q^{16}\right),
\end{aligned}
$$

$\Psi_{3}\left(\chi_{-3}, \tau\right)$ is equal to the form with LMFDB label 36.2.a.a. and $\Psi_{4}\left(\chi_{-4}, \tau\right)$ to the form with LMFDB label 64.2.a.a. These are newforms with complex multiplication by $\mathbb{Q}(\sqrt{-3})$ and $\mathbb{Q}(i)$, respectively. Finally, the form $f$ with LMFDB label 64.2 .b.a has $q$-expansion

$$
f(\tau)=q+2 i q^{3}-q^{9}-6 i q^{11}+O\left(q^{16}\right),
$$

hence

$$
\bar{f}(\tau)=q-2 i q^{3}-q^{9}+6 i q^{11}+O\left(q^{16}\right) .
$$

The formula for $\Psi_{2}\left(\chi_{-4}, \tau\right)$ follows.

The function

$$
D(\tau):=\sum_{n=1}^{\infty} \sigma(n) q^{n}
$$

where $\sigma(n)=\sum_{d \mid n} d$, is an example of a quasimodular form. Let

$$
E_{2}(\tau):=1-24 \sum_{n=1}^{\infty} \sigma(n) q^{n}
$$

be the Eisenstein series of weight 2. If $\tau=u+i v$, then

$$
\widehat{E_{2}}(\tau):=E_{2}(\tau)-\frac{3}{\pi v}
$$

satisfies weight 2 modularity on $\mathrm{SL}_{2}(\mathbb{Z})$ [13, p. 113]. We have $D(\tau)=\frac{1}{24}-\frac{1}{24} E_{2}(\tau)$, hence

$$
\widehat{D}(\tau):=D(\tau)-\frac{1}{24}+\frac{1}{8 \pi v}=-\frac{1}{24} \widehat{E_{2}}(\tau)
$$

also satisfies weight 2 modularity on $\mathrm{SL}_{2}(\mathbb{Z})$.
Lemma 4.2. If $M \in \mathbb{Z}_{\geq 2}$ and $m \in \mathbb{Z}$ is such that $M \nmid m$, then $D \mid S_{M, m} \in M_{2}\left(\Gamma_{0}\left(M^{2}\right)\right)$. In particular, if $\chi_{M, 0}$ denotes the principal character modulo $M$, then $D \otimes \chi_{M, 0} \in M_{2}\left(\Gamma_{0}\left(M^{2}\right)\right)$.
Proof. We have

$$
E_{2}(\tau)-M E_{2}(M \tau)=\widehat{E_{2}}(\tau)-M \widehat{E_{2}}(M \tau)
$$

The left-hand side is holomorphic and the ring-hand side satisfies weight 2 modularity on $\Gamma_{0}(M)$, hence $E_{2}-$ $M E_{2} \mid V_{M}$ is a holomorphic modular form and belongs to $M_{2}\left(\Gamma_{0}(M)\right)$. Since $M \nmid m$, we get

$$
E_{2}\left|S_{M, m}=\left(E_{2}-M E_{2} \mid V_{M}\right)\right| S_{M, m} \in M_{2}\left(\Gamma_{0}\left(M^{2}\right)\right)
$$

by Lemma 3.5, hence also $D\left|S_{M, m}=-\frac{1}{24} E_{2}\right| S_{M, m} \in M_{2}\left(\Gamma_{0}\left(M^{2}\right)\right)$.
It is enough to determine $H_{m, M}(n)$ for $0 \leq m \leq \frac{M}{2}$ since, by definition,

$$
H_{m, M}(n)=\sum_{\substack{t \in \mathbb{Z} \\(\equiv m)}} H\left(4 n-t^{2}\right)=H_{-m, M}(n)
$$

Proposition 4.3. If $\chi_{6,0}$ denotes the principal character modulo 6 , then

$$
\begin{aligned}
\left(\mathcal{H} \theta_{0,6}\right)\left|U_{4} \otimes \chi_{6,0}+2 G_{1,1,3}\right| S_{6,5} & =\frac{1}{3} D\left|S_{6,1}+\frac{2}{3} D\right| S_{6,5}+\frac{1}{6} \Psi_{3}\left(\chi_{-3}, \cdot\right), \\
\left(\mathcal{H} \theta_{1,6}\right) \mid U_{4} \otimes \chi_{6,0} & =\frac{1}{4} D\left|S_{6,1}+\frac{1}{6} D\right| S_{6,5}+\frac{1}{12} \Psi_{3}\left(\chi_{-3}, \cdot\right), \\
\left(\mathcal{H} \theta_{2,6}\right)\left|U_{4} \otimes \chi_{6,0}+G_{1,1,3}\right| S_{6,1}+\frac{1}{2} T_{1,1,6} & =\frac{1}{2} D\left|S_{6,1}+\frac{1}{3} D\right| S_{6,5}-\frac{1}{12} \Psi_{3}\left(\chi_{-3}, \cdot\right), \\
\left(\mathcal{H} \theta_{3,6}\right) \mid U_{4} \otimes \chi_{6,0} & =\frac{1}{6} D\left|S_{6,1}+\frac{1}{3} D\right| S_{6,5}-\frac{1}{6} \Psi_{3}\left(\chi_{-3}, \cdot\right),
\end{aligned}
$$

Proof. We prove in detail the first formula. By Lemma 2.7, the function

$$
\left.\left(\mathcal{H} \theta_{0,6}+\frac{1}{2} \Lambda_{1,0,6}\right) \right\rvert\, U_{4}
$$

is a quasimodular form of weight 2 on $\Gamma_{0}\left(4 \cdot 6^{2}\right)$. Since 6 divides 24 ,

$$
\left.\left(\mathcal{H} \theta_{0,6}+\frac{1}{2} \Lambda_{1,0,6}\right) \right\rvert\, U_{4} \otimes \chi_{6,0}
$$

also satisfies weight 2 modularity on $\Gamma_{0}\left(4 \cdot 6^{2}\right)$ by the "moreover" part of Lemma 3.5. By Lemma 3.3,

$$
\Lambda_{1,0,6}\left|U_{4} \otimes \chi_{6,0}=4 G_{1,1,3}\right| S_{6,5}
$$

hence

$$
\left(\mathcal{H} \theta_{0,6}\right)\left|U_{4} \otimes \chi_{6,0}+2 G_{1,1,3}\right| S_{6,5} \in M_{2}\left(\Gamma_{0}(4 \cdot 36)\right)
$$

By Lemma 4.2, $D \mid S_{6, r} \in M_{2}\left(\Gamma_{0}(36)\right)$ for $r \in\{1,5\}$, and by Lemma 4.1 (1), $\Psi_{3}\left(\chi_{-3}, \tau\right) \in S_{2}\left(\Gamma_{0}(36)\right)$. Thus, both the left-hand side and the right-hand side are modular forms in $M_{2}\left(\Gamma_{0}(4 \cdot 36)\right)$.

If $n \equiv 1(\bmod 6)$, then the coefficient of $q^{n}$ on the left-hand side equals $H_{0,6}(n)$, while the coefficient of $q^{n}$ on the right-hand side equals $\frac{1}{3} \sigma(n)+\frac{1}{12} \psi_{3}\left(\chi_{-3}, n\right)$.

If $n \equiv 5(\bmod 6)$, then the coefficient of $q^{n}$ on the left-hand side equals $H_{0,6}(n)+2 g_{1,0,6}(n)$, while the coefficient of $q^{n}$ on the right-hand side equals $\frac{2}{3} \sigma(n)+\frac{1}{12} \psi_{3}\left(\chi_{-3}, n\right)$.

We have $\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{0}(4 \cdot 36)\right]=288$ by Lemma [2.3, hence we have to compare the first $\frac{288}{6}=48$ coefficients to conclude that the two modular forms are equal by Theorem 2.2 The proof of the remaining formulas is similar.

We checked that the coefficients of the forms on both sides are equal in SageMath [19]. The code is available at https://github.com/zinmik/Hurwitz-class-numbers.

Now we prove the explicit formulas for $H_{m, 6}(p)$.
Theorem 4.4. Let $p \geq 5$ be a prime. For $p \equiv 1(\bmod 3)$, let $p=x^{2}+3 y^{2}$, where $x, y \in \mathbb{Z}$. If $\chi_{-3}$ denotes the non-principal character modulo 3, then

$$
H_{m, 6}(p)=\left\{\begin{array}{llll}
\frac{p+1}{3}+\frac{1}{3} \chi_{-3}(x) x & \text { if } m \equiv 0 \quad(\bmod 6), & p \equiv 1 & (\bmod 3), \\
\frac{2 p-4}{3} & \text { if } m \equiv 0 \quad(\bmod 6), & p \equiv 2 \quad(\bmod 3), \\
\frac{p+1}{4}+\frac{1}{6} \chi_{-3}(x) x & \text { if } m \equiv 1,5 \quad(\bmod 6), & p \equiv 1 \quad(\bmod 3), \\
\frac{p+1}{6} & \text { if } m \equiv 1,5 \quad(\bmod 6), & p \equiv 2 \quad(\bmod 3), \\
\frac{p-1}{2}-\frac{1}{6} \chi_{-3}(x) x & \text { if } m \equiv 2,4 \quad(\bmod 6), & p \equiv 1 \quad(\bmod 3), \\
\frac{p+1}{3} & \text { if } m \equiv 2,3,4 \quad(\bmod 6), & p \equiv 2(\bmod 3), \\
\frac{p+1}{6}-\frac{1}{3} \chi_{-3}(x) x & \text { if } m \equiv 3 \quad(\bmod 6), & p \equiv 1 \quad(\bmod 3)
\end{array}\right.
$$

Proof. We prove the formula in the case $m \equiv 0(\bmod 6)$. It follows from Proposition 4.3 that if $p \equiv 1(\bmod 6)$, then

$$
H_{0,6}(p)=\frac{1}{3} \sigma(p)+\frac{1}{12} \psi_{3}\left(\chi_{-3}, p\right)=\frac{p+1}{3}+\frac{1}{3} \chi_{-3}(x) x
$$

and if $p \equiv 5(\bmod 6)$, then

$$
H_{0,6}(p)+2=\frac{2}{3} \sigma(p)=\frac{2 p+2}{3}
$$

The other cases follow from the other formulas in Proposition 4.3
Proposition 4.5. If $\chi_{8,0}$ denotes the principal character modulo 8 , then

$$
\begin{aligned}
\left(\mathcal{H} \theta_{0,8}\right)\left|U_{4} \otimes \chi_{8,0}+2 G_{1,1,4}\right| S_{8,7} & \left.=\frac{1}{4} D\left|S_{4,1}+\frac{1}{3} D\right| S_{8,3}+\frac{1}{2} D \right\rvert\, S_{8,7}+\frac{1}{4} \Psi_{4}\left(\chi_{-4}, \cdot\right), \\
\left(\mathcal{H} \theta_{1,8}\right) \mid U_{4} \otimes \chi_{8,0} & =\frac{1}{6} D \otimes \chi_{8,0}+\frac{1}{6} \Psi_{2}\left(\chi_{-4}, \cdot\right), \\
\left(\mathcal{H} \theta_{2,8}\right)\left|U_{4} \otimes \chi_{8,0}+G_{1,1,4}\right| S_{4,1}+\frac{1}{2} T_{1,1,4} & =\frac{5}{12} D\left|S_{4,1}+\frac{1}{4} D\right| S_{4,3} \\
\left(\mathcal{H} \theta_{3,8}\right) \mid U_{4} \otimes \chi_{8,0} & =\frac{1}{6} D \otimes \chi_{8,0}-\frac{1}{6} \Psi_{2}\left(\chi_{-4}, \cdot\right), \\
\left(\mathcal{H} \theta_{4,8}\right)\left|U_{4} \otimes \chi_{8,0}+2 G_{1,1,4}\right| S_{8,3} & \left.=\frac{1}{4} D\left|S_{4,1}+\frac{1}{2} D\right| S_{8,3}+\frac{1}{3} D \right\rvert\, S_{8,7}-\frac{1}{4} \Psi_{4}\left(\chi_{-4}, \cdot\right) .
\end{aligned}
$$

Proof. Let us prove the first formula. By Lemma 2.7 the function

$$
\left.\left(\mathcal{H} \theta_{0,8}+\frac{1}{2} \Lambda_{1,0,8}\right) \right\rvert\, U_{4}
$$

is a quasimodular form of weight 2 on $\Gamma_{0}\left(4 \cdot 8^{2}\right)$. Since 8 divides 24 ,

$$
\left.\left(\mathcal{H} \theta_{0,8}+\frac{1}{2} \Lambda_{1,0,8}\right) \right\rvert\, U_{4} \otimes \chi_{8,0}
$$

satisfies weight 2 modularity on $\Gamma_{0}(4 \cdot 64)$ by the "moreover" part of Lemma 3.5. By Lemma 3.4,

$$
\Lambda_{1,0,8}\left|U_{4} \otimes \chi_{8,0}=4 G_{1,1,4}\right| S_{8,7}
$$

hence

$$
\left(\mathcal{H} \theta_{0,8}\right)\left|U_{4} \otimes \chi_{8,0}+2 G_{1,1,4}\right| S_{8,7} \in M_{2}\left(\Gamma_{0}(4 \cdot 64)\right)
$$

By Lemma4.2, $D \mid S_{4,1} \in M_{2}\left(\Gamma_{0}(16)\right)$ and $D \mid S_{8, r} \in M_{2}\left(\Gamma_{0}(64)\right)$ for $r \in\{3,7\}$. By Lemma4.1 $(2), \Psi_{4}\left(\chi_{-4}, \tau\right) \in$ $S_{2}\left(\Gamma_{0}(64)\right)$. Thus, both the left-hand side and the right-hand side are modular forms in $M_{2}\left(\Gamma_{0}(4 \cdot 64)\right)$.

The coefficient of $q^{n}$ on the left-hand side equals

$$
H_{0,8}(n)+ \begin{cases}0 & \text { if } n \equiv 1,3,5 \quad(\bmod 8) \\ 2 g_{1,1,4}(n) & \text { if } n \equiv 7 \quad(\bmod 8)\end{cases}
$$

while the coefficient of $q^{n}$ on the right-hand side equals

$$
\frac{1}{8} \psi_{4}\left(\chi_{-4}, n\right)+\left\{\begin{array}{lll}
\frac{1}{4} \sigma(n) & \text { if } n \equiv 1 & (\bmod 4) \\
\frac{1}{3} \sigma(n) & \text { if } n \equiv 3 & (\bmod 8) \\
\frac{1}{2} \sigma(n) & \text { if } n \equiv 7 & (\bmod 8)
\end{array}\right.
$$

We have $\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{0}(4 \cdot 64)\right]=384$ by Lemma 2.3, hence we have to check the first $\frac{384}{6}=64$ coefficients to conclude that the two modular forms are equal by Theorem 2.2.

We also prove the second formula. By Lemma 2.7, the function

$$
\left.\left(\mathcal{H} \theta_{1,8}+\frac{1}{2} \Lambda_{1,1,8}\right) \right\rvert\, U_{4}
$$

is a quasimodular form of weight 2 on $\Gamma_{0}\left(4 \cdot 8^{2}\right) \cap \Gamma_{1}(8)$. By Lemma 3.4,

$$
\Lambda_{1,1,8} \mid U_{4} \otimes \chi_{8,0}=0
$$

hence if we let $\Gamma(8):=\Gamma_{0}(4 \cdot 64) \cap \Gamma_{1}(8)$, then by Lemma 3.5

$$
\left(\mathcal{H} \theta_{1,8}\right) \mid U_{4} \otimes \chi_{8,0} \in M_{2}(\Gamma(8))
$$

By Lemma 4.2, $D \otimes \chi_{8,0} \in M_{2}\left(\Gamma_{0}(64)\right) \subset M_{2}(\Gamma(8))$. By Lemma4.1 $(3), \Psi_{2}\left(\chi_{-4}, \tau\right) \in S_{2}\left(\Gamma_{0}(64),(\underline{2})\right)$. We have $M_{2}\left(\Gamma_{0}(64),\left(\frac{2}{.}\right)\right) \subset M_{2}(\Gamma(8))$ because if $\gamma=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \Gamma(8)$, then $d \equiv 1(\bmod 8)$, hence $\left(\frac{2}{d}\right)=1$. Thus, both sides belong to $M_{2}(\Gamma(8))$ and the rest of the proof is similar.

Theorem 4.6. Let $p \geq 3$ be a prime. For $p \equiv 1(\bmod 4)$, let $p=x^{2}+4 y^{2}$, where $x, y \in \mathbb{Z}$. If $\chi_{-4}$ denotes the non-principal character modulo 4, then

$$
H_{m, 8}(p)=\left\{\begin{array}{llll}
\frac{p+1}{4}+\frac{1}{2} \chi_{-4}(x) x & \text { if } m \equiv 0 \quad(\bmod 8), & p \equiv 1 & (\bmod 4), \\
\frac{p+1}{3} & \text { if } m \equiv 0 \quad(\bmod 8), & p \equiv 3 & (\bmod 8), \\
\frac{p-3}{2} & \text { if } m \equiv 0 \quad(\bmod 8), & p \equiv 7 & (\bmod 8), \\
\frac{5 p-7}{12} & \text { if } m \equiv 2,6 \quad(\bmod 8), & p \equiv 1 & (\bmod 4), \\
\frac{p+1}{4} & \text { if } m \equiv 2,6 \quad(\bmod 8), & p \equiv 3 & (\bmod 4), \\
\frac{p+1}{4}-\frac{1}{2} \chi_{-4}(x) x & \text { if } m \equiv 4 \quad(\bmod 8), & p \equiv 1 & (\bmod 4), \\
\frac{p-3}{2} & \text { if } m \equiv 4 \quad(\bmod 8), & p \equiv 3 & (\bmod 8), \\
\frac{p+1}{3} & \text { if } m \equiv 4 \quad(\bmod 8), & p \equiv 7 & (\bmod 8) .
\end{array}\right.
$$

Proof. We prove the formula in the case $m \equiv 0(\bmod 8)$. It follows from Proposition 4.5 that if $p \equiv 1(\bmod 4)$, then

$$
H_{0,8}(p)=\frac{1}{4} \sigma(p)+\frac{1}{8} \psi_{4}\left(\chi_{-4}, p\right)=\frac{p+1}{4}+\frac{1}{2} \chi_{-4}(x) x
$$

if $p \equiv 3(\bmod 8)$, then

$$
H_{0,8}(p)=\frac{1}{3} \sigma(p)=\frac{p+1}{3}
$$

and if $p \equiv 7(\bmod 8)$, then

$$
H_{0,8}(p)+2=\frac{1}{2} \sigma(p)=\frac{p+1}{2} .
$$

Theorem 4.7. Let $p \geq 3$ be a prime. For $p \equiv 1,3(\bmod 8)$, let $p=x^{2}+2 y^{2}$, where $x, y \in \mathbb{Z}$. If $\chi_{-4}$ denotes the non-principal character modulo 4 , then

$$
H_{m, 8}(p)=\left\{\begin{array}{llll}
\frac{p+1}{6}+\frac{1}{3} \chi_{-4}(x) x & \text { if } m \equiv 1,7 \quad(\bmod 8), & p \equiv 1,3 & (\bmod 8), \\
\frac{p+1}{6} & \text { if } m \equiv 1,3,5,7 \quad(\bmod 8), & p \equiv 5,7 \quad(\bmod 8), \\
\frac{p+1}{6}-\frac{1}{3} \chi_{-4}(x) x & \text { if } m \equiv 3,5 \quad(\bmod 8), & p \equiv 1,3 \quad(\bmod 8)
\end{array}\right.
$$

Proof. We prove the formula in the case $m \equiv 1(\bmod 8)$. By Proposition 4.5,

$$
H_{1,8}(p)=\frac{1}{6} \sigma(p)+\frac{1}{12} \psi_{2}\left(\chi_{-4}, p\right)=\frac{p+1}{6}+ \begin{cases}\frac{1}{3} \chi_{-4}(x) x & \text { if } p \equiv 1,3(\bmod 8) \\ 0 & \text { if } p \equiv 5,7 \\ (\bmod 8)\end{cases}
$$
