# A positive proportion of monic odd-degree hyperelliptic curves of genus $g \ge 4$ have no unexpected quadratic points

#### Abstract

Let  $\mathcal{F}_g$  be the family of monic odd-degree hyperelliptic curves of genus g over  $\mathbb{Q}$ . Poonen and Stoll have shown that for every  $g \geq 3$ , a positive proportion of curves in  $\mathcal{F}_g$  have no rational points except the point at infinity. In this note, we prove the analogue for quadratic points: for each  $g \geq 4$ , a positive proportion of curves in  $\mathcal{F}_g$  have no points defined over quadratic extensions except those that arise by pulling back rational points from  $\mathbb{P}^1$ .

## 1 Introduction

Let  $C/\mathbb{Q}$  be a smooth projective curve of genus  $g \ge 2$ . Faltings has shown that the set of rational points  $C(\mathbb{Q})$  is finite [Fal83, Satz 7]. It is therefore natural to ask how the quantity  $\#C(\mathbb{Q})$  is distributed as C varies in a family of curves. Many authors (see, e.g., [PV04, Conjecture 2.2], [Po006], [Gra07, Conjecture 1.3(ii)], [St009, Conjecture 1]) have formulated heuristics or conjectures suggesting that in a family of curves C of genus  $g \ge 2$ , the quantity  $\#C(\mathbb{Q})$  is very often as small as possible: i.e., most members ought to possess no rational points beyond those that exist generically among all members in the family. Put rather simply, most curves in a family should be as "pointless" as can be.

This pithy principle has been proven (or partially proven) for several families of curves of interest; see, e.g., [Bha13], [BGW17] (cf. [BSS21, Remark 3.3]), [RT21], [SW18], [Lag22]. Of particular relevance to this note is the major result of Poonen and Stoll [PS14], which concerns the family of monic odd-degree hyperelliptic curves

$$\mathcal{F}_q := \{ C \colon y^2 = f(x) = x^{2g+1} + a_1 x^{2g} + \dots + a_{2g+1} \mid a_i \in \mathbb{Z}, \operatorname{disc}(f) \neq 0 \}$$

ordered by the height  $\operatorname{ht}(C) = \max |a_i|^{1/i}$ . Here C denotes the unique smooth projective curve with affine equation  $y^2 = f(x)$ ; it has a unique point at infinity  $P_{\infty}$ , which is Q-rational. If  $g \geq 3$ , Poonen and Stoll showed that a positive proportion of curves  $C \in \mathcal{F}_g$  satisfy  $C(\mathbb{Q}) = \{P_{\infty}\}$ , and that this proportion tends to 1 exponentially fast as  $g \to \infty$ .

In this note, we consider quadratic points on curves in the family  $\mathcal{F}_g$ . Recall that a point  $P \in C(\overline{\mathbb{Q}})$  is quadratic if its field of definition  $\mathbb{Q}(P)$  is a quadratic extension of  $\mathbb{Q}$ . When C is hyperelliptic, it visibly has infinitely many quadratic points: since C has a degree-2 map  $\pi: C \to \mathbb{P}^1$  defined over  $\mathbb{Q}$ , for all but finitely many points  $P \in \mathbb{P}^1(\mathbb{Q})$  the preimage  $\pi^{-1}(P)$  consists of a Galois-conjugate pair of quadratic points. Explicitly, if  $P = (x: 1) \in \mathbb{P}^1(\mathbb{Q})$  then  $\pi^{-1}(P) = (x, \pm \sqrt{f(x)}) \in C(\overline{\mathbb{Q}})$ . It follows from a more general result of Faltings [Fal91, Theorem 1 & Example 4.5] that if  $C/\mathbb{Q}$  is a hyperelliptic curve of genus  $g \ge 4$ , then Chas only finitely many quadratic points not arising as pullbacks from rational points on  $\mathbb{P}^1$ .

#### 1.1 Results

If  $C \in \mathcal{F}_g$ , we say a rational point P on C is *expected* if  $P = P_{\infty}$ , and unexpected otherwise. We say a quadratic point P on C is *expected* if it maps to a rational point on  $\mathbb{P}^1(\mathbb{Q})$ , and unexpected otherwise. Our main result shows that when  $g \ge 4$ , a positive proportion of curves in  $\mathcal{F}_g$  have no unexpected rational or quadratic points at all. Let  $\mathcal{F}_{g,X} := \{C \in \mathcal{F}_g \mid \operatorname{ht}(C) < X\}$ , and define the lower density

$$\delta_g := \liminf_{X \to \infty} \frac{\#\{C \in \mathcal{F}_{g,X} \mid C \text{ has no unexpected rational points or quadratic points}\}}{\#\mathcal{F}_{g,X}}$$

**Theorem 1.** Let  $g \ge 4$ . When ordered by height, a positive proportion of monic odd hyperelliptic curves  $C/\mathbb{Q}$  of genus g possess no unexpected rational points or quadratic points. In other words,  $\delta_g > 0$ .

Theorem 1 is the first unconditional result of its kind to effectivize Faltings' theorem on the finiteness of unexpected quadratic points in a "large" family of curves.

#### 1.2 Methods

The proof of Theorem 1 relies on partially generalizing the method of Poonen and Stoll [PS14] (later dubbed "Selmer group Chabauty" in [Sto17]) to symmetric squares of curves. Roughly speaking, we proceed in three steps as follows:

- 1. Given a subvariety X of a g-dimensional abelian variety  $J/\mathbb{Q}$  and a prime number p, we prove a criterion guaranteeing that  $X(\mathbb{Q}_p) \cap J(\mathbb{Q})$  is "small", under suitable assumptions concerning the disjointness of two sets: (1) the image of  $\operatorname{Sel}_p J$  in  $J(\mathbb{Q}_p)/pJ(\mathbb{Q}_p)$ , and (2) the image of  $X(\mathbb{Q}_p)$  under the re-scale and reduce mod-p logarithm map  $\rho \log \colon X(\mathbb{Q}_p) \dashrightarrow \mathbb{P}^{g-1}(\mathbb{F}_p)$ ; see §2 specifically, Proposition 2.
- 2. Given a curve  $C \in \mathcal{F}_g$ , we wish to apply the criterion to J = the Jacobian of C, X = the image  $\operatorname{Sym}^2 C \to J$ , and p = 2. This leads to a criterion for C to have no unexpected rational or quadratic points; see §3 specifically, Corollary 5.
- 3. We show that the latter criterion is satisfied for a positive proportion of  $C \in \mathcal{F}_g$  when  $g \geq 4$  using two inputs: (1) an equidistribution theorem concerning the image of  $\operatorname{Sel}_2 J \to J(\mathbb{Q}_2)/2J(\mathbb{Q}_2)$  as Cvaries in  $\mathcal{F}_g$  due to Bhargava–Gross [BG13, Theorem 12.4], and (2) the construction of an explicit subfamily  $\mathcal{F}_g^{(2)} \subset \mathcal{F}_g$  having positive density on which we can control the image  $\rho \log(X(\mathbb{Q}_2))$ ; see §5 — specifically, Proposition 8.

By calculating the density of  $\mathcal{F}_g^{(2)}$ , we obtain explicit lower bounds on the density  $\delta_g$ , proving that  $\delta_g \geq 2^{-4g^2-6g-7}$ ; since the curves in  $\mathcal{F}_g^{(2)}$  all have good reduction at 2, the bound must be exponentially small in g: indeed, it is exceedingly rare for a hyperelliptic curve in short Weierstrass form to have good reduction at 2.

If one would like to go beyond Theorem 1 and prove — analogously to Poonen and Stoll — that  $\delta_g \to 1$ as  $g \to \infty$ , one would need to control the image of  $\rho \log: X(\mathbb{Q}_2) \longrightarrow \mathbb{P}^{g-1}(\mathbb{F}_2)$  for a density 1 set of curves  $C \in \mathcal{F}_g$ , with arbitrary reduction type at 2. The methods of [PS14, §3.2, §5] do not directly apply, due to the lack of the Weierstrass preparation theorem for power series over  $\mathbb{Q}_p$  in more than one variable. It therefore seems that new ideas are needed here.

#### 1.3 Previous work

Using just their result that the average size of  $\operatorname{Sel}_2 J$  is at most 3 in conjunction with an effective version of Chabauty's method, Bhargava and Gross show that a positive proportion of curves in  $\mathcal{F}_g$  have at most 3 rational points. It is natural to ask whether a similar strategy would work to control points of degree d. A version of Chabauty's method for symmetric powers of curves was developed by Siksek [Sik09], and Park [Par16] used to tropical intersection theory to develop an effective version of Siksek's method. However, it was later discovered by Gunther and Morrow [GM19, Remark 5.6] that Park's work is missing a transversality hypothesis; while it may be feasible to verify this hypothesis for individual curves, it is currently unknown how to do so in a family of curves. Conditional on this transversality hypothesis, Gunther and Morrow prove that a positive proportion of curves in  $\mathcal{F}_g$  have at most 24 unexpected quadratic points for each  $g \geq 3$ . Our main result, Theorem 1, unconditionally reduces their bound for quadratic points to zero when  $g \geq 4$ .

In a different direction, there are several papers in the literature where versions of Chabauty's method are used to obtain uniform bounds on the number of rational points on curves; here the bounds tend to depend on the genus as well as on the Mordell–Weil rank of the Jacobian. See, e.g., the works of Stoll [Sto19] and Katz, Rabinoff, and Zureick-Brown [KRZB16]. Analogous uniform bounds were obtained for quadratic points by Vemulapalli and Wang [VW21], but their results depend on the aforementioned work of Park [Par16] and are thus conditional.

We end by mentioning the work of Caro and Pasten [CP23], which has consequences for quadratic points on non-hyperelliptic curves whose Jacobian has Mordell–Weil rank at most one.



## 2 A generalization of *p*-Selmer-group Chabauty

In this section, we generalize the method of p-Selmer group Chabauty — originally developed by Poonen and Stoll to control rational points on a curve embedded inside its Jacobian — to arbitrary subvarieties of abelian varieties. Specifically, we prove Proposition 2, which gives a criterion for a subvariety of an abelian variety to contain only very few rational points.

Let  $J/\mathbb{Q}$  be a *g*-dimensional abelian variety,  $X \subset J$  a closed subvariety, and *p* a prime number. Let  $\overline{J(\mathbb{Q})} \subset J(\mathbb{Q}_p)$  be the *p*-adic closure of  $J(\mathbb{Q})$  in  $J(\mathbb{Q}_p)$ . Consider the following diagram (modeled on [PS14, (6.1)]):



In the diagram (1), the unlabeled maps in (1) are the natural ones, and the dashed arrows refer to partially defined maps. A partially defined map  $f: Y \dashrightarrow Z$  is a map defined on a subset  $S \subset Y$ . The image of such a map is defined to be the image of the subset S and is denoted by f(Y); the composition of two partially defined maps is again a partially defined map, defined on the largest subset where evaluation makes sense. The labeled maps log,  $\mathbb{P}$ ,  $\rho$ ,  $\delta$ ,  $\eta$ , and  $\sigma$  are defined as follows:

- Write  $T_0 J = \mathrm{H}^0(J, \Omega_J^1)^{\vee}$  for the tangent space at the identity of J, and write  $\log: J(\mathbb{Q}_p) \to T_0 J$  for the logarithm map; see [Bou98, III, §7.6] and [Zar96] for its definition. This is the unique *p*-adic Lie group morphism whose derivative equals the identity. It is a local diffeomorphism, and its kernel equals the (finite) torsion subgroup  $J(\mathbb{Q}_p)_{\mathrm{tors}} \subset J(\mathbb{Q}_p)$ . The image of log is a  $\mathbb{Z}_p$ -lattice in  $T_0 J$ ; we fix a basis of  $\mathrm{H}^0(J, \Omega_J^1)$  so that  $\log: J(\mathbb{Q}_p) \to T_0 J \simeq \mathbb{Q}_p^p$  has image exactly  $\mathbb{Z}_p^p$ .
- For a field k we let  $\mathbb{P}: k^g \smallsetminus \{0\} \to \mathbb{P}^{g-1}(k)$  be the usual homogenization map.
- We write  $\rho$  for the reduction map  $\mathbb{P}^{g-1}(\mathbb{Q}_p) \to \mathbb{P}^{g-1}(\mathbb{F}_p)$  or the composite  $\mathbb{Q}_p^g \smallsetminus \{0\} \xrightarrow{\mathbb{P}} \mathbb{P}^{g-1}(\mathbb{Q}_p) \to \mathbb{P}^{g-1}(\mathbb{F}_p)$ .
- The  $\mathbb{F}_p$ -vector space  $\operatorname{Sel}_p J$  is the *p*-Selmer group of J, and it comes equipped with a Kummer map  $\delta: J(\mathbb{Q})/pJ(\mathbb{Q}) \to \operatorname{Sel}_p J$ . If  $x \in \operatorname{Sel}_p J \subset \operatorname{H}^1(\mathbb{Q}, J[p])$ , then the local Galois cohomology class  $x_p$  at p lies in the image of the injective map  $\delta_p: J(\mathbb{Q}_p)/pJ(\mathbb{Q}_p) \to \operatorname{H}^1(\mathbb{Q}_p, J[p])$ . The map  $\eta$  is given by  $x \mapsto \delta_p^{-1}(x_p)$ . The map  $\sigma$  is the composition of  $\eta$  with  $\log \otimes \mathbb{F}_p$ .

All the squares and triangles in this diagram are commutative, whenever compositions are defined.

Observe that  $X(\mathbb{Q})$  lies in the intersection  $X(\mathbb{Q}_p) \cap \overline{J(\mathbb{Q})} \subset J(\mathbb{Q}_p)$ . In Chabauty's method, the objective is to bound  $X(\mathbb{Q})$  by controlling this intersection. The idea of *p*-Selmer group Chabauty is to achieve this control by pushing this intersection forward all the way to  $\mathbb{P}^{g-1}(\mathbb{F}_p)$  via the maps in the diagram (1). Specifically, we obtain the following result:

**Proposition 2.** Suppose  $\sigma$  is injective and  $\mathbb{P}\sigma(\operatorname{Sel}_p J) \cap \rho \log(X(\mathbb{Q}_p)) = \emptyset$ . Then  $X(\mathbb{Q}_p) \cap \overline{J(\mathbb{Q})} \subset J(\mathbb{Q}_p)[p']$ , where  $J(\mathbb{Q}_p)[p']$  denotes the (finite) subgroup of prime-to-p torsion elements of  $J(\mathbb{Q}_p)$ .

*Proof.* The proof is essentially identical to that of [PS14, Proposition 6.2], which never uses the assumption that X is a curve; we include the details for completeness. By assumption,  $\sigma$  is injective, so  $\sigma\delta$  is also injective. It then follows from (1) that  $\mu$  is injective too. Thus,  $\mu$  is an isomorphism, and the map  $\overline{J(\mathbb{Q})}/p\overline{J(\mathbb{Q})} \to \mathbb{F}_p^g$  is injective.

Suppose that the conclusion fails, and let  $P \in X(\mathbb{Q}_p) \cap \overline{J(\mathbb{Q})}$  be an element not contained in  $J(\mathbb{Q}_p)[p']$ . Then P is not infinitely p-divisible in  $J(\mathbb{Q}_p)$ , and hence also not infinitely p-divisible in  $\overline{J(\mathbb{Q})}$ . Thus, there is an element  $Q \in \overline{J(\mathbb{Q})}$  and an integer  $n \geq 0$  such that  $P = p^n Q$  and  $Q \notin p\overline{J(\mathbb{Q})}$ . The image  $\overline{Q}$  of Q in  $\overline{J(\mathbb{Q})}/p\overline{J(\mathbb{Q})}$  is nonzero, so its image under  $\log \otimes \mathbb{F}_p$  in  $\mathbb{F}_p^g$  is nonzero. Consequently,  $\mathbb{P}\sigma\delta\mu^{-1}(\overline{Q})$  is well-defined and lies in  $\mathbb{P}\sigma(\operatorname{Sel}_p J)$ . On the other hand,

$$\mathbb{P}\sigma\delta\mu^{-1}(\overline{Q}) = \rho\log(Q) = \rho\log(p^n Q) = \rho\log(P) \in \rho\log(X(\mathbb{Q}_p)),$$

contradicting our assumption that  $\mathbb{P}\sigma(\operatorname{Sel}_p J) \cap \rho \log(X(\mathbb{Q}_p)) = \emptyset$ .

## 3 A criterion for every rational and quadratic point to be expected

In this section, we specialize the content of §2 to the case of Jacobians of monic odd-degree hyperelliptic curves over  $\mathbb{Q}$ , and we obtain a criterion — namely, Corollary 5 — for every rational point and every quadratic point on such a curve to be expected.

We start slightly more generally and introduce some notation that we will use in the remainder of the paper. Let C be a hyperelliptic curve of genus  $g \ge 2$ . Denote its Jacobian variety by J. There is by definition a degree-2 map  $\pi: C \to \mathbb{P}^1$  defined over  $\mathbb{Q}$ , called the hyperelliptic map, which is unique up to automorphism of  $\mathbb{P}^1$ . We call the pullback along  $\pi$  of a  $\mathbb{Q}$ -point of  $\mathbb{P}^1$  a hyperelliptic divisor, and the linear equivalence class of such a divisor the hyperelliptic divisor class H. The associated linear system is denoted  $|H| := \mathbb{P}(\mathrm{H}^0(C, \mathcal{O}_C(H))) \simeq \mathbb{P}^1$ , and consists of divisors of the form  $\pi^*(t)$ , where t is a point of  $\mathbb{P}^1$ . (When  $C \in \mathcal{F}_g$ , a convenient choice for H is the class  $[2P_\infty]$ .) The symmetric square  $\mathrm{Sym}^2 C$  is a smooth, projective, and geometrically integral variety parametrizing

The symmetric square  $\operatorname{Sym}^2 C$  is a smooth, projective, and geometrically integral variety parametrizing effective divisors of degree 2 on C. We may therefore view |H| as a closed subscheme of  $\operatorname{Sym}^2 C$ . Let AJ:  $\operatorname{Sym}^2 C \to J$  be the Abel–Jacobi morphism sending an effective degree-2 divisor D to the divisor class [D] - H. Let

$$X := \mathrm{AJ}(\mathrm{Sym}^2 C) \tag{2}$$

be the scheme-theoretic image of  $\operatorname{Sym}^2 C$  under AJ. The tangent space of the point 0 in X has dimension g [ACGH85, Chapter IV, Proposition (4.2)], so if  $g \ge 3$ , then X has a singular point, resolved by the map AJ:  $\operatorname{Sym}^2 C \to X$ .

**Lemma 3.** The morphism AJ:  $\operatorname{Sym}^2 C \to J$  is birational onto its image X. It is an isomorphism above  $X \setminus \{0\}$  and the (scheme-theoretic) fiber above  $\{0\}$  is the closed subscheme  $|H| \subset \operatorname{Sym}^2 C$ .

*Proof.* The fiber above  $[E] \in J$  is the projective space of divisors  $D \in \text{Sym}^2 C$  in the linear system |E + H| by [ACGH85, Chapter IV, Lemma (1.1)]. Since |H| is the only positive dimensional degree-2 linear system, the lemma follows.

**Lemma 4.** Suppose that  $X(\mathbb{Q}) = \{0\}$ . Then  $C(\mathbb{Q})$  consists of at most one Weierstrass point, and every quadratic point on C maps to  $\mathbb{P}^1(\mathbb{Q})$  under  $\pi$ .

*Proof.* Using Lemma 3, the condition  $X(\mathbb{Q}) = \{0\}$  implies that  $(\text{Sym}^2 C)(\mathbb{Q}) = |H|(\mathbb{Q})$ . In other words, every  $\mathbb{Q}$ -rational effective degree-2 divisor on C is of the form  $\pi^*(t)$  for some  $t \in \mathbb{P}^1(\mathbb{Q})$ . One can check that this implies the conclusions of the lemma.

Applying Proposition 2 to our choice of X and using Lemma 4, we obtain the following criterion for the absence of unexpected rational and quadratic points on curves  $C \in \mathcal{F}_g$  in terms of the diagram (1):

**Corollary 5.** Let  $C \in \mathcal{F}_g$ . Suppose that:

•  $\sigma: \operatorname{Sel}_p J \to \mathbb{F}_p^g$  is injective;

- $\mathbb{P}\sigma(\operatorname{Sel}_p J) \cap \rho \log(X(\mathbb{Q}_p)) = \emptyset; and$
- $X(\mathbb{Q}_p) \cap J(\mathbb{Q}_p)[p'] = \{0\}.$

Then C has no unexpected rational or quadratic points.

## 4 Controlling the image $(\operatorname{Sym}^2 C)(\mathbb{Q}_2)$ under $\rho \log$

The purpose of this section is to construct a subfamily  $\mathcal{F}_g^{(2)} \subset \mathcal{F}_g$  of positive density for which (in the notation of §3)  $X(\mathbb{Q}_2) \cap J(\mathbb{Q}_2)[2'] = \{0\}$  and for which we can control the image  $\rho \log(X(\mathbb{Q}_2))$ .

In [PS14], which concerns rational points on C, the corresponding problem is to control the set  $\rho \log(C(\mathbb{Q}_2))$ . To do this, Poonen and Stoll consider a particular curve  $C_0/\mathbb{Q}_2$  — namely, the curve with long Weierstrass equation  $C_0: y^2 + y = x^{2g+1} + x + 1$  — and they prove for this choice of  $C_0$  that  $\#\rho \log(C_0(\mathbb{Q}_2)) = 1$ . They then separately prove that as C varies in the moduli space of monic odd hyperelliptic curves of genus g over  $\mathbb{Q}_2$ , the set  $\rho \log(C(\mathbb{Q}_2))$  is locally constant, from which it follows that for every  $g \geq 3$  a positive proportion of curves  $C \in \mathcal{F}_g$  have  $\#\rho \log(C(\mathbb{Q}_2)) = 1$ .

Here, we adopt a slightly different approach: we construct a subfamily  $\mathcal{F}_g^{(2)} \subset \mathcal{F}_g$ , defined by congruence conditions, such that the image  $\rho \log((\operatorname{Sym}^2 C)(\mathbb{Q}_2))$  can be explicitly bounded for all curves  $C \in \mathcal{F}_g^{(2)}$ , much as Poonen and Stoll did for the single curve  $C_0$ . All curves in these subfamilies have good reduction at 2, and their Jacobians all have trivial 2-torsion over both  $\mathbb{Q}_2$  and  $\mathbb{F}_2$ . Thus, while  $\mathcal{F}_g^{(2)}$  has positive density in  $\mathcal{F}_g$ , this density is exponentially small in g.

The curves in  $\mathcal{F}_g^{(2)}$  will be those that arise by completing the square in long Weierstrass equations considered in the following definition:

**Definition 6.** We say a monic polynomial  $h \in \mathbb{Z}_2[x]$  of degree 2g + 1 is good if it satisfies the following property: letting S be the set of exponents of the mod-2 reduction of h, and for each  $i \in \{0, 1, 2\}$ , letting  $S_i \subset S$  be the subset of exponents congruent to  $i \pmod{3}$ , we have  $S \supset \{0, 2g + 1\}, \#S_0 \equiv 0 \pmod{2}$ , and  $\#(S_1 \sqcup S_2) \equiv 1 \pmod{2}$ . For such an h, let  $C_h/\mathbb{Q}_2$  be the hyperelliptic curve with long Weierstrass model

$$y^2 + y = h(x).$$
 (3)

Let  $P_g = \{h(x) = x^{2g+1} + c_1 x^{2g} + \dots + c_{2g+1} \in \mathbb{Z}_2[x]\} = \mathbb{Z}_2^{2g+1}$  be the parameter space of monic polynomials of degree 2g + 1 over  $\mathbb{Z}_2$ , and let  $U_g \subset P_g$  be the open subset of good polynomials.

Let  $C = C_h$ , where  $h \in U_g$  is good. The model (3) has good reduction, hence defines a smooth proper model C of C over  $\mathbb{Z}_2$ . Let  $\mathcal{J} = \operatorname{Pic}^0_{\mathcal{C}/\mathbb{Z}_2}$  be the Néron model of the Jacobian J of C. We write  $P_{\infty} \in \mathcal{C}(\mathbb{Z}_2)$ for the unique point at infinity.

The next lemma records the useful properties satisfied by good curves:

**Lemma 7.** Let  $C/\mathbb{Q}_2$  be a hyperelliptic curve of the form  $C_h$  for some good  $h \in \mathbb{Z}_2[x]$ . Then:

- (a)  $J(\mathbb{Q}_2)[2] = \{0\} = \mathcal{J}(\mathbb{F}_2)[2].$
- (b)  $\mathcal{C}(\mathbb{F}_2) = \{P_{\infty}\}$  and  $\mathcal{C}(\mathbb{F}_4) = \{P_{\infty}, (0, \alpha), (0, \alpha + 1), (1, \alpha), (1, \alpha + 1)\}$ , where  $\alpha \in \mathbb{F}_4 \setminus \{1\}$  denotes a nontrivial third root of unity.
- (c)  $X(\mathbb{Q}_2) \cap J(\mathbb{Q}_2)[2'] = \{0\}$ , where X is defined by (2) and  $J(\mathbb{Q}_2)[2']$  is the prime-to-2 torsion subgroup of  $J(\mathbb{Q}_2)$ .

*Proof.* Completing the square on the left-hand side of (3), we obtain a short Weierstrass equation for C of the form  $y^2 = f(x) := h(x) + 1/4$ , thus realizing C has a monic odd-degree hyperelliptic curve.

To verify (a), note that the Newton polygon of f is the line segment from (0, -2) to (2g + 1, 0), which contains no lattice points, implying that f is irreducible over  $\mathbb{Q}_2$ . Consequently, we have  $J(\mathbb{Q}_2)[2] = 0$ . Since the hyperelliptic involution on  $\mathcal{C}_{\mathbb{F}_2}$  is given by  $(x, y) \mapsto (x, y + 1)$ , its only fixed point is  $P_{\infty} \in \mathcal{C}(\mathbb{F}_2)$ , implying that  $\mathcal{J}(\overline{\mathbb{F}}_2)[2] = 0$ , hence  $\mathcal{J}(\mathbb{F}_2)[2] = 0$ . The verification of (b) is a computation. To verify (c), note that the restriction of the reduction map red:  $J(\mathbb{Q}_2)[2'] \to \mathcal{J}(\mathbb{F}_2)$  is injective, so it suffices to prove that red $(X(\mathbb{Q}_2) \cap J(\mathbb{Q}_2)[2']) = \{0\}$ . Every element in red $(X(\mathbb{Q}_2) \cap J(\mathbb{Q}_2)[2'])$  is represented by a divisor of the form  $P_1 + P_2 - 2P_{\infty}$ , where either  $P_1, P_2 \in \mathcal{C}(\mathbb{F}_2)$ , or  $P_1, P_2$  form a pair of Galois conjugate points in  $\mathcal{C}(\mathbb{F}_4)$ . In both cases, the divisor class  $[P_1 + P_2 - 2P_{\infty}]$  is trivial by (b).

Lemma 7 allows us to choose a basis of differentials uniformly for all  $C_h$  such that the logarithm map is surjective. If  $h \in U_g$  and  $C = C_h$  is the hyperelliptic curve with equation (3), the change-of-variables s := 1/x and  $t := y/x^{g+1}$  applied to (3) yields the equation

$$t^{2} + s^{g+1}t = s^{2g+2}h(1/s).$$
(4)

Define

$$\omega_1 := \frac{dt}{\frac{\partial}{\partial s} \left( t^2 + s^{g+1}t - s^{2g+2}h(1/s) \right)},\tag{5}$$

and  $\omega_j := s^{j-1}\omega_1$  for each  $j \in \{2, \ldots, g\}$ . By the general theory of hyperelliptic curves,  $\omega_1, \ldots, \omega_g$  is a  $\mathbb{Z}_2$ -basis of  $\mathrm{H}^0(\mathcal{C}, \Omega^1_{\mathcal{C}/\mathbb{Z}_2})$ . By Lemma 7 in conjunction with [PS14, Lemma 10.1], the logarithm map log:  $J(\mathbb{Q}_2) \to \mathrm{H}^0(J, \Omega^1_J)^{\vee} \simeq \mathrm{H}^0(C, \Omega^1_C)^{\vee} \simeq \mathbb{Q}_2^g$  corresponding to this choice of basis satisfies  $\log(J(\mathbb{Q}_2)) = (2\mathbb{Z}_2)^g$ . Using this identification, we may consider the subset  $\rho \log(X(\mathbb{Q}_2)) \subset \mathbb{P}^{g-1}(\mathbb{F}_2)$  like we did in §2 and §3.

**Proposition 8.** As h varies in  $U_q$ , the subset  $\rho \log(X(\mathbb{Q}_2)) \subset \mathbb{P}^{g-1}(\mathbb{F}_2)$  is locally constant and satisfies

$$\#\rho \log(X(\mathbb{Q}_2)) \le 5.$$

Proof. Let  $h \in U_g$  be good and  $C = C_h$ . Since  $\rho \log(X(\mathbb{Q}_2)) = \rho \log(\operatorname{AJ}((\operatorname{Sym}^2 C)(\mathbb{Q}_2)))$ , it suffices to determine the latter set. Given a finite extension  $K/\mathbb{Q}_2$  with residue field k and an element  $x \in C(k)$ , let  $D_x(K)$  be the fiber of the reduction map  $C(K) \to C(k)$ . Similarly if  $x \in (\operatorname{Sym}^2 C)(k)$ , let  $D_x(K)$  be the fiber of the reduction map  $C(K) \to C(k)$ . Similarly if  $x \in (\operatorname{Sym}^2 C)(k)$ , let  $D_x(K)$  be the fiber of the reduction map  $C(K) \to C(k)$ . Similarly if  $x \in (\operatorname{Sym}^2 C)(k)$ , let  $D_x(K)$  be the fiber of the reduction map  $(\operatorname{Sym}^2 C)(K) \to (\operatorname{Sym}^2 C)(k)$  above x. Lemma 7(b) shows that  $(\operatorname{Sym}^2 C)(\mathbb{F}_2)$  consists of 3 elements, represented by the degree-2 divisors  $2P_{\infty}, (0, \alpha) + (0, \alpha + 1)$  and  $(1, \alpha) + (1, \alpha + 1)$ . We bound  $\rho \log(X(\mathbb{Q}_2))$  by computing  $\rho \log$  explicitly on each residue polydisk  $D_x(\mathbb{Q}_2)$  for  $x \in (\operatorname{Sym}^2 C)(\mathbb{F}_2)$ .

Residue polydisk centered at  $2P_{\infty}$ . Take a point  $P + Q \in D_{2P_{\infty}}(\mathbb{Q}_2)$ . There are two possibilities: either P, Q are both defined over  $\mathbb{Q}_2$ , or P, Q are conjugates over a quadratic extension of  $\mathbb{Q}_2$ . Let K denote the field of definition of P, and let  $\pi$  be a uniformizer for K. We use the model (4) of C. In that model, the point  $P_{\infty} \in \mathcal{C}(\mathbb{F}_2)$  has coordinates (s,t) = (0,0), and the hyperelliptic involution  $\iota: \mathcal{C} \to \mathcal{C}$  has the form  $\iota(s,t) = (s,s^{g+1}-t)$ . The coordinate  $t := y/x^{g+1}$  is a uniformizer at  $P_{\infty}$  and remains so when reduced mod  $\pi$ , so the assignment  $R \mapsto t(R)$  induces a bijection  $D_{P_{\infty}}(K) \simeq \pi \mathcal{O}_K$ .

We now compute the restriction of the logarithm map to  $D_{P_{\infty}}(K)$  explicitly as a g-tuple of power series in t. Using (4), we can expand s as a power series in t centered at  $P_{\infty}$ ; this expansion has  $\mathbb{Z}_2$ -coefficients and is of the form  $s = t^2 + 2ct^3 + \cdots$  for some  $c \in \mathbb{Z}_2$ . Substituting this expansion of s into (5), we find that  $\omega_1 = (1 + 0t + 0t^2 + 2c't^3 + \cdots)dt$  for some  $c' \in \mathbb{Z}_2$ , and hence that  $\omega_j = (t^{2j-2} + 2c(j-1)t^{2j-1} + \cdots)dt$ for each  $j \in \{1, \ldots, g\}$ . By the theory of Coleman integration [Col85, §II], if  $R \in D_{P_{\infty}}(K)$  has coordinate  $t \in \pi \mathcal{O}_K$ , then  $\log(R - P_{\infty}) = (\int_0^t \omega_1, \ldots, \int_0^t \omega_g)$ .

Denote the coordinates of the points  $P, Q, \iota(Q) \in D_{P_{\infty}}(K)$  by  $t_1, t_2, t_3 \in \pi \mathcal{O}_K$  respectively. Since  $[Q + \iota(Q) - 2P_{\infty}] = 0$  in  $J(\mathbb{Q}_2)$ , we have  $\log(P + Q - 2P_{\infty}) = \log(P - P_{\infty}) - \log(\iota(Q) - P_{\infty})$ , hence

$$\log(P+Q-2P_{\infty}) = \left((t_1-t_3)+\cdots, \frac{t_1^3-t_3^3}{3}+\cdots, \dots, \frac{t_1^{2g-1}-t_3^{2g-1}}{2g-1}+\cdots\right).$$
 (6)

Dividing each component on the right-hand side of (6) by  $t_1 - t_3$ , we deduce that  $\rho \log(P + Q - 2P_{\infty})$  is given by  $\rho(1 + \cdots, \cdots)$ ; here, the ellipses are used to abbreviate terms of the form

$$\frac{c''}{i+1} \cdot \left(t_1^i + t_1^{i-1}t_3 + \dots + t_1t_3^{i-1} + t_3^{i-1}\right),\tag{7}$$

where  $c'' \in \mathbb{Z}_2$  for all  $i \ge 1$  and  $c'' \in 2\mathbb{Z}_2$  when  $i \in \{1,3\}$ . For  $t_1, t_3 \in \pi \mathcal{O}_K$ , the valuation of the expression (7) is always positive. We conclude that the map  $\rho \log$  is constant on  $D_{2P_{\infty}}(\mathbb{Q}_2)$ , with value  $(1:0:\cdots:0)$ .

Residue polydisk above  $(0, \alpha) + (0, \alpha + 1)$ . In this case, we use the model (3). Let  $K := \mathbb{Q}_4$  be the unramified quadratic extension of  $\mathbb{Q}_2$ . Any point in  $D_{(0,\alpha)+(0,\alpha+1)}(\mathbb{Q}_2)$  is of the form  $P + \overline{P}$ , where  $P \in C(K)$  reduces to  $(0, \alpha)$  and  $\overline{P}$  is the  $\operatorname{Gal}(K/\mathbb{Q}_2)$ -conjugate of P. Let  $\gamma \in \mathcal{O}_K$  be an element with  $\gamma^2 + \gamma = h(0)$ ; such an element exists by Hensel's lemma and reduces to  $\alpha \in \mathbb{F}_4$ . Let  $P_0 := (0, \gamma) \in C(K)$ . Then the  $\operatorname{Gal}(K/\mathbb{Q}_2)$ -conjugate  $\overline{P}_0 = (0, -1 - \gamma) \in C(K)$  is in fact the image of  $P_0$  under the hyperelliptic involution  $\iota$ . The coordinate x is a uniformizer at both  $P_0$  and  $\overline{P}_0$ , giving identifications  $D_{(0,\alpha)}(K) \simeq 2\mathcal{O}_K$  and  $D_{(0,\alpha+1)}(K) \simeq 2\mathcal{O}_K$ .

By the general theory of hyperelliptic curves, the elements

$$\eta_1 := \frac{dx}{2y+1} = \frac{dy}{-h'(x)},\tag{8}$$

and  $\eta_j := x^{j-1}\eta_1$  for  $j \in \{2, \ldots, g\}$  form a  $\mathbb{Z}_2$ -basis of  $\mathrm{H}^0(\mathcal{C}, \Omega^1_{\mathcal{C}/\mathbb{Z}_2})$ . Using (3), we can expand y as a power series in x on  $D_{(0,\alpha)}(K)$  centered at  $P_0$ ; this expansion has  $\mathcal{O}_K$ -coefficients and constant term  $\gamma$ . Substituting this expansion of y into (8), we find a power series expansion of  $\eta_1/dx$  with  $\mathcal{O}_K$ -coefficients and constant coefficient  $(2\gamma + 1) \in \mathcal{O}_K^{\times}$ . Now if  $R \in D_{(0,\alpha)}(K)$  corresponds to  $x \in 2\mathcal{O}_K$ , then  $\phi(x) := \log(P - P_\infty) = \log(P_0 - P_\infty) + (\int_0^x \eta_1, \ldots, \int_0^x \eta_g)$ .

Let the points  $P \in D_{(0,\alpha)}(K)$  and  $\overline{P} \in D_{(0,\alpha+1)}(K)$  have coordinates  $x_1, x_2 \in 2\mathcal{O}_K$  respectively. Then  $x_2$  is the  $\operatorname{Gal}(K/\mathbb{Q}_2)$ -conjugate of  $x_1$ , and the hyperelliptic conjugate  $\iota(\overline{P}) \in D_{(0,\alpha)}(K)$  has coordinate  $x_2$ . Since the hyperelliptic involution acts as -1 on the Jacobian, we have  $\log(P + \overline{P} - 2P_{\infty}) = \log(P - P_{\infty}) - \log(\iota(\overline{P}) - P_{\infty}) = \phi(x_1) - \phi(x_2)$ , hence

$$\log(P + \overline{P} - 2P_{\infty}) = \left(\int_{0}^{x_{1}} \eta_{1} - \int_{0}^{x_{2}} \eta_{1}, \dots, \int_{0}^{x_{1}} \eta_{g} - \int_{0}^{x_{2}} \eta_{g}\right).$$
(9)

Each difference of integrals in the g-tuple on the right-hand side of (9) is a sum of terms of the form

$$\frac{c}{i+1} \cdot (x_1^{i+1} - x_2^{i+1})$$

where  $c \in \mathbb{Z}_2$ . For each  $j \in \{1, \ldots, g\}$ , the smallest value of *i* occurring in the  $j^{\text{th}}$  component is exactly j - 1, in which case  $c = 2\gamma + 1$  lies in  $\mathbb{Z}_2^{\times}$ . Dividing each component on the right-hand side of (9) by  $(2\gamma + 1) \cdot (x_1 - x_2)$ , we deduce that  $\rho \log(P + \overline{P} - 2P_{\infty}) = \rho(1 + \cdots, (x_1 + x_2)/2 + \cdots, \cdots)$ , where all the power series in the latter *g*-tuple are sums of terms of the form

$$\frac{c}{i+1} \cdot (x_1^i + x_1^{i-1}x_2 + \dots + x_1x_2^{i-1} + x_2^i), \tag{10}$$

and where once again,  $c \in \mathbb{Z}_2$  and for each  $j \in \{1, \ldots, g\}$ , the smallest value of i occurring in the  $j^{\text{th}}$  component is j-1. For  $x_1, x_2 \in 2\mathcal{O}_K$ , the valuation of the expression (10) is positive so long as  $i \geq 2$ . Therefore  $\rho \log(P + \overline{P} - 2P_{\infty}) = \rho(1, (x_1 + x_2)/2, 0, \cdots, 0)$ . We conclude that, in the basis  $\eta_1, \ldots, \eta_g$ , we have  $\rho \log(D_{(0,\alpha)+(0,\alpha+1)}(\mathbb{Q}_2)) = \{(1:0:0:\cdots:0), (1:1:0:\cdots:0)\}.$ 

Residue polydisk above  $(1, \alpha) + (1, \alpha + 1)$ . Under the transformation  $x \mapsto x - 1$ , the conditions on h in the proposition are preserved. Thus, the analysis for this case is identical to that of the previous case.

Putting the three cases together, we obtain  $\#\rho \log(X(\mathbb{Q}_2)) \leq 1+2+2=5$ . To show that  $\rho \log(X(\mathbb{Q}_2)) \subset \mathbb{P}^{g-1}(\mathbb{F}_2)$  is locally constant as h varies in  $U_g$ , it suffices to show this on each residue polydisk separately. This is obvious for  $D_{2P_{\infty}}(\mathbb{Q}_2)$ . For the residue disk  $D_{(0,\alpha)+(0,\alpha+1)}(\mathbb{Q}_2)$ , there exists a matrix  $A_h \in \operatorname{GL}_g(\mathbb{Z}_2)$  that transforms the basis  $\eta_1, \ldots, \eta_g$  of  $\operatorname{H}^0(\mathcal{C}, \Omega^1_{\mathcal{C}/\mathbb{Z}_2})$  into  $\omega_1, \ldots, \omega_g$ . Since the association  $h \mapsto A_h$  is continuous and  $\rho \log(D_{(0,\alpha)+(0,\alpha+1)}(\mathbb{Q}_2))$  is constant with respect to the basis  $\eta_1, \ldots, \eta_g$ ,  $\rho \log(D_{(0,\alpha)+(0,\alpha+1)}(\mathbb{Q}_2))$  is locally constant with respect to the basis  $\omega_1, \ldots, \omega_g$  as  $h \in U_g$  varies. The argument for  $D_{(1,\alpha)+(1,\alpha+1)}(\mathbb{Q}_2)$  is analogous.

Let  $\mathcal{F}_g^{(2)} \subset \mathcal{F}_g$  be the subset of polynomials f of the form  $4^{2g+1}(h(x/4) + 1/4)$  for some  $h \in U_g \cap \mathbb{Z}[x]$ . Completing the square shows that monic odd hyperelliptic curves with equation  $y^2 = f(x)$  with  $f \in \mathcal{F}_g^{(2)}$  are isomorphic to hyperelliptic curves with of the form (3) for some good  $h \in U_g$ . **Lemma 9.** The subfamily  $\mathcal{F}_g^{(2)} \subset \mathcal{F}_g$  is defined by congruence conditions modulo  $2^{4g+2}$  and has density  $2^{-4g^2-6g-5}$ .

Proof. Equip the parameter space  $P_g = \mathbb{Z}_2^{2g+1}$  of all monic polynomials in  $\mathbb{Z}_2[x]$  of degree 2g + 1 with the probability Haar measure. A combinatorial calculation shows that the open subset of good polynomials  $U_g \subset P_g$  has measure 1/8. On the other hand, the  $\mathbb{Z}_2$ -linear map  $h \mapsto 4^{2g+1}h(x/4)$  on  $P_g$  has determinant  $4 = 4^{2g^2+3g+1}$ , so the subset of  $f \in P_g$  of curves of the form  $4^{2g+1}h(x/4) + 4^{2g}$  for some  $h \in P_g$  has measure  $4^{-2g^2-3g-1}$ . We conclude that the measure of the subset  $\{4^{2g+1}h(x/4) + 4^{2g} \mid h \in U_g\} \subset P_g$  is  $(1/8) \times 4^{-2g^2-3g-1} = 2^{-4g^2-6g-5}$ , so the density of  $\mathcal{F}_g^{(2)}$  is also  $2^{-4g^2-6g-5}$ .

## 5 Proof of Theorem 1

The proof of Theorem 1 is completed by the next proposition. Just as in [PS14], a crucial ingredient in the proof is an equidistribution result of Bhargava–Gross [BG13, Theorem 12.4]. If  $S \subset T \subset \mathcal{F}_g$  are subsets, the relative density of S in T is by definition the quantity  $\lim_{X\to\infty} \#(S \cap \mathcal{F}_{g,X})/\#(T \cap \mathcal{F}_{g,X})$ , whenever it exists. Define the relative lower and upper density of S in T by replacing the limit by liminf and limit sup, respectively.

**Proposition 10.** The relative lower density of the set

$$\{C \in \mathcal{F}_a^{(2)} \mid C \text{ has no unexpected rational or quadratic points}\}$$
(11)

in  $\mathcal{F}_g^{(2)}$  is at least  $1 - 6 \times 2^{1-g}$ . Consequently, if  $g \ge 4$ , a positive proportion of curves in  $\mathcal{F}_g$  have no unexpected rational or quadratic points.

*Proof.* This is a standard adaptation of [PS14, Proposition 8.13] to our setting. Proposition 8 shows that  $\mathcal{F}_{g}^{(2)}$  is partitioned into finitely many subsets  $\mathcal{G}_{1}, \ldots, \mathcal{G}_{m}$ , each defined by congruence conditions modulo a power of 2, such that the subset  $\rho \log(X(\mathbb{Q}_{2})) \subset \mathbb{P}^{g-1}(\mathbb{F}_{2})$  is constant when *h* varies in  $\mathcal{G}_{i}$ . Fix such an  $i \in \{1, \ldots, m\}$ . If  $C \in \mathcal{G}_{i}$ , then  $J(\mathbb{Q}_{2})[2] = 0$  by Lemma 7(*a*), so the logarithm map defined using the basis (5) induces an isomorphism  $J(\mathbb{Q}_{2})/2J(\mathbb{Q}_{2}) \simeq \mathbb{F}_{2}^{g}$ . Write  $\sigma$ : Sel<sub>2</sub>  $J \to \mathbb{F}_{2}^{g}$  for the corresponding composition Sel<sub>2</sub>  $J \to J(\mathbb{Q}_{2})/2J(\mathbb{Q}_{2}) \to \mathbb{F}_{2}^{g}$  considered in §3. Bhargava–Gross have shown [BG13, Theorem 12.4] that nontrivial elements of Sel<sub>2</sub> J equidistribute under  $\sigma$ : when C varies in  $\mathcal{G}_{i}$  and  $I \subset \mathbb{F}_{2}^{g}$  is a subset, they show that the average size of { $s \in \text{Sel}_{2} J \setminus \{0\}$ :  $\sigma(s) \in I$ } is at most  $\#I \times 2^{1-g}$ . It follows that the relative upper density of curves  $C \in \mathcal{G}_{i}$  such that { $s \in \text{Sel}_{2} J \setminus \{0\}$ :  $\sigma(s) \in I$ } is nonempty is at most  $\#I \times 2^{1-g} \ge 1 - 6 \times 2^{1-g}$ . The third condition of Corollary 5 is always satisfied for  $C \in \mathcal{F}_{g}^{(2)}$  by Lemma 7(*c*). We conclude that the intersection of the set (11) with  $\mathcal{G}_{i}$  has relative lower density at least  $1 - 6 \times 2^{1-g}$  in  $\mathcal{F}_{g}^{(2)}$ . Thus, the lower density of curves in  $\mathcal{F}_{g}$  that have no unexpected rational or quadratic points is at least 1

Thus, the lower density of curves in  $\mathcal{F}_g$  that have no unexpected rational or quadratic points is at least  $(1-6\times 2^{1-g})\times (\text{density of }\mathcal{F}_g^{(2)}) = (1-6\times 2^{1-g})\times 2^{-4g^2-6g-5}$  by Lemma 9. This is positive when  $g \ge 4$ .
