SPLITTINGS OF TORIC IDEALS OF GRAPHS

ABSTRACT. Let G be a simple graph on the vertex set $\{v_1, \ldots, v_n\}$. An algebraic object attached to G is the toric ideal I_G . We say that I_G is subgraph splittable if there exist subgraphs G_1 and G_2 of G such that $I_G = I_{G_1} + I_{G_2}$, where both I_{G_1} and I_{G_2} are not equal to I_G . We show that I_G is subgraph splittable if and only if it is edge splittable. We also prove that the toric ideal of a complete bipartite graph is not subgraph splittable. In contrast, we show that the toric ideal of a complete graph K_n is always subgraph splittable when $n \ge 4$. Additionally, we show that the toric ideal of K_n has a minimal splitting if and only if $4 \le n \le 5$. Finally, we prove that any minimal splitting of I_G is also a reduced splitting.

1. INTRODUCTION

Let $A = \{\mathbf{a}_1, \ldots, \mathbf{a}_m\}$ be a subset of \mathbb{N}^n such that A does not contain the zero vector. Consider the polynomial ring $K[x_1, \ldots, x_m]$ over any field K. We grade $K[x_1, \ldots, x_m]$ by the semigroup $\mathbb{N}A = \{l_1\mathbf{a}_1 + \cdots + l_m\mathbf{a}_m\}$ setting $\deg_A(x_i) = \mathbf{a}_i$ for $i = 1, \ldots, m$. The Adegree of a monomial $\mathbf{x}^{\mathbf{u}} = x_1^{u_1} \cdots x_m^{u_m}$ is defined by $\deg_A(\mathbf{x}^{\mathbf{u}}) = u_1\mathbf{a}_1 + \cdots + u_m\mathbf{a}_m \in \mathbb{N}A$. The A-fiber of a vector $\mathbf{b} \in \mathbb{N}^n$ is the set of all monomials in $K[x_1, \ldots, x_m]$ with A-degree equal to \mathbf{b} . The toric ideal I_A is the prime ideal generated by all the binomials $\mathbf{x}^{\mathbf{u}} - \mathbf{x}^{\mathbf{v}}$ such that $\deg_A(\mathbf{x}^{\mathbf{u}}) = \deg_A(\mathbf{x}^{\mathbf{v}})$.

A recent direction in the theory of toric ideals is to decide when I_A is splittable, see [5, 6, 7]. The toric ideal I_A is *splittable* if it has a toric splitting i.e. if there exist toric ideals I_{A_1}, I_{A_2} such that $I_A = I_{A_1} + I_{A_2}$ and $I_{A_i} \neq I_A$, for all $1 \leq i \leq 2$. To every simple graph G one can associate the toric ideal I_G . In [5] G. Favacchio, J. Hofscheier, G. Keiper, and A. Van Tuyl consider the aforementioned problem for the toric ideal I_G , namely they study when I_G has a toric splitting of the form $I_G = I_{G_1} + I_{G_2}$, where $I_{G_i}, 1 \leq i \leq 2$, is the toric ideal of a subgraph G_i of G. More precisely, given a graph G and an even cycle C, they consider the graph H which is formed by identifying any edge of G with an edge of C. They show [5, Theorem 3.7] that $I_H = I_G + I_C$ is a splitting of I_H . They also prove [5, Corollary 4.8] that if G_1 and G_2 form a splitting of G along an edge e and at least one of G_1 or G_2 is bipartite, then $I_G = I_{G_1} + I_{G_2}$ is a splitting of I_G . Moreover, when I_G has such a splitting, they show [5, Theorem 4.11] how the graded Betti numbers of I_G are related with those of I_{G_1} and I_{G_2} . P. Gimenez and H. Srinivasan showed [6, Theorem 3.4] that if G_1 and G_2 form a splitting of G along an edge e and at least one only if at least one of G_1 or G_2 is bipartite.

This paper aims to partially answer [5, Question 5.1], namely for what graphs G can we find G_1 and G_2 so that their respective toric ideals satisfy $I_G = I_{G_1} + I_{G_2}$? More generally, can we classify when I_G is a splittable toric ideal in terms of G? We give a complete answer to the latter question in the case that both G_1, G_2 are subgraphs of G. We call splittings

like that subgraph splittings and the ideal I_G is called subgraph splittable. Note that there may be splittings of graphs G which are not subgraph splittings, see Remark 4.9. Our approach is based on the graphs $G \setminus e$ and G_S^e introduced in section 2, where e is an edge of G and S is a minimal system of binomial generators of I_G . We show that I_G is subgraph splittable if and only if there is an edge e of G and a minimal generating set of binomials S of I_G such that $I_G = I_{G_S^e} + I_{G \setminus e}$ is a splitting, see Theorem 2.10. As an application of our results, we prove that the toric ideal of a complete bipartite graph is not subgraph splittable (see Corollary 2.13) and the toric ideal of the suspension of a cycle of length $n \geq 3$ is subgraph splittable if and only if either n = 4 or n is odd, see Theorem 2.14. In section 3 we study the case that G coincides with the complete graph K_n on nvertices. We show that I_{K_n} is subgraph splittable if and only if $n \geq 4$, see Theorem 3.1. Moreover, we introduce minimal splittings and show (Theorem 3.10) that I_{K_n} does not have a minimal splitting for $n \geq 6$. In section 4 we define reduced splittings of toric ideals and prove that every minimal splitting of I_G is also reduced, see Theorem 4.7.

2. Edge splittings

In this section, we first collect important notations and definitions used in the paper. For unexplained terminology in graph theory, we refer to [10]. Let G be a finite, connected and undirected graph having no loops and no multiple edges on the vertex set V(G) = $\{v_1, \ldots, v_n\}$, and let $E(G) = \{e_1, \ldots, e_m\}$ be the set of edges of G. Two edges of G are called *adjacent* if they share a common vertex. To each edge $e = \{v_i, v_j\} \in E(G)$, we associate the vector $\mathbf{a}_e \in \{0, 1\}^n$ defined as follows: the *i*th entry is 1, the *j*th entry is 1, and the remaining entries are zero. By I_G we denote the toric ideal I_{A_G} in $K[e_1, \ldots, e_m]$, where $A_G = \{\mathbf{a}_e | e \in E(G)\} \subset \mathbb{N}^n$.

A walk of length q of G connecting $v_1 \in V(G)$ with v_{q+1} is a finite sequence of the form $w = (\{v_1, v_2\}, \{v_2, v_3\}, \ldots, \{v_{q-1}, v_q\}, \{v_q, v_{q+1}\})$ with each $\{v_i, v_{i+1}\} \in E(G), 1 \leq i \leq q$. An even (respectively, odd) walk is a walk of even (respectively, odd) length. The walk w is called *closed* if $v_{q+1} = v_1$. A cycle is a closed walk

$$w = (\{v_1, v_2\}, \{v_2, v_3\}, \dots, \{v_{q-1}, v_q\}, \{v_q, v_1\})$$

with $q \geq 3$ and $v_i \neq v_j$, for every $1 \leq i < j \leq q$. A *cut vertex* is a vertex of G whose removal increases the number of connected components of the remaining subgraph. A graph is called *biconnected* if it is connected and does not contain a cut vertex. A *block* is a maximal biconnected subgraph of G.

Given an even closed walk $w = (e_{i_1}, e_{i_2}, \ldots, e_{i_{2q}})$ of G, we write B_w for the binomial $B_w = \prod_{k=1}^q e_{i_{2k-1}} - \prod_{k=1}^q e_{i_{2k}} \in I_G$. By [13, Proposition 10.1.5] the ideal I_G is generated by all the binomials B_w , where w is an even closed walk of G. We say that w is a *primitive walk* if the corresponding binomial B_w is primitive. Recall that given a set of vectors $A \subset \mathbb{N}^n$, the binomial $\mathbf{x}^{\mathbf{u}} - \mathbf{x}^{\mathbf{v}}$ in I_A is called *primitive* if there exists no other binomial $\mathbf{x}^{\mathbf{w}} - \mathbf{x}^{\mathbf{z}} \in I_A$ such that $\mathbf{x}^{\mathbf{w}}$ divides $\mathbf{x}^{\mathbf{u}}$ and $\mathbf{x}^{\mathbf{z}}$ divides $\mathbf{x}^{\mathbf{v}}$. Every minimal binomial generator of I_A is primitive, see [11].

Every even primitive walk $w = (e_{i_1}, e_{i_2}, \ldots, e_{i_{2q}})$ partitions the set of edges of w in the two sets $E_1 = \{e_{i_j} | j \text{ odd}\}$ and $E_2 = \{e_{i_j} | j \text{ even}\}$. The edges of E_1 are called *odd edges* of w and those of E_2 even. A *sink* of a block B is a common vertex of two odd or two even edges of the primitive walk w which belongs to B. The primitive walk w is called *strongly primitive* if it has no two sinks with distance one in any cyclic block.

Let $w = (e_1, e_2, \ldots, e_{2q})$ be an even primitive walk and $f = \{v_i, v_j\}$ be a chord of w with i < j, namely an edge $f = \{v_i, v_j\}$ of G such that $f \notin E(w)$. Then f breaks w in two

walks: $w_1 = (e_1, \ldots, e_{i-1}, f, e_j, \ldots, e_{2q})$ and $w_2 = (e_i, \ldots, e_{j-1}, f)$. The chord f is called *bridge* of w if there exist two different blocks B_i , B_j of w such that $v_i \in B_i$ and $v_j \in B_j$. The chord f is called *even* (respectively *odd*) if it is not a bridge and breaks w in two even walks (respectively odd).

Let $f = \{v_i, v_j\}$ be an odd chord of w with i < j and $f' = \{v_k, v_l\}$ be another odd chord of w with k < l. We say that the odd chords f and f' cross effectively in w if k - i is odd and either i < k < j < l or k < i < l < j. We call an F_4 of the walk w a cycle (e, f, e', f')of length four which consists of two edges e, e' of the walk w both odd or both even, and two odd chords f and f' which cross effectively in w. We say that the odd chords f, f'cross strongly effectively in w if they cross effectively and they do not form an F_4 in w.

A binomial $B_w \in I_G$ is called *minimal* if it belongs to a minimal system of binomial generators of I_G . Since I_G is homogeneous, the graded version of Nakayama's Lemma implies that every minimal system of generators of I_G has the same cardinality.

The next theorem provides a characterization for the minimal binomials of I_G .

Theorem 2.1. ([10, Theorem 4.13]) Let w be an even closed walk of G. Then B_w is a minimal binomial if and only if

- (1) w is strongly primitive,
- (2) all the chords of w are odd and there are not two of them which cross strongly effectively and
- (3) no odd chord crosses an F_4 of the walk w.

A binomial $B_w \in I_G$ is called *indispensable* if every system of binomial generators of I_G contains B_w or $-B_w$. The next theorem provides a characterization for the indispensable binomials of I_G .

Theorem 2.2. ([10, Theorem 4.14]) Let w be an even closed walk of G. Then B_w is an indispensable binomial if and only if w is a strongly primitive walk, all the chords of w are odd and there are not two of them that cross effectively.

It follows from Theorems 2.1, 2.2 that the binomial B_w is not indispensable due to the existence of F_4 's in the walk w. Moreover, a minimal binomial B_w of I_G is indispensable if and only if the walk w does not have any F_4 .

Note that there may exist a subgraph H of the graph G such that $I_H = I_G$. This can happen when there are edges in G that are not used in any walk w such that B_w is a minimal binomial of I_G .

Given an edge e of G, we denote by $G \setminus e$ the graph with the same vertex set as G and whose edge set consists of all edges of G except e. For any set $F \subset E(G)$ of edges of G, we use $G \setminus F$ to denote the subgraph of G containing the same vertices as G but with all the edges of F removed.

Let $S = \{B_{w_1}, B_{w_2}, \ldots, B_{w_r}\}$ be a minimal generating set of I_G . Given an edge e of G, we define G_S^e to be the subgraph of G on the vertex set

$$V(G_S^e) = \bigcup_{1 \le i \le r \text{ and } e \in E(w_i)} V(w_i)$$

with edges

$$E(G_S^e) = \bigcup_{1 \le i \le r \text{ and } e \in E(w_i)} E(w_i).$$

Thus to form the graph G_S^e one needs first to find all binomials $B_{w_i} \in S$, $1 \le i \le r$, such that e is an edge of the walk w_i . Then we take all vertices and edges of such walks.

We use the symbol G_S^e to emphasize that the graph depends not only on the edge e but also on the minimal system of binomial generators S, see Example 2.3. For a toric ideal I_G with a unique minimal system of binomial generators S, we will simply write G^e instead of G_S^e .

Example 2.3. Recall that the complete graph K_n is the graph with n vertices in which each vertex is connected to every other vertex. Let $G = K_4$ be the complete graph on the vertex set $\{v_1, \ldots, v_4\}$. Let $w_1 = (\varepsilon_{12}, \varepsilon_{23}, \varepsilon_{34}, \varepsilon_{14}), w_2 = (\varepsilon_{12}, \varepsilon_{24}, \varepsilon_{34}, \varepsilon_{13})$ and $w_3 = (\varepsilon_{23}, \varepsilon_{13}, \varepsilon_{14}, \varepsilon_{24}),$ where $\varepsilon_{ij} = \{v_i, v_j\}$ for $1 \le i < j \le 4$. Then $S = \{B_{w_1} = \varepsilon_{12}\varepsilon_{34} - \varepsilon_{23}\varepsilon_{14}, B_{w_2} = \varepsilon_{12}\varepsilon_{34} - \varepsilon_{24}\varepsilon_{13}\}$ and $T = \{B_{w_1}, B_{w_3} = \varepsilon_{23}\varepsilon_{14} - \varepsilon_{13}\varepsilon_{24}\}$ are minimal generating sets of I_G . Let $e = \varepsilon_{23}$, then G_S^e is the cycle given by the walk w_1 while G_T^e is the whole graph G.

Theorem 2.4. Let G be a graph and e be an edge of G. Let $S = \{B_{w_1}, B_{w_2}, \ldots, B_{w_r}\}$ be a minimal generating set of I_G , then $I_G = I_{G_S^e} + I_{G \setminus e}$.

Proof. We have that $G \setminus e \subset G$ and $G_S^e \subset G$, so $I_{G \setminus e} \subset I_G$ and $I_{G_S^e} \subset I_G$. Thus $I_{G_S^e} + I_{G \setminus e} \subset I_G$. Let B_{w_i} , $1 \leq i \leq r$, be a minimal binomial in S. Then there are two cases:

- (1) $e \in E(w_i)$. Then B_{w_i} belongs to the ideal $I_{G_S^e}$.
- (2) $e \notin E(w_i)$. Then B_{w_i} belongs to the ideal $I_{G \setminus e}$.

Consequently $I_G \subset I_{G_S^e} + I_{G \setminus e}$.

Example 2.5. We return to Example 2.3. We have that $I_{G_S^e} = \langle B_{w_1} \rangle$ and $I_{G_T^e} = I_G$. Also $G \setminus e$ is the graph with edges $\varepsilon_{12}, \varepsilon_{34}, \varepsilon_{14}, \varepsilon_{13}, \varepsilon_{24}$, thus $I_{G \setminus e} = \langle B_{w_2} \rangle$. Then $I_G = I_{G_S^e} + I_{G \setminus e}$ is a splitting of I_G , while $I_G = I_{G_T^e} + I_{G \setminus e}$ is not a splitting of I_G since $I_{G_T^e} = I_G$.

Definition 2.6. A subgraph splitting $I_G = I_{G_1} + I_{G_2}$ of I_G is called edge splitting if there exist an edge e of G and a minimal generating set S of I_G such that $G_1 = G_S^e$ and $G_2 = G \setminus e$ or $G_1 = G \setminus e$ and $G_2 = G_S^e$. The toric ideal I_G is called edge splittable if there exists an edge splitting of I_G .

Remark 2.7. It is not necessary for all subgraph splittings (if any) of the toric ideal of a graph to be edge splittings. Consider the complete graph K_5 on the vertex set $\{v_1, \ldots, v_5\}$. Let $\varepsilon_{ij} = \{v_i, v_j\}$ for $1 \leq i < j \leq 5$. Consider the subgraphs $G_1 = K_5 \setminus \{\varepsilon_{12}, \varepsilon_{34}\}$ and $G_2 = K_5 \setminus \{\varepsilon_{14}, \varepsilon_{23}\}$ of K_5 . We have that $S = \{\varepsilon_{13}\varepsilon_{24} - \varepsilon_{14}\varepsilon_{23}, \varepsilon_{14}\varepsilon_{25} - \varepsilon_{15}\varepsilon_{24}, \varepsilon_{23}\varepsilon_{45} - \varepsilon_{24}\varepsilon_{35}, \varepsilon_{13}\varepsilon_{25} - \varepsilon_{15}\varepsilon_{23}, \varepsilon_{13}\varepsilon_{45} - \varepsilon_{15}\varepsilon_{24}, \varepsilon_{12}\varepsilon_{35} - \varepsilon_{13}\varepsilon_{25}\}$ is a generating set of I_{G_1} and $T = \{\varepsilon_{12}\varepsilon_{34} - \varepsilon_{13}\varepsilon_{24}, \varepsilon_{24}\varepsilon_{35} - \varepsilon_{25}\varepsilon_{34}, \varepsilon_{13}\varepsilon_{45} - \varepsilon_{15}\varepsilon_{34}, \varepsilon_{12}\varepsilon_{45} - \varepsilon_{15}\varepsilon_{24}, \varepsilon_{12}\varepsilon_{35} - \varepsilon_{13}\varepsilon_{25}\}$ is a generating set of I_{G_2} . Also, $S \cup T$ is a generating set of I_{K_5} and $I_{G_i} \neq I_{K_5}$ for all $1 \leq i \leq 2$, so $I_{K_5} = I_{G_1} + I_{G_2}$ is a splitting of I_{K_5} which is not an edge splitting. Note that both G_1, G_2 cannot be written in the form $K_5 \setminus e$.

Next two Theorems provide a necessary and sufficient condition for a toric ideal I_G to be subgraph splittable in terms of the graph G.

Theorem 2.8. The ideal I_G is edge splittable if and only if there is a minimal system of binomial generators $S = \{B_{w_1}, \ldots, B_{w_r}\}$ of I_G with $r \ge 2$ and an edge $e \in E(w_i)$, $1 \le i \le r$, such that $I_{G_S^e} \ne I_G$.

Proof. (\Longrightarrow) Suppose that the ideal I_G is edge splittable, then there exist a minimal system of binomial generators $S = \{B_{w_1}, \ldots, B_{w_r}\}$ of I_G with $r \ge 2$ and an edge e of G such that $I_G = I_{G_S^e} + I_{G \setminus e}$ is a splitting. Thus $I_{G \setminus e} \ne I_G$, so there is $B_{w_i} \in I_G$, $1 \le i \le r$, such that $B_{w_i} \notin I_{G \setminus e}$ and therefore $e \in E(w_i)$.

(\Leftarrow) Suppose that there is a minimal system of binomial generators $S = \{B_{w_1}, \ldots, B_{w_r}\}$ of I_G with $r \ge 2$ and an edge $e \in E(w_i)$, $1 \le i \le r$, such that $I_{G_S^e} \ne I_G$. Then from Theorem 2.4 we have that $I_G = I_{G_S^e} + I_{G \setminus e}$. Since $e \in E(w_i)$, we have that $B_{w_i} \notin I_{G \setminus e}$ and therefore $I_{G \setminus e} \ne I_G$. From the hypothesis, it holds that $I_{G_S^e} \ne I_G$. Consequently, I_G is edge splittable.




FIGURE 1. The graph G_8

Example 2.9. Let P_n be the graph with 2n + 1 vertices: the *n* vertices of a regular *n*-gon, the *n* midpoints of the edges of the polygon and the center of the polygon. The graph P_n has 3n edges: the *n* radii R_i of the inscribed circle in the polygon corresponding to the midpoints of the edges of the polygon and the 2n segments l_i, r_i joining the vertices of the polygon to the two adjacent midpoints. Let *e* be a new edge attached to the center of the polygon. To each one of the *n* radii of the inscribed circle in the polygon and the edge *e* we attach two edges e_i, R'_i to create *n* cycles (e, R_i, e_i, R'_i) of length 4. Let G_n be the resulting roundabout graph with 3n + 2 vertices and 5n + 1 edges.




FIGURE 2. The graph $G_8 \setminus e$




FIGURE 3. The graph G_8^e

In Figure 1 we plot the graph G_8 with 26 vertices and 41 edges. Since G_n is bipartite, we have, from [8, Theorem 2.3], that I_{G_n} has a unique minimal system of generators consisting of all binomials B_w , where w is an even cycle with no chords. The graph G_n has n cycles with no chords of the form (e, R_i, e_i, R'_i) , n cycles of the form (R_i, l_i, r_i, R_{i-1}) , 1 cycle of the form $(l_1, r_1, l_2, r_2, \ldots, l_n, r_n)$ and $2\binom{n}{2}$ cycles of two forms, namely $(R'_i, e_i, r_i, l_i, r_{i-1}, \ldots, e_j, R'_j)$ and $(R'_i, e_i, l_{i+1}, r_{i+1}, \ldots, e_j, R'_j)$, where $i, j \in \{1, \cdots, n\}$, i-1 equals n when i = 1 and i+1 equals 1 when i = n. Thus G_n has exactly $2n+1+2\binom{n}{2}$ cycles without a chord. Note that G_8 has exactly 73 cycles with no chords, see Figure 1. We plot in Figure 2 the graph $G_8 \setminus e$ and in Figure 3 the graph G_8^e . Note that the toric ideal of the graph $G_8 \setminus e$ has 93 minimal binomials, while the toric ideal of G_8^e has 8 minimal binomials. In general, $I_{G_n \setminus e}$ has $n + 3\binom{n}{2} + 1$ minimal binomials of the form $(R_i, l_i, r_i, R_{i-1}), 1$ cycle of the form $(l_1, r_1, l_2, r_2, \ldots, l_n, r_n), 2\binom{n}{2}$ cycles of two forms, namely $(R'_i, e_i, r_i, l_i, r_{i-1}, \ldots, e_j, R'_j)$ and $(R'_i, e_i, l_{i+1}, r_{i+1}, \ldots, e_j, R'_j),$ and $\binom{n}{2}$ cycles which correspond to cycles $(R_i, e_i, R'_i, R'_j, e_j, R_j)$ in $G_n \setminus e$ of length 6 that in the graph G_n had

e as an even chord. The ideal $I_{G_n^e}$ has n minimal binomials corresponding to the cycles (e, R_i, e_i, R'_i) . It follows from Theorem 2.8 that $I_{G_n} = I_{G_n^e} + I_{G \setminus e}$ is an edge splitting.

Next we state and prove the main result of this article, namely if the toric ideal of a graph has a subgraph splitting then it has also an edge splitting.

Theorem 2.10. The toric ideal I_G is subgraph splittable if and only if it is edge splittable.

Proof. (\Leftarrow) If I_G is edge splittable, then $I_G = I_{G_S^e} + I_{G \setminus e}$ is a splitting of I_G , and therefore it is subgraph splittable.

(\Longrightarrow) Suppose that I_G is subgraph splittable and let $I_G = I_{G_1} + I_{G_2}$ be a subgraph splitting of I_G . Notice that $I_{G_1} \subsetneq I_G$ and $I_{G_2} \gneqq I_G$. Let $\{f_1, \ldots, f_s\}$ be a binomial generating set

of I_{G_1} and $\{g_1, \ldots, g_t\}$ be a binomial generating set of I_{G_2} . Then $\{f_1, \ldots, f_s, g_1, \ldots, g_t\}$ is a generating set of I_G , therefore it contains a minimal binomial generating set $S = \{B_{w_1}, \ldots, B_{w_r}\}$ of I_G , since toric ideals of graphs are homogeneous. Note that $r \ge 2$, since I_{G_1} and I_{G_2} are nonzero ideals. But $S \subset \{f_1, \ldots, f_s, g_1, \ldots, g_t\}$, so each $B_{w_i}, 1 \le i \le r$, belongs to at least one of I_{G_1}, I_{G_2} . If for every $1 \le i \le r$ it holds that $B_{w_i} \in I_{G_2}$, then $I_{G_2} = I_G$ a contradiction. Thus there exists $1 \le i \le r$ such that $B_{w_i} \in I_{G_1}$ and $B_{w_i} \notin I_{G_2}$, so there is $e \in E(w_i)$ such that $e \notin E(G_2)$. For every even closed walk w_j such that $e \in E(w_j)$ we have that $B_{w_j} \in I_{G_1}$, thus $I_{G_S} \subset I_{G_1}$ and therefore $I_{G_S} \ne I_G$ since $I_{G_1} \subsetneq I_G$. By Theorem 2.8 the toric ideal I_G is edge splittable. \Box

Example 2.11. Consider the graph G on the vertex set $\{v_1, \ldots, v_{10}\}$ with edges $e_1 = \{v_1, v_2\}, e_2 = \{v_2, v_3\}, e_3 = \{v_3, v_4\}, e_4 = \{v_4, v_5\}, e_5 = \{v_5, v_6\}, e_6 = \{v_6, v_7\}, e_7 = \{v_7, v_8\}, e_8 = \{v_8, v_9\}, e_9 = \{v_9, v_{10}\}, e_{10} = \{v_1, v_{10}\}, e_{11} = \{v_1, v_5\}, e_{12} = \{v_2, v_6\}$ and $e_{13} = \{v_6, v_8\}$. Then $S = \{e_{1e5} - e_{11e12}, e_{1e9e13} - e_{8e_{10}e_{12}}, e_{5e_{8}e_{10}} - e_{9e_{11}e_{13}}, e_{2e_{4}e_{6}e_{13}} - e_{3e_{5}e_{7}e_{12}}, e_{2e_{4}e_{6}e_{8}e_{10}} - e_{3e_{7}e_{9}e_{11}e_{12}}\}$ is a minimal generating set of I_G . For the edge $f = e_1$ of G we have that $I_{G\setminus f} = \langle e_5e_{8}e_{10} - e_{9e_{11}e_{13}}, e_{2e_{4}e_{6}e_{13}} - e_{3e_{5}e_{7}e_{12}}, e_{2e_{4}e_{6}e_{8}e_{10} - e_{3e_{7}e_{9}e_{11}e_{12}}\}$ is a minimal generating set of I_G . For the edge $f = e_1$ of G we have that $I_{G\setminus f} = \langle e_5e_{8}e_{10} - e_{9e_{11}e_{13}}, e_{2e_{4}e_{6}e_{13}} - e_{3e_{5}e_{7}e_{12}}, e_{2e_{4}e_{6}e_{8}e_{10} - e_{3e_{7}e_{9}e_{11}e_{12}}\}$ is a discorrel of I_G . For the edge $f = e_1$ of G we have that $I_{G\setminus f} = \langle e_{1}e_{5}, e_{8}, e_{9}, e_{10}, e_{11}, e_{12}, e_{13}\}$ and also $I_{G_S^f} = \langle e_{1e_5} - e_{11e_{12}}, e_{1e_{9}e_{13}} - e_{8e_{10}e_{12}}, e_{5e_{8}e_{10}} - e_{9e_{11}e_{13}} >$. Thus $I_G \neq I_{G_S^f}$ and therefore $I_G = I_{G_S^f} + I_{G\setminus f}$ is a splitting of I_G by Theorem 2.8.

Example 2.12. In [6, Example 3.5] P. Gimenez and H. Srinivasan provide an example of a graph G obtained by gluing two bow ties G_1 and G_2 along an edge. Since neither G_1 nor G_2 is bipartite, $I_{G_1} + I_{G_2}$ is not a splitting of I_G by [6, Theorem 3.4(1)]. The ideal I_G has a unique minimal system of generators S consisting of five binomials and $I_{G_S^e} = I_G$, for every edge e of G. By Theorem 2.8, the ideal I_G is not edge splittable, and therefore it is not subgraph splittable by Theorem 2.10. Thus I_G does not have a splitting in the form $I_{H_1} + I_{H_2}$ for any subgraphs H_1, H_2 of G. It is worth mentioning that if a graph G is a gluing of two arbitrary disjoint connected graphs G_1 and G_2 , bipartite or not, along an edge, then from [6, Theorem 3.4(3)] there exists a 3-uniform hypergraph H such that $I_H = I_{G_1} + I_{G_2}$.

Theorems 2.8 and 2.10 are easier to apply when I_G has a unique minimal system of binomial generators. In particular, this is true for the toric ideal of a bipartite graph since it is minimally generated by all binomials of the form B_w , where w is an even cycle with no chords, see [8, Theorem 2.3].

A graph G is called a *complete bipartite* graph if its vertex set can be partitioned into two subsets V_1 and V_2 such that each edge of G connects a vertex of V_1 to a vertex of V_2 . It is denoted by $K_{m,n}$, where m and n are the numbers of vertices in V_1 and V_2 respectively. The next corollary shows that toric ideals of complete bipartite graphs do not admit a subgraph splitting.

Corollary 2.13. The toric ideal of $K_{m,n}$ is not subgraph splittable.

Proof. Let $V_1 = \{x_1, \ldots, x_m\}$, $V_2 = \{y_1, \ldots, y_n\}$ be the bipartition of the complete bipartite graph $K_{m,n}$ and $E(K_{m,n}) = \{b_{ij} | 1 \le i \le m, 1 \le j \le n\}$, where $b_{ij} = \{x_i, y_j\}$. Then $I_{K_{m,n}}$ is minimally generated by the 2×2 minors of the matrix $M = (b_{ij})$, see [13, Proposition 10.6.2]. Thus $I_{K_{m,n}}$ is minimally generated by the set S of all binomials $b_{ij}b_{kl} - b_{il}b_{kj}$ which are in the form B_w , where w is a cycle in $K_{m,n}$ of length 4. Since $K_{m,n}$ is bipartite, the set S is the unique minimal system of binomial generators of $I_{K_{m,n}}$.

Notice that if m = 1 or n = 1, then $I_{K_{m,n}} = \{0\}$. Moreover if m = 2 and n = 2, then $I_{K_{m,n}}$ is minimally generated by $b_{11}b_{22} - b_{12}b_{21}$ and therefore it is not subgraph splittable.

Assume that $m \geq 2$, $n \geq 2$ and $I_{K_{m,n}} \neq I_{K_{2,2}}$. Let $e = b_{ij}$ be any edge of $K_{m,n}$. We claim that $K_{m,n}^e = K_{m,n}$ which implies the equality $I_{K_{m,n}^e} = I_{K_{m,n}}$. By definition $K_{m,n}^e$ is a subgraph of $K_{m,n}$. It suffices to show that all edges of $K_{m,n}$ belong also to the graph $K_{m,n}^e$. Let $\xi = b_{kl} \in E(K_{m,n})$. There are four cases:

- (1) k = i and l = j. Then $\xi = e$ which belongs to $K_{m,n}^e$.
- (2) k = i and $l \neq j$. Let $1 \leq i' \leq m$ with $i' \neq i$. Consider the cycle $w = (e, \xi, b_{i'l}, b_{i'j})$, then $B_w \in S$ and therefore ξ belongs to $K_{m,n}^e$.
- (3) $k \neq i$ and l = j. Let $1 \leq j' \leq n$ with $j' \neq j$. Consider the cycle $w = (e, \xi, b_{kj'}, b_{ij'})$, then $B_w \in S$ and therefore ξ belongs to $K_{m,n}^e$.
- (4) $k \neq i$ and $l \neq j$. Consider the cycle $w = (e, b_{il}, \xi, b_{kj})$, then $B_w \in S$ and therefore ξ belongs to $K_{m,n}^e$.

We conclude that in all cases ξ belongs to $K_{m,n}^e$, so $K_{m,n}^e = K_{m,n}$. From Theorem 2.8 it follows that $I_{K_{m,n}}$ is not edge splittable, and therefore $I_{K_{m,n}}$ is not subgraph splittable by Theorem 2.10.

The suspension \widehat{G} of a graph G is the graph obtained from G by adding a new vertex adjacent to all vertices of G. Given a cycle C_n in G of length $n \ge 3$, the next theorem determines when the toric ideal $I_{\widehat{C_n}}$ is subgraph splittable.

Theorem 2.14. Let C_n be a cycle of length $n \geq 3$ and $\widehat{C_n}$ be the suspension of C_n .

- (1) Suppose that n is even. Then $I_{\widehat{C_n}}$ is subgraph splittable if and only if n = 4.
- (2) If n is odd, then $I_{\widehat{C_n}}$ is subgraph splittable.

Proof. Let $C_n = (\{v_1, v_2\}, \{v_2, v_3\}, \ldots, \{v_{n-1}, v_n\}, \{v_1, v_n\})$ and $G = \widehat{C_n}$ be the suspension of C_n obtained by adding a new vertex v_{n+1} such that $\{v_i, v_{n+1}\}$ is an edge of G, for every $1 \le i \le n$.

(1) Suppose that $n \ge 4$ is even. From [9, Proposition 5.5] there is a bipartite graph H such that $I_G = I_H$, thus I_G has a unique minimal system of generators. We distinguish the following cases.

- (a) n = 4. Let $C_4 = (\varepsilon_{12} = \{v_1, v_2\}, \varepsilon_{23} = \{v_2, v_3\}, \varepsilon_{34} = \{v_3, v_4\}, \varepsilon_{14} = \{v_1, v_4\})$ and $\varepsilon_{i5} = \{v_i, v_5\}$ for $1 \le i \le 4$. Then
- $S = \{\varepsilon_{12}\varepsilon_{45} \varepsilon_{14}\varepsilon_{25}, \varepsilon_{12}\varepsilon_{35} \varepsilon_{23}\varepsilon_{15}, \varepsilon_{12}\varepsilon_{34} \varepsilon_{23}\varepsilon_{14}, \varepsilon_{23}\varepsilon_{45} \varepsilon_{34}\varepsilon_{25}, \varepsilon_{15}\varepsilon_{34} \varepsilon_{14}\varepsilon_{35}\}$

is a minimal generating set of I_G . Let $e = \varepsilon_{15}$, then $E(G^e) = \{\varepsilon_{12}, \varepsilon_{14}, \varepsilon_{15}, \varepsilon_{23}, \varepsilon_{34}, \varepsilon_{35}\}$. Notice that $\varepsilon_{12}\varepsilon_{45} - \varepsilon_{14}\varepsilon_{25} \in I_G$ and $\varepsilon_{12}\varepsilon_{45} - \varepsilon_{14}\varepsilon_{25} \notin I_{G^e}$, so $I_{G^e} \neq I_G$. Also e is an edge of the cycle $w = (\varepsilon_{12}, \varepsilon_{23}, \varepsilon_{35}, \varepsilon_{15})$. Thus $I_G = I_{G^e} + I_{G \setminus e}$ is a splitting of I_G by Theorem 2.8.

- (b) n > 4. Let e be an edge of G then there are two cases:
 - (i) e is an edge of the cycle C_n , for the sake of simplicity let $e = \varepsilon_{12}$. We will show that $G = G^e$. Since C_n is a cycle with no chords, B_{C_n} is a minimal binomial of I_G by Theorem 2.2, and therefore $E(C_n) \subset E(G^e)$. Consider now the odd cycles $w_1 = (e, \{v_2, v_{n+1}\}, \{v_{n+1}, v_1\})$ and $w_2 = (\{v_i, v_{i+1}\}, \{v_{i+1}, v_{n+1}\}, \{v_{n+1}, v_i\})$, where $4 \le i \le n-2$, which share only one vertex, namely v_{n+1} . The even closed walk $w = (w_1, w_2)$ has no chords and no bridges, and therefore B_w is a minimal binomial of I_G by Theorem 2.2. Thus $\{v_i, v_{n+1}\} \in E(G^e)$ for $i = 1, 2, 4, 5, \ldots, n-1$. Consider now the cycle

$$\gamma = (\{v_{n+1}, v_1\}, e, \{v_2, v_3\}, \{v_3, v_{n+1}\})$$

and notice that γ has exactly one odd chord, namely $\{v_2, v_{n+1}\}$, so from Theorem 2.2 B_{γ} is a minimal binomial of I_G . Thus $\{v_3, v_{n+1}\} \in E(G^e)$. Consider the cycle $\delta = (\{v_{n+1}, v_2\}, e, \{v_1, v_n\}, \{v_n, v_{n+1}\})$ and notice that δ has exactly one odd chord, namely $\{v_1, v_{n+1}\}$. By Theorem 2.2 B_{δ} is a minimal binomial of I_G . Thus $\{v_n, v_{n+1}\} \in E(G^e)$ and therefore $E(G) = E(G^e)$. Consequently $G = G^e$, so from Theorems 2.8, 2.10 the ideal I_G is not subgraph splittable.

(ii) $e = \{v_i, v_{n+1}\}$ with $1 \leq i \leq n$. For the sake of simplicity we let i = 1, namely $e = \{v_1, v_{n+1}\}$. Consider the odd cycles $w_1 = (e, \{v_2, v_{n+1}\}, \{v_1, v_2\})$ and $w_2 = (\{v_i, v_{i+1}\}, \{v_{i+1}, v_{n+1}\}, \{v_{n+1}, v_i\})$, where $4 \leq i \leq n-2$, which share only one vertex, namely v_{n+1} . The even closed walk $w = (w_1, w_2)$ has no chords and no bridges, so B_w is a minimal binomial of I_G by Theorem 2.2. Thus $\{v_i, v_{n+1}\} \in E(G^e)$ for $i = 2, 4, 5, \ldots, n-1$. Moreover $\{v_i, v_{i+1}\} \in E(G^e)$ for $i = 1, 4, 5, \ldots, n-2$. Consider now the cycle $\gamma =$ $(e, \{v_1, v_2\}, \{v_2, v_3\}, \{v_3, v_{n+1}\})$ and notice that it has exactly one odd chord, namely $\{v_2, v_{n+1}\}$. By Theorem 2.2 B_γ is a minimal binomial of I_G . Thus $\{v_2, v_{n+1}\}, e, \{v_1, v_n\}, \{v_n, v_{n+1}\})$ and notice that δ has exactly one odd chord, namely $\{v_1, v_2\}$. By Theorem 2.2 B_δ is a minimal binomial of I_G . Thus $\{v_1, v_n\} \in E(G^e)$ and also $\{v_n, v_{n+1}\} \in E(G^e)$. Furthermore

 $\mu = (\{v_{n-1}, v_n\}, \{v_n, v_1\}, e, \{v_{n-1}, v_{n+1}\})$

is an even cycle with exactly one odd chord, namely $\{v_n, v_{n+1}\}$. By Theorem 2.2 B_{μ} is a minimal binomial of I_G , and therefore $\{v_{n-1}, v_n\}$ is an edge of G^e . Consider the odd cycles $\zeta_1 = (e, \{v_1, v_n\}, \{v_n, v_{n+1}\}), \zeta_2 =$ $(\{v_3, v_4\}, \{v_4, v_{n+1}\}, \{v_3, v_{n+1}\})$ and let $\zeta = (\zeta_1, \zeta_2)$. Then B_{ζ} is a minimal binomial of I_G by Theorem 2.2, since ζ does not have any chords or bridges, and therefore $\{v_3, v_4\} \in E(G^e)$. Thus $E(G) = E(G^e)$, so $G = G^e$ and therefore I_G is not subgraph splittable by Theorems 2.8, 2.10.

(2) Suppose that n is odd. Then any odd cycle of G either coincides with C_n or has at least three vertices, namely v_{n+1} and two vertices of C_n . Thus G has no two odd vertex disjoint cycles. For n = 3 we have that $\widehat{C_3}$ is the complete graph on the vertex set $\{v_1, \ldots, v_4\}$, so $I_{\widehat{C_3}}$ is splittable by Example 2.5. Suppose that $n \ge 5$. Consider a minimal binomial $B_w \in I_G$. For the walk w there are two cases:

- (1) w is a cycle of length 4 with exactly one odd chord. Then B_w is indispensable of I_G by Theorem 2.2.
- (2) w has no chords or bridges and it is of the form $w = (w_1, w_2)$ where w_1, w_2 are odd cycles of length 3 intersecting in exactly one vertex, namely v_{n+1} . By Theorem 2.2 the binomial B_w is indispensable of I_G .

Thus I_G has a unique minimal system of generators.

Let $e = \{v_1, v_2\}$, then there is no cycle of length 4 in G containing the edges eand $\varepsilon_{34} = \{v_3, v_4\}$. Consider the odd cycles $\gamma_1 = (e, \{v_2, v_{n+1}\}, \{v_1, v_{n+1}\})$ and $\gamma_2 = (\varepsilon_{34}, \{v_4, v_{n+1}\}, \{v_3, v_{n+1}\})$ intersecting in v_{n+1} . Let $\gamma = (\gamma_1, \gamma_2)$, then B_{γ} is not a minimal binomial of I_G since there is a bridge $\{v_2, v_3\}$. Thus the edge ε_{34} does not belong to $E(G^e)$. Consider the even cycle $\zeta = (\{v_2, v_3\}, \{v_3, v_4\}, \{v_4, v_{n+1}\}, \{v_2, v_{n+1}\})$, then B_{ζ} is a minimal binomial of I_G and also $B_{\zeta} \notin I_{G^e}$. Thus $I_G \neq I_{G^e}$ and therefore I_G is splittable by Theorem 2.8.

3. The complete graph and minimal splittings

In this section, we study the special case of toric ideals of complete graphs. In contrast to toric ideals of (complete) bipartite graphs which always have a unique minimal set of binomial generators, toric ideals of complete graphs have a huge number of different minimal systems of binomial generators.

Let $n \ge 4$ be an integer and K_n be the complete graph on the vertex set $\{v_1, \ldots, v_n\}$ with edges $\{\varepsilon_{ij} | 1 \le i < j \le n\}$, where $\varepsilon_{ij} = \{v_i, v_j\}$. By [12, Theorem 3.3] the set

$$T = \{ \varepsilon_{ij} \varepsilon_{kl} - \varepsilon_{il} \varepsilon_{jk}, \varepsilon_{ik} \varepsilon_{jl} - \varepsilon_{il} \varepsilon_{jk} | 1 \le i < j < k < l \le n \}$$

is a minimal generating set of I_{K_n} . Let $\{\mathbf{e}_1, \ldots, \mathbf{e}_n\}$ be the canonical basis of \mathbb{R}^n . Since T is a minimal generating set of I_{K_n} , the only A_{K_n} -fibers contributing to minimal generators are those consisting of all monomials with A_{K_n} -degree $\mathbf{e}_i + \mathbf{e}_j + \mathbf{e}_k + \mathbf{e}_l$, where $1 \leq i < j < k < l \leq n$. There are $\binom{n}{4}$ such fibers and each one consists of three monomials, namely $\varepsilon_{ij}\varepsilon_{kl}, \varepsilon_{il}\varepsilon_{jk}$ and $\varepsilon_{ik}\varepsilon_{jl}$, which have no common factor other than 1. Therefore to generate the ideal I_{K_n} we need to take any two of the three binomials $\varepsilon_{ij}\varepsilon_{kl} - \varepsilon_{il}\varepsilon_{jk}, \varepsilon_{ik}\varepsilon_{jl} - \varepsilon_{il}\varepsilon_{jk}, \varepsilon_{ij}\varepsilon_{kl} - \varepsilon_{ik}\varepsilon_{jl}$, for every $1 \leq i < j < k < l \leq n$, see [2, 4] for more details. The monomials $\varepsilon_{ij}\varepsilon_{kl}, \varepsilon_{il}\varepsilon_{jk}$ and $\varepsilon_{ik}\varepsilon_{jl}$, where $1 \leq i < j \leq n$, are indispensable monomials, namely each one is a monomial term of at least one binomial in every minimal system of binomial generators of I_{K_n} . Thus every minimal system of binomial generators of I_{K_n} binomials. By [2, Theorem 2.9] the ideal I_{K_n} has $3^{\binom{n}{4}}$ different minimal systems of binomial generators, which is a huge number even for a small n.

Theorem 3.1. The toric ideal of K_n is subgraph splittable if and only if $n \ge 4$.

Proof. For $n \in \{1, 2, 3\}$ we have that $I_{K_n} = \{0\}$, so I_{K_n} is not splittable. Suppose that $n \geq 4$. From the analysis above we deduce that

$$S = \{ \varepsilon_{ij} \varepsilon_{kl} - \varepsilon_{ik} \varepsilon_{jl}, \varepsilon_{il} \varepsilon_{jk} - \varepsilon_{ik} \varepsilon_{jl} | 1 \le i < j < k < l \le n \}$$

is a minimal generating set for I_{K_n} . The set S has a nice geometric interpretation, see [3].

Let $G = K_n$ and $e = \varepsilon_{12}$. First we show that the graph G_S^e contains all edges of G, except perhaps the edges ε_{1n} and ε_{23} . Let ε_{ij} be an edge of G where $\{i, j\} \cap \{1, 2\} = \emptyset$ and $3 \leq i < j \leq n$. Since $\{v_1, v_2, v_i, v_j\}$ is a set of vertices of K_n , the binomials $\varepsilon_{12}\varepsilon_{ij} - \varepsilon_{1i}\varepsilon_{2j}$ and $\varepsilon_{i2}\varepsilon_{1j} - \varepsilon_{1i}\varepsilon_{2j}$ belong to S, thus ε_{ij} is an edge of G_S^e . From the above binomials we also deduce that ε_{1i} , for $3 \leq i \leq n-1$, and ε_{2j} , for $4 \leq j \leq n$, are edges of G_S^e . With the possible exception of the edges ε_{1n} and ε_{23} , the graph G_S^e contains all edges of G. Suppose that ε_{1n} is an edge of G_S^e , so there exists a binomial $B \in S$ in four variables which contains the variables ε_{12} and ε_{1n} . Then $B = \varepsilon_{12}\varepsilon_{in} - \varepsilon_{1n}\varepsilon_{2i}$ where $3 \leq i \leq n-1$. But $\{v_1, v_2, v_i, v_n\}$ is a set of vertices of K_n which contributes the binomials $\varepsilon_{12}\varepsilon_{in} - \varepsilon_{1i}\varepsilon_{2n}$ and $\varepsilon_{1n}\varepsilon_{2i} - \varepsilon_{1i}\varepsilon_{2n}$ in S. Thus B does not belong to S, a contradiction. Consequently ε_{1n} is not an edge of G_S^e . Similar arguments show that ε_{23} is not an edge of G_S^e . Since $\varepsilon_{12}\varepsilon_{3n} - \varepsilon_{1n}\varepsilon_{23} \in I_G$ and $\varepsilon_{12}\varepsilon_{3n} - \varepsilon_{1n}\varepsilon_{23} \notin I_{G_S^e}$, we get $I_{G_S^e} \neq I_G$ and therefore $I_G = I_{G_S^e} + I_{G\setminus e}$ is a splitting of I_G by Theorem 2.8.

Definition 3.2. Let $I_G = I_{G_1} + I_{G_2}$ be a subgraph splitting of I_G , $S = \{f_1, \ldots, f_r\}$ be a minimal system of binomial generators of I_{G_1} and $T = \{g_1, \ldots, g_t\}$ be a minimal system of binomial generators of I_{G_2} . We say that the splitting $I_G = I_{G_1} + I_{G_2}$ is a minimal splitting of I_G if $\{f_1, \ldots, f_r, g_1, \ldots, g_t\}$ is a minimal system of generators of I_G .

Remark 3.3. (1) The property of being minimal splitting does not depend on the minimal systems of generators chosen in the definition. Suppose that $\{f'_1, \ldots, f'_r\}$ is a minimal

system of binomial generators of I_{G_1} and $\{g'_1, \ldots, g'_t\}$ is a minimal system of binomial generators of I_{G_2} . But $I_G = I_{G_1} + I_{G_2}$, so $\{f'_1, \ldots, f'_r, g'_1, \ldots, g'_t\}$ is a generating set of I_G consisting of r + t elements and therefore it is a minimal system of generators.

(2) Let $I_G = I_{G_1} + I_{G_2}$ be a minimal splitting of I_G . For any $f_i \in S$, $1 \le i \le r$, we have that neither f_i nor $-f_i$ belongs to T. For any $g_j \in T$, $1 \le j \le t$, we have that neither g_j nor $-g_j$ belongs to S.

(3) All the splittings which appeared in [5, 6] are minimal splittings.

(4) The splitting of I_{G_n} in Example 2.9 is not minimal, since the ideal $I_{G_n \setminus e}$ has a minimal system of generators with $n+1+3\binom{n}{2}$ binomials, while the ideal I_{G_n} has a minimal system of generators with n binomials and the ideal I_{G_n} is generated minimally with $2n+1+2\binom{n}{2}$ binomials.

Example 3.4. Let K_4 be the complete graph on the vertex set $\{v_1, \ldots, v_4\}$. Let $G_1 = K_4 \setminus \{\varepsilon_{12}, \varepsilon_{34}\}$ and $G_2 = K_4 \setminus \{\varepsilon_{14}, \varepsilon_{23}\}$ be subgraphs of K_4 , then $I_{K_4} = I_{G_1} + I_{G_2}$ is a minimal splitting of I_{K_4} , since $I_{G_1} = \langle \varepsilon_{13}\varepsilon_{24} - \varepsilon_{14}\varepsilon_{23} \rangle$, $I_{G_2} = \langle \varepsilon_{13}\varepsilon_{24} - \varepsilon_{12}\varepsilon_{34} \rangle$ and $I_{K_4} = \langle \varepsilon_{13}\varepsilon_{24} - \varepsilon_{14}\varepsilon_{23}, \varepsilon_{13}\varepsilon_{24} - \varepsilon_{12}\varepsilon_{34} \rangle$.

We will show that the toric ideal of K_n has no minimal splitting for $n \ge 6$.

Proposition 3.5. Let $n \ge 4$ be an integer and w = (a, b, c, d) be an even cycle of K_n . Then

$$I_{K_n} = I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$$

is a splitting of I_{K_n} .

Proof. Since K_n is the complete graph, the cycle w has two chords, namely e and f. Then $ac - ef \in I_{K_n}$ does not belong to $I_{K_n \setminus \{a,c\}}$, thus $I_{K_n \setminus \{a,c\}} \neq I_{K_n}$. Also $I_{K_n \setminus \{b,d\}} \neq I_{K_n}$ since $ef - bd \in I_{K_n}$ does not belong to $I_{K_n \setminus \{b,d\}}$.

It remains to show that $I_{K_n} \subset I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$. Let B_{γ} be a binomial belonging to the set S defined in the proof of Theorem 3.1. Clearly if B_{γ} belongs to $I_{K_n \setminus \{a,c\}}$ or $I_{K_n \setminus \{b,d\}}$, then B_{γ} belongs to $I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$. Suppose that B_{γ} does not belong to $I_{K_n \setminus \{a,c\}}$ or $I_{K_n \setminus \{b,d\}}$. Then γ contains at least one edge from the set $\{a,c\}$, say a, and at least one edge from the set $\{b,d\}$, say b. Let $\gamma = (a, b, c', d')$ and e', f' be the chords of the walk γ . Notice that ac' - e'f' belongs to $I_{K_n \setminus \{b,d\}}$ and bd' - e'f' belongs to $I_{K_n \setminus \{a,c\}}$. Thus

$$B_{\gamma} = ac' - bd' = (ac' - e'f') - (bd' - e'f') \in I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}.$$

So $I_{K_n} = I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$ is a splitting.

Remark 3.6. Let $I_A = I_{A_1} + I_{A_2}$ be a splitting of I_A . If there exists a set A'_1 such that $I_{A_1} \subset I_{A'_1} \subsetneqq I_A$ then $I_A = I_{A'_1} + I_{A_2}$ is also a splitting. By Proposition 3.5, $I_{K_n} = I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$ is a splitting of I_{K_n} , and therefore $I_{K_n} = I_{K_n \setminus a} + I_{K_n \setminus b}$, $I_{K_n} = I_{K_n \setminus \{a,c\}} + I_{K_n \setminus b}$ and $I_{K_n} = I_{K_n \setminus \{b,d\}}$ are also splittings of I_{K_n} .

Proposition 3.7. Let $n \ge 4$ be an integer and $I_{K_n} = I_{G_1} + I_{G_2}$ be a subgraph splitting of I_{K_n} . If e is an edge of K_n which does not belong to G_1 and f is an edge of K_n which does not belong to G_2 , then the edges e, f are adjacent in K_n . Moreover, if h is another edge of K_n which does not belong to G_2 , then the edges f, h are not adjacent in K_n .

Proof. Suppose that the edges e, f are not adjacent. Let $e = \{v_i, v_j\}, f = \{v_k, v_l\}$ and $e \cap f = \emptyset$. Let $\{g_1, \ldots, g_r\}$ be a system of binomial generators of I_{G_1} and $\{h_1, \ldots, h_s\}$ be a system of binomial generators of I_{G_2} , then $\{g_1, \ldots, g_r, h_1, \ldots, h_s\}$ is a generating set of I_G . Therefore we can find a minimal system of generators V of I_{K_n} formed by

binomials belonging to either I_{G_1} or I_{G_2} . From the introduction of section 3 the monomial $ef = \varepsilon_{ij}\varepsilon_{kl}$ is indispensable of I_{K_n} , so it is a monomial term in a binomial B_w of I_{G_1} or I_{G_2} . Since e is not an edge of G_1 , we have that $B_w \notin I_{G_1}$. But f is not an edge of G_2 , so $B_w \notin I_{G_2}$. Thus B_w does not belong to I_{G_1} or I_{G_2} , a contradiction. Consequently, the edges e, f are adjacent.

Let $e = \varepsilon_{ij}$ and $f = \varepsilon_{jk}$. Suppose that h is another edge of K_n which does not belong to G_2 . Since e does not belong to G_1 , we have, from the first part of the Proposition, that the edges e, h are adjacent. We claim that f and h are not adjacent. Suppose that f, h are adjacent. Since h is adjacent to both e and f, there are two cases for the edge h, namely either $h = \varepsilon_{ik}$ or $h = \varepsilon_{jl}$ for an index l different than i, j, k.

- (1) $h = \varepsilon_{ik}$. Let l be an index different than i, j, k. In a previous step we found that there is a minimal system of generators V formed by binomials belonging to either I_{G_1} or I_{G_2} . Moreover, V must contain exactly two of the following three binomials $\varepsilon_{ij}\varepsilon_{kl} - \varepsilon_{il}\varepsilon_{jk} = e\varepsilon_{kl} - \varepsilon_{il}f, \varepsilon_{ik}\varepsilon_{jl} - \varepsilon_{il}\varepsilon_{jk} = h\varepsilon_{jl} - \varepsilon_{il}f, \varepsilon_{ij}\varepsilon_{kl} - \varepsilon_{ik}\varepsilon_{jl} = e\varepsilon_{kl} - h\varepsilon_{jl}$. But none of them belongs to I_{G_2} , since $f, h \notin E(G_2)$, while $e\varepsilon_{kl} - \varepsilon_{il}f$ and $e\varepsilon_{kl} - h\varepsilon_{jl}$ do not belong to I_{G_1} , since $e \notin E(G_1)$. A contradiction.
- (2) $h = \varepsilon_{jl}$. We argue similarly as above. The set V must contain two of the following three binomials $e\varepsilon_{kl} \varepsilon_{il}f$, $\varepsilon_{ik}h \varepsilon_{il}f$, $e\varepsilon_{kl} \varepsilon_{ik}h$. But none of them belongs to I_{G_2} , since $f, h \notin E(G_2)$, while $e\varepsilon_{kl} \varepsilon_{il}f$ and $e\varepsilon_{kl} \varepsilon_{ik}h$ do not belong to I_{G_1} , since $e \notin E(G_1)$. A contradiction.

Consequently, the edges f, h are not adjacent.

Remark 3.8. From Proposition 3.7 we deduce that any of the graphs G_1, G_2 contains all edges of K_n except at most two. Suppose not, and let $e = \varepsilon_{ij} \notin E(G_1)$, $\{f_1, f_2, f_3\} \subset E(K_n)$ such that $f_l \notin E(G_2)$, for every $1 \leq l \leq 3$. By Proposition 3.7, any of the edges f_1, f_2, f_3 is adjacent to $e = \varepsilon_{ij}$, so v_i is a vertex of the edges f_1, f_2, f_3 or v_j is a vertex of the edges f_1, f_2, f_3 . Thus either v_i or v_j is a vertex of at least two of the edges f_1, f_2, f_3 , and therefore two of the edges f_1, f_2, f_3 are adjacent, a contradiction to the second part of Proposition 3.7.

Proposition 3.9. Let $n \ge 4$ be an integer and $I_{K_n} = I_{G_1} + I_{G_2}$ be a subgraph splitting of I_{K_n} . Then there exists a cycle w = (a, b, c, d) in K_n such that

- (1) $G_1 = K_n \setminus a \text{ and } G_2 = K_n \setminus b \text{ or}$
- (2) $G_1 = K_n \setminus \{a, c\}$ and $G_2 = K_n \setminus b$ or
- (3) $G_1 = K_n \setminus a \text{ and } G_2 = K_n \setminus \{b, d\}$ or
- (4) $G_1 = K_n \setminus \{a, c\}$ and $G_2 = K_n \setminus \{b, d\}.$

Proof. Since $I_{G_1} \subsetneq I_{K_n}$, there exists an edge a of K_n such that a is not an edge of G_1 . Thus $I_{G_1} \subset I_{K_n \setminus a}$. Since $I_{G_2} \gneqq I_{K_n}$, there exists an edge b of K_n such that b is not an edge of G_2 . Thus $I_{G_2} \subset I_{K_n \setminus b}$. By Proposition 3.7, the edges a, b are adjacent. We distinguish the following cases:

- (1) $G_1 = K_n \setminus a$ and $G_2 = K_n \setminus b$. Since a, b are adjacent edges in the complete graph K_n with $n \ge 4$ vertices, there exists a cycle w of length 4 in K_n with two consecutive edges a, b.
- (2) $G_1 \subsetneq K_n \setminus a$ and $G_2 = K_n \setminus b$. In this case, there exists an edge c of $K_n \setminus a$ such that c is not an edge of G_1 . By Proposition 3.7, the edges a, c do not share a common vertex and they are adjacent to b. Furthermore, G_1 contains all edges of K_n except at most two. Thus $G_1 = K_n \setminus \{a, c\}$ and there exists a cycle w of length 4 in K_n with three consecutive edges a, b, c.

- (3) $G_1 = K_n \setminus a$ and $G_2 \subseteq K_n \setminus b$. In this case, there exists an edge d of $K_n \setminus b$ such that d is not an edge of G_2 . By Proposition 3.7, the edges b, d do not share a common vertex and they are adjacent to a. Moreover, G_2 contains all edges of K_n except at most two. Thus $G_2 = K_n \setminus \{b, d\}$ and there exists a cycle w of length 4 in K_n with three consecutive edges d, a, b.
- (4) $G_1 \subsetneq K_n \setminus a$ and $G_2 \subsetneq K_n \setminus b$. Then there exists an edge c of $K_n \setminus a$ and an edge d of $K_n \setminus b$ such that c is not an edge of G_1 and d is not an edge of G_2 . By Proposition 3.7, the edges a, c do not share a common vertex and they are adjacent to both b, d. Additionally G_1 contains all edges of K_n except at most two. By the same proposition, the edges b, d do not share a common vertex and they are adjacent to both a, c. Furthermore G_2 contains all edges of K_n except at most two. Thus w = (a, b, c, d) is a cycle in $K_n, G_1 = K_n \setminus \{a, c\}$ and $G_2 = K_n \setminus \{b, d\}$.

Theorem 3.10. Let $n \ge 4$ be an integer. Then I_{K_n} has a minimal splitting if and only if $4 \le n \le 5$.

Proof. Suppose first that n = 4. Then $I_{K_4} = I_{K_4 \setminus \{\varepsilon_{12}, \varepsilon_{34}\}} + I_{K_4 \setminus \{\varepsilon_{14}, \varepsilon_{23}\}}$ is a minimal splitting of I_{K_4} by Example 3.4. Suppose now that n = 5 and let $\{v_1, \ldots, v_5\}$ be the vertex set of K_5 . Let $G_1 = K_5 \setminus \{\{v_1, v_2\}, \{v_3, v_4\}\}$ and $G_2 = K_5 \setminus \{\{v_1, v_4\}, \{v_2, v_3\}\}$ be subgraphs of K_5 . Then $S = \{\varepsilon_{13}\varepsilon_{24} - \varepsilon_{14}\varepsilon_{23}, \varepsilon_{14}\varepsilon_{25} - \varepsilon_{15}\varepsilon_{24}, \varepsilon_{23}\varepsilon_{45} - \varepsilon_{24}\varepsilon_{35}, \varepsilon_{13}\varepsilon_{25} - \varepsilon_{15}\varepsilon_{23}, \varepsilon_{13}\varepsilon_{45} - \varepsilon_{14}\varepsilon_{35}\}$ is a minimal generating set of I_{G_1} and $T = \{\varepsilon_{12}\varepsilon_{34} - \varepsilon_{13}\varepsilon_{24}, \varepsilon_{24}\varepsilon_{35} - \varepsilon_{25}\varepsilon_{34}, \varepsilon_{13}\varepsilon_{45} - \varepsilon_{15}\varepsilon_{24}, \varepsilon_{12}\varepsilon_{55} - \varepsilon_{13}\varepsilon_{25}\}$ is a minimal generating set of I_{G_2} . Also for any binomial $B \in S$ we have that neither B nor -B belongs to T, while for any binomial $B' \in T$ we have that neither B' nor -B' belongs to S. Moreover $S \cup T$ is a minimal generating set of I_{K_5} , and therefore $I_{K_5} = I_{G_1} + I_{G_2}$ is a minimal splitting of I_{K_5} .

Finally assume that $n \ge 6$ and let $I_{K_n} = I_{G_1} + I_{G_2}$ be a minimal splitting of I_{K_n} . Then there exists a cycle w = (a, b, c, d) of K_n such that G_1 and G_2 are of one of the four types of Proposition 3.9. Without loss of generality we can assume that $a = \{v_1, v_2\}$, $b = \{v_2, v_3\}$, $c = \{v_3, v_4\}$ and $d = \{v_1, v_4\}$. Since $n \ge 6$, the graph K_n has at least two more vertices, say v_5 and v_6 . Notice that the complete subgraph of K_n on the vertex set $\{v_1, v_3, v_5, v_6\}$ is also a subgraph of both G_1 and G_2 . Let S be a minimal system of binomial generators of I_{G_1} and T be a minimal system of binomial generators of I_{G_2} . Both S and T must contain exactly two of the binomials $\varepsilon_{13}\varepsilon_{56} - \varepsilon_{15}\varepsilon_{36}, \varepsilon_{13}\varepsilon_{56} - \varepsilon_{16}\varepsilon_{35}, \varepsilon_{15}\varepsilon_{36} - \varepsilon_{16}\varepsilon_{35}$. Thus S and T have at least one minimal generator in common which contradicts the fact that $I_{K_n} = I_{G_1} + I_{G_2}$ is a minimal splitting of I_{K_n} . Consequently, for $n \ge 6$ the ideal I_{K_n} has no minimal splitting.

4. Reduced splittings

In this section, we introduce reduced splittings of toric ideals of graphs and show that every minimal splitting of the toric ideal of a graph is also a reduced splitting.

Definition 4.1. We say that the subgraph splitting $I_G = I_{G_1} + I_{G_2}$ of I_G is reduced if for any subgraphs H_1 of G_1 and H_2 of G_2 with $I_G = I_{H_1} + I_{H_2}$ it holds that $I_{H_1} = I_{G_1}$ and $I_{H_2} = I_{G_2}$.

A basic step towards determining all subgraph splittings of the toric ideal of a graph is to find its reduced splittings. All other subgraph splittings are found from a reduced splitting $I_G = I_{G_1} + I_{G_2}$ by adding edges to one of G_1 , G_2 or both to get graphs G'_1, G'_2 , as long as $I_G = I_{G'_1} + I_{G'_2}$ is a splitting. **Remark 4.2.** The reduced splittings of I_{K_n} are those of the last type in Proposition 3.9, namely $I_{K_n} = I_{G_1} + I_{G_2}$ where $G_1 = K_n \setminus \{a, c\}$ and $G_2 = K_n \setminus \{b, d\}$. The other two types in Proposition 3.9 can be taken from the reduced splittings, by adding edges.

Proposition 4.3. If I_G is subgraph splittable, then it has at least one reduced splitting.

Proof. Any subgraph splitting $I_G = I_{G'_1} + I_{G'_2}$ of I_G is either reduced or there exist a splitting $I_G = I_{G_1} + I_{G_2}$ such that G_1 is a proper subgraph of G'_1 or/and G_2 is a proper subgraph of G'_2 . In the latter case, G_1 has fewer edges than G'_1 or/and G_2 has fewer edges than G'_2 . This procedure cannot be repeated indefinitely, since the number of edges of G is finite.

To understand the structure of reduced splittings one has to generalize first the notion of edge splitting by replacing the edge with a set of edges.

Let $S = \{B_{w_1}, B_{w_2}, \ldots, B_{w_r}\}$ be a minimal system of binomial generators of I_G . Given a set $F \subset E(G)$, we define $G_S^F = \bigcup_{e \in F} G_S^e$ and get $I_G = I_{G_S^F} + I_{G \setminus F}$, by using similar arguments as in the proof of Theorem 2.4.

Of particular interest is the case that F is the set of all edges of G having a common vertex v. Given a vertex v of G, we let G - v be the subgraph of G obtained by deleting the vertex v. We denote by G_S^v the subgraph of G with edges

$$E(G_S^v) = \bigcup_{1 \le i \le r \text{ and } v \in V(w_i)} E(w_i).$$

It holds that $I_G = I_{G_S^v} + I_{G-v}$.

The next theorem asserts that the reduced splittings of I_G are always in the form $I_G = I_{G_G^F} + I_{G\setminus F}$, for suitable sets S and F.

Theorem 4.4. Let $I_G = I_{G_1} + I_{G_2}$ be a reduced splitting of I_G . Then there exist a set $F \subset E(G)$ and a minimal system of binomial generators S of I_G such that $I_{G_1} = I_{G_S^F}$ and $I_{G_2} = I_{G \setminus F}$.

Proof. Let $I_G = I_{G_1} + I_{G_2}$ be a reduced splitting of I_G and set $F = G \setminus G_2$. Let $\{f_1, \ldots, f_s\}$ be a system of binomial generators of I_{G_1} and $S = \{B_{w_1}, \ldots, B_{w_r}\} \subset \{f_1, \ldots, f_s, g_1, \ldots, g_t\}$ be a system of binomial generators of I_G and $S = \{B_{w_1}, \ldots, B_{w_r}\} \subset \{f_1, \ldots, f_s, g_1, \ldots, g_t\}$ be a minimal system of binomial generators of I_G as in the proof of Theorem 2.10. Then $G \setminus F = G_2$, so $I_{G \setminus F} = I_{G_2}$, and $I_{G_S^F} \subset I_{G_1}$ since $I_{G_S^F} \subset I_{G_1}$ for each $e \in F$ from the proof of Theorem 2.10. But $I_G = I_{G_1} + I_{G_2}$ is a reduced splitting of I_G and also $I_G = I_{G_S^F} + I_{G_2}$, since $I_G = I_{G_S^F} + I_{G \setminus F}$ and $I_{G \setminus F} = I_{G_2}$, with $I_{G_S^F} \subset I_{G_1}$, therefore $I_{G_S^F} = I_{G_1}$.

Remark 4.5. A reduced splitting $I_G = I_{G_1} + I_{G_2}$ can be also written in the form $I_G = I_{G\setminus F} + I_{G_S^F}$ where $F = G\setminus G_1$, $I_{G_1} = I_{G\setminus F}$ and $I_{G_2} = I_{G_S^F}$.

Example 4.6. Let G be the bipartite graph consisting of four 4-cycles w_1, w_2, w_3, w_4 in a row, i.e. for i < j it holds that $E(w_i) \cap E(w_j) = \emptyset$ except if j = i + 1 in which case they have one edge in common. The ideal I_G has a unique minimal system of binomial generators consisting of the binomials $B_{w_1}, B_{w_2}, B_{w_3}, B_{w_4}$. Then there are 19 different splittings. More precisely, four minimal and reduced splittings in the form $I_G = \langle B_{w_i} \rangle$ $+ \langle B_{w_j}, B_{w_k}, B_{w_l} \rangle$, where $\{i, j, k, l\} = \{1, 2, 3, 4\}$. Also three minimal and reduced splittings in the form $I_G = \langle B_{w_i}, B_{w_j} \rangle + \langle B_{w_k}, B_{w_l} \rangle$. Finally twelve non-minimal and non-reduced splittings in the form $I_G = \langle B_{w_i}, B_{w_j} \rangle + \langle B_{w_j}, B_{w_k}, B_{w_l} \rangle$. The next Theorem asserts that minimal splittings are always reduced.

Theorem 4.7. Every minimal splitting of I_G is also a reduced splitting.

Proof. Let $I_G = I_{G_1} + I_{G_2}$ be a minimal splitting which is not reduced. Then there exist $I_{G'_1} \subset I_{G_1}$ and $I_{G'_2} \subset I_{G_2}$ such that $I_G = I_{G'_1} + I_{G'_2}$, where $I_{G'_1}$ is a proper subset of I_{G_1} or/and $I_{G'_2}$ is a proper subset of I_{G_2} . Suppose that for instance $I_{G'_1}$ is a proper subset of I_{G_1} . Let $\{B_{w_1}, \ldots, B_{w_s}\}$ and $\{B_{w_{s+1}}, \ldots, B_{w_l}\}$ be minimal systems of binomial generators of the ideals I_{G_1} and I_{G_2} , respectively. Since $I_G = I_{G_1} + I_{G_2}$ is a minimal splitting, the ideal I_G is minimally generated by the set $\{B_{w_1}, \ldots, B_{w_s}, B_{w_{s+1}}, \ldots, B_{w_l}\}$. Let $\{f_1, \ldots, f_t\}$ be a system of binomial generators of $I_{G'_1}$ then from the equality $I_G = I_{G'_1} + I_{G'_2}$ we have that $I_G = I_{G'_1} + I_{G_2}$, since $G'_2 \subset G_2$. Thus there exists a set $\{B_{w'_1}, \ldots, B_{w'_s}\} \subset \{f_1, \ldots, f_t\}$ such that $\{B_{w'_1}, \ldots, B_{w'_s}, B_{w_{s+1}}, \ldots, B_{w_l}\}$ is a minimal system of generators of I_G , since toric ideals of graphs are homogeneous and therefore any two minimal systems of generators have the same cardinality. Then, after reordering $B_{w'_1}, \ldots, B_{w'_s}$ if necessary, we can assume that $B_{w'_j} = B_{w_j}$ if B_{w_j} is indispensable, and the binomials $B_{w'_j}, B_{w_j}$ are F_4 -equivalent if B_{w_i} is dispensable, namely B_{w_i} is not indispensable, since dispensability of toric ideals of graphs is only caused by F_4 's. Recall that two primitive walks γ , γ' are F_4 -equivalent if either $\gamma = \gamma'$ or there exists a series of walks $\gamma_1 = \gamma, \gamma_2, \ldots, \gamma_{r-1}, \gamma_r = \gamma'$ such that γ_i and γ_{i+1} differ by an F_4 , where $1 \leq i \leq r-1$, see [10, Section 4]. Since G'_1 is a proper subgraph of G_1 , there exists an edge $e \in E(w_i) \subset E(G_1)$ which is not in $E(G'_1)$, but $e \notin E(w'_i)$ for at least one index $1 \leq i \leq s$. Then B_{w_i} is dispensable, thus w_i, w'_i are F_4 -equivalent and e belongs to a common F_4 of both w_i, w'_i . Suppose that the edges of the F_4 belonging to w_i are e, f and to w'_i are a, b, thus $F_4 = (e, a, f, b)$. Consider the binomial $ef - ab \in I_G$, we have that all e, f, a, b are edges of G_1 , since $G'_1 \subset G_1$, and therefore $ef - ab \in I_{G_1}$.

We distinguish the following cases.

- (1) ef ab is an indispensable binomial of I_G . The set $\{B_{w'_1}, \ldots, B_{w'_s}, B_{w_{s+1}}, \ldots, B_{w_l}\}$ is a minimal system of generators of I_G and ef - ab is indispensable of I_G , so ef - abis one of the binomials $B_{w'_i}, 1 \leq k \leq s$ or $B_{w_k}, s + 1 \leq k \leq l$. But $ef - ab \notin I_{G'_1}$ since e is not an edge of G'_1 , thus $ef - ab = B_{w_k}$ for an index $s + 1 \leq k \leq l$. Since the binomial ef - ab is indispensable of I_G , the A_G -fiber of $\deg_{A_G}(ef)$ has only two elements, namely ef and ab, see [2]. Then the A_{G_1} -fiber of $\deg_{A_{G_1}}(ef)$ has at most two elements; in fact, it has exactly two with no common factor other than 1 since $ef - ab \in I_{G_1}$. Thus ef - ab is indispensable of I_{G_1} , and therefore $ef - ab = B_{w_q}$ for an index $1 \leq q \leq s$ a contradiction to the hypothesis that $I_G = I_{G_1} + I_{G_2}$ is a minimal splitting.
- (2) ef ab is not an indispensable binomial of I_G . Then there is a binomial ef cdin I_G . In this case, the A_G -fiber of $\deg_{A_G}(ef)$ corresponds to a subgraph of Ghomomorphic to K_4 and it consists of exactly three monomials, namely ef, ab, and cd. Every minimal system of generators of I_G should contain exactly two of the binomials ef - ab, ef - cd, ab - cd. There are two subcases.
 - (i) Both edges c, d belong to G_1 . Then all binomials ef ab, ef cd, ab cd belong to I_{G_1} , so any minimal system of binomial generators of I_{G_1} should contain exactly two of them. Since $I_G = I_{G_1} + I_{G_2}$ is a minimal splitting, the ideal I_{G_2} cannot contain any of the above three binomials. But $I_G = I_{G'_1} + I_{G_2}$ is also a splitting of I_G and e is not an edge of G'_1 , therefore only ab - cd can be an element of $I_{G'_1}$. Then $\{B_{w'_1}, \ldots, B_{w'_s}, B_{w_{s+1}}, \ldots, B_{w_l}\}$ is a minimal generating

set of I_G , which contains at most one of the binomials ef - ab, ef - cd, ab - cd, a contradiction.

(ii) At least one of c, d does not belong to G_1 . Then the binomial ef - ab is indispensable of I_{G_1} , since the A_{G_1} -fiber of $\deg_{A_{G_1}}(ef)$ has only two elements, namely ef and ab, with no common factor other than 1. Thus the set $\{B_{w_1}, \ldots, B_{w_s}\}$ contains the binomial ef-ab. The set $\{B_{w_1}, \ldots, B_{w_s}, B_{w_{s+1}}, \ldots, B_{w_l}\}$ is a minimal system of generators of I_G , so $\{B_{w_{s+1}}, \ldots, B_{w_l}\}$ contains exactly one of the binomials ef - cd or ab - cd and does not contain ef - ab. But $I_G = I_{G'_1} + I_{G_2}$ is a splitting of I_G and none of the binomials ef - ab, ef - cd, ab - cd belongs to $I_{G'_1}$, since e and at least one of c, d does not belong to $E(G'_1)$. Thus the set $\{B_{w_{s+1}}, \ldots, B_{w_l}\}$ contains exactly two of the binomials ef - ab, ef - cd, ab - cd, a contradiction.

In all cases we reach a contradiction, so every minimal splitting is reduced.

Remark 4.8. The converse of Theorem 4.7 is not true. By Theorem 3.10, I_{K_n} does not have a minimal splitting for $n \ge 6$. But from Proposition 3.9 any splitting $I_G = I_{K_n \setminus \{a,c\}} + I_{K_n \setminus \{b,d\}}$ is reduced.

Remark 4.9. In [5, Question 5.1] G. Favacchio, J. Hofscheier, G. Keiper, and A. Van Tuyl pose the following question: For what graphs G can we find G_1 and G_2 so that their respective toric ideals satisfy $I_G = I_{G_1} + I_{G_2}$? We answered this question in the case that G_1, G_2 are subgraphs of G. The general question seems difficult, since one has information from G only about the edges and possible closed walks of G_1, G_2 , but not about their set of vertices.

The next example shows that there may be splittings $I_G = I_{G_1} + I_{G_2}$ such that one of G_1, G_2 or both are not isomorphic to any subgraph of G.



FIGURE 4. The graphs G, G_1 and G_2 of a non subgraph splitting.

Let G be the grid graph of Figure 4 with 9 vertices and 12 edges. The graph G has four cycles of length 4 with no chord, namely w_1 , w_2 , w_3 and w_4 , and a cycle of length 8 with no chord, namely w_5 . Then the ideal I_G is generated by the binomials $B_{w_i}, 1 \leq i \leq 5$. The ideal I_{G_1} is generated by B_{w_1}, B_{w_3} and the ideal I_{G_2} is generated by $B_{w_2}, B_{w_4}, B_{w_5}, B_{w_6}, B_{w_7}, B_{w_8}$, where $w_i, 5 \leq i \leq 8$, are closed walks of length 8 with no chord. Then $I_G = I_{G_1} + I_{G_2}$ is a splitting of I_G and G_2 is not isomorphic to any subgraph of G, since it has 10 vertices. Thus there exist splittings of graphs that are not subgraph splittings.
