# Odd viscous flow past a sphere at low but nonzero Reynolds numbers

Measuring lift force on symmetrically shaped obstacles immersed in laminar flow is the quintessential way of signalling odd viscosity. For flow past cylinders, such a lift force does not arise when incompressibility and no-slip boundary conditions hold, whereas for spheres, a lift force was found in Stokes flow, applying to cases where the Reynolds number is negligible and convection can be ignored. When considering the role of convection at low but nonzero Reynolds numbers, two arising hurdles are the Whitehead paradox and the breaking of axial symmetry, which are overcome by asymptotic matching and the Lorentz reciprocal theorem respectively. We also consider the case where axial symmetry is retained because the translation of the sphere is aligned with the anisotropy vector of odd viscosity. We find that while lift vanishes, the interplay between odd viscosity and convection gives rise to a stream-induced non-vanishing torque.

## <span id="page-0-1"></span>I. INTRODUCTION

In the ever ongoing study of fluids, the exploration of flow instigated by non-dissipative, parity-breaking viscosities has emerged as a new frontier. Such transport coefficients, which fall under the heading of odd viscosity, result from the spinning of microscopic or mesoscopic particles constituting the fluid  $[1-3]$  $[1-3]$ . Odd viscosity gives rise to a wide range of novel physical phenomena, such as azimuthal flow of sedimenting particles [\[4\]](#page-7-4), torque induced by the rate of area change [\[5\]](#page-7-5), non-reciprocal selfinduced flow fields for swimmers [\[6\]](#page-7-6), formation of inertiallike waves [\[7\]](#page-7-7), Hall-like transport in fluids [\[8\]](#page-7-8), oscillating

vortical boundary layers [\[9\]](#page-7-9) and many more [\[10\]](#page-7-10). Furthermore, odd viscosity has implications across various scales and disciplines, from electron fluids [\[11,](#page-7-11) [12\]](#page-7-12), diatomic gases [\[13,](#page-7-13) [14\]](#page-7-14), equatorial waves [\[15,](#page-7-15) [16\]](#page-7-16), colloidal rotors [\[17–](#page-7-17)[22\]](#page-7-18) and biological systems [\[23\]](#page-7-19).

Odd viscosity can be found in multiple dimensions. Originally treated as a viscous analogue of two-dimensional Hall conductivity  $[24-28]$  $[24-28]$ , it was found that three dimensional fluids can display several odd viscosities [\[4\]](#page-7-4), provided that there is a preferred vector giving rise to anisotropy. Odd viscosity is also studied at different Reynolds numbers, ranging from zero Reynolds number Stokes flow [\[4,](#page-7-4) [29,](#page-7-22) [30\]](#page-7-23) or small Reynolds number Oseen flow  $[31]$  to large Reynolds number flows with fully developed turbulence [\[32\]](#page-8-2).

A key tool for understanding fluid behavior at low Reynolds numbers is the Lorentz reciprocal theorem [\[33\]](#page-8-3). However, this theorem assumes reciprocity, which the odd viscous tensor violates. This makes the Lorentz reciprocal theorem in its original form unusable for fluid systems with non-vanishing odd viscosity. Fortunately, it turns out that a generalized version of the Lorentz reciprocal theorem exists which takes this non-reciprocity into account by considering an auxiliary fluid system with an odd viscosity of opposite sign [\[30\]](#page-7-23).

One of the many things that this generalized Lorentz reciprocal theorem allows one to compute is the odd viscosity induced lift force on a translating object. In two dimensions, such a lift force is zero for incompressible fluids with no-slip boundary conditions, but can get a nonvanishing value at quadratic order in slip length [\[34\]](#page-8-4), for compressible fluids [\[31,](#page-8-1) [35,](#page-8-5) [36\]](#page-8-6), or liquid domains that lie within a membrane [\[37\]](#page-8-7).

In Refs. [\[4,](#page-7-4) [30,](#page-7-23) [38\]](#page-8-8), the force and torque for odd Stokes flow past a sphere are computed. Stokes flow, also known as creeping flow, means that the role of inertia, which enters through the convective term in the Navier-Stokes equation, is ignored entirely. The reason why it is worthwhile to not ignore this convective terms is

twofold. Firstly, to ignore the convective term requires the Reynolds number to be negligible, which is not the case in many fluid systems. Secondly, for translating obstacles, convective effects always dominate over viscous ones when one considers the flow sufficiently far from the obstacle [\[39](#page-8-9)[–41\]](#page-8-10). In two dimensions, this is what causes the Stokes paradox, thus preventing one from finding a Stokes solution [\[42\]](#page-8-11). In three dimensions, one can still obtain a Stokes solution but one is faced with the Whitehead paradox [\[43,](#page-8-12) [44\]](#page-8-13), which makes the low Reynolds number expansion a singular perturbation theory [\[40,](#page-8-14) [41,](#page-8-10) [43\]](#page-8-12). Although resolving the Whitehead paradox leads one to find that Stokes solution accurately describes the flow at leading order in Reynolds number, this impediment motivates the need for understanding the role of convection in the case of odd viscous flow. Considering the role of convection for odd viscous flow is what is done in this work. Since the Whitehead paradox is related by the competition between convection and viscosity, complications arise when odd viscosity is taken into account, as now there is a competition between three distinct contributions. This complication is avoided because, similar to many Stokes flow computations [\[4,](#page-7-4) [29,](#page-7-22) [45\]](#page-8-15), we solve the Navier-Stokes equations for low Reynolds numbers but also for small odd viscosity, so that at leading order the Whitehead paradox is resolved with the asymptotic matching procedure corresponding to purely shear viscous fluids. This solution can be corrected to account for odd viscous effects.

The structure of this work is as follows. In Sec. [II](#page-1-0) we describe the general three-dimensional odd viscous model that is being considered. In Sec. [III,](#page-1-1) we study flow past a translating sphere at low Reynolds numbers. Specifically, we compute the odd oseenlet, which serves as the first outer solution in an expansion based on asymptotic matching. In Sec. [IV,](#page-3-1) we obtain the first inner solution exactly for the longitudinal case where *axial symmetry* is upheld, and for the transverse case, where axial symmetry is broken, we use the Lorentz reciprocal theorem to calculate the first inertial correction to Stokes lift for the odd viscosity described in Sec. [II.](#page-1-0)

## <span id="page-1-0"></span>II. ODD VISCOUS NAVIER-STOKES EQUATION

We consider an incompressible fluid system with a freestream velocity  $U_i$ , a shear viscosity  $\eta_s$ , a constant density  $\rho_0$  and a stationary and rigid no-slip sphere with radius a. We use these to non-dimensionalize the coordinate  $x_i$ , fluid velocity  $u_i$  and stress tensor  $\sigma_{ij}$ . In addition, there is a single three-dimensional odd viscosity  $\eta_o$ which is assumed to be small compared to  $\eta_s$ . We start from the steady, incompressible Navier-Stokes equation

where Re is the Reynolds number, given by  $Re =$  $\rho_0|U|a/\eta_s$ . In three dimensions, for there to be odd viscosity, anisotropy is required. This anisotropy gives rise to multiple odd and even coefficients [\[4,](#page-7-4) [45\]](#page-8-15). To keep the computations tractable at nonzero Reynolds numbers, we consider only the simplest possible three-dimensional odd viscosity  $\eta_o$  [\[29,](#page-7-22) [38\]](#page-8-8), namely the odd viscosity that arises upon coarse-graining a system of particles with an intrinsic rotation whose rotation axis is pointed in direction  $\ell_i$ [\[2,](#page-7-24) [46\]](#page-8-16). Without loss of generality, we take this vector to be pointed in the z-direction, i.e.  $\ell_i = \delta_i^z$ . For such an odd viscosity and the isotropic shear viscosity, the stress  $\sigma_{ij}$  constitutes of

where p is the dimensionless pressure,  $\gamma_{o} = \eta_{o}/\eta_{s}$ .  $\varepsilon_{ij}$  is the two-dimensional anisotropic Levi-Civita tensor, i.e.  $\varepsilon_{ij} = \epsilon_{ijk}\ell_k$ , with  $\epsilon_{ijk}$  being the three-dimensional Levi-Civita tensor. Plugging Eq. [\(2\)](#page-1-2) into Eq. [\(1\)](#page-1-3) yields [\[29,](#page-7-22) [45\]](#page-8-15)

where  $p_m$  we introduced the modified pressure [\[47\]](#page-8-17) given by  $p_m = p - \gamma_0 \varepsilon_{ij} \nabla_i u_j$  and  $\Delta$  is the Laplacian operator. Because we exclusively consider no-slip boundary conditions which do not depend on stress, it is more convenient to solve the fluid profile for the modified pressure rather than for the actual pressure.

### <span id="page-1-1"></span>III. ODD OSEENLET

We now consider the effect of a non-vanishing Reynolds number on the flow past an obstacle, which in the lab frame can be considered translating. We work in the co-moving frame, so that  $U_i = U_i^{\infty}$ , where  $U_i^{\infty}$  is the far field fluid velocity as seen from the spherical obstacle. When considering low Reynolds number flow past a sphere, one runs into the Whitehead paradox [\[40–](#page-8-14)[43\]](#page-8-12), which is the finding that is not possible to obtain a low Reynolds number correction to Stokes flow when one assumes the convective term  $\propto$  Re in Eq. [\(3b\)](#page-1-4) to be globally negligible at leading order. To resolve this, we use asymptotic matching [\[39,](#page-8-9) [48,](#page-8-18) [49\]](#page-8-19) which accounts for the fact that the convective term always dominates over viscous contributions far away from the object that causes the disturbance by finding inner and outer solutions to distinct expansions of Eq.  $(3)$ , which are matched to each other at the boundary of their respective regimes of validity.

## <span id="page-2-0"></span>A. Zeroth inner solution

<span id="page-2-1"></span>For the inner solutions, we expand our fluid velocity as

$$
u_i = u_i^{(0)} + \text{Re } u_i^{(1)} + \mathcal{O}(\text{Re}^2) , \qquad (4a)
$$

p_{\rm m} = p_{\rm m}^{(0)} + \text{Re} \, p_{\rm m}^{(1)} + \mathcal{O}(\text{Re}^2) \quad . \tag{4b}

Eq.  $(4)$  means that at leading order, Eq.  $(1)$  is given by

$$
\nabla_i u_i^{(0)} = 0 \quad , \tag{5a}
$$

$$
(\delta_{ij} + \gamma_0 \varepsilon_{ij}) \Delta u_j^{(0)} - \nabla_i p_m^{(0)} = 0 \quad , \tag{5b}
$$

Working in the co-moving frame with the sphere's center as the origin, the boundary conditions we impose are given by

$$
\lim_{r \to \infty} u_i = e_i \quad , \quad u_i|_{r=1} = 0 \quad , \tag{6}
$$

where  $r = \sqrt{x^2 + y^2 + z^2}$  and  $e_i = U_i^{\infty}/|U^{\infty}|$ . Eq. [\(5\)](#page-2-2) has been solved for the boundary conditions of Eq. [\(6\)](#page-2-3) in Refs. [\[29,](#page-7-22) [30,](#page-7-23) [38\]](#page-8-8) by going to Fourier space. We now show a distinct derivation which does not require going to Fourier space because we wish to use the same approach to derive the odd oseenlet in App. [A.](#page-8-0) To understand how [\(5\)](#page-2-2) is solved for flow around a sphere, we first note that far away from the sphere, it can be treated as if the total Stokes force  $\mathcal{F}_i^{(0)}$  were localized at a singular point [\[50\]](#page-8-20). We can thus rewrite Eq. [\(5\)](#page-2-2) as

where  $\delta$  is the Dirac delta function located at  $x_i = 0$ and and  $\mathcal{F}^{(0)}$  is the dimensionless total force on the sphere. We furthermore introduced primed point-force fields, which are related to the original fields as

$$
u_i^{\prime(0)} = u_i^{(0)} + \mathcal{O}(r^{-2}) \quad , \quad p_{\text{m}}^{\prime(0)} = p_{\text{m}}^{(0)} + \mathcal{O}(r^{-3}) \quad , \quad (8)
$$

We first solve for pressure by taking the divergence of Eq.  $(3)$ , this yields

$$
p_{\rm m}^{\prime (0)} = \mathcal{F}_i^{(0)} \nabla_i \frac{1}{4\pi r} + \gamma_o \varepsilon_{ij} \nabla_i u_j^{\prime (0)} \quad , \tag{9}
$$

where we used that  $\delta = -\Delta \frac{1}{4\pi r}$ . Plugging this back into Eq.  $(7b)$ , we obtain

$$
\left[\delta_{ij}\Delta + \gamma_o(\varepsilon_{ij}\Delta - \varepsilon_{kj}\nabla_i\nabla_k)\right]u_j'^{(0)} + \frac{\mathcal{F}_j^{(0)}}{4\pi}(\delta_{ij}\Delta - \nabla_i\nabla_j)\frac{1}{r} = 0

We solve for  $u_j^{\prime(0)}$  perturbatively in  $\gamma_0$  [\[4,](#page-7-4) [29,](#page-7-22) [30\]](#page-7-23). For this, we define for a general function  $f$ 

$$
f = f^{(s)} + \gamma_0 f^{(o)} + \mathcal{O}(\gamma_o^2) \quad , \tag{11}
$$

At zeroth order in  $\gamma_o$ , we can then find the point-force solution given by [\[50\]](#page-8-20)

<span id="page-2-2"></span>where  $G_{ij}^{(0,s)}$  is the Oseen tensor, which can be expressed as

$$
G_{ij}^{(0,s)} = (\delta_{ij}\Delta - \nabla_i\nabla_j) r . \qquad (13)

To obtain  $u_i^{\prime(0,0)}$ , we plug back Eq. [\(12\)](#page-2-5) into Eq. [\(10\)](#page-2-6), yielding

where  $G_{ij}^{(0, o)}$  is the odd Oseen tensor [\[29\]](#page-7-22) given by

$$
G_{ij}^{(0)} = -\left(\varepsilon_{ij}\delta_{kl} + 2\delta_{l[i}\varepsilon_{j]k}\right)\nabla_k\nabla_l r \quad . \tag{16}
$$

<span id="page-2-4"></span>Having found the point-force solution which provides the leading order fluid profile contributions away from the sphere, let us now go back to the question of how the Stokes equation is solved without assuming that one is far away from the sphere. Because of the symmetric shape of the sphere, the leading order correction to the point-force induced flow is given by the Laplacian of the point-force solution. Specifically, imposing the boundary condition  $u_i|_{r=1} = 0$  leads one to find that the odd viscous flow past a sphere is given by [\[30\]](#page-7-23)

$$
u_i^{(0)} = e_i - \frac{1}{8\pi} \left( 1 + \frac{1}{6} \Delta^2 \right) \left( G_{ij}^{(0,s)} + \gamma_o G_{ij}^{(0,o)} \right) \mathcal{F}_j^{(0)} + \mathcal{O}(\gamma_o^2) ,
$$
\n(17)

where the corresponding total Stokes force is required to be [\[30,](#page-7-23) [38,](#page-8-8) [45\]](#page-8-15)

$$
\mathcal{F}_i^{(0)} = \left( C_D^{(0)} \delta_{ij} + C_L^{(0)} \varepsilon_{ij} \right) e_j \quad , \tag{18}
$$

<span id="page-2-8"></span>

C_D^{(0)} = 6\pi \ , \ C_L^{(0)} = 3\pi\gamma_0 \ . \tag{19}

Restoring the dimensionality and defining the total force  $F_i$ , this means

$$
F_i = 6\pi a \eta_s \left( \delta_{ij} + \frac{1}{2} \gamma_o \varepsilon_{ij} + \mathcal{O}(\gamma_o^2, \text{Re}) \right) U_j^{\infty} \quad , \quad (20)
$$

### <span id="page-3-0"></span>B. First outer solution

Having found the zeroth inner solution, we connect this solution to the outer region to obtain the first outer solution. The boundary outer region is characterized by  $\text{Re } r = \mathcal{O}(1)$ , so that in order to consistently match small Reynolds number corrections, we work with the Oseen coordinate  $\tilde{r} = \text{Re } r$ . For the outer solutions, we expand the fields as

The equation that dictates the first outer solution is the Oseen equation [\[42,](#page-8-11) [44\]](#page-8-13), to wit

Asymptotic matching dictates that we must connect  $u_i^{(1)}$ to the zeroth inner solution. We find the corresponding inner boundary condition to be given by

Eq. [\(23\)](#page-3-3) together with the outer boundary condition and Eq. [\(22\)](#page-3-4) force  $\tilde{u}_i^{(1)}$  to be given by

\tilde{u}_i^{(1)} = -\frac{1}{8\pi} \left( \tilde{G}_{ij}^{(1,s)} + \gamma_0 \tilde{G}_{ij}^{(1,o)} \right) \mathcal{F}_j^{(0)} + \mathcal{O}(\gamma_0^2) \quad , \quad (25a)

$$
p_m^{(1)} = \frac{1}{4\pi} \mathcal{F}_i^{(0)} \tilde{\nabla}_i \frac{1}{\tilde{r}} - \frac{\gamma_o}{8\pi} \varepsilon_{ij} \tilde{\nabla}_i \tilde{G}_{jl}^{(1,s)} \mathcal{F}_l^{(0)} + \mathcal{O}(\gamma_o^2) , \qquad (25b)

where  $\tilde{G}^{(1,s)}_{ij}$  represents the even oseenlet of the form [\[51\]](#page-8-21)

$$
\tilde{G}_{ij}^{(1,s)} = 2\left(\delta_{ij}\tilde{\Delta} - \tilde{\nabla}_j\tilde{\nabla}_i\right) \int_0^{\tilde{\zeta}} \frac{1 - \exp(-\xi)}{\xi} d\xi \quad , \quad (26)

with  $\tilde{\zeta} = \frac{1}{2}(\tilde{r} - \tilde{x}_i e_i)$ .  $\tilde{G}_{ij}^{(1,0)}$  is the odd oseenlet, which is given by (see App. [A](#page-8-0) for a derivation)

$$
\tilde{G}_{ij}^{(1,o)} = 2 \left( \varepsilon_{ij} \delta_{kl} + 2 \delta_{l[i} \varepsilon_{j]k} \right) \tilde{\nabla}_k \tilde{\nabla}_l \exp \left( -\tilde{\zeta} \right) \ . \tag{27}

## <span id="page-3-1"></span>IV. FIRST INNER SOLUTION

Having found the first outer solution, we use asymptotic matching to obtain the outer boundary condition for  $u_i^{(1)}$ . Asymptotic matching of the inner solution to the outer solution at  $\mathcal{O}(Re)$  leads to the outer boundary condition

where  $\zeta = \frac{1}{2}(r - x_i e_i)$  and we used the definitions

D_{ij}^{(\rm s)} = \frac{1}{2} (\delta_{ij} \Delta - \nabla_j \nabla_i) \quad , \tag{29a}

D_{ij}^{(o)} = -\left(\varepsilon_{ij}\delta_{kl} + 2\delta_{l[i}\varepsilon_{j]k}\right)\nabla_k\nabla_l \quad . \tag{29b}
$$

<span id="page-3-3"></span>Expanding Eq. [\(1\)](#page-1-3) up  $\mathcal{O}(Re)$ , one finds that the equations that the first inner solution must satisfy a differential equation given by

<span id="page-3-9"></span><span id="page-3-7"></span><span id="page-3-6"></span><span id="page-3-5"></span>
$$
\nabla_i u_i^{(1)} = 0 \quad , \tag{30a}
$$

$$
(\delta_{ij} + \gamma_0 \varepsilon_{ij}) \Delta u_j^{(1)} - \nabla_i p_{\rm m}^{(1)} = u_j^{(0)} \nabla_j u_i^{(0)} . \qquad (30b)
$$

Until now, we made no assumption about the *direction* of the free-stream velocity with respect to  $\ell_i$ . In order to compute the first inner solution, it is important that we do so. Let us first consider the longitudinal case where  $e_i = \ell_i$ . The longitudinal case is simpler than the transverse case as we retain axial symmetry. For the case with transverse free-stream velocity, we refrain from computing the first inner solution. We instead compute the lift force, which is exists only for the transverse case, directly using the Lorentz reciprocal theorem.

#### <span id="page-3-2"></span>A. Longitudinal free-stream velocity

<span id="page-3-10"></span>For the case  $e_i = \ell_i$ , let us first solve Eq. [\(30\)](#page-3-5) at zeroth order in  $\gamma_o$ . For this, we use the axial symmetry of the longitudinal free-stream velocity to take the stream function ansatz [\[52\]](#page-8-22)

$$
u_{\varpi}^{(1,s)} = -\frac{\partial_z \psi^{(1,s)}}{\varpi} \ , \ u_{\phi}^{(1,s)} = 0 \ , \ u_z^{(1,s)} = \frac{\partial_{\varpi} \psi^{(1,s)}}{\varpi}, \tag{31}
$$

where  $\varpi$ ,  $\phi$  and z are cylindrical coordinates as visualized in Fig. [1.](#page-4-1) The solution that Eq.  $(30)$  and satisfies the inner and outer boundary is given by [\[39,](#page-8-9) [40\]](#page-8-14)

$$
\psi^{(1,s)} = \frac{3}{32} \varpi^2 \left( \frac{1}{r^3} - \frac{3}{r} + 2 \right) \n- \frac{3}{32} \varpi^2 z \left( \frac{1}{r^5} - \frac{1}{r^4} + \frac{1}{r^3} - \frac{3}{r^2} + \frac{2}{r} \right) ,
$$
\n(32)

 $U_z$  immersed in a fluid with viscosities  $\eta_s$ ,  $\eta_o$ . The anisotropy vector  $\ell_i$  of the odd viscous fluid is also pointed in the z-direction.

with  $r =$  $\sqrt{\overline{\omega}^2 + z^2}$ . Now we move to  $u_i^{(1,0)}$ . Firstly, we define  $u_i^{(1,o)} = u_i'^{(1,o)} + u_i''^{(1,o)}$ , with

$$
u_i'^{(1,0)} = 0 \ , \ u_\phi'^{(1,0)} = -\frac{\partial_z \psi^{(1,s)}}{\varpi} \ , \ u_z'^{(1,0)} = 0 \ , \ (33)
$$

so that at  $\mathcal{O}(\gamma_o)$  Eq. [\(30b\)](#page-3-6) reduces to

$$
\Delta u_i''^{(1,o)} - \nabla_i p_{\mathbf{m}}^{(1,o)} = u_j^{(0,s)} \nabla_j u_i^{(0,o)} + u_j^{(0,o)} \nabla_j u_i^{(0,s)} \tag{34}
$$

The right hand side of Eq.  $(34)$  only has a non-vanishing  $\phi$ -component and thus  $u_i^{(1,o)}$  also only has a  $\phi$ -component which is automatically incompressible due to axial symmetry, i.e.  $\nabla_i u_i^{(1,o)} = \omega^{-1} \partial_{\phi} u_{\phi}^{(1,o)} = 0$ . Similarly, axial symmetry forces  $p^{(1,0)}$  to be a constant. Lastly, noting that  $u_{\phi}^{(0,s)}=0$ , Eq. [\(34\)](#page-4-2) thus reduces to

$$
\Delta u_{\phi}^{"(1,0)} = u_j^{(0,s)} \nabla_j u_{\phi}^{(0,0)} . \tag{35}
$$

Before we obtain  $u''^{(1,o)}_{\phi}$  $\psi^{(1,0)}_{\phi}$ , let us consider the outer boundary condition of Eq. [\(28a\)](#page-3-7). Since it holds that

$$
\lim_{r \to \infty} (u_{\phi}^{(1,0)} - u_{\phi}'^{(1,0)}) = \frac{3\varpi^3}{16r^3} , \qquad (36)
$$

we must have

$$
\lim_{r \to \infty} u''^{(1,0)}_{\phi} = \frac{3\varpi^3}{16r^3} . \tag{37}
$$

To solve Eq. [\(35\)](#page-4-3) with the given boundary conditions, we define  $u_{\phi}''^{(1,o)} = \Phi_P + \Phi_H$ .  $\Phi_P$  must obey the equation

$$
\mathcal{D}\Phi_P = u_j^{(0,s)} \nabla_j u_{\phi}^{(0,o)} \quad , \tag{38}
$$

with  $\mathcal{D} = \partial_z^2 - \frac{1}{\omega^2} + \frac{1}{\omega} \partial_{\omega} + \partial_{\omega}^2$ . The solution to Eq. [\(38\)](#page-4-4) is given by

$$
\Phi_P = \frac{1}{32} \varpi \left( -\frac{1}{r^6} - \frac{12}{r^4} \right) \n+ \frac{1}{32} \varpi^3 \left( \frac{3}{4r^8} + \frac{18}{r^6} - \frac{12}{r^5} - \frac{9}{2r^4} + \frac{6}{r^3} \right)
$$
\n(39)

Having obtained the particular solution, we look for the homogeneous solution. Note that

$$
\lim_{r \to \infty} \Phi_P = \frac{3\varpi^3}{16r^3} \quad , \tag{40}
$$

so that we require

$$
\lim_{r \to \infty} \Phi_H = 0 \quad . \tag{41}
$$

 $\Phi_H$  obeys the equation

<span id="page-4-5"></span>
$$
\mathcal{D}\Phi_H = 0 \quad . \tag{42}
$$

Eq.  $(42)$  is solved by

$$
\Phi_H = A_1 \frac{\varpi}{r^3} + A_2 \left( \frac{\varpi}{r^5} - \frac{5\varpi^3}{4r^7} \right) , \qquad (43)
$$

To satisfy the inner no-slip boundary condition of Eq. [\(6\)](#page-2-3), we must take  $A_1 = \frac{1}{5}$  and  $A_2 = \frac{33}{160}$ . Having obtained a complete solution up to first order in odd viscosity and Reynolds number, we then compute the force on the sphere corresponding to this solution. As follows from axial symmetry, there is no lift force or any other linear odd correction to the force, to wit

<span id="page-4-2"></span>
$$
F_i = 6\pi a \eta_s |U^{\infty}| \left(1 + \frac{3}{8} \text{Re} + \mathcal{O}(\gamma_o^2, \text{Re}^2)\right) \ell_i \quad . \quad (44)
$$

However, we do find odd viscous effects through the following dimensionless torque

$$
\mathcal{T}_k^{(1)} = \int_B \epsilon_{ijk} x_i \sigma_{jl}^{(1)} dS_l = \frac{2\pi}{5} \gamma_o + \mathcal{O}(\gamma_o^2) \quad . \tag{45}
$$

<span id="page-4-3"></span>Restoring dimensions, the total torque is given by

$$
T_i = \frac{2\pi}{5} a^2 \eta_s |U^{\infty}| \left(\gamma_o \text{Re} + \mathcal{O}(\gamma_o^2, \text{Re}^2)\right) \ell_i \quad . \tag{46}
$$

We thus find that convection can allow for a sphere to feel torque when moving through an odd viscous fluid in an axially symmetry way. Reflection symmetry prevents such a torque from arising for Stokes flow past spheres [\[45\]](#page-8-15).

### <span id="page-4-0"></span>B. Transverse free-stream velocity

<span id="page-4-4"></span>For the case where the free-stream velocity is transverse to  $\ell_i$ , to explicitly solve Eq. [\(30\)](#page-3-5) in a way that

satisfies the inner and outer boundary conditions is challenging, in part because this forbids usage of stream functions. Fortunately, it turns out that we need not know more about the first inner solution than Eqs. [\(28\)](#page-3-8) and [\(30\)](#page-3-5) in order to obtain the first convective correction to drag and lift force on a translating sphere. This because we can use the Lorentz reciprocal theorem to directly compute these forces instead of obtaining them from the force density corresponding to the first inner solution [\[53,](#page-8-23) [54\]](#page-8-24). The Lorentz reciprocal theorem connects two fluid systems, with the first fluid system being the one we wish to better understand and an *auxiliary fluid system* that is used to accomplish this by means of the Lorentz reciprocal theorem. The first fluid system is one corresponding to the first inner solution represented by fluid velocity  $u_i^{(1)}$ . The auxiliary fluid system labelled by  $*$  is identical to the first fluid system except for the following three things:

- 1. We consider for the auxiliary fluid system a dimensionless free-stream velocity  $e_i^*$  which satisfies  $(e_i^*)^2 = 1$  and  $e_i^* \ell_i = 0$ , but is not necessarily parallel to  $e_i$ , as a parallel  $e_i^*$  would not allow one to extract lift force using the Lorentz reciprocal theorem [\[34\]](#page-8-4).
- 2. For the auxiliary fluid system, we consider Stokes flow, i.e. flow which corresponds to the zeroth inner solution represented by fluid velocity  $u_i^{*(0)}$ .
- 3. In order for the Lorentz reciprocal theorem to hold for odd fluids, we require that odd viscosity of the second fluid system is given by  $\gamma_o^* = -\gamma_o$  [\[30\]](#page-7-23).

These differences are represented in Fig. [2.](#page-5-0) Starting from Eq. [\(30\)](#page-3-5), the Lorentz reciprocal theorem gives the relation [\[53,](#page-8-23) [54\]](#page-8-24)

$$
\int_{S_{\infty}} \left( u_j^{*(0)} \sigma_{ij}^{(1)} - u_j^{(1)} \sigma_{ij}^{*(0)} \right) dS_i = \int_{V_{\infty}} u_i^{(0)} \nabla_i u_j^{(0)} u_j^{*(0)} dV, \tag{47}
$$

where  $S_{\infty}$  is the surface of an infinitely large sphere formed around the sphere with no-slip boundary conditions and  $V_{\infty}$  is the volume enclosed by  $S_{\infty}$  and surrounding  $B$ , the boundary of the no-slip sphere. To work out Eq. [\(47\)](#page-5-1), we introduce the definitions

<span id="page-5-1"></span>
$$
I_1 = \int_{S_{\infty}} u_j^{*(0)} \sigma_{ij}^{(1)} dS_i , \qquad (48a)
$$

$$
I_2 = -\int_{S_{\infty}} u_j^{(1)} \sigma_{ij}^{*(0)} dS_i , \qquad (48b)
$$

<span id="page-5-4"></span>
$$
I_3 = \int_{V_{\infty}} u_i^{(0)} \nabla_i u_j^{(0)} u_j^{*(0)} dV \tag{48c}
$$

'For the first two terms it holds that because the sphere with surface  $S_{\infty}$  is infinitely large, any contribution to the integrand which is  $\mathcal{O}(r^{-3})$  can be ignored. To take advantage of this fact, let us introduce for a general field f the notation

<span id="page-5-2"></span>
$$
f = \sum_{n=0} (f)_{-n} r^{-n} , \qquad (49)
$$

where  $(f)_{-n}$  has no further r-dependence. We first consider  $I_1$ , which can be rewritten as

$$
I_1 = \int_{S_{\infty}} (\sigma_{ij}^{(1)})_{-1} \left[ (u_j^{*(0)})_0 r + (u_j^{*(0)})_{-1} r^{-2} \right] dS_i +
$$
  
+ 
$$
\int_{S_{\infty}} (\sigma_{ij}^{(1)})_{-2} (u_j^{*(0)})_0 r^{-2} dS_i .
$$
 (50)

 $u_j^{*(0)}$  is fully even under  $x_i \to -x_i$  and since Eq. [\(50\)](#page-5-2) is a surface integral,  $(\sigma_{ij}^{(1)})_{-1}$  and  $(\sigma_{ij}^{(1)})_{-2}$  must be odd under  $x_i \rightarrow -x_i$  in order for  $I_1$  to be non-vanishing.  $(\sigma_{ij}^{(1)})_{-1}$  is fully determined by  $(p_m)_{-1}$  and  $(u_j^{(1)})_0$ , which are given by Eq. [\(28\)](#page-3-8). Eq. [\(28b\)](#page-3-9) tells us that  $(p_m)_{-1}$  is even under  $x_i \rightarrow -x_i$ . For the remaining part of the stress to give a contribution odd under  $x_i \rightarrow -x_i$  requires  $(u_j^{(1)})_0$  to be even under  $x_i \to -x_i$ . From Eq. [\(28b\)](#page-3-9) it follows that  $(u_j^{(1)})_0$  has a part that is even and odd under  $x_i \to -x_i$ , but the part that is even under  $x_i \to -x_i$  is constant. We define this constant part to be  $J_{jk}^{(1)}\mathcal{F}_k^{(0)}$  $k^{(0)}$ . From Eq. [\(28b\)](#page-3-9) we learn that  $J_{jk}^{(1)}$  is given by

$$
J_{ij}^{(1)} = \frac{1}{32\pi} \left( 3\delta_{ij} - e_i e_j - 2\gamma_o \varepsilon_{ij} \right) . \tag{51}
$$

Because this term is constant, it vanishes when computing the corresponding viscous stress, making  $(\sigma_{ij}^{(1)})_{-1}$ uniformly even under  $x_i \rightarrow -x_i$ . Therefore, this contribution vanishes, and Eq. [\(50\)](#page-5-2) simplifies to

<span id="page-5-3"></span>
$$
I_1 = e_j^* \int_{S_{\infty}} \sigma_{ij}^{(1)} dS_i . \qquad (52)
$$

 $I_1$  can thus be related to the desired  $\mathcal{F}_i^{(1)}$  whose expression is given by

$$
\mathcal{F}_i^{(1)} = \int_B \sigma_{ij}^{(1)} dS_j \quad . \tag{53}
$$

Specifically, from Eq. [\(30b\)](#page-3-6) it follows that

$$
\int_{B+S_{\infty}} \left( \sigma_{ij}^{(1)} - u_j^{(0)} u_j^{(0)} \right) dS_j = 0 \quad . \tag{54}
$$

Eq. [\(54\)](#page-6-1) simplifies by noting that  $u_j^{(0)} = 0$  on B. Furthermore, since  $u_j^{(0)}$  is fully even under  $x_i \rightarrow -x_i$ , we have

$$
\int_{B+S_{\infty}} u_j^{(0)} u_j^{(0)} dS_j = 0 \quad , \tag{55}
$$

leaving us with

$$
\mathcal{F}_i^{(1)} = -\int_{S_{\infty}} \sigma_{ij}^{(1)} dS_j \quad , \tag{56}
$$

Eq. [\(54\)](#page-6-1) can then be used to obtain

$$
I_1 = -e_j^* \mathcal{F}_j^{(1)} \t . \t (57)
$$

We then consider  $I_2$ , which can be rewritten as

$$
I_2 = -\int_{S_{\infty}} r^{-2} (u_j^{(1)})_0 (\sigma_{ij}^{*(0)})_{-2} dS_i , \qquad (58)
$$

because  $(\sigma_{ij}^{*(0)})_{-1} = 0$ .  $(\sigma_{ij}^{*(0)})_{-2}$  is odd under  $x_i \to$  $-x_i$ , so that only the even part of  $(u_j^{(1)})_0$  can contribute. Therefore, using Eq.  $(51)$ ,  $I_2$  simplifies to

$$
I_2 = -J_{jk}^{(1)} \mathcal{F}_k^{(0)} \int_{S_{\infty}} \sigma_{ij}^{*(0)} dS_i , \qquad (59)
$$

Similar to Eq. [\(56\)](#page-6-2), it holds for the zeroth order Stokes force that

$$
\mathcal{F}_{i}^{*(0)} = -\int_{S_{\infty}} \sigma_{ij}^{*(0)} dS_{j} \quad , \tag{60}
$$

so that Eq. [\(59\)](#page-6-3) turns into

$$
I_2 = -J_{jk}^{(1)} \mathcal{F}_j^{*(0)} \mathcal{F}_k^{(0)} . \tag{61}
$$

Lastly,  $u_i^{(0)}$  is fully even under  $x_i \rightarrow -x_i$ , making the integrand of  $I_3$  fully odd under  $x_i \rightarrow -x_i$ , and thus  $I_3 =$ 0. Combining the results for  $I_1$  and  $I_2$ , Eq. [\(47\)](#page-5-1) narrows down to

<span id="page-6-4"></span>
$$
\mathcal{F}_{j}^{(1)} e_{j}^{*} = J_{jk}^{(1)} \mathcal{F}_{j}^{*(0)} \mathcal{F}_{k}^{(0)} . \qquad (62)
$$

We now consider two choices for  $e_i^*$  which enable us to extract drag and lift force respectively. First, we take  $e_i^* = e_i$ . Using Eq. [\(51\)](#page-5-3), Eq. [\(62\)](#page-6-4) then reduces to the

formula for the convective correction to drag force [\[39,](#page-8-9) [40,](#page-8-14) [53,](#page-8-23) [54\]](#page-8-24)

$$
\mathcal{F}_j^{(1)} e_j = C_D^{(1)} = \frac{9\pi}{4} + \mathcal{O}(\gamma_o^2) \quad , \tag{63}
$$

<span id="page-6-1"></span>Let us now consider the case  $e_i^* = \varepsilon_{ij} e_j$ . We find the convective correction to lift force to be given by

$$
\varepsilon_{ij} \mathcal{F}_i^{(1)} e_j = C_L^{(1)} = \frac{9\pi}{16} \gamma_o + \mathcal{O}(\gamma_o^2) \quad . \tag{64}
$$

Using Eq. [\(19\)](#page-2-8) and restoring the dimensionality, we finally obtain the total force

$$
F_i = 6\pi a \left[ \eta_s \left( 1 + \frac{3}{8} \text{Re} \right) \delta_{ij} + \frac{1}{2} \eta_o \left( 1 + \frac{3}{16} \text{Re} \right) \varepsilon_{ij} + \mathcal{O}(\text{Re}^2, \gamma_o^2) \right] U_j^{\infty} .
$$
\n(65)

### <span id="page-6-0"></span>V. DISCUSSION

<span id="page-6-3"></span><span id="page-6-2"></span>In this work we studied the effect of convection for odd viscous flow past a sphere and computed low Reynolds number corrections to the corresponding forces and torques. Since a low Reynolds number expansion is a singular problem, we obtained a solution based on asymptotic matching of an inner and outer solution [\[40\]](#page-8-14). We considered two cases, namely the case where the vector  $\ell_i$ , which represents the intrinsic rotation of the odd viscous fluid is parallel and orthogonal to the free-stream velocity. For the longitudinal case, we could use axial symmetry to fully perform the asymptotic matching up to first order. Due to axial symmetry, lift force vanishes, however we do find that the interplay between convection and odd viscosity can turn on torque for a translating sphere. Torque does not arise for Stokes flow, because in this case a coupling between torque and translation is ruled out by the reflection symmetry of Stokes equation [\[45\]](#page-8-15). For the transverse case, the computation of convective effects on flow is more involved due to the absence of axial symmetry. A tool that was used to still be enabled to compute the first Reynolds number correction to Stokes lift is the odd generalization of the Lorentz reciprocal theorem [\[35\]](#page-8-5). We only considered the case of lift force on a sphere, however it is known that the Lorentz reciprocal theorem allows for making general statements about forces on non-spherical obstacles [\[53](#page-8-23)[–56\]](#page-8-25). In particular, this was found to be true for the case where the obstacle is such that its shape alone cannot induce lift. For the case where the obstacle gives rise to lift for the case where there is only shear viscous flow, the term  $I_3$ in Eq. [\(48c\)](#page-5-4) gives rise to a contribution to the lift force that requires full knowledge of the Stokes flow induced by the obstacle [\[54\]](#page-8-24). For the same reason, it is not possible to find a shape-independent prediction for the first Reynolds number correction to odd viscosity induced lift force on an obstacle, even when the shape of this obstacle is such that it would not generate lift without odd

viscosity. However, the Lorentz reciprocal theorem still allows efficiently computing this term for specific obstacle shapes for which  $I_3$  vanishes by symmetry, as is the case for a spherical obstacle. We exclusively considered the first order odd viscous corrections to shear viscous flow, it would be interesting to see how our results generalize to the case of a non-perturbative odd viscosity, as has been done for the case of Stokes flow. [\[38\]](#page-8-8).

## <span id="page-8-0"></span>Appendix A: Computation of odd oseenlet

To derive the outer solution which obeys the inner boundary conditions Eq. [\(23\)](#page-3-3), we start from Eq. [\(22\)](#page-3-4) and again add a point-force which approximates the sphere at distances far away from it. Introducing the point force yields the equations

$$
\tilde{\nabla}_i \tilde{u}'_i^{(1)} = 0 \quad , \tag{A1a}
$$

$$
(\delta_{ij} + \gamma_0 \varepsilon_{ij}) \tilde{\Delta} \tilde{u}'^{(1)}_j - \tilde{\nabla}_i \tilde{p}'^{(1)}_m = e_j \tilde{\nabla}_j \tilde{u}'^{(1)}_i + \mathcal{F}_i^{(0)} \tilde{\delta} , \qquad (A1b)
$$

where  $\delta$  is the three-dimensional Dirac delta function located at the center of the sphere. Following Ref. [\[51\]](#page-8-21), we take the divergence of Eq.  $(A1b)$  to obtain

$$
\tilde{\Delta}\tilde{p}_{m}^{\prime(1)} = -\mathcal{F}_{i}^{(0)}\nabla_{i}\tilde{\delta} + \gamma_{o}\varepsilon_{ij}\tilde{\Delta}\tilde{\nabla}_{i}u_{j}^{\prime(1)}\quad.\tag{A2}
$$

Using the relation  $\tilde{\delta} = -\tilde{\Delta} \frac{1}{4\pi \tilde{r}}$ , Eq. [\(A2\)](#page-8-27) can be solved as

$$
\tilde{p}_{\mathbf{m}}^{\prime(1)} = \mathcal{F}_i^{(0)} \tilde{\nabla}_i \frac{1}{4\pi \tilde{r}} + \gamma_o \varepsilon_{ij} \tilde{\nabla}_i \tilde{u}_j^{\prime(1)} \quad . \tag{A3}
$$

Plugging this back into Eq. [\(A1b\)](#page-8-26), we obtain

$$
e_j \tilde{\nabla}_j \tilde{u}'_i^{(1)} = \left[ \delta_{ij} \tilde{\Delta} + \gamma_0 (\varepsilon_{ij} \tilde{\Delta} - \varepsilon_{kj} \tilde{\nabla}_i \tilde{\nabla}_k) \right] \tilde{u}'_j^{(1)} + \frac{\mathcal{F}_j^{(0)}}{4\pi} \left( \delta_{ij} \tilde{\Delta} - \tilde{\nabla}_i \tilde{\nabla}_j \right) \frac{1}{\tilde{r}}, \tag{A4}
$$

At zeroth order in  $\gamma_0$ , Eq. [\(A4\)](#page-9-0) can be solved with

$$
\tilde{u}'^{(1,s)}_{i} = -\mathcal{F}_{j}^{(0,s)} \left( \delta_{ij} \tilde{\Delta} - \tilde{\nabla}_{i} \tilde{\nabla}_{j} \right) \mathbb{M} . \tag{A5}
$$

where M is given by

$$
\left(\tilde{\Delta} - e_j \tilde{\nabla}_j\right) \mathbb{M} = \frac{1}{4\pi \tilde{r}} \quad . \tag{A6}
$$

Note that the ansatz of Eq.  $(A5)$  is such that Eq.  $(A1a)$  is automatically satisfied. We can take the Laplacian of Eq.  $(A6)$  to find

$$
\left(\tilde{\Delta} - e_j \tilde{\nabla}_j\right) \Delta M = -\tilde{\delta} \quad . \tag{A7}
$$

We define

<span id="page-9-3"></span>
$$
\tilde{\Delta}M = \Phi \exp\left(\frac{\tilde{x}_i e_i}{2}\right) \tag{A8}
$$

so that Eq.  $(A7)$  turns into the Helmholtz equation

<span id="page-9-5"></span><span id="page-9-4"></span>
$$
\tilde{\Delta}\Phi - \frac{1}{4}\Phi = -\tilde{\delta} \quad , \tag{A9}
$$

whose solution is given by [\[51\]](#page-8-21)

$$
\Phi = \frac{1}{4\pi \tilde{r}} \exp\left(-\frac{\tilde{r}}{2}\right) \tag{A10}
$$

With Eq.  $(A10)$ , Eq.  $(A8)$  becomes

<span id="page-9-7"></span><span id="page-9-6"></span>
$$
\tilde{\Delta}M = \frac{\exp\left(-\tilde{\zeta}\right)}{4\pi\tilde{r}},\tag{A11}
$$

with  $\tilde{\zeta} = \frac{1}{2}(\tilde{r} - \tilde{x}_i e_i)$ . Eq. [\(A11\)](#page-9-6) can be solved to find [\[51\]](#page-8-21)

$$
\mathbb{M} = \frac{1}{4\pi} \int_0^{\tilde{\zeta}} \frac{1 - \exp(-\xi)}{\xi} d\xi \quad . \tag{A12}
$$

Having found  $\tilde{u}'^{(1,s)}_i$ , we move on to  $\tilde{u}'^{(1,o)}_i$ . For this, we take the ansatz

$$
\tilde{u}'^{(1,o)}_i = -\mathcal{F}^{(0,s)}_j A_{ijkl} \tilde{\nabla}_k \tilde{\nabla}_l \mathbb{N} - \mathcal{F}^{(0,o)}_j \left( \delta_{ij} \tilde{\Delta} - \tilde{\nabla}_i \tilde{\nabla}_j \right) \mathbb{M} , \qquad (A13)
$$

where  $A_{ijkl}$  is some four-tensor. The second term on the right-hand side of Eq. [\(A13\)](#page-9-7) cancels out the odd part of the point-force term in Eq. [\(A4\)](#page-9-0). Plugging Eq. [\(A13\)](#page-9-7) into Eq. (A4) and considering the contributions  $\mathcal{O}(\gamma_0)$  we find

$$
\mathcal{F}_{j}^{(0,s)} A_{ijkl} \tilde{\nabla}_{k} \tilde{\nabla}_{l} \left( \tilde{\Delta} \mathbb{N} - e_{m} \tilde{\nabla}_{m} \mathbb{N} \right) = -\mathcal{F}_{j}^{(0,s)} \left( \varepsilon_{il} \tilde{\Delta} - \varepsilon_{kl} \tilde{\nabla}_{i} \tilde{\nabla}_{k} \right) \left( \delta_{lj} \tilde{\Delta} - \tilde{\nabla}_{l} \tilde{\nabla}_{j} \right) \mathbb{M} \quad . \tag{A14}
$$

Simplifying leads to

$$
A_{ijkl}\tilde{\nabla}_k\tilde{\nabla}_l\left(\tilde{\Delta}\mathbb{N} - e_m\tilde{\nabla}_m\mathbb{N}\right) = -\left(\varepsilon_{ij}\delta_{kl} + \varepsilon_{jk}\delta_{il} - \varepsilon_{ik}\delta_{lj}\right)\tilde{\nabla}_k\tilde{\nabla}_l\Delta\mathbb{M} \quad . \tag{A15}
$$

To solve Eq. [\(A15\)](#page-9-8), we take

<span id="page-9-8"></span>
$$
A_{ijkl} = \varepsilon_{ij}\delta_{kl} + \varepsilon_{jk}\delta_{il} - \varepsilon_{ik}\delta_{lj} \quad , \tag{A16}
$$

and also impose

<span id="page-10-0"></span>
$$
\tilde{\Delta}N - e_i \tilde{\nabla}_i N = -\tilde{\Delta}M . \qquad (A17)
$$

Note that we have

$$
\tilde{\nabla}_{i}\tilde{u}_{i}^{(1,o)} = -\tilde{\nabla}_{i}\left[\mathcal{F}_{j}^{(0)}(\varepsilon_{ij}\delta_{kl} + \varepsilon_{jk}\delta_{il} - \varepsilon_{ik}\delta_{lj})\tilde{\nabla}_{k}\tilde{\nabla}_{l}\mathbb{N}\right] = -\frac{\mathcal{F}_{j}^{(0)}}{\eta_{s}}(\varepsilon_{kj}\tilde{\nabla}_{k} + \varepsilon_{jk}\tilde{\nabla}_{k})\tilde{\Delta}\mathbb{N} = 0 \quad , \tag{A18}
$$

and thus incompressibility is guaranteed for  $u_i^{(1,o)}$ . Proceeding, we find that with the help of Eq. [\(A11\)](#page-9-6), Eq. [\(A17\)](#page-10-0) can be rewritten as

$$
\tilde{\Delta}N - e_i \tilde{\nabla}_i N = -\frac{\exp\left(-\tilde{\zeta}\right)}{4\pi\tilde{r}}, \qquad (A19)
$$

which is solved when one takes

$$
N = \frac{\exp(-\tilde{\zeta})}{4\pi} \quad . \tag{A20}
$$

The combination of Eqs. [\(A3\)](#page-8-29), [\(A5\)](#page-9-1) and [\(A13\)](#page-9-7) yields Eq. [\(25\)](#page-3-10) in the main text.
