# Tight bounds for rainbow partial $F$-tiling in edge-colored complete hypergraphs

#### Abstract

For an $r$-graph $F$ and integers $n, t$ satisfying $t \leq n / v(F)$, let $\operatorname{ar}(n, t F)$ denote the minimum integer $N$ such that every edge-coloring of $K_{n}^{r}$ using $N$ colors contains a rainbow copy of $t F$, where $t F$ is the $r$-graphs consisting of $t$ vertex-disjoint copies of $F$. The case $t=1$ is the classical anti-Ramsey problem proposed by Erdős-SimonovitsSós ESS75. When $F$ is a single edge, this becomes the rainbow matching problem introduced by Schiermeyer Sch04 and Özkahya-Young HY13.

We conduct a systematic study of $\operatorname{ar}(n, t F)$ for the case where $t$ is much smaller than $\operatorname{ex}(n, F) / n^{r-1}$. Our first main result provides a reduction of $\operatorname{ar}(n, t F)$ to $\operatorname{ar}(n, 2 F)$ when $F$ is bounded and smooth, two properties satisfied by most previously studied hypergraphs. Complementing the first result, the second main result, which utilizes gaps between Turán numbers, determines $\operatorname{ar}(n, t F)$ for relatively smaller $t$. Together, these two results determine $\operatorname{ar}(n, t F)$ for a large class of hypergraphs. Additionally, the latter result has the advantage of being applicable to hypergraphs with unknown Turán densities, such as the famous tetrahedron $K_{4}^{3}$.


Keywords: anti-Ramsey problem, Turán problem, hypergraphs, boundedness, smoothness, stability.

## 1 Intorduction

Given an integer $r \geq 2$, an $r$-uniform hypergraph (henceforth $r$-graph) $\mathcal{H}$ is a collection of $r$-subsets of some finite set $V$. We identify a hypergraph $\mathcal{H}$ with its edge set and use $V(\mathcal{H})$ to denote its vertex set. The size of $V(\mathcal{H})$ is denoted by $v(\mathcal{H})$. The $n$-vertex complete $r$-graph is denoted by $K_{n}^{r}$. The superscript $r$ will be omitted in the case where $r=2$.

Given an $r$-graph $F$ and an integer $t \geq 1$, let $t F$ denote the $r$-graph consisting of $t$ vertexdisjoint copies of $F$. We say that an edge-colored $t F$ is rainbow if no pair of edges in

[^0]$t F$ share the same color. Motivated by the classical anti-Ramsey problem proposed by Erdős-Simonovits-Sós [ESS75], as well as theorems of Schiermeyer [Sch04] and ÖzkahyaYoung HY13 on rainbow matchings, we aim to initiate a systematic study of the following problem in this work.

Problem 1.1. Given an $r$-graph $F$ and positive integers $n, t$ satisfying $t \leq n / v(F)$, determine the minimum value $N$, denoted by $\operatorname{ar}(n, t F)$, such that every surjective edge-coloring $\chi: K_{n}^{r} \rightarrow[N]$ contains a rainbow copy of $t F$.

Before surveying related results, let us introduce some definitions related to Turán problems. Given a family $\mathcal{F}$ of $r$-graphs, we say an $r$-graph $\mathcal{H}$ is $\mathcal{F}$-free if it does not contain any member of $\mathcal{F}$ as a subgraph. The Turán number $\operatorname{ex}(n, \mathcal{F})$ of $\mathcal{F}$ is the maximum number of edges in an $\mathcal{F}$-free $r$-graph on $n$ vertices. The Turán density of $\mathcal{F}$ is defined as $\pi(\mathcal{F}):=\lim _{n \rightarrow \infty} \operatorname{ex}(n, \mathcal{F}) /\binom{n}{r}$. A family $\mathcal{F}$ of $r$-graphs is called nondegenerate if $\pi(\mathcal{F})>0$, and degenerate otherwise. Determining $\operatorname{ex}(n, \mathcal{F})$, even asymptotically, is a central topic in Extremal Combinatorics. For most hypergraphs and degenerate graphs, we do not know the asymptotic behavior of $\operatorname{ex}(n, \mathcal{F})$. Some notoriously hard problems in this area include the Tetradron Conjecture, proposed by Turán Tur41 over 80 years ago, which asserts that $\pi\left(K_{4}^{3}\right)=5 / 9$, and the Even Cycle Problem, proposed by Erdős Erd64a, BS74, which asks for the exponent of ex $\left(n, C_{2 k}\right)$. Here, we refer the reader to surveys [Kee11, FS13] for further results on Turán problems.

The case $t=1$ in Problem 1.1 corresponds to the classical anti-Ramsey problem introduced by Erdős-Simonovits-Sós in [ESS75]. They established the following general relation between the anti-Ramsey number and the Turán number of an $r$-graph $F$ :

$$
\operatorname{ex}\left(n, F_{-}\right)+2 \leq \operatorname{ar}(n, F) \leq \operatorname{ex}\left(n, F_{-}\right)+o\left(n^{r}\right) .
$$

Here, $F_{-}$denotes the family of $r$-graphs obtained from $F$ by removing exactly one edge. Determining the precise form of the error term in the upper bound is a central topic in anti-Ramsey theory. For complete graphs, Erdős-Simonovits-Sós proved that for fixed $\ell \geq 2$ and sufficiently large $n$,

$$
\operatorname{ar}\left(n, K_{\ell+1}\right)=\operatorname{ex}\left(n, K_{\ell}\right)+2 .
$$

The restriction on $n$ was later removed by Montellano-Ballesteros and Neumann-Lara in MBNL02]. Numerous results on graph anti-Ramsey problems have been obtained by various researchers over the past five decades. For related results, we refer the reader to the survey by Fujita-Magnant-Ozeki FCK10. On the other hand, the understanding of hypergraph anti-Ramsey problems is mostly limited to very sparse and special hypergraphs such as linear paths, linear cycles, and linear trees (see e.g. [GLS20, TLY22, LS23a]). Results on nondegenerate hypergraphs, which extends the Erdős-Simonovits-Sós Theorem on complete graphs, were obtained only very recently LS23b, LTY24.

For $t \geq 2$, there are only a few results on Problem 1.1. A theorem of Jiang-Pikhurko JP09] on doubly edge-critical graphs determines $\operatorname{ar}(n, 2 F)$ when $F$ is an edge-critical graph and $n$ is large, where edge-critical means there exists an edge whose removal will decrease the chromatic number. The theorem of Jiang-Pikhurko was extended to hypergraphs very recently LS23b, LTY24, and hence, $\operatorname{ar}(n, 2 F)$ is also known for a certain class of hypergraphs. Schiermeyer [Sch04] and Özkahya-Young [HY13] initiated the study of Problem 1.1 for $F=K_{r}^{r}$ with $r=2$ and $r \geq 3$, respectively. The case $F=K_{3}$ was studied very recently by Wu-Zhang-Li-Xiao in WZLX23. It appears that $K_{2}$ is the only example, even for large $n$, for which Problem 1.1 has been completely solved Sch04, FKSS09, CLT09, HY12.

In this work, we conduct a systematic study of Problem 1.1 for general $r$-graphs $F$, with a focus on the case where $n$ is sufficiently large and $2 \leq t \ll \operatorname{ex}(n, F) / n^{r-1}$. Our first main result is a reduction theorem (Theorem 1.3), which, for a large class of hypergraphs $F$, reduces the problem of determining $\operatorname{ar}(n, t F)$ to determining $\operatorname{ar}(n, 2 F)$ when $t \ll$ $\operatorname{ex}(n, F) / n^{r-1}$. The second main result (Theorem (1.5) utilizes the gap between Turán numbers ex $(n, F)$ and ex $(n,\{F\} \cup F \oplus F)$ (defined in Section 1.2) to determine ar $(n, t F)$ for relatively small $t$. This theorem, combined with the first main result, determines ar $(n, t F)$ for numerous hypergraphs (see Table (1) when $n$ is large and $2 \leq t \ll \operatorname{ex}(n, F) / n^{r-1}$. In addition, the second main theorem also determines $\operatorname{ar}(n, t F)$ for numerous hypergraphs with unknown Turán densities (see Table (2) when $n$ is large and $2 \leq t \ll \sqrt{n}$. This include the famous $K_{4}^{3}$.

Notations. For an $r$-graph $\mathcal{H}$ and a vertex $v \in V(\mathcal{H})$, the link of $v$ in $\mathcal{H}$ is

$$
L_{\mathcal{H}}(v):=\left\{e \in\binom{V(\mathcal{H})}{r-1}: e \cup\{v\} \in \mathcal{H}\right\} .
$$

The degree of $v$ in $\mathcal{H}$ is $d_{\mathcal{H}}(v):=\left|L_{\mathcal{H}}(v)\right|$. The maximum degree of $\mathcal{H}$ is denoted by $\Delta(\mathcal{H})$.

For an $r$-graph $\mathcal{H}$ and a vertex set $S \subseteq V(\mathcal{H})$, we use $\mathcal{H}[S]$ to denote the induced subgraph of $\mathcal{H}$ on $S$, and use $\mathcal{H}-S$ to denote the induced subgraph of $\mathcal{H}$ on $V(\mathcal{H}) \backslash S$.

Throughout this paper, asymptotic notations are taken with respect to $n$.

### 1.1 The reduction theorem

In this subsection, we present the reduction theorem. To state the main result we need some definitions from $\mathrm{HLL}^{+} 23, \mathrm{HHL}^{+} 23$.

Let $F$ be an $r$-graph. For every $n \in \mathbb{N}$, let

$$
\delta(n, F):=\operatorname{ex}(n, F)-\operatorname{ex}(n-1, F) \quad \text { and } \quad d(n, F):=\frac{r \cdot \operatorname{ex}(n, F)}{n} .
$$

Definition 1.2. Let $r \geq 2$ be an integer and $F$ be an $r$-graph.

- For two real numbers $c_{1}, c_{2}>0$, we say $F$ is $\left(c_{1}, c_{2}\right)$-bounded if there exists $N_{0}$ such that every $r$-graph $\mathcal{H}$ on $n \geq N_{0}$ vertices with

$$
\Delta(\mathcal{H}) \geq d(n, F)+c_{1}\binom{n-1}{r-1} \quad \text { and } \quad|\mathcal{H}| \geq\left(1-c_{2}\right) \cdot \operatorname{ex}(n, F)
$$

contains a copy of $F$. We say $F$ is bounded if it is $\left(c_{1}, c_{2}\right)$-bounded for some constants $c_{1}, c_{2}>0$.

- We say $F$ is smooth if it is degenerat 1 or there exists $N_{0}$ such that

$$
\begin{equation*}
|\delta(n, F)-d(n-1, F)| \leq \frac{1-\pi(F)}{8 v(F)}\binom{n}{r-1} \quad \text { for all } n \geq N_{0} . \tag{1}
\end{equation*}
$$

Boundedness and smoothness, introduced in $\mathrm{HLL}^{+} 23, \mathrm{HHL}^{+} 23$, are crucial properties for determining ex $(n, t F)$, the maximum number of edges in an $n$-vertex $r$-graph without

[^1]$t F$. It was shown in $\left[\mathrm{HLL}^{+} 23\right]$ and $\left.\mathrm{HHL}^{+}\right]$that many well-studied nondegenerate and degenerate $r$-graphs (see Table (1) are bounded and smooth, respectively.

The following theorem presents an application of boundedness and smoothness in antiRamsey theory.

Theorem 1.3. Let $r \geq 2$ be an integer. Suppose that $F$ is an $r$-graph that is smooth and $\left(c_{1}, c_{2}\right)$-bounded for constants $c_{1}, c_{2}$ satisfying $0<c_{1} \leq \frac{1-\pi(F)}{12 m}$ and $c_{2}>0$. Then there exists $\delta>0$ and $N_{0}$ such that for every $n \geq N_{0}$ and for every $t \in\left[0, \frac{\delta \cdot \mathrm{ex}(n, F)}{n^{r-1}}\right]$,

$$
\operatorname{ar}(n,(t+2) F)=\binom{n}{r}-\binom{n-t}{r}+\operatorname{ar}(n-t, 2 F) .
$$

Proof of Theorem 1.3 is presented in Section 3 ,

### 1.2 Anti-Ramsey results from gaps between Turán numbers

Complementing the theorem from the previous subsection, we present a theorem that addresses $\operatorname{ar}(n, t F)$ when $t$ is small, particularly for $t=2$, in this subsection.

Given an $r$-graph $F$ and an edge $e \in F$, let $F_{e-}$ denote the $r$-graph obtained from $F$ by removing the edge $e$. To be specific, $F_{e-}:=F \backslash\{e\}$. Recall that $F_{-}=\left\{F_{e-}: e \in F\right\}$. Let $F, F^{\prime}$ be two $r$-graphs, $\left(e, e^{\prime}\right) \in F \times F^{\prime}$ be a pair of edges, and $\phi: e \rightarrow e^{\prime}$ be a bijection. Following the definition in Wag37, KT90, the edge-sum $F \oplus_{\phi} F^{\prime}$ is the $r$-graph obtained from $F_{e-}$ and $F_{e^{\prime}-}^{\prime}$ by identifying $v$ with $\phi(v)$ for all $v \in e$. For convenience, let

$$
F \oplus F^{\prime}:=\left\{F \oplus_{\phi} F^{\prime}: \phi: e \rightarrow e^{\prime} \text { is bijective for some pair }\left(e, e^{\prime}\right) \in F \times F^{\prime}\right\}
$$

denote the collection of all edge-sums of $F$ and $F^{\prime}$ (see Figure (1). A quick observation is that $C_{k} \oplus C_{\ell}=\left\{C_{k+\ell-2}\right\}$ for all $k, \ell \geq 3$.

For convenience, we slightly abuse notation by letting $\{F\} \cup F \oplus F:=\{F\} \cup(F \oplus F)$.
Note that ex $(n, F)-\operatorname{ex}(n,\{F\} \cup F \oplus F) \geq 0$ for every $F$ and for every $n \in \mathbb{N}$.
Definition 1.4. An r-graph $F$ is edge-sensitive if there exists $N_{0}$ such that

$$
\operatorname{ex}(n, F)-\operatorname{ex}(n,\{F\} \cup F \oplus F) \geq 2 v(F)|F|\binom{n-1}{r-1} \quad \text { for all } \quad n \geq N_{0}
$$

The definition of edge-sensitive is motivated by that of edge-critical. It follows easily from the classical Erdős-Stone-Simonovits Theorem [ES66] that every edge-critical graph is edge-sensitive. However, as shown by the even cycle $C_{2 k}$, the converse does not hold (see Proposition 1.6 (ii).

The following theorem provides an application of the gap between ex $(n, F)$ and $\operatorname{ex}(n,\{F\} \cup$ $F \oplus F)$ in anti-Ramsey theory.

Theorem 1.5. Let $r \geq 2$ be an integer and $F$ be an $r$-graph. For every $n \in \mathbb{N}$,

$$
\operatorname{ar}(n,(t+1) F)=\operatorname{ex}(n, t F)+2 \quad \text { for } \quad 1 \leq t \leq \sqrt{\frac{\operatorname{ex}(n, F)-\operatorname{ex}(n,\{F\} \cup F \oplus F)}{2 v(F)|F|\binom{n-1}{r-1}}}
$$

In particular, if $F$ is edge-sensitive, then for sufficiently large $n$,

$$
\operatorname{ar}(n, 2 F)=\operatorname{ex}(n, F)+2
$$

Proof of Theorem 1.5 is presented in Section 2.

### 1.3 Applications

In this subsection, we present some applications of Theorems 1.3 and 1.5 . Let us first present a simple result concerning Turán numbers.

Proposition 1.6. The following statements hold.
(i) For every $r$-graph $F$, if $\pi\left(F_{-}\right)<\pi(F)$, then $F$ is edge-sensitive.
(ii) For every integer $k \geq 2$, the even cycle $C_{2 k}$ is edge-sensitive.
(iii) For the Fano Plane $\mathbb{F}$, we have $\pi\left(\mathbb{F}_{-}\right)<\pi(\mathbb{F})$.

In the following table, we summarize hypergraphs that exhibit boundedness/smoothness and are edge-sensitive. Proofs for the boundedness/smoothness can be found in either $\left.\mathrm{HLL}^{+} 23\right]$ (for nondegenerate hypergraphs) or $\mathrm{HHL}^{+}$(for degenerate hypergraphs). Definitions for these hypergraphs are included in the Appendix.

In the following table, we summerize edge-sensitive hypergraphs for which the boundedness and smoothness are unknown.

Having completed these preparations, we can now present the corollary of Theorems 1.3 and 1.5 .

Corollary 1.7. Let $r \geq 2$ be an integer and $F$ be an r-graph. There exist $\delta>0$ and $N_{0}$ such that the following statements hold for all $n \geq N_{0}$.
(i) If $F$ is contained in Table 1, then

$$
\operatorname{ar}(n,(t+2) F)=\binom{n}{r}-\binom{n-t}{r}+\operatorname{ex}(n, F)+2 \quad \text { for every } \quad 0 \leq t \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{n^{r-1}}
$$

(ii) If $F$ is contained in Table 2, then

$$
\operatorname{ar}(n,(t+1) F)=\operatorname{ex}(n, t F)+2 \quad \text { for every } \quad 1 \leq t \leq \delta \sqrt{n}
$$

(iii) If $F$ is nondegenerate and contains an edge $e \in F$ such that $F \backslash\{e\}$ is $r$-partite, then

$$
\operatorname{ar}(n,(t+1) F)=\operatorname{ex}(n, t F)+2 \quad \text { for every } \quad 1 \leq t \leq \delta \sqrt{n}
$$

Corollary 1.7 (iii) follows easily from a theorem of Erdős Erd64b], which implies that an $r$-graph is degenerate iff it is $r$-partite.

Proof of Proposition 1.6 is presented in Section 4.

## 2 Proof of Theorem 1.5

In this section, we prove Theorem 1.5. The lower bound in Theorem 1.5 comes from the following simple fact, which holds for all $r$-graphs.

Fact 2.1. For every $r$-graph and positive integers $n, t$ with $1 \leq t \leq n / v(F)$,

$$
\operatorname{ex}(n, t F)+2 \leq \operatorname{ar}(n,(t+1) F) \leq \operatorname{ex}(n,(t+1) F)+1
$$

Proof of Fact 2.1. The upper bound in Fact 2.1 is trivial, so it suffices to prove the lower bound. Let $N:=\operatorname{ex}(n, t F)$. Fix a $t F$-free subgraph $\mathcal{H} \subset K_{n}^{r}$ with exactly ex $(n, t F)$ edges. Let $\chi: K_{n}^{r} \rightarrow \mathbb{N}$ be an edge-coloring satisfying

- the induced coloring of $\chi$ on $\mathcal{H}$ is rainbow and use colors in $[N]$,
- the induced coloring of $\chi$ on $K_{n}^{r} \backslash \mathcal{H}$ uses only the color $N+1$.

Suppose to the contrary that there exists a rainbow copy of $(t+1) F$ in $K_{n}^{r}$ under $\chi$. Then at most one $F$ in this $(t+1) F$ can use the color $N+1$, meaning that there is a rainbow copy of $t F$ using colors from [ $N$ ]. However, this is impossible since $\mathcal{H}$ is $t F$-free.

Next, we prove the upper bound in Theorem [1.5.

Proof of Theorem 1.5. Fix integers $m \geq r \geq 2$ and an $m$-vertex $r$-graph $F$. Let $n$ be a sufficiently large integer and $t$ be an integer satisfying

$$
1 \leq t \leq \sqrt{\frac{\operatorname{ex}(n, F)-\operatorname{ex}(n,\{F\} \cup F \oplus F)}{\left.2 m|F| \begin{array}{c}
n-1 \\
r-1
\end{array}\right)}} .
$$

Let $N:=\operatorname{ex}(n, t F)+2$. Suppose to the contrary that there exists a surjective edge-coloring $\chi: K_{n}^{r} \rightarrow[N]$ without any rainbow copy of $(t+1) F$. Let $\mathcal{H} \subset K_{n}^{r}$ be a rainbow (spanning) subgraph with the maximum number of edges. Then, by assumption, $\mathcal{H}$ is $(t+1) F$-free and

$$
|\mathcal{H}|=N=\operatorname{ex}(n, t F)+2 .
$$

In particular, this implies that

- there exists a copy of $t F$, denoted by $\Gamma$, in $\mathcal{H}$, and
- for every $e \in \Gamma$, there exists a copy of $t F$, denoted by $\Gamma_{e}$, in $\mathcal{H} \backslash\{e\}$.

Let $B:=V(\Gamma) \cup\left(\bigcup_{e \in \Gamma} V\left(\Gamma_{e}\right)\right)$. Note that

$$
|B| \leq(1+t|F|) \cdot t m \leq 2 t^{2} m|F| .
$$

Let $U:=V(\mathcal{H}) \backslash B$ and $\mathcal{G}:=\mathcal{H}-B$. The choice of $t$ ensures that

$$
\begin{aligned}
|\mathcal{G}| \geq \mathcal{H}-|B|\binom{n-1}{r-1} & \geq \operatorname{ex}(n, t F)+2-2 t^{2} m|F|\binom{n-1}{r-1} \\
& \geq \operatorname{ex}(n, t F)+2-(\operatorname{ex}(n, F)-\operatorname{ex}(n,\{F\} \cup F \oplus F)) \\
& >\operatorname{ex}(n,\{F\} \cup F \oplus F) .
\end{aligned}
$$

It is clear that $\mathcal{G}$ is $F$-free, since any copy of $F$ in $\mathcal{G}$ would form a copy of $(t+1) F$ with $\Gamma$. So it follows from the inequality above that $\mathcal{G}$ contains a member in $F \oplus F$ as a subgraph. Let us assume that $F_{e-}^{1}, F_{e^{\prime}-}^{2} \subset \mathcal{G}$ are copies of two (not necessarily distinct) members in $F_{-}$such that $F_{e-}^{1} \cup F_{e^{\prime}-}^{2}$ is a copy of some member in $F \oplus F$. Note that $e$ and $e^{\prime}$ represent the same $r$-set in $U$. Let us consider the color of $e$ under $\chi$. Since $F_{e-}^{1} \cup F_{e^{\prime}-}^{2}$ - is rainbow, either $F^{1}:=F_{e-}^{1} \cup\{e\} \cong F$ or $F^{2}:=F_{e-}^{2} \cup\left\{e^{\prime}\right\} \cong F$ is rainbow. By symmetry, we may assume that $F^{1}$ is rainbow.

- If $\chi(e)$ is different from all the colors in $\Gamma$, then $\Gamma \sqcup F^{1}$ is a rainbow copy of $(t+1) F$.
- If $\chi(e)=\chi(f)$ for some edge $f \in \Gamma$, then $\Gamma_{f} \sqcup F^{1}$ is a rainbow copy of $(t+1) F$.

In both cases, we obtain a rainbow copy of $(t+1) F$, which is a contradiction.

## 3 Proof of Theorem 1.3

In this section, we use Theorem 3.2 to prove Theorem 1.3. The lower bound for Theorem 1.3 comes from the following fact, which holds for all $r$-graphs.

Fact 3.1. For every $r$-graph and integers $n, t$ with $1 \leq t \leq n / v(F)$,

$$
\operatorname{ar}(n,(t+2) F) \geq\binom{ n}{r}-\binom{n-t}{r}+\operatorname{ar}(n-t, 2 F) .
$$

Proof of Fact 3.1. Let $N:=\binom{n}{r}-\binom{n-t}{r}+\operatorname{ar}(n-t, 2 F)-1$. It suffices to show there exists a surjective edge-coloring $\chi: K_{n}^{r} \rightarrow[N]$ without any rainbow copy of $(t+2) F$.

Let $M:=\operatorname{ar}(n-t, 2 F)-1$ and fix a surjective edge-coloring $\chi^{\prime}: K_{n-t}^{r} \rightarrow[M]$ without any rainbow copy of $2 F$. The existence of such a coloring is guaranteed by the definition of $\operatorname{ar}(n-t, 2 F)$. Let $L:=[n-t+1, \ldots, n]$ and note that $|L|=t$. Let $\mathcal{G}:=K_{n}^{r}-L \cong K_{n-t}^{r}$. Note that $\left|K_{n}^{r} \backslash \mathcal{G}\right|=\binom{n}{r}-\binom{n-t}{r}=N-M$. Let $\chi: K_{n}^{r} \rightarrow[N]$ be an edge-coloring such that

- the induced coloring of $\chi$ on $\mathcal{G}$ is identical to $\chi^{\prime}$, and
- the induced coloring of $\chi$ on $K_{n}^{r} \backslash \mathcal{G}$ is rainbow and use colors from $[M+1, \ldots, N]$.

Note that $\chi$ is an edge-coloring of $K_{n}^{r}$ and uses exactly $N$ colors. Suppose to the contrary that there exists a rainbow copy of $(t+2) F$ under the coloring $\chi$. Then there are at most $t$ copies of $F$ use vertices from $L$, which means that there are at least two copies $F$ that are contained in $\mathcal{G}$. However, this contradicts the fact that the coloring $\chi^{\prime}$ does not contain any rainbow copy of $2 F$.

Next, we consider the upper bound in Theorem [1.3, A key ingredient in its proof is the following stability theorem concerning near-extremal $r$-graphs without $t F$. The proof of this stability theorem is postponed to Section 5 .

Theorem 3.2. Let $m \geq r \geq 2$ be integers. Suppose that $F$ is an $m$-vertex $r$-graph that is smooth and $\left(c_{1}, c_{2}\right)$-bounded for constants $c_{1}, c_{2}$ satisfying $0<c_{1} \leq \frac{1-\pi(F)}{12 m}$ and $c_{2}>0$. Then there exists $N_{0}$ such that the following holds for all $n \geq N_{0}$ and $t<\frac{\delta \cdot \mathrm{\delta ex}(n, F)}{2 m\binom{n-1)}{r-1}}$, where $\delta:=\min \left\{\frac{c_{2}}{4}, \frac{1-\pi(F)}{24 m}, \frac{1}{100 r^{2}}\right\}$. Every $n$-vertex $(t+2) F$-free $r$-graph $\mathcal{H}$ with at least

$$
\binom{n}{r}-\binom{n-t}{r}+\operatorname{ex}(n-t, F)-\frac{1-\pi(F)}{30}\binom{n}{r-1}
$$

edges contains at least $t$ vertices with degree at least $d(n, F)+\frac{1-\pi(F)}{7 m}\binom{n-1}{r-1}$.
The following result, which follows easily from the definition of boundedness (see e.g. $\mathrm{HHL}^{+} 23$, Lemma 3.2] and [HLL ${ }^{+}$23, Claim 3.7] for a proof), will be used in proofs of both Theorems 1.3 and 3.2

Lemma 3.3. Let $n \geq r \geq 2$ be integers, $c_{1}, c_{2}, \delta_{1}, \delta_{2}>0$ be real numbers, and $F$ be a $\left(c_{1}, c_{2}\right)$-bounded $r$-graph. Suppose that $\mathcal{H}$ is an $n$-vertex $r$-graph and $v \in V(\mathcal{H})$ is a vertex satisfying

$$
|\mathcal{H}| \geq\left(1-c_{2}+\delta_{1}\right) \cdot \operatorname{ex}(n, F) \quad \text { and } \quad d_{\mathcal{H}}(v) \geq d(n, F)+\left(c_{1}+\delta_{2}\right)\binom{n-1}{r-1} .
$$

Then for every set $R \subset V(\mathcal{H}) \backslash\{v\}$ of size at most $\min \left\{\frac{\delta_{1} \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}}, \frac{\delta_{2}(n-1)}{r-1}\right\}$, there exists a copy of $F$ in $\mathcal{H}$ that avoids $R$ (i.e. has empty intersection with $R$ ).

Now we present the proof of Theorem 1.3.
Proof of Theorem 1.3. Fix integers $m \geq r \geq 2$ and an $m$-vertex $r$-graph $F$ that is smooth and ( $c_{1}, c_{2}$ )-bounded for constants $c_{1}, c_{2}$ satisfying $0<c_{1}<\frac{1-\pi(F)}{12 m}$ and $c_{2}>0$. Let $\delta:=\min \left\{\frac{c_{2}}{4}, \frac{1-\pi(F)}{24 m}, \frac{1}{100 \mathrm{rm}^{2}}\right\}$ and $n$ be a sufficiently large integer. Simple calculations show that $\min \left\{\frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}}, \frac{\delta(n-1)}{r-1}\right\}=\frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}}$. Let

$$
1 \leq t \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{2 m\binom{n-1}{r-1}}-1 \quad \text { and } \quad N:=\binom{n}{r}-\binom{n-t}{r}+\operatorname{ar}(n-t, 2 F) .
$$

Suppose to the contrary that there exists a surjective edge-coloring $\chi: K_{n}^{r} \rightarrow[N]$ without any rainbow copy of $(t+2) F$. Let $\mathcal{H} \subset K_{n}^{r}$ be a rainbow (spanning) subgraph with the maximum number of edges. By assumption and Fact [2.1, we obtain

$$
\begin{equation*}
|\mathcal{H}| \geq N \geq\binom{ n}{r}-\binom{n-t}{r}+\operatorname{ex}(n-t, F)+2 \tag{2}
\end{equation*}
$$

Let $V:=V(\mathcal{H})=V\left(K_{n}^{r}\right), \alpha:=\frac{1-\pi(F)}{7 m} \geq c_{1}+\delta+\frac{1-\pi(F)}{56 m}$, and

$$
L^{\prime}:=\left\{v \in V: d_{\mathcal{H}}(v) \geq d(n, F)+\alpha\binom{n-1}{r-1}\right\} .
$$

Since $\mathcal{H}$ is $(t+2) F$-free, it follows from (2) and Theorem 3.2 that $\left|L^{\prime}\right| \geq t$. Fix a $t$-subset $L \subset L^{\prime}$ and assume that $L=\left\{v_{1}, \ldots, v_{t}\right\}$. Let $S:=V \backslash L$. Since there are exactly $\binom{n}{r}-\binom{n-t}{r}$ edges in $K_{n}^{r}$ that have nonempty intersection with $L$, the number of colors used by edges in $K_{n}^{r}[S] \cong K_{n-t}^{r}$ is at least $N-\left(\binom{n}{r}-\binom{n-t}{r}\right) \geq \operatorname{ar}(n-t, 2 F)$. This implies that $K_{n}^{r}[S]$ contains a rainbow $2 F$. Let $B_{0} \subset S$ be a vertex set of size $2 m$ such that $K_{n}^{r}\left[B_{0}\right]$ contains a rainbow $2 F$. Let $C$ be the collection of colors used by edges in this copy of $2 F$ and note that $|C|=2|F|$ is a constant. Let $\mathcal{H}^{\prime} \subset \mathcal{H}$ denote the subgraph obtained from $\mathcal{H}$ by removing (at most $2|F|$ ) edges whose colors are within $C$. To complete the proof, it suffices to find a copy of $t F$ in $\mathcal{H}^{\prime}\left[V \backslash B_{0}\right]$, as this, together with the $2 F$ found above, forms a rainbow copy of $(t+2) F$.
Claim 3.4. There exists a copy of $t F$ in $\mathcal{H}^{\prime}\left[V \backslash B_{0}\right]$.
Proof of Claim 3.4. We will find $t$ vertex-disjoint copies of $F$, denoted by $F_{1}, \ldots, F_{t}$, from $\mathcal{H}^{\prime}\left[V \backslash B_{0}\right]$ inductively. To start with, let $R_{1}:=B_{0} \cup\left(L \backslash\left\{v_{1}\right\}\right)$. Notice that

$$
\left|R_{1}\right| \leq t+2 m \leq(2 t+2) m \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}} .
$$

Additionally, (2) implies that $\left|\mathcal{H}^{\prime}\right| \geq \operatorname{ex}(n, F)-2|F| \geq\left(1-c_{2}+\delta\right) \cdot \operatorname{ex}(n, F)$, and the definition of $L^{\prime}$ implies that $d_{\mathcal{H}^{\prime}}\left(v_{1}\right) \geq d(n, F)+\alpha\binom{n-1}{r-1}-2|F| \geq d(n, F)+\left(c_{1}+\delta\right)\binom{n-1}{r-1}$. Thus, by Lemma 3.3, there exists a copy of $F$, denoted by $F_{1}$, in $\mathcal{H}^{\prime}$ that avoids $R_{1}$. Suppose that we have found $i$ vertex-disjoint copies of $F$, namely $F_{1}, \ldots, F_{i}$, from $\mathcal{H}^{\prime}$ for some $i \leq t-1$. Let $R_{i+1}:=\bigcup_{1 \leq j \leq i} V\left(F_{j}\right) \cup\left(L \backslash\left\{v_{i+1}\right\}\right) \cup B_{0}$ and note that

$$
\left|R_{i+1}\right| \leq t+2 m+i m \leq(2 t+2) m \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}},
$$

Similar to the argument above, we have $\left|\mathcal{H}^{\prime}\right| \geq\left(1-c_{2}+\delta\right) \cdot \operatorname{ex}(n, F)$ and $d_{\mathcal{H}^{\prime}}\left(v_{i+1}\right) \geq$ $d(n, F)+\left(c_{1}+\delta\right)\binom{n-1}{r-1}$. So by Lemma 3.3, there exists a copy of $F$, denoted by $F_{i+1}$, in $\mathcal{H}^{\prime}$ that avoids $R_{i+1}$. The choice of $t$ ensures that we can repeat this process $t$ times, hence obtaining $t F \subset \mathcal{H}^{\prime}\left[V \backslash B_{0}\right]$.

Claim 3.4 completes the proof of Theorem 1.3 .

## 4 Proof of Proposition 1.6

In this section, we prove Proposition 1.6. We will need the following stability theorem for the proof of Proposition (1.6 (iii).

Theorem 4.1 (Füredi-Simonovits [FS05], Keevash-Sudakov KS05b]). For every $\varepsilon>0$ there is $\delta>0$ and $N_{0}$ such that every $\mathbb{F}$-free 3 -graph $\mathcal{H}$ on $n \geq N_{0}$ vertices with at least $(3 / 4-\delta)\binom{n}{3}$ edges has bipartition $V(\mathcal{H})=V_{1} \cup V_{2}$ such that $\left|\mathcal{H}\left[V_{1}\right]\right|+\left|\mathcal{H}\left[V_{2}\right]\right|<\varepsilon n^{3}$.

Proof of Proposition [1.6. Let $F$ be an $r$-graph. For every integer $k \geq 1$ the $k$-blow-up of $F$, denoted by $F[k]$, is the $r$-graph obtained from $F$ by replacing each vertex with a set of size $k$ and each edge with the corresponding complete $r$-partite $r$-graph. It is well-known that $\pi(F)=\pi(F[k])$ for every $k \geq 1$ (see e.g. Kee11]). Observe that every $F \oplus F$-free $r$ graph must be $F_{-}[2]$-free (see Figure $\rrbracket$ for example). Thus, $\pi(F \oplus F) \leq \pi\left(F_{-}[2]\right)=\pi\left(F_{-}\right)$, which implies Proposition (1.6 (i).

Proposition 1.6 (ii) follows easily from the following two theorems by Lazebnik-UstimenkoWoldar LUW95 and Bondy-Simonovits BS74, respectively.

- $\operatorname{ex}\left(n, C_{2 k}\right)=\Omega\left(n^{1+2 /(3 k-2)}\right)$ for every $k \geq 2$, and
- $\operatorname{ex}\left(n, C_{2 k} \oplus C_{2 k}\right)=\operatorname{ex}\left(n, C_{4 k-2}\right)=O\left(n^{1+1 /(2 k-1)}\right)$ for every $k \geq 2$.

Next, we prove Proposition 1.6 (iii). It suffices to show that there exist $\delta>0$ and $N_{0}$ such that the following holds for all $n \geq N_{0}$ : Every $n$-vertex 3 -graph with at least $(1 / 8-\delta) n^{3}$ edges contains a copy of $\mathbb{F}_{-}$.

Suppose to the contrary that this is not true. Let $\delta>0$ to be sufficiently small and $n$ to be sufficiently large. Let $\mathcal{H}$ be an $n$-vertex $\mathbb{F}_{-}$-free 3 -graph with at least $(1 / 8-\delta) n^{3}$ edges. By Theorem 4.1, there exists a bipartition $V(\mathcal{H})=V_{1} \cup V_{2}$ such that the bipartite subgraph $\mathcal{G}:=\mathcal{H} \backslash\left(\mathcal{H}\left[V_{1}\right] \cup \mathcal{H}\left[V_{2}\right]\right)$ satisfies

$$
\begin{equation*}
|\mathcal{G}|=|\mathcal{H}|-\left|\mathcal{H}\left[V_{1}\right]\right|-\left|\mathcal{H}\left[V_{2}\right]\right| \geq\left(\frac{1}{8}-\delta\right) n^{3}-\varepsilon n^{3} \geq\left(\frac{1}{8}-2 \varepsilon\right) n^{3}, \tag{3}
\end{equation*}
$$

where $\varepsilon=\varepsilon(\delta)>0$ is the constant guaranteed by Theorem 4.1 (and by enlarging $\varepsilon$ if necessary, we may assume that $\varepsilon \geq \delta$ ).

Let $x_{i}:=\left|V_{i}\right| / n$ for $i \in\{1,2\}$. Inequality (3) and simple calculations show that $\left|x_{i}-1 / 2\right| \leq$ $2 \sqrt{\varepsilon}$ for $i \in\{1,2\}$.

Claim 4.2. There exist three vertices $u_{1}, u_{2}, u_{3} \in V_{1}$ such that

$$
\left|\binom{V_{2}}{2} \cap L_{\mathcal{G}}\left(u_{i}\right)\right| \geq(1-110 \varepsilon)\binom{x_{2} n}{2} \quad \text { for } \quad i \in\{1,2,3\}
$$

Proof of Claim 4.2. Let $\mathcal{B}$ denote the collection of all triples that have nonempty intersection with both $V_{1}$ and $V_{2}$. Simple calculations shows that $|\mathcal{B}| \leq n^{3} / 8$. Since $\mathcal{G} \subset \mathcal{B}$, it follows from (3) that

$$
|\mathcal{B} \backslash \mathcal{G}| \leq \frac{n^{3}}{8}-\left(\frac{1}{8}-2 \varepsilon\right) n^{3}=2 \varepsilon n^{3} .
$$

Suppose to the contrary that Claim 4.2 fails. Then we would have

$$
|\mathcal{B} \backslash \mathcal{G}| \geq\left(x_{1} n-2\right)\left(\binom{x_{2} n}{2}-(1-110 \varepsilon)\binom{x_{2} n}{2}\right) \geq \frac{n}{3} \cdot 110 \varepsilon \cdot\binom{n / 3}{2}>2 \varepsilon n^{3}
$$

a contradiction.

Let $u_{1}, u_{2}, u_{3} \in V_{1}$ be three vertices guaranteed by Claim 4.2, and let

$$
G:=\binom{V_{2}}{2} \cap L_{\mathcal{G}}\left(u_{1}\right) \cap L_{\mathcal{G}}\left(u_{2}\right) \cap L_{\mathcal{G}}\left(u_{3}\right) .
$$

By definition, $|G| \geq\binom{ x_{2} n}{2}-3 \cdot 110 \varepsilon\binom{x_{2} n}{2}>\frac{\left(x_{2} n\right)^{2}}{3}$. So it follows Turán's theorem that there exist four vertices $\left\{u_{4}, u_{5}, u_{6}, u_{7}\right\} \subset V_{2}$ that induce a copy of $K_{4}$ in $G$. However, this implies that the induced subgraph of $\mathcal{H}$ on $\left\{u_{1}, \ldots, u_{7}\right\}$ contains a copy of $\mathbb{F}_{-}$, a contradiction.

## 5 Proof of Theorem 3.2

In this section, we present the proof of Theorem 3.2. The following preliminary results will be useful.

Fact 5.1. Suppose that integer $n, t, r \geq 1$ satisfy $t \leq \frac{n-r}{5 r+1}$. Then

$$
\binom{n-t}{r} \geq \frac{1}{e^{1 / 5}}\binom{n}{r} .
$$

Proof of Fact 5.1. For every $i \in[t]$ it follows from $t \leq \frac{n-r}{5 r+1}$ that $\frac{n-i}{n-i-r} \leq \frac{n-t}{n-t-r} \leq 1+\frac{1}{5 t}$. Therefore,

$$
\binom{n}{r}=\prod_{i=0}^{t-1} \frac{n-i}{n-i-r}\binom{n-t}{r} \leq\left(1+\frac{1}{5 t}\right)^{t}\binom{n-t}{r} \leq e^{1 / 5}\binom{n-t}{r},
$$

proving Fact 5.1 .
Fact $\left.5.2\left(\mathrm{HLL}^{+} 23, ~ L e m m a 3.5\right]\right)$. Let $F$ be an $r$-graph. For every $n$ and $t \leq n / r-1$ we have

$$
|d(n, F)-d(n-t, F)| \leq 4 t\binom{n-t}{r-2}
$$

Lemma 5.3. Suppose that $F$ is a smooth $r$-graph. Then for sufficiently large $n$ and for every positive integer $t \leq n$,

$$
|\operatorname{ex}(n, F)-\operatorname{ex}(n-t, F)-t \cdot d(n, F)| \leq\left(\frac{1-\pi(F)}{8 m} t+\frac{4(r-1) t^{2}}{n}\right)\binom{n}{r-1} .
$$

Proof of Lemma 5.3. We may assume that $t \leq n / 2$ since otherwise the inequality is trivial. Let $\Delta:=|\operatorname{ex}(n, F)-\operatorname{ex}(n-t, F)-t \cdot d(n, F)|$. It follows from Fact 5.2 and the smoothness of $F$ that

$$
\begin{aligned}
\Delta & \leq \sum_{i=1}^{t}|\operatorname{ex}(n-i+1, F)-\operatorname{ex}(n-i, F)-d(n-i, F)|+\sum_{i=1}^{t}|d(n-i, F)-d(n, F)| \\
& \leq \sum_{i=1}^{t}|\delta(n-i+1, F)-d(n-i, F)|+\sum_{i=1}^{t} 4 i\binom{n-1}{r-2} \\
& \leq \sum_{i=1}^{t} \frac{1-\pi(F)}{8 m}\binom{n}{r-1}+4 t^{2}\binom{n-1}{r-2}=\left(\frac{1-\pi(F)}{8 m} t+\frac{4 t^{2}(r-1)}{n}\right)\binom{n}{r-1}
\end{aligned}
$$

proving Lemma 5.3 .

Next, we present the proof of Theorem 3.2.

Proof of Theorem [3.2. Fix integers $m \geq r \geq 2$ and an $m$-vertex $r$-graph $F$ that is smooth and $\left(c_{1}, c_{2}\right)$-bounded for constants $c_{1}, c_{2}$ satisfying $0<c_{1} \leq \frac{1-\pi(F)}{12 m}$ and $c_{2}>0$. Let

$$
\delta:=\min \left\{\frac{c_{2}}{4}, \frac{1-\pi(F)}{24 m}, \frac{1}{100 r m^{2}}\right\}
$$

Let $n$ be a sufficiently large integer and $t$ be a positive integer satisfying $t<\frac{\delta \cdot \operatorname{ex}(n, F)}{2 m\binom{n-1}{r-1}}$. Simple calculations show that

$$
t \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{2 m\binom{n-1}{r-1}}-1=\min \left\{\frac{\delta \cdot \operatorname{ex}(n, F)}{2 m\binom{n-1}{r-1}}-1, \frac{\delta(n-1)}{2 m(r-1)}-1, \frac{n}{100 r m^{2}}\right\}
$$

Let $\mathcal{H}$ be an $n$-vertex $(t+2) F$-free $r$-graph with

$$
\begin{equation*}
|\mathcal{H}| \geq\binom{ n}{r}-\binom{n-t}{r}+\operatorname{ex}(n-t, F)-\frac{1-\pi(F)}{30}\binom{n}{r-1} \tag{4}
\end{equation*}
$$

Let $V:=V(\mathcal{H}), \alpha:=\frac{1-\pi(F)}{7 m}>\frac{1-\pi(F)}{12 m}+\frac{1-\pi(F)}{24 m} \geq c_{1}+\delta$,

$$
L:=\left\{v \in V: d_{\mathcal{H}}(v) \geq d(n, F)+\alpha\binom{n-1}{r-1}\right\}, \quad \text { and } \quad S:=V \backslash L
$$

Let $\ell:=L$ and suppose to the contrary that $t-\ell \geq 1$.
Claim 5.4. The r-graph $\mathcal{H}[S]$ is $(t+2-\ell) F$-free.

Proof of Claim 5.4. The proof is similar to that of Claim 3.4. Suppose to the contrary that $(t+2-\ell) F \subset \mathcal{H}[S]$. Let $R_{0} \subset S$ be a set of size $(t+2-\ell) m$ such that $(t+2-\ell) F \subset \mathcal{H}\left[R_{0}\right]$. We will find $\ell$ vertex-disjoint copies of $F$ from $\mathcal{H}\left[V \backslash R_{0}\right]$ inductively. This will contradict the assumption that $\mathcal{H}$ is $(t+2) F$-free. Assume that $L=\left\{v_{1}, \ldots, v_{\ell}\right\}$. To start with, let $R_{1}:=R_{0} \cup\left(L \backslash\left\{v_{1}\right\}\right)$. Notice that

$$
\left|R_{1}\right| \leq(t+2-\ell) m+t \leq(2 t+2) m \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}}
$$

Additionally, (4) implies that $|\mathcal{H}| \geq \operatorname{ex}(n, F)-\frac{1-\pi(F)}{30}\binom{n}{r-1} \geq\left(1-c_{2}+\delta\right) \cdot \operatorname{ex}(n, F)$, and the definition of $L$ implies that $d_{\mathcal{H}}\left(v_{1}\right) \geq d(n, F)+\alpha\binom{n-1}{r-1} \geq d(n, F)+\left(c_{1}+\delta\right)\binom{n-1}{r-1}$. Thus,
by Lemma 3.3, there exists a copy of $F$, denoted by $F_{1}$, in $\mathcal{H}$ that avoids $R_{1}$. Suppose that we have found $i$ vertex-disjoint copies of $F$, namely $F_{1}, \ldots, F_{i}$, from $\mathcal{H}$ for some $i \leq \ell-1$. Let $R_{i+1}:=\bigcup_{1 \leq j \leq i} V\left(F_{j}\right) \cup\left(L \backslash\left\{v_{i+1}\right\}\right) \cup R_{0}$. Since

$$
\left|R_{i+1}\right| \leq i m+t+(t+2-\ell) m \leq(2 t+2) m \leq \frac{\delta \cdot \operatorname{ex}(n, F)}{\binom{n-1}{r-1}}
$$

similar to the argument above, by Lemma 3.3, there exists a copy of $F$, denoted by $F_{i+1}$, in $\mathcal{H}$ that avoids $R_{i+1}$. The choice of $t$ ensures that we can repeat this process $\ell$ times, hence obtaining $\ell F \subset \mathcal{H}\left[V \backslash R_{0}\right]$.

Let $\left\{F_{1}, \ldots, F_{\hat{t}}\right\}$ be a maximum collection of vertex-disjoint copies of $F$ in $\mathcal{H}[S]$ and let $B:=\bigcup_{i \in[\hat{t}]} V\left(F_{i}\right)$. Notice that $\mathcal{H}[S \backslash B]$ is $F$-free. By Claim 5.4, we know that $|B|=m \hat{t} \leq m(t+1-\ell)$. So it follows from the definition of $L$ that

$$
\begin{aligned}
|\mathcal{H}[S]| & \leq \sum_{v \in B} d_{\mathcal{H}}(v)+|\mathcal{H}[S \backslash B]| \\
& \leq m(t+1-\ell)\left(d(n, F)+\alpha\binom{n-1}{r-1}\right)+\operatorname{ex}(n-t-m(t+1-\ell), F) .
\end{aligned}
$$

On the other hand, since there are at most $\binom{n}{r}-\binom{n-\ell}{r}$ edges in $\mathcal{H}$ that have nonempty intersection with $L$, it follows from (4) that

$$
\begin{aligned}
|\mathcal{H}[S]| & \geq|\mathcal{H}|-\left(\binom{n}{r}-\binom{n-\ell}{r}\right) \\
& =\binom{n-\ell}{r}-\binom{n-t}{r}+\operatorname{ex}(n-t, F)-\frac{1-\pi(F)}{30}\binom{n-1}{r-1}
\end{aligned}
$$

Recall that $\alpha=\frac{1-\pi(F)}{7 m}$. Therefore, to establish a contradiction, it suffices to show that

$$
\begin{aligned}
\Delta:= & \left(\binom{n-\ell}{r}-\binom{n-t}{r}+\operatorname{ex}(n-t, F)-\frac{1-\pi(F)}{30}\binom{n-1}{r-1}\right) \\
& -\left(m(t+1-\ell)\left(d(n, F)+\frac{1-\pi(F)}{7 m}\binom{n-1}{r-1}\right)+\operatorname{ex}(n-t-m(t+1-\ell), F)\right)
\end{aligned}
$$

is positive. Notice that $\Delta=\Delta_{1}+\Delta_{2}$, where

$$
\begin{aligned}
\Delta_{1} & :=\operatorname{ex}(n-t, F)-\operatorname{ex}(n-t-m(t+1-\ell), F)-m(t+1-\ell) \cdot d(n, F), \quad \text { and } \\
\Delta_{2} & :=\binom{n-\ell}{r}-\binom{n-t}{r}-\frac{(1-\pi(F))(t+1-\ell)}{7}\binom{n-1}{r-1}-\frac{1-\pi(F)}{30}\binom{n-1}{r-1}
\end{aligned}
$$

First, let us consider $\Delta_{2}$. Since $\binom{n-\ell}{r}-\binom{n-t}{r} \geq(r-\ell)\binom{n-t}{r-1}$ and $t \leq \frac{n}{100 r m^{2}} \leq \frac{n-(r-1)}{5(r-1)+1}$, it follows from Fact 5.1 that

$$
\begin{align*}
\Delta_{2} & \geq(t-\ell)\binom{n-t}{r-1}-\frac{t+1-\ell}{7}\binom{n}{r-1}-\frac{1}{30}\binom{n}{r-1} \\
& \geq \frac{t-\ell}{e^{1 / 5}}\binom{n}{r-1}-\frac{t+1-\ell}{7}\binom{n}{r-1}-\frac{1}{30}\binom{n}{r-1} . \tag{5}
\end{align*}
$$

Next, we consider $\Delta_{1}$. If $F$ is degenerate, then, by the theorem of Erdős Erd64b] (see also $\left[\mathrm{HHL}^{+} 23\right.$, Theorem A.1] for a more precise form $), d(n, F)=r \cdot \operatorname{ex}(n, F) / n \leq m$.
$n^{r-1-c_{F}}$ for some constant $c_{F}>0$. Combining with the assumption that $n$ is sufficiently large, we obtain

$$
\begin{aligned}
\Delta_{1} & =\operatorname{ex}(n-t, F)-\operatorname{ex}(n-t-m(t+1-\ell), F)-m(t+1-\ell) \cdot d(n, F) \\
& \geq-m(t+1-\ell) \cdot d(n, F) \geq-(t+1-\ell) m^{2} \cdot n^{r-1-c_{F}} \geq-\frac{29(t+1-\ell)}{200}\binom{n}{r-1}
\end{aligned}
$$

If $F$ is nondegenerate, then we decompose $\Delta_{1}$ as $\Delta_{1}=\Delta_{1,1}+\Delta_{1,2}$, where

$$
\begin{aligned}
& \Delta_{1,1}:=\operatorname{ex}(n-t, F)-\operatorname{ex}(n-t-m(t+1-\ell), F)-m(t+1-\ell) \cdot d(n-t, F), \quad \text { and } \\
& \Delta_{1,2}:=m(t+1-\ell) \cdot(d(n-t, F)-d(n, F))
\end{aligned}
$$

Applying Lemma 5.3 to $\Delta_{1,1}$, we obtain

$$
\begin{aligned}
\Delta_{1,1} & \geq-\left(\frac{(1-\pi(F)) m(t+1-\ell)}{8 m}+\frac{4(r-1) m^{2}(t+1-\ell)^{2}}{n}\right)\binom{n}{r-1} \\
& \geq-\left(\frac{t+1-\ell}{8}+\frac{4(r-1) m^{2}(t+1-\ell)^{2}}{n}\right)\binom{n}{r-1} \\
& \geq-\left(\frac{t+1-\ell}{8}+\frac{t+1-\ell}{20}\right)\binom{n}{r-1}
\end{aligned}
$$

where the last inequality follows from the assumption that $t \leq \frac{n}{100 \mathrm{rm}^{2}}$. Applying Fact 5.2 to $\Delta_{1,2}$, we obtain

$$
\begin{aligned}
\Delta_{1,2} & \geq-4 m(t+1-\ell) t\binom{n-1}{r-2} \\
& =-(t+1-\ell) \frac{4 m t(r-1)}{n}\binom{n}{r-1} \geq-\frac{t+1-\ell}{20}\binom{n}{r-1}
\end{aligned}
$$

Summing up $\Delta_{1,2}$ and $\Delta_{1,2}$, we obtain

$$
\Delta_{1} \geq-\frac{9(t+1-\ell)}{40}\binom{n}{r-1}
$$

In both cases, we have $\Delta_{1} \geq-\frac{9(t+1-\ell)}{40}\binom{n}{r-1}$. Combining with (5), we obtain

$$
\begin{aligned}
\Delta & =\Delta_{1}+\Delta_{2} \\
& \geq \frac{t-\ell}{e^{1 / 5}}\binom{n}{r-1}-\frac{t+1-\ell}{7}\binom{n}{r-1}-\frac{1}{30}\binom{n}{r-1}-\frac{9(t+1-\ell)}{40}\binom{n}{r-1} \\
& \geq\left(\frac{1}{e^{1 / 5}}-\frac{2}{7}-\frac{1}{30}-\frac{9}{20}\right)\binom{n}{r-1}>\frac{1}{25}\binom{n}{r-1} .
\end{aligned}
$$

Here we used the assumption that $t-\ell \geq 1$.

## 6 Concluding remarks

Recall the definition of edge-sensitive from Section 1.2. Theorem 1.5 motivates the following two questions on Turán problems.

Problem 6.1. Let $r \geq 2$ be an integer. Characterize the family of edge-sensitive $r$-partite $r$-graphs. In particular, is $K_{t, t}$ edge-sensitive for $t \geq 3$ ?

Problem 6.2. Let $r \geq 3$ be an integer. Characterize the family of $r$-graphs $F$ such that $\pi(F)>\pi\left(F_{-}\right)$. In particular, is it true that $\pi\left(K_{\ell}^{r}\right)>\pi\left(K_{\ell}^{r-}\right)$ for all $\ell>r \geq 3$ ?

## Definitions for hypergraphs in Tables 1 and 2

- A graph $F$ is edge-critical if there exists an edge $e \in F$ such that $\chi(F-e)<\chi(F)$.
- Fix a graph $F$, the expansion $H_{F}^{r}$ of $F$ is the $r$-graphs obtained from $F$ by adding a set of $r-2$ new vertices into each edge of $F$, and moreover, these new $(r-2)$-sets are pairwise disjoint.
- Given an $r$-graph $F$ with $\ell+1$ vertices, the expansion $H_{\ell+1}^{F}$ of $F$ is the $r$-graph obtained from $F$ by adding, for every pair $\{u, v\} \subset V(F)$ that is not contained in any edge of $F$, an $(r-2)$-set of new vertices, and moreover, these $(r-2)$-sets are pairwise disjoint.
- We say a tree $T$ is an Erdős-Sós tree if it satisfies the famous Erdős-Sós conjecture on trees. The $(r-2)$-extension $\operatorname{Ext}(T)$ of a tree $T$ is

$$
\operatorname{Ext}(T):=\{e \cup A: e \in T\},
$$

where $A$ is a set of $r-2$ new vertices that is disjoint from $V(T)$. An $r$-graph $F$ is an extended tree if $F=\operatorname{Ext}(T)$ for some tree.

- The ( $r$-uniform) generalized triangle $\mathbb{T}_{r}$ is the $r$-graph with vertex set $[2 r-1]$ and edge set

$$
\{\{1, \ldots, r-1, r\},\{1, \ldots, r-1, r+1\},\{r, r+1, \ldots, 2 r-1\}\} .
$$

- Let $\mathcal{C}_{3}^{2 r}$ (the expanded triangle) denote the $2 r$-graph with vertex set $[3 r]$ and edge set

$$
\{\{1, \ldots, r, r+1, \ldots, 2 r\},\{r+1, \ldots, 2 r, 2 r+1, \ldots, 3 r\},\{1, \ldots, r, 2 r+1, \ldots, 3 r\}\} .
$$

- The Fano plane $\mathbb{F}$ is the 3 -graph with vertex set $\{1,2,3,4,5,6,7\}$ and edge set

$$
\{123,345,561,174,275,376,246\} .
$$

- Let $\mathrm{F}_{7}$ (4-book with 3-pages) denote the 3 -graph with vertex set $\{1,2,3,4,5,6,7\}$ and edge set

$$
\{1234,1235,1236,4567\} .
$$

- Let $\mathbb{F}_{4,3}$ denote the 4 -graph with vertex set $\{1,2,3,4,5,6,7\}$ and edge set

$$
\{1234,1235,1236,1237,4567\} .
$$

- Let $\mathbb{F}_{3,2}$ denote the 3 -graph with vertex set $\{1,2,3,4,5\}$ and edge set

$$
\{123,124,125,345\} .
$$

- The 3 -graph $K_{4}^{3} \sqcup K_{3}^{3}$ has vertex set $\{1,2,3,4,5,6,7\}$ and edge set

$$
\{123,124,234,567\} .
$$

- The $r$-graph $M_{k}^{r}$ ( $r$-uniform $k$-matching) is the $r$-graph consisting of $k$ pairwise disjoint edges.
- The $r$-graph $L_{k}^{r}$ (r-uniform $k$-sunflower) is the $r$-graph consisting of $k$ edges $e_{1}, \ldots, e_{k}$ such that for all $1 \leq i<j \leq k$, it holds that $e_{i} \cap e_{j}=\{v\}$ for some fixed vertex $v$.
- The $r$-graph $K_{\ell}^{r-}$ is the $r$-graph obtained from $K_{\ell}^{r}$ by removing one edge.
- The tight cycle $C_{k}^{3}$ is the 3 -graph with vertex set $\{0,1, \ldots, k-1\}$ and edge set

$$
\{\{i, i+1, i+2\}(\bmod k): 0 \leq i \leq k-1\} .
$$
