# <span id="page-0-0"></span>DUALITIES FOR UNIVERSAL (CO)ACTING HOPF MONOIDS

Abstract. In general, universal (co)measuring (co)monoids and universal (co)acting bi/Hopf monoids, which prove to be a useful tool in the classification of quantum symmetries, do not always exist. In order to ensure their existence, the support of a given object was recently introduced in [\[5\]](#page-47-0) and used to restrict the class of objects considered when defining universal (co)acting objects. It is well-known that, in contrast with the universal coacting Hopf algebra, for actions on algebras over a field it is usually difficult to describe the universal acting Hopf algebra explicitly and this turns the duality theorem into an important investigation tool. In the present paper we establish duality results for universal (co)measuring (co)monoids and universal (co)acting bi/Hopf monoids in pre-rigid braided monoidal categories  $\mathcal C$ . In addition, when the base category  $\mathcal C$  is closed monoidal, we provide a convenient uniform approach to the aforementioned universal objects in terms of the cosupports, which in this case become subobjects of internal hom-objects. In order to explain our constructions, we use the language of locally initial objects. Known results from the literature are recovered when the base category is the category of vector spaces over a field. New cases where our results can be applied are explored, including categories of (co)modules over (co)quasitriangular Hopf algebras, Yetter — Drinfel'd modules and dg-vector spaces.

### 1. INTRODUCTION

The geometrical problem of classifying quantum symmetries of a given algebra A has an algebraic correspondent in the classification of (co)module structures on A. Indeed, recall that if an affine algebraic group  $G$  is acting on an affine algebraic variety  $X$ , the morphic action  $G\times X \to X$  corresponds to a homomorphism of algebras  $\mathcal{O}(X) \to \mathcal{O}(X) \otimes \mathcal{O}(G)$  where  $\mathcal{O}(X)$  and  $\mathcal{O}(G)$  are the algebras of regular functions on X and G, respectively. Moreover, the group structure on G endows  $\mathcal{O}(G)$  with a Hopf algebra structure and  $\mathcal{O}(X)$  becomes an  $\mathcal{O}(G)$ -comodule algebra. Furthermore, if g is the Lie algebra of G, then  $\mathcal{O}(X)$  is a  $U(\mathfrak{g})$ module algebra where  $U(\mathfrak{g})$  denotes the universal enveloping algebra of  $\mathfrak{g}$ . Replacement of the commutative algebras  $\mathcal{O}(G)$  and  $\mathcal{O}(X)$  (respectively the cocommutative Hopf algebra  $U(\mathfrak{g})$ ) with an arbitrary Hopf algebra H (co)acting on an arbitrary algebra A, leads to an action of a quantum group by quantum symmetries on an algebraic variety  $X$  whose algebra of regular functions is A. Furthermore, if these quantum groups act on certain cohomological invariants of the variety, one could hope to obtain more geometrical information.

A typical example of a comodule algebra structure is the one defined by group gradings on an algebra over a field. These are usually classified either up to an isomorphism by considering the grading group to be fixed or up to equivalence when it is not important by elements of which group the graded components are marked, see e.g. [\[11\]](#page-47-2). However, the universal group of a grading allows us to recover all groups that realize a concrete grading. The corresponding notions of equivalence and universal Hopf algebras of (co)module structures on algebras were introduced in [\[3\]](#page-47-3), generalizing the aforementioned universal group of a grading. Furthermore, a unifying theory for universal Hopf algebras of (co)module structures and universal (co)acting bi/Hopf algebras of Sweedler – Manin – Tambara ([\[21,](#page-48-0) [17,](#page-47-4) 22) was introduced in  $[4]$ , by considering V-universal (co)acting bi/Hopf algebras where V is a unital subalgebra of  $\text{End}_{\mathbb{k}}(A)$  and k is the base field. Motivation comes, on the one hand, from the fact that this unified theory simplifies and in certain cases even makes it possible at all to classify (co)module structures by means of duality results. On the other hand, since the universal coacting bi/Hopf algebras of Manin — Tambara do not always exist [\[4,](#page-47-5) Section 4.5], V provides the necessary restriction on the class of comodule structures under consideration to ensure the existence of the universal Hopf algebra for this class.

In [\[5\]](#page-47-0) the authors introduced the categorical foundations for the notion of universal bi/Hopf algebra. Sufficient conditions for the existence of universal (co)measuring (co)monoids and universal (co)acting bi/Hopf monoids over a base (braided or symmetric monoidal) category are given. Furthermore, it was shown that the existence problem for such universal objects is

<span id="page-2-0"></span>a particular case of what we call the Lifting Problem for locally initial objects (see Section [2.1](#page-3-1) for the precise statement) as we will briefly explain. By definition, the (co)action of a universal Hopf monoid is an initial object in some full subcategory of the category of all (co)actions on a fixed  $\Omega$ -magma. In particular, for the whole category of (co)actions this universal (co)action is a *locally initial object* (i.e. an object which admits at most one morphism into any other object). That full subcategory consists of the objects whose images under some forgetful functor admit a morphism from a certain fixed locally initial object. Therefore, the existence problem for universal Hopf monoids can be described as a lifting problem for locally initial objects. The lifting itself is carried out in several steps.

The first duality result for the (absolute) universal comeasuring algebra and measuring coalgebra, which generalizes the classical adjunction between the finite dual (of an algebra over a field) functor and the dual algebra (of a coalgebra over a field) functor (see e.g., [\[10,](#page-47-6) Theorem 1.5.22]), was established by D. Tambara in [\[22\]](#page-48-1). This duality was extended to V -universal (co)measuring (co)algebras and (co)acting bi/Hopf algebras over fields in [\[4,](#page-47-5) Theorems 3.20, 4.14, 4.15. As it was proven in  $[4]$ , the V-universal coacting Hopf algebras over fields admit a transparent description in terms of free algebras and relations, while the construction of  $V$ -universal acting Hopf algebras is not as explicit, since it involves subcoalgebras of cofree coalgebras. For this reason the duality theorems for V-universal acting and coacting Hopf algebras become here one of the main tools of investigation. In the present paper we prove duality results for universal (co)measuring (co)monoids and universal (co)acting bi/Hopf monoids in pre-rigid braided monoidal categories  $\mathcal{C}$ , generalizing the aforementioned existing results.

We use the previously introduced terminology to describe the outline of the paper. Throughout, we use the following notation:

- A and B are  $\Omega$ -magmas;
- MorTens $(A, B)$  and TensMor $(A, B)$  are the categories of, respectively, morphisms  $A \to B \otimes Q$  and morphisms  $P \otimes A \to B$  for some objects P and Q;
- Comeas( $A, B$ ) and Meas( $A, B$ ) are the categories of, respectively, comeasurings  $A \to B \otimes Q$  and measurings  $P \otimes A \to B$  for some comonoids P and monoids Q;
- Comod $\text{Str}(A)$  and  $\text{ModStr}(A)$  the categories of, respectively, comodule structures  $A \to A \otimes P$  and module structures  $Q \otimes A \to A$  where P is a comonoid and Q a monoid;
- **Coact**(A) and  $\textbf{Act}(A)$  are the categories of bimonoid (co)actions on A;
- $\mathbf{HCoact}(A)$  and  $\mathbf{HAct}(A)$  are the categories of Hopf monoid (co)actions on A;
- functors  $G, G_1-G_4, G', G'_1-G'_4$  are the corresponding forgetful/embedding functors;
- $\rho^{\vee}$ :  $Q^* \otimes A \to B$  is the morphism induced by  $\rho: A \to B \otimes Q$  (here we assume that C is pre-rigid, in particular, endowed with a functor  $(-)^*$ :  $\mathcal{C} \to \mathcal{C}^{\mathrm{op}}$ );
- $\varkappa_Q: Q^\circ \to Q^*$  is the natural morphism that relates the finite dual  $Q^\circ$  of a monoid Q with  $Q^*$ .

For full details we refer the reader to Sections [2](#page-3-0)[–3.](#page-10-1) To start with, consider the following (not necessarily commutative) diagram:

In [\[5,](#page-47-0) Theorems 4.23 and 5.19] locally initial objects were lifted along the functors  $G_1$  and  $G'_{1}$ , respectively. Theorem [3.24](#page-20-1) of the present paper provides sufficient conditions for the

<span id="page-3-2"></span>functor  $(-)^{\vee}(\varkappa_{(\dots)} \otimes id_A)$ : **Comeas** $(A, B) \to \textbf{Meas}(A, B)^{\text{op}}$  to map universal comeasurings to universal measurings.

In addition, if  $A = B$ , one can consider bi/Hopf monoid (co)actions. The complete picture is captured by the following diagram which commutes except, possibly, for the lower central square:

In [\[5,](#page-47-0) Corollaries 4.36 and 5.23] objects in  $\mathbf{ComodStr}(A)$  and  $\mathbf{ModStr}(A)^{op}$ , whose

images under G and G' are locally initial, are lifted along the functors  $G_2$  and  $G'_2$ , respectively. The actual lifting is made along  $G_3$  and  $G'_3$ . Theorem [3.32](#page-23-0) is the corresponding duality result.

Furthermore, the locally initial objects obtained in  $\text{Coact}(A)$  and  $\text{Act}(A)^{op}$ , are lifted to  $\textbf{HCoact}(A)$  and  $\textbf{HAct}(A)$ <sup>op</sup>, respectively, in [\[5,](#page-47-0) Theorems 4.40 and 5.26]. The corresponding duality result is proved in Theorem [3.35.](#page-24-0)

In the dualizable theory developed in [\[5\]](#page-47-0), coactions were restricted by their supports while actions were restricted by their cosupports. However, if  $\mathcal C$  is not only pre-rigid, but closed monoidal, there exists an isomorphism of categories

 $K: \textbf{Tensor}(A, B) \to (\mathcal{C} \downarrow [A, B]),$ 

which makes it possible to segregate classes of both measurings and comeasurings in terms of their cosupports. The latter correspond to locally initial objects in the comma category  $(C \downarrow [A, B])^{\text{op}}$ , i.e. just monomorphisms. This approach, which proves to be fruitful for the classification of (co)module structures on a given  $\Omega$ -magma, is undertaken in Section [4.](#page-26-0)

The categorical approach carried out in [\[5\]](#page-47-0) and in the present paper makes it possible not only to recover known results, when the base category is the category of vector spaces over a field, but also to consider new cases, e.g. when the base category itself is a category of (co)modules over a (co)quasitriangular Hopf algebra, Yetter — Drinfel'd modules or dgvector spaces. All these examples are considered in full detail in Section [5.](#page-35-0)

### 2. Preliminaries

<span id="page-3-0"></span>Throughout the paper we assume familiarity with (braided monoidal) categories as covered for instance in  $[2, 15]$  $[2, 15]$  (resp.  $[14]$ ) and Hopf algebras where the relevant background is available in a number of sources such as [\[10,](#page-47-6) [18,](#page-47-10) [20,](#page-48-2) [21\]](#page-48-0). We start by briefly recalling definitions and notation from [\[5\]](#page-47-0) that will be used in the sequel.

<span id="page-3-1"></span>2.1. Locally initial objects. An object  $x_0$  in a category X is locally initial if for every object x in X there exists at most one morphism  $x_0 \to x$ .

Locally initial objects obviously generalize the classical initial object of a category. However, as opposed to an initial object, locally initial objects may not be unique up to isomorphism.

Furthermore, locally initial objects form a preorder  $LIO(X)$  by considering  $x_1 \succcurlyeq x_2$  if there exists a morphism  $x_1 \to x_2$ . If  $x_0$  is a given locally initial object we denote by  $X(x_0)$  the full subcategory of X consisting of all objects x such that there exists a morphism  $x_0 \to x$ . We can easily see that  $x_0$  is the initial object in  $X(x_0)$ .

<span id="page-4-3"></span>Consider now another category Y and a functor  $G: Y \to X$ . Given  $x_0 \in \mathsf{LIO}(X)$  denote by  $Y(x_0)$  the full subcategory of Y consisting of all objects y such that Gy is an object in  $X(x_0)$ . In this context, we formulate:

**Lifting Problem.** Given  $x_0 \in \mathsf{LIO}(X)$ , find an initial object  $y_0$  in  $Y(x_0)$ .

<span id="page-4-0"></span>Note that the condition  $Gy_0 = x_0$  is not assumed to hold.

2.2. Absolute values. For a given object x of the category X denote by |x| an object in  $LIO(X)$  such that x is an object in  $X(|x|)$  and for any other object  $x_1$  in  $LIO(X)$  such that x is an object in  $X(x_1)$  we have  $|x| \preccurlyeq x_1$ . In other words,  $|x|$  is the absolute minimum of such  $x_1 \in \mathsf{LIO}(X)$  for which there exists a morphism  $x_1 \to x$ :



The terminology used is justified by [\[5,](#page-47-0) Example 2.7].

It can be easily seen that for every  $x \in LIO(X)$  we have  $x = |x|$ . Furthermore, note that the arrow  $|x| \to x$  is just the terminal object in the comma category  $(LIO(X) \downarrow x)$ .

Now if  $G: Y \to X$  is a functor, for a given object y in Y we denote  $|y| := |Gy|$ . When we need to stress that the absolute value of y is an object in the category X, we will write  $|y|_X$ .

For objects  $y_1, y_2$  in Y we write  $y_1 \preccurlyeq y_2$  and say that  $y_1$  is *coarser* than  $y_2$  and  $y_2$  is *finer* than  $y_1$  if  $|y_1| \preccurlyeq |y_2|$ . If  $y_1 \preccurlyeq y_2$  and  $y_2 \preccurlyeq y_1$ , then we say that  $y_1$  and  $y_2$  are *(support)* equivalent.

Remark 2.1. If absolute values of all objects in X exist, then, given  $x_0 \in \text{LO}(X)$ , the category  $Y(x_0)$  consists of all objects y in Y such that  $|y| \preccurlyeq x_0$ .

**Definition 2.2.** Let  $K: X \to X'$  be a functor for some categories X, X'. We say that

- 1) K preserves absolute values if for every x in X with an absolute value  $|x|_X$  we have  $K(|x|_X) = |Kx|_{X'};$
- 2) K reflects the preorder (on locally initial objects) if the following two conditions hold:
	- the functor K maps  $LIO(X)$  to  $LIO(X')$ ;
	- $Kx_1 \preccurlyeq Kx_2$  in X' for some  $x_1, x_2 \in \mathsf{LIO}(X)$  if and only if  $x_1 \preccurlyeq x_1$  in X.

<span id="page-4-2"></span>**Proposition 2.3.** Let  $G: Y \to X$  and  $K: X \to X'$  be functors for some categories  $X, X', Y$ such that there exist absolute values of all objects in X and K preserves absolute values and reflects the preorder. Let  $x_0$  be an object in X such that  $Kx_0 \in \mathsf{LIO}(X')$ . Then the categories  $Y(|x_0|)$  (with respect to G) and  $Y(Kx_0)$  (with respect to KG) coincide. As a consequence, if  $y_0$  is the initial object in  $Y(|x_0|)$ , then  $y_0$  is the initial object in  $Y(Kx_0)$ .

*Proof.* Note that  $Y(|x_0|)$  is a full subcategory of  $Y(Kx_0)$  since  $Kx_0 = |Kx_0| = K|x_0|$ . Suppose now that y is an object in  $Y(Kx_0)$ . Then there exists an arrow  $Kx_0 \to KGy$  in X'. By our assumptions,  $K(\vert Gy \vert_X)$  is the absolute value of  $KGy$  in X'. Hence  $Kx_0 \rightarrow KGy$ factors through  $K(|Gy|_X)$ . In particular, there exists an arrow  $K|x_0| \to K(|Gy|_X)$  in X' and  $K(|Gy|_X) \preccurlyeq K|x_0|$ . Thus  $|Gy|_X \preccurlyeq |x_0|$  and y is an object in  $Y(|x_0|)$ .

<span id="page-4-1"></span>2.3.  $\Omega$ -magmas. Let  $\Omega$  be a set together with maps  $s, t: \Omega \to \mathbb{Z}_+$ .

An  $\Omega$ -magma in a monoidal category C is an object A endowed with morphisms  $\omega_A: A^{\otimes s(\omega)} \to A^{\otimes t(\omega)}$  for every  $\omega \in \Omega$ . We will usually drop the subscript A and denote the map just by  $\omega$ . We use the convention  $A^{\otimes 0} := \mathbb{1}$ , the neutral object in C. Note that here we do not require from  $\omega_A$  to satisfy any identities.  $\Omega$ -magmas in  $\mathrm{Vect}_{\mathbb{k}}$  are called  $\Omega$ -algebras over k ([\[4\]](#page-47-5)).

<span id="page-5-1"></span>Examples include many familiar algebraic structures: algebras (either unital or nonunital, associative or non-associative) and coalgebras over a field are  $\Omega$ -magmas in  $Vect_{\mathbb{k}}$  for different  $\Omega$ 's, ordinary monoids are  $\Omega$ -magmas in **Sets**, any object A endowed with a braiding  $c_A: A \otimes A \rightarrow A \otimes A$  is an  $\Omega$ -magma (see [\[5,](#page-47-0) Examples 3.5] for more details).

<span id="page-5-0"></span>2.4. (Co)measurings. Fix a braided monoidal category  $\mathcal C$  with a braiding c and a neutral object 1. Let P be a comonoid in C with a comultiplication  $\Delta: P \to P \otimes P$  and a counit  $\varepsilon: P \to \mathbb{1}$ . Consider the monoidal category **TensMor**(P) where the objects are morphisms  $P \otimes A \to B$  and morphisms between objects  $\psi_1: P \otimes A_1 \to B_1$  and  $\psi_2: P \otimes A_2 \to B_2$  are pairs of morphisms  $\alpha: A_1 \to A_2$  and  $\beta: B_1 \to B_2$  making the diagram below commutative:

The monoidal product  $\psi_1 \widetilde{\otimes} \psi_2$ :  $P \otimes (A_1 \otimes A_2) \rightarrow B_1 \otimes B_2$  of objects  $\psi_1: P \otimes A_1 \rightarrow B_1$ and  $\psi_2$ :  $P \otimes A_2 \to B_2$  in TensMor(P) is defined as the composition of the morphisms below:

The monoidal unit of  $\mathsf{TensMor}(P)$  is the composition  $P \otimes \mathbb{1} \to P \xrightarrow{\varepsilon} \mathbb{1}$ . The axioms of a<br>special external for  $\mathsf{TransDer}(P)$  are expressioness of these for  $C$  and the feet that  $P$  is a monoidal category for  $TensMor(P)$  are consequences of those for C and the fact that P is a comonoid.

A measuring of  $\Omega$ -magmas is an  $\Omega$ -magma  $\psi: P \otimes A \to B$  in the category TensMor(P). Note that the structure of an  $\Omega$ -magma on  $\psi$  endows the objects A and B with structures of  $\Omega$ -magmas in C and the morphism  $\psi$  relates these structures in a special way.

The classical definition of a measuring of (now not necessarily associative) algebras as introduced in [\[21,](#page-48-0) Chapter VII] can be recovered for  $C = \textbf{Vect}_{\mathbb{k}}$  for a field k and a certain  $\Omega$  (see [\[5,](#page-47-0) Examples 3.6]).

For a monoidal category C denote by  $\mathsf{Mon}(\mathcal{C})$  and  $\mathsf{Comon}(\mathcal{C})$  the categories of monoids and comonoids in  $\mathcal{C}$ , respectively.

Recall that if the category  $\mathcal C$  is braided, then  $\textsf{Mon}(\mathcal C)$  is a monoidal category too. Objects of the category  $Common(Mon(\mathcal{C}))$  (which is isomorphic to  $Mon(Comon(\mathcal{C})))$  are called *bimonoids* in  $\mathcal{C}$ .

If P is a bimonoid, then the category  $_P$ Mod of left P-modules is a subcategory of TensMor(P) that inherits from TensMor(P) the monoidal structure. An  $\Omega$ -magma in pMod is called a P-module  $\Omega$ -magma and the corresponding morphism  $\psi: P \otimes A \rightarrow A$  is called a P-action on A.

The classical definition of a (now not necessarily associative) module algebra over a bialgebra can be recovered for  $C = \textbf{Vect}_{k}$  for a field k and a certain  $\Omega$  (see [\[5,](#page-47-0) Examples 3.7]).

Dually, let Q be a monoid in C with a multiplication  $\mu: Q \otimes Q \to Q$  and a unit  $u: \mathbb{1} \to Q$ . Consider the monoidal category MorTens(Q) where the objects are morphisms  $A \to B \otimes Q$ and morphisms between objects  $\rho_1: A_1 \to B_1 \otimes Q$  and  $\rho_2: A_2 \to B_2 \otimes Q$  are pairs of morphisms  $\alpha: A_1 \to A_2$  and  $\beta: B_1 \to B_2$  making the diagram below commutative:

The monoidal unit of MorTens(Q) is the composition  $\mathbb{1} \stackrel{u}{\to} Q \stackrel{\sim}{\to} \mathbb{1} \otimes Q$ . The axioms of a<br>unital extension MarTeng(Q) are concernance of these for C and the fact that Q is a monoidal category for **MorTens**( $Q$ ) are consequences of those for  $C$  and the fact that  $Q$  is a monoid.

A comeasuring of  $\Omega$ -magmas is an  $\Omega$ -magma  $\rho: A \to B \otimes Q$  in the category MorTens(*Q*). Note that the structure of an  $\Omega$ -magma on  $\rho$  endows the objects A and B with structures of  $\Omega$ -magmas in  $\mathcal C$  and the morphism  $\rho$  relates these structures in a special way.

If  $Q$  is a bimonoid, then the category  $\mathsf{Comod}^Q$  of right  $Q$ -comodules is a subcategory of MorTens(Q) that inherits from MorTens(Q) the monoidal structure. An  $\Omega$ -magma in Comod<sup>Q</sup> is called a Q-comodule  $\Omega$ -magma and the corresponding morphism  $\rho: A \to A \otimes Q$  is called a Q-coaction on A.

The classical definition of a (now not necessarily associative) comodule algebra over a bialgebra can be recovered for  $\mathcal{C} = \mathbf{Vect}_{\mathbb{k}}$  for a field k and a certain  $\Omega$  (see [\[5,](#page-47-0) Examples 3.9]).

<span id="page-6-2"></span><span id="page-6-0"></span>2.5. Conditions on the base category. Now we list the conditions on the base category C from  $[5, Section 4.2 and Section 5.1]$  we will refer to in the theorems below:

- (1) there exist all small limits in  $\mathcal{C}$ :
- <span id="page-6-1"></span>(2) there exist finite and countable colimits in  $\mathcal{C}$ ;
- <span id="page-6-3"></span>(3)  $\mathcal{C}$  is (Epi, ExtrMono)-structured;
- <span id="page-6-6"></span>(4)  $\mathcal C$  is well powered;
- (5) for every monomorphism f and every object M both  $f \otimes id_M$  and  $id_M \otimes f$  are monomorphisms too;
- <span id="page-6-7"></span><span id="page-6-5"></span>(5a) for every extremal monomorphism f the morphism  $f \otimes f$  is an extremal monomorphism too;
- (6) for every object M the functor  $M \otimes (-)$  preserves limits (= intersections) of extremal subobjects in  $\mathcal{C}$ ;
- <span id="page-6-4"></span>(7) for every object M the functor  $M \otimes (-)$  preserves preimages, i.e. for every pullback



where  $f$  is an arbitrary monomorphism and  $g$  is an arbitrary morphism having the same codomain  $B$  (recall that in this case h is automatically a monomorphism too)

where  $\pi_{\alpha}$  is the projection from  $\prod$  $A_{\alpha}$  to  $A_{\alpha}$ ,  $\alpha \in \Lambda$ , is a monomorphism;

<span id="page-7-2"></span>α∈Λ (9) for every object M the functor  $M \otimes (-)$  preserves all equalizers;

<span id="page-7-4"></span>(10) the forgetful functor  $\textsf{Mon}(\mathcal{C}) \to \mathcal{C}$  has a left adjoint  $\mathcal{F} \colon \mathcal{C} \to \textsf{Mon}(\mathcal{C})$ .

Remark 2.4. Property [3](#page-6-1) follows from Properties [1](#page-6-2) and [4.](#page-6-3) Property [9](#page-7-2) follows from Proper-ties [1,](#page-6-2) [7](#page-6-4) and [8](#page-7-3) (see e.g.  $[5,$  Proposition 4.2]).

<span id="page-7-0"></span>2.6. Supports of morphisms  $A \to B \otimes Q$ . Let C be a monoidal category. For given objects A, B in C denote by **MorTens** $(A, B)$  the comma category  $(A \downarrow B \otimes (-))$ , i.e. the category where

- the objects are morphisms  $\rho: A \to B \otimes Q$  for some objects  $Q$ ;
- the morphisms between  $\rho_1: A \to B \otimes Q_1$  and  $\rho_2: A \to B \otimes Q_2$  are morphisms  $\tau: Q_1 \to Q_2$  making the diagram below commutative:



For morphisms  $\rho: A \to B \otimes Q$  we are going to use the terminology and the notation from Sections [2.1](#page-3-1) and [2.2](#page-4-0) with respect to  $X = \text{MorTens}(A, B)$ .

**Definition 2.5.** We say that a morphism  $\rho: A \rightarrow B \otimes Q$  is a tensor epimorphism if  $\rho \in \text{LIO}(\text{MorTens}(A, B)),$  i.e. if for every  $f, g: Q \to R$ , such that

$$
(\mathrm{id}_B \otimes f)\rho = (\mathrm{id}_B \otimes g)\rho,
$$

we have  $f = q$ .

If there exists  $|\rho|: A \to B \otimes \tilde{Q}$  for some  $\rho$ , then we call the object supp  $\rho := \tilde{Q}$  the support of  $\rho$ . From the definition of the absolute value it follows that supp  $\rho$  is defined up to an isomorphism compatible with  $|\rho|$ .

**Theorem 2.6** ([\[5,](#page-47-0) Theorem 4.12]). Let C be a monoidal category satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$  and [9](#page-7-2) of Section [2.5.](#page-6-0) Then for every objects A, B in C there exist absolute values of all objects in the category  $MorTens(A, B)$  and, consequently, there exist supports for all morphisms  $\rho: A \to B \otimes Q$  in C.

<span id="page-7-1"></span>2.7. Cosupports of morphisms  $P \otimes A \rightarrow B$ . Cosupports of morphisms are introduced in the dual way.

Let C be a monoidal category. For given objects A, B in C denote by  $\text{Tensor}(A, B)$  the comma category  $((-) \otimes A \downarrow B)$ , i.e. the category where

• the objects are morphisms  $\psi: P \otimes A \to B$  for some objects P;

<span id="page-8-1"></span>• the morphisms between  $\psi_1: P_1 \otimes A \to B$  and  $\psi_2: P_2 \otimes A \to B$  are morphisms  $\tau: P_1 \to P_2$  making the diagram below commutative:



For morphisms  $\psi: P \otimes A \to B$  we are going to use the terminology and the notation from Sections [2.1](#page-3-1) and [2.2](#page-4-0) with respect to  $X = \textbf{Tensor} (A, B)$ <sup>op</sup>.

**Definition 2.7.** We say that a morphism  $\psi: P \otimes A \rightarrow B$  is a tensor monomorphism if  $\rho \in \text{LIO}(\text{Tensor}(A, B)^\text{op}),$  i.e. if for every  $f, g: R \to P$  such that that

$$
\psi(f \otimes \mathrm{id}_A) = \psi(g \otimes \mathrm{id}_A)
$$

we have  $f = q$ .

If there exists  $|\psi|: \tilde{P} \otimes A \to B$  for some  $\psi$ , then we call the object cosupp  $\psi := \tilde{P}$  the cosupport of  $\psi$ . From the definition of the absolute value it follows that cosupp  $\psi$  is defined up to an isomorphism compatible with  $|\rho|$ .

**Theorem 2.8** ([\[5,](#page-47-0) Theorem 5.15]). Let C be a monoidal category satisfying the properties dual to Properties [1,](#page-6-2)  $4\n-6$  $4\n-6$  and [9](#page-7-2) of Section [2.5.](#page-6-0) Then for every objects A, B in C there exist absolute values of all objects in the category  $\text{Tensor}(A, B)$ <sup>op</sup> and, consequently, there exist cosupports for all morphisms  $\psi: P \otimes A \rightarrow B$  in C.

## <span id="page-8-0"></span>2.8. Universal objects.

2.8.1. Universal comeasuring monoids and universal measuring comonoids. Fix Ω-magmas A and B in a braided monoidal category  $\mathcal{C}$ .

Consider the category  $\mathbf{Comeas}(A, B)$  where

- the objects are all comeasurings  $\rho: A \to B \otimes Q$  for all monoids  $Q$ ;
- the morphisms from  $\rho_1: A \to B \otimes Q_1$  to  $\rho_2: A \to B \otimes Q_2$  are monoid homomorphisms  $\varphi: Q_1 \to Q_2$  making the diagram below commutative:

$$

Given a tensor epimorphism  $\rho_U : A \to B \otimes U$  for some object U in C, let us call the monoid  $\mathcal{A}^{\text{\tiny{T}}}(\rho_{U})$  corresponding to the initial object  $\rho_{U}^{\text{Comeas}}$ :  $A \to B \otimes \mathcal{A}^{\text{\tiny{T}}}(\rho_{U})$  in  $\text{Comeas}(A, B)(\rho_{U})$ (if it exists) the U-universal comeasuring monoid from  $A$  to  $B$ .

Consider the category  **where** 

- the objects are all measurings  $\psi: P \otimes A \rightarrow B$  for all comonoids P;
- the morphisms from  $\psi_1: P_1 \otimes A \to B$  to  $\psi_2: P_2 \otimes A \to B$  are monoid homomorphisms  $\varphi: P_1 \to P_2$  making the diagram below commutative:



Let  $\psi_V: V \otimes A \to B$  be a tensor monomorphism for some object V. We call the comonoid  $\mathcal{C}(\psi_V)$  corresponding to the initial object

$$
\psi_V^{\text{Meas}} \colon {}_{{}^\mathbb{C}}\mathcal{C}(\psi_V) \otimes A \to B
$$

in  $\text{Meas}(A, B)^\text{op}(\psi_V)$  (if it exists) the *V*-universal measuring comonoid from A to B.



2.8.2. Universal (co)acting bi/Hopf monoids. Fix an Ω-magma A in a braided monoidal category C.

Consider the category  $\text{Coact}(A)$  where

- the objects are all coactions  $\rho: A \to A \otimes B$  for all bimonoids B;
- the morphisms from  $\rho_1: A \to A \otimes B_1$  to  $\rho_2: A \to A \otimes B_2$  are bimonoid homomorphisms  $\varphi: B_1 \to B_2$  making the diagram below commutative:



Let U be a comonoid and let a tensor epimorphism  $\rho_U: A \to A \otimes U$  define on A a structure of a U-comodule. Let us call the bimonoid corresponding to the initial object in **Coact** $(A)(\rho_U)$  (if it exists) the *U*-universal coacting bimonoid on A.

Consider the category  $\text{Act}(A)$  where

- the objects are all actions  $\psi: B \otimes A \to A$  for all bimonoids B;
- the morphisms from  $\psi_1: B_1 \otimes A \to A$  to  $\psi_2: B_2 \otimes A \to A$  are bimonoid homomorphisms  $\varphi: B_1 \to B_2$  making the diagram below commutative:

$$

Now let V be a monoid and let a tensor monomorphism  $\psi_V : V \otimes A \to A$  define on A a structure of a V -module. Let us call the bimonoid corresponding to the initial object in  $\mathbf{Act}(A)^{op}(\psi_V)$  (if it exists) the *V*-universal acting bimonoid on A.

Consider the category  $\textbf{HCoact}(A)$  where

- the objects are all coactions  $\rho: A \to A \otimes H$  for all Hopf monoids H;
- the morphisms from  $\rho_1: A \to A \otimes H_1$  to  $\rho_2: A \to A \otimes H_2$  are Hopf monoid homomorphisms  $\varphi: H_1 \to H_2$  making the diagram below commutative:



Let U be a comonoid and let a tensor epimorphism  $\rho_U: A \to A \otimes U$  define on A a structure of a U-comodule. We call the Hopf monoid corresponding to the initial object in  $\textbf{HCoact}(A)(\rho_U)$  (if it exists) the *U*-universal coacting Hopf monoid on A.

<span id="page-10-4"></span>Consider the category  $H \text{Act}(A)$  where

- the objects are all actions  $\psi: H \otimes A \to A$  for all Hopf monoids  $H$ ;
- the morphisms from  $\psi_1: H_1 \otimes A \to A$  to  $\psi_2: H_2 \otimes A \to A$  are Hopf monoid homomorphisms  $\varphi: H_1 \to H_2$  making the diagram below commutative:



Let V be a monoid and let a tensor monomorphism  $\psi_V: V \otimes A \to A$  define on A a structure of a V-module. Let us call the Hopf monoid  $\mathcal{H}(\psi_V)$  corresponding to the initial object  $\psi_V^{\textbf{HAct}}$  in  $\textbf{HAct}(A)^\text{op}(\psi_V)$  (if it exists) the *V*-universal acting Hopf monoid on A.

<span id="page-10-0"></span>2.9. Monoidal functors. Let  $(C, \otimes, \mathbb{1}, a, l, r)$  and  $(C', \otimes', \mathbb{1}', a', l', r')$  be two monoidal categories. Recall that a functor  $F: \mathcal{C} \to \mathcal{C}^l$  is called a *(lax) monoidal functor* if there exist fixed natural transformations  $J_{A,B}$ :  $FA \otimes^{\iota} FB \to F(A \otimes B)$  and a morphism  $\varphi: \mathbb{I}^{\iota} \to F\mathbb{1}$  making the diagrams below commutative for all objects  $A, B, C$  in  $\mathcal{C}$ :

A functor  $F$  is called *op-monoidal* if  $F^{\rm op}$  is monoidal.

<span id="page-10-1"></span>If for a monoidal functor F all  $J_{A,B}$  and  $\varphi$  are isomorphisms, then F is called *strong* and if all  $J_{A,B}$  and  $\varphi$  are identity morphisms, then F is called *strict*.

# 3. Duality

<span id="page-10-2"></span>3.1. Pre-rigid categories. A monoidal category  $(C, \otimes, \mathbb{1}, a, l, r)$  is called pre-rigid [\[8,](#page-47-11) [13\]](#page-47-12) if for every object A in C there exists a fixed object  $A^*$  and a morphism  $ev_A: A^* \otimes A \to \mathbb{1}$ such that for every object  $B$  the map

$$
\mathcal{C}(B, A^*) \to \mathcal{C}(B \otimes A, \mathbb{1}), \qquad f \mapsto \text{ev}_A(f \otimes \text{id}_A), \tag{3.1}
$$

is a bijection. Note that the correspondence  $(3.1)$  is automatically natural in B.

<span id="page-11-3"></span>Remark 3.1. Given an object A, the object  $A^*$  is unique up to an isomorphism compatible with ev<sub>A</sub> since ev<sub>A</sub> is the terminal object in the comma category  $((-) \otimes A \downarrow \mathbb{1}).$ 

For a given morphism  $f: A \to B$  in C define  $f^*$  to be the morphism  $B^* \to A^*$  corresponding to ev<sub>B</sub>(id<sub>B<sup>∗</sub>⊗f)</sup> under the bijection [\(3.1\)](#page-10-3). Then  $(-)$ <sup>\*</sup> becomes a contravariant functor such</sub> that the bijection  $(3.1)$  is natural in A too and ev<sub>A</sub> is dinatural in A.

Now we are going to define a monoidal structure on  $(-)^*$ .

Let C be a pre-rigid braided monoidal category with a braiding  $c_{A,B}$ :  $A \otimes B \to B \otimes A$ . For given objects A and B in C denote by  $\theta_{A,B}: A^* \otimes B^* \to (A \otimes B)^*$  the morphism corresponding under the bijection  $(3.1)$  to the composition

$$
A^* \otimes B^* \otimes A \otimes B \xrightarrow{\mathrm{id}_A \otimes c_{A,B^*}^{-1} \otimes \mathrm{id}_B} A^* \otimes A \otimes B^* \otimes B \xrightarrow{\mathrm{ev}_A \otimes \mathrm{ev}_B} \mathbb{1} \otimes \mathbb{1} \xrightarrow{\sim} \mathbb{1}
$$

By  $\iota: \mathbb{1} \to \mathbb{1}^*$  denote the morphism corresponding under the bijection  $(3.1)$  to the identification  $\mathbb{1} \otimes \mathbb{1} \xrightarrow{\sim} \mathbb{1}$ .

<span id="page-11-2"></span>As it was noticed in [\[8,](#page-47-11) Section 4.3], the following theorem holds:

**Theorem 3.2.**  $\theta_{A,B}$  is a natural transformation and  $(-)^{*}: \mathcal{C} \to \mathcal{C}^{\text{op}}$  together with  $\theta$  and  $\iota$ is a braided op-monoidal functor where  $\mathcal{C}^{\mathrm{op}}$  is the braided monoidal category opposite to  $\mathcal C$ as an ordinary category with the same monoidal product as in  $\mathcal{C}$ , the associativity constraint  $a'_{A,B,C} := a_{A,B,C}^{-1}$  and the braiding  $c'_{A,B} := c_{B,A}.$ 

Using the braiding, we get a self-adjunction of  $(-)^*$ :

(3.2)

For a given morphism  $f: A \to B^*$  define  $f^{\sharp}: B \to A^*$  as the image of f under the composition of bijective natural transformations [\(3.2\)](#page-11-0).

Analogously, for a morphism  $g: B \to A^*$  define  $g^{\flat}: A \to B^*$  as the preimage of g under the composition [\(3.2\)](#page-11-0) above. Obviously,  $f = (f^{\sharp})^{\flat}$  for every  $f: A \to B^*$  and  $g = (g^{\flat})^{\sharp}$  for every  $g: B \to A^*$ .

Denote by  $\alpha_A: A \to A^{**}$  the counit of the adjunction  $(3.2)$ , i.e.  $\alpha_A := id_{A^*}^{\flat}$  for every object  $A$  in  $C$ .

The functor  $(-)^*$  induces a contravariant functor

$$
Comon(\mathcal{C}) \to Mon(\mathcal{C}), \qquad (C, \Delta, \varepsilon) \mapsto (C^*, \mu, u)
$$

where  $\mu = \Delta^* \theta_{C,C}$ ,  $u = \varepsilon^* \iota$ . We denote this functor again by  $(-)^*$ .

Example 3.3. One of the important examples of pre-rigid categories are closed monoidal categories (we refer to Section [5](#page-35-0) for concrete examples). A monoidal category  $\mathcal C$  is closed if for every object A in C the functor  $(-) \otimes A$  has a left adjoint  $[A, -]$ , which is called the *internal hom.* Note that the functor  $(-)\otimes 1$  is isomorphic to the identical functor  $id_{\mathcal{C}}$ . Hence we may assume that  $[1, -] = id_{\mathcal{C}}$  too. Since ⊗ is a bifunctor  $\mathcal{C} \times \mathcal{C} \to \mathcal{C}$ , the adjunction

$$
\mathcal{C}(A\otimes B,C)\cong \mathcal{C}(A,[B,C])
$$

defines a bifunctor  $[-,-]: \mathcal{C}^{op} \times \mathcal{C} \to \mathcal{C}$  in a unique way. Let  $ev_{B,A}: [B,A] \otimes B \to A$  be the counit of this adjunction. Then C is pre-rigid with respect to  $(-)^* := [-1]$  and  $ev_A := ev_{A,1}$ .

<span id="page-11-1"></span>**Lemma 3.4.** For every morphism  $f: P \to U^*$  the diagram below is commutative:

Proof. Consider the following diagram:



The polygon on the right is commutative by the definition of  $(-)^{\flat}$ . The lower left quadrilateral is commutative by the naturality of the braiding.

<span id="page-12-0"></span>Therefore the outer rectangle is commutative too and the lemma is proven.  $\Box$ 

3.2. Correspondence between morphisms. Now we introduce several maps defined on morphisms in a pre-rigid braided monoidal category  $\mathcal C$  and prove some of their properties.

For a given morphism  $\rho: A \to B \otimes Q$ , where A, B, Q are some objects, define the morphism  $\rho^{\vee}$ :  $Q^* \otimes A \to B$  by the commutative diagram

$$
Q^* \otimes B \otimes Q \xrightarrow{c_{Q^*,B} \otimes \text{id}_Q} B \otimes Q^* \otimes Q \xrightarrow{\text{id}_B \otimes \text{ev}_Q} B \otimes 1

For a given morphism  $\rho: A \to B \otimes P^*$ , where  $A, B, P$  are some objects, define the morphism  $\rho^{\nabla} \colon P \otimes A \to B$  by the commutative diagram

<span id="page-12-1"></span>**Proposition 3.5.** Let  $\rho: A \to B \otimes U$  and  $f: P \to U^*$  be some morphisms in C. Then  $((\mathrm{id}_B \otimes f^{\flat}) \rho)^{\nabla} = \rho^{\vee} (f \otimes \mathrm{id}_A).$ 

Proof. Consider the diagram below:

The upper left triangle and the left square in the middle are commutative by the functoriality of ⊗, the upper right triangle is commutative by the naturality of the braiding. The lower left triangle is commutative by the corresponding property of the braiding and the lower right polygon is commutative by Lemma [3.4.](#page-11-1) Therefore the outer square is commutative too, which implies the proposition since the compositions on the left and on the right equal  $((id_B \otimes f^{\flat})\rho)^{\nabla}$  and  $\rho^{\vee}(f \otimes id_A)$ , respectively.

The proposition below can be proved directly by a similar diagram chase, however now it is easier to deduce it from the proposition above:

<span id="page-13-2"></span>**Proposition 3.6.** Let  $\rho: A \to B \otimes P$  and  $f: P \to U$  be some morphisms in C. Then  $((id_B \otimes f)\rho)^\vee = \rho^\vee(f^* \otimes id_A).$ 

*Proof.* By the naturality of  $(-)^{\flat}$  we have

$$
f^{*b} = (f^* \mathrm{id}_{U^*})^b = (\mathrm{id}_{U^*})^b f.
$$

Applying Proposition [3.5](#page-12-1) two times, we get

$$
\rho^{\vee}(f^* \otimes \mathrm{id}_A) = ((\mathrm{id}_B \otimes f^{*})\rho)^{\nabla} = ((\mathrm{id}_B \otimes (\mathrm{id}_{U^*})^{\flat}f)\rho)^{\nabla}
$$

$$
= ((\mathrm{id}_B \otimes (\mathrm{id}_{U^*})^{\flat})(\mathrm{id}_B \otimes f)\rho)^{\nabla} = ((\mathrm{id}_B \otimes f)\rho)^{\vee}(\mathrm{id}_{U^*} \otimes \mathrm{id}_A) = ((\mathrm{id}_B \otimes f)\rho)^{\vee}.
$$

Below we deduce from the universal property of ev some cancellation property for morphisms. Recall that  $\alpha_B : B \to B^{**}$  is a monomorphism for every object B in C if and only if the functor  $(-)^*$  is faithful.

<span id="page-13-1"></span>**Lemma 3.7.** Let  $\rho_1, \rho_2 \colon A \to B \otimes P^*$  be morphisms in C for some objects A, B, P such that  $\alpha_B \otimes id_{P^*}$  and  $\theta_{B^*,P}$  are monomorphisms and

<span id="page-13-0"></span>
$$
(\rho_1 \otimes id_P)(id_B \otimes ev_P) = (\rho_2 \otimes id_P)(id_B \otimes ev_P). \tag{3.3}
$$

Then  $\rho_1 = \rho_2$ .

Proof. Consider the following diagram:



By [\(3.3\)](#page-13-0) the composition on the left and lower edges does not depend on whether we take  $\rho_1$  or  $\rho_2$ . The lower left quadrilateral is commutative by the naturality of the braiding. The triangle in the lower right part of the diagram is commutative by the corresponding property of the braiding. The lower right polygon is commutative by the definition of  $\theta$ . The other inner polygons are commutative by the functoriality of ⊗. Therefore, the composition on the right and upper edges does not depend on whether we take  $\rho_1$  or  $\rho_2$  either. Now recall that both  $\alpha_B \otimes id_{P^*}$  and  $\theta_{B^*,P}$  are monomorphisms. Hence the universal property of ev implies that  $\rho_1 = \rho_2$ .

<span id="page-14-0"></span>**Corollary 3.8.** Let  $\rho_1, \rho_2 \colon A \to B \otimes P^*$  be morphisms in C for some objects A, B, P such that  $\alpha_B \otimes id_{P^*}$  and  $\theta_{B^*,P}$  are monomorphisms and  $\rho_1^{\nabla} = \rho_2^{\nabla}$ . Then  $\rho_1 = \rho_2$ .

<span id="page-14-4"></span>**Proposition 3.9.** Let  $\rho: A \to B \otimes U$  be a tensor epimorphism in C such that  $\alpha_B \otimes id_{P^*}$  and  $\theta_{B^*,P}$  are monomorphisms for all objects P. Then  $\rho^{\vee}$ : U\*  $\otimes A \to B$  is a tensor monomorphism.

*Proof.* Let  $f_1, f_2 \colon P \to U^*$  be two morphisms such that  $\rho^{\vee}(f_1 \otimes id_A) = \rho^{\vee}(f_2 \otimes id_A)$ . We claim that  $f_1 = f_2$ .

By Proposition [3.5](#page-12-1) we have

$$
((\mathrm{id}_B \otimes f_1^{\flat}) \rho)^{\nabla} = \rho^{\vee}(f_1 \otimes \mathrm{id}_A) = \rho^{\vee}(f_2 \otimes \mathrm{id}_A) = ((\mathrm{id}_B \otimes f_2^{\flat}) \rho)^{\nabla}.
$$

Now Corollary [3.8](#page-14-0) implies that  $(id_B \otimes f_1^{\flat})\rho = (id_B \otimes f_2^{\flat})\rho$ . Thus  $f_1^{\flat} = f_2^{\flat}$  since  $\rho$  is a tensor epimorphism. Therefore  $f_1 = f_2$  and  $\rho^{\vee}$  is a tensor monomorphism.

Below we prove the commutativity of diagrams that relate operations in a comonoid P and the monoid  $P^*$  dual to  $P$ :

<span id="page-14-3"></span>**Lemma 3.10.** Let  $(P, \Delta, \varepsilon)$  be a comonoid in C and let  $(P^*, \mu, u)$  be the dual monoid. Then the diagrams below are commutative:

Proof. Consider the diagram



The triangle on the left is commutative by the definition of  $u$ , the lower quadrilateral is commutative by the dinaturality of ev, the central quadrilateral is commutative by the functoriality of ⊗, the upper right quadrilateral is commutative by the naturality of the transformation  $\mathbb{1} \otimes M \to M$ , the lower right triangle is commutative by the definition of  $\iota$ . Hence the outer square is commutative too, which yields the commutativity of [\(3.4\)](#page-14-1).

Now consider the diagram



The upper square is commutative by the functoriality of ⊗. The lower square is commutative by the dinaturality of ev. Hence the outer square is commutative too, which yields the commutativity of  $(3.5)$ .

<span id="page-15-2"></span>**Lemma 3.11.** Let  $(P, \Delta, \varepsilon)$  be a comonoid in C and let  $(P^*, \mu, u)$  be the dual monoid. Then the diagrams  $(3.6)$  and  $(3.7)$  below are commutative:

Proof. First, consider the diagram



The inner polygons are commutative by the properties of the braiding and Lemma [3.10.](#page-14-3) Therefore, the outer square is commutative too, which yields the commutativity of [\(3.6\)](#page-15-0).

Now consider the diagram



The inner polygons are commutative by Lemma [3.10,](#page-14-3) the definition of  $\theta$  and the properties of the braiding. Therefore, the outer square is commutative too, which yields the commutativity of  $(3.7)$ .

Applying properties of the braiding, we deduce Lemma [3.12](#page-16-0) below from Lemma [3.11:](#page-15-2)

**Corollary 3.13.** Let  $\rho: A \to B \otimes P^*$  be a morphism in C for some comonoid P and objects A and B. Then for every  $m \in \mathbb{Z}_+$  the diagram below is commutative:



where in the expressions  $(\rho^{\nabla})^{\widetilde{\otimes}m}$  and  $\rho^{\widetilde{\otimes}m}$  we use the monoidal products in the categories Tens $\mathsf{Mor}(P)$  and  $\mathsf{MorTens}(P^*)$  defined in Section [2.4.](#page-5-0)

<span id="page-16-2"></span>**Lemma 3.14.** Let  $\rho: A \to B \otimes P^*$  be a morphism for some  $\Omega$ -magmas A and B and comonoid  $P$  in  $\mathcal{C}$ .

I. If  $\rho$  is a comeasuring, then  $\rho^{\nabla}$ :  $P \otimes A \rightarrow B$  is a measuring.

II. If  $\rho^{\nabla}$  is a measuring and  $\alpha_{B^{\otimes t(\omega)}}\otimes {\rm id}_{P^*}$  and  $\theta_{\left(B^{\otimes t(\omega)}\right)^*,P}$  are monomorphisms for every  $\omega \in \Omega$ , then  $\rho$  is a comeasuring.

<span id="page-17-0"></span>*Proof.* For every  $\omega \in \Omega$  consider the following diagram where  $m = s(\omega)$  and  $n = t(\omega)$ :



The upper and the lower quadrilaterals are commutative by Corollary [3.13.](#page-16-1) The central square is commutative by the naturality of the braiding. The two quadrilaterals on the right are commutative by the functoriality of ⊗ and the naturality of the transformation  $C \otimes \mathbb{1} \longrightarrow C$ .

Now we notice that the left quadrilateral of  $(3.8)$  is the diagram  $(3.9)$  below tensored by P from the left:

Hence if  $\rho$  is a comeasuring, then [\(3.9\)](#page-17-1) is commutative, the outer square of [\(3.8\)](#page-17-0) is commutative too,  $\rho^{\nabla}$ :  $P \otimes A \to B$  is a measuring, and Part I is proved.

Suppose now that  $\rho^{\nabla}$  is a measuring and  $\alpha_{B^{\otimes n}} \otimes id_{P^*}$  and  $\theta_{(B^{\otimes n})^*,P}$  are monomorphisms. Then the outer square of  $(3.8)$  is commutative and, by the naturality of the braiding and Lemma [3.7,](#page-13-1) [\(3.9\)](#page-17-1) is commutative for every  $\omega \in \Omega$ , i.e.  $\rho$  is a comeasuring.

Now we are ready to prove that under some conditions the map  $\rho \mapsto \rho^{\nabla}$  is a bijection:

<span id="page-17-2"></span>**Lemma 3.15.** Let  $\rho_U: A \to B \otimes U$  be a tensor epimorphism in C for  $\Omega$ -magmas A and B and an object U. Suppose  $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects M, N. For a given comonoid P in C denote by  $\text{Meas}(P, \rho_U^{\vee})$  the set of measurings  $\psi \colon P \otimes A \to B$  such that there exists a morphism  $\psi \to \rho_U^{\vee}$  in **TensMor** $(A, B)$  and by Comeas $(P^*, \rho_U)$  the set of comeasurings  $\rho: A \to B \otimes P^*$  such that there exists a morphism  $\rho_U \to \rho$  in **MorTens** $(A, B)$ . Then the map  $\rho \mapsto \rho^{\nabla}$  defines a bijection Comeas( $P^*, \rho_U$ )  $\cong$  Meas( $P, \rho_U^{\vee}$ ) natural in the comonoid P if we regard  $Meas(-, \rho_U^{\vee})$  and  $Comeas((-)^*, \rho_U)$  as functors  $Comon(\mathcal{C}) \to \mathbf{Sets}$ .

*Proof.* By Proposition [3.9,](#page-14-4)  $\rho_U^{\vee}$  is a tensor monomorphism. Hence  $Meas(P, \rho_U^{\vee})$  can be identified with the subset of  $C(P, U^*)$  consisting of such morphisms  $g: P \to U^*$  that  $\psi = \rho_U^{\vee}(g \otimes id_A)$ is a measuring. Analogously, Comeas $(P^*, \rho_U)$  can be identified with the subset of  $\mathcal{C}(U, P^*)$ 

<span id="page-18-6"></span>consisting of such morphisms  $f: U \to P^*$  that  $\rho = (\text{id}_B \otimes f) \rho_U$  is a comeasuring. By Proposition [3.5,](#page-12-1)

<span id="page-18-1"></span>
$$
\rho^{\nabla} = ((\mathrm{id}_B \otimes f) \rho_U)^{\nabla} = \rho_U^{\vee} (f^{\sharp} \otimes \mathrm{id}_B). \tag{3.10}
$$

By Lemma [3.14](#page-16-2) a morphism  $\rho: A \to B \otimes P^*$  is a comeasuring if and only if  $\rho^{\nabla} : P \otimes A \to B$ is a measuring. Now  $(3.10)$  implies that the map  $(-)^{\nabla}$  is a restriction of the natural bijection  $(-)^{\sharp}$ :  $\mathcal{C}(U, P^*) \stackrel{\sim}{\rightarrow} \mathcal{C}(P, U^*)$ ).  $\qquad \qquad \Box$ 

<span id="page-18-0"></span>3.3. Correspondence between supports and cosupports. The naturality of the bijection  $(-)^{\flat}$  implies Proposition [3.16](#page-18-2) below:

<span id="page-18-2"></span>**Proposition 3.16.** Let  $f: A \rightarrow B$  be an epimorphism in a pre-rigid braided monoidal category C. Then  $f^*: B^* \to A^*$  is a monomorphism.

However, below we require a somewhat dual property. Namely, in Theorems [3.18](#page-18-3)[—3.20](#page-18-4) below  $\mathcal C$  is a pre-rigid braided monoidal category satisfying Properties [1,](#page-6-2) [4–](#page-6-3)[6,](#page-6-5) [9](#page-7-2) of Section [2.5](#page-6-0) and their duals, such that the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms.

Remark 3.17. The conditions above hold in  $C = \text{Vect}_{\mathbb{k}}$  for a field k. In Theorems [5.18](#page-44-1) and [5.23](#page-46-1) below we show that these conditions hold in  $C = H$  Mod, the category of left H-modules, for a quasitriangular Hopf algebra H and in  $\mathcal{C} = dgVect_{\mathbb{k}}$ , the category of differential graded vector spaces over a field <sup>k</sup>. In addition, the conditions above hold in  $C = \mathsf{Comod}^{\mathbbk G}$ , the category of G-graded vector spaces, for a field k and a group G (see Section [5.6\)](#page-45-0). In Remarks [5.14](#page-42-0) [\(2\)](#page-42-1) and Remarks [5.22](#page-45-1) [\(2\)](#page-45-2) below we give examples of categories where  $f^*$  is not an epimorphism for some extremal monomorphism  $f$ .

<span id="page-18-3"></span>These theorems will not be used until Section [4:](#page-26-0)

**Theorem 3.18.** Let  $\rho: A \to B \otimes Q$  be a morphism in C such that  $\alpha_B \otimes id_{P^*}$  and  $\theta_{B^*,P}$  are monomorphisms for all objects P. Let  $|\rho|: A \to B \otimes (\text{supp }\rho)$  be the absolute value of  $\rho$ . Then  $\operatorname{cosupp}(\rho^{\vee}) = (\operatorname{supp} \rho)^*$  and  $|\rho|^{\vee}$ :  $(\operatorname{supp} \rho)^* \otimes A \to B$  is the absolute value of  $\rho^{\vee}$ .

*Proof.* Recall that  $|\rho|$  is a tensor epimorphism and  $\rho = (id_B \otimes \tau)|\rho|$  for some extremal monomorphism  $\tau$ : supp  $\rho \mapsto Q$  (see [\[5,](#page-47-0) Remark 4.14 and Lemma 4.16]). Hence by Proposition [3.6](#page-13-2)

$$
\rho^{\vee} = ((\mathrm{id}_B \otimes \tau)|\rho|)^{\vee} = |\rho|^{\vee}(\tau^* \otimes \mathrm{id}_A).
$$

By Proposition [3.9](#page-14-4) the morphism  $|\rho|^{\vee}$  is a tensor monomorphism and, by our assumptions, the morphism  $\tau^*$  is an extremal epimorphism. Hence, by the proposition dual to [\[5,](#page-47-0) Proposition 4.18, the morphism  $|\rho|^{\vee}$  indeed corresponds to the cosupport of  $\rho^{\vee}$ . — Первый проста в проста в проста в серверності в серверності в серверності в серверності в серверності в с<br>При в серверності в сервер

<span id="page-18-5"></span>**Theorem 3.19.** Let  $\rho_i: A \to B \otimes Q_i$ ,  $i = 1, 2$ , be some morphisms in  $C$  such that  $\alpha_B \otimes id_{P^*}$ and  $\theta_{B^*,P}$  are monomorphisms for all objects P. Then  $\rho_1 \succcurlyeq \rho_2$  implies  $\rho_1^{\vee} \succcurlyeq \rho_2^{\vee}$ .

*Proof.* If  $\rho_1 \succcurlyeq \rho_2$ , then there exists a morphism

 $\tau$ : supp  $\rho_1 \rightarrow$  supp  $\rho_2$ 

such that  $(id_B \otimes \tau)|\rho_1| = |\rho_2|$ . By Proposition [3.6](#page-13-2) we have

$$
|\rho_1|^\vee(\tau^*\otimes\mathrm{id}_A)=|\rho_2|^\vee
$$

.

<span id="page-18-4"></span>Now Theorem [3.18](#page-18-3) implies that  $\rho_1^{\vee} \ge \rho_2^{\vee}$ 

**Theorem 3.20.** Let  $\rho_i: A \to B \otimes Q_i$ ,  $i = 1, 2$ , be some morphisms in C such that  $\alpha_P$  is an extremal monomorphism and  $\theta_{B^*,P}$  is a monomorphism for all objects P. Then  $\rho_1^{\vee} \succcurlyeq \rho_2^{\vee}$ implies  $\rho_1 \succcurlyeq \rho_2$ .

.

<span id="page-19-4"></span>*Proof.* By Theorem [3.18,](#page-18-3)  $|\rho_i^{\vee}| = |\rho_i|^{\vee}$ . Suppose that  $\rho_1^{\vee} \ge \rho_2^{\vee}$ . Then  $|\rho_1|^{\vee}(f \otimes \mathrm{id}_A) = |\rho_2|^{\vee}$ 

for some morphism  $f: (\text{supp } \rho_2)^* \to (\text{supp } \rho_1)^*$ . Proposition [3.5](#page-12-1) implies

$$
\left( (\mathrm{id}_B \otimes f^{\flat})|\rho_1| \right)^{\nabla} = |\rho_1|^{\vee} (f \otimes \mathrm{id}_A) = |\rho_2|^{\vee} = |\rho_2|^{\vee} (\mathrm{id}_{(\mathrm{supp}\,\rho_2)^*} \otimes \mathrm{id}_A)
$$

$$
= \left( (\mathrm{id}_B \otimes (\mathrm{id}_{\mathrm{supp}\,\rho_2})^{\flat})|\rho_2| \right)^{\nabla} = \left( (\mathrm{id}_B \otimes \alpha_{\mathrm{supp}\,\rho_2})|\rho_2| \right)^{\nabla}.
$$

By Corollary [3.8,](#page-14-0)

$$
(\mathrm{id}_B \otimes f^{\flat})|\rho_1| = (\mathrm{id}_B \otimes \alpha_{\mathrm{supp}\,\rho_2})|\rho_2|.
$$

Hence  $(id_B \otimes \alpha_{\text{supp }\rho_2})|\rho_2| \preccurlyeq \rho_1$ . Since by our assumptions  $\alpha_{\text{supp }\rho_2}$  is an extremal monomorphism, [\[5,](#page-47-0) Proposition 4.18] implies that

$$
|(\mathrm{id}_B\otimes\alpha_{\mathrm{supp}\,\rho_2})|\rho_2|\big|=|\rho_2|,
$$

<span id="page-19-0"></span>and we get  $\rho_2 \preccurlyeq \rho_1$ .

3.4. Finite dual. Let  $\mathcal C$  be a pre-rigid braided monoidal category. Suppose that the functor  $(-)^*$ : Comon(C) → Mon(C) has an adjoint functor  $(-)^{\circ}$ : Mon(C) → Comon(C) such that there exists a natural bijection

$$
\text{Mon}(\mathcal{C})(A, C^*) \cong \text{Comon}(\mathcal{C})(C, A^{\circ}).
$$

As usual, given an object A in  $\mathsf{Mon}(\mathcal{C})$  the object  $A^\circ$  is called the *finite* or the *Sweedler* dual of A.

<span id="page-19-3"></span>Remark 3.21. By [\[5,](#page-47-0) Theorem 5.9] and [\[7,](#page-47-13) Theorem 1.5] the functor  $(-)^\circ$  exists, for example, if C satisfies Properties [4,](#page-6-3) [5](#page-6-6) and the properties dual to Properties  $1-3$  $1-3$  and [10](#page-7-4) of Section [2.5.](#page-6-0)

Let A be a monoid in C. Denote by  $\varkappa_A: A^\circ \to A^*$  the morphism in C corresponding to  $id_{A^{\circ}}$  under the following composition of bijections and an embedding:

$$
\mathsf{Comon}(\mathcal{C})(A^\circ,A^\circ) \cong \mathsf{Mon}(\mathcal{C})(A,A^{\circ*}) \subseteq \mathcal{C}(A,A^{\circ*}) \xrightarrow{(-)^\sharp} \mathcal{C}(A^\circ,A^*) \; .
$$

<span id="page-19-2"></span>Note that  $\kappa$  is natural in A by the naturality of the maps above.

**Lemma 3.22.** For every monoid Q in  $\mathcal C$  the diagram below is commutative:

$$
Q^{\circ} \otimes Q \xrightarrow{\varkappa_Q \otimes \text{id}_Q} Q^* \otimes Q
$$

<span id="page-19-1"></span>*Proof.* Apply Lemma [3.4](#page-11-1) for  $P = Q^\circ$ ,  $U = Q$ ,  $f = \varkappa_Q$ .

**Proposition 3.23.** Let  $\rho: A \to B \otimes Q$  be a comeasuring for some  $\Omega$ -magmas A and B and a monoid Q in C. Then  $\rho^{\vee}(\varkappa_Q \otimes \mathrm{id}_A)$ :  $Q^{\circ} \otimes A \to B$  is a measuring.

Proof. By Proposition [3.5,](#page-12-1)

$$
((\operatorname{id}_B \otimes \mathcal{H}_Q^{\flat}) \rho)^{\nabla} = \rho^{\vee}(\mathcal{H}_Q \otimes \operatorname{id}_A).
$$

Now we use the fact that  $\mathcal{A}_Q^{\flat}$  is a monoid homomorphism and apply Lemma [3.14.](#page-16-2)

In Theorem [3.24](#page-20-1) below we not only show that  $\mathcal{A}^{\text{I}}(\rho_U)^\circ \cong {}_{\text{I}}\mathcal{C}(\rho_U^\vee)$  but also provide an explicit isomorphism:

**Theorem 3.24.** Let  $\mathcal C$  be a pre-rigid braided monoidal category such that

- there exists the functor  $(-)^\circ$ ;
- $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects M, N.

Let  $\rho_U : A \to B \otimes U$  be a tensor epimorphism in C for  $\Omega$ -magmas A and B and an object U such that there exist  $\mathcal{A}^{\alpha}(\rho_U)$  and  ${}_{\alpha}\mathcal{C}(\rho_U^{\vee})$ . Then

is a measuring and the unique comonoid homomorphism  $\beta\colon \mathcal{A}^{\mathbb{I}}(\rho_U)^{\circ} \to {}_{\mathbb{I}}\mathcal{C}(\rho_U^{\vee})$  making the diagram

Remark 3.25. Consider the following (not necessarily commutative) diagram where  $G_1$  and  $G'_{1}$  are forgetful functors:

Theorem [3.24](#page-20-1) asserts that if  $\rho_U^{\text{Comeas}}$  is the initial object in  $\text{Comeas}(A, B)(\rho_U)$ , then  $(\rho_U^{\text{Comeas}})^\vee(\varkappa_{\mathcal{A}^\circ(\rho_U)}\otimes \mathrm{id}_A)$  is an initial object in  $\text{Meas}(A,B)^\mathrm{op}(\rho_U^\vee)$ .

*Proof of Theorem 3.24*. The morphism  $(\rho_U^{\text{Comeas}})^\vee (\varkappa_{\mathcal{A}^\circ(\rho_U)} \otimes \mathrm{id}_A)$  is a measuring by Proposition [3.23.](#page-19-1)

Inspired by [\[22,](#page-48-1) Remark 1.3], we can add the bijection from Lemma [3.15](#page-17-2) to the following bijections natural in the comonoid  $P$ :

Now if we substitute for P the comonoid  $\mathcal{A}^{\mathbb{I}}(\rho_U)^\circ$ , the comonoid homomorphism  $\mathcal{A}^{\text{I}}(\rho_U)^\circ \to {}_{\text{I}}\mathcal{C}(\rho_U^\vee)$ , corresponding to  $\mathrm{id}_{\mathcal{A}^{\text{I}}(\rho_U)^\circ}$ , will be equal to  $\beta$  by Lemma [3.22.](#page-19-2) If we substitute for P the comonoid  ${}_{\alpha}C(\rho_U^{\vee})$ , by the naturality, the homomorphism  $\mathrm{id}_{\alpha}C(\rho_U^{\vee})$  will correspond to  $\beta^{-1}$ . Hence  $\beta$  is a comonoid isomorphism.

<span id="page-20-3"></span>Corollary 3.26. Let C be a pre-rigid braided monoidal category satisfying Properties [1,](#page-6-2)  $\lambda$ , [5,](#page-6-6) [8,](#page-7-3) [10](#page-7-4) of Section [2.5](#page-6-0) and their duals such that

•  $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects M, N.

\left(\rho_U^{\mathbf{Comeas}}\right)^{\vee}(\varkappa_{\mathcal{A}^{\circ}(\rho_U)}\otimes\mathrm{id}_A)\colon \mathcal{A}^{\circ}(\rho_U)^{\circ}\otimes A\to B
$$

is a measuring and the unique comonoid homomorphism  $\beta \colon \mathcal{A}^{\mathbb{I}}(\rho_U)^\circ \to {}_{\mathbb{I}}\mathcal{C}(\rho_U^\vee)$  making the diagram  $(3.11)$  commutative is a comonoid isomorphism.

<span id="page-21-0"></span>3.6. Duality theorem for (co)actions. For given objects  $A$  and  $B$  in a pre-rigid braided monoidal category C denote by  $\theta_{A,B}^{\text{inv}}: A^* \otimes B^* \to (A \otimes B)^*$  the morphism corresponding under the bijection  $(3.1)$  to the composition

$$
A^* \otimes B^* \otimes A \otimes B \xrightarrow{\mathrm{id}_A \otimes c_{B^*,A} \otimes \mathrm{id}_B} A^* \otimes A \otimes B^* \otimes B \xrightarrow{\mathrm{ev}_A \otimes \mathrm{ev}_B} 1 \otimes 1 \xrightarrow{\sim} 1
$$

(Please notice that in comparison with  $\theta_{A,B}$  in  $\theta_{A,B}^{inv}$  we use the original braiding, not the inverse one.) Again,  $\theta_{A,B}^{\text{inv}}$  is natural in A and B.

<span id="page-21-2"></span>Remark 3.27. By [\[8,](#page-47-11) Proposition 4.4],  $(\hat{\theta}_{A,B}^{inv}, \iota)$  is the monoidal structure on the functor  $(-)^* \colon C^{\text{op}} \to C$  that corresponds to the op-monoidal structure  $(\theta_{A,B}, \iota)$  on  $(-)^* \colon C \to C^{\text{op}}$ under the adjunction  $(-)^{\sharp}$ :  $C^{op}(A^*,B) \stackrel{\sim}{\rightarrow} C(A,B^*)$ .

<span id="page-21-1"></span>**Lemma 3.28.** Let  $\rho_1: B \to C \otimes Q_1$  and  $\rho_2: A \to B \otimes Q_2$  be morphisms in C for some objects  $A, B, C, Q_1, Q_2$ . Then the diagram below is commutative:



Proof. Consider the following diagram:



The upper polygon is commutative by the definition of  $\rho_2^{\vee}$ . The lower right polygon is commutative by the definition of  $\rho_1^{\vee}$ . The upper right triangle is commutative by the properties of a monoidal category. The lower left polygon is commutative by the definition of  $\theta^{\text{inv}}$ . The rectangles in the central part of the diagram are commutative by the functoriality of  $\otimes$ . The squares on the left are commutative by the properties of the braiding. Hence the outer square is commutative too, which implies the lemma.  $\square$ 

<span id="page-22-1"></span>**Lemma 3.29.** Let  $\rho_1: B \to C \otimes Q_1$  and  $\rho_2: A \to B \otimes Q_2$  be morphisms in C for some objects  $A, B, C, Q_1, Q_2$ . Then

$$
((\rho_1 \otimes \mathrm{id}_{Q_2})\rho_2)^{\vee}(\theta_{Q_1,Q_2}^{\mathrm{inv}} \otimes \mathrm{id}_A) = \rho_1^{\vee}(\mathrm{id}_{Q_1^*} \otimes \rho_2^{\vee}).

*Proof.* Apply Lemma [3.28](#page-21-1) and the naturality of the braiding.  $\square$ 

Suppose now that  $\mathcal C$  is a pre-rigid *symmetric* monoidal category, i.e.  $\mathcal C$  is braided and  $c_{B,A} = c_{A,B}^{-1}$  for every objects  $A, B$ . In particular,  $\theta_{A,B} = \theta_{A,B}^{\text{inv}}$ .

<span id="page-22-0"></span>**Lemma 3.30.** Let a morphism  $\rho: M \to M \otimes P$  define on an object M a structure of a right P-comodule for a comonoid P. Then  $\rho^{\vee}$ :  $P^* \otimes M \to M$  defines on M a structure of a left P ∗ -module.

Proof. Consider the following diagram:



The inner polygons are commutative by the naturality of the transformation  $1 \otimes C \rightarrow C$ , the counit property of  $\rho$ , the functoriality of ⊗, Lemma [3.10](#page-14-3) and the properties of the braiding. Therefore the outer polygon is commutative too and  $\rho^{\vee}$  satisfies the unit axiom of a module structure.

Now consider the diagram below:

The inner polygons are commutative by the naturality of the braiding, Lemma [3.10,](#page-14-3) the definition of  $\rho^{\vee}$ , the coassociativity of  $\rho$  and the functoriality of  $\otimes$ . Therefore the outer square is commutative too. By Lemma [3.28,](#page-21-1) the composition along the upper and the right

<span id="page-23-3"></span>sides of the outer square equals  $\rho^{\vee}(\text{id}_{P^*} \otimes \rho^{\vee})$ . Therefore,  $\rho^{\vee}$  satisfies the associativity axiom of a module structure.

When C is symmetric, by Theorem [3.2](#page-11-2) and Remark [3.27,](#page-21-2)  $(-)^*$  is a *symmetric* monoidal functor  $\mathcal{C}^{\text{op}} \to \mathcal{C}$  (i.e. a braided functor in the case of symmetric categories), which is right adjoint to itself considered as an op-monoidal functor  $(-)^*$ :  $\mathcal{C} \to \mathcal{C}^{\text{op}}$ . In particular,  $(-)^*$  induces a monoidal functor  $\textsf{Mon}(\mathcal{C}^{\text{op}}) \to \textsf{Mon}(\mathcal{C})$  and an op-monoidal functor Comon(C) → Comon(C<sup>op</sup>). We denote both of them again by  $(-)^*$ . Suppose now that  $(-)^*$ : Mon( $C^{op}$ ) → Mon( $C$ ) admits a left adjoint functor  $(-)^{\circ}$ : Mon( $C$ ) → Mon( $C^{op}$ ). Then  $(-)^\circ$  is right adjoint to the functor  $(-)^*$ : Comon $(\mathcal{C}) \rightarrow$  Comon $(\mathcal{C}^{\mathrm{op}})$  if we view  $(-)^\circ$  as a functor  $\mathsf{Comon}(\mathcal{C}^{\mathrm{op}}) \to \mathsf{Comon}(\mathcal{C})$ . Moreover,  $(-)^\circ$  being a left adjoint to a monoidal functor is an op-monoidal functor  $\textsf{Mon}(\mathcal{C}) \to \textsf{Mon}(\mathcal{C}^{\text{op}})$ . Analogously,  $(-)^\circ$  is a monoidal functor Comon $(C^{op}) \to \text{Comon}(\mathcal{C})$ . Now recall that  $\text{Comon}(\text{Mon}(\mathcal{C})) = \text{Mon}(\text{Comon}(\mathcal{C})) = \text{Bimon}(\mathcal{C})$ . Hence  $(-)^\circ$  induces functors  $\mathsf{Bimon}(\mathcal{C}) \to \mathsf{Bimon}(\mathcal{C}^\mathrm{op})$  and  $\mathsf{Bimon}(\mathcal{C}^\mathrm{op}) \to \mathsf{Bimon}(\mathcal{C})$ , which we again denote by  $(-)^\circ$ . By [\[13,](#page-47-12) Theorem 2.7],  $(-)^\circ$ : Bimon $(\mathcal{C}) \to \text{Bimon}(\mathcal{C}^{\text{op}})$  is left adjoint to  $(-)^\circ$ : Bimon $(\mathcal{C}^{\mathrm{op}}) \to \mathsf{Bimon}(\mathcal{C})$ .

<span id="page-23-1"></span>**Lemma 3.31.** For every bimonoid B in C the morphism  $\varkappa_B : B^\circ \to B^*$  is a monoid homomorphism.

*Proof.* Applying the proof of [\[13,](#page-47-12) Theorem 2.7] to the case of the functors  $(-)^*$  and  $(-)^{\circ}$ , we see that, given bimonoids  $B_1$  and  $B_2$ , the natural bijection

In particular, the morphism from  $C^{op}(B_1^*,B_2)$  obtained in the second line in fact belongs to **Comon**( $\mathcal{C}^{\text{op}}$ )( $B_1^*, B_2$ ). If we let  $B_1 = B$  and  $B_2 = B^{\circ}$  and consider  $id_B \in \text{Bimon}(\mathcal{C}^{\text{op}})(B^{\circ}, B^{\circ}),$ we get  $\varkappa_B \in \text{Comon}(\mathcal{C}^{\text{op}})(B^*, B^{\circ}),$  which proves the lemma.

<span id="page-24-1"></span>Remark 3.33. Consider the following (not necessarily commutative) diagram where  $G_2$  and  $G'_{2}$  are forgetful functors and  $\text{ModStr}(A)$  is the category of module structures on A:

Theorem [3.32](#page-23-0) asserts that if  $\rho_U^{\text{Coact}}$  is the initial object in  $\text{Coact}(A)(\rho_U)$ , then  $(\rho_U^{\text{Coact}})^\vee(\varkappa_{\mathcal{B}^\circ(\rho_U)}\otimes \text{id}_A)$  is an initial object in  $\text{Act}(A)^\text{op}(\rho_U^\vee)$ .

*Proof of Theorem [3.32.](#page-23-0)* By [\[5,](#page-47-0) Theorems 4.34 and 5.22] there exist  $\mathcal{B}^{\circ}(\rho_U) = \mathcal{A}^{\circ}(\rho_U)$  and  ${}_{\mathbb{E}}\mathcal{B}(\rho_U^{\vee}) = {}_{\mathbb{E}}\mathcal{C}(\rho_U^{\vee})$ . The morphism  $(\rho_U^{\text{Coact}})^{\vee}(\varkappa_{\mathcal{B}^{\mathbb{E}}(\rho_U)} \otimes id_A)$  is an action by Theorem [3.24](#page-20-1) and Lemmas [3.30](#page-22-0) and [3.31.](#page-23-1) Hence the existence of  $\beta$  follows from the definition of  $\beta(\rho_U^{\vee})$ . By Theorem [3.24](#page-20-1) the morphism  $\beta$  is an isomorphism in C. Combined with the fact that  $\beta$  is a bimonoid homomorphism, this implies that  $\beta$  is a bimonoid isomorphism.

**Corollary 3.34.** Let  $C$  be a pre-rigid symmetric monoidal category satisfying Properties [1,](#page-6-2) [4,](#page-6-3) [5,](#page-6-6) [8,](#page-7-3) [10](#page-7-4) of Section [2.5](#page-6-0) and their duals such that

•  $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects M, N.

Let  $\rho_U: A \to A \otimes U$  be a tensor epimorphism defining on an  $\Omega$ -magma A a structure of a U-comodule for a comonoid U. Then

$$
\left(\rho_U^{\mathbf{Coact}}\right)^{\vee}(\varkappa_{\mathcal{B}^{\circ}(\rho_U)}\otimes\mathrm{id}_A)\colon\mathcal{B}^{\circ}(\rho_U)^{\circ}\otimes A\to A
$$

is an action and the unique bimonoid homomorphism  $\beta: B^{\sigma}(\rho_U)^\circ \to B(\rho_U^\vee)$  making the diagram [\(3.13\)](#page-23-2) commutative is a bimonoid isomorphism.

Note that since  $(-)^* \colon \mathcal{C}^{op} \to \mathcal{C}$  is a a symmetric functor, the induced functor  $(-)^*$ : Mon( $\mathcal{C}^{\mathrm{op}}$ ) → Mon( $\mathcal{C}$ ) commutes with the functor  $(-)^{\mathrm{op}}$ , i.e.  $(C^{\mathrm{cop}})^* = (C^*)^{\mathrm{op}}$  for every comonoid C in C. This implies that for the left adjoint functor  $(-)^\circ$ : Mon $(C) \to \textsf{Mon}(\mathcal{C}^\text{op})$ there exists an isomorphism  $(A^{\circ})^{\text{cop}} \cong (A^{\text{op}})^{\circ}$  natural in the monoid A in C. If H is a Hopf monoid in C, then its antipode S is a monoid homomorphism  $H \to H^{\text{op}}$ . Now [\[19,](#page-47-14) Proposition 31] implies that if  $\varkappa_H$  is a monomorphism in C, then  $H^{\circ}$  is a Hopf monoid too where the antipode is the comonoid homomorphism  $(H^{\circ})^{\text{cop}} \to H^{\circ}$  corresponding to  $S^{\circ}$ :  $(H^{\text{op}})^{\circ} \to H^{\circ}$ . As it was noticed in [\[13\]](#page-47-12), the fact that any bimonoid homomorphism between Hopf monoids is in fact a Hopf monoid homomorphism implies that the adjunction

 $\mathsf{Bimon}(\mathcal{C})(H_2,H_1^\circ)\cong \mathsf{Bimon}(\mathcal{C})(H_1,H_2^\circ)$ 

can be restricted to an adjunction

$$
\mathsf{Hopf}(\mathcal{C})(H_2,H_1^\circ)\cong\mathsf{Hopf}(\mathcal{C})(H_1,H_2^\circ)
$$

provided that  $\varkappa_H$  is a monomorphism in C for every Hopf monoid H.

Denote by  $H_l$  and  $H_r$ , respectively, the left and the right adjoint functors (if they exist) to the embedding functor  $\mathsf{Hopf}(\mathcal{C}) \subset \mathsf{Bimon}(\mathcal{C})$ .

<span id="page-24-0"></span>**Theorem 3.35.** Let  $C$  be a pre-rigid symmetric monoidal category such that

- there exist functors  $(-)^\circ$ ,  $H_l$  and  $H_r$ ;
- the morphisms  $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects  $M, N$ ;
- $\varkappa_H$  is a monomorphism in C for every Hopf monoid H.

<span id="page-25-1"></span>Let  $\rho_U: A \to A \otimes U$  be a tensor epimorphism defining on an  $\Omega$ -magma A a structure of a U-comodule for a comonoid U such that there exist  $\mathcal{A}^{\text{\tiny{T}}}(\rho_{U})$  and  ${}_{\text{\tiny{n}}} \mathcal{C}(\rho_{U}^{\vee})$ . Then

$$
\left(\rho^{\textbf{HCoact}}_U\right)^{\vee}(\varkappa_{\mathcal{H}^{\circ}(\rho_U)}\otimes\mathrm{id}_A)\colon \mathcal{H}^{\circ}(\rho_U)^{\circ}\otimes A\to A
$$

is an action and the unique Hopf monoid homomorphism  $\beta^{\text{Hopf}}$ :  $\mathcal{H}^\text{\tiny{I}}(\rho_U)^\circ \to {}_\text{\tiny{I\hspace{-1pt}I}}\mathcal{H}(\rho_U^\vee)$  making the diagram

commutative is a Hopf monoid isomorphism.

Remark 3.36. Consider the following (not necessarily commutative) diagram where  $G_2G_4$ and  $G'_2G'_4$  are forgetful functors:

$$
\operatorname{HCoact}(A) \xrightarrow{(-)^{\vee}(\varkappa_{(\dots)} \otimes \mathrm{id}_A)} \operatorname{HAct}(A)^{\mathrm{op}} \\ G_2 G_4 \downarrow \qquad \qquad \downarrow G_2' G_4' \\ \operatorname{ComodStr}(A) \xrightarrow{(-)^{\vee}} \operatorname{ModStr}(A)^{\mathrm{op}}
$$

Theorem [3.35](#page-24-0) asserts that if  $\rho_U^{\text{HCoact}}$  is the initial object in  $\text{HCoact}(A)(\rho_U)$ , then  $(\rho_U^{\text{HCoact}})^\vee(\varkappa_{\mathcal{H}^\circ(\rho_U)}\otimes \text{id}_A)$  is an initial object in  $\text{HAct}(A)^\text{op}(\rho_U^\vee)$ .

*Proof of Theorem [3.35.](#page-24-0)* Let H be an arbitrary Hopf monoid in C. By [\[5,](#page-47-0) Theorems 4.40] and 5.26] and Theorem [3.32](#page-23-0) we have natural bijections

$$
\mathsf{Hopf}(\mathcal{C})(H, {}_{\scriptscriptstyle\Box}\mathcal{H}(\rho^\vee_U)) = \mathsf{Hopf}(\mathcal{C})(H, H_r({}_{\scriptscriptstyle\Box}\mathcal{B}(\rho^\vee_U))) \cong \mathsf{Bimon}(\mathcal{C})(H, {}_{\scriptscriptstyle\Box}\mathcal{B}(\rho^\vee_U))
$$
  
\n
$$
\cong \mathsf{Bimon}(\mathcal{C})(H, \mathcal{B}^{\scriptscriptstyle\Box}(\rho_U)^{\circ}) \cong \mathsf{Bimon}(\mathcal{C})(\mathcal{B}^{\scriptscriptstyle\Box}(\rho_U), H^{\circ}) \cong \mathsf{Hopf}(\mathcal{C})(H_l(\mathcal{B}^{\scriptscriptstyle\Box}(\rho_U)), H^{\circ})
$$
  
\n
$$
= \mathsf{Hopf}(\mathcal{C})(\mathcal{H}^{\scriptscriptstyle\Box}(\rho_U), H^{\circ}) \cong \mathsf{Hopf}(\mathcal{C})(H, \mathcal{H}^{\scriptscriptstyle\Box}(\rho_U)^{\circ}).
$$

Hence  $\mathcal{H}^{\mathfrak{a}}(\rho_U)$ <sup>o</sup>  $\cong {}_{\mathfrak{a}}\mathcal{H}(\rho_U^{\vee})$  under the isomorphism that corresponds to

$$
\mathrm{id}_{\mathcal{H}^\textup{\text{tr}}(\rho_U)^\circ} \in \textup{Hopf}(\mathcal{C})(\mathcal{H}^\textup{\text{tr}}(\rho_U)^\circ,\mathcal{H}^\textup{\text{tr}}(\rho_U)^\circ)
$$

if we take  $H = \mathcal{H}^{\text{d}}(\rho_U)^\circ$ . But the corresponding element of  $\text{Hopf}(\mathcal{C})(\mathcal{H}^{\text{d}}(\rho_U)^\circ, {}_{\text{d}}\mathcal{H}(\rho_U^\vee))$  is precisely  $\beta^{\text{Hopf}}$  resulting from the universal properties of  $\beta(\rho_U^{\vee})$  and  $\beta(\rho_U^{\vee})$ Hopf resulting from the universal properties of  ${}_{\alpha}\mathcal{B}(\rho_U^{\vee})$  and  ${}_{\alpha}\mathcal{H}(\rho_U^{\vee})$ :



(The right triangle in the diagram above is commutative by Proposition [3.6.](#page-13-2))

The uniqueness of  $\beta^{\text{Hopf}}$  follows from the universal property of  ${}_{\alpha}\mathcal{H}(\rho_{U}^{\vee})$  too.

<span id="page-26-3"></span>Corollary 3.37. Let  $C$  be a pre-rigid symmetric monoidal category satisfying Properties [1,](#page-6-2) [4,](#page-6-3) [5,](#page-6-6) [8,](#page-7-3) [10](#page-7-4) of Section [2.5](#page-6-0) and their duals such that

- the morphisms  $\alpha_M \otimes id_N$  and  $\theta_{M,N}$  are monomorphisms for all objects  $M, N$ ;
	- $\varkappa_H$  is a monomorphism in C for every Hopf monoid H.

Let  $\rho_U: A \to A \otimes U$  be a tensor epimorphism defining on an  $\Omega$ -magma A a structure of a U-comodule for a comonoid U. Then

$$
\left(\rho_U^{\text{HCoact}}\right)^{\vee}(\varkappa_{\mathcal{H}^{\text{U}}(\rho_U)}\otimes\text{id}_A)\colon \mathcal{H}^{\text{U}}(\rho_U)^{\circ}\otimes A\to A
$$

is an action and the unique Hopf monoid homomorphism  $\beta^{\text{Hopf}}$ :  $\mathcal{H}^\text{\tiny{I}}(\rho_U)^\circ \to {}_\text{\tiny{II}}\mathcal{H}(\rho_U^\vee)$  making the diagram [\(3.14\)](#page-25-0) commutative is a Hopf monoid isomorphism.

<span id="page-26-0"></span>Proof. Apply [\[5,](#page-47-0) Proposition 4.2 (1), Theorems 4.6, 4.23, 5.10, 5.19], Remark [3.21](#page-19-3) and Theorem [3.35.](#page-24-0)  $\Box$ 

# 4. Cosupport and duality in closed monoidal categories

<span id="page-26-1"></span>4.1. Cosupports in closed monoidal categories. When the base category  $\mathcal C$  is closed monoidal, we can reduce the Lifting Problem to the Lifting Problem for a forgetful functor between such comma categories that the notion of the absolute value coincides with the notion of the cosupport. This allows us to work with subobjects instead of tensor monomorphisms, which in some situations (say, for  $C = Vect_{\kappa}$ ) is easier.

Let  $\mathcal C$  be a closed monoidal category. (See examples in Section [5](#page-35-0) below.) Recall that by [A, -] we denote the right adjoint functor to  $(-) \otimes A$  and by  $ev_{A,B} : [A, B] \otimes A \rightarrow B$  the counit of this adjunction. Let  $(-)^* := [-1]$ . Then  $ev_A := ev_{A,1}$ .

Given objects A, B in C, consider the comma category  $(C \downarrow [A, B])$ , i.e. the category where

- objects are morphisms  $\zeta: P \to [A, B]$  for objects P in C;
- morphisms between  $\zeta_1: P_1 \to [A, B]$  and  $\zeta_2: P_2 \to [A, B]$  are morphisms  $\tau: P_1 \to P_2$ such that  $\zeta_2 \tau = \zeta_1$ :



*Remark* 4.1. Objects in  $LIO((C \downarrow [A, B])^{op})$  are exactly monomorphisms  $P \rightarrow [A, B]$ . More-over, if C satisfies the property dual to Property [3](#page-6-1) of Section [2.5,](#page-6-0) then in  $(C \downarrow [A, B])^{\text{op}}$  there exist all absolute values, since if  $\zeta = i\tau$  is an (ExtrEpi, Mono)-factorization of  $\zeta : P \to [A, B]$ , then  $|\zeta| = i$ .

Denote by K:  $\textbf{TensMor}(A, B) \rightarrow (\mathcal{C} \downarrow [A, B])$  the isomorphism of categories, corresponding to the natural bijection

$$
\mathcal{C}(P\otimes A,B)\cong \mathcal{C}(P,[A,B]).
$$

Being an isomorphism, the functor K maps  $LIO(TensMor(A, B)^{op})$  onto  $LIO((\mathcal{C} \downarrow [A, B])^{\text{op}})$ , commutes with taking absolute values and preserves the preorder. In other words, we get the following proposition and remarks:

**Proposition 4.2.** The morphism  $\psi: P \otimes A \rightarrow B$  is a tensor monomorphism in C for some objects P, A, B if and only if the corresponding morphism  $K\psi: P \to [A, B]$  is a monomorphism.

<span id="page-26-2"></span>Remarks 4.3.

<span id="page-27-5"></span><span id="page-27-1"></span>(1) Suppose that C satisfies the property dual to Property [3.](#page-6-1) Let  $\psi: P \otimes A \to B$  be a morphism and let  $K\psi = i\pi$  be the (ExtrEpi, Mono)-factorization. Then there exists  $|\psi| = K^{-1}i$ , i.e. i is a morphism cosupp  $\psi \rightarrow [A, B]$  and  $\psi = |\psi|(\pi \otimes id_A)$ :



<span id="page-27-4"></span>In particular,  $|K\psi| = K|\psi|$  and the cosupport of  $\psi$  is just the image of  $K\psi$  in [A, B]; (2) Under the same assumptions as in [\(1\)](#page-27-1) above, we have  $\psi_1 \succcurlyeq \psi_2$  (with respect to  $X = (\mathcal{C} \downarrow [A, B])^{\text{op}}$  if and only if cosupp  $\psi_1$  is a subobject of cosupp  $\psi_2$ .

Proposition [4.4](#page-27-2) below is verified directly using the universal property of ev dually to the proof of [\[5,](#page-47-0) Theorem 4.30]:

<span id="page-27-2"></span>**Proposition 4.4.** For every object A in C the object  $[A, A]$  admits a unique structure of a monoid turning A into a left  $[A, A]$ -module via  $ev_{A,A}$ . Namely, the multiplication  $\mu_{[A,A]}\colon [A,A]\otimes[A,A]\to [A,A]$  and the unit  $u_{[A,A]}\colon{1\to [A,A]}$  are the unique morphisms making the diagrams below commutative:



Moreover, if  $\psi: P \otimes A \to A$  is a morphism for some object A and a monoid  $(P, \mu, u)$  in C, then  $\psi$  defines on A a structure of a P-module if and only if the corresponding morphism  $K\psi: P \to [A, A]$  is a monoid homomorphism. In particular, the isomorphism of categories

 $K: \textbf{Tensor}(A, A) \widetilde{\rightarrow} (\mathcal{C} \downarrow [A, A])$ 

restricts to an isomorphism of categories

$$
\mathbf{ModStr}(A) \stackrel{\sim}{\rightarrow} (\mathsf{Mon}(\mathcal{C}) \downarrow [A, A]),
$$

<span id="page-27-0"></span>which we again denote by the same letter K.

4.2. Universal measuring comonoids and universal acting bimonoids and Hopf monoids in closed monoidal categories. The propositions and remarks above make it possible to provide sufficient conditions for existence of universal (co)measuring (co)monoids in terms of subobjects in  $[A, B]$  and universal (co)acting bimonoids and Hopf monoids in terms of submonoids in  $[A, A]$ .

Let  $C$  be a braided closed monoidal category satisfying the property dual to Property  $3$  of Section [2.5.](#page-6-0)

<span id="page-27-3"></span>Remark 4.5. Note that in a braided closed monoidal category the functor  $M \otimes (-)$  is isomorphic to the functor  $(-) \otimes M$ , which is a left adjoint for every object M. Therefore both functors preserve all colimits and epimorphisms. In particular, the properties dual to Properties [5–](#page-6-6)[9](#page-7-2) of Section [2.5](#page-6-0) hold automatically. Property [10](#page-7-4) follows from [\[15,](#page-47-8) §7.3, Theorem 2].

<span id="page-28-2"></span>Fix  $\Omega$ -magmas A and B and a subobject  $i: V \rightarrow [A, B]$ . The comonoid  ${}_{\alpha}C(A, B, V)$ corresponding to an initial object  $\psi_{A,B,V}$  in  $\mathbf{Meas}(A,B)^{op}(i)$  (with respect to the functor  $(KG_1')^{\text{op}}: \textbf{Meas}(A, B)^{\text{op}} \to (C \downarrow [A, B])^{\text{op}}$  where  $G_1'$  is the forgetful functor  **is called the** *V***-universal measuring comonoid from A** to B.

In other words,  ${}_{\alpha}\mathcal{C}(A, B, V)$  is a V-universal measuring comonoid if for every measuring  $\psi: P \otimes A \to B$ , such that cosupp  $\psi$  is a subobject of V, there exists a unique comonoid homomorphism  $\varphi: P \to \mathcal{C}(A, B, V)$  making the diagram below commutative:



<span id="page-28-0"></span>**Theorem 4.6.** Let A and B be  $\Omega$ -magmas and let  $i: V \rightarrow [A, B]$  be a subobject in a braided closed monoidal category C satisfying Properties  $\frac{1}{4}$ , [5](#page-6-6) and the properties dual to Proper-ties [1,](#page-6-2) [3,](#page-6-1) [10](#page-7-4) of Section [2.5.](#page-6-0) Then the initial object in  $\mathbf{Meas}(A, B)^{op}(i)$  indeed exists if  $\mathbf{Meas}(A,B)^{\mathrm{op}}(i)$  is not empty.

*Proof.* Use the fact that K is an isomorphism of categories and apply  $[5,$  Theorem 5.19] and Remark [4.5.](#page-27-3)  $\Box$ 

*Remark* 4.7. If we take  $i = id_{[A,B]}$ , then we get the measuring that is universal among all measurings from A to B. In particular, the corresponding comonoid is a generalization of the Sweedler universal measuring coalgebra.

Corollary 4.8 ([\[4,](#page-47-5) Theorem 3.10]). Let A and B be  $\Omega$ -algebras over a field k and let  $V \subseteq \textbf{Vect}_{\mathbb{k}}(A, B)$  be a subspace. Then there exists  $({}_\mathbb{R} C(A, B, V), \psi_{A,B,V})$ , which is called the V -universal measuring coalgebra from A to B.

<span id="page-28-1"></span>**Theorem 4.9.** Let A be an  $\Omega$ -magma and let  $i: V \to [A, A]$  be a submonoid (homomorphism of monoids that is a monomorphism in  $\mathcal{C}$ ) in a braided closed monoidal category  $\mathcal{C}$  satisfying the property dual to Property [3](#page-6-1) of Section [2.5](#page-6-0) such that there exists the V-universal measuring comonoid  $\mathcal{C}(A, A, V)$ . Then  $\mathcal{B}(A, V) := \mathcal{C}(A, A, V)$  admits a structure of a bimonoid such that for any bimonoid B and any action  $\psi: B \otimes A \to A$ , such that cosupp  $\psi$  is a submonoid of V, the unique comonoid homomorphism  $\varphi$  making the diagram below commutative is in fact a bimonoid homomorphism:



(Here  $\psi_{A,V} := \psi_{A,A,V}$ ) In other words,  $\mathbb{B}(A, V)$  is the V-universal acting bimonoid on A. *Proof.* Apply Proposition [4.4](#page-27-2) and [\[5,](#page-47-0) Theorem 5.22].

**Theorem 4.10.** Suppose that a braided closed monoidal category C satisfies Properties  $\frac{1}{4}$ , [5](#page-6-6) and the properties dual to Properties [1,](#page-6-2) [3,](#page-6-1) [10](#page-7-4) of Section [2.5.](#page-6-0) Let A be an  $\Omega$ -magma in  $\mathcal C$  and let  $i: V \to [A, A]$  be a submonoid. Then  $\mathcal{B}(A, V) := \mathcal{C}(A, A, V)$  admits a unique monoid structure turning  $\psi_{A,V} := \psi_{A,A,V}$  into an action, which is the initial object in  $\text{Act}(A)^{\text{op}}(i)$ .

*Proof.* Apply [\[5,](#page-47-0) Corollary 5.23], Proposition [4.4](#page-27-2) and Remark [4.5.](#page-27-3)

<span id="page-29-3"></span>Corollary 4.11 ([\[4,](#page-47-5) Theorem 4.2]). Let A be an  $\Omega$ -algebra over a field k and let  $V \subseteq$  End<sub>k</sub> $(A)$  be a unital subalgebra. Then the V-universal measuring coalgebra  $B(A, V) := \mathcal{C}(A, A, V)$  admits a structure of a bialgebra such that for any bialgebra B and any action  $\psi: B \otimes A \to A$  such that cosupp  $\psi \subseteq V$  the unique coalgebra homomorphism  $\varphi$  making the diagram below commutative is in fact a bialgebra homomorphism:



(Here  $\psi_{A,V} := \psi_{A,A,V}.$ )

Again, let  $\mathcal C$  be a braided closed monoidal category satisfying the property dual to Prop-erty [3](#page-6-1) of Section [2.5.](#page-6-0) Fix an  $\Omega$ -magma A and a submonoid  $i: V \to [A, A]$ . The Hopf monoid  ${}_{\alpha}\mathcal{H}(A,V)$  corresponding to an initial object  $\psi_{A,V}^{\text{Hopf}}$  in  $\textbf{HAct}(A)^{op}(i)$  (with respect to the functor  $(KG'_1G'_3G'_4)^{op}$ :  $\textbf{HAct}(A)^{op} \to (\mathcal{C} \downarrow [A, A])^{op}$  where  $G'_3$  is the forgetful functor  $\text{Act}(A) \to \text{Meas}(A, A)$  and  $G'_{4}$  is the forgetful functor  $\text{HAct}(A) \to \text{Act}(A)$  is called the V -universal acting Hopf monoid on A.

In other words,  $H(A, V)$  is a V-universal measuring Hopf monoid if for every action  $\psi: H \otimes A \to H$  of a Hopf monoid H, such that cosupp  $\psi$  is a subobject of V, there exists a unique Hopf monoid homomorphism  $\varphi: H \to H(A, V)$  making the diagram below commutative:



<span id="page-29-2"></span>**Theorem 4.12.** Let A be an  $\Omega$ -magma and let i:  $V \rightarrow [A, A]$  be a submonoid in a braided closed monoidal category  $\mathcal C$  satisfying the property dual to Property [3](#page-6-1) of Section [2.5.](#page-6-0) Suppose that the forgetful functor  $\text{Hopf}(\mathcal{C}) \to \text{Bimon}(\mathcal{C})$  admits a right adjoint functor  $H_r: \textbf{Hopf}(\mathcal{C}) \to \textbf{Bimon}(\mathcal{C})$  and there exists  $\mathbb{B}(V)$ . Then the initial object in  $\textbf{HAct}(A)^{op}(i)$ indeed exists.

<span id="page-29-1"></span>*Proof.* Apply Proposition [4.4](#page-27-2) and [\[5,](#page-47-0) Theorem 5.26].

**Theorem 4.13.** Let A be an  $\Omega$ -magma and let  $i: V \to [A, A]$  be a submonoid in a braided closed monoidal category C satisfying Properties [4,](#page-6-3) [5](#page-6-6) and the properties dual to Properties [1–](#page-6-2) [3,](#page-6-1) [10](#page-7-4) of Section [2.5.](#page-6-0) Then the initial object in  $H \text{Act}(A)^{op}(i)$  indeed exists.

*Proof.* Apply [\[5,](#page-47-0) Corollary 5.27], Proposition [4.4](#page-27-2) and Remark [4.5.](#page-27-3)

*Remark* 4.14. If we take  $i = id_{[A,A]}$ , then we get the action that is universal among all Hopf monoid actions on A.

Again, applying Theorem  $4.13$  above, we recover the existence theorem for V-universal acting Hopf algebras proved in [\[4\]](#page-47-5).

<span id="page-29-0"></span>4.3. Universal comeasuring monoids and universal coacting bimonoids and Hopf monoids in closed monoidal categories. Let  $\mathcal C$  be a braided closed monoidal category satisfying the property dual to Property [3](#page-6-1) of Section [2.5.](#page-6-0)

Fix  $\Omega$ -magmas A and B and a subobject  $i: V \rightarrow [A, B]$ . The monoid  $\mathcal{A}^{n}(A, B, V)$ corresponding to an initial object  $\rho_{A,B,V}$  in **Comeas** $(A, B)(i)$  (with respect to the functor  $K(-)^{\vee}G_1$ : **Comeas** $(A, B) \rightarrow (\mathcal{C} \downarrow [A, B])^{\text{op}}$  where  $G_1$  is the forgetful functor <span id="page-30-2"></span> $Comeas(A, B) \rightarrow MorTens(A, B)$  is called the *V*-universal comeasuring monoid from  $A$  to  $B$ .

In other words,  $\mathcal{A}^{\mathbb{I}}(A, B, V)$  is a V-universal measuring comonoid if for every comeasuring  $\rho: A \to B \otimes Q$ , such that cosupp  $(\rho^{\vee})$  is a subobject of V, there exists a unique monoid homomorphism  $\varphi: \mathcal{A}^{\mathbb{I}}(A, B, V) \to Q$  making the diagram below commutative:



<span id="page-30-1"></span>**Theorem 4.15.** Let C be a braided closed monoidal category satisfying Properties [1,](#page-6-2)  $4-6$ , [8,](#page-7-3) [9](#page-7-2) and the properties dual to Properties [1](#page-6-2) and [4](#page-6-3) of Sections [2.5.](#page-6-0) Suppose, in addition, that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_P$  is an extremal monomorphism and  $\theta_{B^*,P}$  is a monomorphism for all objects P.

Let A and B be  $\Omega$ -magmas and let i:  $V \rightarrow [A, B]$  be a subobject such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U: A \to B \otimes U$  where U is an object in C. Then there exists an initial object in  $\mathbf{Comeas}(A, B)(i)$  if  $\mathbf{Comeas}(A, B)(i)$  is not empty.

*Proof.* Recall that by [\[5,](#page-47-0) Proposition 4.2 (1)] and Remark [4.5](#page-27-3) the category C satisfies Properties [3,](#page-6-1) [10](#page-7-4) and the properties dual to Properties [3](#page-6-1) and [5–](#page-6-6)[9.](#page-7-2) By Theorems [3.18–](#page-18-3)[3.20](#page-18-4) and Remarks [4.3](#page-26-2) [\(2\)](#page-27-4) we are under the assumptions of Proposition [2.3.](#page-4-2) Now we apply [\[5,](#page-47-0) Theorem 4.23].

Remark 4.16. If V is an arbitrary subobject of  $[A, B]$ , say, if  $V = [A, B]$ , then  $C(A, B, V)$ may not exist, see [\[4,](#page-47-5) Section 4.5] for the corresponding examples.

Corollary 4.17 ([\[4,](#page-47-5) Theorem 3.16]). Let A and B be  $\Omega$ -algebras over a field k and let  $V \subseteq \textbf{Vect}_{\mathbb{k}}(A, B)$  be a pointwise finite dimensional subspace closed in the finite topology (see the definitions in  $[4, Section 2.2]$  $[4, Section 2.2]$ . Then there exists the V-universal comeasuring algebra  $\mathcal{C}(A, B, V)$  from A to B.

*Proof.* By [\[4,](#page-47-5) Theorem 2.11] and Theorem [3.18](#page-18-3) there exists a morphism  $\rho_U: A \to B \otimes U$ such that  $i = K(\rho_U^{\vee})$  if and only if V is pointwise finite dimensional and closed in the finite topology.

Remark 4.18. In [\[4\]](#page-47-5) the notion of the cosupport was introduced for linear maps  $\rho: A \to B \otimes Q$ too. Namely, by the definition,  $\operatorname{cosupp} \rho := \operatorname{cosupp}(\rho^{\vee})$ .

In order to proceed to coactions we need the following lemmas:

<span id="page-30-0"></span>**Lemma 4.19.** Let A be an  $\Omega$ -magma in a braided closed monoidal category C and let i:  $V \rightarrow [A, A]$  be a submonoid. Then the morphism  $A \stackrel{\sim}{\rightarrow} A \otimes 1$  is an object in  $\mathbf{Comeas}(A,A)(i)$ .

<span id="page-31-2"></span>*Proof.* By [\[5,](#page-47-0) Lemma 4.32],  $\rho_0: A \to A \otimes \mathbb{1}$  is a comeasuring. Denote by  $u: \mathbb{1} \to V$  the unit of V and consider the diagram



The lower triangle is commutative since  $A$  is a  $V$ -module by Proposition [4.4.](#page-27-2) The other inner polygons are commutative by the properties of the braiding. Hence the outer polygon is commutative too. Now we notice the composition on the upper and the right edges equals  $\rho_0^{\vee}$ :  $\mathbb{I}^* \otimes A \to A$ . Therefore, the diagram below is commutative too:



<span id="page-31-1"></span>In particular,  $\rho_0: A \to A \otimes \mathbb{1}$  is an object in **Comeas** $(A, A)(i)$ .

**Lemma 4.20.** Let A be an  $\Omega$ -magma in a braided closed monoidal category C satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$  and [9](#page-7-2) and the properties dual to Properties [1](#page-6-2) and 4 of Section [2.5](#page-6-0) and let  $i: V \to [A, A]$  be a submonoid such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U: A \to A \otimes U$ where  $U$  is an object in  $\mathcal{C}$ . Suppose, in addition, that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_A \otimes id_{P^*}$  and  $\theta_{A^*,P}$  are monomorphisms for all objects P.

If  $\rho_1: A \rightarrow A \otimes Q_1$  and  $\rho_2: A \rightarrow A \otimes Q_2$  are objects in **Comeas** $(A, A)(i)$  such that  $(\theta_{Q_1,Q_2}^{\text{inv}})^{\flat}: Q_1 \otimes Q_2 \to (Q_1^* \otimes Q_2^*)^*$  is an extremal monomorphism in C, then  $(\rho_1 \otimes \text{id}_{Q_2})\rho_2$  is an object in  $\mathbf{Comeas}(A, A)(i)$  too.

*Proof.* By [\[5,](#page-47-0) Lemma 4.32], the morphism  $(\rho_1 \otimes \mathrm{id}_{Q_2})\rho_2$  is a comeasuring.

By Lemma [3.29,](#page-22-1)

Applying the dual of  $[5, \text{ Lemma } 4.33]$  we obtain that the right hand side of  $(4.1)$  is an object in **Meas** $(A, A)(i)$ . In particular,  $\rho_1^{\vee}(\text{id}_{Q_1^*} \otimes \rho_2^{\vee}) = \rho_U^{\vee}(f \otimes \text{id}_A)$  for some morphism  $f: Q_1^* \otimes Q_2^* \to V$  where  $V = U^*$ .

In virtue of Proposition [3.5,](#page-12-1) we have

$$
\begin{aligned}\n((\mathrm{id}_A\otimes(\theta_{Q_1,Q_2}^{\mathrm{inv}})^{\flat})(\rho_1\otimes \mathrm{id}_{Q_2})\rho_2)^{\nabla} &= ((\rho_1\otimes \mathrm{id}_{Q_2})\rho_2)^{\vee}(\theta_{Q_1,Q_2}^{\mathrm{inv}}\otimes \mathrm{id}_A) = \\
&= \rho_1^{\vee}(\mathrm{id}_{Q_1^*}\otimes \rho_2^{\vee}) = \rho_U^{\vee}(f\otimes \mathrm{id}_A) = ((\mathrm{id}_A\otimes f^{\flat})\rho_U)^{\nabla}.\n\end{aligned}
$$

By Corollary [3.8,](#page-14-0)

$$
(\mathrm{id}_A\otimes\big(\theta_{Q_1,Q_2}^{\mathrm{inv}}\big)^\flat)(\rho_1\otimes\mathrm{id}_{Q_2})\rho_2=(\mathrm{id}_A\otimes f^\flat)\rho_U.

<span id="page-32-3"></span>By [\[5,](#page-47-0) Proposition 4.17], supp  $((id_A \otimes f^{\flat})\rho_U) = \text{supp}(\rho_1 \otimes id_{Q_2})\rho_2$  and  $(\rho_1 \otimes id_{Q_2})\rho_2 \preccurlyeq \rho_U$ . <span id="page-32-0"></span>**Theorem 4.21.** Let A be an  $\Omega$ -magma in a braided closed monoidal category C satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$  and [9](#page-7-2) and the properties dual to Properties [1](#page-6-2) and 4 of Section [2.5](#page-6-0) and let  $i: V \to [A, A]$  be a submonoid such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U: A \to A \otimes U$ where  $U$  is an object in  $\mathcal{C}$ . Suppose, in addition, that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_A \otimes id_{P^*}$  and  $\theta_{A^*P}$  are monomorphisms for all objects P;
- there exists the V-universal comeasuring monoid  $\mathcal{B}^{n}(A, V) := \mathcal{A}^{n}(A, A, V);$

Then  $\mathcal{B}^{\circ}(A, V)$  admits a structure of a bimonoid such that for any bimonoid B and any coaction  $\rho: A \to A \otimes B$ , such that  $\operatorname{cosupp}(\rho^{\vee})$  is a submonoid of V, the unique monoid homomorphism  $\varphi$  making the diagram below commutative is in fact a bimonoid homomorphism:



(Here  $\rho_{A,V} := \rho_{A,A,V}$ .) In other words,  $\mathcal{B}^{(1)}(A,V)$  is the V-universal coacting bimonoid on A.

*Proof.* By Proposition [3.6,](#page-13-2) Lemmas [4.19](#page-30-0) and [4.20](#page-31-1) the category  $\mathcal{D} = \text{Comeas}(A, A)(i)$  sat-isfies the assumptions of [\[5,](#page-47-0) Theorem 4.30].

<span id="page-32-2"></span>Corollary 4.22. Let A be an  $\Omega$ -magma in a braided closed monoidal category C satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$ , [8,](#page-7-3) [9](#page-7-2) and the properties dual to Properties [1](#page-6-2) and 4 of Section [2.5](#page-6-0) and let  $i: V \to [A, A]$  be a submonoid such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U: A \to A \otimes U$ where  $U$  is an object in  $C$ . Suppose, in addition, that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_P$  is an extremal monomorphism and  $\theta_{A^*,P}$  is a monomorphism for all objects P;
- $\bullet$   $(\theta_{B,B}^{\text{inv}})^{\flat}: B \otimes B \rightarrow (B^* \otimes B^*)^*$  is an extremal monomorphism in C for all bimonoids B.

Then  $\mathcal{B}^{\circ}(A, V) := \mathcal{A}^{\circ}(A, A, V)$  admits a unique comonoid structure turning  $\rho_{A, V} := \rho_{A, A, V}$ into a coaction, which is the initial object in  $\mathbf{Coact}(A)(i)$ .

*Proof.* Apply Theorems [4.15](#page-30-1) and [4.21.](#page-32-0)

Again fix an  $\Omega$ -magma A in C. Let  $i: V \to [A, A]$  be a submonoid. We call the Hopf monoid corresponding to the initial object in  $\textbf{HCoact}(A)(i)$  (if it exists) the V-universal coacting Hopf monoid on A.

<span id="page-32-1"></span>**Theorem 4.23.** Let A be an  $\Omega$ -magma in a braided closed monoidal category C and let  $i: V \to [A, A]$  be a submonoid such that there exists the V-universal comeasuring bimonoid  $\mathcal{B}^{\mathbb{I}}(A,V)$ . Suppose, in addition, that the forgetful functor  $\textbf{Hopf}(\mathcal{C})\to\textbf{Bimon}(\mathcal{C})$  admits a left adjoint functor  $H_l: \textbf{Hopf}(\mathcal{C}) \to \textbf{Bimon}(\mathcal{C})$ . Then the initial object in  $\textbf{HCoact}(A)(i)$ indeed exists.

*Proof.* Apply [\[5,](#page-47-0) Theorem 4.39].

Applying Theorem  $4.23$  above, we recover here the existence theorem for V-universal coacting Hopf algebras proved in [\[4\]](#page-47-5).

<span id="page-33-4"></span>Corollary 4.24. - $\alpha_P$  is an extremal monomorphism and  $\theta_{A^*,P}$  is a monomorphism for all objects P;
- $\bullet$   $(\theta_{B,B}^{\text{inv}})^{\flat}: B \otimes B \rightarrow (B^* \otimes B^*)^*$  is an extremal monomorphism in C for all bimonoids B.

Then the initial object in  $\textbf{HCoact}(A)(i)$  indeed exists.

<span id="page-33-0"></span>*Proof.* Apply [\[5,](#page-47-0) Theorem 4.6], Theorem [4.23,](#page-32-1) Remark [4.5](#page-27-3) and Corollary [4.22.](#page-32-2)

- $\alpha_M$  is an extremal monomorphism and  $\theta_{M,N}$  is a monomorphism for all objects M, N.

Let A and B be  $\Omega$ -magmas and let i:  $V \rightarrow [A, B]$  be a subobject such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U \colon A \to B \otimes U$  where U is an object in C and there exist  $\mathcal{A}^{\mathbb{I}}(A, B, V)$  and  $\mathcal{C}(A, B, V)$ . Then

is a measuring and the unique comonoid homomorphism  $\beta \colon \mathcal{A}^{\mathbb{I}}(A, B, V)^{\circ} \to {}_{\mathbb{I}}\mathcal{C}(A, B, V)$ making the diagram  $(4.2)$  commutative is a comonoid isomorphism.

*Proof.* Apply Theorems [4.6,](#page-28-0) [4.15,](#page-30-1) [4.25](#page-33-2) and Remark [3.21.](#page-19-3)

Corollary 4.27 ([\[4,](#page-47-5) Theorem 3.20]). Let A and B be  $\Omega$ -algebras over a field k and let  $V \subseteq \textbf{Vect}_k(A, B)$  be a pointwise finite dimensional subspace closed in the finite topology. Then  $\beta$  from the diagram  $(4.2)$  is a coalgebra isomorphism.

commutative is a bimonoid isomorphism.

*Proof.* By Theorems [4.9](#page-28-1) and [4.21](#page-32-0) the bimonoids  $\mathcal{B}^{n}(A, V) = \mathcal{A}^{n}(A, A, V)$  and  $\mathcal{B}(A, V) = {}_{\mathfrak{a}}\mathcal{C}(A, A, V)$  are indeed V-universal. The morphism  $\rho_{A, V}^{\vee}(\varkappa_{\mathcal{B}^{\mathfrak{a}}(A, V)} \otimes id_A)$  is an action by Theorem [4.25](#page-33-2) and Lemmas [3.30](#page-22-0) and [3.31.](#page-23-1) Hence the existence of  $\beta$  follows from the definition of  $\mathcal{B}(A, V)$ . By Theorem [4.25](#page-33-2) the morphism  $\beta$  is an isomorphism in C. Combined with the fact that  $\beta$  is a bimonoid homomorphism, this implies that  $\beta$  is a bimonoid isomorphism.

**Corollary 4.29.** Let  $C$  be a symmetric closed monoidal category satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$ , [8,](#page-7-3) [9](#page-7-2) and the properties dual to Properties [1,](#page-6-2) 4 and [10](#page-7-4) of Section [2.5](#page-6-0) such that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_M$  is an extremal monomorphism and  $\theta_{M,N}$  is a monomorphism for all objects  $M,N$ ;
- $\bullet$   $(\theta_{B,B}^{\text{inv}})^{\flat}: B \otimes B \to (B^* \otimes B^*)^*$  is an extremal monomorphism in C for all bimonoids B

Corollary 4.30 ([\[4,](#page-47-5) Theorem 4.14]). Let A be an  $\Omega$ -algebra over a field k and let  $V \subseteq \text{End}_{\mathbb{k}}(A)$  be a unital pointwise finite dimensional subalgebra closed in the finite topology. Then  $\beta$  from the diagram  $(4.3)$  is a bialgebra isomorphism.

<span id="page-34-2"></span>**Theorem 4.31.** Let C be a symmetric closed monoidal category satisfying Properties [1,](#page-6-2)  $4\n-6$  $4\n-6$ and [9](#page-7-2) and the properties dual to Properties [1](#page-6-2) and [4](#page-6-3) of Section [2.5](#page-6-0) and let  $i: V \rightarrow [A, A]$  be a submonoid such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U \colon A \to A \otimes U$  where U is an object in C. Suppose, in addition, that

• the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;

- <span id="page-35-2"></span>• there exist functors  $(-)^{\circ}$ ,  $H_l$  and  $H_r$ ;
- $\alpha_M$  is an extremal monomorphism and  $\theta_{M,N}$  is a monomorphism for all objects  $M, N$ ;
- there exist  $\mathcal{B}^{\mathbb{I}}(A, V) = \mathcal{A}^{\mathbb{I}}(A, A, V)$  and  $\mathbb{I}B(A, V) = \mathbb{I}C(A, A, V);$
- $\int \theta_{\mathcal{B}^{\mathbb{I}}(A, V), \mathcal{B}^{\mathbb{I}}(A, V)}^{\mathrm{inv}}$  $\bigcap^{\flat}: \mathcal{B}^{n}(A, V) \otimes \mathcal{B}^{n}(A, V) \to (\mathcal{B}^{n}(A, V)^{*} \otimes \mathcal{B}^{n}(A, V)^{*})^{*}$  is an extremal monomorphism in  $\mathcal{C}$ ;
- $\varkappa_H$  is a monomorphism in C for every Hopf monoid H.

Denote by  $\rho_{A,V}^{\text{Hopf}}: A \to A \otimes \mathcal{H}^{\text{d}}(A, V)$  and  $\psi_{A,V}^{\text{Hopf}}: {}_{\text{d}}\mathcal{H}(A, V) \otimes A \to A$  the initial objects in  $\textbf{HCoact}(A)(i)$  and  $\textbf{HAct}(A)^{\text{op}}(i)$ , respectively. Then

$$
\left(\rho_{A,V}^{\textbf{Hopf}}\right)^{\vee}(\varkappa_{\mathcal{H}^{\circ}(A,V)}\otimes id_A)\colon \mathcal{H}^{\circ}(A,V)^{\circ}\otimes A\to A
$$

is an action and the unique Hopf monoid homomorphism  $\beta^{\text{Hopf}}$ :  $\mathcal{H}^{\sigma}(A, V)^{\circ} \to {}_{\sigma}\mathcal{H}(A, V)$ making the diagram

commutative is a Hopf monoid isomorphism.

Proof. We repeat verbatim the proof of Theorem [3.35](#page-24-0) using Theorems [4.12,](#page-29-2) [4.23](#page-32-1) and [4.28](#page-34-1) instead of  $[5,$  Theorems 4.40 and 5.26 and Theorem [3.32.](#page-23-0)

**Corollary 4.32.** Let  $\mathcal{C}$  be a symmetric closed monoidal category satisfying Properties [1,](#page-6-2)  $4-6$  $4-6$ , [8,](#page-7-3) [9](#page-7-2) and the properties dual to Properties [1,](#page-6-2) 4 and [10](#page-7-4) of Section [2.5](#page-6-0) such that

- the functor  $(-)^*$  maps extremal monomorphisms to extremal epimorphisms;
- $\alpha_M$  is an extremal monomorphism and  $\theta_{M,N}$  is a monomorphism for all objects  $M, N$ ;
- $\bullet$   $(\theta_{B,B}^{\text{inv}})^{\flat}: B \otimes B \rightarrow (B^* \otimes B^*)^*$  is an extremal monomorphism in C for all bimonoids B;
- $\varkappa_H$  is a monomorphism in C for every Hopf monoid H

and let  $i: V \rightarrow [A, A]$  be a submonoid such that  $i = K(\rho_U^{\vee})$  for some morphism  $\rho_U: A \to A \otimes U$  where U is an object in C. Then

$$
\left(\rho_{A,V}^{\text{Hopf}}\right)^{\vee}(\varkappa_{\mathcal{H}^{\circ}(A,V)}\otimes id_A)\colon \mathcal{H}^{\circ}(A,V)^{\circ}\otimes A\to A
$$

is an action and the unique Hopf monoid homomorphism  $\beta^{\text{Hopf}}$ :  $\mathcal{H}^{\sigma}(A, V)^{\circ} \to {}_{\sigma}\mathcal{H}(A, V)$ making the diagram  $(4.4)$  commutative is a Hopf monoid isomorphism.

Proof. Apply [\[5,](#page-47-0) Theorems 4.6 and 5.10], Theorems [4.6,](#page-28-0) [4.15,](#page-30-1) [4.31](#page-34-2) and Remarks [3.21](#page-19-3) and [4.5.](#page-27-3)  $\Box$ 

Corollary 4.33 ([\[4,](#page-47-5) Theorem 4.15]). Let A be an  $\Omega$ -algebra over a field k and let  $V \subseteq \text{End}_{\mathbb{k}}(A)$  be a unital pointwise finite dimensional subalgebra closed in the finite topology. Then  $\beta^{\text{Hopf}}$  from the diagram [\(4.4\)](#page-35-1) is a Hopf algebra isomorphism.

## 5. Applications

<span id="page-35-0"></span>In this section we provide examples of monoidal categories satisfying Properties  $1-10$ , [5a](#page-6-7) of Section [2.5](#page-6-0) and their duals as well as some other properties required in Sections [3](#page-10-1) and [4.](#page-26-0)

Throughout the section we use the standard Sweedler notation:

 $\Delta c = c_{(1)} \otimes c_{(2)}, c \in C$ , for the comultiplication  $\Delta: C \to C \otimes C$  in a coalgebra C over a field <sup>k</sup>;

<span id="page-36-4"></span> $\delta(m) = m_{(-1)} \otimes m_{(0)}, m \in M$ , for the linear map  $\delta: M \to C \otimes M$  defining on a k-vector space M a structure of a left C-comodule;

 $\rho(m) = m_{(0)} \otimes m_{(1)}, m \in M$ , for the linear map  $\rho: M \to M \otimes C$  defining on a k-vector space M a structure of a right C-comodule.

Recall that by  $V^*$  we denote the dual to an object  $V$  in a pre-rigid braided monoidal category C and by  $(-)^\circ$ : Mon $(\mathcal{C}) \to \text{Comon}(\mathcal{C})$  the functor adjoint to the induced functor  $(-)^*$ : Comon $(\mathcal{C}) \to \text{Mon}(\mathcal{C})$ . Below we will have to use the traditional duals (i.e. where  $\mathcal C$  is replaced with  $Vect_{\mathbf{k}}$  for a field  $\mathbf{k}$ ) too. In order to distinguish between them, we will use for the latter a special notation. Namely, for a vector space  $V$  over  $\mathbb k$  we denote its dual vector space  $\text{Hom}_k(V, \mathbb{k})$  by  $V^*_{\mathbb{k}}$  and for a k-algebra A we denote its traditional finite (or Sweedler) dual by  $A_{\mathbb{k}}^{\circ}$ .

<span id="page-36-0"></span>5.1. Modules over Hopf algebras. Let B be a bialgebra over a field k. The category  $_B$ Mod of left B-modules is monoidal where the monoidal product coincides with the tensor product  $\otimes$  over k. It turns out that all the properties from Section [2.5](#page-6-0) as well as their duals hold in  $_B$ Mod:

**Lemma 5.1.** The category <sub>B</sub>Mod satisfies Properties [1–](#page-6-2)[10,](#page-7-4) [5a](#page-6-7) of Section [2.5](#page-6-0) as well as their duals. In addition, all monomorphisms and epimorphisms in  $_B$ Mod are extremal.

*Proof.* The forgetful functor  $_B$ Mod  $\rightarrow$  Vect<sub>k</sub> is a strict monoidal functor that creates small limits and colimits as well as limits of subobjects and colimits of quotient objects. Moreover, the free (tensor) algebra  $T(M)$  of a B-module M inherits the structure of a B-module, which makes  $T(M)$  a B-module algebra. Finally, by [\[1,](#page-47-15) Proposition 4.1] the forgetful functor  $\mathsf{Comon}({}_B\mathsf{Mod}) \to {}_B\mathsf{Mod}$  admits a right adjoint.

Let now H be a Hopf algebra over a field k. Then the category  $_H$  Mod is closed where for every H-modules M and N we have  $[M, N] = \text{Hom}_{\mathbb{k}}(M, N)$ ,

(hf)(m) := h_{(1)}f(Sh_{(2)}m) \text{ for } h \in H, f \in \text{Hom}_{k}(M, N), m \in M.
$$
 (5.1)

In particular, <sub>H</sub>Mod is pre-rigid where for every H-module M we have  $M^* = M^*_{\mathbb{R}}$  and  $(hf)(m) := f((Sh)m)$  for all  $h \in H, f \in M^*, m \in M$ .

<span id="page-36-1"></span>5.2. Comodules over Hopf algebras. Now consider the category Comod<sup>B</sup> of right Bcomodules for a bialgebra B over a field <sup>k</sup> where the monoidal product again coincides with the tensor product  $\otimes$  over k. It turns out that all properties from Section [2.5](#page-6-0) as well as their duals hold in  $\mathsf{Comod}^B$  too:

<span id="page-36-2"></span>**Lemma 5.2.** Let B be a bialgebra over a field  $\mathbb{k}$ . Then the category Comod<sup>B</sup> satisfies Properties [1–](#page-6-2)[10,](#page-7-4) [5a](#page-6-7) of Section [2.5](#page-6-0) and their duals. In addition, all monomorphisms and  $e pimorphisms$  in  $\textsf{Comod}^B$  are extremal.

*Proof.* The forgetful functor  $\text{Comod}^B \to \text{Vect}_k$  creates finite limits and small colimits as well as limits of subobjects and colimits of quotient objects. If  $M_{\alpha}$ ,  $\alpha \in \Lambda$ , are right B-comodules, then their product in Comod<sup>B</sup> is the subspace of their Cartesian product  $\prod M_{\alpha}$  consisting of

α∈Λ all tuples  $(m_\alpha)_{\alpha\in\Lambda}, m_\alpha\in M_\alpha$ , such that for each tuple there exists a single finite dimensional subcoalgebra  $C \subseteq B$  where  $\rho(m_{\alpha}) \in M_{\alpha} \otimes C$  for all  $\alpha \in \Lambda$ . Again, the free algebra  $T(M)$  of a B-comodule M inherits the structure of a B-comodule, which makes  $T(M)$  a B-comodule algebra. Finally, by [\[1,](#page-47-15) Proposition 4.1] the forgetful functor  $\mathsf{Comon}(\mathsf{Comod}^B) \to \mathsf{Comod}^B$ admits a right adjoint.

Let now H be a Hopf algebra over a field k. Then the category  $\mathsf{Comod}^H$  is closed where for every H-comodules M and N the H-comodule  $[M, N]$  is the subspace of  $\text{Hom}_{\mathbb{k}}(M, N)$ consisting of such k-linear maps  $f: M \to N$  that  $f(m_{(0)})_{(0)} \otimes f(m_{(0)})_{(1)}Sm_{(1)} \in M \otimes C$ 

<span id="page-37-2"></span>where  $C \subseteq H$  is a fixed finite dimensional subcoalgebra that may depend on f but does not depend on  $m \in M$ . Then  $\rho: [M, N] \to [M, N] \otimes H$  is defined by  $\rho(f) := f_{(0)} \otimes f_{(1)}$ ,  $f_{(0)}(m) \otimes f_{(1)} := f(m_{(0)})_{(0)} \otimes f(m_{(0)})_{(1)}Sm_{(1)}$  for  $m \in M$  and  $f \in [M, N]$ . In particular, Comod<sup>H</sup> is pre-rigid where for every H-comodule M the dual comodule  $M^*$  is the subspace of  $M^*_{\mathbb{R}}$  consisting of such k-linear functions  $f: M \to \mathbb{R}$  that  $f(m_{(0)})Sm_{(1)} \in C$  where  $C \subseteq H$ is a fixed finite dimensional subcoalgebra that may depend on  $f$  but does not depend on  $m \in M$ . Then  $f_{(0)}(m) f_{(1)} := f(m_{(0)}) S m_{(1)}$  for  $f \in M^*$ ,  $m \in M$ .

<span id="page-37-0"></span>5.3. Left Yetter – Drinfel'd modules. Let H be a Hopf algebra over a field k with an invertible antipode S. Denote by  ${}^H_H$  $YD$  the category of *left Yetter* — *Drinfel'd modules* (or  ${}^H_H$  $\mathcal{YD}\text{-modules}$  for short), i.e. left H-modules and H-comodules M such that the H-action and the H-coaction  $\delta: M \to H \otimes M$  satisfy the following compatibility condition:

 $\delta(hm) = h_{(1)}m_{(-1)}Sh_{(3)} \otimes h_{(2)}m_{(0)}$  for every  $m \in M$  and  $h \in H$ .

For more details on the general theory of Yetter – Drinfel'd modules and their applications we refer to e.g. [\[20,](#page-48-2) Section 11.6], [\[9,](#page-47-16) Section 4.4].

An  ${}^H_H$  $\mathcal{YD}$ -module algebra is an algebra A over a field k that is an  ${}^H_H\mathcal{YD}$ -module, an Hmodule algebra and an H-comodule algebra at the same time. The algebra A is called a unital  $^H_H$  $\mathcal{YD}$ -module algebra if A is unital,  $\delta(1_A) = 1_H \otimes 1_A$  and  $h1_A = \varepsilon(h)1_A$ .

The category  ${}_H^H \mathcal{YD}$  is braided monoidal where the monoidal product of  ${}_H^H \mathcal{YD}$ -modules M and N is their usual tensor product  $M \otimes N$  over k with the induced structures of a left H-module and a left H-comodule. The braiding  $c_{M,N}$ :  $M \otimes N \to N \otimes M$  is defined by the formula

$$
c_{M,N}(m\otimes n):=m_{(-1)}n\otimes m_{(0)}\text{ for }m\in M,\ n\in N.
$$

Its inverse  $c_{M,N}^{-1}: N \otimes M \to M \otimes N$  is defined by

$$
c_{M,N}^{-1}(n \otimes m) := m_{(0)} \otimes (S^{-1}m_{(-1)}) n \text{ for } m \in M, n \in N.
$$

Monoids in  ${}^H_H$  $YD$  are just unital associative  ${}^H_H$  $YD$ -module algebras. Comonoids in  ${}^H_H$  $YD$  are called  $^{H}_{H}$  $\mathcal{YD}$ -module coalgebras.

<span id="page-37-1"></span>**Lemma 5.3.** Let  $H$  be a Hopf algebra over a field  $\Bbbk$  with an invertible antipode  $S$ . Then the category  $H\mathcal{YD}$  satisfies Properties 1-[10,](#page-7-4) [5a](#page-6-7) of Section [2.5](#page-6-0) and their duals. In addition, all monomorphisms and epimorphisms in  ${}^H_H$  $\mathcal{YD}$  are extremal.

*Proof.* The forgetful functor  ${}^H_1YD \to {}^H$ Comod creates small limits and colimits as well as limits of subobjects and colimits of quotient objects. Both categories are abelian. In addition, monomorphisms and epimorphisms are just injective and surjective homomorphisms, respectively. Hence, by Lemma [5.2,](#page-36-2) the category  ${}^H_H$  $\mathcal{YD}$  satisfies Properties [1](#page-6-2)[–9,](#page-7-2) [5a](#page-6-7) and their duals. Moreover, the free algebra  $T(M)$  of an  $H^2$  $\mathcal{YD}$ -module M inherits the structure of an  $H^2$ **VD**-module, which makes  $T(M)$  an  $H^2$ **VD**-module algebra, whence we get Property [10.](#page-7-4) Now we have to prove its dual.

By [\[1,](#page-47-15) Proposition 2.3], the category Comon  $(HVD)$  is cowellpowered. By [1, Theorem 4.5] every element of an H-comodule coalgebra is contained in a finite dimensional Hcomodule subcoalgebra, whence every element of an  ${}^H_H$  $\mathcal{YD}$ -module coalgebra is contained in a  $H^2$  $\mathcal{YD}$ -module subcoalgebra finitely generated as an H-module. In particular, the small set of all  ${}_{H}^{H}$  $\mathcal{YD}$ -module coalgebras finitely generated as H-modules generates the category Comon  $\begin{pmatrix} H & D \\ H & D \end{pmatrix}$ .

The forgetful functor Comon  $(H_V \mathcal{YD}) \to H_V \mathcal{YD}$  preserves small coproducts. Let  $f, g \colon A \to B$ be  ${}^H_H$  $\mathcal{YD}$ -module coalgebra homomorphisms. Then

$$
\Delta(f(a) - g(a)) = (f(a_{(1)}) - g(a_{(1)})) \otimes f(a_{(2)}) + g(a_{(1)}) \otimes (f(a_{(2)}) - g(a_{(2)}))
$$
 for every  $a \in A$ 

implies that the set  $I = \{f(a) - g(a) | a \in A\}$  is a coideal in B that is, in addition, an  $H^2 D$ subcomodule. Hence the surjective homomorphism  $\pi: B \to B/I$  is the coequilizer of f and g both in Comon  $(HJD)$  and  $HJD$ . Therefore, the forgetful functor Comon  $(HJD) \to HJD$ preserves all small colimits. Now we apply the Special Adjoint Functor Theorem.

The category  ${}^H_H$  $YD$  is closed where for every  ${}^H_H$  $YD$ -modules M and N the  ${}^H_H$  $YD$ -module  $[M, N]$  is the subspace of  $\text{Hom}_{\mathbb{k}}(M, N)$  consisting of such k-linear maps  $f: M \to N$  that  $f(m_{(0)})_{(-1)}S^{-1}m_{(-1)} \otimes f(m_{(0)})_{(0)} \in C \otimes M$  where  $C \subseteq H$  is a fixed finite dimensional subcoalgebra that may depend on f but does not depend on  $m \in M$ . Then  $\delta : [M, N] \to H \otimes [M, N]$ is defined by  $\delta(f) := f_{(-1)} \otimes f_{(0)}$ ,

$$
f_{(-1)} \otimes f_{(0)}(m) := f(m_{(0)})_{(-1)}S^{-1}m_{(-1)} \otimes f(m_{(0)})_{(0)}
$$

for  $m \in M$  and  $f \in [M, N]$  and the H-action  $H \otimes [M, N] \to [M, N]$  is defined by [\(5.1\)](#page-36-3). In particular,  $^H_H$  $\mathcal{YD}$  is pre-rigid where for every  $^H_H$  $\mathcal{YD}$ -module M the  $^H_H$  $\mathcal{YD}$ -module M<sup>\*</sup> is the subspace of  $M^*_{\mathbb{R}}$  consisting of such k-linear functions  $f: M \to \mathbb{R}$  that  $f(m_{(0)})S^{-1}m_{(-1)} \in C$ where  $C \subseteq H$  is a fixed finite dimensional subcoalgebra that may depend on f but does not depend on  $m \in M$ . Then  $\delta: M^* \to H \otimes M^*$  is defined by  $\delta(f) := f_{(-1)} \otimes f_{(0)}$ ,  $f_{(0)}(m)f_{(-1)} := f(m_{(0)})S^{-1}m_{(-1)}$  and  $(hf)(m) = f((Sh)m)$  for  $f \in M^*$ ,  $h \in H$  and  $m \in M$ . The functor  $(-)^*$  on  $^H_H$  $\mathcal{YD}$ -module homomorphisms coincides with the usual  $(-)^*$  on k-linear maps.

<span id="page-38-1"></span>Remark 5.4. For a  $^H_H$  $\mathcal{YD}$ -module M define the bilinear map  $\diamond: M^*_{\mathbb{K}} \times M \to H$  by  $f \diamond m := f(m_{(0)})m_{(-1)}$  for all  $f \in M^*_{\mathbb{R}}$  and  $m \in M$ . Now for  $f \in M^*_{\mathbb{R}}$  the condition  $f \in M^*$  is equivalent to  $\dim(f \diamond M) < +\infty$ .

<span id="page-38-0"></span>**Lemma 5.5.** Let M be an  $^H_H$  $\mathcal{YD}$ -module. Define the linear maps  $\xi: M \to M$  and  $\zeta: M \to M$ by

$$
\xi(m) = (S^{-2}m_{(-1)}) m_{(0)} \text{ and } \zeta(m) = (Sm_{(-1)}) m_{(0)} \text{ for } m \in M.
$$

Then

$$
\xi\zeta=\zeta\xi=\mathrm{id}_M.
$$

*Proof.* The definition of an  ${}_H^H \mathcal{YD}$ -module implies that

$$
\xi(hm) = (S^{-2}h)\xi(m) \text{ and } \zeta(hm) = (S^2h)\zeta(m)
$$

for every  $h \in H$  and  $m \in M$ . Hence  $\xi \zeta = \zeta \xi = id_M$ .

Note that for any  $H^2$  $\mathcal{YD}$ -modules M and N we have

$$
\theta_{M,N}(f \otimes g)(m \otimes n) = f(m_{(0)})g(m_{(-1)}n),
$$
  
\n
$$
\theta_{M,N}^{\text{inv}}(f \otimes g)(m \otimes n) = f((S^{-1}n_{(-1)})m)g(n_{(0)}),
$$
  
\n
$$
\varphi^{\flat}(n)(m) = \varphi(m_{(0)})((S^{-1}m_{(-1)})n),
$$
  
\n
$$
\varphi^{\sharp}(n)(m) = \varphi(n_{(-1)}m)(n_{(0)})
$$

<span id="page-38-2"></span>for all  $m \in N$ ,  $n \in M$ ,  $f \in M^*$ ,  $g \in N^*$ ,  $\varphi \in H^* \mathcal{YD}(M, N^*)$ .

**Lemma 5.6.** For every  $^H_H$  $\mathcal{YD}$ -modules M and N the map  $\theta_{M,N}$ :  $M^* \otimes N^* \to (M \otimes N)^*$  is injective.

*Proof.* The map  $\theta_{M,N}: M^* \otimes N^* \to (M \otimes N)^*$  is injective since the map  $m \otimes n \mapsto m_{(0)} \otimes m_{(-1)}n$ is a bijection.

<span id="page-38-3"></span>**Lemma 5.7.** Let M be an  ${}^H_H$  $\mathcal{YD}$ -module. Then the map  $\alpha_M : M \to M^{**}$  is injective if and only if  $\bigcap$  Ker  $f = 0$ .  $f \in M^*$ 

*Proof.* For every  $m \in M$  and  $f \in M^*$  we have

$$
\alpha_M(m)(f) := (\mathrm{id}_{M^*})^b(m)(f) = f_{(0)}((S^{-1}f_{(-1)})m) = ((S^{-2}f_{(-1)})f_{(0)})(m).
$$

Now Lemma [5.5](#page-38-0) implies that  $\alpha_M(m) = 0$  for some  $m \in M$  if and only if  $f(m) = 0$  for all  $f \in M^*$ . .

<span id="page-39-0"></span>**Lemma 5.8.** Let M and N be nonzero  $H^H_y$  $\mathcal{YD}$ -modules. Then the map

$$
\left(\theta_{M,N}^{\text{inv}}\right)^{\flat}: M \otimes N \to (M^* \otimes N^*)^*
$$

is injective if and only if  $\bigcap$  $f \in M^*$ Ker  $f = 0$  and  $\bigcap$ g∈N<sup>∗</sup> Ker  $g=0$ .

*Proof.* Given  $m \in M$ ,  $n \in N$ ,  $f \in M^*$ ,  $g \in N^*$ , we have

$$
(\theta_{M,N}^{\text{inv}})^{\flat}(m \otimes n)(f \otimes g) = \theta_{M,N}^{\text{inv}}((f \otimes g)_{(0)})((S^{-1}(f \otimes g)_{(-1)})(m \otimes n))
$$
  

$$
= \theta_{M,N}^{\text{inv}}((S^{-2}(f \otimes g)_{(-1)})(f \otimes g)_{(0)})(m \otimes n)
$$
  

$$
= ((S^{-2}(f \otimes g)_{(-1)})(f \otimes g)_{(0)})((S^{-1}n_{(-1)})m \otimes n_{(0)}).
$$

Here we have used the fact that for every H-module homomorphism  $\varphi: A \otimes B \to \mathbb{k}$  we have

$$
\varphi(ha\otimes b)=\varphi(h_{(1)}a\otimes h_{(2)}(Sh_{(3)})b)=\varepsilon(h_{(1)})\varphi(a\otimes (Sh_{(2)})b)=\varphi(a\otimes (Sh)b)
$$

for all  $a \in A, b \in B$ .

Now we notice that the map  $m \otimes n \mapsto (S^{-1}n_{(-1)})m \otimes n_{(0)}$  is bijective since  $m \otimes n \mapsto n_{(-1)}m \otimes n_{(0)}$  is its inverse. Combining this with Lemma [5.5,](#page-38-0) we obtain that the map  $(\theta_{M,N}^{\text{inv}})^{\flat}: M \otimes N \to (M^* \otimes N^*)^*$  is not injective only if there exists a nonzero element  $\sum^k$  $i=1$  $m_i \otimes n_i \in M \otimes N$  such that

$$
\sum_{i=1}^{k} f(m_i)g(n_i) = 0 \text{ for all } f \in M^*, \ g \in N^*.
$$

Without loss of generality we may assume that the  $m_i$ 's are linearly independent. Suppose  $\bigcap$  Ker  $f = 0$  and  $\bigcap$  $f \in M^*$ g∈N<sup>∗</sup> Ker  $g = 0$ . Then

$$
\sum_{i=1}^{k} f(m_i)g(n_i) = f\left(\sum_{i=1}^{k} g(n_i)m_i\right) = 0
$$

implies  $\sum^k$  $i=1$  $g(n_i)m_i = 0$  and  $g(n_i) = 0$  for all  $1 \leq i \leq k$  and  $g \in N^*$ . Hence all  $n_i = 0$ ,  $\sum_{k=1}^{k}$  $i=1$  $m_i \otimes n_i = 0$  and  $(\theta_{M,N}^{\text{inv}})^{\flat}$  is injective. Conversely, if  $m \in M$ ,  $n \in N$ , where  $m \neq 0$ ,  $n \neq 0$ , and either  $m \in \bigcap$  $f \in M^*$  $\mathsf{Ker}\, f$  or  $n \in \bigcap$ g∈N<sup>∗</sup> Ker g, then  $(\theta_{M,N}^{\text{inv}})^{\flat}$   $(n_{(-1)}m \otimes n_{(0)})(f \otimes g) = 0$  for all  $f \in M^*,\ g \in N^*$  $\Box$ 

Remark 5.9. An example of  ${}^H_H$   $\mathcal{YD}$ -modules M and N with non-injective  $\alpha_M$  and  $(\theta_{M,N}^{inv})^{\flat}$ will be given in Remark  $5.14$  [\(3\)](#page-42-2) below.

<span id="page-40-2"></span>By Lemma [5.3](#page-37-1) and Remark [3.21,](#page-19-3) the functor  $(-)^*$ : Comon  $\binom{H}{H}$  $\mathcal{YD}$ )  $\rightarrow$  Mon  $\binom{H}{H}$  $\mathcal{YD}$ ) admits an adjoint functor  $(-)^\circ$ : Mon  $(HV) \rightarrow$  Comon  $(HV)$ . However, in order to prove that  $\varkappa_A$  is a monomorphism for every  ${}^H_H$  $\mathcal{YD}$ -module algebra A, we have to provide an explicit construction. We first need the following lemma:

<span id="page-40-1"></span>**Lemma 5.10.** Let  $(A, \mu, u)$  be a monoid and let  $(C, \Delta, \varepsilon)$  be a comonoid in a braided prerigid monoidal category C. Then for  $\varphi \in C(A, C^*)$  we have  $\varphi \in \textsf{Mon}(\mathcal{C})(A, C^*)$  if and only if the diagrams below are commutative:

$$
C \longrightarrow A^* \longrightarrow A^* \longrightarrow A^* \longrightarrow A^* \longrightarrow B^* \longrightarrow B^* \longrightarrow C \longrightarrow B^* \longrightarrow C^* \longrightarrow A^* \longrightarrow C \otimes C \longrightarrow \varphi^{\sharp} \otimes \varphi^{\sharp} \longrightarrow A^* \longrightarrow (A \otimes A)^* \longrightarrow 1 \longrightarrow 1^*
$$
 (5.2)

*Proof.* Apply Remark [3.27](#page-21-2) and [\[13,](#page-47-12) Lemma 2.5].

<span id="page-40-0"></span>Below we present a candidate for  $A^{\circ}$  in  $H^2 \mathcal{YD}$ .

**Lemma 5.11.** Let  $H$  be a Hopf algebra over a field  $\bf{k}$  with an invertible antipode  $S$ . Given a unital associative  $H^2YD$ -module algebra A, the subspace  $A^* \cap A^{\circ}_{\mathbb{k}}$  is a  $H^2YD$ -submodule of  $A^*$ . Moreover,  $A^* \cap A^{\circ}_{\mathbb{k}}$  is an  ${}_H^H \mathcal{YD}$ -module coalgebra, i.e. a comonoid in  ${}_H^H \mathcal{YD}$ , where the comultiplication  $\Delta_{A^*\cap A^{\circ}_{\mathbf{k}}}f := f_{[1]} \otimes f_{[2]}$  and the counit are defined by

$$
f_{[1]}(a) f_{[2]}(b) := f\big((b_{(-1)}a)b_{(0)}\big), \quad \varepsilon_{A^*\cap A^{\circ}_{\mathbf{k}}}(f) := f(1_A),
$$

for all  $f \in A^* \cap A_{\mathbb{k}}^{\circ}, a, b \in A$ .

*Proof.* Note that for every  $f \in A^*$  and  $b \in A$  we have  $\dim(f(b(-)) \diamond A) < +\infty$  and  $\dim(f((-)b) \diamond A) < +\infty$  (recall that  $\diamond$  was defined in Remark [5.4](#page-38-1) above), since

$$
f(b(-)) \diamond a = f(ba_{(0)})a_{(-1)} = f(b_{(0)}a_{(0)})(Sb_{(-2)})b_{(-1)}a_{(-1)} = (Sb_{(-1)})(f \diamond (b_{(0)}a))
$$

and

$$
f((-)b) \diamond a = f(a_{(0)}b)a_{(-1)} = f(a_{(0)}b_{(0)})a_{(-1)}b_{(-1)}S^{-1}b_{(-2)} = (f \diamond (ab_{(0)}))S^{-1}b_{(-1)}.
$$

Suppose  $f \in A^* \cap A_{\mathbb{k}}^{\circ}$ . Then there exist  $s \in \mathbb{Z}_+$  and  $f_i, g_i \in A_{\mathbb{k}}^{\circ}$ ,  $1 \leq i \leq s$ , such that  $f(ab) = \sum_{n=1}^{s}$  $i=1$  $f_i(a)g_i(b)$  for all  $a, b \in A$ . Without loss of generality we may assume that each of the systems  $f_1, \ldots, f_s$  and  $g_1, \ldots, g_s$  of linear functions is linearly independent. Performing Gaussian elimination, one can find  $a_i, b_i \in A$ ,  $1 \leq i \leq s$ , such that  $f_i(a_j) = g_i(b_j) = \delta_{ij}$  for all  $1 \leq i, j \leq s$ . In particular,  $f_i = f((-)b_i)$  and  $g_i = f(a_i(-))$  for all  $1 \leq i \leq s$ . Hence  $f \in A^* \cap A^{\circ}_{\mathbb{k}}$  implies that all  $f_i, g_i \in A^* \cap A^{\circ}_{\mathbb{k}}$ .

Moreover, for every  $h \in H$  and  $a, b \in A$  we have

$$
(hf)(ab) = f((Sh)(ab)) = f(((Sh_{(2)})a)((Sh_{(1)})b))
$$
  
\n
$$
= \sum_{i=1}^{s} f_i((Sh_{(2)})a)g_i((Sh_{(1)})b) = \sum_{i=1}^{s} (h_{(2)}f_i)(a)(h_{(1)}g_i)(b),
$$
  
\n
$$
f_{(0)}(ab)f_{(-1)} = f((ab)_{(0)})S^{-1}((ab)_{(-1)}) = f(a_{(0)}b_{(0)})S^{-1}(b_{(-1)})S^{-1}(a_{(-1)})
$$
  
\n
$$
= \sum_{i=1}^{s} f_i(a_{(0)})g_i(b_{(0)})S^{-1}(b_{(-1)})S^{-1}(a_{(-1)}) = \sum_{i=1}^{s} f_{i(0)}(a)g_{i(0)}(b)g_{i(-1)}f_{i(-1)}.
$$

Therefore, by [\[10,](#page-47-6) Proposition 1.5.6, 3)], the subspace  $A^* \cap A^{\circ}_{\mathbb{k}}$  is an  $H^* \mathcal{YD}$ -submodule of  $A^*$ .

Now

$$
f_{[1]}(a) f_{[2]}(b) := f\big((b_{(-1)}a)b_{(0)}\big) = \sum_{i=1}^s f_i(b_{(-1)}a)g_i(b_{(0)})
$$

$$
= \sum_{i=1}^s \big((S^{-1}b_{(-1)})f_i\big)(a)g_i(b_{(0)}) = \sum_{i=1}^s \big(g_{i(-1)}f_i\big)(a)g_{i(0)}(b) \text{ for all } a, b \in A.
$$

Therefore,  $f_{[1]}\otimes f_{[2]}=\sum^s$  $i=1$  $g_{i(-1)}f_i \otimes g_{i(0)} \in (A^* \cap A^{\circ}_{\mathbb{k}}) \otimes (A^* \cap A^{\circ}_{\mathbb{k}})$  for all  $f \in A^* \cap A^{\circ}_{\mathbb{k}}$  and  $\Delta_{A^*\cap A^{\circ}_{\mathbf{k}}}$  is a comultiplication on  $A^*\cap A^{\circ}_{\mathbf{k}}$ .

An explicit verification shows that  $(A^* \cap A^{\circ}_{\mathbb{k}}, \Delta_{A^* \cap A^{\circ}_{\mathbb{k}}}, \varepsilon_{A^* \cap A^{\circ}_{\mathbb{k}}})$  is indeed a coalgebra. Note that

$$
(hf)_{[1]}(a)(hf)_{[2]}(b) = (hf) \big( (b_{(-1)}a) b_{(0)} \big) = f \big( (Sh)((b_{(-1)}a) b_{(0)}) \big)
$$
  

$$
= f \big( ((Sh_{(2)})b_{(-1)}a)((Sh_{(1)})b_{(0)}) \big) = f \big( (((Sh_{(4)})b_{(-1)}(S^2h_{(2)})Sh_{(1)})a)(Sh_{(3)})b_{(0)} \big)
$$
  

$$
= f \big( (((Sh_{(2)})_{(1)}b_{(-1)}(S(Sh_{(2)})_{(3)})Sh_{(1)})a)(Sh_{(2)})_{(2)}b_{(0)} \big)
$$
  

$$
= f \big( ((((Sh_{(2)})b)_{(-1)}Sh_{(1)})a)((Sh_{(2)})b)_{(0)} \big)
$$
  

$$
= f_{[1]} \big( (Sh_{(1)})a \big) f_{[2]} \big( (Sh_{(2)})b \big) = (h_{(1)}f_{[1]})(a)(h_{(2)}f_{[2]})(b)
$$

and

$$
\varepsilon_{A^*\cap A_\nu^\circ}(hf)=(hf)(1_A)=f((Sh)1_A)=\varepsilon(h)f(1_A)=\varepsilon(h)\varepsilon_{A^*\cap A_\nu^\circ}(f)
$$

for all  $h \in H$ ,  $f \in A^* \cap A^{\circ}_{\mathbb{k}}$ ,  $a, b \in A$ . Hence  $A^* \cap A^{\circ}_{\mathbb{k}}$  is an H-module coalgebra. At the same time,

$$
f_{(0)[1]}(a) f_{(0)[2]}(b) f_{(-1)} = f_{(0)}((b_{(-1)}a)b_{(0)}) f_{(-1)} = f((b_{(-1)}a)b_{(0)})_{(0)}) S^{-1}((b_{(-1)}a)b_{(0)})_{(-1)}
$$
  
\n
$$
= f((b_{(-2)}a)_{(0)}b_{(0)}) S^{-1}((b_{(-2)}a)_{(-1)}b_{(-1)}) = f((b_{(-3)}a_{(0)})b_{(0)}) S^{-1}(b_{(-4)}a_{(-1)}(Sb_{(-2)})b_{(-1)})
$$
  
\n
$$
= f((b_{(-1)}a_{(0)})b_{(0)}) S^{-1}(b_{(-2)}a_{(-1)}) = f((b_{(-1)}a_{(0)})b_{(0)}) (S^{-1}a_{(-1)}) (S^{-1}b_{(-2)})
$$
  
\n
$$
= f_{[1]}(a_{(0)}) f_{[2]}(b_{(0)}) (S^{-1}a_{(-1)}) (S^{-1}b_{(-1)}) = f_{[1](0)}(a) f_{[2](0)}(b) f_{[1](-1)} f_{[2](-1)}
$$

and

$$
\varepsilon_{A^*\cap A^{\circ}_{\mathbb{k}}}(f_{(0)})f_{(-1)} = f_{(0)}(1_A)f_{(-1)} = f(1_A)1_H = \varepsilon_{A^*\cap A^{\circ}_{\mathbb{k}}}(f)1_H
$$

<span id="page-41-0"></span>for all  $f \in A^* \cap A^{\circ}_{\mathbb{k}}$ ,  $a, b \in A$ . Therefore,  $A^* \cap A^{\circ}_{\mathbb{k}}$  is an H-comodule coalgebra.

**Lemma 5.12.** Let  $H$  be a Hopf algebra over a field  $k$  with an invertible antipode  $S$ . Then the finite dual  $A^{\circ}$  in  ${}_H^H$  $\mathcal{YD}$  coincides with  $A^* \cap A^{\circ}_{\mathbb{k}}$  endowed with the coalgebra structure from Lemma [5.11.](#page-40-0) Moreover,

•  $\varkappa_A$  is a monomorphism for every unital associative  ${}^H_H\mathcal{YD}$ -module algebra A.

*Proof.* By Lemma [5.10,](#page-40-1) for every  ${}_H^H \mathcal{YD}$ -module algebra homomorphism  $\varphi: A \to C^*$  where A is a unital associative  ${}^H_H$  $\mathcal{YD}$ -module algebra and C is an  ${}^H_H \mathcal{YD}$ -module coalgebra,  $\mu^*\varphi^{\sharp}(C) \in \theta^{\rm inv}_{A,A}(A^* \otimes A^*).$ 

Recall that

$$
\theta_{A,A}^{\text{inv}}(f \otimes g)(a \otimes b) = f\big((S^{-1}b_{(-1)})a\big)g(b_{(0)}) = \big((S^{-2}b_{(-1)})f\big)(a)g(b_{(0)})
$$

$$
= \big((S^{-1}g_{(-1)})f\big)(a)g_{(0)}(b) = \big((S^{-1}g_{(-1)})f \otimes g_{(0)}\big)(a \otimes b)
$$

for all  $f, g \in A^*, a, b \in A$ . In other words,  $\theta_{A,A}^{\text{inv}}(A^* \otimes A^*)$  coincides with the image of  $A^* \otimes A^*$ in  $(A \otimes A)^*$  under the restriction of the standard embedding  $A^*_{\mathbb{k}} \otimes A^*_{\mathbb{k}} \hookrightarrow (A \otimes A)^*_{\mathbb{k}}$  in  $\mathbf{Vect}_{\mathbb{k}}$ since the map  $f \otimes g \mapsto (S^{-1}g_{(-1)})f \otimes g_{(0)}$  is a bijection. Hence for every  $c \in C$  the linear

<span id="page-42-4"></span>function  $\varphi^{\sharp}(c)$  belongs to  $A^* \cap A^{\circ}_{\mathbf{k}}$ . An explicit verification shows that the diagram below is commutative:

The injectivity of  $\theta_{A,A}^{\text{inv}}$  together with Lemma [5.10](#page-40-1) imply that an  $H^2\mathcal{YD}$ -module homomorphism  $\varphi: A \to C^*$  is an  $^H_H$  $\mathcal{YD}$ -module algebra homomorphism if and only if the corestriction of  $\varphi^{\sharp}$  to  $A^* \cap A^{\circ}_{\mathbf{k}}$  is an  $H^* \mathcal{YD}$ -module coalgebra homomorphism. In particular, the functor  $(-)^*$ : Comon $(HVD)^+$   $\rightarrow$  Mon $(HVD)$  admits an adjoint functor  $(-)^\circ$ : Mon $(H\mathcal{YD}) \rightarrow$  Comon $(H\mathcal{YD})$  where  $A^\circ = A^* \cap A_\mathbb{k}^\circ$ . Note that  $\varkappa_A$  coincides with the restriction of the standard embedding  $A_{\kappa}^{\circ} \hookrightarrow A_{\kappa}^{*}$  and is a monomorphism.

<span id="page-42-3"></span>Finally, we get

**Theorem 5.13.** Let  $H$  be a Hopf algebra over a field  $\Bbbk$  with an invertible antipode  $S$ . Then  ${}^{H}_{H}$ VD is a braided closed monoidal category satisfying Properties [1–](#page-6-2)[10,](#page-7-4) [5a](#page-6-7) of Section [2.5](#page-6-0) and their duals. Moreover, all monomorphisms and epimorphisms in  ${}^H_H$  $\mathcal{YD}$  are extremal and

- $\theta_{M,N}$  is a monomorphism for any  ${}^H_H$  $\mathcal{YD}\text{-modules }M, N;$
- $\alpha_M$  is a monomorphism for an  $^H_H$  $\mathcal{YD}$ -module M if and only if  $\bigcap$  Ker  $f = 0$ ;  $f \in M^*$
- $\bullet$   $(\theta_{M,N}^{\text{inv}})^{\flat}$  is a monomorphism for nonzero  ${}^H_H$   $\mathcal{YD}$ -modules M and N if and only if  $\tilde{\cap}$  $f \in M^*$ Ker  $f = 0$  and  $\bigcap$ g∈N<sup>∗</sup>  $\mathsf{Ker}\, g=0;$
- $\varkappa_A$  is a monomorphism for every unital associative  ${}^H_H\mathcal{YD}$ -module algebra A.

<span id="page-42-0"></span>*Proof.* Apply Lemmas [5.3,](#page-37-1) [5.6](#page-38-2)[–5.8](#page-39-0) and [5.12.](#page-41-0)

Remarks 5.14.

- (1) If the Hopf algebra H is finite dimensional, then  $M^* = M^*_{\mathbb{R}}$  and  $\bigcap$  $f \in M^*$ Ker  $f = 0$  for every  $^H_H$  $\mathcal{YD}$ -module M.
- <span id="page-42-1"></span>(2) Note that the functor  $(-)^*$  does not necessarily map monomorphisms to epimorphisms. Let k be a field and let  $H = \mathbb{k}[x_i \mid i \in \mathbb{N}]$  where  $\Delta_H x_i := x_i \otimes 1_H + 1_H \otimes x_i$ ,  $\varepsilon_H(x_i) := 0$ . Then H is a left H-comodule where  $\delta_H := \Delta_H$ . Consider Hsubcomodules  $k1_H$  and  $V := \langle x_i | i \in \mathbb{N} \rangle_k \oplus k1_H$  of H. Define on V and  $k1_H$  the structure of trivial left H-modules, i.e.  $hm := \varepsilon(h)m$  for all  $m \in V$ . The commutativity of H implies that both V and  $k1_H$  are  $H^2$  $\mathcal{YD}$ -modules. Denote by  $\varphi$  the  ${}_H^H \mathcal{YD}$ -module embedding  $\varphi: \mathbb{k}1_H \hookrightarrow V$ . Let  $f \in V^*_\mathbb{k}$ ,  $\lambda := f(1_H) \neq 0$ ,  $\lambda_i := f(x_i)$ . Then

$$
f \diamond V = \langle f \diamond x_i | i \in \mathbb{N} \rangle_{\mathbb{R}} + f \diamond \mathbb{K}1_H = \left\langle x_i + \frac{\lambda_i}{\lambda} 1_H \middle| i \in \mathbb{N} \right\rangle_{\mathbb{K}} + \mathbb{K}1_H.
$$

In particular,  $\dim(f \circ V) = +\infty$ . Hence  $f(1_H) = 0$  for all  $f \in V^*$  where the dual is taken in  ${}^H_H\mathcal{YD}$ . Therefore,  $\varphi^* = 0$ . At the same time,  $\mathbb{k}^* \neq 0$ . Hence  $\varphi^*: V^* \to \mathbb{k}^*$  is not an epimorphism for the (extremal) monomorphism  $\varphi$  in  $^H_H$  $\mathcal{YD}$ .

- <span id="page-42-2"></span>(3) Let V be the same as in [\(2\)](#page-42-1) above. Then the proof of Lemmas [5.7](#page-38-3) and [5.8](#page-39-0) implies that  $\alpha_V(1_H) = 0$  and  $(\theta_{V,V}^{\text{inv}})^{\flat} (1_H \otimes 1_H) = 0$ . In particular,  $\alpha_V$  and  $(\theta_{V,V}^{\text{inv}})^{\flat}$  are not monomorphisms.
- (4) By Theorem [5.13](#page-42-3) we may apply to the category  $C = H \mathcal{YD}$  all the results of [\[5,](#page-47-0) Sections 4, 5] and Section [4.2](#page-27-0) of the present paper. Unfortunately, by the reasons mentioned

<span id="page-43-2"></span>in Remarks [2](#page-42-1) and [3](#page-42-2) above, for an arbitrary  $H$ , we cannot apply to  ${}^H_H$  $YD$  the results of Sections [3,](#page-10-1) [4.3](#page-29-0) and [4.4.](#page-33-0) Another reason, why we cannot apply the duality theorems for bimonoid and Hopf monoids (co)actions, is that those theorems have been proved only for symmetric categories.

<span id="page-43-0"></span>5.4. Right Yetter – Drinfel'd modules. Let  $F: \mathcal{C} \to \mathcal{D}$  be a braided strong monoidal functor between braided monoidal categories. Suppose  $F$  is an isomorphism of ordinary categories,  $\mathcal C$  is pre-rigid and there exists  $(-)^\circ$ : Mon $(\mathcal C)\to \mathsf{Comon}(\mathcal C)$ . Then  $\mathcal D$  is pre-rigid too and there exists  $(-)^\circ$ : Mon $(\mathcal{D}) \to \mathsf{Comon}(\mathcal{D})$  where  $G(-)^* \cong (G(-))^*$  and  $G(-)^\circ \cong (G(-))^{\circ}$ . Moreover, for every objects A, B in C, M in  $\textsf{Mon}(\mathcal{C})$  and a morphism  $\varphi: A \to B^*$  the morphisms  $\theta_{GA,GB}$ ,  $\theta_{GA,GB}^{inv}$ ,  $(G\varphi)^{\sharp}$ ,  $(G\varphi)^{\sharp}$ ,  $\varkappa_{GM}$  in  $\mathcal D$  can be identified with, respectively,  $G\theta_{A,B}$ ,  $G\theta_{A,B}^{\text{inv}}$ ,  $G(\varphi^{\sharp})$ ,  $G(\varphi^{\sharp})$  and  $G\varkappa_M$  via the corresponding isomorphisms. Hence  $\mathcal C$  and  $\mathcal D$  share the same properties. In particular, this is true when  $\mathcal D$  is just  $\mathcal C$  with the opposite monoidal product and the functor  $F$  is identical on objects and morphisms. This observation has the following important application.

Let  $H$  be a Hopf algebra over a field  $\Bbbk$  with an invertible antipode S. Consider the category  $\mathcal{YD}^H_H$  of *right Yetter — Drinfel'd modules* (or  $\mathcal{YD}^H_H\text{-modules}$  for short), i.e. right  $H\text{-modules}$ and H-comodules M such that the H-action and the H-coaction  $\rho: M \to M \otimes H$  satisfy the following compatibility condition:

$$
\rho(mh) = m_{(0)}h_{(2)} \otimes (Sh_{(1)})m_{(1)}h_{(3)}
$$
 for every  $m \in M$  and  $h \in H$ .

The braiding on  $\mathcal{YD}_{H}^{H}$  is defined by  $c_{M,N}(m \otimes n) := n_{(0)} \otimes mn_{(1)}$  for all  $m \in M$ ,  $n \in N$  and  $\mathcal{YD}_{H}^{H}$ -modules M and N. (Note that in contrast with [\[20,](#page-48-2) Exercise 11.6.21] we consider the standard H-(co)action on  $M \otimes N$  induced from those in  $_H$ Mod and Comod<sup>H</sup>, respectively. As a consequence, our formula for the braiding is different too.) Then  $\mathcal{YD}_H^H$  can be identified with  $H_{\text{op,cop}}^{\text{op,cop}}$  where  $H_{\text{op,cop}}$  is the Hopf algebra H with the opposite product and coproduct and the monoidal product is opposite too. As a consequence, the analog of Theorem [5.13](#page-42-3) holds for  $\mathcal{YD}_{H}^{H}$  too. The only difficulty that one can encounter on this way could be verifying the necessary and sufficient conditions in the analogs of Lemmas [5.7](#page-38-3) and [5.8](#page-39-0) since the description of  $A^*$  in  $\mathcal{YD}_H^H$  in terms of  ${}_{H^{\text{op},\text{cop}}}^{H^{\text{op},\text{cop}}} \mathcal{YD}$  becomes complicated due to the braiding involved and  $ev_A$  no longer being tautological. For this reason, below we give a natural description of the internal hom and the functor  $(-)^*$  in  $\mathcal{YD}_H^H$  as well as explicit formulas for the related maps.

Given  $\mathcal{YD}_{H}^H$ -modules M and N, the  $\mathcal{YD}_{H}^H$ -module [M, N] as a right H-comodule coin-cides with the one defined in Section [5.2.](#page-36-1) The right  $H$ -action on  $[M, N]$  is defined by  $(fh)(m) := f(mS^{-1}h_{(2)})h_{(1)}$  for  $h \in H$ ,  $m \in M$ . In this description,  $[M, N]$  is a subspace of Hom<sub>k</sub> $(M, N)$  and the evaluation map is tautological, i.e.  $f \otimes m \mapsto f(m)$  for  $f \in [M, N]$  and  $m \in M$ . As usual,  $M^* := [M, \mathbb{k}]$ .

For any  ${}^H_H$  $\mathcal{YD}$ -modules M and N we have

$$
\theta_{M,N}^{\text{inv}}(f \otimes g)(m \otimes n) = f(m_{(0)})g(nS^{-1}m_{(1)}),
$$
  

$$
\varphi^{\flat}(n)(m) = \varphi\big(mS^{-1}n_{(1)}\big)(n_{(0)})
$$

for all  $m \in N$ ,  $n \in M$ ,  $f \in M^*$ ,  $g \in N^*$ ,  $\varphi \in H^* \mathcal{YD}(M, N^*)$ .

<span id="page-43-1"></span>Lemmas [5.15](#page-43-1) and [5.16](#page-44-2) below complete the proof of the analog of Theorem [5.13](#page-42-3) for  $\mathcal{YD}_H^H$ :

**Lemma 5.15.** Let M be an  $\mathcal{YD}_H^H$ -module. Then the map  $\alpha_M \colon M \to M^{**}$  is injective if and only if  $\bigcap$  $f \in M^*$ Ker  $f=0$ .

*Proof.* For every  $m \in M$  and  $f \in M^*$  we have

$$
\alpha_M(m)(f) := (\mathrm{id}_{M^*})^{\flat}(m)(f) = (fS^{-1}m_{(1)}) (m_{(0)}) = f(m_{(0)}S^{-2}m_{(1)}).
$$

<span id="page-44-3"></span><span id="page-44-2"></span>Now we apply the analog of Lemma [5.5.](#page-38-0)

**Lemma 5.16.** Let M and N be nonzero  $\mathcal{YD}_H^H$ -modules. Then the map  $\left(\theta_{M,N}^{\text{inv}}\right)^{\flat}: M \otimes N \to (M^* \otimes N^*)^*$  is injective if and only if  $\bigcap$  $f \in M^*$ Ker  $f = 0$  and  $\bigcap$  $g\overline{\in}N^*$ Ker  $g=0$ .

*Proof.* Define linear maps  $\xi, \nu \colon M \otimes N \to M \otimes N$  by

$$
\xi(m \otimes n) = (m \otimes n)_{(0)} S^{-2}(m \otimes n)_{(1)},
$$

$$
\nu(m \otimes n) = m_{(0)} \otimes n S^{-1} m_{(1)}
$$

for  $m \in M$ ,  $n \in N$ .

Fix  $m \in M$ ,  $n \in N$ ,  $f \in M^*$ ,  $g \in N^*$ . Then

$$
(\theta_{M,N}^{\text{inv}})^{\flat}(m \otimes n)(f \otimes g) = \theta_{M,N}^{\text{inv}}((f \otimes g)S^{-1}(m \otimes n)_{(1)})(m \otimes n)_{(0)})
$$
  
=  $\theta_{M,N}^{\text{inv}}(f \otimes g)((m \otimes n)_{(0)}S^{-2}(m \otimes n)_{(1)}) = \theta_{M,N}^{\text{inv}}(f \otimes g)(\xi(m \otimes n)) = (f \otimes g)(\nu\xi(m \otimes n)).$ 

Here we have used that for every right H-module homomorphism  $\varphi: A \otimes B \to \mathbb{k}$  we have

$$
\varphi(ah\otimes b)=\varphi(ah_{(1)}\otimes b(S^{-1}h_{(3)})h_{(2)})=\varepsilon(h_{(1)})\varphi\big(a\otimes bS^{-1}h_{(2)}\big)=\varphi(a\otimes bS^{-1}h)
$$

for all  $a \in A$ ,  $b \in B$ . By the analog of Lemma [5.5,](#page-38-0) the map  $\xi$  is bijective. The map  $\nu$ is bijective too since  $\nu^{-1}(m \otimes n) = m_{(0)} \otimes nm_{(1)}$ . Now we use the same argument as in Lemma [5.8.](#page-39-0)

<span id="page-44-0"></span>5.5. Modules over quasitriangular Hopf algebras. Let  $H$  be a quasitriangular Hopf algebra over a field k, i.e. the category  $_H$ Mod is braided. Then  $c_{M,N}(u) = (Ru)^{21}$  for all left H-modules M, N and  $u \in M \otimes N$  where  $R \in H \otimes H$  is a fixed invertible element called the *R-matrix*,  $(m \otimes n)^{21} := n \otimes m$ . We refer to [\[12,](#page-47-17) Section 8.3], [\[16,](#page-47-18) Chapter 2] or [\[18,](#page-47-10) Section 10.1] for more details.

**Example 5.17.** Every cocommutative Hopf algebra H is quasitriangular where  $R = 1_H \otimes 1_H$ and  $c_{M,N}$  is the ordinary swap.

Recall that in every quasitriangular Hopf algebra  $H$  the antipode is invertible [\[16,](#page-47-18) Proposition 2.1.8]. Moreover, for every left H-module M the map  $\delta: M \to H \otimes M$ , where  $\delta m := R^{21}(1_H \otimes m)$  for  $m \in M$ , defines on M a structure of a left H-comodule that turns M into a  ${}^H_H$  $\mathcal{YD}$ -module. The braiding induced by the  ${}^H_H$  $\mathcal{YD}$ -module structure coincides with the original braiding on  $_H$ Mod. In other words,  $_H$ Mod can be identified with a full subcategory in  ${}^H_H$  $\mathcal{YD}$ . The embedding functor  ${}_H$ **Mod**  $\hookrightarrow {}^H_H \mathcal{YD}$  is a strict braided monoidal functor that commutes with the functor  $(-)^*$  and taking small limits and colimits. This implies that  $\theta_{A,B}$ ,  $\theta_{A,B}^{\text{inv}}$ ,  $\varphi^{\sharp}$ ,  $\varphi^{\sharp}$  in  $_H$ Mod coincide with those in  $_H^H$  $\mathcal{YD}$ . An explicit verification shows that the restriction of the functor  $(-)^\circ$ :  $\mathsf{Mon}(\mathop{H}\limits_H \mathcal{YD}) \to \mathsf{Comon}(\mathop{H}\limits_H \mathcal{YD})$  to  $\mathsf{Mon}(\mathop{H}\limits_H \mathsf{Mod})$ takes values again in Mon( $_H$ Mod). Moreover, for H-module algebras A we have  $A^\circ = A^\circ_\Bbbk$  as vector spaces, but the comultiplication is still twisted. Finally, the equality  $M^* = M^*_{\mathbf{k}}$  for every H-module M implies that the functor  $(-)^*$  maps monomorphisms to epimorphisms. By Theorem [5.13,](#page-42-3) we get

<span id="page-44-1"></span>**Theorem 5.18.** Let H be a quasitriangular Hopf algebra over a field k. Then  $_H$ Mod is a braided closed monoidal category satisfying Properties  $1-10$  $1-10$ ,  $5a$  of Section [2.5](#page-6-0) and their duals. Moreover, all monomorphisms and epimorphisms in  $H$ Mod are extremal and

- the functor  $(-)^*$  maps monomorphisms to epimorphisms;
- $\alpha_M$ ,  $\theta_{M,N}$ ,  $(\theta_{M,N}^{\text{inv}})^{\flat}$  are monomorphisms for any H-modules M, N;
- $\varkappa_A$  is a monomorphism for every unital associative H-module algebra A.

<span id="page-45-4"></span>Remark 5.19. By Theorem [5.18](#page-44-1) we may apply to the category  $C = H$ Mod all the results of [\[5,](#page-47-0) Sections 4 and 5], Sections [4.2,](#page-27-0) [4.3](#page-29-0) of the present paper as well as the duality theorems for (co)measurings (Theorems [3.24,](#page-20-1) [4.25,](#page-33-2) Corollaries [3.26](#page-20-3) and [4.26\)](#page-33-3). If, moreover,  $H$ Mod is symmetric, i.e. the Hopf algebra H is *triangular*, then we may apply to  $_H$ Mod all the results of Sections [3](#page-10-1) and [4,](#page-26-0) in particular, the duality theorems for bimonoid and Hopf monoids (co)actions.

<span id="page-45-0"></span>5.6. Comodules over coquasitriangular Hopf algebras. Let  $H$  be a *coquasitri*angular Hopf algebra over a field k, i.e. the category  $Comod<sup>H</sup>$  is braided. Then  $c_{M,N}(m \otimes n) = R(m_{(1)}, n_{(1)}) n_{(0)} \otimes m_{(0)}$  for all right H-comodules  $M, N, m \in M$  and  $n \in N$ where  $R: H \otimes H \to \mathbb{k}$  is a fixed linear map called the R-form, which is invertible in  $(H \otimes H)^*$ . More details can be found in e.g. [\[12,](#page-47-17) Section 8.3], [\[16,](#page-47-18) Chapter 2] or [\[18,](#page-47-10) Section 10.2].

**Example 5.20.** Every commutative Hopf algebra  $H$  is coquasitriangular where  $R(h, t) = \varepsilon(h)\varepsilon(t)$  for all  $h, t \in H$  and  $c_{M,N}$  is the ordinary swap.

Recall that in every coquasitriangular Hopf algebra  $H$  the antipode is invertible too [\[16,](#page-47-18) Proposition 2.2.4. Moreover, every right H-comodule M is simultaneously a right H-module M too where  $mh := R(m_{(1)}, h)m_{(0)}$  for all  $m \in M$ ,  $h \in H$ , which turns M into a  $\mathcal{YD}_H^H$ module. The braiding induced by the  $\mathcal{YD}_H^H$ -module structure coincides with the original braiding on  $\mathsf{Comod}^H$ . In other words,  $\mathsf{Comod}^H$  can be identified with a full subcategory in  $\mathcal{YD}^H_H$ . The embedding functor  $\mathsf{Comod}^H \hookrightarrow \mathcal{YD}^H_H$  is a strict braided monoidal functor that commutes with the functor  $(-)^*$  and taking small limits and colimits. This implies that  $\theta_{A,B},\,\theta^{\text{inv}}_{A,B},\,\varphi^\flat,\,\varphi^\sharp$  in Comod $^H$  coincide with those in  $\mathcal{YD}_H^H.$ 

Note that the embedding  $\mathsf{Comod}^H \subseteq \mathcal{YD}_H^H$  admits the left adjoint functor  $M \mapsto M/I(M)$ where  $I(M)$  is the  $\mathcal{YD}_{H}^{H}$ -submodule of the  $\mathcal{YD}_{H}^{H}$ -module M generated by all elements  $mh - R(m_{(1)}, h)m_{(0)}$  where  $m \in M$ ,  $h \in H$ . If C is a  $\mathcal{YD}_H^H$ -module coalgebra, then  $I(C)$ is automatically a coideal. Therefore, if C is a limit in  $\mathsf{Comon}(\mathcal{Y}\mathcal{D}_H^H)$  of a diagram in Comon (Comod<sup>H</sup>), then  $C/I(C)$ , which now belongs to Comon (Comod<sup>H</sup>), must be a limit of this diagram too and the embedding  $\mathsf{Comon}(\mathsf{Comod}^H)\subseteq \mathsf{Comon}\big(\mathcal{Y}\mathcal{D}_H^H\big)$  preserves all limits. Now Remark [3.21](#page-19-3) and the proof of [\[7,](#page-47-13) Theorem 1.5] imply that the restriction of the functor  $(-)^\circ \colon \mathsf{Mon}\big(\mathcal{Y}\mathcal{D}_H^H\big) \to \mathsf{Comon}\big(\mathcal{Y}\mathcal{D}_H^H\big)$  to  $\mathsf{Mon}\big(\mathsf{Comod}^H\big)$  takes values in  $\mathsf{Comon}\big(\mathsf{Comod}^H\big)$ . By the remarks made in Section [5.4,](#page-43-0) the following theorem holds:

<span id="page-45-3"></span>**Theorem 5.21.** Let H be a coquasitriangular Hopf algebra over a field k. Then Comod<sup>H</sup> is a braided closed monoidal category satisfying Properties  $1-10$ ,  $5a$  of Section [2.5](#page-6-0) and their duals. Moreover, all monomorphisms and epimorphisms in  $\mathsf{Comod}^H$  are extremal and

- $\theta_{M,N}$  is a monomorphism for any H-comodules M, N;
- $\alpha_M$  is a monomorphism for an H-comodule M if and only if  $\bigcap$  $f \in M^*$ Ker  $f = 0$ ;
- $\bullet$   $(\theta_{M,N}^{\text{inv}})^{\flat}$  is a monomorphism for nonzero H-comodules M and N if and only if  $\tilde{\cap}$  $f \in M^*$ Ker  $f = 0$  and  $\bigcap$ g∈N<sup>∗</sup>  $\mathsf{Ker}\, g=0;$
- $\varkappa_A$  is a monomorphism for every unital associative H-comodule algebra A.

<span id="page-45-1"></span>Remarks 5.22.

- (1) If the Hopf algebra H is finite dimensional, then  $M^* = M^*_{\mathbb{k}}$  and  $\bigcap$  $f \in M^*$  $\mathsf{Ker}\, f = 0 \,\, \text{for}$ every H-comodule M.
- <span id="page-45-2"></span>(2) In Comod<sup>H</sup> the functor  $(-)^*$  does not necessarily map monomorphisms to epimorphisms either. Let k be a field and let  $H = \mathbb{k}[x_i \mid i \in \mathbb{N}]$ , the algebra of polynomials in the variables  $x_i$ , where  $\Delta_H x_i := x_i \otimes 1_H + 1_H \otimes x_i$ ,  $\varepsilon_H(x_i) := 0$ . Then

<span id="page-46-3"></span>H is a right H-comodule where  $\rho_H := \Delta_H$ . Consider H-subcomodules  $k1_H$  and  $V := \langle x_i | i \in \mathbb{N} \rangle_{\mathbb{K}} \oplus \mathbb{K}1_H$  of H. Denote by  $\varphi$  the H-comodule embedding  $\varphi: \mathbb{K}1_H \hookrightarrow V$ . Then the same argument as in Remark [5.14](#page-42-0) [\(2\)](#page-42-1) shows that  $\varphi^*$  is not an epimorphism for the (extremal) monomorphism  $\varphi$  in Comod<sup>H</sup>.

- <span id="page-46-2"></span>(3) Let V be the same as in  $(2)$  above. Then the proof of Lemmas [5.15](#page-43-1) and [5.16](#page-44-2) implies that  $\alpha_V(1_H) = 0$  and  $(\theta_{V,V}^{\text{inv}})^{\flat} (1_H \otimes 1_H) = 0$ . In particular,  $\alpha_V$  and  $(\theta_{V,V}^{\text{inv}})^{\flat}$  are not monomorphisms.
- (4) By Theorem [5.21](#page-45-3) we may apply to the category  $C = \text{Comod}^H$  all the results of [\[5,](#page-47-0) Sections 4 and 5 and Section [4.2](#page-27-0) of the present paper. If, moreover,  $\mathsf{Comod}^H$  is symmetric, i.e. the Hopf algebra H is *cotriangular*, and  $\bigcap$  Ker  $f = 0$  for every H $f \in M^*$

comodule M, then we may apply to  $\mathsf{Comod}^H$  the duality theorems for (co)measurings and (co)actions from Section [3.](#page-10-1) In particular, if  $H = \mathbb{k}G$  for an abelian group G, i.e.  $\text{Comod}^H$  is just the category of G-graded vector spaces, then we may apply to  $\textsf{Comod}^H$  all the results of Sections [3](#page-10-1) and [4.](#page-26-0) By the reasons mentioned in [\(2\)](#page-45-2) and [\(3\)](#page-46-2) above, we cannot apply to  $\mathsf{Comod}^H$  the results of Sections [3,](#page-10-1) [4.3](#page-29-0) and [4.4](#page-33-0) for arbitrary H.

<span id="page-46-0"></span>5.7. Differential graded vector spaces. Let k be a field. Let  $dgVect_k$  be the category of differential Z-graded vector spaces (or dg-vector spaces for short) or, in another terminology, chain complexes in Vect<sub>k</sub>. Objects in dgVect<sub>k</sub> are families  $(V_n)_{n\in\mathbb{Z}}$  of vector spaces  $V_n$ equipped with linear maps  $d: V_n \to V_{n-1}$ ,  $n \in \mathbb{Z}$ , such that  $d^2 = 0$ . The maps d are called *differentials*. Every family  $(V_n)_{n\in\mathbb{Z}}$  can be identified with its Z-graded total space  $V = \bigoplus V_n$ . Moreover d extends to a graded linear map  $V \to V$  of degree (-1) such that n∈Z

 $d^2 = 0$ . Morphisms in  $dgVect_{\mathbb{k}}$  are grading preserving (= graded of degree 0) linear maps commuting with d. Note that  $dgVect_{\mathbf{k}}$  is an abelian category where limits and colimits are computed componentwise.

Let  $U = \bigoplus$  $k\bar{\in}\mathbb{Z}$  $U_k$  and  $V = \bigoplus$ m∈Z  $V_m$  be two dg-vector spaces. Then the monoidal product

$$
W = U \otimes V \text{ in } \mathbf{dgVect}_{\mathbb{k}} \text{ is defined by } W := \bigoplus_{n \in \mathbb{Z}} W_n \text{ where }
$$

$$
W_n := \bigoplus_{k \in \mathbb{Z}} U_k \otimes V_{n-k}.
$$

The differentials  $d: W_n \to W_{n-1}$  are defined by

 $d(u \otimes v) := du \otimes v + (-1)^k u \otimes dv$  for  $u \in U_k$  and  $v \in V_m$ ,  $k, m \in \mathbb{Z}$ .

The monoidal unit in  $dgVect_{\kappa}$  is k regarded as a chain complex concentrated in degree 0 with zero differential. The category  $dgVect_k$  is symmetric where the swap  $c: U_k \otimes V_m \widetilde{\to} V_m \otimes U_k$ is defined by  $c(u \otimes v) := (-1)^{km}v \otimes u$  for all  $u \in U_k$ ,  $v \in V_m$ ,  $k, m \in \mathbb{Z}$ .

Monoids in  $dgVect_{\mathbb{k}}$  are just unital associative differential graded algebras (or dg-algebras for short).

<span id="page-46-1"></span>**Theorem 5.23.** Let k be a field. Then  $dgVect_k$  is a symmetric closed monoidal category satisfying Properties  $1-10$  $1-10$ , [5a](#page-6-7) of Section [2.5](#page-6-0) and their duals. Moreover, all monomorphisms and epimorphisms in  $dgVect_{\mathbb{k}}$  are extremal and

- the functor  $(-)^*$  maps monomorphisms to epimorphisms;
- $\alpha_V$ ,  $\theta_{U,V}$ ,  $(\theta_{U,V}^{\text{inv}})^{\flat}$  are monomorphisms for any dg-vector spaces  $U, V$ ;
- $\varkappa_A$  is a monomorphism for every unital associative dg-algebra A.

*Proof.* Consider the Hopf algebra H over k with the basis  $c^k v^{\ell}$ , where  $k \in \mathbb{Z}$ ,  $\ell = 0, 1$ ,  $vc = -cv, v^2 = 0$ .  $\Delta v = c \otimes v + v \otimes 1$ ,  $\Delta c = c \otimes c$ ,  $Sc = c^{-1}$ ,  $Sv = -c^{-1}v$ . Then  $dgVect_{\mathbb{k}}$ 

<span id="page-47-20"></span>can be identified with  $\mathsf{Comod}^H$  where for every dg-vector space  $(V_m)_{m\in\mathbb{Z}}$  the structure of a right H-comodule on  $\bigoplus_{m\in\mathbb{Z}}V_m$  is given by  $\rho(a) := a\otimes c^{-m} + da\otimes vc^{-m}$  for  $a\in V_m$ ,  $m\in\mathbb{Z}$ , and if V is a right H-comodule, then  $V_m := \{a \in V \mid \lambda_m(a_{(1)})a_{(0)} = a\}$ ,  $da := \mu(a_{(1)})a_{(0)}$ . Here  $\lambda_m, \mu \in H^*$  are defined by  $\mu(c^k v^{\ell}) := \delta_{\ell_1}, \ \lambda_m(c^k v^{\ell}) := \delta_{k,-m} \delta_{\ell_0}$ . (Note that  $\mu^2 = 0$  and  $\lambda_{m-1}\mu=\mu\lambda_m.$ 

Recall that  $dgVect_k$  is closed. An explicit formula for  $[U, V]$  can be found e.g. in [\[6\]](#page-47-19), but the closedness of  $dgVect_{\mathbbk}$  follows from the above identification of  $dgVect_{\mathbbk}$  with Comod<sup>H</sup> too. For a dg-vector space V we obtain that  $V^* := [V, \Bbbk]$  consists of all linear functions  $V \to \Bbbk$ that are nonzero only on a finite number of components. Each monomorphism  $\varphi: U \to V$  in  $dgVect_{\mathbf{k}}$  is just an embedding of graded components compatible with the differentials. Since each linear function  $f \in U^*$  can be extended to a linear function that belongs to  $V^*$ , the map  $\varphi^*: V^* \to U^*$  is surjective, i.e. the functor  $(-)^*$  maps monomorphisms to epimorphisms.

The rest of the properties follow from Theorem [5.21.](#page-45-3)  $\Box$ 

*Remark* 5.24. By Theorem [5.23](#page-46-1) we may apply to the category  $C = dgVect_{\mathbf{k}}$  all the results of [\[5,](#page-47-0) Sections 4 and 5] and Sections [3](#page-10-1) and [4](#page-26-0) of the present paper.
