# Eccentricity and algebraic connectivity of graphs

#### Abstract

Let $G$ be a graph on $n$ nodes with algebraic connectivity $\lambda_{2}$. The eccentricity of a node is defined as the length of a longest shortest path starting at that node. If $s_{\ell}$ denotes the number of nodes of eccentricity at most $\ell$, then for $\ell \geq 2$,


$$
\lambda_{2} \geq \frac{4 s_{\ell}}{\left(\ell-2+\frac{4}{n}\right) n^{2}} .
$$

As a corollary, if $d$ denotes the diameter of $G$, then

$$
\lambda_{2} \geq \frac{4}{\left(d-2+\frac{4}{n}\right) n} .
$$

It is also shown that

$$
\lambda_{2} \geq \frac{s_{\ell}}{1+\ell\left(e\left(G^{\ell}\right)-m\right)},
$$

where $m$ and $e\left(G^{\ell}\right)$ denote the number of edges in $G$ and in the $\ell$-th power of $G$, respectively.

Let $G$ be a simple graph on $V=\left\{v_{1}, v_{2}, \ldots, v_{n}\right\}$ with $m$ edges $E$. The distance between nodes $v_{i}$ and $v_{j}$, denoted by $\operatorname{dist}\left(v_{i}, v_{j}\right)$, is the number of edges in a shortest path joining them. If there is no such path, then we define this value to be $\infty$. The diameter of $G$, denoted by $d$ is the maximum distance between any pair of nodes of $G$. The $\ell$-th power of $G$, denoted by $G^{\ell}$, is the graph with the same node set as $G$ such that two nodes are adjacent in $G^{\ell}$ if and only
if their distance is at most $\ell$ in $G$. The eccentricity of a node in $G$ is defined as the length of a longest shortest path starting at that node. We denote the number of nodes of eccentricity at most $\ell$ by $s_{\ell}$.

The Laplacian matrix of $G$ is defined as $L(G)=D-A$, where $A$ is the adjacency matrix of $G$ and $D$ is a diagonal degree matrix with $D(i, i)=\sum_{j} A(i, j)$. The smallest eigenvalue of $L(G)$ is 0 , where the corresponding eigenvector is the all one vector. The second smallest eigenvalue of $L(G)$, denoted by $\lambda_{2}$, is called the algebraic connectivity of $G$. It is easy to see that the number of nodes with degree $n-1$ is a lower bound for this parameter, that is,

$$
\lambda_{2} \geq s_{1}
$$

Also it is known that [1]

$$
\lambda_{2} \geq \frac{s_{2}}{n}
$$

Here it is shown that for $\ell \geq 3$,

$$
\begin{equation*}
\lambda_{2} \geq \frac{4 s_{\ell}}{\left(\ell-2+\frac{4}{n}\right) n^{2}} \tag{1}
\end{equation*}
$$

This result can be viewed as a generalization, with a slight improvement, of the well-known bound [3]: $\lambda_{2}(G) \geq \frac{4}{d n}$, as setting $\ell=d$ in (1) leads to $s_{d}=n$, and yields

$$
\lambda_{2} \geq \frac{4}{\left(d-2+\frac{4}{n}\right) n}
$$

It is also shown that

$$
\begin{equation*}
\lambda_{2} \geq \frac{s_{\ell}}{1+\ell\left(e\left(G^{\ell}\right)-m\right)} \tag{2}
\end{equation*}
$$

where $e\left(G^{\ell}\right)$ denotes the number of edges in $G^{\ell}$. This also generalizes the known result [2]:

$$
\lambda_{2} \geq \frac{n}{1+d e(\bar{G})} .
$$

## Proofs

Proof of (1). If $G$ is not connected, then $s_{\ell}=0$, and the statement holds trivially. Therefore, we assume that $G$ in connected. Let $\gamma=\left(\ell-2+\frac{4}{n}\right) \frac{n^{2}}{4}$. It is sufficient to show that $M=$
$\gamma L(G)-L\left(G^{\ell}\right)$ is positive semi-definite. Because if so, assuming that $z$ is the unit eigenvector corresponding to $\lambda_{2}$, we can deduce (1) as follows:

$$
\lambda_{2}=z^{T} L(G) z \geq \frac{1}{\gamma} z^{T} L\left(G^{\ell}\right) z \geq \frac{1}{\gamma} \lambda_{2}\left(G^{\ell}\right) \geq \frac{1}{\gamma} s_{1}\left(G^{\ell}\right)=\frac{1}{\gamma} s_{\ell} .
$$

Assume, to the contrary, that the minimum eigenvalue of $M$, denoted by $\mu$, is negative, and let $x=\left(x_{1}, x_{2}, \ldots, x_{n}\right)^{T}$ be an eigenvector corresponding to $\mu$. Since the all one vector is an eigenvector corresponding to eigenvalue 0 of $M$, we have $\sum_{i=1}^{n} x_{i}=0$. We may assume that

$$
x_{n} \leq x_{n-1} \leq \ldots \leq x_{1}
$$

For $k \in\{1,2, \ldots, n-1\}$, we define $E_{k}$ as the set of edges $v_{i} v_{j}$ in $G$ where $i \leq k<j$. Let $k$ be chosen such that

$$
\sum_{v_{i} v_{j} \in E_{k}}\left|x_{i}-x_{j}\right|
$$

is maximized, with the assumption that this sum equals 1 without loss of generality. So, in particular, every edge $v_{i} v_{j}$ in $G$ satisfies $\left|x_{i}-x_{j}\right| \leq 1$.

Let $S=\left\{v_{1}, v_{2}, \ldots, v_{k}\right\}$. For $r \geq 1$, we define $A_{r}$ as the set of nodes in $S$ whose shortest paths to $V \backslash S$ have length $r$. Similarly, $B_{r}$ is the set of nodes in $V \backslash S$ whose shortest paths to $S$ have length $r$.

If $\operatorname{dist}\left(v_{i}, v_{j}\right)=q$ for some $i \leq k<j$, then $v_{i} \in A_{r}$ and $v_{j} \in B_{r^{\prime}}$ for some $r, r^{\prime} \geq 1$ where $r+r^{\prime}=q+1$. Therefore,

$$
\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right): i \leq k<j}\left|x_{i}-x_{j}\right| \leq \sum_{r, r^{\prime} \geq 1: r+r^{\prime} \leq \ell+1} \sum_{v_{i} \in A_{r}, v_{j} \in B_{r^{\prime}}}\left(x_{i}-x_{j}\right)
$$

Let $r, r^{\prime} \geq 2$. Let $s$ be the smallest number such that $v_{s} \in A_{r-1}$ and $t$ be the largest number such that $v_{t} \in B_{r^{\prime}-1}$. We have

$$
\sum_{\substack{v_{i} \in A_{r} \\ v_{j} \in B_{r^{\prime}}}}\left(x_{i}-x_{j}\right) \leq \sum_{\substack{v_{i} \in A_{r} \\ v_{j} \in B_{r^{\prime}}}}\left(x_{s}-x_{t}\right)+\sum_{v_{i} \in A_{r}} \sum_{v_{j} \in B_{r^{\prime}}: j>t}\left(x_{t}-x_{j}\right)+\sum_{v_{j} \in B_{r^{\prime}}} \sum_{v_{i} \in A_{r}: i<s}\left(x_{i}-x_{s}\right) .
$$

There is a path $P$ of length $r-1$ from $v_{s}$ to a node in $V \backslash S$, and a path $P^{\prime}$ of length $r^{\prime}-1$ from $v_{t}$ to a node in $S$. Both paths $P$ and $P^{\prime}$ have an edge in $E_{k}$. Therefore, we conclude:

$$
x_{s}-x_{t} \leq \sum_{v_{i} v_{j} \in E(P) \cup E\left(P^{\prime}\right)}\left|x_{i}-x_{j}\right| \leq r+r^{\prime}-3 .
$$

Moreover, for each $v_{i} \in A_{r}$ with $i<s$, there is some edge $v_{i} v_{j}$ with $j \geq s$ in $G$. Consequently,

$$
\sum_{v_{i} \in A_{r}: i<s}\left(x_{i}-x_{s}\right) \leq \sum_{v_{i} v_{j} \in E_{s-1}}\left|x_{i}-x_{j}\right| \leq 1
$$

Similarly,

$$
\sum_{v_{j} \in B_{r^{\prime}}: j>t}\left(x_{t}-x_{j}\right) \leq \sum_{v_{i} v_{j} \in E_{t}}\left|x_{i}-x_{j}\right| \leq 1
$$

In consequence,

$$
\sum_{v_{i} \in A_{r}, v_{j} \in B_{r^{\prime}}}\left(x_{i}-x_{j}\right) \leq\left|A_{r}\right|\left|B_{r^{\prime}}\right|\left(r+r^{\prime}-3\right)+\left|A_{r}\right|+\left|B_{r^{\prime}}\right| .
$$

For each $v_{j} \in B_{1}$, let $v_{j^{\prime}}$ be the node adjacent to $v_{j}$ in a shortest path from $v_{s}$ to $v_{j}$. Also, denote by $P_{s j^{\prime}}$ a shortest path from $v_{s}$ to $v_{j^{\prime}}$. We then have:

$$
\begin{aligned}
\sum_{v_{i} \in A_{r}, v_{j} \in B_{1}}\left(x_{i}-x_{j}\right) & \leq \sum_{v_{j} \in B_{1}}\left(\sum_{v_{i} \in A_{r}}\left(x_{s}-x_{j}\right)+\sum_{v_{i} \in A_{r}: i<s}\left(x_{i}-x_{s}\right)\right) \\
& \leq\left|A_{r}\right| \sum_{v_{j} \in B_{1}}\left(\left(x_{s}-x_{j^{\prime}}\right)+\left(x_{j^{\prime}}-x_{j}\right)\right)+\left|B_{1}\right| \\
& \leq\left|A_{r}\right| \sum_{v_{j} \in B_{1}} \sum_{v_{a} v_{b} \in P_{s j^{\prime}}}\left|x_{a}-x_{b}\right|+\left|A_{r}\right| \sum_{v_{i} v_{j} \in E_{k}}\left|x_{i}-x_{j}\right|+\left|B_{1}\right| \\
& \leq\left|A_{r}\right|\left|B_{1}\right|(r-2)+\left|A_{r}\right|+\left|B_{1}\right| .
\end{aligned}
$$

Similarly,

$$
\sum_{v_{i} \in A_{1}, v_{j} \in B_{r^{\prime}}}\left(x_{i}-x_{j}\right) \leq\left|A_{1}\right|\left|B_{r^{\prime}}\right|(r-2)+\left|A_{1}\right|+\left|B_{r^{\prime}}\right|
$$

Let $A_{1}=\left\{v_{s_{1}}, v_{s_{2}}, \ldots, v_{s_{p}}\right\}$ and $B_{1}=\left\{v_{s_{p+1}}, v_{s_{p+2}}, \ldots, v_{s_{q}}\right\}$ where $s_{1}<s_{2}<\ldots<s_{q}$. Note that for $i=1,2, \ldots, q-1$, we have

$$
\left|E_{k} \cap E_{s_{i}}\right| \geq \min \{i, q-i\}
$$

as there are edges in $E_{k}$ with end nodes $v_{s_{1}}, v_{s_{2}}, \ldots, v_{s_{i}}$ if $i \leq p$, and $v_{s_{i+1}}, v_{s_{i+2}}, \ldots, v_{s_{q}}$ if $i \geq p+1$. Suppose the vector $y$ is obtained from $x$ by translation such that $y_{s_{[q / 2]}}$ becomes
zero. This lead to,

$$
\begin{aligned}
\sum_{v_{i} \in A_{1}, v_{j} \in B_{1}}\left(x_{i}-x_{j}\right)=\sum_{v_{i} \in A_{1}, v_{j} \in B_{1}}\left(y_{i}-y_{j}\right) \leq \sum_{i<j}\left|y_{s_{i}}-y_{s_{j}}\right| & =\frac{1}{2} \sum_{i=1}^{q} \sum_{j=1}^{q}\left|y_{s_{i}}-y_{s_{j}}\right| \\
& \leq \frac{1}{2} \sum_{i=1}^{q} \sum_{j=1}^{q}\left(\left|y_{s_{i}}\right|+\left|y_{s_{j}}\right|\right) \\
& =q \sum_{i=1}^{q}\left|y_{s_{i}}\right| \\
& =q\left(\sum_{i \leq q / 2} y_{s_{i}}-\sum_{i>q / 2} y_{s_{i}}\right) \\
& =q \sum_{i=1}^{q-1} \min \{i, q-i\}\left(y_{s_{i}}-y_{s_{i+1}}\right) \\
& \leq q \sum_{i=1}^{q-1}\left|E_{k} \cap E_{s_{i}}\right|\left(y_{s_{i}}-y_{s_{i+1}}\right) \\
& =q \sum_{v_{i} v_{j} \in E_{k}}\left|y_{i}-y_{j}\right| \leq q .
\end{aligned}
$$

Now, we can deduce that,
$\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right): i \leq k<j}\left|x_{i}-x_{j}\right| \leq\left|A_{1}\right|+\left|B_{1}\right|+\sum_{r, r^{\prime} \geq 1: 3 \leq r+r^{\prime} \leq \ell+1}\left(r+r^{\prime}-3\right)\left|A_{r}\right|\left|B_{r^{\prime}}\right|+\left|A_{r}\right|+\left|B_{r^{\prime}}\right|$.
The last term is bounded by the maximum possible value of

$$
a_{1}+b_{1}+\sum_{r, r^{\prime} \geq 1: 3 \leq r+r^{\prime} \leq \ell+1}\left(r+r^{\prime}-3\right) a_{r} b_{r^{\prime}}+a_{r}+b_{r^{\prime}}
$$

where $a_{r}, b_{r} \geq 0$ for each $r$, subject to the constraints $\sum_{r=1}^{\ell} a_{r}=k$ and $\sum_{r^{\prime}=1}^{\ell} b_{r^{\prime}}=n-k$. By fixing the $b_{r^{\prime}}$ values, this term reaches its maximum when $a_{t}=k$ for some $t$ and $a_{r}=0$ for $r \neq t$. Subsequently, after fixing the values for $a_{r}$ 's, the term is maximized when $b_{\ell-t+1}=n-k$ and $b_{r^{\prime}}=0$ for $r^{\prime} \neq \ell-t+1$. Therefore,

$$
\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right): i \leq k<j}\left|x_{i}-x_{j}\right| \leq(\ell-2) k(n-k)+n \leq(\ell-2) \frac{n^{2}}{4}+n=\gamma
$$

Now, if $e_{i} \in \mathbb{R}^{n}$ is the $i$-th standard basis vector, then

$$
\begin{aligned}
0 & \leq \gamma \sum_{v_{i} v_{j} \in E_{k}}\left|x_{i}-x_{j}\right|-\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right): i \leq k<j}\left|x_{i}-x_{j}\right| \\
& =\sum_{i \leq k}\left(\gamma \sum_{v_{i} v_{j} \in E: j>k}\left(x_{i}-x_{j}\right)-\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right): j>k}\left(x_{i}-x_{j}\right)\right) \\
& =\sum_{i \leq k}\left(\gamma \sum_{v_{i} v_{j} \in E}\left(x_{i}-x_{j}\right)-\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right)}\left(x_{i}-x_{j}\right)\right) \\
& =\left(e_{1}+e_{2}+\ldots+e_{k}\right)^{T} M x \\
& =\mu \sum_{i=1}^{k} x_{i} \\
& <0
\end{aligned}
$$

which is a contradiction. Therefore, the proof is now complete.

Proof of (2). We need to show that $\left(1+\ell\left(e\left(G^{\ell}\right)-m\right)\right) L(G)-L\left(G^{\ell}\right)$ is positive semi-definite. Consider a vector $x \in \mathbb{R}^{n}$, and let $v_{r} v_{s} \in E\left(G^{\ell}\right)$ be such that $\left|x_{r}-x_{s}\right|$ is maximum. Denote by $P$ a shortest path between $v_{r}$ and $v_{s}$. We then have:

$$
\begin{aligned}
x^{T} L\left(G^{\ell}\right) x & =\sum_{v_{i} v_{j} \in E\left(G^{\ell}\right)}\left(x_{i}-x_{j}\right)^{2} \\
& \leq x^{T} L(G) x+\left(e\left(G^{\ell}\right)-m\right)\left(x_{r}-x_{s}\right)^{2} \\
& \leq x^{T} L(G) x+\ell\left(e\left(G^{\ell}\right)-m\right) \sum_{v_{i} v_{j} \in P}\left(x_{i}-x_{j}\right)^{2} \\
& \leq\left(1+\ell\left(e\left(G^{\ell}\right)-m\right)\right) x^{T} L(G) x .
\end{aligned}
$$

This completes the proof.
