# ON LISSE NON-ADMISSIBLE MINIMAL AND PRINCIPAL W-ALGEBRAS

ABSTRACT. We discuss a possible generalization of a result by the third-named author on the rationality of non-admissible minimal W-algebras. We then apply this generalization to finding rational non-admissible principal W-algebras.

#### 1. INTRODUCTION

Let  $\mathfrak{g}$  be a simple Lie algebra, f a nilpotent element of  $\mathfrak{g}$ , and  $k \neq -h^{\vee}$  a non-critical number, where  $h^{\vee}$  is the dual Coxeter number of  $\mathfrak{g}$ . Let  $\mathcal{W}^k(\mathfrak{g}, f)$ and  $\mathcal{W}_k(\mathfrak{g}, f)$  denote the universal and simple *W*-algebras, respectively [KRW03]. The principal *W*-algebras  $\mathcal{W}^k(\mathfrak{g}) = \mathcal{W}^k(\mathfrak{g}, f_{prin})$  with principal nilpotent elements  $f = f_{prin}$  coincide with the W-algebras defined in [FF90].

It is one of the central problems in the study of W-algebras to classify lisse and rational simple W-algebras  $W_k(\mathfrak{g}, f)$ . Frenkel, Kac, and Wakimoto [FKW92] conjectured the existence and construction of *minimal series W-algebras*, that is, the lisse, rational principal W-algebras that generalize the minimal series Virasoro vertex algebras. The conjecture [FKW92] was proved by the first-named author [Ara15a, Ara15b]; The minimal series W-algebras are obtained by non-degenerate admissible affine vertex algebras through quantum Hamiltonian reduction. The conjecture of Frenkel, Kac, and Wakimoto was generalized by Kac and Wakimoto [KW08] to non-principal W-algebras. This was further generalized by the first named author [Ara15a] to a conjecture stating that each admissible affine vertex algebra produces exactly one lisse, rational W-algebra, by performing the quantum Hamiltonian reduction associated with the unique nilpotent orbit that is open in the associated variety [Ara12] of the admissible affine vertex algebra. At this point, it was believed that all lisse, rational W-algebras should be *admissible*, that is, they should come from admissible affine vertex algebras in this manner [KW08].

While the conjecture of Kac, Wakimoto, and the first named author was proved by [AvE23, Fas22, McR], the third-named author [Kaw18] showed that there exist in fact lisse, rational *non-admissible* W-algebras. More precisely, it was shown in [Kaw18] that for each member g of *Deligne's exceptional series* [Del96]

$$a_1 \subset a_2 \subset g_2 \subset d_4 \subset f_4 \subset e_6 \subset e_7 \subset e_8,$$

the minimal W-algebra  $\mathcal{W}_{-h^{\vee}/6}(\mathfrak{g}, f_{\theta})$  is lisse and rational, where  $h^{\vee}$  is the dual Coxeter number of  $\mathfrak{g}$ . For  $\mathfrak{g} = d_4, e_6, e_7, e_8$ , the level  $-h^{\vee}/6$  is a negative integer, and hence  $\mathcal{W}_{-h^{\vee}/6}(\mathfrak{g}, f_{\theta})$  is not at an admissible level.

After the work [Kaw18], it was shown in [AM18] that, for a member  $\mathfrak{g}$  of Deligne's exceptional series, the minimal W-algebra  $\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta})$  at level

(1) 
$$k(m) = -\frac{h^{\vee}}{6} + m$$

is lisse for all integer m that is equal to or greater than -1. Again, for  $\mathfrak{g} = d_4, e_6, e_7, e_8$ , the lisse W-algebra  $\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta})$  is not at an admissible level. Since  $\mathcal{W}_{k(-1)}(\mathfrak{g}, f_{\theta}) = \mathbb{C}$  [AM18] and  $\mathcal{W}_{k(0)}(\mathfrak{g}, f_{\theta})$  is rational [Kaw18] as explained above, it is natural to ask the following question.

**Question 1.** Let  $\mathfrak{g}$  be a simple Lie algebra of type  $d_4$ ,  $e_6$ ,  $e_7$ ,  $e_8$ , and let m be an integer greater than or equal to -1. Is the lisse minimal W-algebra  $\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta})$  is rational?

Sun [Sun] recently gave an affirmative answer<sup>1</sup> to Question 1 for m = 1 and  $\mathfrak{g} = e_6, e_7, e_8$ , by making use of Hecke operators.

**Conjecture 1.** Let  $\mathfrak{g}$ , m be as in Question 1. The simple minimal W-algebra  $\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta})$  is rational if and only if k(m) < 0, that is, m = -1, 0 for  $d_4$ , m = -1, 0, 1 for  $e_6$ , m = -1, 0, 1, 2 for  $e_7$  and m = -1, 0, 1, 2, 3, 4 for  $e_8$ .

In particular, we conjecture that, for  $\mathfrak{g} = d_4, e_6, e_7, e_8$ , the minimal W-algebra  $\mathcal{W}_k(\mathfrak{g}, f_\theta)$  is lisse and non-rational for a non-negative integer k, which would provide a new family of lisse *logarithmic* vertex algebras.

Let us mention that Conjecture 1 can be used to find new lisse, rational principal W-algebras as well, due to the following assertion.

**Theorem 1.1.** Let  $\mathfrak{g}$ , k(m), be as above with  $m \ge 0$  such that k(m) < 0. Define the number  $\ell(m)$  by

$$\frac{1}{k(m) + h^{\vee}} + \frac{1}{\ell(m) + h^{\vee}} = 1.$$

There is an embedding

$$\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta}) \otimes \mathcal{W}_{\ell(m)}(\mathfrak{g}) \hookrightarrow \mathcal{W}_{k(m-1)}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$$

of conformal vertex algebras, where  $L_1(\mathfrak{g})$  is equipped with the Urod conformal vector [ACF22]. Moreover,  $\mathcal{W}_{k(m)}(\mathfrak{g}, f_{\theta})$  and  $\mathcal{W}_{\ell(m)}(\mathfrak{g})$  form a dual pair in  $\mathcal{W}_{k(m-1)}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$ .

Here vertex subalgebras  $W_1$  and  $W_2$  of a vertex algebra V are said to form a dual pair if  $\text{Com}(W_1, V) = W_2$  and  $\text{Com}(W_2, V) = W_1$ , where

$$Com(W, V) = \{ w \in V \mid [v_{(m)}, w_{(n)}] = 0 \text{ for all } m, n \in \mathbb{Z}, v \in V \}.$$

The following assertion is widely believed.

**Conjecture 2.** Let V be a vertex algebra, W a vertex subalgebra of V. Suppose that V and W are finitely strongly generated, conformal, rational and lisse. Then Com(W, V) is also rational and lisse.

Theorem 1.1, Conjecture 2 and Conjecture 1 implies:

**Conjecture 3.** Let  $\mathfrak{g}$  be a simple Lie algebra of type  $d_4$ ,  $e_6$ ,  $e_7$ ,  $e_8$ , and let m be a non-negative integer. The simple principal W-algebra  $W_{\ell(m)}(\mathfrak{g})$  is rational and lisse if k(m) < 0.

Note that all the levels  $\ell$  appearing in Conjecture 3 (2) are not admissible for  $\hat{\mathfrak{g}}$ , see Table 1.

TABLE 1. The level of principal W-algebras  $\mathcal{W}_{\ell(m)}(\mathfrak{g})$  appearing in Conjecture 3

**Theorem 1.2.** Conjecture 3 is true for m = 0.

Theorem 1.2 was conjectured by [LXY23], see the first row of Table 11 in loc.cit and use the Feigin-Frenkel duality.

## 2. Proof of Theorem 2.1.

Let  $V^k(\mathfrak{g})$  be the universal affine vertex algebra associated to  $\mathfrak{g}$  at level k,  $L_k(\mathfrak{g})$  the unique simple graded quotient of  $V^k(\mathfrak{g})$ .

The central charge of the principal W-algebra  $\mathcal{W}^k(\mathfrak{g})$  is given by

(2) 
$$-\operatorname{rk}(\mathfrak{g})\frac{((h+1)(k+h^{\vee})-h^{\vee})(r^{\vee L}h^{\vee}(k+h^{\vee})-(h+1))}{k+h^{\vee}},$$

where  $\operatorname{rk}(\mathfrak{g})$  is the rank of  $\mathfrak{g}$ , h is the Coxeter number of  $\mathfrak{g}$ ,  ${}^{L}\mathfrak{g}^{\vee}$  is the dual Coxeter number of the Langlands dual of  $\mathfrak{g}$ , and  $r^{\vee}$  is the lacing number of  $\mathfrak{g}$ .

We set

$$\mathfrak{g} = d_4, e_6, e_7, e_8, \quad k = k(0) = -h^{\vee}/6, \quad \ell = \ell(0) = \frac{5h^{\vee}}{5h^{\vee} - 6} - h^{\vee}$$

Then, k = -1, -2, -3, -5 and  $\ell + h^{\vee} = 5/4, 10/9, 15/14, 25/24$ , respectively.

Let  $\operatorname{Vir}^{c}$  be the universal Virasoro vertex algebra at central charge c,  $\operatorname{Vir}_{c}$  the unique simple quotient of  $\operatorname{Vir}^{c}$ . It is known [Wan93] that  $\operatorname{Vir}_{c}$  is rational and lisse if and only if

$$c_{p,q} = 1 - \frac{6(p-q)^2}{pq}$$

for  $p, q \in \mathbb{Z}_{\geq 2}, (p, q) = 1$ .

It is clear that the following assertion proves Conjecture 3 for m = 0.

**Theorem 2.1.** Let  $\mathfrak{g}$  be a simple Lie algebra of type  $d_4$ ,  $e_6$ ,  $e_7$ ,  $e_8$ . We have

$$\mathcal{W}_{\ell(0)}(\mathfrak{g}) \cong \operatorname{Vir}_{c_{2.5}}$$

*Proof.* The central charge of  $W_{\ell}(\mathfrak{g})$  is -22/5, which coincides with that of  $\operatorname{Vir}_{c_{2,5}}$ . Thus we have a conformal vertex algebra homomorphism

$$\varphi: \operatorname{Vir}^{c_{2,5}} \to \mathcal{W}_{\ell}(\mathfrak{g}).$$

We wish to show that  $\operatorname{im} \varphi \cong \operatorname{Vir}_{c_{2,5}}$ . Since  $\operatorname{Vir}^{c_{2,5}}$  has length two, we have either  $\operatorname{im} \varphi \cong \operatorname{Vir}^{c_{2,5}}$  or  $\operatorname{im} \varphi \cong \operatorname{Vir}_{c_{2,5}}$ . So we suppose that  $\operatorname{im} \varphi \cong \operatorname{Vir}^{c_{2,5}}$  and obtain a contradiction.

By Theorem 1.1 and the fact that  $\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \cong \mathbb{C}$  ([AM18]), we have the embedding of vertex algebras

(3) 
$$\mathcal{W}_k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}_\ell(\mathfrak{g}) \hookrightarrow L_1(\mathfrak{g}),$$

which is conformal when  $L_1(\mathfrak{g})$  is equipped with the Urod conformal vector. By [Kaw18], one knows that the simple minimal W-algebra  $\mathcal{W}_k(\mathfrak{g}, f_\theta)$  is lisse and rational. In particular, it admits an asymptotic datum [AvEM]. Since changing the conformal vector to the Urod conformal vector does not affect the asymptotic behavior of the character, we obtain that

(4) 
$$\mathbf{g}_{L_1(\mathfrak{g})} \geq \mathbf{g}_{\mathcal{W}_k(\mathfrak{g}, f_\theta)} + \mathbf{g}_{\mathrm{Vir}^{c_{2,5}}} = \mathbf{g}_{\mathcal{W}_k(\mathfrak{g}, f_\theta)} + 1,$$

where  $\mathbf{g}_V$  denotes the asymptotic growth [AvEM] of V. Here we have used the fact that  $\mathbf{g}_{\text{Vir}^c} = 1$ .

By [Kaw18], one knows that there is an conformal embedding

$$\operatorname{Vir}_{c_{3,5}} \otimes L_1(\mathfrak{g})^{\mathfrak{s}[t]} \hookrightarrow \mathcal{W}_k(\mathfrak{g}, f_\theta),$$

where  $\mathfrak{s}$  is the  $\mathfrak{sl}_2$ -triple  $\langle e_{\theta}, \theta, f_{\theta} \rangle \subset \mathfrak{g}$  associated with the highest root  $\theta$  of  $\mathfrak{g}$  and  $L_1(\mathfrak{g})^{\mathfrak{s}[t]} = \{v \in L_1(\mathfrak{g}) \mid xt^n v = 0 \ \forall x \in \mathfrak{s}, n \geq 0\} = \operatorname{Com}(L_1(\mathfrak{s}), L_1(\mathfrak{g}))$ . It was shown in [Kaw18] that  $L_1(\mathfrak{g})^{\mathfrak{s}[t]}$  is rational and lisse by determining it explicitly. It follows that the vertex algebras  $\operatorname{Vir}_{c_{3,5}} \otimes L_1(\mathfrak{g})^{\mathfrak{s}[t]} \subset \mathcal{W}_k(\mathfrak{g}, f_{\theta})$  and  $L_1(\mathfrak{s}) \otimes L_1(\mathfrak{g})^{\mathfrak{s}[t]} \subset L_1(\mathfrak{g})$  are rational, and satisfy the assumptions in [AvEM, Proposition2.4]. Therefore, we have

(5) 
$$\mathbf{g}_{\mathrm{Vir}_{c_{3,5}}} + \mathbf{g}_{L_1(\mathfrak{g})^{\mathfrak{s}[t]}} = \mathbf{g}_{\mathcal{W}_k(\mathfrak{g}, f_\theta)},$$

(6) 
$$\mathbf{g}_{L_1(\mathfrak{s})} + \mathbf{g}_{L_1(\mathfrak{g})^{\mathfrak{s}[t]}} = \mathbf{g}_{L_1(\mathfrak{g})}$$

On the other hand, one knows form [BFL16] that  $L_1(\mathfrak{s}) = L_1(\mathfrak{sl}_2)$  with a Urod conformal vector is a conformal extension of  $\operatorname{Vir}_{c_{2.5}} \otimes \operatorname{Vir}_{c_{3.5}}$ . Hence we have

(7) 
$$\mathbf{g}_{\operatorname{Vir}_{c_{2,5}}} + \mathbf{g}_{\operatorname{Vir}_{c_{3,5}}} = \mathbf{g}_{L_1(\mathfrak{s})}.$$

From (5), (6), and (7), we obtain that

$$\mathbf{g}_{L_1(\mathbf{\mathfrak{g}})} = \mathbf{g}_{\mathcal{W}_k(\mathbf{\mathfrak{g}}, f_\theta)} + \mathbf{g}_{\mathrm{Vir}_{c_{2,5}}}.$$

But then (4) implies that  $1 \leq \mathbf{g}_{\operatorname{Vir}_{c_{2,5}}} = 1 - \frac{6}{2 \cdot 5}$ , which is a contradiction.

We have shown that  $\operatorname{im} \varphi \cong \operatorname{Vir}_{c_{2,5}}$ , and thus,  $\mathcal{W}_{\ell}(\mathfrak{g})$  decomposes into a direct sum of simple  $\operatorname{Vir}_{c_{2,5}}$ -modules. However,  $\operatorname{Vir}_{c_{2,5}}$  is the only simple module over itself that has an integral conformal dimension. Therefore, we conclude that  $\mathcal{W}_{\ell}(\mathfrak{g}) \cong$  $\operatorname{Vir}_{c_{2,5}}$  as required.  $\Box$ 

Remark 2.1. Let us consider  $\mathfrak{g} = a_1, a_2$  with  $\ell + h^{\vee} = 5h^{\vee}/(5h^{\vee} - 6) = 5/2, 5/3,$  $\mathfrak{g} = g_2$  with  $\ell + 4 = 7/15$  or 5/7 and  $\mathfrak{g} = f_4$  with  $\ell + 9 = 13/20$  or 10/13. Then we can also prove  $W_{\ell}(\mathfrak{g}) \cong \operatorname{Vir}_{c_{2,5}}$  by using growths of characters since in these cases,  $W_{\ell}(\mathfrak{g})$  are rational minimal models ([Ara15b]) and their characters are already known. We thus observe a uniform phenomenon that  $W_{\ell}(\mathfrak{g}) \cong \operatorname{Vir}_{c_{2,5}}$  for the Deligne exceptional series.

#### 3. LINKAGE OF PRINCIPAL W-ALGEBRAS

For a weight  $\lambda$  of  $\hat{\mathfrak{g}}$ , let  $M(\lambda)$  be the Verma module of  $\hat{\mathfrak{g}}$  if highest weight  $\lambda$ ,  $L(\lambda)$  the unique simple quotient of  $M(\lambda)$ . Let  $[M(\lambda) : L(\mu)]$  be the multiplicity of  $L(\lambda)$  in the local composition factor of  $M(\lambda)$ . By [KK79],  $[M(\lambda) : L(\mu)] \neq 0$  if and only if  $\mu \leq \lambda$ , that is, there exists a sequence  $\{\beta_i\}$  of positive roots of  $\hat{\mathfrak{g}}$ , a sequence  $\{n_i\}$  of positive integers and a sequence of weights  $\{\lambda_i\}$  such that  $\lambda_0 = \lambda$ ,  $\lambda_r = \mu$ ,  $\lambda_i = \lambda_{i-1} - n_i\beta_i$ ,  $2(\beta_i, \lambda_{i-1} + \hat{\rho}) = n_i(\beta_i, \beta_i)$ .

Let us describe the linkage of principal W-algebras obtained in [Ara07], see also [Dhi21]. Recall that the Zhu algebra  $\operatorname{Zhu}(W^k(\mathfrak{g}))$  is isomorphic to the center  $\mathcal{Z}(\mathfrak{g})$  of  $U(\mathfrak{g})$  ([Ara07]). For  $\lambda \in \mathfrak{h}^*$ 

$$\chi_{\lambda}: \operatorname{Zhu}(\mathcal{W}^k(\mathfrak{g})) = \mathcal{Z}(\mathfrak{g}) \to \mathbb{C}$$

be the central character as in [ACL19, (27)], so that

(8) 
$$\chi_{\lambda} = \chi_{\mu} \iff \mu \in W \circ_k \lambda,$$

where W is a Weyl group of  $\mathfrak{g}$  and

(9) 
$$w \circ_k \lambda = w(\lambda + \rho - (k + h^{\vee})\rho^{\vee}) - (\rho - (k + h^{\vee})\rho^{\vee})$$

for  $w \in W$ . Here,  $\rho = 1/2 \sum_{\alpha \in \Delta_+} \alpha$ ,  $\rho^{\vee} = 1/2 \sum_{\alpha \in \Delta_+} \alpha^{\vee}$ , and  $\Delta_+$  is the set of positive roots of  $\mathfrak{g}$ .

Let  $\mathbf{M}_k(\chi_{\lambda})$  be the Verma module of  $\mathcal{W}^k(\mathfrak{g})$  with highest weight  $\chi_{\lambda}$ ,  $\mathbf{L}_k(\chi_{\lambda})$  the unique simple graded quotient of  $\mathbf{M}_k(\chi_{\lambda})$ , see [Ara07] for the definition. We have  $\mathcal{W}_k(\mathfrak{g}) \cong \mathbf{L}_k(\chi_0)$ .

Let  $k \neq -h^{\vee}$ , so that  $\mathcal{W}^k(\mathfrak{g})$  is conformal. Let  $\omega_W$  be the conformal vector of  $\mathcal{W}^\ell(\mathfrak{g})$  and set  $L^W(z) = \sum_{n \in \mathbb{Z}} L_n^W z^{-n-2} = Y(\omega_W, z)$ . Let  $M_d^{gen}$  and  $M_d$  be the generalized  $L_0^W$ -eigenspace and the  $L_0^W$ -eigenspace of eigenvalue d of a  $\mathcal{W}^\ell(\mathfrak{g})$ module M, respectively.

We have  $\mathbf{M}_{k}(\chi_{\lambda}) = \bigoplus_{d \in h_{\lambda} + \mathbb{Z}_{\geq 0}} \mathbf{M}_{k}(\chi_{\lambda})_{d}$  and

$$\operatorname{tr}_{\mathbf{M}_{k}(\chi_{\lambda})} q^{L_{0}^{W}} = \frac{q^{h_{\lambda}}}{\prod_{j \ge 1} (1 - q^{j})^{\operatorname{rk} \mathfrak{g}}},$$

where

(10) 
$$h_{\lambda} = \Delta_{\lambda} - (\lambda | \rho^{\vee}), \quad \Delta_{\lambda} = \frac{(\lambda | \lambda + 2\rho)}{2(k + h^{\vee})}.$$

Let  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g}))$  be the full subcategory of the category of  $\mathcal{W}^k(\mathfrak{g})$ -modules consisting of modules M such that  $M = \bigoplus_d M_d^{gen}$ ,  $\dim M_d^{gen} < \infty$  for all d, and there exists finitely many  $d_1, \ldots, d_r \in \mathbb{C}$  such that  $M_d^{gen} = 0$  unless  $d \in \bigcup_i d_i + \mathbb{Z}_{\geq 0}$ . Both  $\mathbf{M}_k(\chi_\lambda)$  and  $\mathbf{L}_k(\chi_\lambda)$  are objects of  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g}))$ , and  $\{\mathbf{L}_k(\chi_\lambda) \mid \lambda \in \mathfrak{h}^*/W \circ_k\}$ gives a complete representative of simple objects of the abelian category  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g}))$ . Let  $[\mathbf{M}_k(\chi_\lambda) : \mathbf{L}_k(\chi_\mu)]$  be the multiplicity of  $\mathbf{L}_k(\chi_\mu)$  in the local composition factor of  $\mathbf{M}_k(\chi_\lambda)$ .

We define a partial ordring  $\leq_k$  on the set  $\mathfrak{h}^*/W \circ_k = \operatorname{Specm}(\operatorname{Zhu}(\mathcal{W}^k(\mathfrak{g})))$  by setting  $\chi_{\mu} \leq_k \chi_{\lambda}$  if and only if there exist  $\lambda' \in W \circ_k \lambda$ ,  $\mu' \in W \circ_k \mu$  such that  $\mu'$  is anti-dominat and

$$\mu' - (k+h^{\vee})\rho^{\vee} + k\Lambda_0 - \Delta_{\mu' - (k+h^{\vee})\rho^{\vee}}\delta \preceq \lambda' - (k+h^{\vee})\rho^{\vee} + k\Lambda_0 - \Delta_{\lambda' - (k+h^{\vee})\rho^{\vee}}\delta.$$

Note that

(11) 
$$h_{\lambda} = \Delta_{\lambda - (k+h^{\vee})\rho^{\vee}} + (\rho|\rho^{\vee}) - \frac{k+h^{\vee}}{2}|\rho^{\vee}|^2.$$

The following assertion is a direct consequence of [Ara07, Main Theorem 1] and the linkage principal of  $\hat{\mathfrak{g}}$ -modules [KK79].

**Theorem 3.1.** For  $\lambda, \mu \in \mathfrak{h}^*$  the following conditions are equivalent.

- (1)  $[\mathbf{M}_k(\chi_\lambda) : \mathbf{L}_k(\chi_\mu)] \neq 0;$
- (2)  $\chi_{\mu} \preceq_k \chi_{\lambda}$ .

Define an equivalence relation  $\sim_k$  in  $\lambda \in \mathfrak{h}^*/W \circ$  by setting  $\chi_{\lambda} \sim \chi_{\lambda'}$  if there exists  $\mu \in \mathfrak{h}^*$  such that  $\chi_{\lambda}, \chi_{\lambda'} \preceq_k \chi_{\mu}$  or  $\chi_{\lambda}, \chi_{\lambda'} \succeq_k \chi_{\mu}$ .

For  $\lambda \in \mathfrak{h}^*/W\circ$ , let  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g}))^{[\chi_\lambda]}$  be the block corresponding to  $[\chi_\lambda]$ , that is the full suncategory of  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g}))$  consisting of objects M such that  $[M : \mathbf{L}_k(\chi_\mu)] = 0$  unless  $\chi_\mu \sim \chi_\lambda$ . Then we have  $\mathcal{O}(\mathcal{W}^k(\mathfrak{g})) = \bigoplus_{[\chi_\lambda]} \mathcal{O}(\mathcal{W}^k(\mathfrak{g}))^{[\chi_\lambda]}$ . For  $M \in \mathcal{O}(\mathcal{W}^k(\mathfrak{g}))$ , let  $M = \bigoplus M^{[\chi_\lambda]}$  be the corresponding decomposition.

#### 4. Proof of Theorem 1.1

**Theorem 4.1.** Let  $V = \bigoplus_{d \ge 0} V_d$  be a non-negatively graded conformal vertex algebra with  $V_0 = \mathbb{C}$ , dim  $V_d < \infty$  for all d, equipped with a non-degenerate symmetric invariant bilinear form (| ) in the sense of [FHL93]. Suppose that V is equipped with a compatible  $\hat{\mathfrak{g}}$ -structure [FBZ04, 7.1.3] with level  $k \notin -h^{\vee} - \mathbb{Q}_{\le 0}$ , that is, there exists a vertex algebra homomorphism  $\varphi : V^k(\mathfrak{g}) \to V$  such that

- (1)  $\varphi(x_{(-1)}|0\rangle)$  is primary of conformal weight 1 for all  $x \in \mathfrak{g}$ ;
- (2)  $k + h^{\vee} \notin \mathbb{Q}_{\leq 0}$ .

Then the commutant  $\operatorname{Com}(\varphi(V^k(\mathfrak{g}), V)) = V^{\mathfrak{g}[t]}$  is simple.

Proof. Set  $U = \text{Com}(\varphi(V^k(\mathfrak{g}), V))$  and  $L_n = \omega_{(n+1)}$ , where  $\omega$  is the conformal vector of V. By the assumption (2),  $V^k(\mathfrak{g})$  is conformal with the Sugawara conformal vector  $\omega_{\mathfrak{g}}$ . Set  $L_n^{\mathfrak{g}} = \varphi(\omega_{\mathfrak{g}})_{(n+1)}$ . By the assumption (1),  $\omega_{\mathfrak{g}} \in V_2$  and  $L_1\varphi(\omega_{\mathfrak{g}}) = 0$ . Hence by [LL04, Theorem 3.11.12 and Remark 3.11.13],  $L_n = L_n^{\mathfrak{g}}$  on  $\varphi(V^k(\mathfrak{g}))$  and  $L_n = \omega''_{(n+1)}$  on U, where  $\omega'' = \omega - \omega^{\mathfrak{g}}$  is the conformal vector of U. It follows that the form ( | ) restricts to a symmetric invariant bilinear form of U.

Now since V is non-negatively graded and each  $V_d$  is finite-dimensional, V belongs to  $\mathrm{KL}_k$  as a  $\widehat{\mathfrak{g}}$ -module. Also, by the assumption (2), the  $\widehat{\mathfrak{g}}$ -module  $V^k(\mathfrak{g})$  is projective in  $\mathrm{KL}_k$  and we have

$$\operatorname{Hom}_{\widehat{\mathfrak{g}}}(V^k(\mathfrak{g}), M) = M_{[0]} = M_{[0]}^{ger}$$

for  $M \in \mathrm{KL}_k$ , where  $M_{[\lambda]}$  and  $M_{[\lambda]}^{gen}$  are the  $L_0^{\mathfrak{g}}$ -eigenspace and the  $L_0^{\mathfrak{g}}$ -generalized eigenspace of M of eigenvalue  $\lambda$ , respectively, see e.g. [ACL19, Lemma 2.1]. Therefore  $U = V^{\mathfrak{g}} \cong \mathrm{Hom}_{\widehat{\mathfrak{g}}}(V^k(\mathfrak{g}), V)$  equals to  $V_{[0]} \subset V$ . Since  $(L_0^{\mathfrak{g}}v, w) = (v, L_0^{\mathfrak{g}}w)$ , the restriction of the form (| ) to  $U = V_{[0]}$  is non-generate. This implies that U is simple as required.

**Theorem 4.2** ([ACL19]). Let  $\mathfrak{g}$  be simply-laced. Assume that  $k + h^{\vee} - 1 \notin \mathbb{Q}_{\leq 0}$ , and define  $\ell$  by the formula

$$\frac{1}{k+h^{\vee}} + \frac{1}{\ell+h^{\vee}} = 1.$$

 $\mathbf{6}$ 

Then we have a vertex algebra isomorphism

(12)  $\mathcal{W}^{\ell}(\mathfrak{g}) \cong \operatorname{Com}(V^{k}(\mathfrak{g}), V^{k-1}(\mathfrak{g}) \otimes L_{1}(\mathfrak{g})) = (V^{k-1}(\mathfrak{g}) \otimes L_{1}(\mathfrak{g}))^{\mathfrak{g}[t]}.$ 

Hence we have a conformal embedding

(13)  $V^k(\mathfrak{g}) \otimes \mathcal{W}^\ell(\mathfrak{g}) \hookrightarrow V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}).$ 

The following assertion gives a generalization of [ACL19, Main Theorem 1].

**Theorem 4.3.** Let  $\mathfrak{g}$  be simply-laced and suppose that  $k + h^{\vee} - 1 \notin \mathbb{Q}_{\leq 0}$ . Then

$$\mathcal{W}_{\ell}(\mathfrak{g}) \cong (L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))^{\mathfrak{g}[t]}$$

In particular, (13) induces a vertex algebra homomorphism

(14) 
$$V^k(\mathfrak{g}) \otimes \mathcal{W}_\ell(\mathfrak{g}) \to L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}).$$

Proof. First,  $L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$  is a simple conical conformal vertex algebra with conformal vector  $\omega = \omega^{\mathfrak{g}} \otimes 1 + 1 \otimes \omega^{\mathfrak{g}}$ . Since  $\omega_{(2)}$  annihilates the weight one space of  $L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}), L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$  is equipped with a non-degenerate invariant symmetric bilinear form ([Li94]). Hence we immediately obtain from Theorem 4.1 that the vertex algebra  $(L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))^{\mathfrak{g}[t]} = \operatorname{Com}(\varphi(V^k(\mathfrak{g})), L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))$  is simple, where  $\varphi: V^k(\mathfrak{g}) \to L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$  is induced by the diagonal action of  $\widehat{\mathfrak{g}}$ on  $L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$ .

On the other hand, we have by Theorem 4.2 that  $W^{\ell}(\mathfrak{g}) \cong (V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))^{\mathfrak{g}[t]} \cong$ Hom<sub> $\hat{\mathfrak{g}}$ </sub> $(V^k(\mathfrak{g}), V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))$ . The projectively of  $V^k(\mathfrak{g})$  (see the proof of Theorem 4.1) implies that the surjection  $V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}) \to L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$  gives rise to the surjection  $W^{\ell}(\mathfrak{g}) \twoheadrightarrow \operatorname{Hom}_{\widehat{\mathfrak{g}}}(V^k(\mathfrak{g}), L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})) \cong (L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))^{\mathfrak{g}[t]}$ . It follows that  $(L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}))^{\mathfrak{g}[t]}$  is isomorphic to the simple quotient  $W_{\ell}(\mathfrak{g})$  of  $W^{\ell}(\mathfrak{g})$ .

Let  $T_{\lambda,0}^{\ell} = H_{DS,f_{prin}}^{0}(V^{k}(\lambda))$ , where  $V^{k}(\lambda)$  is the Weyl module of  $\hat{\mathfrak{g}}$  with highest weight  $\lambda + k\Lambda_{0}$  and  $H_{DS,f}^{0}(?)$  is the quantized Drinfeld-Sokolov reduction associated with f. We have  $T_{\lambda,0}^{\ell} = \bigoplus_{d \in h_{\lambda} + \mathbb{Z}_{\geq 0}} (T_{\lambda,0}^{\ell})_{[d]_{W}}$ , and  $[T_{\lambda,0}^{\ell} : \mathbf{L}(\chi_{\mu})] \neq 0$  only if  $[\mathbf{M}(\chi_{\lambda}) : \mathbf{L}(\chi_{\mu})] \neq 0$ , or equivalently,  $\chi_{\mu} \leq_{\ell} \chi_{\lambda}$ , see [AF19].

By [ACL19, Main Theorem 3] and its proof, we have the following assertion.

**Proposition 4.1.** Suppose that  $k + h^{\vee} - 1 \notin \mathbb{Q}_{\leq 0}$ . We have

$$[V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})] = \sum_{\lambda \in P_+ \cap Q} [V^k(\lambda) \otimes T^{\ell}_{\lambda,0}]$$

in the Grothendieck group  $K_0(V^k(\mathfrak{g})\otimes W^\ell(\mathfrak{g}) \operatorname{-mod})$  of the category  $V^k(\mathfrak{g})\otimes W^\ell(\mathfrak{g}) \operatorname{-mod}$ of  $V^k(\mathfrak{g})\otimes W^\ell(\mathfrak{g})$ -modules.

**Theorem 4.4.** Let  $\mathfrak{g}$  be simply-laced,  $k + h^{\vee} - 1 \notin \mathbb{Q}_{\leq 0}$ . Suppose that if  $\chi_{\lambda} \sim_{\ell} \chi_{0}$  for  $\lambda \in P_{+} \cap Q$  then  $h_{\lambda} \geq h_{0} = 0$  and the equality holds if and only if  $\lambda = 0$ . Then the vertex algebra homomorphism (14) factors through the embedding

(15) 
$$L_k(\mathfrak{g}) \otimes \mathcal{W}_\ell(\mathfrak{g}) \hookrightarrow L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$$

Moreover,  $L_k(\mathfrak{g})$  and  $W_\ell(\mathfrak{g})$  form a dual pair in  $L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$ .

*Proof.* Set  $V = V^{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g}), L = L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})$ . The action of the Sugawara conformal vector of  $V^k(\mathfrak{g})$  gives the decomposition  $V = \bigoplus_{d \in \mathbb{C}} V_{[d]}, L = \bigoplus_{d \in \mathbb{C}} L_{[d]}$ , where  $M_{[d]}$  is the generalized  $L_0^{\mathfrak{g}}$  -eigenspace with eigenvalue d. Each  $V_{[d]}$  and  $L_{[d]}$ 

are  $\mathcal{W}^{\ell}(\mathfrak{g})$ -submodules, which belongs to  $\mathcal{O}(\mathcal{W}^{\ell}(\mathfrak{g}))$  by Proposition 4.1. Hence the multiplicities  $[V_{[d]} : \mathbf{L}_{\ell}(\chi_{\mu})]$  and  $[L_{[d]} : \mathbf{L}_{\ell}(\chi_{\mu})]$  are well-defined.

Consider the multiplicity of  $W_{\ell}(\mathfrak{g}) = \mathbf{L}_{\ell}(\chi_0)$  in  $V_d$ . By the assumption, for  $\lambda \in P_+ \cap Q$ ,  $[T_{\lambda,0}^{\ell} : \mathbf{L}_{\ell}(\chi_0)] \neq 0$  if only if  $\lambda = 0$ . Since  $[T_{0,0}^{\ell} : \mathbf{L}_{\ell}(\chi_0)] = 1$ , it follows from Proposition 4.1 that  $[V_{[d]} : \mathbf{L}_{\ell}(\chi_0)] \leq \dim_{\mathbb{C}} V^k(\mathfrak{g})_{[d]}$ . On the other hand, the injectivity of the map (13) implies that  $[V_{[d]} : \mathbf{L}_{\ell}(\chi_0)] \geq \dim_{\mathbb{C}} V^k(\mathfrak{g})_{[d]}$ . We conclude that

(16) 
$$[V_{[d]}: \mathbf{L}_{\ell}(\chi_0)] = \dim_{\mathbb{C}} V^k(\mathfrak{g})_{[d]}$$

for all d.

Consider the image  $V_{[d]}^{[\chi_0]}$  of the projection of  $V_{[d]}$  to the block  $\mathcal{O}(\mathcal{W}^{\ell}(\mathfrak{g}))^{[\chi_0]}$ ,  $V^{[\chi_0]} = \bigoplus_d V_{[d]}^{[\chi_0]}$ . By the assumption, we have  $\dim(V_{[d]}^{[\chi_0]})_{[0]_W}^{gen} = [V_{[d]} : \mathbf{L}_{\ell}(\chi_0)]$ . Since  $L_0^W$  acts semisimply on the image of (13), we obtain from (16) that

$$(V^{[\chi_0]})^{gen}_{[0]_W} = (V^{[\chi_0]})_{[0]_W} \cong V^k(\mathfrak{g}).$$

It follows that

$$(L^{[\chi_0]})_{[0]_W}^{gen} = (L^{[\chi_0]})_{[0]_W},$$

where  $L^{[\chi_0]} = \bigoplus_d L^{[\chi_0]}_{[d]}$ .

Clearly, the restriction of the non-degenerate invariant form of L to the subspace  $(L^{[\chi_0]})_{[0]_W}^{gen}$  is non-degenerate. Since it is a quotient of  $V^k(\mathfrak{g}_0)$ , we obtain that

$$(L^{[\chi_0]})^{gen}_{[0]_W} \cong L_k(\mathfrak{g}).$$

In other words, the image of the homomorphism  $V^k(\mathfrak{g}) \to L$  induced by the diagonal action of  $\widehat{\mathfrak{g}}$  is simple. We have shown that the vertex algebra homomorphism (14) factors through the embedding  $L_k(\mathfrak{g}) \otimes \mathcal{W}_\ell(\mathfrak{g}) \hookrightarrow L$ .

Finally, we have

$$\operatorname{Com}(\mathcal{W}_{\ell}(\mathfrak{g}), L) \cong \operatorname{Hom}_{\mathcal{W}^{\ell}(\mathfrak{g})}(\mathcal{W}^{\ell}(\mathfrak{g}), L) = \operatorname{Hom}_{\mathcal{W}^{\ell}(\mathfrak{g})}(\mathcal{W}^{\ell}(\mathfrak{g}), L^{[\chi_{0}]}) \cong (L^{[\chi_{0}]})_{[0]_{W}},$$

where the last isomorphism follows from the assumption. Therefore we obtain that  $\operatorname{Com}(\mathcal{W}_{\ell}(\mathfrak{g}), L) \cong L_k(\mathfrak{g})$ , and this completes the proof.  $\Box$ 

**Theorem 4.5** ([ACF22]). Let f be a nilpotent element of  $\mathfrak{g}$  and n a non-negative integer. For any quotient vertex algebra V of  $V^k(\mathfrak{g})$ , we have a vertex algebra isomorphism

$$H^0_{DS,f}(V \otimes L_n(\mathfrak{g})) \cong H^0_{DS,f}(V) \otimes L_n(\mathfrak{g}).$$

Moreover, for any V-module M and  $L_n(\mathfrak{g})$ -module N, there is an isomorphism

$$H^i_{DS,f}(M\otimes N)\cong H^i_{DS,f}(M)\otimes N$$

of  $H^0_{DS,f}(V) \otimes L_n(\mathfrak{g})$ -modules for all  $i \in \mathbb{Z}$ .

**Theorem 4.6.** Let g be simply-laced. Suppose

- (1)  $k \notin \mathbb{Z}_{>0}, k+h^{\vee}-1 \notin \mathbb{Q}_{<0};$
- (2) if  $\chi_{\lambda} \sim_{\ell} \chi_0$  for  $\lambda \in P_+ \cap Q$  then  $h_{\lambda} \ge h_0 = 0$  and the equality holds if and only if  $\lambda = 0$ ;
- (3)  $2\rho (k+h^{\vee})\theta \in \sum_{\alpha \in \Delta_+} \mathbb{R}_{\geq 0} \alpha.$

Then the map (14) induces an embedding

(17) 
$$\mathcal{W}_k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}_\ell(\mathfrak{g}) \hookrightarrow \mathcal{W}_{k-1}(\mathfrak{g}, f_\theta) \otimes L_1(\mathfrak{g})$$

of vertex algebras. Moreover,  $W_k(\mathfrak{g}, f_{\theta})$  and  $W_{\ell}(\mathfrak{g})$  form a dual pair in  $W_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$ .

*Proof.* By [Ara05], the functor  $H^0_{DS,f_{\theta}}(?)$  is exact and  $H^0_{DS,f_{\theta}}(L_k(\mathfrak{g})) \cong \mathcal{W}_k(\mathfrak{g},f_{\theta})$  provided that  $k \notin \mathbb{Z}_{\geq 0}$ . Therefore by applying  $H^0_{DS,f_{\theta}}(?)$  to (14) with respect to the level k action of  $\hat{\mathfrak{g}}$ , we obtain an embedding

(18) 
$$\mathcal{W}_k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}_\ell(\mathfrak{g}) \hookrightarrow H^0_{DS, f_\theta}(L_{k-1}(\mathfrak{g}) \otimes L_1(\mathfrak{g})) \cong \mathcal{W}_{k-1}(\mathfrak{g}, f_\theta) \otimes L_1(\mathfrak{g}),$$

where the last isomorphism follows from Theorem 4.5. Also, the proof of Theorem 4.4 shows that

$$\operatorname{Com}(\mathcal{W}_{k}(\mathfrak{g}), \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g})) \cong \operatorname{Hom}(\mathcal{W}^{\ell}(\mathfrak{g}), \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))$$
$$\cong (\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))_{[0]_{W}}^{[\chi_{0}]} \cong H^{0}_{DS, f_{\theta}}((V_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))_{[0]_{W}}^{[\chi_{0}]})$$
$$\cong H^{0}_{DS, f_{\theta}}(L_{k}(\mathfrak{g})) \cong \mathcal{W}_{k}(\mathfrak{g}, f_{\theta}).$$

It remains to show that

(19) 
$$\operatorname{Com}(\mathcal{W}_{\ell}(\mathfrak{g}, f_{\theta}), \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g})) \cong \mathcal{W}_{\ell}(\mathfrak{g}).$$

Note that  $\operatorname{Com}(\mathcal{W}_{\ell}(\mathfrak{g}, f_{\theta}), \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g})) \cong \operatorname{Hom}_{\mathcal{W}^{k}(\mathfrak{g}, f_{\theta})}(\mathcal{W}^{k}(\mathfrak{g}, f_{\theta}), \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g})).$ 

Similarly as in (18), the map (13) induces an embedding

(20) 
$$\mathcal{W}^k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}^\ell(\mathfrak{g}) \hookrightarrow \mathcal{W}^{k-1}(\mathfrak{g}, f_\theta) \otimes L_1(\mathfrak{g})$$

and hence we can regard  $W^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$  as a  $W^k(\mathfrak{g}, f_{\theta})$ -module. Clearly, each eigenspace  $(W^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[d]_{min}}$  is a  $W^{\ell}(\mathfrak{g})$ -submodule.

Let  $\omega_{min}$  be the conformal vector of the minimal W-algebra  $\mathcal{W}^k(\mathfrak{g}, f_{\theta}), L^{min}(z) = \sum_{n \in \mathbb{Z}} L_n^{min} z^{-n-2} = Y(\omega_{min}, z)$ . Let  $M_{[d]_{min}}^{gen}$  and  $M_{[d]_{min}}$  be the generalized  $L_0^{min}$ -eigenspace and the  $L_0^{min}$ -eigenspace of eigenvalue d of a  $\mathcal{W}^k(\mathfrak{g}, f_{\theta})$ -module M. We claim that

(21) 
$$\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}) = \bigoplus_{d \ge 0} (\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[d]_{min}}^{gen},$$

(22) 
$$(\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen} = (\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}} \cong \mathcal{W}^{\ell}(\mathfrak{g}).$$

To see this, note that by Proposition 4.1

$$[\mathbb{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g})] = \sum_{\lambda \in P_{+} \cap Q} [H^{0}_{DS, f_{\theta}}(V^{k}(\lambda)) \otimes T^{\ell}_{\lambda, 0}]$$

in the Grothendieck group  $K_0(\mathcal{W}^k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}^{\ell}(\mathfrak{g}) \operatorname{-mod})$  of the category  $\mathcal{W}^k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}^{\ell}(\mathfrak{g})$ -mod of  $\mathcal{W}^k(\mathfrak{g}, f_\theta) \otimes \mathcal{W}^{\ell}(\mathfrak{g})$ -modules. We have

$$H^0_{DS,f_{\theta}}(V^k(\lambda)) = \bigoplus_{d \in h^{min}_{\lambda} + 1/2\mathbb{Z}_{\geq 0}} H^0_{DS,f_{\theta}}(V^k(\lambda))_{[d]_{min}}$$

where

$$h_{\lambda}^{min} = \frac{(\lambda|\lambda+2\rho)}{2(k+h^{\vee})} - \frac{1}{2}(\lambda|\theta) = \frac{1}{2(k+h^{\vee})}(|\lambda|^2 + (\lambda|2\rho - (k+h^{\vee})\theta)).$$

Thus the assumption (3) implies that, for  $\lambda \in P_+$ , we have  $h_{\lambda} \geq 0$  and the quality holds if and only if  $\lambda = 0$ . This shows (21). Moreover, since  $H^0_{DS,f_{\theta}}(V^k(0))_{[0]_{min}} = \mathcal{W}^k(\mathfrak{g}, f_{\theta})_{[0]_{min}} = \mathbb{C}$ , it follows that (20) restricts to an isomorphism  $\mathcal{W}^{\ell}(\mathfrak{g}) \cong (\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen}$  and that  $(\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen} = (\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen}$ .

Since  $\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$  is a quotient of  $\mathcal{W}^{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$ , we have by (21) and (22) that

$$\begin{aligned} & \mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}) = \bigoplus_{d \geq 0} (\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))_{[d]_{min}}^{gen}, \\ & (\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))_{[0]_{min}}^{gen} = (\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_{1}(\mathfrak{g}))_{[0]_{min}} \end{aligned}$$

and that  $(\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}$  is a quotient of  $\mathcal{W}^{\ell}(\mathfrak{g})$ . This gives that

$$\operatorname{Hom}(\mathcal{W}^{k}(\mathfrak{g},f_{\theta}),\mathcal{W}_{k-1}(\mathfrak{g},f_{\theta})\otimes L_{1}(\mathfrak{g}))\cong(\mathcal{W}_{k-1}(\mathfrak{g},f_{\theta})\otimes L_{1}(\mathfrak{g}))_{[0]_{min}}^{gen}$$

On the other hand, the vertex algebra  $\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$  is equipped with a nondegenerate invariant form ([AvE23]). Since the restriction of the non-degenerate invariant form on  $\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g})$  to the subspace  $(\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen}$ is non-degenerate, we obtain that  $(\mathcal{W}_{k-1}(\mathfrak{g}, f_{\theta}) \otimes L_1(\mathfrak{g}))_{[0]_{min}}^{gen} \cong \mathcal{W}_{\ell}(\mathfrak{g})$ . This completes the proof.

It is clear that Theorem 1.1 follows from Theorem 4.6 and the following assertion.

**Lemma 4.1.** The three conditions in Theorem 4.6 are satisfied for k as in Theorem 1.1.

*Proof.* The condition (1) is clearly satisfied and it is straight forward to check that the condition (3) is satisfied (see Tables 2-5). Let us show that the condition (2) is satisfied. Set  $\Lambda = \lambda - (\ell + h^{\vee})\rho^{\vee} + \ell\Lambda_0$ . Then

$$\Lambda + \hat{\rho} = -\frac{1}{p-1}\rho + \frac{p}{p-1}\Lambda_0,$$

where  $\hat{\rho} = \rho + h^{\vee} \Lambda_0$ . Let  $\hat{\Delta}(\Lambda) = \{ \alpha \in \widehat{\Delta}^{re} \mid \langle \Lambda + \hat{\rho}, \alpha^{\vee} \rangle \in \mathbb{Z} \}$ , the set of integral roots of  $\Lambda$ , where  $\widehat{\Delta}^{re}$  is the set of real roots of  $\widehat{\mathfrak{g}}$ . One finds that a base  $\widehat{\Pi}(\Lambda)$  of  $\widehat{\Delta}(\Lambda)$  is given by

$$\hat{\Pi}(\Lambda) = y(S_{(p-1)}),$$

where y is an element of the extended Weyl group of  $\hat{\mathfrak{g}}$  given in Tables 2-5 and

$$S_{(q)} = \{\alpha_1, \dots, \alpha_{\mathrm{rk}\,\mathfrak{g}}, -\theta + q\delta\}.$$

Here we have adopted the standard Bourbaki numbering for the simple roots,  $\theta$  is the highest root of  $\mathfrak{g}$ ,  $s_{\alpha}$  is the reflection corresponding to  $\alpha$ , and  $s_i = s_{\alpha_i}$ . By definition  $\chi_{\mu} \sim_{\ell} \chi_0$  if and only if  $\mu - (\ell + h^{\vee})\rho^{\vee} + \ell\Lambda_0 \in \widehat{W}(\Lambda) \circ \Lambda$ , where  $\widehat{W}(\Lambda) = \langle s_{\alpha} \mid \alpha \in \widehat{\Delta}(\Lambda) \rangle$  is integral Weyl group of  $\Lambda$ .

Let  $\beta$  be the element of  $\hat{\Pi}(\Lambda)$  given in Tables 2-5. Then

(23) 
$$\langle \Lambda + \hat{\rho}, \beta^{\vee} \rangle = -1 \text{ and } \langle \Lambda + \hat{\rho}, \gamma^{\vee} \rangle \ge 1 \text{ for } \gamma \in \widehat{\Pi}(\Lambda) \setminus \beta$$

(24)  $\langle \beta, D \rangle = 0 \text{ and } \langle \gamma, D \rangle > 0 \text{ for } \gamma \in \hat{\Pi}(\Lambda) \setminus \beta,$ 

It follows (23) that

$$\Lambda_{+} := s_{\beta} \circ \Lambda \equiv \beta + \Lambda \pmod{\delta}$$

is the unique dominant weight in the orbit  $\widehat{W}(\Lambda) \circ \Lambda$ , and that  $\chi_{\beta+(\ell+h^{\vee})\rho^{\vee}}$  is the only central character  $\chi_{\lambda}$  such that  $\chi_{\lambda} \succeq_{\ell} \chi_{0}, \chi_{\lambda} \neq \chi_{0}$ . It follows from (11) and (24) that  $h_{\lambda} \geq 0$  for all  $\chi_{\lambda}$  such that  $\chi_{\lambda} \sim_{\ell} \chi_{0}$ , and the equality holds if and only if  $\chi_{\lambda} = \chi_{0}, \chi_{\beta+(\ell+h^{\vee})\rho^{\vee}}$ . Since  $\beta + (\ell + h^{\vee})\rho^{\vee} \notin W \circ P_{+}$ , we conclude that the condition (2) is satisfied as required.  $\Box$
