Error minimization for fidelity estimation of GHZ states with arbitrary noise

Fidelity estimation is a crucial component for the quality control of entanglement distribution networks. This work studies a scenario in which multiple nodes share noisy Greenberger-Horne-Zeilinger [\(GHZ\)](#page-0-4) states. Due to the collapsing nature of quantum measurements, the nodes randomly sample a subset of noisy [GHZ](#page-0-4) states for measurement and then estimate the average fidelity of the unsampled states conditioned on the measurement outcome. By developing a fidelity-preserving diagonalization operation, analyzing the Bloch representation of [GHZ](#page-0-4) states, and maximizing the Fisher information, the proposed estimation protocol achieves the minimum mean squared estimation error in a challenging scenario characterized by arbitrary noise and the absence of prior information. Additionally, this protocol is implementation-friendly as it only uses local Pauli operators according to a predefined sequence. Numerical studies demonstrate that, compared to existing fidelity estimation protocols, the proposed protocol reduces estimation errors in both scenarios involving independent and identically distributed (i.i.d.) noise and correlated noise.

I. INTRODUCTION

Entanglement is a primary source of quantum advantage in the emerging quantum networks, such as the quantum Internet [\[1,](#page-14-0) [2](#page-14-1)] and quantum computing networks [\[3,](#page-14-2) [4](#page-14-3)]. In particular, multi-party entanglement plays a critical role in various applications, such as multiparty quantum communication [\[5\]](#page-15-0), computation [\[6](#page-15-1)], and clock synchronization [\[7\]](#page-15-2). In this context, evaluation of the quality of multi-party entanglement is critical for the development of medium to large scale quantum networks. Quantum error detection [\(QED\)](#page-0-5) [\[8](#page-15-3)[–10\]](#page-15-4) and quantum state tomography [\(QST\)](#page-0-6) [\[11](#page-15-5)[–13\]](#page-15-6) can both in principle achieve this task. However, to mitigate the effects of noise, [QED](#page-0-5) must ensure sufficient information redundancy by employing sophisticated quantum circuits, and to obtain complete information about the state, [QST](#page-0-6) requires the number of measurements to grow exponentially with respect to [\(w.r.t.\)](#page-0-7) the dimension of the state [\[14\]](#page-15-7). The advancement of quantum networks necessitates the development of resource-efficient methods for evaluating the quality of multi-party entanglement.

Fidelity indicates the quality of quantum states [\[15](#page-15-8)– [18](#page-15-9)] and can be estimated using separable quantum operations and classical post-processing. Separable quantum operations do not require nodes to have quantum memories, making the estimation protocols feasible with stateof-the-art quantum technologies [\[19](#page-15-10)[–22\]](#page-15-11). Consequently, fidelity estimation emerges as a promising method for evaluating the quality of entanglement. Fidelity estimation protocols have been developed for various entangled states [\[23](#page-15-12)[–27\]](#page-15-13). However, to estimate the fidelity of multiparty entangled states, several key challenges remain to be addressed.

• Limit the detrimental effect of arbitrary noise: Quantum networks frequently experience heterogeneous and correlated noise. This type of noise reduces the amount of information that can be derived from measurements, consequently resulting in excessive estimation error in various quantum protocols [\[28,](#page-15-14) [29](#page-15-15)]. The reduction of the excessive errors caused by arbitrary noise, specifically in the context of fidelity estimation for multiparity entangled states, represents a promising area of research.

• Enhance the efficiency of separable operations: Separable quantum operations are advantageous for implementation as they do not necessitate quantum memories. However, as has been noted in the context [QST,](#page-0-6) in contrast to joint operations, separable operations can result in significant measurement efficiency loss [\[30\]](#page-15-16). Addressing the efficiency loss associated with separable operations in the fidelity estimation of multi-parity entangled states continues to present a notable challenge.

The author's prior work [\[31](#page-15-17)] addresses the above chalaforementioned challenges in the context of two-party entangled states. In this paper, we focus on the fidelity estimation of Greenberger-Horne-Zeilinger [\(GHZ\)](#page-0-4) states, which are a set of maximally entangled states shared by an arbitrary number of parties. These states have numerous applications in quantum networks, including secure communication [\[32,](#page-15-18) [33\]](#page-15-19), error correction [\[34](#page-15-20), [35\]](#page-15-21), and distributed computation [\[36,](#page-15-22) [37\]](#page-15-23). Given that measurements collapse quantum states, we consider a network in which nodes randomly sample a subset of the shared noisy [GHZ](#page-0-4) states to measure and estimate the average fidelity of unsampled noisy states conditioned on the measurement outcome.

Given the limitation of having only separable measurements, we utilize the Bloch representation to decompose the [GHZ](#page-0-4) states into the sum of local operators. By employing this decomposition alongside Fisher information [\[38\]](#page-15-24), we propose a measurement operation that minimizes

the mean squared estimation error of fidelity. The proposed operation is practical for implementation as it involves only local Pauli operators.

The remainder of the paper is organized as follows. Section [II](#page-1-1) formulates the fidelity estimation problem. Section [III](#page-1-2) and [IV](#page-3-0) present the theoretical foundation and detail the construction of the proposed protocol. Section [V](#page-5-1) provides the numerical studies. Finally, Section [VI](#page-6-0) offers the concluding remarks.

Random variables and their realizations are denoted in upper- and lower-case letters, respectively, e.g., F and f .

II. SYSTEM SETUP AND PROBLEM FORMULATION

Consider a quantum network consisting of $L(\geq 2)$ nodes that share multiple copies of noisy entangled states. The nodes are indexed by $l \in \mathcal{L} = \{1, 2, ..., L\}.$ The target shared state is one of the L-qubit [GHZ](#page-0-4) states, which are defined as

$$
|G_j^{\pm}\rangle = \frac{1}{\sqrt{2}} (|j\rangle \pm |\tilde{j}\rangle), \tag{1}
$$

where

$$
\mathbf{j} = [j_1, j_2, \dots, j_L] \in \mathcal{J} = \{0\} \cap \{0, 1\}^{L-1} \tag{2}
$$

is an L -bit binary string, in which \frown denotes the concatenation of two strings, and \tilde{j} is the bitwise complement of j .

Denote the density matrix of $\left|G_j^{\pm}\right\rangle$ by G_j^{\pm} , denote the set of all L -qubit [GHZ](#page-0-4) states by \mathcal{G}_L , and denote the target state by $|G_t^s\rangle$, where $s \in \{+,-\}, t \in \mathcal{J}$.

The nodes share N noisy L -qubit [GHZ](#page-0-4) states and have no prior information of the noise. To assess the quality of entanglement, the nodes randomly sample $M(< N)$ noisy [GHZ](#page-0-4) states for measurement. Since the measured states are no longer entangled, the nodes estimate the fidelity of the unsampled states conditioned on the measurement outcomes. The set of all noisy [GHZ](#page-0-4) states and that of the sampled states are denoted by \mathcal{N} , with $|\mathcal{N}| = N$, and \mathcal{M} , with $|\mathcal{M}| = M$, respectively. Here, $\mathcal M$ is drawn from all M-subsets of N with equal probability

To be implementable on nodes without local quantum memory, the estiamtion protocol employs operators that are separable across all qubits. These operators are denoted by

$$
M_r = \sum_{k} \otimes^{n \in \mathcal{M}} (\otimes^{l \in \mathcal{L}} M_{r,n,k}^{(l)}), \tag{3}
$$

where the [GHZ](#page-0-4) state index $n \in \mathcal{M}$, the node index $l \in$ $\mathcal{L} = \{1, 2, \ldots, L\}$, and operator index $r \in \mathcal{R}$. Here \mathcal{R} represents the set of all possible measurement outcomes. As positive operator-valued measure [\(POVM\)](#page-0-8) operators,

where \succcurlyeq denotes matrix inequality. The set of all measurement operators is denoted by

$$
\mathcal{O} = \{M_r, \ r \in \mathcal{R}\},\tag{5}
$$

Denote ρ_{all} as the density matrix of all [GHZ](#page-0-4) states before being measured, and denote the $\rho_{\text{all}}^{(r)}$ as the density matrix of the [GHZ](#page-0-4) states conditioned on the measurement outcome r . In this case, the density matrix of the n-th [GHZ](#page-0-4) state is

$$
\boldsymbol{\rho}_n^{(r)} = \text{Tr}_{i \in \mathcal{N} \setminus \{n\}} \boldsymbol{\rho}_{\text{all}}^{(r)}.

Based on the measurement outcome, the estimator D is used to estimate the average fidelity of the unsampled [GHZ](#page-0-4) states \bar{f} , i.e.,

$$
\check{f} = \mathcal{D}(r). \tag{7}
$$

Because each M-subset is selected with probability $\binom{N}{M}^{-1}$, the mean squared estimation error is given by

$$
\binom{N}{M}^{-1} \sum_{\mathcal{M}} \mathbb{E}_R \left[(\check{F} - \bar{F})^2 \right],\tag{8}
$$

where \check{F} , \bar{F} , and R are the random variable form of the estimated fidelity \check{f} , the average fidelity \bar{f} , and the measurement outcome r, respectively.

To optimize the efficiency of the measurement without prior information of ρ_{all} , we design the measurement operators to achieve a low estimation error for all types of noise. Specifically, the squared error of the estimated fidelity is minimized for the worst-case state ρ_{all} , subject to the constraint that the estimation is unbiased. This problem is formulated as

 \mathscr{P} -1 (Error minimization with arbitary noise):

\underset{\mathcal{O}, \mathcal{D}}{\text{minimize}} \quad \underset{\rho_{\text{all}} \in \mathcal{S}_{\text{arb}}}{\text{max}} \sum_{\mathcal{M}} \mathbb{E}_R \left[(\check{F} - \bar{F})^2 \right] \tag{9a}

subject to
$$
\sum_{\mathcal{M}} \mathbb{E}_R[\check{F} - \bar{F}] = 0, \ \forall \rho_{\text{all}} \in \mathcal{S}_{\text{arb}}
$$

where \mathcal{S}_{arb} denotes the set of arbitrary $N \times L$ qubit states, and \mathcal{O}, \mathcal{D} are defined in [\(5\)](#page-1-3), [\(7\)](#page-1-4) respectively. The factor $\binom{N}{M}^{-1}$ it is omitted in [\(9a\)](#page-1-5) because it does not affect the optimization of the esitmation protocol $\{\mathcal{O},\mathcal{D}\}.$

The following two sections elaborate the procedures for solving $\mathscr{P}-1$, which involve two main components: problem transformation and operation construction.

III. PROBLEM TRANSFORMATION

This section demonstrates that \mathscr{P} [-1](#page-1-6) can be transformed into an equivalent problem with independent noise. The transformation process involves three steps.

A. Sufficiency of considering classical correlated noise

This step simplifies \mathscr{P} [-1](#page-1-6) to an equivalent problem with classical correlated noise, specifically,

 \mathscr{P} -2 (Error minimization with separable noise):

\underset{\mathcal{O}, \mathcal{D}}{\text{minimize}} \quad \underset{\rho_{\text{all}} \in \mathcal{S}_{\text{sp}}}{\text{max}} \sum_{\mathcal{M}} \mathbb{E}_R \left[(\check{F} - \bar{F})^2 \right] \tag{10a}
$$

subject to
$$
\sum_{\mathcal{M}} \mathbb{E}_R[\check{F} - \bar{F}] = 0, \ \forall \rho_{\text{all}} \in \mathcal{S}_{\text{sp}} \qquad (10b)
$$

where $S_{\rm sp}$ denotes the set of states $\rho_{\rm all}$ that are separable across different L-qubit groups.

We first construct an operation $\mathcal T$ that removes the entanglement among different [GHZ](#page-0-4) states without altering the fidelity.

Definition 1 (Probabilistic multirotation): $T^{(k)}$ is an L-qubit operator that rotates each qubit by 180° around the x- or y-axis according to the string $\mathbf{k} \in [0, 1^L, \text{ i.e.,})$

where k_l is the *l*-th element of **k**, and

\boldsymbol{\sigma}_{xy}^{(k_l)} := \begin{cases} \boldsymbol{\sigma}_y, & \text{if } k_l = 1, \\ \boldsymbol{\sigma}_x, & \text{if } k_l = 0, \end{cases}

in which σ_x and σ_y are the Pauli X and Y matrices, respectively.

Probabilistic operation $\mathcal{T}^{(k)}$ either performs no action or applies the rotation $T^{(k)}$, each with a probability of 0.5, i.e., the two Kraus operators of $\mathcal{T}^{(k)}$ are

\frac{1}{\sqrt{2}}\mathbb{I}_{2^L} \quad \text{and} \quad \frac{1}{\sqrt{2}}\boldsymbol{T}^{(k)}.
$$

Define a set of $\mathcal{T}^{(k)}$ as

$$
\mathcal{T}_{\text{all}} = \{ \mathcal{T}^{(\mathbf{k})} : |\mathbf{k}| \in \{0, 2\} \}.
$$

Operation $\mathcal T$ sequentially performs all $\mathcal T^{(k)} \in \mathcal T_{\text{all}}$ on each [GHZ](#page-0-4) state. \Box

Using operation \mathcal{T} , states in \mathcal{S}_{arb} can be transformed into those in S_{sp} and then estimated using the optimal solution of $\mathscr{P}\text{-}2$. This ensures that the minimum estimation error for states in S_{arb} is no higher than that for states in \mathcal{S}_{sp} .

Lemma [1](#page-2-1) provides a formal proof of the analysis above.

Lemma 1 (Equivalence of \mathscr{P} [-1](#page-1-6) and \mathscr{P} [-2\)](#page-2-0): If a measurement operation \mathcal{O}^* is optimal in \mathcal{P}_2 , the composite operation $\hat{\mathcal{O}}^* = \mathcal{O}^* \circ \mathcal{T}$ is optimal in \mathscr{P}_-1 .

Proof. Please refer to Appendix [A.](#page-6-1)

B. Sufficiency of considering independent noise

This step demonstrates that to solve $\mathscr{P}\text{-}2$, it is sufficient to consider the special case with independent noise, i.e.,

 \mathscr{P} -3 (Error minimization for independent states):

\underset{\mathcal{O}, \mathcal{D}}{\text{minimize}} \quad \underset{\rho_{\text{all}} \in \mathcal{S}_{\text{id}}}{\text{max}} \sum_{\mathcal{M}} \mathbb{E}_R \left[(\check{F} - \bar{f})^2 \right] \tag{15a}
$$

subject to
$$
\sum_{\mathcal{M}} \mathbb{E}_R[\check{F} - \bar{f}] = 0, \ \forall \rho_{\text{all}} \in \mathcal{S}_{\text{id}} \quad (15b)
$$

where $S_{\rm id}$ denotes the set of states $\rho_{\rm all}$ in which the states of all N noisy [GHZ](#page-0-4) states are independent, i.e., $\rho_{\rm all}$ can be expressed as

$$
\boldsymbol{\rho}_{\text{all}} = \otimes^{n \in \mathcal{N}} \boldsymbol{\rho}_n. \tag{16}
$$

In the case of [\(16\)](#page-2-2), the average fidelity of the unsampled states, \bar{f} , is deterministic for each sample set M. Therefore, lowercase letter \bar{f} is used in [\(15\)](#page-2-3).

Correlated noise leads to atypical measurement outcomes, resulting in higher estimation errors [\[29\]](#page-15-15). To bound the estimation error with correlated noise by that with independent noise, first note that any separable state $\rho_{all} \in \mathcal{S}_{sp}$ can be expressed as

\boldsymbol{\rho}_{\text{all}} = \sum_{k \in \mathcal{K}} p_k \otimes^{n \in \mathcal{N}} \boldsymbol{\rho}_{k,n}, \qquad (17)
$$

where p_k is the probability of the ensemble being in case $k,$

p_k \geqslant 0, \sum_{k \in \mathcal{K}} p_k = 1,\tag{18}
$$

and $\rho_{k,n}$ is the density matrix of the *n*-th noisy [GHZ](#page-0-4) state in case k. Denote

$$
\boldsymbol{\rho}_{\text{all}}^{(k)} = \otimes^{n \in \mathcal{N}} \boldsymbol{\rho}_{k,n}.
$$
\n(19)

Then $\rho_{\text{all}}^{(k)} \in \mathcal{S}_{\text{id}}, \forall k \in \mathcal{K}.$

 \Box

According to Bayes' theorem.

$$
\Pr(\boldsymbol{\rho}_{\text{all}}^{(k)}|r) = \frac{p_k}{\Pr(r)} \Pr(r|\boldsymbol{\rho}_{\text{all}}^{(k)}).
$$
 (20)

Given the ensemble ρ_{all} and the measurement operation \mathcal{O}, p_k and Pr(r) are determined. In this context, [\(20\)](#page-2-4) indicates that if a measurement outcome r is atypical for component $\rho_{\text{all}}^{(k)}$, i.e., $\Pr(r|\rho_{\text{all}}^{(k)})$ is close to 0, then the likelihood of this component evaluated at point r, i.e., $\Pr(\boldsymbol{\rho}_{\text{all}}^{(k)}|r)$ is also close to 0. Because the average fidelity \overline{f} is estimated conditioned on the measurement outcome r, components $\rho_{\text{all}}^{(k)}$ with likelihood close to 0 have limited effect on the estimation error. This result provides a method to bound the estim ation error with correlated noise.

Lemma [2](#page-3-1) provides a formal proof of the analysis above.

Lemma 2 (Equivalence of $\mathscr{P}\text{-}2$ and $\mathscr{P}\text{-}3$): If a measurement operation \mathcal{O}^* is optimal in $\mathscr{P}\text{-}3$, it is also optimal in \mathscr{P} [-2.](#page-2-0)

Proof. Please refer to Appendix [B](#page-8-0) \Box

C. Sufficiency of considering the sampled [GHZ](#page-0-4) states

This step demonstrates that to solve $\mathscr{P}-3$, it is sufficient to minimize the estimation error of the sampled [GHZ](#page-0-4) states, i.e.,

 \mathscr{P}_4 (Error minimization for sampled noisy [GHZ](#page-0-4) states):

$$
\underset{\mathcal{O}, \mathcal{D}}{\text{minimize}} \quad \underset{\rho_{\text{all}} \in \mathcal{S}_{\text{id}}(f_{\text{all}})}{\text{max}} \sum_{\mathcal{M}} \mathbb{E}_{R} \left[(\check{F} - \bar{f}_{\mathcal{M}})^2 \right] \tag{21a}
$$

subject to
$$
\mathbb{E}_R[\check{F} - \bar{f}_M | \boldsymbol{\rho}_M] = 0,
$$

 $\forall \boldsymbol{\rho}_{\text{all}} \in \mathcal{S}_{\text{id}}(\boldsymbol{f}_{\text{all}}), \mathcal{M} \subset \mathcal{N}$ (21b)

where ρ_M is the density matrix of all sampled noisy [GHZ](#page-0-4) states, and $S_{\text{id}}(f_{\text{all}})$ denotes the set of N noisy [GHZ](#page-0-4) states with independent noise and fidelity composition $f_{\text{all}} = \{f_n, n \in \mathcal{N}\}\,$, i.e.,

$$
\boldsymbol{\rho}_{\text{all}} = \otimes^{n \in \mathcal{N}} \boldsymbol{\rho}_n,\tag{22}
$$

in which ρ_n is the density matrix of the *n*-th noisy [GHZ](#page-0-4) states,

$$
f_n = \langle G_t^s | \rho_n | G_t^s \rangle, \quad n \in \mathcal{N}, \tag{23}
$$

is the fidelity of the n -th noisy [GHZ](#page-0-4) states, and

$$
\bar{f}_{\mathcal{M}} = \frac{1}{M} \sum_{n \in \mathcal{M}} f_n \tag{24}
$$

is the average fidelity of the sampled noisy [GHZ](#page-0-4) states.

In \mathscr{P} [-3,](#page-2-5) because the noise is independent, the fidelity of the unsampled [GHZ](#page-0-4) states is invariant to the measurment outcome. Consequently, the estimation error of \mathscr{P} [-3](#page-2-5) can be expressed as the sum of two parts, namely the estimation error of the sampled [GHZ](#page-0-4) states,

$$
\sum_{\mathcal{M}} \mathbb{E}_R \left[(\check{F} - \bar{f}_{\mathcal{M}})^2 \right],\tag{25}
$$

and the sampling error, i.e., the deviation between the average fidelity of the sampled and the unsampled [GHZ](#page-0-4) states,

$$
\sum_{\mathcal{M}} (\bar{f}_{\mathcal{M}} - \bar{f})^2.
$$

The sampling error [\(26\)](#page-3-2) is not affected by the estimation protocol, and hence can be omitted in the estimation error minimization problem. In this way, \mathscr{P} [-3](#page-2-5) is transformed into \mathscr{P} [-4.](#page-3-3)

Lemma [3](#page-3-4) provides a formal proof of the analysis above.

Lemma 3 (Equivalence of Problems [3](#page-2-5) and [4\)](#page-3-3): If a measurement operation \mathcal{O}^* is optimal in \mathcal{P} [-4](#page-3-3) for all compositions of fidelity, i.e., $\forall S_{\text{id}}(f_{\text{all}}) \subset S_{\text{id}}$, it is also optimal in \mathscr{P} [-3.](#page-2-5)

Proof. Please refer to Appendix [C](#page-8-1) \Box

The following theorem summarizes the results of this section.

Theorem 1 (Generality of optimality with independent noise): If a measurement operation \mathcal{O}^* is optimal in \mathscr{P}_-4 \mathscr{P}_-4 for all $S_{\text{id}}(f_{\text{all}}) \subset S_{\text{id}}$, then the composite measurement operation $\hat{\mathcal{O}}^* = \mathcal{O}^* \circ \mathcal{T}$ is optimal in $\mathscr{P}\text{-}1$, where the operation $\mathcal T$ is defined as in Definition [1.](#page-2-6)

Proof. The theorem is a direct consequence of Lemmas [1,](#page-2-1) [2,](#page-3-1) and [3.](#page-3-4) □

IV. OPERATION CONSTRUCTION

In this section, we will first characterize the minimum estimation error of \mathscr{P}_4 and then construct a protocol to achieve this minimum error.

A. Lower bound of the measurement error

The characterization of the minimum mean squared error is a key research focus due to its theoretical and practical significance. For \mathscr{P}_-4 , the Cramér-Rao bound [\[39,](#page-16-0) [40\]](#page-16-1) and the quantum Fisher information [\[41](#page-16-2), [42\]](#page-16-3) respectively characterize the minimum estimation error for a given measurement operation \mathcal{O} , and for the case where all measurement operations available.

However, \mathscr{P}_-4 \mathscr{P}_-4 aims to minimize the estimation error with only separable measurement operations. A new method is needed to characterize the minimum error in this case. For noisy Bell states, the minimum estimation error was characterized in the author's prior work [\[31\]](#page-15-17). This result is achieved by indentifying the limitations of separable operations when measuring entangled states. Recognizing that Bell states are a special case of [GHZ](#page-0-4) states, we prove in Lemma [4](#page-3-5) that the minimum estimation error derived in [\[31\]](#page-15-17) also applies to the estimation of noisy [GHZ](#page-0-4) states.

Lemma 4 (Lower bound for the estimation error): The mean squared estimation error, i.e., the objective function of \mathscr{P}_-4 \mathscr{P}_-4 divided by $\binom{N}{M}$, is no less than

\sum_{n \in \mathcal{N}} \frac{(2f_n + 1)(1 - f_n)}{2MN}.

Proof. Please refer to Appendix [D](#page-9-0) for the proof.□

B. Achieving the minimum estimation error

This subsection constructs an estimation protocol that serves as the optimal solution of $\mathscr{P}\text{-}1$.

A noisy [GHZ](#page-0-4) state ρ with fidelity f can be expressed as

$$
\rho = fG_t^s + (1 - f)\mathbf{N},\tag{28}
$$

where the noise component N satisfies

$$
\text{Tr}(\mathbf{N})=1, \ \text{Tr}(\mathbf{G}_t^s \mathbf{N})=0, \ (\mathbb{I}_{2^L}-\mathbf{G}_t^s)\mathbf{N}\succcurlyeq \mathbf{0}. \tag{29}
$$

To ensure an unbiased estimate, the expectation of the measurement outcome R should be determined by the fidelity f and not influenced by the noise component N . Furthermore, with no prior information about the noise, N can be any matrix that satisfies [\(29\)](#page-4-2). Therefore, the observable corresponding to the measurement outcome must have the following form:

$$
\mathbf{M} = c(\mathbb{I}_{2^L} - \mathbf{G}_t^s),\tag{30}
$$

where the coefficient $c \in (0, 1]$. This coefficient represents the probability that the measurement can distinguish the fidelity component G_t^s from the noise component N . In this case, the fidelity of ρ is given by

$$
f = 1 - \frac{1}{c} \text{tr} \left[c(\mathbb{I}_{2^L} - G_t^s) \rho \right]
$$

$$
= 1 - \frac{1}{c} \Pr[R = 1]. \tag{31}
$$

To minimize the estimation error, c needs to be maximized. For the two-node case, i.e., $L = 2$, it has been shown that $\frac{2}{3}$ is the maximum achievable value for c [\[31\]](#page-15-17). Furthermore, based on the analysis in the previous step, the two-node case provides a lower bound on the estimation error for cases with a generic number of nodes. Therefore, we construct Protocol [1](#page-4-3) to achieve $c = \frac{2}{3}$.

Specifically, every L-qubit state ρ has a unique Bloch representation:

$$
\rho = \frac{\mathbb{I}_{2^L}}{2^L} + \sum_{j=1}^{4^L - 1} r^{(j)} \sigma^{(j)},
$$
\n(32)

where $\sigma^{(j)}$ are the L-qubit non-identity Pauli observables, and the Bloch coefficients $r^{(j)} \in \mathbb{R}$ determine the state. Since

$$
r^{(j)} = \text{tr}\big[\rho \sigma^{(j)}\big],\tag{33}
$$

the Bloch coefficients can be inferred through local Pauli measurements. Therefore, the Bloch representation provides a valuable tool for estimating quantum states via local measurements.

Building on the above insights, Lemma [5](#page-5-2) gives the Bloch representation of the [GHZ](#page-0-4) states. Then, by applying this representation in conjunction with combinatorial

Protocol 1 Fidelity estimation

1: Set measurement parameters. The nodes select the sampling set $M \subset \mathcal{N}$ completely at random, with $|\mathcal{M}| = M$. Additionally, the nodes generate M number of independent and identically distributed [\(i.i.d.\)](#page-0-9) random variables $A_n \in \{0,1\}, n \in \mathcal{M}$, with distribution

$$
Pr[A_n = 0] = \frac{1}{3}
$$
, and $Pr[A_n = 1] = \frac{2}{3}$. (34)

In the case of $A_n = 1$, the nodes randomly pick an L-bit string with even l_1 norm, i.e.,

$$
\mathbf{K}_n = [K_{n,1}, K_{n,2}, \dots, K_{n,L}] \in \{0,1\}^L, \ \|\mathbf{K}_n\|_1 \text{ even.} \quad (35)
$$

All strings satisfying [\(35\)](#page-4-4) are picked with equal probability.

- 2: Perform measurements. For the noisy [GHZ](#page-0-4) state $n \in \mathcal{M}$, the L nodes make measurements according to A_n and \mathbf{K}_n , and record the measurement result as correct $(r_n = 0)$ or erroneous $(r_n = 1)$. Specifically,
	- When $A_n = 0$, all L nodes measure in the z-basis and record the result $\mathbf{c}_n \in \{0,1\}^L$ according to [\(36\)](#page-4-5)

$$
r_n = \mathbb{1}\big(c_n \not\in \{t,\tilde{t}\}\big),\tag{36}
$$

where $\mathbb{1}(\cdot)$ is the indicator function.

- When $A_n = 1$, the nodes measure in x- or y-basis to evaluate the Pauli observable

$$
\boldsymbol{\sigma}_{xy}^{(K_n)} = \bigotimes_{l \in \mathcal{L}} \boldsymbol{\sigma}_{xy}^{(K_{n,l})}, \text{ where } \boldsymbol{\sigma}_{xy}^{(k)} = \begin{cases} \boldsymbol{\sigma}_y, \text{ if } k = 1\\ \boldsymbol{\sigma}_x, \text{ if } k = 0 \end{cases} (37)
$$

and get result $c_n \in \{-1, 1\}$. The nodes record the result according to [\(38\)](#page-4-6).

$$
r_n = \begin{cases} \mathbb{1}(c_n = (-1)^{\frac{1}{2}||\mathbf{K}_n||_1 + \mathbf{K}_n \cdot \mathbf{t} - 1}) \text{ if } s = + \\ \mathbb{1}(c_n = (-1)^{\frac{1}{2}||\mathbf{K}_n||_1 + \mathbf{K}_n \cdot \mathbf{t}}) \text{ if } s = - \end{cases}, \quad (38)
$$

where $K_n \cdot t$ is the inner product of two bit strings.

3: Estimate fidelity. The number of errors and the quantum bit error rate [\(QBER\)](#page-0-10) are expressed as $e_{\mathcal{M}} = \sum_{n \in \mathcal{M}} r_n$, and $\varepsilon_{\mathcal{M}} = \frac{e_{\mathcal{M}}}{M}$ $\frac{1}{M}$, respectively. The estimated fidelity is given by

$$
\check{f} = 1 - \frac{3}{2}\varepsilon \mathcal{M}.
$$
 (39)

theory, Lemma [6](#page-5-3) characterizes the expectation of several weighted Pauli observables when measured on [GHZ](#page-0-4) states. Based on this result, Lemma [7](#page-5-4) demonstrates that [\(39\)](#page-4-7) is an unbiased estimator for \mathscr{P}_-4 , and Lemma [8](#page-5-5) further establishes that this estimator is optimal for \mathscr{P}_-4 . Finally, by integrating these findings with Theorem [1,](#page-3-6) Theorem [2](#page-5-6) confirms that Protocol [1](#page-4-3) is the optimal solution for the original fidelity estimation problem $\mathscr{P}\text{-}1$.

Remark 1 (Implementability of Protocol [1\)](#page-4-3): Protocol [1](#page-4-3) exclusively relies on local Pauli measurements, which are standard operations implementable across a variety of quantum platforms [\[43](#page-16-4)[–46\]](#page-16-5). \Box

Lemma 5 (Bloch representation of [GHZ](#page-0-4) states): The Bloch representation of a [GHZ](#page-0-4) state is given by

$$
G_j^{\pm} = \frac{1}{2^L} \sum_{\substack{k \in \{0,1\}^L \\ ||k||_1 \text{ even}}} (-1)^{k \cdot j} \Big(\sigma_{Iz}^{(k)} \pm (-1)^{\frac{||k||_1}{2}} \sigma_{xy}^{(k)} \Big), \tag{40}
$$

where

$$
\boldsymbol{\sigma}_{Iz}^{(k)} = \bigotimes_{l \in \mathcal{L}} \boldsymbol{\sigma}_{Iz}^{(k_l)}, \quad \boldsymbol{\sigma}_{xy}^{(k)} = \bigotimes_{l \in \mathcal{L}} \boldsymbol{\sigma}_{xy}^{(k_l)}, \quad (41)
$$

 k_l is the *l*-th element of **k**, and

$$
\boldsymbol{\sigma}_{Iz}^{(k_l)} = \begin{cases} \boldsymbol{\sigma}_z, & \text{if } k_l = 1, \\ \mathbb{I}_2, & \text{if } k_l = 0, \end{cases}, \quad \boldsymbol{\sigma}_{xy}^{(k_l)} = \begin{cases} \boldsymbol{\sigma}_y, & \text{if } k_l = 1, \\ \boldsymbol{\sigma}_x, & \text{if } k_l = 0, \end{cases}
$$
\n(42)

in which σ_x , σ_y , and σ_z are the Pauli matrices.

Lemma 6 (Value of weighted Pauli observables): Consider the Pauli observables

$$

where $\mathbf{k} = [k_1, k_2, \dots, k_L] \in \{0, 1\}^L$ is an *L*-bit string with even l_1 norm. When these observables are measured on the [GHZ](#page-0-4) states, the expected values have the following properties.

\operatorname{Tr}\left[\left(\frac{1}{2^{L-1}}\sum_{\substack{\mathbf{k}\in\{0,1\}^L\\|\mathbf{k}||_1\text{ even}}}(-1)^{\frac{||\mathbf{k}||_1}{2}+\mathbf{k}\cdot\mathbf{j}}\sigma_{xy}^{(\mathbf{k})}\right)\mathbf{G}_{\tilde{j}}^{\pm}\right]=0, \quad (45)
$$
\n
$$
\forall \tilde{j}\in\mathcal{J},\ \tilde{j}\neq j.
$$

V. APPLICATION EXAMPLE

This section evaluates the mean squared error of the proposed protocol and compares it with existing fidelity estimation methods. The noise model is described first. Noise model: The simulated platform consists of three physically separated Nitrogen-vacancy [\(NV\)](#page-0-11) centers. Within these [NV](#page-0-11) centers, the electronic spin associated with the defect can be utilized as a qubit. The three [NV](#page-0-11) centers aim to generate tripartite [GHZ](#page-0-4) states.

Multiple types of noise are simulated in accordance to the experiment results in [\[20](#page-15-25), [47\]](#page-16-6). In particular, the evolution of dark counts is modeled as a Markov chain. The dark count state is defined as $D_n \in [0, 1]$, where $D_n =$ 0 indicates no dark count in the n -th round of [GHZ](#page-0-4) state generation, and $D_n = 1$ indicates the presence of a dark count. The transition matrix of the dark count states is defined as follows:

$$
\boldsymbol{T} = \begin{bmatrix} 1 - \delta P_{\rm d} & \delta(1 - P_{\rm d}) \\ \delta P_{\rm d} & 1 - \delta(1 - P_{\rm d}) \end{bmatrix} \tag{46}
$$

where $P_d \in [0, 1]$ represents the average probability of a dark count occurring in a single round of [GHZ](#page-0-4) state generation. This parameter influences the noise intensity. The parameter

$$
\delta \in \left(0, \min(\frac{1}{P_{\rm d}}, \frac{1}{1 - P_{\rm d}})\right] \tag{47}
$$

determines the correlation between two consecutive dark count states, i.e.,

$$
cor(Dn, Dn+1) = 1 - \delta.
$$
 (48)

In particular, when $\delta = 1$, the dark count states are independent random variables.

In Fig. [1,](#page-6-2) we plot the mean squared error $\text{Var}(\tilde{F})$ of the proposed protocol, along with those of two existing fidelity estimation protocols, i.e., protocols described in [\[25,](#page-15-26) [26\]](#page-15-27), as functions of the dark count parameters $P_{\rm d}$ and δ .

Fig. [1A](#page-6-2) illustrates that as the noise intensity P_d increases, the mean squared error of all protocols increases. This occurs because stronger noise introduces greater uncertainty in the measurement results. Consequently, the estimation error of the sampled [GHZ](#page-0-4) states, as defined in [\(25\)](#page-3-8), increases.

Fig. [1B](#page-6-2) illustrates that as the noise correlation $1 - \delta$ between two consecutive rounds shifts from negative to positive, the mean squared error of all protocols decreases. This occurs because positive correlation results in a smaller difference between the fidelity of sampled and unsampled [GHZ](#page-0-4) states. As a result, the sampling error, as defined in [\(26\)](#page-3-2), decreases.

The protocol in [\[26\]](#page-15-27) utilizes only local Pauli measurements, thereby ensuring good implementability. However, as shown in Fig. [1,](#page-6-2) it exhibits a relatively high mean squared error. The protocol in [\[25\]](#page-15-26) achieves a lower mean

squared error. However, this protocol necessitates local measurements of the form $\cos(\theta)\boldsymbol{\sigma}_x + \sin(\theta)\boldsymbol{\sigma}_y$, where

$$
\theta \in \left\{ \frac{\pi}{L}, \frac{2\pi}{L}, \dots, \frac{\pi(L-1)}{L} \right\}.
$$

Notably, since the value of θ must be adjusted by $\frac{\pi}{L}$ for each measurement operator, these operators become increasingly difficult to implement as the number of qubits L increases. Similar to the protocol in [\[26\]](#page-15-27), the proposed protocol employs only local Pauli measurements, and Fig. [1](#page-6-2) demonstrates that it yields the minimum mean squared error across all cases. Thus, the proposed protocol simultaneously achieves both good implementability and high estimation accuracy.

VI. CONCLUSION

Fidelity estimation of entangled states shared by remote nodes is a critical component of quantum networks. In this work, we propose a fidelity estimation protocol for [GHZ](#page-0-4) states under arbitrary noise conditions. By utilizing the Bloch representation of [GHZ](#page-0-4) states and applying tools from combinatorial theory, we design a set of local measurement operators to estimate the fidelity of [GHZ](#page-0-4) states. These operators achieve optimal measurement efficiency within the constraint of separable operations. Numerical tests confirm the advantages of the proposed estimation protocol.

Appendix A: Proof of Lemma [1](#page-2-1)

We will first demonstrate that the operation $\mathcal T$ transforms any L-qubit state into a state that is diagonal in the basis of [GHZ](#page-0-4) states while preserving the original state's fidelity. Then by leveraging this property of $\mathcal T$, we construct a Gedankenexperiment to establish the equivalence of \mathscr{P} [-1](#page-1-6) and \mathscr{P} [-2.](#page-2-0)

The [GHZ](#page-0-4) states in set

$$
\mathcal{G}_L = \{ |G_j^{\tau}\rangle, j \in \mathcal{J}, \tau \{ +, - \} \}

 (A1)

form a basis of L-qubit states. Therefore, the density matrix of any L-qubit state can be written as

$$
\rho = \sum_{k \in \mathcal{K}} c_k |\phi_k\rangle\langle\psi_k|,\tag{A2}
$$

where $|\phi_k\rangle, |\psi_k\rangle \in \mathcal{G}_L$ and K is the set of all terms with non-zero coefficient $c_k \in \mathbb{C}$. Given [\(A2\)](#page-6-3), the fidelity of ρ is given by

$$
f = \sum_{k \in \mathcal{K}} \Big(c_k \mathbb{1} \big(|\phi_k \rangle = |\psi_k \rangle = |G_t^s \rangle \Big), \tag{A3}
$$

where $\mathbb{1}(\cdot)$ is the indicator function.

Because $\sigma_x|0\rangle = |1\rangle, \sigma_x|1\rangle = |0\rangle, \sigma_y|0\rangle = i|1\rangle, \text{ and}$ $\bm{\sigma}_y |1\rangle = -\imath |0\rangle, \text{ for any state } |G^\pm_{\bm{j}}\rangle \in \mathcal{G}_L \text{ and any operation }$ $T^{(k)} \in \mathcal{T}_{\text{all}}$, we have that

$$
T^{(k)}|G_j^{\pm}\rangle = T^{(k)}\frac{1}{\sqrt{2}}(|j\rangle \pm |\tilde{j}\rangle)
$$
 (A4a)

$$
= \frac{1}{\sqrt{2}} i^{|\mathbf{k}|} \left((-1)^{\mathbf{k} \cdot \mathbf{j}} |\tilde{\mathbf{j}}\rangle \pm (-1)^{\mathbf{k} \cdot \tilde{\mathbf{j}}} |\mathbf{j}\rangle \right) \quad \text{(A4b)}
$$

$$
=\frac{1}{\sqrt{2}}\imath^{|\boldsymbol{k}|}(-1)^{\boldsymbol{k}\cdot\boldsymbol{j}}\left(|\tilde{\boldsymbol{j}}\rangle\pm|\boldsymbol{j}\rangle\right),\tag{A4c}
$$

where $\boldsymbol{a} \cdot \boldsymbol{b}$ denotes the inner product of strings \boldsymbol{a} and **b.** Since $\mathbf{k} \cdot \mathbf{j} + \mathbf{k} \cdot \tilde{\mathbf{j}} = |\mathbf{k}|$ and $|\mathbf{k}|$ is even, it follows that

$$
(-1)^{k \cdot j} = (-1)^{k \cdot \tilde{j}}.\tag{A5}
$$

Therefore, [\(A4c\)](#page-6-4) holds.

From [\(A4\)](#page-6-4), it follows that for any two states $|G_{j_a}^{\tau_a}\rangle, |G_{j_b}^{\tau_b}\rangle \in \mathcal{G}_L$ and any operation $T^{(k)} \in \mathcal{T}_{\text{all}},$

$$
T^{(k)}|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|T^{(k)\dagger} = \begin{cases} (-1)^{k \cdot j_a + k \cdot j_b} |G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}| & \text{if } \tau_a = \tau_b \\ -(-1)^{k \cdot j_a + k \cdot j_b} |G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}| & \text{if } \tau_a \neq \tau_b \end{cases} (A6)
$$

From (13) and $(A6)$, it is easy to see that

\mathcal{T}^{(k)}\left(|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|\right)

=\frac{1}{2}\left(\mathbb{I}_{2^L}|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|\mathbb{I}_{2^L}^{\dagger} + \mathcal{T}^{(k)}|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|\mathcal{T}^{(k)\dagger}\right)
$$
\n
$$
=\begin{cases}\n|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}| & \text{if } (-1)^{k \cdot j_a + k \cdot j_b} = 1 & \& \tau_a = \tau_b \\
\text{or } (-1)^{k \cdot j_a + k \cdot j_b} = -1 & \& \tau_a \neq \tau_b \\
0 & \text{otherwise}\n\end{cases}.
$$
\n(A7)

From [\(A7\)](#page-7-0), it is evident that for all diagonal terms in the basis of [GHZ](#page-0-4) states, because $j_a = j_b$ and $\tau_a = \tau_b$,

$$
\mathcal{T}^{(k)}(G_j^{\pm}) = G_j^{\pm}, \quad \forall |G_j^{\pm}\rangle \in \mathcal{G}_L, T^{(k)} \in \mathcal{T}_{\text{all}}.\tag{A8}
$$

From [\(A3\)](#page-6-6) and [\(A8\)](#page-7-1), operation $\mathcal T$ does not change the fidelity of any L-qubit state ρ .

Recall the definition of the binary strings j

$$
\mathbf{j} \in \mathcal{J} = \{0\} \cap \{0, 1\}^{L-1},\tag{A9}

where \sim denotes string concatenation. For two different strings $j_a, j_b \in \mathcal{J}$, denote

$$
\mathbf{j}_{a,b} = \{1\} \cap \{0\}^{l-2} \cap \{1\} \cap \{0\}^{L-l},
$$
 (A10)

where l is a bit at which the elements of j_a and j_b mismatch, i.e.,

$$
j_{a,l} \oplus j_{b,l} = 1, \tag{A11}
$$

in which ⊕ denotes the XOR operation.

For two distinct states $|G_{j_a}^{\tau_a}\rangle, [G_{j_b}^{\tau_b}\rangle \in \mathcal{G}_L$, either $j_a \neq j_b$ or $\tau_a \neq \tau_b$. In this case, the following binary string can be defined

$$
\mathbf{k}_{a,b} = \begin{cases} \mathbf{j}_{a,b} & \text{if } \tau_a = \tau_b \\ \{0\}^L & \text{if } \tau_a \neq \tau_b \end{cases} . \tag{A12}
$$

According to [\(14\)](#page-2-8), $\mathcal{T}^{(k_{a,b})} \in \mathcal{T}_{\text{all}}$.

From [\(A12\)](#page-7-2), we have

$$
\boldsymbol{k}_{a,b} \cdot \boldsymbol{j}_a + \boldsymbol{k}_{a,b} \cdot \boldsymbol{j}_b = \begin{cases} 1 & \text{if } \tau_a = \tau_b \\ 0 & \text{if } \tau_a \neq \tau_b \end{cases} . \tag{A13}
$$

By substituting [\(A13\)](#page-7-3) into [\(A7\)](#page-7-0), it can be obtained that

$$
\mathcal{T}^{(k_{a,b})}(|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|)=\mathbf{0}, \ \forall \ |G_{j_a}^{\tau_a}\rangle\neq|G_{j_b}^{\tau_b}\rangle\in\mathcal{G}_L. \quad \text{(A14)}
$$

The operation \mathcal{T} sequentially applies each $\mathcal{T}^{(k)} \in \mathcal{T}_{all}$. Therefore, [\(A8\)](#page-7-1) and [\(A14\)](#page-7-4) indicate that

$$
\mathcal{T}\left(|G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}|\right) = \begin{cases} |G_{j_a}^{\tau_a}\rangle\langle G_{j_b}^{\tau_b}| & \text{if } |G_{j_a}^{\tau_a}\rangle = |G_{j_b}^{\tau_b}\rangle \\ \mathbf{0} & \text{otherwise} \end{cases}.
$$
\n(A15)

Next, consider a Gedankenexperiment where the operation T is performed on the sampled states $n \in \mathcal{M}$ before the measurement \mathcal{O} . Subsequently, this rotation is applied to the unsampled states $n \in \mathcal{N} \backslash \mathcal{M}$. Accord-ing to [\(A15\)](#page-7-5), the rotation $\mathcal T$ on the unsampled states neither affects the measurement outcome r nor the average fidelity of the unsampled states \bar{f} . In this context, the operation considered in the Gedankenexperiment is equivalent to the operation $\mathcal{O} = \mathcal{O} \circ \mathcal{T}$, i.e., both the rotation and the measurement are performed only on the sampled states.

Furthermore, since the rotation $\mathcal T$ on the unsampled states commutes with the measurement \mathcal{O} , the operation $\mathcal O$ is also equivalent to an operation where the rotation $\mathcal T$ is applied to all noisy [GHZ](#page-0-4) states prior to measurement $\mathcal O$. Given these two equivalences, to analyze the performance of the operation $\hat{\mathcal{O}}$, it is equivalent to consider the scenario in which the rotation $\mathcal T$ is applied to all noisy [GHZ](#page-0-4) states before measurement.

An arbitrary $N \times L$ qubits state can be expressed in the [GHZ](#page-0-4) states basis as follows.

where $|\phi_{k,n}\rangle, |\psi_{k,n}\rangle$ are [GHZ](#page-0-4) states, i.e., $|\phi_{k,n}\rangle, |\psi_{k,n}\rangle \in$ \mathcal{G}_L , and K is the set of all terms with non-zero coefficients $c_k \in \mathbb{C}$. Substituting [\(A15\)](#page-7-5) into [\(A16\)](#page-7-6), we find that after applying the rotation $\mathcal T$ to the qubits, their joint state is

where [\(A20b\)](#page-7-8) holds because of [\(A18\)](#page-7-9), i.e., $\mathcal T$ converts an arbitrary state to a separable state, [\(A20c\)](#page-7-10) holds because $\mathcal{O}^*, \mathcal{D}^*$ is the optimal solution to \mathscr{P}_2 .

Moreover, because $S_{\text{arb}} \supset S_{\text{sp}}$,

We have proved in [\[31,](#page-15-17) Lem. B.3] that the objective function of $\mathscr{P}\text{-}6$, when divided by $\binom{N}{M}$, is the lower bounded by (27) . This proves Lemma $\dddot{4}$.
