# $C^2$ ESTIMATES FOR k-HESSIAN EQUATIONS AND A RIGIDITY THEOREM

#### RUIJIA ZHANG

ABSTRACT. We derive a concavity inequality for k-Hessian operators under the semi-convexity condition. As an application, we establish interior estimates for semi-convex solutions of the k-Hessian equations with vanishing Dirichlet boundary and obtain a Liouville-type result. Additionally, we provide new and simple proofs of Guan-Ren-Wang's work [12] on global curvature estimates for k-curvature equations.

#### 1. Introduction

In this paper, we consider the following k-Hessian equations with Dirichlet boundary

$$\begin{cases} \sigma_k(D^2 u) = f(x, u, \nabla u) & \text{in } \Omega, \\ u = 0 & \text{on } \partial\Omega, \end{cases}$$
 (1.1)

where  $\Omega$  is a bounded domain in  $\mathbb{R}^n$ , f is a positive function in  $\overline{\Omega} \times R \times R^n$ , u is a function defined in  $\overline{\Omega}$ . Here we denote by  $\nabla u$  and  $D^2u$  the gradient of u and the Hessian of u, respectively.  $\sigma_k$  is the k-th elementary symmetric polynomial of  $\lambda = (\lambda_1, \ldots, \lambda_n) \in \mathbb{R}^n$ , which is defined as

$$\sigma_k(x) = \sum_{1 \leq i_1 < i_2 \dots < i_k \leq n} \lambda_{i_1} \lambda_{i_2} \dots \lambda_{i_k}, \quad \forall i = 1, \dots, n.$$

Let  $\lambda$  be the eigenvalues of  $D^2u$ . Then the k-Hessian operator of u is defined by  $\sigma_k(D^2u) = \sigma_k(\lambda(D^2))$ .

Research on the k-Hessian equation

$$\sigma_k(D^2u) = f(x, u, \nabla u) \tag{1.2}$$

is a vital area within PDE and geometric analysis. We note that (1.2) simplifies to a semilinear equation when k = 1. For  $2 \le k \le n$ , establishing second-order a priori estimates is essential for proving the existence of solutions to these fully nonlinear equations. Pogorelov was the first to investigate the interior  $C^2$  estimates for the Monge-Ampére equations, as referred to in [10,17]. For general k, Chou-Wang [7] established the Pogorelov estimates for k-convex solutions of the k-Hessian equation

$$\begin{cases} \sigma_k(D^2 u) = f(x, u) & \text{in } \Omega \\ u = 0 & \text{on } \partial\Omega, \end{cases}$$
 (1.3)

where f is independent of  $\nabla u$ . They proved that

$$(-u)^{\beta} \Delta u \leqslant C$$

for some constants  $\beta > 1$  and C > 0 depending on n, k, inf  $f, ||f||_{C^{1,1}}, ||u||_{C^1}$  but independent of  $\Omega$ . Following [3], we define the k-convex function by : For a domain  $\Omega \in \mathbb{R}^n$ , a function  $u \in C^2(\Omega)$  is called k-convex (or k-admissible) if the eigenvalues  $\lambda(X)$  of the Hessian  $D^2u$  are in  $\Gamma_k$  (defined by (2.1)) for all  $X \in \Omega$ . We note that for all k-convex functions u, the k-Hessian operator is elliptic, i.e.,

$$\dot{\sigma}_k^{ij} = \frac{\partial \sigma_k}{\partial u_{ij}}$$

is positive-definite. In the following text, we consider the k-Hessian equation in this realm.

We extend Theorem 1.5 by Chou-Wang [7] to cases where f depends on  $\nabla u$ , under an additional convexity assumption for the function u. We refer to the function u as semi-convex if there exists a constant A > 0 such that the eigenvalues  $\lambda$  of  $D^2u$  satisfy

$$\lambda_i(D^2u(x)) \geqslant -A$$
, for all  $x \in \Omega$ 

for any  $1 \leq i \leq n$ . We have obtained the following interior estimates for semi-convex solutions of Equation (1.1).

**Theorem 1.1.** Assume that  $f \in C^2(\Omega \times R \times R^n)$  satisfies  $f > f_0 > 0$  for a constant  $f_0 > 0$  in  $\overline{\Omega}$ . Then, for any semi-convex k-admissible solution of the Dirichlet problem of the equation (1.1) provided  $2 < k \le n - 1$ , we have

$$(-u)^{\alpha} \Delta u \leqslant C.$$

where  $\alpha > 0$  and C > 0 depend on  $n, k, f_0, ||f||_{C^{1,1}}, ||u||_{C^1}$  but are independent of  $\Omega$ .

Remark 1.1. The interior estimates in Theorem 1.1 were derived by Li-Ren-Wang [15] under the assumption that u is in the (k+1)-convex cone. Tu proved the interior estimates in Theorem 1.1 by using a test function involving  $|X|^2$  in [23]. Both of the results mentioned above depend on the diameter of the domain  $\Omega$ . In the proof of Theorem 1.1, we carry on with the method in [7] by Chou-Wang and have obtained estimates independent of  $\Omega$ .

Using this class of interior estimates, we further derive a rigidity theorem for entire solutions in  $\mathbb{R}^n$  to

$$\sigma_k(D^2 u) = 1. (1.4)$$

It has long been a question of concern whether an entire function u in n-dimensional Euclidean space satisfying (1.4) is quadratic. For k = 1, the Liouville property of harmonic functions implies rigidity results for solutions with bounded Hessian. For k = n, the Jörgens-Calabi-Pogorelov theorem confirms the rigidity results for all convex entire solutions. Cheng and Yau [6] provided an alternative geometric proof. For k = 2, Chang and Yuan [4] proved that the entire solution to 2-Hessian equation (1.4) in  $\mathbb{R}^n$  is quadratic if

$$D^2 u \geqslant \delta - \sqrt{2}n(n-1)I$$

for any  $\delta > 0$ . For  $2 \leq k \leq n-1$ , the authors also guess that the rigidity theorem holds true under the semi-convexity assumption

$$D^2u \geqslant -AI$$

with arbitrarily large constant A > 0. Warren [24] constructed a class of non-trivial solutions to (1.4), which are neither semi-convex nor exhibit quadratic growth. Shankar and Yuan [20] obtained the rigidity theorem for k = 2 under the semi-convexity assumption. For a general k, the rigidity problem for the k-Hessian equation remains open. Assuming a quadratic

growth condition, Bao-Chen-Guan-Ji [2] showed that strictly convex entire solutions to (1.4) are quadratic, Li-Ren-Wang [15] extended the convexity assumption to (k + 1)-convexity, and Chu-Dinew [9] further relaxed the condition to

$$\sigma_{k+1} > -A \tag{1.5}$$

for some A > 0 (see also [23]). A function u is said to have quadratic growth if there exists constants b, c > 0 and sufficient large R > 0, such that the following inequality holds:

$$u(x) \geqslant c|x|^2 - b$$
, for  $|x| \geqslant R$ . (1.6)

In this paper, we confirm Chang-Yang's conjecture under the quadratic growth condition.

**Theorem 1.2.** Given  $2 < k \le n-1$ , let u be any semi-convex entire function in  $\mathbb{R}^n$  with  $\lambda(D^2u) \in \Gamma_k$  that satisfies

$$\sigma_k(D^2u) = 1 \tag{1.7}$$

and exhibits quadratic growth. Then, u is a quadratic polynomial.

To establish the curvature estimates and derive the rigidity theorem, the main difficulty to overcome is how to deal with the third order derivatives. It is well known that  $\sigma_k^{\frac{1}{k}}$  is concave in the  $\Gamma_k$  cone, which is very useful to deal with these terms. It's worth noting that Ren and Wang [18] established the concavity inequality of the Hessian operator for k = n - 1. They proved that

**Theorem 1.3.** [18] Given two positive constants  $\delta < 1$ ,  $\varepsilon$ , for any index i, if  $\kappa_i \geqslant \delta \kappa_1$  and the positive constant K depending only on  $\delta$  and  $\varepsilon$  is sufficient large, then we have

$$\kappa_{i}[K(\sigma_{n-1})_{i}^{2} - \sigma_{n-1}^{pp,qq}h_{ppi}h_{qqi}] - \sigma_{n-1}^{ii}h_{iii}^{2} + (1+\varepsilon)\sum_{j\neq i}\sigma_{n-1}^{jj}h_{jji}^{2} \geqslant 0.$$
 (1.8)

In [18], they also pointed out that the inequality (1.8) is not true even if i = 1,  $\sigma_k = 1$  and  $k_1$  is sufficient large for k < n - 1. Besides, Guan and Qiu [11] established the interior  $C^2$  estimates of  $\sigma_2$ -Hessian equation under the assumption  $\sigma_3 \ge -A$  for some constant A > 0. In their work, it's crucial to observe that under the condition  $\sigma_3 \ge -A$  and  $\kappa_1$  large enough

$$-\sum_{i\neq j} u_{ii1} u_{jj1} + C \frac{(\dot{\sigma}_2^{ii} u_{ii1})^2}{\sigma_2} \geqslant (1 + \delta_0) \frac{\dot{\sigma}_2^{11} u_{111}^2}{u_{11}^2}$$
(1.9)

for some constant C > 0 and  $\delta_0 > 0$ . (1.9) is basically the similar form of (1.8) and is derived by using Chen's [5] work about the optimal concavity of the  $\sigma_2$  operators with the eigenvector decomposition method. We note that the method makes sense only for k = 2 since the Hessian operator is the identity metric. It's difficult to generalize this method to other cases. Moreover, it reminds us that the concavity inequality of the general k-Hessian operator may also hold true under some additional convexity assumption. we develop a method that builds on [12] by Guan-Ren-Wang and [13] by Hong-Zhang which is grounded in the crucial observation of the concavity of  $q_k = \frac{\sigma_k}{\sigma_{k-1}}$ , introduced by Huisken-Sinestrari in [14]. Under the semi-convexity condition, we derive a concavity inequality which plays a crucial role in establishing curvature estimates of the Dirichlet problem of k-Hessian equations (1.1) and (5.1).

**Lemma 1.1.** Assume  $\{\lambda_i\} \in \Gamma_k$ ,  $\lambda_1 \geqslant \lambda_2 \cdots \geqslant \lambda_n$ , and  $\lambda_n > -A$  for a constant A > 0. Then there exists some constant C > 0 depending on n, k,  $\sigma_k$ , A and small constant  $\delta_0 > 0$  depending on k such that if  $k_1 \geqslant C$ , then the following inequality holds

$$-\sum_{p\neq q} \frac{\sigma_k^{pp,qq} \xi_p \xi_q}{\sigma_k} + K \frac{(\sum_i \sigma_k^{ii} \xi_i)^2}{\sigma_k^2} + 2\sum_{i>1} \frac{\sigma_k^{ii} \xi_i^2}{(\lambda_1 + A + 1)\sigma_k} \geqslant (1 + \delta_0) \frac{\dot{\sigma}_k^{11} \xi_1^2}{\lambda_1}$$
(1.10)

for some sufficient large K > 0 (depending on  $\delta_0$ ) where  $\xi = (\xi_1, \dots, \xi_n)$  is an arbitrary vector in  $\mathbb{R}^n$ .

In the following text, we note that  $\sigma_{k+1} > -A$  implies that  $\lambda_i > -C(n, k, \sigma_k, A)$  by using Lemma 2.2. In other words, the semi-convexity of  $\{\lambda_i\}$  is a weaker condition, which means that Lemma 1.1 is useful in deriving Guan-Qiu's [11] interior curvature estimates. Besides, Lemma 1.1 removes the additional assumption that  $|\kappa_n| \ge \delta_0$  for some constant  $\delta_0 > 0$  from Hong and Zhang [13] by employing an enhanced and concise approach.

Using the proof in Lemma 1.1, we also improve Lemma 3.1 from Lu [16] and present it as Lemma 3.1. In [16], the concavity inequality, Lemma 3.1, plays a crucial role in obtaining curvature estimates for admissible solutions to prescribed curvature measure type problem in hyperbolic space (referencing [25]). We present Lemma 3.1 in [16] here for ease of comparision.

**Lemma 1.2** ([16]). Let  $\lambda = (\lambda_1, \dots, \lambda_n) \in \Gamma_k$  with  $\lambda_1 \geqslant \dots \geqslant \lambda_n$  and let  $1 \leqslant l < k$ . For any  $\epsilon, \delta, \delta_0 \in (0, 1)$ , there exists a constant  $\delta' > 0$  depending only on  $\epsilon, \delta, \delta_0, n, k$  and l such that if  $\lambda_l \geqslant \delta \lambda_1$  and  $\lambda_{l+1} \leqslant \delta' \lambda_1$ , then we have

$$-\sum_{p\neq q} \frac{\sigma_k^{pp,qq} \xi_p \xi_q}{\sigma_k} + \frac{\left(\sum_i \sigma_k^{ii} \xi_i\right)^2}{\sigma_k^2} \geqslant (1 - \epsilon) \frac{\xi_1^2}{\lambda_1^2} - \delta_0 \sum_{i>l} \frac{\sigma_k^{ii} \xi_i^2}{\lambda_1 \sigma_k},$$

where  $\xi = (\xi_1, \dots, \xi_n)$  is an arbitrary vector in  $\mathbb{R}^n$ .

As a matter of fact, it's clear that if  $\lambda_n > -A$  for a constant A > 0 and  $\lambda_1$  is large enough, then  $\dot{\sigma}_k^{11} \geqslant \frac{\sigma_k}{\lambda_1}$ , which implies that Lemma 1.1 is a development of Lemma 1.2.

Moreover, Lemma 1.1 can be regarded as an extension of Lemma 3.3 by Chu [8] under a weaker convexity assumption. By applying Lemma 3.3 from [8], Chu gave a simple proof of Theorem 1.1 by Guan, Ren and Wang [12], which established the curvature estimate for convex hypersurfaces satisfying the Weingarten curvature equation

$$\sigma_k(\kappa(X)) = f(X, \nu(X)), \quad \forall X \in M^n,$$
 (1.11)

where  $f \in C^2(\Gamma)$  is a positive function and  $\Gamma$  is an open neighborhood of the unit normal bundle of M in  $\mathbb{R}^{n+1} \times \mathbb{S}^n$ ,  $\kappa(X)$  denotes the principal curvatures,  $\nu(X)$  is the unit outer normal vector at point X, and  $\sigma_k$  represents the k-th mean curvature.

In Remark 4.7 of Guan-Ren-Wang [12], they also deduced the following curvature estimates under a weaker convexity condition. Let  $M^n \in \mathbb{R}^{n+1}$  be a closed hypersurface. We say a hypersurface M is semi-convex if there exists a constant A > 0 such that its principal curvatures satisfy

$$\kappa_i(X) \geqslant -A, \quad 1 \leqslant i \leqslant n, \quad \forall X \in M.$$

**Theorem 1.4** (Guan-Ren-Wang, [12]). For any closed semi-convex hypersurface  $M^n$  satisfying the curvature equation (1.11), there exists a constant C > 0 depending on n, k,  $||M||_{C^1}$ , inf f, and  $||f||_{C^2}$  such that

$$\max_{X \in M} \kappa_i(X) \leqslant C.$$

In the specific case where k=2, they completely resolved the problem.

**Theorem 1.5** (Guan-Ren-Wang, [12]). For the solution of the curvature equation (1.1) with k = 2, it holds that

$$\max_{X \in M} \kappa_i(X) \leqslant C$$

where C > 0 is a constant that depends on n, k,  $||M||_{C^1}$ ,  $\inf f$  and  $||f||_{C^2}$ .

As an application of Lemma 1.1, we also offer new simple proofs of Theorem 1.4 and Theorem 1.5. As mentioned in Remark 4.7 of [12], the curvature estimates in Theorem 1.4 can be obtained by considering the test function

$$\log P(\kappa(X)) + g(u) + a|X|^2$$

where P is a symmetric polynomial of the principal curvatures. It should be noted that Spruck-Xiao [21] provided a simplified proof of Theorem 1.5. Chu proved Theorem 1.4 more simply by assuming further that  $M^n$  is a closed convex hypersurface. In both of these works, the maximum principle was applied to a quantity involving the maximal principal curvature rather than the symmetric curvature function  $P(\kappa)$ . In what follows, we continue with this approach and use Lemma 1.1 to prove these results.

The paper is organized as follows. In Section 2, we collect and prove some algebraic properties of symmetric polynomials. In Section 3, we prove the crucial Lemma concerning the superior concavity of k-Hessian operator. In Section 4, we derive the Pogorelov estimates for the k-Hessian equation with vanishing Dirichlet boundary and complete the proof of Theorem 1.1. In Section 5, we prove the rigidity theorem and complete the proof of Theorem 1.2. In Section 6, we provide a new and simple proof of Guan-Ren-Wang's famous work [12] by using Lemma 1.1 derived in Section 3.

#### 2. Preliminaries

2.1. **Symmetric function.** Here we state some algebraic properties of the elementary symmetric function  $\sigma_m(\lambda)$ ,  $m = 1, \dots, n$ , where  $\lambda = (\lambda_1, \dots, \lambda_n)$ . We recall  $\sigma_m(\lambda)$  defined by

$$\sigma_m(\lambda) = \sum_{1 \le i_1 < \dots < i_m \le n} \lambda_{i_1} \cdots \lambda_{i_m}, \quad m = 1, 2, \dots, n.$$

The Garding cone  $\Gamma_m$  is an open symmetric convex cone in  $\mathbb{R}^n$  with vertex at the origin, given by

$$\Gamma_m = \{ (\lambda_1, \dots, \lambda_n) \in \mathbb{R}^n | \sigma_j(\lambda) > 0, \forall j = 1, \dots, m \}.$$
(2.1)

Clearly  $\sigma_m(\lambda) = 0$  for  $\lambda \in \partial \overline{\Gamma}_m$  and

$$\Gamma_n \subset \cdots \subset \Gamma_m \subset \cdots \subset \Gamma_1$$
.

In particular,  $\Gamma^+ = \Gamma_n$  is called the positive cone,

$$\Gamma^+ = \{(\lambda_1, \cdots, \lambda_n) \in \mathbb{R}^n | \lambda_1 > 0, \cdots, \lambda_n > 0\}.$$

Always assume  $\lambda_1 \geqslant \lambda_2 \geqslant \cdots \geqslant \lambda_n$ . We collect some properties of  $\sigma_k(\lambda)$  where  $\lambda \in \Gamma_k$ :

- (1)  $\sum_{p=1}^{n} \frac{\partial \sigma_{k}}{\partial \lambda_{p}} \lambda_{p}^{2} = \sigma_{1} \sigma_{k} (k+1) \sigma_{k+1}.$ (2)  $\sum_{p=1}^{n} \frac{\partial \sigma_{k}}{\partial \lambda_{p}} = (n-k+1) \sigma_{k-1}.$ (3)  $\frac{\partial \sigma_{k}}{\partial \lambda_{n}} \geqslant \cdots \geqslant \frac{\partial \sigma_{k}}{\partial \lambda_{1}} > 0.$ (4)  $\frac{\partial \sigma_{k}}{\partial \lambda_{1}} \lambda_{1} \geqslant \frac{k}{n} \sigma_{k}.$ (5)  $q_{k} := \frac{\sigma_{k}}{\sigma_{k-1}} \text{ is concave, i.e., } \partial_{\xi}^{2} q_{k} \leqslant 0 \text{ for any } \xi \in \mathbb{R}^{n}.$
- (6) For any s < k,  $\sigma_s > \lambda_1 \lambda_2 \cdots \lambda_s$ .

**Lemma 2.1.** Assume that  $\{\lambda_i\} \in \Gamma_k$  and  $\lambda_1 \geqslant \lambda_2 \cdots \geqslant \lambda_n$ . Then  $\lambda_k > 0$  and  $|\lambda_n| < 1$  $(n-k)\lambda_k$ .

*Proof.* From Property (3), we have

$$\frac{\partial \sigma_k}{\partial \lambda_1 \cdots \partial \lambda_{k-1}} = \lambda_k + \cdots + \lambda_n > 0.$$

Suppose only  $\lambda_n$  is negative, then  $(n-k)\lambda_k > |\lambda_n|$ .

**Lemma 2.2.** Assume that  $\{\lambda_i\} \in \Gamma_k$ ,  $\lambda_1 \geq \lambda_2 \cdots \geq \lambda_n$ , and  $\sigma_k(\lambda)$  bounded from upper and below. If  $\sigma_{k+1} > -A$  for any positive constant A, then  $\lambda$  is semi-convex, i.e.,  $\lambda_{\min} >$ -C(n,k,A).

*Proof.* There exists constant C > 0, such that

$$\frac{\partial \sigma_k}{\partial \lambda_n} \lambda_n^2 \leqslant \sum_i \frac{\partial \sigma_k}{\partial \lambda_i} \lambda_i^2 = \sigma_1 \sigma_k - (k+1)\sigma_{k+1} < C\sigma_1 + (k+1)A. \tag{2.2}$$

Then by Property (3) we have

$$\sum_{i} \frac{\partial \sigma_k}{\partial \lambda_i} \lambda_n^2 < nC\sigma_1 + n(k+1)A.$$

Combining  $(n-k+1)\sigma_{k-1} = \sum_{i} \frac{\partial \sigma_k}{\partial \lambda_i}$  and Property (6), Lemma 2.1, there exists constant C(n,k) > 0

$$C'(n,k)|\lambda_n|^{k+1} \leqslant C(n,k)|\lambda_n|^k \lambda_1 < Cn\lambda_1 + (k+1)A.$$

Thus we get  $|\lambda_n| < C(n, k, A)$  by Lemma 2.1, completing the proof.

**Lemma 2.3.** Assume  $\{\lambda_i\} \in \Gamma_k$  and  $\lambda_1 \geqslant \lambda_2 \cdots \geqslant \lambda_n$ . If  $\lambda_n > -A$ , then  $\lambda_k < C(\sigma_k, n, A)$ .

*Proof.* Assume that  $\lambda_{k-1} > A$ , otherwise  $\lambda_k \leq A$ , then we are done. Since

$$\sigma_k = \sum_{1 \leqslant i_1 \leqslant i_2 \dots \leqslant i_k \leqslant n} \lambda_{i_1} \lambda_{i_2} \dots \lambda_{i_k} > 0.$$

We have

$$\lambda_1 \cdots \lambda_{k-1} \lambda_k \leqslant \sigma_k - C(n, k) \lambda_1 \cdots \lambda_{k-1} \lambda_n. \tag{2.3}$$

Thus

$$\lambda_{k} \leqslant 2 \left(\frac{\sigma_{k}}{\lambda_{1}}\right)^{\frac{1}{k-1}} + 2C(n,k)|\lambda_{n}|$$

$$\leqslant 2 \left(\frac{n\sigma_{k}}{\sigma_{1}}\right)^{\frac{1}{k-1}} + 2C(n,k)A$$

$$\leqslant c(n,k)\sigma_{k}^{\frac{1}{k}} + C(n,k,A).$$
(2.4)

Here we use Property (6) in the second inequality, the last inequality follows from Maclaurin's inequality. Thus there exists some constant C > 0, such that  $\lambda_k \leq C$ , which depends on the bounds of  $\sigma_k$ , n and A.

**Lemma 2.4.** If  $\{\lambda_i\} \in \Gamma_k \text{ and } \lambda_1 \geqslant \lambda_2 \cdots \geqslant \lambda_n, \text{ then } \sigma_{k-1} \geqslant C\lambda_1^{\frac{1}{k-1}}$ .

*Proof.* Using Newton inequality and Property (6), we have

$$\sigma_{k-1} \geqslant C(n,k)\sigma_1^{\frac{1}{k-1}}\sigma_k^{\frac{k-2}{k-1}} \geqslant C\lambda_1^{\frac{1}{k-1}}.$$
 (2.5)

We point out that we will denote C, c or  $C_i$  and  $c_i$  for i = 1, 2, ..., n as some positive constants throughout the subsequent sections, and these constants may change from line to line. Now we state a crucial calculation by Huisken-Sinestrari [14].

**Lemma 2.5.** Given  $k \ge 2$ , if  $\{\lambda_i\} \in \Gamma_k$ , then for any  $\xi \in \mathbb{R}^n$ ,

If  $\xi \perp \gamma$ , then  $-\sigma_1 \partial_{\xi}^2 q_2 \geqslant |\xi|^2$  by (2.6). More generally, we have the following lemmas that are crucial to the proof of Lemma 1.1.

### 3. A CONCAVITY INEQUALITY

In this section, we define

$$\dot{\sigma}_k^{pp}(\lambda) = \frac{\partial \sigma_k}{\partial \lambda_p}, \quad \ddot{\sigma}_k^{pp,qq}(\lambda) = \frac{\partial^2 \sigma_k}{\partial \lambda_p \partial \lambda_q}.$$

Subsequently, we provide the proof of the crucial Lemma 1.1.

$$\dot{\sigma}_k^{11} = \lambda_\alpha \ddot{\sigma}_k^{11,\alpha\alpha} + \sigma_{k-1}(\lambda|1,\alpha), \tag{3.15}$$

$$\dot{\sigma}_k^{\alpha\alpha} = \lambda_1 \ddot{\sigma_k}^{11,\alpha\alpha} + \sigma_{k-1}(\lambda|1,\alpha). \tag{3.16}$$

If  $\sigma_{k-1}(\lambda|1,\alpha) \leq 0$ , then due to (3.15)  $\lambda_{\alpha} > 0$  and

$$\frac{\lambda_{\alpha}}{\lambda_{1}}\dot{\sigma}_{k}^{\alpha\alpha} = \lambda_{\alpha}\ddot{\sigma}_{k}^{11,\alpha\alpha} + \frac{\lambda_{\alpha}}{\lambda_{1}}\sigma_{k-1}(\lambda|1,\alpha) \geqslant \dot{\sigma}_{k}^{11}.$$
(3.17)

If  $\sigma_{k-1}(\lambda|1,\alpha) > 0$ , using the Maclaurin's inequality, we have

$$\sigma_{k-1}(\lambda|1,\alpha)^{\frac{k-2}{k-1}} \leqslant \sigma_{k-2}(\lambda|1,\alpha). \tag{3.18}$$

Since

$$\sigma_{k-1}(\lambda|1,\alpha) \leqslant C\lambda_2\lambda_3\cdots\lambda_{k-1}\lambda_k \leqslant C\lambda_1^{k-2}C(A),$$

multiplying it with (3.18) we obtain

$$\sigma_{k-1}(\lambda|1,\alpha) \leqslant C\lambda_1^{-\frac{1}{k-1}}(\lambda_1\ddot{\sigma_k}^{11,\alpha\alpha}).$$

Then using Property (4), we have

$$\left(\frac{\lambda_{\alpha}}{\lambda_{1}} + C\lambda_{1}^{-\frac{1}{k-1}}\right)\dot{\sigma}_{k}^{\alpha\alpha} \geqslant \left(\frac{\lambda_{\alpha}}{\lambda_{1}} + C\lambda_{1}^{-\frac{1}{k-1}}\right)\lambda_{1}\ddot{\sigma}_{k}^{11,\alpha\alpha} \geqslant \dot{\sigma}_{k}^{11} \geqslant \frac{k\sigma_{k}}{n\lambda_{1}}, \quad \text{for } \lambda_{\alpha} > 0, \tag{3.19}$$

and

$$C\lambda_1^{-\frac{1}{k-1}}\dot{\sigma}_k^{\alpha\alpha} \geqslant (\frac{\lambda_\alpha}{\lambda_1} + C\lambda_1^{-\frac{1}{k-1}})\lambda_1\ddot{\sigma}_k^{11,\alpha\alpha} \geqslant \dot{\sigma}_k^{11} \geqslant \frac{k\sigma_k}{n\lambda_1}, \quad \text{for } \lambda_\alpha \leqslant 0.$$
 (3.20)

We now divide it into two cases. We assume that there exists some positive constant C.

If  $\lambda_{\alpha} \leqslant C\lambda_{1}^{\frac{\kappa-2}{k-1}}$ , then by (3.17), (3.19) and (3.20), we obtain that

$$C\lambda_1^{-\frac{1}{k-1}}\dot{\sigma}_k^{\alpha\alpha} \geqslant \frac{1}{\lambda_1}.\tag{3.21}$$

For any  $k \leq p \leq n$ ,  $|\lambda_p| \leq C(A)$  by Lemma 2.3. Then (3.14) becomes

$$-2\frac{\left(\dot{\sigma}_{k-1}^{11}\dot{\sigma}_{k-1}^{pp} - \ddot{\sigma}_{k-1}^{11,pp}\sigma_{k-1}\right)\xi_{1}\xi_{p}}{\sigma_{k-1}^{2}} \geqslant -\frac{\varepsilon\xi_{1}^{2}}{4(n-1)\lambda_{1}^{2}} - \frac{C\frac{\partial\sigma_{k}}{\partial\lambda_{p}}\xi_{p}^{2}}{\varepsilon\lambda_{1}^{\frac{k}{k-1}}}.$$
(3.22)

For any  $1 < i \le k-1$  and  $\lambda_i \le C\lambda_1^{\frac{k-2}{k-1}}$ , (3.13) becomes

$$-2\frac{\left(\dot{\sigma}_{k-1}^{11}\dot{\sigma}_{k-1}^{ii} - \ddot{\sigma}_{k-1}^{11,ii}\sigma_{k-1}\right)\xi_{1}\xi_{i}}{\sigma_{k-1}^{2}} \geqslant -\frac{\varepsilon\xi_{1}^{2}}{4(n-1)\lambda_{1}^{2}} - \frac{4(n-1)C^{2}\xi_{i}^{2}}{\varepsilon\lambda_{1}^{2}} \geqslant -\frac{\varepsilon\xi_{1}^{2}}{4(n-1)\lambda_{1}^{2}} - \frac{C\dot{\sigma}_{k}^{ii}\xi_{i}^{2}}{(\varepsilon\lambda_{1}^{\frac{1}{k-1}})\lambda_{1}}.$$

$$(3.23)$$

If  $\lambda_{\alpha} \geqslant C\lambda_{1}^{\frac{k-2}{k-1}}$ , then by (3.17) and (3.19), we obtain that

$$C\frac{\lambda_i}{\lambda_1}\dot{\sigma}_k^{ii} \geqslant \frac{\sigma_k}{\lambda_1}.\tag{3.24}$$

For any  $1 < i \le k-1$  and  $\lambda_i \ge C\lambda_1^{\frac{k-2}{k-1}}$ , (3.13) becomes

$$-2\frac{\left(\dot{\sigma}_{k-1}^{11}\dot{\sigma}_{k-1}^{ii} - \ddot{\sigma}_{k-1}^{11,ii}\sigma_{k-1}\right)\xi_{1}\xi_{i}}{\sigma_{k-1}^{2}} \geqslant -\frac{\varepsilon\xi_{1}^{2}}{4(n-1)\lambda_{1}^{2}} - \frac{C(A)\dot{\sigma}_{k}^{ii}\xi_{i}^{2}}{\varepsilon\lambda_{1}^{2}\lambda_{i}^{3}} \geqslant -\frac{\varepsilon\xi_{1}^{2}}{4(n-1)\lambda_{1}^{2}} - \frac{C\dot{\sigma}_{k}^{ii}\xi_{i}^{2}}{\left(\varepsilon\lambda_{1}^{\frac{1}{k-1}}\right)\lambda_{1}}.$$

$$(3.25)$$

By direct calculation, (3.2) implies that

$$-\sum_{p\neq q} \frac{\sigma_{k}^{pp,qq} \xi_{p} \xi_{q}}{\sigma_{k}} + K \frac{\left(\sum_{i} \sigma_{k}^{ii} \xi_{i}\right)^{2}}{\sigma_{k}^{2}} + 2 \sum_{i>1} \frac{\sigma_{k}^{ii} \xi_{i}^{2}}{(\lambda_{1} + A + 1)\sigma_{k}}$$

$$\geqslant -\frac{\partial_{\xi}^{2} q_{k}}{q_{k}} + \left(1 + (1 - \epsilon) \frac{1}{k}\right) \left(\frac{\dot{\sigma}_{k-1}^{11} \xi_{1}}{\sigma_{k-1}}\right)^{2} - \frac{\varepsilon}{4} \frac{\xi_{1}^{2}}{\lambda_{1}^{2}} + \left(2 - \frac{C}{\epsilon \lambda_{1}^{\frac{1}{k-1}}} - \frac{C(A)}{\lambda_{1}^{2}}\right) \sum_{i>1} \frac{\sigma_{k}^{ii} \xi_{i}^{2}}{\lambda_{1} \sigma_{k}}$$

$$\geqslant -\frac{\partial_{\xi}^{2} q_{k}}{q_{k}} + \left(1 + (1 - \epsilon) \frac{1}{k} - \varepsilon\right) \left(1 - \frac{C_{1}(A)}{\lambda_{1}}\right)^{2} \frac{\xi_{1}^{2}}{\lambda_{1}^{2}} + \left(2 - \frac{C_{2}}{\epsilon \lambda_{1}^{\frac{1}{k-1}}} - \frac{C_{3}(A)}{\lambda_{1}^{2}}\right) \sum_{i>1} \frac{\sigma_{k}^{ii} \xi_{i}^{2}}{\lambda_{1} \sigma_{k}}$$
(3.26)

where we use (3.7) in the last inequality. We choose  $\epsilon = \frac{1}{(k+1)^2}$  and assume that  $\lambda_1 > \max\left\{(k+3)C_1(A), \frac{C_3(A)}{C_2(k+1)^2}\right\}$ . Then (3.26) becomes

$$-\sum_{p\neq q} \frac{\sigma_k^{pp,qq} \xi_p \xi_q}{\sigma_k} + K \frac{\left(\sum_i \sigma_k^{ii} \xi_i\right)^2}{\sigma_k^2} + 2 \sum_{i>1} \frac{\sigma_k^{ii} \xi_i^2}{\lambda_1 \sigma_k}$$

$$\geqslant \frac{k+2}{k+1} \left(1 - \frac{C_1(A)}{\lambda_1}\right)^2 \frac{\xi_1^2}{\lambda_1^2} + \left(2 - \frac{C_2}{\epsilon \lambda_1^{\frac{1}{k-1}}} - \frac{C_3(A)}{\lambda_1^2}\right) \sum_{i>1} \frac{\sigma_k^{ii} \xi_i^2}{\lambda_1 \sigma_k}$$

$$\geqslant \frac{(k+2)^2}{(k+1)(k+3)} \frac{\xi_1^2}{\lambda_1^2} + \left(2 - 2(k+1)^2 \frac{C_2}{\lambda_1^{\frac{1}{k-1}}}\right) \sum_{i>1} \frac{\sigma_k^{ii} \xi_i^2}{\lambda_1 \sigma_k}.$$
(3.27)

Recall that

$$\sigma_k = \lambda_1 \dot{\sigma}_k^{11} + \sigma_k(\lambda|1). \tag{3.28}$$

We note that if

$$\sigma_k(\lambda|1) \geqslant -\frac{\sigma_k}{2(k+2)^2 - 1},\tag{3.29}$$

then (3.27) implies the conclusion (1.10) by assuming  $\lambda_1 \geq (C_2(k+1)^2)^{k-1}$  and choosing  $\delta_0 = \frac{1}{2(k+1)(k+3)}$ .

In the subsequent content, we denote by  $c_0 = \frac{1}{2(k+2)^2-1}$  and suppose that

$$\sigma_k(\lambda|1) < -c_0 \sigma_k. \tag{3.30}$$

Under this assumption we have following claims.

Claim 1:

$$\lambda_k \leqslant C(n,k)|\lambda_n|.$$

From (2.3),

$$\lambda_1 \cdots \lambda_k \leqslant 2\sigma_k \tag{3.31}$$

or

$$\lambda_1 \cdots \lambda_k \leqslant 2C(n,k)\lambda_1 \cdots \lambda_{k-1}|\lambda_n|. \tag{3.32}$$

If we assume that (3.31) holds, then

$$|\sigma_k(\lambda|1)| \leqslant C(n,k)\lambda_2 \cdots \lambda_k^2 \leqslant C'(n,k,A)\frac{\sigma_k}{\lambda_1} < c_0\sigma_k$$
 (3.33)

by assuming  $\lambda_1 > \frac{C'(n,k,A)}{c_0}$ , which is contradict to our assumption above. Thus we complete the proof of the first claim.

Claim 2: there exists some  $c_1, c_2 > 0$  such that  $-\sigma_{k+1} \ge c_1 \lambda_1 \cdots \lambda_{k-1} \lambda_k^2 \ge c_2 \lambda_1$ .

By Claim 1 and (3.33), we have

$$\lambda_1 \cdots \lambda_{k-1} \lambda_n^2 \geqslant c \lambda_1 \cdots \lambda_{k-1} \lambda_k^2 \geqslant \frac{c c_0 \sigma_k}{C(n,k)} \lambda_1$$
 (3.34)

and denote  $c_2 = \frac{cc_0}{C(n,k)}$ . Since  $\sigma_k(\lambda|1) < 0$ , we have  $\lambda_n < 0$  and from (3.4)

$$\sigma_k(\lambda|n) = \sigma_k - \lambda_n \dot{\sigma}_k^{nn} > 0. \tag{3.35}$$

Using Property (6), we get

$$\dot{\sigma}_k^{nn} > \lambda_1 \cdots \lambda_{k-1}. \tag{3.36}$$

We suppose that there exists some large M > 0 (to be chosen later) and  $1 < l \le k - 1$ , such that  $\lambda_1 > M^k$ ,  $\lambda_l > M$  and  $\lambda_{l+1} \le M$  in the following proof. By (3.4), (3.36) and Property (1), we have

$$\lambda_{1} \cdots \lambda_{k-1} \lambda_{n}^{2} \leqslant \dot{\sigma}_{k}^{nn} \lambda_{n}^{2} \leqslant \sum_{p=l+1}^{n} \dot{\sigma}_{k}^{pp} \lambda_{p}^{2}$$

$$= \sum_{i=1}^{l} \lambda_{i} (\lambda_{i} \dot{\sigma}_{k}^{ii} + \sigma_{k}(\lambda | i)) + \sum_{p=l+1}^{n} \lambda_{p} \sigma_{k} - \sum_{i=1}^{l} (\lambda_{i} \dot{\sigma}_{k+1}^{ii} + \sigma_{k+1}(\lambda | i))$$

$$- (k+1-l) \sigma_{k+1} - \sum_{i=1}^{l} \dot{\sigma}_{k}^{ii} \lambda_{i}^{2}$$

$$= \sum_{p=l+1}^{n} \lambda_{p} \sigma_{k} - \sum_{i=1}^{l} \sigma_{k+1}(\lambda | i) - (k+1-l) \sigma_{k+1}.$$
(3.37)

We now show that by using Lemma 2.1 for any  $1 \le i \le k-1$ 

$$|\sigma_{k+1}(\lambda|i)| \leqslant \frac{C(n,k)\lambda_1 \cdots \lambda_{k-1}\lambda_k^3}{\lambda_i} \leqslant \frac{C_1(A)}{M}\lambda_1 \cdots \lambda_{k-1}\lambda_n^2.$$
 (3.38)

Applying (3.34), we have

$$\sum_{n=l+1}^{n} \lambda_p \sigma_k \leqslant c_1 M^2 \leqslant \frac{c_1 \lambda_1}{M} \leqslant \frac{\lambda_1 \cdots \lambda_{k-1} \lambda_n^2}{M}.$$
 (3.39)

Then by choosing  $M \geqslant \max\{\frac{\sigma_k}{c_1}, 2(1+(k-1)C_1\})$ , we obtain

$$-\sigma_{k+1} \geqslant \frac{\lambda_1 \cdots \lambda_{k-1} \lambda_n^2}{4},\tag{3.40}$$

which complete the proof of Claim 2.

Claim 3: There exists some  $c_3, c_4 > 0$  such that  $c_3 \frac{\lambda_1 \cdots \lambda_k^2}{\lambda_1^2} \leqslant \dot{\sigma}_k^{11} \leqslant c_4 \frac{\lambda_1 \cdots \lambda_k^2}{\lambda_1^2}$ .

Combining Claim 2, we have

$$-\sigma_k(\lambda|1) = \frac{-\sigma_{k+1} - \sigma_{k+1}(\lambda|1)}{\lambda_1} \leqslant \frac{-\sigma_{k+1} + C\lambda_2 \cdots \lambda_k^3}{\lambda_1} \leqslant \frac{-\sigma_{k+1}(1 + \frac{C}{\lambda_1})}{\lambda_1}.$$
 (3.41)

For the same reason

$$-\sigma_k(\lambda|1) \geqslant \frac{-\sigma_{k+1}(1 - \frac{C}{\lambda_1})}{\lambda_1}.$$
 (3.42)

Then by using the assumption  $\sigma_k(\lambda|1) < -c_0$  and Claim 2, we have

$$\dot{\sigma}_k^{11} = \frac{\sigma_k - \sigma_k(\lambda|1)}{\lambda_1} \geqslant C \frac{-\sigma_k(\lambda|1)}{\lambda_1}$$

$$\geqslant c_4 \frac{\lambda_2 \cdots \lambda_k^2}{\lambda_1^2}.$$
(3.43)

For the same reason, we have

$$\dot{\sigma}_k^{11} \leqslant c_3 \frac{\lambda_2 \cdots \lambda_k^2}{\lambda_1^2} \tag{3.44}$$

which complete the proof of *Claim 3*.

We denote by  $\alpha = (\lambda_1, \dots, \lambda_n)$ ,  $e_1 = (1, 0, \dots, 0)$  and  $\gamma = (0, \gamma_2, \dots, \gamma_k, \dots, \gamma_n)$ . Now we assume that

$$\xi = (1+a)\frac{\alpha\xi_1}{\lambda_1} - a\xi_1 e_1 + \gamma \tag{3.45}$$

and

$$(\gamma_k, \dots, \gamma_n) \perp (\lambda_k, \dots, \lambda_n).$$
 (3.46)

Then by Lemma 2.9 the first term of the right side of (3.26) becomes

$$-\frac{\partial_{\xi}^{2} q_{k}}{q_{k}} = -(-a\xi_{1}e_{1} + \gamma)_{p} \frac{\ddot{q}_{k}^{pp,qq}}{q_{k}} (-a\xi_{1}e_{1} + \gamma)_{q}$$

$$= -2a^{2}\xi_{1}^{2} \frac{\dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}} \left( \frac{\dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k}^{11}}{\sigma_{k}} \right) - \frac{\partial_{\gamma}^{2} q_{k}}{q_{k}}$$

$$+ 2a\xi_{1}\gamma_{\alpha} \left( \frac{\ddot{\sigma}_{k}^{11,\alpha\alpha}}{\sigma_{k}} - \frac{\dot{\sigma}_{k}^{\alpha\alpha}}{\sigma_{k}} \frac{\dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k}^{11}}{\sigma_{k}} \frac{\dot{\sigma}_{k-1}^{\alpha\alpha}}{\sigma_{k-1}} + 2\frac{\dot{\sigma}_{k-1}^{11,\alpha\alpha}}{\sigma_{k-1}^{2}} - \frac{\ddot{\sigma}_{k-1}^{11,\alpha\alpha}}{\sigma_{k-1}} \right).$$
(3.47)

By direct calculation, we obtain following equations:

$$\frac{\ddot{\sigma}_{k}^{11,\alpha\alpha}}{\sigma_{k}} - \frac{\dot{\sigma}_{k}^{\alpha\alpha}}{\sigma_{k}} \frac{\sigma_{k-1}^{11}}{\sigma_{k-1}} = \frac{\dot{\sigma}_{k}^{\alpha\alpha} - \sigma_{k-1}(\lambda|1\alpha)}{\lambda_{1}\sigma_{k}} - \frac{\dot{\sigma}_{k}^{\alpha\alpha}}{\sigma_{k}} \frac{\sigma_{k-1} - \sigma_{k-1}(\lambda|1)}{\lambda_{1}\sigma_{k-1}} \\
= - \frac{\sigma_{k-1}(\lambda|1\alpha)}{\lambda_{1}\sigma_{k}} + \frac{\dot{\sigma}_{k}^{\alpha\alpha}}{\sigma_{k}} \frac{\dot{\sigma}_{k}^{11}}{\lambda_{1}\sigma_{k-1}},$$
(3.48)

and

$$\frac{\ddot{\sigma}_{k-1}^{11,\alpha\alpha}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k-1}^{\alpha\alpha}\dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}^2} = \frac{\sigma_{k-2}^2(\lambda|1\alpha) - \sigma_{k-1}(\lambda|1\alpha)\sigma_{k-3}(\lambda|1\alpha)}{\sigma_{k-1}^2}.$$
 (3.49)

Hence, for any  $2 \le i \le k-1$ , we have

$$\left| \frac{\ddot{\sigma}_{k-1}^{11,ii}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k-1}^{ii} \dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}^2} \right| \leqslant \frac{C(n,k)\lambda_k^2}{\lambda_1^2 \lambda_i^2} \leqslant C \frac{\dot{\sigma}_k^{11} \lambda_k^2}{\lambda_1 \lambda_i^2}. \tag{3.50}$$

For any  $k \leq p \leq n$ , we have

$$\left| \frac{\ddot{\sigma}_{k-1}^{11,pp}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k-1}^{pp} \dot{\sigma}_{k-1}^{11}}{\sigma_{k-1}^2} \right| \leqslant \frac{C(n,k)}{\lambda_1^2} \leqslant C \frac{\dot{\sigma}_k^{11}}{\lambda_1}. \tag{3.51}$$

Here we use Property (4), Claim 2 and Claim 3 in (3.50) and (3.51). Furthermore, for any  $2 \le i \le k-1$ , we have

$$\frac{\ddot{\sigma}_{k}^{11,ii}}{\sigma_{k}} - \frac{\dot{\sigma}_{k}^{ii}}{\sigma_{k}} \frac{\sigma_{k-1}^{11}}{\sigma_{k-1}} - \frac{\dot{\sigma}_{k}^{11}}{\sigma_{k}} \frac{\dot{\sigma}_{k-1}^{ii}}{\sigma_{k-1}} + \frac{\dot{\sigma}_{k-1}^{11} \dot{\sigma}_{k-1}^{ii}}{\sigma_{k-1}^{2}} \\
= \frac{-\sigma_{k} + \dot{\sigma}_{k}^{11} \lambda_{1} + \sigma_{k}(\lambda | 1i)}{\lambda_{1} \lambda_{i} \sigma_{k}} + \frac{\dot{\sigma}_{k}^{ii}}{\sigma_{k}} \frac{\dot{\sigma}_{k}^{11}}{\lambda_{1} \sigma_{k-1}} - \left(\frac{1}{\lambda_{i}} - \frac{\dot{\sigma}_{k}^{ii}}{\lambda_{i} \sigma_{k-1}}\right) \frac{\dot{\sigma}_{k}^{11}}{\sigma_{k}} \\
+ \frac{(\sigma_{k-1} - \dot{\sigma}_{k}^{11}) \left(\sigma_{k-1} - \dot{\sigma}_{k}^{ii}\right)}{\lambda_{1} \lambda_{i} \sigma_{k-1}^{2}} \\
= \frac{\sigma_{k}(\lambda | 1i)}{\lambda_{1} \lambda_{i} \sigma_{k}} - \frac{\dot{\sigma}_{k}^{ii} \sigma_{k}(k | 1)}{\lambda_{1} \lambda_{i} \sigma_{k-1} \sigma_{k}} + \frac{\dot{\sigma}_{k}^{11}}{\lambda_{1}} \left(\frac{\dot{\sigma}_{k}^{ii}}{\sigma_{k-1} \sigma_{k}} - \frac{\sigma_{k-2}(\lambda | i)}{\sigma_{k-1}^{2}}\right). \tag{3.52}$$

Here

$$\left| \frac{\sigma_k(\lambda | 1i)}{\lambda_1 \lambda_i \sigma_k} \right| \leqslant \frac{C \lambda_1 \dots \lambda_k^3}{\lambda_1^2 \lambda_i^2 \sigma_k} \leqslant \frac{C \dot{\sigma}_k^{11} \lambda_k}{\lambda_i^2}. \tag{3.53}$$

By using (3.42), we have

$$\left| \frac{\dot{\sigma}_k^{ii} \sigma_k(k|1)}{\lambda_1 \lambda_i \sigma_{k-1} \sigma_k} \right| \leqslant C \frac{\lambda_1 \cdots \lambda_k^2 \dot{\sigma}_k^{11}}{\lambda_i^2 \sigma_{k-1} \sigma_k} \leqslant C \frac{\lambda_k^2 \dot{\sigma}_k^{11}}{\lambda_i^2}. \tag{3.54}$$

Similarly, combining Claim 2 we have

# 4. Interior estimates of K-Hessian equations with Dirichlet boundary conditions

Somewhere in the sequel, we denote  $\sigma_k$  by F for brevity and define

$$\dot{F}^{pq}(D^2u) := \frac{\partial F}{\partial u_{pq}}, \quad \ddot{F}^{pq,rs}(D^2u) := \frac{\partial^2 F}{\partial u_{qp}\partial u_{rs}}.$$

If We further assume that  $\{u_{ij}\}$  is diagonal at a certain point, then we define

$$\frac{\partial F}{\partial \lambda_p}(\lambda(D^2u)) = \dot{F}^{pp}(D^2u), \quad \frac{\partial^2 F}{\partial \lambda_p \partial \lambda_q}(\lambda(D^2u)) = \ddot{F}^{pp,qq}(D^2u).$$

We first proof Theorem 1.1.

*Proof.* we consider the function for any  $\varepsilon > 0$ ,  $x \in \Omega$ ,  $\xi \in \mathbb{S}^{n-1}$ 

$$\widetilde{P}(x,\xi) = \beta \log(-u) + \log \max\{u_{\xi\xi}(x), 1\} + \frac{L}{2}|Du|^2,$$

where  $L \gg 1$ ,  $\beta > 0$  are constants to be determined later. Clearly, the maximum of  $\widetilde{P}$  is attained in some interior point  $x_0$  of  $\Omega$  and some  $\xi(x_0) \in \mathbb{S}^{n-1}$ . Choose canonical coordinate frames  $e_1, \ldots, e_n$  at  $x_0$  such that  $\xi(x_0) = e_1$  and  $\{u_{ij}(x_0)\}$  is diagonal. Let the eigenvalues  $\lambda$  of  $D^2u$  be ordered as

$$\lambda_1(x_0) \geqslant \lambda_2(x_0) \geqslant \dots \geqslant \lambda_n(x_0).$$

We construct a unit vector field v(s) near p such that  $v(0) = e_1(x_0)$  and  $v'(0) = \sum_{p \neq 1} \frac{u_{1pi}}{\lambda_1 + 1 - \lambda_p} e_p$ . We may also assume that  $\lambda_1(x_0) > 1$  is sufficiently large. Then we consider the function

$$P(x) = \beta \log(-u) + \log \left( u(v(s), v(s)) + (g(v(s), e_1(s)))^2 - 1 \right) + \frac{L}{2} |Du|^2.$$

Note that  $x_0$  is also a maximum point of P. At  $x_0$ , we have

$$0 = \nabla_i P(x_0) = \beta \frac{u_i}{u} + \frac{u_{11i}}{u_{11}} + Lu_i \lambda_i$$
 (4.1)

and

$$0 \geqslant \nabla_{ij} P(x_0)$$

$$=\beta \frac{u_{ij}}{u} - \beta \frac{u_i u_j}{u^2} + \frac{u_{11ij}}{u_{11}} + \sum_{l>1} \frac{u_{1li}^2}{u_{11}(u_{11} - u_{ll} + 1)} - \frac{u_{11i} u_{11j}}{u_{12}^2} + L u_{ki} u_{kj} + L u_{kij} u_k.$$

$$(4.2)$$

By  $\sigma_k(D^2u) = f(x, u, \nabla u)$ , we have at  $x_0$ 

$$\nabla_l \sigma_k = f_l + f_u u_l + f_{u_l} u_{ll} \tag{4.3}$$

and

$$\nabla_{11}^2 \sigma_k = \dot{F}^{ij} u_{ij11} + \ddot{F}^{pq,rs} u_{pq1} u_{rs1} = f_{11}. \tag{4.4}$$

Besides, there exists some constant C>0 depending on  $\|f\|_{C^2}$  and  $\|u\|_{C^1}$  such that

$$|f_1| \le C + Cu_{11}, \quad f_{11} \ge -C - Cu_{11}^2 + f_{u_l}u_{11l}.$$
 (4.5)

Multiplying (4.2) by using  $\dot{F}^{ij}$ , by (4.1), (4.3) and (4.4) we obtain

$$0 \geqslant \beta \frac{kF}{u} - \beta \frac{\dot{F}^{ii}u_{i}^{2}}{u^{2}} + \frac{\dot{F}^{ii}u_{11i}}{u_{11}} + 2\sum_{p>1} \frac{\dot{F}^{ii}u_{1pi}}{u_{11}(u_{11} - \lambda_{p} + 1)} - \frac{\dot{F}^{ii}u_{11i}^{2}}{u_{11}^{2}} + L\dot{F}^{ii}u_{ii}^{2} + L\nabla_{l}\sigma_{k}u_{l}$$

$$\geqslant \beta \frac{kF}{u} - \beta \frac{\dot{F}^{ii}u_{i}^{2}}{u^{2}} - \frac{\dot{F}^{pq,rs}u_{pq1}u_{rs1}}{u_{11}} + \frac{f_{u_{l}}u_{11l}}{u_{11}} + 2\sum_{p>1} \frac{\dot{F}^{ii}u_{1pi}}{u_{11}(u_{11} - u_{pp} + 1)}$$

$$- \frac{\dot{F}^{ii}u_{11i}^{2}}{u_{11}^{2}} + L\dot{F}^{ii}u_{ii}^{2} - Cu_{11} + Lf_{u_{l}}\lambda_{l}u_{l} - CL$$

$$\geqslant \beta \frac{kF}{u} - \beta \frac{\dot{F}^{ii}u_{i}^{2}}{u^{2}} - \frac{\dot{F}^{pq,rs}u_{pq1}u_{rs1}}{u_{11}} + 2\sum_{p>1} \frac{\dot{F}^{ii}u_{1pi}}{u_{11}(u_{11} - u_{pp} + 1)} - \frac{\dot{F}^{ii}u_{11i}^{2}}{u_{11}^{2}} + L\dot{F}^{ii}u_{ii}^{2}$$

$$- \beta \frac{f_{u_{l}}u_{l}}{u} - Cu_{11} - CL.$$

$$(4.6)$$

Referring to Andrews [1], we have

$$-\ddot{F}^{pq,rs}h_{pq1}h_{rs1} = -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{p>q} \ddot{F}^{pp,qq}h_{pq1}^{2}$$

$$\geqslant -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{\lambda_{p}<\lambda_{1}} \frac{\dot{F}^{pp} - \dot{F}^{11}}{\lambda_{1} - \lambda_{p}}h_{11p}^{2}.$$
(4.7)

Besides,

$$\sum_{1 \le p, 1 \le i \le n} \frac{2\dot{F}^{ii} u_{1pi}^2}{(u_{11} + 1 - u_{pp})} \geqslant 2\sum_{p>1} \frac{\dot{F}^{11} u_{11p}^2}{(u_{11} - u_{pp} + 1)} + 2\sum_{i>1} \frac{\dot{F}^{ii} u_{1ii}^2}{(u_{11} - u_{ii} + 1)}.$$
 (4.8)

Using the critical equation (4.1), for any  $i \ge 2$  we have

$$-\beta \frac{\dot{F}^{ii}u_i^2}{u^2} = -\frac{1}{\beta} \left( \frac{u_{11i}}{u_{11}} + Lu_i u_{ii} \right)^2 \geqslant -\frac{2}{\beta} \frac{\dot{F}^{ii}u_{11i}^2}{u_{11}^2} - 2\frac{L^2}{\beta} \dot{F}^{ii}u_i^2 u_{ii}^2. \tag{4.9}$$

Then we choose  $\beta = L^2 \gg 4$  and obtain

$$-\frac{\dot{F}^{pq,rs}u_{pq1}u_{rs1}}{u_{11}} + 2\sum_{p>1}\frac{\dot{F}^{ii}u_{1pi}}{u_{11}(u_{11} - u_{pp} + 1)} - \left(1 + \frac{2}{\beta}\right)\sum_{i\geqslant 2}\frac{\dot{F}^{ii}u_{11i}^{2}}{u_{11}^{2}} - \frac{\dot{F}^{11}u_{111}^{2}}{u_{11}^{2}}$$

$$\geqslant -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{p>1}\frac{\dot{F}^{pp}}{u_{11}(u_{11} - u_{pp} + 1)}h_{11p}^{2} + 2\sum_{i>1}\frac{\dot{F}^{ii}u_{1ii}^{2}}{u_{11}(u_{11} - u_{ii} + 1)}$$

$$-\frac{3}{2}\sum_{i\geqslant 2}\frac{\dot{F}^{ii}u_{11i}^{2}}{u_{11}^{2}} - \frac{\dot{F}^{11}u_{111}^{2}}{u_{11}^{2}}$$

$$= -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{i>1}\frac{\dot{F}^{ii}u_{1ii}^{2}}{u_{11}(u_{11} + A + 1)} - \frac{\dot{F}^{11}u_{111}^{2}}{u_{11}^{2}} - \frac{\dot{F}^{ii}u_{11i}^{2}\left(\frac{1}{2}u_{11} - \frac{3}{2}A - \frac{3}{2}\right)}{u_{11}^{2}(u_{11} - u_{pp} + 1)}$$

$$\geqslant -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{i>1}\frac{\dot{F}^{ii}u_{1ii}^{2}}{u_{11}(u_{11} + A + 1)} - \frac{\dot{F}^{11}u_{111}^{2}}{u_{11}^{2}}$$

$$\geqslant -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{i>1}\frac{\dot{F}^{ii}u_{1ii}^{2}}{u_{11}(u_{11} + A + 1)} - \frac{\dot{F}^{11}u_{111}^{2}}{u_{11}^{2}}$$

by assuming  $\lambda_1 \geqslant 3A + 3$  in the last inequality.

Due to Lemma 1.1, combining (4.7) and (4.8), (4.6) becomes

$$0 \geqslant -L^{2} \frac{\dot{F}^{11} u_{1}^{2}}{u^{2}} - 2\dot{F}^{ii} u_{i}^{2} \lambda_{i}^{2} - \frac{\dot{F}^{pp,qq} u_{pp1} u_{qq1}}{u_{11}} + K \frac{(\nabla_{1} \sigma_{k})^{2}}{u_{11} \sigma_{k}} + 2 \sum_{i>1} \frac{\dot{F}^{ii} u_{1ii}^{2}}{u_{11}(u_{11} + A + 1)} - \frac{\dot{F}^{11} u_{111}^{2}}{u_{11}^{2}} + L \dot{F}^{ii} u_{ii}^{2} - \frac{C_{3} L^{2}}{u} - C_{4} L - C_{5}(K) u_{11}$$

$$\geqslant \left(\frac{L u_{11}^{2}}{5} - \frac{C_{1} L^{2}}{u^{2}}\right) \dot{F}^{11} + \left(\frac{L}{5} - C_{2}\right) \sum_{i=1}^{n} \dot{F}^{ii} u_{ii}^{2} + L \left(\frac{k \sigma_{k}}{5n} u_{11} - C_{3} \frac{L}{u}\right) + L \left(\frac{k \sigma_{k}}{5n} u_{11} - C_{4}\right) + \left(\frac{L k \sigma_{k}}{5n} - C_{5}(K)\right) u_{11}.$$

$$(4.11)$$

where we use Property (4) in the last inequality. In (4.11),  $C_i$ ,  $i=1,2,\ldots,5$  all depends on  $n,\ k,\ \|f\|_{C^2}$  and  $\|u\|_{C^1}$ . We choose  $L=\max\{4,5C_2,\frac{5nC_5}{kf}\}$  such that the second term and the last term in the last inequality of (4.11) are positive. Then we obtain  $\max \lambda_1 u^{\beta} \leqslant \max\{\sqrt{5C_1L}\sup u^{\beta-1},\frac{5nLC_3\sup u^{\beta-1}}{kf_0},\frac{5nC_4\sup u^{\beta}}{kf_0}\}$  and complete the proof.

### 5. A LIOUVILLE PROBLEM FOR GENERAL K-HESSIAN EQUATION

We first consider the interior  $C^2$  estimates for the following Dirichlet problem:

$$\begin{cases} \sigma_k(D^2 u) = 1 & x \in \Omega, \\ u = 0 & x \in \partial \Omega. \end{cases}$$
 (5.1)

**Lemma 5.1.** Assume that  $D^2u \ge -AI$  for some positive constant A > 0. Then, for any k-convex solution  $u \in C^2(\Omega) \cap C^{0,1}(\overline{\Omega})$ , there exists some  $\alpha > 1$  and C > 0 depending on n, k,  $|u|_{C^1}$  and the diameter of  $\Omega$ , such that

$$\max_{x \in \Omega} (-u(x))^{\alpha} |D^2 u(x)| \leqslant C. \tag{5.2}$$

*Proof.* By using the Comparison principle (see [3,10] for detail), there exists large a and b depending on the diameter of  $\Omega$ , such that

$$w = a|x|^2 - b$$

and

$$w \leqslant u \leqslant 0$$
.

Thus, -u can be controlled by the diameter of the domain  $\Omega$ .

Now we consider the function for  $x \in \Omega$ ,  $\xi \in \mathbb{S}^{n-1}$ 

$$\widetilde{P}(x,\xi) = \alpha \log(-u) + \log \max\{u_{\xi\xi}(x), 1\} + \frac{1}{2}|x|^2,$$

where  $\alpha > k-1$  is a constant to be determined later. Clearly, the maximum of  $\widetilde{P}$  is attained in some interior point  $x_0$  of  $\Omega$  and some  $\xi(x_0) \in \mathbb{S}^{n-1}$ . Choose canonical coordinate frames  $e_1, \ldots, e_n$  at  $x_0$  such that  $\xi(x_0) = e_1$  and  $\{u_{ij}(x_0)\}$  is diagonal. Let the eigenvalues  $\lambda$  of  $D^2u$  be ordered as

$$\lambda_1(x_0) \geqslant \lambda_2(x_0) \geqslant \dots \geqslant \lambda_n(x_0).$$

We construct a unit vector field v(s) near p such that  $v(0) = e_1(x_0)$  and  $v'(0) = \sum_{p \neq 1} \frac{u_{1pi}}{\lambda_1 + 1 - \lambda_p} e_p$ . We may also assume that  $\lambda_1(x_0) > 1$  is sufficiently large. Then we consider the function

$$P(x) = \alpha \log(-u) + \log \left( u(v(s), v(s)) + \left( g(v(s), e_1(s)) \right)^2 - 1 \right) + \frac{1}{2} |x|^2.$$

Note that  $x_0$  is also a maximum point of P. At the maximum point  $x_0$ ,

$$0 = P_i = \frac{\alpha u_i}{u} + \frac{u_{11i}}{u_{11}} + x_i, \tag{5.3}$$

and

$$P_{ij} = \frac{\alpha u_{ij}}{u} - \frac{\alpha u_i u_j}{u^2} + \frac{u_{11ij}}{u_{11}} + \sum_{p>1} \frac{2u_{1pi}^2}{u_{11}(u_{11} + 1 - u_{pp})} - \frac{u_{11i}u_{11j}}{u_{11}^2} + \delta_{ij}.$$
 (5.4)

Multiplying (5.4) by  $\dot{F}^{ij}$ , at  $x_0$  we have

$$0 \geqslant \alpha \frac{kF}{u} - \alpha \frac{\dot{F}^{ii}u_i^2}{u^2} + \frac{\dot{F}^{ii}u_{11ii}}{u_{11}} + 2\sum_{p>1} \frac{\dot{F}^{ii}u_{1pi}^2}{u_{11}(u_{11} + 1 - u_{pp})} - \frac{\dot{F}^{ii}u_{11i}^2}{u_{11}^2} + (n - k + 1)\sigma_{k-1}. (5.5)$$

Similar to the proof in Theorem 1.1, using the critical equation (5.3) we obtain at  $x_0$ 

$$-\alpha \frac{\dot{F}^{ii} u_i^2}{u^2} = -\frac{1}{\alpha} \dot{F}^{ii} \left( \frac{u_{11i}}{u_{11}} + x_i \right)^2 \geqslant -\frac{2}{\alpha} \frac{\dot{F}^{ii} u_{11i}^2}{u_{11}^2} - \frac{2}{\alpha} \dot{F}^{ii} x_i^2. \tag{5.6}$$

Taking the derivatives of the equation (5.1), we obtain

$$\dot{F}^{ij}u_{ijk} = 0,$$

and

$$\ddot{F}^{ij,kl}u_{kl1}u_{ij1} + \dot{F}^{ij}u_{ij11} = 0.$$

By (4.7) and (4.8), similar to (4.10) we have by choosing  $\alpha \gg 4$ 

$$-\frac{\dot{F}^{pq,rs}u_{pq1}u_{rs1}}{u_{11}} + 2\sum_{p>1}\frac{\dot{F}^{ii}u_{1pi}}{u_{11}(u_{11} - u_{pp} + 1)} - \left(1 + \frac{2}{\alpha}\right)\sum_{i\geqslant 2}\frac{\dot{F}^{ii}u_{11i}^2}{u_{11}^2} - \frac{\dot{F}^{11}u_{111}^2}{u_{11}^2}$$

$$\geqslant -\ddot{F}^{pp,qq}h_{pp1}h_{qq1} + 2\sum_{i>1}\frac{\dot{F}^{ii}u_{1ii}^2}{u_{11}(u_{11} + A + 1)} - \frac{\dot{F}^{11}u_{111}^2}{u_{11}^2}$$
(5.7)

by assuming  $\lambda_1 \ge 3A + 3$  in the last inequality. Then applying Lemma 1.1, we obtain

$$0 \geqslant \alpha \frac{kF}{u} - \frac{2}{\alpha} \dot{F}^{ii} X_{i}^{2} - \ddot{F}^{pp,qq} h_{pp1} h_{qq1} + 2 \sum_{i>1} \frac{\dot{F}^{ii} u_{1ii}^{2}}{u_{11}(u_{11} + A + 1)}$$

$$- \left(1 + \frac{2}{\alpha}\right) \frac{\dot{F}^{11} u_{111}^{2}}{u_{11}^{2}} + (n - k + 1) \sigma_{k-1}$$

$$\geqslant \alpha \frac{kF}{u} + \left(\delta_{0} - \frac{2}{\alpha}\right) \frac{\dot{F}^{11} u_{111}^{2}}{u_{11}^{2}} + \left(n - k + 1 - \frac{2 \sup_{\Omega} |X|^{2}}{\alpha}\right) \sigma_{k-1}$$

$$\geqslant \frac{C_{1}\alpha}{u} + \frac{n - k + 1}{2} \sigma_{k-1}$$

$$(5.8)$$

by choosing  $\alpha=\max\{4,k-1,\frac{2}{\delta_0},\frac{4\sup_{\Omega}|X|^2}{n-k+1}\}$ . Thus, we employ Lemma 2.4 to obtain that there exists some C>0 only depending on n and the diameter of  $\Omega$ , such that

$$C(-u)u_{11}^{\frac{1}{k-1}} \leqslant (-u)\sigma_{k-1} \leqslant \frac{2C_1\alpha}{n-k+1}.$$
 (5.9)

Then we complete the proof.

We now begin to prove Theorem 1.2.

*Proof.* The proof is standard (refer to [15, 22] for details). Let u be an entire solution of equation (5.1). We consider the domain

$$\Omega_R = \{ y \in \mathbb{R}^n : u(Ry) < R^2 \}$$

for any large R > 0. Let

$$u_R(y) = \frac{u(Ry) - R^2}{R^2}.$$

Then

$$D_y^2 u_R = D_x^2 u. (5.10)$$

Hence  $u_R$  satisfying the following Dirichlet problem

$$\begin{cases}
\sigma_2(D^2 u_R(x)) = 1 & x \in \Omega_R, \\
u_R = 0 & x \in \partial \Omega_R.
\end{cases}$$
(5.11)

The quadratic growth condition in Theorem 1.2 implies that

$$a|Ry|^2 - b \leqslant u(Ry) \leqslant R^2.$$

Then

$$|y|^2 \leqslant \frac{1+b}{a},$$

which means that  $\Omega_R$  is bounded. Applying Lemma 1.1, we obtain

$$(-u_R)^{\alpha}|D^2u_R| \leqslant C \tag{5.12}$$

where C is independent of R. Now we consider the domain

$$\Omega'_R = \{ y \in \mathbb{R}^n : u(Ry) < \frac{R^2}{2} \} \subset \Omega_R.$$

In  $\Omega'_R$ , we have

$$u_R(y) \leqslant -\frac{1}{2}.$$

Due to (5.10) and (5.12),

$$D_x^2 u = |D^2 u_R| \leqslant 2^{\alpha} C.$$

The estimate above holds true for all R. Applying Evans-Krylov theory we have

$$|D^2u|_{C^{\alpha}(B_R)} \leqslant C(n,\alpha) \frac{|D^2u|_{C^0(B_{2R})}}{R^{\alpha}} \leqslant \frac{C(n,\alpha)}{R^{\alpha}}.$$

Hence, we obtain our theorem by letting  $R \to +\infty$ .

## 6. Global curvature estimate for convex hypersurfaces

In this section, we focus on the semi-convex hypersurfaces with the prescribed k-th mean curvature and complete the proof of Theorem 1.4 and Theorem 1.5.

Proof of Theorem 1.4 We consider the test function

$$Q = \log \kappa_1 - A \log u$$

where A is a large constant to be considered. Further, we assume Q attains its maximum at point  $X_0$ . Similar as the proof in [8], also in the proof in Theorem 1.1 and Theorem 1.2, we consider the perturbed quantity

$$\tilde{Q} = \log \tilde{\kappa}_1 - Au,$$

which also attains its maximum at point  $X_0$ .

At  $X_0$ , we have

$$0 = \frac{h_{11i}}{\kappa_1} - Ah_{ii}\langle X, \partial_i \rangle \tag{6.1}$$

and due to Lemma 3.1 in [8]

$$0 \geqslant 2 \sum_{p>1} \frac{\dot{F}^{11,pp} h_{11p}^2}{\kappa_1^2} + 2 \sum_{i>1} \frac{\dot{F}^{11} h_{11i}^2}{\kappa_1 (\kappa_1 - \kappa_i + 1)} - \frac{\ddot{F}^{pp,qq} h_{pp1} h_{qq1}}{\kappa_1} + 2 \sum_{p>1} \frac{\dot{F}^{pp} h_{1pp}^2}{\kappa_1 (\kappa_1 - \kappa_p + 1)} - \sum_{p=1}^n \frac{\dot{F}^{pp} h_{11p}^2}{\kappa_1^2} + \sum_{i=1}^n \left(\frac{A}{C} - C\right) \dot{F}^{ii} \kappa_i^2 - CA.$$

$$(6.2)$$

Then

$$2\sum_{p>1} \frac{\dot{F}^{11,pp}h_{11p}^{2}}{\kappa_{1}^{2}} + 2\sum_{i>1} \frac{\dot{F}^{11}h_{11i}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{i} + 1)} - \sum_{p=1}^{n} \frac{\dot{F}^{pp}h_{11p}^{2}}{\kappa_{1}^{2}}$$

$$\geqslant 2\sum_{i>1} \frac{\dot{F}^{ii}h_{11i}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{i} + 1)} - \sum_{p=1}^{n} \frac{\dot{F}^{pp}h_{11p}^{2}}{\kappa_{1}^{2}}$$

$$\geqslant \sum_{i>1} \frac{\kappa_{1} + \kappa_{i} - 1}{\kappa_{1} - \kappa_{i} + 1} \frac{\dot{F}^{ii}h_{11i}^{2}}{\kappa_{1}} - \frac{\dot{F}^{11}h_{111}^{2}}{\kappa_{1}^{2}}.$$

$$(6.3)$$

According to Lemma 11 in [19], we have

$$-\kappa_i \leqslant \frac{n-k}{k}\kappa_1$$

which implies that

$$\kappa_1 + \kappa_i - 1 = \frac{2k - n}{k} \kappa_1 - 1 > 0 \tag{6.4}$$

by assuming that 2k > n and  $\kappa_1 \gg 1$ . Or under the assumption of Theorem 1.4 that  $\kappa_i \geqslant -A$ , we have

$$\kappa_1 + \kappa_i - 1 \geqslant \kappa_1 - A - 1 > 0 \tag{6.5}$$

by assuming  $\kappa_1 \ge A + 1$  rather than the condition 2k > n. Plugging (6.3) and (6.5) into (6.2), we have

$$0 \geqslant -\frac{\ddot{F}^{pp,qq}h_{pp1}h_{qq1}}{\kappa_{1}} + 2\sum_{p>1} \frac{\dot{F}^{pp}h_{1pp}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{p} + 1)} - \frac{\dot{F}^{11}h_{111}^{2}}{\kappa_{1}^{2}} + \sum_{i=1}^{n} \left(\frac{A}{C} - C\right)\dot{F}^{ii}\kappa_{i}^{2} - CA$$

$$\geqslant \sum_{i=1}^{n} \left(\frac{A}{C} - C\right)\dot{F}^{ii}\kappa_{i}^{2} - K\frac{(\dot{F}^{11}h_{111})^{2}}{\sigma_{k}\kappa_{1}} - CA.$$
(6.6)

Here we use the crucial Lemma 1.1. Differentiating (1.11), we have

$$\sum_{i} \dot{F}^{ii} h_{ii1} = h_{11} d_{\nu} f(e_1) + d_x f(e_1)$$
(6.7)

which implies that

$$\frac{\sum_{i} (\dot{F}^{ii} h_{ii1})^2}{\sigma_k \kappa_1} \leqslant C \kappa_1. \tag{6.8}$$

Then combining Property (4), we have

$$0 \geqslant \sum_{i=1}^{n} \left( \frac{kA}{nC} - \frac{k}{n}C - CK \right) \kappa_1 - CA, \tag{6.9}$$

which implies  $\kappa_1$  is bounded above by some constant C > 0 only depending on  $n, k, ||M||_{C^1}$ , inf f and  $||f||_{C^2}$ .

Remark 6.1. If we further assume 2k > n, following the proof in Theorem 1.4 we can derive the global  $C^2$  estimates of the k-convex hypersurface satisfying (1.11) without the assumption  $\kappa_i > -A$  under the following conjecture.

Conjecture 1.5 Suppose that 2k > n, and  $\kappa = (\kappa_1, \ldots, \kappa_n) \in \Gamma_k$ . If we assume that  $\kappa_1 \ge \cdots \ge \kappa_n$  and  $\kappa_1$  is large enough, then for an arbitrary *n*-vector  $\xi$  in  $\mathbb{R}^n$  and some sufficient large K > 0, the following inequality holds

$$\kappa_1 \left( K(\dot{F}^{jj}\xi_j)^2 - \ddot{\sigma}_k^{pp,qq}\xi_p\xi_q \right) - \dot{F}^{11}\xi_1^2 + (\dot{F}^{jj} + (\kappa_1 + \kappa_j)\ddot{\sigma}_k^{11,jj}) \geqslant 0.$$
 (6.10)

One can refer to [23] for detailed proof. We note that this conjecture is a weakened version of Conjecture 2 by in [19] but exhibits the same capability in deriving the global  $C^2$  estimates of the curvature equation (1.11). Our crucial Lemma 1.1 is a semi-convexity version of Conjecture 1.5.

Finally, we provide a concise proof of Theorem 1.5 using the crucial Lemma 1.1 when k=2.

Sketch proof of Theorem 1.5 We consider the test function for some  $N\gg 1$  and small  $\varepsilon>0$ 

$$Q = \log \kappa_1 - \varepsilon u + \frac{N}{2}|x|^2 \tag{6.11}$$

in this case. We assume that Q attains its maximum at point  $X_0$ . Similar to the proof in Theorem 1.4 using the idea in [8], we disturb Q as below

$$\tilde{Q} = \log \tilde{\kappa}_1 - \varepsilon u + \frac{N}{2} |x|^2 \tag{6.12}$$

which also attains its maximum at  $X_0$ . At  $X_0$ , we have

$$0 = \frac{h_{11i}}{\kappa_1} - \varepsilon \frac{h_{ii}\langle X, \partial_i \rangle}{u} + Nx_i \tag{6.13}$$

and

$$0 \geqslant 2 \sum_{p>1} \frac{\dot{F}^{11,pp} h_{11p}^{2}}{\kappa_{1}^{2}} + 2 \sum_{i>1} \frac{\dot{F}^{11} h_{11i}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{i} + 1)} - \frac{\ddot{F}^{pp,qq} h_{pp1} h_{qq1}}{\kappa_{1}} + 2 \sum_{p>1} \frac{\dot{F}^{pp} h_{1pp}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{p} + 1)}$$

$$- \sum_{p=1}^{n} \frac{\dot{F}^{pp} h_{11p}^{2}}{\kappa_{1}^{2}} + \sum_{i=1}^{n} \varepsilon \dot{F}^{ii} \kappa_{i}^{2} + N \sum_{i} \dot{F}^{ii} - 2NuF - C\kappa_{1} - C$$

$$\geqslant - \frac{\ddot{F}^{pp,qq} h_{pp1} h_{qq1}}{\kappa_{1}} + 2 \sum_{p>1} \frac{\dot{F}^{pp} h_{1pp}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{p} + 1)} + 2 \sum_{i>1} \frac{\dot{F}^{ii} h_{11i}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{i} + 1)} - \sum_{p=1}^{n} \frac{\dot{F}^{pp} h_{11p}^{2}}{\kappa_{1}^{2}}$$

$$+ \sum_{i=1}^{n} \varepsilon \dot{F}^{ii} \kappa_{i}^{2} + N(n-1)\sigma_{1} - C\kappa_{1} - CN.$$

$$(6.14)$$

If we further assume that  $-\kappa_i < A$  for any  $1 < i \le n$ , then applying Lemma 1.1 similar to the proof in (6.6) we have

$$0 \geqslant -\frac{\ddot{F}^{pp,qq}h_{pp1}h_{qq1}}{\kappa_{1}} + 2\sum_{p>1} \frac{\dot{F}^{pp}h_{1pp}^{2}}{\kappa_{1}(\kappa_{1} - \kappa_{p} + 1)} + K\frac{(\dot{F}^{ii}h_{ii1})^{2}}{\sigma_{k}\kappa_{1}} - \frac{\dot{F}^{11}h_{111}^{2}}{\kappa_{1}^{2}} + \sum_{i=1}^{n} \varepsilon \dot{F}^{ii}\kappa_{i}^{2} + N(n-1)\sigma_{1} - (C + CK)\kappa_{1} - CN$$

$$\geqslant (N(n-1) - C - CK)\kappa_{1} - CN.$$
(6.15)

By choosing N large enough (independent of A) we obtain  $\kappa_1$  is bounded above by some constant C. Both N and C depends only on n, k,  $||f||_{C^2}$  inf f and  $||M||_{C^1}$ . If  $|\kappa_n| \ge A$ , then (6.14) becomes

$$0 \geqslant -\frac{\ddot{F}^{pp,qq}h_{pp1}h_{qq1}}{\kappa_{1}} + \frac{(\dot{F}^{ii}h_{ii1})^{2}}{\sigma_{k}\kappa_{1}} - \sum_{p=1}^{n} \frac{\dot{F}^{pp}h_{11p}^{2}}{\kappa_{1}^{2}} + \sum_{i=1}^{n} \varepsilon \dot{F}^{ii}\kappa_{i}^{2} + N(n-1)\sigma_{1} - C\kappa_{1} - CN$$

$$\geqslant -2C\varepsilon^{2} \sum_{p=1}^{n} \dot{F}^{pp}\kappa_{p}^{2} - 2N^{2} \sum_{p=1}^{n} \dot{F}^{pp}X_{p}^{2} + \sum_{i=1}^{n} \varepsilon \dot{F}^{ii}\kappa_{i}^{2} + N(n-1)\sigma_{1} - C\kappa_{1} - CN$$

$$\geqslant \left(-2C\varepsilon^{2} + \frac{\varepsilon}{2}\right) \sum_{p=1}^{n} \dot{F}^{pp}\kappa_{p}^{2} + (-2nN^{2}|X|^{2} + \frac{\varepsilon}{2}\kappa_{n}^{2})\dot{F}^{nn} + N(n-1)\sigma_{1} - C\kappa_{1} - CN.$$

$$(6.16)$$

where we employ (3.1) in the first inequality and the critical equation (6.13) in the second inequality. By setting  $\varepsilon = \frac{1}{4c}$  and  $A = 4N\sqrt{nC}\sup|X|$ , the proof can be completed in the way similar to the one presented above.
