A note on the radially symmetry in the moving plane method

Abstract

Let $\Omega \subset \mathbb{R}^n$, $n \geq 2$, be a bounded connected C^2 domain. For any unit vector $\nu \in \mathbb{R}^n$, let *T* ν $X_{\lambda}^{\nu} = \{x \in \mathbb{R}^{n} : x \cdot \nu = \lambda\}, \ \Sigma_{\lambda}^{\nu}$ χ^{ν} = { $x \in \Omega : x \cdot \nu < \lambda$ } and $x^* = x - 2(x \cdot \nu - \lambda)\nu$ be the reflection of a point $x \in \mathbb{R}^n$ about the plane T^{ν}_{λ} $\frac{\nu}{\lambda}$. Let $\widetilde{\Sigma}_{\lambda}^{\nu}$ $\chi^{\nu}_{\lambda} = \{x \in \Omega : x^* \in \Sigma_{\lambda}^{\nu}\}$ $_{\lambda}^{\nu}$ and $u \in C^2(\overline{\Omega})$. Suppose for any unit vector $v \in \mathbb{R}^n$, there exists a constant $\lambda_v \in \mathbb{R}$ such that Ω is symmetric about the plane T^{ν}_{λ} $\chi^{\nu}_{\lambda\nu}$ and *u* is symmetric about the plane *T* ν $\frac{\partial v}{\partial v}$ and satisfies (i) $\frac{\partial u}{\partial v}(x) > 0 \quad \forall x \in \Sigma^{\nu}$ $\frac{\partial v}{\partial y}$ and (ii) $\frac{\partial u}{\partial y}(x) < 0$ $\forall x \in \widetilde{\Sigma}_{\lambda}^{y}$ $\chi^{\nu}_{\lambda^{\nu}}$. We will give a simple proof that *u* is radially symmetric about some point $x_0 \in \Omega$ and Ω is a ball with center at *x*₀. Similar result holds for the domain \mathbb{R}^n and function $u \in C^2(\mathbb{R}^n)$ satisfying similar monotonicity and symmetry conditions. We also extend this result under weaker hypothesis on the function *u*.

1 Introduction

Moving plane technique [\[CL\]](#page-5-0), [\[GNN1\]](#page-5-1), [\[GNN2\]](#page-5-2), [\[L1\]](#page-5-3), [\[L2\]](#page-5-4), is a very important technique used by many researchers to study the radially symmetry of the solutions of elliptic partial differential equations. In [\[GNN1\]](#page-5-1) and [\[GNN2\]](#page-5-2) B. Gidas, W.M. Ni and L. Nirenberg used moving plane technique to prove the radial symmetry of solutions of the following equation

$$
\Delta u + u^{\frac{n+2}{n-2}} = 0, \quad u > 0, \quad n \ge 3
$$

in a ball $B_R = \{x \in \mathbb{R}^n : |x| < R\}$ and in \mathbb{R}^n respectively. This moving plane technique was also used by W. Chen and C. Li [\[CL\]](#page-5-0) to prove the radially symmetry of solutions of the equation,

$$
\begin{cases} \Delta u + e^u = 0 & \text{in } \mathbb{R}^2 \\ \int_{\mathbb{R}^2} e^{u(x)} dx < +\infty. \end{cases}
$$
 (1.1)

Let $\Omega \subset \mathbb{R}^n$, $n \geq 2$, be a bounded connected C^2 domain. Let $c \in \mathbb{R}$ and $u \in C^2(\overline{\Omega})$ be a solution of the equation,

$$
\begin{cases} \Delta u = -1, & \text{in } \Omega \\ u(x) = 0, & \frac{\partial u}{\partial n} = c \quad \forall x \in \partial \Omega. \end{cases}
$$
 (1.2)

where ∂/∂*n* is the derivative with respect to the unit outward normal *n* to ∂Ω. In [\[S\]](#page-5-5) J. Serrin used the moving plane technique to prove that

$$
\Omega = B_R(x_0) = \{x \in \mathbb{R}^n : |x - x_0| < R\} \quad \text{for some } x_0 \in \mathbb{R}^n \quad \text{and constant } R > 0 \tag{1.3}
$$

and

$$
u(x) = \frac{R^2 - |x - x_0|^2}{2n} \quad \forall x \in B_R(x_0).
$$
 (1.4)

More precisely for any unit vector $v \in \mathbb{R}^n$, let

$$
T_\lambda^\nu=\{x\in\mathbb{R}^n: x\cdot\nu=\lambda\},\quad \Sigma_\lambda^\nu=\{x\in\Omega: x\cdot\nu<\lambda\},
$$

and $x^* = x - 2(x \cdot \nu - \lambda)\nu$ be the reflection of a point $x \in \mathbb{R}^n$ about the plane T^{ν}_{λ} $\frac{\nu}{\lambda}$. Let

$$
\widetilde{\Sigma}_{\lambda}^{\nu} = \{ x \in \Omega : x^* \in \Sigma_{\lambda}^{\nu} \}. \tag{1.5}
$$

J. Serrin [\[S\]](#page-5-5) proved that for any unit vector $\nu \in \mathbb{R}^n$, there exists a constant $\lambda_\nu \in \mathbb{R}$ such that Ω is symmetric about the plane T^{ν}_{λ} $\chi^{\nu}_{\lambda_{\nu}}$ and the solution *u* of [\(1.2\)](#page-1-0) is symmetric about the plane *T* ν $\mathcal{V}_{\lambda_{\nu}}$. From this J. Serrin [\[S\]](#page-5-5) concluded that the solution *u* of [\(1.2\)](#page-1-0) in Ω satisfies [\(1.3\)](#page-1-1) and [\(1.4\)](#page-1-2). However it is not very obvious why [\(1.3\)](#page-1-1) and [\(1.4\)](#page-1-2) hold in [\[S\]](#page-5-5) as the hyperplanes *T* ν λ_{ν} , $\nu \in S^{n-1} = {\nu \in \mathbb{R}^n : |\nu| = 1}$, may not all intersect in a point $x_0 \in \mathbb{R}^n$ so that one cannot apply the Cartan-Dieudonné Theorem [\[Ga\]](#page-5-6) directly to conclude that *u* is radially symmetric.

Note that by the results of J. Serrin [\[S\]](#page-5-5) and Hopf's Lemma [\[PW\]](#page-5-7) the solution *u* of [\(1.2\)](#page-1-0) satisfies

$$
\frac{\partial u}{\partial v}(x) > 0 \quad \forall x \in \Sigma_{\lambda_v}^{\nu}, v \in S^{n-1}, \tag{1.6}
$$

$$
\frac{\partial u}{\partial \nu}(x) < 0 \quad \forall x \in \widetilde{\Sigma}^{\nu}_{\lambda,\nu}, \nu \in S^{n-1},\tag{1.7}
$$

and

$$
u(x) = u(x^*) \quad \forall x \in \Sigma_{\lambda,\nu}^{\nu}, \nu \in S^{n-1}.
$$
\n(1.8)

In this paper we will give a simple proof that if Ω is symmetric about the plane T_{λ}^{ν} λν for any $\nu \in S^{n-1}$ and *u* satisfies [\(1.6\)](#page-1-3), [\(1.7\)](#page-1-4) and [\(1.8\)](#page-1-5), then *u* is radially symmetric about some point *x*₀ \in Ω and Ω is a ball with center *x*₀ and radius *R* for some constant *R* > 0. Similar result holds for the domain \mathbb{R}^n and function $u \in C^2(\mathbb{R}^n)$ satisfying some monotonicity and symmetry conditions. More precisely we will prove the following results:

Theorem 1.1. Let $\Omega \subset \mathbb{R}^n$, $n \geq 2$, be a bounded connected C^2 domain and $u \in C^2(\overline{\Omega})$. Suppose *for any unit vector* $\nu \in \mathbb{R}^n$ *, there exists a constant* $\lambda_\nu \in \mathbb{R}$ *such that* Ω *is symmetric about the plane T*^ν λν *and u satisfies* [\(1.6\)](#page-1-3)*,* [\(1.7\)](#page-1-4) *and* [\(1.8\)](#page-1-5)*. Then u is radially symmetric about some point* $x_0 \in \Omega$ *and* Ω *is a ball with center at* x_0 *.*

Theorem 1.2. Let $\Omega = \mathbb{R}^n$, $n \geq 2$ and let $0 \leq f \in C^1([0,\infty))$ be such that $f(s) > 0$ for any $s > 0$. *Suppose* $u \in C^2(\mathbb{R}^n)$ *is a solution of the equation,*

$$
\Delta u + f(u) = 0, \quad u > 0, \quad in \, \mathbb{R}^n \tag{1.9}
$$

 $\mathit{such that for any}\ v \in S^{n-1}\textit{ there exists a constant}\ \lambda_v \in \mathbb{R} \textit{ such that } u \textit{ satisfies }$

$$
\frac{\partial u}{\partial v}(x) \ge 0 \quad \forall x \in \Sigma_{\lambda_v}^{\nu},\tag{1.10}
$$

$$
\frac{\partial u}{\partial v}(x) \le 0 \quad \forall x \in \widetilde{\Sigma}_{\lambda_{v'}}^{\nu}
$$
\n(1.11)

and [\(1.8\)](#page-1-5). Let $g(v) = \lambda_v$. Suppose the map $g : S^{n-1} \to \mathbb{R}$ is continuous. Then u is radially *symmetric about some point* $x_0 \in \mathbb{R}^n$ *.*

By an argument similar to the proof of Theorem [1.1](#page-2-0) we also have the following result.

Theorem 1.3. Let $\Omega = \mathbb{R}^n$, $n \geq 2$ and $u \in C^2(\mathbb{R}^n)$. Suppose for any unit vector $v \in \mathbb{R}^n$, there *exists a constant* $\lambda_{\nu} \in \mathbb{R}$ *such that u satisfies* [\(1.6\)](#page-1-3), [\(1.7\)](#page-1-4) *and* [\(1.8\)](#page-1-5). *Then u is radially symmetric about some point* $x_0 \in \mathbb{R}^n$ *.*

Remark 1.4. By Theorem [1.1](#page-2-0) the solution $u \in C^2(\overline{\Omega})$ of [\(1.2\)](#page-1-0) is radially symmetric and hence *given by* [\(1.4\)](#page-1-2) *and* Ω *is given by* [\(1.3\)](#page-1-1).

Remark 1.5. *In [\[CL\]](#page-5-0) W. Chen and C. Li proved that the hypothesis of Theorem [1.3](#page-2-1) holds for* any solution u ∈ $C^2(\mathbb{R}^2)$ of [\(1.1\)](#page-1-6). Hence Theorem [1.3](#page-2-1) shows that such solution must be radially *symmetric about some point* $x_0 \in \mathbb{R}^n$ *.*

2 Proof of the main theorems

In this section we will prove Theorem [1.1](#page-2-0) and Theorem [1.2.](#page-2-2) We will let $e_i = (\delta_{ij})_{j=1}^n \in \mathbb{R}^n$ for any $i = 1, \ldots, n$.

Proof of Theorem [1.1](#page-2-0): By the hypothesis of Theorem 1.1 for any $i = 1, \ldots, n$, there exists a constant $\lambda_i := \lambda_{e_i} \in \mathbb{R}$ such that Ω is symmetric about the plane $T^{\epsilon_i}_\lambda$ λ_i and *u* satisfies

[\(1.6\)](#page-1-3), [\(1.7\)](#page-1-4) and [\(1.8\)](#page-1-5) with $\lambda_v = \lambda_i$, $v = e_i$, $i = 1, ..., n$. Then $(\lambda_1, ..., \lambda_n) \in \Omega$. For any $x = (x_1, \ldots, x_n) \in \Omega$, let $y = (y_1, \ldots, y_n)$ be given by

$$
y_i = x_i - \lambda_i \quad \forall i = 1, \dots, n. \tag{2.1}
$$

Then in the new coordinates *y*, the domain Ω is symmetric about the $y_i = 0$ plane for all $i = 1, \ldots, n$ and the origin $0 \in \Omega$. Hence we may assume without loss of generality that $\lambda_i = 0 \quad \forall i = 1, \dots, n.$ Then

$$
0 \in T_{\lambda_i}^{e_i} = \{ y = (y_1, \dots, y_n) \in \mathbb{R}^n : y_i = 0 \} \quad \forall i = 1, \dots, n,
$$

$$
\frac{\partial u}{\partial y_i}(y) > 0 \quad \forall y = (y_1, \dots, y_n) \in \Omega, y_i < 0, i = 1, \dots, n
$$

and

$$
\frac{\partial u}{\partial y_i}(y) < 0 \quad \forall y = (y_1, \ldots, y_n) \in \Omega, y_i > 0, i = 1, \ldots, n.
$$

Hence *u* attains its maximum at the origin. Suppose there exists $v \in S^{n-1}$ such that

$$
0 \notin T_{\lambda_v}^v. \tag{2.2}
$$

Let $P_0 = (a_1, \ldots, a_n)$ be the projection of the origin onto the hyperplane T_λ^v $\chi^{\nu}_{\lambda_{\nu}}$. That is dist $(0, P_0) = \text{dist}(0, T_{\lambda}^{\nu})$ $v_{\lambda_v}^{\nu}$). Since by [\(1.6\)](#page-1-3),

$$
\frac{\partial u}{\partial \overrightarrow{OP_0}} > 0 \quad \text{along } \overrightarrow{OP_0},
$$

 $u(P_0) > u(0)$ which contradicts the fact that the origin is the maximum point of the function *u*. Hence no such *ν* exists and all the hyperplanes T^{ν}_{λ} λ_{ν} , $\nu \in S^{n-1}$, will intersect at the origin or at the point $x_0 = (\lambda_1, ..., \lambda_n)$ in the original *x*-coordinates. Then by [\(1.8\)](#page-1-5) and the Cartan-Dieudonné Theorem [\[Ga\]](#page-5-6), *u* is radially symmetric about the point x_0 and Ω is a ball with center at x_0 .

 \Box

Proof of Theorem [1.2](#page-2-2): By the hypothesis of Theorem [1.2](#page-2-2) for any *i* = 1, . . . , *n*, there exists a constant $\lambda_i := \lambda_{e_i} \in \mathbb{R}$ such that *u* satisfies [\(1.8\)](#page-1-5), [\(1.10\)](#page-2-3) and [\(1.11\)](#page-2-4) with $\lambda_v = \lambda_i$, $v = e_i$, $i = 1, \ldots, n$. For any $x = (x_1, \ldots, x_n) \in \mathbb{R}^n$, let $y = (y_1, \ldots, y_n)$ be given by [\(2.1\)](#page-3-0). Then in the new coordinates *y*, the hyperplane T^e_{λ} $\alpha_{\lambda_i}^{\epsilon_i}$ becomes the hyperplane

$$
\{y=(y_1,\ldots,y_n)\in \mathbb{R}^n : y_i=0\}.
$$

Hence we may assume without loss of generality that $\lambda_i = 0$ $\forall i = 1, \dots, n$. Then

$$
\frac{\partial u}{\partial y_i}(y) \ge 0 \quad \forall y = (y_1, \dots, y_n) \in \mathbb{R}^n, y_i < 0, i = 1, \dots, n
$$

and

$$
\frac{\partial u}{\partial y_i}(y) \le 0 \quad \forall y = (y_1, \dots, y_n) \in \mathbb{R}^n, y_i > 0, i = 1, \dots, n. \tag{2.3}
$$

Hence *u* attains its maximum (say *M*) at the origin. Suppose there exists

$$
\nu = (\nu_1, ..., \nu_n) \in S^{n-1}, \nu_i \neq 0 \text{ for any } i = 1, ..., n,
$$
 (2.4)

such that [\(2.2\)](#page-3-1) holds. Let $P_0 = (a_1, \ldots, a_n)$ be the projection of the origin onto the hyperplane *T* ν $\mathcal{V}_{\lambda_{\nu}}$. Then there exists a constant $0 \neq \mu \in \mathbb{R}$ such that

$$
(a_1, ..., a_n) = \mu(v_1, ..., v_n).
$$
 (2.5)

By [\(2.4\)](#page-4-0) and [\(2.5\)](#page-4-1), $a_i \neq 0$ for any $i = 1, \ldots, n$. Without loss of generality we may assume that

$$
a_i > 0 \quad \forall i = 1, \dots, n. \tag{2.6}
$$

Since *u* attains its maximum at the origin and by the hypothesis of the theorem,

$$
\frac{\partial u}{\partial \overrightarrow{OP_0}} \ge 0 \quad \text{along } \overrightarrow{OP_0},
$$

we have

$$
u(sP_0) = u(0) = M = \max_{\mathbb{R}^n} u \quad \forall 0 \le s \le 1.
$$
 (2.7)

By [\(2.3\)](#page-4-2) and [\(2.6\)](#page-4-3) the function $u(t_1a_1, a_2, \ldots, a_n)$ is decreasing in $t_1 \in (0, 1)$. This together with [\(2.7\)](#page-4-4) implies that

$$
u(t_1a_1, a_2,..., a_n) = u(0) = M \quad \forall 0 \le t_1 \le 1.
$$

Repeating the above argument we get

$$
u(t_1a_1, t_2a_2, \dots, t_na_n) = u(0) = M \quad \forall 0 \le t_i \le 1, i = 1, \dots, n
$$

\n
$$
\Rightarrow u(y_1, y_2, \dots, y_n) = u(0) = M \quad \forall 0 \le y_i \le a_i, i = 1, \dots, n. \tag{2.8}
$$

By [\(1.9\)](#page-2-5) and [\(2.8\)](#page-4-5) we get

$$
f(u(y)) = -\Delta u = 0 \quad \forall y \in \Pi_{i=1}^n[0, a_i] \quad \Rightarrow \quad u(y) = 0 \quad \forall y \in \Pi_{i=1}^n[0, a_i]
$$

and contradiction arises. Hence no such ν exists and $0 \in T^{\nu}_{\lambda}$ $\chi^{\nu}_{\lambda_{\nu}}$ for any ν satisfying [\(2.4\)](#page-4-0). For any $v = (v_1, ..., v_n) \in S^{n-1}$, we choose a sequence $\{v^k\}_{k=1}^{\infty} \subset S^{n-1}$, $v^k = (v_1^k)$ $\{x_1, \ldots, v_n^k\}, v_i^k$ $i^k \neq 0$ for any $i = 1, ..., n, k \in \mathbb{Z}^+$, such that $v^k \to v$ as $k \to \infty$. By continuity of the map $g(v) = \lambda_v$,

$$
\lambda_{\nu^k} \to \lambda_{\nu} \quad \text{as } k \to \infty.
$$

Then

 $0 \in T_{\lambda}^{\nu^k}$ $v^k_{\lambda_{v^k}}$ $\forall k \in \mathbb{Z}^+$ \Rightarrow $0 \in T^{\nu}_{\lambda}$ $\chi^{\nu}_{\lambda_{\nu}}$ as $k \to \infty$.

Hence

$$
0 \in T_{\lambda_v}^v \quad \forall v \in S^{n-1}.
$$

Thus all the hyperplanes *T* ν λ_{ν} , $\nu \in S^{n-1}$, will intersect at the origin or at the point $x_0 =$ $(\lambda_1, \ldots, \lambda_n)$ in the original *x*-coordinates. Then by [\(1.8\)](#page-1-5) and the Cartan-Dieudonné Theorem [\[Ga\]](#page-5-6), u is radially symmetric about the point x_0 .
