# **EXISTENCE OF AN EXTREMAL FUNCTION OF SOBOLEV CRITICAL EMBEDDING WITH AN**  $\alpha$ **-HOMOGENEOUS WEIGHT**

Abstract. In our previous publication [*Calc. Var. Partial Differential Equations*, 60(1):Paper No. 16, 27, 2021], we delved into examining a critical Sobolev-type embedding of a Sobolev weighted space into an exponential weighted Orlicz space. We specifically determined the optimal Moser-type constant for this embedding, utilizing the monomial weight introduced by Cabré and Ros-Oton [J. Differential Equations, 255(11):4312–4336, 2013]. Towards the conclusion of that paper, we pledged to explore the existence of an extremal function within this framework. In this current work, we not only provide a positive affirmation to this inquiry but extend it to a broader range of weights known as  $\alpha$ -homogeneous weights.

### 1. Introduction

It is well-knownthat Trudinger-Mosertype inequalities can be considered as the critical case of Sobolev embeddings. To be more precise, recall that the Sobolev space  $W^{1,d}(\mathbb{R}^d)$ ,  $d \in \mathbb{N}$ , is embedded into the Lebesgue space  $L^q(\mathbb{R}^d)$  for any  $q \in [d, \infty)$ , although  $W^{1,d}(\mathbb{R}^d)$  is not embedded into  $L^{\infty}(\mathbb{R}^d)$ . It was proved in 1967 by Trudinger [\[14\]](#page-4-0) that there is an embedding of this type of  $W_0^{1,d}(\Omega)$  into the Orlicz space  $L^{\Phi}(\Omega)$ , with  $\Omega$  being a bounded domain in  $\mathbb{R}^d$ , and the Young function  $\Phi(x) = \exp(\alpha |x|^{d/(d-1)})$ ,  $t > 0$ , where  $\alpha$  is a positive constant. However, this embedding was announced earlier by Yudovich [\[15\]](#page-4-1) without a proof and, in a slightly weaker form, proved by Pokhozhaev [\[12\]](#page-4-2). In 1971 Moser [\[11\]](#page-4-3) showed that if  $\alpha \le \alpha_d = d\omega_{d-1}^{1/(d-1)}$ , where  $\omega_{d-1}$  denotes the surface area of the unit sphere in  $\mathbb{R}^d$ , then

$$
\sup_{u} \int_{\Omega} \exp\left(\alpha |x|^{d/(d-1)}\right) \mathrm{d}x < \infty,
$$

where the supremum is taken over all functions u from the unit ball of the space  $W_0^{1,d}(\Omega)$ . When  $\alpha > \alpha_d$ , this supremum becomes infinite.

A natural question arises as to whether there exists a function  $u$  such that the supremum is attained. The first step towards solving this problem was made in 1986 by Carleson and Chang [\[3\]](#page-4-4), who showed that an extremal function u exists if  $\Omega$  is a ball in  $\mathbb{R}^d$ . In 1988, Struwe [\[13\]](#page-4-5) demonstrated that this result continues to hold for small perturbations of the ball in  $\mathbb{R}^2$ , and in 1992, Flucher [\[4\]](#page-4-6) extended the result to any bounded domain in  $\mathbb{R}^2$ . Finally, in 1995, Lin [\[10\]](#page-4-7) generalised the result to any dimension. Note that a key ingredient of his proof is the use of  $d$ -Green's functions, the singular solutions to the  $d$ -Laplacian.

In our previous paper, published in 2021 [\[5\]](#page-4-8), we studied a weighted version of the Trudinger-Moser inequality and its relationship with the corresponding Sobolev-type embedding. This research was based on recent results by Cabré and Ros-Oton  $[1]$  $[1]$  and Lam  $[9]$ , whose function spaces involved the so-called *monomial* weight. In our paper, we presented some weighted analogues of the classical results. Namely, we found the "optimal" Orlicz spaces (within the class of Orlicz spaces) of the corresponding critical Sobolev-type embedding and showed that this embedding is not compact. Moreover, we proved, that an embedding into any properly larger Orlicz space is compact, and we also derived a corresponding *concentrated compactness* principle of P.-L. Lions. However, we left the question of the existence of an extremal function unsolved. In this paper, we aim to address this gap, at least for the case where  $\Omega$  is a ball in  $\mathbb{R}^d$ . We are working in a slightly more general context, as our weight is a *homogeneous* weight (more details about the weights can be found in Section [2\)](#page-1-0).

#### 2. Preliminaries

<span id="page-1-0"></span>**Weighted measure on an convex cone.** We denote by  $\Sigma$  an open convex cone in  $\mathbb{R}^d$ ,  $d \in \mathbb{N}$ ,  $d \ge 2$ , with vertex at the origin. Following [\[2\]](#page-4-11),  $w: \overline{\Sigma} \to [0, \infty)$  is a nonnegative (not identically zero) continuous function that is α-homogeneous,  $\alpha > 0$ , and such that  $w^{1/\alpha}$  is concave in Σ. Recall that w is α-homogeneous if

$$
w(\kappa x) = \kappa^{\alpha} w(x) \quad \text{for any } x \in \overline{\Sigma} \text{ and all } \kappa > 0. \tag{2.1}
$$

Throughout the paper  $\mu$  denotes the weighted measure on  $\Sigma$  defined as

$$
d\mu(x) = w(x) dx.
$$

For future reference, we set

$$
D = d + \alpha. \tag{2.2}
$$

Important examples of  $\alpha$ -homogeneous functions are the *monomial weights*. Namely, let  $\Sigma = \Sigma_1 \cap \cdots \cap \Sigma_k$ ,  $k \in \{1, ..., d\}$ , where  $\Sigma_j \neq \mathbb{R}^d$ ,  $j = 1, ..., k$ , are open convex cones in  $\mathbb{R}^d$  with vertex at the origin. Given  $A_1, \ldots, A_k > 0$ , the weight  $w: \overline{\Sigma} \to [0, \infty)$  defined as

$$
w(x) = \prod_{j=1}^{k} dist(x, \partial \Sigma_j)^{A_j}, \ x \in \overline{\Sigma},
$$

satisfies the  $\alpha$ -homogeneity assumptions. For other interesting examples we refer the reader to [\[2,](#page-4-11) Section 2]. In particular, when  $\Sigma_j = \{x \in \mathbb{R}^d : x_j > 0\}$ ,  $j = 1, ..., k$ , the function (cf. also [\[1\]](#page-4-9))

$$
w(x) = x_1^{A_1} \cdots x_k^{A_k}, \ x \in \overline{\Sigma},
$$

we considered in our previous paper [\[5\]](#page-4-8).

### **Basic definitions.**

*Measure space.* By the symbol  $(X, y)$  we denote a measure space X with a nonnegative  $\sigma$ -finite measure  $\nu$ . If  $\Omega$  is a  $\nu$ -measurable subset of X, we denote by  $\nu(\Omega)$  the  $\nu$ -measure of  $\Omega$ , that is,  $v(\Omega) = \int_{\Omega} dv(x)$ . If  $X = \mathbb{R}^d$  with its *n*-dimensional Lebesgue measure  $dv(x) = dx$  and  $M \subset \mathbb{R}^d$  is a Lebesgue measurable set in  $\mathbb{R}^d$ , we use the notation  $|M| = \int_{\Omega} dx$ .

*Lebesgue space.* If  $(X, y)$  is a measure space, we denote by  $L^p(\Omega, y)$ ,  $p \in [1, \infty]$ , the *Lebesgue space*, of all v-measurable functions f on a v-measurable set  $\Omega$  in X, equipped with the norm

$$
||f||_{p,\Omega,\nu} = \begin{cases} \left(\int_{\Omega} |f(x)|^p \, \mathrm{d}\nu(x)\right)^{1/p} & \text{if } p < \infty, \\ \nu\text{-ess sup}_{x \in \Omega} |f(x)| & \text{if } p = \infty. \end{cases}
$$

If  $X = \mathbb{R}^d$  and  $\nu$  is the d-dimensional Lebesgue measure, then we write  $\|\cdot\|_{p,\Omega}$  instead of  $\|\cdot\|_{p,\Omega}$ ,  $\nu$ . Moreover, we simply write  $\|\cdot\|_{p,\nu}$  (or  $\|\cdot\|_p$ ) when  $\Omega = X$  (or  $\Omega = \mathbb{R}^d$ ). For  $p \in [1,\infty]$  we define the *Hölder conjugate* number  $p' \in [1, \infty]$  by the equality  $\frac{1}{p} + \frac{1}{p'} = 1$ .

*Sobolev space.* Let  $\Omega$  be a domain in a measure space  $(\mathbb{R}^d, v)$  with a nonnegative Borel measure v and let  $p \in [1, \infty]$ . The *Sobolev space*  $W_0^{1,p}$  $\int_0^{1,p}(\Omega,\nu)$  is defined as the closure of  $C_c^{\infty}(\Omega)$  (the space of infinitely differentiable functions with compact supports in  $\Omega$ ) with respect to the norm

$$
||u|| = ||\nabla u||_{p,\Omega,\nu},
$$

where  $\nabla u$  is the gradient of u and  $|\nabla u|$  is its Euclidean length, that is,

$$
\nabla u = \left(\frac{\partial u}{\partial x_1}, \dots, \frac{\partial u}{\partial x_n}\right), \quad |\nabla u| = \left(\sum_{j=1}^n (\partial u/\partial x_j)^2\right)^{1/2}
$$

(to simplify the notation we are writing  $\|\nabla u\|_{p,\Omega,\nu}$  instead of  $\|\nabla u\|_{p,\Omega,\nu}$ ).

*Distribution function and rearrangements.* For a measurable function  $f$  in  $\Sigma$  we define its *distribution function with respect to*  $\mu$  as

$$
f_{*\mu}(\tau) = \mu(\{x \in \Sigma : |f(x)| > \tau\}), \quad \tau > 0,
$$

and its *nonincreasing rearrangement with respect to*  $\mu$  as

$$
f_{\mu}^*(t) = \inf\{\tau > 0 : f_{*\mu}(\tau) \le t\}, \quad t > 0.
$$

The function  $f^{\star}_{\mu}$  defined as

$$
f_{\mu}^{\star}(x) = f_{\mu}^{*}(C_{D}|x|^{D}), \quad x \in \mathbb{R}^{d}, \tag{2.3}
$$

where

$$
C_D = \mu(B_1 \cap \Sigma),\tag{2.4}
$$

is the *radial rearrangement* of  $f$  *with respect to*  $\mu$ . We use the notation

$$
B_r = \{x \in \mathbb{R}^d : |x| < r\}, \quad r > 0.
$$

Thanks to the  $\alpha$ -homogeneity of  $w$ , we have

 $\iota$ 

$$
\mu(B_r \cap \Sigma) = C_D r^D, \quad r > 0.
$$

Note that the function  $f_{\mu}^{\star}$  is nonnegative and radially nonincreasing. Though it is defined on the whole  $\mathbb{R}^d$ , it depends only on function values of f in  $\Sigma$ . Furthermore, the functions f and  $f\vec{\mu}$  are equimeasurable with respect to  $\mu$ , that is,

$$
\mu\big(\{x \in \Sigma : |f(x)| > \tau\}\big) = \mu\big(\{x \in \Sigma : |f_{\mu}^{\bigstar}(x)| > \tau\}\big), \quad \tau > 0.
$$

Pólya-Szegö inequality. We need the following important result.

**Theorem 2.1** ([\[6,](#page-4-12) Theorem 3.1]). Let  $1 \leq p < \infty$ . For every function  $u \in C_c^1(\mathbb{R}^d)$ , its radial rearrange $m$ ent  $u^{\bigstar}_{\mu}$  with respect to  $\mu$  is locally absolutely continuous and

$$
\|\nabla u_{\mu}^{\star}\|_{p,\mu} \le \|\nabla u\|_{p,\mu}.\tag{2.5}
$$

*In particular,* supp  $u^*_{\mu} = \overline{B}_R$  where R is such that  $\mu(B_R \cap \Sigma) = \mu(\text{supp } u \cap \Sigma)$ .

We need another obvious result.

<span id="page-2-0"></span>**Lemma 2.2.** *Let*  $\Psi$  :  $(0, \infty) \rightarrow (0, \infty)$  *be an increasing and measurable function. Then* 

$$
\int_{\mathbb{R}^d} \Psi(u_\mu^\bigstar(x)) d\mu(x) = \int_{\mathbb{R}^d} \Psi(|u(x)|) d\mu(x).
$$

## <span id="page-2-2"></span>**Reduction to the one-dimensional problem.**

**Proposition 2.3.** Let  $u \in C_c^1(\mathbb{R}^d)$  be a nonnegative function with supp  $u \subset \Omega$  such that  $\mu(\Omega) < \infty$ . *Assume that*  $0 < a \leq c_D$  *and*  $R > 0$  *is the number satisfying*  $\mu(B_R \cap \Sigma) = \mu(\Omega \cap \Sigma)$ *. Let*  $\mu_R^{\star}$  *be the radial rearrangement of* 𝑢 *with respect to* 𝜇*. Set*

$$
U(|x|) = u^{\star}(x), \quad x \in \mathbb{R}^d \cap \Sigma
$$
 (2.6)

*and*

<span id="page-2-1"></span>
$$
\varphi(t) = C_D^{1/D'} U(Re^{-t/D}), \quad t \in (0, \infty).
$$
 (2.7)

*Then*  $\varphi$  *satisfies that*  $\varphi' \geq 0$  *on*  $(0, \infty)$  *and*  $\varphi(0) = 0$ *. Moreover,* 

$$
\int_{\Omega \cap \Sigma} |\nabla u(x)|^D d\mu(x) \ge \int_{B_R \cap \Sigma} |\nabla u_{\mu}^{\bigstar}(x)|^D d\mu(x) = \int_0^{\infty} (\varphi'(t))^D dt
$$

*and*

$$
\frac{1}{\mu(\Omega \cap \Sigma)} \int_{\Omega \cap \Sigma} \exp (a(u(x))^{D'}) d\mu(x)
$$
  
= 
$$
\frac{1}{\mu(B_R \cap \Sigma)} \int_{B_R \cap \Sigma} \exp (a(u_{\mu}^{\star}(x))^{D'}) d\mu(x) = \int_0^{\infty} \exp (\beta \varphi^{D'}(t) - t) dt,
$$

*where*  $\beta = a/C_D \in (0, 1]$ *.* 

*Proof.* By Lemma [2.2](#page-2-0) with  $\Psi(t) = \exp(at^{D'})$  we have

$$
\frac{1}{\mu(\Omega \cap \Sigma)} \int_{\Omega \cap \Sigma} \exp\left(a |u(x)|^{D'}\right) d\mu(x) = \frac{1}{\mu(B_R \cap \Sigma)} \int_{B_R \cap \Sigma} \exp\left(a (u^{\bigstar}(x))^{D'}\right) d\mu(x). \tag{2.8}
$$

Since  $u^*$  is radially symmetric, we obtain

$$
\int_{B_R \cap \Sigma} \exp \left( a(u^{\star}(x))^{D'} \right) d\mu(x) = \int_0^R \left( \int_{x \in \Sigma, |x| = r} \exp \left( a(u^{\star}(x))^{D'} \right) w(x) d\sigma(x) \right) dr
$$
\n
$$
= \int_0^R \exp \left( a(U(r))^{D'} \right) \left( \int_{x \in \Sigma, |x| = r} w(x) d\sigma(x) \right) dr = P_w(B_1 \cap \Sigma) \int_0^R \exp \left( a(U(r))^{D'} \right) r^{D-1} dr,
$$

where  $U(|x|) = u^{\star}(x)$  and  $P_w(B_1 \cap \Sigma) = \int_{x \in \Sigma, |x| = 1} w(x) d\sigma(x)$  ( $\sigma$  is the Hausdorff measure on the unit sphere centered at the origin). We make the change of variables

<span id="page-3-0"></span>
$$
r = Re^{-t/D} \tag{2.9}
$$

in the last integral to obtain

$$
\int_0^R \exp\left(a(U(r))^D'\right) r^{D-1} \, \mathrm{d}r = D^{-1} R^D \int_0^\infty \exp\left(a(U(Re^{-t/D}))^{D'} - t\right) \mathrm{d}t.
$$

Setting  $\beta = a/C_D \in (0, 1]$  and using the fact, that

$$
C_D = \mu(B_R \cap \Sigma) = \int_{B_R \cap \Sigma} w(x) dx = D^{-1} P_w(B_1 \cap \Sigma) R^D,
$$

we arrive at

$$
\frac{1}{\mu(B_R \cap \Sigma)} \int_{B_R \cap \Sigma} \exp\left(a(u^{\star}(x))^{D'}\right) d\mu(x) = \int_0^{\infty} \exp\left(\beta(\varphi(t))^{D'} - t\right) dt,\tag{2.10}
$$

where the function  $\varphi$  is defined by [\(2.7\)](#page-2-1). Similarly, since  $|\nabla u \star (x)| = |U'(|x|)|, x \in \mathbb{R}^d \cap \Sigma$ , we have

$$
\int_{B_R \cap \Sigma} \left| \nabla u^{\bigstar}(x) \right|^D d\mu(x) = P_w(B_1 \cap \Sigma) \int_0^R \left| U'(r) \right|^D r^{D-1} dr.
$$

Differentiating [\(2.7\)](#page-2-1) we have, for all  $t \in (0, \infty)$ ,

$$
\varphi'(t) = -D^{-1}C_D^{1/D'} U'(Re^{-t/D}) Re^{-t/D} = -D^{-1}C_D^{1/D'} U'(r)r.
$$

Observe that, since  $U$  is nonincreasing, the right hand side is nonnegative. Change of variables [\(2.9\)](#page-3-0) gives

$$
\int_0^R \left| U'(r) \right|^D r^{D-1} \, \mathrm{d}r = D^{-1} (D^{-1} C_D^{1/D'})^{-D} \int_0^\infty \left| D^{-1} C_D^{1/D'} \, U'(Re^{-t/D}) Re^{-t/D} \right|^D \, \mathrm{d}r
$$
\n
$$
= D^{-1} (D^{-1} C_D^{1/D'})^{-D} \int_0^\infty \left| \varphi'(t) \right|^D \, \mathrm{d}t.
$$

That is,

$$
\int_{B_R \cap \Sigma} |\nabla u^{\star}(x)|^D d\mu(x) = P_w(B_1 \cap \Sigma) D^{-1} (D^{-1} C_D^{1/D'})^{-D} \int_0^{\infty} |\varphi'(t)|^D dt = \int_0^{\infty} |\varphi'(t)|^D dt.
$$
\nThe proof is completed.

**Lemma 2.4.** *Let*  $q \in (1, \infty)$ *. Consider nonnegative functions*  $\varphi \in C^1[0, \infty)$  *such that*  $\varphi(0) = 0$ *,*  $\varphi' \ge 0$ *on*  $(0, \infty)$  *and*  $\int_0^\infty (\varphi'(t))^q dt \le 1$ *. Then*

$$
A(q) = \sup_{\varphi} \int_0^{\infty} \exp\left((\varphi(t))^{q'} - t\right) dt < \infty.
$$
 (2.11)

<span id="page-3-3"></span>*Proof.* The proof for  $q \ge 2$  was given by Moser [\[11\]](#page-4-3), for  $q \in (1, 2)$  it was extended by Jodeit [\[8\]](#page-4-13).  $\Box$ 

## **Lemma 2.5.** *The supremum in*  $(2.11)$  *is attained for every*  $q > 1$ *.*

*Proof.* The result for  $q \in \mathbb{N}$ ,  $q \ge 2$  was proved first by by Carleson and Chang [\[3\]](#page-4-4), it was extended to real  $q > 1$  by Hudson and Leckband [\[7\]](#page-4-14). 3. Main result

Now we formulate the main theorem.

**Theorem 3.1.** *Assume that*  $p \in [1, \infty)$  *and* w *is an*  $\alpha$ -homogeneous weight such that  $\alpha > 0$ . Then

$$
S = \sup_{u} \frac{1}{\mu(\Omega \cap \Sigma)} \int_{\Omega \cap \Sigma} \exp (a|u(x)|^{D'}) d\mu(x) < \infty,
$$

where the supremum is taken over all  $u \in C_c^1(\mathbb{R}^d)$  such that  $\sup p u \subset \Omega$  with  $\mu(\Omega) < \infty$  and  $\|\nabla u\|_{p,\mu} \leq 1$ . *If*  $\Omega = B_R$  *with some*  $R > 0$ *, then the supremum is attained.* 

*Proof.* To prove that S is finite we apply Proposition [2.3](#page-2-2) to obtain

$$
1 \geq \int_{\Omega \cap \Sigma} |\nabla u(x)|^D d\mu(x) \geq \int_0^{\infty} (\varphi'(t))^D dt,
$$

and so, by Lemma [2.4](#page-3-2) and Proposition [2.3,](#page-2-2)

$$
\sup_{u} \frac{1}{\mu(\Omega \cap \Sigma)} \int_{\Omega \cap \Sigma} \exp (a|u(x)|^{D'}) d\mu(x) = \sup_{\varphi} \int_{0}^{\infty} \exp ((\varphi(t))^{D'} - t) dt < \infty.
$$

For proving the second part it is enough to take the function

$$
u(x) = U(|x|), \quad x \in B_R \cap \Sigma,
$$

where U is the function such that [\(2.7\)](#page-2-1) holds and  $\varphi$  is the extremal function from Lemma [2.5](#page-3-3) when  $q = D$ .
