Generalizations of the fractional Fourier transform and their analytic properties

Abstract

We consider one-parameter families of quadratic-phase integral transforms which generalize the fractional Fourier transform. Under suitable regularity assumptions, we characterize the one-parameter groups formed by such transforms. Necessary and sufficient conditions for continuous dependence on the parameter are obtained in L^2 , pointwise, and almost-everywhere senses.

Keywords: fractional Fourier transform, linear canonical transform, quadratic phase, maximal function

1 Introduction

The idea of the fractional Fourier transform (FRFT) goes back to Wiener in 1929. In the last few decades, the FRFT has found practical applications in optics [\[1](#page-19-0)] and signal processing [\[2](#page-19-1)], among many others.

As a one-parameter extension of the Fourier transform

$$
\mathscr{F}f(u) = \hat{f}(u) := \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} e^{-iut} f(t) dt \quad (u \in \mathbb{R}),
$$

the FRFT of order $\alpha \in \mathbb{R}$ is defined by

$$
\mathscr{F}_{\alpha}f(u) = \sqrt{\frac{1 - i \cot \alpha}{2\pi}} \int_{\mathbb{R}} e^{i\left[\frac{1}{2}(\cot \alpha)u^2 - (\csc \alpha)ut + \frac{1}{2}(\cot \alpha)t^2\right]} f(t)dt \tag{1}
$$

for $\alpha \notin \mathbb{Z}\pi$, and $\mathscr{F}_{n\pi}f(u) = f((-1)^n u)$ for $n \in \mathbb{Z}$ ([\[3\]](#page-19-2), [\[4](#page-19-3)], [\[5\]](#page-19-4)). Clearly,

$$
\mathscr{F}_{\frac{\pi}{2}}f=\mathscr{F}f.
$$

It is shown in [\[3](#page-19-2)] (see also [\[4\]](#page-19-3), [\[5](#page-19-4)]) that \mathscr{F}_{α} satisfies Plancherel's theorem

$$
\|\mathscr{F}_\alpha f\|_{L^2(\mathbb{R})}=\|f\|_{L^2(\mathbb{R})}
$$

and that $\mathscr{F}_{\alpha} f \in L^2(\mathbb{R})$ depends continuously on α when $f \in L^2(\mathbb{R})$; moreover, $\{\mathscr{F}_{\alpha}\}\$ forms a *one-parameter group*, i.e., it satisfies $\mathscr{F}_0 = I$ (identity) and

$$
\mathscr{F}_{\alpha} \circ \mathscr{F}_{\beta} = \mathscr{F}_{\alpha+\beta} \quad (\alpha, \beta \in \mathbb{R}). \tag{2}
$$

More generally, $\{\mathscr{F}_{\alpha}\}\$ is a subgroup of a three-parameter group of unitary transformations on $L^2(\mathbb{R})$ called the *linear canonical transforms* (LCTs; [\[6](#page-19-5)], [\[7](#page-19-6), Ch. 9]). Up to suitable completion, the LCTs take the form

$$
\mathscr{L}_{A,B,C}f(u) = D \cdot \int_{\mathbb{R}} e^{i\left[\frac{1}{2}Au^2 - But + \frac{1}{2}Ct^2\right]} f(t)dt,\tag{3}
$$

where $A, B, C \in \mathbb{R}, B \neq 0$, and $D \in \mathbb{C}$ is an appropriate constant with $|D| = \sqrt{\frac{|B|}{2\pi}}$ (whose precise value will be omitted). For simplicity, we will denote $\mathscr{L}_{A,B,C}$ by the triple $[A, B, C]$. Thus, for example,

$$
\mathscr{F}_{\alpha} = [\cot \alpha, \csc \alpha, \cot \alpha]. \tag{4}
$$

Besides $\{\mathscr{F}_{\alpha}\}\)$, the LCTs contain two other one-parameter subgroups:

$$
\mathscr{E}_{\alpha} := \left[\frac{1}{\alpha}, \frac{1}{\alpha}, \frac{1}{\alpha}\right],\tag{5}
$$

$$
\mathscr{G}_{\alpha} := [\coth \alpha, \operatorname{csch} \alpha, \coth \alpha]. \tag{6}
$$

It is easy to see that if $[A(\alpha), B(\alpha), C(\alpha)]$ $(\alpha \in \mathbb{R})$ is a one-parameter subgroup of the LCTs, then so are the following (where $\omega, \lambda, \gamma \in \mathbb{R}$ are arbitrary fixed constants):

$$
[A(\omega\alpha), B(\omega\alpha), C(\omega\alpha)], \qquad (7)
$$

$$
\left[\frac{1}{\lambda}A(\alpha), \frac{1}{\lambda}B(\alpha), \frac{1}{\lambda}C(\alpha)\right],\tag{8}
$$

$$
[A(\alpha) - \gamma, B(\alpha), C(\alpha) + \gamma].
$$
\n(9)

The first objective of this note is to show that, up to the transformations $(7)-(9)$ $(7)-(9)$ and under suitable regularity assumptions on the functions $A(\alpha)$, $B(\alpha)$, and $C(\alpha)$, ${\{\mathscr{F}_{\alpha}\}}$, ${\{\mathscr{E}_{\alpha}\}}$, and ${\{\mathscr{G}_{\alpha}\}}$ give all one-parameter subgroups of the LCTs.

Theorem 1.1. Let $\mathcal{L}_{\alpha} = [A(\alpha), B(\alpha), C(\alpha)]$ ($\alpha \in \mathbb{R}$) be a one-parameter subgroup of the LCTs, satisfying [\(14\)](#page-4-0) and [\(15\)](#page-4-1). Then \mathcal{L}_{α} takes one of the following forms:

$$
\begin{cases}\n(I) \quad \left[\frac{1}{\lambda}\cot(\omega\alpha) - \gamma, \ \frac{1}{\lambda}\csc(\omega\alpha), \ \frac{1}{\lambda}\cot(\omega\alpha) + \gamma\right] \quad (\alpha \in \mathbb{R}), \\
(II) \quad \left[\frac{1}{\lambda\alpha} - \gamma, \ \frac{1}{\lambda\alpha}, \ \frac{1}{\lambda\alpha} + \gamma\right] \quad (\alpha \in \mathbb{R}), \\
(III) \quad \left[\frac{1}{\lambda}\coth(\omega\alpha) - \gamma, \ \frac{1}{\lambda}\csch(\omega\alpha), \ \frac{1}{\lambda}\coth(\omega\alpha) + \gamma\right] \quad (\alpha \in \mathbb{R}),\n\end{cases} \tag{10}
$$

for some constants $\omega, \lambda, \gamma \in \mathbb{R}$.

The one-parameter subgroups [\(10\)](#page-2-0) are essentially identified in [\[7](#page-19-6), §9.3] using Lie-theoretic methods. However, the problem of characterizing all one-parameter subgroups of the LCTs is considered only formally in [\[7\]](#page-19-6). Our approach here is more direct: We turn the subgroup property into functional equations satisfied by $A(\cdot)$, $B(\cdot)$, and $C(\cdot)$, and eventually reduce the problem to solving differential equations. It should be noted that the regularity condition of Theorem [1.1](#page-2-1) is limited by our approach and can likely be weakened. Note also that there are one-parameter subgroups of the LCTs (corresponding to the case $B(\alpha) \equiv \infty$) which are not contained in [\(10\)](#page-2-0) (see [\[7\]](#page-19-6)).

The second objective of this note is to study one-parameter families of LCTs of the form

$$
\mathcal{L}_{\alpha}f(u) = D(\alpha) \int_{\mathbb{R}} e^{i\left[\frac{1}{2}A(\alpha)u^2 - B(\alpha)ut + \frac{1}{2}C(\alpha)t^2\right]} f(t)dt \quad (\alpha \in I),\tag{11}
$$

where $A(\alpha)$, $B(\alpha)$, $C(\alpha)$, $D(\alpha)$ are as in [\(3\)](#page-1-2), and I is an interval. More specifically, we are interested in finding necessary and sufficient conditions for $\mathcal{L}_{\alpha} f$ to be continuous in α and f in certain topologies. To this end, it is useful to notice that $A(\alpha)$ does not influence the magnitude of $\mathcal{L}_{\alpha} f$, and that the integral in [\(11\)](#page-2-2) becomes highly oscillatory when $|B(\alpha)|$ or $|C(\alpha)| \to \infty$. Note that, by composing $\mathscr{L}_{A,B,C}$ with $\mathscr{F}_{-\frac{\pi}{2}}$, one has the identity

$$
\mathcal{L}_{A,B,C}f(u) = \mathcal{L}_{A-\frac{B^2}{C}, -\frac{B}{C}, -\frac{1}{C}}\hat{f}(u)
$$

$$
= \frac{D}{\sqrt{|C|}}e^{i(\frac{A}{2}u^2 + \frac{\pi}{4})} \int_{\mathbb{R}} e^{-i\frac{(Bu-v)^2}{2C}} \hat{f}(v)dv,
$$
(12)

which can be used to turn a highly oscillatory integral into a (at least formally) less oscillatory one.

Assuming that $D(\alpha)$ is continuous, in Section [3](#page-7-0) we show that $\mathcal{L}_{\alpha}: L^2(\mathbb{R}) \to L^2(\mathbb{R})$ is strongly continuous in α if and only if $A(\alpha)$, $B(\alpha)$, and $C(\alpha)$ are continuous in α . Assuming that $A(\alpha)$, $B(\alpha)$, $C(\alpha)$, and $D(\alpha)$ are all continuous, in Section [4](#page-9-0) we show that $\mathcal{L}_{\alpha} f(u)$ (u fixed) is continuous in α for all $f \in L^2(\mathbb{R}, (1+t^2)^r dt)$ if and only if $r > 1/2$, and that, assuming additionally $C(\alpha) \neq 0$, $\mathcal{L}_{\alpha} f(u)$ is continuous for all $f \in H^s(\mathbb{R})$ (Sobolev space of order s) if and only if $s > 1/2$.

To study the case where $|C(\alpha)| \to \infty$, we will specialize to the situation where the convergence of $\mathcal{L}_{\alpha} f$ can be reduced by [\(12\)](#page-2-3) to that of

$$
L_a f(u) := \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} e^{i[b(a)uv + av^2]} \hat{f}(v) dv \quad (a \to 0),
$$
 (13)

where $b(a)$ satisfies $\lim_{a\to 0} b(a) = 1$. This is indeed the case, for example, when $\mathcal{L}_{\alpha} = \mathscr{E}_{\alpha}$ (with $a = -\frac{\alpha}{2}$), \mathscr{F}_{α} (with $a = -\frac{\tan \alpha}{2}$), or \mathscr{G}_{α} (with $a = -\frac{\tanh \alpha}{2}$).

Assuming that $b(a)$ is Lipschitz near $a = 0$, in Section [4](#page-9-0) we extend a result by Carleson [\[8](#page-19-7)] for the case $b(a) = 1$, by showing that

$$
\lim_{a \to 0} L_a f(u) = f(u), \quad \forall u \in \mathbb{R}
$$

holds for all $f \in C_c^s(\mathbb{R})$ (Hölder space of order s) if and only if $s > 1/2$, and that

$$
\limsup_{a \to 0} |L_a f(u)| < \infty, \quad \forall u \in \mathbb{R}
$$

holds for all $f \in C_c^s(\mathbb{R})$ if and only if $s \geq 1/2$.

Under the same assumption on $b(a)$, in Section [5](#page-14-0) we show that

$$
\lim_{a \to 0} L_a f(u) = f(u), \quad a.e. \ u \in \mathbb{R}
$$

holds for all $f \in H^s(\mathbb{R})$ if and only if $s \geq 1/4$. The necessity part is a direct gener-alization of a result by Dahlberg-Kenig [\[9\]](#page-19-8) for the case $b(a) = 1$. The sufficiency part is due to Carleson [\[8](#page-19-7)] when $b(a) = 1$, and to Cho-Lee-Vargas [\[10\]](#page-20-0) (for $s > 1/4$) and Ding-Niu [\[11](#page-20-1)] (for $s = 1/4$) in the general case. In fact, [\[10](#page-20-0)] and [\[11\]](#page-20-1) consider more general phase functions and their proofs are quite involved. Here we give a simplified proof utilizing the quadratic phase structure in [\(13\)](#page-3-0).

Finally, Section [6](#page-18-0) is concerned with possible global bound for the maximal function

$$
L_* f(u) := \sup_a |L_a f(u)|, \quad u \in \mathbb{R}.
$$

Extending [\[12,](#page-20-2) Theorem 3] for the case $b(a) = \sqrt{1 + a^2}$, we show that if $b(a) \neq 1$ and is continuous, then no global bound of the form

$$
L_*:H^s(\mathbb{R})\to L^p(\mathbb{R})
$$

holds for $s > 0$ and $p < \infty$. This is in sharp contrast with the case $b(a) = 1$, for which L_* is known to be bounded from $H^{1/4}(\mathbb{R})$ to $L^4(\mathbb{R})$ (see [\[13](#page-20-3)]).

2 Proof of Theorem [1.1](#page-2-1)

In this section we prove Theorem [1.1.](#page-2-1) To formulate the precise conditions, we restate Theorem [1.1](#page-2-1) as follows.

Theorem 2.1. Let \mathcal{L}_{α} ($\alpha \in \mathbb{R}$) be a one-parameter family of LCTs of the form [\(11\)](#page-2-2), satisfying

$$
(i) A(\alpha) + C(\alpha) \neq 0; \tag{14}
$$

$$
(ii) A''(\alpha) \text{ and } B''(\alpha) \text{ exist.} \tag{15}
$$

Then \mathscr{L}_{α} ($\alpha \in \mathbb{R}$) forms a one-parameter group in the sense of [\(2\)](#page-1-3) if and only if \mathscr{L}_{α} belongs to one of the three classes in (10) .

Proof. By calculation, we get $\forall f \in L^2(\mathbb{R})$,

$$
\mathcal{L}_{\tilde{\alpha}} \circ \mathcal{L}_{\alpha} f(u) = D(\tilde{\alpha}) D(\alpha) \sqrt{\frac{i\pi}{C(\alpha) + A(\tilde{\alpha})}} \times \int_{\mathbb{R}} f(t) e^{i \left[(A(\alpha) - \frac{B^2(\alpha)}{4(A(\tilde{\alpha}) + C(\alpha))}) t^2 - \frac{B(\alpha) B(\tilde{\alpha})}{2(A(\tilde{\alpha}) + C(\alpha))} ut + (C(\alpha) - \frac{B^2(\alpha)}{4(A(\tilde{\alpha}) + C(\alpha))}) u^2 \right]} dt.
$$

Then we get that algebraic property is equivalent to equations

$$
\begin{cases}\nA(\tilde{\alpha} + \alpha) = A(\alpha) - B^2(\alpha) (A(\tilde{\alpha}) + C(\alpha))^{-1} & 1 \\
B(\tilde{\alpha} + \alpha) = B(\alpha) B(\tilde{\alpha}) (A(\tilde{\alpha}) + C(\alpha))^{-1} & 2) \\
C(\tilde{\alpha} + \alpha) = C(\alpha) - B^2(\alpha) (A(\tilde{\alpha}) + C(\alpha))^{-1} & 3) \\
D(\tilde{\alpha} + \alpha) = \sqrt{2\pi i} D(\alpha) D(\tilde{\alpha}) (A(\tilde{\alpha}) + C(\alpha))^{-\frac{1}{2}}.\n\end{cases}
$$

For sufficiency, we just need to substitute $(I), (II)$ and (III) into the equations above.

For necessity, firstly we show that $\forall \alpha$, $C(\alpha) - A(\alpha) \equiv const.$ By equation 2) and interchange α and $\tilde{\alpha}$, we get

$$
C(\alpha) + A(\tilde{\alpha}) = \frac{B(\tilde{\alpha})B(\alpha)}{B(\alpha + \tilde{\alpha})},
$$

$$
C(\tilde{\alpha}) + A(\alpha) = \frac{B(\tilde{\alpha})B(\alpha)}{B(\alpha + \tilde{\alpha})}.
$$

So $\forall \alpha, \tilde{\alpha} \in \mathbb{R}, C(\alpha) + A(\tilde{\alpha}) = C(\tilde{\alpha}) + A(\alpha)$. Then $\exists C_0 \in \mathbb{R}, C(\alpha) - A(\alpha) \equiv C_0$. For simplicity, now let $A(\tilde{\alpha}) + C(\alpha) = (A(\tilde{\alpha}) + \frac{C_0}{2}) + (A(\alpha) + \frac{C_0}{2}) \triangleq a(\alpha) + a(\tilde{\alpha}), B(\alpha) \triangleq \frac{1}{b(\alpha)}$. Then rewrite eugations 1)-4) below.

$$
\begin{cases}\na(\tilde{\alpha} + \alpha) - a(\alpha) = -(b^2(\alpha)(a(\alpha) + a(\tilde{\alpha})))^{-1} & 1)'\nb(\alpha + \tilde{\alpha}) = b(\alpha)b(\tilde{\alpha})(a(\alpha) + a(\tilde{\alpha})) & 2)'\nD(\alpha + \tilde{\alpha}) = \sqrt{2\pi i}D(\alpha)D(\tilde{\alpha})(a(\alpha) + a(\tilde{\alpha}))^{-\frac{1}{2}}. & 3)'\n\end{cases}
$$

In order to derive the solution we want, next we need to show that

$$
b'(0) \neq 0, \ (ab)'(0) = 0.
$$

$$
\overline{5}
$$

By 2)' we get

$$
b(\alpha + \tilde{\alpha}) = (ab)(\alpha)b(\tilde{\alpha}) + (ab)(\tilde{\alpha})b(\alpha).
$$
 (16)

Differentiate w.r.t. $\tilde{\alpha}$ and let $\tilde{\alpha} = 0$, we have

$$
b'(\alpha) = (ab)(\alpha)b'(0) + (ab)'(0)b(\alpha).
$$
 (17)

If $b'(0) = 0$, $b'(\alpha) = -2(ab)'(0)b(\alpha)$. When $(ab)'(0) = 0$, $b(\alpha) \equiv const.$ And then by 2)', we get $a(\alpha) \equiv const.$ This leads to contradiction with 1)'. When $(ab)'(0) \neq 0, b(\alpha)$ is an exponential function multiplied by a constant at most. Similarly by 2)', we get $a(\alpha)$ is a constant function, which also leads to contradiction with 1)'. So we get

 $b'(0) \neq 0.$

For $(ab)'(0)$, we set $f(\alpha) \triangleq b(\alpha)e^{-(ab)'(0)\alpha}$. By [\(16\)](#page-5-0) and calculation, we get

$$
f'(\alpha) = b'(0)(af)(\alpha),\tag{18}
$$

 $f(\alpha + \tilde{\alpha}) = (af)(\alpha)f(\tilde{\alpha}) + (af)(\tilde{\alpha})f(\alpha).$ (19)

Differentiate w.r.t. $\tilde{\alpha}$ in [\(19\)](#page-5-1) and let $\tilde{\alpha} = 0$, we have

$$
f'(\alpha) = (af)(\alpha)f'(0) + (af)'(0)f(\alpha).
$$
 (20)

Similar to proof of $b'(0) \neq 0$, we could also show that $f'(0) \neq 0$. By taking derivative of (18) and (20) , we have

$$
f''(0) = b'(0)(af)'(0),
$$

\n
$$
f''(0) = 2f'(0)(af)'(0).
$$
\n(21)

Now we suppose $f''(0) \neq 0$, then $b'(0) = 2f'(0)$. And because $f'(0) = b'(0)(ab)(0)$, we get $(ab)(0) = \frac{1}{2}$, and then we calculate that

$$
(af)'(0) = (ab)'(0)[1 - (ab)(0)] = \frac{1}{2}(ab)'(0).
$$

Based on these results and by (17) , (20) , we have

$$
\frac{1}{2}b'(\alpha)e^{-(ab)'(0)\alpha} = \frac{1}{2}[b'(0)(ab)(\alpha) + (ab)'(0)b(\alpha)]e^{-(ab)'(0)\alpha},
$$

$$
f'(\alpha) = \frac{1}{2}[b'(0)(ab)(\alpha) + (ab)'(0)b(\alpha)]e^{-(ab)'(0)\alpha}.
$$

Thus, $f'(\alpha) = \frac{1}{2}b'(\alpha)e^{-(ab)'(0)\alpha}$. Since $f'(\alpha) = [b'(\alpha)-(ab)'(0)b(\alpha)]e^{-(ab)'(0)\alpha}$, we have

$$
b'(\alpha) = 2(ab)'(0)b(\alpha).
$$

However, it will lead to contradiction with equations 1 ' -2 '. So $f''(0) = 0$. Then by (21) , we get $(af)'(0) = 0$. Now rewrite (20) ,

$$
f'(\alpha) = f'(0)(af)(\alpha). \tag{22}
$$

When $\alpha = 0$, we have that $(af)(0) = 1$. Let $\alpha = \tilde{\alpha} = 0$ in [\(19\)](#page-5-1), then $f(0) = 0$. And differentiate w.r.t. α in [\(22\)](#page-6-0) and let $\alpha = 0$, then $f''(0) = 0$. Lastly by taking partial derivatives of second order in [\(19\)](#page-5-1), we get $\exists \omega \in \mathbb{R}$,

$$
f''(\alpha) = \omega f(\alpha). \tag{23}
$$

In the following, we solve f based on the value range of ω .

When $\omega = 0$, since $f(0) = 0$, we solve that

$$
f(\alpha) = \lambda \alpha,
$$

$$
b(\alpha) = \lambda \alpha e^{(ab)'(0)\alpha}, \ \forall \ \lambda \in \mathbb{R}
$$

Then by equations 1)'-2)', we get that

$$
(ab)'(0) = 0.
$$

For the same reason, when $\omega > 0$ or < 0 , we could solve f from [\(23\)](#page-6-1). Then by $f(0) = 0$ and equations 1)'-2)' we could get that $(ab)'(0) = 0$. So (17) can be rewritten as

$$
b'(\alpha) = b'(0)(ab)(\alpha).
$$

This equation is similar to [\(22\)](#page-6-0), in fact we could follow the proof above and show that $\exists \omega \in \mathbb{R},$

$$
b''(\alpha) = \omega b(\alpha).
$$

In fact, no matter what ω is, the proof idea is same. So we just consider $\omega > 0$ below. When $\omega > 0$, we solve that

$$
b(\alpha) = \lambda e^{\sqrt{\omega}\alpha} + \gamma e^{-\sqrt{\omega}\alpha}, \ \forall \ \lambda, \omega \in \mathbb{R}.
$$

Since $b(0) = f(0) = 0$ and b satisfies 1)'-2)', we can calculate that

$$
\begin{cases}\nA(\alpha) = \frac{1}{\lambda} \coth(\omega \alpha) + \gamma \\
B(\alpha) = \frac{1}{\lambda} \operatorname{csch}(\omega \alpha) \quad \text{for some } \lambda, \omega, \gamma \in \mathbb{R} \\
C(\alpha) = \frac{1}{\lambda} \coth(\omega \alpha) - \gamma.\n\end{cases}
$$

Now solve $D(\alpha)$, let $C_1 \triangleq \sqrt{2\pi i\lambda}$. By 3)', we have $D(\alpha + \tilde{\alpha}) = C_3D(\alpha)D(\tilde{\alpha})$ $(\coth(\omega\alpha) + \coth(\omega\tilde{\alpha}))^{-\frac{1}{2}}$. Take $E(\alpha) \triangleq C_1 \sqrt{\sinh(\omega\alpha)} D(\alpha)$, then $\forall \alpha, \tilde{\alpha} \in \mathbb{R}$,

$$
E(\alpha + \tilde{\alpha}) = E(\alpha)E(\tilde{\alpha}).
$$

$$
7\,
$$

So $\exists \theta \in \mathbb{R}, E(\alpha) = e^{\theta \alpha}, D(\alpha) = \frac{1}{C_1 \sqrt{\sinh(\omega \alpha)}} e^{\theta \alpha} = \sqrt{\frac{1}{2\pi i \lambda \sinh(\omega \alpha)}} e^{\theta \alpha}, \forall \theta \in \mathbb{R}$. On the other hand, we could calculate that

$$
\|\mathscr{L}_\alpha f\|_{L^2(\mathbb{R}}=\Big|D(\alpha)\sqrt{\frac{i}{2A(\alpha)}}\Big|\Big(-\frac{2A(\alpha)}{B(\alpha)}\Big)^{\frac{1}{2}}\|f\|_{L^2(\mathbb{R})}.
$$

Especially when we suppose that \mathscr{L}_{α} is a unitary operator, we have $(\frac{2A(\alpha)}{B(\alpha)})^{\frac{1}{2}} = 1$. Then we get $e^{\theta \alpha} = \sqrt{2\pi}$. Similarly, we get the solutions $\left|D(\alpha)\sqrt{\frac{i}{2A(\alpha)}}\right| \left(-\frac{2A(\alpha)}{B(\alpha)}\right)$ (I) and (II) . This completes the proof of Theorem [2.1.](#page-4-2) \Box

 $3 L²$ convergence

In this section, we consider strong continuity of the operator $\mathcal{L}_{\alpha}: L^2(\mathbb{R}) \to L^2(\mathbb{R})$ with respect to α . We may assume without loss of generality that $C(\alpha) \neq 0$, so that the continuity of \mathcal{L}_{α} reduces by [\(12\)](#page-2-3) to that of G_{α} (which we now define).

Definition 3.1. G_{α} is an operator well defined on $\mathcal{S}(\mathbb{R})$. For each α , $B(\alpha) \neq 0$,

$$
G_{\alpha}f(u) \triangleq D(\alpha) \int_{\mathbb{R}} \hat{f}(\xi) e^{i[A(\alpha)\xi^2 + B(\alpha)u\xi]} d\xi \quad (c_0 \leq \alpha \leq c_1).
$$

By density, there is a unique bounded extension of G_{α} on L^2 .

First we apply Plancherel's theorem to G_{α} . (For related estimates in $L^p(\mathbb{R})$, see $[14]$ $[14]$.)

Lemma 3.1. For $f \in L^2(\mathbb{R})$, we have

$$
||G_{\alpha}f||_{L^{2}(\mathbb{R})} = \left(\frac{2\pi D^{2}(\alpha)}{|B(\alpha)|}\right)^{\frac{1}{2}}||f||_{L^{2}(\mathbb{R})}.
$$

Proof. Take $g(\xi) \triangleq \hat{f}(\xi)e^{i\frac{1}{2}C(\alpha)\xi^2}$. By Plancherel's theorem, we get $\forall f \in \mathcal{S}(\mathbb{R})$,

$$
||G_{\alpha}f||_{L^{2}(\mathbb{R})}^{2} = \frac{2\pi D^{2}(\alpha)}{|B(\alpha)|}||g^{\vee}||_{L^{2}(\mathbb{R})}^{2} = \frac{2\pi D^{2}(\alpha)}{|B(\alpha)|}||f||_{L^{2}(\mathbb{R})}^{2}.
$$

 \Box

By density, we have $\forall f \in L^2(\mathbb{R})$, $||G_\alpha f||_{L^2(\mathbb{R})} = \left(\frac{2\pi D^2(\alpha)}{|B(\alpha)|}\right)$ $\frac{\pi D^2(\alpha)}{|B(\alpha)|}$ $\frac{1}{2}$ $||f||_{L^2(\mathbb{R})}$.

Since we are concerned with continuous $D(\alpha)$, we will assume without loss of generality that

$$
D(\alpha) = 1.
$$

Theorem 3.1. $\lim_{\alpha \to \alpha_0} ||G_{\alpha}f - G_{\alpha_0}f||_{L^2(\mathbb{R})} = 0$ holds for all $f \in L^2(\mathbb{R})$ if and only if $A(\alpha)$ and $B(\alpha)$ are continuous at $\alpha = \alpha_0$.

Proof. For $\delta > 0$, define $U(\alpha_0, \delta) \triangleq {\alpha : |\alpha - \alpha_0| < \delta}$. For sufficiency, by Uniformly Bounded Theorem, it suffices to show that

$$
(1) \exists C_0, \delta_1 > 0, \forall \alpha \in U(\alpha_0, \delta_1), ||G_{\alpha}|| \leq C_0.
$$

$$
(2) \forall f \in C_0^{\infty}(\mathbb{R}), \lim_{\alpha \to \alpha_0} ||G_{\alpha}f - G_{\alpha_0}f||_{L^2(\mathbb{R})} = 0.
$$

For (1) By condition (1) and (2), we get $B(\alpha)$ exists a positive lower bound C_0 on a neighborhood $U(\alpha_0, \delta_1)$. Then using Lemma (3.1) , $\forall \alpha \in U(\alpha_0, \delta_1)$, $\forall f \in L^2(\mathbb{R})$, $||G_{\alpha}f||_{L^2(\mathbb{R})} \leq C_0||f||_{L^2(\mathbb{R})}$. Then $\forall \alpha, ||G_{\alpha}|| \leq C_0$.

For (2) It takes two steps.

I. Show that $\forall u \in L^2(\mathbb{R}), \ \forall f \in C_0^{\infty}(\mathbb{R}), \lim_{\alpha \to \alpha_0} G_{\alpha} f(u) = G_{\alpha_0} f(u)$. In particular, when u belongs to a bounded interval $[a, b]$, the limit above is uniformly convergent w.r.t $u \in [a, b]$.

\forall u \in L^{2}(\mathbb{R}), |G_{\alpha}f(u) - G_{\alpha_{0}}f(u)|
$$

\n
$$
\leq \int_{\mathbb{R}} |\hat{f}(\xi)| |e^{i[(A(\alpha) - A(\alpha_{0}))\xi^{2} + (B(\alpha) - B(\alpha_{0}))u\xi]} - 1| d\xi
$$

\n
$$
\leq \int_{\mathbb{R}} |\hat{f}(\xi)| |[A(\alpha) - A(\alpha_{0})|\xi^{2} + |B(\alpha) - B(\alpha_{0})|(|a| + |b|)|\xi|] d\xi.
$$

By Dominated Convergence Theorem, the limit is zero as $\alpha \to \alpha_0$.

II. Show that $\forall f \in C_0^{\infty}(\mathbb{R})$, $\exists H \in L^2(\mathbb{R})$, $\forall \alpha$, $\forall u$, $|G_{\alpha} f(u)| \leq |H(u)|$. Firstly we can easily get $\exists C_1 > 0$, $\forall \alpha$, $|G_{\alpha} f(u)| \leq \frac{C_1}{|u|}$ by integration by parts and $|G_{\alpha} f(u)| \leq \|f\|_{L^1(\mathbb{R})}$. Now define

$$
H(u) = \begin{cases} ||f||_{L^1(\mathbb{R})} & \forall \ |u| \leq 1, \\ \frac{C_1}{|u|} & \forall \ |u| > 1. \end{cases}
$$

By I and II, we prove that $\forall f \in C_0^{\infty}(\mathbb{R})$, $\lim_{\alpha \to \alpha_0} ||G_{\alpha}f - G_{\alpha_0}f||_{L^2(\mathbb{R})} = 0$.

For necessity, suppose $\lim_{\alpha \to \alpha_0} B(\alpha) \neq B(\alpha_0)$, then $\exists \epsilon_0 > 0$, $\forall \delta > 0$, $\exists \alpha \in U(\alpha_0, \delta)$, $\|G_{\alpha}f - G_{\alpha_0}f\|_{L^2(\mathbb{R})} \geqslant$ $\sqrt{\frac{1}{B(\alpha)}} - \sqrt{\frac{1}{B(\alpha_0)}}$ $\sqrt{2\pi}$ || f || $_{L^2(\mathbb{R})} \geq \epsilon_0 \sqrt{2\pi}$ || f || $_{L^2(\mathbb{R})}$. It leads to contradiction with L^2 convergence. So $\lim_{\alpha \to \alpha_0} B(\alpha) = B(\alpha_0)$ is necessary. Furthermore, let $\lim_{\alpha \to \alpha_0} A(\alpha) \neq A(\alpha_0)$. Without loss of generality, suppose $A(\alpha) - A(\alpha_0) \neq 0$ on $U(\alpha_0, \delta)$ and $B(\alpha) \equiv 1$, then by Plancherel's theorem, we have

$$
||G_{\alpha}f - G_{\alpha_0}f||_{L^2(\mathbb{R})} = ||\hat{f}(\xi)(e^{i[A(\alpha) - A(\alpha_0)]\xi^2} - 1)||_{L^2(\mathbb{R})}.
$$

Take $\hat{f}(\xi) = \chi_E(\xi)$, where $E = U(\sqrt{\frac{\pi}{|A(\alpha) - A(\alpha_0)}}, \sqrt{\frac{1}{50|A(\alpha)}},$ $\frac{1}{50|A(\alpha)-A(\alpha_0)|}$). Then we have $\lim_{\alpha \to \alpha_0} ||G_{\alpha} f - G_{\alpha_0} f||_{L^2(\mathbb{R})} \neq 0$. This leads to a contradiction. The proof of Theorem [3.1](#page-7-2) is complete. \Box

4 Pointwise convergence

In this section we study pointwise continuity of $G_{\alpha} f(u)$ with respect to α . First we consider the problem for f belonging to suitable weighted L^2 spaces.

Lemma 4.1. Suppose $A(\alpha) \neq 0$. Then

$$
G_{\alpha}f(u) = \sqrt{\frac{i}{2A(\alpha)}}D(\alpha) \int_{\mathbb{R}} f(t)e^{-i\frac{(B(\alpha)u-t)^2}{4A(\alpha)}} dt, \quad \forall f \in C_0^{\infty}(\mathbb{R}).
$$

Proof. $\forall f \in C_0^{\infty}(\mathbb{R}),$

$$
G_{\alpha}f(u) = D(\alpha) \int_{\mathbb{R}} \left(\frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} f(t) e^{-i\xi t} dt \right) e^{i[A(\alpha)\xi^{2} + B(\alpha)u\xi]} d\xi
$$

\n
$$
= \lim_{N \to +\infty} D(\alpha) \int_{-N}^{N} e^{i[A(\alpha)\xi^{2} + B(\alpha)u\xi]} \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} f(t) e^{-i\xi t} dt d\xi
$$

\n
$$
= \frac{D(\alpha)}{\sqrt{2\pi}} \lim_{N \to +\infty} \int_{\mathbb{R}} f(t) \int_{-N}^{N} e^{i[A(\alpha)\xi^{2} + (B(\alpha)u - t)\xi]} d\xi dt \quad \text{(Fubini's Theorem)}.
$$

Since $\int_{\mathbb{R}} \sin x^2 dx = \int_{\mathbb{R}} \cos x^2 dx = \sqrt{\frac{\pi}{2}}$ (cf. [\[15\]](#page-20-5)), we have for $a \neq 0$,

$$
\int_{\mathbb{R}} e^{i(a\xi^2 + b\xi)} d\xi = \sqrt{\frac{\pi}{a}} e^{-i\frac{b^2}{4a} + \frac{\pi}{4}i}.
$$

This completes the proof of Lemma [4.1.](#page-9-1)

Theorem 4.1. Suppose $A(\alpha)$ and $B(\alpha)$ are continuous at $\alpha = \alpha_0$, and $A(\alpha_0) \neq 0$. Then for all $f \in L^2((1+t^2)^r dt)$ with $r > \frac{1}{2}$, we have

$$
\lim_{\alpha \to \alpha_0} G_{\alpha} f(u) = G_{\alpha_0} f(u), \quad u \in \mathbb{R}.
$$
\n(24)

.

 \Box

Conversely, if there exists $u_0 \in \mathbb{R}$ such that $\lim_{\alpha \to \alpha_0} G_{\alpha} f(u_0) = G_{\alpha_0} f(u_0)$ holds for all $f \in L^2((1+t^2)^r dt)$, then $r > \frac{1}{2}$.

Proof. By the uniform boundedness theorem, it suffices to show

, $\exists C_0, \delta > 0$, $\sup_{\substack{f \in C_0^{\infty}(\mathbb{R}) \\ \alpha \in U(\alpha_0, \delta)}} \frac{|G_{\alpha}f(u)|}{\|f\|} \leq C_0$, where $\|f\| = \left(\int_{\mathbb{R}} |f(t)|^2 (1+t^2)^r dt\right)^{\frac{1}{2}}$

For I By condition and Theorem [3.1,](#page-7-2) we can get I.

For II By Lemma [4.1,](#page-9-1) When $r > \frac{1}{2}$,

$$
|G_{\alpha}f(u)| \leq C_0 \int_{\mathbb{R}} |f(t)| dt
$$

\n
$$
\leq C_0 \|f\|_{L^2((1+t^2)^r dt)} \Big(\int_{\mathbb{R}} (1+t^2)^{-r} dt\Big)^{\frac{1}{2}}
$$

\n
$$
\leq C_0 \|f\|_{L^2((1+t^2)^r dt)}.
$$

Conversely, if for all $f \in L^2((1+t^2)^r dt)$, $\lim_{\alpha \to \alpha_0} G_{\alpha} f(u_0) = G_{\alpha_0} f(u_0)$. By the uniform boundedness theorem again, $\exists C > 0$, such that $||G_{\alpha}|| \leq C$. By the Riesz representation theorem, we have

$$
||G_{\alpha}|| = \left\| \sqrt{\frac{i}{2A(\alpha)}} (1+(\cdot)^2)^{-\frac{r}{2}} e^{-i\frac{(B(\alpha)u_0 - (\cdot))^2}{4A(\alpha)}} \right\|_{L^2(\mathbb{R})}.
$$

Thus $r > \frac{1}{2}$. This completes the proof of Theorem [4.1.](#page-9-2)

Remark 4.1. When $r > \frac{1}{2}$, we have $L^2((1+t^2)^r dt) \subset L^1(\mathbb{R})$, thus [\(24\)](#page-9-3) holds even when $B(\alpha_0)=0$.

Next, we consider the pointwise convergence problem for f belonging to the Sobolev spaces $H^s(\mathbb{R})$.

Theorem 4.2. Suppose $A(\alpha)$ and $B(\alpha)$ are continuous at $\alpha = \alpha_0$. Then for all $f \in H^s(\mathbb{R})$ with $s > \frac{1}{2}$, we have

$$
\lim_{\alpha \to \alpha_0} G_{\alpha} f(u) = G_{\alpha_0} f(u), \quad u \in \mathbb{R}.
$$

Conversely, if there exists $u_0 \in \mathbb{R}$ such that $\lim_{\alpha \to \alpha_0} G_{\alpha} f(u_0) = G_{\alpha_0} f(u_0)$ holds for all $f \in H^s(\mathbb{R})$, then $s > \frac{1}{2}$.

Proof. Similar to the proof of Theorem [4.1,](#page-9-2) it suffices to show

I $\forall u \in \mathbb{R}, \ \forall f \in C_0^{\infty}(\mathbb{R}), \ \lim_{\alpha \to \alpha_0} G_{\alpha} f(u) = G_{\alpha_0} f(u);$

, $\exists C_0, \delta > 0$, $\sup_{\substack{f \in C_0^{\infty}(\mathbb{R}) \\ \alpha \in U(\alpha_0, \delta)}} \frac{|G_{\alpha}f(u)|}{\|f\|} \leq C_0$, where $||f|| = \left(\int_{\mathbb{R}} |\hat{f}(\xi)|^2 (1 + |\xi|^2)^s dt\right)^{\frac{1}{2}}$.

For I By Theorem [3.1](#page-7-2) and the assumptions, we get I. For II By Definition [3.1,](#page-7-3) for $s > \frac{1}{2}$, we have

$$
|G_{\alpha}f(u)| \leqslant \int_{\mathbb{R}} |\hat{f}(\xi)| d\xi
$$

$$
\leqslant ||f||_{H^{s}(\mathbb{R})} \left(\int_{\mathbb{R}} (1+\xi^{2})^{-s} d\xi \right)^{\frac{1}{2}}
$$

 \Box

 $\leqslant C_0 \|f\|_{H^s(\mathbb{R})}.$

Conversely, if for all $f \in H^s(\mathbb{R})$, $\lim_{\alpha \to \alpha_0} G_{\alpha} f(u_0) = G_{\alpha_0} f(u_0)$ holds. Then $\exists C > 0$ such that $||G_{\alpha}|| \leq C$. By the Riesz theorem again, we have

$$
||G_{\alpha}|| = \left\|(1+(\cdot)^2)^{-\frac{s}{2}}e^{i[(A(\alpha)(\cdot))^2 + B(\alpha)u_0(\cdot)]}\right\|_{L^2(\mathbb{R})}.
$$

 \Box

Thus $s > \frac{1}{2}$. This completes the proof of Theorem [4.2](#page-10-0)

We turn to the operator L_a defined in [\(13\)](#page-3-0) and consider its limit as $a \to 0$. The space of Hölder continuous functions supported in (c, d) will be denoted by $C_c^s(c, d)$, where s is the Hölder exponent. Since $C_c^s(c, d) \subset H^s(\mathbb{R})$ (cf. [\[16,](#page-20-6) §1.4]), by Theorem [4.2](#page-10-0) the pointwise convergence [\(24\)](#page-9-3) holds for all $f \in C_c^s(c, d)$ with $s > 1/2$.

We will show that the condition $s > \frac{1}{2}$ is also optimal for Hölder continuous functions. First we state a positive result.

Theorem 4.3. Suppose $b(a)$ is Lipschitz continuous on $[0, c_1]$, and $b(0) = 1$. Then there exists a constant $C_2 > 0$, such that for all $R > |c| + |d|$, we have

$$
\Big\| \sup_{a \in [0,c_1]} |L_a f| \Big\|_{L^{\infty}[-R,R]} \leq C_2 (1 + |d - c|) R^{\frac{1}{2}} \|f\|_{C_c^{\frac{1}{2}}(c,d)}.
$$

Proof. For simplicity, denote $b(a) \triangleq b$ and $||f||_{C_c^{\frac{1}{2}}(c,d)} \triangleq ||f||$. By Lemma [4.1,](#page-9-1)

$$

\leq |2a|^{-\frac{1}{2}} \left| \int_{c - bu}^{d - bu} f(t + u) e^{-i \frac{t^2}{4a}} dt \right|
$$

\n
$$
+ |2a|^{-\frac{1}{2}} \left| \int_{c - bu}^{d - bu} (f(t + bu) - f(t + u)) e^{-i \frac{t^2}{4a}} dt \right|
$$

\n
$$
\stackrel{\triangle}{=} I + II.
$$

When $u \neq 0$, without loss of generality, suppose the lower limit of the integral above satisfies $c - bu \geq 0$ (if $c - bu < 0$, we can divide I into $\int_{c - bu}^{0}$ and $\int_{0}^{d - bu}$). Now we divide *I* into several parts. Let $t_k = \sqrt{8k\pi a}$ $(k = n_1 + 1, n_1 + 2, \dots, n_2; n_1, n_2 > 0), t_{n_1} =$ $c - bu \in [\sqrt{8n_1\pi a}, \sqrt{8(n_1 + 1)\pi a}), t_{n_2+1} = d - bu \in (\sqrt{8n_2\pi a}, \sqrt{8(n_2 + 1)\pi a}).$

$$
I \leqslant |2a|^{-\frac{1}{2}} \sum_{k=n_1}^{n_2} \left| \int_{t_k}^{t_{k+1}} (f(t+u) - f(t_k+u)) e^{-i \frac{t^2}{4a}} \, dt \right|
$$

$$
+ |2a|^{-\frac{1}{2}} \sum_{k=n_1}^{n_2} |f(t_k+u) \int_{t_k}^{t_{k+1}} e^{-i\frac{t^2}{4a}} dt |.
$$

\n
$$
\stackrel{\triangle}{=} I^{(1)} + I^{(2)}.
$$

\n
$$
I^{(1)} \lesssim |a|^{-\frac{1}{2}} \|f\| \sum_{k=n_1}^{n_2} |t_{k+1} - t_k|^{\frac{3}{2}} \lesssim |a|^{\frac{1}{4}} \|f\| \sum_{k=n_1+1}^{n_2+1} k^{-\frac{3}{4}} \lesssim R^{\frac{1}{2}} \|f\|.
$$

I^{(2)} \lesssim \|f\| \sum_{k=n_1}^{n_2} \Big| \int_{\frac{t_{k+1}^2}{4a}}^{ \frac{t_k^2}{4a}} e^{-it} \frac{1}{\sqrt{t}} dt \Big|.

Now divide $\sum_{n=1}^{n_2}$ $_{k=n_1}$ $\begin{array}{c} \begin{array}{c} \begin{array}{c} \end{array}\\ \begin{array}{c} \end{array} \end{array} \end{array}$ $\int_{\frac{t^2_k}{4a}}^{\frac{t^2_k}{4a}}$ $e^{-it} \frac{1}{\sqrt{2}}$ $\frac{1}{t}$ dt into three parts: (1) Using integration by parts,

(2) \left| \int_{\frac{(c-bu)^2}{4a}}^{2(n_1+1)\pi} e^{-it} \frac{1}{\sqrt{t}} dt \right| : \text{ When } n_1 \leq 3, \left| \int_{\frac{(c-bu)^2}{4a}}^{2(n_1+1)\pi} \right| \leq \int_0^{20} t^{-\frac{1}{2}} dt; \text{ Otherwise,}
$$

$$
\left| \int_{\frac{(c-bu)^2}{4a}}^{2(n_1+1)\pi} \right| \leq \int_{2n_1\pi}^{2(n_1+1)\pi} t^{-\frac{1}{2}} dt \leq n_1^{-\frac{1}{2}} \leq \frac{1}{\sqrt{3}};
$$

(3) \left| \int_{2n_2\pi a}^{\frac{(d-bu)^2}{4a}} e^{-it} \frac{1}{\sqrt{t}} dt \right| : \text{Similar to (2)}.

Thus, by the Lipschitz continuity of $b(a)$, we have

II \lesssim |a|^{-\frac{1}{2}} |(d-c)^2(b-1)u|^{\frac{1}{2}} ||f|| \lesssim |d-c|R^{\frac{1}{2}}||f||.

Since $f \in C_c^{1/2}(c,d)$, it is easy to verify that $L_a f(u)$ is continuous with respect to u. Therefore the case $u = 0$ follows immediately from the bound for $u \neq 0$. This completes the proof of Theorem [4.3.](#page-11-0)

Now we state the negative result.

Proposition 4.1. Suppose $|b(a)| \leq M$ and $b(0) = 1$. Then $\exists f \in C_c^{\frac{1}{2}}[\frac{1}{4}, \frac{1}{2}]$ and $u_0 \in (0, \frac{1}{80M})$, such that

\lim_{a \to 0} L_a f(u_0) \neq L_0 f(u_0).
$$

Proof. Let $a_k = 2^{-k}$, $b_k = b(a_k)$. Take $f(t) = \sum_{k=1}^{+\infty}$ $k=1$ $\sqrt{2a_k} e^{i\frac{(b_ku_0-t)^2}{4a_k}}\phi(t)$, where $\phi \in$ $C_0^{\infty}(\mathbb{R})$ and $supp \phi \subset [\frac{1}{4}, \frac{1}{2}]$. It is easy to see that $f \in C[0, 1]$. Let $0 < u_0 < \frac{1}{80M}$. Then

|L_{a_n}f(u_0)| = \Big| \sum_{k=1}^{+\infty} \sqrt{\frac{a_k}{a_n}} \int_{\mathbb{R}} \phi(t) e^{i\left[\frac{(b_k u_0 - t)^2}{4a_k} - \frac{(b_n u_0 - t)^2}{4a_n}\right]} dt \Big|.
$$

13

Now divide $L_{a_n} f(u_0)$ into three parts.

$$
(1) \ k = n : \int_{\mathbb{R}} \phi(t) \ dt \neq 0.
$$
\n
$$
(2) \ k < n : \int_{\mathbb{R}} \frac{1}{2} 2^{\frac{n-k}{2}} \int_{\mathbb{R}} \phi(t) e^{i[2^{k-2}(b_k u_0 - t)^2 - 2^{n-2}(b_n u_0 - t)^2]} \ dt
$$
\n
$$
\leq \sum_{k=1}^{n-1} \int_{\mathbb{R}} \left| \frac{\phi'(t)}{2^{k-1}(b_k u_0 - t) - 2^{n-1}(b_n u_0 - t)} \right| \ dt
$$
\n
$$
+ \int_{\mathbb{R}} \frac{|\phi'(t)| \ |2^{k-1} - 2^{n-1}|}{|2^{k-1}(b_k u_0 - t) - 2^{n-1}(b_n u_0 - t)|^2} \ dt \quad \text{(using integration by parts)}
$$
\n
$$
\leq \sum_{k=1}^{n-1} \frac{2^{\frac{n-k}{2}}}{|2^{k-1} - 2^{n-1}|}
$$
\n
$$
\leq \sum_{k=1}^{n-1} 2^{\frac{n-k}{2}} 2^{-n}
$$
\n
$$
\leq 2^{-\frac{n}{2}} \to 0, \quad \text{as } n \to +\infty.
$$

(3) $k > n$:

$$
\left| \sum_{k=n+1}^{+\infty} 2^{\frac{n-k}{2}} \int_{\mathbb{R}} \phi(t) e^{i[2^{k-2}(b_k u_0 - t)^2 - 2^{n-2}(b_n u_0 - t)^2]} dt \right|
$$

$$
\lesssim \sum_{k=n+1}^{+\infty} \frac{2^{\frac{n-k}{2}}}{|2^{k-1} - 2^{n-1}|}
$$

$$
\lesssim \sum_{k=n+1}^{+\infty} 2^{\frac{n-k}{2}} 2^{-k}
$$

$$
\lesssim \frac{1}{2^n} \sum_{l=1}^{+\infty} 2^{-\frac{l}{2}} \to 0, \text{ as } n \to +\infty.
$$

Since $L_0 f(u_0) = 0$, we get $\lim_{n \to +\infty} L_{a_n} f(u_0) \neq L_0 f(u_0)$. It remains to show $f \in$ $C_c^{\frac{1}{2}}[\frac{1}{4}, \frac{1}{2}]$, that is, $\exists C > 0$, such that $\forall t_1, t_2 \in [\frac{1}{4}, \frac{1}{2}]$, we have

$$
|f(t_1)-f(t_2)|\leq C|t_1-t_2|^{\frac{1}{2}}.
$$

Since $t_1 \neq t_2$, $\exists N > 0$, such that $2^{-(N+1)} < |t_1 - t_2| \leq 2^{-N}$. Now

$$
|f(t_1) - f(t_2)| \lesssim \sum_{k=1}^{+\infty} |\sqrt{2a_k}| \left| e^{i\frac{(b_k u_0 - t_1)^2}{4a_k}} \phi(t_1) - e^{i\frac{(b_k u_0 - t_2)^2}{4a_k}} \phi(t_2) \right|
$$

14

$$
= \left(\sum_{k \le N} + \sum_{k > N} \right) |\sqrt{2a_k}| \left| e^{i \frac{(b_k u_0 - t_1)^2}{4a_k}} \phi(t_1) - e^{i \frac{(b_k u_0 - t_2)^2}{4a_k}} \phi(t_2) \right|
$$

$$
\stackrel{\triangle}{=} I + II,
$$

where

$$
I \lesssim \sum_{k \le N} 2^{-\frac{k}{2}} (2^k + 1) |t_1 - t_2| \qquad \text{(by the mean value theorem)}
$$

$$
\lesssim 2^{\frac{N}{2}} |t_1 - t_2| \lesssim |t_1 - t_2|^{\frac{1}{2}},
$$

$$
II \lesssim \sum_{k > N} 2^{-\frac{k}{2}}
$$

$$
\lesssim 2^{-\frac{N}{2}} \lesssim |t_1 - t_2|^{\frac{1}{2}}.
$$

Thus $f \in C_c^{\frac{1}{2}}\left[\frac{1}{4}, \frac{1}{2}\right]$. This completes the proof of Proposition [4.1.](#page-12-0)

 \Box

5 Almost-everywhere convergence

In this section we consider the almost-everywhere convergence of $L_a f$ as $a \to a_0$.

The following result is a special case of [\[10,](#page-20-0) Theorem 1.3] and [\[11,](#page-20-1) Theorem 1.3]. Here we give a simplified proof for the specific operator L_a . (For related results in higher dimensions, we refer to [\[17\]](#page-20-7), [\[18\]](#page-20-8), [\[19](#page-20-9)], and references therein.)

Proposition 5.1. Suppose $b(a)$ is Lipschitz continuous near $a = a_0$. Then for all $f \in H^s(\mathbb{R})$ with $s \geqslant \frac{1}{4}$, we have

$$
\lim_{a \to a_0} L_a f(u) = L_{a_0} f(u), \quad a.e. \ u \in \mathbb{R}^1
$$

Before proving Proposition [5.1,](#page-14-2) we first recall that the almost-everywhere convergence of $L_a f$ is implied by boundedness of the corresponding maximal operators

$$
L_*^+ f(u) \triangleq \sup_{a \in (a_0, a_0 + \delta)} |L_a f(u)|
$$

and

$$
L_*^- f(u) \triangleq \sup_{a \in (a_0 - \delta, a_0)} |L_a f(u)|.
$$

For simplicity, we will only consider $L_* f \triangleq L_*^+$ \overline{f} .

Lemma 5.1. Let $E \subset \mathbb{R}$. Suppose

(1)
$$
\lim_{a \to a_0} b(a) = b(a_0);
$$

(2) $\exists C > 0$, such that $||L_* f||_{L^{1,\infty}(E)} \leq C ||f||_{H^s(\mathbb{R})}.$

¹For more quantitative results concerning the rate of convergence, see $[20]$.

Then for all $f \in H^s(\mathbb{R})$, we have

$$
\lim_{a \to a_0} L_a f(u) = L_{a_0} f(u), \quad a.e. \ u \in E.
$$

Proof. The proof follows from a standard density argument, cf. [\[21,](#page-20-11) §1.1].

 \Box

To bound the maximal function L_*f , we use the Kolmogorov-Seliverstov-Plessner method (cf. $[8]$).

Lemma 5.2. Let $E \subset \mathbb{R}$. Then

$$
\exists C>0,\ \|L_*f\|_{L^{1,\infty}(E)}\leqslant C\|f\|_{H^s(\mathbb{R})}\Leftrightarrow \exists \tilde{C}>0,\ \sup_{\{a(\cdot)\}}\|L_{\{a(\cdot)\}}f\|_{L^{1,\infty}(E)}\leqslant \tilde{C}\|f\|_{H^s(\mathbb{R})},
$$

where $a(u)$ is an arbitrary function whose value lies in $(a_0, a_0 + \delta)$.

As in [\[8\]](#page-19-7) we will need the following integral estimate.

Lemma 5.3. There exists a constant $C_0 > 0$ independent of $a, b \in \mathbb{R}$, such that for any $N > \max(\frac{1}{\sqrt{2}})$ $\frac{1}{|b|}, \frac{1}{|b|}),$ we have

$$
\left| \int_{-N}^{N} (1+\xi^2)^{-\frac{1}{4}} e^{i(a\xi^2+b\xi)} d\xi \right| \leq C_0 (|a|^2+|b|^2)^{-\frac{1}{4}}.
$$

Proof. By [\[22](#page-20-12), Ch. 8], when $b = 0$, $\exists C_1 > 0$, such that for $N > 0$, we have

$$
|\int_{-N}^{N} (1+\xi^2)^{-\frac{1}{4}} e^{ia\xi^2} d\xi| \leq C_1 |a|^{-\frac{1}{2}};
$$

when $b \neq 0, \exists C_2 > 0$, such that for $N > \max(\frac{1}{\sqrt{k}})$ $\frac{1}{|b|}, \frac{1}{|b|}$, we have

$$
|\int_{-N}^{N} (1+\xi^2)^{-\frac{1}{4}} e^{i(a\xi^2+b\xi)} d\xi| \leq C_2|b|^{-\frac{1}{2}}.
$$

Combining the above estimates, the desired bound follows.

We are now ready to prove Proposition 5.1 .

Proof of Proposition [5.1.](#page-14-2) By Lemma [5.1](#page-14-3) and Lemma [5.2,](#page-15-0) it suffices to show that there exists $p \geq 1$, such that for any bounded interval $[c, d] \subset \mathbb{R}$, $\exists C > 0$, such that

$$
\sup_{\{a(\cdot)\}} \|L_{a(\cdot)}f\|_{L^p[c,d]} \leqslant C \|f\|_{H^{\frac{1}{4}}(\mathbb{R})}.
$$
\n(25)

$$
\forall f \in C_0^{\infty}(\mathbb{R}), \text{ we have } ||L_{a(u)}f||_{L^p[c,d]} = \sup_{\substack{g \in C_0^{\infty}(\mathbb{R}) \\ ||g||_{L^{p'}[c,d]} \leqslant 1}} \langle L_{a(u)}f, g \rangle, \text{ where } \frac{1}{p} + \frac{1}{p'} = 1. \text{ By}
$$

Fubini's theorem,

$$
\langle L_{a(u)}f, g \rangle = \int_{c}^{d} \int_{\mathbb{R}} \hat{f}(\xi) e^{i(a(u)\xi^{2} + b(a(u))u\xi)} d\xi g(u) du
$$

\n
$$
= \lim_{N \to +\infty} \int_{-N}^{N} \left[(1 + \xi^{2})^{\frac{s}{2}} \hat{f}(\xi) \right] (1 + \xi^{2})^{-\frac{s}{2}} \left[\int_{c}^{d} e^{i(a(u)\xi^{2} + b(a(u))u\xi)} g(u) du \right] d\xi
$$

\n
$$
= \lim_{N \to +\infty} \int_{-N}^{N} (1 + \xi^{2})^{\frac{s}{2}} \hat{f}(\xi) \times
$$

\n
$$
\left[(1 + \xi^{2})^{-s} \int_{c}^{d} \int_{c}^{d} g(u_{1}) \overline{g(u_{2})} e^{i[(a(u_{1}) - a(u_{2}))\xi^{2} + (b(a(u_{1}))u_{1} - b(a(u_{2}))u_{2})\xi]} du_{1} du_{2} \right]^{\frac{1}{2}} d\xi
$$

\n
$$
\leq ||f||_{H^{\frac{1}{4}}(\mathbb{R})} \sup_{N} \left\| \left[(1 + (\cdot)^{2})^{-s} \int_{c}^{d} \int_{c}^{d} g(u_{1}) \overline{g(u_{2})} e^{i[(a_{1} - a_{2})(\cdot)^{2} + (b_{1}u_{1} - b_{2}u_{2})(\cdot)]} du_{1} du_{2} \right]^{\frac{1}{2}} \right\|_{L^{2}[-N,N]},
$$

where for simplicity, let $a_i \triangleq a(u_i)$, $b_i \triangleq b(a(u_i))$. By Fubini's theorem,

$$
\begin{aligned}\n&\left\|\left[(1+(\cdot)^2)^{-s}\int_c^d \int_c^d g(u_1)\overline{g(u_2)}e^{i[(a_1-a_2)(\cdot)^2+(b_1u_1-b_2u_2)(\cdot)]}\ du_1 du_2\right]^{\frac{1}{2}}\right\|_{L^2[-N,N]}^2 \\
&= \int_c^d \int_c^d g(u_1)\overline{g(u_2)}\int_{-N}^N (1+\xi^2)^{-s}e^{i[(a_1-a_2)\xi^2+(b_1u_1-b_2u_2)\xi]}\ d\xi du_1 du_2\n\end{aligned}
$$

Now estimate $K(u_1, u_2) \triangleq \int_{-N}^{N} (1 + \xi^2)^{-s} e^{i[(a_1 - a_2)\xi^2 + (b_1u_1 - b_2u_2)\xi]} d\xi$. Divide $[c, d]^2$ into several parts:

I When $(u_1, u_2) \in \{ [c, d]^2 : a_1 = a_2, b_1 u_1 \neq b_2 u_2 \}$, by Lemma [5.3,](#page-15-1) $|K(u_1, u_2)| \leq$ $C_0|b_1u_1 - b_2u_2|^{-\frac{1}{2}}$. Since $a_1 = a_2 \Rightarrow b_1 = b_2$,

$$
|b_1u_1 - b_2u_2|^{-\frac{1}{2}} = |b_1|^{-\frac{1}{2}}|u_1 - u_2|^{-\frac{1}{2}} \leq C|u_1 - u_2|^{-\frac{1}{2}}.
$$

II When $(u_1, u_2) \in \{ [c, d]^2 : a_1 \neq a_2, b_1u_1 = b_2u_2 \}$, by Lemma [5.3,](#page-15-1) $|K(u_1, u_2)| \leq$ $C_0|a_1 - a_2|^{-\frac{1}{2}}$. Since *b* is Lipschitz continuous,

$$
|a_1 - a_2| \geq C|b_1 - b_2| = C\left|\frac{b_1}{u_2}u_2 - \frac{b_2}{u_1}u_1\right| = C\left|\frac{b_1}{u_2}(u_1 - u_2)\right| \geq C|u_1 - u_2|.
$$

III When $(u_1, u_2) \in \{[c, d]^2 : a_1 \neq a_2, b_1u_1 \neq b_2u_2\}$, for simplicity, let $b_1u_1 \triangleq \frac{1}{\epsilon_1}$, $b_2u_2 \triangleq \frac{1}{\epsilon_2}$. Since $|a_1 - a_2| \ge C|b_1 - b_2| = C|\frac{1}{\epsilon_1u_1} - \frac{1}{\epsilon_2u_2}|$, by Lemma [5.3,](#page-15-1) we get

$$
|K(u_1, u_2)| \leq C_0 \left(\left| \frac{1}{\epsilon_1} - \frac{1}{\epsilon_2} \right| + \left| \frac{1}{\epsilon_1 u_1} - \frac{1}{\epsilon_2 u_2} \right| \right)^{-\frac{1}{2}}.
$$

Since $\left(|\frac{1}{\epsilon_1}-\frac{1}{\epsilon_2}|+|\frac{1}{\epsilon_1u_1}-\frac{1}{\epsilon_2u_2}|\right)^2 \leqslant C_0\epsilon^2\left[u_1^2u_2^2(\frac{\epsilon_2}{\epsilon_1}-1)^2+(\frac{\epsilon_2u_2}{\epsilon_1}-u_1)^2\right]$, now consider $u_1^2 u_2^2 \left(\frac{\epsilon_2}{\epsilon_1} - 1\right)^2 + \left(\frac{\epsilon_2 u_2}{\epsilon_1} - u_1\right)^2$ as a function w.r.t. $\frac{\epsilon_2}{\epsilon_1}$, and we have

$$
\left(|\frac{1}{\epsilon_1} - \frac{1}{\epsilon_2}| + |\frac{1}{\epsilon_1 u_1} - \frac{1}{\epsilon_2 u_2}|\right)^2 \geq C_0(\epsilon_1 u_1)^2 (u_1 - u_2)^2 \geq C_0(u_1 - u_2)^2.
$$

IV When $(u_1, u_2) \in \{ [c, d]^2 : a_1 = a_2, b_1u_1 = b_2u_2 \}$, by **III**, we know that

$$
(|a_1 - a_2| + |b_1u_1 - b_2u_2|)^2 \geq C_0(u_1 - u_2)^2
$$

.

So $\{[c, d]^2 : a_1 = a_2, b_1u_1 = b_2u_2\} \subset \{[c, d]^2 : u_1 = u_2\}$ be a zero measure. Without loss of generality, we can suppose that $a_1 = a_2$ and $b_1u_1 = b_2u_2$ do not hold at the same time.

To sum up, we have $\exists N_0 > 0, \forall N > N_0$,

$$
\left| \int_{c}^{d} \int_{c}^{d} g(u_{1}) \overline{g(u_{2})} K(u_{1}, u_{2}) du_{1} du_{2} \right|
$$

\n
$$
\leq C \int_{c}^{d} \int_{c}^{d} |g(u_{1})g(u_{2})| |u_{1} - u_{2}|^{-\frac{1}{2}} du_{1} du_{2}
$$

\n
$$
\leq C \langle H * |g|, |g| \rangle \qquad (H(u_{1}) \triangleq |u_{1}|^{-\frac{1}{2}})
$$

\n
$$
\leq C ||H * |g| ||_{L^{p}[c,d]} ||g||_{L^{p'}[c,d]}
$$

\n
$$
\leq C ||H ||_{L^{\frac{p}{2},\infty}[c,d]} ||g||_{L^{p'}[c,d]}^{2}
$$

\n
$$
\leq C ||H ||_{L^{\frac{p}{2},\infty}[c,d]}, \text{ where } C \text{ is independent of } N.
$$

In the second last line, we have used Young's inequality on weak type spaces (cf. [\[23,](#page-20-13) Ch. 1]). Now all we need is $||H||_{L^{\frac{p}{2}}_{\infty} < \infty}$, that is, $p \leq 4$. It follows that [\(25\)](#page-15-2) holds for $p \leq 4$. This completes the proof of Proposition [5.1.](#page-14-2)

Remark 5.1. The condition $p \leq 4$ is optimal for [\(25\)](#page-15-2) to hold. This follows from the sharpness of the Sobolev inequality:

$$
||f||_{L^p[c,d]} = c||L_0f||_{L^p[c,d]} \leq c||L_*f||_{L^p[c,d]} \leq C||f||_{H^{\frac{1}{4}}(\mathbb{R})}, \quad p \leq 4.
$$

Now we show that the almost-everywhere convergence in Proposition [5.1](#page-14-2) does not always hold if $s < \frac{1}{4}$. As in [\[9,](#page-19-8) p. 208], the proof reduces to the following proposition.

Proposition 5.2. Suppose $b(a)$ is continuous on $[a_0, a_0 + \delta]$. If there exists a set E of positive measure such that

$$
||L_*f||_{L^{1,\infty}(E)} \leqslant C||f||_{H^s(\mathbb{R})},
$$

then $s \geqslant \frac{1}{4}$.

Proof. For any $N > 10$, take $\Phi \in C_0^{\infty}(\mathbb{R})$, $\Phi_N \triangleq N\Phi(Nx)$ such that $|L_{a_0}\Phi_N(x)| > \frac{N}{2}$
on $[-\frac{1}{N}, \frac{1}{N}]$. By Theorem [3.1,](#page-7-2) we have $\lim_{a \to a_0} |L_a \Phi_N(u)| = |L_{a_0} \Phi_N(u)|$ uniformly w.r.t. $u \in [-\frac{1}{N}, \frac{1}{N}], \ i.e. \ \exists \epsilon_0 < \frac{1}{50}, \ \exists \delta > 0, \ \forall a \in U(a_0, \delta), \ \forall u \in [-\frac{1}{N}, \frac{1}{N}], \ |L_a \Phi_N(u)| >$ $|L_{a_0}\Phi_N(u)|-\epsilon_0>\frac{N}{4}$. Since by calculation,

$$
L_a(e^{i\frac{a-a_0}{a}Ny}\Phi_N(y))(u)=e^{i\left(\frac{[(a-a_0)N]^2}{a}+\frac{b(a)u(a-a_0)}{a}N\right)}L_a\Phi_N(u+\frac{2(a-a_0)N}{b(a)}).
$$

Then $\forall u \in E, \ \exists a = a(u) \in U(a_0, \delta), \ s.t. \ u = \frac{2(a-a_0)N}{b(a)},$

$$
|L_a(e^{-i\frac{a-a_0}{a}Ny}\Phi_N(y))(u)| > |L_{a_0}\Phi_N(u-\frac{2(a-a_0)N}{b(a)})|-\epsilon_0 > \frac{N}{4}.
$$

This is because the range of $\frac{2(a-a_0)}{b(a)}N$ can be denoted by $[C_1N, C_2N]$ $(C_1 < C_2)$ by continuity of b, and we can choose N at the beginning such that $E \subset [C_1N, C_2N]$. Now we have $||L_*(e^{-i\frac{a-a_0}{a}Ny}\Phi_N(y))||_{L^{1,\infty}(E)} \geqslant \frac{N}{4}$. Since $||e^{-i\frac{a-a_0}{a}N(\cdot)}\Phi_N(\cdot)||_{H^s(\mathbb{R})} \leqslant$ $C_0 N^{2s+\frac{1}{2}}$, we get

$$
\frac{N}{4} \leqslant ||L_*(e^{-i\frac{a-a_0}{a}Ny}\Phi_N(y))||_{L^{1,\infty}(E)} \leqslant C||e^{-i\frac{a-a_0}{a}N(\cdot)}\Phi_N(\cdot)||_{H^s(\mathbb{R})} \leqslant CN^{2s+\frac{1}{2}}.
$$

So $1 \leq 2s + \frac{1}{2} \Rightarrow s \geq \frac{1}{4}$. This completes the proof of Proposition [5.2.](#page-17-0)

$$
\square
$$

6 Global boundedness

In this section we consider global boundedness of the maximal function $L_* f$.

Proposition 6.1. Suppose the range of $b(a)$, $a \in (a_0, a_0 + \delta)$ is a set of positive measure. Then

$$
\sup_{\substack{f\in H^s(\mathbb{R})\\f\neq 0}}\frac{\|L_*f\|_{L^p(\mathbb{R})}}{\|f\|_{H^s(\mathbb{R})}}=+\infty
$$

for any $s > 0$ and $p < \infty$.

Proof. The proof is an adaptation of that of [\[12](#page-20-2), Theorem 3]. By Lemma [5.2,](#page-15-0) it suffices to show that $\forall L > 0, \exists f_0 \in H^s(\mathbb{R}), \ \exists a(u), \ \|L_{\alpha(\cdot)}f_0\|_{L^2(\mathbb{R})} > L \|f_0\|_{H^s(\mathbb{R})}.$ Without loss of generality, suppose $a_0 + \delta \neq 0$. Take $\hat{f}_0(\xi) = e^{iN\xi} \chi_{U(0, \frac{1}{\sqrt{a_0 + \delta}})}(\xi)$. $\forall u \in F \triangleq \{-\frac{N}{x} : \forall x \in E\}, \exists \tilde{a}(u) \in (a_0, a_0 + \delta), s.t. \; b(\tilde{a}(u))u + N = 0.$

$$
|L_{\tilde{a}(u)}f_0(u)| = |\int_{-\frac{1}{\sqrt{a_0+\delta}}}^{\frac{1}{\sqrt{a_0+\delta}}} e^{i\tilde{a}(u)\xi^2} d\xi|
$$

>
$$
|\frac{2}{\sqrt{\tilde{a}(u)}} \int_0^{\sqrt{\frac{\tilde{a}(u)}{a_0+\delta}}} \cos \eta^2 d\eta|
$$

19

Since $0 < |E| < \infty$, there exists $C_0 > 0$, s.t. $|F| = C_0N|E| = C_0N$, then

$$
\|L_{\tilde{a}(\cdot)}f_0\|_{L^p(\mathbb R)}\geqslant (\int_F |2\cos 1|^p du)^{\frac{1}{p}}\geqslant C_0N^{\frac{1}{p}}.
$$

If N is chosen large enough, then $\sup_{\epsilon(\cdot)} \|L_{a(\cdot)} f_0\|_{L^2(\mathbb{R})} > L \|f_0\|_{H^s(\mathbb{R})}$, as desired. This ${a(\cdot)}$ completes the proof of Proposition [6.1.](#page-18-1) \Box
