Stability and eigenvalue bounds for micropolar shear flows

Abstract

We prove eigenvalue bounds for two-dimensional linearized disturbances of parallel flows of micropolar fluids, deriving the Orr-Sommerfeld equations and providing a sufficient condition for linear stability of such flows. We also derive wave speed bounds.

1 Introduction

In this short note, we study two dimensional perturbations of parallel flows of micropolar, also known as asymmetric, fluids. To this end, we first derive the Orr-Sommerfeld equations for this kind of fluids and, through a variational method, prove some bounds for their eigenvalues. We obtain bounds for the imaginary part of the eigenvalue ensuring stabilty in some regions of the parameters. We also prove some wave speed bounds for perturbations of the base flow.

The problem of stability for shear flows of incompressible fluids governed by the Navier-Stokes equations is a classical one. For these equations, Synge [\[6\]](#page-9-0) has stablished eigenvalue bounds assuring linear stability in some region of the parameters αR , where R is the Reynolds number and α is the wave number of the perturbations. Later on, Joseph [\[1\]](#page-8-0) obtained a larger region of stability with respect to αR . For the special case of Classical Couette flow, Romanov [\[5\]](#page-9-1) proved its linear stability for all Reynolds numbers.

Here, we are interested in shear flows of micropolar incompressible fluids. Physically, they are fluids consisting of rigid, random oriented (or spherical) particles suspended in a viscous medium, where the deformation of the particles is ignored (for more details see, for example, [\[3\]](#page-8-1)). Our results here are the generalization to micropolar fluids of the results by Joseph [\[1\]](#page-8-0) for the classical Navier-Stokes case. For dipolar fluids, similar results have been obtained by Puri [\[4\]](#page-9-2).

This work is organized as follows: first, in section 2, following Liu [\[2\]](#page-8-2), we write the equations for perturbations of parallel flows and derive the Orr-Sommerfeld equations for micropolar fluids. In section 3, we obtain eigenvalue estimates for such equations. The bounds for the imaginary part of the eigenvalues lead to a region of linear stability.

2 Linear disturbance equations

The incompressible micropolar fluids equations are

\mathbf{u}_t + (\mathbf{u} \cdot \nabla)\mathbf{u} + \nabla p = (\mu + \mu_r)\Delta \mathbf{u} + 2\mu_r \operatorname{curl} \mathbf{w},\tag{1}
$$

where **u** is the linear velocity, **w** the angular velocity of particles and p is the pressure. We are interested in two dimensional perturbations of two dimensional steady parallel flows; so, we look for solutions \mathbf{u}' , \mathbf{v}' , p' of system [\(1\)](#page-1-0)-[\(3\)](#page-1-0) of the form

where the base flow is $U = (U(y), 0, 0)$, $W = (0, 0, W(y))$ and the perturbations are

 $(x, y) \in \mathbb{R} \times [0, 1]$. Componentwise, considering only the first order terms, the equations for the perturbations are

with boundary conditions $u = v = w = 0$ at $y = 0, 1$. Equations [\(4\)](#page-1-1)-[\(7\)](#page-1-1) are the linear disturbance field equations for parallel flow of micropolar fluids. In dimensionless form (see [\[2\]](#page-8-2)), these equations read

where $R_0, R_k, R_\mu, R_\nu, R_\gamma$ are dimensionless numbers. Now, consider the dimensionless stream function ψ such that

where α is the real wave number and C denotes the mode of disturbances (an equivalent approach is to take the Laplace-Fourier transform of the equations). In order to eliminate p from equations [\(8\)](#page-1-2) and [\(9\)](#page-1-2), just differentiate [\(8\)](#page-1-2) with respect to y, differentiate [\(9\)](#page-1-2) with respect to x, subtract one from another and use the incompressibilty condition [\(11\)](#page-1-2) to obtain

where $D = \frac{d}{dy}$. Similarly, equation [\(10\)](#page-1-2) becomes

and, therefore, using identities [\(13\)](#page-1-3), one obtains

The boundary conditions for φ and ω are

Having in mind the classical case, we call equations [\(14\)](#page-2-0) and [\(15\)](#page-2-1) the Orr-Sommerfeld equations for micropolar fluids.

3 Eigenvalue bounds

We are now in position to derive bounds for the eigenvalues

$$
C = C_r + iC_i
$$

of the Orr-Sommerfeld problem for micropolar fluids [\(14\)](#page-2-0), [\(15\)](#page-2-1), [\(16\)](#page-2-2). For four times continuously differentiable functions defined on the interval $y \in [0, 1]$, we denote $\langle f, g \rangle = \int_0^1 f(y) \overline{g(y)} dy$, $||f||^2 =$ $\langle f, f \rangle$ and \overline{H} the complex valued Hilbert space of four times differentiable functions φ completed under the norm $\|\varphi''\|$ by adding limits of sequences satisfying $\varphi(0) = \varphi(1) = \varphi'(0) = \varphi'(1) = 0$. Our first result is the following.

Lemma 1 *The real and imaginary parts of* $C = C_r + iC_i$ *satisfy*

where

Q = \frac{i}{2} \int_0^1 (U' \varphi \overline{\varphi'} - W' \varphi \overline{\omega}) dy.

Proof. Multipliying equations [\(14\)](#page-2-0) and [\(15\)](#page-2-1) by $\overline{\varphi}$ and $\overline{\omega}$, respectively, and integrating over [0, 1], one has

and

C||\omega||^2 + \frac{i}{\alpha R_{\gamma}}(||\omega'||^2 + \alpha^2 ||\omega||^2) + \frac{2iR_0}{\alpha R_{\gamma}}||\omega||^2 = \int_0^1 U|\omega|^2 dy - \int_0^1 W'\varphi\overline{\omega} dy - \frac{i}{\alpha R_{\gamma}}(\langle\varphi'',\omega\rangle - \alpha^2\langle\varphi,\omega\rangle).

Adding up these equations and taking the imaginary and real part of the resulting equation, one directly gets the desired indentities [\(17\)](#page-2-3) and [\(18\)](#page-3-0).

From equation [\(17\)](#page-2-3), one has

\leq Q + \overline{Q} + \left(\frac{R_0}{2R_k} + \frac{1}{2R_\gamma}\right) (||\varphi''||^2 + \alpha^4 ||\varphi||^2 + 2||\omega||^2).
$$

Therefore, if $\frac{1}{R_{\mu}} + \frac{1}{2R_{k}} > \frac{R_{0}}{2R_{1}}$ $\frac{R_0}{2R_k}$ + $\frac{1}{2R_v}$ and $\frac{2R_0}{R_v}$ > $\frac{R_0}{R_k}$ + $\frac{1}{R_v}$ (which is assured, for example, by requiring $R_1 := \min\{\frac{1}{R_\mu}, \frac{1}{2R_k}, \frac{R_0}{R_\nu}\} > R_2 := \max\{\frac{R_0}{2R_k}\}$ $\frac{R_0}{2R_k}, \frac{1}{2R_{\nu}}\}$, one has

$$

+ $\frac{1}{R_\gamma} ||\omega'||^2 + \left(\frac{\alpha^2}{R_\gamma} + R_1 - R_2\right) ||\omega||^2 \le Q + \overline{Q}.$

Simplifying the notation by taking $\frac{1}{R} := \min\{R_1 - R_2, \frac{1}{R_\mu} + \frac{1}{2R_k}, \frac{1}{R_\gamma}\}\)$, we have

\alpha C_i(||\varphi'||^2 + \alpha^2 ||\varphi||^2 + ||\omega||^2) + \frac{1}{R} (||\varphi''||^2 + 2\alpha^2 ||\varphi'||^2 + \alpha^4 ||\varphi||^2 + ||\omega'||^2 + \alpha^2 ||\omega||^2 + ||\omega||^2) \le Q + \overline{Q},
$$

from which follows the estimate

C_i \le \frac{q_1 \|\varphi'\| \|\varphi\| + q_2 \|\varphi\| \|\omega\| - (\alpha R)^{-1} (\|\varphi''\|^2 + 2\alpha^2 \|\varphi'\|^2 + \alpha^4 \|\varphi\|^2 + \|\omega'\|^2 + \alpha^2 \|\omega\|^2 + \|\omega\|^2)}{\|\varphi'\|^2 + \alpha^2 \|\varphi\|^2 + \|\omega\|^2},\tag{19}

where

Theorem 2 Let $R_1 = \min \left\{ \frac{1}{R_\mu}, \frac{1}{2R_k}, \frac{R_0}{R_\nu} \right\}$ and $R_2 = \max \left\{ \frac{R_0}{2R_k} \right\}$ $\frac{R_0}{2R_k}, \frac{1}{2R_{\nu}}\Big\}$. If $R_1 > R_2$, then

where $\frac{1}{R}$ = min $\left\{R_1 - R_2, \frac{1}{R_\mu} + \frac{1}{2R_k}, \frac{1}{R_\gamma}\right\}$. Moreover, no amplified disturbances (C_i > 0) of [\(14\)](#page-2-0), [\(15\)](#page-2-1) *and* [\(16\)](#page-2-2) *exist if*

Proof. In the real-valued Hilbert space H corresponding to \overline{H} , the following inequalities hold:

Using bounds [\(27\)](#page-4-0), [\(28\)](#page-4-1), [\(29\)](#page-4-2) directly in inequality [\(19\)](#page-3-1), one obtains

C_i \le \frac{q_1 + q_2}{2\alpha} - \frac{\pi^2 + \alpha^2}{\alpha R}.
$$

To finish the proof, note that the left hand side of [\(19\)](#page-3-1) is non positive if

and this surely holds if $\alpha R q_1 \leq \frac{\Gamma_1}{2}$ and $\alpha R q_2 \leq \frac{\Gamma_2}{2}$, where

Now, just note that

\Gamma_1 \geq \frac{\|\varphi''\|^2 + 2\alpha^2 \|\varphi'\|^2}{\|\varphi'\|\|\varphi\|} \geq (4, 73)^2 \pi + 2\alpha^2 \pi = M_1,

\Gamma_1 \ge \frac{\|\varphi''\|^2 + 2\alpha^2 \|\varphi'\|^2 + \alpha^4 \|\varphi\|^2}{\|\varphi'\|\|\varphi\|} \ge (4, 73)^2 \pi \frac{2\alpha^2}{\|\varphi\|\|\varphi'\|} \left(\|\varphi'\|^2 + \frac{\alpha^2}{2} \|\varphi\|^2\right)
$$

\n
$$
\ge (4.73)^2 \pi + \frac{2\alpha^2}{\|\varphi\|\|\varphi'\|} \left(\frac{2\alpha \|\varphi\|\|\varphi'\|}{\sqrt{2}}\right) \ge (4, 73)^2 \pi + 2^{\frac{3}{2}} \alpha^3 = M_2,

which proves the result.

Now, we derive estimates for the wave speed C_r . The result is as follows.

Theorem 3 Let $C(\alpha, R) = C_r + iC_i$ be any eigenvalue of [\(14\)](#page-2-0), [\(15\)](#page-2-1) and [\(16\)](#page-2-2). Denote by U_{max} , U'_{min} , U''_{max} , U''_{min} , W'_{max} and W'_{min} the maximum and minimum values on the range of $U(y)$, $U''(y)$ and $W'(y)$ for $y \in [0, 1]$. The *following holds:*

(a) If $U''_{min} \ge 0$ and $W'_{min} \ge 0$, then

U_{min}-\frac{W'_{max}}{2\alpha}\leq C_r\leq U_{max}+\frac{U''_{max}}{2(\pi^2+\alpha^2)}+\frac{W'_{max}}{2\alpha}.
$$

(b) If $U''_{min} \ge 0$ and $W'_{min} \le 0 \le W'_{max}$, then

U_{min}-\frac{W'_{max}}{\alpha}+\frac{W'_{min}}{2\alpha}\leq C_{r}\leq U_{max}+\frac{U''_{max}}{2(\pi^{2}+\alpha^{2})}-\frac{W'_{min}}{\alpha}+\frac{W'_{max}}{2\alpha}.
$$

(c) If $U''_{min} \ge 0$ and $W'_{max} \le 0$, then

(d) If $U_{\min}^{\prime\prime} \leq 0 \leq U_{\max}^{\prime\prime}$ and $W_{\min}^{\prime} \geq 0$, then

U_{min} + \frac{U_{min}^{\prime\prime}}{2\alpha^2} - \frac{W_{max}^{\prime}}{2\alpha} \leq C_r \leq U_{max} + \frac{U_{max}^{\prime\prime}}{2(\pi^2 + \alpha^2)} + \frac{W_{max}^{\prime}}{2\alpha}.
$$

(e) If $U''_{min} \leq 0 \leq U''_{max}$ and $W'_{min} \leq 0 \leq W'_{max}$, then

$$
U_{min}+\frac{U_{min}^{\prime\prime}}{2\alpha^2}-\frac{W_{max}^{\prime}}{\alpha}+\frac{W_{min}^{\prime}}{2\alpha}\leq C_{r}\leq U_{max}+\frac{U_{max}^{\prime\prime}}{2(\pi^2+\alpha^2)}-\frac{W_{min}^{\prime}}{\alpha}+\frac{W_{max}^{\prime}}{2\alpha}.
$$

(f) If $U''_{min} \leq 0 \leq U''_{max}$ and $W'_{max} \leq 0$, then

$$
U_{min}+\frac{U_{min}^{\prime\prime}}{2\alpha^2}+\frac{W_{min}^{\prime}}{2\alpha}\leq C_{r}\leq U_{max}+\frac{U_{max}^{\prime\prime}}{2\alpha^2}-\frac{W_{min}^{\prime}}{2\alpha}.
$$

(g) If $U''_{max} \leq 0$ and $W'_{min} \geq 0$, then

$$
U_{min} + \frac{U_{min}^{\prime\prime}}{2\alpha^2} - \frac{W_{max}^{\prime}}{2\alpha} \leq C_r \leq U_{max} + \frac{W_{max}^{\prime}}{2\alpha}.
$$

(h) If $U''_{max} \le 0$ and $W'_{min} \le 0 \le W'_{max}$, then

$$
U_{min} + \frac{U_{min}''}{2\alpha^2} - \frac{W_{max}'}{\alpha} + \frac{W_{min}'}{2\alpha} \le C_r \le U_{max} - \frac{W_{min}'}{\alpha} + \frac{W_{max}'}{2\alpha}.
$$

(*i*) If $U''_{max} \leq 0$ and $W'_{max} \leq 0$, then

$$
U_{min} + \frac{U_{min}''}{2\alpha^2} + \frac{W_{min}'}{2\alpha} \leq C_r \leq U_{max} - \frac{W_{min}'}{2\alpha}.
$$

Proof. First of all, note that it follows directly from identity [\(18\)](#page-3-0) that

$$
C_r = U(y_1) + \frac{\frac{1}{2}U''(y_2)}{||\varphi||^2 + \alpha^2 + \frac{||\omega||^2}{||\varphi||^2}} - \frac{\frac{1}{2}W'(y_3)[\langle \varphi, \omega \rangle + \langle \omega, \varphi \rangle]}{||\varphi'||^2 + \alpha^2 ||\varphi||^2 + ||\omega||^2}
$$

where y_1, y_2 and $y_3 \in (0, 1)$ are mean values. We use this identity and the Poincaré inequality

||\varphi'||^2 \ge \pi^2 ||\varphi||^2
$$

to prove separately each item of the theorem.

\leq U_{max} + \frac{\frac{1}{2}U''_{max}}{\pi^2 + \alpha^2} + \frac{\frac{1}{2\alpha}W'(y_3)[\alpha^2||\varphi||^2 + ||\omega||^2]}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2}
$$

\n
$$
\leq U_{max} + \frac{\frac{1}{2}U''_{max}}{\pi^2 + \alpha^2} + \frac{W'_{max}}{2\alpha},
$$

using the Poincaré inequality [\(30\)](#page-7-0) and that $W'(y_3) \geq W'_{min} \geq 0$. On other hand,

$$
C_r = U(y_1) + \frac{\frac{1}{2}U''(y_2)}{\frac{||\varphi'||^2}{||\varphi||^2} + \alpha^2 + \frac{||\omega||^2}{||\varphi||^2}} - \frac{\frac{1}{2}W'(y_3)[\langle\varphi, \omega\rangle + \langle\omega, \varphi\rangle]}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2}
$$

\n
$$
\geq U_{min} + \frac{\frac{1}{2}U''_{min}}{\frac{||\varphi'||^2}{||\varphi||^2} + \alpha^2 + \frac{||\omega||^2}{||\varphi||^2}} - \frac{\frac{1}{2}W'(y_3)(\frac{1}{\alpha}\alpha)2||\varphi|| ||\omega||}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2}
$$

\geq U_{min} - \frac{\frac{1}{2\alpha}W'(y_3)(\alpha^2||\varphi||^2 + ||\omega||^2)}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2} \geq U_{min} - \frac{W'(y_3)}{2\alpha} \geq U_{min} - \frac{W'_{max}}{2\alpha}
$$

using Cauchy's inequality, Young's inequality and the hypothesis $U''_{min} \ge 0$.

(b) Case $U''_{min} \ge 0$ and $W'_{min} \le 0 \le W'_{max}$.

C_r = U(y_1) + \frac{\frac{1}{2}U''(y_2)}{\frac{||\varphi'||^2}{||\varphi||^2} + \alpha^2 + \frac{||\omega||^2}{||\varphi||^2}} - \frac{\frac{1}{2}W'(y_3)[\langle\varphi, \omega\rangle + \langle\omega, \varphi\rangle]}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2}
$$

\n
$$
\leq U_{max} + \frac{\frac{1}{2}U'_{max}}{\frac{||\varphi'||^2}{||\varphi||^2} + \alpha^2} - \frac{\frac{1}{2\alpha}W'(y_3)||\alpha\varphi + \omega||^2}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2} + \frac{\frac{1}{2\alpha}W'(y_3)(\alpha^2||\varphi||^2 + ||\omega||^2)}{||\varphi'||^2 + \alpha^2||\varphi||^2 + ||\omega||^2}

using [\(30\)](#page-7-0), the hypothesis $W'_{min} \le 0 \le W'_{max}$ and the parallelogram law. On other hand,

C_{r} = U(y_{1}) + \frac{\frac{1}{2}U''(y_{2})}{||\varphi'||^{2} + \alpha^{2} + ||\omega||^{2}} - \frac{\frac{1}{2}W'(y_{3})[\langle\varphi,\omega\rangle + \langle\omega,\varphi\rangle]}{||\varphi'||^{2} + |\omega||^{2}}

The proof of the remaining items follow through completely analogous arguments to one of the items proved above.
