Fujita type results for a parabolic inequality with a non-linear convolution term on the Heisenberg group

Abstract

The purpose of this paper is to investigate the non-existence of global weak solutions of the following degenerate inequality on the Heisenberg group

> $\sqrt{ }$ $\frac{1}{2}$ \mathcal{L} $u_t - \Delta_{\mathbb{H}} u \geq (\mathcal{K} *_{\mathbb{H}} |u|^p)|u|^q, \qquad \eta \in \mathbb{H}^n, \ \ t > 0,$ $u(\eta, 0) = u_0(\eta),$ $\eta \in \mathbb{H}^n,$

where $n \geq 1$, $p, q > 0$, $u_0 \in L^1_{loc}(\mathbb{H}^n)$, $\Delta_{\mathbb{H}}$ is the Heisenberg Laplacian, and $\mathcal{K} : (0, \infty) \to (0, \infty)$ is a continuous function satisfying $\mathcal{K}(|\cdot|_{\mathbb{H}}) \in L^1_{loc}(\mathbb{H}^n)$ which decreases in a vicinity of infinity. In addition, $*_{\mathbb{H}}$ denotes the convolution operation in \mathbb{H}^n . Our approach is based on the non-linear capacity method.

1 Introduction

In this paper, we are interested in the non-existence of global weak solutions of the following parabolic inequality on the Heisenberg group

$$
\begin{cases} u_t - \Delta_{\mathbb{H}} u \ge (\mathcal{K} *_{\mathbb{H}} |u|^p)|u|^q, & \eta \in \mathbb{H}^n, \ t > 0, \\ u(\eta, 0) = u_0(\eta), & \eta \in \mathbb{H}^n, \end{cases}
$$
(1.1)

where $n \geq 1$, $p, q > 0$, $u_0 \in L^1_{loc}(\mathbb{H}^n)$, and $\Delta_{\mathbb{H}}$ is the Heisenberg Laplacian. The function K: $(0, \infty) \to (0, \infty)$ is continuous, it satisfies $\mathcal{K}(|\eta|_{\mathbb{H}}) \in L^1_{loc}(\mathbb{H}^n)$ and there exists $R_0 > 1$ such that $\inf_{r\in(0,R)} \mathcal{K}(r) = \mathcal{K}(R)$ for all $R > R_0$. The non-linear convolution term $\mathcal{K} *_{\mathbb{H}} |u|^p$ is the Heisenberg convolution between K and $|u|^p$ defined by

(\mathcal{K} *_{\mathbb{H}} |u|^p)(\eta) = \int_{\mathbb{H}^n} \mathcal{K}(d_{\mathbb{H}}(\eta,\xi)) |u(\xi)|^p d\xi = \int_{\mathbb{H}^n} \mathcal{K}(|\xi|_{\mathbb{H}}) |u(\eta \circ \xi^{-1})|^p d\xi,
$$

where $d_{\mathbb{H}}$ and $|\cdot|_{\mathbb{H}}$ are, respectively, the Korányi distance and Korányi norm defined below.

Remark 1.1. Typical examples of K are the constant functions as well as

$$
\mathcal{K}(r) = r^{-\alpha}, \quad \alpha \in (0, Q),
$$

where $Q = 2n + 2$ is the homogeneous dimension of \mathbb{H}^n .

The Heisenberg group is the Lie group $\mathbb{H}^n = \mathbb{R}^{2n+1}$ equipped with the following law

 $\eta \circ \eta' = (x + x', y + y', \tau + \tau' + 2(x \cdot y' - x' \cdot y)),$

where $\eta = (x, y, \tau)$, $\eta' = (x', y', \tau')$, and is the scalar product in \mathbb{R}^n . Let us denote the parabolic dilation in \mathbb{R}^{2n+1} by δ_{λ} , namely, $\delta_{\lambda}(\eta) = (\lambda x, \lambda y, \lambda^2 \tau)$ for any $\lambda > 0$, $\eta = (x, y, \tau) \in \mathbb{H}^n$. The Jacobian determinant of δ_{λ} is λ^{Q} , where $Q = 2n + 2$ is the homogeneous dimension of \mathbb{H}^{n} .

The homogeneous Heisenberg norm (also called Korányi norm) is derived from an anisotropic dilation on the Heisenberg group and is defined by

|\eta|_{\mathbb{H}} = \left(\left(\sum_{i=1}^{n} (x_i^2 + y_i^2) \right)^2 + \tau^2 \right)^{\frac{1}{4}} = \left((|x|^2 + |y|^2)^2 + \tau^2 \right)^{\frac{1}{4}},
$$

where $|\cdot|$ is the Euclidean norm associated to \mathbb{R}^n ; the associated Korányi distance between two points η and ξ of H is defined by

$$
d_{\mathbb{H}}(\eta,\xi)=|\xi^{-1}\circ\eta|_{\mathbb{H}},\quad \eta,\xi\in\mathbb{H},
$$

where ξ^{-1} denotes the inverse of ξ with respect to the group action, i.e. $\xi^{-1} = -\xi$. The left-invariant vector fields that span the Lie algebra are given by

X_i = \partial_{x_i} - 2y_i \partial_{\tau}, \qquad Y_i = \partial_{y_i} + 2x_i \partial_{\tau}.
$$

The Heisenberg gradient is given by

$$
\nabla_{\mathbb{H}} = (X_1, \dots, X_n, Y_1, \dots, Y_n), \tag{1.2}
$$

and the sub-Laplacian (also called Kohn Laplacian) is defined by

$$
\Delta_{\mathbb{H}} = \sum_{i=1}^{n} (X_i^2 + Y_i^2) = \Delta_x + \Delta_y + 4(|x|^2 + |y|^2)\partial_{\tau}^2 + 4\sum_{i=1}^{n} (x_i \partial_{y_i \tau}^2 - y_i \partial_{x_i \tau}^2), \tag{1.3}
$$

where $\Delta_x = \nabla_x \cdot \nabla_x$ and $\Delta_y = \nabla_y \cdot \nabla_y$ stand for the Laplace operators on \mathbb{R}^n .

1.1 Historical background

1.1.1 Results on \mathbb{R}^n

Let us start by the pioneering paper of Fujita [\[10\]](#page-13-0) where the following semi-linear heat equation

\begin{cases}\n u_t - \Delta u = |u|^p & x \in \mathbb{R}^n, \ t > 0, \\
 u(x, 0) = u_0(x) & x \in \mathbb{R}^n,\n\end{cases}
$$
\n(1.4)

has been investigated. The exponent $p_F = 1 + 2/n$ is known as the critical Fujita exponent of [\(1.4\)](#page-1-0). Namely, for $p < p_F$, Fujita [\[10\]](#page-13-0) proved the non-existence of non-negative global-in-time solution for any non-trivial initial condition, and for $p > p_F$, global solutions do exist for any sufficiently small non-negative initial data. The proof of blowing-up non-negative solutions in the critical case $p = p_F$ was completed in [\[15,](#page-14-0) [18,](#page-14-1) [22\]](#page-14-2).

The study of convolution terms in the non-linearity of evolution equations has been used to model various quantities in gravity and quantum physics. For instance, the equation

i\psi_t - \Delta \psi = (|x|^{\alpha - n} * \psi^2)\psi, \qquad x \in \mathbb{R}^n, \ t > 0,
$$
\n

 $\alpha \in (0, n)$, $n \geq 1$, was introduced by D.H. Hartee [\[12,](#page-14-3) [13,](#page-14-4) [14\]](#page-14-5) in 1928, shortly after the publication of the Schrödinger equation, in order to study the non-relativistic atoms, using the concept of self-consistency. The stationary case of [\(1.5\)](#page-1-1) for $n = 3$ and $\alpha = 2$ is known is the literature as the Choquard equation and was introduced in [\[20\]](#page-14-6) as a model in quantum theory.

To our knowledge, the first results in solving [\(1.4\)](#page-1-0) with a nonlocal non-linearity defined by the convolution operation i.e.

\begin{cases} u_t - \Delta u \ge (\mathcal{K} * |u|^p)|u|^q, & x \in \mathbb{R}^n, \ t > 0, \\ u(x, 0) = u_0(x), & x \in \mathbb{R}^n, \end{cases}
$$
 (1.6)

were done recently in 2022 by Filippucci and Ghergu [\[6,](#page-13-1) [7\]](#page-13-2), where $n \ge 1$, $p, q > 0$, and $u_0 \in L^1_{loc}(\mathbb{R}^n)$. The non-linear convolution term $\mathcal{K} * |u|^p$ is defined by

$$
(\mathcal{K} * |u|^p)(x) = \int_{\mathbb{R}^n} \mathcal{K}(|x - y|)|u(y)|^p dy = \int_{\mathbb{R}^n} \mathcal{K}(|y|)|u(x - y)|^p dy.
$$

Indeed, in [\[6,](#page-13-1) [7\]](#page-13-2) the authors studied even more general cases than [\(1.6\)](#page-2-0) which includes quasilinear operators such as m-Laplacian. They proved that [\(1.6\)](#page-2-0) has no nontrivial global weak solutions whenever $p + q > 2$, $u_0 \in L^1(\mathbb{R}^n)$,

$$
\int_{\mathbb{R}^n} u_0(x) dx > 0 \quad \text{and} \quad \limsup_{R \to \infty} \mathcal{K}(R) R^{\frac{2n+2}{p+q} - n} > 0.
$$

They have illustrated their results by discussing the case of pure powers in the potential $\mathcal{K}(r) = r^{-\alpha}$, $\alpha \in (0,1)$, and proved that problem [\(1.6\)](#page-2-0) has no global weak solutions whenever $u_0 \in L^1(\mathbb{R}^n)$, $2 < p + q \leq \frac{2(n+1)}{n+\alpha}$ $\frac{(n+1)}{n+\alpha}$, and $\int_{\mathbb{R}^n} u_0(\eta) d\eta > 0$.

1.1.2 Motivation

Motivated by the above facts, the aim of this paper is to generalize the non-existence of global solutions results to the case of Heisenberg group (Theorem [2.1-](#page-3-0)i below). In addition, we get optimal results under some restrictions on the initial data (Theorem [2.1-](#page-3-0)ii below).

Our proof approach is based on the method of non-linear capacity estimates specifically adapted to the nature of the Heisenberg groups. The non-linear capacity method was introduced to prove the non-existence of global solutions in \mathbb{R}^n by Baras and Pierre [\[1\]](#page-13-3), then used by Baras and Kersner in [\[2\]](#page-13-4); later on, it was developed by Zhang in [\[24\]](#page-14-7) and Pohozaev and Mitidieri in [\[19\]](#page-14-8). It was also used by Kirane and Guedda [\[11\]](#page-13-5), then by Kirane et al. in [\[17\]](#page-14-9), and Fino et al in [\[3,](#page-13-6) [5,](#page-13-7) [8\]](#page-13-8). While, in \mathbb{H}^n , it was used by Pohozaev and Veron in [\[21\]](#page-14-10), by D'Ambrosio in [\[4\]](#page-13-9), and by Jleli-Kirane-Samet in [\[16\]](#page-14-11) and recently by Fino-Ruzhansky-Torebek in [\[9\]](#page-13-10).

2 Main results

Our main results are about the nonexistence of global weak solutions of [\(1.1\)](#page-0-0) for various values of exponents p and q.

Let us start with the definition of the weak solution of (1.1) .

Definition 2.1. (Weak solution of (1.1))

Let $u_0 \in L^1_{loc}(\mathbb{H}^n)$ and $T > 0$. We say that $u \in L^p_{loc}((0,T) \times \mathbb{H}^n)$ is a weak solution of [\(1.1\)](#page-0-0) on $[0, T) \times \mathbb{H}^n$ if

$$
(\mathcal{K} *_{\mathbb{H}} |u|^p)|u|^q \in L^1_{loc}((0,T) \times \mathbb{H}^n),
$$

and

$$
\int_{\mathbb{H}^n} u(\tau, \eta) \psi(\tau, \eta) d\eta - \int_{\mathbb{H}^n} u(0, \eta) \psi(0, \eta) d\eta
$$
\n
$$
\geq \int_0^\tau \int_{\mathbb{H}^n} (\mathcal{K} *_{\mathbb{H}} |u|^p) |u|^q \psi(t, \eta) d\eta dt + \int_0^\tau \int_{\mathbb{H}^n} u \Delta_{\mathbb{H}} \psi(t, \eta) d\eta dt
$$
\n
$$
+ \int_0^\tau \int_{\mathbb{H}^n} u \psi_t(t, \eta) d\eta dt,
$$

holds for all non-negative compactly supported test function $\psi \in C^{1,2}_{t,x}([0,T)\times \mathbb{H}^n)$, and $0 \leq \tau < T$. If $T = \infty$, u is called a global in time weak solution to [\(1.1\)](#page-0-0).

Theorem 2.1. Let $n \geq 1$, $p, q > 0$ such that $p + q > 2$.

(i) If $u_0 \in L^1(\mathbb{H}^n)$,

$$
\int_{\mathbb{H}^n} u_0(\eta) d\eta > 0 \quad \text{and} \quad \limsup_{R \to \infty} \mathcal{K}(R) R^{\frac{2Q+2}{p+q}-Q} > 0,
$$

then problem [\(1.1\)](#page-0-0) has no global weak solutions.

(ii) If $u_0 \in L^1_{loc}(\mathbb{H}^n)$,

$$
u_0(\eta) \ge \varepsilon (1+|\eta|^2_{\mathbb{H}})^{-\gamma/2} \quad \text{and} \quad \liminf_{R \to \infty} \left(\mathcal{K}(R)^{-1} R^{\gamma(p+q-1)-2-Q} \right) = 0,
$$

for some positive constant $\varepsilon > 0$ and any exponent $\gamma > 0$, then problem [\(1.1\)](#page-0-0) has no global weak solutions.

Note that, when

$$
\mathcal{K}(r) = r^{-\alpha}, \quad \alpha \in (0, Q),
$$

i.e.

$$
\begin{cases} u_t - \Delta_{\mathbb{H}} u \ge (|\eta|_{\mathbb{H}}^{-\alpha} *_{\mathbb{H}} |u|^p)|u|^q, & \eta \in \mathbb{H}^n, \ t > 0, \\ u(\eta, 0) = u_0(\eta), & \eta \in \mathbb{H}^n, \end{cases}
$$
 (2.1)

and due to the fact that

$$
\limsup_{R \to \infty} \mathcal{K}(R) R^{\frac{2Q+2}{p+q} - Q} > 0 \iff \lim_{R \to \infty} R^{\frac{2Q+2}{p+q} - Q - \alpha} > 0
$$

$$
\iff \frac{2Q+2}{p+q} - Q - \alpha \ge 0,
$$

and

$$
\liminf_{R \to \infty} \left(\mathcal{K}(R)^{-1} R^{\gamma(p+q-1)-2-Q} \right) = 0 \iff \lim_{R \to \infty} R^{\gamma(p+q-1)-2-Q+\alpha} = 0
$$

$$
\iff \gamma(p+q-1)-2-Q+\alpha < 0,
$$

we have the following

Corollary 2.2. Let $n \ge 1$, $p, q > 0$, $\alpha \in (0, 1)$.

(i) Assume that $u_0 \in L^1(\mathbb{H}^n)$ such that

$$
\int_{\mathbb{H}^n} u_0(\eta) d\eta > 0.
$$

If

$$
2 < p + q \le \frac{2(Q+1)}{Q+\alpha},
$$

then problem [\(2.1\)](#page-3-1) has no global weak solutions.

(ii) Assume that $u_0 \in L^1_{loc}(\mathbb{H}^n)$, and there exists a constant $\varepsilon > 0$ such that, for every $0 < \gamma < Q + \alpha$, the initial datum verifies the following assumption:

$$
u_0(\eta) \geq \varepsilon (1+|\eta|^2_{\mathbb{H}})^{-\gamma/2}.
$$

If

$$
2 < p + q < \frac{2 + Q + \gamma - \alpha}{\gamma},
$$

then problem [\(2.1\)](#page-3-1) has no global weak solutions.

Remark 2.1. Note that, we have chosen $\alpha \in (0,1) = (0,1) \cap (0,Q)$ to ensure that $2 < \frac{2(Q+1)}{Q+\alpha}$ $\frac{(Q+1)}{Q+\alpha}$. In addition, due to

$$
\gamma < Q + \alpha \Longleftrightarrow \frac{2(Q+1)}{Q+\alpha} < \frac{2+Q+\gamma-\alpha}{\gamma},
$$

the result in Corollary [2.2-](#page-4-0)(ii) positively affects on the nonexistence of global weak solutions in Corollary $2.2-(i)$.

Proof of Theorem [2.1.](#page-3-0) (i) The proof is by contradiction. Suppose that u is a global weak solution of (1.1) , then, for all $T \gg 1$, we have

\int_{\mathbb{H}^n} u(T,\eta)\psi(T,\eta) d\eta - \int_{\mathbb{H}^n} u(0,\eta)\psi(0,\eta) d\eta
$$

\geq \int_0^T \int_{\mathbb{H}^n} (\mathcal{K} *_{\mathbb{H}} |u|^p)|u|^q \psi(t,\eta) d\eta dt + \int_0^T \int_{\mathbb{H}^n} u \Delta_{\mathbb{H}} \psi(t,\eta) d\eta dt
$$

+ \int_0^T \int_{\mathbb{H}^n} u \psi_t(t,\eta) d\eta dt
$$

for all nonnegative compactly supported test function $\psi \in C^{1,2}_{t,x}([0,\infty) \times \mathbb{H}^n)$. We choose

$$
\psi(t,\eta) := \varphi^{\ell}(\eta)\varphi_3^{\ell}(t) := \varphi_1^{\ell}(x)\varphi_1^{\ell}(y)\varphi_2^{\ell}(\tau)\varphi_3^{\ell}(t),
$$

with

$$
\varphi_1(x) := \Phi\left(\frac{|x|}{T^{\frac{1}{2}}}\right), \varphi_1(y) := \Phi\left(\frac{|y|}{T^{\frac{1}{2}}}\right), \varphi_2(\tau) := \Phi\left(\frac{|\tau|}{T}\right), \varphi_3(t) := \Phi\left(\frac{t}{T}\right),
$$

where $\ell \gg 1$, and Φ is a smooth nonnegative non-increasing function such that

\Phi(r) = \begin{cases}\n1 & \text{if } 0 \le r \le 1/2, \\
\searrow & \text{if } 1/2 \le r \le 1, \\
0 & \text{if } r \ge 1.\n\end{cases}

\mathcal{B} = \{ \eta = (x, y, \tau) \in \mathbb{H}^n; \ |x|^2, |y|^2, |\tau| \le T \},\

Let us start to estimate I_1 . Using the following Hölder's inequality

 and $\mathcal{K}(R_j)R_j^{\frac{2Q+2}{p+q}-Q} \to \ell > 0$, as $j \to \infty$. (2.16)

Without loss of generality, we may assume that $R_j > R_{j-1}$ for all $j > 1$.

If $\ell = \infty$, replacing T by R_j^2 , we have

$$
\left(\int_0^{R_j^2} J^2(t) dt\right)^{\frac{p+q-1}{p+q}} \le \frac{C}{\mathcal{K}(12 R_j) R_j^{\frac{2(1+Q)}{p+q}-Q}},
$$

passing to the limit when $j \to \infty$, using [\(2.16\)](#page-11-0), and the monotone convergence theorem, we infer that

$$
\int_0^\infty J^2(t) \, dt = 0,
$$

which implies that $J \equiv 0$ a.e. on \mathbb{R}^+ . By [\(2.14\)](#page-10-3), we conclude that

$$
\int_{\mathcal{B}} u_0(\eta) \varphi^{\ell}(\eta) d\eta \le 0, \quad \text{for all } T \gg 1.
$$

Letting $T \to \infty$, using $u_0 \in L^1(\mathbb{H}^n)$ and the dominated convergence theorem, we arrive at

$$
0 < \int_{\mathbb{H}^n} u_0(\eta) \, d\eta \le 0,
$$

contradiction.

If $\ell < \infty$, then [\(2.15\)](#page-11-1) shows that $J \in L^2(0, \infty)$. This implies that

$$
\int_0^{R_j^2}\left(\int_{\mathcal{C}_j}|u|^{\frac{p+q}{2}}\psi(t,\eta)\,d\eta\right)^2\,dt,\quad \int_{\frac{R_j^2}{2}}^{R_j^2}\left(\int_{\mathcal{B}_j}|u|^{\frac{p+q}{2}}\psi(t,\eta)\,d\eta\right)^2\,dt\longrightarrow 0,
$$

when $j \to \infty$, where

$$
\mathcal{B}_j = \{ \eta = (x, y, \tau) \in \mathbb{H}^n; \ |x|^2, |y|^2, |\tau| \le R_j^2 \},\
$$

and

$$
\mathcal{C}_j = \{ \eta = (x, y, \tau) \in \mathbb{H}^n; \ \frac{R_j}{2} \le |x|, |y| \le R_j, \ \frac{R_j^2}{2} \le |\tau| \le R_j^2 \}.
$$

By [\(2.9\)](#page-9-1) and [\(2.13\)](#page-10-2), and by replacing T by R_j^2 , we conclude that

$$
\left(\int_0^{R_j^2} J^2(t)\, dt\right)^{\frac{p+q-1}{p+q}} \le \frac{C}{\mathcal{K}(12\, R_j)\, R_j^{\frac{2(1+Q)}{p+q}-Q}} o(1), \qquad \text{as } j\to \infty.
$$

Again, passing to the limit when $j \to \infty$, using (2.16) and $\ell \in (0, \infty)$, we get

$$
\int_0^\infty J^2(t) \, dt = 0,
$$

which implies as above that

$$
0 < \int_{\mathbb{H}^n} u_0(\eta) \, d\eta \le 0,
$$

contradiction.

(ii) As $T > 1$, we have

$$
\int_{\mathcal{B}} u_0(\eta) \varphi^{\ell}(\eta) d\eta \geq \int_{\mathcal{C}_0} u_0(\eta) \varphi^{\ell}(\eta) d\eta
$$
\n
$$
= \int_{\mathcal{C}_0} u_0(\eta) d\eta
$$
\n
$$
\geq \varepsilon \int_{\mathcal{C}_0} (1 + |\eta|_{\mathbb{H}}^2)^{-\gamma/2} d\eta
$$
\n
$$
\geq \varepsilon C \int_{\mathcal{C}_0} \left(\frac{T}{2} + \frac{T}{2}\right)^{-\gamma/2} d\eta
$$
\n
$$
= \varepsilon C T^{-\frac{\gamma}{2}} \text{meas}(\mathcal{C}_0)
$$
\n
$$
= \varepsilon C T^{\frac{Q-\gamma}{2}},
$$

where

$$
\mathcal{C}_0 := \{ \eta = (x, y, \tau) \in \mathbb{H}^n; \ |x|, |y| \le \frac{T^{\frac{1}{2}}}{2}, \ |\tau| \le \frac{T}{2} \}. \tag{2.17}
$$

Therefore by repeating the same calculation as in the subcritical case (see (2.14)), we get

$$
\mathcal{K}(12T^{\frac{1}{2}})\int_0^T J^2(t) dt + \varepsilon CT^{\frac{Q-\gamma}{2}} \leq C T^{\frac{Q}{2} - \frac{1+Q}{p+q}} \left(\int_0^T J^2(t) dt\right)^{\frac{1}{p+q}},
$$

i.e.

$$
\int_0^T J^2(t) dt + \frac{\varepsilon C}{\mathcal{K}(12 T^{\frac{1}{2}}) T^{\frac{\gamma - Q}{2}}} \leq \frac{C}{\mathcal{K}(12 T^{\frac{1}{2}}) T^{\frac{1+Q}{p+q} - \frac{Q}{2}}} \left(\int_0^T J^2(t) dt \right)^{\frac{1}{p+q}}
$$

$$
\leq \frac{C}{\left(\mathcal{K}(12 T^{\frac{1}{2}}) T^{\frac{1+Q}{p+q} - \frac{Q}{2}} \right)^{\frac{p+q}{p+q-1}}} + \frac{1}{2} \int_0^T J^2(t) dt,
$$

where we have used the following Young's inequality

$$
ab \le \frac{1}{2}a^{p+q} + Cb^{\frac{p+q}{p+q-1}}.
$$

This implies that

$$
\frac{\varepsilon C}{\mathcal{K}(12 T^{\frac{1}{2}}) T^{\frac{\gamma - Q}{2}}} \leq \frac{C}{\left(\mathcal{K}(12 T^{\frac{1}{2}}) T^{\frac{1+Q}{p+q}-\frac{Q}{2}}\right)^{\frac{p+q}{p+q-1}}},
$$

i.e.

$$
\varepsilon \le C \left[\mathcal{K} (12 T^{\frac{1}{2}}) \right]^{-\frac{1}{p+q-1}} T^{\frac{\gamma - Q}{2} - \frac{2(1+Q) - Q(p+q)}{2(p+q-1)}},
$$

and then

$$
\varepsilon \le C \liminf_{T \to \infty} \left(\left[\mathcal{K} (12 T^{\frac{1}{2}}) \right]^{-\frac{1}{p+q-1}} T^{\frac{\gamma-Q}{2} - \frac{2(1+Q)-Q(p+q)}{2(p+q-1)}} \right) = 0,
$$

 \Box

we get a contradiction.
