Multiplicity and asymptotic behavior of normalized solutions to p-Kirchhoff equations

Abstract

In this paper, we study a type of p-Kirchhoff equation

$$\left(a+b\int_{\mathbb{R}^3}\left|\nabla u\right|^p dx\right)\Delta_p u = \lambda \left|u\right|^{p-2} u + \left|u\right|^{q-2} u, x \in \mathbb{R}^3$$

with the prescribed mass

$$\left(\int_{\mathbb{R}^3} |u|^p \, dx\right)^{\frac{1}{p}} = c > 0$$

where $a > 0, b > 0, \frac{3}{2} is the$ *p* $-Laplacian of <math>u, \lambda \in \mathbb{R}$ is Lagrange multiplier. We consider both L^p -subcritical , L^p -critical and L^p -supercritical cases. Precisely, in the L^p -subcritical and L^p -critical cases, we obtain the existence and nonexistence of the normalized solutions for the *p*-Kirchhoff equation. In the L^p -supercritical case, we obtain the existence of radial ground sates and multiplicity of radial normalized solutions for the *p*-Kirchhoff equation. Furthermore, we study the asymptotic behavior of normalized solutions when $b \to 0^+$. Besides, when $\frac{3}{2} , benefit from the uniqueness(up to translations) of optimizer for Gargliardo-Nirenberg inequality, we show the existence and uniqueness of normalized solutions and provide the accurate descriptions.$

Keywords: *p*-Kirchhoff equation, Normalized solution, Ground state, Multiplicity, Asymptotic behavior.

1 Introduction and main results

In this paper, we study a type of *p*-Kirchhoff equation

$$-\left(a+b\int_{\mathbb{R}^3}\left|\nabla u\right|^p dx\right)\Delta_p u = \lambda \left|u\right|^{p-2} u + \left|u\right|^{q-2} u, x \in \mathbb{R}^3$$
(1.1)

with the prescribed mass

$$\left(\int_{\mathbb{R}^3} |u|^p \, dx\right)^{\frac{1}{p}} = c > 0. \tag{1.2}$$

where $a > 0, b > 0, \frac{3}{2} is the$ *p*-Laplacian of*u* $, <math>\lambda \in \mathbb{R}$ is Lagrange multiplier.

In rencent years, many researchers have focused on studying the p-Kirchhoff type problem, e.g., [1, 2, 3] and their references therein.

When p = 2, it reduces to the following general Kirchhoff equation

$$-\left(a+b\int_{\mathbb{R}^3}\left|\nabla u\right|^2 dx\right)\Delta u = \lambda u + \left|u\right|^{q-2} u, x \in \mathbb{R}^3$$
(1.3)

which is first proposed by G. Kirchhoff in [4]. It shows the free vibration of elastic strings and describes the motions of moderately large amplitude. Kirchhoff type problem has been widely studied since a functional analysis approach is proposed in the significant work of J.L. Lions [5].

When a = 1, b = 0, equation(1.1) reduces to the following *p*-Laplacian equation

$$-\Delta_p u = \lambda |u|^{p-2} u + |u|^{q-2} u, x \in \mathbb{R}^3$$
(1.4)

The *p*-Laplacian operator Δ_p has a strong physical significance. It can be used as models for various physical problems. In fluid mechanics, the value 1 (resp., <math>p = 2 and p > 2) corresponds to a pseudoplastic (resp.,Newtonian and diltant) fluid.

Recently, many researchers have focused on normalized solutions. Ye [6] studied the existence of constrained minimizers for the Kirchhoff equation (1.3) and obtained the sharp existence of normalized solutions under different assumptions; Following [6], Zeng and Zhang [7] obtained the existence and uniqueness of normalized solutions for equation (1.3). For the *p*-Laplacian equations (1.4), Lou and Zhang [8] studied the multiplicity of normalized solutions under the L^p mass constraint (1.2). For the *p*-Kirchhoff equation (1.1), Ren and Lan [9] studied the existence of normalized solutions in the L^2 supercritical case.

As far as we know, there are few works concerning with the *p*-Kirchhoff equation (1.1) with the L^p mass constraint (1.2). Thus we will explore Eqs. (1.1)-(1.2) in this paper.

It is well known that the appearance of nonlocal term $\left(\int_{\mathbb{R}^3} |\nabla u|^p dx\right) \Delta_p u$ causes several mathematical difficulties and makes the problem different from the general *p*-Lapalcian case. By taking λ as a Lagrange multiplier, we consider critical points of the following C^1 -functional

$$I(u) := \frac{a}{p} \int_{\mathbb{R}^3} |\nabla u|^p \, dx + \frac{b}{2p} \left(\int_{\mathbb{R}^3} |\nabla u|^p \, dx \right)^2 - \frac{1}{q} \int_{\mathbb{R}^3} |u|^p \, dx.$$
(1.5)

constrained on

$$S(c) := \left\{ u \in W^{1,p}(\mathbb{R}^3) : \left(\int_{\mathbb{R}^3} |u|^p \, dx \right)^{\frac{1}{p}} = c > 0 \right\},\$$

where

$$W^{1,p}(\mathbb{R}^3) := \left\{ u \in L^p(\mathbb{R}^3) : \int_{\mathbb{R}^3} \left| \nabla u \right|^p dx < \infty \right\}.$$

We know the critical points of $I|_{S(c)}$ are weak solutions to (1.1)-(1.2) and define

$$i(c) := \inf_{u \in S(c)} I(u).$$
 (1.6)

In the L^p subcritical and critical cases, we give the existence of normalized solutions to the *p*-Kirchhoff Eqs. (1.1)-(1.2):

Theorem 1.1. (1) Let $p < q < p + \frac{2p^2}{3}$, then (i) when $p < q < p + \frac{p^2}{3}$, i(c) has a minimizer for any c > 0. (ii) when $q = p + \frac{p^2}{3}$, i(c) has a minimizer if and only if $c > a^{\frac{3}{p^2}} |Q|_p$, where $|\cdot|_s$ denote the norm

(ii) when $q = p + \frac{1}{3}$, i(c) has a minimizer if and only if $c > a^{p^2} |Q|_p$, where $|\cdot|_s$ denote the norm of $L^s(\mathbb{R}^3)$ and $Q \in W^{1,p}(\mathbb{R}^3)$ is a ground-state solution to the following equation

$$-\frac{3(q-p)}{p^2}\Delta_p u + \left(1 + \frac{(p-3)(q-p)}{p^2}\right)|u|^{p-2} u = |u|^{q-2} u, x \in \mathbb{R}^3$$

(iii) when $p + \frac{p^2}{3} < q < p + \frac{2p^2}{3}$, there exist $c^* > 0$ such that i(c) has a minimizer if and only if $c \ge c^*$, where

$$c^* = \left[p \left| Q \right|_p^{q-p} \left(\frac{ap}{2p^2 - 3q + 3p} \right)^{\frac{2p^2 - 3q + 3p}{p^2}} \left(\frac{bp}{6pq - 8p^2} \right)^{\frac{3q - 3p - p^2}{p^2}} \right]^{\frac{p}{pq - 3q + 3p}}$$

Moreover, for any $p < q < p + \frac{2p^2}{3}$ and c > 0, if i(c) has a minimzer, then Eqs.(1.1)-(1.2) has a couple of solutions $(u, \lambda) \in W^{1,p}(\mathbb{R}^3) \times \mathbb{R}$ such that $u \in S(c)$ and $\lambda < 0$. (2) When $q = p + \frac{2p^2}{3}$, i(c) has no minimizer for all c > 0. In the following three conclusions, we study the Eqs.(1.1)-(1.2) in the L^p mass supercritical case. In this case, the energy functional I constrained on S(c) is not bounded from below which leads to many difficulties. In order to overcome the lack of compactness, we work on the radially symmetric functionals space $W_r^{1,p}(\mathbb{R}^3)$ and consider the following minimization problem:

$$m(c) := \inf_{u \in M(c)} I(u), \tag{1.7}$$

where

$$M(c) := \{ u \in S_r(c) : P(u) = 0 \},\$$
$$S_r(c) := \{ |u|_p = c : u \in W_r^{1,p}(\mathbb{R}^3) \},\$$

and

$$P(u) := a |\nabla u|_p^p + b |\nabla u|_p^{2p} - \frac{3(q-p)}{pq} |u|_q^q = 0$$

is associated Pohozaev identity of Eqs(1.1)-(1.2).

Definition 1.2. We call (u, λ) is a ground-state solution to (1.1)-(1.2), if (u, λ) is a solution to (1.1)-(1.2) and u minimizes the energy functional I among all solutions of L^p -norm.

Theorem 1.3. Let $p + \frac{2p^2}{3} < q < p^*$, for any c > 0, (1.1)-(1.2) has a couple of solution $(u, \lambda) \in W_r^{1,p}(\mathbb{R}^3) \times \mathbb{R}$ with I(u) = m(c) and $\lambda < 0$. Moreover, u is a radial ground state of (1.1)-(1.2).

Next, we show the multiplicity of normalized solutions to (1.1)-(1.2):

Theorem 1.4. Let $p + \frac{2p^2}{3} < q < p^*$ and c > 0. Then there exists a sequence $\{(u_n, \lambda_n)\}$ of solutions of (1.1)-(1.2) such that u_n is radial and $\lambda_n < 0$ for any $n \in \mathbb{N}^+$. Moreover, we have $||u_n||_{W_r^{1,p}(\mathbb{R}^3)} \to +\infty$ and $I(u_n) \to +\infty$ as $n \to +\infty$.

Based on Theorem 1.4, we study the asymptotic behavior of normalized solutions to (1.1)-(1.2) when $b \to 0^+$. We obtain the following result:

Theorem 1.5. Let $p + \frac{2p^2}{3} < q < p^*$, c > 0 and $\{(u_n^b, \lambda_n^b)\} \subset S_r(c) \times \mathbb{R}^-$ is obtained in Theorem 1.4. Then, for any $\{b_m\} \to 0^+(n \to +\infty)$, there is a subsequence $\{b_{m_l}\}$ such that for each $n \in \mathbb{N}^+$, $u_n^{b_{m_l}} \to u_n^0$ in $W_r^{1,p}(\mathbb{R}^3)$ and $\lambda_n^{b_{m_l}} \to \lambda_n^0$ in \mathbb{R} as $l \to +\infty$, where $\{(u_n^0, \lambda_n^0)\} \subset S_r(c) \times \mathbb{R}^-$ is a sequence of couples of weak solutions to the following equation

$$-a\Delta_p u - \lambda |u|^{p-2} u = |u|^{q-2} u, \ in \ \mathbb{R}^3.$$
(1.8)

As is well known, if 1 , the ground state to (2.2) is unique (up to translation), see [24].However, if <math>p > 2, the uniqueness have not been completely solved. When 1 , we obtain an accurate description of constrained minimizer of <math>I for i(c) when $p < q \le p + \frac{p^2}{3}$ and a accurate solution to (1.1)-(1.2) when $p + \frac{2p^2}{3} \le q < p^*$, which is stated in the following two results. **Theorem 1.6.** We assume that $\frac{3}{2} , then$

(1) When $p < q < p + \frac{p^2}{3}$, i(c) has a unique minimizer (up to translations), which is the form of $u_c = \frac{c\mu_q^{\frac{3}{p}}}{|Q|_p}Q(\mu_q x)$, where $\mu_q = \frac{t_q^{\frac{1}{p}}}{c}$ with t_q being the unique minimum point of the function

$$f_q(t) = \frac{a}{p}t + \frac{b}{2p}t^2 - \frac{c^{q-\frac{3(q-p)}{p}}}{p|Q|_p^{q-p}}t^{\frac{3(q-p)}{p^2}}, t \in (0, +\infty).$$
(1.9)

(2) When $q = p + \frac{p^2}{3}$, if $c > a^{\frac{3}{p^2}} |Q|_p$, then i(c) has a unique minimizer (up to translations)

$$u_{c} = \frac{c\mu_{q}^{\frac{3}{p}}}{|Q|_{p}}Q(\mu_{q}x) \quad where \quad \mu_{q} = \frac{t_{q}^{\frac{1}{p}}}{c} \quad with \quad t_{q} = \frac{c^{\frac{p^{2}}{3}} - ap|Q|_{p}^{\frac{p^{2}}{3}}}{bp|Q|_{p}^{\frac{p^{2}}{3}}}.$$
(1.10)

Moreover, $i(c) = -\frac{b}{2p} \left(\frac{c^{\frac{p^2}{3}} - ap|Q|_p^{\frac{p^2}{3}}}{bp|Q|_p^{\frac{p^2}{3}}} \right)^2$.

When $q \ge p + \frac{2p^2}{3}$, Theorem 1.1 tells that i(c) has no minimizer. Thus, motivated by [7], we investigate the mountain pass type critical points for $I(\cdot)$ on S(c).

Definition 1.7. Given c > 0, the functional $I(\cdot)$ is said to have mountain pass geometry on S(c) if there exists K(c) > 0 such that

$$\gamma(c) := \inf_{h \in \Gamma(c)} \max_{t \in [0,1]} I(h(t)) > \max\{I(h(0)), I(h(1))\}$$
(1.11)

holds in the set $\Gamma(c) = \{h \in C([0,1]; S(c)) : h(0) \in A_{K(c)}, I(h(1)) < 0\}$, where $A_{K(c)} = \{u \in S(c) : |\nabla u|_p^p \le K(c)\}$.

Next, when $\frac{3}{2} , under the following assumption$

$$q > p + \frac{2p^2}{3}, or \ q = p + \frac{2p^2}{3} \ and \ c > \left(\frac{b |Q|_p^{\frac{2p^2}{3}}}{2}\right)^{\frac{2p^2 - 3p}{2p^2 - 3p}},$$
 (1.12)

we investigate some properties of (1.11) by some energy estimates. Moreover, we show that if $u_c \in S(c)$ is a critical point of $I(\cdot)$ on the level $\gamma(c)$, then it is a scaling of Q(x). Still let $f_q(\cdot)$ be given by (1.9) and note that it has a unique maximum point in $(0, +\infty)$ when (1.12) holds. Then, we have the following theorem.

Theorem 1.8. When $\frac{3}{2} , assume (1.12) holds and let <math>\overline{t}_q$ be the unique maximum point of $f_q(t)$ in $(0, +\infty)$. Then $\gamma(c) = f_q(\overline{t}_q)$ and it can be attained by $\overline{u}_c = \frac{c\overline{\mu}_q^{\frac{3}{p}}}{|Q|_p}Q(\overline{\mu}_q x)$ where $\overline{\mu}_q = \frac{\overline{t}_q^{\frac{1}{p}}}{c}$. Meanwhile, \overline{u}_c is a solution of (1.1)-(1.2) for some $\lambda \in \mathbb{R}$. The paper is organized as follows. In Section 2, we present some preliminary results. In Section 3, we study the existence of minimizers for i(c) in the L^p -subcritical and critical cases. In Section 4, we show the existence of normalized ground state in the L^p -supercritical case. In Section 5, we study the multiplicity and asymptotic behavior of normalized solutions in the L^p -supercritical case. In Section 6, we prove the existence and uniqueness of normalized solutions when $\frac{3}{2} .$

2 Preliminaries

In this section, we introduce various preliminary results.

Lemma 2.1. (Gagliardo-Nirenberg inequality of p-Laplacian type, [10]) For $p \in (\frac{3}{2}, 3)$ and any $q \in [p, p^*)$, it holds that

$$|u|_{q} \leq \left(\frac{q}{p} \frac{1}{|Q|_{p}^{q-p}}\right)^{\frac{1}{q}} |\nabla u|_{p}^{\frac{3(q-p)}{qp}} |u|_{p}^{1-\frac{3(q-p)}{qp}},$$
(2.1)

where $|u|_s$ is the norm of $L^t(\mathbb{R}^3)$ and up to translations, $Q \in W^{1,p}(\mathbb{R}^3)$ is a ground-state solution to the following equation([11])

$$-\frac{3(q-p)}{p^2}\Delta_p u + \left(1 + \frac{(p-3)(q-p)}{p^2}\right)|u|^{p-2} u = |u|^{q-2} u, x \in \mathbb{R}^3.$$
 (2.2)

 $\label{eq:Furthermore, when 1$

Lemma 2.2. Let $p \in (\frac{3}{2}, 3)$, $q \in (p, p^*)$, if $(u, \lambda) \in W^{1,p}(\mathbb{R}^3) \times \mathbb{R}$ is a weak solution of (1.1)-(1.2), then the following identity

$$P(u) = a \left| \nabla u \right|_{p}^{p} + b \left| \nabla u \right|_{p}^{2p} - \frac{3(q-p)}{pq} \left| u \right|_{q}^{q} = 0$$
(2.3)

holds. Moreover, it can be obtained that $\lambda < 0$.

Proof. the proof is similar to the Lemma 2.3 of [12] and Lemma 2.6 of [6], so we omit it. \Box

Next, we introduce a useful elementary inequality.

Lemma 2.3. There exists $c_s > 0$ such that for any $x, y \in \mathbb{R}^3$,

$$\begin{cases} \left\langle |x|^{s-2} x - |y|^{s-2} y, x - y \right\rangle_{\mathbb{R}^3} \ge c_s |x - y|^s & \text{for } 2 \le s < 3, \\ (|x| + |y|)^{2-s} \left\langle |x|^{s-2} x - |y|^{s-2} y, x - y \right\rangle_{\mathbb{R}^3} \ge c_s |x - y|^2 & \text{for } 1 < s < 2, \end{cases}$$
(2.4)

where $\langle \cdot, \cdot \rangle_{\mathbb{R}^3}$ denotes the standard inner product in \mathbb{R}^3 .

For $u, v \in W^{1,p}(\mathbb{R}^3)$, it follows from (2.4) that , for $2 \le p < 3$,

$$c_p \int_{\mathbb{R}^3} |\nabla u - \nabla v|^p dx \le \int_{\mathbb{R}^3} (|\nabla u|^{p-2} \nabla u - |\nabla v|^{p-2} \nabla v) \nabla (u - v) dx, \tag{2.5}$$

and for
$$\frac{3}{2} ,
$$c_p^{\frac{p}{2}} \int_{\mathbb{R}^3} |\nabla u - \nabla v|^p dx$$

$$\leq \int_{\mathbb{R}^3} (T(u,v))^{\frac{p}{2}} (|\nabla u| + |\nabla v|)^{\frac{p(2-p)}{2}} dx$$

$$\leq \left(\int_{\mathbb{R}^3} (|\nabla u|^{p-2} \nabla u - |\nabla v|^{p-2} \nabla v) \nabla (u-v) dx \right)^{\frac{p}{2}} \left(\int_{\mathbb{R}^3} (|\nabla u| + |\nabla v|)^p dx \right)^{\frac{2-p}{2}},$$
(2.6)$$

where

$$T(u,v) = \left\langle \left| \nabla u \right|^{p-2} \nabla u - \left| \nabla v \right|^{p-2} \nabla v, \nabla u - \nabla v \right\rangle_{\mathbb{R}^3}$$

note that the domain of integration in (2.5)-(2.6) can be replaced by any open domain of \mathbb{R}^3 .

Lemma 2.4. ([13], Lemma 3) Let $I \in C^1(W^{1,p}(\mathbb{R}^3), \mathbb{R})$. If $\{u_n\} \subset S(c)$ is bounded in $W^{1,p}(\mathbb{R}^3)$, then

$$(I|_{S(c)})'(u_n) \to 0 \quad in \quad \left(W^{1,p}(\mathbb{R}^3)\right)' \quad as \quad n \to \infty$$

$$\Leftrightarrow I'(u_n) - \frac{1}{c^p} \left\langle I'(u_n), u_n \right\rangle |u_n|^{p-2} u_n \to 0 \quad in \quad \left(W^{1,p}(\mathbb{R}^3)\right)' \quad as \quad n \to \infty.$$

3 Proof of Theorem 1.1

In this section, we study the case when $p < q \le p + \frac{2p^2}{3}$. We first give a few of important lemmas before the proof of Theorem 1.1.

$$\begin{array}{l} \text{Lemma 3.1. Assume that } p < q < p + \frac{2p^2}{3}, \ then \\ (1) \ For \ each \ c > 0, \ i(c) \ is \ well \ defined \ and \ i(c) \leq 0. \\ (2) \ If \ p < q < p + \frac{p^2}{3}, \ then \ i(c) < 0 \ for \ all \ c > 0. \\ (3) \ If \ q = p + \frac{p^2}{3}, \ then \ i(c) < 0 \ for \ each \ c > a^{\frac{3}{p^2}} |Q|_p \ and \ i(c) = 0 \ for \ each \ 0 < c \leq a^{\frac{3}{p^2}} |Q|_p. \\ (4) \ If \ p + \frac{p^2}{3} < q < p + \frac{2p^2}{3}, \ then \ i(c) < 0 \ for \ each \ c > c^* \ and \ i(c) = 0 \ for \ each \ c \leq c^*, \ where \\ c^* = \left[p |Q|_p^{q-p} \left(\frac{ap}{2p^2 - 3q + 3p} \right)^{\frac{2p^2 - 3q + 3p}{p^2}} \left(\frac{bp}{6pq - 8p^2} \right)^{\frac{3q - 3p - p^2}{p^2}} \right]^{\frac{p}{pq - 3q + 3p}}. \end{array}$$

Proof. (1) For any c > 0 and $u \in S(c)$, by the Gagaliardo-Nirenberg inequality in Lemma 2.1, it is obtained that

$$I(u) \ge \frac{a}{p} |\nabla u|_p^p + \frac{b}{2p} |\nabla u|_p^{2p} - \frac{c^{q - \frac{3(q-p)}{p}}}{p |Q|_p^{q-p}} |\nabla u|_p^{\frac{3(q-p)}{p}}.$$
(3.1)

Since $0 < \frac{3(q-p)}{p} < 2p$, I is bound from below on S(c). Set $u_t(x) := t^{\frac{3}{p}}u(tx)$, t > 0, then $u_t \in S(c)$ and

$$i(c) \le I(u_t) = t^p \frac{a}{p} |\nabla u|_p^p + t^{2p} \frac{b}{2p} |\nabla u|_p^{2p} - t^{\frac{3(q-p)}{p}} \frac{1}{q} |u|_q^q \to 0 \quad as \quad t \to 0.$$
(3.2)

Hence, $i(c) \le 0$ for all c > 0. (2) If $p < q < p + \frac{p^2}{3}$, then $0 < \frac{3(q-p)}{p} < p$, so (3.2) implies that i(c) < 0 for all c > 0. (3) If $q = p + \frac{p^2}{3}$, similar to (3.1), we see that

$$I(u) \ge \frac{a}{p} |\nabla u|_p^p + \frac{b}{2p} |\nabla u|_p^{2p} - \frac{c^{\frac{p^2}{3}}}{p |Q|_p^{\frac{p^2}{3}}} |\nabla u|_p^p.$$
$$= \frac{b}{2p} |\nabla u|_p^{2p} + \frac{a}{p} |\nabla u|_p^p \left(1 - \frac{c^{\frac{p^2}{3}}}{a |Q|_p^{\frac{p^2}{3}}}\right).$$

Thus, when $0 < c \leq a^{\frac{3}{p^2}} |Q|_p$, we have $i(c) \geq 0$. By $i(c) \leq 0$, it is obtained that i(c) = 0 for all $0 < c \le a^{\frac{3}{p^2}} |Q|_p.$

By (2.2) and corresponding Pohozaev identity, we have

$$|\nabla Q|_p^p = |Q|_p^p = \frac{p}{q} |Q|_q^q.$$
 (3.3)

When $c > a^{\frac{3}{p^2}} |Q|_p$, set

$$Q_t(x) := \frac{c}{|Q|_p} t^{\frac{3}{p}} Q(tx), \quad t > 0,$$
(3.4)

hence, $Q_t(x) \in S(c)$. By (3.3), we have

$$I(Q_t) = \frac{a}{p} (ct)^p + \frac{b}{2p} (ct)^{2p} - \frac{c^q t^p}{p |Q|_p^{q-p}}$$

= $\frac{b}{2p} (ct)^{2p} + \frac{a(ct)^p}{p} \left(1 - \frac{c^{\frac{p^2}{3}}}{a |Q|_p^{\frac{p^2}{3}}} \right).$ (3.5)

Thus, $I(Q_t) < 0$ as $t \to 0$. Since $i(c) \le I(Q_t)$, we conclude that i(c) < 0 when $c > a^{\frac{3}{p^2}} |Q|_p$.

(4) If
$$p + \frac{p}{3} < q < p + \frac{2p}{3}$$
, similar to (3.5), we have

$$I(Q_t) = \frac{a}{p}(ct)^p + \frac{b}{2p}(ct)^{2p} - \frac{c^q}{p |Q|_p^{q-p}} t^{\frac{3(q-p)}{p}}.$$
(3.6)

By Young's inequality, we have

$$\frac{a}{p}(ct)^{p} + \frac{b}{2p}(ct)^{2p} \ge \left(\frac{a}{pp_{1}}c^{p}t^{p}\right)^{p_{1}} \left(\frac{b}{2pp_{2}}c^{2p}t^{2p}\right)^{p_{2}} = t^{p+pp_{2}}c^{p+pp_{2}} \left(\frac{a}{pp_{1}}\right)^{p_{1}} \left(\frac{b}{2pp_{2}}\right)^{p_{2}}, \quad (3.7)$$

where $0 < p_1, p_2 < 1$, $p_1 + p_2 = 1$ and the equality holds if and only if $\frac{a}{pp_1}c^pt^p = \frac{b}{2pp_2}c^{2p}t^{2p}$. Choosing $p_1 = 2 - \frac{3(q-p)}{p^2}$ and $p_2 = \frac{3(q-p)}{p^2} - 1$. Since $p + \frac{p^2}{3} < q < p + \frac{2p^2}{3}$, we have $0 < p_1, p_2 < 1$ and

 $p_1 + p_2 = 1$. Then, by (3.6), we have

- (-)

$$I(Q_t) \geq c^{\frac{3(q-p)}{p}} t^{\frac{3(q-p)}{p}} \left(\frac{ap}{2p^2 - 3q + 3p}\right)^{\frac{2p^2 - 3q + 3p}{p^2}} \left(\frac{bp}{6pq - 8p^2}\right)^{\frac{3q - 3p - p^2}{p^2}} - \frac{c^q}{p |Q|_p^{q-p}} t^{\frac{3(q-p)}{p}} \\ = \frac{c^{\frac{3(q-p)}{p}} t^{\frac{3(q-p)}{p}}}{p |Q|_p^{q-p}} \left[(c^*)^{q - \frac{3(q-p)}{p}} - c^{q - \frac{3(q-p)}{p}} \right].$$

If $c > c^*$, choosing $t_0^p = \frac{2p_2 a}{c^p p_1 b}$ such that $\frac{a}{pp_1} c^p t^p = \frac{b}{2pp_2} c^{2p} t^{2p}$. Then, $i(c) \le I(Q_t) = \frac{c^{\frac{3(q-p)}{p}} t^{\frac{3(q-p)}{p}}}{p |Q|_p^{q-p}} \left[(c^*)^{q - \frac{3(q-p)}{p}} - c^{q - \frac{3(q-p)}{p}} \right] < 0.$

If $0 < c \le c^*$, then for any $u \in S(c)$, by Lemma 2.1 and (3.7), we have

$$I(u) \ge \frac{a}{p} |\nabla u|_p^p + \frac{b}{2p} |\nabla u|_p^{2p} - \frac{c^{q-\frac{3(q-p)}{p}}}{p|Q|_p^{q-p}} |\nabla u|_p^{\frac{3(q-p)}{p}} \ge \frac{1}{p|Q|_p^{q-p}} |\nabla u|_p^{\frac{3(q-p)}{p}} \left[(c^*)^{q-\frac{3(q-p)}{p}} - c^{q-\frac{3(q-p)}{p}} \right] \ge 0$$

Thus $i(c) \ge 0$, combining with $i(c) \le 0$, we conclude that i(c) = 0.

•

$$\begin{aligned} \text{Lemma 3.2. If } q &= p + \frac{2p^2}{3}, \text{ then } i(c) = -\infty \text{ when } c > \left(\frac{b |Q|_p^{\frac{2p^2}{3}}}{2}\right)^{\frac{2p^2 - 3p}{2}} \text{ and } i(c) = 0 \text{ when } \\ c &\leq \left(\frac{b |Q|_p^{\frac{2p^2}{3}}}{2}\right)^{\frac{3}{2p^2 - 3p}} \end{aligned}$$

$$Proof. \text{ When } c > \left(\frac{b |Q|_p^{\frac{2p^2}{3}}}{2}\right)^{\frac{3}{2p^2 - 3p}}, \text{ similar to (3.5), we have} \\ I(Q_t) &= \frac{a}{p}(ct)^p + \frac{b}{2p}(ct)^{2p} - \frac{c^q t^p}{p |Q|_p^{q-p}} \\ &= \frac{a}{p}(ct)^p + \frac{b}{2p}(ct)^{2p} \left(1 - \frac{2c^{\frac{2p^2}{3} - 3p}}{b |Q|_p^{\frac{2p^2}{3}}}\right), \end{aligned}$$

Thus $I(Q_t) \to -\infty$ as $t \to \infty$, which implies $i(c) = -\infty$.

When
$$c \leq \left(\frac{b|Q|_{p}^{3}}{2}\right)$$
, for any $u \in S(c)$, by Lemma 2.1, we have

$$I(u) \geq \frac{a}{p} |\nabla u|_{p}^{p} + \frac{b}{2p} |\nabla u|_{p}^{2p} - \frac{c^{q-\frac{3(q-p)}{p}}}{p|Q|_{p}^{q-p}} |\nabla u|_{p}^{\frac{3(q-p)}{p}}$$

$$= \frac{a}{p} |\nabla u|_{p}^{p} + \frac{b}{2p} |\nabla u|_{p}^{2p} \left(1 - \frac{2c^{\frac{2p^{2}-3p}{3}}}{b|Q|_{p}^{\frac{2p^{2}}{3}}}\right) \geq 0,$$

which implies that $i(c) \ge 0$. Since (3.2) still holds when $q = p + \frac{2p^2}{3}$, we have $i(c) \le 0$ for any c > 0. So we conclude that i(c) = 0.

Lemma 3.3. For each $p < q < p + \frac{2p^2}{3}$, the function $c \mapsto i(c)$ is continuous on $(0, +\infty)$. *Proof.* The proof follows from Lemma 3.1 (1) and is similar to the Lemma 3.3 of [12], so we omit it. \Box **Lemma 3.4.** For each $p < q < p + \frac{2p^2}{3}$, if c satisfies the following condition:

$$\begin{cases} c > 0, & when \quad p < q < p + \frac{p^2}{3}, \\ c > a^{\frac{3}{p^2}} |Q|_p, & when \quad q = p + \frac{p^2}{3}, \\ c > c^*, & when \quad p + \frac{p^2}{3} < q < p + \frac{2p^2}{3}, \end{cases}$$
(3.8)

where c^* is defined in Lemma 3.1, then

$$i(c) < i(\alpha) + i(\sqrt[p]{c^p - \alpha^p}), \ \text{for any} \ 0 < \alpha < c.$$

Proof. We first claim that

$$i(\theta c) < \theta^p i(c), \text{ for any } \theta > 1.$$
 (3.9)

By Lemma 3.1, we have i(c) < 0 when c satisfies (3.8). Let $\{u_n\} \subset S(c)$ be a minimizing sequence for i(c). For any $\theta > 1$, set $u_n^{\theta} = u(\theta^{-\frac{p}{3}}x)$, then $u_n^{\theta} \in S(\theta c)$ and

$$I(u_n^{\theta}) = \theta^p I(u_n) + \left(\theta^{p - \frac{p^2}{3}} - \theta^p\right) \frac{a}{p} |\nabla u_n|_p^p + \left(\theta^{2p - \frac{2p^2}{3}} - \theta^p\right) \frac{b}{2p} |\nabla u_n|_{2p}^p$$
$$\leq \theta^p I(u_n).$$

Let $n \to \infty$, we have $i(\theta c) \leq \theta^p i(c)$, with equality if and only if $|\nabla u_n|_p^p \to 0$ as $n \to \infty$. By (2.1), we have $|u_n|_q^q \to 0$ when $|\nabla u_n|_p^p \to 0$ as $n \to \infty$. Then we obtain $I(u_n) \to 0$ as $n \to \infty$ which contradicts i(c) < 0. Thus, we have $i(\theta c) < \theta^p i(c)$. For any $0 < \alpha < c$, apply (3.9) with $\theta = \frac{c}{\alpha} > 1$ and $\theta = \frac{c}{\sqrt[q]{c^p - \alpha^p}} > 1$ respectively, we get

$$i(c) = \frac{\alpha^p}{c^p} i\left(\frac{c}{\alpha}\alpha\right) + \frac{c^p - \alpha^p}{c^p} i\left(\frac{c}{\sqrt[p]{c^p - \alpha^p}} \sqrt[p]{c^p - \alpha^p}\right) < i(\alpha) + i(\sqrt[p]{c^p - \alpha^p}).$$

Lemma 3.5. For each $p < q < p + \frac{2p^2}{3}$ and any c > 0, let $\{w_n\} \subset S(c)$ be a minimizing sequence for i(c), then i(c) possesses another minimizing sequence $\{v_n\} \subset S(c)$ such that

$$||v_n - w_n||_{W^{1,p}(\mathbb{R}^3)} \to 0, (I|_{S(c)})'(v_n) \to 0 \text{ as } n \to \infty.$$

Proof. When $p < q < p + \frac{2p^2}{3}$, by Lemma 3.1 (1), we know that I is bounded from below on S(c). By Ekeland's variational principle([14], Theorem 2.4), we can get a new minimizing sequence $\{v_n\} \subset S(c)$ for i(c) such that $||v_n - w_n||_{W^{1,p}(\mathbb{R}^3)} \to 0$, which is also a Palais-Smale sequence for $I|_{S(c)}$.

Proof of Theorem 1.1. We complete the proof in four parts.

At fist, we study the case when $p < q < p + \frac{p^2}{3}$:

(1) For $p < q < p + \frac{p^2}{3}$, by Lemma 3.1, we have i(c) < 0 for any c > 0. Let $\{w_n\} \subset S(c)$ be a minimizing sequence for i(c). By Lemma 3.5, there exists a minimizing sequence $\{v_n\} \subset S(c)$ for i(c) such that

$$(I|_{S(c)})'(v_n) \to 0 \quad \text{as } n \to \infty.$$
 (3.10)

Since i(c) < 0, it can be obtained that $\{v_n\}$ is bounded in $W^{1,p}(\mathbb{R}^3)$. In fact, for n sufficiently large, by Lemma 2.1, we have

$$0 \ge I(v_n) \ge \frac{a}{p} |\nabla v_n|_p^p + \frac{b}{2p} |\nabla v_n|_p^{2p} - \frac{c^{q - \frac{3(q-p)}{p}}}{p |Q|_p^{q-p}} |\nabla v_n|_p^{\frac{3(q-p)}{p}} \ge \frac{a}{p} |\nabla v_n|_p^p - \frac{c^{q - \frac{3(q-p)}{p}}}{p |Q|_p^{q-p}} |\nabla v_n|_p^{\frac{3(q-p)}{p}},$$

which indicates $|\nabla v_n|_p$ is bounded in $W^{1,p}(\mathbb{R}^3)$ since there is $\frac{3(q-p)}{p} < p$ when $p < q < p + \frac{p^2}{3}$. Set

$$\sigma := \liminf_{n \to +\infty} \sup_{y \in \mathbb{R}^3} \int_{B_1(y)} |v_n|^p dx$$

If $\sigma = 0$, then by vanishing lemma (see[14], Lemma 1.21), $u_n \to 0$ in $L^s(\mathbb{R}^3)$ for any $p < s < p^*$. Hence, $0 \leq \lim_{n \to +\infty} \left(\frac{a}{p} |\nabla v_n|_p^p + \frac{b}{2p} |\nabla v_n|_p^{2p} \right) = i(c) < 0$, which is impossible. Therefore, we must have $\sigma > 0$, and then, there exists a sequence $\{y_n\} \subset \mathbb{R}^3$ such that

$$\int_{B_1(y_n)} |v_n|^p dx > 0$$

Set $u_n(\cdot) := v_n(\cdot + y_n)$, and then, $\{u_n\}$ is still a bounded Palais-Smale sequence for $I|_{S(c)}$ on the level i(c). We may assume that for some $u \in W^{1,p}(\mathbb{R}^3)$,

$$\begin{cases} u_n \rightharpoonup u \neq 0, & \text{in } W^{1,p}(\mathbb{R}^3), \\ u_n \rightarrow u, & \text{in } L^s_{loc}(\mathbb{R}^3), s \in [p, p^*), \\ u_n(x) \rightarrow u(x), & \text{a.e. in } \mathbb{R}^3. \end{cases}$$
(3.11)

Hence, $\alpha := |u|_p \in (0, c]$. Next, we try to prove $u \in S(c)$ and suppose to the contrary that $\alpha \in (0, c)$.

At first, we verify that, up to subsequence, $\nabla u_n(x) \to \nabla u(x)$ a.e. $x \in \mathbb{R}^3$. We follow some ideas of [15] and [16]. By (3.10) and Lemma 2.4, we have

$$I'(u_n) - \lambda_n |u_n|^{p-2} u_n \to 0 \quad \text{in} \quad \left(W^{1,p}(\mathbb{R}^3)\right)' \quad as \quad n \to \infty.$$
(3.12)

where $\lambda_n = \frac{1}{c^p} \langle I'(u_n), u_n \rangle$. Since $\{u_n\}$ is bounded in $W^{1,p}(\mathbb{R}^3)$, we suppose that, up to subsequence,

$$\lim_{n \to +\infty} |\nabla u_n|_p^p = A \ge 0, \lim_{n \to +\infty} \lambda_n = \lambda.$$
(3.13)

Hence, by (3.12), we have

$$J(u_n) := -(a+bA)\Delta_p u_n - |u_n|^{q-2}u_n - \lambda |u_n|^{p-2}u_n \to 0$$
(3.14)

in $(W^{1,p}(\mathbb{R}^3))'$ as $n \to \infty$. Meanwhile, it is easy to see that

$$J(u) = -(a+bA)\Delta_p u - |u|^{q-2}u - \lambda |u|^{p-2} u \in (W^{1,p}(\mathbb{R}^3))'.$$
(3.15)

Let $\eta \in C_0^{\infty}(\mathbb{R}^3, [0, 1])$ satisfy $\eta|_{B_R} = 1$ and supp $\eta \subset B_{2R}$, where $B_R = \{x \in \mathbb{R}^3 : |x| \leq R\}$. From (3.14), (3.15) and $(u_n - u)\eta \rightharpoonup 0$ in $W^{1,p}(\mathbb{R}^3)$, we obtain

$$(J(u_n) - J(u))[(u_n - u)\eta] \to 0.$$
(3.16)

By Hölder inequality and (3.11), we conclude that

$$\int_{\mathbb{R}^3} (|u_n|^{s-2}u_n - |u|^{s-2}u)(u_n - u)\eta dx = o_n(1), \forall p \le s < p^*,$$
(3.17)

$$\int_{\mathbb{R}^3} (|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u) \nabla \eta (u_n - u) dx = o_n(1).$$
(3.18)

By (3.16)-(3.18), we conclude that

$$\int_{\mathbb{R}^3} (|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u) \nabla (u_n - u) \eta dx = o_n(1)$$

Using (2.5) and (2.6), we infer that

$$\lim_{n \to \infty} \int_{B_{2R}} |\nabla u_n - \nabla u|^p dx = 0$$

Taking into account of the arbitrariness of B_{2R} , we conclude that

$$\nabla u_n(x) \to \nabla u(x) \ a.e. \ x \in \mathbb{R}^3.$$

Then, by the Brezis-Lieb Lemma (see[14], Lemma 1.32), we have

$$|\nabla u_n|_p^p = |\nabla u_n - \nabla u|_p^p + |\nabla u|_p^p + o_n(1), |u_n|_p^p = |u_n - u|_p^p + |u|_p^p + o_n(1).$$
(3.19)

By (3.19), it can be obtained that

$$i(c) = \lim_{n \to +\infty} I(u_n) \ge I(u) + \lim_{n \to +\infty} I(u_n - u) \ge i(\alpha) + i(\sqrt[p]{c^p - \alpha^p}),$$

which contradicts to Lemma 3.4. So, $|u|_p = c$ and $u_n \to u$ in $L^p(\mathbb{R}^3)$. We conclude from Lemma 2.1 that $u_n \to u$ in $L^q(\mathbb{R}^3)$. Then, we have

$$i(c) \le I(u) \le \lim_{n \to +\infty} I(u_n) = i(c).$$

Thus, $u \in S(c)$ is a minimizer of i(c), and then, u is a critical point of $I|_{S(c)}$. Therefore, by Lemma 2.2, there exists $\lambda < 0$ such that (u, λ) is a couple of solution to (1.1) and (1.2).

Secondly, we study the case when $q = p + \frac{p^2}{3}$:

(2) For $q = p + \frac{p^2}{3}$, when $c > a^{\frac{3}{p^2}} |Q|_p$, we have i(c) < 0. Similar to the case when $p < q < p + \frac{p^2}{3}$, we can get a minimizer for i(c) and thus get a couple of solution (u, λ) to (1.1) and (1.2).

When $0 < c \le a^{\frac{3}{p^2}} |Q|_p$, suppose that there exists a minimizer $u \in S(c)$ such that I(u) = i(c) = 0, then

$$\frac{a}{p} |\nabla u|_p^p + \frac{b}{2p} |\nabla u|_p^{2p} = \frac{1}{q} |u|_q^q \le \frac{c^{\frac{p^2}{3}}}{p |Q|_p^{\frac{p^2}{3}}} |\nabla u|_p^p \le \frac{a}{p} |\nabla u|_p^p,$$

which implies that $|\nabla u|_p^{2p} = 0$. Hence u = 0, which is impossible.

Next, we study the case when $p + \frac{p^2}{3} < q < p + \frac{2p^2}{3}$:

(3) When $c > c^*$, we have i(c) < 0. Similar to the case when $p < q < p + \frac{p^2}{3}$, we can get a minimizer for i(c) and thus get a couple of solution (u, λ) to (1.1) and (1.2).

When $c < c^*$, suppose that there exists $u \in S(c)$ such that I(u) = i(c) = 0. Similar to the proof of Lemma 3.4, choose $\theta = \frac{c^*}{c} > 1$ and set $u^{\theta} = u(\theta^{-\frac{p}{3}}x)$. Then $u^{\theta} \in S(\theta c)$ and

$$i(c^*) \le I(u^\theta) < \theta^p I(u) = 0,$$

which contradicts that $i(c^*) = 0$.

When $c = c^*$, set $c_n = c^* + \frac{1}{n}$. For each *n*, there exsists $\{v_n\} \subset S(c)$ such that

$$I(v_n) = i(c_n) < 0. (3.20)$$

By Lemma 2.1, we can deduce that $\{v_n\}$ is bounded in $W^{1,p}(\mathbb{R}^3)$. Moreover, by Lemma 3.3, we see that

$$I(v_n) \to i(c^*) = 0$$

If $|v_n|_q^q \to 0$, then $\frac{a}{p} |\nabla v_n|_p^p + \frac{b}{2p} |\nabla v_n|_p^{2p} \to 0$. Hence, $|\nabla v_n|_p^p \to 0$, by Lemma 2.1 we see that $I(v_n) \ge 0$ for *n* large enough which contradicts to (3.20). Therefore, similar to part (1), there exists $\{y_n\} \subset \mathbb{R}^3$ and $u \in W^{1,p}(\mathbb{R}^3)$ such that

$$\begin{cases} u_n \rightharpoonup u \neq 0, & \text{in } W^{1,p}(\mathbb{R}^3), \\ u_n \rightarrow u, & \text{in } L^s_{loc}(\mathbb{R}^3), s \in [p, p^*), \\ u_n(x) \rightarrow u(x), & \text{a.e. in } \mathbb{R}^3. \end{cases}$$

where $u_n(\cdot) := v_n(\cdot + y_n)$.

We claim that $u \in S(c^*)$ and suppose to the contrary that $|u|_p = \alpha \in (0, c^*)$. For each n, note that $I(u_n) = I(v_n) = i(c_n) < 0$, hence u_n is also a minimizer for $i(c_n)$ and $\{u_n\}$ is bounded in $W^{1,p}(\mathbb{R}^3)$.

By the Lagrange multipliers rule([17], Corollary 4.1.2), there exists $\{\lambda_n\} \subset \mathbb{R}^3$ such that

$$I'(u_n) - \lambda_n |u_n|^{p-2} u_n = 0$$
 in $(W^{1,p}(\mathbb{R}^3))'$.

Obviously, $\{\lambda_n\}$ is bounded in \mathbb{R} since $\{u_n\}$ is bounded in $W^{1,p}(\mathbb{R}^3)$. Similar to (3.13), suppose that, up to subsequence,

$$\lim_{n \to +\infty} |\nabla u_n|_p^p = A \ge 0, \lim_{n \to +\infty} \lambda_n = \lambda.$$

By a similar arugment in part (1), we obtain that $\nabla u_n(x) \to \nabla u(x)$ a.e. on $x \in \mathbb{R}^3$. Thus by the Brezis-Lieb Lemma, we have

$$|\nabla u_n|_p^p = |\nabla u_n - \nabla u|_p^p + |\nabla u|_p^p + o_n(1), |u_n|_p^p = |u_n - u|_p^p + |u|_p^p + o_n(1),$$

moreover,

$$0 = \lim_{n \to +\infty} I(u_n) \ge I(u) + \lim_{n \to +\infty} I(u_n - u).$$

By Lemma 3.1, $i(\alpha) = i(\sqrt[p]{(c^*)^p - \alpha^p}) = 0$. Because $\lim_{n \to \infty} |u_n - u|_p^p = (c^*)^p - \alpha^p$, we have

$$\lim_{n \to \infty} I(u_n - u) \ge i(\sqrt[p]{(c^*)^p - \alpha^p}) = 0,$$

which implies $0 = I(u_n) \ge I(u) + I(u_n - u) \ge I(u) \ge i(\alpha) = 0$. Hence u is a minimizer of $i(\alpha)$, but, by Lemma 3.1, there is no minimizer for $\alpha \in (0, c^*)$. So we have $u \in S(c^*)$ and $u_n \to u$ in $L^p(\mathbb{R}^3)$. Meanwhile, by Lemma 2.1, $u_n \to u$ in $L^q(\mathbb{R}^3)$. So we have

$$0 = \lim_{n \to \infty} I(u_n) \ge I(u) \ge i(c^*) = 0.$$

We conclude that u is a minimizer for $i(c^*)$. Similar to part (1), there exists a $\lambda < 0$ such that (u, λ) is a couple of solution to (1.1)-(1.2).

Finally, we study the case when $q = p + \frac{2p^2}{3}$:

(4) When $c > \left(\frac{b|Q|_{p}^{\frac{2p^{2}}{3}}}{2}\right)^{\frac{3}{2p^{2}-3p}}$, by Lemma 3.2, we have $i(c) = -\infty$ so that i(c) has no minimizer. When $c \le \left(\frac{b|Q|_{p}^{\frac{2p^{2}}{3}}}{2}\right)^{\frac{3}{2p^{2}-3p}}$, suppose that there exists a $u \in S(c)$ such that I(u) = i(c) = 0. Then $\frac{a}{p} |\nabla u|_{p}^{p} + \frac{b}{2p} |\nabla u|_{p}^{2p} = \frac{1}{q} |u|_{q}^{q} \le \frac{c^{q-\frac{3(q-p)}{p}}}{p|Q|_{p}^{q-p}} |\nabla u|_{p}^{\frac{3(q-p)}{p}} \le \frac{b}{2p} |\nabla u|_{p}^{2p}$.

So $|\nabla u|_p^p = 0$, which is impossible.

4 Proof of Theorem 1.3

In this section, we consider the minimization problem (1.7) in the case $p + \frac{2p^2}{3} < q < p^*$.

Lemma 4.1. Let $p + \frac{2p^2}{3} < q < p^*$, then I is not bounded from below on $S_r(c)$ for any c > 0. *Proof.* For any c > 0 and any $u \in S_r(c)$, set $u_t(x) := t^{\frac{3}{p}}u(tx), t > 0$, then $u_t \in S(c)$ and

$$I(u_t) = t^p \frac{a}{p} |\nabla u|_p^p + t^{2p} \frac{b}{2p} |\nabla u|_p^{2p} - t^{\frac{3(q-p)}{p}} \frac{1}{q} |u|_q^q.$$

Because $p + \frac{2p^2}{3} < q < p^*$, $\frac{3(q-p)}{p} > 2p$. Hence, $I(u_t) \to -\infty$ as $t \to +\infty$.

Lemma 4.2. Let $p + \frac{2p^2}{3} < q < p^*$, then I is bounded from below and coercive on M(c) for any c > 0. Moreover, there exists a constant $C_0 > 0$ such that $I(u) \ge C_0$ for all $u \in M(c)$.

Proof. Since P(u) = 0 for all $u \in M(c)$, we have

$$I(u) = I(u) - \frac{p}{3(q-p)}P(u) = a\left(\frac{1}{p} - \frac{p}{3(q-p)}\right)|\nabla u|_p^p + b\left(\frac{1}{2p} - \frac{p}{3(q-p)}\right)|\nabla u|_p^{2p}.$$
(4.1)

Note that $\frac{1}{2p} - \frac{p}{3(q-p)} > \frac{1}{p} - \frac{p}{3(q-p)} > 0$ when $p + \frac{2p^2}{3} < q$, we obtain that I is coercive on M(c). By Lemma 2.1 and P(u) = 0,

$$b \left| \nabla u \right|_p^{2p} \le a \left| \nabla u \right|_p^p + b \left| \nabla u \right|_p^{2p} = \frac{3(q-p)}{pq} \left| u \right|_q^q \le \frac{3(q-p)}{p} \frac{c^{q - \frac{3(q-p)}{p}}}{p \left| Q \right|_p^{q-p}} \left| \nabla u \right|_p^{\frac{3(q-p)}{p}}$$

Since $2p < \frac{3(q-p)}{p}$, we infer that $|\nabla u|_p$ has a positive lower bound. Hence, by (4.1), there exists a constant $C_0 > 0$ such that $I(u) \ge C_0$ for all $u \in M(c)$.

By Lemma 4.2, we know that $m(c) \ge C_0 > 0$.

Lemma 4.3. Let $p + \frac{2p^2}{3} < q < p^*$ and c > 0, for any $u \in S_r(c)$ and $u_t(x) := t^{\frac{3}{p}}u(tx)(t > 0)$, there exists a unique $t_0 > 0$ such that $I(u_{t_0}) = \max_{t>0} I(u_t)$ and $u_{t_0} \in M(c)$. In particular, we have

$$t_0 < 1 \Leftrightarrow P(u) < 0, t_0 = 1 \Leftrightarrow P(u) = 0.$$

Proof. For any $u \in S_r(c)$, let

$$h(t) := I(u_t) = t^p \frac{a}{p} |\nabla u|_p^p + t^{2p} \frac{b}{2p} |\nabla u|_p^{2p} - t^{\frac{3(q-p)}{p}} \frac{1}{q} |u|_q^q, \quad \forall t > 0.$$

Differentiate h(t) with respect to t, we obtain

$$h'(t) = \frac{t^p a \left| \nabla u \right|_p^p + t^{2p} b \left| \nabla u \right|_p^{2p} - t^{\frac{3(q-p)}{p}} \frac{3(q-p)}{qp} \left| u \right|_q^q}{t} = \frac{P(u_t)}{t}$$

Since $\frac{3(q-p)}{p} > 2p > p$, h'(t) > 0 when t > 0 sufficiently small and $\lim_{t \to +\infty} h'(t) = -\infty$. Similar to [18], we infer that h(t) has a unique maximum at some point $t_0 > 0$. Therefore, $h'(t_0) = \frac{P(u_{t_0})}{t_0} = 0$, which implies that $u_{t_0} \in M(c)$.

Next, we prove the last two statements. We first claim that $P(u) < 0 \Rightarrow t_0 < 1$. Just suppose that $t_0 \ge 1$, by using $h'(t_0) = 0$ and P(u) < 0, we obtain the following contradiction

$$\begin{split} 0 &= \frac{t_0^p a \left| \nabla u \right|_p^p + t_0^{2p} b \left| \nabla u \right|_p^{2p} - t_0^{\frac{3(q-p)}{p}} \frac{3(q-p)}{qp} \left| u \right|_q^q}{t_0^{\frac{3(q-p)}{p}}} \\ &\leq a \left| \nabla u \right|_p^p + b \left| \nabla u \right|_p^{2p} - \frac{3(q-p)}{qp} \left| u \right|_q^q < 0, \end{split}$$

So $t_0 < 1$. If P(u) = 0, then

$$\begin{split} \frac{t_0^p a \left| \nabla u \right|_p^p + t_0^{2p} b \left| \nabla u \right|_p^{2p} - t_0^{\frac{3(q-p)}{p}} \frac{3(q-p)}{qp} \left| u \right|_q^q}{t_0^{\frac{3(q-p)}{p}}} \\ &= 0 \\ &= a \left| \nabla u \right|_p^p + b \left| \nabla u \right|_p^{2p} - \frac{3(q-p)}{qp} \left| u \right|_q^q, \end{split}$$

which implies that neither $t_0 > 1$ nor $t_0 < 1$ could occur since $|\nabla u|_p \neq 0$. Thus $P(u) = 0 \Rightarrow t_0 = 1$. Next, we show that $t_0 < 1 \Rightarrow P(u) < 0$ and $t_0 = 1 \Rightarrow P(u) = 0$. If $t_0 < 1$, then

$$0 = \frac{t_0^p a |\nabla u|_p^p + t_0^{2p} b |\nabla u|_p^{2p} - t_0^{\frac{3(q-p)}{p}} \frac{3(q-p)}{qp} |u|_q^q}{t_0^{\frac{3(q-p)}{p}}}$$

> $a |\nabla u|_p^p + b |\nabla u|_p^{2p} - \frac{3(q-p)}{qp} |u|_q^q = P(u).$

Also, $t_0 = 1$ implies $P(u) = P(u_{t_0}) = 0$.

Lemma 4.4. Let c > 0 and $p + \frac{2p^2}{3} < q < p^*$. Then M(c) is a natural C^1 -manifold and each minimizer of $I|_{M(c)}$ is a critical point of $I|_{S_r(c)}$.

Proof. For any $u \in M(c)$, we have P(u) = 0. Set $Q(u) := |u|_p^p - c^p = 0$. Obviously, P, Q are both of C^1 class. In order to prove that M(c) is a manifold, we only need to verify that, for any $u \in M(c)$,

$$(P'(u),Q'(u)):W^{1,p}_r(\mathbb{R}^3)\to\mathbb{R}^2$$
 is surjection

Assume by contradiction that P'(u) and Q'(u) are linearly dependent for some $u \in M(c)$, i.e., there exists a constant $l \in \mathbb{R}$, such that for any $\psi \in W_r^{1,p}(\mathbb{R}^3)$, we have $P'(u)\psi = lQ'(u)\psi$ that is

$$-(a+2b|\nabla u|_p^p)\Delta_p u - \frac{3(q-p)}{p^2}|u|^{q-2}u = l|u|^{p-2}u.$$
(4.2)

By the Nehari identity and Pohozaev identity of (4.2), we obtain

$$p^{2}\left(a|\nabla u|_{p}^{p}+2b|\nabla u|_{p}^{2p}\right) = \frac{9(q-p)^{2}}{pq}|u|_{q}^{q},$$

combining with P(u) = 0, we have

$$\left(\frac{3(q-p)}{p^2} - 1\right)a|\nabla u|_p^p + \left(\frac{3(q-p)}{p^2} - 2\right)b|\nabla u|_p^{2p} = 0.$$

Since $\frac{3(q-p)}{p^2} - 2 > 0$, we conclude that $|\nabla u|_p^p = 0$ which is impossible.

Next, we prove the last statement. Suppose that u is a minimizer of $I|_{M(c)}$, then P(u) = 0. By the Lagrange multiplier rule, there exist two Lagrange multipliers λ and μ such that

$$I'(u) - \lambda |u|^{p-2}u - \mu P'(u) = 0 \quad in \quad \left(W_r^{1,p}(\mathbb{R}^3)\right)'.$$
(4.3)

By the Nehari identity and Pohozaev identity of (4.3), we obtain

$$a|\nabla u|_{p}^{p} + b|\nabla u|_{p}^{2p} - \frac{3(q-p)}{qp}|u|_{q}^{q} - \mu \left[ap|\nabla u|_{p}^{p} + 2bp|\nabla u|_{p}^{2p} - \frac{3(q-p)^{2}}{qp^{2}}|u|_{q}^{q}\right] = 0$$

Recalling that $P(u) = a |\nabla u|_p^p + b |\nabla u|_p^{2p} - \frac{3(q-p)}{pq} |u|_q^q = 0$, we have

$$\mu \left[ap |\nabla u|_p^p + 2bp |\nabla u|_p^{2p} - \frac{3(q-p)^2}{qp^2} |u|_q^q \right] = 0.$$

Using P(u) = 0 again, we obtain

$$\mu\left[\left(p-\frac{3(q-p)}{p}\right)a|\nabla u|_p^p + \left(2p-\frac{3(q-p)}{p}\right)b|\nabla u|_p^{2p}\right] = 0.$$

Since $p - \frac{3(q-p)}{p} < 2p - \frac{3(q-p)}{p} < 0$, we conclude that $\mu = 0$.

Lemma 4.5. For each $p + \frac{2p^2}{3} < q < p^*$, the function $c \mapsto m(c)$ is strictly decreasing for c > 0.

Proof. For any $0 < c_1 < c_2$, by $\gamma(c_1) > 0$ and Lemma 4.3, there exists $\{u_n\} \subset M(c_1)$ such that

$$I(u_n) = \max_{t>0} I((u_n)_t) \le m(c_1) + \frac{1}{n}$$

By (4.1) and Lemma 4.2, there exists $k_i > 0(i = 1, 2, 3, 4)$ independent of n such that

$$k_1 \le |u_n|_q^q \le k_2, k_3 \le |\nabla u_n|_p^p \le k_4.$$
(4.4)

Let $v_n := \left(\frac{c_2}{c_1}\right)^{1-\frac{3}{p}} u_n\left(\frac{c_1}{c_2}x\right)$, then $v_n \in S_r(c_2)$ and $|\nabla v_n|_p^p = |\nabla u_n|_p^p, |v_n|_q^q = \left(\frac{c_2}{c_1}\right)^{\frac{q(p-3)}{p}+3} |u_n|_q^q.$ (4.5) Moreover, by Lemma 4.3, there exists $t_n > 0$ such that $(v_n)_{t_n} \in M(c_2)$ and $I((v_n)_{t_n}) = \max_{t>0} I((v_n)_t)$. Since $\{(v_n)_{t_n}\} \subset M(c_2)$, by Lemma 4.2, $\{|\nabla(v_n)_{t_n}|_p^p\}$ has a positive lower bound which independent of n. Combining with $|\nabla v_n|_p^p = |\nabla u_n|_p^p$, (4.4) and $t_n^p = \frac{|\nabla(v_n)_{t_n}|_p^p}{|\nabla v_n|_p^p}$, we conclude that there exists a constant $C_1 > 0$ such that

$$t_n \ge C_1,\tag{4.6}$$

for any *n*. Hence, by $q < p^* = \frac{3p}{3-p}$ and (4.4)-(4.6), we have

$$m(c_{2}) \leq I((v_{n})_{t_{n}}) = I((u_{n})_{t_{n}}) - \left(\left(\frac{c_{2}}{c_{1}}\right)^{\frac{q(p-3)}{p}+3} - 1\right) \frac{t_{n}^{\frac{3(q-p)}{p}}}{q} |u_{n}|_{q}^{q}$$

$$\leq m(c_{1}) + \frac{1}{n} - \left(\left(\frac{c_{2}}{c_{1}}\right)^{\frac{q(p-3)}{p}+3} - 1\right) \frac{C_{1}^{\frac{3(q-p)}{p}}}{q} k_{1}.$$

$$(4.7)$$

which implies that $m(c_2) < m(c_1)$, by letting $n \to +\infty$.

Proof of Theorem 1.3. For c > 0, let $\{v_n\} \subset M(c)$ be a minimizing sequence for m(c). If $|v_n|_q^q \to 0$, then by $P(v_n) = 0$, we deduce that $|\nabla v_n|_p^p \to 0$ which contradicts with Lemma 4.2. Thus, similar to the proof of Theorem 1.1, there exists $\{y_n\} \subset \mathbb{R}^3$ such that

$$\int_{B_1(y_n)} |v_n|^p dx > 0.$$

Denote $u_n(\cdot) := v_n(\cdot + y_n)$, then $\{u_n\} \subset M(c)$ is still a minimizing sequence for m(c). By (4.1), $\{u_n\}$ is bounded in $W_r^{1,p}(\mathbb{R}^3)$. Hence, up to subsequence, we may assume that there exists $u \in W_r^{1,p}(\mathbb{R}^3)$ such that

$$\begin{cases} u_n \rightharpoonup u \neq 0, & \text{in } W_r^{1,p}(\mathbb{R}^3), \\ u_n \rightarrow u, & \text{in } L^s(\mathbb{R}^3), s \in (p, p^*), \\ u_n(x) \rightarrow u(x), & \text{a.e. in } \mathbb{R}^3. \end{cases}$$
(4.8)

Then, $\alpha := |u|_p \in (0, c]$. Next, we show that u is a minimizer of $I|_{M(c)}$ for m(c). By (4.8) and $u_n \in M(c)$, we obtain that $P(u) \leq \lim_{n \to +\infty} P(u_n) = 0$. Hence, by Lemma 4.3, there exists $t_0 \in (0, 1]$ such that $u_{t_0} \in M(c)$. Thus, we have

$$\begin{split} m(\alpha) &\leq I(u_{t_0}) = I(u_{t_0}) - \frac{p}{3(q-p)} P(u_{t_0}) \\ &= t_0^p a \left(\frac{1}{p} - \frac{p}{3(q-p)}\right) |\nabla u|_p^p + t_0^{2p} b \left(\frac{1}{2p} - \frac{p}{3(q-p)}\right) |\nabla u|_p^{2p} \\ &\leq a \left(\frac{1}{p} - \frac{p}{3(q-p)}\right) |\nabla u|_p^p + b \left(\frac{1}{2p} - \frac{p}{3(q-p)}\right) |\nabla u|_p^{2p} \\ &\leq \liminf_{n \to +\infty} \left[a \left(\frac{1}{p} - \frac{p}{3(q-p)}\right) |\nabla u_n|_p^p + b \left(\frac{1}{2p} - \frac{p}{3(q-p)}\right) |\nabla u_n|_p^{2p} \right] \\ &\leq \liminf_{n \to +\infty} \left(I(u_n) - \frac{p}{3(q-p)} P(u_n) \right) = m(c) \leq m(\alpha), \end{split}$$

which means $m(\alpha) = m(c)$ and $t_0 = 1$. By Lemma 4.5 and $\alpha \in (0, c]$, it must have $\alpha = c$. Thus, $u \in M(c)$ and I(u) = m(c), i.e. $I|_{M(c)}$ attains its minimum at u. By Lemma 4.4 and Lemma 2.2, we conclude that there exists $\lambda < 0$ such that $(u, \lambda) \in W_r^{1,p}(\mathbb{R}^3) \times \mathbb{R}$ is a couple of solution to (1.1)-(1.2). Moreover, if $(v, \mu) \in W_r^{1,p}(\mathbb{R}^3) \times \mathbb{R}$ is also a couple of solution for c. Then, by Lemma 2.2, we have P(v) = 0 wich implies that $v \in M(c)$. Since $I(u) = m(c) = \inf_{w \in M(c)} I(w) \leq I(v)$, we see that u is a radial ground state of (1.1)-(1.2).

5 Proof of Theorem 1.4 and Theorem 1.5

In this section, we study the multiplicity and asymptotic behavior of normalized solutions to (1.1)-(1.2) in the L^p supercritical case. Firstly, we give some lemmas which are important for our proof of Theorem 1.4. We follow some ideas of [19].

Let $\{e'_n\}_{n=1}^{\infty}$ be a Schauder basis of $W^{1,p}(\mathbb{R}^3)([20])$. Set

$$e_n = \int_{O(N)} e'_n(g(x)) d\mu_g,$$

where O(N) denotes the orthogonal group on \mathbb{R}^3 and $d\mu_g$ is the Haar measure on O(N). Then going if necessary to select one in identical elements, we see that $\{e_n\}_{n=1}^{\infty}$ is a Schauder basis of $W_r^{1,p}(\mathbb{R}^3)$. Without loss of generality, we assume that $|e_n| = 1$ for any $n \ge 1$. $\forall n \in \mathbb{N}^+$, denote

$$V_n := \operatorname{span}\{e_1, ..., e_n\}, V_n^{\perp} := \overline{\operatorname{span}\{e_i : i \ge n+1\}}$$

Clearly, $W_r^{1,p}(\mathbb{R}^3) = V_n \oplus V_n^{\perp}$ for any $n \in \mathbb{N}^+$.

Lemma 5.1. ([19], Lemma 6.1) Let $p + \frac{2p^2}{3} < q < p^*$ and c > 0, then there holds

$$\mu_n := \inf_{u \in V_n^{\perp} \cap S_r(c)} \frac{|\nabla u|_p^p}{|u|_q^p} \to +\infty, \ as \ n \to +\infty$$

For $n \in \mathbb{N}^+$, we define

$$\rho_n := \left(\frac{a(\mu_n)^{\frac{q}{p}}}{L}\right)^{\frac{1}{q-p}},$$

where

$$L := \max_{x>0} \frac{(x^p + 1)^{\frac{q}{p}}}{x^q + 1}.$$

Let $B_n := \{ u \in V_n^{\perp} \cap S_r(c) : |\nabla u|_p = \rho_n \}$. We have

Lemma 5.2.

$$\beta_n := \inf_{u \in B_n} I(u) \to +\infty, \text{ as } n \to +\infty.$$

Proof. $\forall u \in B_n$, by Lemma 5.1,

$$|u|_{q}^{p} \leq \mu_{n}^{-1} |\nabla u|_{p}^{p} \leq \mu_{n}^{-1} (|\nabla u|_{p}^{p} + 1).$$

Then,

$$\begin{split} I(u) &= \frac{a}{p} |\nabla u|_{p}^{p} + \frac{b}{2p} |\nabla u|_{p}^{2p} - \frac{1}{q} |u|_{q}^{q} \\ &\geq \frac{a}{p} |\nabla u|_{p}^{p} - \frac{1}{q(\mu_{n})^{\frac{q}{p}}} \left(|\nabla u|_{p}^{p} + 1 \right)^{\frac{q}{p}} \\ &\geq \frac{a}{p} |\nabla u|_{p}^{p} - \frac{L}{q(\mu_{n})^{\frac{q}{p}}} \left(|\nabla u|_{p}^{q} + 1 \right) \\ &= \frac{a}{p} (\rho_{n})^{p} - \frac{L}{q(\mu_{n})^{\frac{q}{p}}} (\rho_{n})^{q} - \frac{L}{q(\mu_{n})^{\frac{q}{p}}} \\ &= \left(\frac{1}{p} - \frac{1}{q} \right) a(\rho_{n})^{p} - \frac{L}{q(\mu_{n})^{\frac{q}{p}}}. \end{split}$$

Thus $\beta_n \ge \left(\frac{1}{p} - \frac{1}{q}\right) a(\rho_n)^p - \frac{L}{q(\mu_n)^{\frac{q}{p}}}$. By Lemma 5.1 and definition of ρ_n , we obtain that $\beta_n \to +\infty$ as $n \to +\infty$.

Lemma 5.3. There exits $0 < \rho'_0 < \rho_0$ such that

$$\sup_{u \in S_r(c), |\nabla u|_p \le \rho'_0} I(u) < \beta_0 := \inf_{u \in S_r(c), |\nabla u|_p = \rho_0} I(u).$$

Moreover, $\beta_0 > 0$.

Proof. Since $u \in S_r(c)$, by Lemma 2.1, we have

$$\begin{split} &\frac{a}{p} \left| \nabla u \right|_{p}^{p} + \frac{b}{2p} \left| \nabla u \right|_{p}^{2p} - \frac{c^{q - \frac{3(q-p)}{p}}}{p \left| Q \right|_{p}^{q-p}} \left| \nabla u \right|_{p}^{\frac{3(q-p)}{p}} \\ &\leq I(u) \leq \frac{a}{p} \left| \nabla u \right|_{p}^{p} + \frac{b}{2p} \left| \nabla u \right|_{p}^{2p}. \end{split}$$

Note that $\frac{3(q-p)}{p} > 2p$, we conclude that there exits $\rho_0 > 0$ small enough such that $\beta_0 > 0$. Meanwhile, we can choose $0 < \rho'_0 < \rho_0$ small enough such that

$$\sup_{u \in S_r(c), |\nabla u|_p \le \rho'_0} I(u) < \frac{\beta_0}{2} < \beta_0.$$

By Lemma 5.2, without loss of generality, we assume that $\beta_n > \beta_0$ for any $n \in \mathbb{N}^+$. Next we begin to set up our min-max procedure. First we introduce the map

$$k: W_r^{1,p}(\mathbb{R}^3) \times \mathbb{R} \to W_r^{1,p}(\mathbb{R}^3)$$

$$(u,\theta) \to k(u,\theta) := e^{\frac{3}{p}\theta} u(e^{\theta}x).$$
(5.1)

Then for any given $u \in S_r(c)$, we have $k(u, \theta) \in S_r(c)$ and

$$|\nabla k(u,\theta)|_p^p = e^{p\theta} |\nabla u|_p^p, |k(u,\theta)|_q^q = e^{\frac{3(q-p)}{p}\theta} |u|_q^q,$$
(5.2)

and

$$I(k(u,\theta)) = e^{p\theta} \frac{a}{p} |\nabla u|_p^p + e^{2p\theta} \frac{b}{2p} |\nabla u|_p^{2p} - e^{\frac{3(q-p)}{p}\theta} \frac{1}{q} |u|_q^q.$$
(5.3)

Note that $\frac{3(q-p)}{p} > 2p$, we conclude from (5.1)-(5.3) that

$$\begin{cases} |\nabla k(u,\theta)|_p^p \to 0, I(k(u,\theta)) \to 0, & \theta \to -\infty, \\ |\nabla k(u,\theta)|_p^p \to +\infty, I(k(u,\theta)) \to -\infty, & \theta \to +\infty. \end{cases}$$

Since V_n is finite dimensional, it follows that for each $n \in \mathbb{N}^+$, there exists $\theta_n > 0$ such that

$$\overline{g}_n \in C([0,1] \times (S_r(c) \cap V_n), S_r(c)) : \overline{g}_n(t,u) = k(u, (2t-1)\theta_n)$$
(5.4)

satisfies

$$\begin{cases} |\nabla \overline{g}_{n}(0,u)|_{p}^{p} < (\rho_{0}')^{p} < (\rho_{n})^{p}, \quad |\nabla \overline{g}_{n}(1,u)|_{p}^{p} > (\rho_{n})^{p}, \\ I(\overline{g}_{n}(0,u)) < \max\{\beta_{0},\beta_{n}\}, \qquad I(\overline{g}_{n}(1,u)) < \beta_{n}, \end{cases}$$
(5.5)

for all $u \in S_r(c) \cap V_n$. Now we define

$$\Gamma_n := \{ g \in C([0,1] \times (S_r(c) \cap V_n), S_r(c)) : g(t,-u) = -g(t,u), \\
g(0,u) = \overline{g}_n(0,u), g(1,u) = \overline{g}_n(1,u), \forall u \in (S_r(c) \cap V_n) \}.$$
(5.6)

Clearly $\overline{g}_n \in \Gamma_n$. We introduce the following linking property:

~

Lemma 5.4. ([21], Lemma 2.3) For each $g \in \Gamma_n$, there exists $(t, u) \in [0, 1] \times (S_r(c) \cap V_n)$ such that $g(t, u) \in B_n$.

Following Lemma 5.4, we have

Lemma 5.5. For each $n \in \mathbb{N}^+$,

$$\gamma_n(c) := \inf_{g \in \Gamma_n(t,u) \in [0,1] \times (S_r(c) \cap V_n)} I(g(t,u)) \ge \beta_n.$$

On the other hand, $\forall g \in \Gamma_n, \forall u \in S_r(c) \cap V_n$, by (5.5), we have

$$|\nabla g(0,u)|_p = |\nabla \overline{g}_n(0,u)|_p < \rho'_0 < \rho_n,$$

$$|\nabla g(1,u)|_p = |\nabla \overline{g}_n(1,u)|_p > \rho_n > \rho_0.$$

By the continuity of $|\nabla g(t, u)|_p$ with respect to t, there exits $t \in (0, 1)$ such that $|\nabla g(t, u)|_p = \rho_0$. Then $\max_{(t,u)\in[0,1]\times(S_r(c)\cap V_n)} I(g(t, u)) \ge \beta_0$. Since $g \in \Gamma_n$ is arbitrary, we deduce that

$$\gamma_n(c) \ge \beta_0 > 0. \tag{5.7}$$

Fix an arbitrary $n \in \mathbb{N}^+$ from now on. We adopt the approach developed by Jeanjean[22]. First, we introduce the auxiliary functional

$$\tilde{I}: S_r(c) \times \mathbb{R} \to \mathbb{R}, (u, \theta) \to I(k(u, \theta)),$$

where $k(u, \theta)$ is given in (5.1). Set

$$\tilde{\Gamma}_n := \{ \tilde{g} \in C([0,1] \times (S_r(c) \cap V_n), S_r(c) \times \mathbb{R}) : \tilde{g}(t,-u) = -\tilde{g}(t,u), \\ k(\tilde{g}(0,u)) = \overline{g}_n(0,u), k(\tilde{g}(1,u)) = \overline{g}_n(1,u), \forall u \in (S_r(c) \cap V_n) \},$$

$$(5.8)$$

and

$$\tilde{\gamma}_n(c) := \inf_{\tilde{g} \in \tilde{\Gamma}_n(t,u) \in [0,1] \times (S_r(c) \cap V_n)} \tilde{I}(\tilde{g}(t,u)),$$

we have

Lemma 5.6.

$$\tilde{\gamma}_n(c) = \gamma_n(c).$$

Proof. It follows immediately from the definition of $\tilde{\gamma}_n(c)$ and $\gamma_n(c)$ along with the fact that the maps

$$\varphi: \Gamma_n \to \tilde{\Gamma}_n, g \to \varphi(g) := (g, 0)$$

Lemma 5.7. There exists a Palais-Smale sequence $\{u_k\} \subset S_r(c)$ for $I|_{S_r(c)}$ at level $\gamma_n(c)$ such that

$$P(u_k) \to 0$$
, as $k \to +\infty$.

Proof. Our proof is similar to the Lemma 6.8 of [19], so we omit it.

Lemma 5.8. Let $\{u_k\} \subset S_r(c)$ be the Palais-Smale sequence obtained in Lemma 5.7. Then there exist $u \in W_r^{1,p}(\mathbb{R}^3)$ and $\{\lambda_k\} \subset \mathbb{R}$ such that up to a subsequence, as $k \to +\infty$

$$\begin{aligned} &(i) \ u_{k} \rightharpoonup u \neq 0 \ in \ W_{r}^{1,p}(\mathbb{R}^{3}); \\ &(ii) \ \lambda_{k} \to \lambda < 0 \ in \ \mathbb{R}; \\ &(iii) \ |\nabla u_{k}|_{p} \to |\nabla u|_{p}; \\ &(iv) \ -(a+b|\nabla u_{k}|_{p}^{p}) \Delta_{p} u_{k} - |u_{k}|^{q-2} u_{k} - \lambda_{k} \ |u_{k}|^{p-2} \ u_{k} \to 0 \ in \ \left(W_{r}^{1,p}(\mathbb{R}^{3})\right)'; \\ &(v) \ -(a+b|\nabla u|_{p}^{p}) \Delta_{p} u - |u|^{q-2} u - \lambda \ |u|^{p-2} \ u = 0 \ in \ \left(W_{r}^{1,p}(\mathbb{R}^{3})\right)'; \\ &(vi) \ u_{k} \to u \ in \ W_{r}^{1,p}(\mathbb{R}^{3}). \end{aligned}$$

Proof. Since $I(u_k) \to \gamma_n(c)$ and $P(u_k) \to 0$ as $k \to +\infty$, we have

$$\gamma_n(c) = I(u_k) + o(1)$$

= $I(u_k) - \frac{p}{3(q-p)}P(u_k) + o(1)$
= $a\left(\frac{1}{p} - \frac{p}{3(q-p)}\right)|\nabla u_k|_p^p + b\left(\frac{1}{2p} - \frac{p}{3(q-p)}\right)|\nabla u_k|_p^{2p} + o(1).$

Thus $\{u_k\}$ is bounded in $W_r^{1,p}(\mathbb{R}^3)$. So, up to a subsequence, there exist $u \in W_r^{1,p}(\mathbb{R}^3)$ such that

If u = 0, we have $|u_k|_q^q = o(1)$. Thus we obtain $|\nabla u_k|_p^p = o(1)$ because $P(u_k) = o(1)$. As a consequence, $I(u_k) = o(1)$, which contradicts with (5.7). Thus (i) is obtained. By Lemma 2.4, we have

$$\leq \lim_{k \to +\infty} \frac{1}{c^p} \left(a |\nabla u_k|_p^p + b |\nabla u_k|_p^{2p} - \frac{3(q-p)}{qp} |u_k|_q^q \right)$$

$$= \lim_{k \to +\infty} \frac{1}{c^p} P(u_k)$$

$$= 0.$$
(5.11)

Since $|u_k|_q^q \to |u|_q^q \neq 0$, we obtain $\lambda < 0$. Thus (ii) is proved. Next we prove that (iii) holds. Suppose that $\lim_{k \to +\infty} |\nabla u_k|_p^p = A \ge 0$. Then, from (ii) and (iv), we have

Combining (5.15) with (5.16), we obtain

Since $\lambda < 0$, by the weakly lower semicontinuity of norm, we obtain

Thus (iii) is proved and (v) is easily deduced by (5.14) and (5.17). Finally, by (5.9) and (5.17), we have $u_k \to u$ in $W_r^{1,p}(\mathbb{R}^3)$ as $k \to +\infty$.

Proof of Theorem 1.4. By Lemma 5.8, we get that for any fixed c > 0, (1.1)-(1.2) has a sequence of couples of normalized solutions $\{(u_n, \lambda_n)\} \subset S_r(c) \times \mathbb{R}^-$ with $I(u_n) = \gamma_n(c)$ for each $n \in \mathbb{N}^+$. By Lemma 2.2, we know that $P(u_n) = 0$ for each $n \in \mathbb{N}^+$. Thus we have

$$\gamma_n(c) = I(u_n) = I(u_n) - \frac{p}{3(q-p)} P(u_n) = a \left(\frac{1}{p} - \frac{p}{3(q-p)}\right) |\nabla u_n|_p^p + b \left(\frac{1}{2p} - \frac{p}{3(q-p)}\right) |\nabla u_n|_p^{2p} .$$

Next, we study the asymptotic behavior of solutions obtained in Theorem 1.4 when $b \to 0^+$. Fix a c > 0 from now on. Since b is a variable in this case, we replace I, P, $\gamma_n(c)$ by I_b , P_b , $\gamma_n^b(c)$, respectively.

For b > 0, we denote $\{(u_n^b, \lambda_n^b)\} \subset S_r(c) \times \mathbb{R}^-$ as a sequence of couples of weak solutions which we obtained in Theorem 1.4. Then, it follows that, for any $n \in \mathbb{N}^+$,

$$I_b(u_n^b) = \gamma_n^b(c). \tag{5.18}$$

Recalling the proof of Lemma 5.2, we see that β_n is independent of b. Thus, we have

Proof of Theorem 1.5. Firstly, we claim that for any $\{b_m\} \to 0^+(m \to +\infty)$, $\{(u_n^{b_m}\}_{m \in \mathbb{N}^+} \subset S_r(c) \text{ is bounded in } W_r^{1,p}(\mathbb{R}^3)$. Without loss of generality, we suppose that $b_m \leq 1$ for any $m \in \mathbb{N}^+$. Since V_n is finite-dimensional, we obtain that for each $n \in \mathbb{N}^+$,

Since $\{(u_n^{b_m}, \lambda_n^{b_m})\} \subset S_r(c) \times \mathbb{R}^-$ is a sequence of couples of weak solutions to (1.1)-(1.2) with $b = b_m$ and

$$\lambda_n^{b_m} = \frac{1}{c^p} \left(a |\nabla u_n^{b_m}|_p^p + b_m |\nabla u_n^{b_m}|_p^{2p} - |u_n^{b_m}|_q^q \right).$$
(5.20)

By Lemma 2.3, we deduce that $P_{b_m}(u_n^{b_m}) = 0$. Then

$$\begin{split} \gamma_n^{b_m}(c) &= I_{b_m}(u_n^{b_m}) = I_{b_m}(u_n^{b_m}) - \frac{p}{3(q-p)} P_{b_m}(u_n^{b_m}) \\ &= a \left(\frac{1}{p} - \frac{p}{3(q-p)} \right) \left| \nabla u_n^{b_m} \right|_p^p + b \left(\frac{1}{2p} - \frac{p}{3(q-p)} \right) \left| \nabla u_n^{b_m} \right|_p^{2p}, \end{split}$$

Combining $P_{b_m}(u_n^{b_m}) = 0$ with (5.20), $\{\lambda_n^{b_m}\}$ is bounded in \mathbb{R} . Then there exists a subsequence of $\{b_m\}$, still denoted by $\{b_m\}$, and $\lambda_n^0 \leq 0$ such that as $m \to +\infty$, $\lambda_n^{b_m} \to \lambda_n^0$ and

$$\begin{cases} u_n^{b_m} \rightharpoonup u_n^0, & \text{in } W_r^{1,p}(\mathbb{R}^3), \\ u_n^{b_m} \rightarrow u_n^0, & \text{in } L^q(\mathbb{R}^3), \\ u_n^{b_m}(x) \rightarrow u_n^0(x), & \text{a.e. in } \mathbb{R}^3. \end{cases}$$
(5.21)

Since $\{(u_n^{b_m}, \lambda_n^{b_m})\}$ is a sequence of couples of weak solutions to (1.1)-(1.2), by $b_m \to 0$ and $\lambda_n^{b_m} \to \lambda_n^0$ as $m \to +\infty$, we have

$$-a\Delta_{p}u_{n}^{b_{m}} - |u_{n}^{b_{m}}|^{q-2}u_{n}^{b_{m}} - \lambda_{n}^{0}|u_{n}^{b_{m}}|^{p-2}u_{n}^{b_{m}} = o_{m}(1).$$
(5.22)

Similar to the proof of Theorem 1.1, we can get, as $m \to +\infty$,

$$\nabla u_n^{b_m}(x) \to \nabla u_n^0(x), \text{a.e.in } \mathbb{R}^3.$$
 (5.23)

In view of the uniqueness of weak limit, using Proposition 5.4.7 of [23], by (5.21), (5.22) and (5.23), we have

$$-a\Delta_p u_n^0 - |u_n^0|^{q-2} u_n^0 - \lambda_n^0 |u_n^0|^{p-2} u_n^0 = 0.$$
(5.24)

By (5.22) and (5.24), we have

If $\lambda_n^0 = 0$, by (5.24), u_n^0 is a weak solution to $-a\Delta_p u_n^0 = |u_n^0|^{q-2}u_n^0$. By the Nehari and Pohozaev identities, we infer that $u_n^0 = 0$. Then, by (5.21), (5.26), as $m \to +\infty$, we have

6 Proof of Theorem 1.6 and Theorem 1.8

Proof of Theorem 1.6. (1) Since $q , we can easily check that <math>f_q(t)$ $(0, +\infty)$ attains its minimum at a unique point, denoted by t_q . Therefore, similar to (3.1), by Lemma 2.1, we obtain

$$i(c) = \prod_{u \in S(c)} I(u) \ge \inf_{t > 0} f_q(t) = f_q(t_q),$$
(6.1)

by setting $t = |\nabla u|_p^p$. On the other hand, set

$$u_{\mu}(x) = \frac{c\mu^{\frac{3}{p}}}{|Q|_p}Q(\mu x),$$

where $\mu > 0$ will be determined later. Then, $u_{\mu} \in S(c)$ and

Choosing $\mu = \frac{t_q^{\frac{1}{p}}}{c}$, i.e., $(c\mu)^p = t_q$, it follows from (6.2) that $i(c) \leq I(u_\mu) = f_q(t_q)$. Together with (6.1), we deduce that

$$i(c) = f_q(t_q) = \inf_{t>0} f_q(t), \tag{6.3}$$

and $u_c = u_{\mu}$ with $\mu = \frac{t_q^{\frac{1}{p}}}{c}$ is a minimizer of i(c).

Next, we show that, up to translations, u_c is the unique minimizer of i(c). Indeed, if $u_0 \in S(c)$ is a minimizer, it then follows from (3.1) that $I(u_0) \ge f_q(t_0)$, with $t_0 = |\nabla u_0|_p^p$, where the equality holds if and only if u_0 is an optimizer of (2.1). This and (6.3) imply that $t_0 = t_p$ and $f_q(t_0) = I(u_0)$. Thus, by Lemma 2.1, up to translations, u_0 must be the form of $u_0 = \alpha Q(\beta x)$. Using $|u_0|_p^p = c^p$, $|\nabla u_0|_p^p = t_q$ and (3.3), we obtain that $\alpha = \frac{c}{|Q|_P} \left(\frac{t_q^{\frac{1}{p}}}{c}\right)^{\frac{3}{p}}$ and $\beta = \frac{t_q^{\frac{1}{p}}}{c}$. Hence, $u_0 = u_c$.

(2) When $q = p + \frac{p^2}{3}$,

$$f_q(t) = \frac{1}{p} \left(a - \frac{c^{\frac{p^2}{3}}}{p|Q|_p^{\frac{p^2}{3}}} \right) t + \frac{b}{2p} t^2.$$

If $c \leq a^{\frac{3}{p^2}} |Q|_p$, by Theorem 1.1, i(c) has no minimizer. If $c > a^{\frac{3}{p^2}} |Q|_p$, from (6.4), we know that $f_q(t)$ $(t \in (0, +\infty))$ attains its minimum at the unique point $t_q = \frac{c^{\frac{p^2}{3}} - ap|Q|_p^{\frac{p^2}{3}}}{bp|Q|_p^{\frac{p^2}{3}}}$. Similar to the arguments

of parts (1), we can prove that up to translations $u_c = \frac{c\mu^{\frac{3}{p}}}{|Q|_p}Q(\mu x)$ with $\mu = \frac{t_q^{\frac{1}{p}}}{c}$ is the unique minimizer of i(c). Moreover, we have $i(c) = -\frac{b}{c}\left(\frac{c^{\frac{p^2}{3}} - ap|Q|_p^{\frac{p^2}{3}}}{c}\right)^2$.

. Moreover, we have $i(c) = -\frac{1}{2p} \left(\frac{\frac{1}{2p} - \frac{1}{2p}}{bp|Q|_p^{\frac{p^2}{3}}} \right)$.

Froof of Theorem 1.8. Firstly, similar to Lemma 5.3, from Definition 1.7, we can prove that there exists K(c) > 0 which can be chosen small enough such that, $I(\cdot)$ admits mountain pass geometry on S(c) if (1.12) holds. We assume that $K(c) < \bar{t}_q$.

For any $h(s) \in \Gamma(c)$, by Lemma 2.1, we have

$$I(h(s)) \ge f_q(|\nabla h(s)|_p^p),\tag{6.5}$$

where equality holds if and only if $h(s) \in S(c)$ is an optimizer of (2.1), i.e., up to translations,

$$(h(s))(x) = \frac{c\mu^{\frac{3}{p}}}{|Q|_{p}}Q(\mu x) \text{ for some } \mu > 0.$$

Since $h(0) \in A_{K(c)}$ with $K(c) < \overline{t}_q$, and note that $f_q(t) > 0$ for any $t \in (0, \overline{t}_q]$, we have

By the continuity of $|\nabla h(s)|_p^p$ respect to s, we deduce from (6.5) and (6.7) that

Thus,

On the contrary, let $u_{\mu}(x) = \frac{c\mu^{\frac{3}{p}}}{|Q|_{p}}Q(\mu x)$ with $\mu = \overline{\mu}_{q} = \frac{\overline{t}_{q}^{\frac{1}{p}}}{c}$. Set $\overline{h}(s) := s^{\frac{3}{p^{2}}}u_{\mu}(s^{\frac{1}{p}}x)$, then we can check that $|\nabla \overline{h}(s)|_{p}^{p} = \overline{t}_{q}s$ and $I(\overline{h}(s)) = f_{q}(\overline{t}_{q}s)$. Choosing $0 < \tilde{t}_{q} < \overline{t}_{q}$ small enough such that $\overline{h}\left(\frac{\overline{t}_{q}}{\overline{t}_{q}}\right) \in A_{K(c)}$, and $\hat{t}_{q} > \overline{t}_{q}$ such that $I\left(\overline{h}\left(\frac{\overline{t}_{q}}{\overline{t}_{q}}\right)\right) = f_{q}(\hat{t}_{q}) < 0$. Let $h(s) = \overline{h}\left((1-s)\frac{\overline{t}_{q}}{\overline{t}_{q}} + s\frac{\overline{t}_{q}}{\overline{t}_{q}}\right)$. Then, $h(0) = \overline{h}\left(\frac{\overline{t}_{q}}{\overline{t}_{q}}\right) \in A_{K(c)}$ and $I(h(1)) = I\left(\overline{h}\left(\frac{\overline{t}_{q}}{\overline{t}_{q}}\right)\right) = f_{q}(\hat{t}_{q}) < 0$. This indicates that $h \in \Gamma(c)$, and

$$\gamma(c) \le \max_{s \in [0,1]} I(h(s)) = I(u_{\overline{\mu}_q}) = f_q(\overline{t}_q).$$

Combining with (6.9), we deduce that $\gamma(c) = f_q(\bar{t}_q)$ and $\bar{u}_c = u_\mu(x) = \frac{c \left(\frac{\bar{t}_q^1}{c}\right)^{\frac{p}{p}}}{|Q|_p} Q\left(\frac{\bar{t}_q^1}{c}x\right) \in S(c)$ is a solution of problem (1.11).

Next, we prove that \overline{u}_c satisfies (1.1)-(1.2) for some $\lambda \in \mathbb{R}^-$. In view of $f'_q(\overline{t}_q) = 0$ and $|\nabla \overline{u}_c|_p^p = \overline{t}_q$, we have

$$\frac{3(q-p)c^{q-\frac{3(q-p)}{p}}}{p^2|Q|_p^{q-p}}(\bar{t}_q)^{\frac{3(q-p)}{p^2}-1} = a + b\bar{t}_q = a + b|\nabla \bar{u}_c|_p^p.$$
(6.10)

Moreover, since Q(x) is a solution of (2.2), by $\overline{u}_c = \frac{c\left(\frac{\overline{t}_q^{\frac{1}{p}}}{c}\right)^p}{|Q|_p} Q\left(\frac{\overline{t}_q^{\frac{1}{p}}}{c}x\right)$, it follows that \overline{u}_c satisfies

$$-\frac{3(q-p)c^{q-\frac{3(q-p)}{p}}}{p^2|Q|_p^{q-p}}(\bar{t}_q)^{\frac{3(q-p)}{p^2}-1}\Delta_p\overline{u}_c - |\overline{u}_c|^{q-1}\overline{u}_c$$
$$= -\left(1 + \frac{(p-3)(q-p)}{p^2}\right)\frac{c^{(q-p)(1-\frac{3}{p})}}{|Q|_p^{q-p}}(\bar{t}_q)^{\frac{3(q-p)}{p^2}}|\overline{u}_c|^{p-1}\overline{u}_c.$$

This together with (6.10) indicates that \overline{u}_c is a solution of (1.1)-(1.2) with

$$\lambda = -\left(1 + \frac{(p-3)(q-p)}{p^2}\right) \frac{c^{(q-p)(1-\frac{3}{p})}}{|Q|_p^{q-p}} (\bar{t}_q)^{\frac{3(q-p)}{p^2}}.$$
