Global existence and blow-up for the variable coefficient Schrödinger equations with a linear potential [∗]

Abstract

In this paper, we study a class of variable coefficient Schrödinger equations with a linear potential

 $i\partial_t u + \nabla \cdot (|x|^b \nabla u) - V(x)u = -|x|^c |u|^p u,$

where $2 - n < b \le 0$, $c \ge b - 2$ and $0 < \mathbf{p}_c \le (2 - b)(p + 2)$, where $\mathbf{p}_c := np - 2c$. In the radial or finite variance case, we firstly prove the global existence and blow-up below the ground state threshold for the mass-critical and inter-critical nonlinearities. Next, adopting the variational method of Ibrahim-Masmoudi-Nakanishi [\[23\]](#page-37-0), we obtain a sufficient condition on the nonradial initial data, under which the global behavior of the general solution is established.

1 Introduction

In this paper, we consider the Cauchy problem for the variable coefficient Schrödinger equation with a linear potential $(INLS_{b,V}$ for short)

$$
\begin{cases}\ni\partial_t u + \nabla \cdot (|x|^b \nabla u) - V(x)u = -|x|^c |u|^p u, & (x, t) \in \mathbb{R}^n \times [0, +\infty), \\
u(x, 0) = u_0(x), & (1.1)\n\end{cases}
$$

where $u: \mathbb{R}^n \times [0, +\infty) \to \mathbb{C}, 2-n < b < 2, c \ge b-2, 0 < \mathbf{p}_c := np-2c \le (2-b)(p+2)$ and the potential $V(x) \geq 0$. The INLS_{b,V} appears in the study of standing waves problem for the following degenerate elliptic equation:

$$
\nabla \cdot (|x|^b \nabla \phi) - V(x)\phi = -|x|^c |\phi|^p \phi,
$$

of which the properties of nontrivial solution have attracted a lot of interests from the mathematical community (see e.g. $[5]$, $[16]$, $[18]$, $[26]$ - $[28]$, $[30]$ and references therein).

We define the functional adapted to the Schrödinger operator

$$
\mathcal{A}_{b,V} := -\nabla \cdot (|x|^b \nabla) + V(x)
$$

by

$$
||u||_{\dot{H}_{b,V}^1}^2 := \langle A_{b,V}u, u \rangle = \int (|x|^b |\nabla u|^2 + V(x)|u|^2) dx.
$$

The INLS_b (case $V = 0$) enjoys a scaling invariance under the scaling $u \mapsto u_\lambda$, where

$$
u_{\lambda}(x,t) := \lambda^{\frac{2-b+c}{p}} u(\lambda x, \lambda^{2-b}t), \quad \lambda > 0.
$$
 (1.2)

A direct calculation gives

$$
||u_{\lambda}(\cdot,0)||_{\dot{H}^{s}} = \lambda^{s+\frac{2-b+c}{p} - \frac{n}{2}} ||u_{0}||_{\dot{H}^{s}},
$$

which shows that [\(1.2\)](#page-1-0) leaves the the usual homogeneous Sobolev \dot{H}^{s_c} -norm of the initial data invariant with the critical Sobolev index

$$
s_c := \frac{n}{2} - \frac{2-b+c}{p}.
$$

The mass-critical case corresponds to $s_c = 0$ (equivalently $p_c = 2(2 - b)$); The energycritical case corresponds to $s_c = \frac{2-b}{2}$ (equivalently $p_c = (2-b)(p+2)$). The intercritical case corresponds to $s_c \in (0, \frac{2-b}{2})$ (equivalently $p_c \in (2(2-b), (2-b)(p+2))$). For later uses, it is convenient to introduce the following exponent:

$$
\sigma := \frac{2 - b - 2s_c}{2s_c} = \frac{(2 - b)(p + 2) - p_c}{p_c - 4 + 2b}.
$$
\n(1.3)

The main purpose of the present paper is to study long time dynamics (global existence, finite or infinite time blow-up) of the radial and non-radial solutions to the INLS_{b,V}. Since $a(x) = |x|^b$ with $b < 0$ can be singular at $x = 0$, the local well-posedness analysis of the $INLS_{b,V}$ is more subtle and intricate in several aspects, for example the energy space associated with $\mathcal{A}_{b,V}$ is no longer usual Sobolev space, and Strichartz estimate arguments fails. To our aim, we take the LWP in $W_b^{1,2}$ $b^{t,2}$ related to the INLS_{b,V}

as an assumption when necessary and build part of our conditional result upon it. This means that we always assume that for any $u_0 \in W_b^{1,2}$ $b^{1,2}$, the INLS_{b,V} admits a unique local solution u in $C([0,T^*); W_h^{1,2})$ $\binom{f_1, f_2}{b}$ with the maximal lifetime $0 < T^* < +\infty$. If

$$
\lim_{t \to T^*} \|\nabla u(t)\|_{b,2} = \infty,
$$

we call such u is the finite time (resp. infinite time) blow-up solution when $T^* < +\infty$ (resp. $T^* = +\infty$). In addition, the solutions to $INLS_{b,V}$ formally conserve their mass and energy (see e.g. [\[3\]](#page-36-1)),

$$
M(u(t)) := \int |u|^2 dx = M(u_0), \tag{1.4}
$$

$$
E_{b,V}(u(t)) := \frac{1}{2} \|\nabla u\|_{b,2}^2 + \frac{1}{2} \int V(x)|u|^2 dx - \frac{1}{p+2} \|u\|_{c,p+2}^{p+2} = E_{b,V}(u_0). \tag{1.5}
$$

Let us review some recent development for the INLS_{b,V}. When $b = 0$ and $V = 0$, (1.1) reduces to the inhomogeneous nonlinear Schrödinger equation (INLS)

$$
i\partial_t u + \Delta u = -|x|^c |u|^p u.
$$

In this case, the local well-posedness in $H¹$ of the solutions were established by Geneoud-Stuart [\[13\]](#page-37-4), whose proof makes use of the energy method developed by Cazenave [\[4\]](#page-36-2). See also [\[14\]](#page-37-5) for other proof based on Strichartz estimates argument. In the mass-critical case, Genoud [\[12\]](#page-36-3) showed that the INLS with $\max\{-2, -n\} < c < 0$ is globally well-posedness in H^1 by assuming $u_0 \in H^1$ and $||u_0||_2 < ||\mathcal{Q}||_2$, where $\mathcal Q$ is the unique positive radial solution to the elliptic equation

$$
\Delta \mathcal{Q} - \mathcal{Q} + |x|^c |\mathcal{Q}|^p \mathcal{Q} = 0.
$$

This result was also extended by Farah [\[10\]](#page-36-4) to the intercritical case, and he also showed that the solution blows up in finite time (see also [\[7\]](#page-36-5)).

When $b = 0$ and $V \neq 0$, the global existence and blow-up for the INLS_V equation

$$
i\partial_t u + \Delta u - Vu = -|x|^c |u|^p u
$$

were already extensively studied in recent years. Under the assumptions that $V \in$ $\mathcal{K}_0 \cap L^{\frac{3}{2}}$ and $||V_-||_{\mathcal{K}} := \sup_{x \in \mathbb{R}^3} \int \frac{|V_-(y)|}{|x-y|}$ $\frac{\sqrt{V-(y)}}{|x-y|}dy < 4\pi$, Hong [\[22\]](#page-37-6) studied the INLS_V and established the local well-posedness in $H¹$. In case $c = 0$, Hamano-Ikeda [\[21\]](#page-37-7) proved that the intercritical INLS_V in three dimension with $V ">= 0, L^{\frac{3}{2}} ">= x \cdot \nabla V " \leq 0$ is globally well-posed in H^1 if $u_0 \in H^1$ and satisfies

$$
E_V(u_0)M(u_0)^{\delta_c} < E_0(Q)M(Q)^{\delta_c}, \quad \|\nabla u_0\|_2 \|u_0\|_2^{\delta_c} < \|\nabla Q\|_2 \|\mathcal{Q}\|_2^{\delta_c},
$$

where $\delta_c := \frac{1-\beta_c}{\beta_c}$ with $\beta_c := \frac{3}{2} - \frac{2}{p}$. They also proved that if $2V + x \cdot \nabla V \ge 0$,

$$
E_V(u_0)M(u_0)^{\delta_c} < E_0(Q)M(Q)^{\delta_c}, \quad \|\nabla u_0\|_2 \|u_0\|_2^{\delta_c} > \|\nabla Q\|_2 \|\mathcal{Q}\|_2^{\delta_c},
$$

and, in addition, either $|x|u_0 \in L^2$ or u_0 is radial, then the solution blows up in finite time. Recently, the global existence and blow-up criteria for $INLS_V$ in inhomogeneous case $-1 < c < 0$ were also studied by Guo-Wang-Yao [\[19\]](#page-37-8) (case $p = 2$) and Dinh [\[6\]](#page-36-6) (case $\frac{4+2c}{3} < p < 4+2c$). More results on other type of potential have also been addressed, see e.g. Killip-Murphy-Visan-Zheng [\[25\]](#page-37-9), Dinh-Keraani [\[8\]](#page-36-7), An-Kim-Jang [\[1\]](#page-36-8) for the inverse-power potential $V(x) = \frac{d}{|x|^{\sigma}}$, or Gustafson-Inui [\[20\]](#page-37-10), Ikeda-Inui [\[24\]](#page-37-11) for repulsive delta potential.

As we see, the global existence and blow-up for the INLS or INLS_V equations have been studied extensively, of which the dispersion coefficient are both $b = 0$. While when $b \neq 0$, the more general variable coefficient Schrödinger equation [\(1.1\)](#page-0-0) or even for $V = 0$ is less understood. Such problem become more subtle in the presence of the dispersion coefficient $|x|^b$. Motivated by the aforementioned works, we are mainly interested in studying the global existence and blow-up behavior for the focusing $INLS_{b,V}$ in case with $2 - n < b < 2$ and $2(2 - b) \le \mathbf{p}_c < (2 - b)(p + 2)$.

In this paper, we pose some additional assumptions on the potential $V(x)$ as follows:

(I) $V(x) \ge 0$, $x \cdot \nabla V + (2 - b)V \ge 0$; (II) $x \cdot \nabla V \in L^{\frac{n}{2}}(\mathbb{R}^n; |x|^{-\frac{nb}{2}}dx);$ (III) $x \cdot \nabla V \leq 0$; $\overline{(\text{IV})}$ $x \cdot \nabla^2 V x^T < -(3-b)x \cdot \nabla V;$

where $\nabla^2 V$ is the Hessian matrix of V.

Our first goal here is to establish a sufficient condition for the global existence and blow-up of $W_h^{1,2}$ $b^{1,2}$ -solution to the INLS_{b,V} for radial or finite variance initial data.

Theorem 1.1. (*Mass-critical case*) Let $n \geq 3$, $2-n < b \leq 0$, $c \geq b-2$, $\mathbf{p}_c = 2(2-b)$ and let $V(x)$ satisfy (I). Suppose u is the solution to the INLS_{b,V} with initial data $u_0\in W_b^{1,2}$ $\stackrel{.1,2}{b}$.

(i) If $||u_0||_2 < ||Q_1||_2$ and u_0 is radial, where Q_1 is the ground state of the following elliptic equation

$$
\nabla \cdot (|x|^b \nabla Q_\omega) - \omega Q_\omega + |x|^c |Q_\omega|^p Q_\omega = 0 \tag{1.6}
$$

with $\omega = 1$, then u exists globally and $\sup_{t \in [0, +\infty)} ||u||_{W_b^{1,2}} < \infty$;

(ii) If $E_{b,V}(u_0) < 0$ and $u_0 \in L^2(|x|^{2-b}dx)$, then the solution u blows up in finite time.

Theorem 1.2. (Intercritical case) Let $n \geq 3$, $2 - n < b \leq 0$, $c \geq b - 2$, $2(2 - b) <$ $\mathbf{p}_c \leq (2-b)(p+2)$ and let $V(x)$ satisfy (I)-(II). Let $u(t)$ be the solution to the INLS_{b,V} with initial data $u_0 \in W_h^{1,2}$ $b^{1,2}$ and $E_{b,V}(u_0)M(u_0)^{\sigma} < E_b(Q_1)M(Q_1)^{\sigma}$.

(i) If $||u_0||_{\dot{H}_{b,V}^1} ||u_0||_2^{\sigma} < ||\nabla Q_1||_{b,2} ||Q_1||_2^{\sigma}$ and u_0 is radial, then u exists globally and

$$
||u||_{\dot{H}_{b,V}^{1}}||u||_{2}^{\sigma} < ||\nabla Q_{1}||_{b,2}||Q_{1}||_{2}^{\sigma} \quad \text{for any } t \in [0,+\infty);
$$

(ii) If $||u_0||_{\dot{H}^1_{b,V}} ||u_0||_2^{\sigma} > ||\nabla Q_1||_{b,2} ||Q_1||_2^{\sigma}$, and either $u_0 \in L^2(|x|^{2-b}dx)$ or u_0 is radial (in this case, we further assume that $p < 4$), then the solution $u(t)$ blows up in finite time and

$$
||u||_{\dot{H}^{1}_{b,V}} ||u||_{2}^{\sigma} > ||\nabla Q_{1}||_{b,2} ||Q_{1}||_{2}^{\sigma} \quad \text{for any } t \in [0, T^{*}).
$$
 (1.7)

Remark 1.3. When u_0 is radial, the restriction $p < 4$ is added to control the nonlinear term \mathcal{R}_3 in the localized virial estimate (see Lemma [2.9\)](#page-13-0).

The main tools for proving Theorems [1.1](#page-3-0) and [1.2](#page-4-0) are the coercivity given by the virial identities related to the following virial functional

$$
P(u) := \|\nabla u\|_{b,2}^2 - \frac{1}{2-b} \int (x \cdot \nabla V)|u|^2 dx - \frac{\mathbf{p}_c}{(2-b)(p+2)} \|u\|_{c,p+2}^{p+2}
$$
(1.8)

and sharp radial Gagliardo-Nirenberg type estimate. How to derive the uniform bounds of the functional P in the presence of space-dependent coefficient $|x|^{b}$ and the term $x \cdot \nabla V$ is the main difficulty we encounter. For this reason, our argument will be more complicated.

In the second part, we aim to extend the global existence and blow-up properties to the $INLS_{b,V}$ with general initial data (not necessarily radial or finite variance). It is conjectured that if a general solution to the $INLS_{b,V}$ satisfies

$$
\sup_{t \in [0,T^*)} P(u) \le -\delta,\tag{1.9}
$$

then it blows up. However, there is no affirmative answer on this conjecture up to data for the INLS_{b,V}. To overcome it, we will replace the threshold $E_b(Q_1)M(Q_1)^\sigma$ in Theorem [1.2](#page-4-0) and classify the initial data by using the ground state Q_{ω} to the elliptic equation [\(1.6\)](#page-3-1), which mainly adopts the variational method of Ibrahim-Masmoudi-Nakanishi [\[23\]](#page-37-0).

To state it, we introduce several notations now. We define the action functional

$$
S_{\omega,V}(\phi) := E_{b,V}(\phi) + \frac{\omega}{2} M(\phi)
$$

= $\frac{1}{2} ||\nabla \phi||_{b,2}^2 + \frac{1}{2} \int V(x) |\phi|^2 dx + \frac{\omega}{2} ||\phi||_2^2 - \frac{1}{p+2} ||\phi||_{c,p+2}^{p+2}.$ (1.10)

By a scaling transformation $\phi \mapsto \phi_{\lambda}^{\alpha,\beta}$ $_{\lambda}^{\alpha,\beta}$, where

$$
\phi^{\alpha,\beta}_{\lambda}(x) := e^{\alpha\lambda}\phi(e^{\beta\lambda}x), \quad x \in \mathbb{R}^n,
$$
\n(1.11)

we define the first order derivative of $S_{\omega,V}(\phi^{\alpha,\beta}_{\lambda})$ $\chi_{\lambda}^{\alpha,\beta}$ at $\lambda = 0$ by $K_{\omega,V}^{\alpha,\beta}(\phi)$

$$
K_{\omega,V}^{\alpha,\beta}(\phi) := \frac{\partial}{\partial \lambda} S_{\omega,V}(\phi_{\lambda}^{\alpha,\beta}) \mid_{\lambda=0}
$$

=
$$
\frac{2\alpha + (2 - b - n)\beta}{2} \|\nabla \phi\|_{b,2}^{2} + \frac{2\alpha - n\beta}{2} (\int V(x)|\phi|^{2} dx + \omega \|\phi\|_{2}^{2})
$$

$$
-\frac{\beta}{2} \int (x \cdot \nabla V)|\phi|^{2} dx - \frac{\alpha(p+2) - (n+c)\beta}{p+2} \|\phi\|_{c,p+2}^{p+2}.
$$
 (1.12)

In particular, when $(\alpha, \beta) = (n, 2)$ and $(\alpha, \beta) = (1, 0)$,

$$
P(\phi) := \frac{1}{2 - b} K_{\omega, V}^{n,2}(\phi)
$$

= $\|\nabla \phi\|_{b,2}^2 - \frac{1}{2 - b} \int (x \cdot \nabla V) |\phi|^2 dx - \frac{P_c}{(2 - b)(p + 2)} ||\phi||_{c, p+2}^{p+2},$

$$
I_{\omega, V}(\phi) := K_{\omega, V}^{1,0}(\phi) = \|\nabla \phi\|_{b,2}^2 + \int V(x) |\phi|^2 dx + \omega ||\phi||_2^2 - ||\phi||_{c, p+2}^{p+2},
$$

where P is the virial functional defined in [\(1.8\)](#page-4-1), and $I_{\omega,V}$ is called Nehari functional.

For each $(\alpha, \beta) \in \mathbb{R}^2$ in the range

$$
\alpha > 0, \quad \beta \ge 0, \quad 2\alpha - n\beta \ge 0 \tag{1.13}
$$

and the elliptic equation [\(1.6\)](#page-3-1), we consider the following constrained minimizing problem for nonradial function

$$
m_{\omega,V}^{\alpha,\beta} = \inf \{ S_{\omega,V}(\phi) : \phi \in W_b^{1,2} \setminus \{0\}, \ K_{\omega,V}^{\alpha,\beta}(\phi) = 0 \}.
$$
 (1.14)

As in [\[33\]](#page-38-2), the minimizing problem $m_{\omega,\zeta}^{1,0}$ $\omega_{\mu,0}^{1,0}$ is proved to be attained by the ground state Q_{ω} . However, the more general case $m^{\alpha,\beta}_{\omega,0}$ $\alpha, \beta \atop \omega, 0$ for (α, β) satisfying (1.13) seems to be unknown in the study of stability analysis, which is essential in our proof of global existence and blow-up of the $INLS_{b,V}$.

In order to do so, we first investigate some properties of the ground state Q_{ω} and make a comparison on the minimization problems between $m_{\omega,0}^{\alpha,\beta}$ $_{\omega,0}^{\alpha,\beta}$ and $m_{\omega,V}^{\alpha,\beta}$.

Proposition 1.4. Let $n \geq 3$, $2 - n < b < 2$, $b - 2 < c \leq \min\{\frac{nb}{n-1}\}$ $\frac{nb}{n-2}, 0$, $\omega >$ 0, $2(2-b) < \mathbf{p}_c < (2-b)(p+2)$ and let (α, β) satisfy (1.13) .

(i) If $V = 0$, then $m_{\omega,0}^{\alpha,\beta}$ $\overset{\alpha, \beta}{\omega, 0}$ is attained by the ground state Q_{ω} of the elliptic equation $(1.6);$ $(1.6);$

(ii) If $V(x)$ satisfies (I) and (III), then $m^{\alpha,\beta}_{\omega,0} \leq m^{\alpha,\beta}_{\omega,V}$.

Proposition [1.4](#page-5-1) shows that $m^{\alpha,\beta}_{\omega,0}$ $\omega, 0, \omega, 0$ is independent of (α, β) . From now on, we express $m_{\omega,0}:=m_{\omega,0}^{\alpha,\beta}$ α, β for simplicity.

Now by defining two subsets in $W_h^{1,2}$ $b^{1,2}$ as follows:

$$
\mathcal{N}^+ = \{ \phi \in W_b^{1,2} : S_{\omega,V}(\phi) < m_{\omega,0}, \quad K_{\omega,V}^{n,2}(\phi) \ge 0 \} \tag{1.15}
$$

and

$$
\mathcal{N}^- = \{ \phi \in W_b^{1,2} : S_{\omega,V}(\phi) < m_{\omega,0}, \quad K_{\omega,V}^{n,2}(\phi) < 0 \},\tag{1.16}
$$

we prove the global existence and blow-up of the nonradial solution to the $INLS_{b,V}$, whose action is less than $m_{\omega,0}$.

Theorem 1.5. Let $n \geq 3$, $2 - n < b < 2$, $b - 2 < c \leq 0$, $\omega > 0$, $2(2 - b) < p_c <$ $(2-b)(p+2)$ and let $V(x)$ satisfy (I)-(IV). Let $u \in C([0,T^*);W_h^{1,2})$ $b^{1,2}$) be the local solution to the INLS_{b,V} with initial data $u_0 \in W_b^{1,2}$ $b^{1,2}$.

(i) If $u_0 \in \mathcal{N}^+$, then the solution exists globally and $u(t) \in \mathcal{N}^+$ for any $t \in [0, +\infty)$. (ii) If $u_0 \in \mathcal{N}^-$ and additionally

$$
c \le b \le 0, \qquad \mathbf{p}_c \le \frac{2c(2-b)}{b},
$$

then $u(t) \in \mathcal{N}^-$ for any $t \in [0,T^*)$ and one of the following finite/infinite time blow-up statement holds true:

(1) $T^* < +\infty$ and $\lim_{t \to T^*} ||\nabla u(t)||_{b,2} = +\infty;$

(2) $T^* = +\infty$ and there exists a time sequence $\{t_n\}$ such that $t_n \to +\infty$ and

$$
\lim_{n \to +\infty} \|\nabla u(t_n)\|_{b,2} = +\infty.
$$

Remark 1.6. There is a restriction $p_c \leq \frac{2c(2-b)}{b}$ for the blow-up. This restriction is due to the Hardy-Sobolev inequality in (2.15) .

As a byproduct of the above criteria, we unify the condition $u_0 \in \mathcal{N}^-$ with [\(1.17\)](#page-6-0), and obtain the following nonradial blow-up result for the $INLS_{b,V}$, which is a version independent of the frequency.

Corollary 1.7. Let n, b, c, p_c and $V(x)$ be the same as in Theorem [1.5](#page-6-1) (ii). Let u be the corresponding solution to the INLS_{b,V} with initial data $u_0 \in W_b^{1,2}$ $b^{1,2}$ and satisfying

$$
\begin{cases} E_{b,V}(u_0)M(u_0)^{\sigma} < E_b(Q_1)M(Q_1)^{\sigma}, \\ \|u_0\|_{\dot{H}_{b,V}^1} \|u_0\|_2^{\sigma} > \|\nabla Q_1\|_{b,2} \|Q_1\|_2^{\sigma}. \end{cases} \tag{1.17}
$$

Then either $T^* < +\infty$, or $T^* = +\infty$ and there exists a time sequence $t_n \to +\infty$ such that $\|\nabla u(t_n)\|_{b,2} \to +\infty$ as $n \to +\infty$.

This paper is organized as follows. In Section 2, we are devoted to preparatory materials, including the weighted Sobolev embedding and virial estimates adapted to the INLS_{b,V}. In Section 3, we prove the global existence and blow-up for the INLS_{b,V} with radial initial data given in Theorems [1.1](#page-3-0) and [1.2.](#page-4-0) In Section 4, we show the variational analysis given in Proposition [1.4.](#page-5-1) Finally, the global existence and blow-up for nonradial solution are given in Section 5.

Notations. We use $L^q(\mathbb{R}^n;\omega(x)dx)$ to denote the weighted Lebesgue space, which is defined via

$$
||u||_{L^q(\mathbb{R}^n; \ \omega(x)dx)} = (\int \omega(x)|u|^q dx)^{\frac{1}{q}}.
$$

To shorten formulas, we often abbreviate $L^q(\mathbb{R}^n; \omega(x)dx)$ by $L^q(\omega(x)dx)$, the norm $\|\cdot\|_{L^q(\mathbb{R}^n;|x|^a dx)}$ by $\|\cdot\|_{a,q}$. In particular, we denote $\|\cdot\|_q = \|\cdot\|_{0,q}$.

We also define by the weighted Sobolev space $W_a^{s,q}(\mathbb{R}^n)$ by the completion of $C_0^{\infty}(\mathbb{R}^n)$ with respect to the norm

$$
||u||_{W_a^{s,q}} = ||(-\Delta)^{\frac{s}{2}}u||_{a,q} + ||u||_q \text{ and } ||u||_{\dot{W}_a^{s,q}} = ||(-\Delta)^{\frac{s}{2}}u||_{a,q}.
$$

We make the usual modifications when q equals to 2. In particular, $H^s = W_0^{s,2}$ $\dot{H}^s =$ $\dot{W}_{0}^{s,2}$ $\int_0^{s,2}$, where H^s (or \dot{H}^s) are usual inhomogeneous (or homogeneous) Sobolev spaces. We denote $\delta_{ij} = 1$ if $i = j$ and 0 if $i \neq j$. If not specified, we use C_{α} to denote various constants which depend on α .

2 Preliminary

2.1 Key tools

The following sharp Gagliardo-Nirenberg inequality for radial functions $f \in W_h^{1,2}$ $b^{1,2}$ can be found in [\[31\]](#page-38-3).

Lemma 2.1. Let $2 - n < b \leq 0$ and let one of the following conditions

$$
b-2 \le c \le 0
$$
: $-2c < \mathbf{p}_c < (2-b)(p+2)$,
(2.1)

(2)
$$
c > 0
$$
:
$$
\frac{(2-b)p}{2} < \mathbf{p}_c < (2-b)(p+2)
$$
 (2.2)

holds. Then for any radial function $f \in W_h^{1,2}$ $b^{1,2}$, we have

$$
||f||_{c,p+2}^{p+2} \le C_{GN} ||\nabla f||_{b,2}^{\frac{\mathbf{p}_c}{2-b}} ||f||_2^{\frac{(2-b)(p+2)-\mathbf{p}_c}{2-b}}, \qquad (2.3)
$$

where $C_{GN} = \left(\frac{\omega \mathbf{p}_c}{(2-b)(p+1)}\right)$ $(2-b)(p+2)-p_c$ $\int_0^{1-\frac{\mathbf{p}_c}{2(2-b)}} \frac{(2-b)(p+2)}{p}$ $\frac{2-0(0+2)}{\mathbf{p}_c \|\mathcal{Q}_{\omega}\|_2^{\mathbf{p}}}$. The equality is attained by Q_{ω} , which is the ground state solution to the elliptic equation [\(1.6\)](#page-3-1).

Remark 2.2. (1) We also have the following Pohozaev's identities:

$$
||Q_{\omega}||_2^2 = \frac{(2-b)(p+2) - \mathbf{p}_c}{(2-b)(p+2)\omega} ||Q_{\omega}||_{c,p+2}^{p+2} = \frac{(2-b)(p+2) - \mathbf{p}_c}{\omega \mathbf{p}_c} ||\nabla Q_{\omega}||_{b,2}^2.
$$
 (2.4)

In particular, we have

$$
C_{GN} = \frac{(2-b)(p+2)}{\mathbf{p}_c} \left(\|\nabla Q_{\omega}\|_{b,2} \|Q_{\omega}\|_2^{\sigma} \right)^{2-\frac{\mathbf{p}_c}{2-b}}.
$$

(2) We note that the Gagliardo-Nirenberg inequality for nonradial functions $f \in$ $W_h^{1,2}$ b

$$
||f||_{c,p+2}^{p+2} \le C||\nabla f||_{b,2}^{\frac{p_c}{2-b}}||f||_2^{\frac{(2-b)(p+2)-\mathbf{p}_c}{2-b}}
$$
\n(2.5)

and $-n < c \leq 0$, $\mathbf{p}_c \leq (2 - b)(p + 2)$ can be derived from the celebrated Caffarelli-Kohn-Nirenberg inequality (see [\[2\]](#page-36-9)), which also occurred in [\[32\]](#page-38-4).

In the case where $\Omega \subset \mathbb{R}^n$ is bounded, the weighted Sobolev embedding lemma has been proved in [\[17\]](#page-37-12).

Lemma 2.3. Let $n \geq 3$ and let $\Omega \subset \mathbb{R}^n$ be an open bounded set. Assume that $b > 2-n$ and $b-2 < c \leq \frac{nb}{n-2}$. Then the embedding

$$
\dot{W}_b^{1,2}(\Omega) \hookrightarrow L^q(\Omega; |x|^c dx)
$$

is continuous provided $q \in \left[1, \frac{2n+2c}{n-2+l}\right]$ $\frac{2n+2c}{n-2+b}$, and this embedding is compact for $q \in \left[1, \frac{2n+2c}{n-2+b}\right]$ $\frac{2n+2c}{n-2+b}$).

Now we extend the above compact embedding lemma to the whole Euclidean space, which mainly adopts the idea in [\[32\]](#page-38-4). We include the proof for completeness.

Lemma 2.4. Let $n \geq 3$, $2 - n < b < 2$, $b - 2 < c \leq \frac{nb}{n-2}$ $\frac{nb}{n-2}$. If the function ω satisfies

$$
\limsup_{|x| \to 0} \frac{\omega(x)}{|x|^c} < \infty \quad \text{and} \quad \limsup_{|x| \to \infty} \frac{\omega(x)}{|x|^c} < \infty,
$$
\n(2.6)

then the following embedding

$$
W_b^{1,2} \hookrightarrow L^{p+2}(\omega(x)dx) \tag{2.7}
$$

is compact for all $2(2 - b) < p_c < (2 - b)(p + 2)$.

Proof. Let $\{f_n\}_{n\in\mathbb{N}}$ be a bounded sequence in $W_b^{1,2}$ $b^{1,2}$. Then there exists a function $f \in W_h^{1,2}$ $b^{1,2}$ such that, up to subsequence,

$$
f_n \rightharpoonup f \qquad \text{in} \ \ W_b^{1,2} \quad \text{as} \ n \to \infty. \tag{2.8}
$$

Define $g_n = f_n - f$. It suffices to show that

$$
\lim_{n \to \infty} \int \omega(x)|g_n|^{p+2} dx = 0.
$$

To do it, by [\(2.6\)](#page-8-0), there exists $R_1 > r_1 > 0$ and various constants $C > 0$ such that

$$
\omega(x) \le C|x|^c \qquad \text{for any } x \text{ with } 0 < |x| \le r_1
$$

and

$$
\omega(x) \le C|x|^c \qquad \text{for any } x \text{ with } |x| \ge R_1.
$$

Now we choose a smooth cut-off function $\psi \in C_0^{\infty}(\mathbb{R}^n)$ satisfying

$$
\psi(x) = \begin{cases} 1, & |x| \le \frac{r_1}{2}, \\ 0, & |x| \ge r_1, \end{cases} \quad \text{and} \quad |\nabla \psi| \le C.
$$

Then for $0 < r < \frac{r_1}{2}$, we get

$$
\int_{|x| \le r} \omega(x)|g_n|^{p+2} dx \le Cr^{\frac{(2-b)(p+2)-\mathbf{p}_c}{2}} \int |x|^{\frac{np-(2-b)(p+2)}{2}} |\psi g_n|^{p+2} dx
$$

$$
\le Cr^{\frac{(2-b)(p+2)-\mathbf{p}_c}{2}} (\int |x|^b |\nabla(\psi g_n)|^2 dx)^{\frac{p+2}{2}}
$$

for all $2(2 - b) < \mathbf{p}_c < (2 - b)(p + 2)$ and $b > 2 - n$, where we used the Hardy-Sobolev inequality [\(2.15\)](#page-10-0) at the last step. So, given any small $\epsilon > 0$ and combined with [\(2.8\)](#page-8-1), there exists $r_1 > r > 0$ such that

$$
\int_{|x| \le r} \omega(x)|g_n|^{p+2} dx < \frac{\epsilon}{3}.\tag{2.9}
$$

Next, we will control the integral $\int \omega(x)|g_n|^{p+2}dx$ out of a big ball. For $R > R_1$, we have

$$
\int_{|x|>R} \omega(x)|g_n|^{p+2} dx \le \frac{C}{R^{\frac{2-b}{2}}} \int_{|x|>R} |x|^{c+\frac{2-b}{2}} |g_n|^{p+2} dx. \tag{2.10}
$$

To estimate [\(2.10\)](#page-9-0), we invoke the Caffarelli-Kohn-Nirenberg inequality to obtain

$$
\int |x|^{c+\frac{2-b}{2}} |g_n|^{p+2} dx \le C \|\nabla g_n\|_{b,2}^{a(p+2)} \|g_n\|_2^{(1-a)(p+2)}
$$

for $p \in \left(\frac{2c+2-b}{n}, \frac{2c+3(2-b)}{n-2+b}\right)$ for $p \in \left(\frac{2c+2-b}{n}, \frac{2c+3(2-b)}{n-2+b}\right)$ and $b > 2-n$, where $a = \frac{\mathbf{p}_c - 2+b}{(2-b)(p+2)} \in (0, 1)$. Thus we have proved that

 $\{g_n\}_{n\in\mathbb{N}}$ is uniformly bounded in $L^{p+2}(|x|^{c+\frac{2-b}{2}}dx)$ (2.11)

for all $p \in (\frac{2(2-b+c)}{n}, \frac{2(2-b+c)}{n-2+b})$ $\frac{(2-\theta+c)}{n-2+b}$. Therefore, for any $\epsilon > 0$, it follows from (2.10) and (2.11) that there exists $R > R_1$ such that

$$
\int_{|x|>R} \omega(x)|g_n|^{p+2}dx < \frac{\epsilon}{3}.\tag{2.12}
$$

Finally, for $R > r > 0$ given above, we deduce from Lemma [2.3](#page-8-2) that the embedding

$$
\dot{W}_b^{1,2}(r < |x| \le R) \hookrightarrow L^{p+2}(r < |x| \le R; |x|^c dx)
$$

is compact for $p < \frac{2(2-b+c)}{n-2+b}$. This together with [\(2.8\)](#page-8-1) yields that

$$
\int_{r<|x|\leq R} \omega(x)|g_n|^{p+2}dx < \frac{\epsilon}{3}.\tag{2.13}
$$

Therefore, putting [\(2.9\)](#page-9-2), [\(2.12\)](#page-10-1) and [\(2.13\)](#page-10-2) all together, we conclude that the embedding [\(2.7\)](#page-8-3) is compact. \Box

As a consequence, for $\omega(x) = |x|^c$ with $b - 2 < c \leq \frac{nb}{n}$ $\frac{nb}{n-2}$, Lemma [2.4](#page-8-4) implies that the embedding

$$
W_b^{1,2} \hookrightarrow L^{p+2}(|x|^c dx) \tag{2.14}
$$

is compact for $2(2 - b) < \mathbf{p}_c < (2 - b)(p + 2)$.

At the end, we recall the radially weighted Strauss inequality cited in [\[31\]](#page-38-3).

Lemma 2.5. Let $b \geq 2 - 2n$ and $f \in W_h^{1,2}$ $b^{1,2}$ be a radial function. Then we have the following inequality

$$
\sup_{x \in \mathbb{R}^n} |x|^{\frac{2n-2+b}{4}} |f| \leq C_n \|\nabla f\|_{b,2}^{\frac{1}{2}} \|f\|_2^{\frac{1}{2}}.
$$

The following known Hardy-Sobolev inequality appears in [\[29\]](#page-38-5).

Lemma 2.6. Let $n \ge 3$, $b > 2 - n$ and $-\frac{b}{2} \le d \le \frac{2-b}{2}$. Then

$$
\left(\int |x|^{-\frac{2nd}{n-2+b+2d}}|f|^{\frac{2n}{n-2+b+2d}}dx\right)^{\frac{n-2+b+2d}{n}} \leq C_{b,d} \int |x|^b|\nabla f|^2 dx. \tag{2.15}
$$

2.2 Virial identities

Given a real value function ψ , we define

$$
I_{\psi}(t) = \int \psi(x)|u|^2 dx.
$$
\n(2.16)

A direct computation shows that

Lemma 2.7. Let $u \in C(I;W^{1,2}_h)$ $(b^{(1,2)})$ be the solution to the INLS_{b,V}. Assume that $\psi, \phi \in$ $W^{4,\infty}$ and satisfy

$$
\nabla \psi(x) = \frac{\nabla \phi(x)}{|x|^b}.
$$

Then

$$
I'_{\psi}(t) = 2\mathrm{Im}\int \nabla \phi \cdot \nabla u \overline{u} dx \qquad (2.17)
$$

and

$$
I''_{\psi}(t) = -\frac{2}{p+2} \int (p|x|^c \Delta \phi - 2\nabla \phi \cdot \nabla |x|^c) |u|^{p+2} dx
$$

\n
$$
-2 \int (\nabla \phi \cdot \nabla |x|^b) |\nabla u|^2 dx - 2 \int \nabla \phi \cdot \nabla V |u|^2 dx
$$

\n
$$
+4 \text{Re} \int (\nabla^2 \phi \cdot \nabla u) \cdot \nabla \overline{u} |x|^b dx
$$

\n
$$
- \int (|x|^b \Delta^2 \phi + \nabla \Delta \phi \cdot \nabla |x|^b) |u|^2 dx.
$$
 (2.18)

Proof. The proof is standard, see, for instance [\[3\]](#page-36-1), which deals with the variable coefficient Schrödinger equation with harmonic potential $V(x) = |x|^2$. Here we omit the details. \Box

As a consequence, we obtain the following virial identity for the $INLS_{b,V}$.

Corollary 2.8. Let $u_0 \in W_b^{1,2} \cap L^2(|x|^{2-b}dx)$. Assume $u \in C(I;W_b^{1,2})$ $\binom{1,2}{b}$ is the maximal lifespan solution to the $INLS_{b,V}$. Then $u \in C(I; L^2(|x|^{2-b}dx))$ and for any $t \in I$,

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 = 2(2-b)^2||\nabla u||_{b,2}^2 - 2(2-b)\int (x \cdot \nabla V)|u|^2 dx - \frac{2(2-b)\mathbf{p}_c}{p+2}||u||_{c,p+2}^{p+2}.
$$

Proof. Let $\varepsilon > 0$, we multiply the INLS_{b,V} equation [\(1.1\)](#page-0-0) by $ie^{-2\varepsilon |x|^{2-b}}|x|^{2-b}\overline{u}$, integrate over \mathbb{R}^n and take the real part of the result to obtain

$$
\frac{d}{dt}\int e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}|u|^2dx = 2\mathrm{Im}\int|x|^b\nabla u\cdot\nabla(e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}\overline{u})dx.
$$

Integrating the above equality with respect to t , we have

$$
\int e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}|u|^2dx = \int e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}|u_0|^2dx
$$
\n
$$
+2(2-b)\mathrm{Im}\int_0^t \int e^{-2\varepsilon|x|^{2-b}}\overline{u}x \cdot \nabla u(1-2\varepsilon|x|^{2-b})dxdt.
$$
\n(2.19)

Since $e^{-\varepsilon |x|^{2-b}} (1 - 2\varepsilon |x|^{2-b})$ is bounded in both x and ε , and that ∇u is bounded in $L^2(|x|^b dx)$, so it follows from [\(2.19\)](#page-11-0) that for every compact interval $I \subset [0, T^*)$, there exists constant C such that

$$
\int e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}|u|^2dx \le C\int e^{-2\varepsilon|x|^{2-b}}|x|^{2-b}|u_0|^2dx < \infty
$$

for all $\varepsilon > 0$. It follows that the function $t \mapsto u(t)$ is weakly continuous in $[0, T^*) \to$ $L^2(|x|^{2-b}dx)$. Now let $\varepsilon \to 0$ in [\(2.19\)](#page-11-0), then

$$
\int |x|^{2-b}|u|^2 dx = \int |x|^{2-b}|u_0|^2 dx + 2(2-b)\mathrm{Im}\int_0^t \int \overline{u}x \cdot \nabla u dx dt,
$$

which yields that the function $t \mapsto u(t)$ is continuous in $[0, T^*) \to L^2(|x|^{2-b}dx)$. Hence, we conclude that the solution $u \in C([0,T^*); L^2(|x|^{2-b}dx)).$

It remains to show the virial identity. Let $\nabla \phi = x$ in Lemma [2.7,](#page-11-1) then

$$
\frac{d^2}{dt^2} ||u(t)||_{2-b,2}^2 = 2(2-b)^2 ||\nabla u||_{b,2}^2
$$

$$
-2(2-b) \int (x \cdot \nabla V) |u|^2 dx - \frac{2(2-b)\mathbf{p}_c}{p+2} ||u||_{c,p+2}^{p+2},
$$

which is the desired result.

Next, we establish a localized virial estimate related to the $INLS_{b,V}$ equation [\(1.1\)](#page-0-0). If we suppose ψ and ϕ are radially symmetric, then Lemma [2.7](#page-11-1) implies

$$
I'_{\psi}(t) = 2\mathrm{Im}\int \phi' \frac{x \cdot \nabla u}{r} \overline{u} dx,
$$
\n(2.20)

 \Box

where $r = |x|$. Moreover, since

$$
4\text{Re}\int (\nabla^2 \phi \cdot \nabla u) \cdot \nabla \overline{u}|x|^b dx = 4 \int \frac{\phi'}{r} |x|^b |\nabla u|^2 dx + 4 \int (\frac{\phi''}{r^2} - \frac{\phi'}{r^3}) |x|^b |x \cdot \nabla u|^2 dx,
$$

which is obtained by the fact that

$$
\frac{\partial}{\partial x_j} = \frac{x_j}{r} \partial_r, \qquad \frac{\partial^2}{\partial x_j \partial x_k} = \left(\frac{\delta_{jk}}{r} - \frac{x_j x_k}{r^3}\right) \partial_r + \frac{x_j x_k}{r^2} \partial_r^2
$$

on radial functions. Thus, [\(2.18\)](#page-11-2) can be rewritten as

$$
I''_{\psi}(t) = 4 \int (\frac{\phi''}{r^2} - \frac{\phi'}{r^3}) |x|^b |x \cdot \nabla u|^2 dx + (4 - 2b) \int \frac{\phi'}{r} |x|^b |\nabla u|^2 dx - \frac{2}{p+2} \int (p\Delta \phi - \frac{2c\phi'}{r}) |x|^c |u|^{p+2} dx - 2 \int \frac{\phi'}{r} (x \cdot \nabla V) |u|^2 dx - \int (|x|^b \Delta^2 \phi + \nabla \Delta \phi \cdot \nabla |x|^b) |u|^2 dx.
$$
 (2.21)

By choosing an appropriate cut-off function similar to x^2 near the origin $x = 0$, we deduce the following localized virial estimate.

Lemma 2.9. Let $n \geq 3$ and $b > 2 - n$. If $x \cdot \nabla V \in L^{\frac{n}{2}}(|x|^{-\frac{nb}{2}}dx)$ and $u \in$ $C([0,T^*);W_h^{1,2})$ $b^{(1,2)}$ is the solution to the INLS_{b,V} with radial initial data u_0 , then there exists constant $C > 0$ depending on $\mathbf{p}_c, b, M(u_0)$ such that the following localized virial estimate

$$
I_{\psi_R}''(t) \le 4(2-b)P(u) + C_{\epsilon}R^{-\frac{2p_c - (2-b)p}{4-p}}M(u_0)^{\frac{p}{4}+1} + CR^{b-2}M(u_0) + (2b+C\epsilon+C\|x\cdot\nabla V\|_{L^{\frac{n}{2}}(|x|>R;\ |x|^{-\frac{nb}{2}}dx)})\|\nabla u\|_{b,2}^2
$$
 (2.22)

holds for any $t \in [0, T^*).$

Proof. We consider the radial function ϕ_R constructed by $\phi_R(x) = R^2 \Theta(\frac{x}{R})$, where

$$
\Theta(x) = \begin{cases} |x|^2, & \text{if } |x| \le 1, \\ \text{smooth}, & \text{if } 1 < |x| < 2, \\ 0, & \text{if } |x| \ge 2 \end{cases} \tag{2.23}
$$

and $\|\Theta\|_{W^{2,\infty}} \leq 2$. Applying $\nabla \psi_R = \frac{\nabla \phi_R}{|x|^b}$ $\frac{\sqrt{\varphi_R}}{|x|^b}$ to (2.21) , we can rewrite $I_{\psi_R}''(t)$ as

$$
I_{\psi_R}''(t) = 4(2 - b)P(u) + \mathcal{R}_1 + \mathcal{R}_2 + \mathcal{R}_3 + \mathcal{R}_4,
$$
\n(2.24)

where \mathcal{R}_j $(j = 1, 2, 3, 4)$ are defined by

$$
\mathcal{R}_1 = 4 \int_{|x|>R} (\frac{\phi_R''}{r^2} - \frac{\phi_R'}{r^3}) |x|^b |x \cdot \nabla u|^2 dx + (4 - 2b) \int_{|x|>R} (\frac{\phi_R'}{r} - 2) |x|^b |\nabla u|^2 dx,
$$

$$
\mathcal{R}_2 = - \int_{|x|>R} (|x|^b \Delta^2 \phi_R + \nabla \Delta \phi_R \cdot \nabla |x|^b) |u|^2 dx,
$$

$$
\begin{aligned} \mathcal{R}_3&=-\frac{2}{p+2}\int_{|x|>R}(p\Delta\phi_R-\frac{2c\phi_R'}{r})|x|^c|u|^{p+2}dx+\frac{4\mathbf{p}_c}{p+2}\int_{|x|>R}|x|^c|u|^{p+2}dx,\\ \mathcal{R}_4&=2\int_{|x|>R}(2-\frac{\phi_R'}{r})(x\cdot\nabla V)|u|^2dx. \end{aligned}
$$

Similarly to the argument of Lemma 2.8 in [\[33\]](#page-38-2), which deals with the $INLS_{b,V}$ without potential, we easily get

$$
\mathcal{R}_1 \le 2b \int_{|x|>R} (2 - \frac{\phi_R'}{r}) |x|^b |\nabla u|^2 dx, \tag{2.25}
$$

$$
\mathcal{R}_2 \le C_{n,b} R^{b-2} \|u\|_2^2 \tag{2.26}
$$

and

$$
\mathcal{R}_3\leq C_{\mathbf{P}_c}\int_{|x|>R}|x|^c|u|^{p+2}dx\leq C_{\mathbf{P}_c}R^{c-\frac{(2n-2+b)p}{4}}\|\nabla u\|_{b,2}^{\frac{p}{2}}\|u\|_2^{\frac{p}{2}+2},
$$

where the last inequality in \mathcal{R}_3 is obtained by Lemma [2.5.](#page-10-3) Thus, applying the Young inequality to \mathcal{R}_3 , we further have

$$
\mathcal{R}_3 \le C_{\epsilon, \mathbf{p}_c} R^{-\frac{2\mathbf{p}_c - (2-b)p}{4-p}} \|u\|_2^{\frac{p}{2}+2} + C\epsilon \|\nabla u\|_{b,2}^2 \|u\|_2^{\frac{p}{2}+2}.
$$
 (2.27)

The remaining task is to control the potential part \mathcal{R}_4 . Since $2 - \frac{\phi'_R}{r} \geq 0$, we use the Hölder inequality to get

$$
\mathcal{R}_4 \leq C \int_{|x|>R} |x \cdot \nabla V| |u|^2 dx
$$

$$
\leq C (\int_{|x|>R} |x|^{-\frac{nb}{2}} |x \cdot \nabla V|^{\frac{n}{2}} dx)^{\frac{2}{n}} (\int_{|x|>R} |x|^{\frac{nb}{n-2}} |u|^{\frac{2n}{n-2}} dx)^{\frac{n-2}{n}},
$$

which together with [\(2.15\)](#page-10-0) yields

$$
\mathcal{R}_4 \le C_b \|x \cdot \nabla V\|_{L^{\frac{n}{2}}(|x|>R; \ |x|^{-\frac{nb}{2}}dx)} \|\nabla u\|_{b,2}^2. \tag{2.28}
$$

Therefore, putting $(2.25)-(2.28)$ $(2.25)-(2.28)$ all together, we conclude the result of Lemma [2.9.](#page-13-0) \Box

3 Global existence and blow-up for radial case

In this section, we are devoted to the proof of Theorems [1.1](#page-3-0) and [1.2.](#page-4-0)

3.1 Global existence

In this part, we study the global existence for the mass-critical and intercritical $\text{INLS}_{b,V}$ with radial initial data, upon the LWP assumption in $W_h^{1,2}$ $b^{t,2}$ stated in Section 1.

Proof of the global parts in Theorems [1.1](#page-3-0) and [1.2.](#page-4-0) Let $u\in C([0,T^*);W^{1,2}_b)$ $\binom{1,2}{b}$ be the solution to the $INLS_{b,V}$ with $u_0 \in W_b^{1,2}$ $b^{1,2}$. In view of the conservation laws, we just need to bound the $W_h^{1,2}$ $b^{(1,2)}$ -norm of $u(t)$ for any $t \in [0, T^*).$

Case 1 (Mass-critical). Since $V(x) \geq 0$, we deduce from the energy conservation that

$$
\|\nabla u\|_{b,2}^2 \le \|\nabla u\|_{b,2}^2 + \int V(x)|u|^2 dx = 2E_{b,V}(u_0) + \frac{2}{p+2}||u||_{c,p+2}^{p+2}.
$$

Invoking the sharp radial Gagliardo-Nirenberg inequality [\(2.3\)](#page-7-0), we further get

$$
\begin{aligned} \|\nabla u\|_{b,2}^2 &\le 2E_{b,V}(u_0) + \frac{2C_{GN}}{p+2} \|\nabla u\|_{b,2}^{\frac{\mathbf{p}_c}{2-b}} \|u\|_2^{\frac{(2-b)(p+2)-\mathbf{p}_c}{2-b}} \\ &= 2E_{b,V}(u_0) + \left(\frac{\|u_0\|_2}{\|Q_\omega\|_2}\right)^p \|\nabla u\|_{b,2}^2. \end{aligned}
$$

Since $||u_0||_2 < ||Q_\omega||_2$, we obtain that $||\nabla u||_{b,2}$ is bounded for any $t \in [0, T^*)$, which derives the global existence in Theorem [1.1](#page-3-0) (i).

Case 2 (Intercritical). Multiplying both sides of $E_{b,V}(u)$ by $M(u)^\sigma$ and using the sharp radial Gagliardo-Nirenberg inequality [\(2.3\)](#page-7-0), we have

$$
E_{b,V}(u)M(u)^{\sigma} = \frac{1}{2}(\|u\|_{\dot{H}^{1}_{b,V}}\|u\|_{2}^{\sigma})^{2} - \frac{1}{p+2}\|u\|_{c,p+2}^{p+2}\|u\|_{2}^{2\sigma}
$$

$$
\geq \frac{1}{2}\left(\|u\|_{\dot{H}^{1}_{b,V}}\|u\|_{2}^{\sigma}\right)^{2} - \frac{C_{GN}}{p+2}(\|u\|_{\dot{H}^{1}_{b,V}}\|u\|_{2}^{\sigma})^{\frac{p_{c}}{2-\delta}},
$$
(3.1)

where we used the fact that $||u||_{\dot{H}_{b,V}^{1}} \ge ||\nabla u||_{b,2}$ for all $V \ge 0$.

Now for $\alpha > 0$, which will be chosen later, we introduce a function

$$
f(x) = \frac{1}{2}x^2 - \frac{2-b}{\mathbf{p}_c} \alpha^{2 - \frac{\mathbf{p}_c}{2 - b}} x^{\frac{\mathbf{p}_c}{2 - b}} \quad \text{for } x \in [0, \infty).
$$

Differentiating the function f with respect to x , we have

$$
f'(x) = \alpha^{2 - \frac{\mathbf{p}_c}{2 - b}} x (\alpha^{\frac{\mathbf{p}_c}{2 - b} - 2} - x^{\frac{\mathbf{p}_c}{2 - b} - 2}).
$$

Since $p_c > 2(2 - b)$, we see that $f'(x) > 0$ on $(0, \alpha)$ and $f'(x) < 0$ on (α, ∞) , which implies that $f(x)$ has a local maximum at $x_{\text{max}} = \alpha$.

We choose $\alpha > 0$ such that $\alpha = ||\nabla Q_1||_{b,2} ||Q_1||_2^{\sigma}$, then it follows from Pohozaev's identities [\(2.4\)](#page-8-5) that

$$
f(\alpha) = \frac{\mathbf{p}_c - 2(2 - b)}{2\mathbf{p}_c} (\|\nabla Q_1\|_{b,2} \|Q_1\|_2^{\sigma})^2 = E_b(Q_1) M(Q_1)^{\sigma}.
$$
 (3.2)

By hypothesis in Theorem [1.2,](#page-4-0) [\(3.1\)](#page-15-0), [\(3.2\)](#page-15-1) and the conservation laws, we obtain

$$
f(||u||_{\dot{H}^1_{b,V}} ||u||_2^{\sigma}) \le E_{b,V}(u)M(u)^{\sigma} < f(||\nabla Q_1||_{b,2} ||Q_1||_2^{\sigma}) \quad \text{for } t \in [0,T^*).
$$

Therefore, we see that

either
$$
||u||_{\dot{H}_{b,V}^1} ||u||_2^{\sigma} < \alpha
$$
 or $||u||_{\dot{H}_{b,V}^1} ||u||_2^{\sigma} > \alpha$ (3.3)

is valid for any $t \in [0, T^*).$

Since $||u_0||_{\dot{H}_{b,V}^1} ||u_0||_2^{\sigma} < \alpha$, by the continuity argument and [\(3.3\)](#page-15-2), we have

$$
\|u(t)\|_{\dot{H}_{b,V}^{1}}\|u(t)\|_{2}^{\sigma}<\alpha
$$

for any $t \in [0, T^*)$, which proves the global existence in Theorem [1.2](#page-4-0) (i).

3.2 Blow-up

In this section, based on the virial identites, we prove the blow-up results for the intercritical INLS $_{b,V}$ with radial or finite variance initial data.

Proof of Theorem [1.1](#page-3-0) (ii). Using [\(1.8\)](#page-4-1) and the virial identity in Corollary [2.8,](#page-11-3) we have

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 = 2(2-b)^2 P(u(t)).
$$

Since $x \cdot \nabla V + (2 - b)V \geq 0$, we deduce that

$$
P(u(t)) \leq \|\nabla u(t)\|_{b,2}^2 + \int V(x)|u(t)|^2 dx - \frac{\mathbf{p}_c}{(2-b)(p+2)}\|u(t)\|_{c,p+2}^{p+2},\tag{3.4}
$$

which implies that

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 \le 4(2-b)^2 E_{b,V}(u(t)) + \frac{2(2-b)^2}{p+2} (2-\frac{\mathbf{p}_c}{2-b})||u(t)||_{c,p+2}^{p+2}.
$$

So by the energy conservation and $\mathbf{p}_c = 2(2 - b)$, we have

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 \le 4(2-b)^2 E_{b,V}(u_0) < 0.
$$

Using the Glassey's argument (see [\[15\]](#page-37-13)), we prove the finite time blow-up result for the fast-decaying and negative-energy solutions.

Proof of Theorem [1.2](#page-4-0) (ii). Firstly, we proceed as in the proof of Theorem 1.2 (i), it follows from the assumption

$$
||u_0||_{\dot{H}^1_{b,V}} ||u_0||_2^{\sigma} > ||\nabla Q_1||_{b,2} ||Q_1||_2^{\sigma}
$$

and [\(3.3\)](#page-15-2) that the lower bound [\(1.7\)](#page-4-2) of the solution $u(t)$ to the INLS_{b,V} also holds.

Case 1 ($u_0 \in L^2(|x|^{2-b}dx)$). By Corollary [2.8](#page-11-3) and [\(1.8\)](#page-4-1), we have

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 = 2(2-b)^2 P(u(t)).
$$
\n(3.5)

Now we claim that there exists $\delta = \delta(b, \mathbf{p}_c, u_0) > 0$ such that the virial functional bound

$$
P(u) \le -\delta \tag{3.6}
$$

holds for either (2.1) or (2.2) .

Indeed, from [\(3.4\)](#page-16-0), it suffices to bound the integral term $||u||^2_{\dot{H}^1_{b,V}} - \frac{P_c}{(p+2)(\dot{H}^1_{b,V})}$ $\frac{\mathbf{p}_c}{(p+2)(2-b)} ||u||_{c,p+2}^{p+2}.$ To our aim, we use the energy conservation to get

$$
||u||_{\dot{H}^{1}_{b,V}}^{2} - \frac{\mathbf{p}_c}{(p+2)(2-b)}||u||_{c,p+2}^{p+2} = \frac{\mathbf{p}_c}{2-b}E_{b,V}(u_0) - (\frac{\mathbf{p}_c}{4-2b} - 1)||u||_{\dot{H}^{1}_{b,V}}^{2}.
$$
 (3.7)

Since

$$
E_{b,V}(u_0) < \frac{M(Q_1)^{\sigma}}{M(u_0)^{\sigma}} E_b(Q_1),
$$

let $\varepsilon = \varepsilon(b, \mathbf{p}_c, u_0, Q_1) > 0$ be such that $\varepsilon := \frac{1}{2} (\frac{M(Q_1)^{\sigma}}{M(u_0)^{\sigma}})$ $\frac{M(Q_1)^2}{M(u_0)^{\sigma}} E_b(Q_1) - E_{b,V}(u_0)$, we get

$$
E_{b,V}(u_0) < \frac{1}{2} E_{b,V}(u_0) + \frac{1}{2} \frac{M(Q_1)^{\sigma}}{M(u_0)^{\sigma}} E_b(Q_1) = \frac{M(Q_1)^{\sigma}}{M(u_0)^{\sigma}} E_b(Q_1) - \varepsilon. \tag{3.8}
$$

Thus, collecting (3.7) , (3.8) and (1.7) , we obtain

$$
||u||_{\dot{H}_{b,V}^{1}}^{2} - \frac{\mathbf{p}_{c}}{(p+2)(2-b)}||u||_{c,p+2}^{p+2}
$$

\n
$$
\leq \frac{\mathbf{p}_{c}}{2-b} (\frac{M(Q_{1})^{\sigma}}{M(u_{0})^{\sigma}} E_{b}(Q_{1}) - \varepsilon) - (\frac{\mathbf{p}_{c}}{4-2b} - 1) \frac{||Q_{1}||_{2}^{2\sigma}}{||u_{0}||_{2}^{2\sigma}} ||\nabla Q_{1}||_{b,2}^{2}
$$

\n
$$
= -\frac{\mathbf{p}_{c}}{2-b} \varepsilon,
$$

where the last equality is obtained by the fact that

$$
E_b(Q_1) = (\frac{1}{2} - \frac{2-b}{\mathbf{p}_c}) \|\nabla Q_1\|_{b,2}^2.
$$

The claim [\(3.6\)](#page-16-2) follows.

At the end, combining [\(3.5\)](#page-16-3) with [\(3.6\)](#page-16-2), we obtain that

$$
\frac{d^2}{dt^2}||u(t)||_{2-b,2}^2 \le -2(2-b)^2\delta
$$

for any $t \in [0, T^*)$. This shows that the solution $u(t)$ to the INLS_{b,V} blows up in finite time.

Case 2 (u_0 is radial). The main blow-up mechanism is governed by an ODE equation $f^s < f'$, namely, if $s > 1$, then f will blow up in finite time. We proceed by contradiction and assume that the maximal existence $T^* = +\infty$.

To start it, we give a lower bound of blow-up rate. That is, there exist $C > 0$ and $T_0 > 0$ such that

$$
\|\nabla u(t)\|_{b,2}^2 \ge C t^2 \tag{3.9}
$$

for all $t \geq T_0$.

In fact, from Lemma [2.9,](#page-13-0) if we take $\epsilon > 0$ sufficiently small such that $C\epsilon < -b$ and then, we take $R > 0$ sufficiently large such that

$$
C||x \cdot \nabla V||_{L^{\frac{n}{2}}(|x|>R; \ |x|^{-\frac{nb}{2}}dx)} < -b
$$

and

$$
C_{\epsilon}R^{-\frac{2\mathbf{p}_c - (2-b)p}{4-p}}M(u_0)^{\frac{p}{4}+1} < 2(2-b)\delta.
$$

Thus we have

$$
I_{\psi_R}''(t) < -2(2 - b)\delta < 0.
$$

Now we integrate the above inequality from 0 to t , then

$$
I'_{\psi_R}(t) \le -2(2-b)\delta t + I'_{\psi_R}(0).
$$

We may choose $T_0 > 0$ sufficiently large such that $I'_{\psi_R}(0) \leq (2 - b)\delta T_0$. Then we get

$$
I'_{\psi_R}(t) \le -(2-b)\delta t, \qquad \forall \ t \ge T_0. \tag{3.10}
$$

Moreover, by Lemma [2.7](#page-11-1) and the Hölder inequality, we deduce

$$
\begin{split} |I'_{\psi_R}(t)| &\le 2R \int |\nabla \Theta\left(\frac{x}{R}\right)| |\nabla u| |\overline{u}| dx \\ &\le 4R \int_{|x| \le R} |\nabla u| |\overline{u}| dx + CR \int_{R < |x| \le 2R} |\nabla u| |\overline{u}| dx \\ &\le CR^{1-\frac{b}{2}} \|\nabla u\|_{b,2} \|u\|_{2}, \end{split} \tag{3.11}
$$

where Θ is defined in [\(2.23\)](#page-13-2). Thus, combining [\(3.10\)](#page-18-0) with [\(3.11\)](#page-18-1), we obtain

$$
(2-b)\delta t \le |I'_{\psi_R}(t)| \le CR^{1-\frac{b}{2}} \|\nabla u\|_{b,2} M(u_0)^{\frac{1}{2}},
$$

which arrives at (3.9) .

To our aim, we also need to give another finer virial estimate about $I''_{\psi_R}(t)$, which is slight modification of (2.22) in Lemma [2.9.](#page-13-0) Here we can see the difference between two cases in the treatment of the functional P and the terms involving $\|\nabla u\|_{b,2}$.

By (2.22) , (3.4) and the energy conservation, we have

$$
I_{\psi_R}''(t) \le 4\mathbf{p}_c E_{b,V}(u_0) - 2(\mathbf{p}_c - 4 + 2b)(\|\nabla u\|_{b,2}^2 + \int V(x)|u|^2 dx)
$$

+ $C_{\epsilon}R^{-\frac{2\mathbf{p}_c - (2-b)p}{4-p}} M(u_0)^{\frac{p}{4}+1} + CR^{b-2} M(u_0)$
+ $C\epsilon M(u_0)^{\frac{p}{4}+1} \|\nabla u\|_{b,2}^2 + C\|x \cdot \nabla V\|_{L^{\frac{n}{2}}(|x|>R; |x|^{-\frac{nb}{2}}dx)} \|\nabla u\|_{b,2}^2.$ (3.12)

If we take $\epsilon > 0$ sufficiently small such that $C \epsilon M(u_0)^{\frac{p}{4}+1} < \frac{1}{2}$ $\frac{1}{2}(\mathbf{p}_c - 4 + 2b)$ and take $R > 0$ sufficiently large such that

$$
C||x \cdot \nabla V||_{L^{\frac{n}{2}}(|x|>R; \ |x|^{-\frac{nb}{2}}dx)} < \frac{1}{2}(\mathbf{p}_c - 4 + 2b),
$$

we then deduce from [\(3.12\)](#page-18-2) that

$$
I_{\psi_R}''(t) \le 4\mathbf{p}_c E_{b,V}(u_0) - (\mathbf{p}_c - 4 + 2b) \|\nabla u\|_{b,2}^2 + C_{\epsilon} R^{-\frac{2\mathbf{p}_c - (2-b)p}{4-p}} M(u_0)^{\frac{p}{4}+1} + CR^{b-2} M(u_0).
$$

Thus, by [\(3.9\)](#page-17-1), there exists $T_1 \ge T_0$ and $\delta_0 := \frac{1}{2}(\mathbf{p}_c - 4 + 2b) > 0$ such that

$$
I_{\psi_R}''(t)\leq -\delta_0 \|\nabla u\|_{b,2}^2
$$

We integrate the above inequality over $[T_1, t]$, then it follows from [\(3.10\)](#page-18-0) that

$$
I'_{\psi_R}(t) \leq -\delta_0 \int_{T_1}^t \|\nabla u(s)\|_{b,2}^2 ds + I'_{\psi_R}(T_1) \leq -\delta_0 \int_{T_1}^t \|\nabla u(s)\|_{b,2}^2 ds. \tag{3.13}
$$

.

So, combining (3.11) with (3.13) , we obtain

$$
\delta_0 \int_{T_1}^t \|\nabla u(s)\|_{b,2}^2 ds \le |I'_{\psi_R}(t)| \le CR^{1-\frac{b}{2}} M(u_0)^{\frac{1}{2}} \|\nabla u\|_{b,2}.
$$

Define $f(t) := \int_{T_1}^t ||\nabla u(s)||_{b,2}^2 ds$ and thus

$$
Af(t)^2 \le f'(t),
$$

where $A := \frac{\delta_0^2}{C^2 R^{2-b} M(u_0)}$. Finally, taking $T_2 > T_1$ and integrating on $[T_2, t]$, we get

$$
A(t-T_2) \le \frac{1}{f(T_2)} - \frac{1}{f(t)} \le \frac{1}{f(T_2)} < \infty.
$$

Due to $f(T_2) > 0$, we let $t \to \infty$ and arrive at a contradiction. Therefore, the solution $u(t)$ to the INLS_{b,V} blows up in finite time. We complete the proof of Theorem [1.2](#page-4-0) (ii).

4 Variational Characterization

In the first two subsections, we show the properties of minimizing problem [\(1.14\)](#page-5-2) for each (α, β) in [\(1.13\)](#page-5-0), and give the proof of Proposition [1.4.](#page-5-1)

4.1 Minimizing problems

For each $(\alpha, \beta) \in \mathbb{R}^2$, we define the following functional:

$$
\widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) := S_{\omega,0}(\phi) - \frac{K_{\omega,0}^{\alpha,\beta}(\phi)}{\mu},\tag{4.1}
$$

where $\mu := \max\{2\alpha + (2 - b - n)\beta, 2\alpha - n\beta\}.$

Lemma 4.1. Let $\beta \in \mathbb{R}$, $b < 2$ and $\omega > 0$. Then

$$
\mu \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) \ge \frac{(2-b)|\beta|}{2} \min\{\|\nabla \phi\|_{b,2}^2, \ \omega \|\phi\|_2^2\} + \frac{p\alpha - (2-b+c)\beta + (2-b)\widetilde{\beta}}{p+2} \|\phi\|_{c,p+2}^{p+2},
$$

where

$$
\widetilde{\beta} = \begin{cases} \beta, & \text{if } \beta < 0, \\ 0, & \text{if } \beta \ge 0. \end{cases}
$$

Proof. By the definition of $S_{\omega,0}$ and $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta, \omega, 0$, we observe that

$$
\mu \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) = \frac{1}{2} [\mu - 2\alpha - (2 - b - n)\beta] ||\nabla \phi||_{b,2}^2 + \frac{\omega}{2} [\mu - (2\alpha - n\beta)] ||\phi||_2^2
$$

$$
-\frac{1}{p+2} [\mu - (p+2)\alpha + (n+c)\beta] ||\phi||_{c,p+2}^{p+2}.
$$

For any $\beta \in \mathbb{R}$, one can easily check that

$$
[\mu - 2\alpha - (2 - b - n)\beta] ||\nabla \phi||_{b,2}^2 = \begin{cases} -(2 - b)\beta ||\nabla \phi||_{b,2}^2, & \beta < 0, \\ 0, & \beta \ge 0, \end{cases}
$$

$$
[\mu - (2\alpha - n\beta)] ||\phi||_2^2 = \begin{cases} 0, & \beta < 0, \\ (2 - b)\beta ||\phi||_2^2, & \beta \ge 0, \end{cases}
$$
\n
$$
[\mu - (p+2)\alpha + (n+c)\beta] ||\phi||_{c,p+2}^{p+2} = \begin{cases} (-p\alpha + c\beta) ||\phi||_{c,p+2}^{p+2}, & \beta < 0, \\ [-p\alpha + (2-b+c)\beta] ||\phi||_{c,p+2}^{p+2}, & \beta \ge 0. \end{cases}
$$

Therefore, we have

$$
\mu \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) \ge \frac{(2-b)|\beta|}{2} \min\{\|\nabla \phi\|_{b,2}^2, \ \omega \|\phi\|_2^2\} + \frac{p\alpha - (2-b+c)\beta + (2-b)\widetilde{\beta}}{p+2} \|\phi\|_{c,p+2}^{p+2}.
$$

 \Box

The proof of Lemma [4.1](#page-20-0) is completed.

Next, we prove the positivity of $K^{\alpha,\beta}_{\omega,V}$ near the origin in $W_b^{1,2}$ $b^{1,2}$.

Lemma 4.2. Let $2 - n < b < 2$, $b - 2 < c ≤ 0$, $2(2 - b) < p_c ≤ (2 - b)(p + 2)$, $V ≥$ $0, x \cdot \nabla V \leq 0$ and let (α, β) satisfy (1.13) . For $\omega > 0$, if the uniform L^2 -bounded sequence $\{\phi_n\}_{n\in\mathbb{N}} \in W_b^{1,2}$ $\{b_n^{(1,2)}\setminus\{0\} \text{ satisfies } ||\nabla \phi_n||_{b,2} \to 0 \text{ as } n \to \infty, \text{ then } K^{\alpha,\beta}_{\omega,V}(\phi_n) > 0$ for sufficiently large n.

Proof. Since $V \geq 0$, $x \cdot \nabla V \leq 0$ and [\(1.13\)](#page-5-0), we use the Gagliardo-Nirenberg inequality (2.5) to get

$$
\begin{aligned} K_{\omega,V}^{\alpha,\beta}(\phi) & \geq \frac{2\alpha+(2-b-n)\beta}{2}\|\nabla \phi\|_{b,2}^2 - \frac{\alpha(p+2)-(n+c)\beta}{p+2}\|\phi\|_{c,p+2}^{p+2} \\ & \geq \frac{2\alpha+(2-b-n)\beta}{2}\|\nabla \phi\|_{b,2}^2 - \frac{\alpha(p+2)-(n+c)\beta}{(p+2)C}\|\nabla \phi\|_{b,2}^{\frac{\mathbf{p}_{c}}{2-b}}\|\phi\|_{2}^{\frac{(2-b)(p+2)-\mathbf{p}_{c}}{2-b}}, \end{aligned}
$$

which is satisfied by the relation

$$
\alpha(p+2) - (n+c)\beta \ge \alpha p - (2-b+c)\beta \ge 0.
$$

Since $\{\phi_n\}_{n\in\mathbb{N}}$ is bounded in L^2 , there exists a constant $C_0 > 0$ such that

$$
C_0 := \sup_{n \in \mathbb{N}} \|\phi_n\|_2 < \infty.
$$

By the hypothesis $\|\nabla \phi_n\|_{b,2} \to 0$ as $n \to \infty$, there exists a large $N \in \mathbb{N}$ such that for $n \geq N$, the estimate holds

$$
\|\nabla \phi_n\|_{b,2} \le \left(\frac{2\alpha + (2-b-n)\beta}{4CC_0^{p+2-\frac{\mathbf{p}_c}{2-b}}}\frac{p+2}{\alpha(p+2)-(n+c)\beta}\right)^{\frac{2-b}{\mathbf{p}_c-2(2-b)}}
$$

Therefore, combining the above three estimates, we obtain

$$
K_{\omega,V}^{\alpha,\beta}(\phi_n) \geq \|\nabla \phi_n\|_{b,2}^2
$$

\$\times \left(\frac{2\alpha + (2-b-n)\beta}{2} - \frac{\alpha(p+2) - (n+c)\beta}{p+2}CC_0^{p+2-\frac{p_c}{2-b}} \|\nabla \phi_n\|_{b,2}^{\frac{p_c}{2-b}-2}\right)\$
\$\geq \frac{2\alpha + (2-b-n)\beta}{4} \|\nabla \phi_n\|_{b,2}^2 > 0\$,

which finishes the proof of this lemma.

As a consequence, we claim that

$$
K^{\alpha,\beta}_{\omega,V}(\phi^{\alpha,\beta}_{\lambda}) > 0 \tag{4.2}
$$

.

 \Box

for sufficiently small $\lambda < 0$. Indeed, from a simple computation

$$
\|\nabla \phi^{\alpha,\beta}_{\lambda}\|_{b,2} = e^{\alpha\lambda + \frac{(2-b-n)\beta\lambda}{2}} \|\nabla \phi\|_{b,2},
$$

we obtain that $\lim_{\lambda \to -\infty} \|\nabla \phi_{\lambda}^{\alpha,\beta}\|$ $\lambda^{\alpha,\beta}$ ||_{b,2} = 0, which together with Lemma [4.2](#page-20-1) concludes $(4.2).$ $(4.2).$

Now we consider the minimizing problem $m_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta, \omega, 0$ for each (α, β) in [\(1.13\)](#page-5-0). To do it, we denote the set of nontrivial solutions to the equation [\(1.6\)](#page-3-1) by

$$
\mathcal{A}_{\omega} := \{ \phi \in W^{1,2}_b \backslash \{0\} : S'_{\omega,0}(\phi) = 0 \}.
$$

The set of ground states is denoted by \mathcal{G}_{ω} :

$$
\mathcal{G}_{\omega} := \{ \phi \in \mathcal{A}_{\omega} : S_{\omega,0}(\phi) \leq S_{\omega,0}(v) \text{ for all } v \in \mathcal{A}_{\omega} \}.
$$

We can solve the minimizing problem (1.14) in the case $V = 0$.

Proposition 4.3. Let $n \geq 3$, $2-n < b < 2$, $b-2 < c \leq \min\{\frac{nb}{n-a}$ $\frac{nb}{n-2}, 0$, $2(2-b) < p_c <$ $(2-b)(p+2)$ and let (α, β) satisfy [\(1.13\)](#page-5-0). Then for $\omega > 0$, there exists $\phi \in W_b^{1,2}$ $\langle b^{1,2}\rangle\{0\}$ such that

$$
S_{\omega,0}(\phi) = m_{\omega,0}^{\alpha,\beta} \quad \text{and} \quad K_{\omega,0}^{\alpha,\beta}(\phi) = 0.
$$

Proof. We split the proof of Proposition [4.3](#page-22-0) into the following three steps.

Step 1. We first prove that the minimizing sequence of (1.14) with $V = 0$ is bounded in $W_h^{1,2}$ $b^{1,2}$ and the weak limit of it is nonzero.

Let $\{\phi_n\}_{n\in\mathbb{N}}\subset W_b^{1,2}$ $\{0\}$ be a minimizing sequence of (1.14) with $V = 0$, namely $K_{\omega,0}^{\alpha,\beta}$ $\alpha^{\alpha,\beta}_{\omega,0}(\phi_n) = 0 \quad \text{and} \quad S_{\omega,0}(\phi_n) \to m^{\alpha,\beta}_{\omega,0}$ α, β as $n \to \infty$.

Thus it follows from [\(4.1\)](#page-19-1) that

$$
\widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi_n) = S_{\omega,0}(\phi_n) \to m_{\omega,0}^{\alpha,\beta} \qquad \text{as} \quad n \to \infty. \tag{4.3}
$$

Since (α, β) satisfies [\(1.13\)](#page-5-0) and $p_c > 2(2-b)$, Lemma [4.1](#page-20-0) and [\(4.3\)](#page-22-1) yield that $\|\phi_n\|_{c,p+}^{p+2}$ $_{c,p+2}$ is bounded. Since $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta}_{\omega,0}(\phi_n) = 0$, then

$$
\frac{2\alpha + (2 - b - n)\beta}{2} \|\nabla \phi_n\|_{b,2}^2 + \frac{(2\alpha - n\beta)\omega}{2} \|\phi_n\|_2^2 \le C
$$

for some $C > 0$, which shows that $\{\phi_n\}_{n \in \mathbb{N}}$ is bounded in $W_b^{1,2}$ $b^{1,2}$. Therefore there exists $\phi \in W_h^{1,2}$ ^{-1,2} such that, up to a subsequence, $\phi_n \rightharpoonup \phi$ weakly in $W_b^{1,2}$ $b^{1,2}$. From Lemma [2.4,](#page-8-4) we obtain

$$
\phi_n \to \phi \quad \text{in} \quad L^{p+2}(|x|^c dx) \tag{4.4}
$$

for all $2(2 - b) < \mathbf{p}_c < (2 - b)(p + 2)$.

Now we claim that $\phi \neq 0$. Assume that $\phi = 0$ by contradiction. Then we deduce from $K^{\alpha,\beta}_{\omega,0}$ $\alpha, \beta(\phi_n) = 0$ and [\(4.4\)](#page-22-2) that

$$
\frac{2\alpha + (2 - b - n)\beta}{2} \|\nabla \phi_n\|_{b,2}^2 + \frac{(2\alpha - n\beta)\omega}{2} \|\phi_n\|_2^2 \to 0 \quad \text{as} \quad n \to \infty.
$$

Thus, Lemma [4.2](#page-20-1) implies that $K^{\alpha,\beta}_{\omega,0}$ $\omega_{\omega,0}^{(\alpha,\beta)}(\phi_n) > 0$ for sufficiently large n, which contradicts $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta(\phi_n) = 0$. Hence $\phi \neq 0$.

Step 3. We prove that ϕ is the minimizer of [\(1.14\)](#page-5-2) with $V = 0$.

Denote $\phi_n = \phi + r_n$, where $r_n \rightharpoonup 0$ in $W_b^{1,2}$ ^{-1,2} as $n \to \infty$. By the definition of $K^{\alpha,\beta}_{\omega,0}$ $_{\omega,0}$ and a simple computation, we have

$$
K_{\omega,0}^{\alpha,\beta}(\phi) = K_{\omega,0}^{\alpha,\beta}(\phi_n) + \frac{2\alpha + (2-b-n)\beta}{2} \|\nabla r_n\|_{b,2}^2 + \frac{(2\alpha - n\beta)\omega}{2} \|r_n\|_2^2 + o_n(1),
$$

where $o_n(1) \to 0$ as $n \to \infty$. This implies that

$$
K_{\omega,0}^{\alpha,\beta}(\phi) \le \liminf_{n \to \infty} K_{\omega,0}^{\alpha,\beta}(\phi_n) = 0.
$$

So $K^{\alpha,\beta}_{\omega,0}$ $\alpha, \beta}_{\omega,0}(\phi) \leq 0.$

Now we assume that $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta(\phi)$ < 0. From Lemma [4.2,](#page-20-1) we easily deduce that $K_{\omega,0}^{\alpha,\beta}$ $\omega_{\mu,0}^{(\alpha,\beta)}(\lambda\phi) > 0$ for sufficiently small $\lambda \in (0,1)$. This together with the continuity of $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta(\lambda\phi)$ in λ implies that there exists $\lambda_0 \in (0,1)$ such that $K_{\omega,0}^{\alpha,\beta}$ $\int_{\omega,0}^{\alpha,\beta} (\lambda_0 \phi) = 0$. By the definition of $m_{\omega,0}^{\alpha,\beta}$ $\omega,0}^{\alpha,\beta}$ and (4.1) , we have

$$
m_{\omega,0}^{\alpha,\beta} \le S_{\omega,0}(\lambda_0 \phi) = \tilde{J}_{\omega,0}^{\alpha,\beta}(\lambda_0 \phi) < \lambda_0^2 \tilde{J}_{\omega,0}^{\alpha,\beta}(\phi). \tag{4.5}
$$

Moreover, by a simple computation, we obtain

$$
\widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) = \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi_n) + o_n(1),
$$

where $o_n(1) \to 0$ as $n \to \infty$. This together with [\(4.3\)](#page-22-1) yields

$$
\widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) \le \liminf_{n \to \infty} \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi_n) \to m_{\omega,0}^{\alpha,\beta}.
$$
\n(4.6)

Therefore, combining (4.5) with (4.6) , we infer that

$$
m_{\omega,0}^{\alpha,\beta} \le S_{\omega,0}(\lambda_0 \phi) < \lambda_0^2 \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) \le m_{\omega,0}^{\alpha,\beta},
$$

which is a contradiction. Hence, $K_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta}_{\omega,0}(\phi) = 0$. Moreover,

$$
S_{\omega,0}(\phi) = \widetilde{J}_{\omega,0}^{\alpha,\beta}(\phi) \le m_{\omega,0}^{\alpha,\beta},
$$

which together with the definition of $m_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta \atop \omega, 0$ yields that $S_{\omega,0}(\phi) = m_{\omega,0}^{\alpha, \beta}$ α, β, μ . Hence, ϕ is the minimizer of (1.14) with $V = 0$. П

4.2 Proof of Proposition [1.4](#page-5-1)

Now, we are able to prove Proposition [1.4,](#page-5-1) which shows the parameter independence of $m_{\omega,0}^{\alpha,\beta}$ $\omega_{\omega,0}^{\alpha,\beta}$ via its characterization by the ground states $Q_{\omega,0}$.

Proof of Proposition [1.4.](#page-5-1) (i) We consider the minimization problem

$$
\mathcal{M}_{\omega} = \{ \phi \in W_b^{1,2} : S_{\omega,0}(\phi) = m_{\omega,0}^{\alpha,\beta}, \quad K_{\omega,0}^{\alpha,\beta}(\phi) = 0 \}.
$$
 (4.7)

By Proposition [4.3,](#page-22-0) we show that $\mathcal{M}_{\omega} \neq \emptyset$. To show that the minimizer of [\(1.14\)](#page-5-2) with $V = 0$ is also the ground state of the equation [\(1.6\)](#page-3-1), it suffices to prove that $\mathcal{M}_{\omega} = \mathcal{G}_{\omega}$.

On one hand, we prove $\mathcal{M}_{\omega} \subset \mathcal{G}_{\omega}$. Assume $\phi \in \mathcal{M}_{\omega}$, we firstly claim that $\phi \in \mathcal{A}_{\omega}$.

Indeed, since ϕ is the minimizer of [\(1.14\)](#page-5-2) with $V = 0$, so there exists a Lagrange multiplier $\tau \in \mathbb{R}$ such that $S'_{\omega,0}(\phi) = \tau K'_{\omega,0}(\phi)$. Recalling the definition $K_{\omega,0}$, we deduce

$$
0 = K_{\omega,0}(\phi) = \mathcal{L}_{\alpha,\beta} S_{\omega,0}(\phi) = \langle S_{\omega,0}'(\phi), \mathcal{L}_{\alpha,\beta} \phi \rangle = \tau \langle K_{\omega,0}'(\phi), \mathcal{L}_{\alpha,\beta} \phi \rangle, \tag{4.8}
$$

where we write $K_{\omega,0} := K_{\omega,0}^{\alpha,\beta}$ $\alpha^{\alpha,\beta}_{\omega,0}$ and $\mathcal{L}_{\alpha,\beta}\phi:=\frac{\partial}{\partial\lambda}\phi^{\alpha,\beta}_{\lambda}$ $\int_{\lambda}^{\alpha,\beta} | \lambda = 0$ for simplicity.

Since

$$
\mathcal{L}_{\alpha,\beta}K_{\omega,0}(\phi)=\langle K'_{\omega,0}(\phi),\mathcal{L}_{\alpha,\beta}\phi\rangle,
$$

which linked with [\(4.8\)](#page-24-0) yields that

$$
0 = K_{\omega,0}(\phi) = \tau \mathcal{L}_{\alpha,\beta} K_{\omega,0}(\phi) = \tau \mathcal{L}_{\alpha,\beta}^2 S_{\omega,0}(\phi).
$$
 (4.9)

We observe that

$$
\mathcal{L}_{\alpha,\beta}^{2} S_{\omega,0}(\phi) = \frac{[2\alpha + (2 - b - n)\beta]^{2}}{2} \|\nabla\phi\|_{b,2}^{2}
$$

+
$$
\frac{\omega(2\alpha - n\beta)^{2}}{2} \|\phi\|_{2}^{2} - \frac{[\alpha(p + 2) - (n + c)\beta]^{2}}{p + 2} \|\phi\|_{c,p+2}^{p+2}
$$

$$
\leq \mu \left(\frac{2\alpha + (2 - b - n)\beta}{2} \|\nabla\phi\|_{b,2}^{2} + \frac{\omega(2\alpha - n\beta)}{2} \|\phi\|_{2}^{2} \right)
$$

$$
-\frac{[\alpha(p + 2) - (n + c)\beta]^{2}}{p + 2} \|\phi\|_{c,p+2}^{p+2}
$$

$$
= \frac{\alpha(p + 2) - (n + c)\beta}{p + 2} [\mu - \alpha(p + 2) + (n + c)\beta] \|\phi\|_{c,p+2}^{p+2} < 0, \qquad (4.10)
$$

where the last inequality holds by the conditions that $c \geq b-2$, $\mathbf{p}_c > 2(2-b)$ and (1.13) . Thus, it follows from (4.9) and (4.10) that

$$
0 = K_{\omega,0}(\phi) = \tau \mathcal{L}_{\alpha,\beta}^2 S_{\omega,0}(\phi) < 0.
$$

This implies that $\tau = 0$, and hence $S'_{\omega,0}(\phi) = 0$. Therefore $\phi \in \mathcal{A}_{\omega}$ is proved.

Next, for any $v \in \mathcal{A}_{\omega}$, we deduce from [\(4.8\)](#page-24-0) that $K_{\omega,0}(v) = \langle S'_{\omega,0}(v), \mathcal{L}_{\alpha,\beta}v \rangle = 0$ and $v \neq 0$. By the definition of \mathcal{M}_{ω} , we have

$$
S_{\omega,0}(\phi) \le S_{\omega,0}(v).
$$

This implies that $\phi \in \mathcal{G}_{\omega}$. So $\mathcal{M}_{\omega} \subset \mathcal{G}_{\omega}$.

On the other hand, from Proposition [4.3,](#page-22-0) there exists $v \in M_\omega$ such that $S_{\omega,0}(v) =$ $m_{\omega,0}^{\alpha,\beta}$ $\omega_{\omega,0}^{(\alpha,\beta)}$ and $K_{\omega,0}(v) = 0$, which immediately implies $v \in \mathcal{A}_{\omega}$. So if we assume $\phi \in \mathcal{G}_{\omega}$, by the definition of \mathcal{G}_{ω} , we get

$$
S_{\omega,0}(\phi) \le S_{\omega,0}(v) = m_{\omega,0}^{\alpha,\beta}.
$$

Moreover, we deduce from $\phi \in \mathcal{A}_{\omega}$ and (4.8) that $K_{\omega,0}(\phi) = 0$ and $\phi \neq 0$, which implies that $m_{\omega,0}^{\alpha,\beta} \leq S_{\omega,0}(\phi)$. Thus, $S_{\omega,0}(\phi) = m_{\omega,0}^{\alpha,\beta}$ ω, ω and then $\mathcal{G}_{\omega} \subset \mathcal{M}_{\omega}$. Therefore, we obtain that $\mathcal{G}_{\omega} = \mathcal{M}_{\omega}$. Hence, $m_{\omega,0}^{\alpha,\beta}$ $\alpha, \beta, \omega, 0$ is attained by the ground state Q_{ω} of [\(1.6\)](#page-3-1).

(ii) We introduce the functional

$$
J_{\omega,V}^{\alpha,\beta}(\phi) := S_{\omega,V}(\phi) - \frac{1}{2\alpha + (2 - b - n)\beta} K_{\omega,V}^{\alpha,\beta}(\phi)
$$
(4.11)

$$
= \frac{\beta}{4\alpha + 2(2 - b - n)\beta} \int [(2 - b)V + x \cdot \nabla V + (2 - b)\omega] |\phi|^2 dx
$$

$$
+ \frac{\alpha p - (2 - b + c)\beta}{(p + 2)[2\alpha + (2 - b - n)\beta]} ||\phi||_{c,p+2}^{p+2}.
$$

In particular, $J_{\omega,0}^{\alpha,\beta} = \tilde{J}_{\omega,0}^{\alpha,\beta}$ in case $V = 0$ and $\beta \ge 0$, which is defined in [\(4.1\)](#page-19-1).

By considering the following minimizing problem in terms of $J^{\alpha,\beta}_{\omega,V}$:

$$
n_{\omega,V}^{\alpha,\beta} := \inf \{ J_{\omega,V}^{\alpha,\beta}(\phi) : \phi \in W_b^{1,2} \setminus \{0\}, \ K_{\omega,V}^{\alpha,\beta}(\phi) \le 0 \},\
$$

we claim that

$$
n_{\omega,V}^{\alpha,\beta} = m_{\omega,V}^{\alpha,\beta}.
$$
\n(4.12)

Indeed, Let $\phi \in W_h^{1,2}$ ^{1,2}\{0} satisfy $K^{\alpha,\beta}_{\omega,V}(\phi) \leq 0$. If $K^{\alpha,\beta}_{\omega,V}(\phi) = 0$, by the definition of $m_{\omega,V}^{\alpha,\beta}$ and [\(4.11\)](#page-25-0), we obtain

$$
m_{\omega,V}^{\alpha,\beta} \le S_{\omega,V}(\phi) = J_{\omega,V}^{\alpha,\beta}(\phi).
$$

If else $K_{\omega,V}^{\alpha,\beta}(\phi) < 0$. From Lemma [4.2](#page-20-1) and the continuity of $K_{\omega,V}^{\alpha,\beta}(\lambda\phi)$ in λ , there exists $\lambda_0 \in (0, 1)$ such that $K_{\omega, V}^{\alpha, \beta}(\lambda_0 \phi) = 0$. Thus,

$$
m_{\omega,V}^{\alpha,\beta} \le S_{\omega,V}(\lambda_0 \phi) = J_{\omega,V}^{\alpha,\beta}(\lambda_0 \phi) < J_{\omega,V}^{\alpha,\beta}(\phi),
$$

where the last inequality is obtained by the fact that $J_{\omega,V}^{\alpha,\beta}(\lambda\phi)$ is monotone increasing in $\lambda \in (0, 1)$. Hence, we conclude that $n_{\omega, V}^{\alpha, \beta} \geq m_{\omega, V}^{\alpha, \beta}$.

To prove $n_{\omega,V}^{\alpha,\beta} \leq m_{\omega,V}^{\alpha,\beta}$, we assume $\phi \in W_b^{1,2}$ $b_1^{1,2} \setminus \{0\}$ satisfies $K_{\omega,V}^{\alpha,\beta}(\phi) = 0$. By the definition of $n_{\omega,V}^{\alpha,\beta}$ and [\(4.11\)](#page-25-0), we get $n_{\omega,V}^{\alpha,\beta} \leq J_{\omega,V}^{\alpha,\beta}(\phi) = S_{\omega,V}$. Thus we have $n_{\omega,V}^{\alpha,\beta} \leq m_{\omega,V}^{\alpha,\beta}$. Therefore, we conclude [\(4.12\)](#page-25-1).

Now, let $\phi \in W_h^{1,2}$ $b^{1,2} \setminus \{0\}$ satisfies $K^{\alpha,\beta}_{\omega,V}(\phi) = 0$. Then we obtain $S_{\omega,V}(\phi) = J^{\alpha,\beta}_{\omega,V}(\phi)$. Since $V \geq 0$ and $x \cdot \nabla V \leq 0$, we get $K_{\omega,0}^{\alpha,\beta}$ $\int_{\omega,0}^{\alpha,\beta}(\phi) \leq K_{\omega,V}^{\alpha,\beta}(\phi) = 0$. Thus it follows from [\(4.12\)](#page-25-1) that

$$
m_{\omega,0}^{\alpha,\beta} \le J_{\omega,0}^{\alpha,\beta}(\phi) \le J_{\omega,V}^{\alpha,\beta}(\phi) = S_{\omega,V}(\phi),
$$

which arrives at $m_{\omega,0}^{\alpha,\beta} \leq m_{\omega,V}^{\alpha,\beta}$. Hence, we finish the proof of Proposition [1.4.](#page-5-1)

4.3 Invariant Flow

In this part, we will prove that the sets \mathcal{N}^{\pm} defined in [\(1.15\)](#page-6-2) and [\(1.16\)](#page-6-3) are invariant under the flow of [\(1.1\)](#page-0-0).

We denote

$$
L_{\omega,V}(\phi) := \|\phi\|_{\dot{H}^1_{b,V}} + \omega \|\phi\|_2^2
$$

and the frequency

$$
\omega_1 := -\frac{1}{2} \inf_{x \in \mathbb{R}^n} [(2 - b)V + x \cdot \nabla V].
$$

The following lemma makes a comparison between $S_{\omega,V}(\phi)$ and $L_{\omega,V}(\phi)$.

Lemma 4.4. Let $b < 2, c \ge b-2, 2(2-b) < \mathbf{p}_c \le (2-b)(p+2),\; x \cdot \nabla V_+(2-b)V \ge 0$ and let (α, β) satisfy [\(1.13\)](#page-5-0). Assume $\omega \geq \omega_1$ and $\phi \in W_b^{1,2}$ ^{1,2} satisfies $K^{\alpha,\beta}_{\omega,V}(\phi) \geq 0$. Then

$$
2S_{\omega,V}(\phi) \le L_{\omega,V}(\phi) \le \frac{2\alpha(p+2) - 2(n+c)\beta}{\alpha p - (2-b+c)\beta} S_{\omega,V}(\phi).
$$

Proof. Since

$$
S_{\omega,V}(\phi) = \frac{1}{2}L_{\omega,V}(\phi) - \frac{1}{p+2}||\phi||_{c,p+2}^{p+2} \le \frac{1}{2}L_{\omega,V}(\phi),
$$

it is clear that the first inequality holds. To prove the second inequality, we rewrite [\(1.12\)](#page-5-3) as

$$
K_{\omega,V}^{\alpha,\beta}(\phi) = \frac{2\alpha + (2 - b - n)\beta}{2} L_{\omega,V}(\phi) - \frac{\alpha(p+2) - (n+c)\beta}{p+2} ||\phi||_{c,p+2}^{p+2}
$$

$$
-\frac{\beta}{2} \int [(2 - b)V + x \cdot \nabla V + (2 - b)\omega] |\phi|^2 dx,
$$

then we further have

$$
K_{\omega,V}^{\alpha,\beta}(\phi) + \frac{\alpha p - (2 - b + c)\beta}{2} L_{\omega,V}(\phi) = [\alpha(p+2) - (n+c)\beta]S_{\omega,V}(\phi)
$$

$$
- \frac{\beta}{2} \int [(2-b)V + x \cdot \nabla V + (2-b)\omega] |\phi|^2 dx
$$

$$
\leq [\alpha(p+2) - (n+c)\beta]S_{\omega,V}(\phi).
$$

Thus, together with $K^{\alpha,\beta}_{\omega,V}(\phi) \geq 0$, we infer that

$$
\frac{\alpha p - (2 - b + c)\beta}{2}L_{\omega, V}(\phi) \leq [\alpha(p+2) - (n+c)\beta]S_{\omega, V}(\phi).
$$

We prove this lemma.

Lemma 4.5. Let $2 - n < b < 2, b − 2 < c \le 0, \ 2(2 - b) < \mathbf{p}_c \le (2 - b)(p + 2), \ V ≥$ $0, -(2 - b)V \leq x \cdot \nabla V \leq 0$, $x\nabla^2 V x^T \leq -(n+3-b-\frac{2\alpha}{\beta})x \cdot \nabla V$ and let (α, β) satisfy [\(1.13\)](#page-5-0). Assume $\phi \in \mathcal{N}_{\alpha,\beta} := \{ \phi \in W_b^{1,2} \}$ $b_1^{1,2}: S_{\omega,V}(\phi) < m_{\omega,0}, K_{\omega,V}^{\alpha,\beta}(\phi) < 0\}.$ Then

$$
K^{\alpha,\beta}_{\omega,V}(\phi) \le -[2\alpha + (2-b-n)\beta](m_{\omega,0} - S_{\omega,V}(\phi)),\tag{4.13}
$$

where $\nabla^2 V$ is the Hessian matrix of V.

Proof. We write $g(\lambda) := S_{\omega, V}(\phi_{\lambda}^{\alpha, \beta})$ $_{\lambda}^{\alpha,\beta}$), where $\phi_{\lambda}^{\alpha,\beta}$ $\alpha^{\alpha,\beta}_\lambda(x) = e^{\alpha\lambda}\phi(e^{\beta\lambda}x)$. Then

g'(\lambda) = \frac{2\alpha + (2 - b - n)\beta}{2} e^{[2\alpha + (2 - b - n)\beta]\lambda} ||\nabla\phi||_{b,2}^2
$$

+
$$
\frac{2\alpha - n\beta}{2} e^{(2\alpha - n\beta)\lambda} (\omega ||\phi||_2^2 + \int V(e^{-\beta \lambda}x) |\phi|^2 dx)
$$

-
$$
\frac{\beta e^{[2\alpha - (n+1)\beta]\lambda}}{2} \int x \cdot \nabla V(e^{-\beta \lambda}x) |\phi|^2 dx
$$

-
$$
\frac{(p+2)\alpha - (n+c)\beta}{p+2} e^{[(p+2)\alpha - (n+c)\beta]\lambda} ||\phi||_{c,p+2}^{p+2}.
$$
 (4.14)

Since $\phi \in \mathcal{N}_{\alpha,\beta}$, we deduce that

$$
g'(0) = K^{\alpha,\beta}_{\omega,V}(\phi) < 0.
$$

By (4.2) , we get

$$
K_{\omega,V}^{\alpha,\beta}(\phi_{\lambda}^{\alpha,\beta}) = g'(\lambda) > 0
$$

 \Box

for sufficiently small $\lambda < 0$. Thus by the continuity of $g'(\lambda)$ in λ , there exists $\lambda_0 < 0$ such that

g'(\lambda_0) = 0 \quad \text{and} \quad g'(\lambda) < 0 \quad \text{for } \lambda \in (\lambda_0, 0]. \tag{4.15}
$$

Thus, by the definition of $m_{\omega,V}^{\alpha,\beta}$ and Proposition [1.4](#page-5-1) (ii), we have

m_{\omega,0} \le m_{\omega,V}^{\alpha,\beta} \le S_{\omega,V}(\phi_{\lambda_0}^{\alpha,\beta}) = g(\lambda_0). \tag{4.16}
$$

Now we differentiate $g'(\lambda)$ again to obtain

g''(\lambda) = \frac{[2\alpha + (2 - b - n)\beta]^2}{2} e^{[2\alpha + (2 - b - n)\beta]\lambda} ||\nabla \phi||_{b,2}^2
$$

+
$$
\frac{(2\alpha - n\beta)^2}{2} e^{(2\alpha - n\beta)\lambda} (\omega ||\phi||_2^2 + \int V(e^{-\beta \lambda}x) |\phi|^2 dx)
$$

+
$$
\frac{(2\alpha - n\beta)^2}{2} e^{(2\alpha - (n + 2)\beta]\lambda} \int x \cdot \nabla V(e^{-\beta \lambda}x) |\phi|^2 dx
$$

+
$$
\frac{\beta^2}{2} e^{[2\alpha - (n + 2)\beta]\lambda} \int x \nabla^2 V(e^{-\beta \lambda}x) x^T |\phi|^2 dx
$$

-
$$
\frac{[(p + 2)\alpha - (n + c)\beta]^2}{p + 2} e^{[(p + 2)\alpha - (n + c)\beta]\lambda} ||\phi||_{c, p+2}^{p+2}
$$

$$
\leq \frac{[2\alpha + (2 - b - n)\beta]^2}{2} e^{[2\alpha + (2 - b - n)\beta]\lambda} ||\nabla \phi||_{b,2}^2
$$

+
$$
\frac{(2\alpha - n\beta)^2}{2} e^{(2\alpha - n\beta)\lambda} (\omega ||\phi||_2^2 + \int V(e^{-\beta \lambda}x) |\phi|^2 dx)
$$

-
$$
\frac{\beta[2\alpha + (2 - b - n)\beta]}{2} e^{[2\alpha - (n + 1)\beta]\lambda} \int x \cdot \nabla V(e^{-\beta \lambda}x) |\phi|^2 dx
$$

-
$$
\frac{[(p + 2)\alpha - (n + c)\beta]^2}{p + 2} e^{[(p + 2)\alpha - (n + c)\beta]\lambda} ||\phi||_{c, p+2}^{p+2},
$$

which together with [\(4.14\)](#page-27-0) yields

$$
g''(\lambda) - [2\alpha + (2 - b - n)\beta]g'(\lambda)
$$

\n
$$
\leq -\frac{(2 - b)(2\alpha - n\beta)\beta}{2}e^{(2\alpha - n\beta)\lambda}(\omega||\phi||_2^2 + \int V(e^{-\beta\lambda}x)|\phi|^2 dx)
$$

\n
$$
-\frac{[(p+2)\alpha - (n+c)\beta][\alpha p - (2 - b + c)\beta]}{p+2}e^{[(p+2)\alpha - (n+c)\beta]\lambda}||\phi||_{c,p+2}^{p+2} \leq 0.
$$

Integrating the above inequality over $[\lambda_0, 0]$, we get

$$
g'(0) - g'(\lambda_0) \leq [2\alpha + (2 - b - n)\beta](g(0) - g(\lambda_0)).
$$

Thus, by [\(4.15\)](#page-28-0) and [\(4.16\)](#page-28-1), we have $K^{\alpha,\beta}_{\omega,V}(\phi) \leq -[2\alpha + (2-b-n)\beta](m_{\omega,0} - S_{\omega,V}(\phi)).$ Hence, Lemma [4.5](#page-27-1) is proved.

Proposition 4.6. Let $2-n < b < 2$, $b-2 < c \le 0$, $2(2-b) < p_c < (2-b)(p+2)$, $V \ge$ $0, -(2-b)V \leq x \cdot \nabla V \leq 0, x\nabla^2 V x^T \leq -(3-b)x \cdot \nabla V$. Then the sets \mathcal{N}^{\pm} are invariant under the flow of (1.1) .

Proof. Since $u_0 \in \mathcal{N}^+$, then $S_{\omega,V}(u_0) < m_{\omega,0}$ and $K_{\omega,V}^{n,2}(u_0) \geq 0$. We discuss it into two cases:

When $K^{n,2}_{\omega,V}(u_0) = 0$, if follows from the definition of $m^{n,2}_{\omega,V}$ and Proposition [1.4](#page-5-1) (ii) that

$$
m_{\omega,V}^{n,2} \le S_{\omega,V}(u_0) < m_{\omega,0} \le m_{\omega,V}^{n,2}.
$$

Thus we have $u_0 \equiv 0$, and then $u(x,t) \equiv 0$. Therefore, $u(t) \in \mathcal{N}^+$.

When $K^{n,2}_{\omega,V}(u_0) > 0$, we prove $u(t) \in \mathcal{N}^+$ by contradiction as follows. If the conclusion does not hold, then there exists $t_0 \in [0, T^*)$ such that $K^{n,2}_{\omega,V}(u(t_0)) = 0$. This implies that

$$
m_{\omega,V}^{n,2} \le S_{\omega,V}(u(t_0)).
$$

By Proposition [1.4](#page-5-1) and the conservation laws, we infer that

$$
S_{\omega,V}(u(t_0)) = S_{\omega,V}(u_0) < m_{\omega,0} \le m_{\omega,V}^{n,2},
$$

which arrives at a contradiction. Hence $u(t) \in \mathcal{N}^+$.

For $u_0 \in \mathcal{N}^-$, Lemma [4.5](#page-27-1) and the conservation laws imply that $K_{\omega, V}^{n, 2}(u) \le -2(2$ $b(m_{\omega,0} - S_{\omega,V}(u_0)) < 0$, which concludes $u(t) \in \mathcal{N}^-$.

5 Global existence and Blow-up for non-radial case

In this section, we prove Theorem [1.5](#page-6-1) and Corollary [1.7,](#page-6-4) of which the proof of blow-up relies on the method of Du-Wu-Zhang [\[9\]](#page-36-10). To start it, we establish the following L^2 estimate in the exterior ball.

Lemma 5.1. For $2 - n < b \le 0$. Let $u \in C([0,\infty);W_h^{1,2})$ $\binom{1,2}{b}$ be the solution to the $INLS_{h,V}$, which satisfies

$$
\sup_{t \in [0,\infty)} \|\nabla u(t)\|_{b,2} < \infty. \tag{5.1}
$$

Then there exists a constant $C > 0$ such that for any $\eta > 0$, $R > 0$ and $t \in$ $[0, \frac{\eta R^{1-b/2}}{C_1 C || u_0 ||}$ $\frac{\eta R^{1-\nu/2}}{C_1C\Vert u_0\Vert_2}$, the following estimate

$$
\int_{|x|>R} |u(x,t)|^2 dx \le o_R(1) + \eta
$$
\n(5.2)

holds, where $o_R(1)$ denotes a function of R satisfying $o_R(1) \rightarrow 0$ as $R \rightarrow \infty$.

 \Box

Proof of Lemma [5.1.](#page-29-0) Let $\psi_R(x) = \theta(\frac{x}{R})$ $\frac{x}{R}$) be a radial function defined as

$$
\theta(x) = \begin{cases} 0, & \text{if} \quad 0 \le |x| \le \frac{1}{2}, \\ \text{smooth}, & \text{if} \quad \frac{1}{2} < |x| < 1, \\ 1, & \text{if} \quad 1 \le |x|. \end{cases}

We note that there exists constant $C > 0$ such that $|\nabla \theta| \leq C$. Using [\(2.17\)](#page-11-4) in Lemma [2.7,](#page-11-1) $\nabla \psi_R = \frac{\nabla \phi_R}{|x|^b}$ $\frac{\sqrt{\varphi_R}}{|x|^b}$ and (5.1) , we have

$$
I_{\psi_R}(t) = I_{\psi_R}(0) + \int_0^t \frac{d}{ds} I_{\psi_R}(s) ds
$$

\n
$$
\leq I_{\psi_R}(0) + \int_0^t |2\text{Im} \int_{|x| \geq \frac{R}{2}} |x|^b \nabla \psi_R \cdot \nabla u \overline{u} dx| ds
$$

\n
$$
\leq I_{\psi_R}(0) + 2t \| |x|^{\frac{b}{2}} \nabla \psi_R \|_{L^\infty(|x| \geq \frac{R}{2})} \| \nabla u \|_{b,2} \| u \|_2
$$

\n
$$
\leq I_{\psi_R}(0) + \frac{C_1 C \| u_0 \|_2 t}{R^{1 - \frac{b}{2}}}
$$

for any $t \in [0, \infty)$, where $C_1 := \sup_{t \in [0, \infty)} ||\nabla u(t)||_{b,2}$. For $u_0 \in W_b^{1,2}$ $b^{1,2}$, one can see that

$$
I_{\psi_R}(0) = \int \psi_R(x) |u_0|^2 dx \le \int_{|x| \ge \frac{R}{2}} |u_0|^2 dx = o_R(1)
$$

and

$$
\int_{|x|>R}|u|^2dx\leq I_{\psi_R}(t).
$$

Thus we conclude [\(5.2\)](#page-29-2). The proof of Lemma [5.1](#page-29-0) is completed. \Box

Next, we give the following important result, which shows that there exists no global solution whose $L^q(|x|^{\frac{c(q-2)}{p}}dx)$ norms are uniformly bounded in time.

Lemma 5.2. Let $n \geq 3$, $2 - n < b \leq 0$, $V(x) \geq 0$ and $x \cdot \nabla V \in L^{\frac{n}{2}}(|x|^{-\frac{nb}{2}}dx)$. Let $u \in C([0,T^*);W_h^{1,2})$ $\mathcal{L}_b^{(1,2)}$ be the corresponding solution to the INLS_{b,V} with $u_0 \in W_b^{1,2}$ $\iota_b^{1,2}$. If there exists $\delta > 0$ such that the virial functional satisfies the bound

$$
\sup_{t \in [0,T^*)} P(u) \le -\delta,\tag{5.3}
$$

then there exists no global solution $u \in C([0,\infty);W_h^{1,2})$ $\binom{1,2}{b}$ with

$$
\sup_{t \in [0,\infty)} \|u(t)\|_{\frac{c(q-2)}{p},q} < \infty \qquad \text{for some } q > p+2. \tag{5.4}
$$

Proof. We assume by contradiction that there exists a global solution $u(t)$ to the $INLS_{b,V}$ such that

$$
T^* = \infty
$$
 and $C_0 := \sup_{t \in [0,\infty)} ||u(t)||_{\frac{c(q-2)}{p},q} < \infty$ (5.5)

for some $q > p+2$. Then we claim that there exists a constant $0 < C_1 = C_1(C_0, E_b(u_0))$, $M(u_0)$ < ∞ such that

$$
C_1 := \sup_{t \in [0,\infty)} \|\nabla u(t)\|_{b,2} < \infty. \tag{5.6}
$$

To see it, we invoke the following weighted interpolation relationship

$$
(L^{p_0}(w_0^{p_0}dx), \ L^{p_1}(w_1^{p_1}dx))_{\vartheta, \widetilde{q}} = L^{\widetilde{q}}(w_0^{(1-\vartheta)\widetilde{q}}w_1^{\vartheta\widetilde{q}}dx)
$$

cited in [\[11\]](#page-36-11), where $\frac{1}{\tilde{q}} = \frac{1-\vartheta}{p_0} + \frac{\vartheta}{p_1}$ and $0 < \vartheta < 1$, which can be applied to give

$$
||u||_{c,p+2} \le C||u||_{\frac{c(q-2)}{p},q}^{1-\vartheta}||u||_2^{\vartheta}
$$
\n(5.7)

for all $q > p + 2$. Since $V(x) \geq 0$, then it follows from the energy conservation and [\(5.7\)](#page-31-0) that

$$
\begin{aligned} \|\nabla u\|_{b,2} &\le 2E_{b,V}(u_0) + \frac{2}{p+2} \|u\|_{c,p+2}^{p+2} \\ &\le 2E_{b,V}(u_0) + \frac{2}{p+2} \|u\|_{\frac{c(q-2)}{p},q}^{(1-\vartheta)(p+2)} \|u\|_{2}^{\vartheta(p+2)}, \end{aligned}
$$

which together with (5.5) yields the result (5.6) .

Now we continue the argument of [\(5.4\)](#page-30-0). Recalling the functional $I_{\psi_R}''(t)$ defined in [\(2.24\)](#page-13-4), we claim that there exists $C = C(b, \mathbf{p}_c, C_0, C_2)$ and $\vartheta_q > 0$ such that the following nonradial version of the localized virial estimate

I_{\psi_R}''(t) \le 4(2-b)P(u) + C||u||_{L^2(|x|>R)}^{\vartheta_q(p+2)} + \frac{C}{R^{2-b}}||u||_{L^2(|x|>R)} + C||x \cdot \nabla V||_{L^{\frac{n}{2}}(|x|>R; |x|^{-\frac{n b}{2}}dx)} \tag{5.8}
$$

holds for $q > p + 2$.

Indeed, from [\(2.24\)](#page-13-4), the estimates for \mathcal{R}_1 and \mathcal{R}_2 are the same as in [\(2.25\)](#page-13-1) and (2.26) respectively, so it reduces to control the terms \mathcal{R}_3 and \mathcal{R}_4 .

For \mathcal{R}_3 , invoking the interpolation inequality [\(5.7\)](#page-31-0) again, we have ϑ_q with $0 < \vartheta_q =$ $\frac{2(q-p-2)}{(q-2)(p+2)} < 1$ such that

$$
\mathcal{R}_3 \leq C_{p,c} \|u\|_{L^q(|x|>R; |x| \frac{c(q-2)}{p} dx)}^{(1-\vartheta_q)(p+2)} \|u\|_{L^2(|x|>R)}^{\vartheta_q(p+2)} \leq C_{p,c} C_0^{(1-\vartheta_q)(p+2)} \|u\|_{L^2(|x|>R)}^{\vartheta_q(p+2)}.
$$
\n(5.9)

For \mathcal{R}_4 , it follows from (2.28) and (5.6) that

$$
\mathcal{R}_4 \le C_b C_1^2 \|x \cdot \nabla V\|_{L^{\frac{n}{2}}(|x|>R; \ |x|^{-\frac{nb}{2}}dx)}.
$$
\n(5.10)

Thus, putting (2.25) , (2.26) , (5.9) - (5.10) all together, we conclude the estimate (5.8) .

Finally, by (5.3) , (5.8) and Lemma [5.1,](#page-29-0) we have

$$
I_{\psi_R}''(s) \le -4(2-b)\delta + o_R(1) + C\eta^{\frac{\vartheta_q(p+2)}{2}} + \frac{CM(u_0)^{\frac{1}{2}}}{R^{2-b}} + C||x \cdot \nabla V||_{L^{\frac{n}{2}}(|x|>R; |x|^{-\frac{nb}{2}}dx)}
$$

$$
\le -4(2-b)\delta + C\eta^{\frac{\vartheta_q(p+2)}{2}} + o_R(1)
$$

for any $\eta > 0, R > 0$ and $s \in [0, \frac{\eta R^{1-\frac{b}{2}}}{C_1 C_2 || \eta_0}]$ $\frac{\eta R}{C_1 C_2 ||u_0||_2}$. We take $\eta = \eta_0 > 0$ sufficiently small such that $\vartheta_q(p+2)$

$$
C\eta^{\frac{\vartheta_q(p+2)}{2}} \le (4-2b)\delta,
$$

which yields

$$
I_{\psi_R}''(s) \le -(4 - 2b)\delta + o_R(1). \tag{5.11}
$$

Now we set

$$
T = T(R) := \alpha_0 R^{1 - \frac{b}{2}} = \frac{\eta_0 R^{1 - \frac{b}{2}}}{C_1 C - 2M(u_0)},
$$

where α_0 is independent of R. So, by integrating [\(5.11\)](#page-32-1) over $s \in [0, t]$ and then integrating over $t \in [0, T]$, one has

$$
I_{\psi_R}(T) \le I_{\psi_R}(0) + I'_{\psi_R}(0)\alpha_0 R^{1-\frac{b}{2}} + \left(-(4-2b)\delta + o_R(1)\right)\alpha_0^2 R^{2-b}.\tag{5.12}
$$

To proceed it, we claim that for $R \to \infty$,

$$
I_{\psi_R}(0) = o_R(1)R^{2-b}, \qquad I'_{\psi_R}(0) = o_R(1)R^{1-\frac{b}{2}}.
$$
\n(5.13)

Indeed, by $\nabla \psi_R = \frac{\nabla \phi_R}{|r|^b}$ $\frac{\sqrt{\varphi_R}}{|x|^b}$, defined as (2.23) , we deduce that

$$
I_{\psi_R}(0) \le \frac{2}{2-b} \int_{|x| \le \sqrt{R}} |x|^{2-b} |u_0|^2 dx + \int_{\sqrt{R} \le |x| \le 2R} (\int_0^x \frac{R^2 \nabla \Theta(\frac{x}{R})}{|x|^b} dx) |u_0|^2 dx
$$

$$
\le \frac{2}{2-b} R^{1-\frac{b}{2}} M(u_0) + CR^{2-b} \int_{|x| \ge \sqrt{R}} |u_0|^2 dx = o_R(1) R^{2-b}.
$$

On the other hand, we have

$$
I'_{\psi_R}(0) = 4\text{Im}\int_{|x|\leq\sqrt{R}} x \cdot \nabla u_0 \overline{u}_0 dx + 2 \int_{\sqrt{R}\leq |x|\leq 2R} R \partial_r \Theta(\frac{x}{R}) \frac{x \cdot \nabla u_0}{r} \overline{u}_0 dx
$$

\n
$$
\leq 4|||x|^{1-\frac{b}{2}}||_{L^{\infty}(|x|\leq \sqrt{R})} ||\nabla u_0||_{b,2} ||u_0||_2
$$

\n
$$
+2CR|||x|^{-\frac{b}{2}}||_{L^{\infty}(\sqrt{R}\leq |x|\leq 2R)} ||\nabla u_0||_{b,2} ||u_0||_{L^2(|x|\geq \sqrt{R})}
$$

\n
$$
\leq 4R^{\frac{2-b}{4}}||\nabla u_0||_{b,2} ||u_0||_2 + 2CR^{1-\frac{b}{2}}||\nabla u_0||_{b,2}o_R(1) = o_R(1)R^{1-\frac{b}{2}},
$$

which arrives at (5.13) .

Hence, combining (5.12) with (5.13) , and choosing R large enough, we infer that

$$
I_{\psi_R}(T) \le [-(4-2b)\delta\alpha_0^2 + o_R(1)]R^{2-b} \le -(2-b)\delta\alpha_0^2,
$$
\n(5.14)

which contradicts $I_{\psi_R}(T) = \int \psi_R(x) |u(x,T)|^2 dx \geq 0$. Hence, we finish the proof of Lemma [5.2.](#page-30-2)

 \Box

With the above lemmas in hand, we give the proof of Theorem [1.5.](#page-6-1)

Proof of Theorem [1.5.](#page-6-1) (i) Let $u_0 \in \mathcal{N}^+$, it follows from Proposition [4.6](#page-29-3) that the corresponding solution $u(t) \in \mathcal{N}^+$ for any $t \in [0, T^*)$. By the local well-posedness theory, we only need to control the $W_h^{1,2}$ $b^{1,2}$ -norm of $u(t)$.

To see it, we use Lemma [4.4](#page-26-0) and $V \geq 0$ to get

$$
C_{\omega}||u(t)||_{W_b^{1,2}}^2 \le L_{\omega,V}(u(t)) \le \frac{2\mathbf{p}_c}{\mathbf{p}_c - 4 + 2b} S_{\omega,V}(u(t)) < C m_{\omega,0}^{\alpha,\beta}
$$

for all $t \in [0, T^*)$, where C is a positive constant depending on b and \mathbf{p}_c . Thus we get $||u(t)||_{W_b^{1,2}}$ is bounded for any $t \in [0, T^*)$, and therefore $u(t)$ exists globally in $[0, \infty)$.

(ii) Let $u_0 \in \mathcal{N}^-$, we obtain $u(t) \in \mathcal{N}^-$ by Proposition [4.6.](#page-29-3) We now prove the blow-up results in two cases:

(1) If $T^* < +\infty$, the local well-posedness theory implies that $\lim_{t\to T^*} ||\nabla u(t)||_{b,2} =$ ∞.

(2) If $T^* = +\infty$. By Lemma [4.5,](#page-27-1) there exists

$$
\delta_1 := 2(m_{\omega,0}^{n,2} - S_{\omega,V}(u_0)) > 0
$$

such that

$$
P(u(t)) = \frac{1}{2 - b} K_{\omega, V}^{n, 2}(u(t)) \le -\delta_1
$$

for all $t \in [0, T^*)$. Thus, Lemma [5.2](#page-30-2) implies that there exists a time sequence $\{t_n\}$ such that $t_n \to \infty$ and

$$
\lim_{t_n \to \infty} ||u(t_n)||_{\frac{c(q-2)}{p},q} = \infty
$$
\n(5.15)

for any $q > p + 2$. For such $u(t_n)$, we use the Hardy-Sobolev inequality in Lemma [2.6](#page-10-4) to get

$$
||u(t_n)||_{\frac{c(q-2)}{p},q} \le C_b ||\nabla u(t_n)||_{b,2}
$$
\n(5.16)

for all $2(2 - b) < \mathbf{p}_c \le \frac{2c(2-b)}{b}$. Therefore, combining [\(5.15\)](#page-33-0) with [\(5.16\)](#page-33-1), we obtain

$$
\lim_{n\to\infty} \|\nabla u(t_n)\|_{b,2} = \infty.
$$

The proof of Theorem [1.5](#page-6-1) is completed. \Box

Finally, we give the proof of Corollary [1.7.](#page-6-4)

Proof of Corollary [1.7.](#page-6-4) From Theorem [1.5](#page-6-1) (ii), it is sufficient to show that (1.17) implies that $u_0 \in \mathcal{N}^-$.

Firstly, we claim that the following two conditions are equivalent:

$$
E_{b,V}(u_0)M(u_0)^{\sigma} < E_b(Q_1)M(Q_1)^{\sigma} \quad \Leftrightarrow \quad S_{\omega,V}(u_0) < m_{\omega,0}.\tag{5.17}
$$

Indeed, by Proposition [1.4,](#page-5-1) we obtain $m_{\omega,0} = S_{\omega,0}(Q_\omega)$, where $Q_\omega(x)$ is the ground state of the elliptic equation [\(1.6\)](#page-3-1). So for $\omega > 0$, we write

f(\omega) := S_{\omega,0}(Q_{\omega}) - S_{\omega,V}(u_0).
$$

Let $Q_{\omega} = \omega^{\frac{2-b+c}{(2-b)p}} Q_1(\omega^{\frac{1}{2-b}}x)$, one can easily check that $Q_1(x)$ satisfies the equation [\(1.6\)](#page-3-1) with $\omega = 1$. This implies that

$$
S_{\omega,0}(Q_{\omega}) = \omega^{\frac{(2-b)(p+2)-\mathbf{p}_c}{(2-b)p}} S_{1,0}(Q_1).
$$

By rewriting

$$
f(\omega) = \omega^{\frac{(2-b)(p+2)-\mathbf{p}_c}{(2-b)p}} S_{1,0}(Q_1) - S_{\omega,V}(u_0),
$$
\n(5.18)

we conclude that the claim [\(5.17\)](#page-34-0) is valid if and only if $\sup_{\omega>0} f(\omega) > 0$.

Since

$$
f'(\omega) = \frac{(2-b)(p+2) - \mathbf{p}_c}{(2-b)p} \omega^{\frac{2(2-b)-\mathbf{p}_c}{(2-b)p}} S_{1,0}(Q_1) - \frac{1}{2}M(u_0),
$$

we solve $f'(\omega_0) = 0$ and obtain

$$
\omega_0 = \left(\frac{(2-b)p}{2(2-b)(p+2) - 2\mathbf{p}_c} \frac{M(u_0)}{S_{1,0}(Q_1)}\right)^{\frac{(2-b)p}{2(2-b)-\mathbf{p}_c}} > 0.
$$

A simple calculation shows that the function f has a maximum value at $\omega = \omega_0$. Therefore, the statement $S_{\omega,V}(u_0) < m_{\omega,0}$ holds if and only if $f(\omega_0) > 0$.

Substituting ω_0 into [\(5.18\)](#page-34-1), we have

$$
f(\omega_0) = \left(\frac{2(2-b)(p+2) - 2\mathbf{p}_c}{(2-b)p}\right)^{\frac{(2-b)p}{\mathbf{p}_c - 4 + 2b}} \frac{\mathbf{p}_c - 4 + 2b}{2(2-b)(p+2) - 2\mathbf{p}_c}
$$

$$
\times \frac{S_{1,0}(Q_1)^{\frac{(2-b)p}{\mathbf{p}_c - 4 + 2b}}}{M(u_0)^{\frac{(2-b)(p+2) - \mathbf{p}_c}{\mathbf{p}_c - 4 + 2b}}} - E_{b,V}(u_0).
$$

Thus it follows from $f(\omega_0) > 0$ that

$$
\left(\frac{2(2-b)(p+2)-2p_c}{(2-b)p}\right)^{\frac{(2-b)p}{p_c-4+2b}} \frac{p_c-4+2b}{2(2-b)(p+2)-2p_c} S_{1,0}(Q_1)^{\frac{(2-b)p}{p_c+2b-4}} \times E_{b,V}(u_0)M(u_0)^{\sigma}, \tag{5.19}
$$

where σ is defined in [\(1.3\)](#page-1-1).

Recalling the Pohozaev identities (2.4) related to Q_1 , we deduce that

$$
S_{1,0}(Q_1) = \frac{(2-b)p}{2\mathbf{p}_c} \|\nabla Q_1\|_{b,2}^2
$$

and

$$
E_b(Q_1)M(Q_1)^{\sigma} = \left(\frac{(2-b)(p+2)}{\mathbf{p}_c} - 1\right)^{\frac{(2-b)(p+2)-\mathbf{p}_c}{\mathbf{p}_c - 4 + 2b}} \frac{\mathbf{p}_c - 4 + 2b}{2\mathbf{p}_c} \|\nabla Q_1\|_{b,2}^{\frac{2(2-b)p}{\mathbf{p}_c - 4 + 2b}},
$$

which yields that

L.H.S. of (5.19) =
$$
E_b(Q_1)M(Q_1)^{\sigma}
$$
.

Hence, we obtain $E_b(Q_1)M(Q_1)^\sigma > E_{b,V}(u_0)M(u_0)^\sigma$.

Next, we need to show that [\(1.17\)](#page-6-0) implies that

$$
K^{n,2}_{\omega,V}(u_0) < 0. \tag{5.20}
$$

To this end, by the definition of the functional P and (3.4) , we get

$$
P(u_0) \leq \|\nabla u_0\|_{b,2}^2 + \int V(x)|u_0|^2 dx - \frac{\mathbf{p}_c}{(p+2)(2-b)}\|u_0\|_{c,p+2}^{p+2}
$$

=
$$
\frac{\mathbf{p}_c}{2-b} E_{b,V}(u_0) - \left(\frac{\mathbf{p}_c}{4-2b} - 1\right) \|u_0\|_{\dot{H}_{b,V}^1}^2
$$

$$
< \frac{\mathbf{p}_c}{2-b} \frac{E_b(Q_1)M(Q_1)^\sigma}{M(u_0)^\sigma} - \left(\frac{\mathbf{p}_c}{4-2b} - 1\right) \frac{\|\nabla Q_1\|_{b,2}^2 \|Q_1\|_2^{2\sigma}}{\|u_0\|_2^{2\sigma}},
$$

so it follows from the Pohozaev's identities and (1.17) that $P(u_0) < 0$, and then (5.20) is proved.

Finally, combining [\(5.17\)](#page-34-0) with [\(5.20\)](#page-35-1), we conclude that $u_0 \in \mathcal{N}^-$. Corollary [1.7](#page-6-4) is proved.
