MODULAR Z2**-CROSSED TAMBARA-YAMAGAMI-LIKE CATEGORIES FOR EVEN GROUPS**

ABSTRACT. We explicitly construct nondegenerate braided \mathbb{Z}_2 -crossed tensor categories of the form $Vect_{\Gamma}/2\Gamma$. They are \mathbb{Z}_2 -crossed extensions, in the sense of [\[ENO10\]](#page-45-0), of the braided tensor category Vect_Γ with \mathbb{Z}_2 -action given by $-i$ d on the finite, abelian group Γ. Thus, we obtain generalisations of the Tambara-Yamagami categories [\[TY98,](#page-46-0) [Gal22\]](#page-45-1), where now the abelian group Γ may have even order and the nontrivial sector $Vect_{\Gamma/2\Gamma}$ more than one simple object.

The idea for this construction comes from a physically motivated approach in [\[GLM24\]](#page-46-1) to construct \mathbb{Z}_2 -crossed extensions of Vect_Γ for any Γ from an infinite Tambara-Yamagami category Vect_{$p d$} ⊕ Vect, which itself is not fully rigorously defined, and then using condensation from $Vect_{\mathbb{R}^d}$ to $Vect_{\Gamma}$, which we prove commutes with crossed extensions.

The Z₂-equivariantisation of Vect_Γ ⊕ Vect_{Γ/2Γ} yields new modular tensor categories, which correspond to the orbifold of an arbitrary lattice vertex operator algebra under a lift of −id, as discussed in [\[GLM24\]](#page-46-1).

1. INTRODUCTION

Braided tensor categories and their specialisations, such as modular tensor categories, have emerged as important structures in low-dimensional physics, in particular 2-dimensional conformal field theories (e.g., in the form of vertex operator algebras or conformal nets) and topological phases of matter. In the presence of an action of a finite group *G*, this notion is naturally modified to that of a braided *G*-crossed tensor category in the sense of [\[Tur00\]](#page-46-2).

At the centre of this article is the notion of a braided *G*-crossed extension, i.e. a braided *G*-crossed tensor category extending a given braided tensor category [\[ENO10\]](#page-45-0). More precisely, given a braided tensor category β together with an action of a finite group *G* by braided tensor autoequivalences, a *braided G-crossed extension* $C \supset \mathcal{B}$ is a *G*-graded tensor category $C = \bigoplus_{g \in G} C_g$ equipped with a *G*-action

satisfying $g_*\mathcal{C}_h = \mathcal{C}_{ghg^{-1}}$ and with a *G*-crossed braiding $\mathcal{C}_g \otimes \mathcal{C}_h \to \mathcal{C}_{ghg^{-1}} \otimes \mathcal{C}_g$ such that the identity component is $C_1 = \mathcal{B}$ with the given braiding and *G*-action.

For a braided *G*-crossed extension $\mathcal{B} \subset \mathcal{C}$, the *G*-equivariantisation $\mathcal{C}/\!\!/ G$, also referred to as gauging of β by *G*, is a braided tensor category extending β/γ *G*.

Braided *G*-crossed extensions are essential for understanding representation categories of (suitably regular) vertex operator algebras [\[McR21\]](#page-46-3), as we discuss in more detail in [\[GLM24\]](#page-46-1). See, e.g., [\[GJ19,](#page-45-3) [DNR21,](#page-45-4) [GR24\]](#page-46-4) for some applications.

In this article, we study braided *G*-crossed extensions of *pointed* braided fusion categories β [\[JS93,](#page-46-5) [EGNO15\]](#page-45-5). The latter have the defining property that all their simple objects are invertible, i.e. they are of the form $\mathcal{B} = \text{Vect}_{\Gamma}^Q$ for some finite, abelian group Γ and a quadratic form *Q* on Γ determining the braiding and associator. In the context of lattices, such pairs (Γ*, Q*) appear as discriminant forms, for which *Q* nondegenerate.

Perhaps the easiest nontrivial examples are the Tambara-Yamagami categories, which provide *G*-crossed extensions of $Vect^Q_\Gamma$ for $G = \mathbb{Z}_2$ acting on Γ by multiplication with -1 . Indeed, in [\[TY98\]](#page-46-0), Tambara and Yamagami classified the \mathbb{Z}_2 -graded fusion categories C with exactly one noninvertible simple object in the graded component of nontrivial degree $g \in \mathbb{Z}_2$, i.e. of the form

$$
C = C_1 \oplus C_g = \text{Vect}_{\Gamma}^Q \oplus \text{Vect}.
$$

In general, this fusion category does not admit a braiding, but with the *G*-action above, there exist *G*-crossed braidings, which were classified in [\[Gal22\]](#page-45-1). This produces two explicit \mathbb{Z}_2 -crossed extensions $\mathcal{C} = \text{Vect}_{\Gamma}^Q[\mathbb{Z}_2, \varepsilon], \, \varepsilon \in \{\pm 1\}, \text{ of } \mathcal{B} = \text{Vect}_{\Gamma}^Q,$ see [Corollary 4.8.](#page-16-1) Finding precisely two *G*-crossed extensions of the given β with the given categorical action of G on β matches the general classification result for braided *G*-crossed extensions in [\[ENO10,](#page-45-0) [DN21\]](#page-45-6); see [Theorem 3.11.](#page-8-0)

One is especially interested in cases where the \mathbb{Z}_2 -crossed braiding, and thus in particular the given braiding on $Vect_{\Gamma}$, i.e. the quadratic form Q , is nondegenerate. In this case, the \mathbb{Z}_2 -equivariantisation \mathcal{C}/\mathbb{Z}_2 is a modular tensor category (see [Proposition 4.7\)](#page-15-0), which was described in [\[GNN09\]](#page-46-6). The definition of the Tambara-Yamagami category requires that on Vect^{*Q*} the associator is trivial and the quadratic form *Q* admits a quadratic form *q* with $Q = q^2$, which appears in the braiding and associator involving the *g*-graded component. In the nondegenerate case, this necessarily means that the group Γ has *odd order* or, equivalently, that *G* acts on Γ with the only fixed point 0.

In this article, we generalise the results in [\[TY98,](#page-46-0) [Gal22\]](#page-45-1) by constructing braided \mathbb{Z}_2 -crossed extensions \mathcal{C} of $\mathcal{B} = \text{Vect}_{\Gamma}^Q$ with the quadratic form Q nondegenerate and the finite, abelian group Γ of *arbitrary order* where $G \cong \mathbb{Z}_2$ still acts (as a certain categorical action, cf. [Remark 5.13\)](#page-25-0) by multiplication with −1 on Γ.

Theorem [5.12.](#page-24-0) For $\varepsilon \in \{\pm 1\}$, the data given in [Section 5.2](#page-22-0) define a \mathbb{Z}_2 -crossed *ribbon fusion category*

$$
\mathcal{C} = \text{Vect}_{\Gamma}^Q[\mathbb{Z}_2, \varepsilon] = \text{Vect}_{\Gamma}^Q \oplus \text{Vect}_{\Gamma/2\Gamma},
$$

which is a braided \mathbb{Z}_2 -crossed extension of Vect_{Γ}^Q for a discriminant form (Γ, Q) with *the above categorical* \mathbb{Z}_2 -action. It is equipped with a natural choice of \mathbb{Z}_2 -ribbon *structure for which all quantum dimensions are positive.*

The definition of the \mathbb{Z}_2 -crossed braiding on C again depends on a (special) choice of square root *q* of the quadratic form *Q* on Γ (see [Proposition 5.8\)](#page-21-0).

By the classification of braided *G*-crossed extensions [\[ENO10,](#page-45-0) [DN21\]](#page-45-6), for each ε , there is a unique braided \mathbb{Z}_2 -crossed extension $Vect^Q_\Gamma[\mathbb{Z}_2,\varepsilon]$ of $Vect^Q_\Gamma$ with the given \mathbb{Z}_2 -action. Can we verify this directly from our construction (see [Problem 1\)](#page-25-1)?

We also compute the \mathbb{Z}_2 -equivariantisation \mathcal{C}/\mathbb{Z}_2 , which is again a modular tensor category (see [Proposition 5.14\)](#page-25-2). In particular, we determine the simple objects, fusion rules and modular data of \mathcal{C}/\mathbb{Z}_2 (see [Proposition 5.15,](#page-25-3) [Proposition 5.16,](#page-26-0) [Proposition 5.18\)](#page-26-1).

The input data for the construction of the above braided \mathbb{Z}_2 -crossed categories are taken from [\[GLM24\]](#page-46-1), where they are produced by using the idea that braided *G*crossed extensions commute in a certain sense with condensations by commutative, associative algebra objects. Concretely, this idea is applied to the situation

$$

\text{Vect}_\Gamma^Q & \xrightarrow{\mathbb{Z}_2\text{-crossed ext.}} & \text{Vect}_\Gamma^Q[\mathbb{Z}_2, \varepsilon]\n\end{array}
$$

where (Γ*, Q*) is realised as an isotropic subgroup (meaning an even lattice *L*) of the quadratic space $(\mathbb{R}^d, \overline{Q})$. While the infinite Tambara-Yamagami category $\mathrm{Vect}_{\mathbb{R}^d}^{\bar{Q}} \oplus \mathrm{Vect}$ is not fully rigorous, we can still use the data obtained in [\[GLM24\]](#page-46-1) as the data that *should* define $Vect^Q_{\Gamma}[\mathbb{Z}_2, \varepsilon]$ and then verify the coherence conditions explicitly (see [Section 6\)](#page-33-0). This yields the rigorous (but without [\[GLM24\]](#page-46-1) ad hoc seeming) definition of the braided \mathbb{Z}_2 -crossed extension $\mathrm{Vect}_{\Gamma}^Q[\mathbb{Z}_2,\varepsilon]$ of Vect_{Γ}^Q given in this paper.

Outline. In [Section 2,](#page-3-0) we briefly recall discriminant forms and lattices.

In [Section 3,](#page-3-1) we recall braided *G*-crossed tensor categories. We also introduce *G*-ribbon structures and discuss pseudo-unitarity in that context.

As a first example, in [Section 4,](#page-13-0) we describe Tambara-Yamagami categories as braided \mathbb{Z}_2 -crossed extensions of pointed braided fusion categories.

Then, in [Section 5.2,](#page-22-0) we define the generalisations of the Tambara-Yamagami categories where the abelian group Γ describing the underlying pointed braided fusion category may be of even order. The necessary input data are defined in [Section 5.1.](#page-17-0) In [Section 5.3,](#page-25-4) we describe the equivariantisations. In [Section 5.4](#page-30-0) we describe these categories explicitly in terms of lattice data. The proof of the main theorem, [Theorem 5.12,](#page-24-0) is given in [Section 6.](#page-33-0)

Notation. Unless stated otherwise, all vector spaces will be over the base field C. Categories will be enriched over $Vect = Vect_C$, but we could equally well take any algebraically closed field of characteristic zero. By \mathbb{Z}_n we shall always mean the cyclic group $\mathbb{Z}/n\mathbb{Z}$. We write $e(x) = e^{2\pi ix}$.

Throughout the text, we denote by *G* a (usually finite) group, written multiplicatively, with *g* denoting an arbitrary element of *G*. However, in the special case of $G = \langle g \rangle \cong \mathbb{Z}_2$, we denote by *g* the nontrivial element of *G*. By contrast, Γ always denotes an abelian group, which we write additively. Quadratic forms on Γ are usually written multiplicatively with values in \mathbb{C}^{\times} ; they are related to the usual notion of quadratic forms with values in \mathbb{Q}/\mathbb{Z} or \mathbb{R}/\mathbb{Z} via e(·).

2. Lattices and Discriminant Forms

By a (rational) *lattice*, we mean a free abelian group *L* of finite rank equipped with a nondegenerate bilinear form $\langle \cdot, \cdot \rangle: L \times L \to \mathbb{Q}$. The lattice *L* is called *integral* if ⟨*v, w*⟩ ∈ Z for all *v, w* ∈ *L*. If ⟨*v, v*⟩ ∈ 2Z for all *v* ∈ *L*, then *L* is called *even*. An integral lattice that is not even is called *odd*. Given a lattice *L*, we denote by $L^* = \{v \in L \otimes_{\mathbb{Z}} \mathbb{Q} \mid \langle v, w \rangle \in \mathbb{Z} \text{ for all } w \in L\}$ the *dual* of *L*, embedded via $\langle \cdot, \cdot \rangle$ into the ambient space of *L*.

If *L* is even, then $L \subset L^*$ and the quotient L^*/L is a finite, abelian group endowed with a nondegenerate quadratic form $Q: L^*/L \to \mathbb{C}^\times$ given by $Q(v+L) = e(\langle v, v \rangle/2)$ for all $v \in L^*$. In that situation, we call L^*/L the *discriminant form* of L.

More generally, we call any pair (Γ, Q) of a finite, abelian group Γ together with a nondegenerate quadratic form *Q*: Γ → C [×] a *discriminant form* (sometimes called *metric group*). The function *Q* being quadratic means that $Q(na) = Q(a)^{n^2}$ for all $a \in \Gamma$ and $n \in \mathbb{Z}$ and that $B_Q: \Gamma \times \Gamma \to \mathbb{C}^\times$ with $B_Q(a, b) := Q(a+b)Q(a)^{-1}Q(b)^{-1}$ for $a, b \in \Gamma$ is bimultiplicative (and nondegenerate). We call B_{Ω} the *associated bimultiplicative form*. Any discriminant form (Γ*, Q*) can be realised as dual quotient L^*/L for some even lattice L [\[Nik80\]](#page-46-7).

Given two discriminant forms (Γ_1, Q_1) and (Γ_2, Q_2) , we denote their (orthogonal) direct sum by $(\Gamma_1 \oplus \Gamma_2, Q_1 \oplus Q_2)$, which represents the group $\Gamma_1 \oplus \Gamma_2$ with the quadratic form $Q_1 \oplus Q_2$ defined by $(Q_1 \oplus Q_2)((a_1, a_2)) = Q_1(a_1)Q_2(a_2)$.

A discriminant form is called *indecomposable* if it cannot be written as an orthogonal direct sum of two nonzero discriminant forms. Such discriminant forms are also referred to as indecomposable Jordan components. [Table 1](#page-3-2) describes the indecomposable Jordan blocks (see, e.g., [\[CS99,](#page-45-7) [Sch09\]](#page-46-8)). Here, $k \in \mathbb{Z}_{>0}$, p is an odd prime and $\left(\frac{1}{2}\right)$ denotes the Kronecker symbol.

3. Braided *G*-Crossed Tensor Categories

In this section, we introduce the main categorical notions relevant for this text, in particular braided *G*-crossed tensor categories and braided *G*-crossed extensions. We also state the results from [\[ENO10,](#page-45-0) [DN21\]](#page-45-6) on the classification of the latter. Then, we describe *G*-ribbon structures, pseudo-unitarity and their relation to the *G*-equivariantisation.

3.1. **Tensor Categories and** *G***-Actions.** In this text, tensor categories are Clinear abelian monoidal categories, similar to [\[DGNO10\]](#page-45-8). Moreover, we consider braided tensor categories, rigid tensor categories and ribbon categories. A fusion category is a tensor category that is finite, semisimple, rigid and has a simple tensor unit **1**, as in [\[EGNO15\]](#page-45-5). A modular tensor category is a ribbon fusion category with nondegenerate braiding.

A rigid tensor category is called *pointed* if every simple object is invertible (or a simple current). In the following, we consider the typical description of pointed (braided) fusion categories associated with finite (abelian) groups and some cohomological data (see, e.g., [\[JS93,](#page-46-5) [EGNO15\]](#page-45-5)).

Example 3.1 (Pointed Fusion Categories)**.** Suppose that *G* is a finite group and $\omega \in Z^3(G, \mathbb{C}^\times)$ a 3-cocycle. Consider the pointed fusion category Vect_G^ω of *G*-graded vector spaces, where the simple objects are \mathbb{C}_g , $g \in G$, and the tensor product is given by $\mathbb{C}_g \otimes \mathbb{C}_h = \mathbb{C}_{gh}$ with associator

$$
(\mathbb{C}_g\otimes \mathbb{C}_h)\otimes \mathbb{C}_k\xrightarrow{\omega(g,h,k)}\mathbb{C}_g\otimes (\mathbb{C}_h\otimes \mathbb{C}_k)
$$

for all $g, h, k \in G$. The pentagon identity for the associator holds precisely because *ω* is a 3-cocycle.

Example 3.2 (Pointed Braided Fusion Categories)**.** Let Γ be a finite, abelian group and $(\sigma, \omega) \in Z^3_{ab}(\Gamma, \mathbb{C}^\times)$ an abelian 3-cocycle on it [\[EM50\]](#page-45-9). We denote by $\mathrm{Vect}_{\Gamma}^{\sigma,\omega}$ the pointed braided fusion category given by the above fusion category Vect_{μ}^{ω} equipped with the braiding

$$
\mathbb{C}_a\otimes \mathbb{C}_b\xrightarrow{\sigma(a,b)}\mathbb{C}_b\otimes \mathbb{C}_a
$$

for $a, b \in \Gamma$. The hexagon identity for the braiding corresponds exactly to the defining property of an abelian 3-cocycle, i.e.

(1)
$$
\frac{\omega(b,a,c)}{\omega(a,b,c)\omega(b,c,a)} = \frac{\sigma(a,b+c)}{\sigma(a,b)\sigma(a,c)}, \quad \frac{\omega(a,b,c)\omega(c,a,b)}{\omega(a,c,b)} = \frac{\sigma(a+b,c)}{\sigma(a,c)\sigma(b,c)}
$$

for $a, b, c \in \Gamma$, in addition to the 3-cocycle property of ω . If $\omega = 1$, [\(1\)](#page-4-0) states that σ is bimultiplicative; else, ω measures its deviation from bimultiplicativity.

Abelian 3-coboundaries are of the form $(\sigma_{\kappa}, d\kappa)$ with $\sigma_{\kappa}(a, b) := \kappa(a, b)\kappa(b, a)^{-1}$ for any function $\kappa: \Gamma \times \Gamma \to \mathbb{C}^{\times}$, and they correspond to braided tensor equivalences $\mathrm{Vect}_{\Gamma}^{\sigma,\omega} \cong \mathrm{Vect}_{\Gamma}^{\sigma,\omega}$ that map each object \mathbb{C}_a to itself but with a possibly nontrivial tensor structure given by *κ*. Hence, cohomology classes of abelian 3-cocycles on Γ correspond to equivalence classes of braided tensor categories on the abelian category $Vect_{\Gamma}$ with the given tensor product.

The abelian 3-cocycles (σ, ω) , up to coboundaries, correspond bijectively to quadratic forms $Q: \Gamma \to \mathbb{C}^{\times}$, as shown in [\[EM50\]](#page-45-9). Recall that $B_Q: \Gamma \times \Gamma \to \mathbb{C}^{\times}$ with $B_Q(a, b) = Q(a + b)Q(a)^{-1}Q(b)^{-1}$ for $a, b \in \Gamma$ denotes the associated bimultiplicative form. In this correspondence, $B_Q(a, b) = \sigma(a, b)\sigma(b, a)$ is the double-braiding and $Q(a) = \sigma(a, a)$ the self-braiding. If the quadratic form Q is nondegenerate, meaning that B_Q is, then the braiding is nondegenerate. We denote by Vect_{Γ}^Q the equivalence class of braided tensor categories corresponding to a cohomology class of abelian 3-cocycles defined by the quadratic form *Q* on Γ.

There is a rigid structure $\mathbb{C}_a^* = \mathbb{C}_{-a}, a \in \Gamma$, with the obvious evaluation and coevaluation. There is also a canonical choice of a ribbon structure $\theta_{\mathbb{C}_a} = Q(a)$. As we shall discuss in [Section 3.4](#page-8-1) and [Section 3.5,](#page-12-0) this is the unique choice of ribbon structure for which all simple objects \mathbb{C}_a have quantum dimension 1, thus coinciding with the Frobenius-Perron dimension. This is known as the pseudo-unitary choice. All possible ribbon structures differ from this by a homomorphism $\Gamma \to {\pm 1}$.

If |Γ| is odd, then the cohomology class associated with the quadratic form *Q* on Γ can be represented by a distinguished abelian 3-cocycle (σ, ω) with $\omega = 1$ and $\sigma(a, b) = B_Q^{1/2}(a, b)$ for $a, b \in \Gamma$. Here, we recall that when the abelian group Γ has odd order, every bimultiplicative map $B: \Gamma \times \Gamma \to \mathbb{C}^\times$ has a unique bimultiplicative square root $B^{1/2}$; an analogous statements holds for quadratic forms.

We describe group actions on tensor categories:

Definition 3.3. Let \mathcal{C} be a tensor category with the associativity constraint given by $(X \otimes Y) \otimes Z \stackrel{\alpha}{\to} X \otimes (Y \otimes Z)$ and *G* a finite group. Then a *G*-action on *C* consists of the following data:

(i) For every element $g \in G$, a functor

 $g_* : \mathcal{C} \to \mathcal{C}.$

We denote the image of an object $X \in \mathcal{C}$ by $g_*(X)$ and that of a morphism *f* by $q_*(f)$.

(ii) For every pair of elements $g, h \in G$, a natural isomorphism

$$
T_2^{g,h}(X)\colon (gh)_*(X)\to g_*(h_*(X))
$$

such that associativity holds: for all $q, h, l \in G$,

$$
T_2^{g,h}(l_*(X)) \circ T_2^{gh,l}(X) = g_*(T_2^{h,l}(X)) \circ T_2^{g,hl}.
$$

(iii) A tensor structure τ^g on each functor g_* , i.e. for every $g \in G$ and every pair of objects $X, Y \in \mathcal{C}$, a natural isomorphism

$$
\tau^g_{X,Y} \colon g_*(X \otimes Y) \to g_*(X) \otimes g_*(Y)
$$

such that the diagrams

$$
g_{*}((X \otimes Y) \otimes Z) \stackrel{\tau^g}{\longrightarrow} g_{*}(X \otimes Y) \otimes g_{*}(Z) \stackrel{\tau^g}{\longrightarrow} (g_{*}(X) \otimes g_{*}(Y)) \otimes g_{*}(Z)
$$

commute for all $q, h \in G$.

A *G*-action is called *strict* if all the monoidal functors (g_*, τ^g) are strict and the natural transformations T_2 are equalities.

Remark 3.4. The data of an action of G on $\mathcal C$ is equivalent to a tensor functor from the discrete tensor category *G*, where the set *G* serves as objects and the tensor product is defined by the multiplication in *G*, to the tensor category of tensor functors $Aut_{\infty}(\mathcal{C})$ along with monoidal natural isomorphisms.

Given a *G*-action on a tensor category, we can define the following category, whose objects arise from *G*-invariant objects of the original tensor category.

Definition 3.5. Let \mathcal{C} be a tensor category and G a finite group acting on \mathcal{C} . The *G*-equivariantisation of C, denoted by $C/\!\!/ G$, is the tensor category with objects the pairs (X, φ) where $X \in \mathcal{C}$ and φ is a family of isomorphisms, $\varphi_g : g_*(X) \to X$ for each $g \in G$, satisfying

$$
\varphi_{gh} = \varphi_g \circ g_*(\varphi_h) \circ T_2^{g,h}
$$

for $g, h \in G$. Morphisms $f: (X, \varphi) \to (Y, \varphi')$ in $\mathcal{C}/\!\!/ G$ satisfy

$$
\varphi'_g \circ g_*(f) = f \circ \varphi_g.
$$

The tensor product is $(X, \varphi) \otimes (Y, \varphi') = (X \otimes Y, \varphi'')$ with

$$
\varphi''_g=\varphi_g\otimes\varphi'_g\circ\tau^g_{X,Y},
$$

and the tensor unit is $(1, id₁)$.

We describe the simple objects of $\mathcal{C}/\!\!/ G$. The group G acts on the set Irr(C) of equivalence classes of simple objects. Fixing a representative X_i for every orbit and denoting the corresponding stabiliser subgroup by *Gⁱ* , we can choose isomorphisms $t_g: g_*(X_i) \to X_i$. The action restricted to G_i defines a 2-cocycle $\chi_i \in Z^2(G_i, \mathbb{C}^\times)$,

(2)
$$
\chi_i(g, h) \mathrm{id}_{X_i} = t_{gh}^{-1} \circ t_g \circ g_*(t_h) \circ T_2^{g, h}.
$$

The cohomology class of χ_i does not depend on the choice of $\{t_g \mid g \in G_i\}$. The simple objects of \mathcal{C}/\mathcal{G} , up to isomorphism, are in bijection with isomorphism classes of irreducible χ_i -projective representations of G_i for every *i*. For more details on the correspondence, see [\[BN13\]](#page-45-10).

Example 3.6. Let $G = \langle g \rangle \cong \mathbb{Z}_2$ be a cyclic group of order 2 acting on a tensor category C. In this case, the classification of simple objects of \mathcal{C}/\mathcal{G} is straightforward. If a simple object *X* has a trivial stabiliser, then $X^g := X \oplus g_*(X)$ is an equivariant object with $\varphi_g = \mathrm{id}_{g_*(X)} \oplus T_2^{g,g}(X)$. If the stabiliser is \tilde{G} , then take $t_g: g_*(X) \to X$ and, using the equation [\(2\)](#page-6-0), define $\gamma = \chi(g,g)^{-1/2}$. The isomorphisms $\varphi_g^{(\pm)} = \pm \gamma t_g : g_*(X) \to X$ endow X with two nonisomorphic equivariant structures.

3.2. **Braided** *G***-Crossed Tensor Categories.** We now endow the categories from the previous section with the additional structure of a braiding. The so obtained braided *G*-crossed tensor categories (see, e.g., [\[Tur00,](#page-46-2) [EGNO15\]](#page-45-5)) are the central objects in this text.

For a tensor category C and a group G, a (faithful) G-grading on C is a decomposition $C = \bigoplus_{g \in G} C_g$ such that the tensor product ⊗ maps $C_g \times C_h$ to C_{gh} , the unit object is in \mathcal{C}_1 and $\mathcal{C}_g \neq 0$ for all $g \in G$.

Definition 3.7. A *braided G*-crossed tensor category is a tensor category C endowed with the following structures:

- (i) an action of G on \mathcal{C} ,
- (ii) a faithful *G*-grading $C = \bigoplus_{g \in G} C_g$,
- (iii) isomorphisms, called the *G-braiding*,

$$
c_{X,Y}: X \otimes Y \to g_*(Y) \otimes X
$$

for $g \in G$, $X \in \mathcal{C}_g$, $Y \in \mathcal{C}$, natural in *X* and *Y*.

These structures are subject to the following conditions, where we omit the associativity constraints in the diagrams for better readability:

(a) $g_*(\mathcal{C}_h) \subset \mathcal{C}_{ghg^{-1}}$ for all $g, h \in G$.

(b) The diagrams

$$
g_*(X \otimes Y) \xrightarrow{g_*(c_{X,Y})} g_*(h_*(Y) \otimes X)
$$

$$
\downarrow \tau_{X,Y}^g \qquad \qquad \downarrow T_2^{ghg^{-1},h}(T_2^{g,h})^{-1}\tau_{h_*Y,X}^g
$$

$$
g_*(X) \otimes g_*(Y) \xrightarrow{c_{g_*(X),g_*(Y)}} (ghg^{-1})_* g_*(Y) \otimes g_*(X)
$$

commute for all $q, h \in G$, $X \in \mathcal{C}_h$, $Y \in \mathcal{C}$.

(c) The diagrams

$$
X \otimes Y \otimes Z \xrightarrow{c_{X,Y \otimes Z}} g_*(Y \otimes Z) \otimes X
$$

$$
\downarrow c_{X,Y \otimes id_Z} g_*(Y) \otimes X \otimes Z \xrightarrow{id_{g_*(Y)} \otimes c_{X,Z}} g_*(Y) \otimes g_*(Z) \otimes X
$$

commute for all $g \in G$, $X \in \mathcal{C}_q$, $Y, Z \in \mathcal{C}$ and the diagrams

$$
X \otimes Y \otimes Z \xrightarrow{ c_{X \otimes Y,Z}} (gh)_*(Z) \otimes X \otimes Y
$$

\n
$$
\downarrow id_X \otimes c_{Y,Z} \qquad \qquad \downarrow T_2^{g,h}
$$

\n
$$
X \otimes h_*(Z) \otimes Y \xrightarrow{c_{X,h_*(Z)} \otimes id_Y} g_*h_*(Z) \otimes X \otimes Y
$$

commute for all $g, h \in G$, $X \in \mathcal{C}_g$, $Y \in \mathcal{C}_h$, $Z \in \mathcal{C}$.

The definition of equivalence of braided *G*-crossed tensor categories is given in [\[Gal17\]](#page-45-11), Section 5.2.

We call C as in the definition a *braided G-crossed extension* of a braided tensor category \mathcal{B} if $\mathcal{C}_1 = \mathcal{B}$.

An important application of braided *G*-crossed tensor categories is the following, related to the equivariantisation, which can be found in the present context in [\[Tur10\]](#page-46-9) (appendix by Michael Müger):

Proposition 3.8 ([\[DGNO10\]](#page-45-8))**.** *Let* C *be a braided G-crossed tensor category. The equivariantisation* C*//G is a braided tensor category that contains a fusion subcat* e^{α} *equivalent to the symmetric category* $\text{Rep}(G)$ *. This corresponds to those equivariant objects* $(V, (\varphi_q)_{q \in G})$ *where V is in the tensor subcategory generated by the unit object of* C*.*

Conversely, for every braided tensor category D *containing the symmetric fusion category* Rep(*G*) *with trivial braiding, we can define a braided G-crossed tensor category* $\mathcal{C} := \mathcal{D}_G$ *as the* de-equivariantisation *by G. This is the tensor category of modules over* C *^G, the algebra of functions on G, which is an algebra object in* $Rep(G)$ *and thus in* D *.*

Remark 3.9. The equivariantisation of a braided G -crossed tensor category \mathcal{C} is a nondegenerate braided tensor category if and only if the neutral component C_1 is a nondegenerate braided tensor category. For the existence of a ribbon element, see [Section 3.4.](#page-8-1)

We discuss some examples of braided *G*-crossed tensor categories and their equivariantisations.

Example 3.10.

(1) The archetypal example of a braided *G*-crossed tensor category is $Vect_G$, the pointed fusion category of *G*-graded vector spaces with the obvious *G*-grading. Up to equivalence, it has a unique braided *G*-crossed structure where the *G*-action is strict and given by $g_*(\mathbb{C}_h) = \mathbb{C}_{ghg^{-1}}$ for $g, h \in G$, with the *G*-braiding being the identity.

In this case, the equivariantisation $Vect_G/G$ is canonically braided equivalent to $\mathcal{Z}(\text{Vect}_G)$, the Drinfeld centre of Vect_G . See [\[NNW09\]](#page-46-10) for more details.

(2) For an arbitrary *G*-graded extension of Vect, we need to *twist* the previous example and consider the braided *G*-crossed tensor category $Vect^{\omega}_G$ for a 3-cocycle

 $\omega \in Z^3(G, \mathbb{C}^\times)$, as in [Example 3.1.](#page-4-1) Given $g, h \in G$, define the maps

(3)
\n
$$
\gamma_{g,h}(x) := \frac{\omega(g,h,x)\omega(ghx(gh)^{-1},g,h)}{\omega(g,hxh^{-1},h)},
$$
\n
$$
\mu_g(x,y) := \frac{\omega(gxg^{-1},g,y)}{\omega(gxg^{-1},gy,g)\omega(g,x,y)}
$$

for $x, y \in G$. The *G*-action on $Vect^{\omega}_G$ on objects is the same as before, and the *G*-braiding is again the identity. However, the action now is nonstrict. Indeed, for each $q \in G$, the constraints are

$$
\tau_{x,y}^g = \mu_g(x,y) \operatorname{id}_{g_*(\mathbb{C}_{xy})}, \quad T_2^{g,h}(\mathbb{C}_x) = \gamma_{g,h}(x) \operatorname{id}_{g_*(h_*(\mathbb{C}_x))}.
$$

The equivariantisation $\text{Vect}_{G}^{\omega}/\!\!/G$ is canonically braided equivalent to the twisted Drinfeld centre $\mathcal{Z}(\text{Vect}_{G}^{\omega})$. Again, see [\[NNW09\]](#page-46-10) for more details.

(3) Now, assume that *G* is abelian. Hence the *G*-action is trivial on objects. In this case, $\mu_a \in Z^2(G, \mathbb{C}^\times)$ is a 2-cocycle for each $a \in G$. The cohomologies μ_a for all $a \in G$ measure whether the category $Vect^{\omega}_{G}/\!\!/G$ is pointed or not. If $\gamma_a = \delta(l_a)$ for some $l_a \in C^1(G, \mathbb{C}^\times)$, then the simple objects of Vect^ω \mathcal{C}/G correspond to elements in $G \times \widehat{G}$. Specifically, the pair (a, γ) corresponds to the object \mathbb{C}_a with the equivariant structure $\varphi_b = \gamma(b) l_a(b) \mathrm{id}_{\mathbb{C}_a}$. The tensor product is determined by the extension of *G* by \hat{G} given by the 2-cocycle $\gamma_{a,b} \frac{l_{ab}}{l_a l_b} \in Z^2(G, \hat{G})$. See [\[GJ16\]](#page-45-12) for details.

3.3. **Classification of Braided** *G***-Crossed Extensions.** We briefly recall the important result from [\[ENO10\]](#page-45-0), Theorem 7.12, the classification of all braided *G*crossed fusion categories C for a given braided fusion category C_1 equipped with an action of a finite group *G*. This is also thoroughly treated in [\[DN21\]](#page-45-6), where the assumption of semisimplicity and rigidity is dropped, but finiteness in the sense of [\[EGNO15\]](#page-45-5) is retained (that is, they are working in the setting of finite braided tensor categories). A more detailed discussion of this result, in the form presented below, is given in Section 2.3 of [\[GLM24\]](#page-46-1).

Theorem 3.11 ([\[DN21\]](#page-45-6), Section 8.3; [\[ENO10\]](#page-45-0), Theorem 7.12)**.** *Let* B *be a finite tensor category with nondegenerate braiding, with an action of a finite group G on* B *by braided autoequivalences. Then, there is a certain obstruction* $O_4 \in H^4(G, \mathbb{C}^\times)$, *and if and only if this obstruction vanishes, there exists a braided G-crossed tensor category* C, where $C_1 = B$ *as a braided tensor category with* G-action. The *equivalence classes of extensions associated with the G-action form a torsor over* $\omega \in H^3(G, \mathbb{C}^\times)$; see *Remark 3.12.*

Remark 3.12.

(1) For a braided *G*-crossed tensor category *C*, we can define for $\omega \in Z^3(G, \mathbb{C}^\times)$ a *twisted* \mathcal{C}^{ω} by modifying the associativity constraint with ω and *twisting* the *G*-action by multiplying with the scalars in equation [\(3\)](#page-8-3). See Proposition 2.2 in [\[EG18\]](#page-45-13) for details.

(2) The braided *G*-crossed extensions and their *G*-equivariantisations of the trivial modular tensor category $\mathcal{B} =$ Vect correspond to $\mathrm{Vect}_{G}^{\omega}$ and its Drinfeld centre, respectively; see [Example 3.10.](#page-7-0)

We remark that the main assertion in this work on the existence of certain braided *G*-crossed extensions (see [Theorem 5.12\)](#page-24-0) do not make use of [Theorem 3.11.](#page-8-0) Nonetheless, it would be interesting to match our constructions to the work of [\[ENO10\]](#page-45-0) (see [Problem 1\)](#page-25-1).

3.4. *G***-Ribbon Structure.** We also consider a *G*-crossed version of ribbon categories. The following definition is adapted from Lemma 2.3 in [\[Kir04\]](#page-46-11); see also Section 4.5 of [\[Gal22\]](#page-45-1).

Definition 3.13. A *G*-twist θ for a braided *G*-crossed tensor category $\bigoplus_{g \in G} C_g$ is a natural isomorphism $\theta_{X_g}: X_g \to g_*(X_g)$ for $X_g \in C_g$ such that $\theta_{\mathbf{1}} = id_{\mathbf{1}}$ and the diagrams

$$
(4) \quad\n\begin{array}{ccc}\nX_g \otimes Y_h & \xrightarrow{\theta_{X_g \otimes Y_h}} & (gh)_*(X_g \otimes Y_h) \\
\downarrow \tau_{X_g, Y_h}^{\mathit{gh}} & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}} \\
\downarrow \tau_{X_g, Y_h}^{\mathit{gh}} & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}} \\
\downarrow \tau_{X_g, Y_h}^{\mathit{gh}} & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}} \\
\downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\
\downarrow \quad & & \downarrow \tau_{X_g, Y_h}^{\mathit{gh}_g^{-1}, \mathit{gh}_g^{-1}} \\

commute for all $g, h \in G$, $X_g \in \mathcal{C}_g$ and $Y_h \in \mathcal{C}_h$.

A *G*-twist in a rigid braided *G*-crossed tensor category is called a *G-ribbon* if the following diagram commutes for all $g \in G$ and $X \in \mathcal{C}_q$:

$$
(6) \quad \underset{X \otimes X^*}{\overset{\text{ev}_X}{\underset{\text{idx } \otimes \theta_{X^*}}{\bigcup}}} X \otimes X^* \xrightarrow{g_*^{-1}(\theta_X \otimes \text{id}_{X^*})} g_*^{-1}(g_*(X) \otimes X^*)} \xrightarrow{\bigcup_{\substack{f,g^{-1} \\ g_*(X),X^*}}{\bigcup_{\substack{f,g^{-1} \\ g_*(X),X^*}}}} (g_*(X) \otimes X^*)
$$

Remark 3.14. In the definition of a *G*-ribbon, if we take *G* to be the trivial group, the condition in diagram [\(6\)](#page-9-0) reduces to $(\mathrm{id}_X \otimes \theta_{X^*}) \circ \mathrm{ev}_X = (\theta_X \otimes \mathrm{id}_{X^*}) \circ \mathrm{ev}_X$. This condition is equivalent to the more common requirement $\theta_{X^*} = (\theta_X)^*$.

In the following, we show that *G*-twist and *G*-ribbon on a braided *G*-crossed tensor category descend to the usual notions of twist and ribbon, respectively, on the equivariantisation.

 ${\bf Lemma 3.15.}$ $Let \ {\mathcal C} \ be \ a \ braided \ G\text{-}crossed \ tensor \ category.$ If $\theta_{X_g}\colon X_g\to g_*X_g$ for $X_g \in \mathcal{C}_g$ *is a natural isomorphism that satisfies the commutativity of diagram* [\(5\)](#page-9-1), *then for any equivariant object* $(X, \varphi) \in \mathcal{C}/\!\!/ G$ *, the isomorphism*

$$
\omega_{(X,\varphi)}\colon X=\bigoplus_{h\in G}X_h \stackrel{\oplus_h\in G\theta_{X_h}}{\longrightarrow} \bigoplus_{h\in G}h_*(X_h) \stackrel{\oplus_h\in G\varphi_h^{(h)}}{\longrightarrow} \bigoplus_{h\in G}X_h=X
$$

is a natural isomorphism of the identity in \mathcal{C}/\mathcal{G} *, where* $\varphi_h^{(h)}$ $h_n^{(n)}: h_*(X_h) \to X_h$ *is the restriction of* φ_h *to* $X_h \subset X$ *.*

Proof. In order to verify that $\omega_{(X,\varphi)}$ is a morphism in $\mathcal{C}/\!\!/G$, we need to check that $\varphi_g g_*(\omega) = \omega \varphi_g$ for all $g \in G$. Since $\varphi_g g_*(\omega) = \omega \varphi_g$ is an equality of morphisms in $\mathcal{C} = \bigoplus_h \mathcal{C}_h$, it is enough to check the equality in the components. Hence, denoting

$$
\varphi_g = \bigoplus_{h \in G} \varphi_g^{(ghg^{-1})} \quad \text{and} \quad \omega = \bigoplus_{h \in G} \omega^{(h)},
$$

where $\varphi_g^{(ghg^{-1})}$: $g_*(X_h) \to X_{ghg^{-1}}$ and $\omega^{(h)} = \varphi_h^{(h)}$ $h^{(n)}_h \theta_{X_h}: X_h \to X_h$, we need to check for all $g, h \in G$ that

$$
\varphi_g^{(ghg^{-1})}g_*(\omega^{(h)})=\omega^{(ghg^{-1})}\varphi_g^{(ghg^{-1})}.
$$

We shall assume, without loss of generality, that the G -action on $\mathcal C$ is strict. Thus, diagram [\(5\)](#page-9-1) simply becomes

$$
(7) \t\t g_*(\theta_X) = \theta_{g_*X}
$$

for every object *X* and $g \in G$. Now, we can check the equality:

$$
\varphi_g^{(ghg^{-1})}g_*(\omega^{(h)}) = \varphi_g^{(ghg^{-1})}g_*(\varphi_h^{(h)})g_*(\theta_h)
$$

\n
$$
= \varphi_{gh} \circ \theta_{g_*(X_h)}
$$

\n
$$
= \varphi_{ghg^{-1}}^{(ghg^{-1})}(ghg^{-1})_*(\varphi_g) \circ \theta_{g_*(X_h)}
$$

\n
$$
= \varphi_{ghg^{-1}}^{(ghg^{-1})}\theta_{X_{ghg^{-1}}} \varphi_g^{ghg^{-1}}
$$

\n
$$
= \omega^{(ghg^{-1})}\varphi_g^{(ghg^{-1})},
$$

where in the second equality we have used the *G*-equivariance of φ and [\(7\)](#page-10-0), in the third the *G*-equivariance of φ again and in the fourth the naturality of θ .

Finally, if $f: (X, \varphi) \to (Y, \varphi')$ is a morphism in $\mathcal{C}/\!\!/ G$, then $\varphi'_{g}g_{*}(f) = f\varphi_{g}$ for all $g \in G$ by definition. Taking the *g*-component of *f*, we get $\varphi'_{g}^{(g)}g_{*}(f^{(g)}) = f^{(g)}\varphi_{g}^{(g)}$. Using the naturality of θ and the previous equation, we obtain for all $g \in G$:

$$
(g)(Y,\varphi') f(g) = \varphi'_g{}^{(g)} \theta_{Y_g} f^{(g)}
$$

= $\varphi'_g{}^{(g)} g_*(f^{(g)}) \theta_{X_g}$
= $f^{(g)} \varphi_h^{(g)} \theta_{X_g}$
= $f^{(g)} \omega_{(X,\varphi)}^{(g)}$.

Therefore, $\omega_{(Y,\varphi')}f = f\omega_{(X,\varphi)}$, i.e. ω is a natural isomorphism of the identity. \square

Recall that if β is a braided tensor category, with braiding c , then a *twist* is a natural isomorphism of the identity $\omega_X : X \to X$ such that $\omega_1 = id_1$ and

(8)
$$
\omega_{X\otimes Y} = (\omega_X \otimes \omega_Y) c_{Y,X} c_{X,Y}
$$

ω

for all *X*, *Y* \in *B*. If *B* is left rigid and additionally $\omega_{X^*} = (\omega_X)^*$ for all *X*, then ω is called a *ribbon*.

Proposition 3.16. Let $\mathcal{C} = \bigoplus_{g \in G} \mathcal{C}_g$ be a braided G-crossed tensor category and θ *a G*^{-twist. Then the natural isomorphism $\omega_{(X,\varphi)}$ of the identity from [Lemma 3.15](#page-9-2)} *defines a twist for* $\mathcal{C}/\!\!/ G$ *. If* θ *is a G-ribbon, then* $\omega_{(X,\varphi)}$ *is a ribbon.*

Proof. The braiding of $C \parallel G$ is given by $\mathbf{c}_{(X,\varphi),(Y,\gamma)} = \bigoplus_{g \in G} \mathbf{c}_{X_g,Y}$, where

$$
\mathbf{c}_{X_g,Y}\colon X_g\otimes Y\xrightarrow{c_{X_g,Y}}g_*(Y)\otimes X_g\xrightarrow{\gamma_g\otimes\mathrm{id}_{X_g}}Y\otimes X_g.
$$

[Lemma 3.15](#page-9-2) states that ω is indeed a natural isomorphism of the identity. Then, equality [\(8\)](#page-10-1) follows, assuming without loss of generality that the *G*-action is strict, using the naturality of θ and diagram [\(4\)](#page-9-3).

Now, if C is rigid, then so is $\mathcal{C}/\!\!/ G$. Indeed, if $(X, \varphi) \in \mathcal{C}/\!\!/ G$ and $(X^*, \text{ev}_X, \text{coev}_X)$ is a dual of *X* as an object in \mathcal{C} , then $(X^*, (\varphi^*)^{-1}) \in \mathcal{C}/\!\!/ G$ and $(\text{ev}_X, \text{coev}_X)$ define a dual in $\mathcal{C}/\!\!/ G$. Now, it is again straightforward to verify, assuming the *G*-action is strict, that diagram [6](#page-9-0) implies that ω is a ribbon. □

For a tensor category C, we shall denote by $Aut_{\otimes}(\mathrm{id}_{\mathcal{C}})$ the abelian group of tensor automorphisms of the identity. If a group G acts on \mathcal{C} , it induces a G -action on $\text{Aut}_{\otimes}(\text{id}_{\mathcal{C}})$ by group automorphisms. We define

$$
\operatorname{Aut}_{\otimes}^G(\operatorname{id}_{\mathcal{C}}) = \{ \gamma \in \operatorname{Aut}_{\otimes}(\operatorname{id}_{\mathcal{C}}) \mid g_*(\gamma_X) = \gamma_{g_*(X)} \text{ for all } X \in \mathcal{C}, g \in G \},
$$

$$
\operatorname{Aut}_{\otimes}^{G_*(\operatorname{id}_{\mathcal{C}})} = \{ \gamma \in \operatorname{Aut}_{\otimes}^G(\operatorname{id}_{\mathcal{C}}) \mid \gamma_X^* = \gamma_{g^{-1}(X)} \text{ for all } X_g \in \mathcal{C}, g \in G \}.
$$

Proposition 3.17. *Let* C *be a braided G-crossed tensor category. The set of all G*-twists is a torsor over the abelian group $\text{Aut}^G_{\otimes}(\text{id}_{\mathcal{C}})$. The set of all *G*-ribbons is *a torsor over* $\mathrm{Aut}_{\otimes}^{G,*}(\mathrm{id}_{\mathcal{C}})$.

Proof. We shall assume without loss of generality that C is a *strict* braided *G*crossed tensor category; see Theorem 5.6 in [\[Gal17\]](#page-45-11). The commutativity of diagram [\(4\)](#page-9-3) corresponds to the equation

$$
\theta_{X\otimes Y} = (ghg^{-1})_*(\theta_X)\otimes g_*(\theta_Y)\circ c_{g_*Y,X}\circ c_{X,Y}
$$

for $X \in \mathcal{C}_q$, $Y \in \mathcal{C}_h$. Now, using the naturality of the *G*-braiding, we also obtain

$$
\theta_{X\otimes Y}=c_{gh*Y,g*X}\circ c_{g*X,h*Y}\circ (\theta_X\otimes \theta_Y).
$$

Let θ and θ' be *G*-twists of *C*. We shall prove that $\gamma_X := \theta_{X_g}^{-1} \theta'_{X_g} : X_g \to X_g$ is a natural isomorphism in $\text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}})$. We observe that

$$
\gamma_{X \otimes Y} = \theta_{X \otimes Y}^{-1} \circ \theta'_{X \otimes Y}
$$

\n
$$
= ((ghg^{-1})_{*}(\theta_{X}) \otimes g_{*}(\theta_{Y}) \circ c_{g_{*}Y,X} \circ c_{X,Y})^{-1}
$$

\n
$$
\circ (c_{gh_{*}Y,g_{*}X} \circ c_{g_{*}X,h_{*}Y} \circ (\theta'_{X} \otimes \theta'_{Y}))
$$

\n
$$
= c_{X,Y}^{-1} \circ c_{g_{*}Y,X}^{-1} \circ (ghg^{-1})_{*}(\theta_{X})^{-1} \otimes g_{*}(\theta_{Y})^{-1}
$$

\n
$$
\circ c_{gh_{*}Y,g_{*}X} \circ c_{g_{*}X,h_{*}Y} \circ (\theta'_{X} \otimes \theta'_{Y})
$$

\n
$$
= c_{X,Y}^{-1} \circ g(\theta_{Y})^{-1} \otimes \theta_{X}^{-1} \circ c_{g_{*}X,h_{*}Y} \circ (\theta'_{X} \otimes \theta'_{Y})
$$

\n
$$
= (\theta_{X}^{-1} \otimes \theta_{Y}^{-1}) \circ (\theta'_{X} \otimes \theta'_{Y}) = (\theta_{X}^{-1} \theta'_{X}) \otimes (\theta_{Y}^{-1} \theta'_{Y})
$$

\n
$$
= \gamma_{X} \otimes \gamma_{Y},
$$

where we have used

$$
c_{g_*Y,X}^{-1} \circ (ghg^{-1})_*(\theta_X)^{-1} \otimes g_*(\theta_Y)^{-1} \circ c_{gh_*Y,g_*X} = g_*(\theta_Y)^{-1} \otimes \theta_X^{-1}
$$

and

$$
\theta_X^{-1} \otimes \theta_Y^{-1} = c_{X,Y}^{-1} \circ (g_*(\theta_Y)^{-1} \otimes \theta_X^{-1}) \circ c_{g_*X,h_*Y}
$$

in the penultimate and last equality, respectively. These equations follow directly from the naturality of the *G*-braiding. Now, for all $q \in G$,

$$
g_*(\gamma_X) = g_*(\theta_X^{-1}\theta_X') = g_*(\theta_X^{-1})g_*(\theta_X') = \theta_{g_*(X)}^{-1}\theta_{g_*(X)}' = \gamma_{g_*(X)}
$$

for all $X \in \mathcal{C}_h$ and $h \in G$.

Conversely, given $\gamma \in \text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}})$ and a *G*-twist θ , it is straightforward to check that $\gamma\theta$ is a new twist. Then the group $\text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}})$ acts freely and transitively on the set of *G*-twists.

Finally, if θ and θ' are *G*-ribbons, then

$$
\gamma_{X^*} = \theta_{X^*}^{-1} \theta'_{X^*}
$$

= $g_*^{-1} (\theta_X)^{-1} g_*^{-1} (\theta'_X)$
= $g_*^{-1} (\theta_X^{-1} \theta'_X)$
= $g_*^{-1} (\gamma_X)$
= $\gamma_{g^{-1}(X)}$

for all $X \in \mathcal{C}$ and $g \in G$. It is easy to verify that, given $\gamma \in \text{Aut}_{\otimes}^{G,*}(\text{id}_{\mathcal{C}})$ and a *G*-twist θ , the natural isomorphism $\gamma \theta$ is a new *G*-ribbon. □

We define a group homomorphism

$$
\Omega: \operatorname{Aut}_{\otimes}^G(\mathrm{id}_{\mathcal{C}}) \to \operatorname{Aut}_{\otimes}(\mathrm{id}_{\mathcal{C}/G}),
$$

$$
\Omega(\gamma)_{(X,\varphi)} = \gamma_X.
$$

The group homomorphism Ω restricted to $\text{Aut}^{G,*}_{\otimes}(\text{id}_{\mathcal{C}})$ takes values in $\text{Aut}^*_{\otimes}(\text{id}_{\mathcal{C}/\!\!/ G})$, the abelian group of tensor isomorphisms of the identity such that $\gamma_{X^*} = \gamma_X^*$.

Corollary 3.18. *Let* C *be a braided G-crossed tensor category. Two G-twists θ, θ*′ *(respectively G-ribbons) produce the same twist (respectively ribbon) on* C*//G if and only if* $\Omega(\theta^{-1}\theta') = id$ *.*

Remark 3.19. If C is fusion, then $\text{Aut}_{\otimes}(\text{id}_{\mathcal{C}})$ is canonically isomorphic to $\widetilde{U}(\widetilde{\mathcal{C}})$. the character group of $U(\mathcal{C})$, called the universal grading group; see [\[GN08\]](#page-46-12). The subgroup $\text{Aut}_{\otimes}^*(\text{id}_{\mathcal{C}})$ consists of elements of order 2, i.e. it is in particular an elementary abelian 2-group. Now, in the case of a braided *G*-crossed fusion category, $\text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}}) = \text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}})$ and $\text{Aut}_{\otimes}^G(\text{id}_{\mathcal{C}}) = \text{Aut}_{\otimes}^*(\text{id}_{\mathcal{C}})$. In particular, in the fusion category case, the number of pivotal and spherical structures corresponds to *G*-twists and *G*-ribbons, respectively.

Example 3.20. Consider the braided *G*-crossed tensor category $Vect_G^{\omega}$ from [Ex](#page-7-0)[ample 3.10.](#page-7-0) This category has a canonical *G*-ribbon given by the identity functor. Hence, it follows from [Proposition 3.17](#page-11-0) that the *G*-twist structures of $Vect^{\omega}_G$ are in bijective correspondence with the linear characters \hat{G} , and the set of *G*-ribbon structures with \hat{G}_2 , the linear characters taking values in $\{\pm 1\}$.

3.5. **Pseudo-Unitary Fusion Categories and** *G***-Graded Extensions.** Finally, we also study the notion of pseudo-unitarity in the context of *G*-graded fusion categories. This will later allow us to single out a particular choice of *G*-ribbon structure (see [Proposition 4.6](#page-15-1) and [Theorem 5.12\)](#page-24-0).

The global dimension, denoted by $\dim(\mathcal{C})$, is defined for any fusion category $\mathcal C$ in, e.g., Definition 2.2 of [\[ENO10\]](#page-45-0). This definition is intrinsic to \mathcal{C} . Another dimension of a fusion category C is the Frobenius-Perron dimension $\text{FPdim}(\mathcal{C}) \in \mathbb{R}_{>0}$, which only depends on the Grothendieck ring $K_0(\mathcal{C})$ of \mathcal{C} ; see Section 8 of [\[ENO10\]](#page-45-0).

We are interested in the relationship between the global dimension and the Frobenius-Perron dimension of fusion categories, as it relates to the existence of spherical structures for which the associated dimension function coincides with the Frobenius-Perron dimensions, as indicated by the following result; see Proposition 8.23 in [\[ENO05\]](#page-45-14).

Proposition 3.21. *Let* C *be a fusion category (over* C*). Then* C *admits a spherical structure whose quantum (or categorical) dimensions match the Frobenius-Perron* dimensions if and only if $\text{FPdim}(\mathcal{C}) = \dim(\mathcal{C})$. Moreover, this spherical structure *is unique.*

The above property naturally leads to the following definition (see, e.g., Section 8.4 of [\[ENO10\]](#page-45-0)).

Definition 3.22. Let $\mathcal C$ be a fusion category (over $\mathbb C$). The category $\mathcal C$ is called *pseudo-unitary* if $\text{FPdim}(\mathcal{C}) = \dim(\mathcal{C})$, or equivalently, by [Proposition 3.21,](#page-12-1) if there exists a spherical structure with respect to which the dimension of every simple object is positive (and equal to the Frobenius-Perron dimension).

The following result is an analogue of Proposition 8.20 in [\[ENO05\]](#page-45-14), focusing on the global dimension rather than the Frobenius-Perron dimension.

Proposition 3.23. Let G be a finite group and $C = \bigoplus_{g \in G} C_g$ a faithfully G -graded *fusion category.* Then $\dim(\mathcal{C}_1) = \dim(\mathcal{C}_g)$ *for all* $g \in \tilde{G}$ *, and the global dimension of* C *is given by* dim $(C) = |G| \dim(C_1)$ *.*

Proof. Consider the C_1 -module category $\bigoplus_{g \in G} C_g$ and the connected multi-fusion category

$$
\mathrm{Fun}_{\mathcal{C}_1}\bigg(\bigoplus_{x\in G}\mathcal{C}_x,\bigoplus_{y\in G}\mathcal{C}_y\bigg)=\bigoplus_{x,y}\mathrm{Hom}_{\mathcal{C}_1}(\mathcal{C}_x,\mathcal{C}_y).
$$

Now, each \mathcal{C}_x is an invertible \mathcal{C}_1 -bimodule; see Theorem 6.1 of [\[ENO10\]](#page-45-0). Therefore, $\text{Hom}_{\mathcal{C}_1}(\mathcal{C}_x, \mathcal{C}_x) \cong \mathcal{C}_1$ as fusion categories, and $\mathcal{C}_{y^{-1}x} = \text{Hom}_{\mathcal{C}_1}(\mathcal{C}_y, \mathcal{C}_x)$ as a \mathcal{C}_1 bimodule category. It then follows from Proposition 2.17 in [\[ENO10\]](#page-45-0) that the global dimension of each \mathcal{C}_x is dim (\mathcal{C}_1) . Therefore,

$$
\dim(\mathcal{C}) = \sum_{g \in G} \dim(\mathcal{C}_g) = |G| \dim(\mathcal{C}_1).
$$

We now relate the pseudo-unitarity of a (braided) *G*-graded (*G*-crossed) fusion category to that of its neutral component and that of its equivariantisation.

Corollary 3.24. *Let G be a finite group.*

(1) Let C *be a faithfully G-graded fusion category. Then* C *is pseudo-unitary if* and only if the neutral component C_1 is pseudo-unitary.

(2) Suppose that C *is a fusion category with a G-action. Then the equivariantisation satisfies* $\dim(\mathcal{C}/\mathcal{G}) = |G| \dim(\mathcal{C})$ *. Hence,* \mathcal{C}/\mathcal{G} *is pseudo-unitary if and only if* C *is pseudo-unitary.*

(3) Let B *be a nondegenerate braided fusion category with a G-action by braided tensor autoequivalences. Then the associated (in the sense of [Theorem 3.11\)](#page-8-0) nondegenerate braided fusion categories* C/G *are pseudo-unitary if and only if* $B = C_1$ *is pseudo-unitary.*

Proof. (1) Proposition 8.20 in [\[ENO05\]](#page-45-14) implies $\text{FPdim}(\mathcal{C}) = |G|\text{FPdim}(\mathcal{C}_1)$. Then, by [Proposition 3.23,](#page-12-2) $FPdim(\mathcal{C}) = dim(\mathcal{C})$ if and only if $FPdim(\mathcal{C}_1) = dim(\mathcal{C}_1)$.

(2) If *G* acts on *C*, the semidirect-product fusion category $C \rtimes G$ is *G*-graded and Morita equivalent to \mathcal{C}/\mathcal{G} (see [\[Nik08\]](#page-46-13), Proposition 3.2). Since Frobenius-Perron dimension and global dimension are invariant under Morita equivalence (see Proposition 2.15 and Proposition 8.12 in [\[ENO10\]](#page-45-0), respectively), it follows that $\dim(\mathcal{C}/\!\!/G) = |G| \dim(\mathcal{C})$ and $\text{FPdim}(\mathcal{C} \rtimes G) = |G| \text{FPdim}(\mathcal{C}).$

 (3) This follows directly from the previous items.

$$
\qquad \qquad \Box
$$

Remark 3.25. It follows from [\[ENO05\]](#page-45-14), Proposition 8.23, that each pseudounitary fusion category admits a unique spherical structure with an associated dimension equal to the Frobenius-Perron dimension. In particular, it follows that any gauging of a pseudo-unitary fusion category is pseudo-unitary. In this paper, we are primarily interested in gauging pointed braided fusion categories, which are, in particular, pseudo-unitary.

Below, we construct certain braided *G*-crossed extensions and also write down a pseudo-unitary *G*-ribbon element, which we then know is unique. More systematic would be a version of the above classification statement, [Theorem 3.11,](#page-8-0) that inherently uses the setting of a ribbon category with ribbon autoequivalences (see Problem 5 in [\[GLM24\]](#page-46-1)).

4. Z₂-CROSSED EXTENSIONS OF TAMBARA-YAMAGAMI TYPE

We give a first nontrivial example of a braided *G*-crossed extension, namely one for which the monoidal structure is of Tambara-Yamagami type. The example is also studied in greater detail in Section 3 of [\[GLM24\]](#page-46-1). In [Section 5,](#page-16-0) we shall then generalise this to allow for more than one simple object in the nontrivial graded component.

From now on, let $G = \langle g \rangle \cong \mathbb{Z}_2$. Tambara and Yamagami classified all \mathbb{Z}_2 -graded fusion categories in which all but one of the simple objects are invertible [\[TY98\]](#page-46-0). The braided *G*-crossed structures on these were classified in [\[Gal22\]](#page-45-1).

Definition 4.1. Let Γ be a finite, abelian group, $\sigma: \Gamma \times \Gamma \to \mathbb{C}^\times$ a symmetric, nondegenerate bimultiplicative form and $\varepsilon \in {\pm 1}$ a sign choice. The *Tambara*-*Yamagami category* $\mathcal{TV}(\Gamma, \sigma, \varepsilon)$ is the semisimple \mathbb{Z}_2 -graded tensor category

$$
\mathcal{T}\mathcal{Y}(\Gamma,\sigma,\varepsilon) = \operatorname{Vect}_{\Gamma} \oplus \operatorname{Vect}
$$

with simple objects \mathbb{C}_a , $a \in \Gamma$, and X, fusion rules

$$
\mathbb{C}_a \otimes \mathbb{C}_b = \mathbb{C}_{a+b}, \quad \mathbb{C}_a \otimes \mathsf{X} = \mathsf{X} \otimes \mathbb{C}_a = \mathsf{X}, \quad \mathsf{X} \otimes \mathsf{X} = \bigoplus_{t \in \Gamma} \mathbb{C}_t
$$

for $a, b \in \Gamma$ and the following nontrivial associators

$$
(\mathbb{C}_a \otimes X) \otimes \mathbb{C}_b = X \xrightarrow{\sigma(a,b)} X = \mathbb{C}_a \otimes (X \otimes \mathbb{C}_b),
$$

$$
(X \otimes \mathbb{C}_a) \otimes X = \bigoplus_{t \in \Gamma} \mathbb{C}_t \xrightarrow{\sigma(a,t)} \bigoplus_{t \in \Gamma} \mathbb{C}_t = X \otimes (\mathbb{C}_a \otimes X),
$$

$$
(X \otimes X) \otimes X = \bigoplus_{t \in \Gamma} X \xrightarrow{\varepsilon |\Gamma|^{-1/2} \sigma(t,r)^{-1}} \bigoplus_{r \in \Gamma} X = X \otimes (X \otimes X).
$$

There is a rigid structure on $\mathcal{TV}(\Gamma, \sigma, \varepsilon)$ with (left) dual objects $\mathbb{C}_a^* = \mathbb{C}_{-a}$ and $X^* = X$, and $\operatorname{coev}_X = \iota_{\mathbb{C}_0}$ and $\operatorname{ev}_X = \varepsilon |\Gamma|^{1/2} \pi_{\mathbb{C}_0}$, where $\iota_{\mathbb{C}_t}$ and $\pi_{\mathbb{C}_t}$ are the canonical embeddings and projections, respectively, for the direct sum $X \otimes X = \bigoplus_{t \in \Gamma} \mathbb{C}_t$, and otherwise the obvious choices. The two zigzag identities relating ev_{X} and coev_X hold as both the associator and inverse associator on $X \otimes X \otimes X$ at $t = 0$ are $\varepsilon |\Gamma|^{-1/2}$.

We then upgrade the above categories to braided \mathbb{Z}_2 -crossed tensor categories. To this end, we first need to introduce the following Gauss sum. Given a finite, abelian group Γ and a nondegenerate quadratic form $q: \Gamma \to \mathbb{C}^{\times}$, we define

(9)
$$
G(\Gamma, q^{-1}) := |\Gamma|^{-1/2} \sum_{a \in \Gamma} q(a)^{-1} = e(\text{sign}(\Gamma, q^{-1})/8) = e(-\text{sign}(\Gamma, q)/8),
$$

where sign denotes the signature (a number in \mathbb{Z}_8) of a discriminant form.

Theorem 4.2 ([\[Gal22\]](#page-45-1), Lemma 4.8, Theorem 4.9, Proposition 4.12)**.** *Consider the Tambara-Yamagami category* $\mathcal{TV}(\Gamma, \sigma, \varepsilon)$ *and* $G = \langle g \rangle \cong \mathbb{Z}_2$.

- *(1) There are two actions of G on* $\mathcal{T} \mathcal{Y}(\Gamma, \sigma, \varepsilon)$ *such that the action on* Vect_Γ *is* $g_*\mathbb{C}_a = \mathbb{C}_{-a}$ *with trivial tensor structure* $\tau^g_{\mathbb{C}_a, \mathbb{C}_b} = \text{id}$ *and trivial compo*sition $T_2^{g,g}(\mathbb{C}_a) = \text{id}, a, b \in \Gamma$. Namely, the actions $g_*\mathsf{X} = \mathsf{X}$ with trivial *tensor structures* $\tau_{C_a}^g$ $\chi = \tau_{X,C_a}^g = \tau_{X,X}^g = id$ *and with composition structures* $T_2^{g,g}(\mathbb{C}_a) = \text{id}$ *and* $T_2^{a,g,g}(X) = \pm \text{id}$.
- (2) *The nonstrict action* $T_2^{g,g}(\mathsf{X}) = -id$ *does not admit a* \mathbb{Z}_2 -braiding.
- *(3)* For the strict \mathbb{Z}_2 -action, the \mathbb{Z}_2 -braidings are in bijection with pairs (q, α) of *a* nondegenerate quadratic form $q: \Gamma \to \mathbb{C}^\times$ with associated bimultiplicative *form* $\sigma(a, b) = q(a + b)q(a)^{-1}q(b)^{-1}$ *and a choice* α *of square root of*

$$
\alpha^2 = \varepsilon \, G(\Gamma, q^{-1}).
$$

Then the \mathbb{Z}_2 *-braiding is, for* $a, b \in \Gamma$ *,*

$$
\mathbb{C}_a \otimes \mathbb{C}_b = \mathbb{C}_{a+b} \xrightarrow{\sigma(a,b)} \mathbb{C}_{a+b} = \mathbb{C}_a \otimes \mathbb{C}_b,
$$

$$
\mathbb{C}_a \otimes \mathsf{X} = \mathsf{X} \xrightarrow{\qquad q(a)^{-1}} \mathsf{X} = \mathsf{X} \otimes \mathbb{C}_a,
$$

$$
\mathsf{X} \otimes \mathbb{C}_a = \mathsf{X} \xrightarrow{\qquad q(a)^{-1}} \mathsf{X} = \mathbb{C}_{-a} \otimes \mathsf{X},
$$

$$
\mathsf{X} \otimes \mathsf{X} = \bigoplus_{t \in \Gamma} \mathbb{C}_t \xrightarrow{\qquad \qquad q(t)} \bigoplus_{t \in \Gamma} \mathbb{C}_t = \mathsf{X} \otimes \mathsf{X}.
$$

(4) The \mathbb{Z}_2 -ribbon structures for a given (q, α) are in correspondence with a *choice of* $\beta = \pm \alpha^{-1}$ *. Then the ribbon twist is, for* $a \in \Gamma$ *,*

$$
\mathbb{C}_a \xrightarrow{q(a)^2} \mathbb{C}_a \quad and \quad \mathsf{X} \xrightarrow{\beta} \mathsf{X}.
$$

We denote by $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$ *the* \mathbb{Z}_2 -crossed ribbon Tambara-Yamagami cate*gory associated with these data.*

Note that because $\alpha^2 = \varepsilon$ e($-\text{sign}(\Gamma, q)/8$) by equation [\(9\)](#page-14-0), it follows that α and *β* are 16-th roots of unity, and in particular $|α| = |β| = 1$. Moreover, $αβ ∈ {±1}$ by definition.

Remark 4.3. As we explain in more detail in Remark 3.4 of [\[GLM24\]](#page-46-1), the two choices of α yield equivalent *G*-crossed ribbon categories $\mathcal{TN}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$.

Remark 4.4. $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$ is a braided \mathbb{Z}_2 -crossed extension of the braided tensor category $\text{Vect}_{\Gamma}^{q^2}$ $\frac{q^2}{\Gamma} \cong \text{Vect}_{\Gamma}^{\sigma,1}$ (with σ symmetric) discussed in [Example 3.2,](#page-4-2) with ribbon structure given by $\theta_{\mathbb{C}_a} = q(a)^2$. In other words, in order to define a braided \mathbb{Z}_2 -crossed extension of Tambara-Yamagami type, we need to, among other things, choose a square root of a quadratic form. (But note that the quadratic form *q* ² on Γ may be degenerate if |Γ| is even.)

Remark 4.5. A symmetric, nondegenerate bimultiplicative form $\sigma : \Gamma \times \Gamma \to \mathbb{C}^{\times}$ admits $|\Gamma/2\Gamma|$ many choices of quadratic form $q: \Gamma \to \mathbb{C}^\times$ with associated bimultiplicative form *σ*.

There is a somewhat natural choice of the sign $\alpha\beta$. Indeed, the following assertion is not difficult to verify, but see Proposition 3.7 in [\[GLM24\]](#page-46-1) for a proof.

Proposition 4.6. *The quantum dimensions of the above* \mathbb{Z}_2 -crossed ribbon fusion *category* $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$ *coincide with the Frobenius-Perron dimensions if and only if* $\alpha\beta = \varepsilon$ *.*

By the definition of α and β , the condition $\alpha\beta = \varepsilon$ is equivalent to the equation $\beta/\alpha = e(\text{sign}(\Gamma, q)/8).$

Proposition 4.7 ([\[GNN09\]](#page-46-6), Proposition 5.1)**.** *The equivariantisation of the braided* \mathbb{Z}_2 -crossed tensor category $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$ has a nondegenerate braiding and *is hence a modular tensor category if and only if* |Γ| *is odd.*

Because it is often natural to demand that the equivariantisation of a braided *G*crossed tensor category be modular, e.g. in the context of vertex operator algebras (cf. [\[GLM24\]](#page-46-1)), the special case of Γ of odd order is the most interesting one.

Assume in the following that $|\Gamma|$ is odd. Then, as explained in [Example 3.2,](#page-4-2) for any nondegenerate quadratic form Q on Γ , the equivalence class Vect_{Γ}^Q has a distinguished representative Vect^{σ 1}, for which the representing abelian 3-cocycle (σ, ω) has trivial associator $\omega = 1$ and braiding given by the symmetric bimultiplicative form $\sigma = B_Q^{1/2}$.

Hence, by [Remark 4.4,](#page-15-2) the Tambara-Yamagami categories $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$ are braided \mathbb{Z}_2 -crossed extensions of Vect^{*Q*}_Γ, concretely represented by Vect_{*Γ*}^{*σ*,1}. Since Γ is of odd order, there is a unique quadratic form *q* with associated bimultiplicative form $B_q = \sigma$ (see [Remark 4.5\)](#page-15-3), and this quadratic form must coincide with the unique square root of Q , i.e. $q = Q^{1/2}$.

Also since $|\Gamma|$ is odd, Vect^Q_{Γ} has a unique ribbon structure (cf. [Section 3.4\)](#page-8-1). The ribbon twist is given by $\theta_{\mathbb{C}_a} = Q(a) = q(a)^2$ for $a \in \Gamma$, and with this ribbon structure the quantum dimensions agree with the Frobenius-Perron dimensions; in particular, Vect^Q_{Γ} is pseudo-unitary. Hence, the \mathbb{Z}_2 -crossed ribbon structure on $\mathcal{TV}(\Gamma, \sigma, \varepsilon \mid q, \alpha, \beta)$ is an extension of the ribbon structure on Vect^Q, and yields

coinciding quantum and Frobenius-Perron dimensions if and only if $\beta = \varepsilon/\alpha$ by [Proposition 4.6.](#page-15-1)

Summarising the above considerations, we obtain the following statement:

Corollary 4.8. *Suppose* |Γ| *is odd. The modular tensor category* Vect*^Q* ^Γ *with strict* \mathbb{Z}_2 -action $g_*\mathbb{C}_a = \mathbb{C}_{-a}$ has two braided \mathbb{Z}_2 -crossed extensions with positive quantum *dimensions, namely, for* $\varepsilon = \pm 1$ *,*

$$
\mathrm{Vect}_{\Gamma}^Q[\mathbb{Z}_2,\varepsilon] \coloneqq \mathcal{TY}(\Gamma,B_Q^{1/2},\varepsilon \mid Q^{1/2},\alpha,\varepsilon/\alpha).
$$

Here, α *is one of the solutions of* $\alpha^2 = \epsilon G(\Gamma, q^{-1}) = \epsilon e(-\text{sign}(\Gamma, q)/8)$ *, which both give equivalent extensions. The equivariantisations* $\text{Vecf}_{\Gamma}^Q[\mathbb{Z}_2, \varepsilon]/\mathbb{Z}_2$ *are again modular.*

Comparing this with the results from [\[ENO10\]](#page-45-0), [Theorem 3.11,](#page-8-0) we conclude that these are the unique two braided \mathbb{Z}_2 -crossed extensions of Vect^{*Q*}_{Γ}.

The equivariantisation $\text{Vect}_{\Gamma}^Q[\mathbb{Z}_2, \varepsilon]/\mathbb{Z}_2$ was described in detail in [\[GNN09\]](#page-46-6) and will be recovered as a special case of our generalisation in [Section 5.3.](#page-25-4)

Remark 4.9. If $|\Gamma|$ is odd, the Gauss sum $G(\Gamma, q^{-1})$ over $q^{-1} = Q^{-1/2}$ can be expressed in a simple way in terms of the signature of the discriminant form sign(Γ*, Q*) (see, e.g., [\[Sch09\]](#page-46-8)):

$$
G(\Gamma, q^{-1}) = |\Gamma|^{-1/2} \sum_{a \in \Gamma} q(a)^{-1} = e(\text{sign}(\Gamma, q^{-1})/8)
$$

$$
= \left(\frac{2}{|\Gamma|}\right) G(\Gamma, Q^{-1}) = \left(\frac{2}{|\Gamma|}\right) e(-\text{sign}(\Gamma, Q)/8),
$$

where $(\frac{1}{n})$ is the Kronecker symbol, and for *n* odd $(\frac{2}{n}) = (\frac{n}{2}) = (-1)^{(n^2-1)/8}$. With the above formula, the ribbon twist eigenvalue on X, up to an irrelevant sign, is

$$
\theta_{\mathbf{X}} = \beta = \varepsilon/\alpha = \pm \left(\varepsilon \left(\frac{2}{|\Gamma|} \right) e(\text{sign}(\Gamma, Q)/8) \right)^{1/2}.
$$

5. \mathbb{Z}_2 -Crossed Extensions for Even Groups

In this section, as the main result of this work, we construct for $G = \langle q \rangle \cong \mathbb{Z}_2$ explicitly the braided *G*-crossed extension

$$
\mathrm{Vect}_{\Gamma}^{Q}[\mathbb{Z}_{2},\varepsilon]=\mathrm{Vect}_{\Gamma}\oplus\mathrm{Vect}_{\Gamma/2\Gamma}
$$

of the (nondegenerate) braided fusion category Vect^Q_Γ for a discriminant form (Γ, Q) with a \mathbb{Z}_2 -action given by −id on Γ. This includes, in particular, a description of the associators, \mathbb{Z}_2 -braiding and \mathbb{Z}_2 -ribbon structure.

Here, in contrast to the previously known results in [Section 4,](#page-13-0) the finite, abelian group Γ may have even order, leading to new examples of braided \mathbb{Z}_2 -crossed tensor categories. Through the process of equivariantisation, these also provide new examples of modular tensor categories (see [Section 5.3\)](#page-25-4).

As discussed in Theorem 8.1 of [\[GLM24\]](#page-46-1), these categories correspond to the representation categories of orbifolds of lattice vertex operator algebras under reflection automorphisms, whose Grothendieck rings were described in [\[ADL05\]](#page-45-15).

The input data for the construction of these braided *G*-crossed categories are produced in Section 6.2 of [\[GLM24\]](#page-46-1) by using the idea that braided *G*-crossed extensions commute in a certain sense with condensations (i.e. going to the local modules over a commutative, associative algebra object in a braided tensor category in the sense

of [\[Par95,](#page-46-14) [KO02\]](#page-46-15)). Concretely, this idea is applied to the situation

$$
\begin{array}{ccc}\n\text{Vect}_{\mathbb{R}^d}^{\bar{Q}} & \xrightarrow{\mathbb{Z}_2\text{-crossed ext.}} & \text{Vect}_{\mathbb{R}^d}^{\bar{Q}} \oplus \text{Vect} \\
\downarrow \text{cond.} & & \downarrow \text{cond.} \\
\text{Vect}_\Gamma^Q & \xrightarrow{\mathbb{Z}_2\text{-crossed ext.}} & \text{Vect}_\Gamma^Q[\mathbb{Z}_2, \varepsilon]\n\end{array}
$$

where (Γ*, Q*) corresponds to an isotropic subgroup (meaning an even lattice *L*) in (\mathbb{R}^d, \bar{Q}) , in order to produce the braided Z₂-crossed tensor category Vect^{Q}_I^{Z}₂, ε] with all structures.

In principle, for this we need an infinite version of a Tambara-Yamagami category associated with the infinite, abelian group R *^d* with automorphism −id, which should $\det^Q(\mathbb{R}^d)$ which we cannot define a tensor product be $\mathrm{Vect}_{\mathbb{R}^d}^Q$ which we cannot define a tensor product in the usual sense.

Nonetheless, we use this approach in [\[GLM24\]](#page-46-1) to very explicitly determine the data that *should* define $Vect^{\mathcal{Q}}_{\Gamma}[\mathbb{Z}_2, \varepsilon]$. We then use this in [Section 5.2](#page-22-0) as input for a rigorous (but without [\[GLM24\]](#page-46-1) ad hoc seeming) definition of a braided \mathbb{Z}_2 -crossed tensor category $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$. We prove that this is indeed a braided \mathbb{Z}_2 -crossed extension of Vect^{*Q*}_C and hence must coincide with Vect_{^{*C*}_C^{*Q*}_L₂, ε .}

Finally, in [Section 5.4](#page-30-0) we realise the discriminant form (Γ*, Q*) explicitly as dual quotient $\Gamma = L^*/L$ of some even lattice L. That is, we view $\text{Vect}_{\Gamma}^Q = \text{Vect}_{\Gamma}^{(\sigma,\omega)}$ concretely as the condensation

$$
\text{Vect}_{\mathbb{R}^d}^{\bar{Q}} = \text{Vect}_{\mathbb{R}^d}^{(\bar{\sigma}, \bar{\omega})} \rightsquigarrow \text{Vect}_{\Gamma}^{Q} = \text{Vect}_{\Gamma}^{(\sigma, \omega)}
$$

of the infinite pointed braided fusion category $Vect_{\mathbb{R}^d}^{\bar{Q}}$ by the even lattice *L*, as discussed in detail in Section 4.3 of [\[GLM24\]](#page-46-1). Then, we discuss how these lattice data produce the data used to define the braided \mathbb{Z}_2 -crossed tensor category $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$. If *L* is positive-definite, the braided \mathbb{Z}_2 -crossed tensor category will in this way appear for the \mathbb{Z}_2 -orbifold of the corresponding lattice vertex operator algebra, which we discuss in [\[GLM24\]](#page-46-1).

5.1. **Special Abelian Cocycles.** Recall from [Example 3.2](#page-4-2) that for a quadratic form *Q* over a finite, abelian group Γ (i.e. a discriminant form if *Q* is nondegenerate), we can consider a representing abelian 3-cocycle (σ, ω) on Γ, namely such that $\sigma(a, a) = Q(a)$ for all $a \in \Gamma$. In the following, we aim to show that every pair (Γ*, Q*) has a special representing abelian 3-cocycle that is particularly suited for the purposes of this text.

For the following discussion, we sometimes refer to the orthogonal decomposition of a discriminant form into its (indecomposable) *Jordan components*. For notation and further details, we refer the reader to [Table 1](#page-3-2) and [\[CS99,](#page-45-7) [Sch09\]](#page-46-8).

Definition 5.1. Let Γ be an abelian group. A normalised symmetric 2-cochain $\sigma: \Gamma \times \Gamma \to \mathbb{C}^\times$ is called *abelian* if $\partial(\sigma)(a;b,c) := \sigma(a,b)\sigma(a,c)\sigma(a,b+c)^{-1} \in \{\pm 1\}$ for $a, b, c \in \Gamma$ and the map

(10)
$$
\partial(\sigma)(-;b,c): \Gamma \to \{\pm 1\}, \quad a \mapsto \partial(\sigma)(a;b,c),
$$

is a group homomorphism for every pair $b, c \in \Gamma$. The subset of all abelian symmetric 2-cochains is an abelian subgroup of the 2-cochains and will be denoted by $C^2_{sym}(\Gamma, \mathbb{C}^\times).$

Note that $\partial(\sigma)$ is by definition symmetric in the last two arguments.

Lemma 5.2. *If* $\sigma \in C^2_{sym}(\Gamma, \mathbb{C}^\times)$ *, then the pair* $(\sigma, \partial(\sigma))$ *is an abelian 3-cocycle. The map* $C_{sym}^2(\Gamma, \mathbb{C}^\times) \to Z_{ab}^3(\Gamma, \mathbb{C}^\times)$, $\sigma \mapsto (\sigma, \partial(\sigma))$ *is a group homomorphism that induces a well-defined homomorphism*

$$
\partial\colon C^2_{\rm sym}(\Gamma,\mathbb{C}^\times)\to H^3_{\rm ab}(\Gamma,\mathbb{C}^\times)
$$

with kernel ker $(\partial) = {\sigma \in C^2_{sym}(\Gamma, \mathbb{C}^\times) \mid \sigma(a, a) = 1 \text{ for all } a \in \Gamma}.$

Proof. By equation [\(10\)](#page-17-1), the map ∂ can be viewed as a group homomorphism

$$
C_{sym}^2(\Gamma, \mathbb{C}^\times) \to Z^2(\Gamma, \widehat{\Gamma}), \quad \sigma \mapsto \partial(\sigma).
$$

It can be readily verified that, in general, for each $\alpha \in Z^2(\Gamma,\widehat{\Gamma})$, the function $\alpha(a;b,c)$ defines a 3-cocycle in $Z^3(\Gamma,\mathbb{C}^\times)$.

Moreover, since $\partial(\sigma)(a;b,c) = \partial(\sigma)(a;c,b)$, the abelian (or hexagon) condition in equation [\(1\)](#page-4-0) for $\omega = \partial(\sigma)$ is given by

$$
\partial(\sigma)(a;b,c)^{-1} = \partial(\sigma)(a;b,c)^{-1}, \quad \partial(\sigma)(c;a,b) = \partial(\sigma)(c;a,b)^{-1}
$$

for $a, b, c \in \Gamma$. Since $\partial(\sigma)(a, b, c) \in \{\pm 1\}$, these conditions are satisfied. Altogether, $(\sigma, \partial(\sigma))$ lies in $Z^3_{ab}(\Gamma, \mathbb{C}^\times)$ for $\sigma \in C^2_{sym}(\Gamma, \mathbb{C}^\times)$.

Finally, an arbitrary abelian 3-cocycle $(\sigma, \omega) \in Z^3_{ab}(\Gamma, \mathbb{C}^\times)$ is cohomologous to the trivial cocycle if and only if $\sigma(a, a) = 1$ for all $a \in \Gamma$. In particular, the same holds for $(\sigma, \partial(\sigma))$.

We shall show that every quadratic form has an associated abelian 3-cocycle that comes from an abelian symmetric 2-cochain. To do this, and to present concrete nontrivial examples, we need to construct an abelian symmetric 2-cochain for two families of discriminant forms (cf. [Table 1\)](#page-3-2).

Example 5.3. Let $\Gamma = \mathbb{Z}_n$ be a cyclic group of even order. We represent the elements in \mathbb{Z}_n by integers $0 \leq x < n$. A generator of the abelian group of quadratic forms over Γ is given by

$$
Q_{2n}^0(x) \coloneqq \mathbf{e}\left(\frac{x^2}{2n}\right), \quad 0 \le x < n,
$$

that is, any other quadratic form over Γ is obtained as a power of Q_{2n}^0 . (In the special case where $n = 2^k$, $k \geq 1$, is a power of 2, this discriminant form is indecomposable and denoted by the Jordan symbol n_1^{+1} , see [Table 1.](#page-3-2) The other Jordan symbols $n_t^{\pm 1}$ are realised by raising Q_{2n}^0 to the power of *t*.)

An abelian symmetric 2-cochain associated with Q_{2n}^0 is given by

$$
\sigma_{2n}^0(x,y) \coloneqq \mathbf{e}\left(\frac{xy}{2n}\right), \quad 0 \le x, y < n.
$$

The associated 3-cocycle, measuring the failure of σ_{2n}^0 to be bimultiplicative, is

$$
\partial(\sigma_{2n}^0)(a;x,y) = (-1)^{a\rho(x,y)}
$$

where

(11)
$$
\rho(x,y) := \begin{cases} 1 & \text{if } x+y \ge n, \\ 0 & \text{otherwise} \end{cases}
$$

for $0 \le x, y < 0$.

Example 5.4. Let $\Gamma_k = \mathbb{Z}_{2^k} \oplus \mathbb{Z}_{2^k}$ for any $k \geq 1$, with representatives (x_1, x_2) for $0 \leq x_1, x_2 < 2^k$. We endow Γ_k with the nondegenerate quadratic forms

$$
Q_k^+(x_1, x_2) \coloneqq e\left(\frac{x_1 x_2}{2^k}\right), \quad Q_k^-(x_1, x_2) \coloneqq e\left(\frac{x_1^2 + x_1 x_2 + x_2^2}{2^k}\right),
$$

where $0 \le x_1, x_2 < 2^k$.

The discriminant form (Γ_k, Q_k^+) corresponds to the Drinfeld centre of the pointed category $Vect_{\mathbb{Z}_{2^k}}$, while (Γ_k, Q_k^-) is a generalisation of the 3-fermion, in the sense that it is anisotropic. Both discriminant forms are indecomposable and their Jordan symbols are $(2^k)_H^{+2}$ and $(2^k)_H^{-2}$, respectively (see [Table 1\)](#page-3-2).

Abelian symmetric 2-cochains associated with Q_k^{\pm} are given by

$$
\sigma_k^+((x_1, x_2), (y_1, y_2)) \coloneqq e\left(\frac{x_1y_2 + x_2y_1}{2^{k+1}}\right),
$$

$$
\sigma_k^-((x_1, x_2), (y_1, y_2)) \coloneqq e\left(\frac{x_1y_1 + x_2y_2 + x_1y_2 + x_2y_1}{2^{k+1}}\right).
$$

where $0 \leq x_i, y_i < 2^k$.

In these cases, the 3-cocycles $\partial(\sigma_k^{\pm})$ are given by

$$
\partial(\sigma_k^+)((a_1, a_2); (x_1, x_2), (y_1, y_2)) = (-1)^{a_1 \rho(x_2, y_2) + a_2 \rho(x_1, y_1)},
$$

\n
$$
\partial(\sigma_k^-)((a_1, a_2); (x_1, x_2), (y_1, y_2)) = (-1)^{a_1(\rho(x_1, y_1) + \rho(x_2, y_2)) + a_2(\rho(x_2, y_2) + \rho(x_1, y_1))},
$$

where $0 \leq x_i, y_i < 2^k$, and ρ is defined in equation [\(11\)](#page-18-0).

Without loss of generality, given a quadratic form *Q* on Γ, we may assume that the representing abelian 3-cocycle (σ, ω) has the following nice form, facilitating the subsequent computations:

Proposition 5.5. *For any abelian group* Γ*, the group homomorphism*

$$
\partial\colon C^2_{\mathrm{sym}}(\Gamma,\mathbb{C}^\times)\to H^3_{\mathrm{ab}}(\Gamma,\mathbb{C}^\times)
$$

is surjective. In other words, any (possibly degenerate) quadratic form Q on Γ *has a representing abelian 3-cocycle of the form* (*σ, ω*) = (*σ, ∂*(*σ*)) *for some abelian symmetric 2-cochain* σ *. In particular, these abelian 3-cocycles* (σ , $ω$) *satisfy the following properties:*

- *(1) σ is normalised, i.e.* $σ(a, 1) = σ(1, a) = 1$ *for all* $a ∈ Γ$ *,*
- *(2) σ is symmetric, i.e.* $σ(a, b) = σ(b, a)$ *for all* $a, b ∈ Γ$,
- *(3) for fixed* $b, c \in \Gamma$, $\omega(\cdot, b, c)$ *defines a group homomorphism* $\Gamma \to \mathbb{C}^{\times}$,
- *(4)* σ (*a, b* + *c*) σ (*a, b*)⁻¹ σ (*a, c*)⁻¹ = *ω*(*a, b, c*) *for all a, b, c* ∈ Γ*.*

This also entails that $\sigma^2 = B_Q$, the bilinear form associated with *Q*, and that *ω* only takes values in $\{\pm 1\}$, such that *ω*(*·, b, c*) defines a group homomorphism $\Gamma/2\Gamma \to \mathbb{C}^\times$ for all $b, c \in \Gamma$. Additionally, $\omega(a, b, c) = \omega(a, c, b)$ for all $a, b, c \in \Gamma$.

We remark that if $|\Gamma|$ is odd, then the above properties reduce to the choice of abelian 3-cocycle (σ, ω) in the second half of [Section 4.](#page-13-0) That is, the only solution in this case is given by $\omega = 1$ and σ the unique bimultiplicative square root of B_{Ω} (see [Example 3.2\)](#page-4-2).

Proof. First, suppose that Γ is odd. For a quadratic form *Q* on Γ, the symmetric bilinear form $\sigma(a, b) \coloneqq B_Q(a, b)^{1/2} = (Q(a + b)/(Q(a)Q(b)))^{1/2}$ is an abelian symmetric 2-cochain such that $\omega := \partial(\sigma) = 1$ and $\sigma(a, a) = Q(a)$ for all $a \in \Gamma$.

Now, to the general case. First, we assume that *Q* is nondegenerate, i.e. that (Γ*, Q*) is a discriminant form. Note that it suffices to prove the assertion for the indecomposable orthogonal components of (Γ*, Q*). Indeed, all of the assertions are preserved under taking orthogonal direct sums. As we will see, the decomposition and [Example 5.3](#page-18-1) and [Example 5.4](#page-18-2) provide us with a concrete way to construct an associated abelian symmetric 2-cochain on Γ. Although the orthogonal decomposition of Γ is not entirely unique, this does not affect the argument, as we are primarily asserting an existence statement.

Without loss of generality, assume now that (Γ*, Q*) is indecomposable and of order a power of 2; we have treated the odd case above. The indecomposable discriminant forms are either over cyclic groups of order a power of 2 or the families constructed in [Example 5.4.](#page-18-2) In both cases, the examples provide specific abelian symmetric 2-cochains, thus allowing us, via the orthogonal decomposition, to construct a concrete symmetric abelian 2-cochain associated with the nondegenerate quadratic form *Q* on Γ.

Finally, if (Γ*, Q*) is degenerate, we can embed it into a (nondegenerate) discriminant form using the construction of the double:

$$
(\Gamma, Q) \to (\Gamma \oplus \widehat{\Gamma}, \widehat{Q}), \quad a \mapsto (a, 0),
$$

where $\widetilde{Q}(a, \gamma) = Q(a)\gamma(a)$ for $a \in \Gamma$ and $\gamma \in \widehat{\Gamma}$; see Proposition 5.8 in [\[DN21\]](#page-45-6). By the previous argument, $(\Gamma \oplus \widehat{\Gamma}, \widetilde{Q})$ has an associated abelian symmetric 2-cochain, and by restriction, this defines another one over (Γ, Q) and by restriction, this defines another one over (Γ, Q) .

In [Proposition 5.21,](#page-31-0) we will see how abelian 3-cocycles with the properties described in [Proposition 5.5](#page-19-0) arise naturally in the context of discriminant forms $\Gamma = L^*/L$ of even lattices, where the bilinear form $\langle \cdot, \cdot \rangle$ takes values in 2Z, i.e. $\Gamma = L/L$ of even factless, where $\sqrt{2}$.

Remark 5.6. The lattices in [Proposition 5.21](#page-31-0) provide an alternative way to prove [Proposition 5.5](#page-19-0) (in the nondegenerate case). While it is clear that not all discriminant forms can be realised as dual quotients L^*/L of even lattices $L = \sqrt{2}K$ with *K* integral, all indecomposable Jordan components do indeed appear in L^*/L for some lattice $L = \sqrt{2K}$. As explained in the above proof, this is sufficient to prove the assertion.

We fix further structures on the (Γ, Q) . In addition to [Proposition 5.5,](#page-19-0) where we described a square root of the bimultiplicative form *B^Q* associated with *Q*, we now describe a square root of the quadratic form *Q* itself. Again, we first consider specific examples, before using these to prove the general case.

Example 5.7.

(1) Consider the discriminant form (\mathbb{Z}_n, Q_{2n}^0) , where $n \geq 2$ is even, and the abelian symmetric 2-cochain σ_{2n}^0 on it from [Example 5.3.](#page-18-1) Set

$$
q_{2n}^0(x) \coloneqq \mathsf{e}\left(\frac{x^2}{4n}\right), \quad 0 \le x < n.
$$

Then $q_{2n}^0(a)^2 = Q_{2n}(a)$, and moreover, with $\omega \coloneqq \partial(\sigma_{2n}^0)$,

$$
\frac{q_{2n}(a+b)}{q_{2n}(a)q_{2n}(b)} = \sigma_{2n}^{0}(a,b)\omega(a+b,a,b)\omega(\delta,a,b)
$$

for all $a, b \in \mathbb{Z}_n$, where $\delta = 0$ if $4 | n$ and $\delta = 1$ otherwise.

(2) Consider the discriminant form $(\mathbb{Z}_{2^k} \oplus \mathbb{Z}_{2^k}, Q_k^+)$ for $k \geq 1$ and the abelian symmetric 2-cochain σ_k^+ from [Example 5.4.](#page-18-2) Define

$$
q_k^+(x_1, x_2) := e\left(\frac{x_1 x_2}{2^{k+1}}\right), \quad 0 \le x_1, x_2 < 2^k.
$$

Then $q_k^+(a_1, a_2)^2 = Q_k^+(a_1, a_2)$, and moreover, with $\omega \coloneqq \partial(\sigma_k^+),$

$$
\frac{q_k^+(a_1+b_1, a_2+b_2)}{q_k^+(a_1, a_2)q_k^+(b_1, b_2)} = \sigma_k^+((a_1, a_2), (b_1, b_2))\omega((a_1+b_1, a_2+b_2), (a_1, a_2), (b_1, b_2))
$$

for all $a_i, b_i \in \mathbb{Z}_{2^k}$.

(3) Consider the discriminant form $(\mathbb{Z}_{2^k} \oplus \mathbb{Z}_{2^k}, Q_k^-)$ for $k \geq 1$ and the abelian symmetric 2-cochain σ_k^- from [Example 5.4.](#page-18-2) Define

$$
q_k^-(x_1, x_2) \coloneqq e\left(\frac{x_1^2 + x_1x_2 + x_2^2}{2^{k+1}}\right),
$$

where $0 \le x_1, x_2 < 2^k$. It follows that $q_k^-(a_1, a_2)^2 = Q_k^-(a_1, a_2)$, and moreover

$$
\frac{q_k^-(a_1+b_1, a_2+b_2)}{q_k^-(a_1, a_2)q_k^-(b_1, b_2)} = \sigma_k^-(a_1, a_2), (b_1, b_2))\omega((a_1+b_1, a_2+b_2), (a_1, a_2), (b_1, b_2))
$$

for all $a_i, b_i \in \mathbb{Z}_{2^k}$, with $\omega \coloneqq \partial(\sigma_k^-)$.

For an abelian group Γ , let $\Gamma_2 := \{a \in \Gamma \mid 2a = 1\}.$

Proposition 5.8. *Given a representing abelian* 3*-cocycle* $(\sigma, \omega) = (\sigma, \partial(\sigma))$ *for* (Γ, Q) *as in [Proposition 5.5,](#page-19-0) there is an element* $\delta \in \Gamma_2$ *and a function* $q: \Gamma \to \mathbb{C}^\times$ *such that:*

 (1) $q(a)^2 = \sigma(a, a) = Q(a)$, *(2)* $q(a + b)q(a)^{-1}q(b)^{-1} = σ(a, b)ω(a + b, a, b)ω(δ, a, b)$

for all $a, b \in \Gamma$ *.*

Proof. The proof is similar to the proof of [Proposition 5.5.](#page-19-0) Again, it suffices to prove the assertion for all indecomposable discriminant forms (Γ*, Q*).

For odd $|\Gamma|$, where σ had to be the unique bimultiplicative square root of B_Q and *ω* trivial, the unique solution is $\delta = 0$ since $\Gamma/2\Gamma = \{0\}$ and *q* the unique quadratic square root of *Q*.

For the indecomposable 2-adic Jordan components, all verified in [Example 5.7,](#page-20-0) a choice of *q* is possible with $\delta = 0$, except for the Jordan components $2_t^{\pm 1}$, where we need to set $\delta = 1 \in \mathbb{Z}_2$. Hence, for any decomposition of (Γ, Q) , the element δ will always lie in Γ_2 .

In other words, in the case of a discriminant form (Γ, Q) and fixing a decomposition into indecomposable Jordan blocks, $\delta \in \Gamma_2$ is of the form

$$
\delta = \sum_{D} \begin{cases} 1 \in \mathbb{Z}_2 \cong D/2D & \text{if } D \cong 2_t^{\pm 1}, \\ 0 \in D/2D & \text{else,} \end{cases}
$$

where the sum runs over the indecomposable Jordan components *D* of Γ.

Since ω is a homomorphism into $\{\pm 1\}$ in the first argument, δ is only relevant modulo 2Γ. Hence, reversely, if we assume, as asserted by [Proposition 5.8,](#page-21-0) that $\delta \in \Gamma_2$, i.e. $2\delta = 0$, then it is not difficult to see that the quotient $\Gamma_2/(2\Gamma \cap \Gamma_2)$ is nontrivial if and only if $\Gamma_2 \not\subset T$ if and only if Γ splits off (as abelian groups) direct summands of order 2. In other words, nontrivial contributions to δ can only come from direct summands of order 2, and this is what we see in the proof of [Proposition 5.8.](#page-21-0)

In view of [Proposition 5.21](#page-31-0) we remark that the Jordan components $2_t^{\pm 1}$ only appear in the context of even lattices $L = \sqrt{2}K$ where K is integral but not even. On the other hand, all other indecomposable Jordan components already appear for lattices $L = \sqrt{2K}$ where K is even. We observe that the somewhat natural choice of δ given in [Proposition 5.22](#page-32-0) for $\Gamma = L^*/L$ agrees with the above formula for δ , as it must.

Remark 5.9. [Proposition 5.8](#page-21-0) can also be proved using the concrete lattice realisation in [Proposition 5.21](#page-31-0) because all all indecomposable Jordan components appear √ in L^*/L for some lattice $L = \sqrt{2}K$ with *K* integral.

For instance, if *K* is even, then it is apparent from the construction there that $\delta = 0$. On the other hand, for $K = \mathbb{Z}$ and $L = \sqrt{2}\mathbb{Z}$ so that $L^*/L \cong 2_1^{+1}$ the construction there yields $\delta = 1 \in \mathbb{Z}_2$, in agreement with the above claim.

5.2. **Braided** \mathbb{Z}_2 -Crossed Tensor Category. In the following, we explicitly define a braided *G*-crossed extension $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$ with $G = \langle g \rangle \cong \mathbb{Z}_2$ of the braided tensor category Vect^Q_C with an action of \mathbb{Z}_2 by $g_*\mathbb{C}_a = \mathbb{C}_{-a}$ and a certain tensor structure $τ^g$.

We assume in the following that the representing abelian 3-cocycle (σ, ω) for the discriminant form (Γ*, Q*) has the form given in [Proposition 5.5.](#page-19-0) We further fix a sign $\varepsilon = \pm 1$. Moreover, let $\delta \in \Gamma/2\Gamma$ be (for now) arbitrary.

Given these data, consider the \mathbb{Z}_2 -graded abelian category

$$
\mathcal{C} = \mathcal{C}_1 \oplus \mathcal{C}_g = \text{Vect}_{\Gamma} \oplus \text{Vect}_{\Gamma/2\Gamma},
$$

where the simple objects are denoted by \mathbb{C}_a for $a \in \Gamma$ and by $X^{\bar{x}}$ for $\bar{x} \in \Gamma/2\Gamma$. In general, we also denote the coset of an element $x \in \Gamma$ by $\bar{x} \in \Gamma/2\Gamma$.

Then we shall prove below (see [Section 6\)](#page-33-0) that the following endows $\mathcal C$ with the structure of a \mathbb{Z}_2 -graded tensor category $\mathcal{GLM}(\Gamma,\sigma,\omega,\delta,\varepsilon)$:

$$
\mathbb{C}_a \otimes \mathbb{C}_b = \mathbb{C}_{a+b},
$$

\n
$$
\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}} = \mathsf{X}^{\bar{a}+\bar{x}},
$$

\n
$$
\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a = \mathsf{X}^{\bar{x}+\bar{a}},
$$

\n
$$
\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}} = \bigoplus_{\substack{t \in \Gamma \\ \bar{t} = \delta + \bar{x} + \bar{y}}} \mathbb{C}_t = \bigoplus_{t \in \delta + \bar{x} + \bar{y}} \mathbb{C}_t
$$

for $a, b \in \Gamma$ and $\bar{x}, \bar{y} \in \Gamma/2\Gamma$, where we take the associator to be

$$
(\mathbb{C}_a \otimes \mathbb{C}_b) \otimes \mathbb{C}_c \xrightarrow{\omega(a,b,c)} \mathbb{C}_a \otimes (\mathbb{C}_b \otimes \mathbb{C}_c),
$$

\n
$$
(\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a) \otimes \mathbb{C}_b \xrightarrow{\omega(\bar{x}+\delta,a,b)} \mathsf{X}^{\bar{x}} \otimes (\mathbb{C}_a \otimes \mathbb{C}_b),
$$

\n
$$
(\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}}) \otimes \mathbb{C}_b \xrightarrow{\sigma(a,b)} \mathbb{C}_a \otimes (\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_b),
$$

(\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}}) \otimes \mathsf{X}^{\bar{x}} \xrightarrow{\omega((a+b)+\bar{x},a,b)} \mathbb{C}_a \otimes (\mathbb{C}_b \otimes \mathsf{X}^{\bar{x}}),
$$

\n

e_{a+t} \in (\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}}) \otimes \mathsf{X}^{\bar{y}} \xrightarrow{\omega(a+\bar{x},a,t)} \mathbb{C}_a \otimes (\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \ni e_a \otimes e_t,
$$

\n
$$
e_a \otimes e_t \in (\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \otimes \mathbb{C}_a \xrightarrow{\omega(\bar{x},t,a)} \mathsf{X}^{\bar{x}} \otimes (\mathsf{X}^{\bar{y}} \otimes \mathbb{C}_a) \ni e_{a+t},
$$

\n
$$
e_t \in (\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a) \otimes \mathsf{X}^{\bar{y}} \xrightarrow{\sigma(a,t)} \mathsf{X}^{\bar{x}} \otimes (\mathbb{C}_a \otimes \mathsf{X}^{\bar{y}}) \ni e_t,
$$

\n
$$
v_t \in (\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \otimes \mathsf{X}^{\bar{z}} \xrightarrow{\varepsilon |2\Gamma|^{-1/2} \sigma(t,r)^{-1}} \mathsf{X}^{\bar{x
$$

with the normalisation factor $|2\Gamma|$ for $a, b, c \in \Gamma$ and $\bar{x}, \bar{y}, \bar{z} \in \Gamma/2\Gamma$. Here, $e_t \in \mathbb{C}_t$ denotes a vector in the tensor product $X^{\bar{x}} \otimes X^{\bar{y}} = \bigoplus_{t \in \delta + \bar{x} + \bar{y}} C_t$ and $v_t \in X^{\bar{t} + \bar{z}}$ in $\text{the tensor product } (\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \otimes \mathsf{X}^{\bar{z}} = \bigoplus_{t \in \delta + \bar{x} + \bar{y}} \mathsf{X}^{\bar{t} + \bar{\bar{z}}}.$

Similarly to [Section 4,](#page-13-0) there is a rigid structure with dual objects $\mathbb{C}_a^* = \mathbb{C}_{-a}$ and $(X^{\bar{x}})^* = X^{-\bar{x}-\delta}$ and with coev_X = *ι*_{C₀} and ev_X = $\varepsilon|2\Gamma|^{1/2}\pi_{C_0}$. The two zigzag identities relating ev_{X} , and $coev_{\mathsf{X}}$ hold because the associator and also the inverse associator on $X \otimes X \otimes X$ at $t = 0$ are $\varepsilon |2\Gamma|^{-1/2}$, by the slightly unusual character sum in [Lemma 6.1](#page-37-0) below.

We shall then show that this tensor category $\mathcal{C} = \mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon)$ admits an action of $G = \langle g \rangle \cong \mathbb{Z}_2$ defined by

$$
g_* \mathbb{C}_a = \mathbb{C}_{-a}, \quad g_* \mathsf{X}^{\bar{x}} = \mathsf{X}^{\bar{x}}
$$

for $a \in \Gamma$, $\bar{x} \in \Gamma/2\Gamma$, with strict composition and with tensor structures τ given by

$$
g_*(\mathbb{C}_a \otimes \mathbb{C}_b) \xrightarrow{\omega(a,b,-b)} g_*\mathbb{C}_a \otimes g_*\mathbb{C}_b,
$$

\n
$$
g_*(\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}}) \xrightarrow{\omega(a+\bar{x},a,-a)} g_*\mathbb{C}_a \otimes g_*\mathsf{X}^{\bar{x}},
$$

\n
$$
g_*(\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a) \xrightarrow{\omega(\bar{x}+\delta,a,-a)} g_*\mathsf{X}^{\bar{x}} \otimes g_*\mathbb{C}_a,
$$

\n
$$
g_*(\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \xrightarrow{\omega(\bar{x},t,-t)} g_*\mathsf{X}^{\bar{x}} \otimes g_*\mathsf{X}^{\bar{y}}
$$

for $a, b \in \Gamma$ and $\bar{x}, \bar{y} \in \Gamma/2\Gamma$ and again with t the summation index appearing in the tensor product of XX-type.

Now, suppose in addition that $\delta \in \Gamma/2\Gamma$ and $q: \Gamma \to \mathbb{C}^\times$ are given as in [Propo](#page-21-0)[sition 5.8.](#page-21-0) Recall that δ must lie in Γ_2 , i.e. $2\delta = 0$.

We shall establish that for every choice of q , the \mathbb{Z}_2 -graded tensor category C above becomes a braided \mathbb{Z}_2 -crossed tensor category $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha)$ with the following braiding:

$$
\mathbb{C}_a \otimes \mathbb{C}_b \xrightarrow{\sigma(a,b)} \mathbb{C}_b \otimes \mathbb{C}_a,
$$

\n
$$
\mathbb{C}_a \otimes \mathsf{X}^{\bar{x}} \xrightarrow{\qquad q(a)^{-1}} \mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a,
$$

\n
$$
\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a \xrightarrow{\qquad q(a)^{-1}\omega(\bar{x}+a,a,-a)} \mathbb{C}_{-a} \otimes \mathsf{X}^{\bar{x}},
$$

\n

\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}} \xrightarrow{\qquad \qquad \alpha q(t)} \mathsf{X}^{\bar{y}} \otimes \mathsf{X}^{\bar{x}}

for $a, b \in \Gamma$ and $\bar{x}, \bar{y} \in \Gamma/2\Gamma$ with a normalisation factor α given by a choice of square root of

$$
\alpha^2 = \varepsilon \, G_\delta(\Gamma, q^{-1})
$$

with the partial Gauss sum

$$
G_{\delta}(\Gamma, q^{-1}) \coloneqq |2\Gamma|^{-1/2} \sum_{a \in \delta} q(a)^{-1}.
$$

Here, *t* is again the summation index in the tensor product $X^{\bar{x}} \otimes X^{\bar{y}}$ and $X^{\bar{y}} \otimes X^{\bar{x}}$.

We study the appearing partial Gauss sum $G_{\delta}(\Gamma, q^{-1})$ in more detail. Recall that the sign $s = \pm$ (not to be confused with the signature) is well-defined for a discriminant form as long as the latter does not contain the Jordan component $2_t^{\pm 1}$. Indeed, for the Jordan components $q^{\pm n}$ (*q* a power of an odd prime) and $q_t^{\pm n}$ and $q_{II}^{\pm n}$ (*q* a power of an even prime) the sign *s* is nothing but the sign in the exponent, and then extends to the whole discriminant form multiplicatively, but for $q = 2$ there are the exceptional isomorphisms $2_1^{+1} \approx 2_5^{-1}$ and $2_3^{-1} \approx 2_7^{+1}$, meaning that the sign is in general not well-defined (see also [Table 1\)](#page-3-2). Also recall that $(\cdot) \in \{\pm 1\}$ denotes the Kronecker symbol.

Proposition 5.10. *Given a discriminant form* (Γ*, Q*) *and a choice of representing* a *belian* 3*-cocycle* (σ, ω) *as in [Proposition 5.5,](#page-19-0) as well as a choice* (q, δ) *as in [Propo](#page-21-0)[sition 5.8,](#page-21-0) the above partial Gauss sum* $G_{\delta}(\Gamma, q^{-1})$ *is well-defined (i.e. independent*

of these choices) if and only if Γ *does not contain a Jordan component* $2^{\pm 1}_t$ *in its orthogonal decomposition, in which case* $\delta = 0 \in \Gamma/2\Gamma$ *and the sum evaluates to*

$$
G_0(\Gamma, q^{-1}) = |2\Gamma|^{-1/2} \sum_{a \in 2\Gamma} q(a)^{-1} = e(-\operatorname{sign}(\Gamma)/8) s(\Gamma_{\text{ev}}) \left(\frac{2}{|\Gamma_{\text{odd}}|}\right),
$$

where $\Gamma = \Gamma_{ev} \oplus \Gamma_{odd}$ *is the decomposition of* Γ *into the* 2-*adic part and the p-adic part for all odd primes p.*

[Proposition 5.10](#page-23-0) generalises the Gauss sum $G(\Gamma, q^{-1})$ in [Section 4,](#page-13-0) see equation [\(9\)](#page-14-0) and [Remark 4.9.](#page-16-2)

Proof. A proof is obtained by proving the assertion for all indecomposable Jordan components. For the *p*-adic components for odd primes *p*, the assertion is simply [Remark 4.9.](#page-16-2) It is not difficult to compute the Gauss sum for the indecomposable 2-adic Jordan components except for $2_t^{\pm 1}$ and see that the assertion holds. \Box

For $2^{+1}_1 \cong 2^{-1}_5$ with signature 1 (mod 8), the above partial Gauss sum evaluates to $e(7/8)$ or $e(3/8)$, depending on the choice of *q*. These are exactly the values one would obtain from the formula in [Proposition 5.10](#page-23-0) by inserting either 1 or −1 for the sign *s*. Similarly, for $2^{-1} \cong 2^{+1}$ with signature 7 (mod 8), the partial Gauss sum yields $e(5/8)$ or $e(1/8)$, again compatible with [Proposition 5.10.](#page-23-0)

Finally, in view of [Proposition 5.23,](#page-32-1) we mention that if $\Gamma = L^*/L$ comes from an even lattice $L = \sqrt{2K}$ where K is even, then the sign factors in [Proposition 5.10](#page-23-0) cancel and the partial Gauss sum evaluates exactly to $e(-\text{sign}(\Gamma)/8)$. Moreover, if $L = \sqrt{2}K$ where K is only integral (in which case Jordan components $2_t^{\pm n}$ appear so that the partial Gauss sum is not well-defined), then the choice of *q* given in [Proposition 5.22](#page-32-0) fixes the value of the Gauss sum, which still evaluates to $e(-\text{sign}(\Gamma)/8)$.

Remark 5.11. Alternatively, in order to prove [Proposition 5.10,](#page-23-0) we note once again that all indecomposable Jordan components appear in discriminant forms √ $\Gamma = L^*/L$ for even lattices $L = \sqrt{2}K$ where K is integral. In fact, since we are excluding $2_t^{\pm 1}$, it suffices to consider $L =$ √ 2*K* for *K* even. Then the Gauss sum $G_0(\Gamma, q^{-1})$ takes the simple form in [Proposition 5.23,](#page-32-1) allowing us to infer the value of the Gauss sum for all indecomposable Jordan components.

For example, suppose that $q = 2^k$ for $k \geq 2$. Then the even lattice $\sqrt{q/2}A_1$ has the discriminant form $\Gamma = q_1^{+1}$, whose signature is 1 (mod 8). By [Proposition 5.23,](#page-32-1) the Gauss sum equals $G_0(\Gamma, q^{-1}) = e(7/8)$ (cf. [Example 5.24\)](#page-32-2).

Finally, we will see that the following \mathbb{Z}_2 -ribbon twist turns C into a \mathbb{Z}_2 -crossed ribbon fusion category $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$:

$$
\mathbb{C}_a \xrightarrow{\sigma(a,a)} \mathbb{C}_a,
$$

$$
\mathsf{X}^{\bar{x}} \xrightarrow{\beta} g_* \mathsf{X}^{\bar{x}}
$$

for a choice $\beta = \pm \alpha^{-1}$. We point out that the ribbon twist takes the same value on all the objects $X^{\bar{x}}$ for $\bar{x} \in \Gamma/2\Gamma$ (cf. [Remark 5.13\)](#page-25-0).

Summarising the above, we state the main result of this section (cf. [Theorem 4.2,](#page-14-1) [Proposition 4.6](#page-15-1) and [Corollary 4.8\)](#page-16-1). The proof is given in [Section 6.](#page-33-0)

Theorem 5.12. *Let* $G = \langle g \rangle \cong \mathbb{Z}_2$. *The data given above define a braided* \mathbb{Z}_2 *crossed tensor category*

$$
\operatorname{\mathcal{GLM}}(\Gamma,\sigma,\omega,\delta,\varepsilon \,|\, q,\alpha,\beta) = \operatorname{Vect}_{\Gamma} \oplus \operatorname{Vect}_{\Gamma/2\Gamma},
$$

which is a braided \mathbb{Z}_2 -crossed extension of Vect_{Γ}^Q for a discriminant form (Γ, Q) *with representing abelian* 3*-cocycle satisfying [Proposition 5.5,](#page-19-0) with the categorical* \mathbb{Z}_2 -action being $g_*\mathbb{C}_a = \mathbb{C}_{-a}$ with tensor structure $g_*(\mathbb{C}_a \otimes \mathbb{C}_b) \to g_*\mathbb{C}_a \otimes g_*\mathbb{C}_b$ given *by* $\omega(a, b, -b)$ *for* $a, b \in \Gamma$. The ribbon twist defined above yields positive quantum *dimensions if and only if* $\alpha\beta = \varepsilon$ *.*

Note that if Γ is odd and we choose $\sigma = B^{1/2}$, $\omega = 1$ and $q = Q^{1/2}$, then the definition exactly reduces to the Tambara-Yamagami category in [Section 4.](#page-13-0)

Problem 1. By the results in [\[ENO10,](#page-45-0) [DN21\]](#page-45-6), for each ε , there is a unique braided \mathbb{Z}_2 -crossed extension $\mathrm{Vect}_{\Gamma}^Q[\mathbb{Z}_2,\varepsilon]$ of Vect_{Γ}^Q (say with a ribbon structure that has positive quantum dimensions) with the given \mathbb{Z}_2 -action (which depended on ω), i.e. independent of the choice of (q, δ) . Can we verify this directly from the construction of $GLM(\Gamma, \sigma, \omega, \delta, \epsilon | q, \alpha, \epsilon/\alpha)$? Cf. [Corollary 4.8.](#page-16-1) The independence of the sign of *α* follows as in [Remark 4.3.](#page-15-4)

Remark 5.13. We point out that the braided \mathbb{Z}_2 -crossed extension in [Theo](#page-24-0)[rem 5.12](#page-24-0) corresponds to a certain categorical action of $G = \langle g \rangle \cong \mathbb{Z}_2$ on Vect^{*Q*}, which in particular permutes the simple objects as $g_*\mathbb{C}_a = \mathbb{C}_{-a}$ for all $a \in \Gamma$.

However, not all \mathbb{Z}_2 -actions with the latter property necessarily give the same extension. Indeed, if we consider the special case of discriminant forms Γ with $2\Gamma = 1$, then \mathbb{Z}_2 does not permute the objects of Vect^Q_{*C*}, which are indexed by Γ, but the action is *not* the trivial action, as can be seen by looking at the tensor structure (see also Example 4.4 in [\[GLM24\]](#page-46-1)).

The \mathbb{Z}_2 -action from [Theorem 5.12](#page-24-0) with $2\Gamma = 1$ and the truly trivial \mathbb{Z}_2 -action both produce braided \mathbb{Z}_2 -crossed extensions of the form $C_1 \oplus \mathbb{C}_g = \text{Vect}_{\Gamma} \oplus \text{Vect}_{\Gamma}$ as abelian categories, but they differ in other aspects. For instance, for our \mathbb{Z}_2 -action the ribbon twists are the same for all objects in $\mathcal{C}_g = \text{Vect}_{\Gamma}$, while this will not typically be the case for the trivial \mathbb{Z}_2 -action.

5.3. **Equivariantisation.** In this section, we consider the equivariantisation

 $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$

of the braided \mathbb{Z}_2 -crossed tensor category from [Theorem 5.12,](#page-24-0) which is a modular tensor category. In particular, we determine the simple objects, the fusion rules and the modular data, i.e. the S - and \mathcal{T} -matrix.

First, similarly to [Proposition 4.7,](#page-15-0) we show:

Proposition 5.14. *The equivariantisation* $GLM(\Gamma, \sigma, \omega, \delta, \epsilon | q, \alpha, \beta)/\mathbb{Z}_2$ *has a nondegenerate braiding, and hence is a modular tensor category.*

Proof. As proved in Proposition 4.56 of [\[DGNO10\]](#page-45-8), the equivariantisation \mathcal{C}/\mathcal{G} of a braided *G*-crossed tensor category $\mathcal C$ is nondegenerate if and only if the grading is faithful and C_1 is nondegenerate. Since $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$ is faithfully graded and the trivial sector is nondegenerate by construction, its \mathbb{Z}_2 -equivariantisation is hence nondegenerate. Furthermore, since it has a \mathbb{Z}_2 -ribbon structure, the equivariantisation is modular. \Box

We describe the simple objects of $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$. To this end, consider the exact sequence $0 \to \Gamma_2 \to \Gamma \to 2\Gamma \to 0$, where $\Gamma_2 = \{a \in \Gamma \mid 2a = 1\}$. In particular, $2\Gamma \cong \Gamma/\Gamma_2$ and $|2\Gamma||\Gamma_2| = |\Gamma|$.

Proposition 5.15. *The simple objects of* $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$, up to iso*morphism, are given by:*

(1) 2 $|\Gamma_2|$ *invertible objects (of quantum dimension 1) indexed by* $\Gamma_2 \times {\pm 1}$ *. They are given by* $X_{a,s} := \mathbb{C}_a$ *with equivariant structure* $\varphi_g = s \mathrm{id}_{\mathbb{C}_a}$ *for* $a \in \Gamma_2$ *and* $s \in \{\pm 1\}.$

- (2) $\frac{1}{2}(|\Gamma| |\Gamma_2|) = \frac{1}{2}|\Gamma|(1 1/2\Gamma|)$ *simple objects of quantum dimension* 2 *indexed by the set of unordered pairs* $\{\{a, -a\} \mid a \in \Gamma \setminus \Gamma_2\}$ *. They are given by* $Y_{\{a,-a\}} \coloneqq \mathbb{C}_a \oplus \mathbb{C}_{-a}$ *for a in* $\Gamma \setminus \Gamma_2$ *, with the equivariant structure given by interchanging the direct summands.*
- (3) $2|\Gamma_2|$ *simple objects of quantum dimension* $(|\Gamma|/|\Gamma_2|)^{1/2} = |2\Gamma|^{1/2}$ *indexed by* $\Gamma/2\Gamma \times {\pm 1}$ *. They are given by* $Z_{\bar{x},s} := X^{\bar{x}}$ *with equivariant structure* $\varphi_q = s \operatorname{id}_{\mathsf{X}^{\bar{x}}}$ *for* $\bar{x} \in \Gamma/2\Gamma$ *and* $s \in {\pm 1}$ *.*

Proof. The assertion follows directly from an application of [Example 3.6.](#page-6-1) \Box

Next, we determine the fusion rules among the simple objects of the equivariantisation. We know that $\sigma(a, -b)\sigma(a, b) = \omega(a, b, -b)$ for $a, b \in \Gamma$. In particular, for $b \in \Gamma_2$, $\omega(a, b, -b) = \sigma(a, b)^2 = B_Q(a, b)$ for $a \in \Gamma$. Moreover, it defines a group homomorphism $\omega(\cdot, a, -a)$: $\Gamma/2\Gamma \to {\pm 1}$ for each $a \in \Gamma$, or $B_Q(\cdot, a)$: $\Gamma/2\Gamma \to {\pm 1}$ for $a \in \Gamma_2$.

Proposition 5.16. *The fusion rules of* $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$ *are:*

$$
X_{a,s} \otimes X_{b,t} = X_{a+b, st\omega(a,b,-b)} = X_{a+b, stB_Q(a,b)},
$$

\n
$$
X_{a,s} \otimes Y_{\{b,-b\}} = Y_{\{a+b,a-b\}},
$$

\n
$$
X_{a,s} \otimes Z_{\bar{x},r} = Z_{\bar{a}+\bar{x}, sr\omega(a+\bar{x},a,-a)} = Z_{\bar{a}+\bar{x}, srB_Q(a+\bar{x},a)},
$$

\n
$$
Y_{\{a,-a\}} \otimes Z_{\bar{x},r} = Z_{\overline{x+a},1} \oplus Z_{\overline{x+a},-1},
$$

\n
$$
Y_{\{b,-b\}} \otimes Y_{\{c,-c\}} = \begin{cases} X_{b+c,1} \oplus X_{b+c,-1} \oplus X_{b-c,1} \oplus X_{b-c,-1} & \text{if } b+c, b-c \in \Gamma_2, \\ Y_{\{b,-b\}} \otimes Y_{\{c,-c\}} = \begin{cases} X_{b+c,1} \oplus X_{b+c,1} \oplus X_{b-c,1} & \text{if } b+c \notin \Gamma_2, b-c \in \Gamma_2, \\ Y_{\{b-c,-b+c\}} \oplus X_{b+c,1} \oplus X_{b+c,-1} & \text{if } b+c \in \Gamma_2, b-c \notin \Gamma_2, \\ Y_{\{b+c,-b-c\}} \oplus Y_{\{b-c,-b+c\}} & \text{if } b+c, b-c \notin \Gamma_2, \\ Y_{\{b+c,-b-c\}} \oplus Y_{\{b-c,-b+c\}} & \text{if } b+c, b-c \notin \Gamma_2, \\ Y_{\bar{c},r} \otimes Z_{\bar{y},s} = \bigoplus_{\bar{t}=\delta+\bar{x}+\bar{y}} X_{t,rs\omega(\bar{x},t,-t)} \oplus \bigoplus_{\bar{t}=\delta+\bar{x}+\bar{y}} Y_{\{t,-t\}} \\ \overline{t=\delta+\bar{x}+\bar{y}} & \text{if } X_{\bar{t},rsB_Q(\bar{x},t)} \oplus \bigoplus_{\bar{t}=\delta+\bar{x}+\bar{y}} Y_{\{t,-t\}}. \end{cases}
$$

Here, $(\Gamma \setminus \Gamma_2)/2$ *indicates that we select one of t or −t for each pair* $\{t, -t\} \subset \Gamma \setminus \Gamma_2$ *.*

Remark 5.17. We remark that the fusion rules of $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$ and those of its \mathbb{Z}_2 -equivariantisation $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$ do not depend on ε . This is analogous to Tambara-Yamagami categories: both $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon \mid q, \alpha, \beta)$ and $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)/\mathbb{Z}_2$ are \mathbb{Z}_2 -graded categories. We can twist the associativity constraint using the nontrivial 3-cocycle $\omega \in Z^3(\mathbb{Z}_2,\mathbb{C}^\times)$ defined by $\omega(1,1,1) = -1$. This twist only alters ε to $-\varepsilon$, leaving the fusion rules unaffected.

Finally, we determine the modular data. Recall that, given a ribbon fusion category B, its *modular data* are defined as the pair of $|\text{Irr}(\mathcal{B})| \times |\text{Irr}(\mathcal{B})|$ -matrices

$$
\mathcal{S}_{X,Y} = \text{tr}(c_{Y,X} \circ c_{X,Y}), \quad \mathcal{T}_{X,Y} = \delta_{X,Y} \theta_X^{-1},
$$

where $X, Y \in \text{Irr}(\mathcal{B})$.

Proposition 5.18. *The modular data of* $GLM(\Gamma, \sigma, \omega, \delta, \epsilon | q, \alpha, \beta)/\mathbb{Z}_2$ *are given by the* T *-matrix with entries*

$$
\mathcal{T}_{X_{a,s},X_{a,s}} = Q(a)^{-1}, \quad \mathcal{T}_{Y_{\{a,-a\}},Y_{\{a,-a\}} = Q(a)^{-1}, \quad \mathcal{T}_{Z_{\bar{x},s},Z_{\bar{x},s}} = s\beta^{-1}
$$

and the S*-matrix with entries*

$$
\begin{aligned}\n\mathcal{S}_{X_{a,s},X_{b,t}} &= B_Q(a,b), & \mathcal{S}_{X_{a,s},Y_{\{b,-b\}}} &= 2B_Q(a,b), \\
\mathcal{S}_{X_{a,s},Z_{\bar{x},r}} &= s|2\Gamma|^{1/2}B_Q(\bar{x},a)Q(a), & \mathcal{S}_{Y_{\{a,-a\}},Z_{\bar{x},r}} &= 0, \\
\mathcal{S}_{Y_{\{b,-b\}},Y_{\{c,-c\}}} &= 2\big(B_Q(b,c) + B_Q(b,c)^{-1}\big), & \\
\mathcal{S}_{Z_{\bar{x},r},Z_{\bar{y},s}} &= \varepsilon \, rs|2\Gamma|^{1/2} G_\delta(\Gamma,q^{-1}) G_{\delta+\bar{x}+\bar{y}}(\Gamma,Q),\n\end{aligned}
$$

with the Gauss sum $G_{\delta+\bar{z}}(\Gamma, Q) = |2\Gamma|^{-1/2} \sum_{a \in \delta+\bar{z}} Q(a)$ *for* $\bar{z} \in \Gamma/2\Gamma$ *and the Gauss sum* $G_{\delta}(\Gamma, q^{-1})$ *over* $q(a)^{-1}$ *from [Proposition 5.10.](#page-23-0)*

Recall that $\varepsilon \in {\pm 1}$, that β is a square root of $\beta^2 = 1/\alpha^2 = \varepsilon / G_{\delta}(\Gamma, q^{-1})$ and that the choice $\beta = \varepsilon/\alpha$ results in positive quantum dimensions. (Note that α itself does not explicitly appear in the modular data.)

Proof. First, we use [Proposition 3.16](#page-10-2) to compute the ribbon element of the equivariantisation. For simple objects graded only over the neutral component, the ribbon is simply the \mathbb{Z}_2 -twist of one of the simple constituents. For simple objects graded only over the nontrivial element g , the ribbon is the \mathbb{Z}_2 -twist of one of the simple constituents composed with φ_g . Using the \mathbb{Z}_2 -ribbons in [\(5.2\)](#page-24-1), we obtain

$$
\theta_{X_{a,s}} = Q(a), \quad \theta_{Y_{\{b,-b\}}} = Q(b), \quad \theta_{Z_{\bar{x},s}} = s\beta.
$$

The expression for the \mathcal{T} -matrix follows.

Then we compute the S -matrix using the fusion rules in [Proposition 5.16](#page-26-0) and the following formula, which holds in any modular tensor category \mathcal{B} :

$$
\mathcal{S}_{X,Y} = \theta_X^{-1} \theta_Y^{-1} \sum_{Z \in \text{Irr}(\mathcal{B})} N_{X,Y}^Z \theta_Z \dim(Z)
$$

for all $X, Y \in \text{Irr}(\mathcal{B})$, with the fusion rules written as $X \otimes Y = \bigoplus_{Z \in \text{Irr}(\mathcal{B})} N_{X,Y}^Z Z$ with $N_{X,Y}^Z \in \mathbb{Z}_{\geq 0}$.

(1) Since $X_{a,s} \otimes X_{b,t} = X_{a+b,stB_Q(a,b)}$, it follows

$$
\mathcal{S}_{X_{a,s},X_{b,t}} = Q(a)^{-1}Q(b)^{-1}Q(a+b) = B_Q(a,b).
$$

(2) Because $X_{a,s} \otimes Y_{\{b,-b\}} = Y_{\{a+b,a-b\}}$, we obtain

$$
\mathcal{S}_{X_{a,s},Y_{\{b,-b\}}} = 2Q(a)^{-1}Q(b)^{-1}Q(a+b) = 2B_Q(a,b).
$$

 (3) Since $X_{a,s} \otimes Z_{\bar{x},r} = Z_{\bar{a}+\bar{x},srB_Q(a+\bar{x},a)}$

$$
\mathcal{S}_{X_{a,s},Z_{\bar{x},r}} = |2\Gamma|^{1/2} Q(a)^{-1} r \beta^{-1} r s \beta B_Q(a+\bar{x},a) = s |2\Gamma|^{1/2} B_Q(\bar{x},a) Q(a).
$$

(4) The fusion rule $Y_{\{a,-a\}} \otimes Z_{\bar{x},r} = Z_{\overline{x+a},1} \oplus Z_{\overline{x+a},-1}$ implies

$$
\mathcal{S}_{Y_{\{a,-a\}},Z_{\bar{x},r}} = Q(a)^{-1} r \beta^{-1} (|2\Gamma|^{1/2} \beta - |2\Gamma|^{1/2} \beta) = 0.
$$

(5) From the fusion rule of $Y_{\{b,-b\}} \otimes Y_{\{c,-c\}}$ we obtain

$$
S_{Y_{\{b,-b\}},Y_{\{c,-c\}}} = Q(b)^{-1}Q(c)^{-1}(2Q(b+c) + 2Q(b-c))
$$

= 2(B_Q(b,c) + B_Q(b,-c))
= 2(B_Q(b,c) + B_Q(b,c)⁻¹).

(6) Finally, the fusion rule of $Z_{\bar{x},r} \otimes Z_{\bar{y},s}$ implies that

$$
\mathcal{S}_{Z_{\bar{x},r},Z_{\bar{y},s}} = rs\beta^{-2} \sum_{t \in \delta + \bar{x} + \bar{y}} Q(t)
$$

= $rs\alpha^2 |2\Gamma|^{1/2} G_{\delta + \bar{x} + \bar{y}}(\Gamma, Q)$
= $\varepsilon rs |2\Gamma|^{1/2} G_{\delta}(\Gamma, q^{-1}) G_{\delta + \bar{x} + \bar{y}}(\Gamma, Q).$

We comment on the product $|2\Gamma|^{1/2}G_{\delta}(\Gamma, q^{-1})G_{\delta+\bar{x}+\bar{y}}(\Gamma, Q)$ of the two partial Gauss sums appearing in the S-matrix entry $\mathcal{S}_{Z_{\bar{x},r},Z_{\bar{y},s}}$. The first Gauss sum is welldefined only for discriminant forms not containing $2_t^{\pm 1}$ and evaluated in [Proposi](#page-23-0)[tion 5.10.](#page-23-0) The second Gauss sum is always well-defined but takes exceptional values for $2_t^{\pm 1}$, $4_t^{\pm 1}$ and $2_H^{\pm 1}$. For ease of presentation, let us assume that the discriminant form (Γ, Q) does not contain these Jordan components. Then $\delta = 0 \in \Gamma/2\Gamma$ and

$$
G_{\delta + \bar{x} + \bar{y}}(\Gamma, Q) = |\Gamma/2\Gamma|^{1/2} e(\text{sign}(\Gamma, Q)/8) \delta_{\bar{x} + \bar{y}, 0}.
$$

Hence, the product of the Gauss sums evaluates to

(12)
$$
|2\Gamma|^{1/2} G_{\delta}(\Gamma, q^{-1}) G_{\delta + \bar{x} + \bar{y}}(\Gamma, Q) = |\Gamma|^{1/2} s(\Gamma_{\text{ev}}) \left(\frac{2}{|\Gamma_{\text{odd}}|}\right) \delta_{\bar{x} + \bar{y}, 0}
$$

if we exclude the possibility of these exceptional cases. Below, we list also the (exceptional) S-matrix entry for the discriminant forms $4_t^{\pm 1}$.

If C and D are braided \mathbb{Z}_2 -crossed tensor categories, then the tensor category $\mathcal{C} \boxtimes^{\mathbb{Z}_2} \mathcal{D} = (\mathcal{C}_1 \boxtimes \mathcal{D}_1) \oplus (\mathcal{C}_q \boxtimes \mathcal{D}_q) \subset \mathcal{C} \boxtimes \mathcal{D}$ is a braided \mathbb{Z}_2 -crossed tensor category with the diagonal \mathbb{Z}_2 -action and the obvious \mathbb{Z}_2 -braiding. In particular,

$$
\mathcal{GLM}(\Gamma_1, \sigma_1, \omega_1, \delta_1, \varepsilon_1 \, | \, q_1, \alpha_1, \beta_1) \boxtimes^{\mathbb{Z}_2} \mathcal{GLM}(\Gamma_2, \sigma_2, \omega_2, \delta_2, \varepsilon_2 \, | \, q_2, \alpha_2, \beta_2) \cong \mathcal{GLM}(\Gamma_1 \oplus \Gamma_2, \sigma_1 \oplus \sigma_2, \omega_1 \oplus \omega_2, \delta_1 \oplus \delta_2, \varepsilon_1 \varepsilon_2 \, | \, q_1 \oplus q_2, \alpha_1 \alpha_2, \beta_1 \beta_2).
$$

Hence, it suffices to present concrete examples associated with *indecomposable* discriminant forms (Γ*, Q*).

Odd Groups. Let (Γ*, Q*) be a discriminant form (indecomposable or not) where Γ is a group of odd order. Then, we already noted that $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$ reduces to the (odd) Tambara-Yamagami category $\mathcal{TV}(\Gamma, \sigma, \varepsilon | q, \alpha, \beta)$, as considered in [Section 4.](#page-13-0) In that case, the equivariantisation was already computed in Section 5 of [\[GNN09\]](#page-46-6).

Recall that in the odd case, q is the unique quadratic square root of Q , σ is the unique bimultiplicative square root of B_Q and $\delta = 0 \in \Gamma_2$. Moreover, $|\Gamma_2| = 1$ and $2\Gamma = \Gamma$.

It is not difficult to reduce our formulae for the fusion rules and the modular data to the special case of odd |Γ|, and we find perfect agreement with [\[GNN09\]](#page-46-6). Indeed, the simple objects are then classified as follows:

(1) Two invertible objects X_s (of quantum dimension 1) for $s \in \{\pm 1\}$.

(2) $(|\Gamma| - 1)/2$ simple objects $Y_{\{a,-a\}}$ of quantum dimension 2 for $a \in \Gamma \setminus \{0\}.$

(3) Two simple objects Z_s of quantum dimension $|\Gamma|^{1/2}$ for $s \in {\pm 1}$.

We forego an explicit description of the fusion rules; they are readily read off from [Proposition 5.16.](#page-26-0)

In the odd case, the modular data are given by the \mathcal{T} -matrix

$$
\mathcal{T}_{X_s,X_s} = 1, \quad \mathcal{T}_{Y_{\{a,-a\}},Y_{\{a,-a\}}} = Q(a)^{-1}, \quad \mathcal{T}_{Z_s,Z_s} = s\beta^{-1}
$$

and the S-matrix

$$
S_{X_s, X_t} = 1, \t S_{X_s, Y_{\{b,-b\}}} = 2,
$$

\n
$$
S_{X_s, Z_r} = s|\Gamma|^{1/2}, \t S_{Y_{\{b,-b\}}, Y_{\{c,-c\}}} = 2(B_Q(b, c) + B_Q(b, c)^{-1}),
$$

\n
$$
S_{Z_s, Z_r} = \varepsilon r s|\Gamma|^{1/2} G(\Gamma, q^{-1}) G(\Gamma, Q) = \varepsilon r s|\Gamma|^{1/2} \left(\frac{2}{|\Gamma|}\right).
$$

In the last formula, we used that the product of the two Gauss sums simplifies to a Kronecker symbol; see equation [\(12\)](#page-28-0) or [Remark 4.9.](#page-16-2)

Here, $\varepsilon \in {\pm 1}$ and β is a square root of $\beta^2 = 1/\alpha^2 = \varepsilon \left(\frac{2}{|\Gamma|}\right) e(\text{sign}(\Gamma, Q)/8)$. The choice $\beta = \varepsilon/\alpha$ results in positive quantum dimensions.

Even Indecomposable Components. As another example, for $k \geq 2$ we consider the indecomposable discriminant form with Jordan symbol $(2^k)^{\pm 1}_t$, i.e. the group $\Gamma = \mathbb{Z}_{2^k}$ with the quadratic form $Q(x) = e\left(\frac{tx^2}{2^{k+1}}\right)$, where $0 \leq x < 2^k$ and $t \in \mathbb{Z}_8^\times$ (see [Table 1\)](#page-3-2). The sign in the Jordan symbol is $s(\Gamma, Q) = \left(\frac{t}{2}\right) = (-1)^{(t^2-1)/8} = \pm 1$, and we write $(2^k)_t := (2^k)^{\pm 1}_t$ for short. The signature is $e(\text{sign}(\Gamma,Q)/8) = e(t/8)(\frac{t}{2})^k$.

Recall that the choice of σ from [Example 5.3,](#page-18-1) the choice $q(x) = e\left(\frac{tx^2}{2^{k+2}}\right)$ from [Example 5.7](#page-20-0) and $\delta = 0 \in \Gamma_2$ satisfy the conditions in [Proposition 5.8.](#page-21-0) To be precise, there we only considered the case $t = 1$, while in general we simply raise σ and q to the power of *t*.

Moreover, $\Gamma_2 = \langle 2^{k-1} \rangle \cong \mathbb{Z}_2$ (which we write as $\{0,1\}$ and not as $\{0,2^{k-1}\}$ in the following) and $2\Gamma = \langle 2 \rangle \cong \mathbb{Z}_{2^{k-1}}$ so that $\Gamma/2\Gamma \cong \mathbb{Z}_2$ (also represented by $\{0, 1\}$). The simple objects are then classified as follows:

- (1) Four invertible objects $X_{a,s}$ (of quantum dimension 1) for $a \in \{0,1\}$ and $s \in \{\pm 1\}.$
- (2) $2^{k-1} 1$ simple objects of quantum dimension 2, denoted by $Y_n := Y_{\{n,-n\}}$, for $1 \leq n \leq 2^{k-1} - 1$.
- (3) Four simple objects $Z_{\bar{x},s}$ of quantum dimension $2^{(k-1)/2}$ for $\bar{x} \in \{0,1\}$ and $s \in \{1, -1\}.$

By [Proposition 5.10,](#page-23-0) the Gauss sum $G_0(\Gamma, q^{-1})$ takes the values

$$
G_0(\Gamma, q^{-1}) = e(-\text{sign}(\Gamma, Q)/8) \left(\frac{t}{2}\right) = e(-t/8) \left(\frac{t}{2}\right)^k \left(\frac{t}{2}\right).
$$

On the other hand, it is not difficult to see that

$$
G_{\bar{x}}(\Gamma, Q) = \sqrt{2} e(\text{sign}(\Gamma, Q)/8) \cdot \begin{cases} \delta_{\bar{x},1} & \text{if } k = 2, \\ \delta_{\bar{x},0} & \text{if } k \ge 3. \end{cases}
$$

Hence, we obtain for the product of these Gauss sums

$$
G_0(\Gamma, q^{-1})G_{\bar{x}}(\Gamma, Q) = \sqrt{2}\left(\frac{t}{2}\right) \cdot \begin{cases} \delta_{\bar{x},1} & \text{if } k = 2, \\ \delta_{\bar{x},0} & \text{if } k \ge 3, \end{cases}
$$

which agrees with [\(12\)](#page-28-0) but in addition treats the cases $4_t^{\pm 1}$. Then, the modular data for $(2^k)_t$ with $k \geq 2$ and $t \in \mathbb{Z}_8^{\times}$ are given by the T-matrix with entries

$$
\mathcal{T}_{X_{a,s},X_{a,s}} = e(-ta^2 2^{k-3}) = \begin{cases} (-1)^a & \text{if } k = 2, \\ 1 & \text{if } k \ge 3, \end{cases}
$$

$$
\mathcal{T}_{Y_n,Y_n} = e(-tn^2/2^{k+1}), \quad \mathcal{T}_{Z_{\bar{x},s},Z_{\bar{x},s}} = s\beta^{-1}
$$

and the S -matrix with entries

$$
\mathcal{S}_{X_{a,s},X_{b,t}} = 1, \qquad \mathcal{S}_{X_{a,s},Y_n} = 2(-1)^{an},
$$
\n
$$
\mathcal{S}_{X_{a,s},Z_{\bar{x},r}} = s2^{(k-1)/2} \begin{cases} (-1)^{a(\bar{x}+1)} & \text{if } k = 2, \\ (-1)^{a\bar{x}} & \text{if } k \ge 3, \end{cases} \qquad \mathcal{S}_{Y_n,Z_{\bar{x},r}} = 0,
$$
\n
$$
\mathcal{S}_{Y_m,Y_n} = 4 \cos(t m n \pi / 2^{k-1}),
$$
\n
$$
\mathcal{S}_{Z_{\bar{x},r},Z_{\bar{y},s}} = \varepsilon r s 2^{k/2} \left(\frac{t}{2}\right) \cdot \begin{cases} \delta_{\bar{x}+\bar{y},1} & \text{if } k = 2, \\ \delta_{\bar{x}+\bar{y},0} & \text{if } k \ge 3. \end{cases}
$$

Here, $\varepsilon \in {\pm 1}$ and β is a square root of $\beta^2 = 1/\alpha^2 = \varepsilon/G_0(\Gamma, q^{-1})$. The choice $\beta = \varepsilon/\alpha$ results in positive quantum dimensions.

Example 5.19. We take the discriminant form $\Gamma = (4)_1 = (4)_1^{\text{+1}}$ (for $k = 2$) with the choice $\varepsilon = 1$, some choice of α and $\beta = \varepsilon/\alpha = 1/\alpha$. The Gauss sum is $G_0(\Gamma, q^{-1}) = e(7/8)$. For definiteness, take $\alpha = e(7/16)$ and so $\beta = \varepsilon/\alpha = e(9/16)$, recalling that $\alpha^2 = \varepsilon G_0(\Gamma, q^{-1})$. Then the modular data are given by

$$
\mathcal{T} = \text{diag}\left(\begin{array}{cccc|c} X_{0,1} & X_{0,-1} & X_{1,-1} & X_{1,1} & Z_{0,-1} & Z_{1,-1} & Z_{0,1} & Z_{1,1} & Y_1 \\ \hline 1 & 1 & -1 & -1 & e\left(\frac{15}{16}\right) & e\left(\frac{7}{16}\right) & e\left(\frac{7}{16}\right) & e\left(\frac{7}{16}\right) & e\left(\frac{7}{8}\right) \end{array}\right)
$$

and

$$
\mathcal{S} = \begin{pmatrix}\nX_{0,1} & X_{0,-1} & X_{1,-1} & X_{1,1} & Z_{0,-1} & Z_{1,-1} & Z_{0,1} & Z_{1,1} & Y_1 \\
X_{0,1} & 1 & 1 & 1 & 1 & \sqrt{2} & \sqrt{2} & \sqrt{2} & 2 \\
X_{0,-1} & 1 & 1 & 1 & -\sqrt{2} & -\sqrt{2} & -\sqrt{2} & 2 \\
X_{1,-1} & 1 & 1 & \sqrt{2} & -\sqrt{2} & \sqrt{2} & -\sqrt{2} & -2 \\
X_{1,1} & 1 & -\sqrt{2} & \sqrt{2} & -\sqrt{2} & \sqrt{2} & -2 \\
X_{0,-1} & 0 & 2 & 0 & -2 & 0 \\
Z_{0,1} & 0 & -2 & 0 & 0 & 2 \\
Z_{1,1} & Y_1 & 0 & 0 & 2 & 0\n\end{pmatrix}.
$$

5.4. **Data for Lattices.** We now discuss how the data used to define the braided \mathbb{Z}_2 -crossed tensor category in [Section 5.2](#page-22-0) can be obtained from lattice data. If the even lattice is positive-definite, the braided \mathbb{Z}_2 -crossed tensor category will in this way appear as category of modules of a \mathbb{Z}_2 -orbifold of the corresponding lattice vertex operator algebra (see Theorem 8.1 in [\[GLM24\]](#page-46-1)).

Any discriminant form (Γ, Q) can be realised as dual quotient $\Gamma = L^*/L$ of some even lattice $L = (L, \langle \cdot, \cdot \rangle)$ embedded into its ambient quadratic space (\mathbb{R}^d, \bar{Q}) with $\overline{Q}(v) = e(\langle v, v \rangle/2)$ for $v \in \mathbb{R}^d$ [\[Nik80\]](#page-46-7). We then recall from Section 4.3 of [\[GLM24\]](#page-46-1) that one can realise $Vect^Q_{\Gamma} = \text{Vect}^{(\sigma,\omega)}_{\Gamma}$ concretely as the condensation

$$
\text{Vect}^{\bar{Q}}_{\mathbb{R}^d} = \text{Vect}^{(\bar{\sigma}, \bar{\omega})}_{\mathbb{R}^d} \rightsquigarrow \text{Vect}^{Q}_{\Gamma} = \text{Vect}^{(\sigma, \omega)}_{\Gamma}
$$

of the infinite pointed braided fusion category $\mathrm{Vect}_{\mathbb{R}^d}^{\bar{Q}}$ by an infinite commutative, associative algebra $A = \mathbb{C}_{\epsilon}[L]$ associated with the even lattice $L \subseteq \mathbb{R}^d$.

In particular, in [\[GLM24\]](#page-46-1) we describe how the abelian 3-cocycle $(\bar{\sigma}, \bar{\omega})$ on the ambient quadratic space (\mathbb{R}^d, \bar{Q}) , chosen as, say,

$$
\bar{\sigma}(u, v) = e(\langle u, v \rangle/2), \quad \bar{\omega}(u, v, w) = 1
$$

for $u, v, w \in \mathbb{R}^d$, induces the abelian 3-cocycle (σ, ω) on (Γ, Q) . The latter further depends on a choice of 2-cocycle $\epsilon: L \times L \to \mathbb{C}^{\times}$ whose skew form equals $\epsilon(u, v)\epsilon(v, u)^{-1} = \bar{\sigma}(u, v)$ for all $u, v \in L$, and further a choice of representatives $\hat{a} \in L^*$ for the *L*-cosets $a \in \Gamma$ and the corresponding 2-cocycle $u: \Gamma \times \Gamma \to L$.

In this section, we assume for simplicity the following strong evenness condition for the lattice *L*:

Assumption 5.20. The lattice *L* fulfils one of the following equivalent conditions:

- (1) $\langle u, v \rangle \in 2\mathbb{Z}$ for all $u, v \in L$,
- (2) $L = \sqrt{2K}$ where *K* is an integral lattice,
- $(3) L \subset 2L^*$,
- (4) $\bar{\sigma}(u, v) = e(\langle u, v \rangle/2) = 1$ for all $u, v \in L$,
- (5) The 2-cocycle ϵ on *L* whose skew form is $\bar{\sigma}|_L$ can be chosen to be trivial,
- (6) $\Gamma/2\Gamma \cong \mathbb{Z}_2^{\text{rk}(L)}$.

Proof. All equivalences except the one to item [\(6\)](#page-30-1) are clear. For an integral lattice of rank $d = \text{rk}(L)$ there is a basis $\{\alpha_1, \ldots, \alpha_d\}$ of L^* and integers $m_1, \ldots, m_d \in \mathbb{Z}$ such that $\{m_1\alpha_1,\ldots,m_r\alpha_d\}$ is a basis of *L*. Then, as abelian group $\Gamma=L^*/L\cong$

 $\mathbb{Z}_{m_1} \times \cdots \times \mathbb{Z}_{m_d}$. This implies that $\Gamma/2\Gamma \cong \mathbb{Z}_2^l$ for some $l \leq d$ and moreover that $\Gamma/2\Gamma \cong \mathbb{Z}_2^d$ if and only if all m_i are even if and only if $L \subset 2L^*$. □

The assumption is made precisely so that $\bar{\sigma}(u, v) = e(\langle u, v \rangle/2) = 1$ for $u, v \in L$, instead of taking values in $\{\pm 1\}$, and hence that the 2-cocycle ϵ on *L* becomes trivial. The particular representing abelian 3-cocycle (σ, ω) for Vect^Q_c from [\[GLM24\]](#page-46-1) then simplifies to

$$
\sigma(a, b) = \bar{\sigma}(\hat{a}, \hat{b}) = e(\langle \hat{a}, \hat{b} \rangle/2),
$$

$$
\omega(a, b, c) = \bar{\sigma}(\hat{a}, u(b, c)) = e(\langle \hat{a}, u(b, c) \rangle/2)
$$

for $a, b, c \in \Gamma$ and hence obeys the additional conditions in [Section 5.2:](#page-22-0)

Proposition 5.21. *For a lattice L fulfilling the stronger evenness condition in [Assumption 5.20,](#page-30-2) the representing abelian* 3*-cocycle* (*σ, ω*) *for the discriminant form* Γ = *L* [∗]*/L from Section 4.3 in* [\[GLM24\]](#page-46-1) *satisfies the properties in [Proposition 5.5.](#page-19-0)*

In particular, this means that σ and $\omega(a, \cdot, \cdot)$ for fixed $a \in \Gamma$ are symmetric and $\omega(\cdot, b, c)$ factors through a group homomorphism $\Gamma/2\Gamma \to \mathbb{C}^\times$ for fixed $b, c \in \Gamma$.

By the definition of the dual lattice, $\bar{\sigma}$ restricts to a bimultiplicative pairing $L^* \times L \to {\pm 1}$. Now, if *L* satisfies [Assumption 5.20,](#page-30-2) $\bar{\sigma}(\hat{a}, u) = e((\hat{a}, u)/2)$ for $u \in L$ does not depend on the choice of coset representative \hat{a} and thus factors through a pairing $\Gamma \times L \rightarrow {\pm 1}$. Because it only takes values in ${\pm 1}$, this further factors through a pairing

$$
p \colon \Gamma / 2\Gamma \times L / 2L \to \{\pm 1\},\
$$

which we can show to be a perfect pairing. This pairing *p* allows us to identify $\Gamma/2\Gamma \cong \text{Hom}(L/2L, \{\pm 1\}).$

This also recovers the interpretation [\(6\)](#page-30-1) of the stronger evenness condition in [Assumption 5.20:](#page-30-2) the 2-torsion of Γ is as large as possible, namely $\Gamma/2\Gamma \cong \mathbb{Z}_2^{\text{rk}(L)}$, noting that for a general even lattice $\Gamma/2\Gamma \cong \mathbb{Z}_2^l$ with $l \leq \text{rk}(L)$.

We now fix a class $\delta \in \Gamma/2\Gamma$ and a function $q: \Gamma \to \mathbb{C}^\times$ with the properties in [Proposition 5.8](#page-21-0) stated in [Section 5.2.](#page-22-0)

To this end, for an even lattice L, we consider the function $v \mapsto e(\langle v, v \rangle/4)$ taking values in $\{\pm 1\}$, which is a certain choice of square root of the natural (and trivial) quadratic form $e(\langle v, v \rangle/2) = 1$ on *L*. This descends to a function

$$
\delta \colon L/2L \to \{\pm 1\}, \quad \delta(v + 2L) \coloneqq e(\langle v, v \rangle/4).
$$

Under the additional evenness condition in [Assumption 5.20,](#page-30-2) i.e. if $\langle u, v \rangle \in 2\mathbb{Z}$ for $u, v \in L$, this function is a group homomorphism $\delta \in \text{Hom}(L/2L, \{\pm 1\})$. Via the pairing *p*, we may identify this δ with a class $\delta \in \Gamma/2\Gamma$, and we note that any representative of δ in Γ is in $\Gamma_2 = \{a \in \Gamma \mid 2a = 1\}$ (cf. [Proposition 5.8\)](#page-21-0).

On the other hand, we can use the choice of representatives for $\Gamma = L^*/L$ to define a function

$$
q \colon \Gamma \to \mathbb{C}^{\times}, \quad q(a) \coloneqq e(\langle \hat{a}, \hat{a} \rangle / 4)
$$

satisfying $q(a)^2 = \sigma(a, a)$ for $a \in \Gamma$. Under the additional evenness condition in [Assumption 5.20](#page-30-2) it satisfies

(13)
$$
q(a+b)q(a)^{-1}q(b)^{-1} = \sigma(a,b)\omega(a+b,a,b)^{-1}\delta(u(a,b))
$$

for all $a, b \in \Gamma$. Identifying δ with its corresponding element in $\Gamma/2\Gamma$ via the pairing p, we may replace $\delta(u(a, b))$ by $\bar{\sigma}(\delta, u(a, b)) = \omega(\delta, a, b)$ so that we recover the conditions in [Proposition 5.8.](#page-21-0) Thus, we proved:

Proposition 5.22. *Given a lattice L fulfilling the stronger evenness condition in [Assumption 5.20](#page-30-2) and given the representing abelian* 3*-cocycle for the discriminant* $f \text{ or } \Gamma = L^* / L$ *from Section 4.3 in* [\[GLM24\]](#page-46-1)*, the above choices of q and* δ *satisfy the conditions in [Proposition 5.8.](#page-21-0)*

Overall, we have shown how to produce the data used to define the braided \mathbb{Z}_2 -crossed tensor category in [Section 5.2](#page-22-0) directly from an even lattice *L* with $\Gamma = L^*/L$.

We finally comment on the partial Gauss sum in [Proposition 5.10](#page-23-0) with the choices made for $\Gamma = L^*/L$ in this section:

Proposition 5.23. *In the situation of [Proposition 5.22,](#page-32-0) the partial Gauss sum Gδ*(Γ*, q*−¹) *in [Proposition 5.10](#page-23-0) evaluates to*

$$
G_{\delta}(\Gamma, q^{-1}) = |2\Gamma|^{-1/2} \sum_{a \in \delta} q(a)^{-1} = e(-\operatorname{sign}(L)/8) = e(-\operatorname{sign}(\Gamma)/8).
$$

Note that here, in contrast to [Proposition 5.10,](#page-23-0) the value of the partial Gauss sum is also well-defined for the indecomposable 2-adic Jordan components $2_t^{\pm 1}$ because we are making a specific choice of q . For instance, if $L =$ components z_t because
 $\sqrt{2}K$ where $K = \mathbb{Z}$ is the (odd) standard lattice, then $\Gamma = L^*/L \cong 2_1^{-1} \cong 2_5^{-1}$ and the Gauss sum takes the value $G_{\delta}(\Gamma, q^{-1}) = e(-\text{sign}(L)/8) = e(7/8)$, and not $e(3/8)$, as would have been possible as well. We discuss this example further:

Example 5.24. We consider the Gauss sum $G_{\delta}(\Gamma, q^{-1}), \Gamma = L^*/L$, for the even lattice $L = \sqrt{n} \mathbb{Z} \cong \sqrt{n/2} A_1$ where $n \in 2\mathbb{Z}_{>0}$. When $n = q$ is a power of 2, this is already discussed in [Remark 5.11.](#page-24-1) This lattice is of the form $L = \sqrt{2K}$ for the integral lattice $K = \sqrt{n/2}\mathbb{Z}$, i.e. *L* satisfies [Assumption 5.20.](#page-30-2) The dual lattice of *L* is $L^* = (1/\sqrt{n})\mathbb{Z}$ so that $\Gamma \cong \mathbb{Z}_n$, and the signature of *L* is $sign(L) = 1 \pmod{8}$.

Hence, with the choices made for (q, δ) in this section, [Proposition 5.23](#page-32-1) asserts that the Gauss sum evaluates to $G_{\delta}(\Gamma, q^{-1}) = e(7/8)$. Note that if 4 | *n*, then already K is even and the Gauss sum will not depend on these choices (cf. the discussion after [Proposition 5.10\)](#page-23-0).

In the following, we compute the Gauss sum for Γ explicitly, and verify [Propo](#page-32-1)in the ionowing, we compute the Gauss sum for 1 explicitly, and verify Fropo[sition 5.23](#page-32-1) for this particular case. We choose the coset representatives $\hat{a} = k/\sqrt{n}$ with $k = 0, \ldots, n - 1$ for $\Gamma = L^*/L$. Then, the function $q: \Gamma \to \mathbb{C}^\times$ is

$$
q(k/\sqrt{n}+L) = \frac{e(k^2/(4n))}{}
$$

for $k = 0, \ldots, n - 1$. Further, $L/2L = (\sqrt{n}\mathbb{Z})/(2\sqrt{n}\mathbb{Z}) \cong \mathbb{Z}_2$ and $\delta: L/2L \to {\pm 1}$ is given by √

$$
\delta(\sqrt{n} + 2L) = e(1/(4n))
$$

evaluated at the nontrivial element in $L/2L \cong \mathbb{Z}_2$. Hence, δ is the trivial character if $n = 0 \pmod{4}$ and the nontrivial character if $n = 2 \pmod{4}$. That is, viewing $\delta \in \Gamma/2\Gamma \cong (\sqrt{n}\mathbb{Z})/(2\sqrt{n}\mathbb{Z})$, we obtain $\delta = 2\sqrt{n}\mathbb{Z}$ when $n = 0 \pmod{4}$ and $\delta = \sqrt{n}(1 + 2\mathbb{Z})$ when $n = 2 \pmod{4}$. Hence, the Gauss sum is

$$
G_{\delta}(\Gamma, q^{-1}) = \sqrt{2/n} \sum_{\substack{k=1 \ k \text{ even}}}^{n-1} e(-k^2/(4n)),
$$

$$
G_{\delta}(\Gamma, q^{-1}) = \sqrt{2/n} \sum_{\substack{k=1 \ k \text{ odd}}}^{n-1} e(-k^2/(4n))
$$

if $n = 0 \pmod{4}$ and $n = 2 \pmod{4}$, respectively. Finally, an explicit computation shows that $G_{\delta}(\Gamma, q^{-1}) = e(7/8)$ in both cases, as asserted by [Proposition 5.23.](#page-32-1)

6. Proof of Main Theorem

Proof of [Theorem 5.12.](#page-24-0) We prove the theorem by explicitly checking all coherence conditions in $\mathcal{C} = \mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$. Recall that $G = \langle q \rangle \cong \mathbb{Z}_2$.

We shall use without mentioning that $\sigma(\cdot, \cdot)$ and $\omega(a, \cdot, \cdot)$ for any fixed $a \in \Gamma$ are symmetric and that $\omega(\cdot, b, c)$ is multiplicative in the first argument and takes values in $\{\pm 1\}$. We also remark that for the subsequent calculations it is helpful to initially ignore terms of the form $\omega(a, b, -b)$, which appear in several steps of the computation, and to only cancel them in the very end.

Tensor Structure: We check that the pentagon identities hold in $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon)$, starting with the ones not involving any $X^{\tilde{x}}$, i.e. the ones in $C_1 = \text{Vect}_{\Gamma}^Q$.

$$
\begin{array}{ccc}\n& \omega(a,b+c,d) & & \\
& (\mathbb{C}_a \otimes (\mathbb{C}_b \otimes \mathbb{C}_c)) \otimes \mathbb{C}_d & \longrightarrow \mathbb{C}_a \otimes ((\mathbb{C}_b \otimes \mathbb{C}_c) \otimes \mathbb{C}_d)) \\
& \omega(a,b,c) & \wedge & \\
& & \omega(b,c,d) & \\
& & \omega(a+b,c,d) & \\
& & & \omega(a+b,c,d) & \\
& & & (\mathbb{C}_a \otimes \mathbb{C}_b) \otimes (\mathbb{C}_c \otimes \mathbb{C}_d) & \omega(a,b,c+d)\n\end{array}
$$

Of course, this identity is satisfied precisely because ω is a 3-cocycle on Γ, which was used in the construction of the tensor category $\text{Vect}_{\Gamma}^{\omega} = C_1$ in [Example 3.1.](#page-4-1)

We now come to the pentagon relations involving a single $X^{\bar{x}}$. First, we consider

$$
\begin{array}{ccc}\n&\omega(\bar{x}+\delta,a+b,c)\\ &\omega(\bar{x}+\delta,a+b,c)\\ \n&\omega(\bar{x}+\delta,a,b)\n\end{array}
$$
\n
$$
(\mathsf{X}^{\bar{x}}\otimes(\mathbb{C}_a\otimes\mathbb{C}_b))\otimes\mathbb{C}_c \longrightarrow \mathsf{X}^{\bar{x}}\otimes((\mathbb{C}_a\otimes\mathbb{C}_b)\otimes\mathbb{C}_c))
$$
\n
$$
\begin{array}{ccc}\n&\omega(a,b,c)\\ \n&\omega(a,b,c)\\ \n&\omega(\bar{x}+\delta,a,b)\n\end{array}
$$
\n
$$
\begin{array}{ccc}\n&\omega(\bar{x}+\delta,a,b+c)\\ \n&\omega(\bar{x}+\delta,a,b+c)\\ \n&\omega(\bar{x}+\delta,a,b+c)\n\end{array}
$$

which holds because $\omega(a, b, c)$ cancels and ω with fixed first argument is a 2-cocycle. Furthermore,

The first identity holds because the difference between $\sigma(a, b+c)$ and $\sigma(a, b)\sigma(a, c)$, which is the coboundary of $\sigma(a, \cdot)$, is equal to $\omega(a, \cdot, \cdot)$. The second identity holds because σ is symmetric, and so the same formula holds for the coboundary of $\sigma(\cdot, c)$. Finally, there is the pentagon identity

which holds because $\omega(a+b+c,\cdot,\cdot)$ and $\omega(\bar{x},\cdot,\cdot)$ are 2-cocycles.

We then come to the pentagon relations involving $X^{\bar{x}}$ and $X^{\bar{y}}$.

$$

The innermost product $X^{\bar{x}} \otimes X^{\bar{y}}$ produces, after multiplication with further X, a basis vector in the multiplicity space denoted by v_t , while the outermost product produces the resulting object \mathbb{C}_s with basis vector denoted by e_s . These bases in the five products in the above diagram are, from left to right, $v_t \otimes e_{s+t}$, $v_r \otimes e_{s+t}$, $v_r \otimes e_{s+t}$, $v_l \otimes e_{s+t}$ and for the bottom node $v_t \otimes e_s$. Again, the conditions $\bar{t} = \bar{x} + \bar{y} + \delta$, $\bar{r} = \bar{y} + \bar{z} + \delta$ and $\bar{s} = \bar{l} = \bar{z} + \bar{w} + \delta$ hold. Again, *σ*(*r, s* + *t*) can be expressed as *σ*(*r, t*), which cancels, times *σ*(*r, s*) times $ω(r, s, t)$. Then, after substituting \bar{r} and \bar{t} , all ω cancel, as does the sign ϵ . However, the factor $|2\Gamma|^{-1/2}|2\Gamma|^{-1/2} = |2\Gamma|^{-1}$ becomes important. The last pentagon identity then follows from the following slightly unusual character sum:

Lemma 6.1. *For* $s, l \in \Gamma$ *with* $\bar{s} = \bar{l} \in \Gamma/2\Gamma$ *and for a coset* $\bar{r} \in \Gamma/2\Gamma$,

Now, the assumption $\overline{s} = \overline{l}$ means that $s - l \in 2\Gamma$, and so $\sigma(\cdot, l - s) = B_O(\cdot, (l - s)/2)$ is a character on Γ. Moreover. *ω*(*r, s, l* − *s*) is always a character as a function of *r*, and on any fixed 2Γ-coset it is a constant $\omega(\bar{r}, s, l - s)$. Hence, the character sum is

Hence, the sum over the character $\sigma(\cdot, l - s) = B_Q(\cdot, (l - s)/2)$ is zero unless $2 \cdot (l - s)/2 = 0$ in Γ, meaning that $l = s$. In this case, the factor $\omega(\bar{r}, s, l - s)\sigma(r_0, l - s)$ is also 1. □

G-Action: We now discuss the \mathbb{Z}_2 -action on $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon)$: the compatibility between the trivial composition structure and the tensor structure amount to the fact that all tensor structures are scalars ± 1 and hence square to one.

To prove the coherences of the tensor structures, which have to compensate for the associators not being \mathbb{Z}_2 -invariant, we collect some formulae on σ and ω with negative entries: by definition,

\begin{array}{ccc} \omega(t+\bar{z},t,-t) & \omega(\bar{x},t,-t) \\ g_{*}((\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \otimes \mathsf{X}^{\bar{z}}) & \longrightarrow & g_{*}(\mathsf{X}^{\bar{x}} \otimes \mathsf{X}^{\bar{y}}) \otimes g_{*}\mathsf{X}^{\bar{z}} & \longrightarrow & (g_{*}\mathsf{X}^{\bar{x}} \otimes g_{*}\mathsf{X}^{\bar{y}}) \otimes g_{*}\mathsf{X}^{\bar{z}} \\ & \downarrow & & \varepsilon \vert 2\Gamma \vert^{-1/2} \sigma(t,r)^{-1} & \varepsilon \vert 2\Gamma \vert^{-1/2} \sigma(-t,-r)^{-1} \bigdownarrow \\ g_{*}(\mathsf{X}^{\bar{x}} \otimes (\mathsf{X}^{\bar{y}} \otimes \mathsf{X}^{\bar{z}})) & \longrightarrow & g_{*}\mathsf{X}^{\bar{x}} \otimes g_{*}(\mathsf{X}^{\bar{y}} \otimes \mathsf{X}^{\bar{z}}) & \longrightarrow & g_{*}\mathsf{X}^{\bar{x}} \otimes (g_{*}\mathsf{X}^{\bar{y}} \otimes g_{*}\mathsf{X}^{\bar{z}}) \\ & \omega(\bar{x}+\delta,r,-r) & \omega(\bar{y},r,-r) & \end{array}
$$

where *t* and *r* satisfy, as for the associator, the conditions $\bar{t} = \bar{x} + \bar{y} + \delta$ and $\bar{r} = \bar{y} + \bar{z} + \delta$. This lets us rewrite the expressions

 $\omega(\bar{z} + \bar{x}, t, -t) = \omega(t + r, t, -t), \quad \omega(\bar{x} + \delta + \bar{y}, r, -r) = \omega(t, r, -r).$

Then, the identity follows from the formulae [\(14\)](#page-37-2) and [\(15\)](#page-37-3) for $\sigma(r, s)\sigma(-r, -s)^{-1}$. This concludes the proof of the tensor structure. We remark that we did not use any information on ε or |2Γ|.

G-Braiding: For the \mathbb{Z}_2 -braiding on $\mathcal{GLM}(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$ we verify the hexagon identities.

The hexagon identity for \mathbb{C}_a , \mathbb{C}_b , \mathbb{C}_c and \mathbb{C}_d is known to hold in $\mathcal{C}_1 = \text{Vect}_{\Gamma}^{(\sigma,\omega)}$, corresponding to the abelian 3-cocycle (σ, ω) . It is satisfied as $\omega(b, c, a) = \omega(b, a, c)$ and $\omega(a, \cdot, \cdot)$ is the coboundary of $\sigma(a, \cdot)$, and similarly for the inverse hexagon identity:

We come to the hexagon identities involving one $X^{\bar{x}}$, starting with

Take note of the appearance of a tensor structure in the top arrow. This hexagon identity can be rewritten using formula [\(15\)](#page-37-3) for $\sigma(-a, b)$ and formula [\(16\)](#page-37-1) for $\omega(\bar{x} + a + b, a + b, -a - b)$. Then all terms $\omega(\bar{x}, \cdot, \cdot)$ cancel and all terms $\omega(a + b, \cdot, \cdot)$ cancel except for a new $\omega(a + b, a, b)$. Then the identity is precisely the defining property of q , $q(a+b)q(a)^{-1}q(b)^{-1} = \sigma(a,b)\,\omega(a+b,a,b)\omega(\delta,a,b)$ for all $a,b \in \Gamma$. Furthermore, consider

Both identities hold directly. If the braiding were not given, these identities would show that the braiding of $\mathbb{C}_a \otimes X^{\bar{x}}$ coincides with the braiding of $\mathbb{C}_a \otimes X^{\bar{x}+b}$, so that it is independent of \bar{x} .

The inverse hexagon identities in these cases are:

In these two identities, most terms cancel, and we use formula [\(15\)](#page-37-3) to express $\sigma(-b, a)$ and $\sigma(a, -b)$ in terms of $\sigma(a, b)$ and $\omega(a, b, -b)$, respectively, which cancels with the corresponding term on the top arrow. If the braiding were not given, these identities would show that the braiding of $X^{\bar{x}} \otimes \mathbb{C}_b$ coincides with the braiding of $X^{\bar{x}+a} \otimes \mathbb{C}_b$ up to a factor $\omega(a, b, -b)$, so it demands the \bar{x} -dependency of $\omega(\bar{x}, b, -b)$. Next, we consider

This hexagon identity again amounts to the defining property of *q*. If the braiding were not given, one might wish to treat this identity (involving the easier braiding $\mathbb{C}_a \otimes X^{\bar{x}}$ and no tensor structure) before the analogous hexagon identity $X^{\bar{x}} \otimes \mathbb{C}_a \otimes \mathbb{C}_b$ above (involving the braiding $\mathsf{X}^{\bar{x}} \otimes \mathbb{C}_a$).

We come to the hexagon identities involving $X^{\bar{x}}$ and $X^{\bar{y}}$. First, consider

We apply formula [\(15\)](#page-37-3) to $\sigma(-a, t + a)$ and the condition $\bar{t} = \bar{x} + \bar{y} + \bar{t}$ to $\omega(\cdot, a, -a)$ and $\omega(\cdot, t, a)$. The parameter α simply cancels at this point. Then the hexagon identity amounts to the other defining condition of $q, q(a)^2 = \sigma(a, a)$ for $a \in \Gamma$, and again the additivity condition on *q*. If the braiding were not given, this identity *would show that the braiding of* $X^{\bar{x}} ⊗ X^{\bar{y}}$ and that of $X^{\bar{x}} ⊗ X^{\bar{y}+a}$ differ by the braiding of $X^{\bar{x}} \otimes \mathbb{C}_a$ by this additivity condition. Next, we look at

where as initial basis vector we choose e_t so that the final basis vector is $e_{-a} \otimes e_{a+t}$. with $\bar{t} = (\bar{x} + \bar{a}) + \bar{y} + \delta$. Then we collect and rewrite $\omega(\bar{x} + \bar{y}, -a, a + t)\omega(\bar{x} + \bar{y}, a, -a)$

using formula [\(17\)](#page-37-4) to $\omega(\bar{x} + \bar{y}, a, t)$, which is equal to $\omega(t + a + \delta, a, t)$. Then the hexagon identity is again the defining additivity relation of *q*. Moreover,

where as initial basis vector we choose e_{a+t} . This hexagon identity holds again because of the defining relation $q(a)^2 = \sigma(a, a)$.

The inverse hexagon identities in these cases are as follows:

Here, as initial basis vector we choose e_{t+a} with $\bar{t} = \bar{x} + \bar{y} + \delta$ and consequently write $\omega(\bar{y} + a, a, -a)\omega(\bar{x} - a, a, -a) = \omega(t, a, -a)\omega(\delta, a, -a)$. We rewrite, using the coboundary property in [Proposition 5.5](#page-19-0) and equation [\(15\)](#page-37-3),

$$
\sigma(-a, t + a) = \sigma(-a, t)\sigma(-a, a)\omega(-a, t, a)
$$

= $\sigma(a, t)\omega(t, a, -a)\sigma(-a, a)\omega(-a, t, a).$

Then the hexagon identity reduces to the following special case of the additivity property

$$
q(a)q(-a) = \sigma(a, -a)^{-1}\omega(\delta, a, -a).
$$

For later use, using $\sigma(a, -a) = \sigma(a, a)^{-1} \omega(a, a, -a)$ and $\sigma(a, a) = q(a)^2$, we show further that

(18)
$$
q(-a) = q(a)\omega(a+\delta, a, -a).
$$

We further consider the identities

As initial basis vector in these two diagrams we choose e_{t+a} and $e_a \otimes e_t$, respectively, in both cases with $\bar{t}=\bar{x}+\bar{y}+\delta$. In both cases, the hexagon identity follows from the coboundary property for $\sigma(a, a+t)$ and $q(a)^2 = \sigma(a, a)$ and the additivity property for *q*.

We finally come to the hexagon identities and inverse hexagon identities involving $X^{\bar{x}}$, $X^{\bar{y}}$ and $X^{\bar{z}}$. These are the only ones where the associator of $X \otimes X \otimes X$ appears, as well as the tensor structure on $X \otimes X$. This is also the only identity where the value of α is relevant. We start with the inverse hexagon identity, which is simpler in some regards:

Here, $\bar{r} = \bar{y} + \bar{z} + \delta$ and $\bar{t} = \bar{x} + \bar{y} + \delta$ and $\bar{s} = \bar{z} + \bar{x} + \delta$, and we note that the inverse of the matrix $(|2\Gamma|^{-1/2} \sigma(t,r)^{-1})_{t,r}$ is $(|2\Gamma|^{-1/2} \sigma(r,t))_{t,r}$, where *r*, *t* run over arbitrary fixed 2Γ-cosets, by the character sum in [Lemma 6.1.](#page-37-0) We spell out the identity in question, using as summation condition $\bar{x} + \bar{y} + \delta = \bar{r} + \bar{s} + \delta$:

$$
\alpha q(r)\sigma(r,s)\alpha q(s) = \varepsilon |2\Gamma|^{-1/2} \sum_{t \in \bar{r} + \bar{s} + \delta} \sigma(r,t) q(t)^{-1} \sigma(t,s).
$$

This is a somewhat modified Gauss sum. We reduce it to a formula that only depends on $r + s$: we use $q(r)\sigma(r, s)q(s) = q(r + s)\omega(r + s, r, s)\omega(\delta, r, s)$ on the lefthand side, and on the right-hand side $\sigma(t, r)\sigma(t, s) = \sigma(t, r + s)\omega(t, r + s)$. Then, by the summation condition on t , the terms involving ω on both sides cancel and the identity in question becomes

$$
\alpha^2 q(r+s) = \varepsilon |2\Gamma|^{-1/2} \sum_{t \in \bar{r} + \bar{s} + \delta} \sigma(t, r+s) q(t)^{-1}.
$$

We may reduce to the case $r+s=0$. Indeed, let $b=r+s$ and substitute $t=a+r+s$ with $a \in \delta$. Then, using again the additivity property of *q* gives

$$
\alpha^2 q(b) = \varepsilon |2\Gamma|^{-1/2} \sum_{a \in \delta} \sigma(a+b,b) \sigma(a,b)^{-1} q(a)^{-1} q(b)^{-1} \omega(a+b+\delta, a, b).
$$

Furthermore, using the coboundary property for $\sigma(\cdot, b)$, the property $\sigma(b, b) = q(b)^2$ and $\omega(a + \delta, \cdot, \cdot) = 0$ by the summation condition reduces the identity in question to the following identity independent of *r* and *s*:

$$
\alpha^2 = \varepsilon |2\Gamma|^{-1/2} \sum_{a \in \delta} q(a)^{-1}.
$$

We defined α just so that this holds, and hence the above inverse hexagon identity holds. Next, we consider the hexagon identity

(X *^x*¯⊗X *y*¯)⊗X *z*¯ X *^x*¯⊗(X *^y*¯⊗X *z*¯) (X *^y*¯⊗X *z*¯)⊗X *x*¯ X *^y*¯⊗(X *^z*¯⊗X *x*¯) (X *^y*¯⊗X *x*¯)⊗X *^z*¯ X *^y*¯⊗(X *^x*¯⊗X *z*¯) *ε*|2Γ| [−]1*/*2*σ*(*t,r*) −1 *q*(*r*) [−]1*ω*(¯*x*+*r,r,*−*r*) *ω*(¯*y,r,*−*r*) *ε*|2Γ| [−]1*/*2*σ*(−*r,s*) −1 *αq*(*t*) *ε*|2Γ| [−]1*/*2*σ*(*t,s*) −1 *αq*(*s*)

where $\bar{t} = \bar{x} + \bar{y} + \delta$ and $\bar{r} = \bar{y} + \bar{z} + \delta$ and $\bar{s} = \bar{z} + \bar{x} + \delta$. We spell out the identity in question and simplify the right-hand side by using formula [\(15\)](#page-37-3) for $\sigma(-r, s)$ and cancelling $\omega(\bar{x} + \bar{y} + r + s, r, -r)$ since $\bar{x} + \bar{y} + \bar{r} + \bar{s} = 0$ in Γ/2Γ:

$$
\alpha q(t)\sigma(t,s)^{-1}\alpha q(s)
$$

= $\varepsilon |2\Gamma|^{-1/2} \sum_{r \in \bar{y} + \bar{z} + \delta} \sigma(t,r)^{-1} \cdot \sigma(-r,s) \cdot q(r)^{-1} \omega(\bar{x} + \bar{y} + r, r, -r)$
= $\varepsilon |2\Gamma|^{-1/2} \sum_{r \in \bar{s} + \bar{t} + \delta} \sigma(t,r)^{-1} \sigma(r,s) q(r)^{-1}.$

If we substitute $t = -l$ and use formula [\(18\)](#page-42-0) for $q(-l)$ and formula [\(15\)](#page-37-3) for $\sigma(-l, s)$ and $\sigma(-l, r)$, we collect an additional factor $\omega(l+\delta, l, -l)\omega(r, l, -l)\omega(s, l, -l)$, which again cancels due to the condition $\bar{t} + \bar{r} + \bar{s} + \delta = 0$ in Γ/2Γ. Then the hexagon identity reduces again to the modified Gauss sum we have proved for the inverse hexagon identity above:

$$
\alpha q(l)\sigma(l,s)\alpha q(s) = \varepsilon |2\Gamma|^{-1/2} \sum_{r \in \bar{s}+\bar{t}+\delta} \sigma(l,r)\sigma(r,s)q(r)^{-1}.
$$

This concludes the proof of the hexagon identities.

G-Ribbon Structure: We shall verify that the following defines a ribbon twist on $GLM(\Gamma, \sigma, \omega, \delta, \varepsilon | q, \alpha, \beta)$:

$$
\theta_{\mathbb{C}_a} = \sigma(a, a), \quad \theta_{\mathsf{X}^{\bar{x}}} = \beta
$$

for $a \in \Gamma$ and $\bar{x} \in \Gamma/2\Gamma$, with a choice of $\beta = \pm \alpha^{-1}$ and $\alpha^2 = \varepsilon |\Gamma|^{-1/2} \sum_{a \in \delta} q(a)^{-1}$ as above. More precisely, we check that the defining condition in [Section 3.4](#page-8-1) holds:

$$
\theta_{\mathbb{C}_{a+b}} \theta_{\mathbb{C}_{a}}^{-1} \theta_{\mathbb{C}_{b}}^{-1} = \sigma(b, a)\sigma(a, b).
$$

This is a standard calculation for abelian 3-cocycles. Indeed, in our case the coboundary formula in [Proposition 5.5](#page-19-0) applied on both sides of $\sigma(a+b, a+b)$ gives $\sigma(a, a)\sigma(a, b)\sigma(b, a)\sigma(b, b)$, and the further terms $\omega(a+b, a, b)\omega(a, a, b)\omega(b, a, b) = 1$. Then, consider

$$
\theta_{\mathsf{X}^{a+\bar{x}}} \theta_{\mathbb{C}_a}^{-1} \theta_{\mathsf{X}^{\bar{x}}}^{-1} = \omega(a+\bar{x}, a, -a) \cdot \omega(\bar{x}+a, a, -a) q(a)^{-1} \cdot q(a)^{-1}.
$$

This holds because on the left-hand side the twists on $X^{\bar{x}}$ and $X^{a+\bar{x}}$ are equal and cancel and because on the right-hand side the tensor structure and the additional *ω* in the braiding cancel, leaving $q(a)^{-2} = \sigma(a, a)^{-1}$. Then, we look at

$$
\theta_{\mathsf{X}^{\bar{x}+a}} \theta_{\mathsf{X}^{\bar{x}}}^{-1} \theta_{\mathbb{C}_a}^{-1} = q(a)^{-1} \omega(a+\bar{x}, a, -a) \cdot \omega(\bar{x}+a, a, -a) q(a)^{-1}.
$$

This holds analogously to the previous case. Finally, we verify

$$
\theta_{\mathbb{C}_t} \theta_{\mathsf{X}^{\bar{x}}}^{-1} \theta_{\mathsf{X}^{\bar{y}}}^{-1} = \alpha q(t) \cdot \alpha q(t)
$$

for any $t \in \bar{x} + \bar{y} + \delta$. Indeed, this holds because the α^2 on both sides cancel and $q(t)^2 = \sigma(t, t).$

This concludes the proof of the \mathbb{Z}_2 -ribbon structure on $\mathcal{GLM}(\Gamma,\sigma,\omega,\delta,\varepsilon | q,\alpha,\beta)$.

We finally verify the assertion that these choices of ribbon structure together with the rigid structure have positive quantum dimensions if and only if $\alpha\beta = \varepsilon$, which is completely analogous to [Section 4.](#page-13-0) For the objects \mathbb{C}_a the quantum dimension is 1. For the objects $X^{\bar{x}}$ we compute that, with the rigid structure and ribbon structure given above, the quantum dimension of $X^{\bar{x}}$ is

$$
\dim(\mathsf{X}^{\bar{x}}) = \operatorname{ev}_{\mathsf{X}^{\bar{x}}} \circ c_{\mathsf{X}^{\bar{x}}, \mathsf{X}^{-\bar{x}-\delta}} \circ (\theta_{\mathsf{X}^{\bar{x}}} \otimes \operatorname{id}_{\mathsf{X}^{-\bar{x}-\delta}}) \circ \operatorname{coev}_{\mathsf{X}^{\bar{x}}}
$$
\n
$$
= \varepsilon |\Gamma|^{1/2} \cdot (\alpha \, q(0)) \beta \operatorname{id}_{\mathsf{X}^{\bar{x}}}
$$
\n
$$
= \varepsilon (\alpha \beta) |\Gamma|^{1/2} \operatorname{id}_{\mathsf{X}^{\bar{x}}},
$$

independently of \bar{x} . This concludes the proof of [Theorem 5.12.](#page-24-0) □
