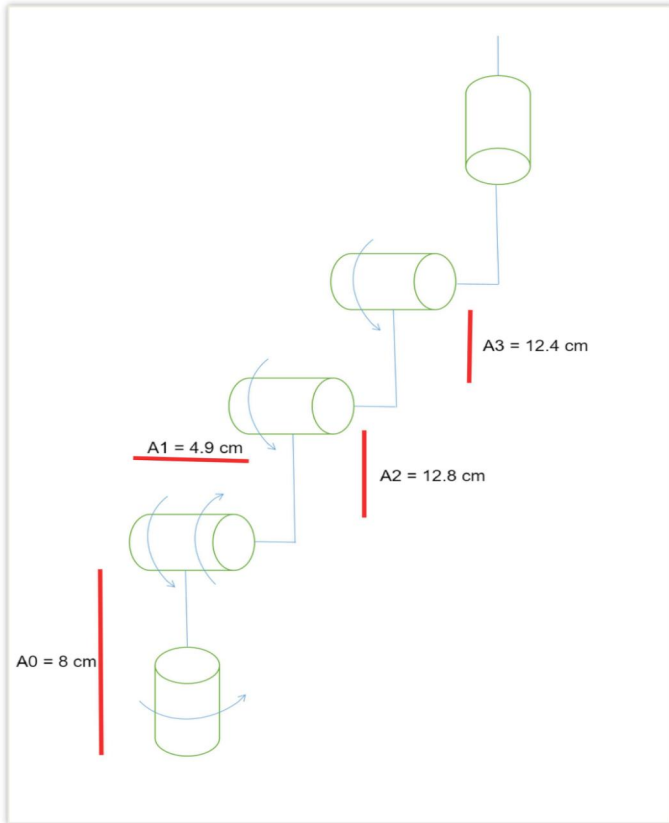


Fig:1 Kinematic Diagram
