UCB ALGORITHMS FOR MULTI-ARMED BANDITS: PRECISE REGRET AND ADAPTIVE INFERENCE

Abstract. Upper Confidence Bound (UCB) algorithms are a widely-used class of sequential algorithms for the *K*-armed bandit problem. Despite extensive research over the past decades aimed at understanding their asymptotic and (near) minimax optimality properties, a precise understanding of their regret behavior remains elusive. This gap has not only hindered the evaluation of their actual algorithmic efficiency, but also limited further developments in statistical inference in sequential data collection.

This paper bridges these two fundamental aspects—precise regret analysis and adaptive statistical inference—through a deterministic characterization of the number of arm pulls for an UCB index algorithm [\[Lai87,](#page-35-0) [Agr95,](#page-33-0) [ACBF02\]](#page-33-1). Our resulting precise regret formula not only accurately captures the actual behavior of the UCB algorithm for finite time horizons and individual problem instances, but also provides significant new insights into the regimes in which the existing theoretical frameworks remain informative. In particular, we show that the classical Lai-Robbins regret formula is exact if and only if the sub-optimality gaps exceed the order $\sigma \sqrt{K \log T/T}$. We also show that its maximal regret de-
vistes from the minimax regret by a logarithmic factor, and therefore settling its viates from the minimax regret by a logarithmic factor, and therefore settling its strict minimax optimality in the negative.

The deterministic characterization of the number of arm pulls for the UCB algorithm also has major implications in adaptive statistical inference. Building on the seminal work of [\[LW82\]](#page-35-1), we show that the UCB algorithm satisfies certain 'stability' properties that lead to quantitative central limit theorems in two settings: for the empirical means of unknown rewards in the bandit setting, and for a class of Ridge estimators when the arm means exhibit a structured relationship through covariates. These results have an important practical implication: conventional confidence sets designed for i.i.d. data remain valid even when data are collected sequentially.

Our technical approach relies on an application of a new comparison principle between the UCB algorithm and its noiseless, continuous-time minimax counterpart. We expect this new principle to be broadly applicable for general UCB index algorithms.

1. INTRODUCTION

1.1. Overview and the motivating questions. Consider the standard *K*-armed bandit problem [\[Tho33,](#page-36-0) [Rob52\]](#page-35-2): at each round $t \in [T]$, the player chooses an arm $A_t \in [K]$ based on the past rewards R_1, \ldots, R_{t-1} , and receives a new reward

$$
R_t \equiv \mu_{A_t} + \sigma \cdot \xi_t, \qquad (1.1)
$$

where μ_a is the mean reward for the arm $a \in [K]$, and $\{\xi_t\}_{t \in [T]}$ are i.i.d. $\mathcal{N}(0, 1)$ noises. The optimal expected reward is denoted by $\mu_* = \max_{b \in [K]} \mu_b$, and $\Delta_a =$ $\mu_* - \mu_a \geq 0$ represents the sub-optimality gap for arm $a \in [K]$.

The multi-armed bandit problem is among the most basic form for modern sequential decision-making problems, and has gained renewed interest due to its natural connections to modern complex reinforcement learning algorithms. For a comprehensive overview of the history of this problem and its wide-ranging applications, readers are referred to recent textbooks [\[BCB12,](#page-34-0) [Sli19,](#page-36-1) [LS20\]](#page-35-3) and the references therein.

The goal for the bandit problem is to design an efficient algorithm $\mathscr A$ that selects the arms $\{A_t\}_{t \in [K]}$ to minimize the *(expected) regret* over the *T* rounds of the game, defined as

$$
\text{Reg}(\mathscr{A}) \equiv \mathbb{E} \sum_{t \in [T]} (\mu_* - R_t) = \mathbb{E} \sum_{t \in [T]} \Delta_{A_t} = \sum_{a: \Delta_a > 0} \Delta_a \mathbb{E} n_{a;T}.
$$
 (1.2)

Here $n_{a;t} \equiv \sum_{s \in [t]} \mathbf{1}_{A_s = a}$ is the number of times arm *a* has been pulled up to round $t \in [T]$.

In this paper, we examine a widely-used class of Upper Confidence Bound (UCB) algorithms through the lens of two fundamental, yet seemingly unrelated, questions:

- (Q1) Can we characterize the *precise regret* of the UCB algorithm for the multiarmed bandit problem [\(1.1\)](#page-1-1)?
- (Q2) Can we perform *adaptive inference* for the mean rewards $\{\mu_a\}_{a \in [K]}$ based on data collected sequentially using the UCB algorithm?

The main goal of this paper is to provide unified, affirmative answers to both (Q1) and (Q2) through a precise characterization of the numbers of arm pulls $\{n_{a,T}\}_{a \in [K]}$. While the connection between the number of arm pulls and the precise regret in (Q1) follows naturally from the very definition [\(1.2\)](#page-1-2), the relevance of this characterization to (Q2) appears less immediate. Interestingly, as we shall demonstrate, a deterministic characterization of the arm pulls is intrinsically linked to a certain '*stability*' property of UCB algorithms, which plays a pivotal role—similar to the role in [\[LW82\]](#page-35-1)—in enabling statistical inference for $\{\mu_a\}_{a \in [K]}$.

1.2. Precise regret. Understanding the behavior of the regret $Reg(\mathscr{A})$ of a given bandit algorithm $\mathscr A$ lies at the heart of evaluating its algorithmic efficacy. To date, there are primarily two distinct but inter-related theoretical paradigms for regrets under which the optimality of a bandit algorithm $\mathscr A$ is evaluated:

 $(R1)$ $\mathscr A$ is *asymptotically optimal*, if it attains the Lai-Robbins lower bound [\[LR85\]](#page-35-4) in the sense that for any non-trivial problem instance Δ ,

$$
\lim_{T \to \infty} \frac{\text{Reg}(\mathscr{A})}{\log T} = \sum_{a: \Delta_a > 0} \frac{2\sigma^2}{\Delta_a}.
$$
 (1.3)

 $(R2)$ $\mathscr A$ is *minimax optimal*, if it achieves the minimax regret [\[ACBFS03\]](#page-33-4) up to a universal constant $C > 0$ in the sense that

$$
\sup_{\Delta \in \mathbb{R}_{\geq 0}^K} \text{Reg}(\mathscr{A}) \leq C \cdot \sigma \sqrt{KT}.
$$
\n(1.4)

The viewpoints under these two paradigms are rather different: while (R1) asserts a precise logarithmic regret in the asymptotic regime $T \rightarrow \infty$ for any fixed bandit problem instance Δ , the minimax approach (R2) pinpoints a substantially larger regret for a worst problem instance that can occur for any finite time horizon *T*. Due to this complementary nature of $(R1)-(R2)$, a significant body of research has been devoted to understanding the (near) optimality properties of the regret of UCB algorithms; the readers are referred to [\[Lai87,](#page-35-0) [Agr95,](#page-33-0) [KR95,](#page-35-5) [ACBFS95,](#page-33-5) [ACBF02,](#page-33-1) [AMS07,](#page-33-6) [AB09,](#page-33-7) [HT10,](#page-35-6) [KCG12,](#page-35-7) [CGM](#page-34-1)+13, [DP16,](#page-34-2) [MG17,](#page-35-8) [Kau18,](#page-35-9) [Lat18,](#page-35-10) [HAYWC19,](#page-35-11) [GHMS22,](#page-34-3) [RZ24\]](#page-36-2) for notable progress in this direction.

While the (near) validation of $(R1)$ - $(R2)$ for UCB algorithms provides important insights into their theoretical optimality, there remains a significant gap between the theory in [\(1.3\)](#page-2-0)-[\(1.4\)](#page-2-1) and the actual algorithmic performance of the regret. For instance, in the most interesting case where the sub-optimality gaps $\{\Delta_a : \Delta_a > 0\}$ are relatively small, although the very definition [\(1.2\)](#page-1-2) necessarily entails a relatively small regret, the Lai-Robbins formula [\(1.3\)](#page-2-0) predicts a large regret, whereas the maximum risk [\(1.4\)](#page-2-1) offers little instance-specific information. This discrepancy reveals an intrinsic limitation of both paradigms (R1) and (R2): these criteria can be overly conservative either for finite time horizons *T* or for individual problem instance Δ 's, and neither approach fully compensates for the weakness of the other.

The first goal of this paper is to offer a new theoretical paradigm for understanding the *precise* regret behavior of a popular class of UCB[1](#page-2-2) algorithms¹ as named in

[\[ACBF02\]](#page-33-1). This new framework addresses both the major limitations of the existing theoretical paradigms $(R1)-(R2)$, and provides a positive answer to $(Q1)$. In particular, we show in Theorem [3.2](#page-8-0) that

$$
\frac{\text{Reg(UCB1)}}{\sum_{a:\Delta_a>0} \Delta_a n_{a;T}^*} \approx 1,
$$
\n(1.5)

where $\{n_a^*\}$ *a*;*T* }*a*∈[*K*] are deterministic quantities computable via a fixed point equation; see Section [3.2](#page-7-2) for a precise definition. While we have presented [\(1.5\)](#page-3-0) in an asymptotic fashion here for simplicity, our technical result in Theorem [3.2](#page-8-0) is fully non-asymptotic with explicit error bounds between the two terms in [\(1.5\)](#page-3-0).

As will be clear in Section [3](#page-7-0) below, our precise regret characterization [\(1.5\)](#page-3-0) not only accurately captures the actual behavior of the UCB1 algorithm for finite time horizon *T* and individual problem instance Δ 's, but also offers significant new insights into the regimes in which the existing paradigms (R1)-(R2) are indeed informative for the UCB1 algorithm. In particular, we will show that the Lai-Robbins regret formula [\(1.3\)](#page-2-0) provides precise approximation to the actual regret of the UCB1 algorithm, if and only if the sub-optimality gap is strong enough with $\min_{a:\Delta_a>0} (\Delta_a/\sigma) \gg \sqrt{K \log T/T}$. Moreover, we will show that the maximal regret of the UCB1 algorithm strictly deviates from the minimax regret by a logarithmic of the UCB1 algorithm strictly deviates from the minimax regret by a logarithmic factor, and is therefore minimax sub-optimal in a strict sense for the general *K*bandit problem.

As may be hinted in the formulae in [\(1.2\)](#page-1-2) and [\(1.5\)](#page-3-0), the technical crux of our regret characterization in [\(1.5\)](#page-3-0) lies in a new method to characterize the number of arm pulls $\{n_{a}$; $T\}_{a \in [K]}$ via the deterministic quantities $\{n_a^*\}$ $_{a;T}^*$ }_{*a*∈[*K*]}. Indeed, we show in Propositions [3.3](#page-8-1) and [3.7](#page-11-1) that such a characterization is possible both in probability and in expectation: uniformly in $a \in [K]$,

$$
\frac{n_{a;T}}{n_{a;T}^*} \approx 1
$$
 with high probability, and
$$
\frac{\mathbb{E} n_{a;T}}{n_{a;T}^*} \approx 1.
$$
 (1.6)

Interestingly, the control of the ratio in expectation exhibits qualitatively different features from its simpler in-probability counterpart. In particular, while an inprobability control of the ratio (1.6) is possible for a large regime of exploration rates in the UCB1 algorithm, the expectation control must witness a fundamental barrier for the exploration rate to stay above $\sigma \sqrt{2 \log T}$ in order to align with Lai-
Robbins asymptotic lower bound (1.3). Such a discrepancy occurs fundamentally Robbins asymptotic lower bound [\(1.3\)](#page-2-0). Such a discrepancy occurs fundamentally due to the heavy-tailed nature of $\{n_{a,T}\}_{a \in [K]}$ in spite of the presence of lighted-tail Gaussian noises.

While we work out in this paper the characterization [\(1.6\)](#page-3-1) only for the UCB1 algorithm, our technical approach to [\(1.6\)](#page-3-1) is applicable to a very general class of UCB index algorithms. We give in Section [2](#page-5-0) an outline for the main principles of our new approach.

1.3. Adaptive inference. The problem of statistical inference for adaptively collected data has posed a significant challenge for decades. By now, it is classical knowledge (cf. [\[DF79,](#page-34-4) [Whi58,](#page-36-3) [Whi59,](#page-36-4) [LW82\]](#page-35-1)) that conventional asymptotic theory may fail when applied to data collected in a sequential manner. More recently, [\[DMST18,](#page-34-5) [ZJM20,](#page-36-5) [DJM23,](#page-34-6) [KDL](#page-35-12)+21, [LKW23,](#page-35-13) [LYG](#page-35-14)+24, [YKZ24\]](#page-36-6) have shown through a combination of theoretical results and simulations—that similar issues may arise in the bandit setting that is our main interest in this paper.

To address these inference challenges, two main approaches have been proposed in the literature:

- (I1) The first approach leverages the martingale nature of the data through the martingale central limit theorem (cf., [\[HH80,](#page-35-15) [Dvo72\]](#page-34-7)). This method, possibly coupled with debiasing techniques to remove biases induced by sequential data collection, typically yields confidence intervals that are provably valid in the asymptotic limit of infinite data. The readers are referred to [\[DMST18,](#page-34-5) [DJM23,](#page-34-6) [KDL](#page-35-12)+21, [LKW23,](#page-35-13) [LYG](#page-35-14)+24, [YKZ24,](#page-36-6) [ZJM20,](#page-36-5) [HHZ](#page-35-16)+21, [BDK](#page-34-8)+21, [ZHHA21,](#page-36-7) [SZ23\]](#page-36-8) for applications of this technique in various concrete contexts.
- (I2) The second approach builds upon non-asymptotic concentration inequalities for self-normalized martingales (cf., [\[dlPnKL04,](#page-34-9) [dlPnLS09\]](#page-34-10)). While this method offers confidence intervals that are valid for any sample size, these intervals are often considerably wider due to the use of theoretical concentration inequalities. The readers are referred to [\[AYPS11,](#page-34-11) [SRR19,](#page-36-9) [WSWR](#page-36-10)+23] and references therein for examples of this approach.

The second goal of this paper is to construct valid confidence intervals for the unknown mean reward vector $\{\mu_a\}_{a \in [K]}$ in [\(1.1\)](#page-1-1) (and beyond) via UCB algorithms that blend the strengths of both (11) and (12) thereby providing a solution to questhat blend the strengths of both (I1) and (I2), thereby providing a solution to question (Q2).

While this goal may appear tangential to our theory in $(1.5)-(1.6)$ $(1.5)-(1.6)$ $(1.5)-(1.6)$, we obtain in Section [4,](#page-11-0) through an essential use of the deterministic characterization for ${n_{a;T}}_{a \in [K]}$ in [\(1.6\)](#page-3-1), quantitative central limit theorems (CLTs) for:

- (i) the empirical sample mean of the unknown rewards in the multi-armed bandit setting, and
- (ii) a general class of Ridge estimators (including the ordinary least squares estimator), where the arm means exhibit some underlying latent structures.

An immediate consequence of these quantitative CLTs is that statistical inference via UCB-type algorithms for the unknown parameters of interest in these models can be conducted as if the data were collected in the conventional, i.i.d. setting, while also enjoying the desired non-asymptotic theoretical guarantees that are exact in the asymptotic limit.

The connection between the deterministic characterization for $\{n_{a,T}\}_{a \in [K]}$ in [\(1.6\)](#page-3-1) and the feasibility of adaptive inference for $\{\mu_a\}_{a \in [K]}$ in the bandit setting [\(1.1\)](#page-1-1) is
concentually related to Π W821, which pioneered the notion of *'stability'* of sample conceptually related to [\[LW82\]](#page-35-1), which pioneered the notion of '*stability*' of sample covariance as a key factor for valid statistical inference, albeit in a different linear regression context. As such, we believe our technical approach in [\(1.6\)](#page-3-1) also opens a new door for other statistical inference applications in sequential decision-making problems with UCB algorithms and beyond.

1.4. Organization. The rest of the paper is organized as follows. Section [2](#page-5-0) outlines a general principle for our theory [\(1.5\)](#page-3-0)-[\(1.6\)](#page-3-1). In Section [3,](#page-7-0) we present our results on the precise characterizations of regret and pseudo-regret for the UCB1 algorithm and its numerous consequences. In Section [4,](#page-11-0) we detail the aforementioned quantitative CLTs. The numerical performance of their associated CI's are reported in Section [5.](#page-14-0) Proofs of all our results are deferred to Sections [6-](#page-15-0)[8](#page-28-0) and the Appendix.

1.5. Notation. For any two integers $m, n \in \mathbb{Z}$, let $[m : n] \equiv \{m, m+1, \ldots, n\}$ when *m* ≤ *n* and ∅ otherwise. Let $[m : n] \equiv [m : n-1]$, $(m : n] \equiv [m+1 : n]$, and we write $[n] \equiv [1 : n]$. For $a, b \in \mathbb{R}$, $a \vee b \equiv \max\{a, b\}$ and $a \wedge b \equiv \min\{a, b\}$. For *a* ∈ R, let *a*[±] ≡ (±*a*) ∨ 0. For *a* > 0, let $log_+(a) \equiv 1 \vee log(a)$. For $x \in \mathbb{R}^n$, let $||x||_p$ denote its *n*-norm $(0 \le n \le \infty)$ and *R* $(R) = \{x \in \mathbb{R}^n : ||x|| \le R\}$ We simply denote its *p*-norm ($0 \le p \le \infty$), and $B_{n,p}(R) \equiv \{x \in \mathbb{R}^n : ||x||_p \le R\}$. We simply write $||x|| \equiv ||x||_2$ and $B_n(R) \equiv B_{n,2}(R)$. For a matrix $M \in \mathbb{R}^{m \times n}$, let $||M||_{op}$ denote the spectral norm of *M*.

We use C_x to denote a generic constant that depends only on x , whose numeric value may change from line to line unless otherwise specified. $a \leq x$ *b* and $a \geq x$ *b* mean $a \leq C_x b$ and $a \geq C_x b$, abbreviated as $a = O_x(b)$, $a = \Omega_x(b)$ respectively; $a \approx_{x} b$ means $a \leq_{x} b$ and $a \geq_{x} b$, abbreviated as $a = \Theta_{x}(b)$. For two nonnegative sequences $\{a_n\}$ and $\{b_n\}$, we write $a_n \ll b_n$ (respectively $a_n \gg b_n$) if $\lim_{n\to\infty} (a_n/b_n) = 0$ (respectively $\lim_{n\to\infty} (a_n/b_n) = \infty$). We follow the convention that $0/0 = 0$. O and o (resp. O_P and o_P) denote the usual big and small O notation (resp. in probability).

For two real-valued random variables *X*, *Y*, their Kolmogorov distance $\delta_{\text{Kol}}(X, Y)$ is defined by

$$
\mathfrak{d}_{\mathrm{Kol}}(X,Y) \equiv \sup_{t \in \mathbb{R}} \left| \mathbb{P}(X \le t) - \mathbb{P}(Y \le t) \right|.

2. PRINCIPLES OF OUR NEW APPROACH TO $(1.5)-(1.6)$ $(1.5)-(1.6)$ $(1.5)-(1.6)$

In this section, we provide a heuristic description of our new analytic approach in a general setting where the multi-armed bandit problem is solved by an UCB index algorithm.

2.1. The general setting. Consider UCB index algorithms of the following form. Let μ_a be the mean reward for arm a . For the *t*-th arm pull, the allocation is determined by

$$
A_t \equiv \underset{a \in [K]}{\arg \max} \; ucb(\hat{\mu}_{a;t-1}, n_{a;t-1}, t, T), \tag{2.1}
$$

where $ucb(\mu, n, t, T)$ is an index function, $\hat{\mu}_{a:t}$ is an estimate of μ_a and $n_{a:t}$ is the sample size from arm *a* with the first *t* pulls and *T* is a predetermined borizon sample size from arm *a* with the first *t* pulls, and *T* is a predetermined horizon for performance evaluation. In general, $ucb(\mu, n, t, T)$ is increasing in (μ, t, T) and decreasing in *n*. For 'anytime' algorithms with unspecified *T*, $ucb(\mu, n, t, T)$ does not depend on *T*. Otherwise, we are typically able to write $ucb(\mu, n, T)$ as the UCB index function when it does not depend on *t*.

The UCB index function in [\(2.1\)](#page-5-1) can be constructed by inverting the (minimum) Kullback-Leibler (KL) divergence between arms with means μ and μ_{+} ,

$$
\operatorname{ucb}(\mu, n, t, T) \equiv \arg \max \left\{ \mu_+ : \mu_+ \ge \mu, \ n \cdot \text{KL}(\mu, \mu_+) \le g(T, t, n) \right\} \tag{2.2}
$$

for some non-negative exploration function $g(T, t, n)$ decreasing in *n* and increasing in (*t*, *^T*). Such KL-based UCB index was first introduced in [\[Lai87\]](#page-35-0) for prespecified horizon *T* and exploration functions of the form $g(T, t, n) = g(T/n)$ with $g(\cdot)$ a decreasing function. Thus, [\(2.2\)](#page-6-0) is a slight generalization of Lai's UCB [\[Lai87\]](#page-35-0). For $g(T, t, n) = \log T$, the UCB index in [\(2.2\)](#page-6-0) is an inversion of the Lai-Robbins [\[LR85\]](#page-35-4) lower bound for the expected number of pulls because

$$
n \leq (\log T)/\text{KL}(\mu_a, \mu_*) \quad \Leftrightarrow \quad \text{ucb}(\mu_a, n, T) \geq \mu_*.
$$

2.2. High-level ideas of our new analytic approach. Our analytical approach is to compare the algorithm in [\(2.1\)](#page-5-1) with its noiseless continuous-time counterpart. In this noiseless continuous-time version, the sample size growth curves $n_{a,t}^*$ are increasing functions of *t* satisfying

$$
\sum_{a \in [K]} n_{a;t}^* = t, \quad \text{ucb}(\mu_a, n_{a;t}^*, t, T) = \mu_{+,t}^*, \quad \forall a \in [K]
$$
 (2.3)

for some function $\mu^*_{+,t}$. Importantly, because $\text{ucb}(\mu, n, t, T)$ is decreasing in *n*, the poiseless version of (2.1) can be viewed as a greedy minimax algorithm for tor some function $\mu_{+,t}$. Importantly, because $\alpha \in \mathcal{L}(\mu, n, t, T)$ is decleasing in *n*, the noiseless version of [\(2.1\)](#page-5-1) can be viewed as a greedy minimax algorithm for $ucb(\mu_a, n_{a;t}^*, t, T)$, and its continuous-time version must have a common value μ^*_+
of the UCB. Thus, by inversion of (2.3), we may solve μ^* , as the unique solution $\mu_a, n_{a;t}, t, t$, *t*), and its continuous-time version must have a common value $\mu_{+,t}$ of the UCB. Thus, by inversion of [\(2.3\)](#page-6-1), we may solve $\mu_{+,t}^*$ as the unique solution of the equation of the equation

$$
\sum_{a \in [K]} \sup \{ n \in [0, t] : ucb(\mu_a, n, t, T) \ge \mu_{+,t}^* \} = t.
$$
 (2.4)

For performance evaluation at $t = T$, the noiseless continuous-time version would provide a target regret

$$
\text{Reg}^* \equiv \sum_{a \in [K]} \Delta_a n^*_{a;T}.
$$
 (2.5)

The objective of our analysis is to find proper conditions for the convergence of the UCB algorithm [\(2.1\)](#page-5-1) and its noiseless continuous-time counterpart in the sense of

$$
\frac{\text{Reg}(\mathscr{A})}{\text{Reg}^*} \approx 1, \quad \max_{a \in [K]} \mathbb{E} \left| \frac{n_{a;T}}{n_{a;T}^*} - 1 \right| \approx 0. \tag{2.6}
$$

This would allow us to gain more precise insight about the performance of the UCB algorithm compared with typical existing results focused on performance upper bounds on the regret and the expected number of pulls from suboptimal arms.

Clearly, the approach outlined above is both distribution dependent and algorithm dependent. In this paper, we confine ourselves to a definitive solution in the canonical Gaussian model with constant exploration function $g(T, t, n)$ in [\(2.2\)](#page-6-0). We expect our new analytic approach developed here to be broadly applicable to the general class of UCB index algorithms with further technical works.

Algorithm 1 UCB1 algorithm with exploration rate $\gamma_T > 0$

- 1: Pull once each of the *K* arms in the first *K* iterations.
- 2: for $t = K + 1$ to T do
- 3: Choose the arm A_t by

$$

3. Precise regret

3.1. The UCB1 algorithm. We consider a generalized version of the UCB algo-rithm [\[Lai87\]](#page-35-0) that is parameterized by an exploration rate $\gamma_T > 0$, hereafter referred to UCB1. To formally describe the UCB1 algorithm, let

$$
\hat{\mu}_{a;t} \equiv \frac{1}{n_{a;t}} \sum_{s \in [t]} R_s \mathbf{1}_{A_s = a}, \quad (a,t) \in [K] \times [T]
$$
\n(3.1)

be the empirical sample mean of μ_a up to round *t*. The UCB1 algorithm is initialized by first pulling each arm once. Then, given the past information $\{(\hat{\mu}_{a,s}, n_{a,s}) : a \in K \mid s \in [t-1] \}$ up to round $t-1$ the UCB1 algorithm at round t chooses an arm A . $[K]$, $s \in [t-1]$ } up to round $t-1$, the UCB1 algorithm at round t chooses an arm A_t
 that maximizes the over-estimated mean $\hat{\theta}_{t-1} + \sigma \gamma \pi / \sqrt{n+1}$. For the convenience that maximizes the over-estimated mean $\hat{\mu}_{a;t-1} + \sigma \gamma_T / \sqrt{n_{a;t-1}}$. For the convenience of the reader, we summarize this generalized ICR1 algorithm in Algorithm 1 of the reader, we summarize this generalized UCB1 algorithm in Algorithm [1.](#page-7-3)

In the Gaussian model, the over-estimated mean in Algorithm [1](#page-7-3) corresponds to Lai's UCB index in [\(2.2\)](#page-6-0) with

$$
KL(\mu, \mu_{+}) = \frac{(\mu_{+} - \mu)^2}{2\sigma^2}, g(T, t, n) = \frac{\gamma_T^2}{2}, ucb(\mu, n, t, T) = \mu + \frac{\sigma \gamma_T}{\sqrt{n}}.
$$
(3.2)

We note that this algorithm operates far beyond the Gaussian model. In fact, [\[ACBF02\]](#page-33-1) derived a nonasymptotic upper bound of the regret for the natural choice of $\gamma_T = \sqrt{2 \log T}$ and named the algorithm UCB1. We adopt here the same name HCR1 for general $\gamma_T > 0$ UCB1 for general $\gamma_T > 0$.

3.2. The fixed point equation and related quantities. The generic expected regret in [\(1.2\)](#page-1-2) for the UCB1 algorithm will be written as

$$
R(\Theta) \equiv \text{Reg(UCB1)}, \quad \Theta \equiv (T, K, \Delta, \sigma, \gamma_T). \tag{3.3}
$$

Here and below, we reserve the notation Θ to summarize all parameters in the bandit problem and the UCB1 algorithm.

Definition 3.1. (1) Let *n*∗(Θ) be determined via the equation

$$
\sum_{a \in [K]} n_*(1 + n_*^{1/2} \Delta_a / (\sigma \gamma_T))^{-2} = T.
$$
 (3.4)

(2) With *n*∗(Θ) defined in [\(3.4\)](#page-7-4), let

$$
n_{a;T}^* \equiv n_*(\Theta)(1 + n_*^{1/2}(\Theta)\Delta_a/(\sigma\gamma_T))^{-2}, \quad a \in [K].
$$
 (3.5)

(3) The theoretical regret $\text{Reg}_{\mathcal{T}}^{*}(\Theta)$ for UCB1 is defined as

$$
\text{Reg}_{T}^{*}(\Theta) \equiv \sum_{a \in [K]} \Delta_{a} n_{a;T}^{*}.
$$
 (3.6)

Remark 1*.* Some interpretation and technical remarks:

- (1) $n_*(\Theta)$ is related to the noiseless UCB in [\(2.3\)](#page-6-1) through $\mu^*_{+,T} = \mu_* + \sigma \gamma_T /$
with (3.2) By Lemma 6.1 helow for any $\sigma > 0$, there exists a unique with [\(3.2\)](#page-7-5). By Lemma [6.1](#page-16-0) below, for any $\sigma > 0$, there exists a unique $n_*(\Theta) \in$
(*T*/*K T*] solving the equation (3.4). Moreover as the man $n \mapsto \sum_{r=0}^{\infty} (1/\sqrt{n+1})^r$ √ *n*∗(Θ) [*T*/*K*, *T*] solving the equation [\(3.4\)](#page-7-4). Moreover, as the map $n \mapsto \sum_{a \in [K]} (1/\sqrt{n} + \lambda)(-\infty)$ $\Delta_a/(\sigma \gamma_T)^{-2}$ is strictly increasing, *n*_{*}(Θ) can be easily solved numerically by bisection methods bisection methods.

in [\(2.3\)](#page-6-1) through [\(3.2\)](#page-7-5). As will be rigorously proven in Section [3](#page-7-0) ahead, the quantity *n* ∗ $a_{a,T}^*$ is ratio consistent for $n_{a,T}$ both in probability and in expectation.

We define two more quantities that will be used repeatedly below:

• First, the error $err(\Theta)$ is defined by

$$
err(\Theta) \equiv \frac{\sqrt{\log \gamma_T} + \sqrt{\log \log T}}{\gamma_T} + \frac{K}{T} + \frac{\|\Delta/\sigma\|_{\infty}^2}{\gamma_T^2}.
$$
 (3.7)

• Next, we define

$$
D_* \equiv \frac{1}{T} \sum_{a \in [K]} \left(\frac{n_{a;T}^*}{n_*}\right)^{1/2} n_{a;T}^*.
$$
 (3.8)

As will be clear from Lemma [6.1](#page-16-0) below, $D_* \in [K^{-1/3}, 1]$.

3.3. Characterization of the expected regret *R*(Θ). We will work with Gaussian noises $\{\xi_t\}$ in this paper, formally recorded as below.

Assumption A. The scaled noises $\{\xi_t\}_{t \in [T]}$ are i.i.d. $\mathcal{N}(0, 1)$.

Our first main result below characterizes the behavior of *R*(Θ) in [\(3.3\)](#page-7-6).

Theorem 3.2. *Suppose Assumption [A](#page-8-2) holds. There exists a universal constant* $C > 0$ *such that if* $err(\Theta) \leq 1/C$, *then*

$$
\left|\frac{R(\Theta)}{Reg_T^*(\Theta)}-1\right|\leq C\cdot(\text{err}(\Theta)+\vartheta_T^*).
$$

Here ϑ^*_I T^* $\equiv \gamma_T^{-2} \cdot Te^{-\gamma_T^2/2}$.

The proof of Theorem [3.2](#page-8-0) leads to the following *two-sided* expectation control for $\mathbb{E} n_{a}$. In fact, we provide a slight stronger control for the first moment of the difference $|n_{a;T}/n_a^*|$ $a_{i,T}^*$ − 1| that will be useful in the applications in Section [4.](#page-11-0)

Proposition 3.3. *Suppose Assumption [A](#page-8-2) holds. There exists a universal constant* $C > 0$ *such that if* $err(\Theta) \leq 1/C$, *then*

$$
\max_{a\in[K]} \mathbb{E}\left|n_{a;T}/n_{a;T}^* - 1\right| \leq C \cdot \left(D_*^{-1} \operatorname{err}(\Theta) + \vartheta_T^*\right).
$$

Here recall D_* *is defined in [\(3.8\)](#page-8-3), and* ϑ^*_I $T^* = \gamma_T^{-2} \cdot Te^{-\gamma_T^2/2}.$ The proofs of both Theorem [3.2](#page-8-0) and Proposition [3.3](#page-8-1) can be found in Section [7.](#page-22-0)

Remark 2*.* Some technical remarks on the conditions and the error terms in Theorem [3.2](#page-8-0) and Proposition [3.3:](#page-8-1)

- (1) The constant $C > 0$ can be tracked easily in the proof; we refrain from doing so to keep the presentation and the proof clean.
- (2) For the canonical choice $\gamma_T = \sqrt{2 \log T}$, $err(\Theta)$ vanishes if and only if $K/T \to 0$ and $\|\Lambda/\sigma\|$, $\gamma_T \to 0$. The formal condition is minimal, and the latter $K/T \to 0$ and $\|\Delta/\sigma\|_{\infty}/\gamma_T \to 0$. The formal condition is minimal, and the latter condition essentially ensures that the (expected) number of arm pulls diverges as $T \rightarrow \infty$. Similar conditions have been adopted in, e.g., [\[LR85,](#page-35-4) [Lai87\]](#page-35-0).
- (3) γ_T cannot drop substantially below $\sqrt{2 \log T}$ for the error terms to be small
due to the the crucial factor θ^* . In fact, if such small γ_T is allowed, then the due to the the crucial factor ϑ_{I}^*
asymptotic Lai-Robbins lower *T*_{*T*}. In fact, if such small γ_T is allowed, then the theory of (3.9) will be violated asymptotic Lai-Robbins lower bound [\(3.9\)](#page-9-0) will be violated.
- (4) The error bound for $\mathbb{E} n_{a;T}/n_a^*$
he clear from Lemma 6.1, this a_{i}^{*} − 1 comes with an additional D_{*}^{-1} . As will be clear from Lemma [6.1,](#page-16-0) this factor arises for optimal arms, but it does not appear in the regret that takes average over sub-optimal arms.
- (5) The Gaussianity assumption on the noises is used in the boundary crossing probability in Lemma [A.1.](#page-32-1) We believe our results hold in a weaker form under the first and second moment assumptions when the left tail of the distribution of the awards from one of the optimal arm is sub-Gaussian.

3.3.1. *Relation to the Lai-Robbins bound.* Recall that in our setting, the Lai-Robbins lower bound [\[LR85\]](#page-35-4) states that for any fixed $K \in \mathbb{N}$ and $\{\Delta_a\} \subset \mathbb{R}^K_{\geq 0}$, and any choice of the exploration rate $\{\gamma_T\}$, the following hold:

$$
\lim_{T \to \infty} \frac{R(\Theta)}{2 \log T} \ge \sum_{a: \Delta_a > 0} \frac{\sigma^2}{\Delta_a}.
$$
\n(3.9)

When $\{\Delta_a\}$ becomes small, $R(\Theta)$ is also small non-asymptotically, so the asymptotic lower bound [\(3.9\)](#page-9-0) becomes uninformative. Our Theorem [3.2](#page-8-0) provides a precise characterization of the magnitude of $\{\Delta_a\}$ for which the Lai-Robbins bound [\(3.9\)](#page-9-0) remains informative for the actual expected regret *R*(Θ).

To this end, we consider the following parameter space. Fix $\eta_T > 0$. For any $L > 0$ and $K \in \mathbb{N}$, let

$$
\mathscr{C}(L) \equiv \Big\{\Delta \in \mathbb{R}^K : \operatorname{supp}(\Delta) \subsetneq [K], \{\Delta_a/\sigma\}_{a:\Delta_a>0} \subset [L\sqrt{K\log T/T}, \eta_T\sqrt{\log T}] \Big\}.
$$

Corollary 3.4. *Suppose Assumption [A](#page-8-2) holds. Consider the* UCB1 *allocation rule* with $\gamma_T \equiv \sqrt{2 \log T}$. Let $R^{\text{LR}}(\Theta) \equiv 2 \log T \cdot \sum_{a:\Delta_a > 0} (\sigma^2/\Delta_a)$. Then there exists some universal constant $C > 0$ such that for $K/T < 1/C$ the following hold: *^a*:∆*a*>⁰ *some universal constant C* > ⁰ *such that for K*/*^T* [≤] ¹/*C, the following hold:*

(1) For any L > *C*, with $\varepsilon_{T,K} \equiv \sqrt{\log \log T / \log T} + K/T$,

 $\sup_{\Delta \in \mathcal{C}(L)} |R(\Theta)/R^{\mathsf{LR}}(\Theta) - 1| \leq C \cdot (1/L + \varepsilon_{T,K} + \eta_T)$

(2) For any $\varepsilon \in (0, 1/2)$ *,*

$$
\inf_{\Delta \in \mathscr{C}(\varepsilon)} R(\Theta)/R^{\mathsf{LR}}(\Theta) \leq C \cdot \varepsilon^2.
$$

The above corollary shows that $\sqrt{K \log T/T}$ is the crucial scaling of the 'signal
ength' min $\pm \sqrt{(\Lambda/\sigma)}$ for the Lai-Robbins bound (3.9) to be informative: strength' min_{a: Δ _{*a*}>0(Δ _{*a*}/ σ) for the Lai-Robbins bound [\(3.9\)](#page-9-0) to be informative:}

- (1) If $\min_{a:\Delta_a>0}(\Delta_a/\sigma) \gg \sqrt{K \log T/T}$, then the Lai-Robbins bound [\(3.9\)](#page-9-0) provides a uniformly accurate characterization of the regret $R(\Theta)$ of the UCB1 algorithm a uniformly accurate characterization of the regret *R*(Θ) of the UCB1 algorithm.
- (2) If $\min_{a:\Delta_a>0} (\Delta_a/\sigma) \leq \sqrt{K \log T/T}$, then the Lai-Robbins bound [\(3.9\)](#page-9-0) can be arbitrarily loose for the regret $R(\Theta)$ of the UCB1 algorithm arbitrarily loose for the regret *R*(Θ) of the UCB1 algorithm.

3.3.2. *Relation to the maximal regret.* Let us now apply Theorem [3.2](#page-8-0) to obtain a lower bound for the maximum regret sup[∆] *R*(Θ).

Corollary 3.5. *Suppose Assumption [A](#page-8-2) holds. Consider the* UCB1 *allocation rule with with* $\gamma_T = \sqrt{2 \log T}$. Then there exists some universal constant $C > 0$ such that for $K/T < 1/G$ with $c = \sqrt{\log \log T / \log T} + K/T$. *that for* $K/T \leq 1/C$, with $\varepsilon_{T,K} \equiv \sqrt{\log \log T / \log T} + K/T$,

$$
\sup_{\Delta \in \mathbb{R}_{\geq 0}^K} (R(\Theta)/\sigma) \geq (1/\sqrt{8} - C \cdot \varepsilon_{T,K})_+ \sqrt{TK \log T}.
$$

The above corollary shows that the maximum risk of the UCB1 algorithm de-viates from the minimax regret [\(1.4\)](#page-2-1) by a multiplicative factor of $\sqrt{\log T}$. The only related result appears to be [\[KZ21,](#page-35-17) Theorem 4], which rigorously confirms the minimax sub-optimality of UCB1 in the two-armed setting. To the best of our knowledge, our lower bound for general *K* in the above corollary is new.

The proofs of both Corollaries [3.4](#page-9-1) and [3.5](#page-10-0) can be found in Section [7.](#page-22-0)

3.4. **Characterization of the pseudo-regret** $\hat{R}^p(\Theta)$. We now complement the results in the previous section by studying their stochastic regret versions. The vanilla *regret* over *T* rounds is given by

$$
\hat{R}(\Theta) \equiv \sum_{t \in [T]} (\mu_* - R_t) = \sum_{t \in [T]} \Delta_{A_t} - \sigma \sum_{t \in [T]} \xi_t.
$$
 (3.10)

As the fluctuation of the random error in [\(3.10\)](#page-10-1) is typically of order $O_P(T^{-1/2})$ whereas the expected regret $R(\Theta)$ in [\(3.3\)](#page-7-6) are typically of a substantially lower order, we shall consider a version of [\(3.10\)](#page-10-1) by removing its random error component to shed light on the underlying stochastic behavior of [\(3.3\)](#page-7-6). Borrowing the terminology from [\[AMS09\]](#page-33-8), let the *pseudo-regret* over *T* rounds be

$$
\hat{R}^{\mathsf{p}}(\Theta) \equiv \sum_{t \in [T]} \Delta_{A_t} = \sum_{a: \Delta_a > 0} \Delta_a n_{a;T}.
$$
 (3.11)

Clearly, $R(\Theta)$ and $\hat{R}^p(\Theta)$ can be related via $\mathbb{E} \hat{R}^p(\Theta) = R(\Theta)$.

Our second main result below provides a characterization for the pseudo-regret $\hat{R}^{\mathsf{p}}(\Theta)$ in [\(3.11\)](#page-10-2).

Theorem 3.6. *Suppose Assumption [A](#page-8-2) holds. There exists a universal constant* $C > 0$ *such that if* $err(\Theta) \leq 1/C$ *, then*

$$
\mathbb{P}\left(\left|\frac{\hat{R}^{p}(\Theta)}{Reg_T^{*}(\Theta)}-1\right|\geq C\cdot err(\Theta)\right)\leq C\cdot \gamma_T^{-100}.
$$

Interestingly, the pseudo-regret $\hat{R}^{\rho}(\Theta)$ can be significantly smaller in order than the expected regret $R(\Theta) = \mathbb{E} \hat{R}^p(\Theta)$. For instance, for $\gamma_T = (\log \log T)^{0.51}$, the above theorem implies that $\hat{R}^p(\Theta) = O_p((\log \log T)^{1.02})$ for fixed Λ whereas the above theorem implies that $\hat{R}^p(\Theta) = O_P((\log \log T)^{1.02})$ for fixed Δ , whereas the expected regret must satisfy $\mathbb{E} \hat{R}^p(\Theta) = \Omega(\log T)$ due to the Lai-Robbins lower

bound [\(3.9\)](#page-9-0). The discrepancy between $\hat{R}^p(\Theta)$ and $\mathbb{E} \hat{R}^p(\Theta)$ has been previously observed in [\[CM07,](#page-34-12) [AYPS11\]](#page-34-11) for a class of UCB algorithms that take the confidence level as an input. Here our results show that such phenomenon continues to hold for the vanilla UCB1 algorithm with small γ ⁷'s.

Similar to Proposition [3.3,](#page-8-1) the proof of Theorem [3.6](#page-10-3) leads to a ratio control for $n_{a;T}/n_a^*$ $_{a;T}^*$ that now holds in probability.

Proposition 3.7. *Suppose [A](#page-8-2)ssumption A holds. Fix* $\gamma \geq 1$ *. There exists a universal constant* $C > 0$ *such that if* $err(\Theta) \vee (\gamma/\gamma_T) \leq 1/C$, then

$$
\max_{a \in [K]} \mathbb{P}\left[|n_{a;T}/n_{a;T}^* - 1| \ge C \cdot (D_*^{-1} \, \text{err}(\Theta) + \gamma/\gamma_T) \right] \le C \cdot (\gamma_T^{-100} + \log T \cdot \gamma e^{-\gamma^2/2}).
$$

Here recall D[∗] *is defined in [\(3.8\)](#page-8-3).*

The proofs of both Theorem [3.6](#page-10-3) and Proposition [3.7](#page-11-1) can be found in Section [7.](#page-22-0)

Remark 3*.* Proposition [3.7](#page-11-1) above recovers several results in [\[KZ21\]](#page-35-17) under a slight variant of the UCB1 algorithm.

(1) In the two-armed case $K = 2$, using the notation of [\[KZ21\]](#page-35-17), with $\sigma = 1$, $\gamma_T = \sqrt{\rho \log T}$ and $\Delta = \sqrt{\theta \log T/T}$, the fixed point equation [\(3.4\)](#page-7-4) becomes

$$
n_* + \left(\frac{1}{\sqrt{n_*}} + \sqrt{\frac{\theta}{\rho T}}\right)^{-2} = T \iff \frac{1}{\sqrt{1 - n_*/T}} - \frac{1}{\sqrt{n_*/T}} = \sqrt{\frac{\theta}{\rho}}.
$$

Compared with [\[KZ21,](#page-35-17) Eqn. 2], by setting $\lambda_p^*(\theta) \equiv n_*/T$ in the above equation,
Proposition 3.7 recovers [KZ21, Theorem 1 and Theorem 41 respectively with Proposition [3.7](#page-11-1) recovers [\[KZ21,](#page-35-17) Theorem 1 and Theorem 4] respectively with a stronger non-asymptotic estimate.

- (2) In the *K*-armed case, [\[KZ21\]](#page-35-17) considered two special cases:
	- (a) In the first case, $\Delta_a = 0$ for all $a \in [K]$. Then it is easy to solve by [\(3.4\)](#page-7-4) that $n_* = T/K$, so Proposition [3.7](#page-11-1) recovers [\[KZ21,](#page-35-17) Theorem 2-(1)].
	- (b) In the second case, *K* is fixed and $\min_{a:\Delta_a>0}(\Delta_a/\sigma) \gg \sqrt{\log T/T}$. In this case, the summation in (3.4) over sub-optimal arms trivializes with $n \approx$ case, the summation in [\(3.4\)](#page-7-4) over sub-optimal arms trivializes with $n_* \approx$ *T*/ $|\{a : \Delta_a = 0\}|$. Proposition [3.7](#page-11-1) then recovers [\[KZ21,](#page-35-17) Theorem 2-(2)].

4. Adaptive inference

4.1. Inference for the mean rewards.

4.1.1. *Stability and quantitative central limit theorems.* The following notion of '*stability*', directly motivated from [\[LW82\]](#page-35-1) in a slightly different context, provides a key connection of our theoretical results in Section [3](#page-7-0) and adaptive inference for the mean reward $\{\mu_a\}_{a \in [K]}$.

Definition 4.1. We call a bandit algorithm $\mathscr A$ *weakly-stable*, if for some deterministic real numbers $\{n_{a,T}^{\star}(\mathscr{A})\}_{a\in[K]}$, the number of arm pulls $\{n_{a,T}(\mathscr{A})\}_{a\in[K]}$ by the algorithm $\mathscr A$ satisfies

$$
\frac{n_{a;T}(\mathscr{A})}{n_{a;T}^{\star}(\mathscr{A})} \xrightarrow{\mathbb{P}} 1, \quad \text{for all arm} \ \ a \in [K]. \tag{4.1}
$$

We further call $\mathscr A$ *strongly-stable*, if

$$
\max_{a \in [K]} \mathbb{E} \left| \frac{n_{a;T}(\mathscr{A})}{n_{a;T}^\star(\mathscr{A})} - 1 \right| \le \text{err}_{\mathscr{A}}(\Theta),\tag{4.2}
$$

where $err_{\mathscr{A}}(\Theta)$ is some algorithmic-specific error term that vanishes as $T \to \infty$.

It is easy to show, following an argument of [\[LW82,](#page-35-1) Theorem 3], that for any weakly-stable bandit algorithm $\mathscr A$, the sample mean is asymptotically normal:

$$
(n_{a;T}(\mathscr{A})/\sigma^2)^{1/2} \cdot (\widehat{\mu}_{a;T}(\mathscr{A}) - \mu_a) \stackrel{d}{\to} \mathcal{N}(0,1) \quad \text{as } T \to \infty.
$$
 (4.3)

From here, our Proposition [3.7](#page-11-1) immediately implies that under the conditions assumed therein, the central limit theorem [\(4.3\)](#page-12-0) holds for the UCB1 algorithm. In fact, we may prove strong stability of UCB1 in the non-asymptotic sense of [\(4.2\)](#page-12-1) by leveraging the expectation control in Proposition [3.3.](#page-8-1) Recall δ_{Kol} defined in [\(1.7\)](#page-5-2).

Theorem 4.2. *Suppose [A](#page-8-2)ssumption A holds and* $\gamma_T \leq (\log T)^{100}$ *. Then there exists* a universal constant $C > 0$ such that *a universal constant C* > ⁰ *such that*

$$
\max_{a\in[K]} \mathfrak{d}_{\text{Kol}}\Big((n_{a;T}/\sigma^2)^{1/2}(\hat{\mu}_{a;T}-\mu_a),\mathcal{N}(0,1)\Big)\leq C\cdot(D_*^{-1}\,\text{err}(\Theta)+\vartheta_T^*)^{1/3}.
$$

Here ($err(\Theta), D_$ ^{*x*}) *are defined in* [\(3.7\)](#page-8-4)*-*[\(3.8\)](#page-8-3) *and* ϑ^*_1 $T^* = \gamma_T^{-2} \cdot Te^{-\gamma_T^2/2}.$

The proof of the above theorem can be found in Section [8.](#page-28-0) As an immediate application, we may construct confidence intervals for μ_a using the sample mean $\hat{\mu}_{\alpha,T}$ with sample size $n_{\alpha,T}$ as if the data were collected in an i.i.d. fashion: for any $\alpha \in (0, 1)$, consider the following $(1 - \alpha)$ confidence interval for μ_a :

$$
\mathsf{Cl}_a(\alpha) \equiv [\hat{\mu}_{a;T} \pm z_{\alpha/2} \cdot \sigma n_{a;T}^{-1/2}]. \tag{4.4}
$$

Here and below, whenever confidence intervals are concerned, we reserve the notation z_α as the normal $1 - \alpha$ quantile in that $\mathbb{P}(\mathcal{N}(0, 1) \le z_\alpha) = 1 - \alpha$. The following corollary follows directly from Theorem [4.2](#page-12-2) above, so we omit a detailed proof.

Corollary 4.3. *Consider the setting in Theorem [4.2.](#page-12-2) Then there exists some universal constant C* > ⁰ *such that*

$$
\max_{a\in[K]} \sup_{\alpha\in(0,1)} \left| \mathbb{P}\left(\mu_a \in \mathsf{Cl}_a(\alpha)\right) - (1-\alpha) \right| \leq C \cdot \left(\mathbf{err}(\Theta) + \vartheta_T^*\right)^{1/3}.
$$

In the above discussion we have assumed known noise level $\sigma > 0$ for simplicity. If the noise level is unknown, we may use any consistent estimator $\hat{\sigma}$ of σ for practical implementation. A simple choice in our setting is

$$
\hat{\sigma}^2 \equiv \frac{1}{K} \sum_{a \in [K]} \bigg(\frac{1}{n_{a;T}} \sum_{t \in [T]} (R_t - \hat{\mu}_{a;T})^2 \mathbf{1}_{A_t = a} \bigg).
$$

In fact, each term in the parentheses is a consistent estimator of the variance for arm $a \in [K]$, and therefore in the current homogeneous noise setting we may further take an average of these individual estimates to reduce the variability. These ramifications will not be further pursued for simplicity of presentation.

4.2. Inference for bandits with structured mean rewards.

4.2.1. *The setup and the algorithm.* Consider the linear regression model, where we observe data $\{(x_t, y_t) \in \mathbb{R}^d \times \mathbb{R} : t \in [T]\}$, consisting of the covariates $\{x_t\}$ and associated responses $\{y_t\}$ which are related through associated responses $\{y_t\}$, which are related through

$$
y_t = \langle x_t, \beta_* \rangle + \xi_t, \quad t \in [T]. \tag{4.5}
$$

Here $\beta_* \in \mathbb{R}^d$ is the unknown parameter of interest, and $\{\xi_t\}$'s represent the additive noises. For notational convenience, we define the design matrix $X \in \mathbb{R}^{T \times d}$, where noises. For notational convenience, we define the design matrix $X \in \mathbb{R}^{T \times d}$, where each row corresponds to x_t^T , the response vector $Y = (y_1, \ldots, y_T) \in \mathbb{R}^T$, and the error vector $\xi = (\xi_1, \xi_T) \in \mathbb{R}^T$ error vector $\xi = (\xi_1, \dots, \xi_T) \in \mathbb{R}^T$.

We consider here a special case: suppose the covariates $\{x_t\}$ take values in a finite decision set $\mathcal{X} \equiv \{z_1, \ldots, z_K\} \subset \mathbb{R}^d$, and at round *t*, the covariate $x_t \equiv z_{A_t}$ is selected via the UCR1 algorithm in Algorithm 1, where \hat{u} , therein is now replaced selected via the UCB1 algorithm in Algorithm [1,](#page-7-3) where $\hat{\mu}_{a;t}$ therein is now replaced
by $\hat{v}_i = n^{-1} \sum_i y_i \hat{\mathbf{l}}_i$. But simply for a relatively small size of the decision by $\hat{y}_{a;t} \equiv n_{a;t}^{-1} \sum_{s \in [t]} y_s \mathbf{1}_{A_s = a}$. Put simply, for a relatively small size of the decision set $\mathscr X$, the selection rule of this algorithm treats the problem as a *K*-arm bandit problem with arm means $\{\langle z_a, \beta_* \rangle\}_{a \in [K]}^2$ $\{\langle z_a, \beta_* \rangle\}_{a \in [K]}^2$. $$
R^{\text{lin}}(\Theta) = \mathbb{E} \sum_{t \in [T]} \left(\max_{z \in \mathcal{X}} \langle z, \beta_* \rangle - \langle x_t, \beta_* \rangle \right) \tag{4.6}
$$

is the same (up to logarithmic factors) as the contextual bandit algo-rithms [\[AYPS11\]](#page-34-11) when $|\mathcal{X}| = O(d)$. The key difference in the current setting is that we are interested in the unknown regression coefficient vector $\beta_* \in \mathbb{R}^d$ rather
than the arm means $\{(\tau, \beta)\}_{\tau \in \mathbb{R}^d}$ than the arm means $\{\langle z_a, \beta_* \rangle\}_{a \in [K]}$.

4.2.2. *The Ridge estimator.* Once the data $\{(x_t, y_t)\}_{t \in [T]}$ is collected, we can estimate the parameter β , of interest as via a Ridge regression estimator: mate the parameter β_* of interest as via a Ridge regression estimator:

$$
\hat{\beta}_{\lambda} = \underset{\beta \in \mathbb{R}^d}{\arg \min} \left\{ \frac{1}{T} ||Y - X\beta||^2 + \lambda ||\beta||^2 \right\} = \frac{1}{T} (S_T + \lambda I)^{-1} X^\top Y, \tag{4.7}
$$

where $S_T \equiv T^{-1}X^{\top}X = T^{-1} \sum_{t \in [T]} x_t x_t^{\top} \in \mathbb{R}^{d \times d}$ is the sample covariance. The case $\lambda = 0$ in [\(4.7\)](#page-13-1) is in general understood as the limit of the right hand side as $\lambda \downarrow 0$. When S_T is invertible, this limit $\hat{\beta}_0$ coincides with the ordinary least squares estimator. $$
\sqrt{T/\sigma^2} \cdot S_T^{-1/2} (S_T + \lambda I)(\hat{\beta}_\lambda - (S_T + \lambda I)^{-1} S_T \beta_*) \stackrel{d}{\approx} \mathcal{N}(0, I). \tag{4.8}
$$

For random designs, S_T can be replaced by the popular covariance matrix in low dimensions, but would otherwise require a mean-field modification in high dimensions, cf. [\[DW18,](#page-34-13) [HMRT22,](#page-35-18) [HX23,](#page-35-19) [BHX23\]](#page-34-14).

²When the size of the decision set $\mathscr X$ is large, one may instead use a contextual bandit algorithm, cf. [\[AYPS11,](#page-34-11) [LS20\]](#page-35-3).

4.2.3. *Quantitative central limit theorems.* Let $\Delta_a^{\text{lin}} \equiv \max_{a' \in [K]} \langle z'_a, \beta_* \rangle - \langle z_a, \beta_* \rangle$
for all $a \in [K]$. Let Δ_a^{lin} be defined as $(3, 3)$, wⁱⁱⁿ be the solution to $(3, 4)$, and $x^{*,\text{lin}}$ for all $a \in [K]$. Let Θ^{lin} be defined as [\(3.3\)](#page-7-6), n_{\ast}^{lin} be the solution to [\(3.4\)](#page-7-4), and $n_{a;T}^{*,\text{lin}}$ be defined as [\(3.5\)](#page-7-7), all upon replacing $\{\Delta_a\}$ therein with $\{\Delta_a^{\text{lin}}\}$. Furthermore, let *S* ∗ T^* = T^{-1} $\sum_{a \in [K]} n^*_{a;T} z_a z_a^\top$ be the 'population' version of *S T*.

Theorem 4.4. Consider the above linear regression setting with span(\mathscr{X}) = \mathbb{R}^d . *Suppose [A](#page-8-2)ssumption A holds and* $\gamma_T \leq (\log T)^{100}$. $$
\delta_{\text{Kol}}\Big(\langle w, \sqrt{T/\sigma^2} \cdot S_T^{-1/2} (S_T + \lambda I)(\hat{\beta}_{\lambda} - (S_T + \lambda I)^{-1} S_T \beta_*)\rangle, \mathcal{N}(0, 1) \Big) \leq C \cdot (D_{*}^{\lim, -1} \text{err}(\Theta^{\lim}) + \vartheta_T^{*})^{1/3} \cdot [1 + (z_K/\sigma_T^{*})^{1/3}].
$$

Here $z_K \equiv T^{-1} \sum_{a \in [K]} n_{a;T}^{*,\text{lin}} ||z_a||^2$, σ_T^* $\frac{1}{T} \equiv \lambda_{\text{min}} (S_T^*)$ ^{*}_{*T*}), $(D_*^{\text{lin}}, \text{err}(\Theta^{\text{lin}}))$ are defined via [\(3.7\)](#page-8-4)-[\(3.8\)](#page-8-3) with Θ therein replaced by Θ^{lin} and ϑ^*_I $T^* = \gamma_T^{-2} \cdot Te^{-\gamma_T^2/2}.$

The proof of the above theorem can be found in Section [8.](#page-28-0) Note that in the above theorem the decision set $\mathscr{X} = \{z_a\}_{a \in [K]}$ is only required to expand \mathbb{R}^d without orthogonality requirements (which would otherwise trivialize the problem).

Similar to the development in the previous subsection, Theorem [4.4](#page-14-1) above can be easily used to validate the 'conventional' confidence intervals for the lowdimensional projections $\{\langle w, \beta_* \rangle\}_{w \in \partial B_d(1)}$. We omit these repetitive details.

Remark 4*.* In a related work, [\[ZJM20\]](#page-36-5) observes the failure of the central limit theorem for the ordinary least squares estimator in a Bernoulli batched bandit problem, in the asymptotic regime of the large batch limit with a *fixed* horizon *T*. Here our Theorem [4.4](#page-14-1) asserts a quantitative CLT in the large horizon limit $T \to \infty$. However, the distributional convergence to normal can be fairly slow, as empirically observed previously in a related two-arm bandit problem, cf. [\[DMST18,](#page-34-5) Figure 2].

5. Some illustrative simulations

For numerical illustration, we consider a two-armed bandit setting $K = 2$ with sub-optimality gap $\Delta \ge 0$. The noise level is set as $\sigma = 0.1$. All simulation results below are based on $B = 1000$ Monte Carlo averages.

5.1. Regrets and arm pulls. In the first simulation, we will numerically validate:

- (1) Precise regret characterizations in Theorems [3.2](#page-8-0) and [3.6.](#page-10-3)
- (2) Proposition [3.3](#page-8-1)/[3.7](#page-11-1) that provide characterizations for the number of arm pulls.

The exploration rate is set to be $\gamma_T = \sqrt{2 \log T}$ as in the UCB1 allocation rule with time borizon $T = 3000$ for this simulation time horizon $T = 3000$ for this simulation.

In the left penal of Figure [1,](#page-15-1) we numerically validate (1) by plotting:

- the expected regrets *R*(Θ) in the dotted red line via Monte-Carlo average of the pseudo-regrets $\hat{R}^{\mathsf{p}}(\Theta)$ in [\(3.11\)](#page-10-2);
- the theoretical regrets $\sum_{a:\Delta_a>0} \Delta_a n_a^*$ $_{a;T}^*$ in the blue line;
- the Lai-Robbins regrets $R^{\text{LR}}(\Theta) = \gamma_T^2 \sum_{a:\Delta_a > 0} (\sigma^2/\Delta_a)$ in the green line.

Figure 1. *Left panel*: Regrets for various sub-optimality gaps ∆ ∈ [0.01, ⁰.25]. *Right panel*: Number of arm pulls for various suboptimality gaps $\Delta \in [0.01, 0.05]$.

The expected regret $R(\Theta)$ closely aligns with the theoretical regret formula obtained in Theorems [3.2](#page-8-0) and [3.6](#page-10-3) across different choices of the sub-optimality gap ∆. Moreover, the Lai-Robbins asymptotic regret *R* LR(Θ) only aligns with the expected regret $R(\Theta)$ for large values of Δ ; this matches the theory in Corollary [3.4.](#page-9-1)

In the right panel of Figure [1,](#page-15-1) we numerically validate (2) by plotting

- the expected numbers of arm pulls for both optimal and sub-optimal arms in dotted lines;
- theoretical numbers of arm pulls {*n* ∗ $_{a;T}^*$ } in the solid lines.

The dotted lines closely align with the solid lines, and thereby verifying the conclusions in Propositions [3.3](#page-8-1) and [3.7.](#page-11-1) For visualization purposes, we only display the curves for $\Delta \in [0.01, 0.05]$.

5.2. Gaussian approximation of the empirical mean, and coverage of the CI's. In the second simulation, we examine numerically (i) the Gaussian approximation of $\hat{\mu}_{a,T}$ in Theorem [4.2,](#page-12-2) and (ii) the numerical performance of the coverage probabilities of the CI's defined in [\(4.4\)](#page-12-3).

We choose the common exploration rate $\gamma_T = \sqrt{6 \log T/T}$ with time horizon – 10,000. The optimal arm has mean $\mu_t = 1$ and the sub-optimal arm has mean $T = 10,000$. The optimal arm has mean $\mu_1 = 1$ and the sub-optimal arm has mean $\mu_2 = 1 - \sqrt{\log T/T}$. So the sub-optimality gap is $\Delta_2 = \sqrt{\log T/T}$.
From the left panel, the Gaussian approximation of $\hat{\mu}_x$ (after

From the left panel, the Gaussian approximation of $\hat{\mu}_{a:T}$ (after normalization) appears quite accurate. From the right panel, coverage probabilities remain precise across various targeted nominal levels. These numerical findings are consistent for various choices of exploration rates γ_T 's and sub-optimality gaps Δ_2 's.

6. Proof preliminaries

We note that the allocation rule in Algorithm [1](#page-7-3) can be written as

which depends on the data and parameters only through the scaled $\mathcal{N}(0, 1)$ noises ξ_t and $(T, K, \Delta/\sigma, \gamma_T)$ due to location-scale invariance. Thus, $\mathbb{E} n_{\alpha,T}$ and $R(\Theta)/\sigma$ are functions of $(T, K, \Delta/\sigma, \gamma_T)$ only. Therefore, we may take $\mu_* = 0$ or $\sigma = 1$ without loss of generality throughout the proof.

We recall and define some further notation in the proofs below:

- Let $n_* \equiv n_*(\Theta)$ be defined as in [\(3.4\)](#page-7-4), and $n_{a,T}$ be defined as in [\(3.5\)](#page-7-7).
- Let $\mathcal{A}_0 \equiv \{a \in [K] : \Delta_a = 0\}$ collect all optimal arms.
- Let $\mathcal{A}_+ \equiv \{a \in [K] : \Delta_a > 0\}$ collect all sub-optimal arms.

6.1. Time continuity of noiseless UCB. The continuous-time, noiseless UCB and sample size growth curves in [\(2.3\)](#page-6-1) for UCB1 are given by

$$
\mu_{+,t}^* = \mu_a + \sigma \gamma_T / (n_{a;t}^*)^{1/2}, \quad \sum_{a \in [K]} n_{a;t}^* = t. \tag{6.1}

\text{Reg}_t^*(\Theta) \equiv \sum_{a \in [K]} \Delta_a n_{a;t}^*.

Let *H_x* be the distribution putting mass $(1/\sqrt{h(x)} + y_a)^{-2}n_*/(xT)$ at $y_a = n^{1/2} \Lambda / (\sqrt{g(x)})$ for all $a \in [K]$. By (6.0) *y_a* = $n_*^{1/2} \Delta_a / (\sigma \gamma_T)$ for all $a \in [K]$. By [\(6.9\)](#page-17-6),

$$
\frac{xh'(x)}{h^{3/2}(x)} \int \frac{1}{1/\sqrt{h(x)} + y} H_x(\mathrm{d}y) = 1. \tag{6.12}
$$

 $h^{3/2}(x) \int 1/\sqrt{h(x)} + y$
To study the regret growth curve, let $f(x) = \text{Reg}_{xT}^*(\Theta)/\text{Reg}_T^*(\Theta)$. By [\(6.2\)](#page-16-2) and [\(6.4\)](#page-16-3), we have $\text{Reg}_{xT}^*(\Theta) = (\sigma \gamma_T n_*^{1/2}) \sum_{a \in [K]} y_a (1/n_a)$ $\frac{1}{\chi}$ $\overline{h(x)} + y_a$ ⁻², so

f(x) = \frac{\sum_{a \in [K]} y_a/(1/\sqrt{h(x)} + y_a)^2}{\sum_{a \in [K]} y_a/(1 + y_a)^2}

$$
\stackrel{(*)}{=} \frac{\int y(1/\sqrt{h(x)} + y)^{-1} H_x(\mathrm{d}y)}{x \int y H_x(\mathrm{d}y) \int (1/\sqrt{h(x)} + y)^{-1} H_x(\mathrm{d}y)} \stackrel{(**)}{\leq} 1/x.
$$

Here in (*) we used [\(6.12\)](#page-18-0), and in (**) we used Chebyshev's correlation inequality, cf. [\[BLM13,](#page-34-15) Theorem 2.14]. Thus, as $f(1) = 1$, $\log f(x) \le \log x$ for $x > 1$ and $\log f(x) > \log x$ for $x \in (0, 1]$. This vields (6.8). $\log f(x) \geq \log x$ for $x \in (0, 1]$. This yields [\(6.8\)](#page-17-5).

We note that ${W_a}_{a \in [K]}$ are i.i.d. 1-Lipschitz functions of standard Gaussian variables $\{\xi_{a;[T]}\}_{a \in [K]}$ with $W_a \approx \sqrt{2 \log \log T}$ by the law of the iterated logarithm.

Let us define the events:

- For $t > 0$, $E_-(t, \gamma_T) \equiv \left\{ \sum_{a \in [K]} n_{a;t}^*(1 + W_a/\gamma_T)^2 + K < T \right\}$.

Clearly $t \mapsto E_+(t, \gamma_T)$ is non-decreasing and $t \mapsto E_-(t, \gamma_T)$ is non-increasing.

Because the left-hand side is positive on $E_0(\gamma_T)$, and $n_{b;T_a-1} \leq n_{b;T}$, $n_{a;T_a-1} =$ $n_{a;T} - 1$ hold, there exists certain positive $\overline{\mu}_+$ such that for all $(a, b) \in [K]^2$,

On the event $E_0(\gamma_T) \cap E_-(T_-, \gamma_T)$, the second inequality of [\(6.16\)](#page-19-0) implies $\hat{t} \geq T_-\$, so that the first inequality (6.15) implies the claim in (3). the first inequality (6.15) implies the claim in (3) .

6.3. Some probabilistic results. We first give two simple results.

Lemma 6.3. *There exists some universal constant C* > ⁰ *such that if* $\sqrt{\log \log T}/\gamma_T \leq 1/C$,

\mathbb{P}\bigg(\sum_{a\in[K]}\omega_a n^*_{a;T_+}(1-W_a/\gamma_T)^2_{+}\leq \bigg\{\sum_{a\in[K]}\omega_a n^*_{a;T}+\delta\bigg\}_+\bigg)\leq \exp\bigg(-\frac{C_0^2}{2}\frac{\langle \omega, n^*_{\cdot;T_+}\rangle\gamma_T^2\eta^2}{\|\omega\circ n^*_{\cdot;T_+}\|_{\infty}}\bigg).
$$

(2) *Let* $T_$ > 0, $\delta \in \mathbb{R}$ *be such that* $\left(\sum_{a \in [K]} \omega_a n_a^* \right)$ *a*;*T*− / $\left(\sum_{a\in[K]} \omega_a n_a^*\right)$ $\int_{a,T}^{*} - \delta$)₊ ≤ 1/(1+ ²*C*0η) 2 *. Then*

\mathbb{P}\bigg(\sum_{a\in[K]}\omega_a n^*_{a;T_-}(1+W_a/\gamma_T)^2_{+}\geq \bigg\{\sum_{a\in[K]}\omega_a n^*_{a;T}-\delta\bigg\}_+\bigg)\leq \exp\bigg(-\frac{C_0^2}{2}\frac{\langle \omega, n^*_{\cdot;T_-}\rangle\gamma_T^2\eta^2}{\|\omega\circ n^*_{\cdot;T_-}\|_{\infty}}\bigg).
$$

Proof. We need a few more notation in the proof:

- $\hat{T}_{\omega;\pm} \equiv \sum_{a \in [K]} \omega_a n_a^*$
• $T = \sum_{p} \cos(\omega_a n_p^*)$ $\int_{a;T_{\pm}}^{a} (1 \mp W_a/\gamma_T)^2_{+}.$
- $T_{\omega;\pm} \equiv \sum_{a \in [K]} \omega_a n_a^*$ $\sum_{a:T_{\pm}}^{\infty}$, $T_{\omega} \equiv \sum_{a \in [K]} \omega_a n_a^*$ *a*;*T* .

Here for two vectors *a*, *b*, we write $a \circ b \equiv (a_i b_i)$. To prove [\(6.17\)](#page-20-0), first note that $W_a = W_a(\xi_{a;[T]})$ so we may identify W_a as a map $\mathbb{R}^{[T]} \to \mathbb{R}$, and with this identifi-
cation, it is easy to verify $||W||_V \le 1$. Consequently, for any $u, v \in \mathbb{R}^{[K] \times [T]}$ cation, it is easy to verify $||W_a||_{\text{Lip}} \leq 1$. Consequently, for any $u, v \in \mathbb{R}^{\lfloor K \rfloor \times \lfloor T \rfloor}$,

$$

$$
\le ||\omega \circ n_{;T_\pm}^*||_{\infty}^{1/2} \gamma_T^{-1} \cdot ||u - v||,
$$

proving the claim [\(6.17\)](#page-20-0).

Using Gaussian-Poincaré inequality, we have

|\mathbb{E}\,\hat{T}_{\omega;\pm}-(\mathbb{E}\,\hat{T}_{\omega;\pm}^{1/2})^2|\leq T_{\omega;\pm}\gamma_T^{-2}.

\mathbb{P}(\hat{T}_{\omega;+}^{1/2} \leq (T_{\omega} + \delta)^{1/2}) \leq \mathbb{P}(\hat{T}_{\omega;+}^{1/2} - \mathbb{E} \,\hat{T}_{\omega;+}^{1/2} \leq (T_{\omega} + \delta)^{1/2} - T_{\omega;+}^{1/2} \cdot (1 - C_0 \eta_T)_+)
$$
\n
$$
\leq \exp\left(-C_0^2 T_{\omega;+} \eta^2 / (2\sigma_{\omega;+}^2)\right) \leq \exp\left(-\frac{C_0^2}{2} \frac{T_{\omega;+} \gamma_T^2 \eta^2}{\|\omega \circ n_{\cdot;T_+}^*\|_{\infty}}\right).
$$

For the other direction, by choosing $\eta \ge \eta_T$ and $T_{\omega,-}$ such that $(T_{\omega} - \delta)^{1/2} \ge T^{1/2} (1+2C)^{1/2}$ $T^{1/2}_{\omega;-}(1+2C_0\eta),$

\mathbb{P}(\hat{T}_{\omega;-}^{1/2} \geq (T_{\omega} - \delta)^{1/2}) \leq \mathbb{P}(\hat{T}_{\omega;-}^{1/2} - \mathbb{E} \,\hat{T}_{\omega;-}^{1/2} \geq (T_{\omega} - \delta)^{1/2} - T_{\omega;-}^{1/2} \cdot (1 + C_0 \eta_T))
$$

$$
\leq \exp\left(-C_0^2 T_{\omega;-} \eta^2 / (2\sigma_{\omega;-}^2)\right) \leq \exp\left(-\frac{C_0^2}{2} \frac{T_{\omega;-} \gamma_T^2 \eta^2}{\|\omega \circ n_{\cdot;T-}^*\|_{\infty}}\right).
$$

The proof is complete. □

As a direct application of the proceeding concentration result, we have:

Proof. As $T_+/T = 1 + 20C_0\varepsilon_T \ge 1/(1 - 2C_0\varepsilon_T)^2$, using Lemma [6.5-](#page-20-1)(1) with $\omega = 1 \times \delta = 0$ and $n = \varepsilon_T$ $\omega \equiv \mathbf{1}_K$, $\delta \equiv 0$ and $\eta \equiv \varepsilon_T$,

\mathbb{P}\left(E_{+}^{c}(T_{+},\gamma_{T})\right) \leq \mathbb{P}\left(\sum_{a\in[K]}n_{a;T_{+}}^{*}(1-W_{a}/\gamma_{T})_{+}^{2} \leq T\right) \leq \exp\left(-\frac{C_{0}^{2}}{2}\frac{T_{+}\log\gamma_{T}}{n_{*,T_{+}}}\right).
$$

The claim for $\mathbb{P}(E_{-}^{c}(T_{-}, \gamma_{T}))$ holds similarly, where we take $\omega = \mathbf{1}_{K}$, $\delta = K$ and $\eta = \epsilon_{T}$ therein, and verify that $T/(T_{-}K) < (1-20C_0\epsilon_{T})/(1-\epsilon_{T}) < 1/(1+2C_0\epsilon_{T})^2$ ε_T therein, and verify that $T_-/(T-K) \le (1-20C_0\varepsilon_T)/(1-\varepsilon_T) \le 1/(1+2C_0\varepsilon_T)^2$. □

7. Proofs for Section [3](#page-7-0)

7.1. In-probability controls: Proofs of Proposition [3.7](#page-11-1) and Theorem [3.6.](#page-10-3)

Proof of Proposition [3.7.](#page-11-1) Fix some large universal constant $C_0 > 2$ and let $\varepsilon_T \equiv$ $\max\{(\sqrt{\log \gamma_T} + \sqrt{\log \log T})/\gamma_T, K/T\} \le 1/C_0^3$. Let $T_{\pm} \equiv (1 \pm C_0 \epsilon_T) + T$. Consider the event $F(\gamma) = 0$, $F^c(T, \gamma_T) \cap F_0(\gamma_T) \cap W < \gamma$ where $\gamma > 1$. Then I emma the event $E_a(\gamma) \equiv \bigcap_{\beta \in \pm} E_{\gamma}^c(T_{\pm}, \gamma_T) \cap E_0(\gamma_T) \cap \{W_a \leq \gamma\}$, where $\gamma \geq 1$. Then Lemma 6.4. Corollary 6.6 and I emma A 1 yield that [6.4,](#page-20-2) Corollary [6.6](#page-21-1) and Lemma [A.1](#page-32-1) yield that

Consequently, for err_△(Θ) \leq 1/(2 C_0), using the alternative estimate min_{*a*∈[*K*] $n_{a:T}^* \geq \min\{T/K, \gamma_T^2/||\Delta||_\infty^2\}$, we have} $\sum_{a,T}^* \gtrsim \min\{T/K, \gamma_T^2/||\Delta||_{\infty}^2\}$, we have

We remark that the exact asymptotic expression of the boundary crossing probability in Lemma [A.1-](#page-32-1)(1) may be computed by the method of Wald's likelihood ratio, cf. [\[Sie85,](#page-36-11) [Sie86\]](#page-36-12). Non-asymptotic upper bounds for such boundary cross-ing probabilities can be also obtained through the same method; see [\[RZ24\]](#page-36-2) where it is proved $p_T(x) \leq \varphi(x) \{x(\log T + 2) + \sqrt{2/\pi} + 4/x\}$. By writing $\eta^{-1} = 1 - \varepsilon$ for some $\varepsilon \in (0, 10^{-1})$, the right hand side of the above display can be further bounded by an absolute constant multiple of log T. above display can be further bounded by an absolute constant multiple of log *T* · $e^{-1}x^{-1}e^{-(1-\varepsilon)x^2/2}$, and therefore
