# <span id="page-0-1"></span>SemTalk: Holistic Co-speech Motion Generation with Frame-level Semantic Emphasis

#### <span id="page-0-0"></span>Abstract

*A good co-speech motion generation cannot be achieved without a careful integration of common rhythmic motion and rare yet essential semantic motion. In this work, we propose SemTalk for holistic co-speech motion generation with frame-level semantic emphasis. Our key insight is to separately learn general motions and sparse motions, and then adaptively fuse them. In particular, rhythmic consistency learning is explored to establish rhythm-related base motion, ensuring a coherent foundation that synchronizes gestures with the speech rhythm. Subsequently, semantic emphasis learning is designed to generate semantic-aware sparse motion, focusing on frame-level semantic cues. Finally, to integrate sparse motion into the base motion and generate semantic-emphasized co-speech gestures, we further leverage a learned semantic score for adaptive synthesis. Qualitative and quantitative comparisons on two pub-* *lic datasets demonstrate that our method outperforms the state-of-the-art, delivering high-quality co-speech motion with enhanced semantic richness over a stable base motion.*

## 1. Introduction

Nonverbal communication, including body language, hand gestures, and facial expressions, is integral to human interactions. It enriches conversations with contextual cues and enhances understanding among participants [\[6,](#page-8-0) [13,](#page-8-1) [19,](#page-8-2) [23\]](#page-9-1). This aspect is particularly significant in holistic co-speech motion generation, where the challenge lies in synthesizing gestures that align with speech rhythm while also capturing the infrequent yet critical semantic gestures that convey specific ideas [\[24,](#page-9-2) [37\]](#page-9-3).

Most existing methods [\[16,](#page-8-3) [29,](#page-9-4) [47\]](#page-10-0) rely heavily on rhythm-related audio features as conditions for gesture generation. While these rhythm-based features successfully align gestures with the timing of speech, they often over-

<span id="page-1-0"></span>shadow the sparse yet expressive semantic motion (see Fig. [1\)](#page-0-0). As a result, the generated motions may lack the contextual depth necessary and nuanced expressiveness for natural interaction. Some methods try to address this by incorporating semantic information like emotion, style, and content[\[9,](#page-8-4) [11,](#page-8-5) [22,](#page-9-5) [31\]](#page-9-6). However, rhythm features tend to dominate, making it difficult to capture sparse, semantically relevant gestures at the frame level. These rare but impactful gestures are often diluted or overlooked, highlighting the challenge of balancing rhythmic alignment with semantic expressiveness in co-speech motion generation.

In real-world human conversations, we have an observation that while most speech-related gestures are indeed rhythm-related, only a limited number of frames involve semantically emphasized gestures. This insight suggests that co-speech gestures can be decomposed into two distinct components: (i) General rhythm-related motions. These provide a continuous, coherent base motion aligned with the speech rhythm, reflecting the natural timing of speaking. *(ii)* Sparse semantic-aware motions: These occur infrequently but are essential for conveying specific meanings or emphasizing key points within the conversation.

Inspired by this observation, we propose a new framework SemTalk. SemTalk models the base motion and the sparse motion separately and then fuse them adaptively to generate high-fidelity co-speech motion. Specifically, we first focus on capturing the foundational patterns of speech by introducing *rhythmic consistency learning*. This method aligns the generated motions with rhythm by a fine-grained refinement and local-global consistency learning. For finegrained refinement, we incorporate a *coarse2fine crossattention module*, which progressively refines the base motion cues in a coarse-to-fine manner, starting from the face and moving through the hands, upper body, and lower body. This approach ensures consistent rhythmic transmission across all body parts, enhancing coherence and rhythmic base motion. For local-global consistency learning, locally, we use a frame-level consistency loss that encourages each frame to synchronize with the corresponding speech features, ensuring precise temporal alignment. Globally, we employ a sequence-level consistency loss that maintains the overall rhythmic flow across the entire motion sequence.

Furthermore, we introduce *semantic emphasis learning*, which focuses on generating sparse yet meaningful semantic motion. This approach utilizes frame-level semantic cues from textual information, high-level speech features, and emotion labels to identify frames that require emphasis. A gating mechanism is then employed to adaptively activate semantic motions at key frames, allowing the model to produce gestures that not only align with the rhythm but also enhance the motion with deeper semantic meaning and contextual relevance. Finally, the learned base motion and sparse motion are integrated through a dynamically learned

semantic score, which selectively amplifies expressiveness by incorporating semantic gestures into the rhythm-aligned base motion. This adaptive approach enables the model to capture the full spectrum of human expressiveness, generating motions that are semantically aligned with the speech. Our contributions are summarized below:

- We propose SemTalk, a novel framework for holistic cospeech motion generation that separately models general rhythm-related base motion and semantic-aware sparse motion, adaptively integrating them based on a learned semantic score.
- We introduce *rhythmic consistency learning* to incorporate latent face and latent hands features with rhythmrelated priors, ensuring coherent and rhythm-related base motion. We then propose *semantic emphasis learning* to synthesize semantic gestures at certain frames, enhancing expressive semantic-aware sparse motion.
- Experimental results show that our model surpasses state-of-the-art methods qualitatively and quantitatively, achieving higher motion quality and richer semantics.

## 2. Related Work

Co-speech Gesture Generation. Co-speech gesture generation focuses on creating gestures that naturally align with speech to enhance communication. Early rule-based methods [\[7,](#page-8-6) [18,](#page-8-7) [20,](#page-8-8) [21,](#page-8-9) [40\]](#page-9-7) lacked the ability to capture the variability of human motion. Deterministic models [\[5,](#page-8-10) [7,](#page-8-6) [35,](#page-9-8) [45,](#page-10-1) [48\]](#page-10-2) attempted direct mappings from speech to gestures. Probabilistic models like GANs [\[1,](#page-8-11) [16,](#page-8-3) [39\]](#page-9-9) and diffusion models [\[2,](#page-8-12) [9,](#page-8-4) [46,](#page-10-3) [52\]](#page-10-4) introduced variability. Some approaches incorporated semantic information. HA2G [\[31\]](#page-9-6) and SEEG [\[27\]](#page-9-10) used hierarchical networks and alignment techniques. LivelySpeaker [\[51\]](#page-10-5) focuses on generating cospeech gestures by conditioning on both rhythmic features and semantic information. However, it lacked adaptability for integrating semantic gestures with the speech rhythm. DisCo [\[28\]](#page-9-11) also addresses gesture diversity by disentangling content and rhythm, and balancing data distributions for more diverse motions, but it does not explicitly model sparse semantic gestures or dynamically integrate them with the rhythmic base motion. In contrast, SemTalk introduces a novel framework that separately models rhythm-related base motions and generates sparse semantic gestures. To ensure two components are seamlessly integrated, we dynamically combine base motion and sparse motion based on a learned semantic score.

Holistic Co-speech Motion Generation. Generating synchronized, expressive full-body motion in response to speech remains challenging, especially in coordinating the face, hands, and torso [\[8,](#page-8-13) [30,](#page-9-0) [33,](#page-9-12) [36,](#page-9-13) [47\]](#page-10-0). Previous methods gave way to generative models that enhance synchronization across regions. Habibie et al. [\[16\]](#page-8-3) introduced a CNN-based approach for face and body genera<span id="page-2-2"></span>tion, though it often led to uncoordinated gestures. Talk-SHOW [\[47\]](#page-10-0) improved synchronization with VQ-VAE [\[41\]](#page-9-14) cross-conditioning but handled facial expressions separately, causing fragmented outputs. DiffSHEG [\[8\]](#page-8-13) and EMAGE [\[30\]](#page-9-0) partially address this by using separate encoders for expressions and gestures, though unidirectional flow restricts expressive coherence, and ProbTalk [\[32\]](#page-9-15) leverages PQ-VAE [\[42\]](#page-9-16) for better body-facial synchronization. These methods, however, primarily rely on audiorelated rhythmic cues, risking the loss of nuanced semantic gestures. Inspired by TM2D [\[14\]](#page-8-14), which decomposes dance motion into music-related and text-aware components, we decompose co-speech motion into rhythm-related and sparse semantic motions, learning each independently. This separation enables us to better capture both the rhythmic flow and the expressive nuances of the motion.

# 3. Method

#### 3.1. Preliminary on RVQ-VAE

Following [\[4,](#page-8-15) [15,](#page-8-16) [50\]](#page-10-6), our approach uses a residual vectorquantized autoencoder (RVQ-VAE) to precisely capture complex body movements in a latent space. Unlike standard VQ-VAE [\[41\]](#page-9-14), which has a single quantized latent space, RVQ-VAE decomposes motion into multiple quantization levels, capturing both coarse and fine details. To retain unique motion characteristics across body regions, we segment the body into four parts—face, upper body, hands, and lower body—each with a dedicated RVQ-VAE, following [\[3,](#page-8-17) [30\]](#page-9-0). This segmentation preserves each part's dynamics and prevents feature entanglement. Each part's motion sequence, denoted  $M = m_{1:N} \in \mathbb{R}^{N \times D}$ , is mapped to a latent sequence  $z_{1:n} \in \mathbb{R}^{n \times d}$  via a 1D convolutional encoder with downsampling factor  $n/N$ . This latent sequence undergoes a series of quantization steps  $Q_1, Q_2, \ldots, Q_V$ to progressively capture fine details. Each quantization layer assigns the latent vector to the nearest codebook entry, recording residuals at each step. This cumulative encoding yields a refined latent representation  $\hat{z}$ , and the decoding mirrors the encoding, with distinct decoders for each region.

### 3.2. Overview

As shown in Figure [2,](#page-2-0) our SemTalk pipeline includes two main components: the Base Motion Blocks  $f_r(\cdot)$  and the Sparse Motion Blocks  $f_s(\cdot)$ . Given rhythmic features  $\gamma_b$ ,  $\gamma_h$ , a seed pose  $\tilde{m}$ , and a speaker ID *id*, the Base Motion Blocks generate rhythm-aligned codes  $q<sup>r</sup>$ , forming the rhythmic foundation of the base motion:

$$
f_r: (\gamma_b, \gamma_h, \tilde{m}, id; \theta_{f_r}) \to q^r, \tag{1}
$$

where  $\theta_{f_r}$  denotes the learnable parameters of the Base Motion Blocks. The Sparse Motion Blocks then take semantic

features  $\phi_l$ ,  $\phi_g$ ,  $\phi_e$ , along with  $\gamma_h$ ,  $\tilde{m}$  and *id*, to produce frame-level semantic codes  $q^s$  and semantic score  $\psi$ .  $\psi$ then triggers these codes only for semantically significant frames, producing a sparse motion representation:

$$
f_s: (\phi_l, \phi_g, \phi_e, \tilde{m}, id; \theta_{f_s}) \to (q^s, \psi), \tag{2}
$$

where  $\theta_{f_s}$  represents the Sparse Motion Block parameters. Finally, the semantic emphasis mechanism  $\mathcal E$  combines  $q^r$ and  $q^s$ , guided by  $\psi$ , to form the final motion codes  $q^m$ :

$$
q^m = \mathcal{E}(q^r, q^s; \psi). \tag{3}
$$

The motion decoder then uses  $q^m$  to generate the output  $m'$ , enriched with rhythm alignment and semantic emphasis.

#### <span id="page-2-1"></span>3.3. Generating Rhythm-related Base Motion

The Base Motion Generation (Fig. [3](#page-3-0) a) in SemTalk establishes a rhythmically aligned foundation for co-speech gesture generation by leveraging both rhythmic and speakerspecific features, enhancing the naturalness and personalization of generated gestures.

Rhythmic Speech Encoding. To synchronize motion with speech, SemTalk incorporates rhythmic features: beats  $\gamma_b$ and HuBERT features  $\gamma_h$ .  $\gamma_b$ , derived from amplitude,

short-time energy [\[10\]](#page-8-18), and onset detection, mark key rhythmic points for aligning gestures with speech. Meanwhile,  $\gamma_h$ , extracted by the HuBERT encoder [\[17\]](#page-8-19), captures highlevel audio traits such as phonetic structure and speaker nuances, adding details to the gestures. In addition to rhythmic features  $\gamma$ , SemTalk uses a seed pose  $\tilde{m}$  and speaker identity  $id$  to generate a personalized, rhythm-aligned latent pose  $p$ . Then MLP-based Face Enhancement and Body Part-Aware modules utilize  $\gamma$ , p and id to obtain latent face  $f_e$ , hands  $f_h$ , upper body  $f_u$  and lower body  $f_l$ .

Rhythmic Consistency Learning. To enforce a rhythmically coherent base motion, we introduce *rhythmic consistency learning*, which includes a fine-grained refinement and local-global consistency learning designed to align generated gestures with the speech. To refine base motion, we first proposed a transformer-based *Coarse2Fine Cross-Attn Module* utilize  $\gamma$ , p and *id* to obtain latent base motion  $f_b$ . The refinement begins with  $\gamma$  for  $f_e$ , which guides the rhythmic representation for  $f_h$ , followed by conditioning  $f_u$  and finally influencing  $f_l$ . This progression from face to hands, upper body, and lower body enables the model to create synchronized motions that align naturally with spoken content. An MLP layer then generates codes that synchronize different body regions with the rhythm, producing distinct codes for the face  $q_f^r$ , hands  $q_h^r$ , upper body  $q_u^r$ , and lower body  $q_l^r$ , ensuring temporal coherence across all parts.

Inspired by CoG's use of InfoNCE loss [\[44\]](#page-10-7) to synchronize facial expressions with audio cues, our approach adopts a similar philosophy of aligning motion and speech. However, we differ fundamentally by incorporating separate local and global rhythmic consistency losses, which are applied to both latent face  $f_e$  and latent hands  $f_h$ , ensuring a more cohesive and synchronized representation across the entire motion sequence. InfoNCE loss maximizes mutual information and ensures temporal alignment by contrasting frame-level or sentence-level features across modalities, synchronizing rhythm. By leveraging HuBERT features  $\gamma_h$ instead of basic beat features  $\gamma_b$ , which only capture rhythmic pauses, we incorporate rich, high-level audio representations that enhance the model's ability to capture rhythmrelated motion patterns and maintain temporal coherence.

This rhythmic consistency loss ensures that the motions are not only synchronized at the frame level but also maintain a consistent rhythmic flow across the entire sequence. It can be defined as:

$$
\mathcal{L}_{\text{Rhy}} = -\frac{1}{N} \sum_{i=1}^{N} \log \frac{\exp\left(\sin\left(h\left(f_{i}\right), \gamma_{h}^{i}\right) / \tau\right)}{\sum_{j=1}^{N} \exp\left(\sin\left(h\left(f_{i}\right), \gamma_{h}^{j}\right) / \tau\right)},\tag{4}
$$

where N denotes the number of frames(or the batch size),  $\tau$ denotes the temperature hyperparameter,  $h(\cdot)$  is the projection head for latent motion,  $f_i$  and  $\gamma_h^i$  are the latent motion and rhythmic features at frame (or sample) i, and  $\text{sim}(\cdot)$ represents cosine similarity.

The local frame-level consistency loss  $\mathcal{L}_{\text{Rhy}}^{(L)}$  aligns the motion features of each frame with the corresponding rhythmic cues. This local loss encourages each frame's gestures and facial movements to align with subtle rhythmic variations, embedding rhythm within each temporal segment.

To ensure rhythmic coherence at a broader level, we incorporate a global sample-level consistency loss  $\mathcal{L}_{\text{Rhy}}^{(G)}$ . Unlike local loss,  $\mathcal{L}_\text{Rhy}^{(G)}$  reinforces rhythm consistency throughout the sequence, ensuring that the generated motion main-

<span id="page-4-0"></span>tains a smooth, rhythm-aligned motion flow throughout its duration. By jointly minimizing  $\mathcal{L}_{\text{Rhy}}^{(L)}$  and  $\mathcal{L}_{\text{Rhy}}^{(G)}$ , *rhythmic consistency learning* enables SemTalk to produce base motions that are rhythmically aligned and temporally cohesive, forming a solid foundation upon which further semantic gesture refinement can be applied.

#### 3.4. Generating Semantic-aware Sparse Motion

The Sparse Motion Generation (Fig. [3](#page-3-0) b) in SemTalk adds expressive, context-specific gestures to the rhythm-aligned base motion by incorporating sparse but meaningful semantic cues drawn from speech content and emotional tone. By separating rhythm and semantics, this stage enhances gesture generation with contextually nuanced movements, focusing on moments of high semantic relevance.

Semantic Speech Encoding. To capture the breadth of semantic cues in speech, *Semantic Emphasis Learning* combines three types of information: frame-level text embeddings  $\phi_l$ , sentence-level features  $\phi_g$  from the CLIP model [\[38\]](#page-9-17), and emotion features  $\phi_e$  from the emotion2vec model [\[34\]](#page-9-18). Together, these features form a comprehensive semantic representation  $f_t$  that reflects both the content and emotional undertones of speech, enabling SemTalk to activate motions that are sensitive to nuanced semantic cues.

Semantic Emphasis Learning. *Semantic Emphasis Learning* in SemTalk is designed to capture sparse, semantically rich gestures that enhance motion by focusing on frames of high contextual relevance. Learning semantic-aware motion separately from rhythm-based gestures enables SemTalk to highlight meaningful frames that enrich gesture expressiveness without disrupting the underlying base motion.

The process begins by generating fused semantic features  $f_t$ , combining local and global cues from text, speech, and emotion embeddings to help identify frames needing semantic emphasis. Using  $f_t$ , SemTalk computes a semantic score  $\psi$ , which highlights frames with high semantic value, while reducing attention to rhythm-only frames.  $\psi$ , informed by broader context, filters back semantic features  $f_t$  to activate frames with significant relevance, ensuring that the model emphasizes frames aligned with specific communicative intentions. Supervision of  $\psi$  through a classification loss  $\mathcal{L}_{cls}^G$  based on semantic labels further refines the model's ability to identify key frames. To propagate semantic emphasis cohesively across different body regions, we use *Coarse2Fine Cross-Attention Module* sim-ilar to Sec. [3.3](#page-2-1) to get sparse semantic motion  $f_s$ . In this stage, the emphasis in Sparse Motion Generation is placed on body motion, as these are more critical for conveying semantic meaning in co-speech interactions.

Once  $\psi$  is established, it modulates the integration of rhythm-aligned base motion  $f_b$  and sparse semantic motion  $f_s$ . Through alpha-blending, frames with high semantic relevance draw more from  $f_s$ , while others rely on  $f_b$ . The

final motion codes  $q^s$  are computed as:

$$
q^s = MLP(\psi f_s + (1 - \psi)f_b), \tag{5}
$$

To foster diverse motion generation, SemTalk includes a code classification loss  $\mathcal{L}_{cls}$  and a reconstruction loss  $\mathcal{L}_{rec}$ . These losses are specifically focused on frames with high semantic scores, guiding the model to prioritize the generation of sparse, meaningful gestures.

#### 3.5. Semantic Score-based motion fusion

The Adaptive Fusion stage (Fig. [3](#page-3-0) c) in SemTalk seamlessly integrates sparse semantic-aware motion into the rhythmicrelated base motion. By strategically enhancing frames based on their semantic importance, it maintains a smooth and natural motion flow across sequences. For each frame i, the semantic score  $\psi_i$  computed during the Sparse Motion Generation stage is compared to a threshold  $\beta$ . If  $\psi_i > \beta$ , the base motion's latent code  $q_i^r$  is replaced with the sparse semantic code  $q_i^s$ , effectively highlighting expressive gestures where they are most relevant; otherwise,  $q_i = q_i^r$ .

This selective replacement emphasizes semantically critical gestures while preserving the natural rhythmic base motion. By blending  $q^r$  and  $q^s$  based on semantic scores, SemTalk adapts to the expressive needs of the speech context while ensuring coherence. The result is a realistic motion sequence where important gestures stand out without disrupting the foundational rhythm. To ensure smooth transitions and consistency across all body parts, this frameby-frame replacement prevents abrupt shifts and effectively emphasizes the most expressive frames.

## 4. Experiments

#### 4.1. Experimental Setup

Datasets. For training and evaluation, we utilize two primary datasets: BEAT2 and SHOW. BEAT2, as introduced in EMAGE [\[30\]](#page-9-0), is an extension of the original BEAT dataset [\[29\]](#page-9-4), which includes 76 hours data featuring 30 speakers. BEAT2 standardizes the BEAT into a mesh representation with paired audio, text transcripts, and frame-level semantic labels. Following [\[30\]](#page-9-0), we focus on the BEAT2-standard subset, allocating data for 85%/7.5%/7.5% train/val/test. SHOW [\[47\]](#page-10-0) contains 26.9 hours of high-quality, in-the-wild talk show videos featuring 3D body meshes at 30fps. Due to the absence of framelevel semantic labels in the SHOW dataset, we adapt the Sem-gate module from SemTalk, pre-trained on the BEAT2 dataset, to generate these labels. Following [\[47\]](#page-10-0), we select video sequences longer than 10 seconds and divide the dataset into 80%/10%/10% train/val/test split.

Implementation Details. Our model is trained on a single NVIDIA A100 GPU. For both datasets, training runs for 200 epochs with a batch size of 64. We use the RVQ-VAE

architecture [\[41\]](#page-9-14) as the auto-encoder, with ResNet blocks in both encoder and decoder, downscaling by a factor of 4. The residual quantization employs 6 layers with a code dimension and codebook size of 256, and a dropout rate of 0.2, we predict the remaining five codes through five transformer layers from the first layer's output. In *Base Motion Learning*, the temperature  $\tau$  is set to 0.1. In *Sparse Motion Learning*,  $\beta$  is set to 0.5. The training uses the ADAM optimizer with a learning rate of 1e-4. Inspired by [\[30\]](#page-9-0), we first train with a four-frame seed pose, then gradually increase the masked joints and frames ratio from 0 to 40% over the initial 120 epochs, fixing it afterward.

Metrics. We evaluate the generated body gestures using the FGD metric [\[49\]](#page-10-8) to assess the distributional alignment between generated and GT, reflecting gesture realism. DIV [\[25\]](#page-9-19) is measured by the average L1 distance across multiple gesture clips, indicating the range of gesture variation. To assess speech-motion synchrony, we employ BC [\[26\]](#page-9-20), which measures the temporal alignment between gesture

rhythm and audio beats. For facial expressions, we utilize two reconstruction metrics: vertex MSE [\[46\]](#page-10-3) to quantify positional differences, and vertex L1 difference LVD [\[47\]](#page-10-0) to gauge discrepancies between GT and generated facial vertices. Given the lack of explicit semantic consistency labels, we further conduct a comprehensive user study. We excluded ProbTalk [\[32\]](#page-9-15) from our comparison because we were unable to obtain correct results during retraining using the publicly available code.

## 4.2. Qualitative Results

Qualitative Comparisons. We strongly encourage readers to view our demo video for a clear understanding of SemTalk's qualitative performance. Overall, our method demonstrates superior alignment between speech and motion, generating more realistic, diverse, and semantically consistent motion than the baselines on both datasets. On the BEAT2 dataset (Fig. [4\)](#page-5-0), TalkSHOW, EMAGE, and Diff-SHEG all exhibit slight jitter effects. EMAGE displays

noticeable jitters mainly in the legs and shoulders, while TalkSHOW suffers from instability throughout the body. DiffSHEG, designed primarily to focus on the upper body without considering the lower body holistically, generates slow motions with visible inconsistencies, especially at the boundaries of speech clips. Regarding motion diversity, DiffSHEG generates a broader range of gestures than EMAGE and TalkSHOW; however, EMAGE maintains a higher degree of naturalness. SemTalk surpasses all baselines by achieving the highest levels of both diversity and realism. Compared to the SemTalk\* baseline, SemTalk generates gestures that are contextually appropriate, lively, and expressive. Although SemTalk\* ensures rhythmic consistency, it lacks strong semantic expressiveness. SemTalk, by contrast, emphasizes key phrases, such as raising both hands to highlight "dream job" or using a definitive pointing gesture for "that is why," thereby reinforcing the semantics. SemTalk\* lacks expressiveness, but can still generate a well-formed, general base motion that is rhythmically consistent. With the semantic emphasis on frame-level motion, our SemTalk finally generates motions that are both rhythmrelated and semantic-aware. This highlights the effectiveness of our *rhythmic consistency learning* and *semantic emphasis learning*.

In facial comparisons (Fig. [6\)](#page-6-0), EMAGE shows minimal lip movement, while both DiffSHEG and EMAGE reveal inconsistencies between lip motion and the rhythm of speech. In contrast, SemTalk produces smooth, natural transitions across syllables, resulting in realistic and expressive

lips, significantly surpassing the baselines.

On the SHOW dataset (Fig. [5\)](#page-6-1), SemTalk shows more agile gestures than TalkSHOW, EMAGE, and DiffSHEG, when applied to unseen data. Our method captures natural and contextually rich gestures, particularly in moments of emphasis such as "I like to do" and "relaxing," where our model produces lively hand and body movements that align with the speech content. Unlike baselines, which tend to generate repetitive or overly simplistic motions, SemTalk maintains a high degree of diversity and subtlety, producing gestures that vary naturally across different phrases.

Semantic Score. Fig. [7](#page-6-2) illustrates the relationship between semantic emphasis and gesture intensity, represented by variations in the semantic score. To model this correlation smoothly, we extracted actual semantic scores from selected key frames, capturing trends in gesture emphasis. Words with high semantic significance, such as "comes," "fantastic," and "captured," align with peaks in the semantic score, highlighting moments where the model emphasizes expressive gestures. These peaks indicate points in the audio that prompt the generation of more dynamic and engaging body movements, creating a closer alignment between gesture intensity and the expected meaning of the speaking.

User study. We conducted a user study using 10 video samples, recruiting 25 participants with varied backgrounds to assess several aspects of generated motion, including realism, semantic consistency, motion-speech synchronism, and diversity. The study required participants to rank shuf-

fled videos across different methods on these criteria. As shown in Fig. [8,](#page-7-0) our approach received dominant preferences across all metrics, particularly excelling in semantic consistency and motion diversity. This indicates that our model produces highly synchronized and contextually appropriate gestures that align well with the spoken content, outperforming baselines in delivering realistic and expressive motion that users find engaging and natural.

#### 4.3. Quantitative Results

Comparison with Baselines. As shown in Tab. [2,](#page-7-1) on the BEAT2 dataset, SemTalk achieves superior results in FGD, MSE, and LVD, showing improved distribution alignment and reduced motion errors compared to previous methods. To ensure a fair comparison, we add a lower-body VQ-VAE to TalkSHOW, DiffSHEG, and SemTalk, following [\[30\]](#page-9-0). Notably, our approach reduces FGD significantly, indicating robust distribution matching, particularly in generating expressive and context-aware gestures. While TalkSHOW and EMAGE achieve competitive diversity (DIV) scores, SemTalk maintains a balance between high semantic relevance and natural motion flow.

On the SHOW dataset, SemTalk excels with the lowest FGD, MSE, and the highest BC, indicating precise beat alignment with the audio and enhanced semantic consistency in generated motions. Although EMAGE exhibits high DIV, our model achieves comparable results while maintaining smooth, realistic motion free from jitter.

Ablation Study. We assess the impact of each component of our model on BEAT2 and present the results in Tab. [1,](#page-7-2) which reveals several key insights (more ablation results

- Rhythmic Consistency Learning (RC) is essential for achieving temporal coherence in motion sequences. By capturing and preserving consistent rhythmic patterns, RC enhances the natural flow of generated motions. This approach not only boosts performance on key metrics like FGD, LVD, and BC but also reduces the MSE, contributing to smoother and more realistic base motion.
- Semantic Emphasis Learning (SE) proves essential for selectively enhancing semantic-rich gestures. The inclusion of SE, as shown in rows with SE enabled, improves both diversity (DIV) and FGD, enabling the model to emphasize semantically relevant motions. SE demonstrates its effectiveness in focusing on frame-level semantic information, which contributes to the generation of lifelike gestures with enriched contextual meaning.
- Coarse2Fine Cross-Attention Module (C2F) effectively refines motion details, improving BC, FGD, and DIV. When combined with RVQ and RC, C2F achieves the best MSE and LVD, highlighting its role in enhancing gesture realism and diversity through fine-tuning from coarse to refined levels.
- RVQ-VAE (RVQ) enhances the diversity and realism of generated motion. Though it slightly increases MSE and LVD, it notably improves FGD, leading to more natural motion generation compared to standard VQ-VAE.

# 5. Conclusion

We propose SemTalk, a novel approach for holistic co-speech motion generation with frame-level semantic emphasis. Our method addresses the integration of sparse yet crucial semantically significant gestures into foundational rhythm-related motions, which has received less attention in previous works. We develop a framework that separately learns rhythm-related base motion through *rhythmic consistency learning* and semantic-aware semantic motion through *semantic emphasis learning*, and adaptively fuses them based on a learned semantic score. Our approach has demonstrated state-of-the-art performance on two public datasets quantitatively and qualitatively. The qualitative results and user study show that our method can generate high-quality co-speech motion sequences that enhance frame-level semantics over robust base motions, reflecting the full spectrum of human expressiveness.
