

# MVICAD<sup>2</sup>: Multi-View Independent Component Analysis with Delays and Dilations

## Abstract

Machine learning techniques in multi-view settings face significant challenges, particularly when integrating heterogeneous data, aligning feature spaces, and managing view-specific biases. These issues are prominent in neuroscience, where data from multiple subjects exposed to the same stimuli are analyzed to uncover brain activity dynamics. In magnetoencephalography (MEG), where signals are captured at the scalp level, estimating the brain’s underlying sources is crucial, especially in group studies where sources are assumed to be similar for all subjects. Common methods, such as Multi-View Independent Component Analysis (MVICA), assume identical sources across subjects, but this assumption is often too restrictive due to individual variability and age-related changes. Multi-View Independent Component Analysis with Delays (MVICAD) addresses this by allowing sources to differ up to a temporal delay. However, temporal dilation effects, particularly in auditory stimuli, are common in brain dynamics, making the estimation of time delays alone insufficient. To address this, we propose Multi-View Independent Component Analysis with Delays and Dilations (MVICAD<sup>2</sup>), which allows sources to differ across subjects in both temporal delays and dilations. We present a model with identifiable sources, derive an approximation of its likelihood in closed form, and use regularization and optimization techniques to enhance performance. Through simulations, we demonstrate that MVICAD<sup>2</sup> outperforms existing multi-view ICA methods. We further validate its effectiveness using the Cam-CAN dataset, and showing how delays and dilations are related to aging.

## Introduction and related works

### Introduction

Machine learning techniques often encounter challenges when dealing with multiple views of the same

underlying phenomenon. These challenges include integrating heterogeneous data, aligning different feature spaces, and managing view-specific biases while maintaining consistency across views [37, 31, 38]. This is particularly evident in fields like neuroscience, where data from diverse subjects exposed to the same stimuli are analyzed to unveil the intricacies of brain activity. In this context, a view corresponds to a subject. For instance, a technique like magnetoencephalography (MEG) provides non-invasive recordings of magnetic fields produced by neurons in the brain. Then, throughout MEG data analysis, signals captured at the scalp level can provide valuable insights into brain dynamics, by estimating sources of activity within the brain itself. To draw general conclusions about these sources, group studies with hundreds of participants have been conducted with the objective of uncovering common sources for all subjects [23, 5].

When dealing with only one view, a common approach to estimate sources starts with Principal Component Analysis (PCA) to reduce the dimensionality of the observed signals. Then, a single-view Independent Component Analysis (ICA) algorithm [10, 17, 16, 1] is applied to extract independent sources. Indeed, ICA relies on the assumption that components are independent and non-Gaussian, and it estimates the model’s latent sources by maximizing the independence of the components according to some criteria. However, the extension of ICA to a multi-view context is not straightforward.

State-of-the-art models in this domain such as Multi-View Independent Component Analysis (MVICA) [27] and GroupICA [7] assume that sources are shared and identical across views. However, this assumption of exact source similarity across subjects is restrictive and may not always hold true. Factors such as age or individual variability can lead to variations in the underlying sources, making them similar but not identical across different subjects [14, 28, 8, 12, 29, 13].

Heurtebise et al. [15] relaxed this assumption with Multi-View Independent Component Analysis with Delays (MVICAD) by allowing sources to differ with a temporal delay across subjects. However, biological studies have shown that temporal dilations, in addition to delays, are common characteristics of neural sources, in particular for auditory tasks [26, 36, 25, 2, 30].

Building upon MVICAD, we introduce the Multi-View Independent Component Analysis with Delays and Dilations (MVICAD<sup>2</sup>) algorithm. MVICAD<sup>2</sup> al-

lows sources to differ by a temporal delay *and a dilation* across views. This means that while all sources are shared across views, each source of each view may exhibit specific temporal variations, enhancing the model’s flexibility and accuracy.

In Section 1, we present our model, establish its identifiability, and derive an approximation of its likelihood which is cheap to compute. We estimate the parameters of the model by maximizing this approximate-likelihood. Section 2 focuses on regularization and optimization techniques used for this problem. Then, we evaluate our method using comprehensive simulations in Section 3. Synthetic experiments with varying hyperparameters, such as the number of subjects, sources, or the noise level, demonstrate the superior performance of our method compared to existing multi-view ICA algorithms. Finally, in Section 4, we evaluate MVICAD<sup>2</sup> on Cam-CAN, a large MEG population dataset [32]. Our results reveal that the delays and dilations of neural responses recovered by our model correlate with age, in accordance with previous findings in the neuroscience literature [26].

## Related works

Various ICA algorithms have been proposed to process data from multiple datasets at once. PermICA [27] is a naive approach to multi-view ICA. It was designed as an initialization step for MVICA. It consists in applying a single-view ICA algorithm, like FastICA [16], to each view separately and then to reorder sources with the Hungarian algorithm [21] such that they are in the same order for all views.

Group ICA encompasses a range of ICA algorithms designed to process multiple views of the same data. This approach typically begins with the application of Principal Component Analysis (PCA) to each view independently. Next, the resulting sets are combined into a single dataset through either concatenation or multi-set Canonical Correlation Analysis (CCA) [20, 11], possibly followed by an additional PCA step. An ICA algorithm is then applied to the consolidated set [35, 34]. Concatenation can be performed spatially or temporally: temporal concatenation yields individual sources with a common mixing matrix, while spatial concatenation produces common sources with individual mixing matrices. Given our focus on shared sources, we compare our method with Group ICA using spatial concatenation [7]. Note that Goup ICA has shown inferior performance to MVICA on various neuroimaging tasks [27].

MVICA [27] is our first reference algorithm. It is designed to identify shared independent components across multiple datasets. To do so, MVICA jointly estimates independent individual sources for each dataset and averages them to produce shared sources. During optimization, the distance between individual and shared sources is minimized, which ensures that all views share approximately the same sources. Unlike some other multi-view ICA approaches, MVICA’s likelihood can be written in closed form and is then

optimized with a quasi-Newton algorithm, using the gradient and an approximation of the Hessian of the likelihood.

MVICAD [15] is our second reference algorithm. As in [27], it uses a quasi-Newton algorithm to estimate shared independent components across multiple datasets, but it allows individual sources to be time-delayed. Optimization is done by alternating minimization with respect to delays and unmixing matrices (that will be defined later).

## 1 Method

**Notation** In the following sections, lowercase letters are used for scalar values, lowercase bold letters are for vectors, capital letters denote matrices, and capital bold letters are used for multivariate signals. A multivariate signal  $\mathbf{S} : \mathbb{R} \rightarrow \mathbb{R}^p$  can be evaluated at a time point  $t \in \mathbb{R}$ , as in  $\mathbf{S}(t) \in \mathbb{R}^p$ , or at different time points  $\mathbf{t} \in \mathbb{R}^p$  simultaneously, as in  $\mathbf{S}(\mathbf{t})$  with slight abuse of notation. Additionally, applying a scalar-valued function  $f$  to a matrix  $S \in \mathbb{R}^{p \times n}$  means applying it to all the entries of  $S$  and summing the results, as follows:  $f(S) = \sum_{j,k} f(S_{jk})$ . Similarly, applying  $f$  to a multivariate signal  $\mathbf{S}$  is defined by  $f(\mathbf{S}) = \sum_{j=1}^p \int_{t \in \mathbb{R}} f(\mathbf{S}_j(t)) dt$ , where  $\mathbf{S}_j$  is the  $j$ -th component of  $\mathbf{S}$ . The  $\ell_2$  norm of a vector  $\mathbf{s}$  is  $\|\mathbf{s}\|$  and  $\|S\|$  is the Frobenius norm of a matrix. The norm of a multivariate signal is  $\|\mathbf{S}\| = \left( \sum_{j=1}^p \|\mathbf{S}_j\|_{L^2}^2 \right)^{\frac{1}{2}}$ , where  $\|\cdot\|_{L^2}$  is the  $L^2$  norm. The set of integers  $\{1, \dots, m\}$  is denoted  $\llbracket m \rrbracket$ .

### 1.1 Model

We model the observed data  $\mathbf{X}^i(t) \in \mathbb{R}^p$  from view  $i \in \llbracket m \rrbracket$  as a linear combination of shared but temporally modified sources  $\mathbf{S}(t) \in \mathbb{R}^p$ , plus noise. Specifically, for each view  $i$ , we temporally modify the sources using delay parameters  $\boldsymbol{\tau}^i = (\tau_1^i, \dots, \tau_p^i)$  valued in  $[-\tau_{\max}, \tau_{\max}]$  and dilation parameters  $\boldsymbol{\rho}^i = (\rho_1^i, \dots, \rho_p^i)$  valued in  $[1/\rho_{\max}, \rho_{\max}]$ . These delays and dilations are applied using operators  $\mathcal{D}_{\boldsymbol{\tau}^i}^1$  and  $\mathcal{D}_{\boldsymbol{\rho}^i}^2$

$$\mathcal{D}_{\boldsymbol{\tau}^i}^1(\mathbf{S})(\mathbf{t}) = \mathbf{S}(\mathbf{t} - \boldsymbol{\tau}^i) \quad \text{and} \quad \mathcal{D}_{\boldsymbol{\rho}^i}^2(\mathbf{S})(\mathbf{t}) = \mathbf{S}(\boldsymbol{\rho}^i \odot \mathbf{t}) , \quad (1)$$

whose combination  $\overrightarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i} = \mathcal{D}_{\boldsymbol{\rho}^i}^2 \circ \mathcal{D}_{\boldsymbol{\tau}^i}^1$  yields the temporal modification operator

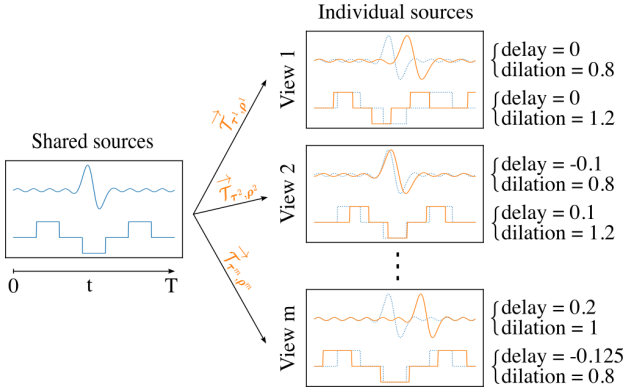


Figure 1: Illustration of delays and dilations of sources. There are 2 components. The multivariate signal on the left (in blue) represents the shared sources  $\mathbf{S} : [0, T] \rightarrow \mathbb{R}^2$ . Each individual source (in orange) is delayed and dilated, compared to its corresponding shared source.

$$\overrightarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{S})(\mathbf{t}) = \mathbf{S}(\boldsymbol{\rho}^i \odot (\mathbf{t} - \boldsymbol{\tau}^i)) \quad (2)$$

visualized in Figure 1. For later use, we also define the inverse operator

$$\overleftarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i} = \mathcal{D}_{-\boldsymbol{\tau}^i}^1 \circ \mathcal{D}_{1/\boldsymbol{\rho}^i}^2 . \quad (3)$$

Now, we formally model the observed data as,  $\forall i \in \llbracket m \rrbracket, \forall t \in \mathbb{R}$ ,

$$\mathbf{X}^i(t) = A^i(\overrightarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{S})(t) + \mathbf{N}^i(t)) , \quad (4)$$

where the  $A^i \in \mathbb{R}^{p \times p}$  are view-specific mixing matrices, assumed to be full-rank, and the  $\mathbf{N}^i = (\mathbf{N}^i(t))_{t \in \mathbb{R}}$ , where  $\mathbf{N}^i(t) \in \mathbb{R}^p$ , are stochastic processes representing view-specific noise. We assume that the  $\mathbf{N}^i$  are i.i.d. Gaussian distributed and independent across views with variance  $\sigma^2$ . In theory,  $\sigma > 0$  should be estimated, yet, as shown in [27] for MVICA it has no critical impact on results and can be safely set to 1. Last, we assume the sources  $\mathbf{S}$  have components that are independent and i.i.d. across time, i.e.  $\forall t_1, t_2 \in \mathbb{R}, t_1 \neq t_2, \mathbf{S}(t_1)$  and  $\mathbf{S}(t_2)$  are i.i.d.

In the context of MEG data, the data of subject  $i$  are usually reduced to only  $p$  components with PCA, resulting in a multivariate signal  $\mathbf{X}^i : [0, T] \rightarrow \mathbb{R}^p$ , where  $T$  represents the duration of the experiment. The hypothesis of shared sources up to time variability simply means that, after a common stimulus, brain activations from one subject to another have the same shape but differ up to delays and dilations. Moreover, matrices  $A^i \in \mathbb{R}^{p \times p}$  model the linear transformation between sources at the cortex level and observations at the scalp level.

## 1.2 Identifiability

A model is said to be identifiable when it is described by one set of parameters, at most. Mathematically, this can be formulated as the injectivity of a mapping from parameters (here, mixing matrices and time delays and dilations) to the probability model of the observations. Our model is identifiable, up to some indeterminacies, which makes recovering the sources a well-posed problem.

**Theorem 1** (Identifiability). *Let,  $\forall t \in \mathbb{R}, \mathbf{X}^i(t) = A^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S})(t) + \mathbf{N}^i(t))$  and  $\mathbf{X}^i(t) = A^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}')(t) + \mathbf{N}^i(t))$ . Let us assume that the components of  $\mathbf{S}$  are independent of each other, and so are the components of  $\mathbf{S}'$ . In addition, suppose that  $\mathbf{S}$  (resp.  $\mathbf{S}'$ ) is i.i.d. across time with density  $\mathbb{P}_{\mathbf{S}}$  (resp.*

$\mathbb{P}_{\mathbf{S}'}$ ), where  $\mathbb{P}_{\mathbf{S}}$  and  $\mathbb{P}_{\mathbf{S}'}$  are not reduced to point-like masses. We also assume that the  $\mathbf{N}^i$  are i.i.d. Gaussian distributed with variance  $\sigma^2$ , independent from one to another, and so are the  $\mathbf{N}^i$ . Moreover, let us assume that  $A^i$  and  $A^i$  are invertible. Finally, we assume that  $\rho^i, \rho^i \in ]0, +\infty[^p$ . Then, the parameters  $(A^i, \tau^i, \rho^i)$  and  $(A^i, \tau^i, \rho^i)$  are equal up to permutation and scale indeterminacies. Specifically, there exists a scale-permutation matrix  $P_\star \in \mathbb{R}^{p \times p}$  and vectors  $\tau_\star, \rho_\star \in \mathbb{R}^p$  such that,  $\forall i \in \llbracket m \rrbracket$ ,

$$A^i = A^i P_\star, \tau^i = (P_\star^\top \tau^i - \tau_\star) \odot \rho_\star \text{ and } \rho^i = \frac{P_\star^\top \rho^i}{\rho_\star}, \quad (5)$$

where  $\odot$  is the element-wise multiplication and  $\frac{P_\star^\top \rho^i}{\rho_\star}$  uses the element-wise division.

The proof of the theorem is given in Appendix A.

## 1.3 Approximate-likelihood

As usual in ICA, we look for the inverse of the mixing matrices  $A^i$ , called unmixing matrices  $W^i := (A^i)^{-1}$ , since  $W^i \mathbf{X}^i$  approximately gives the individual sources  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S})$ . Given that we also want to estimate delays  $\tau^i$  and dilations  $\rho^i$ , the likelihood of our model depends on 3 terms:  $\mathcal{W} = (W^1, \dots, W^m)$ ,  $\tau = (\tau^1, \dots, \tau^m)$ , and  $\rho = (\rho^1, \dots, \rho^m)$ . Note that we make a slight abuse of notations for  $\tau, \rho \in \mathbb{R}^{m \times p}$ , written in lowercase bold letters instead of capital letters.

Computing the likelihood of (4) requires knowing the source distribution, which is commonly assumed to be a sub-Gaussian or super-Gaussian density. In the context of MEG data, neural sources are usually super-Gaussian because of their sparse and heavy-tailed nature [3, 16]. Following [18], we thus choose the source density  $\mathbb{P}_{\mathbf{S}}$  so that, for all  $j \in \llbracket p \rrbracket$  and for almost all  $s \in \mathbb{R}$ ,

$$-\frac{d}{ds} \log(\mathbb{P}_{\mathbf{S}_j}(s)) = s + \tanh(s). \quad (6)$$

From now on, we interchangeably use  $\mathbb{P}_{\mathbf{S}}$  on vectors and scalars.

We define for later use a smoothed version  $f$  of the source density by convolution with a Gaussian kernel  $\mathcal{N}(0_p, \frac{\sigma^2}{m} I_p)$ , where  $0_p$  is a vector of  $p$  zeros and  $I_p$  is the identity matrix of size  $p$ . We have

$$f(s) := -\log \left( \int_u \mathbb{P}_{\mathbf{S}}(s-u) \exp \left( -\frac{m}{2\sigma^2} u^2 \right) du \right). \quad (7)$$

Then, we can derive an approximation of the negative log-likelihood (NLL) of our model (details about the computations are given in Appendix B). For a given duration  $T > 0$ , the approximate-NLL over  $[0, T]$  is

$$\begin{aligned} \mathcal{L}(\mathcal{W}, \tau, \rho) = & -\sum_{i=1}^m \log |\det(W^i)| + \frac{1}{T} \int_{t=0}^T f(\bar{\mathbf{Y}}(t)) dt \\ & + \frac{1}{T} \int_{t=0}^T \frac{1}{2\sigma^2} \sum_{i=1}^m \|\mathbf{Y}^i(t) - \bar{\mathbf{Y}}(t)\|^2 dt, \end{aligned} \quad (8)$$

where

$$\mathbf{Y}^i(t) := \overleftarrow{\mathcal{T}}_{\tau^i, \rho^i}(W^i \mathbf{X}^i)(t) \in \mathbb{R}^p \quad (9)$$

are the aligned estimated sources of subject  $i$ , and

$$\overline{\mathbf{Y}}(t) := \frac{1}{m} \sum_{i=1}^m \mathbf{Y}^i(t) \quad (10)$$

are the average estimated sources. We define for later use  $\mathbf{Y}^i = (\mathbf{Y}^i(t))_{t \in \mathbb{R}}$  and  $\overline{\mathbf{Y}} = (\overline{\mathbf{Y}}(t))_{t \in \mathbb{R}}$ .

Equation (8) is an approximation -and not the true-NLL because of delays and dilations. However, it tends towards the true NLL when delays tend to 0, dilations tend to 1, and the following condition is verified:  $\forall j \in \llbracket p \rrbracket, \forall i_1, i_2 \in \llbracket m \rrbracket, i_1 \neq i_2$ , we have  $\tau_j^{i_1} \neq \tau_j^{i_2}$  or  $\rho_j^{i_1} \neq \rho_j^{i_2}$ . This last condition is almost sure if  $\boldsymbol{\tau}$  and  $\boldsymbol{\rho}$  are drawn uniformly. See Section II of the supplementary materials for details.

The hyperparameters of this cost function are  $\sigma$ ,  $\tau_{\max}$ , and  $\rho_{\max}$ .

## 2 Regularization and optimization

### 2.1 Regularization terms

Without loss of generality, one can assume that the mean of  $\boldsymbol{\tau}$  is 0 and the mean of  $\boldsymbol{\rho}$  is 1. As forcing each mean to be 0 and 1 would lead to affine constraints that are hard to deal with when using quasi-Newton methods, we rather propose to use a quadratic penalization term  $\mathcal{R}_1$ :

$$\mathcal{R}_1(\boldsymbol{\tau}, \boldsymbol{\rho}) = \sum_{j=1}^p \left( \frac{\bar{\rho}_j - 1}{\rho_{\max} \mathbb{1}_{\{\bar{\rho}_j \geq 1\}} + \frac{1}{\rho_{\max}} \mathbb{1}_{\{\bar{\rho}_j < 1\}} - 1} \right)^2 + \sum_{j=1}^p \left( \frac{\bar{\tau}_j}{\tau_{\max}} \right)^2, \quad (11)$$

where  $\bar{\tau}_j = \frac{1}{m} \sum_{i=1}^m \tau_j^i$  and  $\bar{\rho}_j = \frac{1}{m} \sum_{i=1}^m \rho_j^i$  are the average among subjects and for the  $j$ -th source. Since for all  $j$ ,  $\bar{\tau}_j \in [-\tau_{\max}, \tau_{\max}]$  and  $\bar{\rho}_j \in [1/\rho_{\max}, \rho_{\max}]$ , we deduce that  $\mathcal{R}_1(\boldsymbol{\tau}, \boldsymbol{\rho}) \in [0, 2p]$ .

Adding this term to (8), we define

$$\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = \mathcal{L}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) + \lambda \mathcal{R}_1(\boldsymbol{\tau}, \boldsymbol{\rho}), \quad (12)$$

where  $\lambda \geq 0$  is a hyperparameter representing the regularization scale. We show in Appendix C that results are not sensitive to  $\lambda$  between  $10^{-7}$  and  $10^3$ . It is therefore set to 1 in all experiments.

Unfortunately, (8), and thus (12), is non-convex, as illustrated by the indeterminacies of our model. For example, in the presence of a periodic signal, delays that are equal to any multiple of the signal's period (within the authorized bounds) correspond to local minima, even in the presence of the regularization term  $\mathcal{R}_1$ . To mitigate this, we add another regularization term  $\mathcal{R}_2$  that captures information about the sources' envelope. More specifically,  $\mathcal{R}_2$  forces a smoothed version of the absolute value of the sources to be close to their average.

Using definition (9), let us define the collection of aligned estimated sources  $\mathcal{Y} = (\mathbf{Y}^1, \dots, \mathbf{Y}^m)$ . Signal smoothing is done with the operator  $\mathcal{S}_l$ , where  $l > 0$  is the smoothing filter length. We define  $\mathcal{R}_2$  as:

$$\mathcal{R}_2(\mathcal{Y}, l) = \frac{1}{2\sigma^2} \sum_{i=1}^m \left\| \mathcal{S}_l(|\mathbf{Y}^i|) - \overline{\mathbf{S}} \right\|^2, \quad (13)$$

where  $\overline{\mathbf{S}} = \frac{1}{m} \sum_{i=1}^m \mathcal{S}_l(|\mathbf{Y}^i|)$ . Adding this term to (12) gives the formula of the regularized approximate-NLL:

$$\tilde{\tilde{\mathcal{L}}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = \tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) + \mathcal{R}_2(\mathcal{Y}, l). \quad (14)$$

Equation (14) is the loss that will be optimized.

### 2.2 Refining parameters' scales

We choose the limited-memory BFGS (L-BFGS) [22] algorithm to optimize (14) with respect to the parameters  $\mathcal{W}$ ,  $\boldsymbol{\tau}$ , and  $\boldsymbol{\rho}$ . Since  $\boldsymbol{\tau}$  and  $\boldsymbol{\rho}$  are bounded, we opt for a version of L-BFGS that allows parameters to be constrained, namely L-BFGS-B [6]. This algorithm requires the gradient  $G$  and an approximation of the Hessian  $\mathcal{H}$  of the loss, which is easily done with automatic differentiation techniques as implemented by the JAX library [4].

L-BFGS-B finds the descent direction by refining the gradient of (14) with curvature information derived from previous steps. This makes the algorithm robust to differences in parameters' scales. However, in the first iteration, curvature information, represented by the Hessian of the loss, is assumed to be the identity. Thus, having parameters  $\mathcal{W}$ ,  $\boldsymbol{\tau}$ , and  $\boldsymbol{\rho}$  of different scales can be detrimental to the optimization. To address this problem, we correct scale dissimilarities at the beginning of the algorithm.

First, we align delays' scale with dilations' scale. To do so, for a given duration  $T > 0$ , we measure how much varying some delays  $\tilde{\boldsymbol{\tau}} \in \mathbb{R}^p$  around  $\mathbf{0}$  and dilations  $\tilde{\boldsymbol{\rho}} \in \mathbb{R}^p$  around  $\mathbf{1}$  affects the quantity

$$\int_0^T \left\| \overrightarrow{\mathcal{T}}_{\tilde{\boldsymbol{\tau}}, \tilde{\boldsymbol{\rho}}}(\overline{\mathbf{Y}})(t) - \overline{\mathbf{Y}}(t) \right\|^2 dt. \quad (15)$$

Of course, (15) equals 0 when  $\tilde{\boldsymbol{\tau}} = \mathbf{0}$  and  $\tilde{\boldsymbol{\rho}} = \mathbf{1}$ . Also, one can observe that (15) looks like the third term of (8), up to a factor and without the sum over views. Indeed,  $\overrightarrow{\mathcal{T}}_{\tilde{\boldsymbol{\tau}}, \tilde{\boldsymbol{\rho}}}(\overline{\mathbf{Y}})$  is a delayed and dilated version of the shared sources  $\overline{\mathbf{Y}}$ , so it looks like the individual sources  $\mathbf{Y}^i$  for specific  $\tilde{\boldsymbol{\tau}}$  and  $\tilde{\boldsymbol{\rho}}$ . Calculating the Hessian of (15) with respect to  $\tilde{\boldsymbol{\tau}}$  and  $\tilde{\boldsymbol{\rho}}$  then allows to change delays' scale, so that varying equally delays around  $\mathbf{0}$  or dilations around  $\mathbf{1}$  affects equally (15).

The Hessian of (15) with respect to  $\tilde{\boldsymbol{\tau}}$  and  $\tilde{\boldsymbol{\rho}}$  is a  $2p \times 2p$  matrix. Since the pairs  $(\tilde{\tau}_j, \tilde{\rho}_j)_{j \in \llbracket p \rrbracket}$  act independently from each other in  $\overrightarrow{\mathcal{T}}$ , the Hessian can be written as a block-diagonal matrix, with  $p$  blocks of size  $2 \times 2$ . We multiply each  $j$ -th delay by the factor, defined as  $\Lambda_j \in \mathbb{R}$ , that makes the diagonal of each block contain the same number twice. We use (see



Appendix D for details),  $\forall j \in \llbracket p \rrbracket$ ,

$$\Lambda_j = n \sqrt{\frac{\int_0^T t^2 (\nabla_t \bar{\mathbf{Y}}_j(t))^2 dt}{\int_0^T (\nabla_t \bar{\mathbf{Y}}_j(t))^2 dt}}. \quad (16)$$

We define  $\Lambda^1 := (\Lambda_1, \dots, \Lambda_p)^\top \in \mathbb{R}^p$ .

Second, we multiply the scale of both time parameters (delays and dilations) by a hyperparameter  $\Lambda^2 \in \mathbb{R}$ . Varying this hyperparameter allows to give more or less importance to the optimization of delays and dilations, compared to the optimization of unmixing matrices. In practice, we observe that  $\Lambda^2$  is critical and that it has to be high. Details are given in Appendix E.

## 2.3 Initialization

A naive way to initialize the parameters of our algorithm would be to start from random unmixing matrices, delays equal to 0, and dilations equal to 1. But to avoid starting far from the true parameters and eventually finding a bad local minimum, we initialize separately the unmixing matrices of each view, and then delays and dilations. A simple single-view ICA algorithm suffices to initialize the unmixing matrices separately but may estimate sources in different orders, from one view to another, because of the permutation indeterminacy inherent to ICA. We use Picard [1] to perform single-view ICA. To find the permutations that put sources of all views in the same order, MVICA [27] correlates individual sources with sources of a reference view, and then uses the Hungarian algorithm [33]. In our case, due to delays, one could consider a cross-correlation followed by the Hungarian algorithm. However, due to dilations, this is not sufficient. Therefore, we propose to search initial delay and dilation values over a grid of candidate values and use correlation of delayed and dilated sources with the sources of the reference view. Algorithm 1 (in Appendix F) describes how the initialization works and Algorithm 2 (in Appendix G) summarizes the entire pipeline.

## 2.4 Interpolation and boundary conditions

In practice, MVICAD<sup>2</sup> takes as input a collection  $\mathcal{X} = (\mathbf{X}^1, \dots, \mathbf{X}^m)$  of multivariate signals that contain a fixed number of time instants, typically defined over an evenly sampled grid. When dealing with operator  $\overline{\mathcal{T}}$ , changing the time axis with a continuous delay or dilation means evaluating the signal of the initial grid. To address this problem, we use linear interpolation, that is also amenable to automatic differentiation.

Furthermore, multivariate signals have a fixed duration  $T > 0$ . Delaying and dilating signals sometimes requires to evaluate them at  $t < 0$  or  $t > T$ . To address these cases, we use cyclic boundary conditions. In other words, we define sources  $\mathbf{S}$  outside of  $[0, T]$  by saying that  $\mathbf{S}$  is a periodic multivariate signal with period  $T$ . Although sometimes unsuitable for

real signals, having boundary conditions doesn't produce abrupt discontinuities at the edges of the signal if the sources start and finish at the same level. This can be enforced by windowing the signals, but is also typically the case for MEG data, due to high pass filtering and baseline correction preprocessing.

## 2.5 Differences with MVICAD

We next highlight the differences between MVICAD [15] and MVICAD<sup>2</sup> detailed in this work. First, MVICAD only estimates delays whereas MVICAD<sup>2</sup> finds delays and dilations. Second, parameters estimated by the proposed method are real numbers instead of integers. Third, MVICAD removed the function  $f$  of the loss during delays optimization to ease computations, whereas MVICAD<sup>2</sup> optimizes the total loss. Finally, MVICAD minimizes the loss sequentially with respect to each view, whereas MVICAD<sup>2</sup> optimizes it jointly over all parameters.

## 3 Synthetic experiments

All the code is written in Python and is available on our [GitHub repository](#). In our experiments, we compare our method to the algorithms PermICA [27], GroupICA [7], MVICA [27], and MVICAD [15]. Comparisons with other non-ICA methods such as the Shared Response Model (SRM) [9] and BCorrCA [19] were already made in [27].

### 3.1 Synthetic data

We generate synthetic data following our model (4). Except for figures that precisely aim to vary these parameters, we choose the number of views  $m = 5$ , the number of sources  $p = 3$ , the number of samples  $n = 600$ , the maximum delay  $\tau_{\max} = 0.05$ , and the maximum dilation  $\rho_{\max} = 1.15$ . Matrices  $A^i$  are randomly drawn with a Gaussian i.i.d. distribution, vectors  $\boldsymbol{\tau}^i$  (resp.  $\boldsymbol{\rho}^i$ ) are uniformly drawn in  $[-\tau_{\max}, \tau_{\max}]$  (resp.  $[1/\rho_{\max}, \rho_{\max}]$ ), and all the elements of the noise matrices  $\mathbf{N}^i$  are i.i.d. and follow the distribution  $\mathcal{N}(0, \sigma^2)$  with  $\sigma$  set to 1.

To generate the sources, we use the function  $x \mapsto -x \exp(-x^2)$ . This function has a positive peak to the left of 0 and a negative peak to the right of 0 that we halve. The heights, means and variances of the peaks are different from one source to another. Then, we add small features by decomposing the time axis into 10 different bins and generating sin waves of different frequencies in each bin, before applying a Hamming

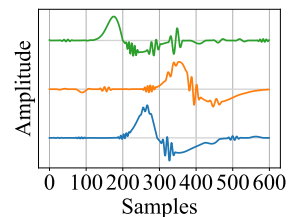


Figure 4: Example of synthetic sources. We used  $p = 3$  and  $n = 600$ .

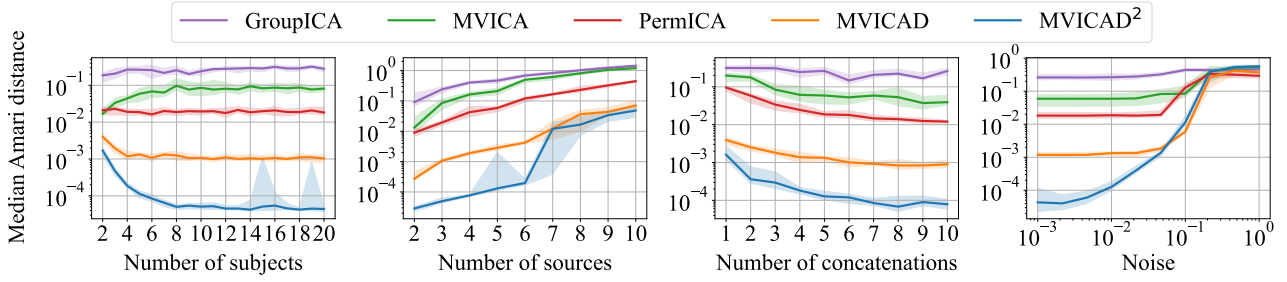


Figure 2: Amari distance of multiple methods with respect to the number of subjects (upper left), number of sources (upper right), number of concatenations (lower left), and noise level (lower right). We used 30 different seeds and plotted the median result over all seeds.

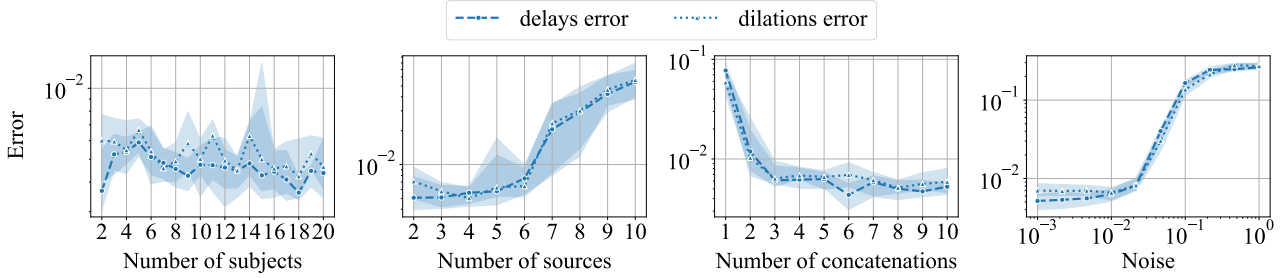


Figure 3: Delays error  $d_{\text{delays}}$  and dilations error  $d_{\text{dilations}}$  of our method with respect to the number of subjects (upper left), number of sources (upper right), number of concatenations (lower left), and noise level (lower right). We used 30 different seeds.

window in each segment. Typical sources are displayed in Figure 4.

Finally, to increase the statistical performance of the method, we generate these kind of sources  $n_{\text{concat}} = 5$  times and temporally concatenate them, so the source matrix has the shape  $p \times n_{\text{concat}}n$ . We also sample  $n_{\text{concat}}$  times the noise matrices, so that the  $N^i$  have the same shape as  $S$ .

### 3.2 Metrics

Measuring performances of an ICA algorithm is often done by computing the Amari distance [24] between estimated unmixing matrices  $W^i$  and true mixing matrices  $A^i$ . The mathematical definition of the Amari distance is the following. For two matrices  $W, A \in \mathbb{R}^{p \times p}$ , their Amari distance is

$$d_{\text{Amari}}(W, A) = \sum_{i=1}^p \left( \sum_{j=1}^p \frac{|P_j^i|}{\max_k |P_k^i|} - 1 \right) + \sum_{j=1}^p \left( \sum_{i=1}^p \frac{|P_j^i|}{\max_k |P_j^k|} - 1 \right), \quad (17)$$

where  $P = WA$ . So, this metric is scale and permutation invariant.

To quantify the error on delays, we also introduce the quantity  $d_{\text{delays}}$  that takes as inputs the true delays  $\tau_{\text{true}} \in \mathbb{R}^{m \times p}$  and the estimated delays  $\tau \in \mathbb{R}^{m \times p}$ . True and estimated delays are mapped from  $[-\tau_{\text{max}}, \tau_{\text{max}}]$  onto  $[-\frac{1}{2}, \frac{1}{2}]$  to make them independent of  $\tau_{\text{max}}$ , and they are centered around  $0_p$  because they can only be estimated up to a global delay. In doing

so, we obtain  $\hat{\tau}_{\text{true}}$  and  $\hat{\tau}$ . We define  $d_{\text{delays}}(\tau_{\text{true}}, \tau) \in [0, 2[$  as the mean of  $|\hat{\tau}_{\text{true}} - \hat{\tau}| \in \mathbb{R}^{m \times p}$ .

Following the same procedure, we define the quantity  $d_{\text{dilations}}$ .

### 3.3 Synthetic results

We now present results obtained from synthetic experiments. Figure 2 shows how well the unmixing matrices are estimated. Specifically, it tracks how the Amari distance of several methods behaves when changing the numbers of subjects, sources, and concatenations, and when we vary the noise level. Results were obtained from 30 different seeds. We observe that our method outperforms the other algorithms by an order of magnitude, except when the noise level or the number of sources is too big. Note that, for the plot with respect to the number of sources, we used 10 views instead of 5. However, we can hypothesize that the increase of Amari distance when the number of sources exceeds 6 partially comes from our source generation. Indeed, synthetic sources are generated in similar way and the possibility to delay and dilate them can make source separation more tedious, as the number of sources increases.

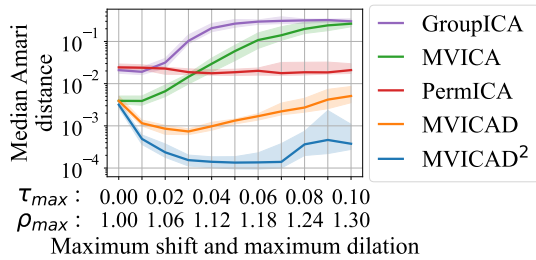


Figure 5: Amari distance of our method with respect to the maximum delay  $\tau_{\max}$  and the maximum dilation  $\rho_{\max}$ . We used 30 different seeds and plotted the median of all seeds.

Figure 5 was obtained by jointly varying the quantity of delays and dilations introduced in the model. We chose to vary  $\tau_{\text{max}}$  from 0 to 0.10 (resp.  $\rho_{\text{max}}$  from 1 to 1.30) because, in the context of MEG data and with a sampling rate of 1000 Hz, the maximum delay observed (resp. the maximum dilation observed) is approximately 0.06 (resp. 1.4) for a visual stimulus, and 0.02 (resp. 1.25) for an auditory stimulus [26]. We ob-

serve that MVICA, MVICAD, and MVICAD<sup>2</sup> approximately start from the same point, but only MVICAD and MVICAD<sup>2</sup> improve when the quantity of delays and dilations increases. On the other hand, MVICA and GroupICA suffer from the addition of temporal variations. As for PermICA, it estimates sources independently for each view, so it is not affected by  $\tau_{\max}$  and  $\rho_{\max}$ , hence the flat curve.

Figure 3 represents the errors on delays and dilations. Note that the errors in estimating the different parameters in MVICAD<sup>2</sup> — delays and dilations (Figure 3) and unmixing matrices (Figure 2) — all vary together as we change different design choices such as the number of sources.

## 4 Real data experiments

### 4.1 Cam-CAN dataset

The Cam-CAN dataset [32] is a large and comprehensive dataset of neuroimaging, cognitive, and demographic data collected from a group of healthy adults. The dataset includes data from 661 participants, ranging in age from 18 to 88 years old, with equal numbers of participants in each 10-year age range. The participants were recruited from the general population in the Cambridgeshire area of the UK, with the aim of recruiting a sample that was representative of the local population in terms of age, sex, and education level.

The MEG data in the Stage 2 repository includes recordings of brain activity using a whole-head 306 channel Elekta Neuromag Vectorview system. It contains data from several cognitive tasks, including visual and auditory tasks for which participants were presented a series of stimuli.

### 4.2 Preprocessing

We focus on both visual and auditory tasks. Data were preprocessed using a Maxwell filter, a 40 Hz low-pass filter, and an SSP filter. After the preprocessing step, subjects with unusual signals were removed, which reduced the number of subjects to 150 for the visual task and 160 for the auditory one. Then, we averaged data among stimuli to keep only  $n_{\text{concat}} = 2$  periods of time. Finally, we drew epochs of 0.7 seconds, spanning from

$t = -0.2$  s to  $t = 0.5$  s, where  $t = 0$  s corresponds to the stimulus onset. The sampling rate is 1000 Hz, thus giving 701 different samples.

### 4.3 Real data results

One can notice that the metrics  $d_{\text{Amari}}$ ,  $d_{\text{delays}}$ , and  $d_{\text{dilations}}$  depend on true parameters that are usually unknown, so they cannot be used on real data. Instead, we can verify if the estimated time delays and shifts are coherent, by checking if their correlation with participants’ age produces known results in the literature [26].

We compare our results with [26]. In this paper, the authors used MEG data of hundreds of subjects that were presented series of visual and auditory stimuli. They applied PCA on each individual data and only kept the first component. Then, they estimated how much this first component was delayed and dilated, compared to the average, and plotted the results with the age in  $x$ -axis.

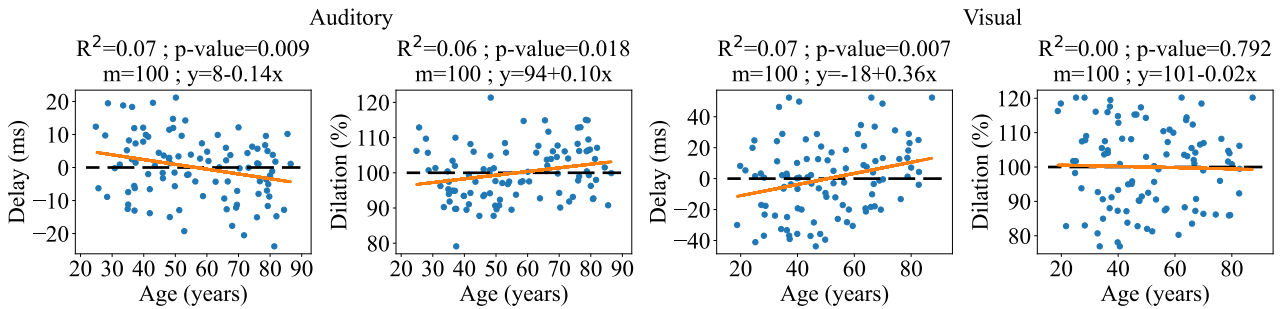


Figure 6: Scatter plots of estimated delays and dilations VS ages of the subjects for the auditory task (both figures on the left) and the visual task (both figures on the right).

We reproduced this experiment in Figure 6. We kept 100 randomly chosen subjects of the visual and auditory datasets mentioned in 4.2, and applied PCA with 8 components to reduce dimension, resulting in two datasets of shape (100, 8, 2, 701). Then, we used our method to estimate sources, delays, and dilations. It is important to notice that some of the 8 sources correspond to noise and not brain activations, so they should not present a time variability correlated to age. Thus, before plotting the results, we visually select sources that have the strongest cross-correlation (i.e. those that look the least like noise), and average their corresponding delays and dilations. In the figure, we kept 2 sources out of the 8 for the visual task, and 3 sources for the auditory one.

As in [26], we observe that, after a visual stimulus, brain activations are generally shifted to the right and are not dilated when age increases. Furthermore, after an auditory stimulus, sources appear to expand with age; however, contrary to [26], we observe a negative correlation between age and delays rather than no correlation. This difference could be explained by the fact that our method estimates delays and dilations based on multiple independent components, instead of only one component found with simple orthogonal assumptions of the PCA. We can therefore expect our estimates to be more precise.

## 5 Discussion

Our method MVICAD<sup>2</sup> is designed to learn two types of representations of data: representations that are common across views, and others that are view-specific. Results of synthetic experiments show that MVICAD<sup>2</sup> outperforms state-of-the-art methods in many scenarios by an order of magnitude (Figures 2 and 5). Experiments on the Cam-CAN dataset reveal that our method learns delays and dilations for each participant that correlate with their age, suggesting

its ability to capture meaningful time variability not modeled by other multi-view ICA algorithms. However, MVICAD<sup>2</sup> is challenged in the regimes of high noise or too many sources to estimate (see Section 3.3): increasing the robustness to these effects is a direction for future work. Future directions also include extending our method to handle more general temporal variability than delays and dilations, and also applying it to EEG data in addition to the MEG data in this work.

## Conclusion

We have proposed an unsupervised algorithm, named Multi-View ICA with Delays and Dilations (MVICAD<sup>2</sup>), that reveals latent sources observed through different views. This algorithm goes beyond the Multi-View ICA model by allowing latent sources to temporally differ from one view to another. The temporal variation is modeled as a delay and a dilation, since these effects both appear in neuroimaging group studies. We proved that our model is identifiable, derived an approximation of its likelihood in closed-form, and proposed regularization and optimization techniques to maximize it efficiently. We demonstrated, using various synthetic experiments, the superior performance of our method, compared to state-of-the-art multi-view ICA algorithms. We further validated the usefulness of MVICAD<sup>2</sup> for neuroimaging group studies on MEG data, by showing that estimated delays and dilations are correlated to age. Our method is not specific to neuroimaging data and could be relevant to other observational sciences like genomics or astrophysics where ICA is already widely used.

# Appendix

## A Identifiability proof

*Proof.* This proof is based on the one of [15]. Using the assumptions of our identifiability theorem, we have,  $\forall i \in \llbracket m \rrbracket, \forall t \in \mathbb{R}$ ,

$$\mathbf{X}^i(t) = A^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S})(t) + \mathbf{N}^i(t)) \quad (18)$$

and

$$\mathbf{X}^i(t) = A^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}')(t) + \mathbf{N}^i(t)) . \quad (19)$$

We assumed that sources were non-Gaussian and independent from one to another and across time. So,  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S})$  and  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}')$  have non-Gaussian independent components. Moreover,  $\mathbf{N}^i$  and  $\mathbf{N}^i$  have Gaussian independent components. So,  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}) + \mathbf{N}^i$  and  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}') + \mathbf{N}^i$  have non-Gaussian independent components. Following [10], Theorem 11, there exists a scale-permutation matrix  $P^i$  such that  $A^i = A^i P^i$ .

As a consequence, and since  $A^i$  is invertible, we have,  $\forall i \in \llbracket m \rrbracket$ ,

$$\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}) + \mathbf{N}^i = P^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}') + \mathbf{N}^i) . \quad (20)$$

We define in (20) the product between matrix  $P^i \in \mathbb{R}^{p \times p}$  and multivariate signal  $\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}') + \mathbf{N}^i : \mathbb{R} \rightarrow \mathbb{R}^p$  by considering that it is done pointwise for each time  $t$ . From now on, we allow such products. By applying  $\overleftarrow{\mathcal{T}}_{\tau^i, \rho^i}$  on both sides of (20), we get

$$\begin{aligned} \mathbf{S} + \overleftarrow{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{N}^i) &= \overleftarrow{\mathcal{T}}_{\tau^i, \rho^i} \left( P^i(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}') + \mathbf{N}^i) \right) \\ &= P^i \overleftarrow{\mathcal{T}}_{(P^i)^\top \tau^i, (P^i)^\top \rho^i}(\vec{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{S}') + \mathbf{N}^i), \end{aligned} \quad (21)$$

where the last equality comes from the fact that, for any vectors  $\tau, \rho \in \mathbb{R}^p$ , any multivariate signal  $\mathbf{S} : \mathbb{R} \rightarrow \mathbb{R}^p$ , and any scale-permutation matrix  $P \in \mathbb{R}^{p \times p}$ , we have

$$\overleftarrow{\mathcal{T}}_{\tau, \rho}(P\mathbf{S}) = P \overleftarrow{\mathcal{T}}_{P^\top \tau, P^\top \rho}(\mathbf{S}) . \quad (22)$$

Furthermore, for any vectors  $\tau, \rho, \tau', \rho' \in \mathbb{R}^p$ , any multivariate signal  $\mathbf{S} : \mathbb{R} \rightarrow \mathbb{R}^p$ , and any time  $t \in \mathbb{R}^p$ , the composition of  $\overleftarrow{\mathcal{T}}_{\tau, \rho}$  and  $\vec{\mathcal{T}}_{\tau', \rho'}$  gives

$$\begin{aligned} \overleftarrow{\mathcal{T}}_{\tau, \rho} \circ \vec{\mathcal{T}}_{\tau', \rho'}(\mathbf{S})(t) &= \mathbf{S} \left( \frac{1}{\rho} \odot (\rho' \odot (t - \tau')) + \tau \right) \\ &= \mathbf{S} \left( \frac{\rho'}{\rho} \odot t - \frac{\rho' \odot \tau'}{\rho} + \tau \right) \\ &= \overleftarrow{\mathcal{T}}_{\tau - \frac{\rho' \odot \tau'}{\rho}, \frac{\rho'}{\rho}}(\mathbf{S})(t) , \end{aligned} \quad (23)$$

where  $\frac{\rho'}{\rho}$  and  $\frac{\rho' \odot \tau'}{\rho}$  use the element-wise division. Consequently,

$$\begin{aligned} \mathbf{S} + \overleftarrow{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{N}^i) &= P^i \overleftarrow{\mathcal{T}}_{(P^i)^\top \tau^i - \frac{\rho^i \odot \tau^i}{(P^i)^\top \rho^i}, \frac{(P^i)^\top \rho^i}{(P^i)^\top \rho^i}}(\mathbf{S}') \\ &\quad + P^i \overleftarrow{\mathcal{T}}_{(P^i)^\top \tau^i, (P^i)^\top \rho^i}(\mathbf{N}^i) . \end{aligned} \quad (24)$$

From now on, we define for simplicity,  $\forall i \in \llbracket m \rrbracket$ ,

$$\tilde{\tau}^i := (P^i)^\top \tau^i - \frac{\rho^i \odot \tau^i}{(P^i)^\top \rho^i} \quad \text{and} \quad \tilde{\rho}^i := \frac{(P^i)^\top \rho^i}{\rho^i} . \quad (25)$$

In addition, we define the noises

$$\tilde{\mathbf{N}}^i := \overleftarrow{\mathcal{T}}_{\tau^i, \rho^i}(\mathbf{N}^i) \quad \text{and} \quad \tilde{\mathbf{N}}_P^i := P^i \overleftarrow{\mathcal{T}}_{(P^i)^\top \tau^i, (P^i)^\top \rho^i}(\mathbf{N}^i) \quad (26)$$

and we also define

$$\tilde{\mathbf{S}}^i := \overleftarrow{\mathcal{T}}_{\tilde{\tau}^i, \tilde{\rho}^i}(\mathbf{S}') . \quad (27)$$

Using definitions (26) and (27), we can reformulate (24) as,  $\forall i \in \llbracket m \rrbracket$ ,

$$\mathbf{S} + \tilde{\mathbf{N}}^i = P^i \tilde{\mathbf{S}}^i + \tilde{\mathbf{N}}_P^i . \quad (28)$$

We focus on subject 1 and subject  $i \neq 1$ . We have

$$\mathbf{S} + \overleftarrow{\mathbf{N}}^1 - (\mathbf{S} + \overleftarrow{\mathbf{N}}^i) = P^1 \overleftarrow{\mathbf{S}}'^1 + \overleftarrow{\mathbf{N}}_P'^1 - (P^i \overleftarrow{\mathbf{S}}'^i + \overleftarrow{\mathbf{N}}_P'^i) . \quad (29)$$

Thus,

$$P^1 \overleftarrow{\mathbf{S}}'^1 - P^i \overleftarrow{\mathbf{S}}'^i = \overleftarrow{\mathbf{N}}^1 - \overleftarrow{\mathbf{N}}^i + \overleftarrow{\mathbf{N}}_P'^i - \overleftarrow{\mathbf{N}}_P'^1 . \quad (30)$$

The right-hand side of (30) is a linear combination of Gaussian random variables, which implies that  $P^1 \overleftarrow{\mathbf{S}}'^1 - P^i \overleftarrow{\mathbf{S}}'^i$  is also Gaussian.

Let us show that  $\tilde{\boldsymbol{\tau}}^1 = \tilde{\boldsymbol{\tau}}^i$  and  $\tilde{\boldsymbol{\rho}}^1 = \tilde{\boldsymbol{\rho}}^i$ . By contradiction, suppose that  $\tilde{\boldsymbol{\tau}}^1 \neq \tilde{\boldsymbol{\tau}}^i$  or  $\tilde{\boldsymbol{\rho}}^1 \neq \tilde{\boldsymbol{\rho}}^i$ , i.e.  $\exists j \in \llbracket p \rrbracket$ ,  $\tilde{\tau}_j^1 \neq \tilde{\tau}_j^i$  or  $\tilde{\rho}_j^1 \neq \tilde{\rho}_j^i$ . Then, for all  $t \in \mathbb{R}$  (except maybe for one time point), we have

$$\frac{1}{\tilde{\rho}_j^1} t + \tilde{\tau}_j^1 \neq \frac{1}{\tilde{\rho}_j^i} t + \tilde{\tau}_j^i . \quad (31)$$

We fix such a time  $t$ . Let us define for simplicity

$$\mathbf{u} := \overleftarrow{\mathbf{S}}'^1(t) \in \mathbb{R}^p \quad \text{and} \quad \mathbf{v} := \overleftarrow{\mathbf{S}}'^i(t) \in \mathbb{R}^p . \quad (32)$$

From (27), (31), and the fact that  $\mathbf{S}'$  is independent across time, we deduce that  $u_j$  and  $v_j$  are independent, where  $u_j$  (resp.  $v_j$ ) is the  $j$ -th component of  $\mathbf{u}$  (resp.  $\mathbf{v}$ ). Since the components of  $\mathbf{v}$  are independent from one to another and  $u_j$  is independent from  $v_j$ , then  $u_j$  is independent from all the components of  $\mathbf{v}$ .

We know that  $P^1$  is a scale-permutation matrix, so it has exactly one non-zero value in each of its columns. Let us call  $j'$  the row number of the non-zero value of its  $j$ -th column. Matrix  $P^1$  moves  $u_j$  from the  $j$ -th row to the  $j'$ -th row, as follows:  $(P^1 \mathbf{u})_{j'} = P_{j'j}^1 u_j$ . Since  $u_j$  is independent of all the entries of  $\mathbf{v}$ , we have, in particular, that  $(P^1 \mathbf{u})_{j'}$  is independent of  $(P^i \mathbf{v})_{j'}$ . In other words, we proved that  $(P^1 \overleftarrow{\mathbf{S}}'^1(t))_{j'}$  is independent from  $(P^i \overleftarrow{\mathbf{S}}'^i(t))_{j'}$ .

Since the whole multivariate signal  $P^1 \overleftarrow{\mathbf{S}}'^1 - P^i \overleftarrow{\mathbf{S}}'^i$  is Gaussian, we deduce that, in particular,  $(P^1 \overleftarrow{\mathbf{S}}'^1(t))_{j'} - (P^i \overleftarrow{\mathbf{S}}'^i(t))_{j'}$  is Gaussian too. So, by Lévy-Cramér's theorem, we should have that  $\overleftarrow{\mathbf{S}}'^1_{j'}(t)$  and  $\overleftarrow{\mathbf{S}}'^i_{j'}(t)$  are Gaussian. But this is absurd, given that all the components of  $\mathbf{S}'$  are non-Gaussian. So,  $\tilde{\boldsymbol{\tau}}^1 = \tilde{\boldsymbol{\tau}}^i$  and  $\tilde{\boldsymbol{\rho}}^1 = \tilde{\boldsymbol{\rho}}^i$ .

In other words, there exists vectors  $\boldsymbol{\tau}_\star$  and  $\boldsymbol{\rho}_\star$  such that,  $\forall i \in \llbracket m \rrbracket$ ,

$$\tilde{\boldsymbol{\tau}}^1 = \tilde{\boldsymbol{\tau}}^i =: \boldsymbol{\tau}_\star \quad \text{and} \quad \tilde{\boldsymbol{\rho}}^1 = \tilde{\boldsymbol{\rho}}^i =: \boldsymbol{\rho}_\star . \quad (33)$$

Using the definitions of  $\tilde{\boldsymbol{\tau}}^i$  and  $\tilde{\boldsymbol{\rho}}^i$  in (25), it follows that,  $\forall i \in \llbracket m \rrbracket$ ,

$$\boldsymbol{\tau}^i = ((P^i)^\top \boldsymbol{\tau}^i - \boldsymbol{\tau}_\star) \odot \boldsymbol{\rho}_\star \quad \text{and} \quad \boldsymbol{\rho}^i = \frac{(P^i)^\top \boldsymbol{\rho}^i}{\boldsymbol{\rho}_\star} . \quad (34)$$

We recall that,  $\forall i \in \llbracket m \rrbracket$ ,  $\overleftarrow{\mathbf{S}}'^i = \overleftarrow{\mathcal{T}}_{\tilde{\boldsymbol{\tau}}^i, \tilde{\boldsymbol{\rho}}^i}(\mathbf{S}')$ . Given that  $\tilde{\boldsymbol{\tau}}^1 = \tilde{\boldsymbol{\tau}}^i$  and  $\tilde{\boldsymbol{\rho}}^1 = \tilde{\boldsymbol{\rho}}^i$ , we define

$$\tilde{\mathbf{S}} := \overleftarrow{\mathbf{S}}'^1 = \overleftarrow{\mathbf{S}}'^i . \quad (35)$$

We know that  $P^1 \overleftarrow{\mathbf{S}}'^1 - P^i \overleftarrow{\mathbf{S}}'^i$  is Gaussian. In other words,  $(P^1 - P^i) \tilde{\mathbf{S}}$  is Gaussian. This only holds if  $P^1 = P^i$ . Therefore, the matrices  $P^i$  are all equal, and there exists a scale-permutation matrix  $P_\star \in \mathbb{R}^{p \times p}$  such that,  $\forall i \in \llbracket m \rrbracket$ ,  $A^i = A^i P_\star$ .

In conclusion, we proved that there exists a scale-permutation matrix  $P_\star$  and vectors  $\boldsymbol{\tau}_\star$  and  $\boldsymbol{\rho}_\star$  such that,  $\forall i \in \llbracket m \rrbracket$ ,

$$A^i = A^i P_\star, \quad \boldsymbol{\tau}^i = (P_\star^\top \boldsymbol{\tau}^i - \boldsymbol{\tau}_\star) \odot \boldsymbol{\rho}_\star \quad \text{and} \quad \boldsymbol{\rho}^i = \frac{P_\star^\top \boldsymbol{\rho}^i}{\boldsymbol{\rho}_\star} . \quad (36)$$

## B Deriving the approximate negative log-likelihood

*Proof.* Let us derive the approximation of the negative log-likelihood (NLL) of our model. Recall that our model is,  $\forall i \in \llbracket m \rrbracket$  and  $\forall t \in \mathbb{R}$ ,

$$\mathbf{X}^i(t) = A^i \left( \overrightarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{S})(t) + \mathbf{N}^i(t) \right) . \quad (37)$$

Let us define

$$\mathbf{Z}^i = \overrightarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{S}) . \quad (38)$$



By change of variables, we have, from (37) and (38), that

$$\mathbf{N}^i(t) = W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t) , \quad (39)$$

where  $W^i = (A^i)^{-1}$ . So, the distribution of  $\mathbf{X}^i(t)$  conditioned on  $\mathbf{Z}^i(t)$ , is

$$\mathbb{P}_{\mathbf{X}^i}(\mathbf{X}^i(t)|\mathbf{Z}^i(t); W^i, \boldsymbol{\tau}^i, \boldsymbol{\rho}^i) = |\det(W^i)| \mathbb{P}_{\mathbf{N}^i}(W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t)) , \quad (40)$$

where  $\mathbb{P}_{\mathbf{N}^i}$  is the distribution of  $\mathbf{N}^i(t)$ , i.e.  $\mathcal{N}(0_p, \sigma^2 I_p)$ . Thus,

$$\mathbb{P}_{\mathbf{N}^i}(W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t)) = (2\pi\sigma^2)^{-\frac{p}{2}} \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t)\|^2}{2\sigma^2}\right) . \quad (41)$$

We define  $\mathcal{X} = (\mathbf{X}^1, \dots, \mathbf{X}^m)$  and  $\mathcal{Z} = (\mathbf{Z}^1, \dots, \mathbf{Z}^m)$ . Let us use the notations  $\mathcal{X}(t) = (\mathbf{X}^1(t), \dots, \mathbf{X}^m(t))$  and  $\mathcal{Z}(t) = (\mathbf{Z}^1(t), \dots, \mathbf{Z}^m(t))$ , and recall that  $\mathcal{W} = (W^1, \dots, W^m)$ ,  $\boldsymbol{\tau} = (\boldsymbol{\tau}^1, \dots, \boldsymbol{\tau}^m)$ , and  $\boldsymbol{\rho} = (\boldsymbol{\rho}^1, \dots, \boldsymbol{\rho}^m)$ . We can remark that, conditionally on  $\mathbf{Z}^i(t)$ ,  $W^i$ ,  $\boldsymbol{\tau}^i$ , and  $\boldsymbol{\rho}^i$ ,  $i = 1, \dots, m$ , the r.v.  $\mathbf{X}^1(t), \dots, \mathbf{X}^m(t)$  are mutually independent. Consequently, we have

$$\mathbb{P}_{\mathcal{X}}(\mathcal{X}(t)|\mathcal{Z}(t); \mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = \prod_{i=1}^m |\det(W^i)| (2\pi\sigma^2)^{-\frac{p}{2}} \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t)\|^2}{2\sigma^2}\right) . \quad (42)$$

To derive the joint distribution of  $\mathcal{X}(t)$  and  $\mathcal{Z}(t)$ , conditioned on  $\mathcal{W}$ ,  $\boldsymbol{\tau}$ , and  $\boldsymbol{\rho}$ , we multiply by the distribution of  $\mathcal{Z}(t)$ , as follows:

$$\mathbb{P}_{\mathcal{X}}(\mathcal{X}(t), \mathcal{Z}(t)|\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = \mathbb{P}_{\mathcal{Z}}(\mathcal{Z}(t)) \prod_{i=1}^m |\det(W^i)| (2\pi\sigma^2)^{-\frac{p}{2}} \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{Z}^i(t)\|^2}{2\sigma^2}\right) . \quad (43)$$

Note that the distribution of  $\mathcal{Z}(t)$  is the joint distribution of  $(\mathbf{Z}^1(t), \dots, \mathbf{Z}^m(t))$ , so it can be written  $\mathbb{P}_{(\mathbf{Z}^1, \dots, \mathbf{Z}^m)}(\mathbf{Z}^1(t), \dots, \mathbf{Z}^m(t))$ . By integrating (43) over  $\mathcal{Z}(t)$ , we derive the likelihood at time  $t$  of our model:

$$\begin{aligned} \mathbb{P}_{\mathcal{X}}(\mathcal{X}(t)|\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) &= \int_{\mathbf{z}_t^1, \dots, \mathbf{z}_t^m \in \mathbb{R}^p} \mathbb{P}_{(\mathbf{Z}^1, \dots, \mathbf{Z}^m)}(\mathbf{z}_t^1, \dots, \mathbf{z}_t^m) \prod_{i=1}^m |\det(W^i)| \\ &\quad \times (2\pi\sigma^2)^{-\frac{p}{2}} \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{z}_t^i\|^2}{2\sigma^2}\right) d\mathbf{z}_t^1 \dots d\mathbf{z}_t^m . \end{aligned} \quad (44)$$

Thus, the NLL at time  $t$  is

$$\begin{aligned} \mathcal{L}_t(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) &= -\sum_{i=1}^m \log |\det(W^i)| + \frac{mp}{2} \log(2\pi\sigma^2) \\ &\quad - \log\left(\int_{\mathbf{z}_t^1, \dots, \mathbf{z}_t^m \in \mathbb{R}^p} \mathbb{P}_{(\mathbf{Z}^1, \dots, \mathbf{Z}^m)}(\mathbf{z}_t^1, \dots, \mathbf{z}_t^m) \prod_{i=1}^m \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{z}_t^i\|^2}{2\sigma^2}\right) d\mathbf{z}_t^1 \dots d\mathbf{z}_t^m\right) , \end{aligned} \quad (45)$$

where the integrand factorizes in the previous integral. Indeed, we know that,  $\forall t \in \mathbb{R}$ , the components of  $\mathbf{S}(t)$  are independent of each other and the  $\mathbf{S}(t)$  are independent across time  $t$ . So, the  $(\mathbf{Z}_j^1, \dots, \mathbf{Z}_j^m)$ , for  $j = 1, \dots, p$ , are independent of each other, where  $\mathbf{Z}_j^i$  is the  $j$ -th component of  $\mathbf{Z}^i$ . Thus, the integrand can be written

$$\begin{aligned} \mathbb{P}_{(\mathbf{Z}^1, \dots, \mathbf{Z}^m)}(\mathbf{z}_t^1, \dots, \mathbf{z}_t^m) &\prod_{i=1}^m \exp\left(-\frac{\|W^i \mathbf{X}^i(t) - \mathbf{z}_t^i\|^2}{2\sigma^2}\right) \\ &= \prod_{j=1}^p \mathbb{P}_{(\mathbf{Z}_j^1, \dots, \mathbf{Z}_j^m)}(z_{j,t}^1, \dots, z_{j,t}^m) \prod_{i=1}^m \exp\left(-\frac{((\mathbf{w}_j^i)^\top \mathbf{X}^i(t) - z_{j,t}^i)^2}{2\sigma^2}\right) , \end{aligned} \quad (46)$$

where  $z_{j,t}^i$  is a realization of the  $j$ -th component of  $\mathbf{Z}^i(t)$ , and  $\mathbf{w}_j^i$  is the  $j$ -th row of  $W^i$ .

Assume that,  $\forall j \in \llbracket p \rrbracket$ ,  $\forall i_1, i_2 \in \llbracket m \rrbracket$ ,  $i_1 \neq i_2$ , we have  $\tau_j^{i_1} \neq \tau_j^{i_2}$  or  $\rho_j^{i_1} \neq \rho_j^{i_2}$ , which is almost sure if  $\boldsymbol{\tau}$  and  $\boldsymbol{\rho}$  are drawn uniformly. Then, for all  $t \in \mathbb{R}$  (except maybe for one value of  $t$  where the two affine lines cross), we have

$$\rho_j^{i_1}(t - \tau_j^{i_1}) \neq \rho_j^{i_2}(t - \tau_j^{i_2}) . \quad (47)$$

Given (38), (47), and the fact that the  $\mathbf{S}_j(t)$  are i.i.d. across time, we get that, for all  $t$  (except maybe for one of them),  $\mathbf{Z}_j^{i_1}(t)$  and  $\mathbf{Z}_j^{i_2}(t)$  are independent. So, for almost all  $t \in \mathbb{R}$ , we have

$$\mathbb{P}(\mathbf{Z}_j^1, \dots, \mathbf{Z}_j^m)(z_{j,t}^1, \dots, z_{j,t}^m) = \prod_{i=1}^m \mathbb{P}_{\mathbf{Z}_j}(z_{j,t}^i) . \quad (48)$$

As a consequence, for almost all  $t \in \mathbb{R}$ ,

$$(46) = \prod_{i=1}^m \prod_{j=1}^p \mathbb{P}_{\mathbf{Z}_j}(z_{j,t}^i) \exp\left(-\frac{((\mathbf{w}_j^i)^\top \mathbf{X}^i(t) - z_{j,t}^i)^2}{2\sigma^2}\right) . \quad (49)$$

It follows that, up to the constant  $\frac{mp}{2} \log(2\pi\sigma^2)$ , and for almost all  $t \in \mathbb{R}$ , the NLL at time  $t$  is

$$\mathcal{L}_t(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = -\sum_{i=1}^m \log |\det(W^i)| - \sum_{i=1}^m \sum_{j=1}^p \log \left( \int_{z_{j,t}^i \in \mathbb{R}} \mathbb{P}_{\mathbf{Z}_j}(z_{j,t}^i) \exp\left(-\frac{((\mathbf{w}_j^i)^\top \mathbf{X}^i(t) - z_{j,t}^i)^2}{2\sigma^2}\right) dz_{j,t}^i \right) . \quad (50)$$

Let  $T > 0$ . The NLL averaged over time is

$$\begin{aligned} \mathcal{L}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) &= \int_{t=0}^T \mathcal{L}_t(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) dt \\ &= -T \sum_{i=1}^m \log |\det(W^i)| - \sum_{i=1}^m \sum_{j=1}^p \delta_j^i , \end{aligned} \quad (51)$$

where  $\delta_j^i \in \mathbb{R}$  is defined as

$$\delta_j^i = \int_{t=0}^T \log \left( \int_{z_{j,t}^i \in \mathbb{R}} \mathbb{P}_{\mathbf{Z}_j}(z_{j,t}^i) \exp\left(-\frac{((\mathbf{w}_j^i)^\top \mathbf{X}^i(t) - z_{j,t}^i)^2}{2\sigma^2}\right) dz_{j,t}^i \right) dt . \quad (52)$$

We want to use the change of variable that corresponds to the  $j$ -th component of the operator  $\overleftarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}$  defined as,  $\forall \boldsymbol{\tau}^i, \boldsymbol{\rho}^i \in \mathbb{R}^p$  and  $\forall \mathbf{t} \in \mathbb{R}^p$ ,

$$\overleftarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{S})(\mathbf{t}) = \mathbf{S} \left( \frac{1}{\boldsymbol{\rho}^i} \odot \mathbf{t} + \boldsymbol{\tau}^i \right) . \quad (53)$$

Let  $\tilde{\mathbf{t}}^i = \boldsymbol{\rho}^i \odot (t\mathbf{1}_p - \boldsymbol{\tau}^i)$ , which implies that  $t\mathbf{1}_p = \frac{1}{\boldsymbol{\rho}^i} \odot \tilde{\mathbf{t}}^i + \boldsymbol{\tau}^i$ . By the definition of  $\mathbf{Z}^i$  given in (38), we have,  $\forall t \in \mathbb{R}$ ,

$$\begin{aligned} \mathbf{Z}^i(t) &= \mathbf{Z}^i(t\mathbf{1}_p) = \mathbf{Z}^i \left( \frac{1}{\boldsymbol{\rho}^i} \odot \tilde{\mathbf{t}}^i + \boldsymbol{\tau}^i \right) \\ &= \overleftarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(\mathbf{Z}^i)(\tilde{\mathbf{t}}^i) = \mathbf{S}(\tilde{\mathbf{t}}^i) . \end{aligned} \quad (54)$$

Let  $\tilde{t} = \rho_j^i(t - \tau_j^i)$ , where we will drop the dependence on  $i$  and  $j$  for simplicity. In addition,  $\forall i \in \llbracket m \rrbracket$ , let us define  $\mathbf{S}^i = (\mathbf{S}^i(t))_{t \in \mathbb{R}}$ , where  $\mathbf{S}^i(t) := W^i \mathbf{X}^i(t) \in \mathbb{R}^p$ . The  $j$ -th component of  $\mathbf{S}^i$  is  $\mathbf{S}_j^i = (\mathbf{w}_j^i)^\top \mathbf{X}^i$ , so that it implicitly depends on  $\mathbf{w}_j^i$ . Note that  $\mathbf{S}^i$  are the estimated sources for view  $i$ , and are different from the true shared sources  $S$ . Also note that, in this definition, we can multiply  $\mathbf{X}^i$  by  $W^i$  or  $(\mathbf{w}_j^i)^\top$  either before or after fixing the time  $t$ . Using the same idea as in (54) but in one dimension, the change of variable gives

$$\delta_j^i = \int_{\tilde{t} = -\rho_j^i \tau_j^i}^{\rho_j^i(T - \tau_j^i)} \log \left( \int_{s_{j,\tilde{t}} \in \mathbb{R}} \mathbb{P}_{\mathbf{S}_j}(s_{j,\tilde{t}}) \exp\left(-\frac{\left(\mathbf{S}_j^i \left( \frac{1}{\rho_j^i} \tilde{t} + \tau_j^i \right) - s_{j,\tilde{t}} \right)^2}{2\sigma^2}\right) ds_{j,\tilde{t}} \right) \frac{1}{\rho_j^i} d\tilde{t} . \quad (55)$$

Let us define the following approximation of  $\delta_j^i$ :

$$\tilde{\delta}_j^i = \int_{\tilde{t}=0}^T \log \left( \int_{s_{j,\tilde{t}} \in \mathbb{R}} \mathbb{P}_{\mathbf{S}_j}(s_{j,\tilde{t}}) \exp\left(-\frac{\left(\mathbf{S}_j^i \left( \frac{1}{\rho_j^i} \tilde{t} + \tau_j^i \right) - s_{j,\tilde{t}} \right)^2}{2\sigma^2}\right) ds_{j,\tilde{t}} \right) d\tilde{t} \quad (56)$$

where we modified the range of the integral and removed the multiplicative factor of  $1/\rho_j^i$  in the integrand. From (51) and (56), let us also define an approximation of the NLL integrated over time:

$$\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = -T \sum_{i=1}^m \log |\det(W^i)| - \sum_{i=1}^m \sum_{j=1}^p \tilde{\delta}_j^i . \quad (57)$$

Since  $\forall i \in \llbracket m \rrbracket, \forall j \in \llbracket p \rrbracket, \tilde{\delta}_j^i \rightarrow \delta_j^i$  as soon as  $\tau_j^i \rightarrow 0$  and  $\rho_j^i \rightarrow 1$ , we infer that  $\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) \rightarrow \mathcal{L}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho})$  as soon as  $\boldsymbol{\tau} \rightarrow \mathbf{0}$  and  $\boldsymbol{\rho} \rightarrow \mathbf{1}$ .

In the following, we replace  $\tilde{t}$  with  $t$  for simplicity. One can notice that, in (56),  $\mathbf{S}_j^i \left( \frac{1}{\rho_j^i} t + \tau_j^i \right)$  corresponds to the  $j$ -th component of  $\mathbf{Y}^i(t)$ , which is defined in the paper as  $\mathbf{Y}^i(t) = \overleftarrow{\mathcal{T}}_{\boldsymbol{\tau}^i, \boldsymbol{\rho}^i}(W^i \mathbf{X}^i)(t) \in \mathbb{R}^p$ . Let  $y_{j,t}^i := \mathbf{Y}_j^i(t) \in \mathbb{R}$ . The approximate-NLL is

$$\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = -T \sum_{i=1}^m \log |\det(W^i)| - \int_{t=0}^T \log \left( \prod_{j=1}^p \int_{s_{j,t} \in \mathbb{R}} \mathbb{P}_{\mathbf{S}_j}(s_{j,t}) \exp \left( -\frac{\sum_{i=1}^m (y_{j,t}^i - s_{j,t})^2}{2\sigma^2} \right) ds_{j,t} \right) dt . \quad (58)$$

Let us focus on the integral over  $s_{j,t}$ , then fix  $j$  and  $t$ , and drop them for simplicity. We need to solve

$$\int_s \mathbb{P}_{\mathbf{S}}(s) \exp \left( -\frac{\sum_{i=1}^m (y^i - s)^2}{2\sigma^2} \right) ds . \quad (59)$$

Following [27], we wish to rewrite (58) in terms of the sources averaged across views. To do so, we use the following decomposition. For any  $y \in \mathbb{R}$ ,

$$\begin{aligned} \sum_{i=1}^m (y^i - s)^2 &= \sum_{i=1}^m (y^i - y + y - s)^2 \\ &= m(y - s)^2 + \sum_{i=1}^m (y^i - y)^2 + 2(y - s) \sum_{i=1}^m (y^i - y) , \end{aligned} \quad (60)$$

and  $\sum_{i=1}^m (y^i - y)$  vanishes if we take  $y = \frac{1}{m} \sum_{i=1}^m y^i =: \bar{y}$ . So,

$$\begin{aligned} (59) &= \int_s \mathbb{P}_{\mathbf{S}}(s) \exp \left( -\frac{m(\bar{y} - s)^2 + \sum_{i=1}^m (y^i - \bar{y})^2}{2\sigma^2} \right) ds \\ &= \exp \left( -\frac{\sum_{i=1}^m (y^i - \bar{y})^2}{2\sigma^2} \right) \int_s \mathbb{P}_{\mathbf{S}}(s) \exp \left( -\frac{m}{2\sigma^2} (\bar{y} - s)^2 \right) ds \\ &= \exp \left( -\frac{\sum_{i=1}^m (y^i - \bar{y})^2}{2\sigma^2} \right) \exp(-f(\bar{y})) , \end{aligned} \quad (61)$$

by using a change of variable and where  $f$  is defined in the paper as

$$f(\bar{y}) := -\log \left( \int_s \mathbb{P}_{\mathbf{S}}(\bar{y} - s) \exp \left( -\frac{m}{2\sigma^2} s^2 \right) ds \right) . \quad (62)$$

Putting (61) into (58) gives

$$\begin{aligned} \tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) &= -T \sum_{i=1}^m \log |\det(W^i)| - \int_{t=0}^T \log \left( \prod_{j=1}^p \exp(-f(\bar{y}_{j,t})) \exp \left( -\frac{\sum_{i=1}^m (y_{j,t}^i - \bar{y}_{j,t})^2}{2\sigma^2} \right) \right) dt \\ &= -T \sum_{i=1}^m \log |\det(W^i)| - \int_{t=0}^T \log \left( \exp \left( -\sum_{j=1}^p f(\bar{y}_{j,t}) \right) \exp \left( -\frac{\sum_{i=1}^m \|\mathbf{Y}^i(t) - \bar{\mathbf{Y}}(t)\|^2}{2\sigma^2} \right) \right) dt , \end{aligned} \quad (63)$$

where  $\bar{\mathbf{Y}}(t)$  is defined in the paper as  $\bar{\mathbf{Y}}(t) = \frac{1}{m} \sum_{i=1}^m \mathbf{Y}^i(t)$ . It follows that

$$\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = -T \sum_{i=1}^m \log |\det(W^i)| + \int_{t=0}^T f(\bar{\mathbf{Y}}(t)) dt + \int_{t=0}^T \frac{1}{2\sigma^2} \sum_{i=1}^m \|\mathbf{Y}^i(t) - \bar{\mathbf{Y}}(t)\|^2 dt . \quad (64)$$

By dividing by  $T$ , we get that the averaged approximation of the negative log-likelihood over  $[0, T]$  is, up to a factor,

$$\tilde{\mathcal{L}}(\mathcal{W}, \boldsymbol{\tau}, \boldsymbol{\rho}) = - \sum_{i=1}^m \log |\det(W^i)| + \frac{1}{T} \int_{t=0}^T f(\bar{\mathbf{Y}}(t)) dt + \frac{1}{T} \int_{t=0}^T \frac{1}{2\sigma^2} \sum_{i=1}^m \|\mathbf{Y}^i(t) - \bar{\mathbf{Y}}(t)\|^2 dt . \quad (65)$$

In the paper, we call this approximate-NLL  $\mathcal{L}$  instead of  $\tilde{\mathcal{L}}$ . ■

## C Scale of the regularization term $\mathcal{R}_1$

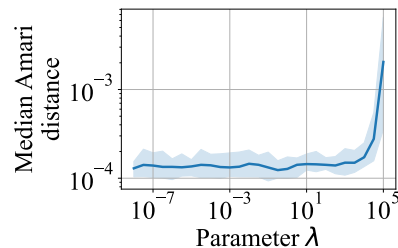


Figure 7: Amari distance of our method with respect to penalization scale.

This section addresses the choice of the hyperparameter  $\lambda \geq 0$ . This hyperparameter controls the weight given to the regularization term  $\mathcal{R}_1$ , which penalizes deviations when the subject-averaged delays and dilations are not centered. As shown in Figure 7, the Amari distance is relatively unaffected by  $\lambda$  as long as it remains below  $10^4$ . The sharp increase in error beyond this point can be attributed to  $\lambda\mathcal{R}_1(\boldsymbol{\tau}, \boldsymbol{\rho})$  dominating the other terms in the loss function, which causes the algorithm to focus primarily on optimizing  $\mathcal{R}_1(\boldsymbol{\tau}, \boldsymbol{\rho})$ . In practice, we set  $\lambda = 1$  by default.

## D Deriving dilations' scale $\Lambda^1$

*Proof.* Recall that  $\bar{\mathbf{Y}} : \mathbb{R} \rightarrow \mathbb{R}^p$  are the averaged estimated sources and let  $\tilde{\boldsymbol{\tau}} = (\tilde{\tau}_1, \dots, \tilde{\tau}_p)^\top \in \mathbb{R}^p$  be delays close to  $\mathbf{0}$  and  $\tilde{\boldsymbol{\rho}} = (\tilde{\rho}_1, \dots, \tilde{\rho}_p)^\top \in \mathbb{R}^p$  be dilations close to  $\mathbf{1}$ . Our goal is to find a vector  $\Lambda^1 = (\Lambda_1, \dots, \Lambda_p)^\top \in \mathbb{R}^p$  such that, for each source number  $j \in \llbracket p \rrbracket$ , delaying the  $j$ -th component  $\bar{\mathbf{Y}}_j$  by  $\Lambda_j \tilde{\tau}_j \in \mathbb{R}$  and dilating it by  $\tilde{\rho}_j \in \mathbb{R}$  have comparable effects on the quantity

$$\int_0^T \left\| \vec{\mathcal{T}}_{\Lambda^1 \odot \tilde{\boldsymbol{\tau}}, \tilde{\boldsymbol{\rho}}}(\bar{\mathbf{Y}})(t) - \bar{\mathbf{Y}}(t) \right\|^2 dt . \quad (66)$$

To do so, we use the second-order information of (66). More specifically, we want to calculate the Hessian matrix of (66) with respect to  $\tilde{\boldsymbol{\tau}}$  and  $\tilde{\boldsymbol{\rho}}$ .

We can rewrite (66) as

$$(66) = \sum_{j=1}^p \int_0^T \left( \vec{\mathcal{T}}_{\Lambda_j \tilde{\tau}_j, \tilde{\rho}_j}(\bar{\mathbf{Y}}_j)(t) - \bar{\mathbf{Y}}_j(t) \right)^2 dt , \quad (67)$$

where we observe that the pairs  $(\tilde{\tau}_j, \tilde{\rho}_j)_{j \in \llbracket p \rrbracket}$  have no effect on each other. Thus, the  $2p \times 2p$  Hessian matrix is a block-diagonal matrix, with  $p$  blocks of size  $2 \times 2$ , and we can treat each block separately.

Let us consider the  $j$ -th block of the Hessian, for a fixed  $j \in \llbracket p \rrbracket$ . For simplicity, we define  $\Lambda := \Lambda_j$ ,  $\tau := \tilde{\tau}_j$ ,  $\rho := \tilde{\rho}_j$ , and  $\forall t \in \mathbb{R}$ ,  $y(t) := \bar{\mathbf{Y}}_j(t)$ , with a slight abuse of notation for  $y$ , which is a signal written in lowercase letter instead of capital bold letter. We want to compute the Hessian of

$$F(\tau, \rho) := \int_0^T (y(\rho(t - \Lambda\tau)) - y(t))^2 dt , \quad (68)$$

with respect to  $\tau \in \mathbb{R}$  and  $\rho \in \mathbb{R}$ . Let us define the function

$$f : (t, \tau, \rho) \mapsto (y(\rho(t - \Lambda\tau)) - y(t))^2 . \quad (69)$$

We denote  $H_F(\tau, \rho) \in \mathbb{R}^{2 \times 2}$  (resp.  $H_f(\tau, \rho)(t) \in \mathbb{R}^{2 \times 2}$ ) the Hessian of  $F$  (resp. of  $f(t, \cdot, \cdot)$ ) with respect to  $\tau$  and  $\rho$ . Using Leibniz integral rule, we have

$$H_F(\tau, \rho) = \int_0^T H_f(\tau, \rho)(t) dt , \quad (70)$$

where taking the integral of a matrix means integrating each element of the matrix individually.

Our goal is to compare how fast function  $F$  varies when  $\tau$  and  $\rho$  vary around 0 and 1, respectively. To do so, we consider the elements in the diagonal of the matrix  $H_F(\tau, \rho) \in \mathbb{R}^{2 \times 2}$ , that is

$$\int_0^T \frac{\delta^2 f}{\delta \tau^2}(t, \tau, \rho) dt \quad \text{and} \quad \int_0^T \frac{\delta^2 f}{\delta \rho^2}(t, \tau, \rho) dt . \quad (71)$$

Simple calculations give

$$\frac{\delta^2 f}{\delta \tau^2}(t, \tau, \rho) = 2\Lambda^2 \rho^2 \left[ y'^2(\rho(t - \Lambda\tau)) + y''(\rho(t - \Lambda\tau)) [y(\rho(t - \Lambda\tau)) - y(t)] \right] , \quad (72)$$

where  $\Lambda^2$  is the square of  $\Lambda$ , and not the hyperparameter that controls the scale of delays and dilations relative to that of the unmixing matrices. Furthermore,

$$\frac{\delta^2 f}{\delta \rho^2}(t, \tau, \rho) = 2(t - \Lambda\tau)^2 \left[ y'^2(\rho(t - \Lambda\tau)) + y''(\rho(t - \Lambda\tau)) [y(\rho(t - \Lambda\tau)) - y(t)] \right] . \quad (73)$$



Thus, at the point  $(\tau, \rho) = (0, 1)$ , these second-order derivatives simplify to:

$$\frac{\delta^2 f}{\delta \tau^2}(t, 0, 1) = 2\Lambda^2 y'^2(t) , \quad (74)$$

and

$$\frac{\delta^2 f}{\delta \rho^2}(t, 0, 1) = 2t^2 y'^2(t) . \quad (75)$$

Consequently, the diagonal of the matrix  $H_F(0, 1) \in \mathbb{R}^{2 \times 2}$  is, up to the factor 2,

$$\left( \Lambda^2 \int_0^T y'^2(t) dt, \int_0^T t^2 y'^2(t) dt \right) . \quad (76)$$

So that the diagonal contains two times the same number, we must choose

$$\Lambda = \sqrt{\frac{\int_0^T t^2 y'^2(t) dt}{\int_0^T y'^2(t) dt}} . \quad (77)$$

This concludes the proof.

■

## E Hyperparameter $\Lambda^2$

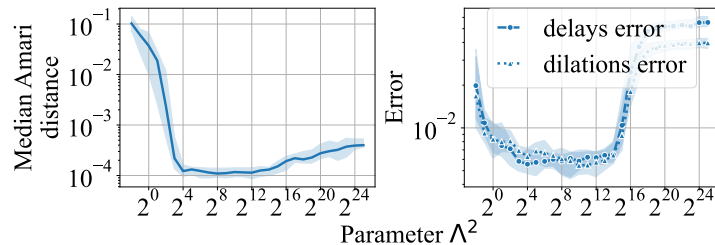


Figure 8: Amari distance (left) and time parameters errors (right) of our method with respect to the hyperparameter  $\Lambda^2$ .

This section provides details on selecting the hyperparameter  $\Lambda^2$ , which controls the scale of delays and dilations relative to that of the unmixing matrices. Figure 8 illustrates that, with our synthetic data settings (5 views, 3 sources, 600 samples,  $\tau_{\max} = 0.05$ , and  $\rho_{\max} = 1.15$ ), the Amari distance drops sharply until  $\Lambda^2$  reaches  $2^4$ . Additionally, the errors on delays and dilations increase significantly when  $\Lambda^2$  exceeds  $2^{14}$ . Therefore, in this context,  $\Lambda^2$  should be selected within  $[2^4, 2^{14}]$ , a range that fortunately does not require high specificity. This selection causes MVICAD<sup>2</sup> to prioritize optimizing delays and dilations over unmixing matrices, especially during the initial iterations.

## F Initialization

Algorithm 1 describes in detail the initialization algorithm. It works as follows. A single-view ICA algorithm, like Picard [1], is applied to each view  $\mathbf{X}^i$  to get the individual sources  $\mathbf{S}^i$ . Then, first-view sources  $\mathbf{S}^1$  are chosen as the reference and we iterate over the other sources  $\mathbf{S}^i$ ,  $i \geq 2$ . For each source number  $j \in \llbracket p \rrbracket$ , we iterate over  $k \in \llbracket p \rrbracket$  to check if  $\mathbf{S}_j^1$  and  $\mathbf{S}_k^i$  correspond to the same source. For such a pair, we test several combinations of delay  $\tau_k^i$  and dilation  $\rho_k^i$ , each one over a grid with  $n_{\text{grid}}$  points (typically set to 10). Only the combination that produces the highest correlation between  $\mathbf{S}_j^1$  and  $\overleftarrow{\mathcal{T}}_{\tau_k^i, \rho_k^i}(\mathbf{S}_k^i)$  is stored. Finally, we use the Hungarian algorithm to recover the optimal pairs of sources  $(j, k)$ . In the end, this procedure arranges the individual sources to match the order of the first-view’s sources and identifies delays and dilations that approximately align them.

## G Main algorithm

Algorithm 2 summarizes the entire pipeline. It starts with the initialization in Algorithm 1 and proceeds through the steps outlined in Section II of the paper. To speed up computations, we use Just-In-Time (JIT) compilation of the loss function and its gradient.
