The multiplicative constant in asymptotics of higher-order analogues of the Tracy-Widom distribution

Abstract

In this paper, we are concerned with higher-order analogues of the Tracy-Widom distribution, which describe the eigenvalue distributions in unitary random matrix models near critical edge points. The associated kernels are constructed by functions related to the even members of the Painlevé I hierarchy P_1^{2k} , $k \in \mathbb{N}^+$, and are regarded as higher-order analogues of the Airy kernel. We present a novel approach to establish the multiplicative constant in the large gap asymptotics of the distribution, resolving an open problem in the work of Clayes, Its and Krasovsky. An important new feature of the expression is the involvement of an integral of the Hamiltonian associated with a special, real, pole-free solution for P_I^{2k} . In addition, we show that the total integral of the Hamiltonian vanishes for all k , and establish a transition from the higher-order Tracy-Widom distribution to the classical one in the asymptotic regime. Our approach can also be adapted to calculate similar critical constants in other problems arising from mathematical physics.

1 Introduction and statement of results

Let \mathcal{M}_n be the space of $n \times n$ Hermitian matrices $M = (M_{ij})_{1 \leq i,j \leq n}$, equipped with the probability measure

\frac{1}{\mathcal{Z}_n} e^{-n \text{tr} V(M)} dM. \tag{1.1}
$$

Here,

denotes the Lebesgue measure for Hermitian matrices,

$$
\mathcal{Z}_n = \int_{\mathcal{M}_n} e^{-n \text{tr} V(M)} dM \tag{1.3}
$$

is the normalization constant, and the potential V is a real analytic function over $\mathbb R$ satisfying

$$
\lim_{|x| \to \infty} \frac{V(x)}{\log(1+x^2)} = +\infty.
$$

Due to the unitary invariant feature of (1.1) , it is well-known that $(cf. [24, 57])$ $(cf. [24, 57])$ $(cf. [24, 57])$ $(cf. [24, 57])$ the eigenvalues of M form a determinantal point process characterized by the correlation kernel

$$
K_n(x, y) := e^{-\frac{n}{2}(V(x) + V(y))} \sum_{i=0}^{n-1} p_i(x) p_i(y), \qquad (1.4)
$$

where $p_j(x) = \kappa_j x^j + \cdots, \ \kappa_j > 0$, are orthonormal polynomials associated with the weight function $e^{-nV(x)}$ over $\mathbb{R}, i.e.,$

$$
\int_{\mathbb{R}} p_i(x) p_j(x) e^{-nV(x)} dx = \delta_{i,j}.
$$
\n(1.5)

Various eigenvalue statistics are encoded in the correlation kernel K_n . The assumption on V ensures that the limiting mean eigenvalue distribution μ_V admits a density function ρ_V , which can be retrieved from the relation

$$
\lim_{n \to \infty} \frac{1}{n} K_n(x, x) = \rho_V(x); \tag{1.6}
$$

see [\[24,](#page-55-0) [31\]](#page-56-0). Moreover, μ_V is the unique equilibrium measure that minimizes the logarithmic energy functional [\[60\]](#page-58-0)

$$
I_V(\mu) = \iint \log \frac{1}{|x - y|} d\mu(x) d\mu(y) + \int V(x) d\mu(x), \tag{1.7}
$$

among all the probability measure μ on R. The remarkable result in [\[31\]](#page-56-0) shows that $\text{supp}(\mu_V)$ consists of a finite union of intervals, and

$$
\rho_V(x) = \frac{1}{\pi} \sqrt{\mathcal{Q}_V^-(x)},
$$
\n(1.8)

where \mathcal{Q}_V is a real analytic function depending on V and $\mathcal{Q}_V^ \overline{V}$ denotes its negative part.

In contrast to the limiting mean distribution, the local statistics of M are universal as the matrix size tends to infinity in the sense that it depends only on the local behaviors of the density function ρ_V ; see [\[3,](#page-54-0) [25,](#page-56-1) [32,](#page-56-2) [59\]](#page-58-1). This particularly implies that the microscopic limits of K_n will converge to several definite limiting kernels. For example, since generically ρ_V vanishes as a squared root at the endpoints of supp (μ_V) [\[54\]](#page-57-1), one encounters the so-called soft-edge universality. More precisely, let b_V be the rightmost endpoint of supp (μ_V) , there exists a constant c_V such that

\lim_{n \to \infty} \frac{1}{c_V n^{2/3}} K_n \left(b_V + \frac{x}{c_V n^{2/3}}, b_V + \frac{y}{c_V n^{2/3}} \right) = K_{\text{Ai}}(x, y), \tag{1.9}

uniformly for x and y in any compact subset of \mathbb{R} , where

$$
K_{\text{Ai}}(x, y) = \frac{\text{Ai}(x)\text{Ai}'(y) - \text{Ai}'(x)\text{Ai}(y)}{x - y}
$$
\n(1.10)

is the Airy kernel with Ai being the Airy function. This, together with the determinantal structure for the eigenvalues of M , also implies that (cf. [\[32\]](#page-56-2))

$$
\lim_{n \to \infty} \text{Prob}\left(c_V n^{\frac{2}{3}}(\lambda_n - b_V) < s\right) = \det(I - \mathbb{K}_s^{\text{Ai}}),\tag{1.11}
$$

where λ_n is the largest eigenvalue of M and $\mathbb{K}_s^{\mathbf{A}i}$ stands for the trace-class operator acting on $L^2(s,\infty)$ with the Airy kernel [\(1.10\)](#page-2-0).

The distribution $F_{\text{TW}}(s) := \det(I - \mathbb{K}_s^{\text{Ai}})$ is the celebrated Tracy-Widom distribution, whose appearance in a variety of physical, combinatorial and probabilistic models highlights the underlying connections among seemingly different areas; cf. [\[20\]](#page-55-1). An interesting result established in [\[62\]](#page-58-2) shows that the Tracy-Widom distribution admits the following integral representation:

$$
F_{\rm TW}(s) = \exp\left(-\int_s^\infty (x-s)q(x)^2 dx\right),\tag{1.12}
$$

where q is the Hastings-McLeod solution [\[43\]](#page-57-2) of the Painlevé II equation

$$
q''(x) = xq(x) + 2q(x)^3,
$$
\n(1.13)

fixed by the boundary condition

$$
q(x) \sim \begin{cases} \text{Ai}(x), & x \to +\infty, \\ \sqrt{-x/2}, & x \to -\infty. \end{cases}
$$
 (1.14)

Combining [\(1.12\)](#page-2-1) and [\(1.14\)](#page-2-2), the large gap asymptotics of the Airy-kernel determinant reads

$$
\log F_{\rm TW}(s) = \log \det(I - \mathbb{K}_s^{\rm Ai}) = -\frac{|s|^3}{12} - \frac{1}{8} \log |s| + \chi^{(0)} + \mathcal{O}(|s|^{-\frac{3}{2}}), \quad s \to -\infty,
$$
 (1.15)

where the constant term $\chi^{(0)}$ is conjectured in [\[62\]](#page-58-2) to be

$$
\chi^{(0)} = \frac{1}{24} \log 2 + \zeta'(-1) \tag{1.16}
$$

with $\zeta(z)$ being the Riemann zeta function. This conjecture was independently proved in [\[1,](#page-54-1) [27\]](#page-56-3); see also [\[52\]](#page-57-3) for the Airy-kernel determinant on two large intervals.

By tuning the potential V in [\(1.1\)](#page-1-1), it is possible that the limiting mean density ρ_V vanishes faster than a square root at the rightmost endpoint b_V , which leads to singular cases. According to [\[31,](#page-56-0) [54\]](#page-57-1), \mathcal{Q}_V has a zero of order $4k+1, k \in \mathbb{N} = 0, 1, 2, \ldots$, at b_V , which means that

$$
\rho_V(x) \sim \mathsf{c}_V |x - b_V|^{\frac{4k+1}{2}}, \qquad x \to b_V,\tag{1.17}
$$

for some positive constant c_V . At the singular edge points, the (multiple) scaling limit of the correlation kernel will be built from functions relevant to the Painlevé I hierarchy, as conjectured in the physical literature [\[6,](#page-54-2) [7\]](#page-55-2) and rigorously proved in [\[18\]](#page-55-3) for the case $k = 1$. More precisely, to obtain the most general result, one could deform the singular potential to be

$$
\widehat{V}(x) = V(x) + \sum_{i=0}^{2k-1} T_i V_i(x)
$$
\n(1.18)

for some functions V_i , where T_i are constants. In the multiple scaling regime, *i.e.*, $n \to \infty$ and simultaneously $T_i \to 0$ at an appropriate rate in n, it is expected that

$$
\lim_{n \to \infty} \frac{1}{c_V n^{2/(4k+3)}} K_n \left(b_V + \frac{u}{c_V n^{2/(4k+3)}}, b_V + \frac{v}{c_V n^{2/(4k+3)}} \right) = K^{(k)}(u, v), \tag{1.19}
$$

where the limiting kernel $K^{(k)}(u, v) = K^{(k)}(u, v; x, t_1, \ldots, t_{2k-1})$ depends on the real parameters x, t_1, \ldots, t_{2k-1} related to the scaling of T_0, \ldots, T_{2k-1} . Since the function $K^{(k)}$ is given explicitly in terms of solutions of the Lax pair associated with a distinguished solution of $2k$ -th member of the first Painlevé hierarchy (see [\(3.1\)](#page-14-2) below for the precise definition), we call $K^{(k)}$ the P^{2k}_{I} kernel.

As a consequence of [\(1.19\)](#page-3-0), it is readily seen that, as $n \to \infty$ and after proper scaling, the fluctuations of the largest eigenvalue of M around the edge b_V in the singular cases is governed by the higher-order analogues of the Tracy-Widom distribution $\det(I - \mathbb{K}_s^{(k)})$, where $\mathbb{K}_s^{(k)}$ is the trace-class operator acting on $L^2(s,\infty)$ with the P_1^{2k} kernel [\(1.19\)](#page-3-0). A natural question then is to explore the integrable structure and large gap asymptotics of this determinant, following the classical results [\(1.14\)](#page-2-2) and [\(1.15\)](#page-3-1) of the Tracy-Widom distribution. The investigation of this direction has been initiated by Claeys, Its and Krasovsky in [\[17\]](#page-55-4). It comes out that $\frac{d}{ds} \det(I - \mathbb{K}_s^{(k)})$ can be explicitly expressed in terms of a special smooth solution to the Painlevé II hierarchy, which generalizes the Tracy-Widom formula [\(1.12\)](#page-2-1). In addition, as $s \to -\infty$, it follows from [\[17,](#page-55-4) Theorem 1.5] that

$$
\log \det(I - \mathbb{K}_s^{(k)}) = \frac{1}{4} \alpha_k^2 \frac{s^{4k+3}}{4k+3} + \frac{\alpha_k}{2(2k+2)} x s^{2k+2} + \sum_{m=2}^{4k+1} a_m |s|^m + \frac{x^2 s}{4}
$$

$$
- \frac{2k+1}{8} \log |s| + C^{(k)} + \mathcal{O}(|s|^{-2}),
$$
 (1.20)

where

$$
\alpha_k := \frac{2\Gamma\left(2k + \frac{3}{2}\right)}{\Gamma\left(2k + 2\right)\Gamma\left(\frac{3}{2}\right)}\tag{1.21}
$$

with $\Gamma(z)$ being the gamma function, a_m are functions of x, t_1, \ldots, t_{2k-1} and vanish when $t_1 = t_2 = \ldots = t_{2k-1} = 0$. The s-independent constant $C^{(k)}$ is unknown except for $k = 0$. For our purpose, the variable and parameters used here are slightly different from those used in [\[17\]](#page-55-4), and they are related to each other through simple scalings

\det(I - \mathbb{K}_s^{(k)})(x, \dots, t_j, \dots, t_{2k-1})
$$
\n
$$
= \det \left(I - \mathbb{K}_{2^{\frac{2}{4k+3}}s}^{(k)}\right)_{\text{CIK}} \left(-2^{-\frac{4k+4}{4k+3}}x, \dots, (-1)^{j-1}2^{1-\frac{2j+1}{4k+3}}t_j, \dots, 2^{\frac{2}{4k+3}}t_{2k-1}\right),
$$
\n(1.22)

where $\det(I - \mathbb{K}_s^{(k)})_{\text{CIK}}$ stands for the determinant in [\[17\]](#page-55-4). Thus, it follows that

$$
\det(I - \mathbb{K}_s^{(0)}) = F_{\rm TW}(2^{\frac{2}{3}}s). \tag{1.23}
$$

Clearly, there is no accurate description of the large gap asymptotics for the higher-order Tracy-Widom distribution without the explicit formula of $C^{(k)}$. Evaluation of the constant term in asymptotics of various distributions, the Painlevé equations or Hankel/Toeplitz determinants arising from mathematical physics, however, is a great challenge with a long history; cf. [\[26,](#page-56-4) [46,](#page-57-4) [47,](#page-57-5) [48,](#page-57-6) [50\]](#page-57-7). The constant term appearing in the asymptotics of sine determinant is also known as the Widom-Dyson constant, which was first obtained by Dyson [\[37\]](#page-56-5) based on an earlier work of Widom [\[64\]](#page-58-3). A rigorous derivation of the Widom-Dyson constant was given independently in [\[38,](#page-56-6) [51\]](#page-57-8); see also [\[2,](#page-54-3) [28\]](#page-56-7). In addition to the Airy-kernel and sine-kernel determinants, the multiplicative constant problems were solved in [\[30,](#page-56-8) [39\]](#page-56-9) for the Bessel-kernel determinants, in [\[11,](#page-55-5) [12\]](#page-55-6) for the determinants of some generalized Bessel kernels, in [\[5,](#page-54-4) [22,](#page-55-7) [65\]](#page-58-4) for the determinants of Painlevé-type kernels and in $[8, 10]$ $[8, 10]$ for two-dimensional point processes.

It is the aim of this work to resolve the constant problem for the higher-order Tracy-Widom distribution by a novel approach. We present our main results in what follows.

1.1 Main results

We start with the introduction of the Painlevé I hierarchy P_I^m ; cf. [\[41,](#page-57-9) [53,](#page-57-10) [58,](#page-58-5) [61\]](#page-58-6). The m-th member of P_I^m is a nonlinear ordinary differential equation of order $2m$ defined by

$$
x + \mathcal{L}_m(q) + \sum_{j=1}^{m-1} t_j \mathcal{L}_{j-1}(q) = 0, \qquad t_1, \dots, t_{m-1} \in \mathbb{R},
$$
\n(1.24)

where the operator $\mathcal L$ satisfies the Lenard-Magri recursion relation

$$
\begin{cases}\n\frac{d}{dx}\mathcal{L}_{k+1}(q) = \left(\frac{1}{4}\frac{d^3}{dx^3} - 2q\frac{d}{dx} - q_x\right)\mathcal{L}_k(q), & k = 0, \dots, m-1, \\
\mathcal{L}_0(q) = -4q, & \mathcal{L}_j(0) = 0, \quad j = 1, \dots, m.\n\end{cases}
$$
\n(1.25)

If $m = 1$ in [\(1.24\)](#page-4-1), one recovers the Painlevé I equation $q_{xx} = 6q^2 + x$, and the equation for $m = 2$ reads

$$
q_{xxxx} = 4x - 40q^3 + 10q_x^2 + 20qq_x - 16t_1q^* \tag{1.26}
$$

*After the rescalings $U = -60^{2/7}q$, $X = 60^{-1/7}x$, and $T = -4 \times 60^{-3/7}t_1$, this equation reduces to

$$
\frac{1}{240}U_{XXXX} + \frac{1}{24}(U_X^2 + 2UU_{XX}) + \frac{1}{6}U^3 + X - TU = 0,
$$

which is the P_1^2 equation studied in several literature [\[14,](#page-55-10) [18,](#page-55-3) [42\]](#page-57-11).

The relevance to our work is the even member of the Painlevé I hierarchy. It follows from a series of works [\[14,](#page-55-10) [19,](#page-55-11) [49\]](#page-57-12) that there exists a real and pole-free solution q to each equation P_I^{2k} with the boundary condition

$$
\mathsf{q}(x) = \frac{1}{2} \alpha_k^{-\frac{1}{2k+1}} x^{\frac{1}{2k+1}} + \mathcal{O}\left(|x|^{-\frac{1}{2k+1}}\right), \qquad x \to \pm \infty,
$$
 (1.27)

where α_k is given in [\(1.21\)](#page-4-3). For P_1^2 , q is called the tritronquée solution in [\[42\]](#page-57-11), and it is worth noting that this family of special functions is essential to describe the critical behaviors for the solutions of a large class of Hamiltonian PDEs [\[14,](#page-55-10) [34,](#page-56-10) [35,](#page-56-11) [36\]](#page-56-12); see also [\[15,](#page-55-12) [16\]](#page-55-13) for the studies in the context of Korteweg-de Vries equation and its hierarchy. It comes out the Hamiltonian associated with q will appear in the evaluation of the multiplicative constant $C^{(k)}$.

Theorem 1.1. For $k = 1, 2, ...,$ let $\mathbb{K}_s^{(k)}$ be the trace-class operator acting on $L^2(s, \infty)$ with the kernel $K^{(k)}(u, v)$ [\(1.19\)](#page-3-0) and define

$$
F(s; x, t_1, \dots, t_{2k-1}) := \log \det(I - \mathbb{K}_s^{(k)}).
$$

Assume that $t_1 = t_2 = \ldots = t_{2k-1} = 0$, we have, as $s \to -\infty$,

F(s; x) = F(s; x, 0, ..., 0)
$$

= $\frac{1}{4(4k+3)} \alpha_k^2 s^{4k+3} + \frac{\alpha_k}{2(2k+2)} x s^{2k+2} + \frac{x^2 s}{4} - \frac{1}{8} \log |\alpha_k s^{2k+1} + x|$

+ $\frac{\log(2k+1)}{24} + \frac{\log \alpha_k}{24(2k+1)} + \chi^{(0)} + \mathcal{O}(|s|^{-\epsilon_0}),$ (1.29)

uniformly valid for $x \in [-c_1|s|^{2k+1}, \alpha_k|s|^{2k+1} - c_2|s|^{\frac{2k}{3} + \epsilon}$ with c_1, c_2 being arbitrarily fixed real positive numbers and fixed $\epsilon \in (0, \frac{4k}{3} + 1)$, where $\epsilon_0 = \min\{\frac{1}{6}\}\$ $\frac{1}{6}$, 2 ϵ }. Here, the constants α_k and $\chi^{(0)}$ are defined in [\(1.21\)](#page-4-3) and [\(1.16\)](#page-3-2), respectively,

$$
I_h(x) := -\int_{-\infty}^x [h(\mu) - h_{\text{Asy}}(\mu)] d\mu = \int_x^{+\infty} [h(\mu) - h_{\text{Asy}}(\mu)] d\mu,
$$
 (1.30)

where h is the Hamiltonian associated with the special solution q of the Painlevé I hierarchy P_I^{2k} [\(1.24\)](#page-4-1) and

$$
h_{\text{Asy}}(x) := \frac{(2k+1)}{2(2k+2)} \alpha_k^{-\frac{1}{2k+1}} \cdot x^{\frac{2k+2}{2k+1}} + \frac{kx}{12(2k+1)(x^2+1)}.
$$
\n(1.31)

The Hamiltonian $h(x) = h(x, t_1, \ldots, t_{2k-1})$ is related to q through the relation $dh(x)/dx =$ $q(x)$, and following the analysis in [\[14\]](#page-55-10) (see also Appendix [C](#page-51-0) below), we have, if $t_1 = t_2 = \ldots =$ $t_{2k-1} = 0$,

$$
h(x) = h_{\text{Asy}}(x) + \mathcal{O}\left(|x|^{-\frac{8k+5}{4k+2}}\right), \qquad x \to \pm \infty,
$$
\n(1.32)

where h_{Asy} is defined in [\(1.31\)](#page-5-1). Thus, the function I_h in [\(1.30\)](#page-5-2) is well-defined. We also mention that it is possible to improve the error estimate in [\(1.29\)](#page-5-3). Since the main focus of this work is on the constant term and uniformity of the expansion in x , we do not pursue an optimal error estimate here.

We assume that all the parameters t_j , $j = 1, \ldots, 2k - 1$, vanish in Theorem [1.1](#page-5-0) to simplify the asymptotic formula. For general non-zero t_j , it is expected that there will be extra terms for the powers of s and x, whose coefficients are dependent on t_j . Our analysis is also applicable to handle this case. Below, we present the result for $k = 1$; see Remark [4.2](#page-19-1) below for some explanations.

Corollary 1.2. Let $h(\mu, t_1)$ be the Hamiltonian corresponding to the P_1^2 tritronquée solution q. As $s \to -\infty$, we have

uniformly valid for t_1 in any compact subset of $\mathbb R$ and $x \in [-c_1|s|^3, \frac{5}{4}$ $\frac{5}{4}|s|^3 - c_2|s|^{\frac{2}{3}+\epsilon}$ with $c_1, c_2 > 0$ and $\epsilon \in (0, \frac{7}{3})$ $\frac{7}{3}$) being fixed, where $\chi^{(0)}$ is defined in [\(1.16\)](#page-3-2),

J_0(x, t_1) = \int_x^{+\infty} \left[h(\mu, t_1) - h_{\text{Asy}}(\mu, t_1) \right] d\mu \tag{1.34}

with

$$
J_1(x,t_1) = \frac{9}{56} \left(\frac{4}{5}\right)^{\frac{1}{3}} x^{\frac{7}{3}} - \frac{3t_1}{10} \left(\frac{4}{5}\right)^{\frac{2}{3}} x^{\frac{5}{3}} + \frac{4t_1^2}{15} x - \frac{8}{45} \left(\frac{4}{5}\right)^{\frac{1}{3}} t_1^3 x^{\frac{1}{3}}.

If x belongs to a compact subset of \mathbb{R} , one can further simplify [\(1.29\)](#page-5-3) by noting that $\log |\alpha_k s^{2k+1} + x| = \log |\alpha_k s^{2k+1}| + \mathcal{O}(|s|^{-2k-1})$ as $s \to -\infty$. This particularly leads to [\(1.20\)](#page-3-3) with $a_m = 0, m = 2, ..., 4k + 1$, and

$$
C^{(k)} = \int_{-\infty}^{x} \left[h(\mu) - h_{\text{Asy}}(\mu) \right] d\mu + \frac{(2k+1)^2}{2(2k+2)(4k+3)} \alpha_k^{-\frac{1}{2k+1}} \cdot x^{\frac{4k+3}{2k+1}} + \frac{k \log(x^2+1)}{24(2k+1)} + \frac{\log(2k+1)}{24} - \frac{1+3k}{12(2k+1)} \log \alpha_k + \chi^{(0)}.
$$
 (1.37)

Two applications of our main theorem are given in sequel. In view of [\(1.30\)](#page-5-2), it is immediate that the total integral of the Hamiltonian corresponding to the special solution q vanish.

Corollary 1.3. With the same Hamiltonian h as in Theorem [1.1,](#page-5-0) we have

$$
\int_{-\infty}^{+\infty} \left[h(\mu) - h_{\text{Asy}}(\mu) \right] d\mu = 0. \tag{1.38}
$$

This formula generalizes the result in [\[21\]](#page-55-14), where the above equality is proved for the P_1^2 case.

The other application of Theorem [1.1](#page-5-0) follows from the uniformity of (1.29) in x. By a proper scaling of x in terms of s, one could recover the asymptotics of Tracy-Widom distribution, as stated in the following corollary.

Corollary 1.4. With $F(s; x)$ defined in [\(1.29\)](#page-5-3), we have, as $s \to -\infty$,

$$
F\left(s;\alpha_k|s|^{2k+1} + (2k+1)^{\frac{1}{3}}\alpha_k^{\frac{1}{3}}\tilde{s}|s|^{\frac{2k}{3}}\right) = -\frac{1}{12}|\tilde{s}|^3 - \frac{1}{8}\log|\tilde{s}| + \chi^{(0)} + o(1),\tag{1.39}
$$

uniformly for $|s|^{\epsilon} \ll -\tilde{s} \ll |s|^{\frac{k}{3}+\frac{1}{4}}$, where ϵ is any real number belonging to $(0, \frac{k}{3} + \frac{1}{4})$ $(\frac{1}{4}),$ the constants α_k and $\chi^{(0)}$ are defined in [\(1.21\)](#page-4-3) and [\(1.16\)](#page-3-2), respectively.

The above corollary is straightforward when replacing x by $\alpha_k|s|^{2k+1} + (2k+1)^{\frac{1}{3}}\alpha_k^{\frac{1}{3}}\tilde{s}|s|^{\frac{2k}{3}}$ in [\(1.29\)](#page-5-3). It particularly reveals the transition from higher-order analogues of Tracy-Widom distribution to the classical Tracy-Widom distribution in the large gap asymptotic regime. It is also worth noting that a transition from the $P_I²$ kernel to the Airy kernel was established in [\[13\]](#page-55-15), which should compare with [\(1.39\)](#page-7-1) for $k = 1$.

1.2 Strategy of the proof

With $F(s; x)$ defined in [\(1.29\)](#page-5-3), it is readily seen that $F(+\infty; x) = 0$, and thus

$$
F(s;x) = -\int_{s}^{+\infty} \frac{\partial F}{\partial \tau}(\tau; x) d\tau.
$$
 (1.40)

The large gap asymptotics of F then follows from the asymptotics of $\frac{\partial F}{\partial s}(s; x)$ as $s \to -\infty$. Particularly, due to the integrable structure of the P_1^{2k} kernel (see [\(3.1\)](#page-14-2) below), $\frac{\partial F}{\partial s}(s; x)$ is related to a Riemann-Hilbert (RH) problem under a general framework established in [\[29\]](#page-56-13). By performing the powerful Deift-Zhou nonlinear steepest descent analysis [\[33\]](#page-56-14) for the associated RH problem, one finally achieves the goal. This is exactly the idea adapted in [\[17\]](#page-55-4) to establish [\(1.20\)](#page-3-3).

An insurmountable obstacle occurs if one wants to further evaluate the constant of integration $C^{(k)}$ by the same strategy. The challenge lies in the fact that one needs to understand detailed information of $\frac{\partial F}{\partial s}(s; x)$ across an infinite interval $(s, +\infty)$ for that purpose. This seems impracticable since the function $\frac{\partial F}{\partial s}(s; x)$ is highly transcendental (see [\[17,](#page-55-4) Theorem 1.12]). This limitation also explains why most of the similar constant problems arising from mathematical physics remain open.

To overcome this difficulty, the key idea in our approach is to investigate uniform asymptotics of the partial derivatives of $F(s; x)$ with respect to both s and x. The motivation follows from the observation that

$$
F(s;x) = -\int_{x}^{x_0} \frac{\partial F}{\partial \mu}(s;\mu)d\mu - \int_{s}^{+\infty} \frac{\partial F}{\partial \tau}(\tau;x_0)d\tau, \tag{1.41}
$$

which is valid for any real x_0 . In particular, the arbitrariness of x_0 provides the flexibility of choosing the variable $|x_0|$ to be large alongside the variable $|s|$. This is essential in the sense that the behaviors of $\frac{\partial F}{\partial x}(s; x)$ and $\frac{\partial F}{\partial s}(s; x)$ degenerate in the asymptotic regime, which can be readily established through their connections with RH problems. It comes out that both $\frac{\partial F}{\partial s}(s; x)$ and $\frac{\partial F}{\partial x}(s; x)$ exhibit qualitatively different asymptotic behaviors in three different regions of the (x, s) -plane as illustrated in Figure [1](#page-8-0) and explained next.

• (Algebraic growth region) This region lies on the left hand side of the critical curve $x = -\alpha_k s^{2k+1}$; see the blue part of Figure [1.](#page-8-0) The partial derivatives of F grow like powers of s in this region; see Lemmas [2.1](#page-10-1) and [2.2](#page-10-2) for detailed descriptions.

Figure 1: The three regions in asymptotic studies of $\frac{\partial}{\partial s}F(s; x)$ and $\frac{\partial}{\partial x}F(s; x)$. The exponentially decay and algebraic growth regions are separated by the transitional region in the middle. The dashed curve stands for the critical curve $x = -\alpha_k s^{2k+1}$, where α_k is given in [\(1.21\)](#page-4-3).

- (Exponential decay region) This region lies on the right hand side of the critical curve $x = -\alpha_k s^{2k+1}$; see the yellow part of Figure [1.](#page-8-0) The partial derivatives of F decay exponentially in this region; see Lemma [2.4](#page-11-1) for a detailed description.
- (Transition region) This region bridges the aforementioned two regions, which surrounds the critical curve $x = -\alpha_k s^{2k+1}$. Transition asymptotics in this region involves the Hamiltonian associated with the Hastings-McLeod solution of the Painlevé II equation; see Lemma [2.3](#page-11-0) for a detailed description.

As long as uniform asymptotics of the partial derivatives of $F(s; x)$ are available, we are able to determine the multiplicative constant in the asymptotics of $F(s; x)$ after substituting the integrand in [\(1.41\)](#page-7-2) by their asymptotic approximations. More precisely, we will set $x_0 =$ $\pm |s|^{2k+1}$ in [\(1.41\)](#page-7-2), replace the contour of integration therein by the lines depicted in Figure [2](#page-9-0) and conduct the following derivation.

- To evaluate the integral $\int_x^{x_0}$ $\frac{\partial F}{\partial \mu}(s;\mu)d\mu$, we note that (s,μ) with $\mu \in (x,x_0)$ is always contained in the algebraic growth region of Figure [1.](#page-8-0) The asymptotic approximation then follows from the result in Lemma [2.1.](#page-10-1)
- To evaluate the integral $\int_s^{+\infty}$ $\frac{\partial F}{\partial \tau}(\tau; x_0)d\tau$, we split the interval of integration into three parts: (s, s_1) , (s_1, s_2) and $(s_2, +\infty)$, as shown in Figure [2.](#page-9-0) These three sub-intervals lie in the algebraic growth region, the transition region and the exponential decay region, respectively. Uniform asymptotics of the $\frac{\partial}{\partial s}F(s; x)$ for each region are available in Lemmas [2.2–](#page-10-2)[2.4.](#page-11-1) It is worth noting that the integral over (s_1, s_2) in the transition region will contribute to the nontrivial constant term $\chi^{(0)}$ in [\(1.16\)](#page-3-2) in the asymptotics of $F(s; x)$.

Figure 2: The contours of integration in the (x, s) -plane. We choose the red lines if $x_0 > 0$ and the blue lines if $x_0 < 0$. The dashed curve is the critical curve $x = -\alpha_k s^{2k+1}$, where α_k is given in [\(1.21\)](#page-4-3).

In the proof of Theorem [1.1,](#page-5-0) it suffices to choose either the red or the blue lines of integration depicted in Figure [2.](#page-9-0) Given that the final asymptotic result remains the same regardless of the chosen contour, we can compare the asymptotic results obtained with $x_0 = -|s|^{2k+1}$ and $x_0 = |s|^{2k+1}$. This comparison leads to the total integral for the Hamiltonian in [\(1.38\)](#page-6-0), which is a by-product of our major findings.

Finally, we believe that our approach has the advantage of being applicable to evaluate the similar multiplicative constant encountered in the studies of large gap asymptotics. Some examples include the (hard-edge) Pearcey determinant [\[23,](#page-55-16) [67\]](#page-58-7), the higher order Airy determinant [\[9\]](#page-55-17) and the determinants associated with transcendental kernels constructed from the Painlevé II hierarchy. We plan to report the relevant results in future publications.

Organization of the paper The rest of the paper is organized as follows. In Section [2,](#page-10-0) we state four key lemmas about the uniform asymptotics of partial derivatives of F in different asymptotic regions. A combination of these lemmas will lead to the proof of Theorem [1.1.](#page-5-0) In Section [3,](#page-14-0) a few preliminary work is made to prepare for the asymptotic analysis. This includes formulation of RH problems and derivations of two differential identities. The Deift-Zhou steepest analysis of the associated RH problems is conducted in Sections [4–](#page-18-0)[6,](#page-39-0) which serves to validate the lemmas presented in Section [2.](#page-10-0) Additional generalizations of the existing asymptotic results are provided in Appendices [A–](#page-44-0)[C](#page-51-0) to complete the analysis presented in this paper.

Notations Throughout this paper, the following notations are frequently used.

- If A is a matrix, then $(A)_{ij}$ stands for its (i, j) -th entry and A^T stands for its transpose. An unimportant entry of A is denoted by \star . We use I to denote the identity matrix.
- We denote by $U(z_0; r)$ the open disc centered at z_0 with radius $r > 0$, *i.e.*,

$$
U(z_0; r) := \{ z \in \mathbb{C} \mid |z - z_0| < r \},\tag{1.42}
$$

and by $\partial U(z_0; r)$ its boundary. The orientation of $\partial U(z_0; r)$ is taken in a clockwise manner.

• As usual, the Pauli matrices $\{\sigma_j\}_{j=1}^3$ are

$$
\sigma_1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \qquad \sigma_2 = \begin{pmatrix} 0 & -i \\ i & 0 \end{pmatrix}, \qquad \sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}.
$$
 (1.43)

- If a function $f(z)$ admits a pole at z_0 , we use $\text{Res}(f(z), z_0)$ to denote its residue at z_0 .
- We will perform Deift-Zhou nonlinear steepest descent analysis for a RH problem several times. We adopt the same notations (such as R, v_R, \ldots) during each analysis. They should be understood in different contexts, and we trust that this will not lead to any confusion.

2 Key lemmas and proof of Theorem [1.1](#page-5-0)

Recall [\(1.41\)](#page-7-2) and denote the integrals therein by

$$
I_1(s; x, x_0) := \int_x^{x_0} \frac{\partial F}{\partial \mu}(s; \mu) d\mu, \qquad I_2(s; x_0) = \int_s^{+\infty} \frac{\partial F}{\partial \tau}(\tau; x_0) d\tau. \tag{2.1}
$$

As mentioned before, we take $x_0 = \pm |s|^{2k+1}$ and derive the asymptotics of $I_1(s; x, x_0)$ and $I_2(s; x_0)$ as $s \to -\infty$. To achieve this goal, we need the following key lemmas, whose proofs will be postponed in Sections [4.3,](#page-25-0) [5.3](#page-37-0) and [6.2,](#page-43-0) respectively. These lemmas provide essential asymptotics for the partial derivatives of $F(s; x)$ in the (x, s) -plane, under which Theorem [1.1](#page-5-0) will be proved.

Lemma 2.1 (Large s asymptotics of $\frac{\partial F}{\partial x}$ in the algebraic growth region). Let α_k be defined in (1.21) and $h(x)$ be the Hamiltonian associated with the special solution q of the Painlevé I hierarchy P_I^{2k} [\(1.24\)](#page-4-1). As $s \to -\infty$, we have

$$
\frac{\partial F}{\partial x}(s;x) = h(x) + \frac{\alpha_k}{4k+4}s^{2k+2} + \frac{xs}{2} - \frac{1}{8(\alpha_k s^{2k+1} + x)} \left(1 + \mathcal{O}(|s|^{-3\epsilon})\right),\tag{2.2}
$$

uniformly for all $x \in [-c_1|s|^{2k+1}, \alpha_k|s|^{2k+1} - c_2|s|^{\frac{2k}{3} + \epsilon}$, where c_1, c_2 and ϵ are three arbitrarily fixed positive constants with $\epsilon \in (0, \frac{4k}{3} + 1)$.

Lemma 2.2 (Large x asymptotics of $\frac{\partial F}{\partial s}$ in the algebraic growth region). With α_k given in [\(1.21\)](#page-4-3), we have

$$
\frac{\partial F}{\partial s}(s;x) = \frac{1}{4} \left(\alpha_k s^{2k+1} + x \right)^2 - \frac{(2k+1)\alpha_k s^{2k}}{8\left(\alpha_k s^{2k+1} + x \right)} \left(1 + \mathcal{O}(|x|^{-\frac{k+\frac{1}{2}}{2k+1}}) \right) \tag{2.3}
$$

as $|x| \to +\infty$, uniformly for s such that $\alpha_k s^{2k+1} + x \in \left[-M|x|, -C|x|^{\frac{k+1/6}{2k+1}}\right]$. Here, M and C are two arbitrarily positive constants.

Lemma 2.3 (Large x asymptotics of $\frac{\partial F}{\partial s}$ in the transition region). As $|x| \to +\infty$, we have

$$
\frac{\partial F}{\partial s}(s;x) = \frac{\partial \chi(s;x)}{\partial s} H_{\rm P_{II}}\left(\chi(s;x)\right) \left(1 + \mathcal{O}(|x|^{-\frac{k+5/6}{2k+1}})\right) + \mathcal{O}(|x|^{\frac{k-1/3}{2k+1}}),\tag{2.4}
$$

uniformly for s such that $\alpha_k s^{2k+1} + x \in \left[-C|x|^{\frac{k+1/6}{2k+1}} , C|x|^{\frac{k+1/6}{2k+1}} \right]$. Here, C is an arbitrarily fixed positive constant, α_k is defined in [\(1.21\)](#page-4-3), $H_{\rm{P_{II}}}(\cdot)$ is the Hamiltonian corresponding to the Hastings-McLeod solution of the Painlevé II equation and

$$
\chi(s;x) := \begin{cases} \frac{\alpha_k s^{2k+1} + x}{(2k+1)^{\frac{1}{3}} \alpha_k^{\frac{1}{3(2k+1)}} x^{\frac{2k}{3(2k+1)}}}, & \alpha_k s^{2k+1} + x \in \left[-C|x|^{\frac{k+1/6}{2k+1}}, 0 \right],\\ f_3\left(s; s_0\right), & \alpha_k s^{2k+1} + x \in \left[0, C|x|^{\frac{k+1/6}{2k+1}} \right], \end{cases} \tag{2.5}
$$

is a continuous and piecewise differentiable function. In the above formula, the function f_3 is defined in [\(5.54\)](#page-36-0) and

$$
s_0 = -\left(x/\alpha_k\right)^{\frac{1}{2k+1}}.\tag{2.6}
$$

Lemma 2.4 (Large x asymptotics of $\frac{\partial F}{\partial s}$ in the exponential decay region). There exists a positive constant M such that as $|x| \to +\infty$,

$$
\frac{\partial F}{\partial s}(s;x) = \mathcal{O}\left(e^{-M|x|^{\frac{4k}{4k+2}}(s-s_0)^{\frac{3}{2}}}\right),\tag{2.7}
$$

uniformly for all s such that $\alpha_k s^{2k+1} + x \in \left[C|x|^{\frac{k+1/6}{2k+1}}, +\infty\right]$. Here, C is an arbitrarily fixed positive constant, α_k is defined in [\(1.21\)](#page-4-3) and s_0 is given in [\(2.6\)](#page-11-2).

Remark 2.5. Note that in the transition region, both |s| and |x| are large. Although the error term in [\(2.4\)](#page-11-3) is large as $|x| \to +\infty$, its contribution to the asymptotics of $F(s; x)$ as $s \to -\infty$ is small since the integration interval with respect to s in the transition region is small enough and we refer to the proof of Theorem [1.1](#page-5-0) below for a detailed discussion.

With the aid of the above lemmas, we are ready to prove our main theorem.

Proof of Theorem [1.1](#page-5-0) Let us first consider the integral $I_1(s; x, x_0)$ in [\(2.1\)](#page-10-3). According to Figures [1](#page-8-0) and [2,](#page-9-0) the contour of integration is always contained in the algebraic region. It then follows from a combination of [\(1.31\)](#page-5-1) and [\(2.2\)](#page-10-4) that, as $s \to -\infty$,

$$
I_1(s; x, x_0) = \int_x^{x_0} [h(\mu) - h_{\text{Asy}}(\mu)] d\mu + \int_x^{x_0} h_{\text{Asy}}(\mu) d\mu + \int_x^{x_0} \left[\frac{\alpha_k s^{2k+2}}{4k+4} + \frac{\mu s}{2} \right] d\mu
$$

$$
- \frac{1}{8} \int_x^{x_0} \frac{1}{\alpha_k s^{2k+1} + \mu} d\mu + \mathcal{O}(|s|^{-2\epsilon})
$$

$$
= I_{1,1}(x, x_0) + I_{1,2}(s; x_0) - I_{1,2}(s; x) + \mathcal{O}(|s|^{-2\epsilon}),
$$
 (2.8)

uniformly for all $x \in \left[-c_1|s|^{2k+1}, \alpha_k|s|^{2k+1} - c_2|s|^{\frac{2k}{3} + \epsilon}\right]$, where c_1, c_2, ϵ are three arbitrary fixed positive constants with $\epsilon \in (0, \frac{4k}{3} + 1)$, where

$$
I_{1,1}(x, x_0) = \int_x^{x_0} [h(\mu) - h_{\text{Asy}}(\mu)] d\mu
$$

=
$$
\begin{cases} \int_x^{+\infty} [h(\mu) - h_{\text{Asy}}(\mu)] d\mu + \mathcal{O}(|s|^{-(4k+3)/2}), & \text{when } x_0 = |s|^{2k+1}, \\ -\int_{-\infty}^x [h(\mu) - h_{\text{Asy}}(\mu)] d\mu + \mathcal{O}(|s|^{-(4k+3)/2}), & \text{when } x_0 = -|s|^{2k+1}, \end{cases}
$$
(2.9)

and

$$
I_{1,2}(s;x) = \frac{(2k+1)^2}{2(2k+2)(4k+3)} \alpha_k^{-\frac{1}{2k+1}} \cdot x^{\frac{4k+3}{2k+1}} + \frac{k}{24(2k+1)} \log(x^2+1) + \frac{\alpha_k}{4k+4} s^{2k+2} x + \frac{1}{4} x^2 s - \frac{1}{8} \log|\alpha_k s^{2k+1} + x|.
$$
\n(2.10)

Next, we proceed to compute the second integral $I_2(s; x_0)$ in [\(2.1\)](#page-10-3). In view of Figures [1](#page-8-0) and [2](#page-9-0) again, the contour of integration has to cross all the algebraic growth, transition and exponential decay regions. Based on this observation, we further divide the contour of integration into three parts: (s, s_1) ∪ (s_1, s_2) ∪ $(s_2, +\infty)$, where

$$
s_1 := -\left(\frac{x_0}{\alpha_k}\right)^{\frac{1}{2k+1}} (1 + \text{sgn}(x_0)|s|^{-k - \frac{5}{6}})^{\frac{1}{2k+1}},
$$

\n
$$
s_2 := -\left(\frac{x_0}{\alpha_k}\right)^{\frac{1}{2k+1}} (1 - \text{sgn}(x_0)|s|^{-k - \frac{5}{6}})^{\frac{1}{2k+1}}.
$$
\n(2.11)

With the choice of $x_0 = \pm |s|^{2k+1}$, we have from the above formula that

$$
\alpha_k s_1^{2k+1} + x_0 = -|s|^{k+\frac{1}{6}} = -|x_0|^{\frac{k+1/6}{2k+1}} \quad \text{and} \quad \alpha_k s_2^{2k+1} + x_0 = |s|^{k+\frac{1}{6}} = |x_0|^{\frac{k+1/6}{2k+1}}.\tag{2.12}
$$

Then, we rewrite $I_2(s; x_0)$ as

$$
I_2(s; x_0) = \int_s^{s_1} \frac{\partial F}{\partial \tau}(\tau; x_0) d\tau + \int_{s_1}^{s_2} \frac{\partial F}{\partial \tau}(\tau; x_0) d\tau + \int_{s_2}^{+\infty} \frac{\partial F}{\partial \tau}(\tau; x_0) d\tau = I_{2,1}(s; x_0) + I_{2,2}(s; x_0) + I_{2,3}(s; x_0),
$$
\n(2.13)

and calculate the three terms $I_{2,j}(s; x_0)$, $j = 1, 2, 3$, one by one. According to Lemma [2.2,](#page-10-2) we have

$$
I_{2,1}(s;x_0) = J_2(s_1;x_0) - J_2(s;x_0) + \frac{1}{8} \log \left| \alpha_k s^{2k+1} + x_0 \right| - \frac{1}{8} \log \left| \alpha_k s^{2k+1} + x_0 \right| + \mathcal{O}(|s|^{-k}), \tag{2.14}
$$

as $s \to -\infty$, where

$$
J_2(s; x_0) = \frac{\alpha_k^2}{4(4k+3)} s^{4k+3} + \frac{\alpha_k}{4k+4} x_0 s^{2k+2} + \frac{1}{4} x_0^2 s. \tag{2.15}
$$

Moreover, Lemma [2.4](#page-11-1) implies that $I_{2,3}(s; x_0)$ is exponentially small as $s \to -\infty$.

The remaining task is to derive the asymptotic behavior of $I_{2,2}(s; x_0)$ as $s \to -\infty$. It is readily seen from the definitions of s_1 and s_2 in [\(2.11\)](#page-12-0) that $\chi(s_1; x_0)$ and $\chi(s_2; x_0)$ tend to negative and positive infinity, respectively and $|s_1 - s_2| = \mathcal{O}(|s|^{-k + \frac{1}{6}})$ as $s \to -\infty$. Hence, by Lemma [2.3](#page-11-0) and the fact that the Hamiltonian $H_{\rm{P_{II}}}(\chi)$ decays exponentially as $\chi \to +\infty$, we have

$$
I_{2,2}(s;x_0) = \left[\int_{s_1}^{s_2} \frac{\partial \chi(\tau; x_0)}{\partial \tau} H_{\text{PI}}(\chi(\tau; x_0)) d\tau \right] \left(1 + \mathcal{O}(|s|^{-k - \frac{5}{6}}) \right) + \mathcal{O}(|s|^{-\frac{1}{6}})
$$

=
$$
\left[\int_{\chi(s_1; x_0)}^{+\infty} H_{\text{PI}}(\xi) d\xi \right] \left(1 + \mathcal{O}(|s|^{-k - \frac{5}{6}}) \right) + \mathcal{O}(|s|^{-\frac{1}{6}}).
$$

A combination of [\(1.15\)](#page-3-1) and [\(A.7\)](#page-45-0) yields, as $s \to -\infty$,

$$
I_{2,2}(s;x_{0})
$$
\n
$$
= \left[-\chi^{(0)} - \frac{\chi(s_{1};x_{0})^{3}}{12} + \frac{\log|\chi(s_{1};x_{0})|}{8} + \mathcal{O}(|\chi(s_{1};x_{0})|^{-\frac{3}{2}}) \right] \left(1 + \mathcal{O}(|s|^{-k-\frac{5}{6}}) \right) + \mathcal{O}(|s|^{-\frac{1}{6}}),
$$
\n
$$
= \left[-\chi^{(0)} - \frac{\chi(s_{1};x_{0})^{3}}{12} + \frac{1}{8} \log|\chi(s_{1};x_{0})| \right] \left(1 + \mathcal{O}(|s|^{-k-\frac{5}{6}}) \right) + \mathcal{O}(|s|^{-\frac{1}{6}}),
$$
\n(2.16)

where $\chi(\tau; x_0)$ is defined in [\(2.5\)](#page-11-4). Here we have used the facts that, as $s \to -\infty$, $\chi(s_1; x_0)$ tends to negative infinity and $|\chi(s_1; x_0)|^{-\frac{3}{2}}$ is controlled by $\mathcal{O}(|s|^{-\frac{3}{4}})$. Moreover, it follows from the definition of s_1 and $\chi(\tau; x_0)$ that $\chi(s_1; x_0) = \mathcal{O}(|s|^{\frac{k}{3} + \frac{1}{6}})$ and $\frac{|s|^{-k-5/6}\chi(s_1; x_0)^3}{12} = \mathcal{O}(|s|^{-\frac{1}{3}})$ as $s \to -\infty$. Hence, as $s \to -\infty$, we have

$$
I_{2,2}(s;x_0) = -\frac{\chi(s_1;x_0)^3}{12} + \frac{1}{8}\log\left|\left(\alpha_k s_1^{2k+1} + x_0\right)\right| - \frac{k}{12(2k+1)}\log|x_0|
$$

$$
-\chi^{(0)} - \frac{\log(2k+1)}{24} - \frac{\log\alpha_k}{24(2k+1)} + \mathcal{O}(|s|^{-\frac{1}{3}}). \tag{2.17}
$$

Now, we have obtained asymptotics of the integrals $I_1(s; x, x_0)$ and $I_2(s; x_0)$ in [\(2.1\)](#page-10-3). A combination of the formulas (2.8) – (2.10) , (2.13) – (2.15) and (2.17) yields

$$
F(s;x) = \frac{1}{4(4k+3)}\alpha_k^2 s^{4k+3} + \frac{\alpha_k}{4k+4} x s^{2k+2} + \frac{x^2 s}{4} - \frac{1}{8} \log \left| \alpha_k s^{2k+1} + x \right| - I_{1,1}(x) + \frac{(2k+1)^2}{2(2k+2)(4k+3)} \alpha_k^{-\frac{1}{2k+1}} \cdot x^{\frac{4k+3}{2k+1}} + \frac{k \log(x^2+1)}{24(2k+1)} + \chi^{(0)} + \frac{\log(2k+1)}{24} + \frac{\log \alpha_k}{24(2k+1)} - \frac{(2k+1)^2}{2(2k+2)(4k+3)} \alpha_k^{-\frac{1}{2k+1}} \cdot x_0^{\frac{4k+3}{2k+1}} - J_2(s_1; x_0) + \frac{\chi(s_1; x_0)^3}{12} + \mathcal{O}(|s|^{-\frac{1}{6}})
$$
(2.18)

as $s \to -\infty$. To complete the proof of Theorem [1.1,](#page-5-0) we only need to show the last line in the above formula does not contribute to the constant term, that is,

$$
\frac{(2k+1)^2}{2(2k+2)(4k+3)}\alpha_k^{-\frac{1}{2k+1}} \cdot x_0^{\frac{4k+3}{2k+1}} + J_2(s_1; x_0) - \frac{\chi(s_1; x_0)^3}{12} = \mathcal{O}(|s|^{-\frac{1}{3}}), \qquad s \to -\infty. \tag{2.19}
$$

Let us consider the case when $x_0 = |s|^{2k+1}$; the case $x_0 = -|s|^{2k+1}$ can be proved in a similar manner. First, it follows from the definition of $\chi(s; x)$ in [\(2.5\)](#page-11-4) and the relation [\(2.12\)](#page-12-4) that

$$
\frac{(2k+1)^2}{2(2k+2)(4k+3)}\alpha_k^{-\frac{1}{2k+1}} \cdot x_0^{\frac{4k+3}{2k+1}} - \frac{\chi(s_1; x_0)^3}{12}
$$
\n
$$
= \frac{(2k+1)^2\alpha_k^{-\frac{1}{2k+1}}}{2(2k+2)(4k+3)}|s|^{4k+3} + \frac{\alpha_k^{-\frac{1}{2k+1}}}{12(2k+1)}|s|^{k+\frac{1}{2}}.\tag{2.20}
$$

Next, for the remaining factor $J_2(s_1; x_0)$ in [\(2.19\)](#page-13-1), we use its definition from [\(2.15\)](#page-12-3) and the relationship [\(2.12\)](#page-12-4) once more to obtain

$$
J_2(s_1; x_0) = s_1 \left(\frac{\alpha_k^2 s_1^{4k+2}}{4(4k+3)} + \frac{\alpha_k s_1^{2k+1}}{4k+4} x_0 + \frac{1}{4} x_0^2 \right)
$$

= $s_1 \left(\frac{(2k+1)^2}{4(k+1)(4k+3)} |s|^{4k+2} - \frac{2k+1}{4(k+1)(4k+3)} |s|^{3k+\frac{7}{6}} + \frac{1}{4(4k+3)} |s|^{2k+\frac{1}{3}} \right).$ (2.21)

Figure 3: The jump contours Γ_j , $j = 1, 2, 3, 4$, of the RH problem for Ψ .

Recalling the definition of s_1 in [\(2.11\)](#page-12-0), when $x_0 = |s|^{2k+1} > 0$, it is straightforward to see that

$$
\alpha_k^{\frac{1}{2k+1}} s_1 = -|s| - \frac{|s|^{-k + \frac{1}{6}}}{2k+1} + \frac{k\,|s|^{-2k - \frac{2}{3}}}{(2k+1)^2} - \frac{k(4k+1)}{3(2k+1)^3}|s|^{-3k - \frac{3}{2}} + \mathcal{O}\left(|s|^{-4k - \frac{7}{3}}\right). \tag{2.22}
$$

as $s \to -\infty$. Finally, by combining the above three formulas, we arrive at the desired approximation in [\(2.19\)](#page-13-1). This finishes the proof of Theorem [1.1.](#page-5-0) \Box

3 Preliminaries

3.1 A Riemann-Hilbert characterization of the P_I^{2k} kernel

Recall the P_1^{2k} kernel $K^{(k)}$ in [\(1.19\)](#page-3-0). By [\[17\]](#page-55-4), we have

$$
K^{(k)}(u,v) = K^{(k)}(u,v;x,t_1,\ldots,t_{2k-1}) = \frac{\Psi_1^{(2k)}(u)\Psi_2^{(2k)}(v) - \Psi_1^{(2k)}(v)\Psi_2^{(2k)}(u)}{-2\pi i(u-v)},
$$
(3.1)

where $(\Psi_1^{(2k)}(\zeta), \Psi_2^{(2k)}$ $(2k)(\zeta)$ ^T is related to the following RH problem.

RH problem for Ψ

(a) $\Psi(\zeta) = \Psi^{(2k)}(\zeta; x, t_1, \ldots, t_{2k-1})$ is a 2×2 matrix-valued function, which is analytic for ζ in $\mathbb{C}\backslash{\{\cup_{j=1}^{4}\Gamma_j\cup\{0\}\}}$, where

$$
\Gamma_1 = (0, +\infty), \quad \Gamma_2 = e^{\frac{4k+2}{4k+3}\pi i} (0, +\infty), \quad \Gamma_3 = (-\infty, 0), \quad \Gamma_4 = e^{-\frac{4k+2}{4k+3}\pi i} (0, +\infty),
$$

with the orientation shown in Figure [3.](#page-14-3)

(b) On the contour $\cup_{j=1}^4 \Gamma_j$, the limiting values of $\Psi_{\pm}(\zeta)$ exist and satisfy the jump condition

$$
\Psi_{+}(\zeta) = \Psi_{-}(\zeta) \begin{cases}\n\begin{pmatrix}\n1 & 1 \\
0 & 1\n\end{pmatrix}, & \zeta \in \Gamma_{1}, \\
\begin{pmatrix}\n1 & 0 \\
1 & 1\n\end{pmatrix}, & \zeta \in \Gamma_{2} \cup \Gamma_{4}, \\
\begin{pmatrix}\n0 & 1 \\
-1 & 0\n\end{pmatrix}, & \zeta \in \Gamma_{3}.\n\end{cases}
$$
\n(3.2)

(c) As $\zeta \to \infty$, we have

$$
\Psi(\zeta) = \left(I + \frac{\Psi_{-1}}{\zeta} + \mathcal{O}\left(\zeta^{-2}\right)\right)\zeta^{-\frac{1}{4}\sigma_3}Ne^{-\theta(\zeta)\sigma_3},\tag{3.3}
$$

where Ψ_{-1} is a ζ -independent matrix, σ_3 is the Pauli matrix defined in [\(1.43\)](#page-10-5),

$$
N = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & 1 \\ -1 & 1 \end{pmatrix} e^{-\frac{1}{4}\pi i \sigma_3}
$$
\n
$$
(3.4)
$$

is a constant matrix, and

$$
\theta(\zeta) = \theta(\zeta; x, t_1, \dots, t_{2k-1}) = \frac{4}{4k+3} \zeta^{\frac{4k+3}{2}} + 4 \sum_{j=1}^{2k-1} \frac{t_j}{2j+1} \zeta^{\frac{2j+1}{2}} + x \zeta^{\frac{1}{2}}.
$$
 (3.5)

In the above formulas, the principal branch of the fractional powers is taken.

(d) $\Psi(\zeta)$ is bounded at $\zeta = 0$.

In [\[19\]](#page-55-11), it has been proved that the above RH problem for Ψ is uniquely solvable for $k = 1$. The proof can be easily generalized to any integer larger than 1; see also [\[17\]](#page-55-4). The RH problem for Ψ is related to the Painlevé I hierarchy through the fact that

$$
\Psi_{-1} = \begin{pmatrix} \frac{h^2 - \mathbf{q}}{2} & h \\ \star & \frac{h^2 + \mathbf{q}}{2} \end{pmatrix},\tag{3.6}
$$

where q is the special solution of P_I^{2k} described in Section [1.1](#page-4-0) and h is the associated Hamiltonian.

The functions $(\Psi_1^{(2k)}, \Psi_2^{(2k)})$ $(2k)$ ^T appearing in the P_I^{2k} kernel [\(3.1\)](#page-14-2) are the analytic continuation of the first column of Ψ in the region bounded by Γ_1 and Γ_2 to the whole complex plane. Moreover, Ψ satisfies a Lax pair as follows (cf. [\[14\]](#page-55-10)):

$$
\frac{\partial \Psi}{\partial \zeta}(\zeta, x) = A(\zeta, x)\Psi(\zeta, x), \qquad \frac{\partial \Psi}{\partial x}(\zeta, x) = L(\zeta, x)\Psi(\zeta, x), \tag{3.7}
$$

where A is a polynomial in ζ of degree $2k+1$ and

$$
L(\zeta, x) = \begin{pmatrix} 0 & 1 \\ \zeta + 2\mathsf{q}(x) & 0 \end{pmatrix}.
$$
 (3.8)

Remark 3.1. If $k = 0$ (i.e., all the parameters x, t_1, \dots, t_{2k-1} , vanish), the RH problem for Ψ can reduce to the one for the Airy kernel. More precisely, we have $\Psi^{(0)}(\zeta) = 2^{\frac{1}{6}\sigma_3}\Phi^{(\mathrm{Ai})}(2^{\frac{2}{3}}\zeta),$ where $\Phi^{(Ai)}$ is the classical Airy parametrix; cf. [\[24,](#page-55-0) [32\]](#page-56-2).

3.2 Differential identities

In view of the integrable structure of the P_I^{2k} kernel given in [\(3.1\)](#page-14-2), it is well-known that we are able to establish connections between ∂F and specific RH problems.

RH problem for Y

- (a) $Y(\zeta)$ is analytic in $\mathbb{C} \setminus [s, +\infty)$.
- (b) For $\zeta \in (s, +\infty)$, the limiting values $Y_{\pm}(\zeta)$ exist and satisfy the jump condition $Y_{+}(\zeta)$ = $Y_-(\zeta)J_Y(\zeta)$ with

$$
J_Y(\zeta) = I - 2\pi i \mathbf{f}(\zeta) \mathbf{h}^\top(\zeta),\tag{3.9}
$$

where

$$
\mathbf{f}(\zeta) = \begin{pmatrix} \Psi_1^{(2k)}(\zeta) \\ \Psi_2^{(2k)}(\zeta) \end{pmatrix}, \qquad \mathbf{h}(\zeta) = \frac{1}{2\pi i} \begin{pmatrix} -\Psi_2^{(2k)}(\zeta) \\ \Psi_1^{(2k)}(\zeta) \end{pmatrix}.
$$
 (3.10)

(c) As $\zeta \to \infty$, we have

$$
Y(\zeta) = I + \frac{Y_{-1}}{\zeta} + \mathcal{O}(\zeta^{-2}).
$$
\n(3.11)

- (d) As $\zeta \to s$, we have $Y(\zeta) = \mathcal{O}(\log(\zeta s)).$
	- By $[29, \text{Lemma } 2.12]$, we have

$$
Y(\zeta) = I - \int_{s}^{\infty} \frac{\mathbf{F}(u)\mathbf{h}^{\top}(u)}{u - \zeta} du,
$$
\n(3.12)

where

$$
\mathbf{F} := (I - \mathbb{K}_s^{(k)})^{-1} \mathbf{f}, \qquad \mathbf{H} := (I - \mathbb{K}_s^{(k)})^{-1} \mathbf{h}.
$$
 (3.13)

Then, $\partial F/\partial x$ is related to the above RH problem in the following way.

Lemma 3.2. For any $x, s \in \mathbb{R}$, we have

$$
\frac{\partial F}{\partial x}(s; x) = \frac{\partial}{\partial x}\log \det(I - \mathbb{K}_s^{(k)}) = -(Y_{-1})_{12},\tag{3.14}
$$

where Y_{-1} is the coefficient of $1/\zeta$ term in [\(3.11\)](#page-16-0).

Proof. A combination of [\(3.1\)](#page-14-2) and the Lax pair of $\Psi(\zeta)$ in [\(3.7\)](#page-15-1) yields

$$
\frac{\partial}{\partial x} K_s^{(k)}(u, v; x, t) = \frac{1}{2\pi i} \Psi_1^{(2k)}(u) \Psi_1^{(2k)}(v).
$$
\n(3.15)

With the well-known property of trace-class operators, we have

$$
\frac{\partial}{\partial x}\log \det(I - \mathbb{K}_s^{(k)}) = -\text{tr}\left((I - \mathbb{K}_s^{(k)})^{-1}\frac{\partial \mathbb{K}_s^{(k)}}{\partial x}\right)
$$
\n
$$
= -\frac{1}{2\pi i}\int_s^\infty \left((I - \mathbb{K}_s^{(k)})^{-1}\Psi_1^{(2k)}\right)(u)\Psi_1^{(2k)}(u)du.
$$
\n(3.16)

From the explicit expression of $Y(\zeta)$ in [\(3.12\)](#page-16-1), we find $Y_{-1} = \int_{s}^{\infty} \mathbf{F}(u) \mathbf{h}^{T}(u) du$. Recall that $\mathbf{F}(u) = (I - \mathbb{K}_{s}^{(k)})^{-1}\mathbf{f}(u)$, we obtain [\(3.14\)](#page-16-2) from the above formula.

By combining the RH problems for Y and X , we can get a new one with constant jump matrices. More precisely, as in [\[17\]](#page-55-4), we define

$$
X(\zeta) = \begin{cases} Y(\zeta)\Psi(\zeta), & \zeta \in I \cup II \cup III, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in IV, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix}, & \zeta \in V, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix}, & \zeta \in I \cup II \cup III, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix}, & \zeta \in IV, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in V, \\ Y(\zeta)\Psi(\zeta) \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in V, \end{cases}
$$
(3.17)

where the regions I–V are illustrated in Figure [4.](#page-17-0) It is then readily seen that X satisfies the following RH problem.

Figure 4: Regions I–V and jump contours of the RH problem for X. The case $s < 0$ is presented on the left and the case $s > 0$ is presented on the right.

RH problem for X

- (a) $X(\zeta)$ is analytic in $\mathbb{C} \setminus \Sigma$, where $\Sigma := \Sigma_1 \cup \Sigma_2 \cup \Sigma_3$ is shown in Figure [4.](#page-17-0)
- (b) On Σ , the limiting values $X_{\pm}(\zeta)$ exist and satisfy the following jump conditions

$$
X_{+}(\zeta) = X_{-}(\zeta) \begin{cases} \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in \Sigma_{1} \cup \Sigma_{3}, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \zeta \in \Sigma_{2}. \end{cases}
$$
(3.18)

(c) As $\zeta \to \infty$, we have

$$
X(\zeta) = \left(I + \frac{X_{-1}}{\zeta} + \mathcal{O}(\zeta^{-2})\right) \zeta^{-\frac{1}{4}\sigma_3} N e^{-\theta(\zeta; x)\sigma_3},\tag{3.19}
$$

where N and θ are defined in [\(3.4\)](#page-15-2) and [\(3.5\)](#page-15-3),

$$
X_{-1} = \Psi_{-1} + Y_{-1} \tag{3.20}
$$

with Ψ_{-1} and Y_{-1} given in [\(3.6\)](#page-15-4) and [\(3.11\)](#page-16-0), respectively.

(d) As $\zeta \to s$, we have $X(\zeta) = \mathcal{O}(\log(\zeta - s)).$

As shown in [\[17,](#page-55-4) Equation (2.17)], the second differential identity reads as follows.

Lemma 3.3. For any $x, s \in \mathbb{R}$, we have

$$
\frac{\partial F}{\partial s}(s;x) = \frac{\partial}{\partial s}\log \det(I - \mathbb{K}_s^{(k)}) = \lim_{\zeta \to s} \frac{1}{2\pi i}(X(\zeta)^{-1}X'(\zeta))_{21},\tag{3.21}
$$

where the limit is taken as $\zeta \rightarrow s$ from sector I in Fig [4.](#page-17-0)

The differential identities in Lemmas [3.2](#page-16-3) and [3.3](#page-18-1) establish connections between $\frac{\partial F}{\partial s}$ and $\frac{\partial F}{\partial x}$ with specific entries of a RH problem. To prove Lemmas [2.1–](#page-10-1)[2.4](#page-11-1) presented in Section [2,](#page-10-0) we will employ the Deift-Zhou nonlinear steepest descent method to study asymptotics of the above RH problem for X. It is important to note that the asymptotic results in Lemmas [2.1–](#page-10-1)[2.4](#page-11-1) hold uniformly as |s| and/or |x| tend to $+\infty$. While one could conduct separate asymptotic analysis for cases like $s \to -\infty$ in Lemma [2.1](#page-10-1) or $x \to +\infty$ and $x \to -\infty$ in Lemmas [2.2](#page-10-2)[–2.4,](#page-11-1) such an approach may lead to redundant analyses due to similarities. Therefore, we adopt a unified approach by introducing a new large variable $\lambda > 0$ and setting

$$
s = r\lambda \quad \text{and} \quad x = y\lambda^{2k+1},\tag{3.22}
$$

with $r \geq -1$ and $y \in \mathbb{R}$ being bounded parameters. In this way, the three regions in Lemmas [2.1](#page-10-1)[–2.4](#page-11-1) can be characterized as follows (see Remark [4.3](#page-20-0) below for a more detailed explanation on why these three regions are divided):

algebraic growth region:
$$
\alpha_k r^{2k+1} + y \in [-M, -C_1 \lambda^{-k-1+\delta}],
$$

\ntransition region: $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, C_1 \lambda^{-k-1+\delta}],$ (3.23)
\nexponential decay region: $\alpha_k r^{2k+1} + y \in [C_1 \lambda^{-k-1+\delta}, +\infty),$

where α_k is defined in [\(1.21\)](#page-4-3), $M > 0$, $C_1 > 0$, and $\delta \in \mathbb{R}$ are arbitrary fixed constants with $\delta \in \left(-\frac{k}{3}\right]$ $\frac{k}{3}, k+1$) for the algebraic growth case and $\delta \in (0, \frac{1}{4})$ $\frac{1}{4}$) for the transition and exponential decay cases.

Before proceeding with the asymptotic analysis, we note that our analysis requires the presence of at least one large variable, either s or x. This condition implies that

$$
|r| + |y| \ge \delta_0 \tag{3.24}
$$

for some fixed constant $\delta_0 > 0$.

4 Asymptotic analysis in the algebraic growth region

In this section, we assume that $\alpha_k r^{2k+1} + y \in [-M, -C_1\lambda^{-k-1+\delta}],$ where M and C are two fixed positive constants with $\delta \in \left(-\frac{k}{3}\right)$ $\frac{k}{3}, k+1$). By choosing r and y appropriately, we will prove Lemmas [2.1](#page-10-1) and [2.2](#page-10-2) by carrying out asymptotic analysis of the RH problem for X. The relevant asymptotic analysis bears some similarity to that performed in [\[17,](#page-55-4) Section 3], corresponding to $r = -1$ and $y = 0$ in the notation introduced in [\(3.22\)](#page-18-2). The main difference is that, instead of $\alpha_k r^{2k+1} + y = -\alpha_k$ as in [\[17,](#page-55-4) Section 3], our asymptotic analysis is uniformly valid for $\alpha_k r^{2k+1} + y$ within a large interval $[-M, -C_1 \lambda^{-k-1+\delta}],$ where the right ending point can approach 0 as $\lambda \to +\infty$. Thus, some careful uniform treatments have to be conducted in this context. We start with the introduction of the so-called g-function.

4.1 Construction of the g-function

By introducing the scaling $\zeta = \lambda \eta$ and the change of variables in [\(3.22\)](#page-18-2), the intersection point $\zeta = s$ in Figure [4](#page-17-0) is mapped to $\eta = r$. Moreover, we have from [\(3.5\)](#page-15-3) that

$$
\theta(\zeta; x) := \theta(\zeta; x, 0, \dots, 0) = \theta(\lambda \eta; y\lambda^{2k+1}) = \lambda^{\frac{4k+3}{2}} \left[\frac{4}{4k+3} \eta^{\frac{4k+3}{2}} + y\eta^{\frac{1}{2}} \right] = \lambda^{\frac{4k+3}{2}} \theta(\eta; y). \tag{4.1}
$$

In order to normalize the RH problem for X , we introduce the *q*-function as follows:

$$
g_1(\eta) = \sum_{j=0}^{2k+1} (-1)^{j+1} b_j(\eta - r)^{\frac{1}{2} + j}, \qquad \eta \in \mathbb{C} \setminus (-\infty, r], \tag{4.2}
$$

where

$$
b_0 = -\alpha_k r^{2k+1} - y,\tag{4.3}
$$

$$
b_j = (-1)^{j+1} \frac{\Gamma(2k+2)\Gamma(\frac{3}{2})}{\Gamma(2k+2-j)\Gamma(j+\frac{3}{2})} \alpha_k r^{2k+1-j}.
$$
\n(4.4)

Then, it is straightforward to verify that

$$
\theta(\eta; y) - g_1(\eta) = d_1 \eta^{-\frac{1}{2}} + \mathcal{O}(\eta^{-\frac{3}{2}}), \qquad \eta \to \infty,
$$
\n(4.5)

where

$$
d_1 = \frac{\alpha_k}{4(k+1)} r^{2k+2} + \frac{ry}{2}.\tag{4.6}
$$

Remark 4.1. It is also natural to rewrite $g_1(\eta)$ and $g'_1(\eta)$ in the form

$$
g_1(\eta) = (\eta - r)^{\frac{1}{2}} p_1(\eta), \qquad g'_1(\eta) = (\eta - r)^{-\frac{1}{2}} \tilde{p}_1(\eta), \qquad (4.7)
$$

where both $p_1(\eta)$ and $\tilde{p}_1(\eta)$ are polynomials of degree $2k + 1$. From the matching condition [\(4.5\)](#page-19-2), we conclude that

$$
p_1(\eta) = \sum_{j=0}^{2k+1} \frac{4}{4k+3} \frac{\Gamma(j+\frac{1}{2})}{\Gamma(j+1)\Gamma(\frac{1}{2})} r^j \eta^{2k+1-j} + y,\tag{4.8}
$$

$$
\tilde{p}_1(\eta) = 2\eta^{2k+1} \sum_{j=0}^{2k+1} \frac{\Gamma(j-\frac{1}{2})}{\Gamma(j+1)\Gamma(-\frac{1}{2})} \left(\frac{r}{\eta}\right)^j + \frac{y}{2}.\tag{4.9}
$$

Remark 4.2. In Theorem [1.1,](#page-5-0) it is assumed that $t_1 = t_2 = \cdots = t_{2k-1} = 0$. When considering general parameters t_j , the function $\theta(\zeta)$ in [\(3.5\)](#page-15-3) involves additional terms dependent on t_j . Consequently, when we define the g-function in a manner similar to (4.2) , the coefficients b_j in [\(4.4\)](#page-19-4) and d_1 in [\(4.6\)](#page-19-5) also depend on the parameters t_j . In particular, when $k = 1$, we have

$$
d_1 = \frac{5}{32}r^4 + \frac{ry}{2} + \frac{t_1r^2}{2|s|^2}, \qquad b_0 = -\frac{5}{4}r^3 - y - \frac{2t_1r}{|s|^2}, \qquad b_1 = \frac{5}{2}r^2 + \frac{4t_1}{3|s|^2}.
$$
 (4.10)

As $s \to -\infty$, the additional factors dependent on t_1 are relatively small compared to the leading terms in [\(4.4\)](#page-19-4). This suggests that we can essentially adopt the same approach as in the present paper to study the general case when $t_j \neq 0$ and obtain results similar to that in Corollary [1.2.](#page-6-1)

Remark 4.3. From [\(4.4\)](#page-19-4), it is clear that the function $g_1(\eta)$ has different properties (particularly the sign of Re $g_1(\eta)$ near $\eta = r$, when the leading coefficient b_0 varies with respect to r and y. This difference significantly influences our asymptotic analysis, leading to very different results. This is the reason why we characterize three distinct regions based on $\alpha_k r^{2k+1} + y$ in [\(3.23\)](#page-18-3).

Lemma 4.4. There exists $\theta_0 > 0$ such that, for any bounded $M > 0$ and r with $\alpha_k r^{2k+1} + y \in$ $[-M, 0]$, we have

$$
\operatorname{Re} g_1(\eta) < 0,\tag{4.11}
$$

where $\arg (\eta - r) \in (-\pi, -\pi + \theta_0] \cup [\pi - \theta_0, \pi)$.

Proof. To prove [\(4.11\)](#page-20-1), it is sufficient to show that, for $\alpha_k r^{2k+1} + y \in [-M, 0]$,

Im
$$
g'_{1,\pm}(\eta) > 0
$$
, $\eta \in (-\infty, r)$. (4.12)

It follows from [\(4.2\)](#page-19-3) and [\(4.7\)](#page-19-6) that

$$
g'_1(\eta) = (\eta - r)^{-\frac{1}{2}} \left[\sum_{j=0}^{2k+1} (-1)^{j+1} \left(j + \frac{1}{2} \right) b_j(\eta - r)^j \right] := (\eta - r)^{-\frac{1}{2}} \tilde{p}_1(\eta), \tag{4.13}
$$

where $\tilde{p}_1(\eta)$ is a polynomial in η with degree $2k + 1$. Obviously, we have

$$
\tilde{p}_1(r) = -\frac{b_0}{2} = \frac{\alpha_k r^{2k+1}}{2} + \frac{y}{2} \le 0.
$$
\n(4.14)

Next, to establish [\(4.12\)](#page-20-2), we will show that $\tilde{p}_1(\eta) < 0$ holds for all $\eta \in (-\infty, r)$.

When $r \leq 0$, it follows from the definition of b_j , $j = 0, 1, \dots, 2k + 1$, in [\(4.4\)](#page-19-4) that $b_j \geq 0$ for all j. Given that $|r|+|y| \ge \delta_0 > 0$ (see the explanation at the end of Section [3\)](#page-14-0), we immediately have $\tilde{p}_1(\eta) < 0$ for $\eta \in (-\infty, r)$.

When $r > 0$, we note the explicit expression of $\tilde{p}_1(\eta)$ in [\(4.9\)](#page-19-7) and first consider the function

$$
\varphi(z) = \sum_{j=0}^{2k+1} \frac{\Gamma\left(j - \frac{1}{2}\right)}{\Gamma\left(j + 1\right)\Gamma\left(-\frac{1}{2}\right)} z^j.
$$
\n(4.15)

It is easy to verify that $\varphi(z)$ is a monotonically decreasing function for $z \in (1, +\infty)$ and $\varphi(1) > 0$. Although the above series is alternating when $z < 0$, we can still show that $\varphi(z) > 0$ for $z \in (-\infty, 0)$. To see this, when $z \in (-1, 0)$, as the absolute values of the coefficients decrease with respect to j, we have $\varphi(z) > 0$. When $z \in (-\infty, -1)$, we consider the second order derivative

$$
\varphi''(z) = \sum_{j=0}^{2k-1} \frac{\Gamma\left(j + \frac{3}{2}\right)}{\Gamma\left(j + 1\right)\Gamma\left(-\frac{1}{2}\right)} z^j,\tag{4.16}
$$

which is also an alternating series. In this case, the absolute values of the coefficients increase with respect to j. This gives us $\varphi''(z) > 0$ for $z \in (-\infty, -1)$ and

$$
\varphi'(z) < \varphi'(-1) = \sum_{j=0}^{2k} \frac{\Gamma(j + \frac{1}{2})}{\Gamma(j + 1)\Gamma(-\frac{1}{2})} (-1)^j < 0, \quad \forall z \in (-\infty, -1). \tag{4.17}
$$

Given that $\varphi(-1) > 0$, we conclude that $\varphi(z) > 0$ for $z \in (-\infty, -1]$.

Based on the above properties for $\varphi(z)$, we can have that when $\eta \in (0,r)$ (*i.e.*, $z = \frac{r}{r}$ $rac{r}{\eta} \in$ $(1, +\infty)$,

$$
\tilde{p}_1(\eta) < 2\eta^{2k+1}\varphi(1) + \frac{y}{2} < \tilde{p}_1(r) \le 0, \qquad \forall \eta \in (0, r).
$$
\n(4.18)

When $\eta \in (-\infty, 0)$ $(i.e., z = \frac{r}{n})$ $\frac{r}{\eta} \in (-\infty, 0)$), we get

$$
\tilde{p}_1(\eta) = 2\eta^{2k+1}\varphi\left(\frac{r}{\eta}\right) + \frac{y}{2} < \frac{y}{2}, \quad \forall \eta \in (-\infty, 0). \tag{4.19}
$$

Since $\alpha_k r^{2k+1} + y \le 0$, it follows that $y < 0$. Therefore, we obtain $\tilde{p}_1(\eta) < 0$ for $\eta \in (-\infty, 0)$. This finishes the proof of the lemma. \Box

Remark 4.5. The above lemma holds for $\alpha_k r^{2k+1} + y \in [-M, 0]$, a condition that is stronger than $\alpha_k r^{2k+1} + y \in [-M, -C_1 \lambda^{-k-1+\delta}]$ in the present section. Therefore, $g_1(\eta)$ can serve as a suitable g-function for the subsequent analysis in Section [5.1](#page-27-1) where $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$.

4.2 Riemann-Hilbert analysis when $\alpha_k r^{2k+1} + y \in [-M, -C_1 \lambda^{-k-1+\delta}]$

First transformation The first transformation is a scaling and partial normalization of the RH problem for X . It is defined by

$$
T(\eta) = (\lambda b_0)^{\frac{1}{4}\sigma_3} \begin{pmatrix} 1 & 0\\ -d_1 \lambda^{2k+2} & 1 \end{pmatrix} X(\lambda(b_0 \eta + r)) \exp\{\lambda^{\frac{4k+3}{2}} g_1(b_0 \eta + r) \sigma_3\},\tag{4.20}
$$

where the function g_1 is defined in [\(4.2\)](#page-19-3), b_0 and d_1 are two constants given in [\(4.3\)](#page-19-8) and [\(4.6\)](#page-19-5), respectively. Here, we rescale η to $\lambda b_0 \eta + r$ rather than $\lambda \eta + r$, which is different from the counterpart used in [\[17,](#page-55-4) Equation (3.1)]. This modification enables us to perform uniform asymptotic analysis on X for $\alpha_k r^{2k+1} + y = -b_0 \in [-M, -C_1 \lambda^{-k-1+\delta}]$ with $\delta \in (-\frac{k}{3})$ $\frac{k}{3}, k+1$). In view of the RH problem for X, it is readily seen that T satisfies the following RH problem.

RH problem for T

- (a) $T(\eta)$ is analytic in $\mathbb{C} \setminus \Sigma^T$, where $\Sigma^T := \Sigma^T_1 \cup \Sigma^T_2 \cup \Sigma^T_3$ is illustrated in Figure [5.](#page-22-0)
- (b) On Σ^T , the limiting values $T_{\pm}(\eta)$ exist and satisfy the jump condition

$$
T_{+}(\eta) = T_{-}(\eta) \begin{cases} \begin{pmatrix} 1 & 0 \\ \exp\{2\lambda^{\frac{4k+3}{2}}g_1(b_0\eta + r)\} & 1 \end{pmatrix}, & \eta \in \Sigma_1^T \cup \Sigma_3^T, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in \Sigma_2^T = (-\infty, 0). \end{cases}
$$
(4.21)

(c) As $\eta \to \infty$, we have

$$
T(\eta) = \left(I + \frac{T_{-1}}{\eta} + \mathcal{O}(\eta^{-2})\right) \eta^{-\frac{1}{4}\sigma_3} N,\tag{4.22}
$$

where N is defined in (3.4) and

$$
(T_{-1})_{12} = \left((X_{-1})_{12} + d_1 \lambda^{2k+2} \right) \lambda^{-\frac{1}{2}} b_0^{-\frac{1}{2}}.
$$
 (4.23)

(d) As $\eta \to 0$, we have $T(\eta) = \mathcal{O}(\log \eta)$.

By Lemma [4.4,](#page-20-3) it follows that there exists $\theta_0 > 0$ such that $\text{Re } g_1(\eta) < 0$ when $\arg(\eta - r) \in$ $(-\pi, -\pi + \theta_0] \cup [\pi - \theta_0, \pi]$. Thus, there exists a positive constant M_1 such that for $\eta \in \Sigma_1^T \cup \Sigma_3^T$,

$$
\lambda^{\frac{4k+3}{2}} \text{Re}\, g_1(b_0 \eta + r) \le -M_1 \lambda^{\frac{k}{2} + \frac{3}{2}\delta} < 0,\tag{4.24}
$$

provided that η is bounded away from the origin. This particularly implies that the jump matrix of T tends to the identity matrix exponentially fast on $\Sigma_1^T \cup \Sigma_3^T$ as $\lambda \to +\infty$. We are then in the stage of construction of global and local parametrices.

Global parametrix The global parametrix $T^{(\infty)}$ reads as follows.

\mathbf{R} H problem for $T^{(\infty)}$

- (a) $T^{(\infty)}(\eta)$ is analytic in $\mathbb{C} \setminus (-\infty, 0]$.
- (b) $T^{(\infty)}$ satisfies the jump condition

$$
T_{+}^{(\infty)}(\eta) = T_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, 0). \tag{4.25}
$$

(c) As $\eta \to \infty$, we have

$$
T^{(\infty)}(\eta) = (I + \mathcal{O}(\eta^{-1})) \eta^{-\frac{1}{4}\sigma_3} N.
$$
 (4.26)

It is easily seen that

$$
T^{(\infty)}(\eta) = \eta^{-\frac{1}{4}\sigma_3} N, \qquad \eta \in \mathbb{C} \setminus (-\infty, 0], \tag{4.27}
$$

solves the above RH problem.

Local parametrix The non-uniform convergence of the jump matrix of T on $\Sigma_1^T \cup \Sigma_3^T$ to the identity matrix suggests the following local parametrix in a small neighborhood of the origin.

$\mathbf{R} \mathbf{H}$ problem for $T^{(0)}$

- (a) $T^{(0)}(\eta)$ is analytic in $\Sigma^T \setminus U(0;\rho_1)$, where $U(0;\rho_1)$ defined in [\(1.42\)](#page-10-6) is an open disk centered at 0 with fixed and small radius $\rho_1 > 0$.
- (b) On $\Sigma^T \cap U(0;\rho_1)$, the limiting values $T_{\pm}^{(0)}(\eta)$ exist and satisfy the jump condition

$$
T_{+}^{(0)}(\eta) = T_{-}^{(0)}(\eta) \begin{cases} \begin{pmatrix} 1 & 0 \\ \exp\{2\lambda^{\frac{4k+3}{2}}g_1(b_0\eta+r)\} & 1 \end{pmatrix}, & \eta \in U(0;\rho_1) \cap (\Sigma_1^T \cup \Sigma_3^T), \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in U(0;\rho_1) \cap \Sigma_2^T. \end{cases}
$$
\n(4.28)

(c) As $\eta \to 0$, we have $T^{(0)}(\eta) = \mathcal{O}(\log \eta)$.

(d) As $\lambda \to \infty$, $T^{(0)}$ satisfies the matching condition

$$
T^{(0)}(\eta) = (I + o(1))T^{(\infty)}(\eta), \qquad \eta \in \partial U(0; \rho_1).
$$
 (4.29)

As in [\[17\]](#page-55-4), one can solve the above RH problem by using a modified Bessel parametrix. More precisely, we introduce

$$
f_1(\eta) := b_0^{-3} \left(-g_1(b_0 \eta + r) \right)^2 = \eta \left[1 + \sum_{j=1}^{2k+1} (-1)^j b_j b_0^{j-1} \eta^j \right]^2, \tag{4.30}
$$

which is a conformal mapping in $U(0; \rho_1)$, and then define

$$
T^{(0)}(\eta) = E_1(\eta) \Phi^{(\text{Bes})}(\lambda^{4k+3} b_0^3 f_1(\eta)) \exp\{\lambda^{\frac{4k+3}{2}} g_1(b_0 \eta + r) \sigma_3\},\tag{4.31}
$$

where

$$
E_1(\eta) := \eta^{-\frac{1}{4}\sigma_3} (\lambda^{4k+3} b_0^3 f_1(\eta))^{\frac{1}{4}\sigma_3}
$$
\n(4.32)

is a prefactor analytic in $U(0; \rho_1)$ and $\Phi^{(\text{Bes})}$ is a modified Bessel parametrix used in [\[17,](#page-55-4) Equations (3.22) – (3.24)] inspired by the one in [\[55,](#page-57-13) [56\]](#page-57-14). Since $\Phi^{(Bes)}$ satisfies the jump condition

$$
\Phi_{+}^{(\text{Bes})}(z) = \Phi_{-}^{(\text{Bes})}(z) \begin{cases} \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & z \in \Sigma_{1}^{T} \cup \Sigma_{3}^{T}, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & z \in \Sigma_{2}^{T}, \end{cases}
$$
(4.33)

the asymptotic behaviors

$$
\Phi^{(\text{Bes})}(z) = z^{-\frac{1}{4}\sigma_3} N \left[I + \frac{1}{8\sqrt{z}} \begin{pmatrix} -1 & -2i \\ -2i & 1 \end{pmatrix} + \mathcal{O}(z^{-1}) \right] e^{z^{\frac{1}{2}}\sigma_3}, \quad z \to \infty,
$$
(4.34)

and

$$
\Phi^{(\text{Bes})}(z) = \left(\frac{\sqrt{\pi}}{e^{\pi i/4}}\right)^{\sigma_3} \left[\begin{pmatrix} 1 & \frac{\gamma_{\text{E}} - \log 2}{\pi i} \\ 0 & 1 \end{pmatrix} + \mathcal{O}\left(z\right) \right] \begin{pmatrix} 1 & \frac{\log z}{2\pi i} \\ 0 & 1 \end{pmatrix}, \quad z \to 0, \quad \text{arg } z \in \left(-\frac{2\pi}{3}, \frac{2\pi}{3}\right),\tag{4.35}
$$

with $\gamma_{\rm E}$ being Euler's constant, one can check that $T^{(0)}$ defined in [\(4.31\)](#page-23-0) indeed solves the local parametrix near the origin.

Final transformation With the aid of the global and local parametrices built in [\(4.27\)](#page-22-1) and [\(4.31\)](#page-23-0), the final transformation is defined by

$$
R(\eta) = \begin{cases} T(\eta)T^{(0)}(\eta)^{-1}, & \eta \in U(0;\rho_1), \\ T(\eta)T^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus U(0;\rho_1). \end{cases}
$$
(4.36)

It is straightforward to check that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is analytic in $\mathbb{C} \setminus \mathbb{Z}^R$, where $\mathbb{Z}^R := \mathbb{Z}_1^T \cup \mathbb{Z}_3^T \cup \partial U(0; \rho_1) \setminus U(0; \rho_1)$ is depicted in Figure [6.](#page-24-0)
- (b) On Σ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

$$
R_+(\eta) = R_-(\eta)v_R(\eta),
$$

where

$$
v_R(\eta) = \begin{cases} T^{(\infty)}(\eta) \begin{pmatrix} 1 & 0 \\ e^{2|s|^{\frac{4k+3}{2}}g_1(\eta)} & 1 \end{pmatrix} T^{(\infty)}(\eta)^{-1}, & \eta \in \Sigma^R \setminus \partial U(0; \rho_1), \\ T^{(0)}(\eta) T^{(\infty)}(\eta)^{-1}, & \eta \in \partial U(0; \rho_1). \end{cases} (4.37)
$$

(c) As $\eta \to \infty$, we have $R(\eta) = I + \frac{T_{-1}}{\eta} + \mathcal{O}(\eta^{-2})$, where T_{-1} is defined in [\(4.22\)](#page-21-1).

From [\(4.24\)](#page-21-2) and [\(4.27\)](#page-22-1), it is readily seen that if $\eta \in \Sigma^R \setminus \partial U(0; \rho_1)$,

$$
v_R(\eta) = I + \mathcal{O}(\lambda^{\frac{2k}{3}} e^{-M_2 \lambda^{\frac{k}{2} + \frac{3}{2}\delta}}), \qquad \lambda \to +\infty.
$$
 (4.38)

If $\eta \in \partial U(0;\rho_1)$, making use of the full asymptotic expansion of the modified Bessel parametrix (see [\[63,](#page-58-8) Equation (3.79)]), we have

$$
v_R(\eta) \sim I + \sum_{j=1}^{+\infty} \frac{v_j(\eta)}{\left(\lambda^{(4k+3)/2} b_0^{3/2}\right)^j}, \qquad \lambda \to +\infty,
$$
\n(4.39)

where b_0 is defined in (4.3) and

$$
v_j(\eta) = \eta^{-\frac{1}{4}\sigma_3} J_j \eta^{\frac{1}{4}\sigma_3} f_1(\eta)^{-\frac{j}{2}}, \qquad j = 1, 2, \dots
$$
 (4.40)

In [\(4.40\)](#page-24-1), the function f_1 is defined in [\(4.30\)](#page-23-1) and J_j are constant matrices arising from the asymptotic expansion of $\Phi^{(Bes)}$. In particular, we have J_{2j} and J_{2j-1} are diagonal and antidiagonal matrices, respectively, and

$$
J_1 = \frac{1}{8} \begin{pmatrix} 0 & -1 \\ 3 & 0 \end{pmatrix} . \tag{4.41}
$$

Recall that $b_0 \in [C_1 \lambda^{-k-1+\delta}, M]$, it then follows that for all fixed $\delta \in (-\frac{k}{3}]$ $\frac{k}{3}, k+1$, $v_R(\eta) =$ $I + \mathcal{O}(\lambda^{-\frac{k}{2} - \frac{3}{2}\delta})$ uniformly for all $\eta \in \partial U(0; \rho_1)$.

By a standard argument of the small norm RH problem (cf. [\[24\]](#page-55-0)), we conclude that

R(\eta) \sim I + \sum_{j=1}^{\infty} \frac{R_j(\eta)}{\left(\lambda^{(4k+3)/2} b_0^{3/2}\right)^j}, \qquad \lambda \to +\infty,
$$
\n(4.42)

where R_j is analytic in $\mathbb{C} \setminus \partial U(0;\rho_1)$, behaves like $\mathcal{O}(1/\eta)$ as $\eta \to \infty$, and satisfies the jump condition \overline{R} , (n) \overline{R} , (n) + v1(n)

$$
R_{1,+}(\eta) = R_{1,-}(\eta) + v_1(\eta),
$$

\n
$$
R_{j,+}(\eta) = R_{j,-}(\eta) + v_j(\eta) + \sum_{m=1}^{j-1} R_{m,-}(\eta) v_{j-m}(\eta), \qquad j > 1,
$$
\n(4.43)

for $\eta \in \partial U(0;\rho_1)$. It is easily seen that

$$
R_1(\eta) = \begin{cases} \frac{\text{Res}(v_1,0)}{\eta} - v_1(\eta), & \eta \in U(0;\rho_1), \\ \frac{\text{Res}(v_1,0)}{\eta}, & \eta \in \mathbb{C} \setminus U(0;\rho_1), \end{cases}
$$
(4.44)

where $\text{Res}(v_1, 0)$ stands for the residue of v_1 at the origin. From the definition of v_1 in [\(4.40\)](#page-24-1), it follows that

$$
R_1(0) = \begin{pmatrix} 0 & \frac{b_1}{8} \\ -\frac{3}{8} & 0 \end{pmatrix}, \qquad R'_1(0) = \begin{pmatrix} 0 & \star \\ -\frac{3b_1}{8} & 0 \end{pmatrix}.
$$
 (4.45)

Since J_{2j} and J_{2j-1} are diagonal and anti-diagonal matrices, respectively, we see from [\(4.40\)](#page-24-1) that v_{2j} and v_{2j-1} bear the same structure. By induction, we then conclude from [\(4.43\)](#page-25-1) that $R_{2j}(\eta)$ are all diagonal matrices and $R_{2j-1}(\eta)$ are all anti-diagonal matrices. These, together with [\(4.42\)](#page-25-2), [\(4.45\)](#page-25-3) and the fact that $b_0 \in [C_1 \lambda^{-k-1+\delta}, M]$, implies that, as $\lambda \to +\infty$,

$$
R(0) = \begin{pmatrix} 1 + \mathcal{O}(\lambda^{-k-3\delta}) & \frac{b_1}{8} b_0^{-\frac{3}{2}} \lambda^{-\frac{4k+3}{2}} \left(1 + \mathcal{O}(\lambda^{-k-3\delta}) \right) \\ -\frac{3}{8} b_0^{-\frac{3}{2}} \lambda^{-\frac{4k+3}{2}} \left(1 + \mathcal{O}(\lambda^{-k-3\delta}) \right) & 1 + \mathcal{O}(\lambda^{-k-3\delta}) \end{pmatrix}
$$
(4.46)

and

$$
R'(0) = \begin{pmatrix} \mathcal{O}(\lambda^{-k-3\delta}) & \star \\ -\frac{3b_1}{8}b_0^{-\frac{3}{2}}\lambda^{-\frac{4k+3}{2}}\left(1+\mathcal{O}(\lambda^{-k-3\delta})\right) & \mathcal{O}(\lambda^{-k-3\delta}) \end{pmatrix} . \tag{4.47}
$$

4.3 Proofs of Lemmas [2.1](#page-10-1) and [2.2](#page-10-2)

Proof of Lemma [2.1](#page-10-1) Note that $R(\eta) = I + \frac{T_{-1}}{\eta} + \mathcal{O}(\eta^{-2})$ as $\eta \to \infty$, we have

$$
T_{-1} = \lim_{\eta \to \infty} \eta (R(\eta) - I).
$$
 (4.48)

According to [\(4.42\)](#page-25-2), [\(4.43\)](#page-25-1) and the fact that $R_1(\eta)$ is anti-diagonal and $R_2(\eta)$ is diagonal, we further obtain

$$
(T_{-1})_{12} = b_0^{-\frac{3}{2}} \lambda^{-\frac{4k+3}{2}} \lim_{\eta \to \infty} \eta(R_1(\eta))_{12} \left(1 + \mathcal{O}(\lambda^{-k-3\delta})\right)
$$

= $-\frac{1}{8} b_0^{-\frac{3}{2}} \lambda^{-\frac{4k+3}{2}} \text{Res}\left(\eta^{-\frac{1}{2}} f_1(\eta)^{-\frac{1}{2}}, 0\right) \left(1 + \mathcal{O}(\lambda^{-k-3\delta})\right)$
= $-\frac{1}{8} b_0^{-\frac{3}{2}} \lambda^{-\frac{4k+3}{2}} \left(1 + \mathcal{O}(\lambda^{-k-3\delta})\right).$ (4.49)

It then follows from [\(4.3\)](#page-19-8), [\(4.23\)](#page-21-3) and the above estimate that

$$
(X_{-1})_{12} = -d_1 \lambda^{2k+2} + (\lambda b_0)^{\frac{1}{2}} (T_{-1})_{12}
$$

=
$$
-d_1 \lambda^{2k+2} + \frac{1}{8} \frac{1}{(\alpha_k s^{2k+1} + x)} \left(1 + \mathcal{O} \left(\lambda^{-k-3\delta} \right) \right), \qquad \lambda \to +\infty.
$$
 (4.50)

The error bound holds uniformly for all (y, r) satisfying $\alpha_k r^{2k+1} + y \in [-M, -C_1 \lambda^{-k-1+\delta}]$ with $\delta \in \left(-\frac{k}{3}\right]$ $\frac{k}{3}, k+1$. Recalling the differential identity in [\(3.14\)](#page-16-2), we have from [\(3.6\)](#page-15-4) and [\(3.20\)](#page-17-1) that

$$
\frac{\partial F}{\partial x}(s; x) = -(Y_{-1})_{12} = (\Psi_{-1})_{12} - (X_{-1})_{12} = h(x) - (X_{-1})_{12}.\tag{4.51}
$$

Taking $\lambda = |s|$ (*i.e.* $r = -1$ in [\(3.22\)](#page-18-2)), $\delta = -\frac{k}{3} + \epsilon$, and substituting [\(4.50\)](#page-26-0) into the above formula, we obtain [\(2.2\)](#page-10-4) with the definition of d_1 in [\(4.6\)](#page-19-5). Recall that $x = y\lambda^{2k+1} = y|s|^{2k+1}$ (see [\(3.22\)](#page-18-2)), we find that the asymptotic formula [\(2.2\)](#page-10-4) holds uniformly for $x \in [-c_1] \cdot s^{|2k+1|}, \alpha_k |s|^{2k+1}$ $c_2|s|^{\frac{2k}{3}+\epsilon}$ with $c_1, c_2 > 0$ and $\epsilon \in (0, \frac{4k}{3}+1)$ being arbitrary fixed. This finishes the proof of Lemma [2.1.](#page-10-1)

Proof of Lemma [2.2](#page-10-2) By inverting the transformations [\(4.20\)](#page-21-4) and [\(4.36\)](#page-23-2), it follows from [\(3.21\)](#page-18-4) that

$$
\frac{\partial F}{\partial s}(s;x) = \frac{b_0^2 \lambda^{4k+2}}{2\pi i} \left(\Phi^{(\text{Bes})}(z)^{-1} \frac{d\Phi^{(\text{Bes})}(z)}{dz} \right)_{21} \Big|_{z \to 0} \n+ \frac{1}{2\pi i \lambda b_0} \left(\Phi^{(\text{Bes})}(z)^{-1} E_1(\eta)^{-1} E_1'(\eta) \Phi^{(\text{Bes})}(z) \right)_{21} \Big|_{\eta \to 0} \n+ \frac{1}{2\pi i \lambda b_0} \left(\Phi^{(\text{Bes})}(z)^{-1} E_1(\eta)^{-1} R(\eta)^{-1} R'(\eta) E_1(\eta) \Phi^{(\text{Bes})}(z) \right)_{21} \Big|_{\eta \to 0}, \quad (4.52)
$$

where $z = z(\eta) = \lambda^{4k+3} b_0^3 f_1(\eta)$ with f_1 given in [\(4.30\)](#page-23-1) and E_1 is defined in [\(4.32\)](#page-23-3). In view of the local behavior of $\Phi^{(Bes)}$ near the origin given in [\(4.35\)](#page-23-4), one can show that

$$
\frac{b_0^2 \lambda^{4k+2}}{2\pi i} \left(\Phi^{(\text{Bes})}(z)^{-1} \frac{d\Phi^{(\text{Bes})}(z)}{dz} \right)_{21} \bigg|_{z \to 0} = \frac{1}{4} b_0^2 \lambda^{4k+2} \tag{4.53}
$$

and

$$
\frac{1}{2\pi i\lambda b_0} \left(\Phi^{(\text{Bes})}(z)^{-1} E_1(\eta)^{-1} E_1'(\eta) \Phi^{(\text{Bes})}(z) \right)_{21} \bigg|_{\eta \to 0} = 0. \tag{4.54}
$$

To estimate the third term on the right hand side of [\(4.52\)](#page-26-1), we first observe from [\(4.46\)](#page-25-4) and [\(4.47\)](#page-25-5) that

$$
R(0)^{-1}R'(0) = \begin{pmatrix} \star & \star \\ -\frac{3}{8}b_1b_0^{-\frac{3}{2}}\lambda^{-\frac{4k+3}{2}}\left(1+\mathcal{O}(\lambda^{-k-3\delta})\right) & \star \end{pmatrix}, \qquad \lambda \to +\infty.
$$
 (4.55)

Moreover, from the definition of $E_1(\eta)$ in [\(4.32\)](#page-23-3), one can see that $E_1(0) = \lambda^{\frac{4k+3}{4}\sigma_3} b_0^{\frac{3}{4}\sigma_3}$ $\int_0^{\overline{4}^{03}}$. These, together with [\(4.35\)](#page-23-4), imply that

$$
\frac{1}{2\pi i\lambda b_0} \left(\Phi^{(\text{Bes})}(z)^{-1} E_1(\eta)^{-1} R(\eta)^{-1} R'(\eta) E_1(\eta) \Phi^{(\text{Bes})}(z) \right)_{21} \Big|_{\eta \to 0}
$$
\n
$$
= \frac{1}{2\pi i\lambda b_0} \left(\Phi^{(\text{Bes})}(z)^{-1} \left(-\frac{3b_1}{8} \left(1 + \mathcal{O} \left(\lambda^{-k-3\delta} \right) \right)^{-k} \right) \Phi^{(\text{Bes})}(z) \right)_{21} \Big|_{\eta \to 0}
$$
\n
$$
= \frac{3b_1}{16b_0\lambda} \left(1 + \mathcal{O} \left(\lambda^{-k-3\delta} \right) \right), \qquad \lambda \to +\infty. \tag{4.56}
$$

Finally, recall that $x = y\lambda^{2k+1}$, we fix $y \neq 0$ and take $\delta = \frac{1}{6}$ $\frac{1}{6}$, then a combination of (4.52) – (4.56) and the definitions of b_0 , b_1 in [\(4.3\)](#page-19-8) and [\(4.4\)](#page-19-4) yields [\(2.3\)](#page-10-7) as $|x| \to +\infty$, uniformly for s such that $\alpha_k s^{2k+1} + x \in \left[-M|x|, -C|x|^{\frac{k+1/6}{2k+1}} \right]$.

5 Asymptotic analysis in the transition region

In this section, we study the large λ behavior of $X(\lambda \eta)$ for $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, C_1 \lambda^{-k-1+\delta}]$ with $\delta \in (0, \frac{1}{4})$ $\frac{1}{4}$). As discussed at the end of Section [3.2,](#page-15-0) this corresponds to the transition region. Our goal is to establish the validity of Lemma [2.3.](#page-11-0) It is crucial to emphasize that $b_0 = -\alpha_k r^{2k+1} - y$ is small and may vanish in this context. Therefore, the function $f_1(\eta)$ defined in [\(4.30\)](#page-23-1) is no longer a valid conformal mapping in a small neighborhood of $\eta = 0$. Consequently, the local Bessel parametrix used in Section [4](#page-18-0) becomes inappropriate and will be replaced by the Painlevé XXXIV (P₃₄) parametrix $\Phi(\zeta; x)$ or its variant $\Phi(\zeta; x)$ with x being a parameter; see Appendix [A](#page-44-0) for the definitions.

As shown in Appendix [B,](#page-46-0) the uniform asymptotic behavior of $\Phi(\zeta; x)$ differs depending on whether $\zeta \to \infty$ and x approaches negative infinity, as compared to the case when $\zeta \to \infty$ and x approaches positive infinity. These qualitatively different asymptotic behaviors lead us to split the analysis into two cases, that is, $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$ and $\alpha_k r^{2k+1} + y \in$ $[0, C_1 \lambda^{-k-1+\delta}].$

5.1 Riemann-Hilbert analysis when $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$

First transformation As previously noted in Remark [4.5,](#page-21-5) when $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$, the function q_1 in [\(4.2\)](#page-19-3) remains suitable for normalizing the RH problem for X. We thus define

$$
P(\eta) = \begin{pmatrix} 1 & 0 \\ -d_1 \lambda^{2k+2} & 1 \end{pmatrix} X(\lambda \eta) \exp\{\lambda^{\frac{4k+3}{2}} g_1(\eta) \sigma_3\},\tag{5.1}
$$

where d_1 is defined in [\(4.6\)](#page-19-5). It is then straightforward to check that P satisfies the following RH problem.

RH problem for P

- (a) $P(\eta)$ is analytic in $\mathbb{C} \setminus \mathbb{S}^P$, where $\Sigma^P = \Sigma_1^P \cup \Sigma_2^P \cup \Sigma_3^P$ is illustrated in Figure [7.](#page-28-0)
- (b) On Σ^P , the limiting values $P_{\pm}(\eta)$ exist and satisfy the jump condition

$$
P_{+}(\eta) = P_{-}(\eta) \begin{cases} \begin{pmatrix} 1 & 0 \\ e^{2\lambda \frac{4k+3}{2}g_{1}(\eta)} & 1 \end{pmatrix}, & \eta \in \Sigma_{1}^{P} \cup \Sigma_{3}^{P}, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in \Sigma_{2}^{P}. \end{cases}
$$
(5.2)

- (c) As $\eta \to r$, we have $P(\eta) = \mathcal{O}(\log(\eta r)).$
- (d) As $\eta \to \infty$, we have

$$
P(\eta) = \left(I + \mathcal{O}(\eta^{-1})\right)(\lambda \eta)^{-\frac{1}{4}\sigma_3} N,\tag{5.3}
$$

where N is defined in (3.4) .

According to Lemma [4.4,](#page-20-3) there exist two positive constants M_2 and C_2 such that for $\eta \in$ Σ P ¹ ∪ Σ P 3 , 4k+3 4k+3 3 k

$$
\lambda^{\frac{4k+3}{2}} \text{Re}\, g_1(\eta) \le -M_2 \lambda^{\frac{4k+3}{2}} |\eta - r|^{\frac{3}{2}} \le -C_2 \lambda^{\frac{k}{2}},\tag{5.4}
$$

uniformly for $|\eta - r| \geq \lambda^{-k-1}$ and λ large enough. As a consequence, the jump matrix of F tends to the identity matrix exponentially fast on $\Sigma_1^P \cup \Sigma_3^P$ as $\lambda \to +\infty$.

Global parametrix By ignoring the jump matrix on $\Sigma_1^P \cup \Sigma_3^P$, the global parametrix is actually a shift of that in Section [4.2.](#page-21-0)

\mathbf{R} H problem for $P^{(\infty)}$

- (a) $P^{(\infty)}(\eta)$ is analytic in $\mathbb{C} \setminus (-\infty, r]$.
- (b) $P^{(\infty)}$ satisfies the jump condition

$$
P_{+}^{(\infty)}(\eta) = P_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, r). \tag{5.5}
$$

(c) As $\eta \to \infty$, we have

$$
P^{(\infty)}(\eta) = (I + \mathcal{O}(\eta^{-1})) (\lambda \eta)^{-\frac{1}{4}} N.
$$
 (5.6)

A solution of the above RH problem is given by

$$
P^{(\infty)}(\eta) = (\lambda(\eta - r))^{-\frac{1}{4}\sigma_3} N. \tag{5.7}
$$

Local parametrix The non-uniform convergence of the jump matrix of P on $\Sigma_1^P \cup \Sigma_3^P$ to the identity matrix suggests the following local parametrix in a small neighborhood $U(r; \rho_2)$ of $\eta = r$. Particularly, we later will take $\rho_2 = \rho_2(\lambda)$ in a precise way such that $\rho_2(\lambda) \to 0$ as $\lambda \to +\infty$, so the disc is shrinking as λ increases.

\mathbf{R} H problem for $P^{(r)}$

(a) $P^{(r)}(\eta)$ is analytic in $\Sigma^P \setminus U(r;\rho_2)$.

(b) On $\Sigma^P \cap U(r; \rho_2)$, the limiting values $P_{\pm}^{(r)}(\eta)$ exist and satisfy the jump condition

$$
P_{+}^{(r)}(\eta) = P_{-}^{(r)}(\eta) \begin{cases} \begin{pmatrix} 1 & 0 \\ e^{2\lambda \frac{4k+3}{2}g_1(\eta)} & 1 \end{pmatrix}, & \eta \in U(r; \rho_2) \cap (\Sigma_1^P \cup \Sigma_3^P), \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in U(r; \rho_2) \cap \Sigma_2^P. \end{cases}
$$
(5.8)

- (c) As $\eta \to r$, we have $P^{(r)}(\eta) = \mathcal{O}(\log(\eta r)).$
- (d) As $\lambda \to \infty$, $P^{(r)}$ satisfies the matching condition

$$
P^{(r)}(\eta) = (I + o(1))P^{(\infty)}(\eta), \qquad \eta \in \partial U(r; \rho_2). \tag{5.9}
$$

To solve the above RH problem, we first introduce a conformal mapping in the disk $U(r; \rho_2)$ defined by

$$
f_2(\eta) = \left[\frac{3}{2} \left(\sum_{i=1}^{2k+1} (-1)^{i+1} b_i (\eta - r)^{i-1}\right)\right]^{\frac{2}{3}} (\eta - r),\tag{5.10}
$$

where b_i , $i = 1, \ldots, 2k+1$, are given in [\(4.4\)](#page-19-4). Note that $f_2(\eta)$ is independent of b_0 , it thus serves as a conformal mapping uniformly for $b_0 = -\alpha_k r^{2k+1} - y \in [0, C_1 \lambda^{-k-1+\delta}]$. Then, we define

$$
P^{(r)}(\eta) = E_2(\eta)\Phi(\lambda^{\frac{4k+3}{3}}f_2(\eta); \lambda^{\frac{4k+3}{3}}\kappa_0)e^{\lambda^{\frac{4k+3}{2}}g_1(\eta)\sigma_3}, \quad \eta \in U(r;\rho_2),
$$
 (5.11)

where κ_0 is a constant independent of η to be determined later,

$$
E_2(\eta) := (\lambda(\eta - r))^{-\frac{1}{4}\sigma_3} (\lambda^{\frac{4k+3}{3}} f_2(\eta))^{\frac{1}{4}\sigma_3} e^{-\frac{\pi i}{4}\sigma_3}
$$
(5.12)

is analytic in $U(r; \rho_2)$ and $\Phi(\zeta; x)$ is the P₃₄ parametrix given in Appendix [A.](#page-44-0)

In [\(5.11\)](#page-29-0), the function Φ depends on b_0 through the constant κ_0 . To determine it, we set

$$
\kappa(\eta) = -b_0(\eta - r)^{\frac{1}{2}} f_2(\eta)^{-\frac{1}{2}},\tag{5.13}
$$

so that

$$
g_1(\eta) = \frac{2}{3} (f_2(\eta))^{\frac{3}{2}} + \kappa(\eta) (f_2(\eta))^{\frac{1}{2}}.
$$
 (5.14)

The constant κ_0 is chosen to be the approximation of $\kappa(r)$ for large λ . More precisely, note that if $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$ and $|r| + |y| \ge \delta_0 > 0$ (see [\(3.24\)](#page-18-5)), we have

$$
r = -\left(\frac{y}{\alpha_k}\right)^{\frac{1}{2k+1}} \left(1 + \mathcal{O}(\lambda^{-k-1+\delta})\right), \qquad \lambda \to +\infty.
$$
 (5.15)

This, together with the definition of b_1 in [\(4.4\)](#page-19-4), implies that

$$
\kappa(r) = -b_0 \left[\frac{3}{2} b_1 \right]^{-\frac{1}{3}} = \kappa_0 \left(1 + \mathcal{O}(\lambda^{-k-1+\delta}) \right), \qquad \lambda \to +\infty,
$$
\n(5.16)

where

$$
\kappa_0 := \kappa_0(r; y) = -b_0 \left[(2k+1)\alpha_k \left(\frac{y}{\alpha_k} \right)^{\frac{2k}{2k+1}} \right]^{-\frac{1}{3}} \le 0.
$$
 (5.17)

For later use, we derive the approximation of $f_2'(r)$ for large λ . From the definition of b_0 in [\(4.3\)](#page-19-8), we see that $\frac{\partial b_0}{\partial r} = -(2k+1)\alpha_k r^{2k} = -\frac{3}{2}$ $\frac{3}{2}b_1$. This fact, together with [\(5.15\)](#page-29-1) and [\(5.17\)](#page-29-2), yields

$$
f_2'(r) = \left(\frac{3}{2}b_1\right)^{\frac{2}{3}} = \left(\frac{3}{2}b_1\right)\left(\frac{3}{2}b_1\right)^{-\frac{1}{3}}
$$

=
$$
\frac{(2k+1)\alpha_k r^{2k}}{\left[(2k+1)\alpha_k \left(\frac{y}{\alpha_k}\right)^{\frac{2k}{2k+1}}\right]^{\frac{1}{3}}} \left(1 + \mathcal{O}(\lambda^{-k-1+\delta})\right) = \frac{\partial \kappa_0}{\partial r} \left(1 + \mathcal{O}(\lambda^{-k-1+\delta})\right), \qquad (5.18)
$$

as $\lambda \to +\infty$ uniformly for $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0].$

With the aid of κ_0 in [\(5.17\)](#page-29-2), we now choose the radius ρ_2 of the disk to be

$$
\rho_2 = \frac{1}{\lambda^{\frac{4k+3}{2}} |\kappa_0| + \lambda^{\frac{2k}{3} + \frac{1}{2}}},\tag{5.19}
$$

and prove the following lemma.

Lemma 5.1. The function $P^{(r)}$ defined in [\(5.11\)](#page-29-0) solves the RH problem for $P^{(r)}$.

Proof. Recalling that $E_2(\eta)$ is an analytic prefactor in $U(r; \rho_2)$, and using the jump condition of Φ in [\(A.1\)](#page-44-1), it is straightforward to verify that $P^{(r)}$ satisfies the jump condition in [\(5.8\)](#page-29-3). The next task is to verify the matching condition [\(5.9\)](#page-29-4). From the large ζ behavior of Φ in [\(A.2\)](#page-44-2), it is clear that the exponential factor cannot be completely canceled by the choice of κ_0 in [\(5.17\)](#page-29-2); see the relation between g_1 and f_2 in [\(5.14\)](#page-29-5). To ensure that the remaining exponential quantity is controllable, we need to choose a shrinking radius ρ_2 in [\(5.19\)](#page-30-0).

When $\alpha_k r^{2k+1} + y = -b_0 \in [-C_1 \lambda^{-k-1+\delta}, 0]$ with $\delta \in (0, \frac{1}{4})$ $\frac{1}{4}$, it is readily seen from (5.17) that

$$
\kappa_0 = \mathcal{O}(\lambda^{-k-1+\delta}), \qquad \lambda \to +\infty. \tag{5.20}
$$

This implies that $\rho_2 \gg \lambda^{-k-1}$ when λ is large enough. Due to [\(5.4\)](#page-28-1), one can see that the jump of P on $(\Sigma_1^P \cup \Sigma_3^P) \setminus U(r;\rho_2)$ indeed tends to the identity matrix exponentially fast.

To verify the matching condition (5.9) , we first obtain from (5.7) , (5.11) and (5.12) that

$$
P^{(r)}(\eta)P^{(\infty)}(\eta)^{-1} = \left(\frac{\lambda^{\frac{4k+3}{3}}f_2(\eta)}{\lambda(\eta-r)e^{\pi i}}\right)^{\frac{1}{4}\sigma_3} \Phi(\lambda^{\frac{4k+3}{3}}f_2(\eta); \lambda^{\frac{4k+3}{3}}\kappa_0)e^{\lambda^{\frac{4k+3}{2}}g_1(\eta)\sigma_3}N^{-1}(\lambda(\eta-r))^{\frac{1}{4}\sigma_3}.
$$
 (5.21)

As $\zeta \to \infty$, $\Phi(\zeta; x)$ exhibits different asymptotic behaviors for bounded x or $x \to -\infty$; see [\(A.2\)](#page-44-2) and [\(B.1\)](#page-46-1). We thus split the discussions into two cases in what follows, namely, $\lambda^{\frac{4k+3}{3}}\kappa_0$ is bounded and $\lambda^{\frac{4k+3}{3}}\kappa_0 \to -\infty$.

When $\lambda^{\frac{4k+3}{3}}\kappa_0$ is bounded, *i.e.* $b_0 = \mathcal{O}(\lambda^{-\frac{4k+3}{3}})$ as $\lambda \to +\infty$, according to [\(5.19\)](#page-30-0), we find that ρ_2 behaves like $C(\lambda)\lambda^{-\frac{2k}{3}-\frac{1}{2}}$ as $\lambda \to +\infty$, where $C(\lambda)$ is bounded and non-zero when λ is large enough. A combination of (5.13) , (5.16) and (5.17) gives us

$$
\kappa(\eta) - \kappa_0 = \mathcal{O}(\lambda^{-2k - \frac{3}{2}}), \qquad \lambda \to +\infty,
$$
\n(5.22)

uniformly for $\eta \in \partial U(r;\rho_2)$. From the above formula and [\(5.14\)](#page-29-5), we have

$$
\exp\left\{\lambda^{\frac{4k+3}{2}}g_1(\eta) - \frac{2}{3}\left(\lambda^{\frac{4k+3}{3}}f_2(\eta)\right)^{\frac{3}{2}} - \lambda^{\frac{4k+3}{3}}\kappa_0\left(\lambda^{\frac{4k+3}{3}}f_2(\eta)\right)^{\frac{1}{2}}\right\} \n= \exp\left\{\lambda^{\frac{4k+3}{2}}(\kappa(\eta) - \kappa_0)(f_2(\eta))^{\frac{1}{2}}\right\} = 1 + \mathcal{O}(\rho_2^{\frac{1}{2}}), \qquad \lambda \to +\infty,
$$
\n(5.23)

uniformly for all $\eta \in \partial U(r;\rho_2)$. This implies that

$$
N \exp \left\{ \left\{ \lambda^{\frac{4k+3}{2}} (\kappa(\eta) - \kappa_0) (f_2(\eta))^{\frac{1}{2}} \right\} \sigma_3 \right\} N^{-1} = I + \begin{pmatrix} \mathcal{O}(\rho_2) & \mathcal{O}(\rho_2^{\frac{1}{2}}) \\ \mathcal{O}(\rho_2^{\frac{1}{2}}) & \mathcal{O}(\rho_2) \end{pmatrix} \tag{5.24}
$$

as $\lambda \to +\infty$ uniformly for all $\eta \in \partial U(r;\rho_2)$ and $\lambda^{\frac{4k+3}{3}}|\kappa_0| = \mathcal{O}(1)$. Therefore, in view of $(A.2)$, we obtain from [\(5.21\)](#page-30-1) and the above approximation that

$$
\times (\lambda(\eta - r))^{-\frac{1}{4}\sigma_3} N \exp \left\{ \left\{ \lambda^{\frac{4k+3}{2}} (\kappa(\eta) - \kappa_0) (f_2(\eta))^{\frac{1}{2}} \right\} \sigma_3 \right\} N^{-1} (\lambda(\eta - r))^{\frac{1}{4}\sigma_3}
$$
\n
$$
= (\lambda \rho_2)^{-\frac{1}{4}\sigma_3} \left(I + \begin{pmatrix} \mathcal{O}(\rho_2) & \mathcal{O}(\rho_2^{\frac{1}{2}}) \\ \mathcal{O}(\rho_2^{\frac{1}{2}}) & \mathcal{O}(\rho_2) \end{pmatrix} \right) (\lambda \rho_2)^{\frac{1}{4}\sigma_3}, \quad \lambda \to +\infty, \tag{5.25}

uniformly for all $\eta \in \partial U(r;\rho_2)$ and $\lambda^{\frac{4k+3}{3}}|\kappa_0| = \mathcal{O}(1)$.

When $-\lambda^{\frac{4k+3}{3}}\kappa_0 \gg 1$ as $\lambda \to +\infty$, it is obvious that $\lambda^{\frac{4k+3}{2}}|\kappa_0| \gg \lambda^{\frac{2k}{3}+\frac{1}{2}}$. Then, it follows from (5.19) that

\n
$$
\times (\lambda(\eta - r))^{-\frac{1}{4}\sigma_3} N \exp \left\{ \left\{ \lambda^{\frac{4k+3}{2}} (\kappa(\eta) - \kappa_0) (f_2(\eta))^{\frac{1}{2}} \right\} \sigma_3 \right\} N^{-1} (\lambda(\eta - r))^{\frac{1}{4}\sigma_3}
$$
\n
$$
= (\lambda \rho_2)^{-\frac{1}{4}\sigma_3} \left(I + \begin{pmatrix} \mathcal{O}(\rho_2) & \mathcal{O}(\rho_2^{\frac{1}{2}}) \\ \mathcal{O}(\rho_2^{\frac{1}{2}}) & \mathcal{O}(\rho_2) \end{pmatrix} \right) (\lambda \rho_2)^{\frac{1}{4}\sigma_3}, \qquad \lambda \to +\infty, \tag{5.27}

uniformly for all $\eta \in \partial U(r;\rho_2)$ and $-\lambda^{\frac{4k+3}{3}}\kappa_0 \gg 1$.

Combining [\(5.25\)](#page-31-1) and [\(5.27\)](#page-31-2), we conclude that

Final transformation With the aid of the global and local parametrices built in (5.7) and [\(5.11\)](#page-29-0), the final transformation is defined by

$$
(5.29)

It is straightforward to check that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is analytic in $\mathbb{C} \setminus \Sigma^R$, where $\Sigma^R = (\Sigma_1^P \cup \Sigma_3^P \cup \partial U(r;\rho_2)) \setminus U(r;\rho_2)$ is shown in Figure [8.](#page-32-0)
- (b) On Σ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

where

v_R(\eta) = \begin{cases} I + \mathcal{O}(\lambda^{\frac{2k}{3} + \frac{1}{2}} e^{-C_2 \lambda^{\frac{k}{2}}}), & \eta \in \Sigma^R \setminus \partial U(r; \rho_2), \\ I + \begin{pmatrix} \mathcal{O}(\rho_2) & \mathcal{O}(\rho_2^{\frac{1}{2}}) \\ \mathcal{O}(\rho_2^{\frac{1}{2}}) & \mathcal{O}(\rho_2) \end{pmatrix}, & \eta \in \partial U(r; \rho_2) \end{cases}

(5.31)

as $\lambda \to +\infty$.

(c) As $\eta \to \infty$, we have $R(\eta) = I + \mathcal{O}(\eta^{-1})$.

From [\(5.31\)](#page-32-1), it is readily seen that that $v_R(\eta)$ tends to identity matrix exponentially fast as $\lambda \to +\infty$ uniformly for all $\eta \in \Sigma^R \setminus \partial U(r;\rho_2)$. When $\eta \in \partial U(r;\rho_2)$, we see that $v_R(\eta)$ $I + \mathcal{O}(\rho_2^{\frac{1}{2}})$. Following the standard argument of the small norm RH problem (cf. [\[24,](#page-55-0) [33\]](#page-56-14)), we conclude that

uniformly for $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$, where ρ_2 is defined in [\(5.19\)](#page-30-0) and $\delta \in (0, \frac{1}{4})$ $rac{1}{4}$) is an arbitrarily fixed constant.

Proof. From [\(5.30\)](#page-32-2), we have

By Plemelj's formula, it follows that

For $\eta \in \partial U(r;\rho_2)$, we obtain from [\(5.31\)](#page-32-1) and [\(5.32\)](#page-32-3) that

uniformly for $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$. This finishes the proof of Lemma [5.2.](#page-32-5) \Box

5.2 Riemann-Hilbert analysis when $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}]$

Construction of the g-function Since the conclusion in Lemma [4.4](#page-20-3) is not applicable in this case, we have to introduce a new g-function in the form

where $p_2(\eta)$ is a polynomial of degree 2k and r_0 is a constant to be determined. It is required that g_2 satisfies the matching condition

\n(5.39)

where $\theta(\eta; y)$ is defined in [\(4.1\)](#page-19-9) and d_2 is a constant independent of η whose explicit value is unimportant. A direct calculation yields that

g_2(\eta) = (\eta - r_0)^{\frac{3}{2}} \sum_{j=0}^{2k} \frac{4}{4k+3} \frac{\Gamma(j+\frac{3}{2})}{\Gamma(j+1)\Gamma(\frac{3}{2})} r_0^j \eta^{2k-j}, \qquad \eta \in \mathbb{C} \setminus (-\infty, r_0].
$$
 (5.42)

First transformation Utilizing the above g_2 , we can normalize X as

$$
\tilde{P}(\eta) = \begin{pmatrix} 1 & 0 \\ -d_2 \lambda^{2k+2} & 1 \end{pmatrix} X(\lambda \eta) \begin{cases} \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix} e^{\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3}, & \eta \in \mathcal{I}, \\ \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix} e^{\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3}, & \eta \in \mathcal{II}, \\ e^{\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3}, & \text{elsewhere,} \end{cases}
$$
\n(5.43)

where regions I and II are illustrated in Figure [9](#page-34-0) and the constant d_2 is given in [\(5.39\)](#page-33-2). It is evident that \tilde{P} satisfies the following RH problem.

RH problem for \tilde{P}

- (a) $\tilde{P}(\eta)$ is analytic in $\mathbb{C} \setminus \Gamma^{\tilde{P}}$, where $\Gamma^{\tilde{P}} := \Gamma_1^{\tilde{P}} \cup \Gamma_2^{\tilde{P}} \cup \Gamma_3^{\tilde{P}} \cup \Gamma_4^{\tilde{P}}$ is shown in Figure [9.](#page-34-0)
- (b) On $\Gamma^{\tilde{P}}$, the limiting values $\tilde{P}_{\pm}(\eta)$ exist and satisfy the jump condition

$$
\tilde{P}_{+}(\eta) = \tilde{P}_{+}(\eta) \begin{cases}\n\begin{pmatrix}\n1 & e^{-2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} \\
0 & 1\n\end{pmatrix}, & \eta \in \Gamma_{1}^{\tilde{P}}, \\
\begin{pmatrix}\n1 & 0 \\
e^{2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} & 1\n\end{pmatrix}, & \eta \in \Gamma_{2}^{\tilde{P}} \cup \Gamma_{4}^{\tilde{P}}, \\
\begin{pmatrix}\n0 & 1 \\
-1 & 0\n\end{pmatrix}, & \eta \in \Gamma_{3}^{\tilde{P}}.\n\end{cases}
$$
\n(5.44)

- (c) As $\eta \to r$, we have $\tilde{P}(\eta) = \mathcal{O}(\log(\eta r)).$
- (d) As $\eta \to \infty$, we have

$$
\tilde{P}(\eta) = \left(I + \mathcal{O}(\eta^{-1})\right)(\lambda \eta)^{-\frac{1}{4}\sigma_3} N,\tag{5.45}
$$

where N is defined in (3.4) .

Note that

$$
g_2(|y|^{\frac{1}{2k+1}}\eta) = |y|^{\frac{4k+3}{4k+2}}g(\eta), \qquad r_0 = |y|^{\frac{1}{2k+1}}z_0,\tag{5.46}
$$

where g is defined in $(C.4)$ and z_0 is specified in $(C.6)$. These facts, together with [\[14,](#page-55-10) Proposition 2.5 and Corollary 2.6, yield that $\text{Re } g_2(\eta) < 0$ for $\eta \in \Gamma_2^{\tilde{P}} \cup \Gamma_4^{\tilde{P}}$ and $\text{Re } g_2(\eta) > 0$ for $\eta \in \Gamma_1^{\tilde{P}}$, provided that $\eta \neq r_0$. Moreover, we can show that there exist two fixed constants M_3 , $\tilde{\rho}_2 > 0$ such that

\operatorname{Re} g_2(\eta) \le -M_3, \quad \eta \in \Gamma_2^{\tilde{P}} \cup \Gamma_4^{\tilde{P}},\tag{5.47}

provided that $|\eta - r_0| \ge \tilde{\rho}_2$. This implies that, as $\lambda \to \infty$, the jump matrices of \tilde{P} converge exponentially fast to the identity matrix, uniformly for $\eta \in (\Gamma_1^{\tilde{P}} \cup \Gamma_2^{\tilde{P}} \cup \Gamma_4^{\tilde{P}}) \setminus U(r_0; \tilde{\rho}_2)$, where $U(r_0; \tilde{\rho}_2)$ is a fixed neighborhood of $\eta = r_0$.

Global parametrix In view of the fact that $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}],$ it follows from [\(5.40\)](#page-33-3) that $r - r_0 = \mathcal{O}(\lambda^{-k-1+\delta})$ as $\lambda \to +\infty$. This indicates that r lies within the open disk $U(r_0; \tilde{\rho}_2)$ for large λ . Hence, we proceed to define the global parametrix in this case by

\tilde{P}^{(\infty)}(\eta) = (\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3} N,\tag{5.49}

which solves the following RH problem.

RH problem for $\tilde{P}^{(\infty)}$

- (a) $\tilde{P}^{(\infty)}(\eta)$ is analytic in $\mathbb{C} \setminus (-\infty, r_0]$.
- (b) $\tilde{P}^{(\infty)}$ satisfies the jump condition

$$
\tilde{P}_{+}^{(\infty)}(\eta) = \tilde{P}_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, r_0). \tag{5.50}
$$

(c) As $\eta \to \infty$, we have

$$
\tilde{P}^{(\infty)}(\eta) = (I + \mathcal{O}(\eta^{-1}))(\lambda \eta)^{-\frac{1}{4}\sigma_3} N. \tag{5.51}
$$

Local parametrix Since \tilde{P} and $\tilde{P}^{(\infty)}$ are not uniformly close to each other in $U(r_0; \tilde{\rho}_2)$, it is necessary to construct a local parametrix that satisfies the following RH problem.

RH problem for $\tilde{P}^{(r_0)}$

- (a) $\tilde{P}^{(r_0)}(\eta)$ is analytic in $U(r_0; \tilde{\rho}_2) \setminus \Gamma^{\tilde{P}}$.
- (b) On $U(r_0; \tilde{\rho}_2) \cap \Gamma^{\tilde{P}}$, the limiting values $\tilde{P}_{\pm}^{(r_0)}$ exist and satisfy the jump condition

$$
\tilde{P}_{+}^{(r_{0})}(\eta) = \tilde{P}_{+}^{(r_{0})}(\eta) \begin{cases}\n\begin{pmatrix}\n1 & e^{-2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} \\
0 & 1\n\end{pmatrix}, & \eta \in \Gamma_{1}^{\tilde{P}} \cap U(r_{0}; \tilde{\rho}_{2}), \\
\begin{pmatrix}\n1 & 0 \\
e^{2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} & 1\n\end{pmatrix}, & \eta \in (\Gamma_{2}^{\tilde{P}} \cup \Gamma_{4}^{\tilde{P}}) \cap U(r_{0}; \tilde{\rho}_{2}), \\
\begin{pmatrix}\n0 & 1 \\
-1 & 0\n\end{pmatrix}, & \eta \in \Gamma_{3}^{\tilde{P}} \cap U(r_{0}; \tilde{\rho}_{2}).\n\end{cases}
$$
\n(5.52)

(c) As $\lambda \to \infty$, $\tilde{P}^{(r_0)}$ satisfies the matching condition

$$
\tilde{P}^{(r_0)}(\eta) = (I + o(1))\tilde{P}^{(\infty)}(\eta), \qquad \eta \in \partial U(r_0; \tilde{\rho}_2), \tag{5.53}
$$

where $\tilde{P}^{(\infty)}$ is given in [\(5.49\)](#page-35-0).

To solve this RH problem, we introduce the function

where $g_2(\eta)$ is defined in [\(5.38\)](#page-33-4). Clearly, $f_3(\eta; r_0)$ is analytic in $U(r_0; \tilde{\rho}_2)$. Indeed, we have

where $p_2(r_0) > 0$ by [\(5.41\)](#page-33-5). Thus, $f_3(\eta; r_0)$ is a conformal mapping for $\eta \in U(r_0, \tilde{\rho}_2)$. We next define

\tilde{P}^{(r_0)}(\eta) = \tilde{E}_2(\eta)\tilde{\Phi}(\lambda^{\frac{4k+3}{3}}f_3(\eta; r_0); \lambda^{\frac{4k+3}{3}}f_3(r; r_0))\exp\left\{\lambda^{\frac{4k+3}{2}}g_2(\eta)\sigma_3\right\},\tag{5.56}
$$

where

$$
\tilde{E}_2(\eta) := (\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3} (\lambda^{\frac{4k+3}{3}} f_3(\eta; r_0))^{\frac{1}{4}\sigma_3} e^{-\frac{\pi i}{4}\sigma_3}
$$
\n(5.57)

is an analytic prefactor in $U(r_0; \tilde{\rho}_2)$ and $\tilde{\Phi}(\zeta; x)$ is a variant of the P₃₄ parametrix defined in [\(A.8\)](#page-45-1). From the RH problem for $\tilde{\Phi}$ given in Appendix [A,](#page-44-0) one can easily check that that $\tilde{P}^{(r_0)}$ in (5.56) satisfies items (a) and (b) in the RH problem for $\tilde{P}^{(r_0)}$. To show the matching condition [\(5.53\)](#page-35-1), we see from [\(A.10\)](#page-46-2), [\(B.12\)](#page-48-0), [\(5.49\)](#page-35-0) and [\(5.56\)](#page-36-1) that, as $\lambda \to +\infty$,

$$
\tilde{P}^{(r_0)}(\eta)\tilde{P}^{(\infty)}(\eta)^{-1} = \left(\frac{\lambda(\eta - r_0)}{\lambda^{\frac{4k+3}{3}}f_3(\eta; r_0)}\right)^{-\frac{1}{4}\sigma_3} \left(I + \mathcal{O}(\lambda^{-\frac{4k+3}{3}}f_3(\eta; r_0)^{-1})\right) \left(\frac{\lambda(\eta - r_0)}{\lambda^{\frac{4k+3}{3}}f_3(\eta; r_0)}\right)^{\frac{1}{4}\sigma_3} = I + \mathcal{O}(\lambda^{-\frac{2k}{3}-1}), \qquad \eta \in \partial U(r; \tilde{\rho}_2),
$$
\n(5.58)

uniformly for $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}].$

Final transformation The final transformation is defined by

$$
R(\eta) = \begin{cases} \tilde{P}(\eta)\tilde{P}^{(r_0)}(\eta)^{-1}, & \eta \in U(r_0; \tilde{\rho}_2), \\ \tilde{P}(\eta)\tilde{P}^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus U(r_0; \tilde{\rho}_2). \end{cases}
$$
(5.59)

From the global and local parametrices built in (5.49) and (5.56) it is easy to check that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is defined and analytic in $\mathbb{C} \setminus \Gamma^R$, where $\Gamma^R := \left(\Gamma_2^{\tilde{P}} \cup \Gamma_4^{\tilde{P}} \cup \partial U(r_0; \tilde{\rho}_2)\right) \setminus U(r_0; \tilde{\rho}_2)$ is shown in Figure [10.](#page-36-2)
- (b) On Γ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

$$
R_{+}(\eta) = R_{-}(\eta)v_{R}(\eta), \tag{5.60}
$$

where

$$
v_R(\eta) = \begin{cases} I + \mathcal{O}(\lambda^{-\frac{2k}{3}-1}), & \eta \in \partial U(r_0; \tilde{\rho}_2), \\ I + \mathcal{O}(\lambda^{-\frac{1}{2}} e^{-M_3 \lambda^{\frac{4k+3}{2}}}), & \eta \in \Gamma_R \setminus \partial U(r_0; \tilde{\rho}_2), \end{cases}
$$
(5.61)

as $\lambda \to +\infty$.

(c) As $\eta \to \infty$, we have $R(\eta) = I + \mathcal{O}(\eta^{-1})$.

By the standard argument of the small norm RH problem, we conclude that, as $\lambda \to +\infty$,

$$
R(\eta) = I + \mathcal{O}(\lambda^{-\frac{2k}{3}-1}), \qquad R'(r) = \mathcal{O}(\lambda^{-\frac{2k}{3}-1}), \tag{5.62}
$$

uniformly for $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}].$

5.3 Proof of Lemma [2.3](#page-11-0)

We split the proof into two parts, corresponding to the analysis performed in Sections [5.1](#page-27-1) and [5.2,](#page-33-0) respectively.

The case when $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$

This part is an outcome of the analysis carried out in Section [5.1.](#page-27-1) From Lemma [3.3](#page-18-1) and the definition of P in (5.1) , we obtain

By inverting the transformation in [\(5.29\)](#page-31-3), it follows from the above equation that

\frac{\partial F}{\partial s}(s;x) = \frac{1}{2\pi i\lambda} \left[(P^{(r)}(\eta)^{-1} P^{(r)'}(\eta))_{21} + (P^{(r)}(\eta)^{-1} (\lambda \rho_2)^{-\frac{1}{4}\sigma_3} R(\eta)^{-1} R'(\eta) (\lambda \rho_2)^{\frac{1}{4}\sigma_3} P^{(r)}(\eta))_{21} \right] \Big|_{\eta \to r}.
$$
\n(5.64)

Substituting $P^{(r)}$ in [\(5.11\)](#page-29-0) into the above formula, we obtain from the local behavior of Φ near the origin given in [\(A.3\)](#page-44-3) and [\(A.4\)](#page-44-4) that

\frac{\partial F}{\partial s}(s; x) = \Theta_1(r) + \Theta_2(r) + \Theta_3(r),\tag{5.65}

where

\Theta_1(r) = \frac{\lambda^{\frac{4k+3}{3}}}{2\pi i\lambda} f_2'(r) \left(\Phi_1(\lambda^{\frac{4k+3}{3}} \kappa_0) \right)_{21},
$$
\n(5.66)

$$
\Theta_2(r) = \frac{1}{2\pi i \lambda} \left(\Phi_0(\lambda^{\frac{4k+3}{3}} \kappa_0)^{-1} \Xi_1(r) \Phi_0(\lambda^{\frac{4k+3}{3}} \kappa_0) \right)_{21},\tag{5.67}
$$

$$
\Theta_3(r) = \frac{1}{2\pi i \lambda} \left(\Phi_0(\lambda^{\frac{4k+3}{3}} \kappa_0)^{-1} \Xi_2(r) \Phi_0(\lambda^{\frac{4k+3}{3}} \kappa_0) \right)_{21},\tag{5.68}
$$

with $\Xi_1(\eta) = E_2(\eta)^{-1} E_2'(\eta)$, $\Xi_2(\eta) = E_2(\eta)^{-1} (\lambda \rho_2)^{-\frac{1}{4}\sigma_3} R(\eta)^{-1} R'(\eta) (\lambda \rho_2)^{\frac{1}{4}\sigma_3} E_2(\eta)$ and κ_0 given in [\(5.17\)](#page-29-2).

We next estimate $\Theta_i(r)$, $i = 1, 2, 3$, in [\(5.65\)](#page-37-1), respectively. In view of the definition of E_2 in (5.12) , it is readily seen that $E_2(r)$ is diagonal and

A further appeal to the estimate of $R(r)$ and $R'(r)$ in [\(5.33\)](#page-32-4) gives us

It is then readily seen from the above two estimates and large λ behavior of $\Phi_0(-\lambda)$ in [\(B.20\)](#page-50-0) that as $\lambda \to +\infty$,

\Theta_2(r) = \mathcal{O}(\lambda^{\frac{k}{3}-1+\delta}) \quad \text{and} \quad \Theta_3(r) = \mathcal{O}(\lambda^{k-\frac{1}{2}+\delta}), \tag{5.71}

uniformly for $\alpha_k r^{2k+1} + y \in [-C_1 \lambda^{-k-1+\delta}, 0]$. To estimate Θ_1 , we see from [\(5.66\)](#page-38-0) and [\(5.18\)](#page-30-3) that

\Theta_1(r) = \frac{\lambda^{\frac{4k+3}{3}}}{2\pi i \lambda} \frac{\partial \kappa_0}{\partial r} \left(\Phi_1(\lambda^{\frac{4k+3}{3}} \kappa_0) \right)_{21} \left(1 + \mathcal{O}(\lambda^{-k-1+\delta}) \right)
$$

=
$$
\frac{1}{2\pi i} \frac{\partial \chi(s; x)}{\partial s} \left(\Phi_1(\chi(s; x))_{21} \left(1 + \mathcal{O}(\lambda^{-k-1+\delta}) \right), \qquad \lambda \to +\infty, \tag{5.72}
$$

where $\chi(s; x)$ is defined in [\(2.5\)](#page-11-4) with $s = r\lambda$ and $x = y\lambda^{2k+1}$.

Finally, substituting [\(5.71\)](#page-38-1) and [\(5.72\)](#page-38-2) into [\(5.65\)](#page-37-1), we obtain the desired result in [\(2.4\)](#page-11-3) by making use of the fact in [\(A.6\)](#page-45-2) and by setting $\delta = 1/6$ and $y \neq 0$ fixed.

The case when $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}]$

This part is an outcome of the analysis carried out in Section [5.2.](#page-33-0) Similar to the derivation of [\(5.65\)](#page-37-1), one can show in this case that

$$
\frac{\partial F}{\partial s}(s;x) = \frac{1}{2\pi i\lambda} \left(e^{\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3} \tilde{P}(\eta)^{-1} \tilde{P}(\eta)' e^{-\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3} \right)_{21}\Big|_{\eta \to r}
$$
\n
$$
= \tilde{\Theta}_1(r) + \tilde{\Theta}_2(r) + \tilde{\Theta}_3(r), \tag{5.73}
$$

where

$$
\tilde{\Theta}_1(r) = \frac{\lambda^{\frac{4k+3}{3}}}{2\pi i \lambda} f_3'(r; r_0) \left(\Phi_1 \left(\lambda^{\frac{4k+3}{3}} f_3(r; r_0) \right) \right)_{21},
$$
\n(5.74)

$$
\tilde{\Theta}_2(r) = \frac{1}{2\pi i \lambda} \left(\tilde{\Phi}_0 \left(\lambda^{\frac{4k+3}{3}} f_3(r; r_0) \right) \right)^{-1} \tilde{\Xi}_1(r) \tilde{\Phi}_0 \left(\lambda^{\frac{4k+3}{3}} f_3(r; r_0) \right) \right)_{21}, \tag{5.75}
$$

$$
\tilde{\Theta}_3(r) = \frac{1}{2\pi i \lambda} \left(\tilde{\Phi}_0 \left(\lambda^{\frac{4k+3}{3}} f_3(r; r_0) \right) \right)^{-1} \tilde{\Xi}_2(r) \tilde{\Phi}_0 \left(\lambda^{\frac{4k+3}{3}} f_3(r; r_0) \right) \right)_{21}.
$$
 (5.76)

Here, Φ_1 , $\tilde{\Phi}_0$, f_3 are given in [\(A.12\)](#page-46-3), [\(A.13\)](#page-46-4) and [\(5.54\)](#page-36-0), respectively, $\tilde{\Xi}_1(\eta) = \tilde{E}_2(\eta)^{-1} \tilde{E}'_2(\eta)$ and $\tilde{\Xi}_2(\eta) = \tilde{E}_2(\eta)^{-1} R(\eta)^{-1} R'(\eta) \tilde{E}_2(\eta).$

In view of the definition of E_2 in [\(5.57\)](#page-36-3) and the estimates of $R(r)$ and $R'(r)$ in [\(5.62\)](#page-37-2), it follows that

\tilde{\Xi}_1(r) = \mathcal{O}(1), \qquad \tilde{\Xi}_2(r) = \mathcal{O}(\lambda^{-1}), \qquad \lambda \to +\infty.

This, together with large λ asymptotics of $\tilde{\Phi}_0(\lambda)$ in [\(B.21\)](#page-50-1) and the fact that $f_3(r; r_0)$ = $\mathcal{O}(\lambda^{-k-1+\delta})$, implies that

\tilde{\Theta}_2(r) = \mathcal{O}\left(\lambda^{\frac{k}{6} + \frac{\delta}{2} - 1}\right), \qquad \tilde{\Theta}_3(r) = \mathcal{O}\left(\lambda^{\frac{k}{6} + \frac{\delta}{2} - 2}\right)
$$
\n(5.78)

as $\lambda \to +\infty$, uniformly for $\alpha_k r^{2k+1} + y \in [0, C_1 \lambda^{-k-1+\delta}].$

From the definition of f_3 in [\(5.54\)](#page-36-0), it is readily seen that

$$
\lambda^{\frac{4k+3}{3}} f_3(r;r_0) = f_3(s;s_0) \quad \text{and} \quad \lambda^{\frac{4k}{3}} f'_3(r;r_0) = f'_3(s;s_0), \tag{5.79}
$$

where $s = r\lambda$ and $s_0 = r_0\lambda$ with r_0 and s_0 given in [\(5.40\)](#page-33-3) and [\(2.6\)](#page-11-2) respectively. Inserting [\(5.78\)](#page-39-2) into [\(5.73\)](#page-38-3), we thus obtain [\(2.4\)](#page-11-3) by [\(5.79\)](#page-39-3), [\(A.6\)](#page-45-2), and by setting $\delta = 1/6$ and $y \neq 0$ fixed.

6 Asymptotic analysis in the exponential decay region

In this section, we establish the large λ asymptotics of $X(\lambda \eta)$ for $\alpha_k r^{2k+1} + y \in [C_1 \lambda^{-k-1+\delta}, +\infty)$ with $\delta \in (0, \frac{1}{4})$ $\frac{1}{4}$, which finally leads to the proof of Lemma [2.4.](#page-11-1) As discussed at the end of Section [3.2,](#page-15-0) this case corresponds to the exponential decay region. It comes out the first transformation and the global parametrix are exactly the same as those given in Section [5.2.](#page-33-0) The difference lies in the construction of local parametrix. Due to our assumption on r and y , we have $|r - r_0| \ge C_1 \lambda^{-k-1+\delta}$, which means that r tends to r_0 slower than the case in Section [5.2.](#page-33-0) Hence, we construct local parametrices around $\eta = r_0$ and $\eta = r$, respectively. In particular, the one near $\eta = r_0$ involves the Airy parametrix.

6.1 Riemann-Hilbert analysis when $\alpha_k r^{2k+1} + y \in [C_1 \lambda^{-k-1+\delta}, +\infty)$

First transformation and global parametrix We define $Q(\eta) = \tilde{P}(\eta)$, where \tilde{P} is given in [\(5.43\)](#page-34-1). It then follows that Q satisfies the following RH problem.

RH problem for Q

- (a) $Q(\eta)$ is analytic in $\mathbb{C} \setminus \Gamma^Q$, where $\Gamma^Q = \Gamma_1^Q \cup \Gamma_2^Q \cup \Gamma_3^Q \cup \Gamma_4^Q$ $\frac{Q}{4}$ is shown in Fig [11.](#page-40-0)
- (b) On Γ_Q , the limiting values $Q_{\pm}(\eta)$ exist and satisfy $Q_{+}(\eta) = Q_{+}(\eta)v_Q(\eta)$, where

$$
v_Q(\eta) := \begin{cases} \begin{pmatrix} 1 & e^{-2\lambda^{\frac{4k+3}{2}}g_2(\eta)} \\ 0 & 1 \end{pmatrix}, & \eta \in \Gamma_1^Q, \\ \begin{pmatrix} 1 & 0 \\ e^{2\lambda^{\frac{4k+3}{2}}g_2(\eta)} & 1 \end{pmatrix}, & \eta \in \Gamma_2^Q \cup \Gamma_4^Q, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in \Gamma_3^Q, \end{cases}
$$
 (6.1)

with q_2 given in (5.38) .

Figure 11: The jump contours of the RH problem for Q , where r_0 is defined in [\(5.40\)](#page-33-3).

- (c) As $\eta \to r$, we have $Q(\eta) = \mathcal{O}(\log(\eta r)).$
- (d) As $\eta \to \infty$, we have

$$
Q(\eta) = \left(I + \mathcal{O}(\eta^{-1})\right)(\lambda \eta)^{-\frac{1}{4}\sigma_3} N,\tag{6.2}
$$

where N is defined in (3.4) .

As mentioned in Section [5.2,](#page-33-0) we know that $\text{Re } g_2(\eta) < 0$ when $\eta \in \Gamma_2^Q \cup \Gamma_4^Q$ $\frac{dQ}{4}$ and Re $g_2(\eta) > 0$ when $\eta \in \Gamma_1^Q$ ^{Q}. Moreover, from [\(5.41\)](#page-33-5), we see that $p_2(r_0) > 0$ is fixed, then it follows from [\(5.38\)](#page-33-4) that there exist a constant $M_4 > 0$ such that

$$
\lambda^{\frac{4k+3}{2}} \text{Re}\, g_2(\eta) \le -M_4 \lambda^{\frac{k}{2} + \frac{3}{2}\delta}, \quad \eta \in \Gamma_2^Q \cup \Gamma_4^Q,\tag{6.3}
$$

$$
\lambda^{\frac{4k+3}{2}} \text{Re}\, g_2(\eta) \ge M_4 \lambda^{\frac{k}{2} + \frac{3}{2}\delta}, \qquad \eta \in \Gamma_1^Q \tag{6.4}
$$

provided that $|\eta-r_0|\geq \rho_3$, where $\rho_3=\mathcal{O}(\lambda^{-k-1+\delta})$ is a shrinking radius given in [\(6.7\)](#page-40-1). Although the above approximation is slightly weaker than those in (5.47) and (5.48) , it is sufficient to guarantee $v_Q(\eta) \to I$ exponentially fast uniformly for $\eta \in \Gamma_1^Q \cup \Gamma_2^Q \cup \Gamma_4^Q$ $\frac{Q}{4}$ and $|\eta - r_0| \ge \rho_3$. We thus have the global parametrix

$$
Q^{(\infty)}(\eta) = (\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3} N, \qquad \eta \in \mathbb{C} \setminus (-\infty, r_0],
$$
\n(6.5)

which satisfies the asymptotics [\(6.2\)](#page-40-2) and the jump condition

$$
Q_{+}^{(\infty)}(\eta) = Q_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, r_0). \tag{6.6}
$$

Local parametrices near $\eta = r_0$ and $\eta = r$ Since Q and $Q^{(\infty)}$ are not uniformly close to each other near $\eta = r_0$ and Q admits a logarithm singularity near $\eta = r$, we need to construct local parametrices around these two points. More precisely, let

$$
\rho_3 = C_3 \lambda^{-k-1+\delta},\tag{6.7}
$$

where $C_3 > 0$ is a small positive constant, the local parametrices $Q^{(r_0)}$ and $Q^{(r)}$ will be built in two shrinking disks $U(r_0; \rho_3)$ and $U(r; \rho_3)$, respectively. Note that for large λ and appropriately chosen C_3 , $U(r_0; \rho_3) \cap U(r; \rho_3) = \emptyset$.

The local parametrix in $U(r_0; \rho_3)$ reads as follows.

RH problem for $Q^{(r_0)}$

- (a) $Q^{(r_0)}(\eta)$ is analytic in $U(r_0;\rho_3) \setminus \Gamma^Q$.
- (b) On $U(r_0; \rho_3) \cap \Gamma^Q$, the limiting values $Q_{\pm}^{(r_0)}(\eta)$ exist and satisfy the jump condition

$$
Q_{+}^{(r_{0})}(\eta) = Q_{-}^{(r_{0})}(\eta) \begin{cases} \begin{pmatrix} 1 & e^{-2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} \\ 0 & 1 \end{pmatrix}, & \eta \in \Gamma_{1}^{Q} \cap U(r_{0};\rho_{3}), \\ \begin{pmatrix} 1 & 0 \\ e^{2\lambda^{\frac{4k+3}{2}}g_{2}(\eta)} & 1 \end{pmatrix}, & \eta \in (\Gamma_{2}^{Q} \cup \Gamma_{4}^{Q}) \cap U(r_{0};\rho_{3}), \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in \Gamma_{3}^{Q} \cap U(r_{0};\rho_{3}). \end{cases}
$$
(6.8)

(c) As $\lambda \to \infty$, $Q^{(r_0)}$ satisfies the matching condition

$$
Q^{(r_0)}(\eta) = (I + o(1))Q^{(\infty)}(\eta), \qquad \eta \in \partial U(r_0; \rho_3), \tag{6.9}
$$

where $Q^{(\infty)}$ is given in [\(6.5\)](#page-40-3).

The conformal mapping we used here is the same as that used in Section [5.2,](#page-33-0) *i.e.*

$$
f_3(\eta; r_0) = \left(\frac{3}{2}g_2(\eta)\right)^{\frac{2}{3}},\tag{6.10}
$$

which behaves like

$$
f_3(\eta; r_0) = \left(\frac{3p_2(r_0)}{2}\right)^{\frac{2}{3}} (\eta - r_0) + \mathcal{O}((\eta - r_0)^2), \quad \text{as} \quad \eta \to r_0,

 (6.11)

with $p_2(r_0) > 0$. The local parametrix $Q^{(r_0)}(\eta)$ is given by

$$
Q^{(r_0)}(\eta) = E_3(\eta) \Phi^{(\text{Ai})}(\lambda^{\frac{4k+3}{3}} f_3(\eta; r_0)) \exp\left\{\lambda^{\frac{4k+3}{2}} g_2(\eta) \sigma_3\right\},\tag{6.12}
$$

where

$$
E_3(\eta) = (\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3} e^{-\frac{\pi i}{4}\sigma_3} (\lambda^{\frac{4k+3}{3}} f_3(\eta; r_0))^{\frac{1}{4}\sigma_3}
$$
(6.13)

and $\Phi^{(Ai)}$ is the classical Airy parametrix (cf. [\[32\]](#page-56-2)). Recall that $\Phi^{(Ai)}$ satisfies the jump condition

$$
\Phi_{+}^{(\text{Ai})}(z) = \Phi_{-}^{(\text{Ai})}(z) \begin{cases} \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & z < 0, \\ \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix}, & z > 0, \\ \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & z \in e^{\frac{2\pi i}{3}}(0, +\infty), \\ \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & z \in e^{\frac{-2\pi i}{3}}(0, +\infty), \end{cases}
$$
(6.14)

and the asymptotic behavior

$$
\Phi^{(\text{Ai})}(z) = \frac{1}{\sqrt{2}} z^{-\frac{1}{4}\sigma_3} \begin{pmatrix} 1 & i \\ i & 1 \end{pmatrix} \left(I + \mathcal{O}(z^{-\frac{3}{2}}) \right) e^{-\frac{2}{3}z^{3/2}\sigma_3}, \qquad z \to \infty,
$$
 (6.15)

one can check that $Q^{(r_0)}$ in [\(6.12\)](#page-41-0) indeed solves the RH problem for $Q^{(r_0)}$ by noting that the prefactor $E_3(\eta)$ is analytic in $U(r_0, \rho_3)$.

Similarly, we need to solve the following local parametrix in $U(r; \rho_3)$.

RH problem for $\mathbb{Q}^{(r)}$

- (a) $Q^{(r)}(\eta)$ is analytic in $U(r; \rho_3) \setminus [r_0, r]$.
- (b) On $U(r; \rho_3)$, the limiting values $Q_{\pm}^{(r)}(\eta)$ exist and satisfy the jump condition

$$
Q_{+}^{(r)}(\eta) = Q_{-}^{(r)}(\eta) \begin{pmatrix} 1 & e^{-2\lambda \frac{4k+3}{2}g_2(\eta)} \\ 0 & 1 \end{pmatrix}.
$$
 (6.16)

- (c) As $\eta \to r$, we have $Q^{(r)}(\eta) = \mathcal{O}(\log(\eta r)).$
- (d) As $\lambda \to +\infty$, $Q^{(r)}$ satisfies the matching condition

$$
Q^{(r)}(\eta) = (I + o(1))Q^{(\infty)}(\eta), \qquad \eta \in \partial U(r; \rho_3). \tag{6.17}
$$

It is straightforward to check that

$$
Q^{(r)}(\eta) = (\lambda(\eta - r_0))^{-\frac{\sigma_3}{4}} N \begin{pmatrix} 1 & \mathcal{C}_1(\eta, \lambda) \\ 0 & 1 \end{pmatrix} \tag{6.18}
$$

solves the RH problem for $Q^{(r)}$, where

$$
C_1(\eta,\lambda) = \frac{1}{2\pi i} \int_{\frac{r+r_0}{2}}^r \frac{e^{-2\lambda^{\frac{4k+3}{2}}g_2(\xi)}}{\xi - \eta} d\xi.
$$
 (6.19)

Final transformation As usual, the final transformation is defined by

$$
R(\eta) = \begin{cases} Q(\eta)Q^{(r_0)}(\eta)^{-1}, & \eta \in U(r_0; \rho_3), \\ Q(\eta)Q^{(r)}(\eta)^{-1}, & \eta \in U(r; \rho_3), \\ Q(\eta)Q^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus (U(r_0; \rho_3) \cup U(r; \rho_3)). \end{cases}
$$
(6.20)

Then it is readily seen that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is defined and analytic in $\mathbb{C} \setminus \Gamma^R$, where Γ^R is shown in Figure [6.1.](#page-43-1)
- (b) On Σ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

$$
R_{+}(\eta) = R_{-}(\eta)v_{R}(\eta), \qquad \eta \in \Gamma^{R}, \tag{6.21}
$$

where

$$
v_R(\eta) = \begin{cases} Q^{(r_0)}(\eta)Q^{(\infty)}(\eta)^{-1}, & \eta \in \partial U(r_0; \rho_3), \\ Q^{(r)}(\eta)Q^{(\infty)}(\eta)^{-1}, & \eta \in \partial U(r; \rho_3), \\ Q^{(\infty)}(\eta)v_Q(\eta)Q^{(\infty)}(\eta)^{-1}, & \eta \in \Gamma^R \setminus (\partial U(r_0; \rho_3) \cup \partial U(r; \rho_3)), \end{cases} (6.22)
$$

with v_Q given in (6.1) .

(c) As $\eta \to \infty$, we have

$$
R(\eta) = I + \mathcal{O}(\eta^{-1}).
$$
\n(6.23)

When $\eta \in \Gamma^R \setminus \partial U(r_0;\rho_3)$, we have from [\(6.3\)](#page-40-4) and [\(6.4\)](#page-40-5) that

$$
v_R(\eta) = I + \mathcal{O}(\lambda^{\frac{k-\delta}{2}} e^{-M_4 \lambda^{\frac{k}{2} + \frac{3}{2}\delta}}), \qquad \lambda \to +\infty,
$$
 (6.24)

for some constant $M_4 > 0$. For $\eta \in \partial U(r_0;\rho_3)$, substituting the large z asymptotic expansion of $\Phi^{(Ai)}(z)$ [\(6.15\)](#page-41-1) into [\(6.12\)](#page-41-0) and [\(6.22\)](#page-42-0), we have

$$
v_R(\eta) = Q^{(r_0)} Q^{(\infty)}(\eta)^{-1}
$$

= $(\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3} \left(I + \mathcal{O}(\lambda^{-\frac{4k+3}{2}} f_3(\eta; r_0)^{-\frac{3}{2}}) \right) (\lambda(\eta - r_0))^{-\frac{1}{4}\sigma_3}$
= $I + \mathcal{O}(\lambda^{-2k-2}(\eta - r_0)^{-2}) = I + \mathcal{O}(\lambda^{-2\delta}), \qquad \lambda \to +\infty.$ (6.25)

By a standard argument of the small norm RH problem, we conclude that, as $\lambda \to +\infty$,

$$
R(\eta) = I + \mathcal{O}(\lambda^{-2\delta}), \quad R'(\eta) = \mathcal{O}(\lambda^{k+1-3\delta}), \quad \eta \in \mathbb{C} \setminus \partial U(r_0; \rho_3). \tag{6.26}
$$

6.2 Proof of Lemma [2.4](#page-11-1)

Since $\zeta = \lambda \eta$, $s = r\lambda$, we find that $\zeta \to s$ yields $\eta \to r$. As mentioned at the beginning of this section, we take $Q(\eta) = \tilde{P}(\eta)$. It then follows from [\(5.73\)](#page-38-3) that

$$
\frac{\partial F}{\partial s}(s;x) = \frac{1}{2\pi i\lambda} \left(e^{\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3} Q(\eta)^{-1} Q(\eta)' e^{-\lambda \frac{4k+3}{2}g_2(\eta)\sigma_3} \right)_{21}\Big|_{\eta \to r}
$$
\n
$$
= \frac{1}{2\pi i\lambda} e^{-2\lambda \frac{4k+3}{2}g_2(\eta)} \tilde{Q}_{21}(\eta) \Big|_{\eta \to r},
$$
\n(6.27)

where

$$
\tilde{Q}(\eta) = Q^{(r)}(\eta)^{-1} R(\eta)^{-1} R(\eta)' Q^{(r)}(\eta) + Q^{(r)}(\eta)^{-1} Q^{(r)}(\eta)'.
$$

Making use of the explicit expression of $Q^{(r)}(\eta)$ in [\(6.18\)](#page-42-1) and the approximations of $R(\eta)$, $R'(\eta)$ in [\(6.26\)](#page-43-1), one can easily find that $\tilde{Q}_{21}(r)$ exhibits only algebraic growth as $\lambda \to +\infty$ and $g_2(r) > 0$. Hence, we derive from [\(6.27\)](#page-43-2) that

$$
\frac{\partial F}{\partial s}(s;x) = \mathcal{O}\left(e^{-\lambda \frac{4k+3}{2}g_2(r)}\right) \tag{6.28}
$$

as $\lambda \to +\infty$. Observing that $x = y\lambda^{2k+1}$, $s = r\lambda$ and the definitions of s_0, r_0 in [\(2.6\)](#page-11-2), [\(5.40\)](#page-33-3) respectively, one can easy to find that $s_0 = \lambda r_0$. Moreover, by fixing $y \neq 0$, we can further obtain

$$
\frac{\partial F}{\partial s}(s; x) = \mathcal{O}\left(e^{-My^{\frac{4k+3}{4k+2}}\lambda^{\frac{4k+3}{2}}(r-r_0)^{\frac{3}{2}}}\right)
$$
(6.29)

as $\lambda \to +\infty$ for some fixed constant $M > 0$. This implies [\(2.7\)](#page-11-6) immediately. With this, the proof of Lemma [2.4](#page-11-1) is concluded.

The P³⁴ parametrix used in the present work is defined by the following RH problem.

- (a) $\Phi(\zeta; x)$ is analytic for $\zeta \in \mathbb{C} \setminus \Gamma$, where $x \in \mathbb{R}$ and $\Gamma := \cup_{j=1}^3 \Gamma_j$ is shown in Figure [13.](#page-44-5)
- (b) On Γ, the limiting values $\Phi_{\pm}(\zeta; x)$ exist and satisfy the jump condition

\Phi_{+}(\zeta;x) = \Phi_{-}(\zeta;x) \begin{cases} \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in \Gamma_{1} \cup \Gamma_{3}, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \zeta \in \Gamma_{2}. \end{cases}
$$
(A.1)

(c) As $\zeta \to \infty$, we have

$$
\Phi(\zeta; x) = \left(I + \frac{\Phi_{-1}}{\zeta} + \mathcal{O}(\zeta^{-2}) \right) \zeta^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} e^{-\left(\frac{2}{3}\zeta^{\frac{3}{2}} + x\zeta^{\frac{1}{2}}\right)\sigma_3}, \tag{A.2}
$$

where Φ_{-1} is independent of ζ .

(d) As $\zeta \to 0$, we have

$$
\Phi(\zeta;x) = \Phi^{(0)}(\zeta;x) \begin{pmatrix} 1 & \frac{\log \zeta}{2\pi i} \\ 0 & 1 \end{pmatrix} \begin{pmatrix} I, & \zeta \in I, \\ \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix}, & \zeta \in \Pi, \\ \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in \Pi, \end{pmatrix}
$$
(A.3)

where regions I–III are shown in Figure [13](#page-44-5) and $\Phi^{(0)}$ is analytic near the origin satisfying

$$
\Phi^{(0)}(\zeta; x) = \Phi_0(x)(I + \Phi_1(x)\zeta + \mathcal{O}(\zeta^2)), \qquad \zeta \to 0.
$$
 (A.4)

The above RH problem is actually a special case of the general P_{34} parametrix which depends on two parameters. By [\[44,](#page-57-15) [45,](#page-57-16) [66\]](#page-58-9), Φ exists uniquely. Moreover, with Φ_{-1} given in [\(A.2\)](#page-44-2),

$$
u(x) := -\frac{x}{2} - i(\Phi_{-1})'_{12}(x)
$$

satisfies the P_{34} equation

$$
u''(x) = 4u(x)^{2} + 2su(x) + \frac{u'(x)^{2}}{2u(x)}
$$

and is pole-free on the real axis.

It is worthwhile noting that Φ is also closely related to the Airy determinant. Indeed, by [\[17,](#page-55-4) Equation (2.17)], it follows that (up to a shift)

$$
\frac{d}{dx}\log\det(I - \mathbb{K}_x^{\mathcal{A}i}) = \frac{1}{2\pi i} \lim_{\zeta \to 0} \left(\Phi(\zeta; x)^{-1} \frac{\partial}{\partial \zeta} \Phi(\zeta; x) \right)_{21} = \frac{1}{2\pi i} (\Phi_1(x))_{21}, \tag{A.5}
$$

where the second equality follows from $(A.4)$. On the other hand, it is well-known that

$$
\log \det(I - \mathbb{K}_x^{\mathcal{A}\mathbf{i}}) = -\int_x^{+\infty} H_{\mathcal{P}_{\mathcal{H}}}(\xi) d\xi,
$$
\n(A.6)

where $H_{\text{P}_{\text{II}}}(x)$ is the Hamiltonian (also known as the Jimbo-Miwa-Okamoto σ form) associated with the Hastings-McLeod solution q of Painlevé II equation [\(1.13\)](#page-2-3); cf. [\[40,](#page-56-15) [62\]](#page-58-2). A combination of the above two formulas gives us

$$
\log \det(I - \mathbb{K}_x^{\mathcal{A}i}) = -\int_x^{+\infty} \frac{1}{2\pi i} (\Phi_1(\xi))_{21} d\xi = -\int_x^{+\infty} H_{\mathcal{P}_{II}}(\xi) d\xi.
$$
 (A.7)

We conclude this section by introducing a variant of the P_{34} parametrix, which will be used in Section [5.2.](#page-33-0) It is defined by

$$
\tilde{\Phi}(\zeta;x) = \begin{pmatrix} 1 & 0 \\ ix^2/4 & 1 \end{pmatrix} \Phi(\zeta - x;x) \begin{cases} I, & \zeta \in I, \\ \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}, & \zeta \in \Pi', \\ \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix}, & \zeta \in \Pi I', \end{cases}
$$
(A.8)

where regions I, II' and III' are illustrated in Figure [14](#page-46-5) and we choose $x > 0$. It is then readily seen that Φ satisfies the following RH problem.

RH problem for $\tilde{\Phi}$

- (a) $\tilde{\Phi}(\zeta; x)$ is analytic for $\zeta \in \mathbb{C} \setminus \tilde{\Sigma}$, where $\tilde{\Sigma} := \cup_{j=1}^4 \tilde{\Gamma}_j$ is shown in Figure [14.](#page-46-5)
- (b) On $\tilde{\Sigma}$, the limiting values $\tilde{\Phi}_{\pm}(\zeta; x)$ exist and satisfy the jump condition

$$
\tilde{\Phi}_{+}(\zeta;x) = \tilde{\Phi}_{-}(\zeta;x) \begin{cases}\n\begin{pmatrix}\n1 & 1 \\
0 & 1\n\end{pmatrix}, & \zeta \in \tilde{\Gamma}_{1}, \\
\begin{pmatrix}\n1 & 0 \\
1 & 1\n\end{pmatrix}, & \zeta \in \tilde{\Gamma}_{2} \cup \tilde{\Gamma}_{4}, \\
\begin{pmatrix}\n0 & 1 \\
-1 & 0\n\end{pmatrix}, & \zeta \in \tilde{\Gamma}_{3}.\n\end{cases}
$$
\n(A.9)

(c) As $\zeta \to \infty$, we have

$$
\tilde{\Phi}(\zeta;x) = \left(I + \mathcal{O}(\zeta^{-1})\right)\zeta^{-\frac{1}{4}\sigma_3}\frac{I + i\sigma_1}{\sqrt{2}}e^{-\frac{2}{3}\zeta^{\frac{3}{2}}\sigma_3},\tag{A.10}
$$

uniformly for any positive bounded x .

(d) As $\zeta \to x$, we have

$$
\tilde{\Phi}(\zeta;x) = \tilde{\Phi}^{(0)}(\zeta;x) \begin{pmatrix} 1 & \frac{\log(\zeta-x)}{2\pi i} \\ 0 & 1 \end{pmatrix},\tag{A.11}
$$

and

$$
\tilde{\Phi}^{(0)}(\zeta; x) = \tilde{\Phi}_0(x)(I + \Phi_1(x)(\zeta - x) + \mathcal{O}((\zeta - x)^2)).
$$
\n(A.12)

Here,

$$
\tilde{\Phi}_0(x) = \begin{pmatrix} 1 & 0 \\ ix^2/4 & 1 \end{pmatrix} \Phi_0(x),\tag{A.13}
$$

and Φ_i , $i = 0, 1$, are given in [\(A.4\)](#page-44-4).

B Uniform asymptotics of the P_{34} parametrix

The main purpose of this section is to extend the asymptotics in $(A.2)$ and $(A.10)$ for bounded x to the case where both ζ and x are large. More precisely, as $\zeta \to \infty$, we will establish asymptotics of $\Phi(\zeta; x)$ and $\bar{\Phi}(\zeta; x)$ for large negative and positive x, respectively. They are crucial in the Riemann-Hilbert analysis in Section [5.1](#page-27-1) and [5.2.](#page-33-0) The Riemann-Hilbert analysis for the P_{34} parametrix has already been documented in [\[4,](#page-54-5) [45,](#page-57-16) [66\]](#page-58-9), but the specific results we enumerated are not explicitly presented in the literature. To facilitate the reader's understanding, we state the results in the form of lemmas and provide sketch of proofs.

Lemma B.1. Let Φ be the P₃₄ parametrix introduced in Appendix [A.](#page-44-0) There exists a fixed constant $L > 0$ such that, as $x \to -\infty$,

$$
\Phi(\zeta; x) = \zeta^{-\frac{1}{4}\sigma_3} \left(I + \begin{pmatrix} \mathcal{O}(x^{-2}\zeta^{-1}) & \mathcal{O}(x^{-1}\zeta^{-1/2}) \\ \mathcal{O}(x^{-3}\zeta^{-3/2}) & \mathcal{O}(x^{-2}\zeta^{-1}) \end{pmatrix} \right) \frac{I + i\sigma_1}{\sqrt{2}} e^{-\left(\frac{2}{3}\zeta^{\frac{3}{2}} + x\zeta^{\frac{1}{2}}\right)\sigma_3}, \tag{B.1}
$$

uniformly for all $|\zeta| \ge L|x|$.

Proof. Make the scaling $\zeta = |x|\eta$. Let $U(0;\rho)$ be a fixed small disk centered at $\eta = 0$ with radius $\rho > 0$. We define

$$
R(\eta) := \begin{cases} \Phi(|x|\eta; -|x|)e^{|x|^{\frac{3}{2}} \left(\frac{2}{3}\eta^{\frac{3}{2}} - \eta^{\frac{1}{2}}\right)\sigma_3} P^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus U(0; \rho), \\ \Phi(|x|\eta; -|x|)e^{|x|^{\frac{3}{2}} \left(\frac{2}{3}\eta^{\frac{3}{2}} - \eta^{\frac{1}{2}}\right)\sigma_3} P^{(0)}(\eta)^{-1}, & \eta \in U(0; \rho), \end{cases}
$$
(B.2)

where

$$
P^{(\infty)}(\eta) = (|x|\eta)^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}}
$$
(B.3)

and

$$
P^{(0)}(\eta) = (|x|\eta)^{-\frac{1}{4}\sigma_3}(|x|^3 f(\eta))^{\frac{1}{4}\sigma_3} e^{\frac{\pi i}{4}\sigma_3} \Phi^{(\text{Bes})}(|x|^3 f(\eta)) e^{|x|^{\frac{3}{2}} (\frac{2}{3}\eta^{\frac{3}{2}} - \eta^{\frac{1}{2}})} \sigma_3, \tag{B.4}
$$

In [\(B.4\)](#page-47-0),

$$
f(\eta) := (\eta^{\frac{1}{2}} - \frac{2}{3}\eta^{\frac{3}{2}})^2 = \eta(1 - \frac{2}{3}\eta)^2
$$
 (B.5)

and $\Phi^{(Bes)}$ is the Bessel parametrix characterized by the jump condition [\(4.33\)](#page-23-5) and asymptotic behaviors (4.34) – (4.35) .

Since

$$
P_{+}^{(\infty)}(\eta) = P_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, 0), \tag{B.6}
$$

it is readily seen from $(B.2)$ and RH problem for Φ that R satisfies the following RH problem.

RH problem for R

- (a) R is analytic in $\mathbb{C} \setminus \mathbb{Z}^R$, where Σ_R is illustrated in Figure [15.](#page-48-1)
- (b) On Σ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the following jump condition

$$
R_+(\eta) = R_-(\eta)v_R(\eta),
$$

where

$$
v_R(\eta) = \begin{cases} I + \mathcal{O}(e^{-Cx^{\frac{3}{2}}}), & \eta \in \Sigma^R \setminus (\partial U(0; \rho)), \\ I + \mathcal{O}\left(\frac{1}{|x|}\right), & \eta \in \partial U(0; \rho), \end{cases}
$$
 (B.7)

for some positive C and large $|x|$.

(c) As $\eta \to \infty$, we have $R(\eta) = I + \mathcal{O}(\eta^{-1})$.

From the large z expansion of $\Phi^{(Bes)}$ in [\(4.34\)](#page-23-6), we actually have

$$
v_R(\eta) \sim I + (|x|\eta)^{-\frac{1}{4}\sigma_3} \left(\sum_{j=1}^{\infty} \frac{J_j}{(|x|^3 f(\eta))^{\frac{j}{2}}}\right) (|x|\eta)^{\frac{1}{4}\sigma_3}, \qquad \eta \in \partial U(0;\rho), \tag{B.8}
$$

as $|x| \to +\infty$, where J_{2j} and J_{2j+1} are diagonal and anti-diagonal constant matrices, respectively.

By a standard argument of the small norm RH problem, it then follows from [\(B.7\)](#page-47-2) and [\(B.8\)](#page-47-3) that

$$
R(\eta) \sim |x|^{-\frac{1}{4}\sigma_3} \left(I + \sum_{j=1}^{\infty} \frac{R_j(\eta)}{|x|^{\frac{3j}{2}}} \right) |x|^{\frac{1}{4}\sigma_3} \tag{B.9}
$$

as $|x| \to +\infty$, where $R_j(\eta)$ is analytic in $\mathbb{C} \setminus \partial U(0;\rho)$. In particular, the structures of J_j in [\(B.8\)](#page-47-3) imply that for $\eta \in \mathbb{C} \setminus \overline{U(0;\rho)}$, R_i , $i = 1, 2, 3$, takes the following form:

$$
R_1(\eta) = \frac{\begin{pmatrix} 0 & \star \\ 0 & 0 \end{pmatrix}}{\eta}, \qquad R_2(\eta) = \frac{\begin{pmatrix} \star & 0 \\ 0 & \star \end{pmatrix}}{\eta}
$$
(B.10)

and

$$
R_3(\eta) = \frac{\begin{pmatrix} 0 & \star \\ \star & 0 \end{pmatrix}}{\eta} + \frac{\begin{pmatrix} 0 & \star \\ 0 & 0 \end{pmatrix}}{\eta^2},
$$
 (B.11)

where \star stands for a constant independent of η and x.

By inverting the transformation in [\(B.2\)](#page-47-1) and noting that $\zeta = |x|\eta$, we obtain [\(B.1\)](#page-46-1) from the combination of [\(B.9\)](#page-47-4), [\(B.10\)](#page-48-2), [\(B.11\)](#page-48-3) and [\(B.3\)](#page-47-5). \Box

Lemma B.2. Let $\tilde{\Phi}$ be a variant of the P₃₄ parametrix defined in [\(A.8\)](#page-45-1). There exists a fixed constant $L > 1$ such that, as $x \to +\infty$,

$$
\tilde{\Phi}(\zeta;x) = \left(I + \mathcal{O}\left(\frac{1}{\zeta}\right)\right)\zeta^{-\frac{1}{4}\sigma_3}\frac{I + i\sigma_1}{\sqrt{2}}e^{-\frac{2}{3}\zeta^{\frac{3}{2}}\sigma_3},\tag{B.12}
$$

uniformly for all $|\zeta| \ge L|x|$.

Proof. Let $U(0;\rho)$ and $U(1;\rho)$ be two fixed disks centered at $\eta = 0$ and $\eta = 1$ with radius $\rho \in (0, \frac{1}{2})$ $(\frac{1}{2})$, respectively. Similar to [\(B.2\)](#page-47-1), we define

$$
R(\eta) = \begin{cases} \tilde{\Phi}(x\eta; x) e^{\frac{2}{3}x^{\frac{3}{2}}\eta^{\frac{3}{2}}\sigma_3} S^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus \left(\overline{U(0;\rho)} \cup \overline{U(1;\rho)} \right), \\ \tilde{\Phi}(x\eta; x) e^{\frac{2}{3}x^{\frac{3}{2}}\eta^{\frac{3}{2}}\sigma_3} S^{(0)}(\eta)^{-1}, & \eta \in U(0;\rho), \\ \tilde{\Phi}(x\eta; x) e^{\frac{2}{3}x^{\frac{3}{2}}\eta^{\frac{3}{2}}\sigma_3} S^{(1)}(\eta)^{-1}, & \eta \in U(1;\rho), \end{cases}
$$
(B.13)

where

$$
S^{(\infty)}(\eta) = (x\eta)^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}},
$$
\n(B.14)

$$
S^{(0)}(\eta) = \Phi^{(\text{Ai})}(x\eta)e^{\frac{2}{3}x^{\frac{3}{2}}\eta^{\frac{3}{2}}\sigma_3},
$$
\n(B.15)

$$
S^{(1)}(\eta) = (x\eta)^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} \begin{pmatrix} 1 & \mathcal{C}_2(\eta; x) \\ 0 & 1 \end{pmatrix}.
$$
 (B.16)

Here, $\Phi^{(Ai)}$ is the Airy parametrix characterized by the jump condition [\(6.14\)](#page-41-2) and the asymptotic behavior [\(6.15\)](#page-41-1), and

$$
C_2(\eta; x) = \frac{1}{2\pi i} \int_{\frac{1}{2}}^1 \frac{e^{-\frac{4}{3}(x\xi)^{\frac{3}{2}}}}{\xi - \eta} d\xi, \qquad \eta \in \mathbb{C} \setminus \left[\frac{1}{2}, 1\right].
$$
 (B.17)

The functions $S^{(\infty)}$ and $S^{(i)}$, $i = 0, 1$, serve as global and local parametrices for $\tilde{\Phi}(x\eta; x)e^{\frac{2}{3}x^{\frac{3}{2}}\eta^{\frac{3}{2}}\sigma_3}$, respectively.

It is then straightforward to check from RH problem for $\tilde{\Phi}$ that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is analytic in $\mathbb{C} \setminus \mathbb{Z}^R$, where \mathbb{Z}^R is shown in Figure [16.](#page-49-0)
- (b) On Σ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

$$
R_{+}(\eta) = R_{-}(\eta)v_{R}(\eta),
$$

where

$$
v_R(\eta) = \begin{cases} I + \mathcal{O}(e^{-Cx^{\frac{3}{2}}}), & \eta \in \Sigma^R \setminus (\partial U(0;\rho)), \\ I + \mathcal{O}\left(\frac{1}{|x|}\right), & \eta \in \partial U(0;\rho), \end{cases}
$$
(B.18)

for some positive C and large $|x|$.

(c) As $\eta \to \infty$, we have $R(\eta) = I + \mathcal{O}(\eta^{-1})$

The small norm RH problem implies that there exists a positive constant $L > 1$ such that $R(\eta) = I + \mathcal{O}(1/(\eta))$ as $x \to \infty$ uniformly for all $|\eta| > L$. By inverting the transformations [\(B.13\)](#page-48-5) and noting that $\zeta = x\eta$, we obtain [\(B.12\)](#page-48-0). \Box

Remark B.3. A combination of [\(B.12\)](#page-48-0) and [\(A.8\)](#page-45-1) yields

$$
\Phi(\zeta; x) = \begin{pmatrix} 1 & 0 \\ -ix^2/4 & 1 \end{pmatrix} \left(I + \mathcal{O}\left(\frac{1}{\zeta}\right) \right) (\zeta + x)^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} e^{-\frac{2}{3}(\zeta + x)^{\frac{3}{2}}\sigma_3}.
$$
 (B.19)

as $x \to +\infty$ uniformly for all $|\zeta| \geq L|x|$. It is much different from the asymptotic behavior of $\Phi(\zeta; x)$ as $x \to -\infty$ given in [\(B.1\)](#page-46-1).

From the proofs of Lemmas [B.1](#page-46-6) and [B.2,](#page-48-4) we also have the following asymptotics for Φ_0 and $\tilde{\Phi}_0$ defined in [\(A.4\)](#page-44-4) and [\(A.12\)](#page-46-3) respectively.

Lemma B.4. As $x \to +\infty$, we have

$$
\Phi_0(-x) = \left(I + \mathcal{O}\left(\frac{1}{x}\right)\right) (x\pi)^{\frac{1}{2}\sigma_3} \begin{pmatrix} 1 & \varphi_0(x) \\ 0 & 1 \end{pmatrix},\tag{B.20}
$$

and

$$
\tilde{\Phi}_0(x) = \left(I + \mathcal{O}\left(\frac{1}{x}\right)\right) x^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} e^{-\frac{2}{3}x^{\frac{3}{2}}\sigma_3} \begin{pmatrix} 1 & \tilde{\varphi}_0(x) \\ 0 & 1 \end{pmatrix},\tag{B.21}
$$

where $\varphi_0(x)$ and $\tilde{\varphi}_0(x)$ are two functions of x whose explicit expressions are not needed. *Proof.* To show [\(B.20\)](#page-50-0), we see from [\(B.4\)](#page-47-0) and [\(B.2\)](#page-47-1) that for $\eta \in U(0, \rho)$,

$$
\Phi(x\eta; -x) = R(\eta)P^{(0)}(\eta)e^{-x^{\frac{3}{2}}(\frac{2}{3}\eta^{\frac{3}{2}}-\eta^{\frac{1}{2}})\sigma_3}
$$

= $R(\eta)(x\eta)^{-\frac{1}{4}\sigma_3}(x^3f(\eta))^{\frac{1}{4}\sigma_3}e^{\frac{\pi i}{4}\sigma_3}\Phi^{(\text{Bes})}(x^3f(\eta)).$ (B.22)

In view of the asymptotic behavior of $\Phi^{(Bes)}$ in [\(4.35\)](#page-23-4) and [\(B.5\)](#page-47-6), one has

$$
\Phi^{(\text{Bes})}(x^3 f(\eta)) \sim \left(\frac{\sqrt{\pi}}{e^{\frac{\pi i}{4}}}\right)^{\sigma_3} \left[\begin{pmatrix} 1 & \frac{\gamma_E - \log 2}{\pi i} \\ 0 & 1 \end{pmatrix} + \mathcal{O}\left(x^3 f(\eta)\right) \right] \begin{pmatrix} 1 & \frac{\log(x^3 f(\eta))}{2\pi i} \\ 0 & 1 \end{pmatrix}, \quad \eta \to 0. \quad (B.23)
$$

This, together with the asymptotic behavior of $\Phi(\zeta; x)$ as $\zeta \to 0$ in [\(A.3\)](#page-44-3) and [\(B.9\)](#page-47-4), implies that as $x \to +\infty$,

$$
\Phi_0(-x) = R(0)(x\pi)^{\frac{1}{2}\sigma_3} \begin{pmatrix} 1 & \frac{\gamma_E + \log(x/2)}{\pi i} \\ 0 & 1 \end{pmatrix} = \left(I + \mathcal{O}\left(\frac{1}{x}\right) \right) (x\pi)^{\frac{1}{2}\sigma_3} \begin{pmatrix} 1 & \frac{\gamma_E + \log(x/2)}{\pi i} \\ 0 & 1 \end{pmatrix}, \quad (B.24)
$$

which is [\(B.20\)](#page-50-0).

To show [\(B.21\)](#page-50-1), we see from [\(B.16\)](#page-48-6) and [\(B.13\)](#page-48-5) that for $\eta \in U(1;\rho)$,

$$
\tilde{\Phi}(x\eta;x) = R(\eta)(x\eta)^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} \begin{pmatrix} 1 & \mathcal{C}_2(\eta;x) \\ 0 & 1 \end{pmatrix} e^{-\frac{2}{3}(x\eta)^{\frac{3}{2}}\sigma_3},
$$
\n(B.25)

where $C_2(\eta; x)$ is defined in [\(B.17\)](#page-49-1). Comparing the above formula with [\(A.11\)](#page-46-7) and taking the limit $\eta \to 1$, we have

$$
\tilde{\Phi}_0(x) = R(1)x^{-\frac{1}{4}\sigma_3} \frac{I + i\sigma_1}{\sqrt{2}} e^{-\frac{2}{3}x^{\frac{3}{2}}\sigma_3} \begin{pmatrix} 1 & \tilde{\varphi}_0(x) \\ 0 & 1 \end{pmatrix}.
$$
 (B.26)

In the above formula, we need the definition of $C_2(\eta; x)$ in [\(B.17\)](#page-49-1) and its property $C_2(\eta; x)$ = $\frac{e^{-\frac{4}{3}x^{\frac{3}{2}}}}{2\pi i} \log(\eta - 1) + \mathcal{O}(1)$ as $\eta \to 1$. This implies the limit

$$
\tilde{\varphi}_0(x) = \lim_{\eta \to 1} \left(e^{\frac{4}{3}(x\eta)^{\frac{3}{2}}} C_2(\eta; x) - \frac{\log(x(\eta - 1))}{2\pi i} \right) \tag{B.27}
$$

exists. Inserting the fact $R(1) = I + \mathcal{O}(x^{-1})$ as $x \to +\infty$ into [\(B.26\)](#page-50-2), we arrive at [\(B.21\)](#page-50-1) immediately. \Box

C Asymptotics of the Hamiltonian h

Let $h(x) = h(x, t_1, \ldots, t_{2k-1})$ be the Hamiltonian associated with the special solution q of the Painlevé I hierarchy P_I^{2k} . Following the asymptotics analysis carried out in [\[14\]](#page-55-10), it is the aim of this section to prove [\(1.32\)](#page-5-4), that is, if $t_1 = t_2 = \cdots = t_{2k-1} = 0$,

$$
h(x) = \frac{(2k+1)}{2(2k+2)} \alpha_k^{-\frac{1}{2k+1}} x^{\frac{2k+2}{2k+1}} + \frac{2k}{24(2k+1)x} + \mathcal{O}\left(x^{-\frac{6k+4}{2k+1}}\right), \qquad x \to \pm \infty,
$$
 (C.1)

where α_k is defined in [\(1.21\)](#page-4-3).

Suppose $t_1 = \cdots = t_{2k-1} = 0$, we begin the analysis with the following RH problem for S; see [\[14,](#page-55-10) Section 2.3.3], where m is replaced by $2k$ in the discussion below.

RH problem for S

- (a) $S(\eta)$ is analytic in $\mathbb{C} \setminus \Gamma_{z_0}$, where $\Gamma_{z_0} := \Gamma_1^S \cup \Gamma_2^S \cup \Gamma_3^S \cup \Gamma_4^S$ is shown in Figure [17.](#page-51-2)
- (b) On Γ_{z_0} , the limiting values $S_{\pm}(\eta)$ exist and satisfy the jump condition

$$
S_{+}(\eta) = S_{-}(\eta) \begin{cases} \begin{pmatrix} 1 & e^{-2|x|^{\frac{4k+3}{4k+2}}g(\eta) \\ 0 & 1 \end{pmatrix}, & \eta \in \Gamma_{1}^{S}, \\ \begin{pmatrix} 1 & 0 \\ e^{2|x|^{\frac{4k+3}{4k+2}}g(\eta) & 1 \end{pmatrix}, & \eta \in \Gamma_{2}^{S} \cup \Gamma_{4}^{S}, \\ \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, & \eta \in \Gamma_{3}^{S}. \end{cases}
$$
(C.2)

(c) As $\eta \to \infty$, we have

$$
S(\eta) = \left[I + \frac{B_1(x)}{\eta} + \mathcal{O}(\eta^{-2}) \right] |x|^{-\frac{1}{8k+4}\sigma_3} \eta^{-\frac{1}{4}\sigma_3} N,\tag{C.3}
$$

where N is given in [\(3.4\)](#page-15-2) and B_1 is independent of η .

In $(C.2)$, the function g is defined by

$$
g(\eta) = (\eta - z_0)^{\frac{3}{2}} p\left(\frac{\eta}{z_0}\right),\tag{C.4}
$$

where

$$
p(z) = \frac{4}{4k+3} z_0^{2k} \sum_{j=0}^{2k} \frac{\Gamma(j+\frac{3}{2})}{\Gamma(j+1)\Gamma(\frac{3}{2})} z^{2k-j},
$$
 (C.5)

and

$$
z_0 = -\text{sgn}(x) \left[\frac{\Gamma(2k+2)\Gamma(\frac{3}{2})}{2\Gamma(2k+\frac{3}{2})} \right]^{\frac{1}{2k+1}} = -\text{sgn}(x)\alpha_k^{-\frac{1}{2k+1}}.\tag{C.6}
$$

On account of Equations (2.4), (2.35), (2.56) and (2.60) in [\[14\]](#page-55-10), it comes out that the Hamiltonian h is related to the above RH problem through the formula

$$
h(x) = \frac{2k+1}{4(k+1)} \alpha_k^{-\frac{1}{2k+1}} |x|^{\frac{2k+2}{2k+1}} + |x|^{\frac{1}{2k+1}} (B_1(x))_{12}.
$$
 (C.7)

To establish the large $|x|$ behavior of B_1 , we need to construct global and local parametrices for the RH problem for S. The global parametrix reads

$$
P^{(\infty)}(\eta) = (|x|^{\frac{1}{2k+1}}(\eta - z_0))^{-\frac{1}{4}\sigma_3} N, \quad \eta \in \mathbb{C} \setminus (-\infty, z_0],
$$
 (C.8)

which satisfies the jump condition

$$
P_{+}^{(\infty)}(\eta) = P_{-}^{(\infty)}(\eta) \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad \eta \in (-\infty, z_0). \tag{C.9}
$$

For the local parametrix, we define

$$
f(\eta) = \left(\frac{3}{2}g(\eta)\right)^{\frac{2}{3}},\tag{C.10}
$$

where g is given in [\(C.4\)](#page-51-1). Note that, as $\eta \to z_0$,

$$
f(\eta) = \left[\frac{3}{2}p(1)(\eta - z_0)^{\frac{3}{2}} \left(1 + \frac{p'(1)}{z_0 p(1)}(\eta - z_0) + \mathcal{O}((\eta - z_0)^2)\right)\right]^{\frac{2}{3}}
$$

=
$$
\left(\frac{3}{2}\right)^{\frac{2}{3}} p(1)^{\frac{2}{3}} (\eta - z_0) + \mathcal{O}((\eta - z_0)^2),
$$
 (C.11)

it is then readily seen that f is conformal in a small fixed disk $U(z_0; \rho)$ around $\eta = z_0$. We build the local parametrix by

$$
P^{(z_0)}(\eta) = E(\eta)\Phi^{(\text{Ai})}(|x|^{\frac{4k+3}{3(2k+1)}}f(\eta))e^{|x|^{\frac{4k+3}{2(2k+1)}}g(\eta)\sigma_3}, \qquad \eta \in U(z_0; \rho), \tag{C.12}
$$

where

$$
E(\eta) := (|x|^{\frac{1}{2k+1}}(\eta - z_0))^{-\frac{1}{4}\sigma_3} e^{-\frac{\pi i}{4}\sigma_3} (|x|^{\frac{4k+3}{3(2k+1)}} f(\eta))^{\frac{1}{4}\sigma_3}, \tag{C.13}
$$

is an analytic prefactor in $U(z_0; \rho)$ and $\Phi^{(Ai)}$ is the Airy parametrix characterized by the jump condition [\(6.14\)](#page-41-2) and the asymptotic behavior [\(6.15\)](#page-41-1).

As usual, by setting

$$
R(\eta) = \begin{cases} S(\eta)P^{(z_0)}(\eta)^{-1}, & \eta \in U(z_0; \rho), \\ S(\eta)P^{(\infty)}(\eta)^{-1}, & \eta \in \mathbb{C} \setminus \overline{U(z_0; \rho)}, \end{cases}
$$
(C.14)

it is straightforward to check that R satisfies the following RH problem.

RH problem for R

- (a) $R(\eta)$ is analytic in $\mathbb{C} \setminus \Gamma^R$, where $\Gamma^R := \Gamma_1^S \cup \Gamma_2^S \cup \Gamma_4^S \cup \partial U(z_0; \rho) \setminus U(z_0; \rho)$.
- (b) On Γ^R , the limiting values $R_{\pm}(\eta)$ exist and satisfy the jump condition

$$
R_+(\eta) = R_-(\eta)v_R(\eta),
$$

where

$$
v_R(\eta) = \begin{cases} P^{(\infty)}(\eta) \begin{pmatrix} 1 & e^{-2|x|^{\frac{4k+3}{4k+2}}g(\eta)} \\ 0 & 1 \end{pmatrix} P^{(\infty)}(\eta)^{-1}, & \eta \in \Gamma_1^S \setminus \partial U(z_0; \rho), \\ P^{(\infty)}(\eta) \begin{pmatrix} 1 & 0 \\ e^{2|x|^{\frac{4k+3}{2}}g(\eta)} & 1 \end{pmatrix} P^{(\infty)}(\eta)^{-1}, & \eta \in \Gamma_2^S \cup \Gamma_4^S \setminus \partial U(z_0; \rho), \\ P^{(z_0)}(\eta) P^{(\infty)}(\eta)^{-1}, & \eta \in \partial U(z_0; \rho). \end{cases} (C.15)
$$

(c) As $\eta \to \infty$, we have

$$
R(\eta) = I + \frac{R_1(x)}{\eta} + \mathcal{O}(\eta^{-2}),
$$
\n(C.16)

where

$$
R_1(x) = B_1(x) - \frac{z_0}{4}\sigma_3.
$$
 (C.17)

As $x \to \pm \infty$, $v_R(\eta)$ tends to the identity matrix exponentially fast for $\eta \in \Gamma^R \setminus \partial U(z_0; \rho)$. For $\eta \in \partial U(z_0; \rho)$, we have from [\(C.8\)](#page-52-1), [\(C.12\)](#page-52-2) and [\(6.15\)](#page-41-1) that

$$
v_R(\eta) = |x|^{-\frac{1}{4(2k+1)}\sigma_3} \left(I + \frac{\Delta_1(\eta)}{|x|^{\frac{4k+3}{2(2k+1)}}} + \frac{\Delta_2(\eta)}{|x|^{\frac{4k+3}{2k+1}}} + \mathcal{O}(|x|^{-\frac{3(4k+3)}{2(2k+1)}}) \right) |x|^{\frac{1}{4(2k+1)}\sigma_3}, \quad (C.18)
$$

as $x \to \pm \infty$, where Δ_1 is an off-diagonal matrix-valued function and Δ_2 is a diagonal matrixvalued function with

$$
(\Delta_1)_{12} = \frac{5}{48} \frac{1}{f(\eta)^{\frac{3}{2}} (\eta - z_0)^{\frac{1}{2}}}.
$$
\n(C.19)

By the standard argument for the small norm RH problem, it follows from [\(C.18\)](#page-53-0) that

$$
(R_1)_{12} = |x|^{-\frac{2(k+1)}{2k+1}} \text{Res}((\Delta_1)_{12}, z_0) + \mathcal{O}(|x|^{-\frac{6k+5}{2k+1}}). \tag{C.20}
$$

In view of [\(C.11\)](#page-52-3), we have

$$
Res ((\Delta_1)_{12}, z_0) = -\frac{5}{72z_0} \frac{p'(1)}{p(1)^2},
$$
\n(C.21)

where p is defined in [\(C.5\)](#page-52-4). To calculate $p(1)$ and $p'(1)$, we rewrite $q(\eta)$ in the form

$$
g(\eta) = (\eta - z_0)^{\frac{3}{2}} q(\eta)
$$
 (C.22)

with

$$
q(\eta) = \sum_{j=0}^{2k} q_j (\eta - z_0)^j.
$$
 (C.23)

It then follows that

$$
p(1) = q_0, \qquad p'(1) = z_0 q_1. \tag{C.24}
$$

Note that (see [\(5.39\)](#page-33-2) and [\(5.38\)](#page-33-4))

$$
\theta(\eta; sgn(x)) - g(\eta) = \mathcal{O}(\eta^{-\frac{1}{2}}), \qquad \eta \to \infty,
$$
\n(C.25)

where $\theta(\zeta; x)$ is given in [\(4.1\)](#page-19-9). By expanding the left hand side of the above formula in terms of powers of $\eta - z_0$, we obtain

$$
q_0 = \frac{2\Gamma\left(2k + \frac{3}{2}\right)}{\Gamma(2k+1)\Gamma\left(\frac{5}{2}\right)} z_0^{2k}, \qquad q_1 = \frac{2\Gamma\left(2k + \frac{3}{2}\right)}{\Gamma(2k)\Gamma\left(\frac{7}{2}\right)} z_0^{2k-1}.
$$
 (C.26)

This, together with [\(C.24\)](#page-53-1) and [\(C.21\)](#page-53-2), implies that

$$
Res((\Delta_1)_{12}, z_0) = -\frac{5}{72} \frac{2k \cdot \Gamma(2k+1)\Gamma(\frac{5}{2})}{5\Gamma(2k+\frac{3}{2})} z_0^{-2k-1} = \frac{sgn(x)}{24} \frac{2k}{2k+1}.
$$
 (C.27)

A combination of $(C.6)$, $(C.7)$, $(C.17)$, $(C.20)$ and $(C.27)$ finally leads to $(C.1)$.
