PERTURBATIONS OF EMBEDDED EIGENVALUES OF ASYMPTOTICALLY PERIODIC MAGNETIC SCHRÖDINGER OPERATORS ON A CYLINDER

Abstract. We investigate the persistence of embedded eigenvalues for a class of magnetic Laplacians on an infinite cylindrical domain. The magnetic potential is assumed to be $C²$ and asymptotically periodic along the unbounded direction, with an algebraic decay rate towards a periodic background potential. Under the condition that the embedded eigenvalue of the unperturbed operator lies away from the thresholds of the continuous spectrum, we show that the set of nearby potentials for which the embedded eigenvalue persists forms a smooth manifold of finite and even codimension. The proof employs tools from Floquet theory, exponential dichotomies, and Lyapunov–Schmidt reduction. Additionally, we give an example of a potential which satisfies the assumptions of our main theorem.

1. INTRODUCTION

Embedded eigenvalues are eigenvalues of an operator which also belong to the continuous spectrum. They appear in a variety of different settings, including many applied problems coming from physics, such as in quantum mechanics in which eigenvalues represent the energies of the bound states which the underlying system may attain [\[RS78\]](#page-17-0). The behaviour of isolated eigenvalues under perturbations is well known, much due to [\[Kat95\]](#page-17-1), in that they persist under small perturbations. Embedded eigenvalues on the other hand typically behave rather differently. As it turns out, they generally cease to exist or turn into resonances even under arbitrarily small perturbations [\[AHS89\]](#page-16-0). In this paper we study the structure of the set of perturbations which do not remove the embedded eigenvalue.

More specifically, we consider the magnetic Laplacian on an infinite cylinder, that is we study the elliptic operator given by

$$
L_{A_0} = -\partial_z^2 - (\partial_{\varphi} + iA_0(z, \varphi))^2,
$$

where $(z, \varphi) \in \mathbb{R} \times S^1$ and $A_0 \colon \mathbb{R} \times S^1 \to \mathbb{R}$ is a magnetic potential, which is asymptotically periodic in z. We call A_0 asymptotically periodic if there exists a potential $A_{\text{per}}: \mathbb{R} \times S^1 \to \mathbb{R}$, which is periodic in z, i.e. $A_{per}(z+p,\varphi) = A_{per}(z,\varphi)$ for all $(z,\varphi) \in \mathbb{R} \times S^1$ and some $p > 0$, and such that $|A_0(z, \varphi) - A_{\text{per}}(z, \varphi)| \to 0$ as $|z| \to \infty$.

Furthermore, we assume that L_{A_0} has a simple eigenvalue $\lambda_0 > 0$ embedded in the continuous spectrum of L_{A_0} .

The goal of this paper is to analyze the persistence of the embedded eigenvalue under perturbations of the magnetic potential, which in this case will mean that we replace the potential A_0 for another potential A close to A_0 in some specified Banach space. To this end, we aim to define a manifold of such perturbations for which the eigenvalue λ_0 persists, in the sense that there exists an eigenvalue, λ , of the perturbed operator in a neighborhood of the original eigenvalue, λ_0 . Lastly we prove that this manifold has a finite and even codimension in the Banach space of perturbations. In order for the codimension to be well-defined, it is required that λ_0 does not cross any thresholds of the continuous spectrum where the spectrum changes multiplicity. Note that, by Weyl's perturbation theorem, $\sigma_{\rm ess}(L_A) = \sigma_{\rm ess}(L_{A_0}) = \sigma_{\rm ess}(L_{A_{\rm per}})$ and it is a well-known fact that the spectrum of periodic elliptic operators can be written as a union of, in this case, at most countably many closed intervals, called spectral bands, see e.g. [\[Plu11\]](#page-17-2). The edges of these spectral bands are called spectral edges and it is only at these points that the spectrum may change multiplicity. These are exactly the points that have to be avoided.

The result of this paper is an extension of a previous result involving asymptotically zero potentials [\[LM17\]](#page-17-3). Therefore similar methods are applied, with the addition of Floquet theory instead of the theory of semigroups, as in the current setting the equation is not asymptotically autonomous, which indeed introduces additional, non-trivial complications. Perturbations of embedded eigenvalues have also previously been studied for the bilaplacian on a cylinder in [\[DMS08\]](#page-16-1), with similar methods, as well as in a more abstract setting in [\[AHM11\]](#page-16-2).

Remark 1.1. In Section [6](#page-13-0) we provide a method which can be used to find an infinite family of examples of an operator with the required properties, as well as one explicit example.

2. The Main Result

For $\beta > 1$, we define the space of admissible perturbations

$$
\mathcal{X}_{\beta} = \{ B \in C^2(\mathbb{R} \times S^1) : ||B||_{\beta} < \infty \},\
$$

where

$$
||B||_{\beta} = \sup_{(z,\varphi)\in\mathbb{R}\times S^1} |D^2 B(z,\varphi)| + \sup_{(z,\varphi)\in\mathbb{R}\times S^1} \Big(|B(z,\varphi)| + \Big| \frac{\partial B}{\partial \varphi}(z,\varphi) \Big| \Big) (1+|z|)^{\beta}.
$$

We make the following assumptions:

- (A.1) $A_0 \in C^2(\mathbb{R} \times S^1)$ and there is a p-periodic magnetic potential $A_{\text{per}} \in C^2(\mathbb{R} \times S^1)$ such that $A_0 - A_{\text{per}} \in \mathcal{X}_{\beta}$ for some $\beta > 1$;
- (A.2) there exists $z_0 \in \mathbb{R}$ such that $\int_{S^1} A_0(z_0, \varphi) d\varphi \neq \int_{S^1} A_{\text{per}}(z_0, \varphi) d\varphi;$
- (A.3) $\lambda_0 > 0$ is a simple eigenvalue of L_{A_0} , which is (without loss of generality) embedded in the continuous spectrum of L_{A_0} ;

(A.4) λ_0 is not situated on a threshold of the spectrum of L_{A_0} . In particular, $\lambda_0 \notin \sigma_{\text{per}}(L_{A_{\text{per}}})$. Here, we denote by $\sigma_{per}(L_{A_{per}})$ the spectrum of the operator $L_{A_{per}}$ on $L_{per}^2([0,p] \times S^1)$, where $L^2_{\text{per}}([0,p] \times S^1)$ denotes the space of functions on $\mathbb{R} \times S^1$, which are p-periodic with respect to the z-variable and locally square integrable. Moreover, the second part of $(A.3)$ is not a restriction, as the corresponding result for the case where λ_0 is an isolated eigenvalue holds by the extensive previous work on perturbation theory pertaining to isolated eigenvalues, see e.g. [\[Kat95\]](#page-17-1). Our method can also handle this case, and then the proof is shorter. Hence, we focus on the more difficult case where the result is not well-known. A threshold of the spectrum is a point where the essential spectrum changes multiplicity.

We want to analyze the persistence of the embedded eigenvalue λ_0 under small perturbations of the magnetic potential A_0 . Therefore, we define the set

 $\mathcal{M}_{\delta} = \{A \in C^2(\mathbb{R} \times S^1) : A - A_0 \in \mathcal{X}_{\beta} \text{ and there exists } \lambda \in (\lambda_0 - \delta, \lambda_0 + \delta) \text{ such that } \lambda \in \sigma_p(L_A)\}\$

for $\delta > 0$ sufficiently small. Here, σ_p denotes the point spectrum. Note further that \mathcal{M}_{δ} is nonempty since $A_0 \in \mathcal{M}_{\delta}$. The aim of this paper is to analyze the structure of the set \mathcal{M}_{δ} . We will show that, locally around A_0 , M_δ defines a manifold of perturbations for which the eigenvalue persists and we determine its codimension, leading to the following result.

Theorem 2.1. Suppose that $(A.1)$ – $(A.4)$ hold. Then there exists $\delta > 0$, $m \in \mathbb{N}$ and a neighborhood $\overline{\mathcal{O}}$ of A_0 in $A_0 + \mathcal{X}_\beta$ such that $M_\delta \cap \mathcal{O}$ is a smooth manifold of codimension $2m$.

The methods we use combine those in [\[LM17\]](#page-17-3) with more general methods from spatial dynamics and Floquet theory.

3. The ODE Formulation

We now study the eigenvalue equation

(3.1)
$$
L_A u = \lambda u, \quad A \in A_0 + \mathcal{X}_\beta
$$

in more detail. In order to do this, we rewrite the system using spatial dynamics. To simplify notation, we denote by $\partial: H^j(S^1) \to H^{j-1}(S^1)$ the operator of differentiation in the φ -direction. Then we may rewrite the eigenvalue problem [\(3.1\)](#page-1-3) as

(3.2) U ′ = B(z; λ, A)U,

where the prime means differentiation with respect to $z, \mathcal{U} = (u, u')^T$ and

$$
\mathcal{B}(z; \lambda, A) = \begin{pmatrix} 0 & 1 \\ -(\partial + iA)^2 - \lambda & 0 \end{pmatrix}.
$$

Note that the magnetic potential A acts on functions in $C(\mathbb{R}; H^k(S^1))$ via $Au(z) = A(z, \cdot)u(z)$. The matrix operator $\mathcal{B}(z; \lambda, A)$ acts on the space $X = H^1(S^1) \times L^2(S^1)$ with domain $D(\mathcal{B}) =$ $H^2(S^1) \times H^1(S^1)$. The eigenvalue equation and the spatial dynamics formulation are equivalent descriptions.

Lemma 3.1. $u \in H^2_{loc}(\mathbb{R} \times S^1)$ solves the eigenvalue problem [\(3.1\)](#page-1-3) if and only if the spatial dynamics formulation [\(3.2\)](#page-1-4) has a solution $\mathcal{U} \in C(\mathbb{R}; D(\mathcal{B})) \cap C^1(\mathbb{R}; X)$.

A proof of this result can be found in [\[LM17,](#page-17-3) Lem. 1].

3.1. The system at infinity. The next goal is to show that eigenfunctions of L_A decay exponentially as $|z| \to \infty$. In order to obtain this result, we must first analyze the asymptotic behaviour of solutions to [\(3.2\)](#page-1-4) and construct evolution operators corresponding to the spatial dynamics formulation, using exponential dichotomies as a tool.

As by assumption [\(A.1\),](#page-1-1) the magnetic potential A_0 and its perturbations are asymptotically periodic, we may study the system at infinity given by

(3.3)
$$
\mathcal{U}' = \mathcal{B}(z; \lambda, A_{\text{per}}) \mathcal{U}.
$$

We define the operator $\mathcal{T}: L^2(\mathbb{R};X) \to L^2(\mathbb{R};X)$ by

(3.4)
$$
\mathcal{TU} = \frac{d}{dz}\mathcal{U} - \mathcal{B}(z; \lambda, A_{\text{per}})\mathcal{U} = \frac{d}{dz}\mathcal{U} - (\mathcal{A} + \Lambda_{\text{per}}(z; \lambda))\mathcal{U},
$$

where

$$
\mathcal{A} = \begin{pmatrix} 0 & 1 \\ -\partial^2 & 0 \end{pmatrix} \text{ and } \Lambda_{\text{per}}(z; \lambda) = \begin{pmatrix} 0 & 0 \\ A_{\text{per}}(z, \cdot)^2 - i(\partial A_{\text{per}})(z, \cdot) - 2iA_{\text{per}}(z, \cdot)\partial - \lambda & 0 \end{pmatrix}
$$

with domain $D(\mathcal{T}) = H^1(\mathbb{R}; X) \cap L^2(\mathbb{R}; D(\mathcal{B}))$. Note that A is closed, densely defined and, by the Rellich–Kondrachev theorem, has a compact resolvent.

As A_{per} is periodic, we associate to $\mathcal T$ the Floquet operator $\mathcal T_{\text{per}}: L^2_{\text{per}}([0,p],X) \to L^2_{\text{per}}([0,p],X)$, which is defined by

(3.5)
$$
\mathcal{T}_{\text{per}}\mathcal{U} = \frac{d}{dz}\mathcal{U} - (\mathcal{A} + \Lambda_{\text{per}}(z; \lambda))\mathcal{U}, \quad D(\mathcal{T}_{\text{per}}) = H_{\text{per}}^1([0, p]; X) \cap L_{\text{per}}^2([0, p]; D(\mathcal{B})).
$$

The eigenvalues $\alpha \in \sigma_p(\mathcal{T}_{per})$ are called Floquet exponents of T. In particular, $\mathcal{T}_{per}\mathcal{U}_{\alpha} = \alpha \mathcal{U}_{\alpha}$ implies that $\mathcal{U}(z) = e^{-\alpha z} \mathcal{U}_{\alpha}(z)$ is a solution to [\(3.3\)](#page-2-0). We want to prove that the set of Floquet exponents is discrete. To do this, we first need some preliminary results.

Lemma 3.2. The operator $\tilde{\mathcal{T}}_{\text{per}} := \frac{d}{dz} - \mathcal{A}$ acting on $L^2_{\text{per}}([0, p], X)$ has compact resolvent.

Proof. The eigenvalue equation of this operator is

$$
\left(\frac{d}{dz} - \mathcal{A} - \alpha\right)\mathcal{U} = 0.
$$

By periodicity in the z-variable, we can expand $\mathcal U$ in a Fourier series as

$$
\mathcal{U} = \sum_{k \in \mathbb{Z}} \mathcal{U}_k e^{-\frac{2\pi k i}{p} z}.
$$

Then, for $k \in \mathbb{Z}$,

$$
\left(-\frac{2\pi ki}{p} - \mathcal{A} - \alpha\right)\mathcal{U}_k = 0.
$$

Rewriting yields

$$
\mathcal{A}\mathcal{U}_k = -\left(\frac{2\pi ki}{p} + \alpha\right)\mathcal{U}_k.
$$

Thus, $-\left(\frac{2\pi ki}{\pi}\right)$ $\frac{\pi ki}{p} + \alpha$ must be an eigenvalue of A and \mathcal{U}_k an eigenvector, for $k \in \mathbb{Z}$. Hence, the eigenvalues of the operator $\tilde{\mathcal{T}}_{\text{per}}$ are

$$
\alpha_{nk} = -\mu_n - \frac{2\pi ki}{p}, \quad n \in \mathbb{N}, \ k \in \mathbb{Z},
$$

where μ_n are eigenvalues of A. Thus, the operator $\tilde{\mathcal{T}}_{\text{per}}$ has discrete spectrum and hence the resolvent set is non-empty. This means that, for α in the resolvent set, $(\tilde{\mathcal{T}}_{\text{per}} - \alpha)^{-1}$ is a bounded operator from $L^2_{\text{per}}([0,p],X)$ to $D(\tilde{\mathcal{T}}_{\text{per}}) = H^1_{\text{per}}([0,p],X) \cap L^2_{\text{per}}([0,p],D(\mathcal{A})),$ and hence compact from $L^2_{\text{per}}([0, p], X)$ to itself by the Aubin–Lions lemma.

The following lemma follows the ideas of [\[Mie96\]](#page-17-4), with slight changes due to the different setting.

Lemma 3.3. Exactly one of the following holds:

- (i) For all $\alpha \in \mathbb{C}$ there exists a $\mathcal{U} \in D(\mathcal{T}_{\mathrm{per}}) \setminus \{0\}$ with $\mathcal{T}_{\mathrm{per}}\mathcal{U} = \alpha \mathcal{U}$.
- (ii) The spectrum of \mathcal{T}_{per} is discrete and the resolvent is compact.

Proof. Assume that (i) does not hold. Then there exists an $\alpha \in \mathbb{C}$ such that $\mathcal{T}_{per} \mathcal{U} = \alpha \mathcal{U}$ has only the trivial solution. Rewriting, the eigenvalue equation becomes

$$
\mathcal{T}_{\mathrm{per}}\mathcal{U}=\tilde{\mathcal{T}}_{\mathrm{per}}\mathcal{U}-\Lambda_{\mathrm{per}}(\lambda)\mathcal{U}=(\tilde{\mathcal{T}}_{\mathrm{per}}-\tilde{\alpha})\mathcal{U}+\tilde{\alpha}\mathcal{U}-\Lambda_{\mathrm{per}}(\lambda)\mathcal{U}=\alpha\mathcal{U}.
$$

Applying the resolvent $(\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1}$, for some $\tilde{\alpha}$ in the resolvent set of $\tilde{\mathcal{T}}_{\text{per}}$, and rewriting yields

$$
\mathcal{U} - (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1} \Lambda_{\text{per}}(\lambda) \mathcal{U} = (\alpha - \tilde{\alpha}) (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1} \mathcal{U}.
$$

Thus, the equation

$$
M(\alpha;\lambda)U=\mathcal{U},
$$

where $M(\alpha; \lambda) \coloneqq (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1}(\Lambda_{\text{per}}(\lambda) + \alpha - \tilde{\alpha}),$ has only the trivial solution. The operator $M(\alpha; \lambda)$ is clearly compact, as the composition of a compact and a bounded operator. By Fredholm theory, it follows that $1 - M(\alpha; \lambda)$ is invertible. Since

$$
(\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})(1 - M(\alpha; \lambda)) = (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})(1 - (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1}(\Lambda_{\text{per}}(\lambda) + \alpha - \tilde{\alpha})
$$

$$
= \tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha} - \Lambda_{\text{per}}(\lambda) - \alpha + \tilde{\alpha}
$$

$$
= \underbrace{\tilde{\mathcal{T}}_{\text{per}} - \Lambda_{\text{per}}(\lambda)}_{= \tilde{\mathcal{T}}_{\text{per}}} - \alpha
$$

and $({\tilde{T}}_{\text{per}} - \tilde{\alpha})^{-1}$ is compact, it follows that

$$
(\mathcal{T}_{\text{per}} - \alpha)^{-1} = (1 - M(\alpha; \lambda))^{-1} (\tilde{\mathcal{T}}_{\text{per}} - \tilde{\alpha})^{-1}
$$

is the compact resolvent of $\mathcal{T}_{\mathrm{per}}.$ In particular (ii) holds.

Clearly, (i) and (ii) can not be true simultaneously. Additionally, if the spectrum is not discrete, then if (i) does not hold, it follows by the above that (ii) holds and we arrive at a contradiction and so (i) must hold. Then the resolvent is not defined for any $\alpha \in \mathbb{C}$ and so no compact resolvents exist. \Box

Now we can prove that the set of Floquet exponents is discrete.

Lemma 3.4. Assume [\(A.4\).](#page-1-2) Then the spectrum $\sigma(\mathcal{T}_{\text{per}})$ of \mathcal{T}_{per} consists only of Floquet exponents and is discrete. Furthermore, the operator \mathcal{T}_{per} has compact resolvent.

Proof. As can be noted in the proof of Lemma [3.3,](#page-3-0) it is enough to prove that there is an $\alpha \in \mathbb{C}$ such that $\mathcal{T}_{per}U = \alpha U$ only has the trivial solution or, in other words, that the operator $\mathcal{T}_{per} - \alpha I$ is invertible for some $\alpha \in \mathbb{C}$. Consider the equation

$$
(\mathcal{T}_{\text{per}} - \alpha I)\mathcal{U} = 0,
$$

or more explicitly

$$
\frac{d}{dz} \mathcal{U} - \left(\begin{matrix} \alpha & 1 \\ -(\partial + iA_{\text{per}}(z, \cdot))^{2} - \lambda & \alpha \end{matrix} \right) \mathcal{U} = 0.
$$

For this to hold, we must have that

$$
\begin{cases} \partial_z u_1 = \alpha u_1 + u_2 \\ \partial_z u_2 = -(\partial_{\varphi} + iA_{\text{per}}(z,\varphi))^2 u_1 - \lambda u_1 + \alpha u_2. \end{cases}
$$

In particular, from the first equation we can see that it must hold that $u_2 = \partial_z u_1 - \alpha u_1$. Substituting this into the second equation gives us that

(3.6)
$$
\underbrace{-\partial_z^2 u - (\partial_\varphi + A_{\text{per}}(z, \varphi))^2 u - \lambda u}_{=(L_{\text{per}} - \lambda I)u} + 2\alpha u_z - \alpha^2 u = 0.
$$

Note that the operator $L_{A_{per}}$ is acting on the Hilbert space $L_{per}^2([0,p]\times S^1)$ with periodic boundary conditions, and therefore is self-adjoint and has a compact resolvent for every $\lambda \notin \sigma_{per}(L_{A_{per}})$. We can equivalently write [\(3.6\)](#page-4-0) as

$$
(I + (L_{A_{\text{per}}} - \lambda)^{-1} (2\alpha \partial_z - \alpha^2 I))u = 0.
$$

We define the operator-valued function

$$
\mathbb{C} \ni \alpha \mapsto K(\alpha) \in \mathcal{L}\left(L_{\text{per}}^2([0, p] \times S^1)\right),
$$

where

$$
K(\alpha) = -(L_{A_{\text{per}}} - \lambda)^{-1} (2\alpha \partial_z - \alpha^2 I)
$$

is analytic on all of $\mathbb C$. Moreover, keeping in mind that the operator $(2\alpha\partial_z - \alpha^2I)$ is relatively bounded with respect to L_{per} , we clearly have that $K(\alpha)$ is compact for each $\alpha \in \mathbb{C}$. Thus, the existence of $(\mathcal{T}_{per}-\alpha I)^{-1}$ for some $\alpha \in \mathbb{C}$ is equivalent to the existence of $(I-K(\alpha))^{-1}$. According to the Analytic Fredholm theorem [\[RR04,](#page-17-5) Thm. 8.92], we have that either

- (1) $(I K(\alpha))^{-1}$ exists for no $\alpha \in \mathbb{C}$, or
- (2) $(I K(\alpha))^{-1}$ exists for every $\alpha \in \mathbb{C} \setminus S$, where S is a discrete set in C. In this case the function $\alpha \mapsto (I - K(\alpha))^{-1}$ is analytic on $\mathbb{C} \setminus S$, and if $\alpha \in S$, then $K(\alpha)u = u$ has a finite-dimensional family of solutions.

It is clear that we end up in the second case, as $(I - K(\alpha))^{-1}$ exists for $\alpha = 0$. This concludes the proof. \Box

Lemma 3.5. Assume [\(A.4\).](#page-1-2) Then $\alpha = 0$ is not a Floquet exponent of \mathcal{T} .

Proof. To show this, we first prove that $\alpha = 0$ is a Floquet exponent if and only if $\lambda \in \sigma_{\text{per}}(L_{A_{\text{per}}})$. If $\alpha = 0$ is a Floquet exponent, then there exists a non-trivial U_0 such that $\mathcal{T}_{per}U_0 = 0$. This means that, setting $\mathcal{U}_0 = (u_0, v_0)^T$, we have

$$
\begin{aligned}\n\begin{cases}\nu_0' &= v_0 \\
v_0' &= -(\partial + iA(z, \cdot))^2 u_0 - \lambda u_0\n\end{cases} \quad \Longleftrightarrow \quad \begin{cases}\nv_0 &= u'_0 \\
u''_0 &= -(\partial + iA(z, \cdot))^2 u_0 - \lambda u_0\n\end{cases} \\
&\iff\n\begin{cases}\nv_0 &= u'_0 \\
L_{A_{\text{per}}} u_0 &= \lambda u_0.\n\end{cases}\n\end{aligned}
$$

The other direction is trivial. Now, since we assumed in [\(A.4\)](#page-1-2) that $\lambda_0 \notin \sigma_{per}(L_{A_{per}})$, the result follows by the discreteness of $\sigma_{\text{per}}(L_{A_{\text{per}}})$ for λ close to λ_0 .

Lemma 3.6. If $\lambda \in \sigma(L_{A_{\text{per}}})$, then there exists a purely imaginary Floquet exponent $\alpha \in i\mathbb{R}$ of \mathcal{T} .

Proof. It is well known that since $L_{A_{per}} = L_{A_{per}}(D)$ is a periodic elliptic differential operator, then the spectrum of $L_{A_{per}}$ is a union of closed intervals, i.e.,

$$
\sigma(L_{A_{\text{per}}}) = \bigcup_{k \in \mathbb{N}} I_k,
$$

where $I_k = \{\lambda_k(\theta) : \theta \in [-\pi/p, \pi/p]\}$, and $\lambda_k(\theta)$ are the eigenvalues corresponding to the eigenvalue problem on the fundamental domain of periodicity with semi-periodic boundary conditions

$$
L_{A_{\text{per}}}(D)u = \lambda u,
$$

$$
u(z+p) = e^{i\theta p}u(z).
$$

Or, equivalently they can be seen as eigenvalues corresponding to a transformed eigenvalue problem on the fundamental domain of periodicity with periodic boundary conditions

$$
L_{A_{\text{per}}}(D + i\theta)u = \lambda u,
$$

$$
u(z + p) = u(z).
$$

Clearly, if $\lambda \in \sigma(L_{A_{\text{per}}})$, there must exist a $k_0 \in \mathbb{N}$ and $\theta_0 \in [-\pi/p, \pi/p]$ such that $\lambda = \lambda_{k_0}(\theta_0)$. Thus, it follows by the equivalence of formulations that $\alpha = i\theta_0$ is a Floquet exponent. For more $details, see [Plu11].$ $details, see [Plu11].$ $details, see [Plu11].$

Next, as $\sigma(\mathcal{T}_{\text{per}})$ is discrete by Lemma [3.4,](#page-3-1) we may define a continuous family of spectral projection operators $P(z)$, $z \in \mathbb{R}$, for \mathcal{T}_{per} as in [\[Mie96,](#page-17-4) Sec. 2.4]. Note that if $\alpha \in \sigma(\mathcal{T}_{\text{per}}) \cap i\mathbb{R}$, then also $\alpha + 2\frac{\pi}{p}i \in \sigma(\mathcal{T}_{\text{per}})$ and the spectral projection $P(0)$ onto $\sigma(\mathcal{T}_{\text{per}}) \cap i\mathbb{R}$ may be written as

(3.7)
$$
P(0)\mathcal{U} = \sum_{k=1}^{N} \langle \mathcal{U}, \psi_k \rangle \varphi_k,
$$

where φ_k are eigenfunctions of \mathcal{T}_{per} and ψ_k are eigenfunctions of $\mathcal{T}_{\text{per}}^*$. We are now able to define

(3.8)
$$
X^{c} = \text{Ran } P(0) = \text{span}\{\varphi_{1}, \ldots, \varphi_{N}\}
$$

to be the central part of \mathcal{T}_{per} .

Proposition 3.7. Assume $(A.\mathcal{A})$. Then dim X^c is positive and even.

Proof. That the dimension is positive follows directly from Lemma [3.6](#page-4-1) since $\lambda_0 \in \sigma_{\text{ess}}(L_{A_0})$ $\sigma_{\rm ess}(L_{A_{\rm per}}) \subset \sigma(L_{A_{\rm per}})$, and the finiteness follows from (3.7) – (3.8) .

We can use the projection to decompose our eigenvalue problem into two parts. One finitedimensional, taking projections onto X^c , and one infinite-dimensional part (for more on this, see [\[Kat95,](#page-17-1) Thm. 6.17]).

Now, let $R: X \to X$ be the involution defined by

$$
R:\mathcal{U}\mapsto\begin{pmatrix}r&0\\0&-r\end{pmatrix}\mathcal{U},
$$

where $(rf)(z) = f(-z)$. It holds that $R^2 = I$, and if we define

$$
\ell_{A_{\text{per}}}(z) = -(\partial + iA_{\text{per}}(z, \cdot))^2 - \lambda I,
$$

we have that

$$
\mathcal{B}(z; \lambda, A_{\rm per})R = \begin{pmatrix} 0 & 1 \\ \ell_{A_{\rm per}}(z) & 0 \end{pmatrix} \begin{pmatrix} r & 0 \\ 0 & -r \end{pmatrix} = \begin{pmatrix} 0 & -r \\ \ell_{A_{\rm per}}(z)r & 0 \end{pmatrix}.
$$

Furthermore,

$$
R\mathcal{B}(-z; \lambda, A_{\text{per}}) = \begin{pmatrix} r & 0 \\ 0 & -r \end{pmatrix} \begin{pmatrix} 0 & 1 \\ \ell_{A_{\text{per}}}(-z) & 0 \end{pmatrix} = \begin{pmatrix} 0 & r \\ -r\ell_{A_{\text{per}}}(-z) & 0 \end{pmatrix}
$$

$$
= \begin{pmatrix} 0 & r \\ -\ell_{A_{\text{per}}}(z)r & 0 \end{pmatrix} = -\mathcal{B}(z; \lambda, A_{\text{per}})R.
$$

Now we have, following the ideas of Remark 4.2 in [\[Mie96\]](#page-17-4), that $\Phi^c(z, z_0)$ is the fundamental matrix of the reduced linear problem. By the "reversibility" above, we know that $\Phi^c(-z, -z_0) =$ $R^c \Phi^c(z, z_0) R^c$, in addition to the standard properties $\Phi^c(z_0, z)^{-1} = \Phi^c(z, z_0) = \Phi^c(z + p, z_0 + p)$. As a consequence, the monodromy matrix $M = \Phi^c(p, 0)$ satisfies $M = \Phi^c(0, p) = \Phi^c(-p, 0)$ $R^c M R^c$. Since det $\Phi^c(z, z_0) > 0$ and det $R^c = 1$, we find that det $M = 1$, so the multiplicity of the eigenvalue −1 must be even and all the other eigenvalues (Floquet multipliers) are on the unit circle and appear either in pairs or are $+1$. However, since $\alpha = 0$ is not a Floquet exponent, $+1$ is not an eigenvalue of the monodromy matrix, and the result follows. \Box

3.2. Exponential dichotomies. Next, we introduce the concept of exponential dichotomies, which are essential to our approach for defining evolution operators for the spatial dynamics formulation.

Definition 3.8 (Exponential dichotomy). Let $J = \mathbb{R}_-$, \mathbb{R}_+ or \mathbb{R} . An ODE system

(3.9) U ′ = B(z)U,

where $\mathcal{U}(z) \in X$ and $\mathcal{B}(z) : X \to X$, is said to possess an exponential dichotomy on J if there exists a family of projections $P(z) \in \mathcal{L}(X)$, $z \in J$, such that the projections satisfy $P(\cdot) \mathcal{U} \in C(J; X)$ for any $\mathcal{U} \in X$, and there exist constants K and $\kappa^s < 0 < \kappa^u$ with the following properties:

(i) For any $z_0 \in J$ and $\mathcal{U} \in X$ there exists a unique solution $\Phi^s(z, z_0)\mathcal{U}$ of [\(3.9\)](#page-6-0) defined for $z \ge z_0, z, z_0 \in J$, such that $\Phi^s(z_0, z_0) \mathcal{U} = P(z_0) U$ and

$$
\|\Phi^s(z,z_0)\mathcal{U}\|_X \leq Ke^{\kappa^s(z-z_0)}\|\mathcal{U}\|_X,
$$

for every $z \geq z_0, z, z_0 \in J$.

(ii) For any $z_0 \in J$ and $\mathcal{U} \in X$, there exists a unique solution $\Phi^u(z, z_0)\mathcal{U}$ defined for $z \leq z_0$, $z, z_0 \in J$, such that $\Phi^u(z_0, z_0) \mathcal{U} = (I - P(z_0)) \mathcal{U}$ and

$$
\|\Phi^u(z,z_0)\mathcal{U}\|_X \leq Ke^{\kappa^u(z-z_0)}\|\mathcal{U}\|_x,
$$

for every $z \le z_0, z, z_0 \in J$.

(iii) The solutions $\Phi^s(z, z_0)$ U and $\Phi^u(z, z_0)$ U satisfy

 $\Phi^s(z, z_0) \mathcal{U} \in \text{Ran} P(z)$ for all $z \ge z_0, z, z_0 \in J$, $\Phi^u(z, z_0) \mathcal{U} \in \ker P(z)$ for all $z \leq z_0, z, z_0 \in J$.

As the center space X^c was proven to be non-empty, the system at infinity clearly does not possess an exponential dichotomy. Therefore, we must introduce a shift, $\pm \eta$, such that, for a new shifted system, none of the Floquet exponents are purely imaginary. This is true by the discreteness of the Floquet exponents.

(3.10)
$$
\mathcal{V}'_{\pm} = (\mathcal{B}(z; \lambda, A_{\text{per}}) \pm \eta I) \mathcal{V}_{\pm}.
$$

Lemma 3.9. Assume [\(A.4\).](#page-1-2) Then there exists $\delta > 0$ such that for any $\eta \in (0, \delta)$ the system [\(3.10\)](#page-6-1) possesses an exponential dichotomy on R.

Proof. By Theorem 2.3 in [\[Mie96\]](#page-17-4), it follows that $\mathcal{T}_{\pm\eta} := \mathcal{T} - (\pm \eta)I$ is invertible for all $\eta \in (0, \delta(\lambda)),$ with

$$
\delta(\lambda) = \min_{\substack{\alpha \in \sigma(\mathcal{T}_{\text{per}}(\lambda))\\ \text{Re}(\alpha) \neq 0}} | \text{Re}(\alpha) | > 0,
$$

which exists and is well-defined by the discreteness of the spectrum. The rest follows from the proof of Lemma 5.5 in [\[SS01\]](#page-17-6) and related results. The arguments apply verbatim with $\mathcal{T} \coloneqq \mathcal{T}_{\pm \eta}$ and $\mathcal{T}_{\text{ref}} \coloneqq \frac{d}{dz} - (\mathcal{A} \pm \eta).$

Finally, we can now show that the full system, once it is shifted, also possesses an exponential dichotomy. Again, using the change of variables $V_{\pm} = e^{\pm \eta z} U$, we obtain the shifted system

(3.11)
$$
\mathcal{V}'_{\pm} = (\mathcal{B}(z; \lambda, A) \pm \eta I) \mathcal{V}_{\pm}.
$$

Note that we may rewrite this as

(3.12)
$$
\mathcal{V}'_{\pm} = (\mathcal{B}(z; \lambda, A_{\text{per}}) \pm \eta + S(z; A)) \mathcal{V}_{\pm},
$$

where

$$
S(z; A) = \begin{pmatrix} 0 & 0 \\ -2i(A - A_{\text{per}})\partial + 2A_{\text{per}}(A - A_{\text{per}}) + (A - A_{\text{per}})^2 - i(A - A_{\text{per}})_{\varphi}' & 0 \end{pmatrix},
$$

or, equivalently

$$
\mathcal{T}_{\pm\eta}\mathcal{V}_{\pm} = S(z;A)\mathcal{V}_{\pm}.
$$

Lemma 3.10. Assume that $(A.1)$ – $(A.4)$ are satisfied. Then there exists $\delta = \delta(\lambda)$ such that for any $\eta \in (0,\delta)$ the system [\(3.11\)](#page-6-2) possesses exponential dichotomies on \mathbb{R}_+ and \mathbb{R}_- , respectively. Moreover, we may choose the dichotomies so that ker $P(0; \lambda, A) = \text{ker } P(0; \lambda_0, A_{per})$ for all (λ, A) in a neighborhood of (λ_0, A_0) . The corresponding evolution operators are denoted by $\Psi^s(\cdot; \lambda, A)$ and $\Psi^{cu}(\cdot;\lambda,A)$ for \mathcal{V}_+ on \mathbb{R}_+ , etc. Moreover, the evolution operators depend smoothly on λ and A.

Proof. The proof follows from the non-autonomus generalization of Theorem 1 mentioned in [\[PSS97\]](#page-17-7). In fact, the proof is almost exactly the same as the proof of this theorem, with $e^{-A-(t-\tau)}P_-\$ and $e^{A+(t-\tau)}P_+$ replaced by the evolution operators of the unperturbed system [\(3.10\)](#page-6-1) here denoted by $\Omega^{s}(z, z_0)$ and $\Omega^{cu}(z, z_0)$ for $+\eta$ and $\Omega^{u}(z, z_0)$ and $\Omega^{cs}(z, z_0)$ for $-\eta$. Fol-lowing the strategy of [\[PSS97,](#page-17-7) Lem. 3.2], we define the operator $\tilde{T}_0 : \mathscr{X}_{z_0}^s \to \mathscr{X}_{z_0}^s$ of the form $T_0 = I + I_1 + I_2$, where I is the identity operator and I_1 and I_2 are the integral operators

$$
(I_1 \mathcal{V}^s)(z) = -\int_0^z \Omega^s(z,\xi) S(\xi) \mathcal{V}^s(\xi) d\xi
$$

$$
(I_2 \mathcal{V}^s)(z) = \int_z^\infty \Omega^{cu}(z,\sigma) S(\xi) \mathcal{V}^s(\xi) d\xi
$$

and

$$
\mathscr{X}^s_{z_0} = \{ \mathcal{V} \in C^0 \left([z_0, \infty), X \right) : \, |\mathcal{V}| \, \mathscr{X}^s_{z_0} \coloneqq \sup_{z \ge z_0} e^{\eta |z - z_0|} |\mathcal{V}(z)| < \infty \}.
$$

For any z_* we may decompose $I_1 = S_1 + K_1$ according to

$$
(K_1 \mathcal{V}^s)(z) := \begin{cases} -\int_0^z \Omega^s(z,\xi) S(\xi) \mathcal{V}^s(\xi) d\xi, & z \le z_*,\\ -\Omega^s(z,z_*) \int_0^{z_*} \Omega^s(z_*,\xi) S(\xi) \mathcal{V}^s(\xi) d\xi, & z \ge z_*, \end{cases}
$$

$$
(S_1 \mathcal{V}^2)(z) = \begin{cases} 0, & z \le z_*,\\ -\int_{z_*}^z \Omega^s(z,\xi) S(\xi) \mathcal{V}^s(\xi) d\xi, & z \ge z_*. \end{cases}
$$

Now, we just have to prove that the operator $K_1: \mathscr{X}^s_{z_0} \to \mathscr{X}^s_{z_0}$ is compact and that S_1 has sufficiently small norm. Note that for large z_* we have, just as in [\[PSS97\]](#page-17-7), that

$$
||S_1||_{\mathcal{L}(\mathscr{X}_{z_0}^s)} \leq C \sup_{z \geq z_*} ||S(z)||_{\mathcal{L}(X)} \leq C\varepsilon.
$$

Since ε can be chosen arbitrarily small for z_* large enough, we are done and it remains now only to prove that K_1 is compact. To this end, we restrict K_1V^s to the interval $[0, z_*]$. K_1 maps $\mathscr{X}^s_{z_0}$ continuously into $C^1([0, z_*], D(\mathcal{B})) \cap C([0, z_*], X)$ and since $D(\mathcal{B})$ is compactly embedded into X, it follows by Arzela–Ascoli that this is compactly embedded into $C^0([0, z_*], X)$. Thus, the operator K_1 is a compact operator as the composition of a compact and a bounded operator. The rest follows in a completely similar way as in [\[PSS97\]](#page-17-7), after pointing out that also the condition (H5) of the paper [\[PSS97\]](#page-17-7) is fulfilled by Theorem 2.5 in [\[MZ02\]](#page-17-8). Smoothness of the exponential dichotomies with respect to the parameters (λ, A) can be shown by applying the implicit function theorem in a neighborhood of a point (λ_0, A_0) . □

Reversing the shift, we obtain evolution operators for the system [\(3.2\)](#page-1-4) Φ^s and Φ^{cu} on \mathbb{R}_+ and Φ^u and Φ^{cs} on \mathbb{R}_- given by

$$
\Phi^{s}(z, z_{0}; \lambda, A) = e^{-\eta(z - z_{0})} \Psi^{s}(z, z_{0}; \lambda, A), \quad \Phi^{cu}(z, z_{0}; \lambda, A) = e^{-\eta(z - z_{0})} \Psi^{cu}(z, z_{0}; \lambda, A),
$$

$$
\Phi^{u}(z, z_{0}; \lambda, A) = e^{\eta(z - z_{0})} \Psi^{u}(z, z_{0}; \lambda, A), \quad \Phi^{cs}(z, z_{0}; \lambda, A) = e^{\eta(z - z_{0})} \Psi^{cs}(z, z_{0}; \lambda, A).
$$

Lemma 4.1. Let U be a solution of (3.2) . Then

(i) if U is bounded on \mathbb{R}_+ , then for every $R \geq 0$ there exists a $\mathcal{U}_0^s \in X^s$ and a $\mathcal{U}_0^c \in X^c$ such that for $z \geq R$,

$$
\mathcal{U}(z) = \Phi^s(z, R; \lambda, A_{\text{per}}) \mathcal{U}_0^s + \Phi^c(z, 0; \lambda, A_{\text{per}}) \mathcal{U}_0^s + \int_R^z \Phi^s(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi - \int_z^\infty \Phi^{cu}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi,
$$

(ii) if U is bounded on \mathbb{R}_- , then for every $R \geq 0$ there exists a $\mathcal{V}_0^u \in X^u$ and a $\mathcal{V}_0^c \in X^c$ such that for $z \leq -R$,

$$
\mathcal{U}(z) = \Phi^{u}(z, -R; \lambda, A_{\text{per}}) \mathcal{V}_{0}^{s} + \Phi^{c}(z, 0; \lambda, A_{\text{per}}) \mathcal{V}_{0}^{s} - \int_{z}^{-R} \Phi^{u}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi
$$

$$
+ \int_{-\infty}^{z} \Phi^{cs}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi.
$$

Proof. We consider the case when $\mathcal U$ is bounded on \mathbb{R}_+ , since the other case is completely identical. We introduce $\mathcal{U}^i := P^i(\cdot; \lambda, A) \mathcal{U}$ for $i \in \{s, c, u\}$. By the variation of constants formula, after applying projections, we get

$$
\mathcal{U}^{s}(z) = \Phi^{s}(z, \zeta; \lambda, A_{\text{per}}) \mathcal{U}^{s}(\zeta) + \int_{\zeta}^{z} \Phi^{s}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi, \quad z \ge \zeta \ge 0,
$$

(4.1)
$$
\mathcal{U}^{c}(z) = \Phi^{c}(z, \zeta; \lambda, A_{\text{per}}) \mathcal{U}^{c}(\zeta) + \int_{\zeta}^{z} \Phi^{c}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi, \quad z, \zeta \ge 0,
$$

$$
\mathcal{U}^{u}(z) = \Phi^{s}(z, \zeta; \lambda, A_{\text{per}}) \mathcal{U}^{u}(\zeta) + \int_{\zeta}^{z} \Phi^{u}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi, \quad \zeta \ge z \ge 0.
$$

Since $\|\mathcal{U}(z)\|_X$ is bounded, it follows that also $\mathcal{U}^s, \mathcal{U}^c$ and \mathcal{U}^u all are bounded.

We first look at \mathcal{U}^u and let $\zeta \to \infty$ in the last equation of [\(4.1\)](#page-8-0). Since \mathcal{U}^u is bounded, the first term goes to zero, and it follows that

\mathcal{U}^{u}(z) = -\int_{z}^{\infty} \Phi^{u}(z,\xi;\lambda,A_{\text{per}})S(\xi;A)\mathcal{U}(\xi)d\xi.

Next, we study the equation for \mathcal{U}^c .

Note that $\Phi^c(z,\xi;\lambda,A_{\text{per}})$ is a bounded operator mapping a finite-dimensional set into itself. Therefore

Now it follows that the integral on the right-hand side of the second equation of [\(4.1\)](#page-8-0) converges as $\zeta \to \infty$ since $\|\Phi^c(0,\xi;\lambda,\tilde{A}_{\text{per}})\|$ is uniformly bounded for all $\xi \in \mathbb{R}$ and since

$$
\int_{z}^{\infty} \|S(\xi; A)U(\xi)\|_{X} d\xi \le \|S(\cdot; A)\|_{X_{\beta}} \|U\|_{L^{\infty}} \int_{z}^{\infty} \frac{1}{(1+\xi)^{\beta}} d\xi
$$

$$
= \frac{1}{\beta-1} \|S(\cdot; A)\|_{X_{\beta}} \|U\|_{L^{\infty}} \frac{1}{(1+z)^{\beta-1}}
$$

where we recall the assumption that $\beta > 1$. Since the left-hand side of the equation for \mathcal{U}^c does not depend on ξ , it follows that $\lim_{\zeta \to \infty} \Phi^c(0,\xi;\lambda,A_{\text{per}}) \mathcal{U}^c(\xi)$ exists. Hence, there exists a $\mathcal{U}_0^c \in X^c$ such that

,

$$
\mathcal{U}^{c}(z) = \Phi^{c}(z, 0; \lambda, A_{\text{per}}) \mathcal{U}_{0}^{c} - \int_{z}^{\infty} \Phi^{c}(z, \xi; \lambda, A_{\text{per}}) S(\xi, A) \mathcal{U}(\xi) d\xi.
$$

For \mathcal{U}^s , we choose $\xi = R \geq 0$ arbitrarily, so that by [\(4.1\)](#page-8-0) for $z \geq R$,

\mathcal{U}(z) = \Phi^{s}(z, R; \lambda, A_{\text{per}}) \mathcal{U}_{0}^{s} + \Phi^{c}(z, 0; \lambda, A_{\text{per}}) \mathcal{U}_{0}^{s} + \int_{R}^{z} \Phi^{s}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi
$$

$$
- \int_{z}^{\infty} \Phi^{cu}(z, \xi; \lambda, A_{\text{per}}) S(\xi; A) \mathcal{U}(\xi) d\xi,
$$

$$
\mathcal{U}_{0}^{s} = \mathcal{U}^{s}(R).
$$

with $\mathcal{U}_0^s = \mathcal{U}^s$

Lemma 4.2. Assume that assumptions $(A.1)-(A.4)$ $(A.1)-(A.4)$ are satisfied. Further assume that $\lambda > 0$ is an eigenvalue of the operator L_A with corresponding eigenfunction $u \in H^2(\mathbb{R} \times S^1)$. We denote by U the corresponding solution of the system (3.2) . Let $\eta \in (0, \delta(\lambda))$. Then there exists a constant $K > 0$ such that

$$
\|\mathcal{U}(z)\|_X \leq Ke^{-\eta|z|},
$$

for all $z \in \mathbb{R}$.

Proof. In light of Lemma [4.1,](#page-8-1) the proof follows by a fixed-point argument, exactly as Lemma 6 in $[LM17]$.

5. Lyapunov–Schmidt reduction

We are now ready to prove our main result. For this, we choose to utilize the Lyapunov-Schmidt reduction. We denote by u_* the eigenfunction corresponding to the embedded eigenvalue of the unperturbed problem, i.e., $L_{A_0} u_* = \lambda_0 u_*$. We assume, without loss of generality, that u_* is normalized. We further write $\mathcal{U}_* = (u_*, u'_*)^T$ as the corresponding solution of (3.2) with $A = A_0$. Using the evolution operators and their related projections from the exponential dichotomy, we define the stable and unstable subspaces E^s_+ and E^u_- by

$$
E_{+}^{s} = \{ \mathcal{U} \in Y; \ \ P_{+}^{s}(0; \lambda_{0}, A_{0})\mathcal{U} = \mathcal{U} \},
$$

$$
E_{-}^{u} = \{ \mathcal{U} \in Y; \ \ P_{-}^{u}(0; \lambda_{0}, A_{0})\mathcal{U} = \mathcal{U} \}.
$$

These subspaces consist of inital values of solutions of the unperturbed system which decay exponentially as $z \to \infty$ and $z \to -\infty$, respectively. We have that $E^s_+ \cap E^u_- = \text{span}\{\mathcal{U}_*(0)\}\$, since λ_0 was assumed to be of multiplicity 1. The following is a corollary of Lemma [4.2.](#page-9-0)

Corollary 5.1. Let U be a solution of [\(3.2\)](#page-1-4). If $\mathcal{U}(0) \in E_+^s \cap E_-^u$, then $\mathcal{U}_0^c = \mathcal{V}_0^c$ in (i) and (ii) of Lemma [4.1.](#page-8-1)

To find embedded eigenvalues, we define the mapping $\iota: E^s_+ \times E^u_- \times \mathbb{R} \times (A_{\text{per}} + \mathcal{X}_{\beta}) \to X$ by

$$
\iota\colon (\mathcal{U}_0^s, \mathcal{U}_0^u; \lambda, A) = P_+^s(0; \lambda, A)\mathcal{U}_0^s - P_-^u(0; \lambda, A)\mathcal{U}_0^u.
$$

Lemma 5.2. It holds that $\lambda \notin \sigma_{per}(L_{A_{per}})$ is an eigenvalue of L_A if and only if there exist $\mathcal{U}_0^s \in E^s_+$ and $\mathcal{U}_0^u \in E_{-}^u$ with $(\mathcal{U}_0^s, \mathcal{U}_0^u) \neq (0, 0)$ such that

(5.1)
$$
\iota(\mathcal{U}_0^s, \mathcal{U}_0^u; \lambda, A) = 0.
$$

Proof. The result follows exactly as in [\[LM17\]](#page-17-3). \square

To solve [\(5.1\)](#page-9-1), we must first observe that for any $(\mathcal{U}_0^s, \mathcal{U}_0^u) \in E^s_+ \times E^u_-$ we have

$$
\iota(\mathcal{U}_0^s, \mathcal{U}_0^u; \lambda_0, A_0) = \mathcal{U}_0^s - \mathcal{U}_0^u.
$$

Thus, $\text{Ran}_l(\cdot, \cdot; \lambda_0, A_0) = E^s_+ + E^u_-.$ Next, we will provide a result on the codimension of $E^s_+ + E^u_-.$

Lemma 5.3. We have that $\text{codim}(E_+^s + E_-^u) = \dim(X^c) + 1 = 2m + 1$.

Proof. In light of the constructions in Lemma [3.10,](#page-7-0) the proof follows in a completely similar way as the proof of Lemma 8 in [\[LM17\]](#page-17-3), just with $4m-2$ substituted with $\dim(X^c) = 2m$ everywhere and with the constructions of S_j and K_j according to Lemma [3.10.](#page-7-0) □

Let Q be the projection in X onto $\text{Ran}\iota(\cdot,\cdot;\lambda_0,A_0) = E^s_+ + E^u_-.$ Lemma [5.3](#page-9-2) implies that $\dim(\ker Q) = \dim(X^c) + 1 = 2m + 1$. Equation [\(5.1\)](#page-9-1) can be rewritten as

(5.2)
$$
Q_{l}(\mathcal{U}_{0}^{s}, \mathcal{U}_{0}^{u}; \lambda, A) = 0,
$$

$$
(I - Q)_{l}(\mathcal{U}_{0}^{s}, \mathcal{U}_{0}^{u}; \lambda, A) = 0.
$$

Next, we want to add a condition to fix the solution amongst infinitely many to get a unique solution using the implicit function theorem.

Lemma 5.4. Let $D \subset E_{+}^{s} \times E_{-}^{u}$ be an affine hyperplane such that

 $D \cap span \{ (\mathcal{U}_*(0), \mathcal{U}_*(0)) \} = \{ (\mathcal{U}_*(0), \mathcal{U}_*(0)) \}.$

For (λ, A) close to (λ_0, A_0) , the first equation of [\(5.2\)](#page-10-0) has a unique solution

$$
(\mathcal{U}_0^s, \mathcal{U}_0^u) = (\mathcal{U}_0^s(\lambda, A), \mathcal{U}_0^u(\lambda, A)) \in D
$$

in a neighborhood of $((\mathcal{U}_*(0),\mathcal{U}_*(0))$. Moreover, \mathcal{U}_0^s and \mathcal{U}_0^u are smooth in their arguments.

Proof. This follows immediately from [\[LM17\]](#page-17-3) by the implicit function theorem. \Box

Using the variation of constants formula, see e.g. [\[Hen81\]](#page-17-9), we get that

$$
\iota(\cdot, \cdot; \lambda, A) = \mathcal{U}_0^s - \mathcal{U}_0^u
$$

+
$$
\int_{-\infty}^0 \Phi^{cs}(0, z; \lambda_0, A_0)((\lambda - \lambda_0)N + \tilde{S}(z; A))\Phi^{u}(z, 0; \lambda, A)\mathcal{U}_0^u dz
$$

+
$$
\int_0^{\infty} \Phi^{cu}(0, z; \lambda_0, A_0)((\lambda - \lambda_0)N + \tilde{S}(z; A))\Phi^{s}(z, 0; \lambda, A)\mathcal{U}_0^s dz,
$$

where $N: X \to X$ is given by

$$
(5.3) \t\t N = \begin{pmatrix} 0 & 0 \\ 1 & 0 \end{pmatrix}
$$

and \hat{S} is defined exactly as in [\(3.12\)](#page-6-3), but with A_{per} replaced with A_0 , as we are now perturbing from the unperturbed system and not the system at infinity.

To solve the second equation of [\(5.2\)](#page-10-0), we define $F : \mathbb{R} \times (A_{per} + \mathcal{X}_{\beta}) \to \ker Q$ by

(5.4)
\n
$$
F(\lambda, A) = -\iota(\mathcal{U}_0^s(\lambda, A), \mathcal{U}_0^u(\lambda, A); \lambda, A) = -(I - Q)\iota(\mathcal{U}_0^s(\lambda, A), \mathcal{U}_0^u(\lambda, A); \lambda, A)
$$
\n
$$
= \int_{-\infty}^0 (I - Q)\Phi^{cs}(0, z; \lambda_0, A_0)((\lambda - \lambda_0)N + \tilde{S}(z; A))\Phi^u(z, 0; \lambda, A)\mathcal{U}_0^u dz
$$
\n
$$
+ \int_0^\infty (I - Q)\Phi^{cu}(0, z; \lambda_0, A_0)((\lambda - \lambda_0)N + \tilde{S}(z; A))\Phi^s(z, 0; \lambda, A)\mathcal{U}_0^s dz.
$$

Note in particular that F is a smooth function in both arguments and that solving (5.2) is equivalent to solving $F(\lambda, A) = 0$. To solve the equation $F(\lambda, A) = 0$, we use the dual space $X^* = H^{-1}(S^1) \times L^2(S^1)$ of X and the adjoint equation for $\lambda = \lambda_0$ as well as $A = A_0$, that is the equation

(5.5)
$$
\mathcal{W}' = -(\mathcal{B}(z; \lambda_0, A_{\text{per}}) + S(z; A_0))^* \mathcal{W}.
$$

The adjoint system possesses exponential dichotomies on \mathbb{R}_+ and \mathbb{R}_- denoted by $\Psi^s(z, z_0; \lambda_0, A_0)$, $\Psi^{cu}(z, z_0; \lambda_0, A_0)$ and $\Psi^{cs}(z, z_0; \lambda_0, A_0)$, $\Psi^u(z, z_0; \lambda_0, A_0)$, respectively. They are related to the exponential dichotomies of the unperturbed system in [\(3.2\)](#page-1-4), with $\lambda = \lambda_0$ and $A = A_0$, in the following way

$$
\Psi^s(z, z_0; \lambda_0, A_0) = \Phi^{cu}(z_0, z; \lambda_0, A_0)^*, \quad \Psi^{cu}(z, z_0; \lambda_0, A_0) = \Phi^s(z_0, z; \lambda_0, A_0)^*,
$$

$$
\Psi^{cs}(z, z_0; \lambda_0, A_0) = \Phi^u(z_0, z; \lambda_0, A_0)^*, \quad \Psi^u(z, z_0; \lambda_0, A_0) = \Phi^{cs}(z_0, z; \lambda_0, A_0)^*,
$$

where z_0 , z are in the appropriate intervals. It is straightforward to verify that $\mathcal{U}_*^{\perp} = (-u'_*, u_*)^T$ solves the adjoint equation [\(5.5\)](#page-10-1) and is exponentially decaying as $|z| \to \infty$. For $\mathcal{U}^s \in E^s_+$ and $\mathcal{U}^u \in E^u_-$ it is easy to see that

$$
\frac{d}{dz}\langle \mathcal{U}_{*}^{\perp}(z),\Phi^{s}(z,0;\lambda_{0},A_{0})\mathcal{U}^{s}\rangle = \frac{d}{dz}\langle \Psi^{s}(z,0;\lambda_{0},A_{0})\mathcal{U}_{*}^{\perp}(0),\Phi^{s}(z,0;\lambda_{0},A_{0})\mathcal{U}^{s}\rangle = 0,
$$
\n
$$
\frac{d}{dz}\langle \mathcal{U}_{*}^{\perp}(z),\Phi^{u}(z,0;\lambda_{0},A_{0})\mathcal{U}^{u}\rangle = \frac{d}{dz}\langle \Psi^{u}(z,0;\lambda_{0},A_{0})\mathcal{U}_{*}^{\perp}(0),\Phi^{u}(z,0;\lambda_{0},A_{0})\mathcal{U}^{u}\rangle = 0.
$$

Moreover, since $\mathcal{U}_*^{\perp}(z) \to 0$ as $|z| \to \infty$ and $\Phi^s(z, 0; \lambda_0, A_0) \mathcal{U}^s$ and $\Phi^u(z, 0; \lambda_0, A_0) \mathcal{U}^u$ are bounded on \mathbb{R}_+ and \mathbb{R}_- respectively, it follows that $\langle \mathcal{U}_*^{\perp}(0), \mathcal{U}^s + \mathcal{U}^u \rangle = 0$. This also implies that for any $\mathcal{U} \in X$ we have that $\langle \mathcal{U}_{*}^{\perp}(0), \mathcal{U} \rangle = \langle Q^* \mathcal{U}_{*}^{\perp}(0), \mathcal{U} \rangle = 0$, and so it follows that $\mathcal{U}_{*}^{\perp}(0) \in \text{ker } Q^*$.

Lemma 5.5. The equation $\langle U^{\perp}_{*}(0), F(\lambda, A) \rangle = 0$ defines a smooth function $\lambda(A)$ in a neighborhood of $A = A_0$ such that $\lambda(A_0) = \lambda_0$. Furthermore, for any $B \in \mathcal{X}_{\beta}$,

$$
(5.6)\qquad \lambda'(A_0)B=-\int_{-\infty}^{\infty} \langle u_*(z), (-2iB(z,\cdot)\partial -iB'_{\varphi}(z,\cdot)+2A_0(z,\cdot)B(z,\cdot))u_*(z)\rangle_{L^2(S^1)}\,\mathrm{d}z.
$$

Proof. We have that

$$
0 = F_*(\lambda, A) := \langle \mathcal{U}_*^{\perp}(0), F(\lambda, A) \rangle
$$

\n
$$
= \int_{-\infty}^0 \langle \mathcal{U}_*^{\perp}(0), \Phi^{cs}(0, z; \lambda_0, A_0) ((\lambda - \lambda_0)N + \tilde{S}(z; A)) \Phi^{u}(z, 0; \lambda, A) \mathcal{U}_0^{u}(\lambda, A) \rangle dz
$$

\n
$$
+ \int_0^{\infty} \langle \mathcal{U}_*^{\perp}(0), \Phi^{cu}(0, z; \lambda_0, A_0) ((\lambda - \lambda_0)N + \tilde{S}(z; A)) \Phi^{s}(z, 0, \lambda, A) \mathcal{U}_0^{s}(\lambda, A) \rangle dz
$$

\n
$$
= \int_{-\infty}^0 \langle \mathcal{U}_*^{\perp}(z), ((\lambda - \lambda_0)N + \tilde{S}(z; A)) \Phi^{u}(z, 0; \lambda, A) \mathcal{U}_0^{u}(\lambda, A) \rangle dz
$$

\n
$$
+ \int_0^{\infty} \langle \mathcal{U}_*^{\perp}(z), ((\lambda - \lambda_0)N + \tilde{S}(z; A)) \Phi^{s}(z, 0, \lambda, A) \mathcal{U}_0^{s}(\lambda, A) \rangle dz.
$$

By Lemma [3.10](#page-7-0) it follows that F_* is a smooth function of λ and A in a neighborhood of (λ_0, A_0) . Moreover, $F_*(\lambda_0, A_0) = 0$ and

$$
\frac{\partial F_*}{\partial \lambda}(\lambda_0, A_0) = \int_{-\infty}^{\infty} \langle \mathcal{U}_*^{\perp}(z), N \mathcal{U}_*(z) \rangle \, dz = \int_{-\infty}^{\infty} ||u_*(z)||^2_{L^2(S^1)} \, dz = 1,
$$

by the normalization of u_* . This allows for the application of the implicit function theorem to solve for λ giving it as a function of A in a neighborhood of $A = A_0$ with $\lambda(A_0) = \lambda_0$. Differentiation of the function $F_*(\lambda(A), A) = 0$ and evaluating in $A = A_0$ gives the expression in [\(5.6\)](#page-11-0). For more details on the computation of the derivatives, see [\[MT24,](#page-17-10) Lem. 4.4] as it follows similarly. \Box

We are now ready to prove Theorem [2.1.](#page-1-5)

Proof of Theorem [2.1.](#page-1-5) Since $\dim(\ker Q^*) = 2m + 1$, and we know that $\mathcal{U}_*^{\perp}(0) \in \ker Q$, we define $W_k(0) \in X'$, k=1,...,2m, to be such that $\{W_k(0); k = 1,\ldots,2m\} \cup \{U_*^{\perp}(0)\}\$ is a basis for ker Q^* . Let W_k be the solutions of the unperturbed system with initial value $W_k(0)$ and define $F_k: A_{\text{per}} + \mathcal{X}_{\beta} \to \mathbb{R}$ by

$$
F_k(A) = \langle \mathcal{W}_k(0), F(\lambda(A), A) \rangle, \quad \text{for } k = 1, \dots, 2m,
$$

with F as in [\(5.4\)](#page-10-2). All F_k are clearly smooth, since F is by Lemma [3.10.](#page-7-0) Further if $F_k(A) = 0$ for some $A \in A_{per} + \mathcal{X}_{\beta}$ for all $k = 1, \ldots, 2m$, then $F(\lambda(A), A) = 0$ since $\{\mathcal{W}_k(0); k = 1, \ldots, 2m\}$ { $U^{\perp}_{*}(0)$ } constitutes a basis for ker Q^* . The converse clearly holds as well.

In order to prove the theorem, we show that there is a manifold of perturbations A with codimension 2m defined by the equations $F_k(A) = 0$ for $k = 1, \ldots, 2m$. Using the notation

$$
\mathcal{U}(z;A) := \begin{cases} \Phi^s(z,0;\lambda(A),A)\mathcal{U}_0^s(\lambda(A),A), & \text{for } z \ge 0, \\ \Phi^u(z,0;\lambda(A),A)\mathcal{U}_0^u(\lambda(A),A), & \text{for } z < 0, \end{cases}
$$

we get that

$$
F_k(A) = \int_{-\infty}^{\infty} \langle \mathcal{W}_k(z), ((\lambda(A) - \lambda_0)N + \tilde{S}(z; A))\mathcal{U}(z; A) \rangle dz
$$

=
$$
\int_{-\infty}^{\infty} \langle w_k(z), (\lambda(A) - \lambda_0 - 2i(A - A_0)\partial + (A_0 + A)(A - A_0) - i(A - A_0) \rangle)u(z; A) \rangle_{L^2(S^1)} dz,
$$

where $W_k = (-w'_k, w_k)^T$, $u(z; A)$ is the first component of $U(z; A)$ and N as in [\(5.3\)](#page-10-3).

Next, we wish to prove that $F'_k(A_0)$, $k = 1, ..., 2m$ are linearly independent. Using [\(5.4\)](#page-10-4) and Lemma [5.5,](#page-11-1) we get that, for every $B \in \mathcal{X}_{\beta}$

$$
F'_{k}(A_0)B = \int_{-\infty}^{\infty} \langle w_k(z), ([\lambda'(A_0)B] - 2iB\partial + 2A_0B - iB'_{\varphi})u_*(z) \rangle_{L^2(S^1)} dz
$$

with $\lambda'(A_0)B$ as in [\(5.6\)](#page-11-0). Now assume that there exists $\alpha_1, \ldots, \alpha_m \in \mathbb{C}$ such that

$$
0 = \sum_{k=1}^{2m} \alpha_k F'_k(A_0) B
$$

=
$$
\int_{-\infty}^{\infty} \langle w(z), ([\lambda'(A_0)B] - 2iB\partial + 2A_0B - iB'_{\varphi})u_*(z) \rangle_{L^2(S^1)} dz
$$

=
$$
\int_{-\infty}^{\infty} \langle w(z) + \alpha_* u_*(z), (-2iB\partial + 2A_0B - iB'_{\varphi})u_*(z) \rangle_{L^2(S^1)} dz,
$$

for every $B \in \mathcal{X}_{\beta}$. Here,

$$
w = \sum_{k}^{2m} \alpha_k w_k,
$$

together with

$$
\alpha_* := \int_{-\infty}^{\infty} \overline{\langle w(z), u_*(z) \rangle_{L^2(S^1)}} \, dz.
$$

Using integration by parts in the φ -variable, this becomes

$$
\int_{-\infty}^{\infty} \int_{S^1} \left(i \partial_{\varphi} \left(u_*(z, \varphi) \overline{(w(z, \varphi) + \alpha_* u_*(z, \varphi))} \right) - 2i u'_{\varphi}(z, \varphi) \overline{(w(z, \varphi) + \alpha_* u_*(z, \varphi))} \right) \right. \\
\left. + 2A_0(z, \varphi) u_*(z, \varphi) \overline{(w(z, \varphi) + \alpha_* u_*(z, \varphi))} \right) B(z, \varphi) d\varphi dz,
$$

for every $B \in \mathcal{X}_{\beta}$. Since \mathcal{X}_{β} is dense in $L^2(\mathbb{R} \times S^1; \mathbb{R})$, we get that, after rewriting (5.7)

$$
u_*(z, \varphi)\overline{(w(z, \varphi)+\alpha_* u_*(z, \varphi))} - \big(u'_{*\varphi}(z, \varphi)+2iA_0(z, \varphi)u_*(z, \varphi)\big)\overline{(w(z, \varphi)+\alpha_* u_*(z, \varphi))} = 0,
$$

for every $(z, \varphi) \in \mathbb{R} \times S^1$, since u_* and w are continuously differentiable. We now wish to prove that $w + \alpha_* u_* \equiv 0$. This will be done by first proving that the function vanishes on an open set, followed by unique continuation, yielding the result. We know by $(A.2)$ that there exists a $z_0 \in \mathbb{R}$ such that $\int_{S^1} A_0(z_0, \varphi) d\varphi \neq \int_{S^1} A_{\text{per}}(z_0, \varphi) d\varphi$.

However, since clearly

$$
\left| \int_{S^1} A_0(z,\varphi) \, d\varphi - \int_{S^1} A_{\rm per}(z,\varphi) \, d\varphi \right| \longrightarrow 0
$$

as $|z| \to \infty$, it follows by continuity and the intermediate value theorem that we can choose z_0 in the way we want. By continuity, there exists an open interval I such that $z_0 \in I$ and $\int_{S^1} A_0(z_0, \varphi) d\varphi \neq k\pi$ for all $z \in I$. We now wish to prove that either $w + \alpha_* u_*$ or u_* vanishes on an open interval. This however now follows exactly in the same way as in [\[LM17\]](#page-17-3). Then, by unique continuation, it follows that it has to vanish on the entire $\mathbb{R} \times S^1$. However u_* is an eigenfunction by assumption, and so it cannot vanish everywhere, giving that $w + \alpha_* u_* \equiv 0$ on $\mathbb{R} \times S^1$. Thus, it follows that $\alpha_k = 0$ for all $k = 1, ..., 2m$, implying that $F'_k(A_0), k = 1, ..., 2m$ are linearly independent. The final result is then obtained in the following way:

Define $\mathcal{F}: A_{\text{per}} + \mathcal{X}_{\beta} \to \mathbb{C}^{2m}$ by

$$
\mathcal{F}(A) \coloneqq (F_1(A), \ldots, F_{2m}(A))^T.
$$

It follows by the linear independence of $\mathcal{F}'(A_0)$ that we can decompose the space \mathcal{X}_{β} in the following way

$$
\mathcal{X}_{\beta} = (\ker \mathcal{F}'(A_0)) \oplus \mathcal{M},
$$

where M is 2m-dimensional. The map $\mathcal{F}'(A_0)$ is clearly surjective. In light of the decomposition \mathcal{X}_{β} , we write for any $B \in \mathcal{X}_{\beta}$ $B = B_1 + B_2$, where $B_1 \in \text{ker } \mathcal{F}'(A_0)$ and $B_2 \in \mathcal{M}$. We may then define

$$
\mathcal{G}: (\ker \mathcal{F}'(A_0)) \oplus \mathcal{M} \to \mathbb{C}^{2m}
$$

by

$$
\mathcal{G}(B_1,B_2)=\mathcal{F}(B_1+B_2+A_0).
$$

The Fréchet derivative of G at $(0,0)$ with respect to B₂ denoted by $\partial_{A_2} \mathcal{G}(0,0)$ is invertible and hence allows for the application of the implicit function theorem, solving for B_2 in terms of B_1 , defining a smooth manifold of dimension 2m in a neighborhood of $A = A_0$. For more explicit details on the construction, see the proof of Theorem 1.3 in [\[MT24\]](#page-17-10), as it is identical. \Box

6. Example

The following example shows that there exist operators satisfying the conditions $(A.1)$ – $(A.4)$. For simplicity, we consider an operator whose potential is independent of φ . We emphasize that the theorems in the paper do not rely on the φ -independence of A_0 .

Example 6.1. Let $A_{per}(z) = \cos z$. We will find a potential A_0 such that $|A_0(z) - A_{per}(z)| \to 0$ as $|z| \to \infty$. For simplicity, we will construct the embedded eigenvalue for a fairly small λ_0 . Examples for other values of λ_0 can be constructed with the same method used here, but with more work if λ_0 is large. The essential spectra of A_0 and A_{per} on $L^2(\mathbb{R} \times S^1)$ are the same due to Weyl's theorem, and so we establish the essential spectrum of A_{per} first. It is generated by functions of the form $v(z)e^{im\varphi}$, $m \in \mathbb{Z}$, where v is a bounded solution of

(6.1)
$$
-v''(z) + (m + \cos z)^2 v(z) = \lambda v(z).
$$

The essential spectrum is the closure of the set of numbers λ for which such solutions exist. For a fixed m, we obtain bounded solutions v, when λ belongs to the essential spectrum of the operator

$$
\ell_m = -\frac{d^2}{dz^2} + (m + \cos z)^2
$$

on $L^2(\mathbb{R})$. Such an operator has essential spectrum with a band structure, i.e. it consists of a countable union of closed intervals [\[Eas73,](#page-16-3) Thm. 5.3.2] which is contained in a half-line (μ_m, ∞) , where $\mu_m \in [\min(m + \cos z)^2, \max(m + \cos z)^2]$. In particular, $\mu_m \in [0, 1]$ if $m = 0$ while $\mu_m \in$ $[(|m|-1)^2, (|m|+1)^2]$ if $m \neq 0$. The start and endpoints of each of these closed intervals can be computed more accurately numerically by computing the discriminant $\gamma(\lambda) = \frac{1}{2}(\varphi_1(p) + \varphi_2'(p)),$ where p is the period of the potential $(p = \pi \text{ for } m = 0 \text{ and } p = 2\pi \text{ for } m \ge 1)$ and φ_i are the two linearly independent solutions of the periodic ODE satisfying the initial conditions $\varphi_1(0) = 1$, $\varphi'_1(0) = 0$ and $\varphi_2(0) = 0$, $\varphi'_2(0) = 1$, respectively, and solving for the intersections of the graph of γ with the lines $y = 1$ and $y = -1$. This follows from the fact that λ belongs to the continuous spectrum precisely when $|\gamma(\lambda)| \leq 1$, see [\[Eas73,](#page-16-3) Thm. 5.3.2]. It can also be shown that there exists a Λ such that $\gamma(\lambda) > 1$ for all $\lambda < \Lambda$, meaning that the first intersection of γ with $y = 1$ should give the start of the first closed interval. Additionally, it can be shown that the endpoint of the interval is at the first intersection of γ with $y = -1$ (if it exists, otherwise the spectrum continues to $+\infty$), after which the second interval starts again at the next intersection of γ with $y = -1$ and ends at the second intersection of γ with $y = 1$ and then repeats in a similar fashion (assuming that there are intersections so that the bands are not infinitely long) [\[Eas73,](#page-16-3) Thm. 2.3.1].

As we focus on the essential spectrum in a neighborhood of our embedded eigenvalue and we want to consider small values of λ_0 , we only need to consider $m = 0$ and $m = \pm 1$, as the spectra of the other ODE operators should not contain λ_0 , if it is small enough. Indeed, for $|m| = 2$, the

first band starts after $\lambda = 2$, as can be computed numerically, and for other m, the first band starts even further away. We also note that the operators with $m = 1$ and $m = -1$ have the same essential spectra.

For $m = 0$, as $\cos^2 z = (1 + \cos 2z)/2$, the essential spectrum of this ordinary differential operator is the spectrum of the Schrödinger operator with a Mathieu potential, shifted by 1/2 to the right. Hence, the first band of the essential spectrum for the ODE operator for $m = 0$ starts at $\mu_0 \approx 0.469$ and ends at a point which is approximately 1.242.

For $m = \pm 1$ the first band is starts around $\mu_m \approx 0.564$ and ends at approximately 0.572 and the second one starts around 1.88.

Going back to the operator A_{per} , it has essential spectrum which is the union of the essential spectra of the above ODE operators for $m \in \mathbb{Z}$.

To construct the operator A_0 , we will pick a λ_0 which belongs to the essential spectrum of the ODE operator associated with $m = 0$, but not in the essential spectrum for the ODE operators associated with $m = \pm 1$ $m = \pm 1$. For example, we may choose $\lambda_0 = 0.5$. See Figure 1 below for the spectral picture.

FIGURE 1. Spectra of the ODE operators corresponding to $m = 0$ and $m = \pm 1$ respectively together with λ_0 .

It follows from [\[Eas73,](#page-16-3) Thm. 1.1.2] that there are linearly independent solutions ψ_1 and ψ_2 of the ODEs such that either $\psi_i(z) = e^{\alpha_i z} p_i(z)$, where α_i constants, not necessarily distinct and p_i are periodic with the same period as the potential, or $\psi_1(z) = e^{\alpha z} p_1(z)$, $\psi_2(z) = e^{\alpha z} (zp_1(z) + p_2(z))$. Here, α_i are defined as $e^{\alpha_i p} = \rho_i$, where ρ_i are the eigenvalues of the matrix

$$
M = \begin{pmatrix} \varphi_1(p) & \varphi_1'(p) \\ \varphi_2(p) & \varphi_2'(p) \end{pmatrix}.
$$

By letting $m = 1$ and $\lambda_0 = 0.5$, we may now compute the α_i numerically, obtaining approximately ± 0.1729 . Now by denoting $\alpha = |\alpha|$ and defining

$$
f_{\pm}(z) = e^{\pm \alpha z} p_{\pm}(z),
$$

where p_+ and p_- are the periodic functions corresponding to the exponents $+\alpha$ and $-\alpha$, respectively. Since f_{\pm} are two linearly independent solutions, they satisfy $f''_{\pm}(z) = ((m + A_{\text{per}}(z))^2 - \lambda_0)$ with $f_{\pm}(z)$ decaying exponentially at $z \to \pm \infty$ respectively, we may define

$$
v_*(z) = \frac{1}{2}(1 - \tanh(\beta z))f_+(z) + \frac{1}{2}(1 + \tanh(\beta z))f_-(z), \quad \text{ for some } \beta > 0.
$$

Numerically, these functions can by found by solving for the eigenvectors of the matrix M and then using them as initial conditions when solving the ODE. Due to the symmetries of the equation, it should be noted that if we define

$$
f_+(z) = f(z) = e^{\alpha z} p(z),
$$

and $\text{Re}\,\alpha > 0$, it follows that

$$
f_{-}(z) = f(-z)
$$

is also a solution to the equation, with $f_+, f_- > 0$ and linearly independent.

The solution in our case will look something like in Figure [2](#page-15-0) below.

FIGURE 2. Eigenfunction of ℓ_m for $m = 1$ corresponding to $\lambda_0 = 0.5$.

Note that v_* is bounded and decays exponentially to 0 as $|z| \to 0$ and that, after some calculations,

$$
\frac{v_\ast''(z)}{v(z)}=\frac{2\beta\,\text{sech}^2(\beta z)\left(\beta\,\text{tanh}(\beta x)f_+(z)-f_+'(z)-(\beta\,\text{tanh}(\beta z)f_-(z)-f_-'(z))\right)}{(1-\text{tanh}(\beta z))f_+(z)+(1+\text{tanh}(\beta z))f_-(z)}+(m+A_\text{per})^2-\lambda_0.
$$

Plugging in that $f'_{\pm}(z) = \pm \alpha e^{\pm \alpha z} p_{\pm}(z) + e^{\pm \alpha z} p'_{\pm}(z) = \pm \alpha f_{\pm}(z) + e^{\pm \alpha z} p'_{\pm}(z)$, we get

$$
\frac{v''_{*}(z)}{v(z)}=\frac{2\beta\,\textrm{sech}^2(\beta z)\left(\left((\beta\,\textrm{tanh}(\beta x)-\alpha)e^{\alpha z}p_+(z)-(\beta\,\textrm{tanh}(\beta z)-\alpha)e^{-\alpha z}p_-(z)\right)-\left(e^{\alpha z}p_+'(z)+e^{-\alpha z}p_-'(z)\right)\right)}{(1-\tanh(\beta z))e^{\alpha z}p_+(z)+(1+\tanh(\beta z))e^{-\alpha z}p_-(z)}\\+(m+A_{\textrm{per}})^2-\lambda_0.
$$

Using the value $\beta = 1$, we can write the localized part of the potential as

$$
\frac{v''_{*}(z)}{v(z)} - (m + A_{\text{per}}(z))^{2} + \lambda_{0} = S(z)
$$

=
$$
\frac{2 \operatorname{sech}^{2}(z) \left((f_{+}(z) + f_{-}(z) - (\alpha e^{\alpha z} p_{+}(z) + e^{\alpha z} p'_{+}(z) - \alpha e^{-\alpha z} p_{-}(z) + e^{-\alpha z} p'_{-}(z)) - 2v(z) \right)}{2v(z)}.
$$

But $f_{\pm}(z) = \pm \alpha e^{\pm \alpha z} p_{\pm}(z) + e^{\pm \alpha z} p'_{\pm}(z)$, and so we obtain

$$
S(z) = \frac{2 \operatorname{sech}^2(z) \left((f_+(z) + f_-(z) - f_+'(z) - f_-'(z) - 2v(z) \right)}{2v(z)}.
$$

Note additionally that

$$
|S(z)| \le Ce^{-(2-\alpha)|z|} \quad \text{ for all } z \in \mathbb{R},
$$

and so clearly $S(z)\rightarrow 0$ as $|z|\rightarrow \infty$ exponentially as $\alpha < 2.$

Then it follows that

$$
(m + A_0(z))^2 = \frac{v''_*(z)}{v(z)} + \lambda_0 = (m + A_{\text{per}}(z))^2 + S(z),
$$

as illustrated in Figure [3.](#page-16-4)

FIGURE 3. Potential of ℓ_m with the desired properties.

Finally, solving for A_0 , we get that

$$
A_0(z) = -m + \sqrt{(m + A_{\text{per}}(z))^2 + S(z)},
$$

with A_0 plotted numerically in Figure [4.](#page-16-5)

FIGURE 4. Magnetic potential of the operator having $\lambda_0 = 0.5$ as an embedded eigenvalue.
