# MONOTONICITY OF THE ULTRAFILTER NUMBER FUNCTION

## TOSHIMICHI USUBA

ABSTRACT. We investigate whether the ultrafilter number function  $\kappa \mapsto \mathfrak{u}(\kappa)$  on the cardinals is monotone, that is,  $\mathfrak{u}(\lambda) \leq \mathfrak{u}(\kappa)$  holds for all cardinals  $\lambda < \kappa$  or not. We show that monotonicity can fail, but the failure has a large cardinal strength. On the other hand, we prove that there are many limitations of the failure of monotonicity. For instance, if  $\kappa$  is a singular cardinal with countable cofinality or a strong limit singular cardinal, then  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$  holds.

## 1. Introduction

For a cardinal  $\kappa$ , let  $\mathfrak{u}(\kappa)$  denote the ultrafilter number at  $\kappa$ , that is, the minimal cardinality of a base of a uniform ultrafilter over  $\kappa$ . A central research on the ultrafilter number is comparison between  $\mathfrak{u}(\kappa)$  and other cardinal invariants at  $\kappa$ : A typical one is, whether  $\mathfrak{u}(\kappa) < 2^{\kappa}$  is consistent or not. In this context, the ultrafilter number at  $\omega$  is studied extensively, and recently the ultrafilter number at singular cardinals is actively researched (e.g., [3], [6], [7], [8], [9], [10]). In contrast, little is known about the ultrafilter number at successor cardinals. While it is still open if  $\mathfrak{u}(\omega_1) < 2^{\omega_1}$  is consistent or not, Raghavan and Shelah [14] proved the consistency of  $\mathfrak{u}(\omega_{\omega+1}) < 2^{\omega_{\omega+1}}$  under some large cardinal assumption. However it is unknown if this large cardinal assumption is necessary or not.

This paper also investigates the ultrafilter number, but does not aim to study comparison between  $\mathfrak{u}(\kappa)$  and other cardinal invariants at  $\kappa$ . Instead, we identify the ultrafilter numbers as the function  $\kappa \mapsto \mathfrak{u}(\kappa)$  on the cardinals, and we shall consider a behavior of the ultrafilter number function. Under GCH, the ultrafilter number  $\mathfrak{u}(\kappa)$  is just  $2^{\kappa} = \kappa^{+}$ , hence the ultrafilter number function is just the continuum function  $\kappa \mapsto 2^{\kappa}$ , in particular it is strictly increasing. On the other hand, it is easy to construct a model in which the ultrafilter number function is not strictly increasing: Assuming GCH, just add  $\omega_2$  many Cohen real. Then  $\mathfrak{u}(\omega) = \mathfrak{u}(\omega_1) = \omega_2$  holds in the generic extension (e.g., see Lemma 4.1). Under this viewpoint, a natural question arises. This is a main topic of this paper.

**Question 1.1.** Is the ultrafilter number function *monotone*? That is, for every cardinals  $\lambda < \kappa$ , does  $\mathfrak{u}(\lambda) \leq \mathfrak{u}(\kappa)$  always hold?

For some cardinal invariant, it is easy to show that monotonicity of that cardinal invariant can fail: For the dominating number  $\mathfrak{d}(\kappa)$ , suppose GCH and add  $\omega_3$  many Cohen reals. Then  $\mathfrak{d}(\omega) = \omega_3 > \omega_2 = \mathfrak{d}(\omega_1)$  holds in

the generic extension. However, this naive approach does not work for the ultrafilter numbers; In the generic extension, we have  $\mathfrak{u}(\omega) = \mathfrak{u}(\omega_1) = \omega_3$  (see Lemma 4.1 again).

In this paper, we prove that the failure of monotonicity is actually consistent. On the other hand, we also prove that the failure of it has a large cardinal strength. Moreover there are many ZFC-limitations of the failure of monotonicity. First, by using Raghavan and Shelah's argument, we show that monotonicity of the ultrafilter number function can fail.

- **Theorem 1.2.** (1) Suppose there is a measurable cardinal. Then, in some generic extension, there are cardinals  $\kappa$ ,  $\lambda$  such that  $\lambda < \kappa$  but  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .
  - (2) Suppose there is a supercompact cardinal. Then, in some generic extension,  $\mathfrak{u}(\omega_{\omega+1}) < \mathfrak{u}(\omega_1)$  holds.
  - (3) Suppose there is a strongly compact cardinal. Then, in some generic extension, there is a singular cardinal  $\kappa$  with cofinality  $\omega_1$  such that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ .
  - (4) Suppose there is a strongly compact cardinal. Then, in some generic extension, there is a regular cardinal  $\kappa$  such that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\omega_1)$ .

Raghavan and Shelah's argument involves indecomposable ultrafilters, but it is not clear if the use of indecomposable ultrafilters is necessary for their theorem. We see that, however, the failure of monotonicity is directly connected with indecomposability. Using this connection, we also prove that there are many limitations of the failure of monotonicity.

**Theorem 1.3.** (1)  $\mathfrak{u}(\omega) \leq \mathfrak{u}(\kappa)$  holds for every cardinal  $\kappa$ .

- (2) For cardinals  $\kappa, \lambda$ , if  $\lambda$  is regular,  $\lambda < \kappa$ , but  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ , then  $\lambda^{+\omega} < \kappa$ .
- (3) If  $\kappa$  is a singular cardinal with countable cofinality, or a strong limit singular cardinal, then  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$ .
- (4) For a singular cardinal  $\kappa$ , if  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ , then the set  $\{\lambda < \kappa \mid \lambda \text{ is regular, } \mathfrak{u}(\lambda) > \mathfrak{u}(\kappa^+)\}$  is bounded in  $\kappa$ .
- (5) If  $\square(\kappa)$  holds for a regular  $\kappa$ , then  $\mathfrak{u}(\lambda) \leq \mathfrak{u}(\kappa)$  holds for every  $\lambda < \kappa$ .

Finally we show that the failure of monotonicity has a large cardinal strength, so the large cardinal assumption in Theorem 1.2 cannot be eliminated.

**Theorem 1.4.** The following theories are equiconsistent:

- (1) ZFC+"there is a measurable cardinal".
- (2)  $\mathsf{ZFC} + \text{``there are cardinals } \kappa, \lambda \text{ such that } \lambda < \kappa \text{ but } \mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)\text{''}.$

**Theorem 1.5.** Suppose there are cardinals  $\kappa$ ,  $\lambda$  such that  $\lambda \leq \kappa$  but  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\lambda)$ . Then there is an inner models of a proper class of strong cardinals.

## 2. Preliminaries

Throughout this paper, a *filter* means a non-principal proper filter over a non-empty set. A filter  $\mathcal{F}$  over a set S is *uniform* if |X| = |S| for every  $X \in \mathcal{F}$ . For an ultrafilter  $\mathcal{U}$  over a set S, a subfamily  $\mathcal{G} \subseteq \mathcal{U}$  is a *base* for  $\mathcal{U}$  if for every  $Y \in \mathcal{U}$  there is  $X \in \mathcal{G}$  with  $X \subseteq Y$ . Let  $\chi(\mathcal{U}) = \min\{|\mathcal{G}| \mid \mathcal{G} \subseteq \mathcal{U}\}$ 

is a base}.  $\chi(\mathcal{U})$  is called the *character* of  $\mathcal{U}$ . Let  $\mathfrak{u}(\kappa)$  be the cardinal  $\min\{\chi(\mathcal{U}) \mid \mathcal{U} \text{ is a uniform ultrafilter over } \kappa\}$ , it is called the *ultrafilter number at*  $\kappa$ . It is clear that  $\mathfrak{u}(\kappa) \leq 2^{\kappa}$ .

Fact 2.1 (Garti and Shelah [6]).  $\mathfrak{u}(\kappa) \geq \kappa^+$  and  $\mathrm{cf}(\mathfrak{u}(\kappa)) > \omega$ .

Let  $\lambda$  be a cardinal. A filter  $\mathcal{F}$  over a set S is said to be  $\lambda$ -decomposable if there is a family  $\{A_{\alpha} \mid \alpha < \lambda\}$  such that  $\bigcup_{\alpha < \lambda} A_{\alpha} = S$  and  $\bigcup_{\alpha \in X} A_{\alpha} \notin \mathcal{F}$  for every  $X \in [\lambda]^{<\lambda}$ .  $\mathcal{F}$  is  $\lambda$ -indecomposable if it is not  $\lambda$ -decomposable. The following lemmas can be verified easily:

**Lemma 2.2.** For a filter  $\mathcal{F}$  over a set S and a cardinal  $\lambda$ , the following are equivalent:

- (1)  $\mathcal{F}$  is  $\lambda$ -decomposable.
- (2) There is  $f: S \to \lambda$  such that for every  $X \subseteq \lambda$  with size  $< \lambda$ , we have  $f^{-1}(X) \notin \mathcal{F}$ .

**Lemma 2.3.** If  $\mathcal{F}$  is a  $\lambda$ -indecomposable filter, then every filter extending  $\mathcal{F}$  is  $\lambda$ -indecomposable.

It is known that the existence of an indecomposable uniform ultrafilter is a large cardinal property.

**Fact 2.4** (Prikry and Silver [13]). Let  $\lambda < \kappa$  be regular cardinals. If  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter, then every stationary subset of  $\{\alpha < \kappa \mid \operatorname{cf}(\alpha) = \lambda\}$  is reflecting, that is, for every stationary  $S \subseteq \{\alpha < \kappa \mid \operatorname{cf}(\alpha) = \lambda\}$ , there is  $\beta < \kappa$  such that  $S \cap \beta$  is stationary in  $\beta$ .

If  $\kappa$  is regular, then the set  $\{\alpha < \kappa^+ \mid \mathrm{cf}(\alpha) = \kappa\}$  is a non-reflecting stationary set. By this observation, we have:

**Lemma 2.5.** If  $\kappa$  is regular, then every uniform ultrafilter over  $\kappa^+$  is  $\kappa$ -decomposable.

If  $\delta$  is a cardinal, then every  $\delta^+$ -complete ultrafilter is  $\delta$ -indecomposable, and an ultrafilter is  $\sigma$ -complete if and only if it is  $\omega$ -indecomposable.

Non-large cardinal can have an indecomposable ultrafilter.

Fact 2.6 (Ben-David and Magidor [2]). Suppose GCH and there is a supercompact cardinal. Then there is a forcing extension in which GCH holds and  $\omega_{\omega+1}$  has a uniform ultrafilter  $\mathcal{U}$  such that  $\mathcal{U}$  is  $\omega_n$ -indecomposable for every  $0 < n < \omega$ .

Let  $\mu$ ,  $\nu$  be cardinals. An ultrafilter  $\mathcal{U}$  over a set S is  $(\mu, \nu)$ -regular if there is a family  $\mathcal{F} \subseteq \mathcal{U}$  of size  $\nu$  such that for every  $\mathcal{F}' \in [\mathcal{F}]^{\mu}$ , we have  $\bigcap \mathcal{F}' = \emptyset$ . It is easy to check that an ultrafilter  $\mathcal{U}$  over S is  $(\mu, \nu)$ -regular if and only if there is a family  $\{x_s \mid s \in S\}$  such that  $x_s \in [\nu]^{<\mu}$ , and for every  $i < \nu$ , the set  $\{s \in S \mid i \in x_s\}$  is in  $\mathcal{U}$ .

The following lemma might be folklore:

**Lemma 2.7.** Every  $\nu$ -indecomposable ultrafilter is not  $(\omega, \nu)$ -regular.

*Proof.* For a given  $\{x_s \mid s \in S\}$  with  $x_s \in [\nu]^{<\omega}$ , suppose  $\{s \in S \mid \beta \in x_s\} \in \mathcal{U}$  for every  $\beta < \nu$ . Because  $\nu^{<\omega} = \nu$  and  $\mathcal{U}$  is  $\nu$ -indecomposable, we can find  $A \subseteq [\nu]^{<\omega}$  such that  $|A| < \nu$  and  $\{s \in S \mid x_s \in A\} \in \mathcal{U}$ . We have  $|\bigcup A| < \nu$ , hence there is  $\beta \in \nu \setminus \bigcup A$ . But then  $\{s \in S \mid \beta \notin x_s\} \in \mathcal{U}$ , this is a contradiction.

Let  $\mathcal{U}$  be an ultrafilter over a set S. For a set T and  $f: S \to T$ , let  $f_*(\mathcal{U}) = \{X \subseteq T \mid f^{-1}(X) \in \mathcal{U}\}$ .  $f_*(\mathcal{U})$  is an ultrafilter (possibly principal) over T. It is easy to check that if  $\mathcal{U}$  is  $\lambda$ -indecomposable, then so is  $f_*(\mathcal{U})$ . The next lemma can be verified easily.

**Lemma 2.8.** An ultrafilter  $\mathcal{U}$  over S is  $\lambda$ -decomposable if and only if there is a function  $f: S \to \lambda$  such that  $f_*(\mathcal{U})$  is a uniform ultrafilter over  $\lambda$ .

For a regular cardinal  $\kappa$  and a non-empty set X, let  $Add(\kappa, X)$  be the poset of all partial functions  $p: \kappa \times X \to 2$  with size  $< \kappa$ . The order is given by the reverse inclusion. The poset  $Add(\kappa, X)$  is  $\kappa$ -closed, satisfies the  $(2^{<\kappa})^+$ -c.c., and adds X-many new subsets of  $\kappa$ . For  $Y \subseteq X$ , we will identify  $Add(\kappa, Y)$  as a complete suborder of  $Add(\kappa, X)$ .

## 3. Raghavan and Shelah's Theorem

In this section we give a slightly general form of Raghavan and Shelah's theorem with relatively simple proof. Using this theorem, we will show the consistency of the failure of monotonicity of the ultrafilter number function in the next section.

**Theorem 3.1** (Raghavan and Shelah [14]). Let  $\kappa$  and  $\mu$  be uncountable cardinals such that:

- (1)  $cf(\mu) < \kappa < \mu$ .
- (2)  $\nu^{\kappa} < \mu$  for every  $\nu < \mu$ .
- (3)  $\kappa$  has a cf( $\mu$ )-indecomposable uniform ultrafilter  $\mathcal{U}$ .

Let  $\mathbb{P}$  be a poset such that  $\mathbb{P}$  has the  $cf(\mu)$ -c.c. and  $|\mathbb{P}| \leq \mu$ . Then  $\mathbb{P}$  forces that  $\mathfrak{u}(\kappa) \leq \mu$ .

*Proof.* We may assume that  $|\mathbb{P}| = \mu$ , otherwise the assertion is trivial. Fix an enumeration  $\{p_i \mid i < \mu\}$  of  $\mathbb{P}$ . For  $\gamma < \mu$ , let us say that a  $\mathbb{P}$ -name  $\dot{A}$  is a  $\gamma$ -nice name if  $\dot{A}$  is of the form  $\bigcup_{\alpha < \kappa} (\{\check{\alpha}\} \times I_{\alpha})$ , where each  $I_{\alpha}$  is an antichain in  $\mathbb{P}$  and  $I_{\alpha} \subseteq \{p_i \mid i < \gamma\}$   $(I_{\alpha} = \emptyset)$  is possible.

Claim 3.2. For every  $\mathbb{P}$ -name  $\dot{B}$  with  $\Vdash \dot{B} \subseteq \check{\kappa}$ , there is  $D \in \mathcal{U}$ ,  $\gamma < \mu$ , and a  $\gamma$ -nice name  $\dot{A}$  such that  $\Vdash \dot{B} \cap \check{D} = \dot{A}$ .

*Proof.* For each  $\alpha < \kappa$ , take a maximal antichain  $J_{\alpha}$  in  $\mathbb{P}$  such that each  $p \in J_{\alpha}$  decides the statement  $\check{\alpha} \in \dot{B}$ . Since  $\mathbb{P}$  has the cf( $\mu$ )-c.c., there is  $\gamma_{\alpha} < \mu$  such that  $J_{\alpha} \subseteq \{p_i \mid i < \gamma_{\alpha}\}$ .  $\mathcal{U}$  is cf( $\mu$ )-indecomposable, hence we can find  $\gamma < \mu$  such that  $D = \{\alpha < \kappa \mid \gamma_{\alpha} \leq \gamma\} \in \mathcal{U}$ . Let  $\dot{A} = \{\langle \check{\alpha}, p \rangle \mid \alpha \in D, p \in J_{\alpha}, p \Vdash \check{\alpha} \in \dot{B}\}$ . Clearly  $\dot{A}$  is a  $\gamma$ -nice name and  $\Vdash \dot{A} \subseteq \check{D}$ . We shall show that  $\Vdash \dot{B} \cap \check{D} = \dot{A}$ .

Fix  $q \in \mathbb{P}$  and  $\alpha < \kappa$ , and first suppose  $q \Vdash \check{\alpha} \in \dot{A}$ . We have  $\alpha \in D$  by the definition of  $\dot{A}$ . Pick  $p \in J_{\alpha}$  which is compatible with q. Take  $r \leq p, q$ . Since  $r \Vdash \check{\alpha} \in \dot{A}$ , there is some  $\langle \check{\alpha}, p' \rangle \in \dot{A}$  such that p' is compatible with r. Since  $p, p' \in J_{\alpha}$  and  $J_{\alpha}$  is an antichain, we have p = p'. Hence  $p \Vdash \check{\alpha} \in \dot{B}$ , and  $r \Vdash \alpha \in \dot{B} \cap \check{D}$ .

For the converse, suppose  $q \Vdash \check{\alpha} \in \dot{B} \cap \check{D}$ . Again, pick  $p \in J_{\alpha}$  which is compatible with q. Take  $r \leq p, q$ . We have  $p \Vdash \check{\alpha} \in \dot{B}$ , hence  $\langle \check{\alpha}, p \rangle \in \dot{A}$ , and  $p \Vdash \check{\alpha} \in \dot{A}$ . Thus  $r \Vdash \check{\alpha} \in \dot{A}$ .

Let  $\mathcal{N} = \{\dot{A} \mid \dot{A} \text{ is a } \gamma\text{-nice name for some } \gamma < \mu\}$ . Since  $\mathbb{P}$  has the cf( $\mu$ )-c.c.,  $|\{p_i \mid i < \gamma\}| < \mu$  for  $\gamma < \mu$ , and  $\nu^{\kappa} < \mu$  for every  $\nu < \mu$ , we have  $|\mathcal{N}| \leq \mu$ .

Take a  $(V, \mathbb{P})$ -generic G. In V[G], take a uniform ultrafilter  $\mathcal{V}$  over  $\kappa$  extending  $\mathcal{U}$ . Let  $\mathcal{G} = \{\dot{A}_G \in \mathcal{V} \mid \dot{A} \in \mathcal{N}\}$ . We have  $|\mathcal{G}| \leq \mu$  and  $\mathcal{G} \subseteq \mathcal{V}$ . We prove that for every  $B \in \mathcal{V}$ , there is some  $A \in \mathcal{G}$  with  $A \subseteq B$ . This completes our proof.

Fix  $B \in \mathcal{V}$ , and take a  $\mathbb{P}$ -name  $\dot{B}$  for B. We may assume that  $\Vdash \dot{B} \subseteq \check{\kappa}$  in V. By the claim, there is  $\dot{A} \in \mathcal{N}$  and  $D \in \mathcal{U}$  such that  $\Vdash \dot{B} \cap \check{D} = \dot{A}$ . Since  $\mathcal{U} \subseteq \mathcal{V}$ , we have  $\dot{A}_G = B \cap D \in \mathcal{V}$  and  $\dot{A}_G \in \mathcal{G}$ .

**Theorem 3.3** ([14]). Let  $\kappa$  be a measurable cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with  $\omega_1 \leq \mathrm{cf}(\mu) < \kappa$ . Then  $\mathrm{Add}(\omega, \mu)$  forces that  $\mathfrak{u}(\kappa) < 2^{\kappa}$ .

*Proof.* Note that  $|\operatorname{Add}(\omega,\mu)| = \mu$  and every  $\kappa$ -complete ultrafilter over  $\kappa$  is  $\operatorname{cf}(\mu)$ -indecomposable. Hence, in the generic extension, we have  $\mathfrak{u}(\kappa) \leq \mu = 2^{\omega} \leq 2^{\kappa}$  by Theorem 3.1, and we know  $\mu < 2^{\kappa}$  since  $\operatorname{cf}(\mu) < \kappa$ .

**Theorem 3.4** ([14]). Suppose the continuum hypothesis. Let  $\kappa$  be a measurable cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with  $\omega_2 \leq \mathrm{cf}(\mu) < \kappa$ . Then  $\mathrm{Add}(\omega, \kappa) \times \mathrm{Add}(\omega_1, \mu)$  forces that  $\kappa = 2^{\omega}$  and  $\mathfrak{u}(\kappa) < 2^{\kappa}$ .

*Proof.* We know that the cardinality of  $Add(\omega, \kappa) \times Add(\omega_1, \mu)$  is just  $\mu$ , and has the  $\omega_2$ -c.c. By the standard argument,  $Add(\omega, \kappa) \times Add(\omega_1, \mu)$  forces that  $\kappa = 2^{\omega}$  and  $2^{\kappa} > 2^{\omega_1} = \mu$ . By Proposition 3.1, we have  $\mathfrak{u}(\kappa) \leq \mu < 2^{\kappa}$  in the generic extension.

The same argument together with Fact 2.6 proves:

**Theorem 3.5** ([14]). Suppose there is a supercompact cardinal. Then there is a forcing extension in which  $\mathfrak{u}(\omega_{\omega+1}) < 2^{\omega_{\omega+1}}$  holds.

**Theorem 3.6.** Let  $\kappa$  be a measurable cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with  $\omega_1 \leq \operatorname{cf}(\mu) < \kappa$ . Let  $\mathcal{U}$  be a normal measure over  $\kappa$ , and  $\mathbb{P}_{\mathcal{U}}$  the Prikry forcing associated with  $\mathcal{U}$ . Then  $\mathbb{P}_{\mathcal{U}} \times \operatorname{Add}(\omega, \mu)$  forces that  $\operatorname{cf}(\kappa) = \omega$  and  $\mathfrak{u}(\kappa) < 2^{\kappa}$ .

*Proof.* In the Prikry forcing extension  $V^{\mathbb{P}u}$ , it is known that  $\mathcal{U}$  generates an  $\nu$ -indecomposable uniform ultrafilter for every regular uncountable  $\nu < \kappa$  (e.g., see Kanamori [12]). Hence, the forcing with  $\mathrm{Add}(\omega,\mu)$  over  $V^{\mathbb{P}u}$  forces that  $\kappa$  is singular with countable cofinality and  $\mathfrak{u}(\kappa) \leq \mu$  by Proposition 3.1. Moreover  $\mu < 2^{\kappa}$  since  $\mathrm{cf}(\mu) < \kappa$ .

## 4. Models with the failure of monotonicity 1

In this section we construct models in which monotonicity of the ultrafilter number function fails. For this sake, we need the following lemmas.

The next lemma might be a kind of folklore.

**Lemma 4.1.** Let  $\kappa$  be a cardinal,  $\mu > \kappa$  a cardinal, and  $\delta \leq \kappa$  a regular cardinal. If  $Add(\delta, \mu)$  has the  $\kappa'$ -c.c. for some  $\kappa' < \mu$  and preserves  $\kappa$ , then it forces  $\mathfrak{u}(\kappa) \geq \mu$ .

Proof. Suppose not. Take an  $\operatorname{Add}(\delta,\mu)$ -name  $\dot{\mathcal{U}}$  for a uniform ultrafilter over  $\kappa$  with character  $\nu<\mu$ , and  $\operatorname{Add}(\omega,\mu)$ -names  $\{\dot{A}_{\alpha}\mid\alpha<\nu\}$  of a base for  $\mathcal{U}$ . Fix a sufficiently large regular cardinal  $\theta$ , and take  $M\prec H_{\theta}$  such that  $\nu+\kappa\subseteq M$  and  $|M|<\mu$ . By the  $\kappa'$ -c.c. of  $\operatorname{Add}(\delta,\mu)$ , we may assume that for every  $\alpha<\nu$ ,  $\dot{A}_{\alpha}$  is an  $\operatorname{Add}(\delta,M\cap\mu)$ -name. Take a  $(V,\operatorname{Add}(\delta,\mu))$ -generic G, and let  $H=G\cap\operatorname{Add}(\delta,M\cap\mu)$ , which is  $(V,\operatorname{Add}(\delta,M\cap\mu))$ -generic. We know  $(\dot{A}_{\alpha})_G=(\dot{A}_{\alpha})_H$ , hence  $(\dot{A}_{\alpha})_G\in V[H]$ . By the standard genericity argument, the forcing  $\operatorname{Add}(\delta,\mu\setminus M)$  over V[H] adds a new set  $B\in[\kappa]^{\kappa}$  such that  $(\dot{A}_{\alpha})_G\nsubseteq B$  and  $(\dot{A}_{\alpha})_G\nsubseteq \kappa\setminus B$  for every  $\alpha<\nu$ , this contradicts to that  $\{(\dot{A}_{\alpha})_G\mid\alpha<\nu\}$  is a base for  $\mathcal{U}$ .

**Lemma 4.2.** Let  $\kappa$  be a cardinal,  $\mu > \kappa$  a cardinal with  $\operatorname{cf}(\mu) = \operatorname{cf}(\kappa)$ , and  $\delta < \kappa$  a regular cardinal. If  $\operatorname{Add}(\delta, \mu)$  satisfies the  $\kappa'$ -c.c. for some  $\kappa' < \mu$ , preserves  $\kappa$ , and  $|\operatorname{Add}(\delta, \mu)| = \mu$ , then it forces  $\mathfrak{u}(\kappa) \neq \mu$ .

*Proof.* Suppose not. Take an  $Add(\delta, \mu)$ -name  $\dot{\mathcal{U}}$  for a uniform ultrafilter over  $\kappa$  with character  $\mu$ , and  $Add(\delta, \mu)$ -names  $\{\dot{A}_{\alpha} \mid \alpha < \mu\}$  of a base for  $\mathcal{U}$ .

Fix a sufficiently large regular cardinal  $\theta$ . Since  $\operatorname{cf}(\mu) = \operatorname{cf}(\kappa)$ , we can take a sequence  $\langle M_i \mid i < \kappa \rangle$  such that:

- (1)  $M_i \prec H_\theta$  and  $M_i$  contains all relevant objects.
- (2)  $M_i \subseteq M_j$  for  $i < j < \kappa$ .
- (3)  $\kappa \subseteq M_i$ .
- (4)  $|M_i| < \mu$ .
- (5)  $\mu \subseteq \bigcup_{i < \kappa} M_i$ .

For  $i < \kappa$ , since  $Add(\delta, \mu)$  has the  $\kappa'$ -c.c., we may assume that for every  $\alpha \in M_i \cap \mu$ ,  $\dot{A}_{\alpha}$  is an  $Add(\delta, M_i \cap \mu)$ -name. Fix a partition  $\{C_i \mid i < \kappa\}$  of  $\kappa$  with  $|C_i| = \delta$ . Fix also a bijection  $\pi_i : \delta \to C_i$ . Take a sequence  $\langle \beta_i \mid i < \kappa \rangle$  in  $\mu$  such that  $\beta_i \notin M_i \cap \mu$  for  $i < \kappa$ .

Now take a  $(V, \operatorname{Add}(\delta, \mu))$ -generic G, and for  $\gamma < \mu$ , let  $r_{\gamma}$  be the  $\gamma$ -th generic subset of  $\delta$  induced by G. Since  $\beta_i \notin M_i$ , we know that  $r_{\beta_i}$  is  $V[G \cap \operatorname{Add}(\delta, M_i \cap \mu)]$ -generic, hence we have that  $s_i = \pi_i \text{``} r_{\beta_i}$  has cardinality  $\delta$ . Let  $B = \bigcup_{i < \kappa} s_i$ . We know  $B \in [\kappa]^{\kappa}$ . We prove that  $(\dot{A}_{\alpha})_G \nsubseteq B$  for  $\alpha < \mu$ . Fix  $\alpha < \mu$ , and take a condition  $p \in G$ . Pick a large  $i < \kappa$  such that  $\alpha, p \in M_i$ . Let  $H = G \cap \operatorname{Add}(\delta, M_i \cap \mu)$ . We know  $(\dot{A}_{\alpha})_G = (\dot{A}_{\alpha})_H$ , hence  $(\dot{A}_{\alpha})_G \in V[H]$ . Since  $\bigcup_{j \leq i} C_j$  has cardinality  $< \kappa$  but  $(\dot{A}_{\alpha})_G$  has  $\kappa$ , we can take k > i and  $\xi \in (\dot{A}_{\alpha})_G \cap C_k$ . By the definition of  $s_k$ , there is a condition  $q \in \operatorname{Add}(\delta, \mu \setminus M_i)$  such that, in V[H], q forces that  $\xi \notin \dot{s}_k$ , where  $\dot{s}_k$  is a canonical name for  $s_k$ . Thus, in V, there is some  $p' \leq p$  in  $\operatorname{Add}(\delta, \mu)$  such that  $p' \Vdash \dot{A}_{\alpha} \nsubseteq \dot{B}$ , where  $\dot{B}$  is a canonical name for B. A similar argument shows that  $(\dot{A}_{\alpha})_G \nsubseteq \kappa \setminus B$  for  $\alpha < \mu$ . These means that  $B, \kappa \setminus B \notin (\dot{\mathcal{U}})_G$ , this is a contradiction.

**Note 4.3.** We does not need this lemma if  $cf(\mathfrak{u}(\kappa)) \neq cf(\kappa)$  is provable from ZFC, and it is an open problem asked in [6].

We are ready to show that monotonicity of the ultrafilter number function can fail.

**Proposition 4.4.** Let  $\kappa$  be a cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with  $\omega_1 \leq \operatorname{cf}(\mu) < \kappa$ . Let  $\lambda < \kappa$  be a cardinal with  $\operatorname{cf}(\lambda) = \operatorname{cf}(\mu)$ . If

 $\kappa$  has a cf( $\lambda$ )-indecomposable uniform ultrafilter, then Add( $\omega$ ,  $\mu$ ) forces that  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .

*Proof.* In the generic extension, we know  $\mathfrak{u}(\kappa) \leq \mu \leq \mathfrak{u}(\lambda)$  by Theorem 3.1 and Lemma 4.1. By Lemma 4.2, we have  $\mu \neq \mathfrak{u}(\lambda)$ , so  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .

The following theorems are typical applications of this proposition:

**Theorem 4.5.** If  $\kappa$  is measurable and  $\mu > \kappa$  is a strong limit singular cardinal with cofinality  $\omega_1$ , then  $Add(\omega, \mu)$  forces  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_1)$ .

We note that  $\omega_1$  can be replaced by any cardinal  $< \kappa$  with uncountable cofinality.

**Theorem 4.6.** Suppose  $\kappa$  is measurable and  $\mathcal{U}$  a normal measure over  $\kappa$ . Let  $\mathbb{P}_{\mathcal{U}}$  be the Prikry forcing associated with  $\mathcal{U}$ . Let  $\mu > \kappa$  be a strong limit singular cardinal with cofinality  $\omega_1$ . Then  $\mathbb{P}_{\mathcal{U}} \times \operatorname{Add}(\omega, \mu)$  forces that  $\kappa$  is a singular cardinal with countable cofinality and  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_1)$ .

By using Fact 2.6 we have:

**Theorem 4.7.** Relative to a certain large cardinal assumption, it is consistent that  $\mathfrak{u}(\omega_{\omega+1}) < \mathfrak{u}(\omega_1)$ .

If  $\kappa$  is strongly compact, then every regular cardinal  $\lambda \geq \kappa$  has a  $\kappa$ -complete uniform ultrafilter. By this fact, we have:

**Theorem 4.8.** Suppose  $\kappa$  is strongly compact. Let  $\mu > \kappa^{+\omega_1}$  be a strong limit singular cardinal with  $\operatorname{cf}(\mu) = \omega_1$ . Then  $\operatorname{Add}(\omega, \mu)$  forces that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\omega_1)$  and  $\mathfrak{u}(\kappa^{+\omega_1+1}) < \mathfrak{u}(\kappa^{+\omega_1})$ .

## 5. Easy ZFC-results

In this section we shall establish some easy but useful observations about the ultrafilter number function.

The following lemmas will be used frequently.

**Lemma 5.1.** Let  $\lambda < \kappa$  be cardinals, and  $\mathcal{U}$  a  $\lambda$ -decomposable ultrafilter over  $\kappa$ . Then  $\mathfrak{u}(\lambda) \leq \chi(\mathcal{U})$ .

Proof. Since  $\mathcal{U}$  is  $\lambda$ -decomposable, there is  $f: \kappa \to \lambda$  such that  $f_*(\mathcal{U})$  is a uniform ultrafilter over  $\lambda$ . If  $\mathcal{G}$  is a base for  $\mathcal{U}$ , then  $\{f^*A \mid A \in \mathcal{G}\}$  generates  $f_*(\mathcal{U})$ ; For  $A \in \mathcal{G}$ , since  $A \subseteq f^{-1}(f^*A)$ , we have  $f^*A \in f_*(\mathcal{U})$ . For the converse, if  $X \in f_*(\mathcal{U})$ , pick  $A \in \mathcal{G}$  with  $A \subseteq f^{-1}(X)$ . Then  $f^*A \subseteq X$ . These show that  $\{f^*A \mid A \in \mathcal{G}\}$  generates  $f_*(\mathcal{U})$ .  $\square$ 

**Lemma 5.2.** Let  $\lambda < \kappa$  be cardinals with  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ . Then every uniform ultrafilter  $\mathcal{U}$  over  $\kappa$  with  $\chi(\mathcal{U}) = \mathfrak{u}(\kappa)$  is  $\lambda$ -indecomposable.

*Proof.* Take any uniform ultrafilter  $\mathcal{U}$  over  $\kappa$  with  $\chi(\mathcal{U}) = \mathfrak{u}(\kappa)$ . If it is  $\lambda$ -decomposable, then  $\mathfrak{u}(\lambda) \leq \chi(\mathcal{U}) = \mathfrak{u}(\kappa)$  by Lemma 5.1, this contradicts to the assumption.

By these observations, we can obtain some limitations of the failure of monotonicity.

**Proposition 5.3.**  $\mathfrak{u}(\omega) \leq \mathfrak{u}(\kappa)$  for every cardinal  $\kappa$ .

*Proof.* If not, then  $\kappa$  has an  $\omega$ -indecomposable uniform ultrafilter  $\mathcal{U}$  by Lemma 5.2. Then  $\mathcal{U}$  is in fact  $\sigma$ -complete, so there is a measurable cardinal  $\lambda \leq \kappa$ . Hence we have  $\mathfrak{u}(\omega) \leq 2^{\omega} < \lambda \leq \kappa \leq \mathfrak{u}(\kappa)$ , this is a contradiction.  $\square$ 

**Proposition 5.4.** (1) If  $\kappa$  is regular, then  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$ .

- (2) If  $\lambda$  is regular,  $\kappa > \lambda$  a cardinal, and  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ , then  $\lambda^{+\omega} \leq \kappa$ .
- *Proof.* (1). If  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ , then  $\kappa^+$  has a  $\kappa$ -indecomposable uniform ultrafilter, but this is impossible by Lemma 2.5.
  - (2). By (1), we have  $\mathfrak{u}(\lambda) \leq \mathfrak{u}(\lambda^+) \leq \mathfrak{u}(\lambda^{++}) \leq \cdots$ , hence  $\lambda^{+\omega} \leq \kappa$ .

We will prove that  $\mathfrak{u}(\omega_{\omega}) < \mathfrak{u}(\omega_1)$  is consistent (Corollary 7.7). In this sense,  $\lambda^{+\omega} \leq \kappa$  in (2) of this corollary cannot be strengthened to  $\lambda^{+\omega+1} \leq \kappa$ . If  $\kappa$  is singular, every uniform ultrafilter over  $\kappa$  is  $\mathrm{cf}(\kappa)$ -indecomposable.

Corollary 5.5. If  $\kappa$  is singular, then  $\mathfrak{u}(\mathrm{cf}(\kappa)) \leq \mathfrak{u}(\kappa)$ .

## 6. Models with the failure of monotonicity 2

In Section 4, we constructed some models with  $\lambda < \kappa$  but  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ . Our main tools were Raghavan and Shelah's theorem 3.1 and Lemmas 4.1, 4.2. However, to use these tools, it is necessary that  $\mathrm{cf}(\lambda) > \omega$ , and we cannot apply our argument to the case  $\mathrm{cf}(\lambda) = \omega$  easily. In this section, we show that it is possible that  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_{\omega})$  for some  $\kappa > \omega_{\omega}$ .

The following lemma was proved by Donder [4], but we give a proof for the reader's convenience.

**Lemma 6.1** (Donder [4]). Let  $\kappa$  be a singular cardinal with countable cofinality, and  $\langle \kappa_n \mid n < \omega \rangle$  a strictly increasing sequence of regular cardinals with limit  $\kappa$ . If  $\mathcal{U}$  is a uniform ultrafilter over  $\kappa$  such that  $\mathcal{U}$  is not  $(\omega, \lambda)$ -regular for some  $\lambda < \kappa_0$ , then there is  $f : \kappa \to \kappa$  such that  $f_*(\mathcal{U})$  is a uniform ultrafilter over  $\kappa$  and for every  $C \subseteq \kappa$ , if  $C \cap \kappa_n$  is a club in  $\kappa_n$  for every  $n < \omega$ , then  $C \in f_*(\mathcal{U})$ .

*Proof.* We recall some definition and notations. For  $f, g \in {}^{\kappa}\kappa$ , define  $f \leq g$  if  $f(\alpha) \leq g(\alpha)$  for every  $\alpha < \kappa$ , and  $f <_{\mathcal{U}} g$  if  $\{\alpha < \kappa \mid f(\alpha) < g(\alpha)\} \in \mathcal{U}$ . Let  $\mathcal{F}$  be the family of all  $f : \kappa \to \kappa$  such that:

- (1) f is monotone, that is, if  $\alpha \leq \beta$  then  $f(\alpha) \leq f(\beta)$ .
- (2)  $\sup(f "\kappa_n) = \kappa_n \text{ for every } n < \omega.$

We claim that there is  $f \in \mathcal{F}$  which is  $<_{\mathcal{U}}$ -minimal in  $\mathcal{F}$ , that is, if  $g \in \mathcal{F}$  then  $\{\alpha < \kappa \mid g(\alpha) \geq f(\alpha)\} \in \mathcal{U}$ . Such a  $<_{\mathcal{U}}$ -minimal function is a require one; This can be verified as follows. It is easy to check that  $f_*(\mathcal{U})$  is uniform. First note that for every  $g \in \mathcal{F}$ , since  $g \circ f \in \mathcal{F}$  and  $f \leq_{\mathcal{U}} g \circ f$ , if  $g \leq$  id then  $\{\alpha < \kappa \mid g(\alpha) = \alpha\} \in f_*(\mathcal{U})$  Now take  $C \subseteq \kappa$  such that  $C \cap \kappa_n$  is a club in  $\kappa_n$  for every  $n < \omega$ . Define  $g : \kappa \to \kappa$  by  $g(\alpha) = \sup(C \cap \alpha)$ . Clearly  $g \in \mathcal{F}$  and  $g \leq$  id. Hence  $X = \{\alpha < \kappa \mid g(\alpha) = \alpha\} \in f_*(\mathcal{U})$ . By the definition of g, we have  $X \subseteq (C \setminus (\min(C) + 1)) \cup \{\kappa_n \mid n < \omega\}$ . On the other hand, since  $f_*(\mathcal{U})$  is uniform, we have  $\{\kappa_n \mid n < \omega\} \notin \mathcal{U}$ , hence  $C \in f_*(\mathcal{U})$ .

We show that  $\mathcal{F}$  has a  $<_{\mathcal{U}}$ -minimal element. Suppose to the contrary that such an element does not exist. By induction on  $\xi < \lambda$ , we take  $f_{\xi} \in \mathcal{F}$  so that:

- (a)  $f_{\xi+1} <_{\mathcal{U}} f_{\xi}$ .
- (b)  $f_{\xi} \leq f_{\eta}$  whenever  $\eta < \xi < \delta$ .

For a successor step, if  $f_{\xi}$  is defined, there is  $g \in \mathcal{F}$  with  $g <_{\mathcal{U}} f_{\xi}$  by our assumption. Define  $f_{\xi+1} \in {}^{\kappa}\kappa$  by  $f_{\xi+1}(\alpha) = g(\xi)$  if  $g(\alpha) < f_{\xi}(\alpha)$ , otherwise let  $f_{\xi+1}(\alpha) = f_{\xi(\alpha)}$ . One can check that  $f_{\xi+1} \in \mathcal{F}$ ,  $f_{\xi+1} \leq f_{\xi}$ , and  $f_{\xi+1} <_{\mathcal{U}} f_{\xi}$ . For a limit  $\xi < \lambda$ , define  $f_{\xi}(\alpha) = \min\{f_{\zeta}(\alpha) \mid \zeta < \xi\}$ . It is not hard to check that  $f_{\xi} \in \mathcal{F}$  and  $f_{\xi} \leq f_{\zeta}$  for  $\zeta < \xi$ .

Finally, for  $\xi < \delta$ , let  $X_{\xi} = \{\alpha < \kappa \mid f_{\xi+1}(\alpha) < f_{\xi}(\alpha)\} \in \mathcal{U}$ . It is easy to check that  $\{X_{\xi} \mid \xi < \delta\}$  witnesses that U is  $(\omega, \lambda)$ -regular, this is a contradiction.

The following can be seen as a diagonal version of Prikry and Silver's theorem (Fact 2.4).

**Proposition 6.2.** Let  $\kappa$  be a singular cardinal with countable cofinality, and  $\lambda < \kappa$  a regular cardinal with  $\lambda^{\omega} = \lambda$ . Suppose there are sequences  $\langle \kappa_n \mid n < \omega \rangle$  and  $\langle S_n \mid n < \omega \rangle$  satisfying the following:

- (1)  $\langle \kappa_n \mid n < \omega \rangle$  is an increasing sequence of regular cardinals with limit  $\kappa$ .
- (2) For each  $n < \omega$ ,  $S_n$  is a non-reflecting stationary subset of  $\{\alpha < \kappa_n \mid cf(\alpha) = \lambda\}$ .
- (3) For every large regular cardinal  $\theta$ , the set  $\{M \in [H_{\theta}]^{\lambda} \mid {}^{\omega}M \subseteq M$ , and  $\forall n < \omega(\sup(M \cap \kappa_n) \in S_n)\}$  is stationary in  $[H_{\theta}]^{\lambda}$ .

Then there is no  $\lambda$ -indecomposable uniform ultrafilter over  $\kappa$ .

*Proof.* Fix such  $\langle \kappa_n \mid n < \omega \rangle$  and  $\langle S_n \mid n < \omega \rangle$ . We may assume that  $\lambda < \kappa_0$  and  $S_n \cap S_m = \emptyset$  whenever  $n < m < \omega$ . For each  $\beta < \kappa$ , let  $n(\beta)$  be the minimal  $n < \omega$  with  $\beta < \kappa_n$ .

For  $n < \omega$  and  $\alpha \in S_n$ , fix a club  $c_\alpha \subseteq \alpha$  with order type  $\lambda$ . Let  $\langle \xi_i^\alpha \mid i < \lambda \rangle$  be the increasing enumeration of  $c_\alpha$ . The following is well-known, e.g., see Lemma 2.12 in Eisworth [5]:

**Fact 6.3.** For every  $n < \omega$  and  $\beta < \kappa_n$ , there is a function  $F_{\beta} : S_n \cap \beta \to \lambda$  such that whenever  $\alpha_0, \alpha_1 \in S_n \cap \beta$  with  $\alpha_0 \neq \alpha_1$ , the set  $\{\xi_i^{\alpha_0} \mid F_{\beta}(\alpha_0) < i < \lambda\}$  is disjoint from  $\{\xi_i^{\alpha_1} \mid F_{\beta}(\alpha_1) < i < \lambda\}$ .

Now suppose the contrary that there is a  $\lambda$ -indecomposable uniform ultrafilter  $\mathcal{U}$  over  $\kappa$ . By Lemma 6.1, we may assume that for every  $t \in \prod_{n < \omega} \kappa_n$ , the set  $\bigcup_{n < \omega} [t(n), \kappa_n)$  is in  $\mathcal{U}$ . For  $t \in \prod_{n < \omega} S_n$ , define  $\lambda(t) < \lambda$  as follows: By the choice of  $\mathcal{U}$ , we have that  $X_t = \{\beta < \kappa \mid \beta > t(n(\beta))\} \in \mathcal{U}$ . Define  $G_t : X_t \to \lambda$  by  $G_t(\beta) = F_{\beta}(t(n(\beta)))$ . Since  $\mathcal{U}$  is  $\lambda$ -indecomposable, there is  $\lambda(t) < \lambda$  such that  $Y_t = \{\beta \in X_t \mid G_t(\beta) = F_{\beta}(t(n(\beta)) < \lambda(t)\} \in \mathcal{U}$ .

Claim 6.4. For  $t, t' \in \prod_{n < \omega} S_n$ , if  $\{n < \omega \mid t(n) \neq t(n')\}$  is cofinite, then there are infinitely many  $n < \omega$  such that  $\{\xi_i^{t(n)} \mid \lambda(t) < i < \lambda\} \cap \{\xi_i^{t'(n)} \mid \lambda(t') < i < \lambda\} = \emptyset$ .

Proof. We know  $Y_t \cap Y_{t'} \in \mathcal{U}$ . Hence for a given  $m < \omega$ , we can find  $\beta \in Y_t \cap Y_{t'}$  such that  $m < n(\beta)$ ,  $t(n(\beta)) \neq t'(n(\beta))$ , and  $t(n(\beta)), t'(n(\beta)) < \beta$ . By the choice of  $F_{\beta}$ , we have  $\{\xi_i^{t(n(\beta))} \mid F_{\beta}(t(n(\beta))) < i < \lambda\} \cap \{\xi_i^{t'(n(\beta))} \mid F_{\beta}(t'(n(\beta))) < i < \lambda\} = \emptyset$ . Because  $\beta \in Y_t \cap Y_{t'}$ , we know  $F_{\beta}(t(n(\beta))) < \lambda(t)$ 

and 
$$F_{\beta}(t'(n(\beta))) < \lambda(t')$$
. Hence  $\{\xi_i^{t(n(\beta))} \mid \lambda(t) < i < \lambda\} \cap \{\xi_i^{t'(n(\beta))} \mid \lambda(t') < i < \lambda\} = \emptyset$ .

Fix a large regular  $\theta$ . By the choice of the  $S_n$ 's, we can find  $M \in [H_{\theta}]^{\lambda}$  containing all relevant objects such that  $M \prec H_{\theta}$ ,  ${}^{\omega}M \subseteq M$ , and  $\forall n < \omega(\sup(M \cap \kappa_n) \in S_n)$ . Define  $t \in \prod_n S_n$  by  $t(n) = \sup(M \cap \kappa_n)$ . Note that  $\sup(c_{t(n)} \cap M \cap \kappa_n) = \sup(M \cap \kappa_n)$  because  $c_{t(n)}$  is a club in t(n) and  ${}^{\omega}M \subseteq M$ . For  $n < \omega$ , pick  $\xi_n \in M \cap \{\xi_i^{t(n)} \mid \lambda(t) < i < \lambda\}$ . We know  $\langle \xi_n \mid n < \omega \rangle \in M$  by the closure property of M. By the elementarity of M, there is  $t' \in M \cap \prod_n S_n$  such that  $\xi_n \in \{\xi_i^{t'(n)} \mid \lambda(t') < i < \lambda\}$  for every  $n < \omega$ . Clearly  $t(n) \neq t'(n)$  for every  $n < \omega$ , hence there is  $n < \omega$  with  $\{\xi_i^{t(n)} \mid \lambda(t) < i < \lambda\} \cap \{\xi_i^{t'(n)} \mid \lambda(t') < i < \lambda\} = \emptyset$  by Claim 6.4. However this is impossible since  $\xi_n \in \{\xi_i^{t(n)} \mid \lambda(t) < i < \lambda\} \cap \{\xi_i^{t'(n)} \mid \lambda(t') < i < \lambda\}$ .  $\square$ 

To show that the assumption of Proposition 6.2 is consistent, we use the forcing notion which adds a non-reflecting stationary subsets.

For a poset  $\mathbb{P}$  and an ordinal  $\alpha$ , let  $\Gamma_{\alpha}(\mathbb{P})$  denote the following two players game of length  $\alpha$ : At each inning, Players I and II choose conditions of  $\mathbb{P}$  alternately with  $p_0 \geq q_0 \geq p_1 \geq q_1 \geq \cdots$ , but if  $\beta < \alpha$  is limit, at the  $\beta$ -th inning, Player I does not move and only Player II choose a condition  $q_{\beta}$  which is a lower bound of the partial play  $\langle p_{\xi}, q_{\zeta} \mid \xi, \zeta < \beta, \xi = 0$  or successor $\rangle$  (if it is possible):

Player II wins if I and II could choose their moves at each inning, otherwise, I wins.

 $\mathbb{P}$  is  $\alpha$ -strategically closed if Player II has a winning strategy in the game  $\Gamma_{\alpha}(\mathbb{P})$ . If  $\kappa$  is a cardinal and  $\mathbb{P}$  is  $\kappa$ -strategically closed, then it is easy to see that  $\mathbb{P}$  is  $\kappa$ -Baire, and the forcing with  $\mathbb{P}$  does not add new  $< \kappa$ -sequences.

**Fact 6.5.** Let  $\kappa$  be a cardinal, and  $\langle \mathbb{P}_n, \dot{\mathbb{Q}}_n \mid n < \omega \rangle$  be an  $\omega$ -stage iteration such that each  $\dot{\mathbb{Q}}_n$  is forced to be  $\kappa$ -strategically closed. Then the inverse limit of the  $\mathbb{P}_n$ 's is  $\kappa$ -strategically closed.

For a regular uncountable cardinal  $\mu$  and regular  $\lambda < \mu$ , let  $\mathbb{S}_{\mu,\lambda}$  be the poset of all bounded subsets  $p \subseteq \{\alpha < \mu \mid \mathrm{cf}(\alpha) = \lambda\}$  such that p has a maximal element  $\max(p)$  and for every  $\beta \le \max(p)$ ,  $p \cap \beta$  is non-stationary in  $\beta$ . Define  $p \le q$  if p is an end-extension of q.

Let  $\mathbb{S} = \mathbb{S}_{\mu,\lambda}$ . The following is easy to check:

**Lemma 6.6.**  $|S| = 2^{<\mu}$ , so S satisfies the  $(2^{<\mu})^+$ -c.c.

The following lemma is well-known, and we only sketch the proof.

**Lemma 6.7.** (1)  $\mathbb{S}$  is  $\mu$ -strategically closed, hence the forcing with  $\mathbb{S}$  does not add new  $< \mu$ -sequences.

(2) If G is  $(V, \mathbb{S})$ -generic, then  $\bigcup G$  is a non-reflecting stationary subset of  $\{\alpha < \mu \mid \operatorname{cf}(\alpha) = \lambda\}$ .

Sketch of the proof. (1). For a limit  $\beta < \mu$  and a partial play  $\langle p_{\xi}, q_{\zeta} \mid \xi, \zeta < \beta, \xi = 0$  or successor $\rangle$ , suppose  $q = \bigcup_{\zeta < \beta} q_{\zeta}$  is non-reflecting. Let  $\gamma = \sup(q)$ . Then Player II takes  $q \cup \{\gamma + \lambda\}$  as his move. This is a winning strategy of Player II.

(2). Non-reflectingness is immediate from the definition of  $\mathbb{S}$ . To show that  $\bigcup G$  is stationary, take a name  $\dot{C}$  for a club in  $\mu$ . Take a descending sequence  $\langle p_i \mid i < \lambda \rangle$  such that for every  $i < \lambda$ , there is  $\alpha_i$  such that  $\alpha_i < \sup(p_i) < \alpha_{i+1}$  and  $p_{i+1} \Vdash \check{\alpha}_i \in \dot{C}$ . Let  $\alpha = \sup_i \alpha_i$ , and  $p = \bigcup_{i < \lambda} p_i \cup \{\alpha\}$ . It is easy to check that  $p \in \mathbb{S}$  and  $p \Vdash \alpha \in \dot{C} \cap \bigcup \dot{G}$ .

**Proposition 6.8.** Let  $\kappa$  be a singular cardinal with countable cofinality, and suppose GCH. Let  $\langle \kappa_n \mid n < \omega \rangle$  be a strictly increasing sequence of regular uncountable cardinals with limit  $\kappa$ , and  $\lambda$  a regular uncountable cardinal with  $\lambda < \kappa_0$ . Then there is a poset  $\mathbb P$  such that  $\mathbb P$  preserves all cardinals, and adds a sequence  $\langle S_n \subseteq \kappa_n \mid n < \omega \rangle$  satisfying the conditions of Proposition 6.2.

*Proof.* Fix such  $\langle \kappa_n \mid n < \omega \rangle$  and  $\lambda$ . Define  $\mathbb{P}_n$  and  $\dot{\mathbb{Q}}_n$  for  $n < \omega$  as follows. Let  $\mathbb{P}_0$  be the trivial poset. Suppose  $\mathbb{P}_n$  is defined. Then  $\dot{\mathbb{Q}}_n$  is a  $\mathbb{P}_n$ -name such that

$$\Vdash_{\mathbb{P}_n} \dot{\mathbb{Q}}_n = \dot{\mathbb{S}}_{\kappa_n,\lambda}.$$

Put  $\mathbb{P}_{n+1}$  as the forcing product  $\mathbb{P}_n * \dot{\mathbb{Q}}_n$ . It is routine to show that  $|\mathbb{P}_{n+1}| \leq 2^{<\kappa_n} = \kappa_n$ , so it satisfies the  $(\kappa_n)^+$ -c.c. Let  $\mathbb{P}$  be the inverse limit of the  $\mathbb{P}_n$ 's. We check that  $\mathbb{P}$  is a required poset.

By Fact 6.5, for each  $n < \omega$ ,  $\mathbb{P}$  can be factored as a forcing product  $\mathbb{P}_n * \dot{\mathbb{Q}}_n * \dot{\mathbb{P}}_{tail}$  such that  $\Vdash_{\mathbb{P}_n * \dot{\mathbb{Q}}_n}$  " $\dot{\mathbb{P}}_{tail}$  is  $\kappa_{n+1}$ -strategically closed". This factorization shows that the forcing with  $\mathbb{P}$  preserves all cofinalities.

Take a  $(V, \mathbb{P})$ -generic G, and let  $S_n$  be a generic subset of  $\kappa_n$  induced by G. By the factorization before, we have that  $S_n$  is a non-reflecting stationary subset of  $\{\alpha < \kappa_n \mid \operatorname{cf}(\alpha) = \lambda\}$  in V[G].

Finally, we see that the sequence  $\langle S_n \mid n < \omega \rangle$  satisfies the the conditions of Proposition 6.2. To do this, return to V. Let  $\theta$  be a sufficiently large regular cardinal and  $N = H_{\theta}$ . Let  $\dot{S}_n$  be a canonical name for  $S_n$ . Take a  $\mathbb{P}$ -name  $\dot{f}$  such that  $p \Vdash \dot{f} : [\check{N}]^{<\omega} \to N$ . It is enough to show that there is  $X \subseteq N$  and  $q \leq p$  such that  $|X| = \lambda \subseteq X$ ,  $[X]^{\omega} \subseteq X$ , and

$$q \Vdash \dot{f}$$
" $[\check{X}]^{<\omega} \subseteq \check{X}, \sup(\check{X} \cap \kappa_n) \in \dot{S}_n \text{ for } n < \omega.$ 

Take a large regular cardinal  $\chi > \theta$  and  $M \prec H_{\chi}$  containing all relevant objects such that  $|M| = \lambda \subseteq M$  and  $[M]^{<\lambda} \subseteq M$ . Let  $X = M \cap H_{\theta}$ . Note that  $|X| = \lambda$ ,  $[X]^{\omega} \subseteq X$ , and  $\operatorname{cf}(\sup(X \cap \kappa_n)) = \lambda$  for every  $n < \omega$ . Fix an enumeration  $\langle x_i | i < \lambda \rangle$  of all elements of X. By the  $\lambda$ -strategically closedness of  $\mathbb P$  and the closure property of M, we can take a descending sequence  $\langle q_i | i < \lambda \rangle$  in  $\mathbb P$  such that the following holds:

- (1)  $q_0 \leq p$  and  $q_i \in M$  for  $i < \lambda$ .
- (2) For  $i < \lambda$ , there is  $y_i \in X$  such that  $q_i \Vdash \dot{f}(\check{x}_i) = \check{y}_i$ .
- (3) For  $i < \lambda$  and  $n < \omega$ , there is  $\alpha \in X \cap \kappa_n$  such that  $q_{i+1} \Vdash \max(q_i(n)) = \check{\alpha}$ .

Then take a function q on  $\omega$  as follows: q(n) is a  $\mathbb{P}_n$ -name such that  $\Vdash_{\mathbb{P}_n} "q(n) = \bigcup_{i < \lambda} q_i(n) \cup \{\sup(\check{X} \cap \check{\kappa}_n)\}$ . It is straightforward to show that

q is a lower bound of the  $q_i$ 's, and  $q \Vdash \dot{f}$ " $[\check{X}]^{<\omega} \subseteq \check{X}, \sup(\check{X} \cap \kappa_n) \in \dot{S}_n$  for  $n < \omega$ .

By this proposition, if  $\kappa$  is measurable we can take a generic extension in which  $\kappa$  is measurable and there is no  $\omega_1$ -indecomposable uniform ultrafilter over  $\omega_{\omega}$ .

**Theorem 6.9.** Suppose there is no  $\omega_1$ -indecomposable uniform ultrafilter over  $\omega_{\omega}$ . Let  $\kappa$  be a measurable cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with cofinality  $\omega_1$ .

- (1) Add $(\omega, \mu)$  forces  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_{\omega})$ .
- (2) If  $\mathcal{U}$  is a normal measure over  $\kappa$  and  $\mathbb{P}_{\mathcal{U}}$  is the Prikry forcing associated with  $\mathcal{U}$ , then  $\mathbb{P}_{\mathcal{U}} \times \operatorname{Add}(\omega, \mu)$  forces that  $\kappa$  is a singular cardinal with countable cofinality and  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_{\omega})$ .
- Proof. (1). Take a  $(V, \operatorname{Add}(\omega, \mu))$ -generic G. In V[G], we have  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_1)$ . We claim that, in V[G],  $\omega_{\omega}$  does not have an  $\omega_1$ -indecomposable uniform ultrafilter. Suppose to the contrary that there is an  $\omega_1$ -indecomposable uniform ultrafilter  $\mathcal{U}$ . Let  $\dot{\mathcal{U}}$  be a name for  $\mathcal{U}$ . In V, let  $\mathcal{F} = \{X \subseteq \omega_{\omega} \mid \vdash X \in \dot{\mathcal{U}}\}$ .  $\mathcal{F}$  is a uniform filter over  $\omega_{\omega}$ , and since  $\operatorname{Add}(\omega, \mu)$  has the c.c.c. and  $\mathcal{U}$  is  $\omega_1$ -indecomposable, for every  $f: \omega_{\omega} \to \omega_1$  there is  $\gamma < \omega_1$  such that  $\{\alpha \mid f(\alpha) \leq \gamma\} \in \mathcal{F}$ . Then every ultrafilter extending  $\mathcal{F}$  is an  $\omega_1$ -indecomposable uniform ultrafilter, this is a contradiction.

Now, in V[G], every uniform ultrafilter over  $\omega_{\omega}$  is  $\omega_1$ -decomposable. By Lemma 5.2, we have that  $\mathfrak{u}(\omega_1) \leq \mathfrak{u}(\omega_{\omega})$ , hence  $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_1) \leq \mathfrak{u}(\omega_{\omega})$ .

(2) follows from a similar argument.

We also have the following theorem. We leave the proof to the reader.

**Theorem 6.10.** Suppose there is no  $\omega_1$ -indecomposable uniform ultrafilter over  $\omega_{\omega}$ . Let  $\kappa$  be a strongly compact cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with cofinality  $\omega_1$ . Then  $Add(\omega, \mu)$  forces that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\omega_{\omega})$  and  $\mathfrak{u}(\kappa^{+\omega+1}) < \mathfrak{u}(\omega_{\omega})$ .

We will show that both  $\mathfrak{u}(\kappa^{+\omega}) < \mathfrak{u}(\omega_{\omega})$  and  $\mathfrak{u}(\kappa^{+\omega_1}) < \mathfrak{u}(\omega_{\omega})$  are consistent as well. See Corollaries 7.7 and Proposition 7.18.

## 7. Monotonicity at a singular cardinal and its successor

We had seen that  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$  always holds if  $\kappa$  is regular. By Theorem 4.8, if  $\kappa$  is singular then it is possible that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ . On the other hand, we will show there are some limitation of the failure of monotonicity at singular and its successor.

We use Shelah's PCF theory. We present some definitions and basic facts. See Shelah [16], Abraham and Magidor [1], and Eisworth [5] for details.

- Fact 7.1 (Shelah). Let  $\kappa$  be a singular cardinal. Then there is an increasing sequence  $\langle \kappa_{\xi} | \xi < \operatorname{cf}(\kappa) \rangle$  of regular cardinals with limit  $\kappa$  such that  $\prod_{\xi} \kappa_{\xi}$  admits a scale  $\langle f_i | i < \kappa^+ \rangle$  of length  $\kappa^+$ , that is, the following hold:
  - (1)  $f_i \in \prod_{\varepsilon} \kappa_{\varepsilon}$ .
  - (2) For  $i < j < \kappa^+$ ,  $f_i \leq^* f_j$  holds, that is, there is  $\zeta < \operatorname{cf}(\kappa)$  with  $f_i(\xi) \leq f_j(\xi)$  for every  $\xi \geq \zeta$ .

(3) For every  $g \in \prod_{\xi} \kappa_{\xi}$ , there is  $i < \kappa^+$  with  $g \leq^* f_i$ .

We also use the following Kanamori's result.

**Fact 7.2** (Kanamori [11]). Let  $\kappa$  be a singular cardinal. Then every uniform ultrafilter over  $\kappa^+$  is  $(\kappa, \kappa^+)$ -regular.

Now we prove the following proposition, which plays a crucial role in this section.

**Proposition 7.3.** Let  $\kappa$  be a singular cardinal. Let S be a set and  $\mathcal{U}$  an ultrafilter over S. If  $\mathcal{U}$  is  $\kappa^+$ -decomposable and  $\mathrm{cf}(\kappa)$ -decomposable, then  $\mathcal{U}$  is  $\kappa$ -decomposable as well.

*Proof.* First we check that  $\mathcal{U}$  is  $(\kappa, \kappa^+)$ -regular. Since  $\mathcal{U}$  is  $\kappa^+$ -decomposable, we can find  $f: S \to \kappa^+$  such that  $f_*(\mathcal{U})$  is a uniform ultrafilter over  $\kappa^+$ . By Fact 7.2,  $f_*(\mathcal{U})$  is  $(\kappa, \kappa^+)$ -regular. Fix  $\mathcal{F} \subseteq f_*(\mathcal{U})$  which witnesses that  $f_*(\mathcal{U})$  is  $(\kappa, \kappa^+)$ -regular. Then it is easy to show that  $\{f^{-1}(X) \mid X \in \mathcal{F}\}$  also witnesses that  $\mathcal{U}$  is  $(\kappa, \kappa^+)$ -regular.

Since  $\mathcal{U}$  is  $(\kappa, \kappa^+)$ -regular, we can take a family  $\{x_s \mid s \in S\}$  such that  $|x_s| < \kappa$  and for every  $i < \kappa^+$ , we have  $\{s \in S \mid i \in x_s\} \in \mathcal{U}$ . Fix an increasing sequence  $\langle \kappa_{\xi} \mid \xi < \operatorname{cf}(\kappa) \rangle$  of regular cardinals with limit  $\kappa$  which admits a scale  $\langle f_i \mid i < \kappa^+ \rangle$ . Since  $\mathcal{U}$  is  $\operatorname{cf}(\kappa)$ -decomposable, we can find  $g: S \to \{\kappa_{\xi} \mid \xi < \operatorname{cf}(\kappa)\}$  such that for every  $\eta < \operatorname{cf}(\kappa)$ , we have  $\{s \in S \mid g(\alpha) > \kappa_{\eta}\} \in \mathcal{U}$ .

Now we define  $h: S \to \kappa$  as follows: Fix  $s \in S$ . Take  $\xi_s < \operatorname{cf}(\kappa)$  such that  $g(s) + |x_s| < \kappa_{\xi_s}$ . Then the set  $\{f_i(\xi_s) \mid i \in x_s\}$  is bounded in  $\kappa_{\xi_s}$ . So we can take  $h(s) < \kappa_{\xi_s}$  with  $h(s) > f_i(\xi_s)$  for every  $i \in x_s$ . We show that h witnesses that  $\mathcal{U}$  is  $\kappa$ -decomposable. Suppose not. Take  $X \in [\kappa]^{<\kappa}$  such that  $\{s \in S \mid h(s) \in X\} \in \mathcal{U}$ . Fix  $\zeta_0 < \operatorname{cf}(\kappa)$  with  $|X| < \kappa_{\zeta_0}$ . Then we can find  $j < \kappa^+$  and  $\zeta_1 > \zeta_0$  such that  $\sup(X \cap \kappa_{\xi}) < f_j(\xi)$  for every  $\xi$  with  $\zeta_1 \le \xi < \operatorname{cf}(\kappa)$ . Pick  $s \in S$  with  $g(s) > \kappa_{\zeta_1}$ ,  $j \in x_s$ , and  $h(s) \in X$ . Since  $g(s) > \kappa_{\zeta_1}$ , we have  $\kappa_{\xi_s} > \kappa_{\zeta_1}$ . Hence  $f_j(\xi_s) < h(s) < \kappa_{\xi_s}$ , however this is impossible since  $h(s) \le \sup(X \cap \kappa_{\xi_s}) < f_j(\xi_s)$ .

**Lemma 7.4.** Let  $\kappa$  be a cardinal, and suppose  $\kappa$  has a  $\sigma$ -complete uniform ultrafilter  $\mathcal{U}$  with  $\chi(\mathcal{U}) = \mathfrak{u}(\kappa)$ . Then there is a uniform ultrafilter  $\mathcal{V}$  over  $\kappa$  such that  $\chi(\mathcal{V}) = \mathfrak{u}(\kappa)$  and  $\mathcal{V}$  is not  $\sigma$ -complete.

*Proof.* It is sufficient to show that there is a non- $\sigma$ -complete uniform ultrafilter  $\mathcal{V}$  over  $\omega \times \kappa$  with  $\chi(\mathcal{V}) = \mathfrak{u}(\kappa)$ .

By the assumption, there is a measurable cardinal  $\leq \kappa$ . Hence we have  $2^{\omega} \leq \kappa$ . Fix a uniform ultrafilter  $\mathcal{W}$  over  $\omega$ . Define the filter  $\mathcal{V}$  over  $\omega \times \kappa$  by:  $X \in \mathcal{V} \iff$  there is  $Y \in \mathcal{W}$  and  $Z \in \mathcal{U}$  with  $Y \times Z \subseteq X$ . We have that  $\chi(\mathcal{V}) \leq \chi(\mathcal{U}) \times 2^{\omega} = \chi(\mathcal{U})$ . We can check  $\mathcal{V}$  is not  $\sigma$ -complete as follows:  $X_n = [n, \omega) \times \kappa \in \mathcal{V}$  but  $\bigcap_n X_n = \emptyset$ . We have to show that  $\mathcal{V}$  is an ultrafilter. Take  $X \subseteq \omega \times \kappa$ . Consider the set  $Y = \{n < \omega \mid \{\alpha < \kappa \mid \langle n, \alpha \rangle \in X\} \in \mathcal{U}\}$ . Case 1:  $Y \in \mathcal{W}$ . For  $n \in Y$ , take  $Z_n = \{\alpha < \kappa \mid \langle n, \alpha \rangle \in X\} \in \mathcal{U}$ . Since

Case 1:  $Y \in \mathcal{W}$ . For  $n \in Y$ , take  $Z_n = \{\alpha < \kappa \mid \langle n, \alpha \rangle \in X\} \in \mathcal{U}$ . Since  $\mathcal{U}$  is  $\sigma$ -complete, we have  $Z = \bigcap_n Z_n \in \mathcal{U}$ . Then  $Y \times Z \subseteq X$ , hence  $X \in \mathcal{V}$ . Case 2:  $Y \notin \mathcal{W}$ . Then  $Y' = \{n < \omega \mid \{\alpha < \kappa \mid \langle n, \alpha \rangle \in \kappa \setminus X\} \in \mathcal{U}\}$  is in  $\mathcal{W}$ . For  $n \in Y'$ , let  $Z'_n = \{\alpha < \kappa \mid \langle n, \alpha \rangle \in \kappa \setminus X\} \in \mathcal{U}$ , and  $Z' = \bigcap_n Z'_n \in \mathcal{U}$ . Then  $Y' \times Z' \subseteq (\omega \times \kappa) \setminus X$ , hence  $(\omega \times \kappa) \setminus X \in \mathcal{V}$ .

Now we can prove that  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$  always holds if  $\kappa$  is a singular cardinal with countable cofinality.

**Theorem 7.5.** If  $\kappa$  is a singular cardinal with countable cofinality, then  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$ .

Proof. Suppose to the contrary that  $\mathfrak{u}(\kappa) > \mathfrak{u}(\kappa^+)$ . If  $\mathcal{U}$  is a uniform ultrafilter over  $\kappa^+$  with  $\chi(\mathcal{U}) = \mathfrak{u}(\kappa^+)$ , then  $\mathcal{U}$  is  $\kappa$ -indecomposable but  $\kappa^+$ -decomposable, so  $\omega$ -indecomposable by Proposition 7.3. In particular  $\mathcal{U}$  is  $\sigma$ -complete. By Lemma 7.4, there is a uniform ultrafilter  $\mathcal{V}$  over  $\kappa^+$  such that  $\chi(\mathcal{V}) = \mathfrak{u}(\kappa^+)$  and  $\mathcal{V}$  is not  $\sigma$ -complete. Then  $\mathcal{V}$  is  $\mathrm{cf}(\kappa)$ -decomposable, hence is  $\kappa$ -decomposable by Proposition 7.3 again, and we have  $\mathfrak{u}(\kappa) \leq \chi(\mathcal{V}) = \mathfrak{u}(\kappa^+)$  by Lemma 5.1. This is a contradiction.

We note that, by Theorem 4.8, the countable cofinality assumption of this theorem cannot be eliminated.

Corollary 7.6. If  $\kappa$  is regular, then  $\mathfrak{u}(\kappa^{+\alpha}) \leq \mathfrak{u}(\kappa^{+\alpha+1})$  for every  $\alpha < \omega_1$ .

Again,  $\mathfrak{u}(\kappa^{+\omega_1+1}) < \mathfrak{u}(\kappa^{+\omega_1})$  is consistent by Theorem 4.8. Combining Theorem 7.5 with Theorems 4.7 and 6.10 we have:

Corollary 7.7. (1) Relative to a certain large cardinal assumption, it is consistent that  $\mathfrak{u}(\omega_{\omega}) < \mathfrak{u}(\omega_{1})$ .

(2) Relative to a certain large cardinal assumption, it is consistent that there is a cardinal  $\kappa$  with  $\mathfrak{u}(\kappa^{+\omega}) < \mathfrak{u}(\omega_{\omega})$ .

Next we prove that  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$  holds if  $\kappa$  is a strong limit singular cardinal.

**Proposition 7.8.** Let  $\kappa$  be a singular cardinal and  $\lambda < \kappa$  a cardinal, and suppose  $\mu^{\lambda} \leq \kappa^{+}$  for every  $\mu < \kappa$ . If  $\kappa^{+}$  has a  $\kappa$ -indecomposable uniform ultrafilter, then  $\kappa^{\lambda} \leq \kappa^{+}$ .

*Proof.* We may assume  $\lambda \geq \operatorname{cf}(\kappa)$ . Fix a  $\kappa$ -indecomposable uniform ultrafilter  $\mathcal{U}$  over  $\kappa^+$ , which is  $\operatorname{cf}(\kappa)$ -indecomposable by Proposition 7.3.  $\mathcal{U}$  is  $(\kappa, \kappa^+)$ -regular by Fact 7.2, so we can take a family  $\{x_\alpha \mid \alpha < \kappa^+\}$  such that  $|x_\alpha| < \kappa$  and  $\{\alpha \mid i \in x_\alpha\} \in \mathcal{U}$  for  $i < \kappa^+$ .

Fix an enumeration  $\{B_i \mid i < \kappa^+\}$  of  $\bigcup_{\mu < \kappa} [\mu]^{\leq \lambda}$  such that for every  $j < \kappa^+$ , the set  $\{i \mid B_i = B_j\}$  is cofinal in  $\kappa^+$ . For  $\alpha < \kappa^+$ , let  $\mathcal{B}_{\alpha} = \{\bigcup_{i \in c} B_i \mid c \in [x_{\alpha}]^{\mathrm{cf}(\kappa)}\}$ . Since  $\mu^{\lambda} \leq \kappa^+$  for every  $\mu < \kappa$  and  $|x_{\alpha}| < \kappa$ , we have  $|\mathcal{B}_{\alpha}| \leq \kappa^+$ . Thus  $|\bigcup_{\alpha} \mathcal{B}_{\alpha}| \leq \kappa^+$ . We prove that  $[\kappa]^{\lambda} \subseteq \bigcup_{\alpha} \mathcal{B}_{\alpha}$ , then we have  $\kappa^{\lambda} \leq \kappa^+$  as required.

Fix an increasing sequence  $\langle \kappa_{\xi} \mid \xi < \operatorname{cf}(\kappa) \rangle$  with limit  $\kappa$ . For  $X \in [\kappa]^{\lambda}$ , we can take an increasing sequence  $\langle i_{\xi} \mid \xi < \operatorname{cf}(\kappa) \rangle$  such that  $X \cap \kappa_{\xi} = B_{i_{\xi}}$ . Put  $d = \{i_{\xi} \mid \xi < \operatorname{cf}(\kappa)\}$ , which has order type  $\operatorname{cf}(\kappa)$ . Because  $\{\alpha \mid i_{\xi} \in x_{\alpha}\} \in \mathcal{U}$  for  $\xi < \operatorname{cf}(\kappa)$  and  $\mathcal{U}$  is  $\operatorname{cf}(\kappa)$ -indecomposable, there must be  $\alpha < \kappa^{+}$  such that  $|d \cap x_{\alpha}| = \operatorname{cf}(\kappa)$ . Then  $X = \bigcup_{i \in d \cap x_{\alpha}} B_{i} \in \mathcal{B}_{\alpha}$ .

**Theorem 7.9.** If  $\kappa$  is a strong limit singular cardinal, then  $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)$ .

*Proof.* If  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ , then  $\kappa^+$  has a  $\kappa$ -indecomposable uniform ultrafilter, hence  $2^{\kappa} = \kappa^{\mathrm{cf}(\kappa)} = \kappa^+$  by Proposition 7.8. But then  $\mathfrak{u}(\kappa) \leq 2^{\kappa} = \kappa^+ \leq \mathfrak{u}(\kappa^+)$ , this is a contradiction.

The strong limit assumption of this theorem cannot be eliminated by Theorem 4.8.

Next we prove that if  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ , then  $\mathfrak{u}(\kappa^+)$  is an upper bound of the ultrafilter numbers at almost all regular cardinals below  $\kappa$ .

**Definition 7.10.** Let  $\kappa$  be a singular cardinal, and  $A \subseteq \kappa$  be a set of regular cardinals with  $\sup(A) = \kappa$  and  $|A| = \operatorname{cf}(\kappa)$ . Let U be an ultrafilter over A. For  $f, g \in \prod A$ , define  $f \leq_U g$  by  $\{\mu \in A \mid f(\mu) \leq g(\mu)\} \in U$ . A set  $\mathcal{F} \subseteq \prod A$  is  $\leq_{U}$ -cofinal if for every  $f \in \prod A$ , there is  $g \in \mathcal{F}$  with  $f \leq_{U} g$ . Let  $\operatorname{cf}(\prod A, \leq_{U}) = \min\{|\mathcal{F}| \mid \mathcal{F} \text{ is } \leq_{U}\text{-cofinal}\}$ , and  $\operatorname{PP}(\kappa)$  the set of all  $\operatorname{cf}(\prod A, \leq_{U})$ 's where  $A \subseteq \kappa$  is a set of regular cardinals with  $\sup(A) = \kappa$ ,  $|A| = \operatorname{cf}(\kappa)$ , and U an ultrafilter over A which does not contain bounded subsets of A. Let  $\operatorname{pp}(\kappa)$  be the supremum of  $\operatorname{PP}(\kappa)$ .

**Fact 7.11** (Shelah). For a singular cardinal  $\kappa$ , the following are equivalent:

- (1)  $pp(\kappa) = \kappa^+$ .
- (2) For every increasing sequence  $\langle \kappa_{\xi} | \xi < \operatorname{cf}(\kappa) \rangle$  of regular cardinals with limit  $\kappa$ , there is a subsequence  $\langle \kappa'_{\xi} | \xi < \operatorname{cf}(\kappa) \rangle$  of the sequence with limit  $\kappa$  which admits a scale of length  $\kappa^+$ .

**Definition 7.12.** For a cardinal  $\kappa$ , let  $ADS_{\kappa}$  be the following assertion: there is a sequence  $\langle A_i \mid i < \kappa^+ \rangle$  such that  $A_i$  is an unbounded subset of  $\kappa$  with size  $cf(\kappa)$ , and for every  $\alpha < \kappa^+$  there is  $f : \alpha \to \kappa$  such that  $(A_i \setminus f(i)) \cap (A_i \setminus f(j)) = \emptyset$  for every  $i < j < \alpha$ .

**Fact 7.13** (Shelah). Let  $\kappa$  be a singular cardinal. If  $pp(\kappa) > \kappa^+$ , then  $ADS_{\kappa}$  holds.

**Proposition 7.14.** Let  $\kappa$  be a singular cardinal, and suppose  $\kappa^+$  has a  $\kappa$ -indecomposable uniform ultrafilter. Then  $ADS_{\kappa}$  fails, in particular  $pp(\kappa) = \kappa^+$ .

*Proof.* Suppose to the contrary that  $ADS_{\kappa}$  holds. Let  $\langle A_i \mid i < \kappa^+ \rangle$  be a  $ADS_{\kappa}$ -sequence.

Let  $\mathcal{U}$  be a  $\kappa$ -indecomposable uniform ultrafilter over  $\kappa^+$ . By Proposition 7.3,  $\mathcal{U}$  is cf( $\kappa$ )-indecomposable. For  $\alpha < \kappa^+$ , we can find  $g_\alpha : \alpha + 1 \to \kappa$  such that the sequence  $\langle A_i \setminus f(i) \mid i \leq \alpha \rangle$  is pairwise disjoint. Fix  $\beta < \kappa^+$ . Since  $\mathcal{U}$  is cf( $\kappa$ )-indecomposable, we can find  $\delta_\beta < \kappa$  such that  $X_\beta = \{\alpha < \kappa^+ \mid g_\alpha(\beta) < \delta_\beta\} \in \mathcal{U}$ . Now there must be some  $\delta < \kappa^+$  such that  $Y = \{\beta < \kappa^+ \mid \delta_\beta = \delta\}$  is unbounded in  $\kappa^+$ . We show that the sequence  $\langle A_\beta \setminus \delta \mid \beta \in Z \rangle$  is pairwise disjoint, but this is impossible since  $|Y| = \kappa^+$ 

Pick  $\beta, \beta' \in Y$  with  $\beta < \beta'$ . We know that  $X_{\beta} \cap X_{\beta'} \in \mathcal{U}$ , so there is a large  $\alpha > \beta, \beta'$  with  $\alpha \in X_{\beta} \cap X_{\beta'}$ . Then  $g_{\alpha}(\beta), g_{\alpha}(\beta') < \delta$ . Because  $A_{\beta} \setminus g_{\alpha}(\beta)$  and  $A_{\beta'} \setminus g_{\alpha}(\beta')$  are disjoint and  $g_{\alpha}(\beta), g_{\alpha}(\beta') < \delta$ , we have that  $A_{\beta} \setminus \delta$  and  $A_{\beta'} \setminus \delta$  are disjoint as well.

**Proposition 7.15.** Let  $\kappa$  be a singular cardinal, and  $\mathcal{U}$  a uniform ultrafilter over  $\kappa^+$ . If  $\mathcal{U}$  is  $\kappa$ -indecomposable, then there is a cardinal  $\lambda < \kappa$  such that  $\mathcal{U}$  is  $\mu$ -decomposable for every regular  $\mu$  with  $\lambda < \mu < \kappa$ .

*Proof.* Suppose to the contrary that the set  $\{\mu < \kappa \mid \mu \text{ is regular, } \mathcal{U} \text{ is } \mu\text{-indecomposable}\}$  is unbounded in  $\kappa$ .

By Proposition 7.3, we have that  $\mathcal{U}$  is  $\operatorname{cf}(\kappa)$ -indecomposable. Applying Proposition 7.14 and Facts 7.11, 7.13, we can take an increasing sequence  $\langle \kappa_{\xi} \mid \xi < \operatorname{cf}(\kappa) \rangle$  of regular cardinals with limit  $\kappa$  such that  $\mathcal{U}$  is  $\kappa_{\xi}$ -indecomposable, and  $\prod_{\xi} \kappa_{\xi}$  admits a scale  $\langle f_i \mid i < \kappa^+ \rangle$ .

For  $\xi < \operatorname{cf}(\kappa)$ , since  $\mathcal{U}$  is  $\kappa_{\xi}$ -indecomposable, we can find  $\delta_{\xi} < \kappa_{\xi}$  such that  $\{\alpha < \kappa^{+} \mid f_{\alpha}(\xi) < \delta_{\xi}\} \in \mathcal{U}$ . Now take a large  $\beta < \kappa^{+}$  such that  $\delta_{\xi} < f_{\beta}(\xi)$  for almost all  $\xi < \operatorname{cf}(\kappa)$ .

For  $\alpha < \kappa^+$  with  $\alpha > \beta$ , there is  $\zeta_{\alpha} < \operatorname{cf}(\kappa)$  such that  $f_{\beta}(\xi) < f_{\alpha}(\xi)$  for all  $\xi \geq \zeta_{\alpha}$ . Since  $\mathcal{U}$  is  $\operatorname{cf}(\kappa)$ -indecomposable, there is  $\zeta < \operatorname{cf}(\kappa)$  with  $\{\alpha < \kappa^+ \mid \zeta_{\alpha} < \zeta\} \in \mathcal{U}$ . Hence we can find  $\alpha < \kappa^+$  with  $\beta < \alpha$  and  $\zeta_{\alpha} < \zeta$ . By the choice of  $\zeta_{\alpha}$ , we have  $\delta_{\zeta} < f_{\beta}(\zeta) < f_{\alpha}(\zeta)$ , this is a contradiction.  $\square$ 

The following theorem is immediate from Lemmas 5.1, 5.2 and Proposition 7.15.

**Theorem 7.16.** Let  $\kappa$  be a singular cardinal, and suppose  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ . Then there is a cardinal  $\lambda < \kappa$  such that  $\mathfrak{u}(\mu) \leq \mathfrak{u}(\kappa^+)$  for every regular  $\mu$  with  $\lambda < \mu < \kappa$ .

Note that we can improve "every regular  $\mu$ " in this theorem to "every regular or singular with countable cofinality  $\mu$ " by Theorem 7.5, however cannot to "every cardinal  $\mu$ "; Suppose  $\kappa$  is strongly compact, and let  $\mu > \kappa$  be a strong limit singular cardinal with cofinality  $\omega_1$ . Then  $Add(\omega, \mu)$  forces  $\mathfrak{u}(\kappa^{+\omega_1^2+1}) < \mathfrak{u}(\kappa^{+\omega_1^2+1}) < \mathfrak{u}(\kappa^{+\omega_1^2+1})$  for every  $\alpha < \omega_1$ .

We end this section by showing the consistency of  $\mathfrak{u}(\kappa^{+\omega_1}) < \mathfrak{u}(\omega_{\omega})$ .

## **Lemma 7.17.** Let $\kappa$ be a singular cardinal. Then $\mathfrak{u}(\kappa) \leq \mathfrak{u}(\kappa^+)^{\mathrm{cf}(\kappa)}$ .

Proof. We may assume  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ . Fix an increasing sequence  $\langle \kappa_i \mid i < \mathrm{cf}(\kappa) \rangle$  of regular cardinals with limit  $\kappa$ . By Proposition 7.15, there is  $\lambda < \kappa$  such that  $\mathfrak{u}(\mu) \leq \mathfrak{u}(\kappa^+)$  for every regular  $\mu$  with  $\lambda < \mu < \kappa$ . Hence we may assume that for every  $i < \mathrm{cf}(\kappa)$ , there is a uniform ultrafilter  $\mathcal{U}_i$  over  $\kappa_i$  with  $\chi(\mathcal{U}_i) \leq \mathfrak{u}(\kappa^+)$ . Fix also a uniform ultrafilter  $\mathcal{V}$  over  $\mathrm{cf}(\kappa)$ . Now define a filter  $\mathcal{D}$  over  $\kappa$  as:  $X \in \mathcal{D} \iff \{i < \mathrm{cf}(\kappa) \mid X \cap \kappa_i \in \mathcal{U}_i\} \in \mathcal{V}$ . It is easy to show that  $\mathcal{D}$  is a uniform ultrafilter over  $\kappa$ , and since  $\chi(\mathcal{U}_i) \leq \mathfrak{u}(\kappa^+)$ , we have  $\chi(\mathcal{D}) \leq \mathfrak{u}(\kappa^+)^{\mathrm{cf}(\kappa)} \cdot 2^{\mathrm{cf}(\kappa)}$ . Thus  $\mathfrak{u}(\kappa) \leq \chi(\mathcal{D}) \leq \mathfrak{u}(\kappa^+)^{\mathrm{cf}(\kappa)}$ .

**Proposition 7.18.** Suppose there is no  $\omega_3$ -indecomposable uniform ultrafilter over  $\omega_{\omega}$  and  $2^{\omega_1} = \omega_2$ . Let  $\kappa$  be a strongly compact cardinal, and  $\mu > \kappa$  a strong limit singular cardinal with  $\operatorname{cf}(\mu) = \omega_3$ . Then  $\operatorname{Add}(\omega_2, \mu)$  forces  $\mathfrak{u}(\kappa^{+\omega_1}) < \mathfrak{u}(\omega_{\omega})$ .

*Proof.* In the generic extension, we have that  $\mathfrak{u}(\kappa^{+\omega_1+1}) < \mathfrak{u}(\omega_3)$ . Since  $\mathrm{Add}(\omega_2, \mu)$  satisfies the  $\omega_3$ -c.c., we have  $\mathfrak{u}(\omega_3) \leq \mathfrak{u}(\omega_\omega)$  as in the proof of Theorem 6.9, so we have that  $\mathfrak{u}(\kappa^{+\omega_1+1}) < \mathfrak{u}(\omega_\omega)$ .

We prove that  $\mathfrak{u}(\kappa^{+\omega_1}) \leq \mathfrak{u}(\kappa^{+\omega_1+1})$  in the generic extension. Suppose to the contrary that  $\mathfrak{u}(\kappa^{+\omega_1+1}) < \mathfrak{u}(\kappa^{+\omega_1})$ . We note that  $\mathfrak{u}(\kappa^{+\omega_1+1}) = \mu$  by Lemma 4.1. By Lemma 7.17, we have  $\mathfrak{u}(\kappa^{+\omega_1}) \leq \mathfrak{u}(\kappa^{+\omega_1+1})^{\omega_1}$ . However, since  $\mathfrak{u}(\kappa^{+\omega_1+1}) = \mu$ ,  $\mathrm{cf}(\mu) = \omega_3$ , and  $\mathrm{Add}(\omega_2, \mu)$  is  $\omega_2$ -closed, we have  $\mathfrak{u}(\kappa^{+\omega_1}) \leq \mu^{\omega_1} = \mu = \mathfrak{u}(\kappa^{+\omega_1+1})$ , this is a contradiction.

## 8. Consistency strength of the failure of monotonicity

In this section, we study the consistency strength of the failure of monotonicity of the ultrafilter number function. We will show that the failure has a large cardinal strength.

We use the following Donder's theorem.

- Fact 8.1 (Donder [4]). Suppose there is no inner model of a measurable cardinal. Let  $\kappa$  be an uncountable cardinal.
  - (1) If  $\kappa$  is singular, then every uniform ultrafilter over  $\kappa$  is  $(\omega, \kappa)$ -regular.
  - (2) If  $\kappa$  is regular, then every uniform ultrafilter over  $\kappa$  is  $(\omega, \lambda)$ -regular for every  $\lambda < \kappa$ .

**Proposition 8.2.** Suppose there is a cardinal  $\kappa$  such that  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter for some  $\lambda < \kappa$ . Then there is an inner model of a measurable cardinal.

*Proof.* Let  $\mathcal{U}$  be a  $\lambda$ -indecomposable uniform ultrafilter over  $\kappa$ . Then  $\mathcal{U}$  is not  $(\omega, \lambda)$ -regular by Lemma 2.7, and the assertion follows from Fact 8.1.  $\square$ 

**Theorem 8.3.** Suppose there are cardinals  $\lambda < \kappa$  such that  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ . Then there is an inner model of a measurable cardinal.

*Proof.* By the assumption,  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter. Then there is an inner model of a measurable cardinal by Proposition 8.2.

By Theorems 4.5, 4.6, and 8.3, we have the equiconsistency result.

**Theorem 8.4.** The following are equiconsistent:

- (1) There is a measurable cardinal.
- (2) There are cardinals  $\lambda < \kappa$  with  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .
- (3) There is a weakly inaccessible cardinal  $\kappa$  and a cardinal  $\lambda < \kappa$  with  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .
- (4) There is a singular cardinal  $\kappa$  and a cardinal  $\lambda < \kappa$  with  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ .
- (5) There are cardinals  $\lambda < \kappa$  such that  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter.

Here let us mention another application of Donder's theorem, which contrasts with Theorem 7.16.

**Proposition 8.5.** Relative to a certain large cardinal assumption, it is consistent that there is a weakly inaccessible cardinal  $\kappa$  such that  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$  for every uncountable cardinal  $\lambda < \kappa$ .

*Proof.* Suppose there is a measurable cardinal  $\kappa$  and a normal measure U over  $\kappa$  such that V = L[U], and  $V_{\kappa}$  is a model of ZFC+"there is no inner model of a measurable cardinal". By Fact 8.1, for every uncountable cardinal  $\lambda < \kappa$ ,  $\lambda$  has no  $\omega_1$ -indecomposable uniform ultrafilter.

Fix a large strong limit singular cardinal  $\mu > \kappa$  with cofinality  $\omega_1$ , and take a generic extension V[G] via poset  $Add(\omega, \mu)$ . In V[G], we have  $\mathfrak{u}(\kappa) \le \mu < \mathfrak{u}(\omega_1)$ . We see that, in V[G], every uncountable cardinal  $\lambda < \kappa$  does not have an  $\omega_1$ -indecomposable uniform ultrafilter. Then  $\mathfrak{u}(\omega_1) \le \mathfrak{u}(\lambda)$ , hence

 $\mathfrak{u}(\kappa) < \mathfrak{u}(\omega_1) \leq \mathfrak{u}(\lambda)$  as required. Suppose to the contrary that  $\lambda$  has an  $\omega_1$ -indecomposable uniform ultrafilter. Since V[G] is a c.c.c. forcing extension of V, by the argument used in the proof of Theorem 6.9, we can take an  $\omega_1$ -indecomposable uniform ultrafilter over  $\lambda$  in V. This contradicts to the choice of V.

Next we turn to the consistency strength of the statement  $\mathfrak{u}(\lambda) < \mathfrak{u}(\kappa^+)$  for some  $\lambda \leq \kappa$ . For this sake, we will consider the square principles.

**Definition 8.6.** Let  $\kappa$  be a cardinal. A sequence  $\langle c_{\alpha} \mid \alpha < \kappa^{+} \rangle$  is said to be a  $\square_{\kappa}$ -sequence if the following hold:

- (1)  $c_{\alpha}$  is a club in  $\alpha$  with order type  $\leq \kappa$ .
- (2) For every  $\alpha < \beta < \kappa^+$ , if  $\alpha$  is a limit point of  $c_\beta$  then  $c_\alpha = c_\beta \cap \alpha$ .

Let  $\square_{\kappa}$  be the assertion that there is a  $\square_{\kappa}$ -sequence.

**Definition 8.7.** Let  $\kappa$  be a cardinal. A sequence  $\langle c_{\alpha} \mid \alpha < \kappa \rangle$  is said to be a  $\square(\kappa)$ -sequence if the following hold:

- (1)  $c_{\alpha}$  is a club in  $\alpha$ .
- (2) There is no club C in  $\kappa$  such that for every  $\alpha < \kappa$ , if  $\alpha$  is a limit point of C then  $C \cap \alpha = c_{\alpha}$ .

Let  $\square(\kappa)$  be the assertion that there is a  $\square(\kappa)$ -sequence.

Clearly  $\square_{\kappa} \Rightarrow \square(\kappa^+)$ . It is known that the failure of the square principle at a singular cardinal, or at successive cardinals have a very strong large cardinal strength, but the exact strength is unknown. We just present the following Schimmerling's result.

Fact 8.8 (Schimmerling [15]). Suppose that:

- (1)  $\square_{\kappa}$  fails for some singular  $\kappa$ , or
- (2) Both  $\square(\kappa)$  and  $\square_{\kappa}$  fail for some  $\kappa \geq \omega_2$ .

Then there is an inner model of a proper class of strong cardinals.

We will prove that if  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter then  $\square(\kappa)$  fails. For this sake, we also need the next definition and Kanamori's another result.

**Definition 8.9.** Let  $\mathcal{U}$  be an ultrafilter over  $\kappa$ .

- (1) A function  $f: \kappa \to \kappa + 1$  is a least function of  $\mathcal{U}$  if  $\{\alpha < \kappa \mid \beta < f(\alpha)\} \in \mathcal{U}$  for every  $\beta < \kappa$ , and for every  $g: \kappa \to \kappa$ , if  $\{\alpha \mid g(\alpha) < f(\alpha)\} \in \mathcal{U}$ , then there is  $\beta < \kappa$  such that  $\{\alpha \mid g(\alpha) \leq \beta\} \in \mathcal{U}$ .
- (2) If the identity map is a least function, then  $\mathcal{U}$  is called a weakly normal ultrafilter.

Note that if  $\mathcal{U}$  is an ultrafilter over  $\kappa$  and  $f : \kappa \to \kappa$ , then the filter  $f_*(\mathcal{U})$  over  $\kappa$  is weakly normal if and only if f is a least function of  $\mathcal{U}$ .

**Fact 8.10** (Kanamori [11]). Let  $\kappa$  be a regular cardinal, and  $\mathcal{U}$  a uniform ultrafilter over  $\kappa$ . If there is  $\lambda < \kappa$  such that  $\mathcal{U}$  is not  $(\omega, \lambda)$ -regular, then  $\mathcal{U}$  has a least function.

By Lemma 2.7, if  $\mathcal{U}$  is a uniform ultrafilter over  $\kappa$  and there is a  $\lambda < \kappa$  such that  $\mathcal{U}$  is  $\lambda$ -indecomposable, then  $\mathcal{U}$  is not  $(\omega, \lambda)$ -regular. Hence  $\mathcal{U}$  has a least function.

**Proposition 8.11.** Let  $\kappa$  be a regular uncountable cardinal, and suppose there is a regular  $\lambda < \kappa$  such that  $\kappa$  has a  $\lambda$ -indecomposable uniform ultrafilter  $\mathcal{U}$ . Then  $\square(\kappa)$  fails.

*Proof.* To show that  $\Box(\kappa)$  fails, suppose to the contrary that there is a  $\Box(\kappa)$ -sequence  $\langle c_{\alpha} \mid \alpha < \kappa \rangle$ . By Fact 8.10,  $\mathcal{U}$  has a least function. Hence we may assume that  $\mathcal{U}$  is weakly normal.

Claim 8.12. For every  $\beta < \kappa$ , there is  $\gamma < \kappa$  such that  $\beta < \gamma$  and  $\{\alpha < \kappa \mid \gamma \in \lim(c_{\alpha})\} \in \mathcal{U}$ .

*Proof.* We shall take a strictly increasing sequence  $\langle \beta_i \mid i < \lambda \rangle$  by induction on  $\lambda$  such that for every  $i < \lambda$ ,  $\{\alpha < \kappa \mid [\beta_i, \beta_{i+1}) \cap c_\alpha \neq \emptyset\} \in \mathcal{U}$ . First let  $\beta_0 = \beta$ . Suppose  $\beta_j$  is defined for all j < i. If i is limit, then  $\beta_i = \sup_{j < i} \beta_j$ . Suppose i is successor, say i = k + 1. By the weak normality of  $\mathcal{U}$ , we can find  $\beta_{k+1}$  such that  $\{\alpha \mid [\beta_k, \beta_{k+1}) \cap c_\alpha \neq \emptyset\} \in \mathcal{U}$ .

Let  $\gamma = \sup_i \beta_i$ . Clearly  $\gamma > \beta$  and  $\operatorname{cf}(\gamma) = \lambda$ . We show that  $\{\alpha < \kappa \mid \gamma \in \lim(c_\alpha)\} \in \mathcal{U}$ . For  $i < \lambda$ , let  $X_i = \{\alpha \mid [\beta_i, \beta_{i+1}) \cap c_\alpha \neq \emptyset\} \in \mathcal{U}$ . Since  $\mathcal{U}$  is  $\lambda$ -indecomposable, the set  $Y = \{\alpha \mid \{i < \lambda \mid \alpha \in X_i\} \text{ is cofinal in } \lambda\}$  is in  $\mathcal{U}$ . Take  $\alpha \in Y$ . By the choice of the  $X_i$ 's, we have that  $c_\alpha \cap \gamma$  is unbounded in  $\gamma$ , hence  $\gamma \in \lim(c_\alpha)$ .

Let A be the set of all  $\gamma < \kappa$  such that  $\{\alpha < \kappa \mid \gamma \in \lim(c_{\alpha})\} \in \mathcal{U}$ . A is unbounded in  $\kappa$  by the previous claim. For  $\beta_0, \beta_1 \in A$  with  $\beta_0 < \beta_1$ , there is a large  $\alpha$  such that  $\beta_0, \beta_1 \in \lim(c_{\alpha})$ . Hence  $c_{\beta_1} \cap \beta_0 = c_{\beta_0}$ . This argument shows that  $C = \bigcup \{c_{\beta} \mid \beta \in A\}$  is a club in  $\kappa$  and  $C \cap \beta = c_{\beta}$  for every  $\beta \in \lim(C)$ . This is a contradiction.

**Corollary 8.13.** (1) Let  $\kappa$  be a regular cardinal. If  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$  holds for some  $\lambda < \kappa$ , then  $\square(\kappa)$  fails.

(2) If  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\lambda)$  holds for some  $\lambda \leq \kappa$ , then  $\square_{\kappa}$  fails.

*Proof.* (2) is immediate from (1).

(1). By the assumption, we can find a  $\lambda$ -indecomposable uniform ultrafilter  $\mathcal{U}$ . If  $\lambda$  is regular, then  $\square(\kappa)$  fails by Proposition 8.11. If  $\lambda$  is singular, then  $\mathcal{U}$  is either cf( $\lambda$ )-indecomposable, or  $\lambda^+$ -indecomposable by Proposition 7.3. In either case, we have that  $\square(\kappa)$  fails by Proposition 8.11 again.  $\square$ 

We point out that, if  $\kappa$  is singular then the weak square principle  $\square_{\kappa}^*$  implies  $ADS_{\kappa}$ . Hence by Proposition 7.14,  $\square_{\kappa}^*$  fails if  $\kappa$  is singular and  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ 

The failure of the square principle is reflecting.

**Proposition 8.14.** Let  $\kappa$  be a regular cardinal, and suppose there is a cardinal  $\lambda \leq \kappa$  such that  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\lambda)$  holds. Then both  $\square(\kappa)$  and  $\square(\kappa^+)$  fail.

*Proof.* By the assumption,  $\kappa^+$  has a  $\lambda$ -indecomposable uniform ultrafilter  $\mathcal{U}$ . We know that  $\mathcal{U}$  is  $\kappa$ -decomposable. Now we show that there is a regular cardinal  $\mu < \kappa$  such that  $\mathcal{U}$  is  $\mu$ -indecomposable. Since  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ , there is a  $\lambda$ -indecomposable uniform ultrafilter. If  $\lambda$  is regular, let  $\mu = \lambda$ . Suppose  $\lambda$  is singular. By Proposition 7.3,  $\mathcal{U}$  is either  $\mathrm{cf}(\lambda)$ -indecomposable, or else  $\lambda^+$ -indecomposable. If it is  $\mathrm{cf}(\lambda)$ -indecomposable, then let  $\mu = \mathrm{cf}(\lambda)$ . If  $\lambda^+$ -indecomposable, we have  $\lambda^+ < \kappa$  and put  $\mu = \lambda^+$ .

We have that  $\Box(\kappa^+)$  fails by Proposition 8.11. Because  $\mathcal{U}$  is  $\kappa$ -decomposable, we can find a  $\mu$ -indecomposable uniform ultrafilter over  $\kappa$ . By applying Proposition 8.11 again,  $\Box(\kappa)$  fails.

**Proposition 8.15.** Let  $\kappa$  be a singular cardinal. If  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\kappa)$ , then the set  $\{\lambda < \kappa \mid \lambda \text{ is regular and } \square(\lambda) \text{ holds } \}$  is bounded in  $\kappa$ .

*Proof.* By the assumption, we can take a  $\kappa$ -indecomposable uniform ultrafilter  $\mathcal{U}$  over  $\kappa^+$ , which is in fact  $\mathrm{cf}(\kappa)$ -indecomposable by Proposition 7.3. Now suppose to contrary that the set  $\{\lambda < \kappa \mid \lambda \text{ is regular and } \square(\lambda) \text{ holds} \}$  is unbounded in  $\kappa$ . By Proposition 7.15, we can take a regular  $\lambda < \kappa$  such that  $\lambda > \mathrm{cf}(\kappa)$ ,  $\mathcal{U}$  is  $\lambda$ -decomposable, and  $\square(\lambda)$  holds. Then we can take a  $\mathrm{cf}(\kappa)$ -indecomposable uniform ultrafilter  $\mathcal{V}$  over  $\lambda$ . Hence  $\square(\lambda)$  fails by Proposition 8.11, this is a contradiction.

By Fact 8.8 and these propositions, we obtain the following lower bound of the consistency strength.

**Theorem 8.16.** Let  $\kappa$  be a cardinal. If  $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\lambda)$  holds for some cardinal  $\lambda \leq \kappa$ , then there is an inner model of a proper class of strong cardinals.

To conclude this paper, we would like to ask some questions.

**Question 8.17.** (1) What is the exact consistency strength of the statement that " $\mathfrak{u}(\kappa^+) < \mathfrak{u}(\lambda)$  for some  $\lambda \leq \kappa$ "?

- (2) Is it consistent that there are cardinals  $\lambda < \kappa$  such that  $2^{<\lambda} = \lambda$  and  $\mathfrak{u}(\kappa) < \mathfrak{u}(\lambda)$ ?
- (3) Is it consistent that monotonicity of the ultrafilter number function fails at three cardinals? Namely, is it consistent that there are three cardinals  $\kappa_0 < \kappa_1 < \kappa_2$  with  $\mathfrak{u}(\kappa_2) < \mathfrak{u}(\kappa_1) < \mathfrak{u}(\kappa_0)$ ? How about  $\mathfrak{u}(\kappa_1) < \mathfrak{u}(\kappa_2) < \mathfrak{u}(\kappa_0)$  and  $\mathfrak{u}(\kappa_2) < \mathfrak{u}(\kappa_0) < \mathfrak{u}(\kappa_1)$ ?
- (4) Is there anther cardinal invariant function  $\mathfrak{t}(\kappa)$  on the cardinals such that the failure of monotonicity of  $\mathfrak{t}$  has a large cardinal strength?
