AN ALTERNATIVE Q-FORM OF THE CYCLOTOMIC DOUBLE SHUFFLE LIE ALGEBRA

ABSTRACT. We present an alternative \mathbb{Q} -form for Racinet's cyclotomic double shuffle Lie algebra, inspired by the double shuffle relations among congruent multiple zeta values studied by Yuan and Zhao. Our main result establishes an invariance characterization theorem, demonstrating how these two \mathbb{Q} -forms can be reconstructed from each other under Galois action.

0. INTRODUCTION

Multiple zeta values (MZVs in short) are real numbers defined by the following series

$$\zeta(k_1,\ldots,k_r) = \sum_{n_1 > \cdots > n_r > 0} \frac{1}{n_1^{k_1} \cdots n_r^{k_r}},$$

where r, k_1, \ldots, k_r are positive integers with $k_1 \neq 1$ ([15]). These values appear in the studies of many subjects in mathematics and physics such as mixed Tate motives, knot invariant, the KZ-equation and Feynman integrals to name a few (for example, the reader may refer to [2, 6, 17] for a comprehensive presentation).

For a positive integer N, one may consider two level N generalizations of multiple zeta values, such that MZV correspond to the N = 1 case. The first generalization (cf. [7]), called *multiple* polylogarithm values at N^{th} roots of unity (N-MPVs in short), are complex numbers defined by

the following series

(0.1)
$$\operatorname{Li}_{(k_1,\dots,k_r)}(\zeta_1,\dots,\zeta_r) = \sum_{n_1 > \dots > n_r > 0} \frac{\zeta_1^{n_1} \cdots \zeta_r^{n_r}}{n_1^{k_1} \cdots n_r^{k_r}}$$

where r, k_1, \ldots, k_r are positive integers and ζ_1, \ldots, ζ_r are Nth roots of unity with $(k_1, \zeta_1) \neq (1, 1)$. They are also called multiple *L*-values in [1], cyclotomic multiple zeta values in [12] or the colored multiple zeta values in [5]. The second generalization, called *N*-congruent multiple zeta values (*N*-CMZVs in short) are real numbers defined by the following series

(0.2)
$$\zeta_{(\alpha_1,...,\alpha_r)}^{\text{mod }N}(k_1,...,k_r) = \sum_{\substack{n_1 > \dots > n_r > 0\\ n_j \in \alpha_j}} \frac{1}{n_1^{k_1} \cdots n_r^{k_r}},$$

where $r, k_1, \ldots, k_r \in \mathbb{Z}_{>0}$ with $k_1 \neq 1$ and $\alpha_1, \ldots, \alpha_r \in \mathbb{Z}/N\mathbb{Z}$. They are also called the *level* N multiple zeta value in [14]. Denote by $\iota : [\![1, N]\!] \to \mathbb{Z}/N\mathbb{Z}$ the substitution that identifies each element of $[\![1, N]\!]$ with its equivalence class. It has been established in [14, (8)] that N-CMZVs (0.2) are related to N-MPVs (0.1) by the following formula (0.3)

$$\zeta_{(\alpha_1,\dots,\alpha_r)}^{\text{mod }N}(k_1,\dots,k_r) = \frac{1}{N^r} \sum_{m_1=1}^N \cdots \sum_{m_r=1}^N \zeta_N^{-(m_1\iota^{-1}(\alpha_1)+\dots+m_r\iota^{-1}(\alpha_r))} \operatorname{Li}_{(k_1,\dots,k_r)}(\zeta_N^{m_1},\dots,\zeta_N^{m_r}),$$

where $\zeta_N := \exp\left(\frac{2\pi i}{N}\right)$.

The values (0.1) can be expressed as an iterated integral as follows (see for example [7])

(0.4)
$$\operatorname{Li}_{(k_1,\dots,k_r)}(\zeta_1,\dots,\zeta_r) = \int_0^1 \Omega_0^{k_1-1} \Omega_{\zeta_1} \Omega_0^{k_2-1} \Omega_{\zeta_1\zeta_2} \cdots \Omega_0^{k_r-1} \Omega_{\zeta_1\cdots\zeta_r}$$

where $\Omega_0 = \frac{dt}{t}$ and $\Omega_{\zeta} = \frac{dt}{\zeta^{-1}-t}$, for any root of unity ζ . Thanks to formula (0.3) and the iterated integral expression (0.4), one deduces the following identity (see [14, p.185])

$$\zeta_{(\alpha_1,\dots,\alpha_r)}^{\text{mod }N}(k_1,\dots,k_r) = \frac{1}{N^r} \int_0^1 \omega^{k_1-1} \omega_{\alpha_1-\alpha_2} \cdots \omega^{k_{r-1}-1} \omega_{\alpha_{r-1}-\alpha_r} \omega^{k_r-1} \omega_{\alpha_r},$$

where $\omega = \frac{dt}{t}$ and $\omega_{\alpha} = \frac{Nt^{t^{-1}(\alpha)-1}dt}{1-t^{N}}$ for any $\alpha \in \mathbb{Z}/N\mathbb{Z}$. One may also check that [14, p.185]

(0.5)
$$\omega = \Omega_0 \text{ and } \omega_{\alpha} = \sum_{m=1}^{N} \zeta_N^{-m\iota^{-1}(\alpha)} \Omega_{\zeta_N^m}$$

Using iterated sums and iterated integral expression, one deduces linear and algebraic relations between N-MPVs called the (regularized) double shuffle relations. To describe these relations Hoffmann [8] introduced a word algebra setting whose letters are free noncommutative variables assimilated to the differential 1-forms Ω_0 and Ω_{ζ} ($\zeta \in \mu_N$). This setting has been utilized to provide two kinds of algebraic frameworks for these relations. The first one, introduced by Racinet [11] uses noncommutative formal power series Hopf algebras. This framework introduced a Q-Lie algebra $\mathfrak{dmt}_0^{\mu_N}$, which is a key ingredient in Racinet's main result on the torsor structure of (regularized) double shuffle and distribution relations. The second framework, introduced by Arakawa-Kaneko [1], was inspired by Ihara-Kaneko-Zagier [9] (N = 1) and utilizes noncommutative free polynomial algebras. The equivalence between the two frameworks is related to dual nature of the relation between algebras and Hopf algebras in general. The relation (0.3) suggests that N-CMZVs also satisfy (regularized) double shuffle relations. In fact, this has been introduced by Yuan-Zhao [14] and written down precisely by Kanno in [10] thanks to the word algebra setting whose letters are the free noncommutative variables associated to the differential 1-forms ω and ω_{α} ($\alpha \in \mathbb{Z}/N\mathbb{Z}$).

In this paper, we utilize the identities (0.5) to construct an algebra isomorphism between the free noncommutative series algebras with coefficients in the cyclotomic field $\mathbb{Q}(\mu_N)$ associated to each set of differential 1-forms (see Lemma 3.1). This enables us to introduce a dual equivalent of the formalism of [10], which facilitates the formulation of double shuffle relations among *N*-CMZVs within the formalism of [11]. We then show that this algebra isomorphism is in fact a Hopf algebra isomorphism with respect to the newly introduced coproducts and the coproducts of [11], thus establishing the relations between both formalisms. After that, we define a \mathbb{Q} -Lie algebra $\mathfrak{dmr}_0^{[N]}$ related to the (regularized) double shuffle relations among *N*-CMZVs and establish the following result:

Theorem 0.1 (Theorem 3.11). There is a $\mathbb{Q}(\mu_N)$ -Lie algebra isomorphism

 $\mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{O}} \, \mathfrak{dmr}_0^{[N]} \xrightarrow{\simeq} \mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{O}} \, \mathfrak{dmr}_0^{\mu_N}.$

Finally, we focus our interest in the \mathbb{Q} -forms of these Lie algebra. In order to do so, we introduce a suitable action of the Galois group $\operatorname{Gal}(\mathbb{Q}(\mu_N)/\mathbb{Q})$, which enables us to establish the following result:

Theorem 0.2 (Theorem 3.16). There is a Q-Lie algebra isomorphism between $\mathfrak{dmr}_0^{\mu_N}$ (resp. $\mathfrak{dmr}_0^{[N]}$) and the invariant subspace of $\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{[N]}$ (resp. $\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{\mu_N}$) under the action of $\mathrm{Gal}(\mathbb{Q}(\mu_N)/\mathbb{Q})$.

Notation. Throughout this paper, let $N \geq 3$ be a positive integer and μ_N be the group of complex roots of unity. Denote by $\iota : [\![1,N]\!] \to \mathbb{Z}/N\mathbb{Z}$ the substitution that identifies each element of $[\![1,N]\!]$ with its equivalence class. Finally, let \mathbb{Q} be a commutative \mathbb{Q} -algebra with unit.

1. Algebraic framework related to N-MPVs

This section reviews the algebras in which one expresses shuffle and harmonic relations between N-MPVs. Their dual counterparts are Hopf algebras in which Racinet formulates [11] the cyclotomic double shuffle Lie algebra $\mathfrak{dmr}_0^{\mu_N}$.

1.1. Shuffle and harmonic algebras. Denote by $\mathbb{Q}\langle X \rangle$ the free noncommutative polynomial \mathbb{Q} -algebra with unit over the alphabet $X := \{x_0, x_\zeta \mid \zeta \in \mu_N\}$.

Consider the set $Y := \{y_{k,\zeta} \mid (k,\zeta) \in \mathbb{Z}_{>0} \times \mu_N\}$ and denote by $\mathbb{Q}\langle Y \rangle$ the free noncommutative polynomial \mathbb{Q} -algebra with unit over Y. The \mathbb{Q} -algebra $\mathbb{Q}\langle Y \rangle$ can be seen as a subalgebra of $\mathbb{Q}\langle X \rangle$ thanks to the injective algebra morphism $\mathbb{Q}\langle Y \rangle \hookrightarrow \mathbb{Q}\langle X \rangle$ given by $y_{k,\zeta} \mapsto x_0^{k-1}x_{\zeta}$, for any $(k,\zeta) \in \mathbb{Z}_{>0} \times \mu_N$.

Lemma 1.1 ([1, 16]). (a) The \mathbb{Q} -linear space $\mathbb{Q}\langle X \rangle$ is equipped with a commutative \mathbb{Q} -algebra structure with respect to the shuffle product given inductively by

$$1 \mod w = w \mod 1 = w$$

for a word w in $\mathbb{Q}\langle X \rangle$, and

 $uw_1 \equiv vw_2 = u(w_1 \equiv vw_2) + v(uw_1 \equiv w_2),$

for words w_1, w_2 in $\mathbb{Q}\langle X \rangle$ and $u, v \in X$; and extending by \mathbb{Q} -bilinearity.

(b) The \mathbb{Q} -linear space $\mathbb{Q}\langle Y \rangle$ is equipped with a commutative \mathbb{Q} -algebra structure with respect to the harmonic product (a.k.a. stuffle product) given inductively by

$$1 \ast w = w \ast 1 = w,$$

for a word w in $\mathbb{Q}\langle Y \rangle$, and

$$y_{k_1,\zeta_1}w_1 * y_{k_2,\zeta_2}w_2 = y_{k_1,\zeta_1}(w_1 * y_{k_2,\zeta_2}w_2) + y_{k_2,\zeta_2}(y_{k_1,\zeta_1}w_1 * w_2) + y_{k_1+k_2,\zeta_1\zeta_2}(w_1 * w_2)$$

for words w_1, w_2 in $\mathbb{Q}\langle Y \rangle$, $(k_1, \zeta_1), (k_2, \zeta_2) \in \mathbb{Z}_{>0} \times \mu_N$; and extending by \mathbb{Q} -bilinearity.

These algebraic structures provide a framework for formulating the shuffle and harmonic product formulas for N-MPVs, as elaborated in [8].

1.2. Shuffle and harmonic Hopf algebras. Denote by $\mathbb{Q}\langle\langle X \rangle\rangle$ the free noncommutative series \mathbb{Q} -algebra with unit over X and let $\mathbb{Q}\langle\langle Y \rangle\rangle$ be the free noncommutative series \mathbb{Q} -algebra with unit over Y.

The Q-algebra $\mathbb{Q}\langle\langle Y\rangle\rangle$ can be seen as a subalgebra of $\mathbb{Q}\langle\langle X\rangle\rangle$ thanks to the injective algebra morphism $\mathbb{Q}\langle\langle Y\rangle\rangle \hookrightarrow \mathbb{Q}\langle\langle X\rangle\rangle$ given by $y_{k,\zeta} \mapsto x_0^{k-1}x_{\zeta}$, for any $(k,\zeta) \in \mathbb{Z}_{>0} \times \mu_N$. Recall the direct sum decomposition (of Q-linear subspaces) (see ([11, §2.2.5])

$$\mathbb{Q}\langle\langle X\rangle\rangle = \mathbb{Q}\langle\langle Y\rangle\rangle \oplus \mathbb{Q}\langle\langle X\rangle\rangle x_0.$$

Let then $\pi_Y : \mathbb{Q}\langle\langle X \rangle\rangle = \mathbb{Q}\langle\langle Y \rangle\rangle \oplus \mathbb{Q}\langle\langle X \rangle\rangle x_0 \twoheadrightarrow \mathbb{Q}\langle\langle Y \rangle\rangle$ be the projection from $\mathbb{Q}\langle\langle X \rangle\rangle$ to $\mathbb{Q}\langle\langle Y \rangle\rangle$, that is, the surjective \mathbb{Q} -module morphism such that it is the identity on $\mathbb{Q}\langle\langle Y \rangle\rangle$ and maps any element of $\mathbb{Q}\langle\langle X \rangle\rangle x_0$ to 0.

Let **p** be the Q-linear automorphism of $\mathbb{Q}\langle\langle X \rangle\rangle$ given by ([11, §2.2.7])

$$\mathbf{p}(x_0^{k_1-1}x_{\zeta_1}x_0^{k_2-1}x_{\zeta_2}\cdots x_0^{k_r-1}x_{\zeta_r}x_0^{k_r+1-1}) = x_0^{k_1-1}x_{\zeta_1}x_0^{k_2-1}x_{\zeta_1\zeta_2}\cdots x_0^{k_r-1}x_{\zeta_1\cdots\zeta_r}x_0^{k_r+1-1},$$

for $r \in \mathbb{Z}_{\geq 0}$, $k_1, \ldots, k_{r+1} \in \mathbb{Z}_{>0}$ and $\zeta_1, \ldots, \zeta_r \in \mu_N$. Denote by \mathcal{L} either X or Y. Define the pairing

$$\mathbb{Q}\langle\langle \mathcal{L} \rangle\rangle \otimes \mathbb{Q}\langle \mathcal{L} \rangle \to \mathbb{Q}, \ \psi \otimes w \mapsto (\psi \mid w),$$

where $(\psi \mid w)$ denotes the coefficient of the word w in ψ (and extend by linearity). Using this pairing, one obtains the following result:

Lemma 1.2. (a) The Q-algebra $\mathbb{Q}\langle\langle X\rangle\rangle$ is equipped with a Hopf algebra structure with respect to the shuffle coproduct, which is the algebra morphism $\widehat{\Delta}_{\mathrm{m}} : \mathbb{Q}\langle\langle X\rangle\rangle \to \mathbb{Q}\langle\langle X\rangle\rangle^{\hat{\otimes}^2}$ given by

$$x_0 \mapsto x_0 \otimes 1 + 1 \otimes x_0 \text{ and } x_{\zeta} \mapsto x_{\zeta} \otimes 1 + 1 \otimes x_{\zeta}, \text{ for } \zeta \in \mu_N.$$

(b) The Q-algebra $\mathbb{Q}\langle\langle Y \rangle\rangle$ is equipped with a Hopf algebra structure with respect to the harmonic coproduct, which is the algebra morphism $\widehat{\Delta}_* : \mathbb{Q}\langle\langle Y \rangle\rangle \to \mathbb{Q}\langle\langle Y \rangle\rangle^{\hat{\otimes}^2}$ given by

$$y_{k,\zeta} \mapsto y_{k,\zeta} \otimes 1 + 1 \otimes y_{k,\zeta} + \sum_{\substack{k_1+k_2=k\\\zeta_1\zeta_2=\zeta}} y_{k_1,\zeta_1} \otimes y_{k_2,\zeta_2}, \text{ for } (k,\zeta) \in \mathbb{Z}_{>0} \times \mu_N$$

Proof. Setting \bullet to be either \mathbf{m} or *, this follows from the identity (for explicit proof the reader may refer to [4, Lemma A.3])

$$\widehat{\Delta}_{\bullet}(\psi) = \sum_{u, v \text{ words in } \mathcal{L}} (\psi \mid u \bullet v) u \otimes v,$$

for any $\psi \in \mathbb{Q}\langle\langle \mathcal{L} \rangle\rangle$.

1.3. Racinet's cyclotomic double shuffle Lie algebra $\mathfrak{dmr}_0^{\mu_N}$. For $\psi \in \mathbb{Q}\langle\langle X \rangle\rangle$, let d_{ψ} be the derivation of $\mathbb{Q}\langle\langle X \rangle\rangle$ given by [11, §3.1.12.2]

(1.1)
$$x_0 \mapsto 0, \text{ and } x_{\zeta} \mapsto [x_{\zeta}, t_{\zeta}(\psi)] \text{ for } \zeta \in \mu_N,$$

where t_{ζ} is the algebra automorphism of $\mathbb{Q}\langle\langle X \rangle\rangle$ given by

(1.2)
$$x_0 \mapsto x_0$$
, and $x_\eta \mapsto x_{\zeta\eta}$, for $\eta \in \mu_N$.

We then define a Lie bracket on $\mathbb{Q}\langle\langle X\rangle\rangle$ as follows [11, §3.1.10.2]:

(1.3)
$$\langle \psi_1, \psi_2 \rangle := d_{\psi_1}(\psi_2) - d_{\psi_2}(\psi_1) + [\psi_1, \psi_2],$$

for any $\psi_1, \psi_2 \in \mathbb{Q}\langle\langle X \rangle\rangle$.

Definition 1.3 ([11, Definitions 3.3.1 and 3.3.8]). We define $\mathfrak{dmt}_0^{\mu_N}$ to be the set of elements $\psi \in \mathbb{Q}\langle\langle X \rangle\rangle$ such that

(i) $(\psi \mid x_0) = (\psi \mid x_1) = 0;$ (iii) ¹ $(\psi \mid x_{\zeta} - x_{\zeta^{-1}}) = 0$ for any $\zeta \in \mu_N;$

(ii)
$$\widehat{\Delta}_{\mathrm{m}}(\psi) = \psi \otimes 1 + 1 \otimes \psi;$$
 (iv) $\widehat{\Delta}_{*}(\psi_{*}) = \psi_{*} \otimes 1 + 1 \otimes \psi_{*};$

where

$$\psi_* = \pi_Y \circ \mathbf{p}^{-1}(\psi) + \sum_{n \ge 2} \frac{(-1)^{n-1}}{n} (\psi \mid x_0^{n-1} x_1) y_{1,1}^n \in \mathbb{Q} \langle \langle Y \rangle \rangle.$$

Proposition 1.4 ([11, Proposition 4.A.i)]). The pair $(\mathfrak{dmr}_0^{\mu_N}, \langle \cdot, \cdot \rangle)$ is a Lie subalgebra of $(\mathbb{Q}\langle\langle X \rangle\rangle, \langle \cdot, \cdot \rangle)$.

2. Algebraic framework related to N-CMZVs

Paralleling the approach in the previous section, we first recall from [10] the algebras in which one expresses shuffle and harmonic relations between N-CMZVs. Then we introduce here their dual counterparts which are Hopf algebras in which we formulate a congruent double shuffle Lie algebra $\mathfrak{dmr}_{0}^{[N]}$.

2.1. Shuffle and harmonic algebras. Denote by $\mathbb{Q}\langle \widetilde{X} \rangle$ the free noncommutative polynomial \mathbb{Q} -algebra with unit over the alphabet $\widetilde{X} := \{\widetilde{x}, \widetilde{x}_{\alpha} \mid \alpha \in \mathbb{Z}/N\mathbb{Z}\}.$

Consider the set $\widetilde{Y} := \{ \widetilde{y}_{k,\alpha} \mid (k,\alpha) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z} \}$ and denote by $\mathbb{Q}\langle \widetilde{Y} \rangle$ the free noncommutative polynomial \mathbb{Q} -algebra with unit over \widetilde{Y} . The \mathbb{Q} -algebra $\mathbb{Q}\langle \widetilde{Y} \rangle$ can be seen as a subalgebra of $\mathbb{Q}\langle \widetilde{X} \rangle$ thanks to the injective algebra morphism $\mathbb{Q}\langle \widetilde{Y} \rangle \hookrightarrow \mathbb{Q}\langle \widetilde{X} \rangle$ given by $\widetilde{y}_{k,\alpha} \mapsto \widetilde{x}^{k-1}\widetilde{x}_{\alpha}$, for $(k,\alpha) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z}$.

Lemma 2.1 ([10, p. 5 and 6]). (a) The \mathbb{Q} -linear space $\mathbb{Q}\langle \tilde{X} \rangle$ is equipped with a commutative \mathbb{Q} -algebra structure with respect to the shuffle product given inductively by

$$1 \ \tilde{\mathbf{m}} \ \tilde{w} = \tilde{w} \ \tilde{\mathbf{m}} \ 1 = \tilde{w},$$

for a word \tilde{w} in $\mathbb{Q}\langle \widetilde{X} \rangle$; and

$$\tilde{u}\tilde{w}_1 \text{ if } \tilde{v}\tilde{w}_2 = \tilde{u}(\tilde{w}_1 \text{ if } \tilde{v}\tilde{w}_2) + \tilde{v}(\tilde{u}\tilde{w}_1 \text{ if } \tilde{w}_2),$$

for words \tilde{w}_1, \tilde{w}_2 in $\mathbb{Q}\langle \widetilde{X} \rangle$ and $\tilde{u}, \tilde{v} \in \widetilde{X}$, and extending by \mathbb{Q} -bilinearity.

¹In [11], this condition is given as $(\psi_* \mid x_0^{k-1}x_{\zeta}) = (-1)^{k-1} (\psi_* \mid x_0^{k-1}x_{\zeta^{-1}})$ for $(k,\zeta) \in \mathbb{Z}_{>0} \times \mu_N$, but thanks to [11, Propositions 3.3.3 and 3.3.7], it is enough to have (iii) for k = 1 and any $\zeta \in \mu_N$ since this identity is always true for all the other cases. By definition of ψ_* this is equivalent to the stated identity.

(b) The \mathbb{Q} -linear space $\mathbb{Q}\langle \widetilde{Y} \rangle$ is equipped with a commutative \mathbb{Q} -algebra structure with respect to the harmonic product given inductively by

$$1 \ \tilde{*} \ \tilde{w} = \tilde{w} \ \tilde{*} \ 1 = \tilde{w},$$

for a word \tilde{w} in $\mathbb{Q}\langle \tilde{Y} \rangle$, and

$$y_{k_{1},\alpha_{1}}w_{1} * y_{k_{2},\alpha_{2}}w_{2} = \begin{cases} \tilde{y}_{k_{1},\alpha_{1}}(\tilde{w}_{1}\tilde{*}\tilde{y}_{k_{2},\alpha_{2}}\tilde{w}_{2}) + \tilde{y}_{k_{2},\alpha_{2}}(\tilde{y}_{k_{1},\alpha_{1}}\tilde{w}_{1}\tilde{*}\tilde{w}_{2}) & \text{if } \alpha_{1} \neq \alpha_{2} \\ \tilde{y}_{k_{1},\alpha}(\tilde{w}_{1}\tilde{*}\tilde{y}_{k_{2},\alpha}\tilde{w}_{2}) + \tilde{y}_{k_{2},\alpha}(\tilde{y}_{k_{1},\alpha}\tilde{w}_{1}\tilde{*}\tilde{w}_{2}) + \tilde{y}_{k_{1}+k_{2},\alpha}(\tilde{w}_{1}\tilde{*}\tilde{w}_{2}) & \text{if } \alpha = \alpha_{1} = \alpha_{2} \end{cases}$$

for words \tilde{w}_1, \tilde{w}_2 in $\mathbb{Q}\langle \widetilde{Y} \rangle$, $(k_1, \alpha_1), (k_2, \alpha_2) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z}$; and extending by \mathbb{Q} -bilinearity.

These algebraic structures provide a framework for formulating the shuffle and harmonic product formulas for N-CMZVs, as elaborated in [10].

2.2. Shuffle and harmonic Hopf algebras. Denote by $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ the free noncommutative series \mathbb{Q} -algebra with unit over \widetilde{X} . Denote by $\mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle$ the free noncommutative series \mathbb{Q} -algebra with unit over \widetilde{Y} .

The Q-algebra $\mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle$ can be seen as a subalgebra of $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ thanks to the injective algebra morphism $\mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle \hookrightarrow \mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ given by $\tilde{y}_{k,\alpha} \mapsto \tilde{x}^{k-1}\tilde{x}_{\alpha}$, for $(k,\alpha) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z}$. One checks that we have the direct sum decomposition (of Q-submodules)

$$\mathbb{Q}\langle\langle X\rangle\rangle = \mathbb{Q}\langle\langle Y\rangle\rangle \oplus \mathbb{Q}\langle\langle X\rangle\rangle\tilde{x}.$$

Let then $\pi_{\widetilde{Y}} : \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle = \mathbb{Q}\langle\langle \widetilde{Y} \rangle\rangle \oplus \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle \tilde{x} \twoheadrightarrow \mathbb{Q}\langle\langle \widetilde{Y} \rangle\rangle$ be the projection from $\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ to $\mathbb{Q}\langle\langle \widetilde{Y} \rangle\rangle$, that is, the surjective \mathbb{Q} -module morphism such that it is the identity on $\mathbb{Q}\langle\langle \widetilde{Y} \rangle\rangle$ and maps any element of $\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle \tilde{x}$ to 0.

Let $\widetilde{\mathbf{q}}$ be the \mathbb{Q} -linear automorphism of $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ given by

$$\widetilde{\mathbf{q}}(\widetilde{x}^{k_1-1}\widetilde{x}_{\alpha_1}\cdots\widetilde{x}^{k_{r-1}-1}\widetilde{x}_{\alpha_{r-1}}\widetilde{x}^{k_r-1}\widetilde{x}_{\alpha_r}\widetilde{x}^{k_{r+1}-1}) = \widetilde{x}^{k_1-1}\widetilde{x}_{\alpha_1-\alpha_2}\cdots\widetilde{x}^{k_{r-1}-1}\widetilde{x}_{\alpha_{r-1}-\alpha_r}\widetilde{x}^{k_r-1}\widetilde{x}_{\alpha_r}\widetilde{x}^{k_{r+1}-1},$$

for $r \in \mathbb{Z}_{\geq 0}, k_1, \dots, k_{r+1} \in \mathbb{Z}_{> 0}$ and $\alpha_1, \dots, \alpha_r \in \mathbb{Z}/N\mathbb{Z}.$

Denote by \mathcal{L} either X or Y. Define the pairing

$$\mathbb{Q}\langle\langle \widetilde{\mathcal{L}}\rangle\rangle\otimes\mathbb{Q}\langle \widetilde{\mathcal{L}}\rangle\to\mathbb{Q},\,\widetilde{\psi}\otimes\tilde{w}\mapsto(\widetilde{\psi}\mid\tilde{w}),$$

where $(\tilde{\psi} \mid \tilde{w})$ denotes the coefficient of the word \tilde{w} in $\tilde{\psi}$ (and extend by linearity). Using this pairing, one obtains the following result:

Lemma 2.2. (a) The \mathbb{Q} -algebra $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ is equipped with a Hopf algebra structure with respect to the shuffle coproduct, which is the algebra morphism $\widehat{\Delta}_{\tilde{\mathfrak{m}}}: \mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle \to \mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle^{\hat{\otimes}^2}$ given by

$$\tilde{x} \mapsto \tilde{x} \otimes 1 + 1 \otimes \tilde{x} \text{ and } \tilde{x}_{\alpha} \mapsto \tilde{x}_{\alpha} \otimes 1 + 1 \otimes \tilde{x}_{\alpha}, \text{ for } \alpha \in \mathbb{Z}/N\mathbb{Z}.$$

(b) The Q-algebra $\mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle$ is equipped with a Hopf algebra structure with respect to the harmonic coproduct, which is the algebra morphism $\widehat{\Delta}_{\widetilde{*}} : \mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle \to \mathbb{Q}\langle\langle \widetilde{Y}\rangle\rangle^{\hat{\otimes}^2}$ given by

$$\tilde{y}_{k,\alpha} \mapsto \tilde{y}_{k,\alpha} \otimes 1 + 1 \otimes \tilde{y}_{k,\alpha} + \sum_{k_1+k_2=k} \tilde{y}_{k_1,\alpha} \otimes \tilde{y}_{k_2,\alpha}, \text{ for } (k,\alpha) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z}.$$

Proof. Setting $\tilde{\bullet}$ to be either \tilde{m} or $\tilde{*}$, this follows from the identity (for explicit proof the reader may refer to [4, Lemma A3])

$$\widehat{\Delta}_{\widehat{\bullet}}(\widetilde{\psi}) = \sum_{\widetilde{u}, \widetilde{v} \text{ words in } \widetilde{\mathcal{L}}} (\widetilde{\psi} \mid \widetilde{u} \ \widehat{\bullet} \ \widetilde{v}) \widetilde{u} \otimes \widetilde{v},$$

for any $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{\mathcal{L}}\rangle\rangle$.

3. Congruent double shuffle Lie algebra $\mathfrak{dmt}_0^{[N]}$

Motivated by identity (0.3), we relate the formalisms of double shuffle relations for *N*-MPVs and *N*-CMZVs. Subsequently, we introduce a congruent double shuffle Lie algebra $\mathfrak{dmr}_0^{[N]}$ and demonstrate that it provides a new Q-form of $\mathfrak{dmr}_0^{\mu_N}$. Our main result is a G_N -invariance characterization theorem, which establishes how these two Q-structures can be reconstructed from each other under Galois action, thus elucidating their intricate relationship.

3.1. Comparison between the frameworks related to N-MPVs and N-CMZVs.

Lemma 3.1. The $\mathbb{Q}(\mu_N)$ -algebra morphism $\mathcal{F}: \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle \to \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle$ given by

$$\tilde{x} \mapsto x_0 \text{ and } \tilde{x}_{\alpha} \mapsto \sum_{m=1}^N \zeta_N^{-m\iota^{-1}(\alpha)} x_{\zeta_N^m} \text{ for } \alpha \in \mathbb{Z}/N\mathbb{Z}$$

is an isomorphism whose inverse \mathcal{F}^{-1} is given by

$$x_0 \mapsto \tilde{x} \text{ and } x_{\zeta_N^m} \mapsto \frac{1}{N} \sum_{a=1}^N \zeta_N^{am} \tilde{x}_{\iota(a)} \text{ for } m \in [\![1,N]\!].$$

Proof. This follows from a direct computation using the identity

$$\sum_{j=1}^{N} \zeta_N^{Mj} = \begin{cases} N & \text{if } N \mid M \\ 0 & \text{otherwise} \end{cases}$$


Lemma 3.2. The $\mathbb{Q}(\mu_N)$ -algebra isomorphism $\mathcal{F} : \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle \to \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle$ restricts to the $\mathbb{Q}(\mu_N)$ -algebra isomorphism $\mathcal{F}_Y : \mathbb{Q}(\mu_N)\langle\langle \widetilde{Y} \rangle\rangle \to \mathbb{Q}(\mu_N)\langle\langle Y \rangle\rangle$ given by

$$\tilde{y}_{k,\alpha} \mapsto \sum_{m=1}^{N} \zeta_N^{-m\iota^{-1}(\alpha)} y_{k,\zeta_N^m} \text{ for } (k,\alpha) \in \mathbb{Z}_{>0} \times \mathbb{Z}/N\mathbb{Z}.$$

Proof. This follows from the fact $\mathcal{F}_Y : \mathbb{Q}(\mu_N) \langle \langle \widetilde{Y} \rangle \rangle \to \mathbb{Q}(\mu_N) \langle \langle Y \rangle \rangle$ is the unique $\mathbb{Q}(\mu_N)$ -algebra morphism such that the following diagram

$$\begin{array}{cccc}
\mathbb{Q}(\mu_N)\langle\langle \widetilde{Y}\rangle\rangle & \xrightarrow{\mathcal{F}_Y} & \mathbb{Q}(\mu_N)\langle\langle Y\rangle\rangle \\
& & & & \downarrow \\
\mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle
\end{array}$$

commutes, whose inverse is the unique $\mathbb{Q}(\mu_N)$ -algebra morphism $\mathbb{Q}(\mu_N)\langle\langle Y \rangle\rangle \to \mathbb{Q}(\mu_N)\langle\langle \tilde{Y} \rangle\rangle$ such that the following diagram



commutes.

Lemma 3.3. The following diagrams of $\mathbb{Q}(\mu_N)$ -linear maps are commutative

(3.1)
$$\begin{array}{ccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle \\ \pi_{\widetilde{Y}} \downarrow & & \downarrow \pi_Y \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{Y}\rangle\rangle & \xrightarrow{\mathcal{F}_Y} & \mathbb{Q}(\mu_N)\langle\langle Y\rangle\rangle \end{array}$$

and

(3.2)
$$\begin{array}{ccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \\ & \widetilde{\mathbf{q}} & & & \downarrow \mathbf{p} \\ & \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \end{array}$$

Proof. From the definition, an immediate computation enables one to prove the commutativity of Diagram (3.1). Let us prove the commutativity of Diagram (3.2). It is enough to prove it on a basis of $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle$. Let $\tilde{x}^{k_1-1}\tilde{x}_{\alpha_1}\tilde{x}^{k_2-1}\tilde{x}_{\alpha_2}\cdots\tilde{x}^{k_r-1}\tilde{x}_{\alpha_r}\tilde{x}^{k_{r+1}-1}$ with $r \in \mathbb{Z}_{\geq 0}, k_1, \ldots, k_{r+1} \in \mathbb{Z}_{>0}$ and $\alpha_1, \ldots, \alpha_r \in \mathbb{Z}/N\mathbb{Z}$. We have

where the last equality follows from the change of variable $m_1 = m'_1, m_2 = m'_2 - m'_1, \dots, m_r = m'_r - m'_{r-1}$. On the other hand,

$$\begin{split} \mathbf{p} &\circ \mathcal{F}(\tilde{x}^{k_{1}-1}\tilde{x}_{\alpha_{1}}\tilde{x}^{k_{2}-1}\tilde{x}_{\alpha_{2}}\cdots\tilde{x}^{k_{r}-1}\tilde{x}_{\alpha_{r}}\tilde{x}^{k_{r+1}-1}) \\ &= \mathbf{p}\left(x_{0}^{k_{1}-1}\sum_{m_{1}=1}^{N}\zeta_{N}^{-m_{1}\iota^{-1}(\alpha_{1})}x_{\zeta_{N}^{m_{1}}}x_{0}^{k_{2}-1}\sum_{m_{2}=1}^{N}\zeta_{N}^{-m_{2}\iota^{-1}(\alpha_{2})}x_{\zeta_{N}^{m_{2}}}\cdots x_{0}^{k_{r}-1}\sum_{m_{r}=1}^{N}\zeta_{N}^{-m_{r}\iota^{-1}(\alpha_{r})}x_{\zeta_{N}^{m_{r}}}x_{0}^{k_{r+1}-1}\right) \\ &= \sum_{m_{1}=1}^{N}\sum_{m_{2}=1}^{N}\cdots\sum_{m_{r}=1}^{N}\zeta_{N}^{-m_{1}\iota^{-1}(\alpha_{1})-m_{2}\iota^{-1}(\alpha_{2})-\dots-m_{r}\iota^{-1}(\alpha_{r})}x_{\zeta_{N}^{m_{1}}}x_{0}^{k_{2}-1}x_{\zeta_{N}^{m_{1}}}x_{0}^{m_{1}+m_{2}}\cdots x_{0}^{k_{r}-1}x_{\zeta_{N}^{m_{1}}+\dots+m_{r}}x_{0}^{k_{r+1}-1}, \end{split}$$

thus proving that $\mathcal{F} \circ \widetilde{\mathbf{q}} = \mathbf{p} \circ \mathcal{F}$.

- **Lemma 3.4.** (a) The map $\mathcal{F} : (\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle, \widehat{\Delta}_{\tilde{\mathfrak{m}}}) \to (\mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle, \widehat{\Delta}_{\mathfrak{m}})$ is a Hopf algebra isomorphism;
- (b) The map $\mathcal{F}_Y: (\mathbb{Q}(\mu_N)\langle\langle \widetilde{Y}\rangle\rangle, \widehat{\Delta}_*) \to (\mathbb{Q}(\mu_N)\langle\langle Y\rangle\rangle, \widehat{\Delta}_*)$ is Hopf algebra isomorphism.

Proof. (a) The statement is equivalent to the commutativity of the following diagram

$$\begin{array}{ccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle \\ & & & & & & \\ \widehat{\Delta}_{\scriptscriptstyle \tilde{\mathrm{ff}}} & & & & & \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle^{\hat{\otimes}2} & \xrightarrow{\mathcal{F}^{\otimes 2}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle^{\hat{\otimes}2} \end{array}$$

Since all arrows are $\mathbb{Q}(\mu_N)$ -algebra morphisms, it suffices to verify equality of the morphisms $\widehat{\Delta}_{\mathrm{III}} \circ \mathcal{F}$ and $\mathcal{F}^{\otimes 2} \circ \widehat{\Delta}_{\widetilde{\mathrm{III}}}$ on generators of the algebra $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle$. This can be achieved through an immediate computation.

(b) The statement is equivalent to the commutativity of the following diagram

$$\begin{array}{ccc}
\mathbb{Q}(\mu_N)\langle\langle \widetilde{Y} \rangle\rangle & \xrightarrow{\mathcal{F}_Y} & \mathbb{Q}(\mu_N)\langle\langle Y \rangle\rangle \\
\widehat{\Delta}_{\tilde{\ast}} \downarrow & & \downarrow \widehat{\Delta}_{\ast} \\
\mathbb{Q}(\mu_N)\langle\langle \widetilde{Y} \rangle\rangle^{\hat{\otimes}^2} & \xrightarrow{\mathcal{F}_Y^{\otimes 2}} & \mathbb{Q}(\mu_N)\langle\langle Y \rangle\rangle^{\hat{\otimes}^2}
\end{array}$$

Since all arrows are $\mathbb{Q}(\mu_N)$ -algebra morphisms, it suffices to verify equality of the morphisms $\widehat{\Delta}_* \circ \mathcal{F}_Y$ and $\mathcal{F}_Y^{\otimes 2} \circ \widehat{\Delta}_{\tilde{*}}$ on generators of the algebra $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle$. This can be achieved through an immediate computation.

For $a \in [\![1,N]\!]$, we define the $\mathbb{Q}(\mu_N)$ -algebra automorphism \tilde{t}_a of $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle$ as follows:

$$\tilde{x} \mapsto \tilde{x} \text{ and } \tilde{x}_{\alpha} \mapsto \zeta_N^{a\iota^{-1}(\alpha)} \tilde{x}_{\alpha} \text{ for } \alpha \in \mathbb{Z}/N\mathbb{Z}.$$

Lemma 3.5. For $a \in [\![1, N]\!]$, the following diagram of $\mathbb{Q}(\mu_N)$ -algebra morphisms is commutative:

$$\begin{array}{ccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \\ & & & \downarrow^{t_{\zeta_N^a}} \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \end{array}$$

where $t_{\zeta_N^a}$ is the automorphism of $\mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle$ given in (1.2).

Proof. Since all the maps appearing in the diagram are algebra morphisms, it is enough to show the claim for algebraic generators \tilde{x} and \tilde{x}_{α} ($\alpha \in \mathbb{Z}/N\mathbb{Z}$). We have

$$\mathcal{F} \circ \tilde{t}_{a}(\tilde{x}_{\alpha}) = \mathcal{F}(\zeta_{N}^{a\iota^{-1}(\alpha)}\tilde{x}_{\alpha}) = \zeta_{N}^{a\iota^{-1}(\alpha)} \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} x_{\zeta_{N}^{m}},$$

$$t_{\zeta_{N}^{a}} \circ \mathcal{F}(\tilde{x}_{b}) = t_{\zeta_{N}^{a}} \left(\sum_{m'=1}^{N} \zeta_{N}^{-m'\iota^{-1}(\alpha)} x_{\zeta_{N}^{m'}} \right) = \sum_{m'=1}^{N} \zeta_{N}^{-m'\iota^{-1}(\alpha)} x_{\zeta_{N}^{m'+a}}$$

$$= \sum_{m=1}^{N} \zeta_{N}^{-(m-a)\iota^{-1}(\alpha)} x_{\zeta_{N}^{m}} = \zeta_{N}^{a\iota^{-1}(\alpha)} \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} x_{\zeta_{N}^{m}}.$$

We also have $\mathcal{F} \circ \tilde{t}_a(\tilde{x}) = t_{\zeta_N^a} \circ \mathcal{F}(\tilde{x})$. Whence our claim is obtained.

3.2. Construction of a Lie bracket $\langle -, -\rangle$. From now on, denote by G_N the Galois group $\operatorname{Gal}(\mathbb{Q}(\mu_N)/\mathbb{Q})$. Recall that

 $G_N = \{ \sigma \in \operatorname{Aut}_{\mathbb{Q}}(\mathbb{Q}(\mu_N)) \mid \exists k \in \llbracket 1, N-1 \rrbracket \text{ with } \operatorname{gcd}(k, N) = 1 \text{ such that } \sigma(\zeta_N) = \zeta_N^k \}.$

Therefore, one may identify G_N with $(\mathbb{Z}/N\mathbb{Z})^{\times}$ under the natural isomorphism

$$(3.3) G_N \simeq (\mathbb{Z}/N\mathbb{Z})^{\times}$$

given by $\sigma \mapsto \iota(k)$, for some $k \in [\![1, N-1]\!]$ with gcd(k, N) = 1.

Definition 3.6. For $a \in [\![1, N]\!]$, we define the $\mathbb{Q}(\mu_N)$ -linear automorphism of $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle$ as follows:

$$\widetilde{T}_a := \frac{1}{N} \sum_{m=1}^N \zeta_N^{-ma} \, \widetilde{t}_m.$$

Lemma 3.7. The operator \widetilde{T}_a $(a \in [\![1, N]\!])$ preserves the \mathbb{Q} -form, that is, $\widetilde{T}_a \in \operatorname{Aut}_{\mathbb{Q}-\operatorname{lin}}(\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle)$. Proof. The group G_N acts on $\mathbb{Q}(\mu_N) \left[(\widetilde{t}_a)_{a \in [\![1,N]\!]} \right]$ by

$$\sigma \cdot r = \sigma(r)$$
, for $r \in \mathbb{Q}(\mu_N)$ and $\sigma \cdot \tilde{t}_a = \tilde{t}_a^k$ for $a \in [1, N]$.

Next, recall that for any $k \in [\![1, N-1]\!]$ with gcd(k, N) = 1, we have (3.4) $\tilde{t}_a^k = \tilde{t}_{\iota^{-1}(\overline{ak})}.$

Indeed, we have $\tilde{t}^k_a(\tilde{x}) = \tilde{x} = \tilde{t}_{\iota^{-1}(\overline{ak})}(\tilde{x})$ and for $\alpha \in \mathbb{Z}/N\mathbb{Z}$

$$\tilde{t}_a^k(\tilde{x}_\alpha) = \zeta_N^{ak\iota^{-1}(\alpha)} \tilde{x}_\alpha = \zeta_N^{\iota^{-1}(\overline{ak})\iota^{-1}(\alpha)} \tilde{x}_\alpha = \tilde{t}_{\iota^{-1}(\overline{ak})}(\tilde{x}_\alpha).$$

Finally, for any $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$, we have

$$\begin{split} \sigma \cdot \widetilde{T}_{a}(\widetilde{\psi}) &= \frac{1}{N} \sum_{m'=1}^{N} \sigma(\zeta_{N}^{-m'a}) \ \sigma \cdot \widetilde{t}_{m'}(\widetilde{\psi}) = \frac{1}{N} \sum_{m'=1}^{N} \zeta_{N}^{-km'a} \ \widetilde{t}_{m'}^{k}(\widetilde{\psi}) = \frac{1}{N} \sum_{m'=1}^{N} \zeta_{N}^{-\iota^{-1}(\overline{km'})a} \ \widetilde{t}_{\iota^{-1}(\overline{km'})}(\widetilde{\psi}) \\ &= \frac{1}{N} \sum_{m=1}^{N} \zeta_{N}^{-ma} \ \widetilde{t}_{m}(\widetilde{\psi}) = \widetilde{T}_{a}(\widetilde{\psi}), \end{split}$$

where the third equality comes from identity (3.4). Hence $\widetilde{T}_a(\widetilde{\psi}) \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$. Lemma 3.7 enables us to define the following:

Definition 3.8. For $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$, define a derivation $\widetilde{d}_{\widetilde{\psi}} : \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle \to \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ by

$$\tilde{x} \mapsto 0$$
, and $\tilde{x}_{\alpha} \mapsto \widetilde{T}_{\iota^{-1}(\alpha)} \left(\left[\sum_{\beta \in \mathbb{Z}/N\mathbb{Z}} \tilde{x}_{\beta}, \ \widetilde{\psi} \right] \right)$ for $\alpha \in \mathbb{Z}/N\mathbb{Z}$

Proposition 3.9. For $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$, the following diagram is commutative²

$$\begin{array}{ccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle \\ & & & & \downarrow d_{\mathcal{F}(\widetilde{\psi})} \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X\rangle\rangle \end{array}$$

where $d_{\mathcal{F}(\tilde{\psi})}$ is the derivation in (1.1).

²Here, we abusively denote by $\tilde{d}_{\tilde{\psi}}$ (resp. $d_{\mathcal{F}(\tilde{\psi})}$) the derivation $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes \tilde{d}_{\tilde{\psi}}$ (resp. $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes d_{\mathcal{F}(\tilde{\psi})}$) of $\mathbb{Q}(\mu_N)\langle\langle \tilde{X} \rangle\rangle \simeq \mathbb{Q}(\mu_N)\hat{\otimes}_{\mathbb{Q}}\mathbb{Q}\langle\langle \tilde{X} \rangle\rangle$).

Proof. Since all vertical arrows of the diagram are derivations and all horizontal arrows are algebra morphisms, we will demonstrate this equality by applying both sides to generators \tilde{x} and \tilde{x}_{α} and showing that they yield the same result. The computation for \tilde{x} being immediate, we will focus on \tilde{x}_{α} . We have

$$\begin{split} \mathcal{F} \circ \tilde{d}_{\widetilde{\psi}}(\widetilde{x}_{a}) &= \mathcal{F} \circ \widetilde{T}_{\iota^{-1}(\alpha)} \left(\left[\sum_{\beta \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_{\beta}, \ \widetilde{\psi} \right] \right) = \frac{1}{N} \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ \mathcal{F} \circ \widetilde{t}_{m} \left(\left[\sum_{\beta \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_{\beta}, \ \widetilde{\psi} \right] \right) \\ &= \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ t_{\zeta_{N}^{m}} \circ \mathcal{F} \left(\left[\frac{1}{N} \sum_{\beta \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_{\beta}, \ \widetilde{\psi} \right] \right) \\ &= \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ t_{\zeta_{N}^{m}} \left(\left[\mathcal{F} \left(\frac{1}{N} \sum_{\beta \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_{\beta} \right), \ \mathcal{F}(\widetilde{\psi}) \right] \right) \\ &= \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ t_{\zeta_{N}^{m}} \left(\left[x_{1}, \ \mathcal{F}(\widetilde{\psi}) \right] \right) = \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ \left[t_{\zeta_{N}^{m}}(x_{1}), \ t_{\zeta_{N}^{m}} \circ \mathcal{F}(\widetilde{\psi}) \right] \\ &= \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ \left[x_{\zeta_{N}^{m}}, \ t_{\zeta_{N}^{m}} \left(\mathcal{F}(\widetilde{\psi}) \right) \right] = \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ d_{\mathcal{F}(\widetilde{\psi})}(x_{\zeta_{N}^{m}}) \\ &= d_{\mathcal{F}(\widetilde{\psi})} \left(\sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \ x_{\zeta_{N}^{m}} \right) = d_{\mathcal{F}(\widetilde{\psi})} \circ \mathcal{F}(\widetilde{x}_{\alpha}), \end{split}$$

where the third equality comes from Lemma 3.5.

Definition 3.10. The *N*-congruent double shuffle Lie algebra $\mathfrak{dmt}_0^{[N]}$ is the \mathbb{Q} -linear space consisting of elements $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ such that

(i)
$$(\widetilde{\psi} \mid \widetilde{x}) = \sum_{\alpha \in \mathbb{Z}/N\mathbb{Z}} (\widetilde{\psi} \mid \widetilde{x}_{\alpha}) = 0;$$

(ii) $(\widetilde{\psi} \mid x_{\alpha} - x_{-\alpha}) = 0 \text{ for any } \alpha \in \mathbb{Z}/N\mathbb{Z};$
(ii) $\widehat{\Delta}_{\tilde{i}\tilde{i}}(\widetilde{\psi}) = \widetilde{\psi} \otimes 1 + 1 \otimes \widetilde{\psi};$
(iv) $\widehat{\Delta}_{\tilde{*}}(\widetilde{\psi}_{\tilde{*}}) = \widetilde{\psi}_{\tilde{*}} \otimes 1 + 1 \otimes \widetilde{\psi}_{\tilde{*}};$

where

$$\widetilde{\psi}_{\widetilde{*}} = \pi_{\widetilde{Y}} \circ \widetilde{\mathbf{q}}^{-1}(\widetilde{\psi}) + \sum_{n \ge 2} \sum_{a=1}^{N} \sum_{b_1=1}^{N} \cdots \sum_{b_n=1}^{N} \frac{(-1)^{n-1}}{n N^{n+1}} \left(\widetilde{\psi} \mid \widetilde{x}^{n-1} \widetilde{x}_{\iota(a)} \right) \ \widetilde{y}_{1,\iota(b_1)} \cdots \widetilde{y}_{1,\iota(b_n)} \in \mathbb{Q}\langle\langle \widetilde{Y} \rangle\rangle.$$

Similarly to (1.3), we define a Lie bracket on $\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ as follows:

(3.5)
$$\langle \widetilde{\psi}_1, \widetilde{\psi}_2 \rangle := \tilde{d}_{\widetilde{\psi}_1}(\widetilde{\psi}_2) - \tilde{d}_{\widetilde{\psi}_2}(\widetilde{\psi}_1) + [\widetilde{\psi}_1, \widetilde{\psi}_2],$$

for any $\widetilde{\psi}_1, \widetilde{\psi}_2 \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$.

Theorem 3.11. (a) The Q-linear space $\mathfrak{dmr}_0^{[N]}$ forms a Lie algebra under the bracket $\langle -, -\rangle$. (b) The map \mathcal{F} induces a $\mathbb{Q}(\mu_N)$ -Lie algebra isomorphism

(3.6)
$$\left(\mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{Q}} \, \mathfrak{dmr}_0^{[N]}, \, \langle -, -\rangle \right) \xrightarrow{\simeq} \left(\mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{Q}} \, \mathfrak{dmr}_0^{\mu_N}, \, \langle -, -\rangle \right).$$

Proof. The claim (a) follows from the claim (b) since for any $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$, the map $\widetilde{d}_{\widetilde{\psi}}$ is, by definition, a derivation of $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle \subset \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle$. We now proceed to prove claim (b). One immediately checks that condition (i) of Definition 3.10 corresponds to condition (i) of Definition 1.3 under the isomorphism \mathcal{F} . In addition, thanks to Lemma 3.4.(a), condition (ii) of Definition 3.10 corresponds to condition (ii) of Definition 1.3 under the isomorphism \mathcal{F} . The equivalence between condition (iii) of Definition 3.10 and condition (iii) of Definition 1.3 is established through the following identities

$$x_{\zeta_N^m} - x_{\zeta_N^{-m}} = \frac{1}{N} \sum_{a=1}^N \zeta_N^{am} \mathcal{F}(\tilde{x}_{\iota(a)} - \tilde{x}_{-\iota(a)})$$

and

$$\tilde{x}_{\alpha} - \tilde{x}_{-\alpha} = \sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} \mathcal{F}^{-1}(x_{\zeta_{N}^{m}} - x_{\zeta_{N}^{-m}}),$$

for $m \in [\![1, N]\!]$ and $\alpha \in \mathbb{Z}/N\mathbb{Z}$. The equivalence between condition (iv) of Definition 3.10 and condition (iv) of Definition 1.3 follows from the subsequent arguments. Let $\psi = \mathcal{F}(\tilde{\psi})$ with $\tilde{\psi} \in \mathbb{Q}\langle\langle \tilde{X} \rangle\rangle$. Then we have

$$\begin{aligned} \mathcal{F}_{Y}(\widetilde{\psi}_{*}) &= \mathcal{F}_{Y}\left(\pi_{\widetilde{Y}} \circ \widetilde{\mathbf{q}}^{-1}(\widetilde{\psi}) + \sum_{n \geq 2} \sum_{a=1}^{N} \sum_{b_{1}=1}^{N} \cdots \sum_{b_{n}=1}^{N} \frac{(-1)^{n-1}}{n N^{n+1}} (\widetilde{\psi} \mid \widetilde{x}^{n-1} \widetilde{x}_{\iota(a)}) \ \widetilde{y}_{1,\iota(b_{1})} \cdots \widetilde{y}_{1,\iota(b_{n})} \right) \\ &= \pi_{Y} \circ \mathbf{p}^{-1}(\psi) + \sum_{n \geq 2} \frac{(-1)^{n-1}}{n} \left(\widetilde{\psi} \mid \frac{1}{N} \sum_{a=1}^{N} \widetilde{x}^{n-1} \widetilde{x}_{\iota(a)}\right) y_{1,1}^{n} \\ &= \pi_{Y} \circ \mathbf{p}^{-1}(\psi) + \sum_{n \geq 2} \frac{(-1)^{n-1}}{n} \left(\widetilde{\psi} \mid \mathcal{F}^{-1}(x_{0}^{n-1}x_{1})\right) y_{1,1}^{n} \\ &= \pi_{Y} \circ \mathbf{p}^{-1}(\psi) + \sum_{n \geq 2} \frac{(-1)^{n-1}}{n} \left(\mathcal{F}(\psi) \mid x_{0}^{n-1}x_{1}\right) y_{1,1}^{n} = \psi_{*}, \end{aligned}$$

where the second equality follows from Lemma 3.3. By Lemma 3.4 (b), we establish the wanted equivalence under the map \mathcal{F}_Y .

The compatibility of Lie brackets is verified as follows: set $\psi_1 = \mathcal{F}(\tilde{\psi}_1)$ and $\psi_2 = \mathcal{F}(\tilde{\psi}_2)$ with $\tilde{\psi}_1, \tilde{\psi}_2 \in \mathfrak{dmr}_0^{[N]}$. Then by Proposition 3.9, we have

$$\begin{split} \langle \widetilde{\psi}_1, \widetilde{\psi}_2 \rangle &= \widetilde{d}_{\widetilde{\psi}_1}(\widetilde{\psi}_2) - \widetilde{d}_{\widetilde{\psi}_2}(\widetilde{\psi}_1) + [\widetilde{\psi}_1, \widetilde{\psi}_2] \\ &= \mathcal{F}^{-1}(d_{\mathcal{F}(\widetilde{\psi}_1)}(\mathcal{F}(\widetilde{\psi}_2))) - \mathcal{F}^{-1}(d_{\mathcal{F}(\widetilde{\psi}_2)}(\mathcal{F}(\widetilde{\psi}_1))) + \mathcal{F}^{-1}([\psi_1, \psi_2]) \\ &= \mathcal{F}^{-1}(d_{\psi_1}(\psi_2) - d_{\psi_2}(\psi_1) + [\psi_1, \psi_2]) \\ &= \mathcal{F}^{-1}(\langle \psi_1, \psi_2 \rangle) = \mathcal{F}^{-1}(\langle \mathcal{F}(\widetilde{\psi}_1), \mathcal{F}(\widetilde{\psi}_2) \rangle). \end{split}$$

Remark 3.12. Building upon the work of [3, 13], Kanno [10] investigated double shuffle relations for level N multiple Eisenstein series, with N-CMZVs as Fourier expansion constant terms. His explicit presentation of Goncharov coproduct [10, Proposition 4.15] may offer an alternative view on the Lie bracket formula (3.5). We anticipate that the Lie algebra $\mathfrak{dmr}_0^{[N]}$ will contribute to the study of algebraic structure of level N multiple Eisenstein series.

3.3. G_N -invariance characterization theorem. For each $\gamma \in (\mathbb{Z}/N\mathbb{Z})^{\times}$, we define δ_{γ} to be the algebra automorphism of $\mathbb{Q}\langle\langle X \rangle\rangle$ given by

(3.7)
$$x_0 \mapsto x_0, \text{ and } x_{\zeta} \mapsto x_{\zeta^{\iota^{-1}(\gamma)}}, \text{ for } \zeta \in \mu_N.$$

We also define $\widetilde{\delta}_{\gamma}$ to be the algebra automorphism of $\mathbb{Q}\langle\langle \widetilde{X}\rangle\rangle$ given by

(3.8)
$$\tilde{x} \mapsto \tilde{x}, \text{ and } \tilde{x}_{\alpha} \mapsto \tilde{x}_{\gamma\alpha}, \text{ for } \alpha \in \mathbb{Z}/N\mathbb{Z}$$

These correspondences induce actions of $(\mathbb{Z}/N\mathbb{Z})^{\times}$ on the algebras $\mathbb{Q}\langle\langle X \rangle\rangle$ and $\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ by $\gamma \mapsto \delta_{\gamma}$ and $\gamma \mapsto \widetilde{\delta}_{\gamma}$ respectively. We denote by $\sigma \mapsto \Delta_{\sigma}$ (resp. $\sigma \mapsto \widetilde{\Delta}_{\sigma}$) the action of G_N on $\mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \simeq \mathbb{Q}(\mu_N)\hat{\otimes}\mathbb{Q}\langle\langle X \rangle\rangle$ (resp. on $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle \simeq \mathbb{Q}(\mu_N)\hat{\otimes}\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$) where σ acts on the first component via the Galois action and on the second component via the $(\mathbb{Z}/N\mathbb{Z})^{\times}$ -action given in (3.7) (resp. (3.8)) thanks to the isomorphism (3.3).

We now consider the linear map $\mathcal{F} : \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \to \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle$ defined in Lemma 3.1, and establish the following statement which expresses equivariance properties of \mathcal{F} with respect to Galois actions:

Lemma 3.13. For $\sigma \in G_N$, the following equalities hold:

(3.9)
$$\mathcal{F} \circ (\sigma \otimes \operatorname{id}_{\mathbb{Q}(\langle \widetilde{X} \rangle)}) = \Delta_{\sigma} \circ \mathcal{F},$$

and

(3.10)
$$\mathcal{F} \circ \Delta_{\sigma} = (\sigma \otimes \mathrm{id}_{\mathbb{Q}\langle\langle X \rangle\rangle}) \circ \mathcal{F},$$

where $\sigma \otimes \operatorname{id}_{\mathbb{Q}\langle\langle X \rangle\rangle}$ (resp. $\sigma \otimes \operatorname{id}_{\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle}$) denotes the action on $\mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \simeq \mathbb{Q}(\mu_N)\hat{\otimes}\mathbb{Q}\langle\langle X \rangle\rangle$ (resp. $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle \simeq \mathbb{Q}(\mu_N)\hat{\otimes}\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$) such that σ acts only on the first component via the Galois action.

Proof. We will prove equality (3.10). Equality (3.9) can be proven in a similar manner. First, equality (3.10) is immediate for \tilde{x} . Next, let $z = r\tilde{x}_{\alpha}$ with $r \in \mathbb{Q}(\mu_N)$ and $\alpha \in \mathbb{Z}/N\mathbb{Z}$. Let γ be an element in $(\mathbb{Z}/N\mathbb{Z})^{\times}$ which corresponds to σ under the identification (3.3). Then

$$\mathcal{F}((\widetilde{\Delta}_{\sigma}(z)) = \mathcal{F}((\sigma \otimes \widetilde{\delta}_{\sigma})(r\widetilde{x}_{\alpha})) = \mathcal{F}(\sigma(r)\widetilde{x}_{\gamma\alpha}) = \sigma(r)\mathcal{F}(\widetilde{x}_{\gamma\alpha}) = \sigma(r)\sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\gamma\alpha)} x_{\zeta_{N}^{m}}$$
$$= \sigma(r)\sum_{m=1}^{N} \sigma(\zeta_{N}^{-m\iota^{-1}(\alpha)}) x_{\zeta_{N}^{m}} = (\sigma \otimes \mathrm{id}) \left(r\sum_{m=1}^{N} \zeta_{N}^{-m\iota^{-1}(\alpha)} x_{\zeta_{N}^{m}}\right) = (\sigma \otimes \mathrm{id})(\mathcal{F}(r\widetilde{x}_{\alpha}))$$
$$= (\sigma \otimes \mathrm{id})(\mathcal{F}(z)).$$

Finally, since \mathcal{F} is an algebra morphism, equality (3.10) follows for all elements in $\mathbb{Q}(\mu_N)\langle\langle \widetilde{X}\rangle\rangle$.

Proposition 3.14. The subspace $\mathfrak{dmr}_0^{[N]}$ (resp. $\mathfrak{dmr}_0^{\mu_N}$) is stable under the action of $(\mathbb{Z}/N\mathbb{Z})^{\times}$ on $\mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$ (resp. $\mathbb{Q}\langle\langle X \rangle\rangle$).

Proof. The invariance of these subspaces follows directly from an examination of their defining equations (i)-(iv). One can verify that each of these equations is preserved under the respective actions, thus ensuring the stability of the subspaces. \Box

Corollary 3.15. The subspace $\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{[N]}$ (resp. $\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{\mu_N}$) is stable under the action $\sigma \mapsto \widetilde{\Delta}_{\sigma}$ (resp. $\sigma \mapsto \Delta_{\sigma}$) of G_N on $\mathbb{Q}(\mu_N) \langle \langle \widetilde{X} \rangle \rangle$ (resp. $\mathbb{Q}(\mu_N) \langle \langle X \rangle \rangle$).

Proof. This follows immediately from Proposition 3.14 and by definition of the action $\sigma \mapsto \widetilde{\Delta}_{\sigma}$ (resp. $\sigma \mapsto \Delta_{\sigma}$).

The following theorem establishes our G_N -invariance characterization result for the double shuffle Lie algebras: **Theorem 3.16.** Denote by $(\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{[N]})^{\widetilde{\Delta}_{G_N}}$ (resp. $(\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{\mu_N})^{\Delta_{G_N}}$) the invariant subspace under the action of G_N described in Corollary 3.15. Under the isomorphism \mathcal{F} given in (3.6), the following identities hold:

(3.11)
$$(\mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{Q}} \, \mathfrak{dmr}_0^{[N]})^{\widetilde{\Delta}_{G_N}} \simeq \mathfrak{dmr}_0^{\mu_N}$$

and

(3.12)
$$\mathfrak{dmr}_0^{[N]} \simeq (\mathbb{Q}(\mu_N) \,\,\widehat{\otimes}_{\mathbb{Q}} \,\,\mathfrak{dmr}_0^{\mu_N})^{\Delta_{G_N}}.$$

Proof. We will prove identity (3.11). Identity (3.12) can be proven in a similar manner. Let $f \in (\mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{[N]})^{\widetilde{\Delta}_{G_N}}$. By Theorem 3.11 (b), we have $\mathcal{F}(f) \in \mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{\mu_N}$. Moreover, by equality (3.10) of Lemma 3.13, we have

$$\mathcal{F}(f) = \mathcal{F}\left(\widetilde{\Delta}_{\sigma}(f)\right) = (\sigma \otimes \mathrm{id}_{\mathbb{Q}\langle\langle X \rangle\rangle})(\mathcal{F}(f)).$$

Thus proving that $\mathcal{F}(f) \in \mathfrak{dmr}_0^{\mu_N}$. Conversely, assume $g \in \mathfrak{dmr}_0^{\mu_N} \subset \mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{\mu_N}$. Then by Theorem 3.11 (b), $\mathcal{F}^{-1}(g) \in \mathbb{Q}(\mu_N) \otimes_{\mathbb{Q}} \mathfrak{dmr}_0^{[N]}$. From equality (3.10) of Lemma 3.13, we have

$$\mathcal{F}^{-1}(g) = \mathcal{F}^{-1}\left((\sigma \otimes \operatorname{id}_{\mathbb{Q}\langle\langle X \rangle\rangle})(g)\right) = \widetilde{\Delta}_{\sigma} \circ \mathcal{F}^{-1}(g).$$

Hence we have $\mathcal{F}^{-1}(g) \in (\mathbb{Q}(\mu_N) \, \hat{\otimes}_{\mathbb{Q}} \, \mathfrak{dmr}_0^{[N]})^{\widetilde{\Delta}_{G_N}}.$

Our investigation addresses a fundamental question concerning the descent of the isomorphism presented in equation (3.6). Specifically, we examine whether this isomorphism, initially defined over the cyclotomic field $\mathbb{Q}(\mu_N)$, can be realized over the rational number field \mathbb{Q} . This inquiry leads us to the following problem:

Problem 3.17. Are the Lie algebras $\mathfrak{dmr}_0^{[N]}$ and $\mathfrak{dmr}_0^{\mu_N}$ isomorphic over \mathbb{Q} ?

This problem might have potential implications for our understanding of the arithmetic properties of multiple zeta values. It may also provide insights into the deeper structure of motivic Lie algebras associated with mixed Tate motives over cyclotomic fields.

Appendix A. Distribution relations on N-CMZVs

In this appendix, we aim to describe explicitly finite and regularized distribution relations among N-CMZVs by utilizing the finite and regularized distribution relations among N-MPVs. Those latter are expressed by the following identity (see [7])

(A.1)
$$\operatorname{Li}_{(k_1,\dots,k_r)}(\eta_1,\dots,\eta_r) = d^{k_1+\dots+k_r-r} \sum_{\substack{\zeta_i^d = \eta_i \\ 1 \le i \le r}} \operatorname{Li}_{(k_1,\dots,k_r)}(\zeta_1,\dots,\zeta_r),$$

for any divisor d of N, where r, k_1, \ldots, k_r are positive integers and η_1, \ldots, η_r are $\frac{N}{d}$ th roots of unity with $(k_1, \eta_1) \neq (1, 1)$. In [11, §2.5.3], Racinet introduced an algebraic framework to describe these relations as follows: for d a divisor of N, set $X_d := \{x_0, x_\zeta \mid \zeta \in \mu_{\frac{N}{d}}\}$, this is a subset of X thanks to the equality $\mu_{\frac{N}{d}} = \mu_N^d$ of subgroups of μ_N . Define the algebra morphisms p_*^d and $i_d^* : \mathbb{Q}\langle\langle X_d \rangle\rangle \to \mathbb{Q}\langle\langle X_d \rangle\rangle$ by (see also [16, §4])

$$p_*^d: \begin{array}{ccc} x_0 \mapsto d \, x_0 \\ x_{\zeta} \mapsto x_{\zeta^d} \end{array} \text{ and } \begin{array}{ccc} x_0 \mapsto x_0 \\ a_d^*: \\ x_{\zeta} \mapsto \begin{cases} x_{\zeta} & \text{if } \zeta \in \mu_{\frac{N}{d}} \\ 0 & \text{otherwise} \end{cases}$$

Definition A.1 ([11, (3.3.1.3)]). Let $\mathfrak{dmrd}_0^{\mu_N}$ be the \mathbb{Q} -Lie subalgebra of $\mathfrak{dmr}_0^{\mu_N}$ defined by

$$\mathfrak{dmrd}_0^{\mu_N} := \left\{ \psi \in \mathfrak{dmr}_0^{\mu_N} \mid \forall d | N, \ p_*^d(\psi) = i_d^*(\psi) + \sum_{\zeta \in \mu_{\frac{N}{d}}} (\psi \mid x_\zeta) x_1 \right\}$$

On the other hand, for a divisor d of N, consider the substitution $\iota_d : [\![1, \frac{N}{d}]\!] \to \mathbb{Z}/\frac{N}{d}\mathbb{Z}$, which associates to each element of $[\![1, \frac{N}{d}]\!]$ its equivalence class. One then checks that there exists a group isomorphism $\nu_d : \mathbb{Z}/\frac{N}{d}\mathbb{Z} \to d\mathbb{Z}/N\mathbb{Z}$ such that the following diagram

(A.2)
$$\begin{array}{c} d\mathbb{Z}/N\mathbb{Z} \\ \downarrow^{d\iota} & \uparrow^{\nu_d} \\ \llbracket 1, \frac{N}{d} \rrbracket \xrightarrow{\iota_d} \mathbb{Z}/\frac{N}{d}\mathbb{Z} \end{array}$$

commutes, where $d\iota : m \mapsto d\iota(m)$, for any $m \in [\![1, \frac{N}{d}]\!]$. Set $\widetilde{X}_d := \{\widetilde{x}, \widetilde{x}_\beta \mid \beta \in \mathbb{Z}/\frac{N}{d}\mathbb{Z}\}$, which one sees as a subset of X thanks to the isomorphism ν_d .

Definition A.2. Define the algebra morphism $\mathcal{F}_d : \mathbb{Q}(\mu_N) \langle \langle \widetilde{X}_d \rangle \rangle \to \mathbb{Q}(\mu_N) \langle \langle X_d \rangle \rangle$ by

$$\tilde{x} \mapsto x_0 \text{ and } \tilde{x}_{\beta} \mapsto \sum_{m=1}^{\frac{N}{d}} \zeta_N^{-md\iota_d^{-1}(\beta)} x_{\zeta_N^{dm}} \text{ for } \beta \in \mathbb{Z}/\frac{N}{d}\mathbb{Z}.$$

By replacing N by $\frac{N}{d}$ in \mathcal{F} , one checks that \mathcal{F}_d is an isomorphism with reciprocal given by

$$x_0 \mapsto \tilde{x} \text{ and } x_{\zeta_N^{md}} \mapsto \frac{d}{N} \sum_{a=1}^{\frac{N}{d}} \zeta_N^{amd} \tilde{x}_{\iota_d(a)} \text{ for } m \in \llbracket 1, \frac{N}{d} \rrbracket.$$

Definition A.3. Define the algebra morphisms \tilde{p}^d_* and $\tilde{i}^*_d : \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle \to \mathbb{Q}\langle\langle \widetilde{X}_d \rangle\rangle$ by

Lemma A.4. The following diagrams³

$$\begin{array}{cccc} \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle & & \mathbb{Q}(\mu_N)\langle\langle \widetilde{X} \rangle\rangle & \xrightarrow{\mathcal{F}} & \mathbb{Q}(\mu_N)\langle\langle X \rangle\rangle \\ & & & & \downarrow_{p_*^d} & & & & & \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}_d \rangle\rangle & \xrightarrow{\mathcal{F}_d} & \mathbb{Q}(\mu_N)\langle\langle X_d \rangle\rangle & & & & & \\ \mathbb{Q}(\mu_N)\langle\langle \widetilde{X}_d \rangle\rangle & \xrightarrow{\mathcal{F}_d} & \mathbb{Q}(\mu_N)\langle\langle X_d \rangle\rangle & & & \\ \end{array}$$

commute.

Proof. Let us show the commutativity of the left diagram. The proof is analogous for the right one. Since all arrows are algebra morphisms, it suffices to show equality on the generators. We have

$$p_*^d \circ \mathcal{F}(\tilde{x}) = p_*^d(x_0) = d x_0 = \mathcal{F}_d(d \, \tilde{x}) = \mathcal{F}_d \circ \tilde{p}_*^d(\tilde{x})$$

³Here, we abusively denote by \tilde{p}^d_* and p^d_* (resp. \tilde{i}^*_d and i^*_d) the algebra morphisms $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes \tilde{p}^d_*$ and $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes p^d_*$ (resp. $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes \tilde{i}^*_d$ and $\mathrm{id}_{\mathbb{Q}(\mu_N)} \otimes i^*_d$).

Next, let $\alpha \in \mathbb{Z}/N\mathbb{Z}$. We have

$$\mathcal{F}_{d} \circ \tilde{p}_{*}^{d}(\tilde{x}_{\alpha}) = \begin{cases} \mathcal{F}_{d}\left(d\tilde{x}_{\nu_{d}^{-1}(\alpha)}\right) & \text{if } \alpha \in d\mathbb{Z}/N\mathbb{Z} \\ 0 & \text{otherwise} \end{cases} = \begin{cases} d\sum_{m=1}^{\frac{N}{d}} \zeta_{N}^{-md(\nu_{d}\circ\iota_{d})^{-1}(\alpha)} x_{\zeta_{N}^{dm}} & \text{if } \alpha \in d\mathbb{Z}/N\mathbb{Z} \\ 0 & \text{otherwise} \end{cases}$$

On the other hand, we have

$$p_*^d \circ \mathcal{F}(\tilde{x}_{\alpha}) = \sum_{m=1}^N \zeta_N^{-m\iota^{-1}(\alpha)} x_{\zeta_N^{dm}} = \sum_{m=1}^{\frac{N}{d}} \zeta_N^{-m\iota^{-1}(\alpha)} x_{\zeta_N^{dm}} + \sum_{m=\frac{N}{d}+1}^{2\frac{N}{d}} \zeta_N^{-m\iota^{-1}(\alpha)} x_{\zeta_N^{dm}} + \dots + \sum_{m=(d-1)\frac{N}{d}+1}^N \zeta_N^{-m\iota^{-1}(\alpha)} x_{\zeta_N^{dm}}$$
$$= \sum_{j=1}^d \sum_{m_j=1}^{\frac{N}{d}} \zeta_N^{-\binom{m_j+(j-1)\frac{N}{d}}{\ell}\iota^{-1}(\alpha)} x_{\zeta_N^{d\binom{m_j+(j-1)\frac{N}{d}}{\ell}}} = \sum_{j=1}^d \sum_{m_j=1}^{\frac{N}{d}} \zeta_N^{-\binom{m_j+(j-1)\frac{N}{d}}{\ell}\iota^{-1}(\alpha)} x_{\zeta_N^{dm_j}}$$
$$= \sum_{m=1}^{\frac{N}{d}} \sum_{j=1}^d \zeta_N^{-\binom{m+(j-1)\frac{N}{d}}{\ell}\iota^{-1}(\alpha)} x_{\zeta_N^{dm}}} = \sum_{m=1}^{\frac{N}{d}} \zeta_N^{-m\iota^{-1}(\alpha)} \sum_{j=1}^d \zeta_N^{-\binom{(j-1)\frac{N}{d}\iota^{-1}(\alpha)}{\ell}} x_{\zeta_N^{dm}},$$

where the third equality comes by setting the change of variables $m_j = m - (j-1)\frac{N}{d}$ for any $j \in [\![1,d]\!]$ and the fourth one from the factorization by $x_{\zeta_N^{dm}}$, for any $m \in [\![1,\frac{N}{d}]\!]$. The summation in the middle is the sum of terms of a geometric sequence with first term 1 and common ratio $\zeta_N^{-\frac{N}{d}\iota^{-1}(\alpha)}$. In order to compute this summation, we need to consider two cases: Case 1 Assume that $\alpha \in d\mathbb{Z}/N\mathbb{Z}$. Therefore, there exists a unique $a \in [\![1,\frac{N}{d}]\!]$ such that

Case I Assume that $\alpha \in d\mathbb{Z}/N\mathbb{Z}$. Therefore, there exists a unique $a \in [1, \frac{N}{d}]$ such that $\alpha = \nu_d \circ \iota_d(a)$. It follows from the commutativity of diagram (A.2) that

$$\alpha = \nu_d \circ \iota_d(a) = d\iota(a) = \iota(da).$$

This implies that $\iota^{-1}(\alpha) = d(\nu_d \circ \iota_d)^{-1}(\alpha)$, which implies that $\zeta_N^{-\frac{N}{d}\iota^{-1}(\alpha)} = \zeta_N^{-\frac{N}{d}d(\nu_d \circ \iota_d)^{-1}(\alpha)} = 1$. We then obtain

$$p_*^d \circ \mathcal{F}(\tilde{x}_\alpha) = d \sum_{m=1}^{\frac{N}{d}} \zeta_N^{-md(\nu_d \circ \iota_d)^{-1}(\alpha)} x_{\zeta_N^{dm}}.$$

Case 2 Assume that $\alpha \notin d\mathbb{Z}/N\mathbb{Z}$. Therefore, $\zeta_N^{-\frac{N}{d}\iota^{-1}(\alpha)} \neq 1$ and then

$$\sum_{j=1}^{d} \zeta_N^{-(j-1)\frac{N}{d}\iota^{-1}(\alpha)} = 0,$$

which implies that

Thus

$$p_*^d \circ \mathcal{F}(\tilde{x}_\alpha) = 0.$$

proving the equality $p_*^d \circ \mathcal{F}(\tilde{x}_\alpha) = \mathcal{F}_d \circ \tilde{p}_*^d(\tilde{x}_\alpha)$ for any $\alpha \in \mathbb{Z}/N\mathbb{Z}$.

Remark A.5. Let d be a divisor of N and consider positive integers r, k_1, \ldots, k_r with $k_1 \neq 1$ and elements $\alpha_1, \ldots, \alpha_r \in d\mathbb{Z}/N\mathbb{Z}$. Let β_1, \ldots, β_r be the unique elements in $\mathbb{Z}/\frac{N}{d}\mathbb{Z}$ such that $\nu_d(\beta_i) = \alpha_i$. Then we have

$$d^{k_1+\dots+k_r}\zeta_{(\alpha_1,\dots,\alpha_r)}^{\mathrm{mod }N}(k_1,\dots,k_r)=\zeta_{(\beta_1,\dots,\beta_r)}^{\mathrm{mod }\frac{N}{d}}(k_1,\dots,k_r).$$

Consequently, we obtain the distribution relation

$$d^{k_1+\dots+k_r}\zeta_{(\alpha_1,\dots,\alpha_r)}^{\text{mod }N}(k_1,\dots,k_r) = \sum_{\substack{d\alpha'_i = \alpha_i \\ 1 \le i \le r}} \zeta_{(\alpha'_1,\dots,\alpha'_r)}^{\text{mod }N}(k_1,\dots,k_r).$$

Definition A.6. Let $\mathfrak{dmrd}_0^{[N]}$ be the Q-Lie subalgebra of $\mathfrak{dmr}_0^{[N]}$ defined by

$$\mathfrak{dmrd}_0^{[N]} := \Big\{ \widetilde{\psi} \in \mathfrak{dmr}_0^{[N]} \mid \forall d | N, \ \widetilde{p}^d_*(\widetilde{\psi}) = \widetilde{i}^*_d(\widetilde{\psi}) + (\widetilde{\psi} \mid \widetilde{x}_0) \ \sum_{\alpha \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_\alpha \Big\}.$$

Corollary A.7. The map \mathcal{F} induces a $\mathbb{Q}(\mu_N)$ -Lie algebra isomorphism

$$\left(\mathbb{Q}(\mu_N) \ \hat{\otimes}_{\mathbb{Q}} \ \mathfrak{dmrd}_0^{[N]}, \ \langle -, -\rangle \right) \xrightarrow{\simeq} \left(\mathbb{Q}(\mu_N) \ \hat{\otimes}_{\mathbb{Q}} \ \mathfrak{dmrd}_0^{\mu_N}, \ \langle -, -\rangle \right).$$

Proof. This follows by applying Theorem 3.11, Lemma A.4 to the defining identities of both Lie algebras and from the identity

$$\mathcal{F}_d\Big((\widetilde{\psi} \mid \widetilde{x}_0) \sum_{\alpha \in \mathbb{Z}/N\mathbb{Z}} \widetilde{x}_\alpha\Big) = \sum_{\zeta \in \mu_{\frac{N}{d}}} (\mathcal{F}_d(\widetilde{\psi}) \mid x_\zeta) x_1,$$

for any $\widetilde{\psi} \in \mathbb{Q}\langle\langle \widetilde{X} \rangle\rangle$

Remark A.8. It can be shown that Theorem 3.16 extend to the pair $(\mathfrak{dmrd}_0^{[N]}, \mathfrak{dmrd}_0^{\mu_N})$, preserving the G_N -invariance characterization property established for $(\mathfrak{dmr}_0^{[N]}, \mathfrak{dmrd}_0^{\mu_N})$.
