

# WEIGHTED WEAK-TYPE (1, 1) INEQUALITIES FOR PSEUDO-DIFFERENTIAL OPERATORS WITH SYMBOL IN $S_{0,\delta}^N$

**ABSTRACT.** Let  $T_a$  be a pseudo-differential operator defined by exotic symbol  $a$  in Hörmander class  $S_{0,\delta}^m$  with  $m \in \mathbb{R}$  and  $0 \leq \delta \leq 1$ . It is well-known that the weak type (1,1) behavior of  $T_a$  is not fully understood when the index  $m$  is equal to the possibly optimal value  $-\frac{n}{2} - \frac{n}{2}\delta$  for  $0 \leq \delta < 1$ , and that  $T_a$  is not of weak type (1,1) when  $m = -n$  and  $\delta = 1$ .

In this note, we prove that  $T_a$  is of weighted weak type (1,1) if  $a \in S_{0,\delta}^{-n}$  with  $0 \leq \delta < 1$ . Additionally, we show that the dual operator  $T_a^*$  is of weighted weak type (1,1) if  $a \in L^\infty S_0^{-n}$ . We also identify  $m = -n$  as a critical index for these weak type estimates. As applications, we derive weighted weak type (1,1) estimates for certain classes of Fourier integral operators.

## 1. INTRODUCTION AND MAIN RESULTS

The study of pseudo-differential operators (PDOs) originated with foundational work by Hörmander [15] and Nirenberg [19]. These operators are defined by the following formula:

$$T_a u(x) = \int_{\mathbb{R}^n} e^{i\langle x, \xi \rangle} a(x, \xi) \hat{u}(\xi) d\xi, \quad (1.1)$$

where  $\hat{u}$  denotes the Fourier transform of  $u$  and  $a(x, \xi)$  is the symbol or amplitude of the operator. A key class of symbols is the Hörmander class  $S_{\varrho,\delta}^m$  [14]. Let  $m \in \mathbb{R}$ ,  $0 \leq \varrho, \delta \leq 1$ . A symbol  $a(x, \xi)$  belongs to the Hörmander class  $S_{\varrho,\delta}^m$ , if  $a(x, \xi) \in C^\infty(\mathbb{R}^n \times \mathbb{R}^n)$ , and for any multi-indices  $\alpha, \beta$ , the following inequality holds:

$$|\partial_x^\beta \partial_\xi^\alpha a(x, \xi)| \leq C_{\alpha,\beta} \langle \xi \rangle^{m - \varrho|\alpha| + \delta|\beta|},$$

where  $C_{\alpha,\beta}$  is a constant depending on  $\alpha$  and  $\beta$ .

The theory of pseudo-differential operators (PDOs) has long been an important area of study, particularly with regard to their behavior in both weighted and unweighted  $L^p$  spaces. The fundamental result on  $L^2$  regularity was established by Hörmander [12] and Hounie [13], who showed that if  $a \in S_{\varrho,\delta}^{-\frac{n}{2} \max\{\delta - \varrho, 0\}}$  with  $0 \leq \varrho \leq 1$  and  $0 \leq \delta < 1$ , then  $T_a$  is bounded on  $L^2$ . For endpoint estimates, Stein, in his unpublished lecture notes, showed that  $T_a$  is of weak type (1,1) if  $a \in S_{\varrho,\delta}^{-\frac{n}{2}(1-\varrho)}$  and either  $0 < \delta = \varrho < 1$  or  $0 \leq \delta < \varrho \leq 1$ . A more general result

for a broader range of  $\varrho$  and  $\delta$  was later established by Álvarez and Hounie [1], which can be summarized as follows:

**Theorem 1.1** (Álvarez and Hounie [1]). *Let  $0 < \varrho \leq 1$ ,  $0 \leq \delta < 1$  and  $m \in \mathbb{R}$ . If  $a(x, \xi) \in S_{\varrho, \delta}^m$ , then  $T_a$  is of weak type  $(1, 1)$ , provided*

$$m \leq -\frac{n}{2}(1 - \varrho) - \frac{n}{2} \max\{\delta - \varrho, 0\}.$$

In the special case where  $\delta = 1$  and  $\varrho = 0$ , Guo et.al. [11] construct a symbol  $a \in S_{0,1}^{-n}$  such that  $T_a$  is not weak type  $(1, 1)$ . For results related to the  $(H^1, L^1)$ -estimate and  $(L^\infty, BMO)$ -estimate, see Coifman et. al. [4] for  $\varrho = \delta = 0$ , Stein [34] for  $0 < \delta = \varrho < 1$  or  $0 \leq \delta < \varrho \leq 1$ , and Wang [39] or Álvarez et. al. [1] for  $0 \leq \varrho < \delta < 1$ .

The remaining open question concerns endpoint estimates: for  $a \in S_{0, \delta}^m$  with  $0 \leq \delta < 1$  and  $m \leq \frac{n}{2} - \frac{n}{2}\delta$ , is  $T_a$  of weak type  $(1, 1)$ . While we cannot provide a definitive answer, we can give the result in the weighted case, where the bound on  $m$  is sharp.

**Theorem 1.2.** *Let  $a \in S_{0, \delta}^{-n}$  with  $0 \leq \delta < 1$  and  $\omega \in A_1$ . Then*

$$\|T_a u\|_{L_\omega^{1, \infty}} \lesssim \|u\|_{L_\omega^1}.$$

*This result is sharp.*

Here and below,  $A_p$  denotes the Muckenhoupt class. A nonnegative locally integrable function  $\omega$  belongs to  $A_p$  if there exists a constant  $C > 0$  such that

$$\sup_{Q \subset \mathbb{R}^n} \left( \frac{1}{|Q|} \int_Q \omega(x) dx \right) \left( \frac{1}{|Q|} \int_Q \omega(x)^{\frac{1}{1-p}} dx \right)^{p-1} \leq C \text{ for } 1 < p < \infty,$$

and for  $p = 1$

$$M\omega(x) \leq C\omega(x) \text{ for almost all } x \in \mathbb{R}^n.$$

For  $p = \infty$ , one define  $A_\infty := \cup_{p > 1} A_p$ . The smallest constant appearing in these inequalities is the  $A_p$  constant of  $\omega$  denoted by  $[\omega]_p$ . The following norm notations are used:

$$\|u\|_{L_\omega^p}^p = \int_{\mathbb{R}^n} |u(x)|^p \omega(x) dx \text{ and } \|u\|_{L_\omega^{p, \infty}}^p = \sup_{\lambda > 0} \lambda^p \omega(x \in \mathbb{R}^n : |u(x)| > \lambda).$$

Consider the dual operators  $T_a^*$  defined by the formula

$$T_a^* u(x) = \int_{\mathbb{R}^n} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a(y, \xi) d\xi u(y) dy. \quad (1.2)$$

Interestingly, one can obtain similar estimates for the operators  $T_a^*$  even without smoothness in the frequency variable  $\xi$  of  $a(x, \xi)$ , i.e.  $a \in L^\infty S_0^{-n}$ . Here  $L^\infty S_\varrho^m$  denotes the rough Hörmander class [8, 21] where  $a(x, \xi)$  obeys

$$\|\partial_\xi^\alpha a(\cdot, \xi)\|_{L^\infty(\mathbb{R}^n)} \leq C_\alpha \langle \xi \rangle^{m - \varrho|\alpha|}.$$

Clearly, the inclusion  $S_{\varrho, \delta}^m \subset L^\infty S_\varrho^m$  holds for any  $m \in \mathbb{R}$ ,  $1 \leq \varrho, \delta \leq 1$ .

**Theorem 1.3.** *Let  $a \in L^\infty S_0^{-n}$  and  $\omega \in A_1$ . Then*

$$\|T_a^* u\|_{L_\omega^{1, \infty}} \lesssim \|u\|_{L_\omega^1}.$$

*This result is sharp.*

The study of weighted  $L^p$ -estimates for pseudo-differential operators has been an active area of research, particularly in the 1980s [1, 7, 18, 26], and has seen further improvements by Michalowski et. al. [24, 25] in the late, with more recent work by Wang [38, 39] and Park [29, 30]. These results can be summarized as follows:

**Theorem 1.4** (Wang [39]). *Let  $0 \leq \varrho \leq 1$ ,  $0 \leq \delta < 1$ ,  $1 \leq r \leq 2$  and  $a(x, \xi) \in S_{\varrho, \delta}^{-\frac{n}{r}(1-\varrho)}$ . Suppose  $\omega \in A_{p/r}$  with  $r < p < \infty$ . Then there is a constant  $C$  independent of  $a$  and  $u$ , such that*

$$\|T_a u\|_{L_\omega^p} \leq C \|u\|_{L_\omega^p}. \quad (1.3)$$

The case  $r = 2$ , we refer Chanillo et.al [7] for  $0 \leq \delta < \varrho < 1$ , Miyachi et.al [26] for  $0 < \delta = \varrho < 1$  and Michalowski et.al [25] for  $0 < \varrho < \delta < 1$ . In the case  $r = 1$  and  $\varrho \neq 0$ , we refer Michalowski et.al [24]. In the case  $1 \leq r \leq 2$  and  $0 < \delta \leq \varrho < 1$ , we refer Chen [6] and Park [29, 31]. Notably, the case  $p = r = 1$  has not been fully explored in the existing literature. Our results address this gap for the case  $p = r = 1$  and  $\varrho = 0$ .

The remainder of the paper is organized as follows: Section 2 introduces the necessary preliminaries and contains proofs of the main results, while Section 3 show Counterexamples and some applications to weighted estimates for certain classes of Fourier integral operators.

## 2. THE PROOF OF POINTWISE ESTIMATE FOR THE SHARP MAXIMAL FUNCTION

When  $\varrho > 0$ , PDOs with symbols in  $S_{\varrho, \delta}^m$  are pseudo-local, meaning their kernels are smooth away from the diagonal. However, when  $\varrho = 0$ , these operators are no longer pseudo-local. This departure implies that the Calderón-Zygmund composition method is no longer directly applicable to  $\varrho = 0$ . Nonetheless, it has been found that  $T_a$  is bounded on  $L^1$  with a suitable order. This property and  $L^2$ -estimate for PDOs allow these operators to enjoy local estimates after applying a dyadic partition of unity. Consequently, the local estimate guarantees the convergence of the resulting series.

We are going to get a pointwise estimate for PDOs with respect to Fefferman-Stein sharp maximal function and Hardy-Littlewood maximal function.

**Proposition 2.1.** *If  $a \in S_{0, \delta}^{-n}$  with  $0 \leq \delta < 1$ , then*

$$M^\sharp(T_a f)(x) \lesssim Mf(x).$$

**Proposition 2.2.** *If  $a \in L^\infty S_0^{-n}$  then*

$$M^\sharp(T_a^* f)(x) \lesssim Mf(x).$$

Then, Theorem 1.2 and Theorem 1.3 follows from the famous Fefferman-Stein's inequalities [10]:

$$\|Mu\|_{L_\omega^p} \lesssim \|M^\sharp u\|_{L_\omega^p}, \quad \|Mu\|_{L_\omega^{p, \infty}} \lesssim \|M^\sharp u\|_{L_\omega^{p, \infty}}$$

for  $0 < p < \infty$  and  $\omega \in A_\infty$ . Moreover, one can get the following results:

**Theorem 2.3.** *Let  $a \in S_{0, \delta}^{-n}$  with  $0 \leq \delta < 1$  and  $\omega \in A_p$  with  $1 < p < \infty$ . Then*

$$\|T_a u\|_{L_\omega^p} \lesssim \|u\|_{L_\omega^p}.$$

**Theorem 2.4.** *Let  $a \in L^\infty S_0^{-n}$  and  $\omega \in A_p$  with  $1 < p < \infty$ . Then*

$$\|T_a^* u\|_{L_\omega^p} \lesssim \|u\|_{L_\omega^p}.$$

For a function  $u \in L^1_{loc}(\mathbb{R}^n)$ , we define the Fefferman-Stein sharp maximal function and Hardy-Littlewood maximal function by the formula:

$$M^\sharp u(x) = \sup_{x \in Q} \inf_c \frac{1}{|Q|} \int_Q |u(y) - c| dy \quad \text{and} \quad Mu(x) = \sup_{x \in Q} \frac{1}{|Q|} \int_Q |u(y)| dy$$

respectively, where  $c$  moves over all complex number, and  $Q$  containing  $x$  moves over all cubes with its sides parallel to the coordinate axes.

Now we are going to prove Proposition 2.1 and Proposition 2.2. Before this, we state two useful facts

**Proposition 2.5.** *Let  $0 \leq \varrho \leq 1$ ,  $0 \leq \delta < 1$  and  $a(x, \xi) \in S^m_{\varrho, \delta}$ . If*

$$m < -\frac{n}{2}(1 - \varrho) - \frac{n}{2} \max\{\delta - \varrho, 0\},$$

then

$$\|T_a u\|_{L^1} \lesssim \|u\|_{L^1}.$$

**Proposition 2.6.** *Let  $0 \leq \varrho \leq 1$  and  $a(x, \xi) \in L^\infty S^m_\varrho$ . If*

$$m < -\frac{n}{2}(1 - \varrho),$$

then

$$\|T_a^* u\|_{L^1} \lesssim \|u\|_{L^1}.$$

Their proofs is trivial. See [1] for the case  $0 < \varrho \leq 1$ , the proofs are contained in  $(H^1, L^1)$  estimates for  $T_a$  and  $T_a^*$  respectively. The case  $\varrho = 0$  can be gotten by a similar argument.

Let

$$K(x, y) = \frac{1}{(2\pi)^n} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a(x, \xi) d\xi \quad \text{and} \quad K^*(x, y) = \frac{1}{(2\pi)^n} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a(y, \xi) d\xi. \quad (2.1)$$

Then  $T_a$  and  $T_a^*$  can be written as

$$T_a u(x) = \int_{\mathbb{R}^n} K(x, y) u(y) dy \quad \text{and} \quad T_a^* u(x) = \int_{\mathbb{R}^n} K^*(x, y) u(y) dy \quad (2.2)$$

respectively. Now we introduce the standard Littlewood-Paley partition of unity. Let  $C > 1$  be a constant. Set  $E_{-1} = \{\xi : |\xi| \leq 2C\}$ ,  $E_j = \{\xi : C^{-1}2^j \geq |\xi| \leq C2^{j+1}\}$ ,  $j = 0, 1, 2, \dots$ .

**Lemma 2.7.** *There exist  $\psi_{-1}(\xi), \psi(\xi) \in C_0^\infty$ , such that*

- (1)  $\text{supp } \psi \subset E_0$ ,  $\text{supp } \psi_{-1} \subset E_{-1}$ ;
- (2)  $0 \leq \psi \leq 1$ ,  $0 \leq \psi_{-1} \leq 1$ ;
- (3)  $\psi_{-1}(\xi) + \sum_{j=1}^{\infty} \psi(2^{-j}\xi) = 1$ .

By Lemma 2.7, the symbol  $a(x, \xi)$  can be written as

$$a(x, \xi) = a(x, \xi) \left( \psi_{-1}(\xi) + \sum_{j=1}^{\infty} \psi(2^{-j}\xi) \right) =: \sum_{j=0}^{\infty} a_j(x, \xi).$$

Consequently, the operator  $T_a$  and  $T_a^*$  can be decomposed as

$$T_a u(x) = \sum_{j=0}^{\infty} T_j u(x) \text{ and } T_a^* u(x) = \sum_{j=0}^{\infty} T_j^* u(x), \quad (2.3)$$

respectively, where

$$T_j u(x) = \int_{\mathbb{R}^n} K_j(x, y) u(y) dy \quad \text{with} \quad K_j(x, y) = \frac{1}{(2\pi)^n} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a_j(x, \xi) d\xi \quad (2.4)$$

$$T_j^* u(x) = \int_{\mathbb{R}^n} K_j^*(x, y) u(y) dy \quad \text{with} \quad K_j^*(x, y) = \frac{1}{(2\pi)^n} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a_j(y, \xi) d\xi \quad (2.5)$$

In this note, we denote by  $Q(x_0, l)$  a fixed cube centered at  $x_0$  with the side length  $l > 0$ .

**Lemma 2.8.** *Let  $l < 1$  and  $j$  be a positive integer. If  $a \in S_{0,\delta}^{-n}$  with  $0 \leq \delta < 1$ , then*

$$\int_{\mathbb{R}^n} |u(y)| |K_j(x, y) - K_j(z, y)| dy \lesssim 2^j l M u(x_0), \quad \forall x, z \in Q(x_0, l) \quad (2.6)$$

If  $a \in L^\infty S_0^{-n}$ , then

$$\int_{\mathbb{R}^n} |u(y)| |K_j^*(x, y) - K_j^*(z, y)| dy \lesssim 2^j l M u(x_0), \quad \forall x, z \in Q(x_0, l). \quad (2.7)$$

*Proof.* The proof of (2.6) and (2.7) is standard. We only show a outline of proving (2.7). Integrand of left side of (2.7) can be bounded by

$$\int_{\mathbb{R}^n} |u(y)| \left| \int_{\mathbb{R}^n} (e^{i\langle x-y, \xi \rangle} - e^{i\langle z-y, \xi \rangle}) a_j(y, \xi) d\xi \right| dy. \quad (2.8)$$

Break up this integrand as follows

$$\int_{|y-x_0| \leq 2} + \int_{|y-x_0| > 2}.$$

A direct calculation gives the first term is bounded by  $2^j l M u(x_0)$ , and integration by parts with respect to the variable  $\xi$  yields that the second term has the same bound. Thus the proof is completed.  $\square$

**Lemma 2.9.** *Let  $l < 1$  and  $j$  be a positive integer satisfying  $2^j \geq l^{-1}$ . If  $a \in S_{0,\delta}^{-n-\frac{n}{2}\delta}$  with  $0 \leq \delta < 1$  then*

$$\frac{1}{|Q(x_0, l)|} \int_{Q(x_0, l)} |T_j u(x)| dx \lesssim 2^{-j\frac{n}{2}} l^{-\frac{n}{2}} M u(x_0). \quad (2.9)$$

If  $a \in L^\infty S_0^{-n}$ , then

$$\frac{1}{|Q(x_0, l)|} \int_{Q(x_0, l)} |T_j^* u(x)| dx \lesssim 2^{-j\frac{n}{2}} l^{-\frac{n}{2}} M u(x_0). \quad (2.10)$$

*Proof.* We prove (2.9) first. Hölder's inequality and Minkowski's inequality implies that the left hand in (2.9) can be bounded by

$$l^{-\frac{n}{2}} \int_{\mathbb{R}^n} \left( \int_{|x-x_0|<l} |K_j(x, y)|^2 dx \right)^{\frac{1}{2}} |u(y)| dy.$$

So, it suffices to show

$$\int_{\mathbb{R}^n} \left( \int_{|x-x_0|<l} |K_j(x, y)|^2 dx \right)^{\frac{1}{2}} |u(y)| dy \lesssim 2^{-j\frac{n}{2}} Mu(x_0).$$

Break up the integral with respect to the variable  $y$  as follows

$$\int_{|y-x_0|\leq 2} + \int_{|y-x_0|>2}. \quad (2.11)$$

Let  $c_j(x, \xi) = a_j(x, \xi)|\xi|^n$  and  $\widehat{h_j(\xi)} = |\xi|^{-n}\chi_j(\xi)$ . Then we can write

$$K_j(x, y) = \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} a_j(x, \xi) d\xi = \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} c_j(x, \xi) \widehat{h_j(\xi)} d\xi = T_{c_j} h_j(x-y)$$

So, the first term in (2.11) can be wrote as

$$\int_{|y-x_0|\leq 2} \left( \int_{\mathbb{R}^n} |T_{c_j} h_j(x-y)|^2 dx \right)^{\frac{1}{2}} |u(y)| dy$$

Notice  $c_j \in S_{0, \delta}^{-\frac{n}{2}\delta}$ . Moreover  $T_{c_j}$  is bounded on  $L^2$ . So it can be bounded by

$$\int_{|y-x_0|\leq 2} |u(y)| dy \left( \int_{\mathbb{R}^n} |h_j(\xi)|^2 d\xi \right)^{\frac{1}{2}} \leq 2^{-j\frac{n}{2}} Mu(x_0).$$

Now we estimate the second term in (2.11). For positive integer  $N > n/2$ , denote  $\tilde{c}_j(x, \xi) = \Delta_\xi^N a_j(x, \xi)|\xi|^n$  and  $\widehat{\tilde{h}_j(\xi)} = |\xi|^{-n}\chi_j(\xi)$ . Then we can write

$$K_j(x, y) = \frac{1}{|x-y|^{2N}} \int_{\mathbb{R}^n} e^{i\langle x-y, \xi \rangle} \Delta_\xi^N a_j(x, \xi) d\xi = \frac{1}{|x-y|^{2N}} T_{\tilde{c}_j} \tilde{h}_j(x-y)$$

So, the second term in (2.11) can be wrote as

$$\int_{|y-x_0|>2} \left( \int_{|x-x_0|<l} \left| \frac{1}{|y-x|^{2N}} T_{\tilde{c}_j} \tilde{h}_j(x-y) \right|^2 dx \right)^{\frac{1}{2}} |u(y)| dy.$$

Notice that  $|y-x| \sim |y-x_0|$  for any  $|x-x_0| < l < 1$  and  $|y-x_0| > 2 \geq 2l$ . Then it is bounded by

$$\int_{|y-x_0|>2} \frac{1}{|y-x_0|^{2N}} \left( \int_{\mathbb{R}^n} |T_{\tilde{c}_j} \tilde{h}_j(x-y)|^2 dx \right)^{\frac{1}{2}} |u(y)| dy.$$

Clearly,  $\tilde{c}_j \in S_{0, \delta}^{-\frac{n}{2}\delta}$ . So  $L^2$  boundedness of  $T_{\tilde{c}_j}$  gives that it has bound

$$\int_{|y-x_0|>2} \frac{1}{|y-x_0|^{2N}} |u(y)| dy \left( \int_{\mathbb{R}^n} |\tilde{h}_j(\xi)|^2 d\xi \right)^{\frac{1}{2}} \leq 2^{-j\frac{n}{2}} Mu(x_0).$$

For (2.10), it be got by the same argument as above with  $L^2$  boundedness of pseudo-differential operators replaced by Parseval's identity and there is no use for the smoothness of variable  $y$  of  $a(y, \xi)$ . So the proof is finished.  $\square$

**Lemma 2.10.** *Let  $l < 1$  and  $j$  be a positive integer satisfying  $2^j \geq l^{-1}$ . If  $a \in S_{0,\delta}^{-n}$  with  $0 < \delta < 1$ , then for any  $\lambda \geq 1$ ,*

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \lesssim (2^{j\delta} l^\lambda + l^{-\frac{n\lambda}{2}} 2^{-j\frac{n}{2}}) M u(x_0).$$

*Proof.* If  $\lambda > 1$ , then  $l^\lambda < l$ . Take integer  $L$  such that it is the first number no less than  $l^{1-\lambda}$ , that is  $L - 1 < l^{1-\lambda} \leq L$ . Then there are  $L^n$  cubes with the same side length  $l^\lambda$  covering  $Q(x_0, l)$ . Moreover, we have

$$Q(x_0, l) \subset \cup_{i=1}^{L^n} Q(x_i, l^\lambda) \subset Q(x_0, 2l).$$

Clearly,  $L^n \leq 2^n l^{n(1-\lambda)}$ . Denote

$$T_{j,i} u(x) = \int_{\mathbb{R}^n} e^{i\langle x, \xi \rangle} a(x_i, \xi) \psi(2^{-j}\xi) \hat{u}(\xi) d\xi. \quad (2.12)$$

$$\begin{aligned} & \frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \\ & \leq \frac{1}{|Q|} \sum_{i=1}^{L^n} \left( \int_{Q(x_i, l^\lambda)} |T_j u(x) - T_{j,i} u(x)| dx + \int_{Q(x_i, l^\lambda)} |T_{j,i} u(x)| dx \right). \end{aligned}$$

Lemma 2.8 and Lemma 2.9 imply

$$|T_j f(x) - T_{j,i} f(x)| \lesssim l^\lambda 2^{j\delta} M u(x_0)$$

and

$$\int_{Q(x_i, l^\lambda)} |T_{j,i} u(x)| dx \lesssim 2^{-j\frac{n}{2}} l^{\frac{n\lambda}{2}} M u(x_0),$$

respectively. Recall  $L^n \leq 2^n l^{n(1-\lambda)}$ , the desired estimate can be gotten immediately.

If  $\lambda = 1$ , we define

$$T_{j,0} u(x) = \int_{\mathbb{R}^n} e^{i\langle x, \xi \rangle} a(x_0, \xi) \psi(2^{-j}\xi) \hat{u}(\xi) d\xi. \quad (2.13)$$

Then the desired estimate can be got by the same argument as above with  $T_{j,i} u$  replaced by  $T_{j,0} u$ . So we complete the proof.  $\square$

Here, the range of  $\lambda$  can be extended to  $[1, \infty)$ . However, to make some sums convergent,  $\lambda$  has to be confined to a finite range. To this end, fix positive integer  $N_\delta > \frac{2n}{1-\delta} + n$  and take

$$\max\{0, \frac{n}{2}(1-\delta) - \frac{nN_\delta}{N_\delta - n}\} < \theta_0 < \frac{n}{2}(1-\delta) - \frac{n^2}{N_\delta - n}.$$

Denote

$$T_\delta = -\frac{n^2}{N_\delta} + (1 - \frac{n}{N_\delta}) (\frac{n}{2}(1-\delta) - \theta_0). \quad (2.14)$$

Clearly  $\theta_0 > 0$  is well defined and  $T_\delta > 0$ .

**Lemma 2.11.** *Let  $Q(x_0, l)$  be a fixed cube with side length  $l < 1$ . For any positive integer  $j$  with  $l^{-\frac{n-n^2/N_\delta}{T_\delta}} \leq 2^j$ , if  $a \in S_{0,\delta}^{-n}$  with  $0 \leq \delta < 1$  then*

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \lesssim 2^{-jT_\delta} l^{\frac{n^2}{N_\delta} - n} Mu(x_0),$$

where  $T_\delta$  is given by (2.14).

*Proof.* Denote

$$\Gamma_0 = l^{\frac{n}{N_\delta}} 2^{j\frac{n}{N_\delta} + j\frac{1}{N_\delta} \left( \frac{n}{2}(1-\delta) - \theta_0 \right)},$$

Set  $u_1(x) = u(x)\chi_{Q(x_0, 2\Gamma_0)}(x)$  and  $u_2(x) = u(x) - u_1(x)$ . Then

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \leq \frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u_1(x)| dx + \frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u_2(x)| dx. \quad (2.15)$$

Notice that  $a_j(x, \xi) \in S_{0,\delta}^{-\frac{n}{2} - \frac{n}{2}\delta - \theta_0}$  with bounds  $\lesssim 2^{-j\frac{n}{2}(1-\delta) + j\theta_0}$ . The  $L^1$ -estimate of  $T_j$  (Proposition 2.1) gives that

$$\frac{1}{|Q|} \int_Q |T_j u_1(x)| dx \lesssim 2^{-j\frac{n}{2}(1-\delta) + j\theta_0} \Gamma_0^n l^{-n} Mu(x_0) = 2^{-jT_\delta} l^{\frac{n^2}{N_\delta} - n} Mu(x_0). \quad (2.16)$$

Recall  $\max\{0, \frac{n}{2}(1-\delta) - \frac{nN_\delta}{N_\delta - n}\} < \theta_0 < \frac{n}{2}(1-\delta) - \frac{n^2}{N_\delta - n}$  and  $2^j \geq l^{-\frac{n-n^2/N_\delta}{T_\delta}}$ . Then we have  $\frac{n-n^2/N_\delta}{T_\delta} > 1$  and  $2^j \geq l^{-\frac{n-n^2/N_\delta}{T_\delta}} \geq l^{-1}$  which implies that

$$\Gamma_0 = (l2^j)^{\frac{n}{N_\delta}} 2^{j\frac{1}{N_\delta} \left( \frac{n}{2}(1-\delta) - \theta_0 \right)} > 1 > l.$$

Consequently, one have  $|y-x| \sim |y-x_0|$  for  $\forall x \in Q(x_0, l)$  and  $\forall y \in Q^C(x_0, 2\Gamma_0)$ . Integrating by parts  $N_\delta$ -th with respect to  $\xi$  gives that

$$|T_j u_2(x)| \lesssim 2^{jn} \Gamma_0^{(n-N_\delta)} Mu(x_0) = 2^{-jT_\delta} l^{\frac{n^2}{N_\delta} - n} Mu(x_0). \quad (2.17)$$

Clearly, the desired estimate follows from (2.15), (2.16) and (2.17).  $\square$

Now we consider the case  $l \geq 1$ , which can be done by a similar method as above lemma.

**Lemma 2.12.** *Let  $l \geq 1$  and  $j$  be a positive integer. Suppose  $0 \leq \delta < 1$ ,  $0 < \theta_1 < \frac{n}{2}(1-\delta)$  and  $\epsilon > 0$ . If  $a \in S_{0,\delta}^{-n}$ , then for any positive integer  $N > n$*

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \lesssim (2^{-j\frac{n}{2}(1-\delta) + j\theta_1 + j\epsilon n} + 2^{-j\epsilon(N-n)} l^{-(N-n)}) Mu(x_0). \quad (2.18)$$

If  $a \in L^\infty S_{0,\delta}^{-n}$ , then for any positive integer  $N > n$

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j^* u(x)| dx \lesssim (2^{-j\frac{n}{2} + j\theta_1 + j\epsilon n} + 2^{-j\epsilon(N-n)} l^{-(N-n)}) Mu(x_0). \quad (2.19)$$



*Proof.* Denote

$$\Gamma = l2^{j\epsilon},$$

Set  $u_3(x) = u(x)\chi_{Q(x_0, 2\Gamma)}(x)$  and  $u_4(x) = u(x) - u_3(x)$ . Then

$$\frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx \leq \frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u_3(x)| dx + \frac{1}{|Q|} \int_{Q(x_0, l)} |T_j u_4(x)| dx. \quad (2.20)$$

Notice that  $a_j(x, \xi) \in S_{0, \delta}^{-\frac{n}{2} - \frac{n}{2}\delta - \theta_1}$  with bounds  $\lesssim 2^{-j\frac{n}{2}(1-\delta) + j\theta_1}$ . The  $L^1$ -estimate of  $T_j$  give that

$$\frac{1}{|Q|} \int_Q |T_j u_3(x)| dx \lesssim 2^{-j\frac{n}{2}(1-\varrho) + j\theta_1 + j\epsilon n} M u(x_0). \quad (2.21)$$

Notice that  $|y - x| \sim |y - x_0|$  for  $\forall x \in Q(x_0, l)$  and  $\forall y \in Q^C(x_0, 2\Gamma)$ . So integrating by parts gives that

$$|T_j u_4(x)| \lesssim 2^{-j\epsilon(N-n)} l^{-(N-n)} M u(x_0). \quad (2.22)$$

Clearly, the desired estimate follows from (2.15), (2.16) and (2.17).  $\square$

*Proof of Theorem 1.3.* Without loss of generality, we assume that the symbol  $a(x, \xi)$  vanishes for  $|\xi| \leq 1$ . Let  $Q = Q(x_0, l)$  denote the cube centered at  $x_0$  with the side length  $l$ . We are going to prove

$$\frac{1}{|Q|} \int_Q |T_a^* u(x) - C_Q| dx \lesssim M u(x_0), \quad (2.23)$$

where  $C_Q = \frac{1}{|Q|} \int_Q T_a^* u(y) dy$ . By Lemma 2.7, it suffices to prove

$$\sum_j \frac{1}{|Q|^2} \int_Q \int_Q |T_j^* u(x) - T_j^* u(y)| dy dx \lesssim M u(x_0). \quad (2.24)$$

For the case  $l \geq 1$ , the left hand above can be controlled by

$$\sum_j \frac{2}{|Q|} \int_{Q(x_0, l)} |T_j^* u(x)| dx.$$

Applying Lemma 2.12 with taking  $0 < \epsilon < \frac{1}{2} - \frac{\theta_1}{n}$ , one can get the desired estimate immediately.

For the case  $l < 1$ . Break up the sum in the left hand in (2.24) as follows

$$\sum_{2^j < l^{-1}} \frac{1}{|Q|^2} \int_Q \int_Q |T_j^* u(x) - T_j^* u(y)| dy dx + \sum_{l^{-1} < 2^j} \frac{2}{|Q|} \int_{Q(x_0, l)} |T_j^* u(x)| dx$$

Then, (2.7) and (2.10) give that the corresponding sum is bounded by

$$\sum_{2^j < l^{-1}} 2^j l M u(x_0) + \sum_{l^{-1} < 2^j} 2^{-j\frac{n}{2}} l^{-\frac{n}{2}} M u(x_0) \lesssim M u(x_0),$$

respectively. So the proof is finished.  $\square$

*Proof of Theorem 1.2.* It can be proved by a similar argument as above. Clearly, it suffices to show

$$\sum_j \frac{1}{|Q|^2} \int_Q \int_Q |T_j u(x) - T_j u(y)| dy dx. \quad (2.25)$$

For the case  $l \geq 1$ . By (2.18) in Lemma 2.12, we can get that it can be bounded by

$$\sum_j (2^{-j\frac{n}{2}(1-\delta)+j\theta_1+j\epsilon n} + 2^{-j\epsilon(N-n)} l^{-(N-n)}) Mu(x_0).$$

Take  $0 < \epsilon < \frac{1-\delta}{2} - \frac{\theta_1}{n}$ , then the sum is convergent.

For the case  $l < 1$ . If  $\delta = 0$ , break up the sum in (2.25) as follows

$$\sum_{2^j < l^{-1}} + \sum_{l^{-1} < 2^j}.$$

Then Lemma 2.8 and Lemma 2.9 imply that (2.25) can be bounded by

$$\sum_{2^j < l^{-1}} 2^j l Mu(x_0) + \sum_{l^{-1} < 2^j} 2^{-j\frac{n}{2}} l^{-\frac{n}{2}} Mu(x_0) \lesssim Mu(x_0).$$

If  $0 < \delta < 1$ , break up the sum further

$$\sum_{2^j < l^{-1}} + \sum_{l^{-1} \leq 2^j \leq l^{-(n-n^2/N_\delta)/T_\delta}} + \sum_{l^{-(n-n^2/N_\delta)/T_\delta} < 2^j},$$

where  $N_\delta$  and  $T_\delta$  are given in Lemma 2.11. Using Lemma 2.8 and Lemma 2.11, one can get that the first term and the last term are bounded by

$$\sum_{2^j < l^{-1}} 2^j l Mu(x_0) + \sum_{l^{-(n-n^2/N_\delta)/T_\delta} < 2^j} 2^{-jT_\delta} l^{\frac{n^2}{N_\delta} - n} Mu(x_0) \lesssim Mu(x_0).$$

For the second term, we write

$$\begin{aligned} \sum_{l^{-1} < 2^j \leq l^{-(n-n^2/N_\delta)/T_\delta}} \frac{2}{|Q|} \int_Q |T_j u(x)| dx &= \left( \sum_{l^{-1} < 2^j \leq l^{-\frac{1}{\delta}}} + \sum_{l^{-\frac{1}{\delta}} < 2^j \leq l^{-\frac{1}{\delta^2}}} + \dots + \sum_{l^{-\frac{1}{\delta^{k-1}}} < 2^j \leq l^{-\frac{1}{\delta^k}}} \right. \\ &\quad \left. + \dots + \sum_{l^{-\frac{1}{\delta^{\gamma-1}}} < 2^j \leq l^{-(n-n^2/N_\delta)/T_\delta}} \right) \frac{2}{|Q|} \int_{Q(x_0, l)} |T_j u(x)| dx, \end{aligned}$$

where  $\gamma$  is the first positive integer such that  $\frac{1}{\delta^\gamma} \geq \frac{n-n^2/N_\delta}{T_\delta}$ . Then take  $\lambda = \frac{1}{\delta^k}$ ,  $k = 0, 1, \dots, \gamma - 1$  in Lemma 2.10 respectively, we can see that each sum above is bounded by  $Mu(x_0)$ .  $\square$

### 3. APPLICATIONS TO FOURIER INTEGRAL OPERATORS

Fourier integral operators (FIOs), introduced by Hörmander in [16], can be formally expressed as

$$T_{a,\varphi} u(x) = \int_{\mathbb{R}^n} e^{i\varphi(x,\xi)} a(x,\xi) \hat{u}(\xi) d\xi, \quad (3.1)$$

where  $a$  is the amplitude function and  $\varphi$  is the phase function. The regularity of these operators has been extensively studied since the 1980s in works such as [2, 3, 9, 16, 17, 23, 28, 32, 35, 37]. More recently, some results have been revisited in [5, 8, 22, 36, 40, 41]. However, to the best of our knowledge, there has been limited research on the weighted regularity of these operators, with notable contributions in [8, 33].

In this study, we focus on a class of phase functions, originally defined by Dos Santos Ferreira et.al. [8].

**Definition 3.1.** ( $\Phi^k$ ) A real-valued function  $\varphi(x, \xi)$  belongs to the class  $\Phi^k$  if the following conditions hold:

- $\varphi(x, \xi) \in C^\infty(\mathbb{R}^n \times \mathbb{R}^n \setminus \{0\})$ ,
- $\varphi(x, \xi)$  is positively homogeneous of degree 1 in the frequency variable  $\xi$ ,
- For any multi-indices  $\alpha$  and  $\beta$  with  $|\alpha| + |\beta| \geq k$ , there exists a positive constant  $C_{\alpha, \beta}$  such that

$$\sup_{(x, \xi) \in \mathbb{R}^n \times \mathbb{R}^n \setminus \{0\}} |\xi|^{-1+|\alpha|} |\partial_\xi^\alpha \partial_x^\beta \varphi(x, \xi)| \leq C_{\alpha, \beta}.$$

**Definition 3.2.** ( $L^\infty \Phi^k$ ) A real-valued function  $\varphi(x, \xi)$  belongs to the phase class  $L^\infty \Phi^k$  if it satisfies the following conditions:

- $\varphi(x, \xi)$  is positively homogeneous of degree 1 in the frequency variable  $\xi$ ,
- $\varphi(x, \xi)$  is smooth on  $\mathbb{R}^n \setminus \{0\}$  in the frequency variable  $\xi$  and is bounded measurable in the spatial variable  $x$ ,
- For all multi-indices  $|\alpha| \geq k$ , it satisfies

$$\sup_{\xi \in \mathbb{R}^n} |\xi|^{-1+|\alpha|} \|\partial_\xi^\alpha \varphi(x, \xi)\|_{L^\infty(\mathbb{R}^n)} \leq C_\alpha,$$

where  $C_\alpha$  is a positive constant depending only on  $\alpha$ .

Let  $b(x, \xi) = a(x, \xi) e^{i(\varphi(x, \xi) - \langle x, \xi \rangle)}$ , so that we can rewrite  $T_{a, \varphi} u(x)$  as:

$$T_{a, \varphi} u(x) = \int_{\mathbb{R}^n} e^{i\langle x, \xi \rangle} e^{i(\varphi(x, \xi) - \langle x, \xi \rangle)} a(x, \xi) \hat{u}(\xi) d\xi = T_b u(x).$$

If  $a \in S_{1, \delta}^{-n}$  and  $\varphi(x, \xi) - \langle x, \xi \rangle \in \Phi^1$ , then  $b(x, \xi) \in S_{0, \delta}^{-n}$ . Therefore, by Theorem 1.2, we obtain the following result:

**Theorem 3.1.** Let  $a \in S_{1, \delta}^{-n}$  with  $0 \leq \delta < 1$  and  $\varphi(x, \xi) - \langle x, \xi \rangle \in \Phi^1$ . Then the operators  $T_{a, \varphi}$  defined by (3.1) satisfy:

$$\|T_{a, \varphi} u\|_{L_\omega^1, \infty} \lesssim \|u\|_{L_\omega^1}.$$

Similarly, defining the dual operator by

$$T_{a, \varphi}^* u(x) = \int_{\mathbb{R}^n} \int_{\mathbb{R}^n} e^{i(\varphi(y, \xi) - \langle x, \xi \rangle)} a(y, \xi) d\xi u(y) dy, \quad (3.2)$$

we obtain the following result:

**Theorem 3.2.** Let  $a \in L^\infty S_{1, \delta}^{-n}$  and  $\varphi(x, \xi) - \langle x, \xi \rangle \in L^\infty \Phi^1$ . Then the operators  $T_{a, \varphi}^*$  defined by (3.2) satisfy:

$$\|T_{a, \varphi}^* u\|_{L_\omega^1, \infty} \lesssim \|u\|_{L_\omega^1}.$$

Under the condition of Theorem 3.1, we can use Proposition 2.1 to obtain:

$$M^\sharp(T_{a,\varphi}u)(x) \lesssim Mu(x).$$

Moreover,  $T_{a,\varphi}$  is a bounded operator on  $L^p_\omega$  for  $1 < p < \infty$  and  $\omega \in A_p$ . A similar result holds for  $T_{a,\varphi}^*$  under the condition of Theorem 3.2.

**Counterexamples :** The sharpness of Theorem 1.2 and Theorem 1.3 follows from following counterexample going back to [20]. Let  $0 > m > -n$  and  $a(x, \xi) = e^{i\xi_1}(1 + |\xi|^2)^{\frac{m}{2}}$ , where  $\xi_1$  is the first component of  $\xi \in \mathbb{R}^n$ . Clearly  $a(x, \xi) \in S_{0,0}^m$ . Consider PDOs

$$T_a u(x) = \int_{\mathbb{R}^n} e^{i\langle x, \xi \rangle + i\xi_1} (1 + |\xi|^2)^{\frac{m}{2}} \hat{u}(\xi) d\xi$$

Choose  $a$  and  $b$  so that  $0 < -m < a < n$ ,  $0 < b < n$ ,  $a + b + m > n$ , and let

$$u(x) = |x|^{-a} \chi_{|x| < \eta}(x), \quad \omega = |x - x_0|^{-b},$$

where  $x_0 = (1, 0, \dots, 0)$  and  $\eta > 0$  small enough. Clearly,  $u \in L^1$  and  $\omega \in A_1$ . Now we check  $T_a u \notin L_\omega^{1,\infty}$ . Notice that

$$T_a u(x) = G_{-m}(\cdot - x_0) * u(x),$$

where  $G_{-m}(x) = \left( (1 + |\cdot|^2)^{\frac{m}{2}} \right)^\wedge(x)$  is the Bessel potential of order  $-m$ . It is well known  $G_{-m}(x) \sim |x|^{-n-m}$  near  $x = 0$ . Then we see that

$$T_a u(x) \geq C_0 |x - x_0|^{-a-m} \text{ near } x = x_0.$$

Therefore,  $\forall \epsilon > 0$  small enough

$$\begin{aligned} & C_0 \epsilon^{-a-m} \omega(\{x \in \mathbb{R}^n : |T_a u(x)| > C_0 \epsilon^{-a-m}\}) \\ & \geq C_0 \epsilon^{-a-m} \omega(\{x \in \mathbb{R}^n : |T_a u(x)| > C_0 \epsilon^{-a-m}, |x - x_0| < \epsilon\}) \\ & \geq C_0 \epsilon^{-a-m} \omega(\{x \in \mathbb{R}^n : |x - x_0| < \epsilon\}) \\ & \geq C_0 \epsilon^{-a-m-b+n} \end{aligned}$$

The proof is finished by the fact  $-a - m - b + n < 0$ .
