LONG-TERM BEHAVIOR FOR WAVE EQUATION WITH NONLINEAR DAMPING AND SUPER-CUBIC NONLINEARITY

ABSTRACT. In this paper, we consider the semilinear wave equation involving the nonlinear damping term $g(u_t)$ and nonlinearity f(u). The well-posedness of the weak solution satisfying some additional regularity is achieved under the wider ranges of the exponents g and f. Moreover, the existence of global attractor and exponential attractor are proved.

1. INTRODUCTION

In this paper, we are concerned with the following nonlinear damped wave equation with periodic boundary conditions

$$\begin{cases} u_{tt} + g(u_t) - \Delta u + u + f(u) = \phi, \ (t, x) \in \mathbb{R}_+ \times \mathbb{T}^3, \\ u(0, x) = u_0, \ u_t(0, x) = u_1, x \in \mathbb{T}^3, \end{cases}$$
(1.1)

where $\mathbb{T}^3 = [0, 2\pi]^3$ is the torus in \mathbb{R}^3 , the external force term $\phi \in L^2(\mathbb{T}^3)$ is independent of time.

We impose the following assumptions on the nonlinear damping g and the nonlinearity f.

Assumptions on nonlinear damping g. Let $g \in C^1(\mathbb{R})$ satisfy g(0) = 0 and

$$c_1(|s|^m - c_2) \le |g(s)| \le c_3(|s|^m + 1), \ 1 < m \le \frac{7}{5},$$
 (G1)

and

$$\gamma \le g'(s) \le c(1+g(s)s)^{2/3},$$
 (G2)

where $\gamma > 0$ is a positive constant.

Assumptions on nonlinearity f. Let $f \in C^2(\mathbb{R})$, with f(0) = f'(0) = 0 and satisfy the following growth condition

$$|f''(s)| \le c(1+|s|^{p-2}), \ 3 \le p \le 7-2m,$$
 (F1)

along with the dissipative condition

$$\liminf_{|s| \to \infty} \frac{f(s)}{s} > 0.$$
 (F2)

Concerning the phase-spaces for our problem, we consider $\mathcal{H} = \mathcal{H}^1(\mathbb{T}^3) \times L^2(\mathbb{T}^3)$ and the fractional space $\mathcal{H}^{\sigma} = H^{\sigma+1}(\mathbb{T}^3) \times H^{\sigma}(\mathbb{T}^3)$.

The well-posedness and longtime behavior of problem (1.1) has been discussed widely. Lions and Strauss[9] established the existence of the weak solution in \mathbb{R}^3 for the case of $2 \leq p \leq m$. Raugel[14] established the global attractor subject to restriction $m_1 \leq g'(s) \leq c(1+|s|^{2/3})$ with m_1 sufficiently large. Feireisl[6] discussed the well-posedness of problem (1.1) when $p < 6m/(m+1), 1 \leq m < 5$, then proved the existence of the global attractor. Chueshov and Lasiecka[3] considered the existence of global attractors and their properties (structure, dimension, etc.) in the case of m < 5, p < 3, with large damping parameter when p = 3, they gave a general abstract framework for discussing the asymptotic behaviors of solutions for evolutionary equation with second-order time term, see [4] for more details. Sun[16] proved the existence of the global attractor of the weak solution in the case of r = 1, $p \leq 3$, m < 5. Under the condition p < 3, $r = m \leq 5$, Nakao[11] gave a polynomial absorbing rate of absorbing ball and the existence of the global attractor. Khanmamedov[8] established the existence of the global attractor of the weak solution when $p \leq 3$, $m \leq 5$.

With regard to the higher growth nonlinearity, some more complicated estimates are required. Recently, Todorova[17] has established the $L^4(0,T;L^{12}(R^3))$ a priori space-time estimate by choosing a suitable nonlinear test function in the case of $m = \frac{5}{3}$. Thereby the well-posedness of weak solution in \mathbb{R}^3 was obtained, they also proved the well-posedness of strong solution on \mathbb{R}^3 for $m \ge 2$. Inspired by Todorova[17], the authors[10] proved a priori estimate and extended the results of both the well-posedness and global attractor up to the range $p \le \min\{3m, 5\}, m \le 5$.

We summarize the known results through Figure 1 for clarity, the well-posedness of weak soluton, the existence and regularity of the global attractor are all solved in region I, II and III.



Figure 1. Region of exponents for damping term and nonlinearity

However, there still exists a gap. The a priori space-time estimate obtained in [10] is strongly depends on the lower growth condition of nonliear damping g. However, when the growth exponent m is near to 1, the a priori space-time estimate will not be enough to deal with the higher growth of nonlinearity f. In this paper, we will fix the gap partially. In detail, in the case of $3 \le p \le 7 - 2m$, we can prove the the weak solution is well-posed provided the solutoin has an extra space-time regularity, then, the existence and regularity of the global attractor are established.

Throughout the paper, the symbol C stands for a generic constant indexed occasionally for the sake of clarity.

2. Well-posedness

Definition 2.1. [Weak solution] A function u satisfies

$$u \in C([0,T]; H^1(\mathbb{T}^3)), \ u_t \in C([0,T]; L^2(\mathbb{T}^3)), \ g(u_t) \in L^{\frac{1}{m}+1}([0,T] \times \mathbb{T}^3)$$

possessing the properties $u(0) = u_0$ and $u_t(0) = u_1$ is said to be a weak solution of problem (1.1) on $[0,T] \times \mathbb{T}^3$, if and only if equation (1.1) is satisfied in the sense of distribution, i.e.

$$\int_0^T \int_{\mathbb{T}^3} \left[-u_t \psi_t + g(u_t)\psi + \nabla u \nabla \psi + u\psi + f(u)\psi \right] \mathrm{d}x \mathrm{d}t = \int_0^T \int_{\mathbb{T}^3} \phi \psi \mathrm{d}x \mathrm{d}t$$

for any $\psi \in C_0^{\infty}((0,T) \times \mathbb{T}^3)$.

When dealing with the Cauchy problem for nonlinear wave equations, the mixed norms $L_t^q L_x^r$ estimates called "Strichartz estimates" are particularly useful. The Strichartz estimates are well established on flat Euclidean space, see for example Keel and Tao [7], and references therein. For a compact manifold without boundary, as mentioned in [1], finite speed of propagation shows that it suffices to work in coordinate charts, and to establish local Strichartz estimates for variable coefficient wave operators on Euclidean space.

Regarding the solution u of linear wave equation

$$\begin{cases} u_{tt} - \Delta u = F(t), \text{ in } \mathbb{R}_+ \times \mathbb{T}^3, \\ u(0) = u_0, u_t(0) = u_1, \end{cases}$$
(2.1)

The Strichartz estimate can be stated as follows: in the following lemma, (r', s') are the Hölder dual exponents to (r, s).

Lemma 2.2 (Strichartz estimate). Supposed $2 < q \le \infty$, $2 \le r < \infty$ and (q, r, σ) is a triple satisfying

$$\frac{1}{q} + \frac{3}{r} = \frac{3}{2} - \sigma \quad and \quad \frac{2}{q} + \frac{2}{r} \le 1$$
(2.2)

and $(\tilde{q}', \tilde{r}', 1-\sigma)$ satisfies the same conditions as (q, r, σ) . Then we have the following estimates for the solutions u to (2.1) satisfying periodic boundary conditions,

$$\|u\|_{L^{q}([-T,T];L^{r}(\mathbb{T}^{3}))} \leq C_{T}(\|u_{0}\|_{H^{\sigma}} + \|u_{1}\|_{H^{\sigma-1}} + \|F\|_{L^{\tilde{q}}([-T,T];L^{\tilde{r}}(\mathbb{T}^{3}))}), \qquad (2.3)$$

where C_T may depend on T.

In the natural phase space \mathcal{H} , i.e. in the case of $\sigma = 1$, the only admissible pair for (\tilde{q}, \tilde{r}) is $\tilde{q} = 1, \tilde{r} = 2$. Since the nonlinear damping term $g(u_t)$ only belongs to $L^{\frac{m+1}{m}}([0,T] \times \mathbb{T}^3)$, but not $L^2([0,T] \times \mathbb{T}^3)$, we can not apply Strichartz estimates in the natural phase space \mathcal{H} directly. To overcome this obstruction, we will apply Strichartz estimates in a lower regular phase space $\mathcal{H}^{\sigma-1}$ for some $\sigma < 1$ such that $\tilde{r}=\frac{m+1}{m}.$ In details, in the rest of the paper we will set parameters in Lemma 2.2 as follows:

$$\sigma = \frac{2}{m+1}, r = \frac{2(m+1)}{m-1}, q = m+1, \tilde{r} = \frac{m+1}{m} \text{ and } \tilde{q} = \frac{2(m+1)}{m+3}.$$
 (2.4)

It is easy to check that (q, r, σ) and $(\tilde{q}', \tilde{r}', 1 - \sigma)$ both satisfy condition (2.2).

Definition 2.3 (Regular solution). A weak solution u of problem (1.1) is said to be a regular solution if the following additional regularity holds: $u \in L^q(0,T;L^r(\mathbb{T}^3))$.

Theorem 2.4 (Well-posedness of regular solution in region IV). Let $\phi \in L^2(\mathbb{T}^3)$ and conditions (G1)-(F2) hold. Then, for every $(u_0, u_1) \in \mathcal{H}$, there exists a regular solution $u(\cdot)$ of equation (1.1) and the following energy estimate holds

$$\|(u, u_t)\|_{\mathcal{H}} + \|u\|_{L^q(t, t+1; L^r(\mathbb{T}^3))} \le Q(\|(u_0, u_1)\|_{\mathcal{H}} + \|\phi\|), \tag{2.5}$$

for any $t \ge 0$, where Q is a continuous increasing function. Furthermore, the regular solution depends continuously on the initial data.

Proof. To prove the existence, we give below the formal derivation of the a priori estimate, which can be justified via Galerkin approximation. Multiplying (1.1) by $u_t(t)$ and integrating over \mathbb{T}^3 , we get the energy estimate

$$E(u(t)) + \int_0^t \int_{\mathbb{T}^3} g(u_t) u_t \mathrm{d}x \mathrm{d}t \le E(u(0)),$$
(2.6)

where the energy functional

$$E(u(t)) = \frac{1}{2} ||u_t||^2 + \frac{1}{2} ||\nabla u||^2 + \frac{1}{2} ||u||^2 + \int_{\mathbb{T}^3} F(u) dx - \int_{\mathbb{T}^3} \phi u dx$$

For any fixed $S \ge 0$, let us consider linear equation with initial data

$$w_{tt} - \Delta w + w = 0, \quad w(S) = u(S), w_t(S) = u_t(S).$$
 (2.7)

Then v = u - w satisfies the following vanishing initial data problem

$$v_{tt} - \Delta v + v = -f(v+w) - g(u_t), \quad v(S) = 0, v_t(S) = 0.$$
(2.8)

Applying the Strichartz estimate in $\mathcal{H}^{\sigma-1}$ as parameters setting (2.4) to above equation, for any T < 1, we have

$$\|v\|_{L^{q}(S,S+T;L^{r}(\mathbb{T}^{3}))} \leq C\|f(v+w)\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))} + C\|g(u_{t})\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))}.$$
(2.9)

The second term will be dominated as follows

$$\begin{aligned} \|g(u_t)\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^3))} &= \left(\int_{S}^{S+T} \|g(u_t)\|_{L^{(m+1)/m}(\mathbb{T}^3)}^{\tilde{q}} \mathrm{d}t\right)^{1/\tilde{q}} \\ &\leq CT^{\frac{3-m}{2+2m}} \|u_t\|_{L^{m+1}([S,S+T]\times\mathbb{T}^3)}^m + CT^{\frac{m+3}{2(m+1)}}. \end{aligned}$$
(2.10)

According to condition (F1), for the first term on the right side in inequality (2.9), we have

$$\|f(v+w)\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))}$$

$$\leq C\|u^{2}+|v|^{p}+|w|^{p}\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))}$$

$$\leq CT^{\frac{4+2m}{3m+3}}\|u\|_{L^{\infty}([S,S+T];L^{6}(\mathbb{T}^{3}))}^{2}+C\||v|^{p}+|w|^{p}\|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))}.$$
(2.11)

By virtue of Strichartz estimate to equation (2.7) in \mathcal{H} , we can obtain

$$\|w\|_{L^{\frac{2p(m+1)}{p(m+1)-6m}}(S,S+T;L^{p\tilde{r}}(\mathbb{T}^3))} \le C\left(E(u(S))\right)^{1/2},$$
(2.12)

hence

$$\| \| w \|^{p} \|_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^{3}))} \leq CT^{\frac{7m+3-p(m+1)}{2(m+1)}} \| w \|_{L^{\frac{2p(m+1)}{p(m+1)-6m}}(S,S+T;L^{p\tilde{r}}(\mathbb{T}^{3}))}$$

$$\leq CT^{\frac{2m}{m+1}} \left(E(u(S)) \right)^{p/2}.$$

$$(2.13)$$

Using interpolation of Lebesgue spaces, we have

 $|| |v|^p ||_{L^{\tilde{q}}([S,S+T];L^{\tilde{r}}(\mathbb{T}^3))} = ||v||_{L^{p\tilde{q}}([S,S+T];L^{p\tilde{r}}(\mathbb{T}^3))}^p$

$$\leq C \|v\|_{L^{\alpha p \bar{q}}(S, S+T; L^{r}(\mathbb{T}^{3}))}^{\alpha p} \|v\|_{L^{\infty}(S, S+T; L^{6}(\mathbb{T}^{3}))}^{(1-\alpha)p}$$
(2.14)

$$\leq CT^{1-\frac{\alpha pq}{q}} \|v\|_{L^{q}(S,S+T;L^{r}(\mathbb{T}^{3}))}^{\alpha p} \|v\|_{L^{\infty}(S,S+T;L^{6}(\mathbb{T}^{3}))}^{(1-\alpha)p}.$$

where

$$\alpha = (\frac{1}{6} - \frac{1}{p\tilde{r}})/(\frac{1}{6} - \frac{1}{r}).$$

Since $p \leq 7 - 2m < 6 - m$, we have

$$\alpha p \tilde{q} = (p - \frac{6}{\tilde{r}})\tilde{q}/(1 - \frac{6}{r}) = \frac{p(m+1) - 6m}{(2-m)(m+3)}(m+1) < m+1 = q.$$

Substituting (2.10)-(2.14) into (2.9) and combining with the energy inequality (2.6), we have inequality

$$X(T) \le T^{a} A X^{c}(T) + B T^{b} \le A X^{c+1}(T) + A T^{a} + B T^{b}, \forall T \in [0, 1],$$
(2.15)

where $X(t) = \|v\|_{L^q(S,S+t;L^r(\mathbb{T}^3))}$, $a = 1 - \frac{\alpha p \tilde{q}}{q} > 0$, $b = \frac{2m}{m+1} > 0$, $c = \alpha p > 0$ and the constant A, B only depend on E(u(0)).

Let $\psi(X) = X - AX^{c+1}$ and X_0 be the maximum point of $\psi(X)$. Since c > 0, then $\psi(X_0) > 0$. We choose $T_0 > 0$ such that $AT_0^a + BT_0^b = \frac{1}{2}\psi(X_0)$, then we assert that

$$X(t) \le X_0, \forall t \in [0, T_0].$$
(2.16)

If not, there exists a time $t_1 \in [0, T_0]$ such that $X(t_1) > X_0$. Then, by continuity of X(t), there exists a time $t_2 \in [0, t_1)$ such that $X(t_2) = X_0$. However,

$$X(t_2) - AX^{c+1}(t_2) = \psi(X(t_2)) = \psi(X_0) > \frac{1}{2}\psi(X_0) = AT_0^a + BT_0^b \ge At_2^a + Bt_2^b,$$

which contradicts with (2.15). Therefore, we can obtain that $||v||_{L^q(S,S+T_0;L^r(\mathbb{T}^3))}$ can be dominated by E(u(0)) uniformly on $S \ge 0$.

To verify the continuous dependence, for any two regular solutions u(t) and v(t) with finite $L^q(0,T;L^r(\mathbb{T}^3))$ norms, let the difference $\bar{u} = u - v$. Then \bar{u} satisfies

$$\bar{u}_{tt} - \Delta \bar{u} + \bar{u} + g(u_t) - g(v_t) + f(u) - f(v) = 0$$
(2.17)

By the Mean Value Theorem, we have

$$\|f(u) - f(v)\| = \left\| \int_0^1 f'(\tau u + (1 - \tau)v) d\tau \bar{u} \right\| \le C \|(1 + |u|^{p-1} + |v|^{p-1})\bar{u}\|$$

$$\le C(1 + \|u\|_{L^{3p-3}(\mathbb{T}^3)}^{p-1} + \|v\|_{L^{3p-3}(\mathbb{T}^3)}^{p-1}) \|\bar{u}\|_{L^6(\mathbb{T}^3)} = I(t) \|\bar{u}\|_{L^6(\mathbb{T}^3)}.$$

(2.18)

Since $3p - 3 \le 18 - 6m < r$, then by Hölder's inequality

$$\|u\|_{L^{3p-3}(\mathbb{T}^3)}^{p-1} \le \|u\|_{L^r(\mathbb{T}^3)}^{\beta(p-1)} \|u\|_{L^6(\mathbb{T}^3)}^{(1-\beta)(p-1)},$$

where

$$\beta = (\frac{1}{6} - \frac{1}{3p-3})/(\frac{1}{6} - \frac{1}{r}).$$

Notice that

$$\beta(p-1) = \frac{(p-3)r}{r-6} = \frac{(p-3)(m+1)}{4-2m} \le q,$$

thus $I(\cdot) \in L^1(0,T)$ and $f(u) - f(v) \in L^1(0,T;L^2(\mathbb{T}^3))$. This fact allows us to multiply equation (2.17) with \bar{u}_t , which implies that

$$\frac{\mathrm{d}}{\mathrm{d}t} \left(\frac{1}{2} \|\bar{u}_t\|^2 + \frac{1}{2} \|\nabla\bar{u}\|^2 + \frac{1}{2} \|\bar{u}\|^2 \right) + \int_{\mathbb{T}^3} (g(u_t) - g(v_t)) \bar{u}_t \mathrm{d}x + \int_{\mathbb{T}^3} (f(u) - f(v)) \bar{u}_t \mathrm{d}x = 0.$$

Since g(s) is increasing, thus

$$\int_{\mathbb{T}^3} (g(u_t) - g(v_t)) \bar{u}_t \mathrm{d}x \ge 0.$$

According to inequality (2.18),

$$\left| \int_{\mathbb{T}^3} (f(u) - f(v)) \bar{u}_t \mathrm{d}x \right| \le I(t) \|\bar{u}\|_{L^6(\mathbb{T}^3)} \|\bar{u}_t\| \le I(t) \left(\frac{1}{2} \|\bar{u}_t\|^2 + \frac{1}{2} \|\nabla\bar{u}\|^2 + \frac{1}{2} \|\bar{u}\|^2\right).$$
(2.19)

Hence, the continuous dependence can be deduced by applying Gronwall's inequality on the following inequality

$$\frac{\mathrm{d}}{\mathrm{d}t} \left(\frac{1}{2} \|\bar{u}_t\|^2 + \frac{1}{2} \|\nabla \bar{u}\|^2 + \frac{1}{2} \|\bar{u}\|^2 \right) \le I(t) \left(\frac{1}{2} \|\bar{u}_t\|^2 + \frac{1}{2} \|\nabla \bar{u}\|^2 + \frac{1}{2} \|\bar{u}\|^2 \right),$$

ided $I(t) \in L^1(0, T).$

provided $I(t) \in L^1(0,T)$.

3. GLOBAL ATTRACTOR

Repeating arguments of the section 4 and 5 in [10] word by word, we can be obtain the global attractors associated with problem (1.1).

Theorem 3.1. Let the assumptions of Theorem 2.4 hold. Then, the solution semigroup S(t) generated by the regular solution of problem (1.1) possesses a global attractor \mathscr{A} in the phase space \mathcal{H} . Moreover, the global attractor \mathscr{A} is bounded in \mathcal{H}^1 .

4. EXPONENTIAL ATTRACTOR

In this section, we will prove the existence of exponential attractor provided the nonlinearity f satisfies

$$f''(s)| \le c_2(1+|s|^{p-2}),$$
 (F3)

where $3 \le p < 7 - 2m$.

The main result of this section is the following theorem.

Theorem 4.1. Let $\phi \in L^2(\mathbb{T}^3)$ and conditions (G1), (G2), (F2) and (F3) hold. Then the solution semigroup S(t) possesses an exponential attractor \mathscr{A}_{exp} , which is compact in \mathcal{H} and satisfies the following properties:

(i) \mathscr{A}_{exp} is positive invariant, i.e., $S(t)\mathscr{A}_{exp} \subset \mathscr{A}_{exp}$ for all $t \geq 0$;

(ii) $\dim_F \mathscr{A}_{exp} < \infty$, i.e., \mathscr{A}_{exp} has finite fractal dimension in \mathcal{H} ;

(iii) there exists a constant $\mu > 0$ such that, for any bounded set $B \subset \mathcal{H}$,

 $dist_{\mathcal{H}}(S(t)B, \mathscr{A}_{exp}) \leq Q(||B||_{\mathcal{H}})e^{-\mu t} \text{ for all } t \geq 0,$

where $dist_{\mathcal{H}}(B,A) = \sup_{x \in B} \inf_{y \in A} ||x - y||_{\mathcal{H}}$ is the Hausdorff semi-distance.

There are only a few results concerned on exponential attractor of wave equation with nonliear damping, Pražák[12, 13] obtained the exponential attractor under condition m < 7/3 and p < 3.

4.1. The quasi-stablity and exponential attractor. Our construction of exponential attractor depends on the quasi-stablity of semigroup.

Definition 4.2 ([2], Definition 3.4.1). Let (X, S(t)) be a dynamical system in some Banach space X. This system is said to be quasi-stable on a set $\mathscr{B} \subset X$ (at time t_*) if there exist (a) time $t_* > 0$, (b) a Banach space Z, (c) a globally Lipschitz mapping $K : \mathscr{B} \to Z$, and (d) a compact seminorm $n_Z(\cdot)$ on the space Z, such that

$$||S(t_*)y_1 - S(t_*)y_2||_X \le q||y_1 - y_2||_X + n_Z(y_1 - y_2)$$
(4.1)

for every $y_1, y_2 \in \mathscr{B}$ with $0 \leq q < 1$.

Theorem 4.3 ([2], Theorem 3.4.7). Assume that a dynamical system (X, S(t)) is dissipative and quasi-stable on some bounded absorbing set \mathscr{B} at some moment $t_* > 0$. We also assume that

$$||S(t_*)y_1 - S(t_*)y_2||_X \le C_{\mathscr{B}} ||y_1 - y_2||_X \text{ for every } y_1, y_2 \in \mathscr{B} \text{ and } t \in [0, t_*]$$
(4.2)

and there exists a space $\tilde{X} \supset X$ such that $t \mapsto S(t)y$ is Hölder continuous in \tilde{X} for every $y \in \mathscr{B}$ in the sense that there exist $0 < \theta \leq 1$ and $C_{\mathscr{B},t_*} > 0$ such that

$$\|S(t_1)y - S(t_2)y\|_{\tilde{X}} \le C_{\mathscr{B},t_*}|t_1 - t_2|^{\theta}, \ t_1, t_2 \in [0,t_*], y \in \mathscr{B}.$$
(4.3)

Then the dynamical system (X, S(t)) possesses a (generalized) fractal exponential attractor whose dimension is finite in the space \tilde{X} .

For $0 < \alpha < 1/2$, by Cauchy's inequality, we have the equivalence

(4.14)

it needs to prove that the asymptotic regularity of S(t) from \mathcal{H} to \mathcal{H}^{δ} and the boundedness of $\frac{d}{dt}S(t)$ in $\mathcal{H}^{\delta-1}$.

4.3.1. Asymptotic regularity. We decompose the solution of problem (1.1) with initial data $z_0 = (u_0, u_1)$ into

For the second term on the last line of (4.22), by Hölder's inequality with conjugate exponents $(\frac{3}{1-\delta}, 2, \frac{6}{1+2\delta})$, we have

$$\int_{\mathbb{T}^{3}} f'(u) u_{t} A^{2\delta} w dx \leq \|f'(u)\|_{L^{\frac{3}{1-\delta}}(\mathbb{T}^{3})} \|u_{t}\| \cdot \|A^{2\delta} w\|_{L^{\frac{6}{1+2\delta}}(\mathbb{T}^{3})} \\
\leq C \|f'(u)\|_{L^{\frac{3}{1-\delta}}(\mathbb{T}^{3})} \|u_{t}\| \cdot \|A^{2\delta} w\|_{H^{1-\delta}(\mathbb{T}^{3})} \\

we also decompose the solution to $u^n(t) = v^n(t) + w^n(t)$, where $v^n(t)$ solves the problem

$$v_{tt}^{n} + P_{n}g(u_{t}^{n}) - g(w_{t}^{n}) - \Delta v^{n} + v^{n} = 0, v^{n}(0) = P_{n}u_{0}, v_{t}^{n}(0) = P_{n}u_{1}, \quad (4.33)$$

and the remainder $w^n(t)$ satisfies

$$w_{tt}^{n} + P_{n}g(w_{t}^{n}) - \Delta w^{n} + w^{n} + P_{n}f(u) = P_{n}\phi, w^{n}(0) = 0, \ w_{t}^{n}(0) = 0.$$
(4.34)

Then $v^n(t)$ and $w^n(t)$ have the same estimates as (4.18) and (4.31). Then passing the limit $n \to \infty$ and applying the lower semi-continuity of norms, we can derive the desired regularity estimate on w(t).

This completes the proof.

$$\|v_t(t)\| + \|\nabla v\| + \|v\| \le Ce^{-\rho t} \|(u_0, u_1)\|_{\mathcal{H}}.$$
(4.35)

Proof. Multiplying both sides of equation (4.15) by $v_t + \alpha v$, $\alpha \in (0, 1)$ and integrating over \mathbb{T}^3 , we obtain

$$\frac{\mathrm{d}}{\mathrm{d}t} \left(\|v_t\|^2 + \|\nabla v\|^2 + \|v(t)\|^2 + 2\alpha \langle v_t, v \rangle \right) + 2\alpha \|\nabla v\|^2 + 2\alpha \|v\|^2 - 2\alpha \|v_t\|^2 + 2\int_{\mathbb{T}^3} \left[g(u_t) - g(w_t) \right] (v_t + \alpha v) \mathrm{d}x = 0.$$
(4.36)

For the last term, similar to the derivation of (4.7), we have

$$2\int_{\mathbb{T}^3} (g(u_t) - g(w_t))(v_t + \alpha v) \mathrm{d}x \ge \gamma \|v_t\|^2 - \alpha^2 C \left(1 + \int_{\mathbb{T}^3} g_2(u_t, w_t) \mathrm{d}x\right) \|v(t)\|_{L^6(\mathbb{T}^3)}^2$$
(4.37)

So taking into account this inequality in (4.36) with $\alpha < \min\{\gamma/4, 1/2\}$ we find

$$\frac{\mathrm{d}}{\mathrm{d}t} \left(\|v_t\|^2 + \|\nabla v\|^2 + \|v\|^2 + 2\alpha \langle v_t, v \rangle \right) + \alpha (\|v_t\|^2 + \|\nabla v\|^2 + \|v\|^2 + 2\alpha \langle v_t, v \rangle) \\
\leq \alpha^2 C \int_{\mathbb{T}^3} g_2(u_t, w_t) \mathrm{d}x \|v\|_{L^6(\mathbb{T}^3)}^2 \\
\leq \alpha^2 C \int_{\mathbb{T}^3} g_2(u_t, w_t) \mathrm{d}x (\|v_t\|^2 + \|\nabla v\|^2 + \|v\|^2 + 2\alpha \langle v_t, v \rangle).$$
(4.38)

From $\int_0^{+\infty} \int_{\mathbb{T}^3} g(u_t) u_t dx dt \leq Q(||(u_0, u_1)||_{\mathcal{H}})$ and (4.21), it follows that

$$\alpha^{2}C \int_{0}^{t} \int_{\mathbb{T}^{3}} g_{2}(u_{t}, w_{t}) \mathrm{d}x \mathrm{d}s \leq (1+t)\alpha^{2}CQ(\|(u_{0}, u_{1})\|_{\mathcal{H}}) \leq \frac{\alpha}{2}(1+t).$$
(4.39)

Taking α to be small enough such that

$$\alpha^2 C \int_0^t \int_{\mathbb{T}^3} g_2(u_t, w_t) \mathrm{d}x \mathrm{d}s \le \frac{\alpha}{2} (1+t),$$
(4.40)

then by Gronwall's inequality, we have

$$\|v_t(t)\|^2 + \|\nabla v(t)\|^2 + \|v(t)\|^2 \le C \left(\|u_1\|^2 + \|\nabla u_0\|^2 + \|u_0\|^2\right) e^{-\frac{\alpha}{2}t}.$$
 (4.41)

We now turn to the asymptotic regularity.

Lemma 4.7. Under the assumptions of Theorem 4.1, there exists a compact positive invariant set \mathscr{B}_1 in \mathcal{H}^{δ} and a positive constant μ such that, for any bounded set $B \subset \mathcal{H}$,

$$dist_{\mathcal{H}}(S(t)B, \mathscr{B}_1) \le Q(\|B\|_{\mathcal{H}})e^{-\mu t} \quad for \ all \ t \ge 0.$$

Proof. Let \mathscr{B}_0 be an absorbing set of S(t), denote $\mathscr{K} = \overline{\bigcup_{t \ge 0} S_w(t) \mathscr{B}_0}^{\mathcal{H}}$, recall that by Lemma 4.5, \mathscr{K} is bounded in \mathcal{H}^{δ} . We will show that \mathscr{K} is an exponentially attracting set.

Since \mathscr{B}_0 is an absorbing set, then for any given bounded set $B \subset \mathcal{H}$, there exists a $T = T(||B||_{\mathcal{H}})$ such that, $S(t)B \subset \mathscr{B}_0$, for all $t \geq T$. This implies that, for $t \geq T$,

$$dist_{\mathcal{H}}(S(t)B,\mathscr{K}) = dist_{\mathcal{H}}(S(t-T)S(T)B,\mathscr{K})$$

$$\leq dist_{\mathcal{H}}(S(t-T)S(T)B, S_{w}(t-T)\mathscr{B}_{0})$$

$$\leq dist_{\mathcal{H}}(S(t-T)\mathscr{B}_{0}, S_{w}(t-T)\mathscr{B}_{0})$$

$$\leq \|S_{v}(t-T)\mathscr{B}_{0}\|_{\mathcal{H}}.$$

$$(4.42)$$

Combining this with (4.35) leads to

C

$$list_{\mathcal{H}}(S(t)B,\mathscr{K}) \le \|S_v(t-T)\mathscr{B}_0\|_{\mathcal{H}} \le Ce^{-\rho(t-T)}\|\mathscr{B}_0\|_{\mathcal{H}}.$$
(4.43)

On the other hand, by energy estimate (2.5), we have the uniform estimate

$$dist_{\mathcal{H}}(S(t)B,\mathscr{K}) \le Q(\|B\|_{\mathcal{H}}), \quad t \ge 0.$$

$$(4.44)$$

Combining the above two inequalities, we obtain

$$dist_{\mathcal{H}}(S(t)B,\mathscr{K}) \le (Q(\|B\|_{\mathcal{H}})e^{\rho T} + Ce^{\rho T}\|\mathscr{B}_0\|_{\mathcal{H}})e^{-\rho t}, \quad t \ge 0.$$

$$(4.45)$$

Towards to invariant, we define $\mathscr{B}_1 = \overline{\bigcup_{t \ge 0} S(t) \mathscr{K}}^{\mathcal{H}}$, then \mathscr{B}_1 is a positive invariant set and also satisfies exponentially attracting property

$$dist_{\mathcal{H}}(S(t)B,\mathscr{B}_1) \le (Q(\|B\|_{\mathcal{H}})e^{\rho T} + Ce^{\rho T}\|\mathscr{B}_0\|_{\mathcal{H}})e^{-\rho t}, \quad t \ge 0.$$
(4.46)

It remains to show that \mathscr{B}_1 is bounded in \mathcal{H}^{δ} . Multiplying both sides of (1.1) by $A^{2\delta}u_t + \alpha A^{2\delta}u$ with $\alpha \in (0, 1)$, then repeating the arguments from (4.23) to (4.29) word by word, it follows that $S(t)\mathscr{K}$ is bounded in \mathcal{H}^{δ} uniformly for $t \geq 0$. This implies that \mathscr{B}_1 is bounded in \mathcal{H}^{δ} , which completes the proof. \Box

4.3.2. The Hölder continuity. Let's firstly prove the $\mathcal{H}^{\delta-1}$ boundedness of operator $\frac{d}{dt}S(t)$ on $\mathbb{R}^+ \times \mathscr{B}_1$.

Lemma 4.8. Given $z_0 = (u_0, u_1) \in \mathscr{B}_1$, then $\frac{d}{dt}S(t)z_0 = (u_t, u_{tt}) \in L^{\infty}(\mathbb{R}^+; \mathcal{H}^{\delta-1})$ and for any $t \ge 0$,

$$\left\|\frac{d}{dt}S(t)z_0\right\|_{\mathcal{H}^{\delta-1}} \le Q(\|\mathscr{B}_1\|_{\mathcal{H}^{\delta}}).$$
(4.47)

Proof. According to the fact that \mathscr{B}_1 is positive invariant, we deduce that $S(t)z_0 = (u(t), u_t(t)) \in \mathscr{B}_1 \subset \mathcal{H}^{\delta}$. Therefore, it remains to show that $u_{tt} \in H^{\delta-1}$.

Following from (1.1), we have $u_{tt} = \phi - g(u_t) + \Delta u - u - f(u)$. For the damping term, since $\delta = \min\{(7-2m-p)/2, 1/8\} \le 1/8$ and $m \le 7/5$, then $6m/(5-2\delta) \le 2$, we have

$$\|g(u_t)\|_{H^{\delta-1}(\mathbb{T}^3)} \le C(1 + \|u_t\|_{L^{\frac{6m}{5-2\delta}}(\mathbb{T}^3)}^m) \le C(1 + \|u_t\|^m).$$
(4.48)

By the embedding

$$L^{\frac{6}{5-2\delta}}(\mathbb{T}^3) = \left(L^{\frac{6}{1+2\delta}}(\mathbb{T}^3)\right)' \hookrightarrow \left(H^{1-\delta}(\mathbb{T}^3)\right)' = H^{\delta-1}(\mathbb{T}^3), \tag{4.49}$$

we can obtain that

$$\|f(u)\|_{H^{\delta-1}(\mathbb{T}^3)} \le C \|f(u)\|_{L^{\frac{6}{5-2\delta}}(\mathbb{T}^3)} \le C(1+\|u\|_{L^{\frac{6p}{5-2\delta}}(\mathbb{T}^3)}^p).$$
(4.50)

It follows form $\delta \leq (5-p)/2$ that $6p/(5-2\delta) \leq 6$, therefore

$$\|f(u)\|_{H^{\delta-1}(\mathbb{T}^3)} \le C(1+\|u\|_{L^{\frac{6p}{5-2\delta}}(\mathbb{T}^3)}^p) \le C(1+\|u\|_{H^1(\mathbb{T}^3)}^p).$$
(4.51)

Consequently, all the right terms in equation $u_{tt} = \phi - g(u_t) + \Delta u - u - f(u)$ belong to $L^{\infty}(\mathbb{R}^+; H^{\delta-1})$, thus $u_{tt} \in L^{\infty}(\mathbb{R}^+; H^{\delta-1})$ and $\|u_{tt}\|_{L^{\infty}(\mathbb{R}^+; H^{\delta-1})} \leq Q(\|\mathscr{B}_1\|_{\mathcal{H}^{\delta}})$. The proof is complete.

Now, we can verify the Hölder continuity.

Lemma 4.9. The mapping $t \mapsto S(t)z$ is Hölder continuous of order δ on $[0, t_*]$ for any $t_* > 0$ and $z \in \mathscr{B}_1$.

Proof. For $z \in \mathscr{B}_1$, and $t_1, t_2 \in [0, t_*]$ we have

$$\|S(t_{1})z - S(t_{2})z\|_{\mathcal{H}} \leq \|S(t_{1})z - S(t_{2})z\|_{\mathcal{H}^{\delta-1}}^{\delta} \|S(t_{1})z - S(t_{2})z\|_{\mathcal{H}^{\delta}}^{1-\delta} = \left\|\int_{t_{1}}^{t_{2}} \frac{d}{dt}S(s)zds\right\|_{\mathcal{H}^{\delta-1}}^{\delta} \|S(t_{1})z - S(t_{2})z\|_{\mathcal{H}^{\delta}}^{1-\delta} \leq \left|\int_{t_{1}}^{t_{2}} \left\|\frac{d}{dt}S(s)z\right\|_{\mathcal{H}^{\delta-1}} ds\right|^{\delta} \|S(t_{1})z - S(t_{2})z\|_{\mathcal{H}^{\delta}}^{1-\delta}$$
(4.52)

and

$$||S(t_1)z - S(t_2)z||_{\mathcal{H}^{\delta}} \le ||S(t_1)z||_{\mathcal{H}^{\delta}} + ||S(t_2)z||_{\mathcal{H}^{\delta}} \le 2||\mathscr{B}_1||_{\mathcal{H}^{\delta}}.$$
(4.53)

According to Lemma 4.8, we have

$$\left\| \int_{t_1}^{t_2} \left\| \frac{d}{dt} S(s) z \right\|_{\mathcal{H}^{\delta-1}} ds \right\| \leq \left\| \frac{d}{dt} S(\cdot) z \right\|_{L^{\infty}(\mathbb{R}^+;\mathcal{H}^{\delta-1})} |t_1 - t_2| \leq Q(\|\mathscr{B}_1\|_{\mathcal{H}^{\delta}}) |t_1 - t_2|.$$

$$\tag{4.54}$$

Substituting (4.53), (4.54) into (4.52), we obtain

$$||S(t_1)z - S(t_2)z||_{\mathcal{H}} \le Q(||\mathscr{B}_1||_{\mathcal{H}^{\delta}})|t_1 - t_2|^{\delta}.$$

Proof of Theorem 4.1. By Theorem 2.4, Theorem 4.4 and Lemma 4.8, all assumptions of Theorem 4.3 are satisfied, thus the local dynamical system $(S(t), \mathscr{B}_1)$ has an exponential attractor \mathscr{A}_{exp} such that

$$dist_{\mathcal{H}}(S(t)\mathscr{B}_1,\mathscr{A}_{\exp}) \le C_1 e^{-\nu t}, \forall t \ge 0,$$

for some $\nu > 0$.

Recall that \mathscr{B}_1 is an exponential attracting set, then apply the transitivity property of exponential attraction[5], we conclude that \mathscr{A}_{exp} attracts B exponentially.
