# **E-FRAME MULTIPLIERS**

#### HASSAN HEDAYATIRAD AND TAYEBE LAL SHATERI

ABSTRACT. This article is dedicated to investigating some notions related to *E*-frames and multipliers. *E*-frames are a new generalization for the concept of frames for  $\mathcal{H}$ , where *E* is an infinite invertible complex matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$ . A Multiplier is an operator that combines (frame-like) analysis, multiplication with a fixed sequence, called the symbol, and synthesis. Firstly, we try to reintroduce the operators associated with *E*-frames in terms of the frame's analysis and synthesis operators, under certain conditions. Secondly, we define the notion of *E*-multiplier and investigate some results.

### 1. INTRODUCTION

Suppose that  $\mathcal{H}$  is a separable Hilbert space. Recall that a sequence  $\{\psi_k\}_{k=1}^{\infty}$  is a frame for  $\mathcal{H}$  if and only if there exist positive constants A, B such that

$$A \|f\|^{2} \leq \sum_{k=1}^{\infty} |\langle f, \psi_{k} \rangle|^{2} \leq B \|f\|^{2} \qquad (f \in \mathcal{H}).$$
(1.1)

If only the right inequality holds in (1.1), we say  $\{\psi_k\}_{k=1}^{\infty}$  is Bessel and *E*-Bessel respectively. Associated to each Bessel sequence  $\Psi = \{\psi_k\}_{k=1}^{\infty}$ , the synthesis (pre-frame) operator  $T_{\Psi}$ :  $\ell^2(\mathbb{N}) \longrightarrow \mathcal{H}$ ;  $T_{\Psi} \{c_k\}_{k=1}^{\infty} = \sum_{k=1}^{\infty} c_k \psi_k$  is well-defined and bounded. The adjoint operator of T, is called the analysis operator and is defined by  $T_{\Psi}^* : \mathcal{H} \longrightarrow \ell^2(\mathbb{N})$ ;  $T_{\Psi}^* f = \{\langle f, \psi_k \rangle\}_{k=1}^{\infty}$ . The operator  $S = T_{\Psi}T_{\Psi}^*$  is the frame operator which is self adjoint, positive and invertible [4].

Consider an infinite invertible matrix mapping E on  $\bigoplus_{n=1}^{\infty} \mathcal{H} = \{\{f_n\}_{n=1}^{\infty}, \sum_{n=1}^{\infty} \|f_n\|^2 < \infty\}$ . A sequence  $\{\psi_k\}_{k=1}^{\infty}$  is called an E-frame [9] if and only if  $E\{\psi_k\}_{k=1}^{\infty}$  is a well defined sequence in  $\mathcal{H}$  and there exist positive numbers A, B such that

$$A \|f\|^{2} \leq \sum_{n=1}^{\infty} \left| \left\langle f, (E \{\psi_{k}\}_{k=1}^{\infty})_{n} \right\rangle \right|^{2} \leq B \|f\|^{2}, \qquad (1.2)$$

for all  $f \in \mathcal{H}$ . Similarly,  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  is an *E*-Bessel sequence if and only if the synthesis (pre *E*-frame) operator  $T_E : \ell^2(\mathbb{N}) \longrightarrow \mathcal{H}$ ;  $T_E \{c_n\}_{n=1}^{\infty} = \sum_{n=1}^{\infty} c_n (E \{\psi_k\}_{k=1}^{\infty})_n$  is well defined and bounded. The adjoint of  $T_E$  is defined by  $T_E^* : \mathcal{H} \longrightarrow \ell^2(\mathbb{N})$ ;  $T_E^* f = \{\langle f, (E \{\psi_k\}_{k=1}^{\infty})_n \rangle\}_{n=1}^{\infty}$ . Finally,  $S_E = T_E T_E^*$  is a self adjoint, positive and invertible operator which is called the *E*-frame operator [9].

For sequences  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  in  $\mathcal{H}$  and any sequence of complex numbers  $m = \{m_k\}_{k=1}^{\infty}$  (called symbol), the operator  $M_{m,\Psi,\Phi}$ , given by

$$M_{m,\Psi,\Phi}f = \sum_{k=1}^{\infty} m_k \langle f, \phi_k \rangle \psi_k \qquad (f \in \mathcal{H}),$$
(1.3)

is called a multiplier [1]. We say  $M_{m,\Psi,\Phi}$  is well defined on  $\mathcal{H}$  if the series in (1.3) converges for all  $f \in \mathcal{H}$ . If  $\sum_{k=1}^{\infty} m_k \langle f, \phi_k \rangle \psi_k$  is unconditionally convergent, then we say  $M_{m,\Psi,\Phi}$  is unconditionally convergent. Depending on  $\Psi$ ,  $\Phi$  and m, the corresponding multiplier might not be well defined, it might be well defined but not unconditionally convergent and it might be unconditionally convergent [2].

In this paper, we first show that any infinite matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$  can be considered as an operator on  $\ell^2(\mathbb{N})$ , under certain conditions. Using this, we reintroduce  $T_E$  and  $T_E^*$  in terms of  $T_{\Psi}$  and  $T_{\Psi}^*$  where  $\Psi$  is a fixed Bessel sequence in  $\mathcal{H}$ . Secondly, we introduce the notion of an *E*-frame multiplier which is the extension of the concept of a multiplier for *E*-sequences and investigate some results about these multipliers.

## 2. Main Results

Throughout this section,  $\mathcal{H}$  is a separable Hilbert space and  $\mathcal{E} = \{e_n\}_{n=1}^{\infty}$  is an orthonormal basis.

2.1. *E*-frame. Now we want to check some conditions to transmute a matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$  into a matrix mapping on  $\ell^2(\mathbb{N})$ .

*Remark* 2.1.1. Let E be an infinite complex matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$  defined by

$$E: \bigoplus_{n=1}^{\infty} \mathcal{H} \longrightarrow \bigoplus_{n=1}^{\infty} \mathcal{H} ; \ E\{f_k\}_{k=1}^{\infty} = \left\{ \sum_{k=1}^{\infty} E_{n,k} f_k \right\}_{n=1}^{\infty},$$

which satisfies

$$\sum_{n=1}^{\infty} \sum_{k=1}^{\infty} |E_{n,k}|^2 < \infty.$$
(2.1)

Then E is bounded. In fact,

$$||E||^{2} = \sup_{\sum_{k} ||f_{k}||^{2} \le 1} ||E\{f_{k}\}_{k=1}^{\infty}||_{\bigoplus \mathcal{H}}^{2} = \sup_{\sum_{k} ||f_{k}||^{2} \le 1} \sum_{n=1}^{\infty} \left\| \sum_{k=1}^{\infty} E_{n,k}f_{k} \right\|^{2}$$

$$\leq \sup_{\sum_{k} ||f_{k}||^{2} \le 1} \sum_{n=1}^{\infty} \left( \sum_{k=1}^{\infty} |E_{n,k}| \, ||f_{k}|| \right)^{2}$$

$$\leq \sup_{\sum_{k} ||f_{k}||^{2} \le 1} \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} |E_{n,k}|^{2} \sum_{k=1}^{\infty} ||f_{k}||^{2} < \infty.$$
(2.2)

Now we use this to directly prove that  $\{E_{n,k}\}_{k=1}^{\infty} \in \ell^2(\mathbb{N})$  for all  $n \in \mathbb{N}$ . Consider an orthonormal basis  $\{e_k\}_{k=1}^{\infty}$  for  $\mathcal{H}$  and for given  $j \in \mathbb{N}$ , suppose that  $\{\delta_{j,k}\}_{k=1}^{\infty}$  is a sequence in  $\mathcal{H}$  defined by

$$\delta_{j,k} = \begin{cases} e_j & k = j \\ 0 & k \neq j \end{cases}$$

It is clear that  $\{\delta_{j,k}\}_{k=1}^{\infty}$  belongs to  $\bigoplus_{n=1}^{\infty} \mathcal{H}$ . Furthermore,

$$E\{\delta_{j,k}\}_{k=1}^{\infty} = \left\{\sum_{k=1}^{\infty} E_{n,k}\delta_{j,k}\right\}_{n=1}^{\infty} = \{E_{n,j}e_j\}_{n=1}^{\infty}.$$

Therefore, (2.2) implies that

$$\sum_{n=1}^{\infty} |E_{n,j}|^2 = \sum_{n=1}^{\infty} ||E_{n,j}e_j||^2 = \left\| \{E_{n,j}e_j\}_{n=1}^{\infty} \right\|_{\bigoplus \mathcal{H}}^2 = \left\| E\{\delta_{j,k}\}_{k=1}^{\infty} \right\|_{\bigoplus \mathcal{H}}^2 \le ||E||.$$
(2.3)

•

2.3 shows that each columns of E belongs to  $\ell^2(\mathbb{N})$ . An analogous argument applying on  $E^*$  proves that  $\{E_{n,k}\}_{k=1}^{\infty} \in \ell^2(\mathbb{N})$ .

Now we are going to define an operator on  $\ell^2(\mathbb{N})$  using E, we will denote it again by E and define it as follow

$$E: \ell^2(\mathbb{N}) \longrightarrow \ell^2(\mathbb{N}) ; \ E\{c_k\}_{k=1}^\infty = \left\{\sum_{k=1}^\infty E_{n,k}c_k\right\}_{n=1}^\infty$$

The above discussion together with (2.1), make E well defined. Similarly, one can easily shows that

$$E^{t}\{c_{k}\}_{k=1}^{\infty} = \left\{\sum_{k=1}^{\infty} E_{k,n}c_{k}\right\}_{n=1}^{\infty} \text{ and } \overline{E}\{c_{k}\}_{k=1}^{\infty} = \left\{\sum_{k=1}^{\infty} \overline{E_{n,k}}c_{k}\right\}_{n=1}^{\infty},$$

are well defined matrix operators on  $\ell^2(\mathbb{N})$ .

**Proposition 2.1.2.** Let *E* be an infinite complex matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$  which satisfies (2.1). Suppose that  $\{f_k\}_{k=1}^{\infty} \in \bigoplus_{n=1}^{\infty} \mathcal{H}$  is an *E*-Bessel sequence. Then for each  $\{c_n\}_{n=1}^{\infty} \in \ell^2(\mathbb{N})$ , the series

$$\sum_{n=1}^{\infty} \sum_{k=1}^{\infty} c_n E_{n,k} f_k$$

is absolutely convergent.

Proof.

$$\begin{split} \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} \|c_n E_{n,k} f_k\| &= \sum_{n=1}^{\infty} |c_n| \sum_{k=1}^{\infty} |E_{n,k}| \|f_k\| \\ &\leq \left\{ \sum_{n=1}^{\infty} |c_n|^2 \right\}^{\frac{1}{2}} \left\{ \sum_{n=1}^{\infty} \left( \sum_{k=1}^{\infty} |E_{n,k}| \|f_k\| \right)^2 \right\}^{\frac{1}{2}} \\ &\leq \left\{ \sum_{n=1}^{\infty} |c_n|^2 \right\}^{\frac{1}{2}} \left\{ \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} |E_{n,k}|^2 \sum_{k=1}^{\infty} \|f_k\|^2 \right\}^{\frac{1}{2}} \\ &= \left\{ \sum_{n=1}^{\infty} |c_n|^2 \right\}^{\frac{1}{2}} \left\{ \sum_{k=1}^{\infty} \|f_k\|^2 \right\}^{\frac{1}{2}} \left\{ \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} |E_{n,k}|^2 \right\}^{\frac{1}{2}} < \infty. \end{split}$$

**Theorem 2.1.3.** Let *E* be an infinite complex matrix mapping on  $\bigoplus_{n=1}^{\infty} \mathcal{H}$  which satisfies (2.1). Suppose that  $\{f_k\}_{k=1}^{\infty} \in \bigoplus_{n=1}^{\infty} \mathcal{H}$  is an *E*-Bessel sequence. Then

(i) For each sequence  $\{c_n\}_{n=1}^{\infty} \in \ell^2(\mathbb{N})$ ,

$$T_E \{c_n\}_{n=1}^{\infty} = T \left( E^t \{c_n\}_{n=1}^{\infty} \right).$$

(ii) For each  $f \in \mathcal{H}$ ,

$$T_E^* f = \overline{E} T^* f.$$

*Proof.* Using Remark 2.1.1 and Proposition 2.1.2 and applying the Fubini's theorem we have

$$T_E \{c_n\}_{n=1}^{\infty} = \sum_{n=1}^{\infty} c_n \left( E \{f_k\}_{k=1}^{\infty} \right)_n$$

$$= \sum_{n=1}^{\infty} \sum_{k=1}^{\infty} c_n E_{n,k} f_k$$
(2.4)

$$=\sum_{k=1}^{\infty} \left(\sum_{n=1}^{\infty} c_n E_{n,k}\right) f_k = T \left\{\sum_{n=1}^{\infty} c_n E_{n,k}\right\}_{k=1}^{\infty} = T \left(E^t \left\{c_n\right\}_{n=1}^{\infty}\right)$$

where  $E^t$  is the transpose of E.

$$T_E^* f = \left\{ \left\langle f, \left( E\left\{ f_k \right\}_{k=1}^\infty \right)_n \right\rangle \right\}_{n=1}^\infty = \left\{ \left\langle f, \sum_{k=1}^\infty E_{n,k} f_k \right\rangle \right\}_{n=1}^\infty$$
$$= \left\{ \sum_{k=1}^\infty \overline{E_{n,k}} \left\langle f, f_k \right\rangle \right\}_{n=1}^\infty$$
$$= \overline{E} \left\{ \left\langle f, f_k \right\rangle \right\}_{k=1}^\infty = \overline{E} T^* f.$$

Note that  $\{f_k\}_{k=1}^{\infty}$  is a Bessel sequence and so  $\{\langle f, f_k \rangle\}_{k=1}^{\infty}$  belongs to  $\ell^2(\mathbb{N})$ .

### 2.2. E-multiplier.

**Definition 2.2.1.** Let *E* be an infinite complex matrix. We say a sequence  $\{f_k\}_{k=1}^{\infty}$  is an *E*-sequence in  $\mathcal{H}$  if, its *E*-transform, the sequence

$$E\{f_k\}_{k=1}^{\infty} = \left\{\sum_{k=1}^{\infty} E_{n,k}f_k\right\}_{n=1}^{\infty},$$

is a well defined sequence in  $\mathcal{H}$ .

**Definition 2.2.2.** Consider two separable Hilbert spaces  $\mathcal{H}_1$  and  $\mathcal{H}_2$  and suppose that  $E_1$  and  $E_2$  are infinite complex matrices. For any  $E_1$ -sequence  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  in  $\mathcal{H}_1$  and  $E_2$ -sequence  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  in  $\mathcal{H}_2$  and any sequence of complex number  $m = \{m_n\}_{n=1}^{\infty}$  (we call it the symbol), the operator  $M_{m,\Psi,\Phi}^{(E_1,E_2)}$  from  $\mathcal{H}_1$  to  $\mathcal{H}_2$  defined by

$$M_{m,\Psi,\Phi}^{(E_1,E_2)}f = \sum_{n=1}^{\infty} m_n \left\langle f, \left(E_1 \left\{\phi_k\right\}_{k=1}^{\infty}\right)_n \right\rangle \left(E_2 \left\{\psi_k\right\}_{k=1}^{\infty}\right)_n,$$
(2.5)

is a  $(E_1, E_2)$ -Multiplier.

Depending on m,  $\Psi$  and  $\phi$ , the series in (2.5) might not converges for some  $f \in \mathcal{H}_1$ . If  $\Phi$ and  $\Psi$  are  $E_1$ -Bessel and  $E_2$ -Bessel respectively and  $m \in \ell^{\infty}$ , then the convergence of the series in (2.5) is guaranteed for all  $f \in \mathcal{H}_1$ . In the case  $\mathcal{H}_1 = \mathcal{H}_2$  and  $E_1 = E_2$ , we use  $M_{m,\Psi,\Phi}^E$  in notation.

**Theorem 2.2.3.** Suppose that  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  are dual frames for  $\mathcal{H}$  and E is any infinite diagonal complex matrix. Then the multipliers  $M_{1,\Psi,\Phi}^{\overline{E},E^{-1}}$ ,  $M_{1,\Phi,\Psi}^{\overline{E},E^{-1}}$ ,  $M_{1,\Psi,\Phi}^{E^{-1},\overline{E}}$  and  $M_{1,\Phi,\Psi}^{E^{-1},\overline{E}}$  are well defined. In fact, they are equal to  $Id_{\mathcal{H}}$ .

*Proof.* We just show that  $M_{1,\Phi,\Psi}^{\overline{E},E^{-1}} = Id_{\mathcal{H}}$ . The other cases will be proved analogously.

It is clear that  $\Phi$  and  $\Psi$  are  $\overline{E}$ -sequence and  $E^{-1}$ -sequence respectively. Furthermore, for given  $f \in \mathcal{H}$ ,

$$M_{1,\Psi,\Phi}^{\overline{E},E^{-1}}f = \sum_{n=1}^{\infty} \left\langle f, \left(\overline{E}\left\{\phi_{k}\right\}_{k=1}^{\infty}\right)_{n}\right\rangle \left(E^{-1}\left\{\psi_{k}\right\}_{k=1}^{\infty}\right)_{n}$$
$$= \sum_{n=1}^{\infty} \left\langle f, \overline{E}_{n,n}\phi_{n}\right\rangle E_{n,n}^{-1}\psi_{n}$$
$$= \sum_{n=1}^{\infty} \left\langle f, \phi_{n}\right\rangle \psi_{n} = f.$$

**Lemma 2.2.4.** Let  $\{\psi_k\}_{k=1}^{\infty}$  be an *E*-frame for  $\mathcal{H}$ . Suppose that  $\{m_k\}_{k=1}^{\infty}$  is a semi-normalized sequence of complex numbers. Then  $\{|m_k|\psi_k\}_{k=1}^{\infty}$  is an *E*-frame for  $\mathcal{H}$ .

*Proof.* First note that  $0 < m = \inf_k |m_k| \le \sup_k |m_k| = M < \infty$ . Hence, for given  $f \in \mathcal{H}$ ,

$$\begin{split} \sum_{n=1}^{\infty} \left| \left\langle f, \left( E\left\{ \left| m_{k} \right| \psi_{k} \right\}_{k=1}^{\infty} \right)_{n} \right\rangle \right|^{2} &= \sum_{n=1}^{\infty} \left| \left\langle f, \sum_{k=1}^{\infty} E_{n,k} \left| m_{k} \right| \psi_{k} \right\rangle \right|^{2} \\ &\leq M^{2} \sum_{n=1}^{\infty} \left| \left\langle f, \left( E\left\{ \psi_{k} \right\}_{k=1}^{\infty} \right)_{n} \right\rangle \right|^{2} \leq M^{2} B \left\| f \right\|^{2} . \end{split}$$

where B is the upper E-frame bound of  $\{\psi_k\}_{k=1}^{\infty}$ . Similarly, an straightforward argument shows that

$$\sum_{n=1}^{\infty} \left| \left\langle f, \left( E\left\{ \left| m_k \right| \psi_k \right\}_{k=1}^{\infty} \right)_n \right\rangle \right|^2 \ge m^2 A \| f \|^2,$$

where A is the lower E-frame bound of  $\{\psi_k\}_{k=1}^{\infty}$ .

**Theorem 2.2.5.** Consider an infinite diagonal matrix E and an E-frame  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and suppose that  $m = \{m_k\}_{k=1}^{\infty}$  is a positive (resp. negative) and semi-normalized sequence of complex numbers. Then  $M_{m,\Psi,\Psi}^E = S_E\{\sqrt{m_k}\psi_k\}$  (resp.  $M_{m,\Psi,\Psi}^E = -S_E\{\sqrt{|m_k|}\psi_k\}$ ) for the E-frame  $\{\sqrt{m_k}\psi_k\}_{k=1}^{\infty}$  (resp.  $\{\sqrt{|m_k|}\psi_k\}_{k=1}^{\infty}$ ) and is therefore invertible on  $\mathcal{H}$ .

*Proof.* We prove the case m is positive. The other case is similar.

For given  $f \in \mathcal{H}$ ,

$$M_{m,\Psi,\Psi}^{E}f = \sum_{n=1}^{\infty} m_n \left\langle f, \left(E\left\{\psi_k\right\}_{k=1}^{\infty}\right)_n \right\rangle \left(E\left\{\psi_k\right\}_{k=1}^{\infty}\right)_n$$
$$= \sum_{n=1}^{\infty} \left\langle f, \sqrt{m_n} E_{n,n} \psi_n \right\rangle \sqrt{m_n} E_{n,n} \psi_n$$
$$= \sum_{n=1}^{\infty} \left\langle f, E_{n,n} \sqrt{m_n} \psi_n \right\rangle E_{n,n} \sqrt{m_n} \psi_n$$
$$= \sum_{n=1}^{\infty} \left\langle f, \left(E\left\{\sqrt{m_k} \psi_k\right\}_{k=1}^{\infty}\right)_n \right\rangle \left(E\left\{\sqrt{m_k} \psi_k\right\}_{k=1}^{\infty}\right)_n = S_E\left\{\sqrt{m_k} \psi_k\right\} f.$$

**Theorem 2.2.6.** Suppose that  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  are *E*-Riesz basis and *E*-sequence in  $\mathcal{H}$  respectively and  $m = \{m_n\}_{n=1}^{\infty}$  is a symbol. Then  $M_{m,\Psi,\Phi}^E = UM_{m,\mathcal{E},E\Phi}$ , where *U* is a bijection on  $\mathcal{H}$ .

*Proof.* First note that

$$(E\Psi)_n = \left( E \left\{ U \left( E^{-1} \left\{ e_j \right\}_{j=1}^\infty \right)_k \right\}_{k=1}^\infty \right)_n = \left( UE \left\{ \left( E^{-1} \left\{ e_j \right\}_{j=1}^\infty \right)_k \right\}_{k=1}^\infty \right)_n = Ue_n.$$

Thus for given  $f \in \mathcal{H}$ ,

$$M_{m,\Psi,\Phi}^{E}f = \sum_{n=1}^{\infty} m_n \langle f, (E\Phi)_n \rangle (E\Psi)_n$$
$$= \sum_{n=1}^{\infty} m_n \langle f, (E\Phi)_n \rangle Ue_n$$
$$= U\left(\sum_{n=1}^{\infty} m_n \langle f, (E\Phi)_n \rangle e_n\right) = UM_{m,\mathcal{E},E\Phi}f$$

$$M_{m,\Psi,\Phi}^{E}f = \sum_{n=1}^{\infty} m_n \left\langle f, \left(E\left\{\phi_k\right\}_{k=1}^{\infty}\right)_n \right\rangle \left(E\left\{\psi_k\right\}_{k=1}^{\infty}\right)_n$$
$$= T_E \left(m_n U_E^* f\right) = T \left(E^t \left\{m_n \left(\overline{E}U^* f\right)\right\}\right).$$

**Theorem 2.2.7.** Let H be a separable Hilbert space and  $E = (E_{n,k})_{n,k\geq 1}$  an infinite complex diagonal matrix. Suppose that  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  are E-Bessel sequences for  $\mathcal{H}$  and  $m = \{m_n\}_{n=1}^{\infty} \in \ell^{\infty}$ . If the sequence  $\{\lambda_n\}_{n=1}^{\infty} = \{E_{n,n}\}_{n=1}^{\infty}$  belongs to  $\ell^{\infty}$ , then the multiplier operator for sequences  $\{\psi_n\}_{n=1}^{\infty}$  and  $\{\phi_n\}_{n=1}^{\infty}$  with symbol  $m' = \{|\lambda_n|^2 m_n\}_{n=1}^{\infty}$  is well defined.

*Proof.* The multiplier  $M_{m,\Psi,\Phi}^E$  is well defined. Now for given  $f \in \mathcal{H}$ ,

$$M_{m,\Psi,\Phi}^{E}f = \sum_{n=1}^{\infty} m_n \left\langle f, \left( E\left\{\phi_k\right\}_{k=1}^{\infty}\right)_n \right\rangle \left( E\left\{\psi_k\right\}_{k=1}^{\infty}\right)_n$$
$$= \sum_{n=1}^{\infty} m_n \left\langle f, \lambda_n \phi_n \right\rangle \lambda_n \psi_n$$
$$= \sum_{n=1}^{\infty} |\lambda_n|^2 m_n \left\langle f, \phi_n \right\rangle \psi_n = M_{\left(|\lambda_n|^2 m_n\right),\Psi,\Phi} f.$$

**Theorem 2.2.8.** Consider two dual *E*-frames  $\Psi = \{\psi_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  in  $\mathcal{H}$  where *E* is an infinite complex diagonal matrix. Then  $M_{m,\Psi,\Phi} = M_{m,\Phi,\Psi} = Id_{\mathcal{H}}$  with  $m = \{|E_{n,n}|^2\}_{n=1}^{\infty}$ .

*Proof.* For given  $f \in \mathcal{H}$ ,

$$M_{m,\Psi,\Phi}f = \sum_{n=1}^{\infty} |E_{n,n}|^2 \langle f, \phi_n \rangle \psi_n$$
  
= 
$$\sum_{n=1}^{\infty} \langle f, E_{n,n}\phi_n \rangle E_{n,n}\psi_n$$
  
= 
$$\sum_{n=1}^{\infty} \langle f, (E \{\phi_k\}_{k=1}^{\infty})_n \rangle (E \{\psi_k\}_{k=1}^{\infty})_n = f.$$

Similarly, one can easily shows that  $M_{m,\Phi,\Psi} = Id_{\mathcal{H}}$ .

**Example 2.2.9.** Let  $\mathcal{H}$  be a separable Hilbert space with an orthonormal basis  $\{e_k\}_{k=1}^{\infty}$ . Then  $\Psi = \{\psi_k\}_{k=1}^{\infty} = \{ke_k\}_{k=1}^{\infty}$  and  $\Phi = \{\phi_k\}_{k=1}^{\infty} = \{k^2e_k\}_{k=1}^{\infty}$  are non-Bessel sequences. Now consider the invertible infinite matrix E as follow

$$E_{n,j} = \begin{cases} \frac{1}{n^2} & n = j, \\ 0 & n \neq j. \end{cases}$$

The matrix form of E is

$$E = \begin{pmatrix} 1 & 0 & 0 & \cdots \\ 0 & \frac{1}{4} & 0 & \cdots \\ 0 & 0 & \frac{1}{9} & \cdots \\ \vdots & \vdots & \vdots & \ddots \end{pmatrix}.$$

An easy argument shows that  $\{\psi_k\}_{k=1}^{\infty}$  and  $\{\phi_k\}_{k=1}^{\infty}$  are *E*-Bessel sequences. Thus  $M_{m,\Psi,\Phi}^E$  is well defined for all  $m \in \ell^{\infty}$ . Suppose that m = 1 and  $f \in \mathcal{H}$ . Then

$$M_{m,\Psi,\Phi}^{E}f = \sum_{n=1}^{\infty} 1 \left\langle f, \left(E\left\{\phi_{k}\right\}_{k=1}^{\infty}\right)_{n}\right\rangle \left(E\left\{\psi_{k}\right\}_{k=1}^{\infty}\right)_{n}$$
$$= \sum_{n=1}^{\infty} \left\langle f, \frac{1}{n^{2}}\phi_{n}\right\rangle \frac{1}{n^{2}}\psi_{n}$$
$$= \sum_{n=1}^{\infty} \frac{1}{n^{4}} \left\langle f, \phi_{n}\right\rangle \psi_{n} = M_{\left(\frac{1}{n^{4}}\right),\Psi,\Phi}f$$
$$= \sum_{n=1}^{\infty} \frac{1}{n} \left\langle f, e_{n}\right\rangle e_{n} = M_{\left(\frac{1}{n}\right),(e_{n}),(e_{n})}f.$$

**Theorem 2.2.10.** Suppose that E is an infinite complex diagonal matrix and  $\Psi = \{\psi_k\}_{k=1}^{\infty}$ and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  are two Bessel sequence which is not frame. Then the following holds.

- (i) If  $\Psi$ ,  $\Phi$  are  $\| \|$ -semi-normalized and  $\{|E_{n,n}|^2\}_{n=1}^{\infty} \in \ell^{\infty}$  but not semi-normalized, then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Phi,\Psi}^E$  are unconditionally convergent but not invertible.
- (ii) If  $\Psi$  is  $\| \|$ -semi-normalized,  $\Phi$  is non-norm bounded below and  $\{ |E_{n,n}|^2 \}_{n=1}^{\infty} \in \ell^{\infty}$  but not semi-normalized, then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Phi,\Psi}^E$  are unconditionally convergent but not invertible.
- (iii) If  $\Psi$ ,  $\Phi$  are non-norm bounded below and  $\{|E_{n,n}|^2\}_{n=1}^{\infty} \in \ell^{\infty}$  but not semi-normalized, then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Phi,\Psi}^E$  are unconditionally convergent but not invertible.

**Example 2.2.11.** Suppose that  $\Phi = \{e_2, e_3, e_4, ...\}$  and let

$$E = \begin{pmatrix} \frac{1}{2} & 0 & 0 & \cdots \\ 0 & \frac{1}{3} & 0 & \cdots \\ 0 & 0 & \frac{1}{4} & \cdots \\ \vdots & \vdots & \vdots & \ddots \end{pmatrix}$$

Then for given  $f \in \mathcal{H}$ ,

$$M_{1,\Phi,\Phi}^{E}f = \sum_{n=1}^{\infty} \langle f, (E\Phi)_{n} \rangle (E\Phi)_{n}$$
$$= \sum_{n=2}^{\infty} \frac{1}{n^{2}} \langle f, e_{n} \rangle e_{n},$$

which is unconditionally convergent because  $\{\langle f, e_n \rangle\}_{n=2}^{\infty} \in \ell^2(\mathbb{N}), \ \{\frac{1}{n^2}\}_{n=1}^{\infty} \in \ell^{\infty} \text{ and } \{e_n\}_{n=2}^{\infty}$  is Bessel. Clearly,  $M_{1,\Phi,\Phi}^E$  is not surjective, since there is no f such that  $M_{1,\Phi,\Phi}^E f = e_1$ .

**Example 2.2.12.** Suppose that  $\Phi = \{e_2, e_3, e_4, ...\}$  and  $\Psi = \{\frac{1}{2}e_2, \frac{1}{3}e_3, \frac{1}{4}e_4, ...\}$  and let

$$E = \begin{pmatrix} 2 & 0 & 0 & \cdots \\ 0 & 3 & 0 & \cdots \\ 0 & 0 & 4 & \cdots \\ \vdots & \vdots & \vdots & \ddots \end{pmatrix}.$$

Then for given  $f \in \mathcal{H}$ ,

$$M_{1,\Psi,\Phi}^{E}f = \sum_{n=1}^{\infty} \langle f, (E\Phi)_{n} \rangle (E\Psi)_{n}$$
$$= \sum_{n=2}^{\infty} \langle f, e_{n} \rangle e_{n} = f - \langle f, e_{1} \rangle e_{1},$$

which is unconditionally convergent because  $\{e_n\}_{n=1}^{\infty}$  is an orthonormal basis. Clearly,  $M_{1,\Phi,\Phi}^E$  is not surjective, since there is no f such that  $M_{1,\Phi,\Phi}^E f = e_1$ .

**Theorem 2.2.13.** Suppose that *E* is an infinite complex diagonal matrix and  $\Psi = \{\psi_k\}_{k=1}^{\infty}$ and  $\Phi = \{\phi_k\}_{k=1}^{\infty}$  are two Riesz bases. Then the following holds.

- (i) If  $\Psi$ ,  $\Phi$  are  $\| \|$ -semi-normalized and  $\{ |E_{n,n}|^2 \}_{n=1}^{\infty}$  is semi-normalized, then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Psi,\Psi}^E$  are unconditionally convergent and invertible.
- (ii)  $\Psi$ ,  $\Phi$  are  $\| \|$ -semi-normalized and  $\{|E_{n,n}|^2\}_{n=1}^{\infty} \in \ell^{\infty}$  but not semi-normalized, then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Phi,\Psi}^E$  are unconditionally convergent but not invertible.
- (iii) If  $\Psi$ ,  $\Phi$  are  $\| \|$ -semi-normalized and  $\{|E_{n,n}|^2\}_{n=1}^{\infty} \notin \ell^{\infty}$ , then  $M_{1,\Psi,\Phi}^E$  and  $M_{1,\Phi,\Psi}^E$  are not well defined.

**Example 2.2.14.** Fix  $k \in \mathbb{N}$  and suppose that  $\Phi = \{e_1, e_2, e_3, e_4 \dots\}$ .Let

$$E = \begin{pmatrix} 1 & 0 & 0 & 0 & \cdots \\ 0 & \frac{1}{2^k} & 0 & 0 & \cdots \\ 0 & 0 & \frac{1}{3^k} & 0 & \cdots \\ 0 & 0 & 0 & \frac{1}{4^k} & \cdots \\ \vdots & \vdots & \vdots & \vdots & \ddots \end{pmatrix}.$$

Then for given  $f \in \mathcal{H}$ ,

$$M_{1,\Phi,\Phi}^{E}f = \sum_{n=1}^{\infty} \langle f, (E\Phi)_{n} \rangle (E\Phi)_{n}$$
$$= \sum_{n=1}^{\infty} \frac{1}{n^{2k}} \langle f, e_{n} \rangle e_{n},$$

which is unconditionally convergent by [1, Theorem 6.1]. Clearly,  $M_{1,\Phi,\Phi}^E$  is not surjective, since for example the element  $\sum_{n=1}^{\infty} \frac{1}{n^k} e_n$  belongs to  $\mathcal{H}$  but dose not belong to the range of  $M_{1,\Phi,\Phi}^E$ .
