Orthogonal polynomials in the spherical ensemble with two insertions

Abstract

We consider planar orthogonal polynomials $P_{n,N}$ with respect to the weight

$$\frac{|z-w|^{NQ_1}}{(1+|z|^2)^{N(1+Q_0+Q_1)+1}}, \quad (Q_0, Q_1 > 0)$$

in the whole complex plane. With $n,N\to\infty$ and N-n fixed, we obtain the strong asymptotics of the polynomials, and asymptotics for the weighted L^2 norm and the limiting zero counting measure. These results apply to the pre-critical phase of the underlying Coulomb gas system, when the equilibrium measure is simply connected. Our method relies on specifying the mother body of the two-dimensional potential problem. It relies too on the fact that the planar orthogonality can be rewritten as a non-Hermitian contour orthogonality. This allows us to perform the Deift-Zhou steepest descent analysis of the associated 2×2 Riemann-Hilbert problem.

1 Introduction and statement of results

1.1 Underlying Coulomb gas, random matrix ensemble and relation to planar orthogonal polynomials

Let $\{\mathbf{r}_j\}_{j=1}^N$ be N points on the surface of the sphere of radius $\frac{1}{2}$ embedded in \mathbb{R}^3 and centred at the origin. Let $||\mathbf{x}||$ denote the usual Euclidean length in \mathbf{R}^3 . Suppose these N unit points are in fact charges obeying Poisson's equation as defined on the surface of the sphere so that a point at \mathbf{x} and a point at \mathbf{x}' interact via the pair potential $-\log ||\mathbf{x} - \mathbf{x}'||$; see e.g. [28, Eq. (15.105)]. In addition, let there be two fixed charges of (macroscopic) strengths NQ_0 and NQ_1 at positions \mathbf{R}_0 and \mathbf{R}_1 , with $Q_0, Q_1 > 0$. Up to a multiplicative constant, the corresponding Boltzmann factor has the functional form

$$||\mathbf{R}_{0} - \mathbf{R}_{1}||^{\beta N^{2}Q_{0}Q_{1}} \prod_{l=1}^{N} ||\mathbf{R}_{0} - \mathbf{r}_{l}||^{\beta NQ_{0}}||\mathbf{R}_{1} - \mathbf{r}_{l}||^{\beta NQ_{1}} \prod_{1 \leq j < k \leq N} ||\mathbf{r}_{k} - \mathbf{r}_{j}||^{\beta},$$
(1.1)

where $\beta > 0$ is the inverse temperature. By rotational invariance of the sphere, it is always possible to choose \mathbf{R}_0 to be at the south pole $(0,0,-\frac{1}{2})$, which we henceforth assume.

From the viewpoint of charge neutrality in the Coulomb gas picture, it has been noted in [14] that associated with fixed charges at positions \mathbf{R}_0 and \mathbf{R}_1 are spherical caps of area $\pi Q_0/(Q_0+Q_1+1)$ and $\pi Q_1/(Q_0+Q_1+1)$, respectively. As already evident from potential theoretic viewpoints [10, 20, 21, 23, 42] the Coulomb gas exists in two phases depending on there being no overlap of the spherical caps (referred to as the *post-critical phase*), or the spherical caps overlapping (referred to as the *pre-critical phase*). With (θ, ϕ) the polar angle, azimuthal angle pair corresponding to the point \mathbf{R}_1 , we have from [14, Eq. (1.7)] that the condition for no overlap, and thus the post-critical phase is

$$\cos^{2}(\theta/2) > \frac{1}{(\gamma_{1} + \gamma_{2} + 2)^{2}} \left(\sqrt{(\gamma_{1} + 1)(\gamma_{1} + \gamma_{2} + 1)} + \sqrt{\gamma_{2} + 1} \right)^{2} \Big|_{\substack{\gamma_{1} = -1 + Q_{0}/Q_{1} \\ \gamma_{2} = 1/Q_{1}}}.$$
(1.2)

On the other hand, if this inequality is in the other direction, the Coulomb gas system is in the pre-critical phase.

Suppose now that the points on the sphere are stereographically projected to the complex plane, viewed to be tangent to the north pole; this construction is illustrated e.g. in [28,

Figure 15.2]. With \mathbf{r} , \mathbf{r}' points on the sphere and z, z' the corresponding points on the plane, we then have that [28, equivalent to (15.126)]

$$||\mathbf{r} - \mathbf{r}'|| = \frac{|z - z'|}{(1 + |z|^2)^{1/2} (1 + |z'|^2)^{1/2}}.$$
(1.3)

Noting too the relation between the differential on the surface of the sphere dS say, and the flat measure on the complex plane viewed as \mathbb{R}^2 [28, Eq. (15.127)]

$$dS = \frac{1}{(1+|z|^2)^2} dx dy, \tag{1.4}$$

we have that the stereographically projected form of (1.1) is equal to

$$\frac{1}{(1+|w|^2)^{\beta Q_0 Q_1 N^2}} \prod_{l=1}^{N} \frac{1}{(1+|z_l|^2)^{\beta (Q_0 + Q_1 + 1)N/2 + 2 - \beta/2}} |w - z_l|^{\beta Q_1 N} \prod_{1 \le j < k \le N} |z_k - z_j|^{\beta}, \quad (1.5)$$

where w is the stereographic projection onto the complex plane of \mathbf{R}_1 . It is convenient to rotate the sphere about the veritical axis so that w > 0. The equation (1.2) can be rewritten in terms of w. Thus the requirement that the spherical caps associated with two charges overlap restricts Q_0, Q_1, w to be such that [14, Eq. (2.74)]

$$w > w_{\text{cri}} := \left(2Q_0Q_1 + Q_0 + Q_1 + 2\sqrt{Q_0Q_1(1+Q_0)(1+Q_1)}\right)^{-1/2}.$$
 (1.6)

Now set

$$\beta = 2, \quad Q_1 N = r, \quad Q_0 N = K$$
 (1.7)

in (1.5). The factor in (1.5) independent of w is then

$$\prod_{l=1}^{N} \frac{1}{(1+|z_l|^2)^{K+r+N+1}} \prod_{1 \le j < k \le N} |z_k - z_j|^2.$$
 (1.8)

As revised in [14, §3.1] this functional form, up to proportionality, is the eigenvalue probability density function for the ensemble $\mathrm{SrUE}_{(N,s)}$ with s=K+r. The (non-Hermitian) ensemble $\mathrm{SrUE}_{(N,s)}$ is formed from random matrices $(G^{\dagger}G)^{-1/2}X$ where G is an $(N+s)\times N$ complex standard Gaussian matrix and X is an $N\times N$ complex standard Gaussian matrix; the case s=0 corresponds to the complex spherical ensemble [13, §2.5]. This allows (1.5) with the substitution (1.7) to be identified as proportional to

$$\frac{1}{(1+|w|^2)^{2rK}} \left\langle \prod_{l=1}^N |w-z_l|^{2r} \right\rangle_{SrUE_{n,N,K+r}}.$$
 (1.9)

In words the second factor is the ensemble average with respect to $SrUE_{N,K+r}$ of the 2r-th power of the absolute value of the characteristic polynomial $\prod_{l=1}^{N} |w - z_l|$. A result from [29] gave that this ensemble average is, assuming $k \geq r$, equal to the different ensemble average

$$\left\langle \prod_{l=1}^{r} (|w|^2 + t_l)^N \right\rangle_{\text{JUE}_{r,(0,K-r)}}.$$
 (1.10)

Here $JUE_{r,(0,K-r)}$ denotes the (Hermitian) Jacobi unitary ensemble of r eigenvalues $\{t_l\}$ supported on the interval (0,1) and distributed according to the probability density function proportional to

$$\prod_{l=1}^{r} (1 - t_l)^{K-r} \prod_{1 \le j < k \le n} |t_k - t_j|^2;$$

for more on this see [28, Ch. 3]. Since the roles of N and r in the average in (1.9) and that of (1.9) their equality is referred to as a duality identity. In [14] this was used as one tool to study the large n form of the configuration integral associated with the $\beta = 2$ case of the Boltzmann factor (1.1) or equivalently (1.5), in both the pre- and post-critical phases.

A salient feature of (1.1) and (1.5) with $\beta = 2$ is that they both specify determinantal point processes. Consider for definiteness (1.5). Excluding the first factor, this can be written

$$\prod_{l=1}^{N} e^{-NV(z_l)} \prod_{1 \le j < k \le N} |z_k - z_j|^2, \tag{1.11}$$

where

$$V(z) = \left(1 + \frac{1}{N} + Q_0 + Q_1\right) \log(1 + |z|^2) - 2Q_1 \log|z - w|. \tag{1.12}$$

Introduce monic orthogonal polynomials $\{P_{k,N}(z)\}_{k=0}^{N-1}$ of degree k such that

$$\int_{\mathbb{C}} P_{l,N}(z) \overline{P_{k,N}(z)} e^{-NV(z)} dA(z) = h_{k,N} \delta_{k,l}, \quad (l,k = 0, 1..., N-1),$$
(1.13)

where dA(z) = dx dy. One notes that V(z) and thus the polynomials $P_{k,N}(z)$ depend on w, although this dependance is suppressed in the notation. Standard theory (see e.g. [28, §15.3]) gives that

$$\int_{\mathbb{C}} dA(z_1) \cdots \int_{\mathbb{C}} dA(z_N) \prod_{l=1}^{N} e^{-NV(z_l)} \prod_{1 \le j \le k \le N} |z_k - z_j|^2 = N! \prod_{l=0}^{N-1} h_{l,N},$$
 (1.14)

and

$$\rho_{(k)}(z_1, \dots, z_k) = \det[K_N(z_i, z_j)]_{i,j=1}^k, \tag{1.15}$$

with

$$K_N(w,z) = e^{-\frac{N}{2}(V(w) + V(z))} \sum_{l=0}^{N-1} \frac{P_{l,N}(w)\overline{P_{l,N}(z)}}{h_{l,N}}.$$
(1.16)

In (1.15), $\rho_{(k)}$ denotes the k-point correlation function, defined as a suitable normalisation times (1.11) integrated over z_{k+1}, \ldots, z_N ; see e.g. [28, §5.1.1]. Of particular interest is the large N form of the partition function (1.14), which will be dependent on the phase (post or pre-critical), as well as the correlation function (1.16), which in fact can be proved to exhibit universal properties [1, 2, 33] in the microscopic scaling regime. The study of [33] (and its subsequent work [32]) is particularly relevant to the present work, as it derives the asymptotic form of the orthonormal polynomials $h_{n,N}^{-1/2}P_{n,N}(z)$ outside the droplet in the large N, n limit, with $n/N \in (0,1]$ fixed. This result holds for a general class of potentials V(z) under certain conditions, such as the connectivity of the droplet. Here, the droplet refers to the support of the equilibrium measure associated with V; see e.g. [47].

In the present work we take up the problem of obtaining asymptotics of $h_{n,N}$ and $P_{n,N}(z)$ separately in the case that V(z) is given by (1.12), using ideas introduced in the work [4] in the case that

$$V^{g}(z) = |z|^{2} - 2Q \log|z - w|. \tag{1.17}$$

The term $-2Q \log |z-w|$ is the potential due to an external charge; the effect of which in two-dimensional Coulomb gas systems has been studied in the recent works [3, 11, 12, 15, 16, 17, 18, 19, 24, 36, 50]. A preliminary to obtaining the asymptotics requires developing a mother body theory relating to the equilibrium measure associated with (1.11), which is of independent interest.

1.2 Statement of results

For a compactly supported finite Borel measure μ we denote the logarithmic potential and corresponding logarithmic energy as

$$U^{\mu}(z) = \int \log \frac{1}{|z-s|} d\mu(s), \qquad I(\mu) = \int U^{\mu}(z) d\mu(z). \tag{1.18}$$

The equilibrium measure associated with the large-N limit of the potential (1.12) corresponds to the unique probability measure ν_0 which minimizes the energy functional

$$I(\nu) - 2Q_1 \int \log|w - u| \, d\nu(u) + (Q_0 + Q_1 + 1) \int \log(1 + |u|^2) \, d\nu(u), \tag{1.19}$$

over all probability measures supported on the complex plane. The external field is strongly admissible (i.e. has sufficient growth at infinity [47]), hence the equilibrium measure is compactly supported. We denote $\operatorname{supp}(\nu_0) = \Omega$. For the equilibrium measure, it is well known [47] that there exists a real constant ℓ_{2D} (the precise form is given in [14, Prop. 2.9]) such that the variational conditions

$$\mathcal{U}_{2D}(z) = 2U^{\nu_0}(z) - 2Q_1 \log|z - w| + (Q_0 + Q_1 + 1) \log(1 + |z|^2) + \ell_{2D} \begin{cases} = 0 & z \in \Omega, \\ \geq 0 & z \in \mathbb{C} \setminus \Omega \end{cases}$$
(1.20)

hold.

The particular (connected) domain Ω solving (1.20) in the pre-critical phase has been determined in [14]. There (in Prop. 2.7) the parameters ρ , a, b of the conformal map

$$f(u) := \frac{\rho}{u} \frac{1 - bu}{1 - au},\tag{1.21}$$

from the interior of the unit disc \mathbb{D} to the exterior of the droplet $\mathbb{C} \setminus \Omega$ have been specified. The details are not required in the present work, except for the features that $\rho > 0$, 0 < a < 1 and a < b. One comments too that ν_0 is absolutely continuous with respect to the two-dimensional Lebesgue measure dA(u) with density given by

$$d\nu_0(u) = \frac{(1+Q_0+Q_1)}{\pi} \frac{1}{(1+|u|^2)^2} dA(u).$$
 (1.22)

Our first result is concerning the mother body (see e.g. the introduction of [9], [31] for contextual and historical remarks). We construct a one-dimensional measure supported on a curve Γ_0 whose Cauchy (also known as Stieltjes) transform agrees with the Cauchy transform of the two-dimensional equilibrium measure on the exterior of Ω .




Figure 1: Evolution of the droplet (in shaded blue) and mother body (in dashed red) as w decreases.

Theorem 1.1. There exists a Borel probability measure μ_0 , supported on a curve Γ_0 , which lies in the interior of Ω and intersects the real line between (-1/w, 0) with the following properties:

(1) There is a rational function R_0 (explicitly given in (3.18)) such that

$$d\mu_0(s) = \frac{1}{2\pi i} \sqrt{R_0(s)} \, ds,\tag{1.23}$$

where ds represents the line element of Γ_0 . The branch cut of the square root of $R_0(s)$ is taken in Γ_0 and the branch is taken such that

$$\sqrt{R_0(z)} = \frac{Q_0}{z} + \mathcal{O}(z^{-2}), \quad as \ z \to \infty.$$
 (1.24)

(2) There is a smooth simple closed curve Γ , which has 0 in its interior and -1/w in its exterior, with $\Gamma_0 \subset \Gamma$ and a real constant ℓ_0 such that

$$2U^{\mu_0}(z) + \operatorname{Re} \mathcal{V}(z) + \ell_0 \begin{cases} = 0 & z \in \Gamma_0, \\ > 0 & z \in \Gamma \setminus \Gamma_0, \end{cases}$$
 (1.25)

where

$$\mathcal{V}(z) = (1 + Q_1)\log z + (1 + Q_0)\log\left(z + \frac{1}{w}\right) - Q_1\log(z - w). \tag{1.26}$$

Here, the branch of the logarithm is chosen on $(-\infty, -1/w] \cup [0, w]$.

(3) We have the equality of Cauchy transforms

$$\int \frac{d\nu_0(s)}{z-s} = \int \frac{d\mu_0(s)}{z-s}, \quad z \in \mathbb{C} \setminus \Omega.$$
 (1.27)

Remark 1.2. The measure μ_0 can also be characterized as a solution to a max-min equilibrium problem. The steps are given in Appendix A.

To obtain the large N asymptotics of the orthogonal polynomials $P_{n,N}$, we rely on the fact that the planar orthogonality can be reformulated as non-Hermitian contour orthogonality, a fact which is of independent interest.

Proposition 1.3. Let $N, NQ_1, NQ_0 \in \mathbb{N}$. Furthermore, let $P_{n,N}(z)$ satisfy

$$\int_{\mathbb{C}} P_{n,N}(z) \overline{(z-w)}^k \frac{|z-w|^{2NQ_1}}{(1+|z|^2)^{N(1+Q_0+Q_1)+1}} dA(z) = 0, \quad k = 0, \dots n-1.$$
 (1.28)

Then for a simple closed contour Γ with positive orientation which has 0 in the interior and -1/w in the exterior we have

$$\oint_{\Gamma} P_{n,N}(z)z^{j}(z-w)^{NQ_{1}} \frac{1}{(1+zw)^{N+NQ_{0}}} \frac{1}{z^{n+NQ_{1}}} = 0, \quad j = 1, \dots n-1.$$
(1.29)

For the orthogonal polynomials associated with the external potential (1.17), the equivalent contour orthogonality was established in [4, §3] and further extended in [6, 40] to the case of multiple point charges. Such contour orthogonality serves as a cornerstone for several works [5, 7, 16, 18, 36, 39, 41, 50] in various asymptotic analyses of orthogonal polynomials, as well as in the study of statistical properties of the associated Coulomb gases. Since (1.17) can be obtained as a particular limit of (1.12) (see [14] for a related discussion), Proposition 1.3 can be regarded as an extension of the result in [4, §3].

Remark 1.4. From (1.29), the weight function for the non-Hermitian contour orthogonality is given as

$$w_{n,N}(z) = (z - w)^{NQ_1} \frac{1}{(z + 1/w)^{N+NQ_0}} \frac{1}{z^{n+NQ_1}}.$$
(1.30)

This matches with $e^{-N\mathcal{V}(z)}$ (recall (1.26) for definition of \mathcal{V}) up to a factor z^{n-N} . This will play a crucial role in the steepest descent analysis that follows.

By [26], Proposition 1.3 further allows us to write $P_{n,N}$ as a solution to a 2×2 Riemann-Hilbert problem which is described at the beginning of Section 5, referred to as RH problem 5.1. To obtain the strong asymptotics of $P_{n,N}$ we proceed in Section 5 to perform the Deift-Zhou steepest descent analysis [25] of the Riemann-Hilbert problem, which at a technical level has steps in common with the works [4, 5, 6, 7, 8, 16, 18, 35, 39, 40, 41]. To state our main result about in this regard, we recall the measure μ_0 in Theorem 1.1 and its associated g-function,

$$g(z) = \int \log(z - s) d\mu_0(s).$$
 (1.31)

Further, we denote the conformal map F_1 which maps the exterior of the droplet Ω to the unit disc $\mathbb{D}(0,1)$. It is the inverse of the analytic function f(u) given in (1.21), which behaves as $F_1(z) = \rho z^{-1} + \mathcal{O}(z^{-2})$ as $z \to \infty$.

Theorem 1.5. Let w satisfy (1.6) and let $n, N \to \infty$ be such that $n - N = r_0 < 0$ is fixed. Moreover, assume that N, NQ_1 , and NQ_0 are integers. Then we have

$$P_{n,N}(z) = i \left(\frac{\rho}{F_1(z)}\right)^{r_0} \frac{\sqrt{\rho F_1'(z)}}{F_1(z)} e^{Ng(z)} (1 + \mathcal{O}(N^{-1})) \quad as \ N \to \infty$$
 (1.32)

uniformly for z in compact subsets of $\overline{\mathbb{C}} \setminus \Gamma_0$

Remark 1.6.

1. It is expected that the assumptions that N, NQ_1 , and NQ_0 are integers are not essential and that the statement of the theorem holds without them.

- 2. In (1.32), the pre-factor in front of $e^{Ng(z)}$ appears as the (1,1) entry of the global parametrix 5.8, and the branch cut of $\sqrt{F_1'(z)}$ is taken such that $i\sqrt{\rho F_1'(z)}/F_1(z)$ tends to 1 as $z \to \infty$.
- 3. The map $F_1(z)$ originally defined in $\mathbb{C} \setminus \Omega$ has an analytic continuation to the domain $\mathbb{C} \setminus \Gamma_0$. Moreover, we will also see that $F_1(z) \neq 0$ and finite valued in $\mathbb{C} \setminus \Gamma_0$. This analytic continuation is used in (1.32).
- 4. The map

$$F_0(z) = \frac{1}{F_1(z)} : \mathbb{C} \setminus \Omega \to \mathbb{C} \setminus \mathbb{D}$$
 (1.33)

is the conformal map from the exterior of the droplet to the exterior of the unit disc. Then (1.32) can be rewritten as

$$P_{n,N}(z) = (\rho F_0(z))^{r_0} e^{Ng(z)} \sqrt{\rho F_0'(z)} (1 + \mathcal{O}(N^{-1})). \tag{1.34}$$

The expansion (1.34) is similar to the strong asymptotics of the orthogonal polynomials obtained in [4], and consistent with the known expansion of [33] in the exterior of the droplet.

As a consequence of Theorem 1.5, we obtain the limiting zero counting measure of the polynomials $P_{n,N}$.

Theorem 1.7. Under the same assumption of Theorem 1.5 all zeros of $P_{n,N}$ tend to Γ_0 . In addition, μ_0 is the weak limit of the normalized zero counting measure of $P_{n,N}$.

We also obtain the large N expansion of the normalization $h_{n,N}$ in (1.13). Recall ρ in (1.21) and ℓ_{2D} in (1.20).

Theorem 1.8. Under the same assumption of Theorem 1.5, we have

$$h_{n,N} = \pi \sqrt{\frac{2\pi}{N(Q_1 + Q_0 + 1)}} \rho^{2r_0 + 1} e^{N\ell_{2D}} \left(1 + \mathcal{O}(N^{-1}) \right). \tag{1.35}$$

Remark 1.9.

- 1. We find Theorem 1.8 remarkable. The RH problem 5.1 gives us the asymptotics of the normalization of $P_{n,N}$ with respect to the weight $w_{n,N}$, and this involves the Robin constant ℓ_0 in (1.25). However, we can express ℓ_0 in terms of ℓ_{2D} in a curious way, as is done in Lemma 6.1 (a similar miraculous relation also appears in [4, Lemma 7.2]). As we shall see, this drastically simplifies $h_{n,N}$ and gives us (1.35).
- 2. If (1.35) should be uniformly valid in r_0 for large N, substitution in (1.14) predicts the leading large N asymptotic form

$$\log Q_N \sim N^2(\ell_{\rm 2D} - \log \rho). \tag{1.36}$$

Here Q_N is the configuration integral associated with (1.11), as given in the LHS of (1.14). Using the identification of ρ in (1.21) as the logarithmic capacity of the droplet (see e.g. [4, text below (1.24)]),

$$\log \rho = \int_{\Omega} d\mu(z) \int_{\Omega} d\mu(w) \log |w - z|,$$

we see that (1.36) is consistent with the electrostatic argument of [14, §2.4].

2 Construction of a meromorphic function on a Riemann surface

The map f in (1.21) is a rational map of degree 2 with poles at 1/a and 0 and zeros at 1/b and ∞ . In addition, the equation f'(u) = 0 admits two complex conjugate solution (due to the fact a < b), which are denoted by u_1, u_2 and the critical values $f(u_j)$ are denoted as z_j . We also note at this stage that the equation f(z)f(1/z) + 1 = 0 permits two solutions, v_0 , $1/v_0$ both of which are real with $0 < v_0 < 1$ and

$$f(v_0) = w, f(1/v_0) = -1/w;$$
 (2.1)

see [14, §2.3]

Lemma 2.1. Each z_i lies on the interior of Ω .

Proof. By symmetry it suffices to consider z_1 . Since f is a twofold branched covering, and the map f is conformal on the interior of the unit disc \mathbb{D} , we have $u_1 \in \mathbb{C} \setminus \mathbb{D}$, and z_1 has only one preimage u_1 . If z_1 was in $\mathbb{C} \setminus \Omega$, then since we require f to be surjective from $\mathbb{D}(0,1)$ to $\mathbb{C} \setminus \Omega$, we must have u_1 in the interior of the unit disc, which is a contradiction.

By definition, the deck transformation, denoted deck(u), is characterised by the condition that

$$f(u) = f(\operatorname{deck}(u)). \tag{2.2}$$

Since f is given by (1.21), one can see that

$$\operatorname{deck}(u) = \frac{a-b}{ab} \frac{u}{u-1/b} + \frac{1}{a},\tag{2.3}$$

and the fixed points of $\operatorname{deck}(u)$ are the critical points of f, u_1 and u_2 . The map f has two inverses denoted by F_1 and F_2 which are determined by their behaviour at ∞ ,

$$F_1(z) = \frac{\rho}{z} + \mathcal{O}(z^{-2}), \qquad F_2(z) = \frac{1}{a} + \mathcal{O}(z^{-1}).$$
 (2.4)

In the case of the first of these, F_1 maps the exterior of the droplet Ω to the unit disc \mathbb{D} as already noted in the sentence above Theorem 1.5. The two inverses are related by

$$F_2(z) = \operatorname{deck}(F_1(z)). \tag{2.5}$$

These inverse functions have the explicit forms

$$F_1(z) = \frac{b\rho + z - \sqrt{(z - z_1)(z - z_2)}}{2az},$$
(2.6)

$$F_2(z) = \frac{b\rho + z + \sqrt{(z - z_1)(z - z_2)}}{2az}.$$
 (2.7)

The branch cut of the square root is taken as a simple curve \mathcal{B} which joins z_1 and z_2 while intersecting the real line between (-1/w,0) once. Moreover, F_1 has analytic continuation to a second sheet by F_2 which is connected to the first sheet in a crisscross manner across \mathcal{B} . We will in particular make a precise choice of this cut which will turn out to be the mother body.




Figure 2: The plot of the function F_1 in red and its analytic continuation F_2 in blue on the real line. One observes F_2 has a pole at 0.

2.1 Spherical Schwarz function

Denote

$$\nu = \frac{1}{Q_0 + Q_1 + 1} \nu_0,\tag{2.8}$$

where we recall the definition ν_0 is the equilibrium measure of (1.19). Applying ∂_z to the variational conditions (1.20), we obtain

$$\int \frac{d\nu(s)}{u-s} + \frac{Q_1}{1+Q_0+Q_1} \frac{1}{u-w} = \frac{\overline{u}}{1+|u|^2}, \qquad u \in \Omega.$$
 (2.9)

Since f maps the unit circle to a closed simple curve $\partial\Omega$, we have $F_1:\partial\Omega\mapsto\mathbb{S}^1$. Note that if

$$f(u) = z, \qquad |u| = 1, \ z \in \partial\Omega, \tag{2.10}$$

then

$$f(1/F_1(z)) = f(1/u) = f(\overline{u}) = \overline{f(u)} = \overline{z}.$$
(2.11)

Here we have used that the rational map f has real coefficients.

We define

$$S_1(z) := \frac{f(1/F_1(z))}{1 + zf(1/F_1(z))}, \qquad z \in \mathbb{C} \setminus \mathcal{B}.$$

$$(2.12)$$

It is immediate that $S_1(z)$ has a pole at z = w with residue $Q_1/(1 + Q_0 + Q_1)$. Also, it is meromorphic in $\mathbb{C} \setminus \mathcal{B}$. From the precedent of [20], we call S_1 the spherical Schwarz function of the droplet Ω .

We know from [14, Eq. (2.48)] that with u replaced by f(u), $|u| \leq 1$ and thus $f(u) \in \overline{\mathbb{C} \setminus \Omega}$, the RHS of (2.9) can be replaced by the meromorphic function f(1/u)/(1 + f(u)f(1/u)). Equivalently, we have

$$\int \frac{d\nu(s)}{z-s} + \frac{Q_1}{1+Q_0+Q_1} \frac{1}{z-w} = S_1(z), \qquad z \in \overline{\mathbb{C}\backslash\Omega}.$$
 (2.13)




Figure 3: The Riemann surface \mathcal{R}

One notes from (2.11) that the equality herein for $z \in \Omega$ is consistent with (2.9).

We define the analytic continuation of S_1 across the branch cut \mathcal{B} (the precise form is yet to be chosen) joining z_1, z_2 by the map F_2 as

$$S_2(z) := \frac{f(1/F_2(z))}{1 + zf(1/F_2(z))}. (2.14)$$

Then defining \mathcal{R} to be a two-sheeted Riemann surface with sheets \mathcal{R}_j (j=1,2), the map

$$S(z) := \begin{cases} S_1(z) & z \in \mathcal{R}_1, \\ S_2(z) & z \in \mathcal{R}_2, \end{cases}$$
 (2.15)

defines a meromorphic function on \mathcal{R} ; see Figure 3.

We now determine its poles, zeros and an underlying algebraic equation. From the asymptotic behaviour given by (2.4), it is easy to see that

$$S_1(z) = \frac{b\rho^2}{z(a+b\rho^2)} + \mathcal{O}(z^{-2}) = \frac{Q_1+1}{Q_0+Q_1+1} \frac{1}{z} + \mathcal{O}(z^{-2}), \qquad z \to \infty.$$
 (2.16)

An alternative derivation is to recall that $S_1(z)$ has a pole at z = w with residue $Q_1/(1 + Q_0 + Q_1)$, and to note that by (2.8), the Cauchy transform of the droplet measure satisfies

$$\int \frac{d\nu(s)}{z-s} = \frac{1}{Q_0 + Q_1 + 1} \frac{1}{z} + \mathcal{O}(z^{-2}), \qquad z \to \infty.$$

In addition, by (2.4), we have

$$S_2(z) = \frac{1}{z} + \mathcal{O}(z^{-2}), \qquad z \to \infty.$$
 (2.17)

Due to the fact $F_2(z)$ has a pole at 0 (as it should as f maps ∞ to zero), we have by residue calculation that

$$S_2(z) = \frac{Q_1 + 1}{1 + Q_0 + Q_1} \frac{1}{z} + \mathcal{O}(z^{-2}), \qquad z \to 0.$$
 (2.18)

Remark 2.2. Note that f has a pole at 1/a and therefore 1/F(f(a)) = 1/a at f(a), telling us that S has an isolated singularity at f(a). However, due to the pole appearing in the numerator and denominator together in (2.14), the singularity is removable.

Recall (2.1). Since the sum of residues of a meromorphic function S_2 (viewed on the Riemann surface \mathcal{R}) should vanish, it follows from (2.14), (2.18), (2.16), (2.17) and (2.9) that S_2 has a pole at -1/w with residue $(1+Q_0)/(1+Q_0+Q_1)$.

Lemma 2.3. There exists c_0 , with $c_0 > w$, such that $S_1(c_0) = S_2(c_0)$.

Proof. We first observe that S_1, S_2 are real and analytic in (w, ∞) . In addition, S_1 has a pole at w, with a positive residue, giving us $S_1(s) > S_2(s)$ for $s \in (w, w + \varepsilon)$, with $\varepsilon > 0$ sufficiently small. Next, from (2.16) and (2.17) we can conclude $S_2(s) > S_1(s)$ for sufficiently large s. The proof is then complete, invoking the intermediate value theorem.

2.2 Spectral Curve

With the knowledge in the previous subsection, we are ready to determine the underlying algebraic curve, referred to as the *spectral curve*. The symmetric functions of the branches of a meromorphic function are rational; hence, we have $S_1 + S_2$ and S_1S_2 are rational functions. Define,

$$P_1(z) := S_1(z) + S_2(z)$$

$$= \frac{1 + Q_0}{1 + Q_0 + Q_1} \frac{1}{z + 1/w} + \frac{Q_1}{1 + Q_0 + Q_1} \frac{1}{z - w} + \frac{Q_1 + 1}{1 + Q_0 + Q_1} \frac{1}{z},$$
(2.19)

and

$$P_2(z) := S_1(z)S_2(z) = \frac{Q_1 + 1}{1 + Q_0 + Q_1} \frac{z - f(b)}{(z - w)(z + 1/w)z}.$$
 (2.20)

Here, to evaluate the coefficients in (2.20), we have used the asymptotic behaviours (2.16) and (2.17), as well as the fact that S has a zero at f(b) by construction (2.12), (2.14), (2.11) and (1.21).

Hence we have determined the spectral curve completely, as specified by

$$P(S,z) = S^{2} + P_{1}(z)S + P_{2}(z) = 0,$$
(2.21)

where $P_1(z)$ and $P_2(z)$ are given by the RHS of (2.19) and (2.20).

Remark 2.4. P(S, z) is not symmetric in S, z. In S it has degree 2, while in z degree 3.

We now write the rational function

$$R(z) := P_1(z)^2 - 4P_2(z)$$
(2.22)

for the discriminant of the algebraic curve (2.21). Completing the square in (2.21) we have

$$\left(S - \frac{P_1(z)}{2}\right)^2 = \frac{1}{4}R(z).$$
(2.23)

By (2.23), we obtain

$$S_2(z) - \frac{P_1(z)}{2} = \frac{1}{2}\sqrt{R(z)}, \qquad S_1(z) - \frac{P_1(z)}{2} = -\frac{1}{2}\sqrt{R(z)}.$$
 (2.24)

In the above and what follows the branch cut of $\sqrt{R(z)}$ is taken to be \mathcal{B} (the same branch cut of F_1 defined in (2.6)), and we also have for this branch that as $z \to \infty$,

$$\sqrt{R(z)} = \frac{Q_0}{1 + Q_0 + Q_1} \frac{1}{z} + \mathcal{O}(z^{-2}); \tag{2.25}$$




Figure 4: The Schwarz function S_1 and S_2 on the real axis. One can observe three poles, one zero and a node at the real axis.

see (2.16), (2.17) and (2.19). In addition, it follows from (2.24) that

$$R(z) = (S_1(z) - S_2(z))^2. (2.26)$$

We can make R(z) more explicit. By using (2.16), (2.17), (2.19), (2.20) and (2.22), we have

$$R(z) = \left(\frac{Q_0}{1 + Q_0 + Q_1}\right)^2 \frac{1}{z^2} + \mathcal{O}(z^{-3}), \quad z \to \infty.$$
 (2.27)

Also, we have R(z) to be a rational function with double poles at w, -1/w, 0. Hence, it must be that

$$R(z) = \frac{P_4(z)}{(z - w)^2 (z + 1/w)^2 z^2},$$
(2.28)

where $P_4(z)$ is a quartic polynomial. We determine its zeros. As we observed that R(z) coincides with the discriminant of the spectral curve, the zeros occur when $S_1(z) = S_2(z)$. Two solutions are evidently the branch points z_1, z_2 . Further Lemma 2.3 gives us c_0 is a double zero. Thus we have

$$R(z) = \left(\frac{Q_0}{1 + Q_0 + Q_1}\right)^2 \frac{(z - z_1)(z - z_2)(z - c_0)^2}{(z - w)^2(z + 1/w)^2 z^2},\tag{2.29}$$

where z_1, z_2 are given as the critical values of the conformal map f and c_0 is a multiple zero of Disc(P(S, z), S). In regards to this, we also have from (2.24) that

$$R(z) = \left(S_2(z) - \frac{P_1(z)}{2}\right)^2 \tag{2.30}$$

and $S_2(z)$ has a pole at 0 with residue $(Q_1 + 1)/(Q_0 + Q_1 + 1)$. By comparing the leading-order coefficient of $1/z^2$ in the two expressions for R as $z \to 0$, and using (2.18), (2.19), along with the relation $z_2 = \overline{z}_1$, we obtain

$$c_0 = \frac{1 + Q_1}{Q_0} \frac{1}{|z_1|}. (2.31)$$

Next we make note of a particular property relating to c_0 which will be required in subsequent working.

Lemma 2.5. Suppose

$$S_1(z) = \frac{\overline{z}}{1 + |z|^2} \quad \text{for } z \notin \partial\Omega.$$
 (2.32)

Then $z = c_0$.

Proof. Let z = f(v). Then by (2.12) the condition (2.32) is rewritten as

$$\frac{f(1/v)}{1 + f(v)f(1/v)} = \frac{f(\overline{v})}{1 + f(v)f(\overline{v})}.$$
 (2.33)

Simplifying shows

$$f(1/v) = f(\overline{v}), \tag{2.34}$$

which means

$$\operatorname{deck}(v) = 1/\overline{v},\tag{2.35}$$

where we have used (2.2). Therefore we have

$$S_1(z) = \frac{f(1/v)}{1 + f(1/v)f(v)} = \frac{f(\overline{v})}{1 + f(v)f(\overline{v})} = \frac{f(1/\operatorname{deck}(v))}{1 + f(1/\operatorname{deck}(v))f(v)} = S_2(z), \tag{2.36}$$

which implies $z=z_1$ or z_2 or c_0 by the discussion above (2.29). Since u_1 and u_2 are fixed points of $\operatorname{deck}(u)$, it follows that if $z=z_k$ for k=1 or 2, by (2.35), $|u_k|=1$, which implies that $z\in\partial\Omega$. Hence, z must be c_0 .

Recall (1.20) for the definition of \mathcal{U}_{2D} . As a corollary, we observe that c_0 is the only critical point of \mathcal{U}_{2D} in $\mathbb{C} \setminus \Omega$.

Lemma 2.6. The inequality in (1.20) is strict. That is

$$\mathcal{U}_{2D}(z) > 0, \quad z \in \mathbb{C} \setminus \Omega.$$
 (2.37)

Proof. By (1.20) we find $\partial \mathcal{U}_{2D} = \overline{\partial} \mathcal{U}_{2D} = 0$ on Ω . Assume that there is a local minimum of \mathcal{U}_{2D} on $\mathbb{C} \setminus \Omega$. Then the Mountain Pass Theorem guarantees that there is a critical point on a path connecting Ω and the local minimum. By (2.13), one can notice that $\partial \mathcal{U}_{2D}$ is equivalent to the condition (2.32). On the other hand, by Lemma 2.5 there is at most one critical point in \mathcal{U}_{2D} , therefore there is no local minimum of \mathcal{U}_{2D} on $\mathbb{C} \setminus \Omega$.

3 The mother body

In this section Theorem 1.1 will be established.

3.1 Analysis of the trajectories of the quadratic differential

We are interested in the trajectories of the quadratic differential

$$R(z) dz^2 < 0.$$

This in essence will give us a real measure μ with density

$$d\mu(z) = \frac{1}{2\pi i} \sqrt{R(z)} \, dz,$$

supported on the critical trajectories. Here, dz represents the complex line element. We recall from (2.29) and (2.31)

$$R(z) = \left(\frac{Q_0}{1 + Q_0 + Q_1}\right)^2 \frac{(z - z_1)(z - z_2)(z - c_0)^2}{z^2(z - w)^2(z + 1/w)^2}, \qquad c_0 = \frac{1 + Q_1}{Q_0} \frac{1}{|z_1|}.$$
 (3.1)

In that regard, we have the meromorphic differential

$$(S_1(z) - S_2(z))^2 dz^2 = R(z) dz^2.$$

By general theory [34, 45, 48, 49], we have the following rules for the trajectories of the quadratic differential $R(z) dz^2 < 0$.

- (1) z_1, z_2 are simple zeros of R(z). Hence, there are three equiangular arcs emanating from z_1 and z_2 .
- (2) c_0 is a double zero of R(z). Therefore, there are four equiangular arcs emanating from c_0 .
- (3) 0, w, -1/w are double poles with positive residues. Hence, the trajectories near 0, w, -1/w are locally circular.
- (4) $R(z) \sim z^{-2}$, as a result, infinity is a double pole with positive residue. Then the trajectories near infinity are also circular, that is closed loops.
- (5) We use the weak version of Teichmüller's Lemma: a simply connected domain bounded by critical trajectories that does not contain a pole on its boundary must have a pole in its interior.
- (6) By symmetry, if γ is a trajectory, then so is $\overline{\gamma}$.

Due to item (4), the short critical trajectories are finite and do not escape to infinity. Consequently, the trajectories emanating from z_1 in the upper half-plane must terminate at either z_2 or c_0 . Moreover, at most one of these three trajectories can end at c_0 , as ensured by items (5) and (6).

In the following, we show all the critical trajectories emanating from z_1 terminate at z_2 .

3.1.1 Potential theoretic preliminaries

We begin with some definitions.

Definition 3.1. For $z \in \mathbb{C} \setminus \mathcal{B}$, define

$$\mathcal{U}(z) := \log(1+|z|^2) - \log(1+|z_0|^2) - 2\operatorname{Re}\int_{z_0}^z S_1(s) \, ds, \tag{3.2}$$

where the contour of integration is away from the branch cut \mathcal{B} and z_0 is in $\partial\Omega$.

Notice that by (1.20) and (2.13),

$$\mathcal{U}_{2D}(z) = (Q_0 + Q_1 + 1)\mathcal{U}(z), \qquad z \in \overline{\mathbb{C}\backslash\Omega}.$$

Next, we define an indefinite integral with $\sqrt{R(s)}$ as the integrand.

Definition 3.2. For $z \in \mathbb{C} \setminus \mathcal{B}$, define

$$\mathcal{U}_0(z) := \operatorname{Re} \int_{z_1}^z \sqrt{R(s)} \, ds, \tag{3.3}$$

where the contour of integration is in $\mathbb{C} \setminus \mathcal{B}$.

Recall that c_0 is defined in Lemma 2.3 and is given by the expression in (2.31).

Proposition 3.3. We have

$$\mathcal{U}_0(c_0) = \mathcal{U}(c_0) > 0.$$

Proof. The last inequality is an easy consequence of Lemma 2.6 combining with Lemma 2.3 which tells us $c_0 \in \mathbb{C} \setminus \Omega$. We prove the first equality. Let us denote $F_1(c_0) = v$. Then by (2.35) we have $\operatorname{deck}(1/v) = \overline{v}$. Then by (2.26), (2.12), (2.14) and (2.5), we have

$$2\int_{z_{1}}^{c_{0}} \sqrt{R(s)} ds = 2\int_{z_{1}}^{c_{0}} (S_{2}(s) - S_{1}(s)) ds$$

$$= 2\int_{u_{1}}^{v} \frac{f(1/\operatorname{deck}(u))}{1 + f(1/\operatorname{deck}(u))f(u)} d(f(\operatorname{deck}(u))) - 2\int_{u_{1}}^{v} \frac{f(1/u)}{1 + f(1/u)f(u)} d(f(u))$$

$$= 2\int_{u}^{\operatorname{deck}(v)} \frac{f(1/u)}{1 + f(1/u)f(u)} d(f(u)).$$
(3.4)

Let $z_0 \in \partial \Omega$ and $v_0 \in \partial \mathbb{D}$ such that $f(v_0) = z_0$. We decompose the last integral as $A_1 + B_1$, where

$$A_1 := \int_v^{v_0} \frac{f(1/u)}{1 + f(1/u)f(u)} d(f(u)), \qquad B_1 := \int_{v_0}^{\operatorname{deck}(v)} \frac{f(1/u)}{1 + f(1/u)f(u)} d(f(u)).$$

Notice that by definition (2.12), we have


$$A_1 = -\int_{z_0}^{c_0} S_1(s) \, ds. \tag{3.5}$$

On the other hand, we have

$$B_{1} = \int_{v_{0}}^{\operatorname{deck}(v)} d \log(1 + f(1/u)f(u)) + \frac{f(u)f'(1/u)}{u^{2}(1 + f(1/u)f(u))} du$$

$$= \left[\log(1 + f(1/u)f(u)) \right]_{v_{0}}^{\operatorname{deck}(v)} + \int_{1/\operatorname{deck}(v)}^{1/v_{0}} \frac{f(1/x)f'(x)}{1 + f(1/x)f(x)} dx$$

$$= \log(1 + |c_{0}|^{2}) - \log(1 + |z_{0}|^{2}) - \int_{\overline{z}_{0}}^{\overline{c}_{0}} S_{1}(x) dx.$$
(3.6)






Figure 5: Possible topological configuration of critical trajectories. Case I in left, Case II (in box) in right which satisfies the inequality in Proposition 3.3.

Combining all of the above, we obtain

$$2\mathcal{U}_{0}(c_{0}) = 2\operatorname{Re} \int_{z_{1}}^{c_{0}} \sqrt{R(s)} \, ds = 2\operatorname{Re}(A_{1} + B_{1})$$

$$= 2\log(1 + |c_{0}|^{2}) - 2\log(1 + |z_{0}|^{2}) - 2\operatorname{Re} \int_{\overline{z}_{0}}^{\overline{c}_{0}} S_{1}(x) \, dx - 2\operatorname{Re} \int_{z_{0}}^{c_{0}} S_{1}(s) \, ds$$

$$= \mathcal{U}(c_{0}) + \mathcal{U}(\overline{c}_{0}) = 2\mathcal{U}(c_{0})$$

$$(3.7)$$

This finishes the proof.

We have seen that the three equiangular trajectories emanating from z_1 must all terminate at z_2 , forming two simply connected domains, $\tilde{\Omega}_1$ and $\tilde{\Omega}_2$, each containing at least one pole. By Teichmüller's Lemma [48, Appendix], if a domain $\tilde{\Omega}_j$ contains two poles, it must also contain two zeros (counted with multiplicty, hence in this case it must contain c_0). This reduces to two cases:

- Case I: $\tilde{\Omega}_1$ contains 0, w and c_0 , while $\tilde{\Omega}_2$ contains -1/w. This corresponds left panel of Figure 5.
- Case II: $\tilde{\Omega}_1$ contains 0 and $\tilde{\Omega}_2$ contains -1/w. This corresponds to right panel of Figure 5.

We now negate Case I. Since we have $\sqrt{R(x)} > 0$ for $x > c_0$ and $\sqrt{R(x)} < 0$ for $x \in (w, c_0)$. Then $\int_x^{c_0} \sqrt{R(s)} ds < 0$ for $x \in (w, \infty)$ and $x \neq c_0$. Suppose Case I is taking place; then we have a trajectory (part of the boundary of Ω_1) emanating from z_1 intersecting the real line at x_0 with $x_0 > c_0$. Then one observes

$$\operatorname{Re} \int_{z_1}^{c_0} \sqrt{R(s)} \, ds = \operatorname{Re} \int_{z_1}^{x_0} \sqrt{R(s)} \, ds + \operatorname{Re} \int_{x_0}^{c_0} \sqrt{R(s)} \, ds < 0.$$
 (3.8)

This contradicts Proposition 3.3.

As a corollary, we obtain the following.

Corollary 3.4.

(1) All the three equiangular arcs emanating from z_1 terminates at z_2 . These form two simply connected domains, $\tilde{\Omega}_1$ (containing 0) and $\tilde{\Omega}_2$ (containing -1/w).




Figure 6: Global structure of trajectories of the quadratic differential $(S_1(z) - S_2(z)^2 dz^2)$: mother body in red, droplet in purple, poles in green, node in blue dots.

(2) From c_0 , emanates four equiangular arcs, forming two loops, one enclosing w and one enclosing all the poles -1/w, 0, w.

This finishes the discussion on the trajectories of the quadratic differential and confirms the numerical simulation in Figure 6.

Lemma 3.5. The steepest ascent path Γ_1 of \mathcal{U}_0 from z_1 terminates at c_0 and similarly the steepest ascent path Γ_2 of \mathcal{U}_0 from z_2 terminates at c_0 . Moreover, we have $\mathcal{U}_0(z) > 0$ for $z \in \Gamma_j$, where j = 1, 2.




Figure 7: The contour $\Gamma = \Gamma_0 \cup \Gamma_1 \cup \Gamma_2$. The steepest ascent path Γ_1 and Γ_2 in dashed purple. Γ_0 in dashed blue.

Proof. The proof follows in the same line as that of [4, Lemma 3.3, Appendix C]. That is, if $v = F_1(z)$ satisfies $\operatorname{deck}(v) = 1/\overline{v}$, then LHS of (3.4) is purely real. Since c_0 is such a point, we have $\int_{z_1}^{c_0} \sqrt{R(s)} ds = \mathcal{U}(c_0) > 0$. Thus, c_0 lies on the steepest ascent path from z_1 . By symmetry we can conclude the same about Γ_2 . See also Figure 7 for numerical confirmation.

3.2 Proof of Theorem 1.1

Definition 3.6. Define Γ_0 as the unique trajectory of the quadratic differential $R(z) dz^2 < 0$ emanating from z_1 and terminating at z_2 which intersects the real line between -1/w, 0 which is guaranteed by Corollary 3.4. Further, define

$$d\mu(s) := \frac{1}{2\pi i} \sqrt{R(s)} \, ds, \quad s \in \Gamma_0. \tag{3.9}$$

We are now ready to prove Theorem 1.1.

Proof of Theorem 1.1. According to Definition 3.6, μ is a real measure supported on Γ_0 , with a density that vanishes as a square root at z_1 and z_2 , while remaining strictly positive in the interior.

Now choosing the branch cut \mathcal{B} to be exactly on Γ_0 we obtain

$$\frac{1}{2\pi i} \left(S_{1,-}(z) - S_{1,+}(z) \right) dz = d\mu(z), \quad z \in \Gamma_0. \tag{3.10}$$

Then we obtain by the residue theorem,

$$\int \frac{d\mu(s)}{z-s} = \frac{1}{2\pi i} \int_{\Gamma_0} \frac{S_{1,-}(s) - S_{1,+}(s)}{z-s} \, ds = S_1(z) - \frac{Q_1}{1 + Q_0 + Q_1} \frac{1}{z-w}. \tag{3.11}$$

A similar calculation shows

$$S_1(z) = \int \frac{d\mu(s)}{z - s} + \frac{Q_1}{1 + Q_0 + Q_1} \frac{1}{z - w},$$

$$S_2(z) = -\int \frac{d\mu(s)}{z - s} + \frac{1 + Q_1}{1 + Q_0 + Q_1} \frac{1}{z} + \frac{1 + Q_0}{1 + Q_0 + Q_1} \frac{1}{z + 1/w}.$$
(3.12)

By comparing the behaviour at ∞ in the LHS and RHS of (3.12) using (2.16) and (2.17), we obtain

$$\mu(\mathbb{C}) = \frac{1}{1 + Q_0 + Q_1}. (3.13)$$

In what follows we will denote,

$$C^{\mu}(z) = \int \frac{d\mu(s)}{z - s}, \qquad z \in \mathbb{C} \setminus \text{supp}(\mu).$$
 (3.14)

Putting (3.12) and (2.19) in (2.23), we obtain

$$\left(C^{\mu}(z) + \frac{1}{2} \left(\frac{Q_1}{1 + Q_0 + Q_1} \frac{1}{z - w} - \frac{1 + Q_0}{1 + Q_0 + Q_1} \frac{1}{z + 1/w} - \frac{Q_1 + 1}{1 + Q_0 + Q_1} \frac{1}{z} \right) \right)^2 = \frac{1}{4} R(z).$$
(3.15)

Also, it is convenient to define the scaling of μ and R. Thus for μ defined in (3.6) we introduce the scaled form

$$\mu_0 = (1 + Q_0 + Q_1)\mu. \tag{3.16}$$

Then due to (3.13) we have μ_0 to be a probability measure supported on Γ_0 . That is

$$\mu_0(\mathbb{C}) = 1. \tag{3.17}$$

In relation to R we define the scaled form

$$R_0(z) = (1 + Q_0 + Q_1)^2 R(z), (3.18)$$

and we introduce too

$$\tilde{\mathcal{U}}(z) = (1 + Q_0 + Q_1)\mathcal{U}(z), \qquad \tilde{\mathcal{U}}_0(z) = (1 + Q_0 + Q_1)\mathcal{U}_0(z).$$
 (3.19)

This then establishes item (1) in Theorem 1.1, where we have also used (2.25).

Next, we verify item (2). For this, recall from definition (1.26),

$$\mathcal{V}(z) = (1 + Q_1)\log z + (1 + Q_0)\log\left(z + \frac{1}{w}\right) - Q_1\log(z - w),\tag{3.20}$$

where the branch of the logarithm is chosen on $(-\infty, -1/w] \cup [0, w]$. Then (3.15) can be rewritten as

$$\left(C^{\mu_0}(z) - \frac{1}{2}\mathcal{V}'(z)\right)^2 = \frac{1}{4}R_0(z). \tag{3.21}$$

Recall Γ_1 and Γ_2 from Lemma 3.5. Now we are ready to define the contour

$$\Gamma = \Gamma_0 \cup \Gamma_1 \cup \Gamma_2, \tag{3.22}$$

which is a closed contour enclosing 0 and has -1/w on the exterior. From (3.21) and Lemma 3.5 integrating in z and taking the real part, we obtain that there exists a real constant ℓ_0 such that

$$2U^{\mu_0}(z) + \operatorname{Re} \mathcal{V}(z) + \ell_0 \begin{cases} = 0 & z \in \Gamma_0, \\ > 0 & z \in \Gamma \setminus \Gamma_0. \end{cases}$$
(3.23)

This establishes item (2) of Theorem 1.1.

For item (3), we first note that $\mathcal{B} = \Gamma_0 \subset \Omega$. We do not provide a proof of this, as it is identical to that of [4, Lemma 2.8]. As a consequence, by comparing (3.12) and (2.12), we obtain (1.27). This establishes item (3) of Theorem 1.1.

Remark 3.7. It also follows from (3.21) and (1.25) that the contour Γ_0 is a *S curve* (See [43, Lemma 5.4]. That is we have,

$$\frac{\partial}{\partial n_{+}} \left(2U^{\mu_{0}}(z) + \operatorname{Re} \mathcal{V}(z) \right) = \frac{\partial}{\partial n_{-}} \left(2U^{\mu_{0}}(z) + \operatorname{Re} \mathcal{V}(z) \right), \quad z \in \Gamma_{0}, \tag{3.24}$$

where n_{\pm} are the unit normal vectors to Γ_0 at z. This S property has appeared in several works such as [37, 44, 46].

4 Contour Orthogonality

Crucial to our subsequent Riemann-Hilbert analysis is that the planar orthogonality relation with respect to the weight $e^{-NV(z)}$, with V(z) given by (1.12), is proportional to a non-Hermitian contour orthogonality with weight function (1.30).

Lemma 4.1. Let $N, NQ_1, NQ_0 \in \mathbb{N}$. Further, let $j, k \leq N$. We have

$$\int_{\mathbb{C}} z^{j} \overline{(z-w)^{k}} |z-w|^{2NQ_{1}} \left(\frac{1}{1+|z|^{2}}\right)^{N(1+Q_{0}+Q_{1})+1} dA(z)
= G_{k,N} \oint_{\Gamma} z^{j} (z-w)^{NQ_{1}} \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} dz,$$
(4.1)

where Γ is a simple closed contour with positive orientation and has 0 on the interior and -1/w on the exterior and

$$G_{k,N} := \frac{\Gamma(N + NQ_0 - k)\Gamma(1 + k + NQ_1)}{2i\Gamma(N(1 + Q_0 + Q_1) + 1)}.$$
(4.2)

Remark 4.2. Before the proof, let us consider the special case w = 0 of the formula (4.1). For w = 0, the LHS of (4.1) can be evaluated using polar coordinates and Euler's beta integral as

$$\int_{\mathbb{C}} \frac{z^{j} \overline{z}^{k} |z|^{2NQ_{1}}}{(1+|z|^{2})^{N(1+Q_{0}+Q_{1})+1}} \, dA(z) = 2\pi \int_{0}^{\infty} \frac{r^{2k+2NQ_{1}+1}}{(1+r^{2})^{N(1+Q_{0}+Q_{1})+1}} \, dr \, \delta_{j,k} = 2\pi i \, G_{k,N} \, \delta_{j,k}.$$

On the other hand, the integral in the RHS of (4.1) is evaluated as

$$\oint_{\Gamma} z^{j-k-1} dz = 2\pi i \, \delta_{j,k}.$$

Thus one can directly observe that (4.1) holds for w = 0.

Proof of Lemma 4.1. Consider the integral

$$\int_{\mathbb{C}} z^{j} \overline{(z-w)^{k}} |z-w|^{2NQ_{1}} \left(\frac{1}{1+|z|^{2}}\right)^{N(1+Q_{0}+Q_{1})+1} dA(z). \tag{4.3}$$

Following [4], we denote

$$\chi(z) := (z - w)^{NQ_1} \int_w^{\overline{z}} (s - w)^{NQ_1 + k} \left(\frac{1}{1 + zs}\right)^{N(Q_1 + Q_0 + 1) + 1} ds. \tag{4.4}$$

Then we have

$$\overline{\partial}_z \chi(z) = \overline{(z-w)^k} |z-w|^{2NQ_1} \left(\frac{1}{1+|z|^2}\right)^{N(1+Q_0+Q_1)+1}.$$
(4.5)

Clearly $\chi(z)$ is smooth in $\mathbb{C} \setminus \{-1/w\}$ due to the assumption that $N, NQ_1, NQ_0 \in \mathbb{N}$. Also, the integrand in (4.4) has a pole at -1/z, however, it is easy to see, that the residue is 0, hence (4.4) does not depend on the choice of contour.

Let $\varepsilon > 0$ be sufficiently small. For $z \notin (\mathbb{D}(-1/w, \varepsilon) \cup \{0\})$ we divide the integral in (4.4) in two parts

$$\int_{w}^{\overline{z}} (s-w)^{NQ_1+k} \left(\frac{1}{1+zs}\right)^{N(Q_1+Q_0+1)+1} ds = \mathcal{A}_1(z) + \mathcal{B}_1(z), \tag{4.6}$$

where

$$\mathcal{A}_1(z) := \int_w^{\overline{z} \times \infty} (s - w)^{NQ_1 + k} \left(\frac{1}{1 + zs}\right)^{N(Q_1 + Q_0 + 1) + 1} ds,$$

and

$$\mathcal{B}_{1}(z) := -\int_{\overline{z}}^{\overline{z} \times \infty} (s - w)^{NQ_{1} + k} \left(\frac{1}{1 + zs}\right)^{N(Q_{1} + Q_{0} + 1) + 1} ds$$
$$= -\overline{z} \int_{1}^{\infty} (t\overline{z} - w)^{NQ_{1} + k} \left(\frac{1}{1 + |z|^{2}t}\right)^{N(Q_{1} + Q_{0} + 1) + 1} dt.$$

Thus $\mathcal{B}_1(z)$ is continuous away from 0, in particular in a neighborhood of -1/w. For k < N and for |z| > R we have for R sufficiently large

$$|\mathcal{B}_1(z)| = \mathcal{O}\left(\frac{1}{(1+|z|)^{2NQ_0+NQ_1+N}}\right).$$
 (4.7)

Due to continuity of $\mathcal{B}_1(z)$, for $z \in \mathbb{D}(-1/w, 2\varepsilon)$, where $\varepsilon > 0$ is sufficiently small, there is a constant $C_1 > 0$ independent of ε , such that

$$|\mathcal{B}_1(z)| \le C_1. \tag{4.8}$$

For the quantity A_1 , we have a remarkable exact evaluation in terms of gamma functions. For this, note that

$$\begin{split} \mathcal{A}_1(z) &= \int_0^{\overline{z}\times\infty} t^{NQ_1+k} \Big(\frac{1}{1+wz+zt}\Big)^{N(Q_1+Q_0+1)+1} dt \\ &= \Big(\frac{1}{1+wz}\Big)^{N(Q_1+Q_0+1)+1} \int_0^{\overline{z}\times\infty} t^{NQ_1+k} \Big(1+\frac{z}{1+wz}t\Big)^{-N(Q_1+Q_0+1)-1} dt \\ &= \Big(\frac{1}{1+wz}\Big)^{N(Q_1+Q_0+1)+1} \overline{z}^{NQ_1+k+1} \int_0^\infty x^{NQ_1+k} \Big(1+\frac{|z|^2}{1+wz}x\Big)^{-N(Q_1+Q_0+1)-1} dx. \end{split}$$

According to [30, 3.194, (3)], we have

$$\int_0^\infty \frac{x^{a-1}}{(1+bx)^{\nu}} dx = b^{-a} B(a, \nu - a), \qquad |\arg b| < \pi, \quad \text{Re } \nu > \text{Re } a > 0, \tag{4.9}$$

where

$$B(z_1, z_2) = \frac{\Gamma(z_1)\Gamma(z_2)}{\Gamma(z_1 + z_2)}$$

is the Beta function. Applying this to the above integral, with

$$a = NQ_1 + k + 1$$
, $\nu = N(Q_1 + Q_0 + 1) + 1$, $b = |z|^2/(1 + wz)$,

it follows that

$$\mathcal{A}_{1}(z) = \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} B(NQ_{1}+k+1,NQ_{0}+N-k)$$

$$= \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} \frac{\Gamma(N+NQ_{0}-k)\Gamma(1+k+NQ_{1})}{\Gamma(N(Q_{1}+Q_{0}+1)+1)}.$$
(4.10)




Figure 8: The last contour in the countour integral of (4.11)

To make use of the above results, we proceed by Stokes theorem. Denote $\Gamma_{\varepsilon,r}$ to be the tubular neighborhood of height ε of around the interval $[-r, -1/w - \varepsilon]$; see Figure 8.

Note that by (4.5), the LHS of (4.1) can be written as

$$\lim_{r \to \infty} \int_{|z| < r} z^{j} \overline{\partial} \chi(z) dA(z) - \lim_{\varepsilon \to 0} \int_{\mathbb{D}(-1/w,\varepsilon)} z^{j} \overline{\partial} \chi(z) dA(z) - \lim_{\varepsilon \to 0} \int_{\Gamma_{\varepsilon,r}} z^{j} \overline{\partial} \chi(z) dA(z)$$

$$= \lim_{r \to \infty} \frac{1}{2i} \oint_{|z| = r} z^{j} \chi(z) dz - \lim_{\varepsilon \to 0} \frac{1}{2i} \oint_{\partial \mathbb{D}(-1/w,\varepsilon)} z^{j} \chi(z) dz - \lim_{\varepsilon \to 0} \frac{1}{2i} \oint_{\partial \Gamma_{\varepsilon,r}} z^{j} \chi(z) dz.$$

Recall from (4.4) and (4.6) that

$$\chi(z) = (z - w)^{NQ_1} \Big(\mathcal{A}_1(z) + \mathcal{B}_1(z) \Big).$$

Moreover, using (4.7) and (4.8), along with the fact that $\mathcal{B}_1(z)$ is continuous away from 0, it follows that

$$\lim_{r \to \infty} \oint_{|z|=r} z^{j} (z - w)^{NQ_{1}} \mathcal{B}_{1}(z) dz = 0,$$

$$\lim_{\varepsilon \to 0} \oint_{\partial \mathbb{D}(-1/w,\varepsilon)} z^{j} (z - w)^{NQ_{1}} \mathcal{B}_{1}(z) dz = 0,$$

$$\lim_{\varepsilon \to 0} \oint_{\partial \Gamma_{\varepsilon,r}} z^{j} (z - w)^{NQ_{1}} \mathcal{B}_{1}(z) dz = 0.$$

Combining all of the above with (4.10), the LHS of (4.1) is given by

$$G_{k,N} \lim_{r \to \infty} \oint_{|z|=r} z^{j} (z-w)^{NQ_{1}} \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} dz$$

$$-G_{k,N} \lim_{\varepsilon \to 0} \oint_{\partial \mathbb{D}(-1/w,\varepsilon)} z^{j} (z-w)^{NQ_{1}} \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} dz \qquad (4.11)$$

$$-G_{k,N} \lim_{\varepsilon \to 0} \oint_{\partial \Gamma_{\varepsilon,r}} z^{j} (z-w)^{NQ_{1}} \left(\frac{1}{1+wz}\right)^{N+NQ_{0}-k} \left(\frac{1}{z}\right)^{k+1+NQ_{1}} dz,$$

where $G_{k,N}$ is given by (4.2).

The contour integral in (4.11) does not depend on r and ε and the contour in

$$\oint_{|z|=r} - \oint_{\partial \Gamma_{\varepsilon,r}} - \oint_{\partial \mathbb{D}(-1/w,\varepsilon)}$$

is homotopic to a contour Γ which has 0 on the interior and -1/w, ∞ on the exterior (See Figure 8). Since the integrand is meromorphic we can deform the last contour in (4.11) to Γ . This finishes the proof.

4.1 Proof of Proposition 1.3

With Lemma 4.1 we are now ready to show that the planar orthogonal polynomials also satisfy non-Hermitian contour orthogonality.

Proof of Proposition 1.3. If (1.28) holds true then from Lemma 4.1 we have for $\varepsilon < 1/w$,

$$\oint_{|z|=\varepsilon} P_{n,N}(z)(z-w)^{NQ_1} \left(\frac{1}{1+wz}\right)^{N+NQ_0-k} \left(\frac{1}{z}\right)^{k+1+NQ_1} dz = 0, \tag{4.12}$$

for $k = 0, \dots n - 1$. Denote

$$Q_{n,N}(z) := z^n P_{n,N}(1/z). \tag{4.13}$$

Then changing variable $z \mapsto 1/z$ in (4.12) yields

$$\oint_{|z|=\varepsilon^{-1}} Q_{n,N}(z)(z+w)^k \frac{z^{N+NQ_0-n-1}(1-zw)^{NQ_1}}{(z+w)^{N+NQ_0}} dz = 0,$$
(4.14)

for k = 0, ..., n - 1. Since $\{(z + w)^k\}_{k=0}^{n-1}$ also forms a basis for the space of holomorphic polynomials of degree at most n - 1, we have

$$\oint_{|z|=\varepsilon^{-1}} Q_{n,N}(z)z^{k+1} \frac{z^{N+NQ_0-n-2}(1-zw)^{NQ_1}}{(z+w)^{N+NQ_0}} dz = 0,$$
(4.15)

for k = 0, ..., n - 1

Rewriting (4.13) as $P_{n,N}(z) = Q_{n,N}(1/z)z^n$, we see by changing variables $z \mapsto \frac{1}{z}$ again in (4.15) and relabeling k+1=n-j that

$$\oint_{|z|=\varepsilon} P_{n,N}(z)z^{j}(z-w)^{NQ_{1}} \left(\frac{1}{1+wz}\right)^{N+NQ_{0}} \left(\frac{1}{z}\right)^{n+NQ_{1}} dz = 0, \tag{4.16}$$

for $j = 0 \dots n-1$. By Cauchy's theorem, the contour of integration (4.16) can be deformed to a contour Γ , as long as 0 lies in the interior and -1/w lies in the exterior of Γ . Hence $P_{n,N}$ is a family of orthogonal polynomials on the contour Γ with respect to the weight (1.30).

Remark 4.3. We outline an alternative proof of Proposition 1.3, provided to us by Arno Kuijlaars (personal communication). Although the following proof is more elegant, we retain the previous proof since a similar argument will be used in the proof of Theorem 1.8. The statement (4.12) is equivalent to

$$\oint_{|z|=\varepsilon} P_{n,N}(z)(z-w)^{NQ_1} \left(\frac{1}{1+wz}\right)^{N+NQ_0} \left(\frac{1}{z}\right)^{n+NQ_1} (1+wz)^k z^{n-k-1} dz = 0, \quad (4.17)$$

for $k=0,\ldots,n-1$. As k ranges from 0 to n-1, we obtain a family of polynomials $\{p_k\}_{k=0}^{n-1}$ of degree n-1, where $p_k(z)=(1+wz)^kz^{n-k-1}$. If $w\neq 0$, this family is linearly independent. Consequently, $\{p_k\}_{k=0}^{n-1}$ forms a basis for the vector space of polynomials of degree less than n. Thus we can write the monomials z^j with $0\leq j\leq n-1$ as a linear combination of p_k . This in turn implies (4.16).

5 Riemann-Hilbert analysis

By Proposition 1.3 the planar orthogonal polynomials $P_{n,N}$ satisfy non-Hermitian contour orthogonality, and consequently by the renowned work of [26] $P_{n,N}$ is a solution to the Riemann-Hilbert (RH) problem described below.

The RH problem is for the orthogonality contour Γ (now fixed as given in Theorem 1.1). Namely, $\Gamma = \Gamma_0 \cup \Gamma_1 \cup \Gamma_2$, where Γ_0 is defined in Definition 3.6, and Γ_1 and Γ_2 are defined in Lemma 3.5.

RH problem 5.1. Y is the solution of the following RH problem.

- $Y: \mathbb{C} \setminus \Gamma \to \mathbb{C}^{2\times 2}$ where Γ is a contour that encloses 0 and has -1/w on the exterior, with counterclockwise orientation.
- On Γ we have

$$Y_{+}(z) = Y_{-}(z) \begin{pmatrix} 1 & w_{n,N}(z) \\ 0 & 1 \end{pmatrix},$$

where Y_{\pm} is the boundary values of Y on Γ . Here, $w_{n,N}$ is given by (1.30).

• As $z \to \infty$ we have

$$Y(z) = \left(I_2 + \mathcal{O}(z^{-1})\right) \begin{pmatrix} z^n & 0\\ 0 & z^{-n} \end{pmatrix}. \tag{5.1}$$

Then we have $P_{n,N}(z) = Y_{1,1}(z)$.

5.1 Some preliminaries

At this point, one should observe from (1.26) and (1.30) that

$$w_{n,N}(z) = \frac{1}{z^{r_0}} e^{-N\mathcal{V}(z)},$$
 (5.2)

where we also recall from the statement of Theorem 1.5 that $r_0 = n - N$.

Definition 5.2. We define

$$\varphi(z) := \int_{z_1}^z \sqrt{R_0(s)} \, ds,\tag{5.3}$$

where the contour of integration lies in $\mathbb{C} \setminus (\Gamma_0 \cup \Gamma_1 \cup [c_0, \infty))$. Then we also have from (3.3), (3.18) and (3.19) that $\tilde{\mathcal{U}}_0(z) = \text{Re } \varphi(z)$.

Definition 5.3. We define the g function as

$$g(z) := \int \log(z - s) d\mu_0(s),$$
 (5.4)

where the branch cut of the logarithm is taken in $\Gamma_0 \cup \Gamma_1 \cup [c_0, \infty)$.

Notice that from (5.4) and (3.17), we have

$$g(z) = \log z + \mathcal{O}(z^{-1}) \quad z \to \infty.$$
 (5.5)

On the other hand, by (1.18) and (3.14), we have

$$\operatorname{Re} g(z) = -U^{\mu_0}(z), \qquad g'(z) = C^{\mu_0}(z).$$

Then it follows from (3.21) that

$$2g'(z) = \mathcal{V}'(z) - \sqrt{R_0(z)}.$$

Here, the sign of $\sqrt{R_0(z)}$ can be identified by the $z \to \infty$ behaviour of both sides; cf. (1.24). Then by (1.25), we obtain

$$2g(z) = \mathcal{V}(z) - \varphi(z) + \ell_0 \tag{5.6}$$

Recall that U_0 is defined by (3.3). Then from item (2) of Theorem 1.1

$$w_{n,N}(z)e^{N(g_{+}(z)+g_{-}(z)-\ell_{0})} = z^{-r_{0}}e^{-N/2(\varphi_{+}(z)+\varphi_{-}(z))} = \begin{cases} z^{-r_{0}}, & z \in \Gamma_{0}, \\ z^{-r_{0}}e^{-N\mathcal{U}_{0}(z)}, & z \in \Gamma \setminus \Gamma_{0}. \end{cases}$$
(5.7)

5.2 Transformation with the g function

Our first transformation is the transformation with the g function defined in (5.4). This normalizes the behaviour at infinity due to (5.5) and makes the (1,2) entry of the jump on the contour Γ_0 to be z^{-r_0} due to (5.7) while exponentially small on the rest of Γ .

Definition 5.4. We define

$$X(z) := e^{-\frac{N}{2}\ell_0 \sigma_3} Y(z) e^{-N\left(g(z) - \frac{\ell_0}{2}\right) \sigma_3}.$$
 (5.8)

Here $\sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$, the third Pauli matrix. Then it follows from the RH problem 5.1, (5.7), and (5.5) that we have the following RH problem for X.

RH problem 5.5. X is the solution to the following RH problem.

- $X : \mathbb{C} \setminus \Gamma \to \mathbb{C}^{2 \times 2}$ is analytic.
- $X_+ = X_- J_X$ on Γ with

$$J_X := \begin{cases} \begin{pmatrix} e^{-N(g_{-}(z) - g_{+}(z))} & z^{-r_0} \\ 0 & e^{N(g_{-}(z) - g_{+}(z))} \end{pmatrix}, & \text{on } \Gamma_0, \\ \begin{pmatrix} 1 & z^{-r_0} e^{-N\mathcal{U}_0(z)} \\ 0 & 1 \end{pmatrix}, & \text{on } \Gamma \setminus \Gamma_0. \end{cases}$$
(5.9)

• As $z \to \infty$ we have

$$X(z) = (I_2 + \mathcal{O}(z^{-1})) \begin{pmatrix} z^{r_0} & 0 \\ 0 & z^{-r_0} \end{pmatrix}.$$
 (5.10)

5.3 Opening the lenses

The RH Problem 5.5 has oscillatory diagonal entries on the cut Γ_0 . We open two lenses L_+, L_- on either side of Γ_0 . The condition on the lens is that we must have Re $\varphi(z) < 0$ in the interior and the boundary of the lenses. This can be done in a neighborhood of Γ_0 , as the measure μ_0 has a strictly positive density on the interior.

Definition 5.6. We define

$$T(z) := X(z) \begin{cases} I_2, & z \in \mathbb{C} \setminus L_{\pm}, \\ \begin{pmatrix} 1 & 0 \\ \mp z^{r_0} e^{N\varphi(z)} & 1 \end{pmatrix}, & z \in L_{\pm}. \end{cases}$$
 (5.11)

RH problem 5.7. T satisfies the following RH problem.

- $T: \mathbb{C} \setminus \Sigma_T \to \mathbb{C}^{2 \times 2}$ is analytic where $\Sigma_T = \Gamma \cup \partial L_{\pm}$.
- $T_+ = T_- J_T$ on Σ_T with

$$J_T := \begin{cases} \begin{pmatrix} 0 & z^{-r_0} \\ -z^{r_0} & 0 \end{pmatrix}, & \text{on } \Gamma_0, \\ \begin{pmatrix} 1 & z^{-r_0} e^{-N\mathcal{U}_0(z)} \\ 0 & 1 \end{pmatrix}, & \text{on } \Gamma \setminus \Gamma_0, \\ \begin{pmatrix} 1 & 0 \\ z^{r_0} e^{N\varphi(z)} & 1 \end{pmatrix}, & \text{on } \partial L_{\pm}. \end{cases}$$
 (5.12)

• As $z \to \infty$, we have

$$T(z) = (I_2 + \mathcal{O}(z^{-1})) \begin{pmatrix} z^{r_0} & 0 \\ 0 & z^{-r_0} \end{pmatrix}.$$
 (5.13)

Since r_0 is fixed, observe that away from z_1 and z_2 , the jumps on $\Gamma \setminus \Gamma_0$ and ∂L_{\pm} converges to the identity matrix exponentially fast as $N \to \infty$. On the other hand, on Γ_0 it has simple jumps. This motivates the construction of the global matrix, which approximates T(z) away from the branch points.

5.4 Global parametrix

RH problem 5.8. We seek a matrix M that satisfies the following conditions.

- $M: \mathbb{C} \setminus \Gamma \to \mathbb{C}^{2 \times 2}$ is analytic.
- On Γ_0 we have $M_+(z) = M_-(z)J_M$, with

$$J_M := \begin{pmatrix} 0 & z^{-r_0} \\ -z^{r_0} & 0 \end{pmatrix}. {5.14}$$

• As $z \to x^*$, with $x^* \in \{z_1, z_2\}$, we have

$$M(z) = \mathcal{O}((z - x^*)^{1/4}).$$

• As $z \to \infty$ we have

$$M(z) = (I_2 + \mathcal{O}(z^{-1})) \begin{pmatrix} z^{r_0} & 0\\ 0 & z^{-r_0} \end{pmatrix}.$$
 (5.15)

Lemma 5.9. Define

$$D(z) := \sqrt{\frac{\rho}{a}} \frac{1}{F_1(z)},\tag{5.16}$$

where F_1 , one of the inverses of the map f, is given by (2.6). Then it satisfies the following.

- (1) D(z) is analytic and nonzero in $\mathbb{C} \setminus \Gamma_0$;
- (2) $D_{+}(z)D_{-}(z) = z \text{ if } z \in \Gamma_{0};$

(3)
$$D(z) = D_{\infty}z + \mathcal{O}(1)$$
 as $z \to \infty$, where $D_{\infty} := \frac{1}{\sqrt{\rho a}}$.

Proof. Item (1) is immediate from definition (5.16). Item (3) follows from (2.4). We prove item (2). By direct computation using (1.21) and (2.3), we have

$$f(u) = \frac{\rho}{a} \frac{1}{\operatorname{deck}(u)u} \tag{5.17}$$

Notice that by (2.5), we have

$$F_1(z_{\pm}) = F_2(z_{\mp}) = \operatorname{deck}(F_1(z_{\mp})), \quad z \in \Gamma_0.$$

Thus we obtain

$$D_{+}(z)D_{-}(z) = \frac{\rho}{a} \frac{1}{F_{1}(z)} \frac{1}{\operatorname{deck}(F_{1}(z))} = z, \quad z \in \Gamma_{0}.$$
 (5.18)

Next, we consider

$$M(z) = D_{\infty}^{-r_0 \sigma_3} N(z) D(z)^{r_0 \sigma_3}, \tag{5.19}$$

and the Riemann-Hilbert problem associated with N(z).

RH problem 5.10. Following RH problem 5.8 and (5.19), we seek a matrix N that satisfies the following conditions.

- $N: \mathbb{C} \setminus \Gamma \to \mathbb{C}^{2 \times 2}$ is analytic.
- On Γ_0 we have $N_+(z) = N_-(z)J_N$, with

$$J_N := \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}. \tag{5.20}$$

• As $z \to x^*$, with $x^* \in \{z_1, z_2\}$, we have

$$N(z) = \mathcal{O}((z - x^*)^{1/4}).$$

• As $z \to \infty$ we have

$$N(z) = (I_2 + \mathcal{O}(z^{-1})). \tag{5.21}$$

We construct the solution of RH Problem 5.10 by means of the conformal map F_1 defined in (2.6). Denote

$$\tilde{\Gamma}_{\pm} := F_1(\Gamma_{0\pm}) = F_2(\Gamma_{0\mp}).$$

We are looking for a solution of the form

$$N(z) = \begin{pmatrix} N_1(F_1(z)) & N_1(F_2(z)) \\ N_2(F_1(z)) & N_1(F_2(z)) \end{pmatrix},$$
(5.22)

where N_1 and N_2 are two scalar-valued functions on $\mathbb{C} \setminus \tilde{\Gamma}_{\pm}$.

In order to satisfy the jump condition (5.20) we must have

$$N_{k_{+}}(u) = \begin{cases} -N_{k_{-}}(u), & u \in \tilde{\Gamma}_{+}, \\ N_{k_{-}}(u), & u \in \tilde{\Gamma}_{-}. \end{cases}$$
 (5.23)

Hence N_k is analytic across $\tilde{\Gamma}_-$. We recall from (2.4) that as $z \to \infty$

$$F_1(z) = \frac{\rho}{z} + \mathcal{O}(z^{-2}), \qquad F_2(z) = \frac{1}{a} + \mathcal{O}(z^{-1}),$$
 (5.24)

and a direct computation shows in (1.21)

$$\frac{1}{\sqrt{f'(z)}} = (z - 1/a)\frac{i}{\sqrt{a(b-a)\rho}} + \mathcal{O}((z - 1/a)^2), \quad z \to 1/a,$$
 (5.25)

$$\frac{1}{\sqrt{f'(z)}} = iz\frac{1}{\sqrt{\rho}} + \mathcal{O}(z), \quad z \to 0.$$
 (5.26)

With this in mind, we set

$$N_1(u) := a_1 \frac{1}{\sqrt{f'(u)}} \frac{1}{u}, \qquad N_2(u) := a_2 \frac{1}{\sqrt{f'(u)}} \frac{1}{u - 1/a},$$
 (5.27)

where

$$a_1 = i\sqrt{\rho}, \qquad a_2 = -i\sqrt{\frac{a}{b-a}\frac{1}{\rho}},$$
 (5.28)

and the branch of the square root of $\sqrt{f'(u)}$ is taken on $\tilde{\Gamma}_+$. Since $f(F_i(z)) = z$ (j = 1, 2) we have the chain rule

$$\frac{1}{\sqrt{f'(F_i(z))}} = \sqrt{F'_j(z)}.$$

Then by (5.22) and (5.27), we have

$$N(z) = \begin{pmatrix} a_1 \frac{\sqrt{F_1'(z)}}{F_1(z)} & a_1 \frac{\sqrt{F_2'(z)}}{F_2(z)} \\ a_2 \frac{\sqrt{F_1'(z)}}{F_1(z) - 1/a} & a_2 \frac{\sqrt{F_2'(z)}}{F_2(z) - 1/a} \end{pmatrix}.$$
 (5.29)

As a consequence, by (5.19), we obtain

$$M(z) = D_{\infty}^{-r_0\sigma_3} \begin{pmatrix} a_1 \frac{\sqrt{F_1'(z)}}{F_1(z)} & a_1 \frac{\sqrt{F_2'(z)}}{F_2(z)} \\ a_2 \frac{\sqrt{F_1'(z)}}{F_1(z) - 1/a} & a_2 \frac{\sqrt{F_2'(z)}}{F_2(z) - 1/a} \end{pmatrix} D(z)^{r_0\sigma_3}.$$
 (5.30)

5.5 Local parametrices

Local parametrices are defined in a neighbourhood of the branch points z_j and are constructed in the discs $\mathbb{D}(z_j, \delta)$ for $j \in \{1, 2\}$. We take

$$D = \mathbb{D}(z_1, \delta) \cup \mathbb{D}(z_2, \delta). \tag{5.31}$$

For $\delta > 0$ small, the local parametrices are defined in D, with jump matrices that agree with J_T given in (5.12). In addition, it agrees with M on the boundary of the discs up to an error $\mathcal{O}(n^{-1})$ as $n \to \infty$. Specifically, we introduce P(z) according to the following RH problem.




Figure 9: The jump contour Σ_S

RH problem 5.11. *P* satisfies the following RH problem.

- P(z) analytic in $D \setminus \Sigma_P$ where $\Sigma_P := \Sigma_T \cap D$. (Recall Σ_T in RH problem 5.7.)
- $P_+ = P_- J_P$ on Σ_P with

$$J_{P} := \begin{cases} \begin{pmatrix} 0 & z^{-r_0} \\ -z^{r_0} & 0 \end{pmatrix}, & \text{on } \Gamma_0 \cap D, \\ \begin{pmatrix} 1 & z^{-r_0} e^{-N\mathcal{U}_0(z)} \\ 0 & 1 \end{pmatrix}, & \text{on } \Gamma \setminus \Gamma_0 \cap D, \\ \begin{pmatrix} 1 & 0 \\ z^{r_0} e^{N\varphi(z)} & 1 \end{pmatrix}, & \text{on } \partial L_{\pm} \cap D. \end{cases}$$
 (5.32)

• P(z) matches with the outer parametrix M that is

$$P(z) = M(z) \left(1 + \mathcal{O}(n^{-1}) \right) \quad n \to \infty, \tag{5.33}$$

uniformly as $z \in \partial D$.

The functions $\varphi(z) = \text{const} \times (z - z_j)^{3/2} \left(1 + \mathcal{O}(z - z_j)^{1/2}\right)$ and the local parametrices of $z^{(r_0/2)\sigma_3}P(z)z^{(-r_0/2)\sigma_3}$ can be constructed out of Airy functions; see for instance [22]. We omit the construction here, as the precise form is not necessary for our main purpose.

5.6 Final transformation

Definition 5.12. We make the final transformation

$$S(z) := \begin{cases} T(z)M(z)^{-1}, & z \in \mathbb{C} \setminus (D \cup \partial L_{\pm} \cup \Gamma) \\ T(z)P(z)^{-1}, & z \in D \setminus (\partial L_{\pm} \cup \Gamma). \end{cases}$$
 (5.34)

The jump matrices of T and M coincide on Γ_0 , while the jump matrices of T and P coincide on D. It follows that S(z) has an analytic continuation to $\mathbb{C} \setminus \Sigma_S$, as shown in Figure 9. The matching condition (5.33) ensures that $PM^{-1} = I_2 + \mathcal{O}(N^{-1})$ uniformly as $N \to \infty$ on ∂D . Thus, as $N \to \infty$,

$$S_{+}(z) = S_{-}(z) \left(I + \mathcal{O}(N^{-1}) \right),$$
 (5.35)

uniformly on ∂D . While on the rest of the contour Σ_S , as $N \to \infty$, there exists c > 0 such that

$$S_{+}(z) = S_{-}(z) \left(I + \mathcal{O}(e^{-cN}) \right),$$
 (5.36)

uniformly on ∂D . Since $S(z) \to I_2$ as $z \to \infty$, standard arguments yield that as $N \to \infty$,

$$S(z) = I + \mathcal{O}\left(\frac{1}{N(1+|z|)}\right),\tag{5.37}$$

uniformly in $z \in \mathbb{C} \setminus \Sigma_S$.

5.6.1 Proof of Theorem 1.5

Proof. We take z in a compact subset K of $\overline{\mathbb{C}} \setminus \Gamma_0$. We may further assume that L_{\pm} and $\mathbb{D}(z_i, \delta)$ are such that K is in their exterior.

Following the transformation

$$Y \mapsto X \mapsto T \mapsto S$$

and recalling $P_{n,N} = Y_{1,1}$ we obtain the asymptotic formula

$$P_{n,N}(z) = e^{Ng(z)} M_{1,1}(z) (1 + \mathcal{O}(N^{-1})), \quad z \in \mathbb{C} \setminus (D \cup L_{\pm}), \tag{5.38}$$

where the convergence is uniform in K. By computing the (1,1)-entry of the matrix M given in (5.30), we obtain (1.32).

5.6.2 Proof of Theorem 1.7

Proof. The proof is immediate from the strong asymptotic formula (1.32). By (5.27), we have $M_{1,1}(z) \neq 0$ for $z \in \mathbb{C} \setminus \Gamma_0$. Hence, the zeros of $P_{n,N}$ accumulate on Γ_0 as $N \to \infty$. From (1.32) we further conclude that

$$\lim_{n \to \infty} \frac{1}{n} \log |P_{n,N}(z)| = \text{Re}\,g(z) = \int \log |z - s| \,d\mu_0(s), \tag{5.39}$$

uniformly for compact subsets of $\mathbb{C} \setminus \Gamma_0$. It is well known [47] that this implies μ_0 is the weak limit of the normalized zero counting measure; see also [35].

6 Proof of Theorem 1.8

Recall ℓ_{2D} in (1.20). We first relate the constants ℓ_{2D} and ℓ_0 appearing in Theorem 1.1

Lemma 6.1. We have the following relation between ℓ_{2D} and ℓ_0 :

$$\ell_0 = \ell_{2D} + (1 + Q_0) \log w + \text{Re } g(0) - (1 + Q_1) \log(1 + Q_1) - Q_0 \log Q_0 + (1 + Q_0 + Q_1) \log(1 + Q_0 + Q_1).$$
(6.1)

Proof. Recall that $\tilde{\mathcal{U}}_0$ is given in (3.19). We observe as $z \to 0$ we have

$$2\tilde{\mathcal{U}}_0(z) = 2(1 + Q_1 + Q_0)\log\left(1 + \frac{b\rho^2}{a}\right) + \tilde{\mathcal{U}}(z) + \tilde{\mathcal{U}}(s) - (1 + Q_1 + Q_0)\log(1 + s^2) + \mathcal{O}(z),$$
(6.2)

where $s = \frac{b\rho^2}{az}$. This identity follows from the steps of Proposition 3.3, replacing c_0 by 0 and noting $F_1(0) = 1/b$ since f(1/b) = 0 follows from the definition (1.21), and that $\operatorname{deck}(1/b) = \infty$ by (2.3). Then using the expansion

$$f\left(\frac{1}{\operatorname{deck}(F_1(z))}\right) = \frac{b\rho^2}{az} + \mathcal{O}(1), \quad z \to 0,$$

gives (6.2).

By (3.19), (3.3) and (3.21), the LHS of (6.2) can be written as

$$2\tilde{\mathcal{U}}_0(z) = 4U^{\mu_0}(z) + 2(1+Q_1)\log|z| + 2(1+Q_0)\log|z| + 1/w| - 2Q_1\log|z-w| + 2\ell_0.$$

Then by (5.4), we have

$$2\tilde{\mathcal{U}}_0(z) = 2(1+Q_1)\log|z| - 2(1+Q_0)\log w - 2Q_1\log w - 4\operatorname{Re}g(0) + 2\ell_0 + \mathcal{O}(z), \quad (6.3)$$

as $z \to 0$.

Next, we compute the asymptotic behaviour of the RHS of (6.2) as $z \to 0$. By (3.2) we can write

$$\tilde{\mathcal{U}}(z) = 2U^{\mu_0}(z) - 2Q_1 \log|z - w| + (1 + Q_0 + Q_1) \log(1 + |z|^2) + \ell_{2D}.$$

Therefore, we have

$$\tilde{\mathcal{U}}(z) = -2Q_1 \log w - 2 \operatorname{Re} g(0) + \ell_{2D} + \mathcal{O}(z), \tag{6.4}$$

as $z \to 0$. On the other hand, we have

$$\tilde{\mathcal{U}}(s) = 2Q_0 \log|s| + \ell_{2D} + \mathcal{O}(1/s), \tag{6.5}$$

as $s \to \infty$. Hence combining (6.4) and (6.5) we find that the RHS of (6.2) has an expansion

$$-2Q_1 \log w - 2 \operatorname{Re} g(0) + 2\ell_{2D} + 2(1 + Q_1) \log |z| - 2(1 + Q_1) \log \frac{b\rho^2}{a} + 2(1 + Q_0 + Q_1) \log \left(1 + \frac{b\rho^2}{a}\right) + \mathcal{O}(z),$$

$$(6.6)$$

as $z \to 0$. Now substituting [14, Eq 2.60],

$$\frac{b\rho^2}{a} = \frac{1 + Q_1}{Q_0},\tag{6.7}$$

equating (6.3) with (6.6) gives (6.1).

Recall that $h_n \equiv h_{n,N}$ is the squared norm in the planar orthogonality (1.13). We also denote by $\tilde{h}_n \equiv \tilde{h}_{n,N}$ the squared norm in the non-Hermitian contour orthogonality (1.29), i.e.

$$\oint_{\Gamma} P_{n,N}^2(z) \frac{(z-w)^{NQ_1}}{(1+zw)^{N+NQ_0}} \frac{1}{z^{n+NQ_1}} = \tilde{h}_{n,N}.$$
(6.8)

Lemma 6.2. We have

$$\tilde{h}_{n,N} = -\frac{1}{G_{n,N}} P_{n+1,N}(0) h_{n,N}, \tag{6.9}$$

where $G_{n,N}$ is defined by (4.2).

Proof. The proof follows the same approach as in [4, Appendix E]. We define

$$\mu_{ij} := \int_{\mathbb{C}} z^{i} \,\overline{z}^{j} \, \frac{|z - w|^{NQ_1}}{(1 + |z|^2)^{N(1 + Q_0 + Q_1)}} \, dA(z) \tag{6.10}$$

and

$$\nu_i := \int_{\Gamma} z^i (z - w)^{NQ_1} \frac{1}{(1 + zw)^{N + NQ_0}} \frac{1}{z^{n + NQ_1}} dz.$$
 (6.11)

Then from the determinantal expressions for $P_{n,N}$, we have

$$h_n = \frac{\det[\mu_{ij}]_{0 \le i,j \le n}}{\det[\mu_{ij}]_{0 < i,j < n-1}}, \qquad \tilde{h}_n = \frac{\det[\nu_{i+j}]_{0 \le i,j \le n}}{\det[\nu_{i+j}]_{0 < i,j < n-1}}.$$
(6.12)

We relate first relate $\det[\nu_{i+j}]_{0 \le i,j \le n}$ to $\det[\mu_{ij}]_{0 \le i,j \le n}$. Observe that, with the change of variables $z \mapsto 1/z$ and the relabelling k = n + 1 - j, we have

$$\det[\nu_{i+j}]_{0 \le i,j \le n} = \det\left[\int_{\Gamma} z^{i+1} z^{j} \frac{(z-w)^{NQ_{1}}}{(1+zw)^{N+NQ_{0}}} \frac{1}{z^{n+NQ_{1}+1}} dz\right]_{0 \le i,j \le n}$$

$$= (-1)^{n(n+1)/2} \det\left[\int_{\Gamma^{-1}} \frac{z^{k+1}}{z^{i+1}} \frac{(1-zw)^{NQ_{1}}}{(z+w)^{N+NQ_{0}}} z^{N+NQ_{0}-2} dz\right]_{0 \le i,k \le n}$$

$$= (-1)^{n(n+1)/2} \det\left[\int_{\Gamma^{-1}} \frac{z(z+w)^{k}}{z^{i+1}} \frac{(1-zw)^{NQ_{1}}}{(z+w)^{N+NQ_{0}}} z^{N+NQ_{0}-2} dz\right]_{0 \le i,k \le n}$$

$$= (-1)^{n(n+1)/2} \det\left[\int_{\Gamma} z^{i+1} (z-w)^{NQ_{1}} \frac{1}{(1+zw)^{N+NQ_{0}-k}} \frac{1}{z^{NQ_{1}+1+k}} dz\right]_{0 \le i,k \le n},$$

where we have used (1.29). Then it follows from Lemma 4.1 that $\det[\nu_{i+j}]_{0 \le i,j \le n}$ is given by

$$(-1)^{n(n+1)/2} \prod_{\ell=0}^{n} \frac{1}{G_{\ell,N}} \det \left[\int_{\mathbb{C}} z^{i+1} \overline{(z-w)^{k}} \frac{|z-w|^{NQ_{1}}}{(1+|z|^{2})^{N(1+Q_{0}+Q_{1})+1}} dA(z) \right]_{0 \leq i,k \leq n}$$

$$= (-1)^{n(n+1)/2} \prod_{\ell=0}^{n} \frac{1}{G_{\ell,N}} \det [\mu_{ik}]_{1 \leq i \leq n+1} \atop 0 \leq k \leq n}$$

$$= (-1)^{n(n+1)/2} \prod_{\ell=0}^{n} \frac{1}{G_{\ell,N}} (-1)^{n+1} P_{n+1,N}(0) \det [\mu_{ik}]_{0 \leq i,k \leq n}.$$

$$(6.13)$$

Similarly, we have

$$\det[\nu_{i+j}]_{0 \le i, j \le n-1} = (-1)^{n(n-1)/2} \prod_{\ell=0}^{n-1} \frac{1}{G_{\ell,N}} \det[\mu_{ik}]_{0 \le i, k \le n-1}.$$
 (6.14)

Combining these, we obtain the desired result (6.9).

We are now ready to prove Theorem 1.8.

Proof of Theorem 1.8. Define

$$\hat{h}_n := \tilde{h}_n w^{N+NQ_0}. \tag{6.15}$$

The large n asymptotic for \hat{h}_n can be written in terms of solution of the RH problem 5.1. In particular it follows from the standard theory [22] that

$$\hat{h}_{n} = -2\pi i \lim_{z \to \infty} z^{n+1} \left[e^{N\frac{\ell_{0}}{2}\sigma_{3}} \left(I_{2} + \mathcal{O}\left(\frac{1}{N(1+|z|)}\right) \right) M(z) e^{N(g(z) - \frac{\ell_{0}}{2})\sigma_{3}} \right]_{12}$$

$$= 2\pi i (\rho a)^{r_{0}} \sqrt{a(b-a)} \rho e^{N\ell_{0}} \left(1 + \mathcal{O}(N^{-1}) \right).$$
(6.16)

Here, in the second line, we have used

$$N_{1,2}(z) = i \frac{\sqrt{\rho F_2'(z)}}{F_2(z)} = -\rho \frac{\sqrt{a(b-a)}}{z} + \mathcal{O}(z^{-1}), \qquad z \to \infty, \tag{6.17}$$

which follows from RH problem 5.8.

By (2.6), we also have

$$i\frac{\sqrt{\rho F_1'(z)}}{F_1(z)} = -\sqrt{\frac{b-a}{b}} + \mathcal{O}(z) \qquad z \to 0.$$

$$(6.18)$$

Then from (1.32) we obtain,

$$P_{n+1,N}(0) = -(\rho b)^{r_0+1} \sqrt{\frac{b-a}{b}} e^{Ng(0)} \left(1 + \mathcal{O}(N^{-1})\right). \tag{6.19}$$

Combining (6.9), (6.15), (6.16) and (6.19) we obtain

$$h_{n,N} = 2\pi i \, G_{n,N} \left(\frac{a}{b}\right)^{r_0} \sqrt{\frac{a}{b}} e^{N\ell_0} e^{-Ng(0)} \frac{1}{w^{N+NQ_0}} \left(1 + \mathcal{O}(N^{-1})\right)$$
(6.20)

Notice here that by (4.2) and Stirling approximation

$$\Gamma(z) = \sqrt{\frac{2\pi}{z}} z^z e^{-z} \left(1 + \mathcal{O}(z^{-1}) \right), \tag{6.21}$$

we have

$$2iG_{n,N} = \sqrt{\frac{2\pi}{N}} e^{N(Q_0 \log Q_0 + (1+Q_1) \log(1+Q_1) - (1+Q_0+Q_1) \log(1+Q_0+Q_1))} \times \left(\frac{1+Q_1}{Q_0}\right)^{1+r_0} \sqrt{\frac{Q_0}{(Q_0+Q_1+1)(Q_1+1)}} \left(1+\mathcal{O}(N^{-1})\right).$$
(6.22)

Substituting $G_{n,N}$ and replacing ℓ_0 by ℓ_{2D} as given in Lemma 6.1 in (6.9) we obtain

$$h_N = \pi \sqrt{\frac{2\pi}{N}} \left(\frac{1+Q_1}{Q_0}\right)^{1+r_0} \sqrt{\frac{Q_0}{(Q_0+Q_1+1)(Q_1+1)}} \left(\frac{a}{b}\right)^{r_0+1/2} e^{N\ell_{2D}} \left(1+\mathcal{O}(N^{-1})\right).$$

Then by (6.7), we obtain (1.35). This finishes the proof of Theorem 1.8.

A Appendix

The measure μ_0 obtained in Theorem 1.1 can also be characterized as a solution of an equilibrium problem. An alternate approach is to start with the equilibrium problem and build the algebraic curve from the measure. We sketch the steps here.

Consider the following max-min problem

$$\max_{\Gamma \in \mathcal{F}} \min_{\substack{\sup \mu \subset \Gamma \\ \mu(\mathbb{C}) = 1}} \left[\iint \log \frac{1}{|x - y|} \, d\mu(x) \, d\mu(y) + \int \operatorname{Re} \mathcal{V}(x) \, d\mu(x) \right], \tag{A.1}$$

where the maximum is taken over \mathcal{F} the collection of all closed contours \mathcal{F} which has 0 in the interior and -1/w in the exterior, and the minimum is taken over the set of Borel probability measures μ on Γ . By standard capacity estimates we have been able to show that the solution to the max-min problem exists and is unique and the max-min contour Γ_0 is a *critical set* in the following sense.

Fix a contour F_0 in \mathcal{F} , then denote

$$I^{\mathcal{V}}(F_0) := \min_{\substack{\sup \mu \subset F_0 \\ \mu(C) = 1}} \left[\iint \log \frac{1}{|x - y|} d\mu(x) d\mu(y) + \int \operatorname{Re} \mathcal{V}(x) d\mu(x) \right]. \tag{A.2}$$

The solution to the equilibrium problem exists and is unique as the external field is admissible.

Next consider any C_c^2 function $h(z):\mathbb{C}\to\mathbb{C}$ and its one-parameter deformation

$$F_0^t := \{ z + th(z) \mid z \in F_0 \}. \tag{A.3}$$

Here t is chosen small enough such that $F_0^t \in \mathcal{F}$. Then the set F_0 is a *critical set*, if we have

$$\lim_{t \to 0} \frac{I^{\mathcal{V}}(F_0^t) - I^{\mathcal{V}}(F_0)}{t} = 0, \quad t \in \mathbb{R}.$$
 (A.4)

Having defined the notion of *critical set* we turn to the notion of *critical measure*.

For a Borel probability measure, denote

$$I_{\mathcal{V}}(\mu) = I(\mu) + \int \operatorname{Re} \mathcal{V}(z) d\mu(z). \tag{A.5}$$

We now define the Schiffer variations: For a C^2 compactly supported test function h in \mathbb{C} , denote

$$h_t(z) = z + th(z). (A.6)$$

Then we consider the h_t perturbation of the measure by $\mu \to \mu_{t,h}$ induced by the push-forward perturbation h_t , defined in the weak sense as

$$\int f d\mu_{t,h} = \int f(x+th(x))d\mu(x). \tag{A.7}$$

The critical measure is such that for all C_c^2 test function h we have

$$\lim_{t \to 0} \frac{I_{\mathcal{V}}(\mu) - I_{\mathcal{V}}(\mu_{t,h})}{t} = 0. \tag{A.8}$$

It is well known [37] that for log rational external fields, for the critical measure which we denote now by μ_0 there exists a rational function R(z) such that

$$\left(C^{\mu_0}(z) - \frac{\mathcal{V}'(z)}{2}\right)^2 = R(z).$$
 (A.9)

Now to relate the *critical set* and *critical measure*, one uses a well-known result [37, 46] that the equilibrium measure of the *critical set* is a *critical measure*.

Hence obtaining μ_0 in this fashion, one can define the spherical Schwarz function as (3.12) and due to (A.9), S_1, S_2 are branches of a meromorphic function and the *spectral* curve P(S, z) in (2.21) is then obtained. To obtain the droplet, one can then verify that the parametrization

$$\left(\frac{f(1/w)}{1+f(w)f(1/w)},f(w)\right)$$

is a rational parametrization of P(S, z) = 0.
