Note on Von Neumann Entropy and the Ordering of Inverse Temperatures

I show that for two inverse temperatures β_1 and β_2 , the von Neumann entropy $S(\rho_\beta)$ of the Gibbs state ρ_β for a given Hamiltonian H satisfies $S(\rho_{\beta_1}) \ge S(\rho_{\beta_2}) \iff \beta_1 \le \beta_2$. That is, von Neumann entropy is a monotonically increasing function of temperature.

The von Neumann entropy is an important aspect of quantum theory [1]. For a thermal state or Gibbs state ρ_{β} associated with a Hamiltonian H with inverse temperature β , the von Neumann entropy is given by:

$$S(\rho_{\beta}) = -\operatorname{Tr}\left(\rho_{\beta}\log\rho_{\beta}\right),\tag{1}$$

where the density matrix is given by:

$$\rho_{\beta} = \frac{e^{-\beta H}}{\operatorname{Tr}\left(e^{-\beta H}\right)}.$$

We consider, the Hamiltonian H has eigenvalues E_i ordered in a non-decreasing fashion. Although, it is intuitive from classical thermodynamics that for a given system entropy increases with temperature, a rigorous proof of the same in case of discrete system scarce in literature. Herein, I am giving the following proof to the relation (Eq. (3) below. We claim —

$$S(\rho_{\beta_1}) \ge S(\rho_{\beta_2}) \iff \beta_1 \le \beta_2, \qquad (3)$$

This simple proof is based on majorization theory [2]. We demonstrate that the eigenvalue distribution of a lowertemperature thermal state majorizes that of a highertemperature state. Given that the von Neumann entropy is Schur concave [3], this immediately implies the desired monotonicity result. This proof is purely algebraic and holds for all finite-dimensional quantum systems.

Let us consider the following lemma.

Lemma 1. If the for all positive reals $p_i, q_i, i = 1(1)N$ we have the following relation:

$$\frac{p_1}{q_1} \ge \frac{p_i}{q_i} \ge \frac{p_N}{q_N},\tag{4}$$

then it implies,

$$\frac{\sum_{i=1}^{k} p_i}{\sum_{i=1}^{k} q_i} \ge \frac{\sum_{i=1}^{N} p_i}{\sum_{i=1}^{N} q_i}, \qquad for \ k = 2(1)N - 1 \quad (5)$$

Proof: Using the identity, if $\frac{p}{q} \ge \frac{r}{s}$ for $p, q, r, s \ge 0$ and real (the property of arithmetic mean),

$$\frac{p}{q} \ge \frac{p+r}{q+s} \ge \frac{r}{s},\tag{6}$$

we proceed to use proof by induction.

Step 1: k = 2, we have using the above relation in Eq. (6)

$$\frac{p_1}{q_1} \ge \frac{p_1 + p_2}{q_1 + q_2} \ge \frac{p_2}{q_2}.$$
(7)

Step 2: We take k = 3, and using the statement of the Lemma 1), we have

$$\frac{p_2}{q_2} \ge \frac{p_3}{q_3}, \quad \text{from Eq. (4)}$$

$$\implies \frac{p_1 + p_2}{q_1 + q_2} \ge \frac{p_3}{q_3}, \quad \text{from Eq. (7)}$$

$$\implies \frac{p_1 + p_2}{q_1 + q_2} \ge \frac{p_1 + p_2 + p_3}{q_1 + q_2 + q_3} \ge \frac{p_3}{q_3}.$$
(8)

Step 3: Lets assume for some k = r < N-1 the following holds true,

$$\frac{\sum_{i=1}^{r-1} p_i}{\sum_{i=1}^{r-1} q_i} \ge \frac{\sum_{i=1}^r p_i}{\sum_{i=1}^r q_i} \ge \frac{p_r}{q_r} \tag{9}$$

so we consider k = r + 1

$$\frac{\sum_{i=1}^{r} p_i}{\sum_{i=1}^{r} q_i} \ge \frac{p_{r+1}}{q_{r+1}}, \\
\implies \frac{\sum_{i=1}^{r} p_i}{\sum_{i=1}^{r} q_i} \ge \frac{\sum_{i=1}^{r+1} p_i}{\sum_{i=1}^{r+1} q_i} \ge \frac{p_{r+1}}{q_{r+1}}.$$
(10)

Therefore, we can write the following

$$\frac{p_1 + p_2}{q_1 + q_2} \ge \frac{\sum_{i=1}^r p_i}{\sum_{i=1}^r q_i} \ge \frac{\sum_{i=1}^N p_i}{\sum_{i=1}^N q_i},\tag{11}$$

which concludes the proof. \Box

We will prove the main statement in Eq. (3) by contradiction. We assume the following,

$$\beta_1 \ge \beta_2 \tag{12}$$

and try to show $S(\rho_{\beta_1}) \geq S(\rho_{\beta_2})$. Note, we have consider the energy eigenvalues to be in non-decreasing sequence, *i.e.*, $E_1 \leq E_i \leq E_N$. Hence, we write the following (from Eq. (12)):

$$e^{\beta_{1}E_{i}} \geq e^{\beta_{2}E_{i}}, \quad \forall E_{i},$$

$$\implies e^{-\beta_{1}E_{i}} \leq e^{-\beta_{2}E_{i}},$$

$$\implies \sum_{i} e^{-\beta_{1}E_{i}} \leq \sum_{i} e^{-\beta_{2}E_{i}},$$

$$\implies Z(\beta_{1}) \leq Z(\beta_{2}). \quad (13)$$

To proceed further, we need to prove our main theorem as under.

Theorem 1. If $\beta_1 \geq \beta_2$, the density matrix ρ_{β_1} majorizes ρ_{β_2} ($\rho_{\beta_1} \succ \rho_{\beta_2}$). That is

$$\sum_{i=1}^{k} \frac{e^{-\beta_1 E_i}}{Z(\beta_1)} \ge \sum_{i=1}^{k} \frac{e^{-\beta_2 E_i}}{Z(\beta_2)},\tag{14}$$

where k = 1(1)N and equality holds for k = N.

Proof: We first note that, since $E_1 \leq E_i \leq E_N$, $\frac{e^{-\beta E_1}}{Z(\beta)} \geq \frac{e^{-\beta E_N}}{Z(\beta)}$. Let us define the ratio

$$\mathbf{R}_{k} = \frac{\sum_{i=1}^{k} e^{-\beta_{1}E_{i}}/Z(\beta_{1})}{\sum_{i=1}^{k} e^{-\beta_{2}E_{i}}/Z(\beta_{2})} = \frac{\sum_{i=1}^{k} e^{-\beta_{1}E_{i}}}{\sum_{i=1}^{k} e^{-\beta_{2}E_{i}}} \cdot \frac{Z(\beta_{2})}{Z(\beta_{1})}.$$
 (15)

Consider the case k = 1,

$$R_{1} = \frac{e^{-\beta_{1}E_{1}}/Z(\beta_{1})}{e^{-\beta_{2}E_{1}}/Z(\beta_{2})},$$

$$\implies \qquad = \frac{\sum_{j} e^{-\beta_{2}(E_{j}-E_{1})}}{\sum_{i} e^{-\beta_{1}(E_{i}-E_{1})}}.$$
(16)

Given, $E_1 \leq E_i$, $\forall i$, we can write using Eq (12),

$$e^{-\beta_2(E_i - E_1)} \ge e^{-\beta_1(E_i - E_1)},$$

$$\implies \sum_j e^{-\beta_2(E_j - E_1)} \ge \sum_i e^{-\beta_1(E_i - E_1)},$$

$$\implies \mathbf{R}_1 \ge 1, \tag{17}$$

$$\implies \frac{e^{-\beta_1 E_1}}{Z(\beta_1)} \ge \frac{e^{-\beta_2 E_1}}{Z(\beta_2)} \tag{18}$$

Let us consider the ratio R_2

$$R_{2} = \frac{\left(e^{-\beta_{1}E_{1}} + e^{-\beta_{1}E_{2}}\right)/Z(\beta_{1})}{\left(e^{-\beta_{2}E_{1}} + e^{-\beta_{2}E_{2}}\right)/Z(\beta_{2})}.$$
(19)

Using Lemma 1 we have:

$$\frac{\left(e^{-\beta_{1}E_{1}}+e^{-\beta_{1}E_{2}}\right)}{\left(e^{-\beta_{2}E_{1}}+e^{-\beta_{2}E_{2}}\right)} \ge \frac{Z(\beta_{1})}{Z(\beta_{2})}, \qquad (20)$$

$$\implies \frac{\left(e^{-\beta_{1}E_{1}}+e^{-\beta_{1}E_{2}}\right)}{\left(e^{-\beta_{2}E_{1}}+e^{-\beta_{2}E_{2}}\right)} \cdot \frac{Z(\beta_{2})}{Z(\beta_{1})} \ge 1,$$

thus satisfying the second step of this proof by induction

$$R_2 \ge 1. \tag{21}$$

Similarly, we consider the next step, and assume $R_r \ge 1$ for some $1 \le r \le N - 1$, which implies

$$\frac{\sum_{i=1}^{r} e^{-\beta_1 E_i}}{\sum_{i=1}^{r} e^{-\beta_2 E_i}} \cdot \frac{Z(\beta_2)}{Z(\beta_1)} \ge 1$$
(22)

Using Lemma 1 once more, we can write

$$\frac{\sum_{i=1}^{r} e^{-\beta_1 E_i}}{\sum_{i=1}^{r} e^{-\beta_2 E_i}} \ge \frac{\sum_{i=1}^{r} e^{-\beta_1 E_i}}{\sum_{i=1}^{r} e^{-\beta_2 E_i}} \ge \frac{Z(\beta_1)}{Z(\beta_2)},$$

$$\implies \frac{\sum_{i=1}^{r} e^{-\beta_1 E_i}}{\sum_{i=1}^{r} e^{-\beta_2 E_i}} \ge \frac{Z(\beta_1)}{Z(\beta_2)},$$

$$\implies \frac{\sum_{i=1}^{r} e^{-\beta_2 E_i}}{\sum_{i=1}^{r} e^{-\beta_2 E_i}} \cdot \frac{Z(\beta_2)}{Z(\beta_1)} \ge 1,$$

$$\implies R_{r+1} \ge 1$$
(23)

So, we conclude that the ratio in Eq. (15) is always greater than or equal to one for the desired values of k = 1(1)N while being strictly equal to one at k = Nimplying $\rho_{\beta_1} \succ \rho_{\beta_2}$. This proves the theorem. \Box

Now we can use Schur concavity property [2] to claim since $\rho_{\beta_1} \succ \rho_{\beta_2}$, $S(\rho_{\beta_1}) \leq S(\rho_{\beta_2})$. But this contradicts the claim in Eq. (3). Thus our original assumption, $\beta_1 \geq \beta_2$ was wrong. And we have $S(\rho_{\beta_1}) \geq S(\rho_{\beta_2}) \Longrightarrow$ $\beta_1 \leq \beta_2$. In the same spirit, we note that, given the result of Theorem 1, $\beta_1 \geq \beta_2 \implies \rho_{\beta_1} \succ \rho_{\beta_2}$, and we have the same relation with ρ_β and $S(\rho_\beta)$ using Schur's concavity property, we see the reverse is also true. That is, $\beta_1 \leq \beta_2 \implies S(\rho_{\beta_1}) \geq S(\rho_{\beta_2})$. Therefore, we prove our original claim.
