Some New Congruences For Overpartition Function With ℓ -Regular Non-Overlined Parts

Abstract: Alanzi et al. (2022) investigated overpartition of a positive integer n with ℓ -regular non-overlined parts denoted by $\overline{R}_{\ell}^*(n)$, and proved some results for the case $\ell = 3$. As extension to the results of Alanzi et al., Sellers (2024) proved some new congruences for $\overline{R}_{3}^*(n)$. In this paper, we prove some new infinite families and particular congruences for $\overline{R}_{\ell}^*(n)$ for $\ell = 4, 5k, 6$, and 8, where k is any positive integer. We also offer some congruences connecting $\overline{R}_{\ell}^*(n)$ with some other partition functions.

1. INTRODUCTION

A partition of a positive integer n is a finite non-increasing sequence of positive integers s_1, s_2, \ldots, s_k satisfying $s_1 + s_2 + \cdots + s_k = n$, where the integers s_1, s_2, \ldots, s_k are called as parts or summands of the partition. For example, the partitions of n = 3 are given by 3, 2+1, 1+1+1. The number of partition of a non-negative integer n is usually denoted by p(n) and its generating function is given by

$$\sum_{n=0}^{\infty} p(n)q^n = \frac{1}{(q;q)_{\infty}}, \qquad p(0) = 1,$$

where for any complex number a and |q| < 1,

$$(a;q)_{\infty} = \prod_{n=0} (1 - aq^n).$$

For brevity, we will use the notation $f_h := (q^h; q^h)_{\infty}$ for any positive integer h. Ramanujan [20, 21](also see [6]) offered following beautiful congruences for the partition function p(n):

$$p(5n+4) \equiv 0 \pmod{5}, \quad p(7n+5) \equiv 0 \pmod{7}, \quad p(11n+6) \equiv 0 \pmod{11}.$$

For any positive integer ℓ , an ℓ -regular partition of a positive integer n is a partition of n such that none of its part is divisible by ℓ . If $b_{\ell}(n)$ denotes the number of ℓ -regular

partitions of n, then the generating function of $b_{\ell}(n)$ is given by

$$\sum_{n=0}^{\infty} b_{\ell}(n)q^n = \frac{(q^{\ell}; q^{\ell})_{\infty}}{(q; q)_{\infty}} = \frac{f_{\ell}}{f_1}.$$

The arithmetic properties of ℓ -regular partition have been studied by different authors, for example see [3, 4, 8, 10, 11, 15, 17, 19, 25, 27].

An overpartition of a positive integer n is a partition of n wherein first occurrence of any part may be overlined. The number of overpartitions of a positive integer n is usually denoted by $\overline{p}(n)$ which is first studied by Corteel and Lovejoy [9]. The generating function of $\overline{p}(n)$ [9] is given by

$$\sum_{n\geq 0}^{\infty} \overline{p}(n)q^n = \frac{(q^2; q^2)_{\infty}}{(q; q)_{\infty}^2} = \frac{f_2}{f_1^2}.$$

For instance, $\overline{p}(3) = 8$ with overpartitions of 3 given by $3, \overline{3}, 2 + 1, \overline{2} + 1, 2 + \overline{1}, \overline{2} + \overline{1}, 1 + 1 + 1, \overline{1} + 1 + 1$. One may see [14, 13, 16, 18, 22, 26] and references therein for congruence and other arithmetic properties of overpartition function $\overline{p}(n)$.

As an extension to the overpartition function $\overline{p}(n)$, overpartition with ℓ -regular overlined parts denoted by $\overline{p}_{\ell}(n)$ was defined. For example, $\overline{p}_2(3) = 6$ with the relevant partitions given by 3, $\overline{3}$, 2+1, $2+\overline{1}$, 1+1+1, $\overline{1}+1+1$. The generating function for $\overline{p}_{\ell}(n)$ [2] is given by

$$\sum_{n=0}^{\infty} \overline{p}_{\ell}(n) q^n = \frac{(q^2; q^2)_{\infty}(q^{\ell}; q^{\ell})_{\infty}}{(q; q)_{\infty}^2 (q^{2\ell}; q^{2\ell})_{\infty}} = \frac{f_2 f_{\ell}}{f_1^2 f_{2\ell}}.$$

Ballantine and Merca [2] investigated the connections between $\overline{p}_{\ell}(n)$ and other restricted overpartition functions, and also established recurrence relations for $\overline{p}_3(n)$. Shivanna and Chandrappa [24] proved congruences modulo 5, 7, 40 and powers of 2 for $\overline{p}_{\ell}(n)$ with $\ell \in \{4, 8\}$. Buragohain and Saikia [7] proved some congruences for $\overline{p}_{\ell}(n)$ with $\ell \in$ 3, 5, 9, 12, 16, 18, 24 using q-series manipulations.

Recently, Alanzi et al. [1] considered overpartition of positive integer n with ℓ -regular non-overlined parts denoted by $\overline{R}_{\ell}^*(n)$. For instance, $\overline{R}_2^*(3) = 6$ with the relevant partitions given by 3, $\overline{3}$, $\overline{2}+1$, $\overline{2}+\overline{1}1+1+1$, $\overline{1}+1+1$. Alanzi et al. [1] proved some general parity results and specific congruences for the case $\ell = 3$ of $\overline{R}_{\ell}^*(n)$. The generating function of $\overline{R}_{\ell}^*(n)$ was given by Sellers [23] as

$$\sum_{n=0}^{\infty} \overline{R}_{\ell}^{*}(n)q^{n} = \frac{(q^{\ell}; q^{\ell})_{\infty}(q^{2}; q^{2})_{\infty}}{(q; q)_{\infty}^{2}} = \frac{f_{2}f_{\ell}}{f_{1}^{2}}.$$

As an extension to the work of Alanzi et al. [1], Sellers [23] found some infinite families and some specific congruences modulo 3 and 4 for $\overline{R}_3^*(n)$. In closing remarks of [23], further congruences for the partition function $\overline{R}_{\ell}^*(n)$ are desired. In this paper, we will prove some infinite families and particular congruences for $\overline{R}_{\ell}^*(n)$ for $\ell = 4, 5k, 6, 8$, where k is any positive integer. We also offer some congrunce relations connecting $\overline{R}_{\ell}^*(n)$ with some other partition functions.

2. Preliminaries

Ramanujan's general theta-function F(x, y) is defined by

$$F(x,y) = \sum_{n=-\infty}^{\infty} x^{n(n+1)/2} y^{n(n-1)/2}, \ |xy| < 1.$$

Three important special cases of F(x, y) [5, p. 36, Entry 22 (i), (ii))] are the thetafunctions $\phi(q)$, $\psi(q)$ and f(-q) given by

$$\phi(q) := F(q,q) = \sum_{\nu=0}^{\infty} q^{\nu^2} = (-q;q^2)_{\infty}^2 (q^2;q^2)_{\infty} = \frac{f_2^5}{f_1^2 f_4^2},$$

$$\psi(q) := F(q, q^3) = \sum_{\nu \ge 0} q^{\nu(\nu+1)/2} = \frac{(q^2; q^2)_{\infty}}{(q; q^2)_{\infty}} = \frac{f_2^2}{f_1},$$

and

$$f(-q) := F(-q, -q^2) = \sum_{\nu = -\infty}^{\infty} (-1)^{\nu} q^{\nu(3\nu+1)/2} = f_1.$$

Employing elementary q-operations, it is easily seen that

$$\phi(-q) = \frac{f_1^2}{f_2}.$$
(2.5)

Lemma 2.1. [10, Theorem 2.1] For any odd prime, we have

$$\psi(q) = \sum_{j=0}^{(p-3)/2} q^{(j^2+j)/2} F\left(q^{(p^2+(2j+1)p)/2}, q^{(p^2-(2j+1)p)/2}\right) + q^{(p^2-1)/8} \psi(q^{p^2}).$$

Furthermore, $(j^2 + j)/2 \not\equiv (p^2 - 1)/8 \pmod{p}$ for $0 \le j \le (p - 3)/2$.

Lemma 2.2. [10, Theorem 2.2] For any prime $p \ge 5$, we have

$$f_{1} = \sum_{\substack{k=-(p-1)/2\\k\neq(\pm p-1)/6}}^{(p-1)/2} (-1)^{k} q^{(3k^{2}+k)/2} F\left(-q^{(3p^{2}+(6k+1)p)/2}, -q^{(3p^{2}-(6k+1)p)/2}\right) + (-1)^{(\pm p-1)/6} q^{(p^{2}-1)/24} f_{p^{2}}, \qquad (2.7)$$

where

$$\frac{\pm p - 1}{6} = \begin{cases} \frac{(p - 1)}{6}, & \text{if } p \equiv 1 \pmod{6} \\ \frac{(-p - 1)}{6}, & \text{if } p \equiv -1 \pmod{6}. \end{cases}$$

Furthermore, if
$$\frac{-(p-1)}{2} \le k \le \frac{(p-1)}{2}$$
 and $k \ne \frac{(\pm p-1)}{6}$ then
 $\frac{3k^2 + k}{2} \ne \frac{p^2 - 1}{24} \pmod{p}.$

Lemma 2.3. [12] We have

$$f_1^2 = \frac{f_2 f_8^5}{f_4^2 f_{16}^2} - 2q \frac{f_2 f_{16}^2}{f_8}, \tag{2.8}$$

$$\frac{1}{f_1^2} = \frac{f_8^5}{f_2^5 f_{16}^2} + 2q \frac{f_4^2 f_{16}^2}{f_2^5 f_8},\tag{2.9}$$

$$\frac{1}{f_1^4} = \frac{f_4^{14}}{f_2^{14}f_8^4} + 4q \frac{f_4^2 f_8^4}{f_2^{10}} \tag{2.10}$$

and

$$f_1^4 = \frac{f_4^{10}}{f_2^2 f_8^4} - 4q \frac{f_2^2 f_8^4}{f_4^2}.$$

Lemma 2.4. [14] We have

$$\frac{1}{\phi(-q)} = \frac{1}{\phi(-q^4)^4} \Big(\phi(q^4)^3 + 2q\phi(q^4)^2\psi(q^8) + 4q^2\phi(q^4)\psi(q^8)^2 + 8q^3\psi(q^8)^3 \Big).$$

$$\begin{split} \mathbf{Lemma \ 2.5. \ [14] \ We \ have} \\ & \frac{1}{\phi(q)} = \frac{\phi(q^{25})}{\phi(q^5)^6} \bigg[\phi(q^{25})^4 - 2q\phi(q^{25})^3 X(q^5) + 4q^2\phi(q^{25})^2 X(q^5)^2 - 8q^3\phi(q^{25}) X(q^5)^3 \\ & + q^4 \left(16X(q^5)^4 - 2\phi(q^{25})^3 Y(q^5) \right) - 12q^5\phi(q^{25})^2 X(q^5) Y(q^5) + 16q^6\phi(q^{25}) X(q^5)^2 Y(q^5) \\ & - 16q^7 X(q^5)^3 Y(q^5) + 4q^8\phi(q^{25})^2 Y(q^5)^2 + 16q^9\phi(q^{25}) X(q^5) Y(q^5)^2 \\ & + 16q^{10} X(q^5)^2 Y(q^5)^2 - 8q^{12}\phi(q^{25}) Y(q^5)^3 - 16q^{13} X(q^5) Y(q^5)^3 + 16q^{16} Y(q^5)^4 \bigg], \end{split}$$

Lemma 2.6. [5, p. 49] We have

$$\psi(q) = F(q^3, q^6) + q\psi(q^9).$$

We will also employ following congruences which can be easily proved by using the binomial theorem: For any prime p,

$$f_p \equiv f_1^p \,(\mathrm{mod}\,p),\tag{2.13}$$

and

$$f_1^{p^2} \equiv f_p^{-p} \,(\text{mod}\,p^2).$$

3. Congrurences for $\overline{R}^*_{\ell}(n)$

Theorem 3.1. We have

(i) $\overline{R}_{4}^{*}(4n+\xi) \equiv 0 \pmod{4}; \quad \xi = 2, 3,$

(ii) Let $p \ge 13$ be a prime with $\left(\frac{-6}{p}\right) = -1$ and $1 \le r \le p-1$. Then for any integers $\alpha \ge 0$ and $n \ge 0$, we have

$$\sum_{n=0}^{\infty} \overline{R}_4^* \left(4 \cdot p^{2\alpha} n + \frac{7 \cdot p^{2\alpha} - 1}{6} \right) \equiv 2f_1 \psi(q^2) \pmod{4}$$
(3.1)

and

$$\overline{R}_{4}^{*}\left(4 \cdot p^{2\alpha+1}(pn+r) + \frac{7 \cdot p^{2\alpha+2} - 1}{6}\right) \equiv 0 \pmod{4}.$$
(3.2)

Proof. Setting $\ell = 4$ in (1.7) and simplifying, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^*(n) q^n = \frac{f_4 f_2 f_1^2}{f_1^4}.$$
(3.3)

Employing (2.14) with p = 2 in (3.3) and then simplifying using (2.5), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^*(n) q^n \equiv f_4 \phi(-q) \pmod{4}.$$
(3.4)

From [5, p.49], we note that

$$\phi(q) = \phi(q^{n^2}) + \sum_{r=1}^{n-1} q^{r^2} F(q^{n(n-2r)}, q^{n(n+2r)}).$$
(3.5)

Setting n = 2 in (3.5) and simplifying, we obtain

$$\phi(q) = \phi(q^4) + q\psi(q^8).$$
(3.6)

Replacing q by -q in (3.6) and then employing in (3.4), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^*(n) q^n \equiv f_4\left(\phi(q^4) - 2q\psi(q^8)\right) \pmod{4}.$$
(3.7)

Extracting the terms involving $q^{4n+\xi}$ for $\xi = 2, 3$ from (3.7), we arrive at (i).

To prove (ii), we employ the principle of mathematical induction. Extracting the terms involving q^{4n+1} from (3.7), dividing by q and replacing q^4 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^* (4n+1)q^n \equiv 2f_1 \psi(q^2) \pmod{4}, \tag{3.8}$$

which is $\alpha = 0$ case of (ii). Assume that (ii) is true for some integer $\alpha \ge 0$. Using (2.6) and (2.7) in (ii), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{4}^{*} \left(4 \cdot p^{2\alpha} n + \frac{7 \cdot p^{2\alpha} - 1}{6} \right)$$

$$\equiv 2 \left[\sum_{\substack{k=-(p-1)/2\\k\neq(\pm p-1)/6}}^{(p-1)/2} (-1)^{k} q^{\frac{3k^{2}+k}{2}} F\left(-q^{(3p^{2}+(6k+1)p)/2}, -q^{(3p^{2}-(6k+1)p)/2} \right) + (-1)^{(\pm p-1)/6} q^{(p^{2}-1)/24} f_{p^{2}} \right]$$

$$\times \left[\sum_{j=0}^{(p-3)/2} q^{2(j^{2}+j)/2} F\left(q^{2(p^{2}+(2j+1)p)/2}, q^{2(p^{2}-(2j+1)p)/2} \right) + q^{2(p^{2}-1)/8} \psi(q^{2p^{2}}) \right] (\text{mod } 4).$$

$$(3.9)$$

Consider the congruence

$$\left(\frac{3k^2+k}{2}\right) + 2\left(\frac{j^2+j}{2}\right) \equiv \frac{7(p^2-1)}{24} \,(\bmod \, p),$$

which is similar to

$$(6k+1)^2 + 6(2j+1)^2 \equiv 0 \pmod{p}$$

Since $\left(\frac{-6}{p}\right) = -1$, the above congruence has only solution $k = (\pm p - 1)/6$ and $j = (\pm p - 1)/2$. So, extracting the terms involving $q^{pn+7(p^2-1)/24}$ from both sides of (3.9), dividing by $q^{7(p^2-1)/24}$ and then replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^* \left(4p^{2\alpha+1}n + \frac{7p^{2\alpha+2} - 1}{6} \right) q^n \equiv 2f_p \psi(q^{2p}) \pmod{4}.$$
(3.10)

Extracting the terms involving q^{pn} from (3.10) and replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_4^* \left(4p^{2(\alpha+1)}n + \frac{7p^{2\alpha+2} - 1}{6} \right) q^n \equiv 2f_1 \psi(q^2) \pmod{4}, \tag{3.11}$$

which is $\alpha + 1$ case of (3.1). Extracting the coefficients of the terms involving q^{pn+r} , for $1 \leq r \leq p-1$, from both sides (3.10), we arrive (3.2).

Theorem 3.2. For any positive integer k, we have

- (i) $\overline{R}_{5k}^*(5n+\xi) \equiv 0 \pmod{4}; \quad \xi = 2, 3,$
- (*ii*) $\overline{R}_{5k}^*(5n+1) \equiv 0 \pmod{2}$.

Proof. Setting $\ell = 5k$ in (1.7) and employing (2.5), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{5k}^*(n) q^n = \frac{f_{5k} f_2}{f_1^2} = \frac{f_{5k}}{\phi(-q)}.$$
(3.12)

Employing Lemma 2.5 in (3.12) and simplifying using (2.14) with p = 2, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{5k}^{*}(n)q^{n} \equiv \frac{f_{5k} \phi(-q^{25})}{\phi(-q^{5})^{6}} \Big[\phi(-q^{25})^{4} + 2q\phi(-q^{25})^{3}X(q^{5}) -2q^{4}\phi(-q^{25})^{3}Y(-q^{5}) \Big] \pmod{4}.$$
(3.13)

Extracting the terms involving $q^{5n+\xi}$ for $\xi = 2, 3$ from (3.13), we arrive at (i). Similarly, (ii) follows from (3.12) by employing (2.13) with p = 2 and then extracting the terms involving q^{5n+1} .

Theorem 3.3. For any integer $\alpha \geq 0$, we have

(i)
$$\overline{R}_6^*\left(9^{\alpha}n + \frac{9^{\alpha}-1}{4}\right) \equiv \overline{R}_6^*(n) \pmod{3},$$

(ii) $\overline{R}_6^*\left(9^{\alpha+1}n + \frac{21 \cdot 9^{\alpha}-1}{4}\right) \equiv 0 \pmod{3},$
(iii) $\overline{R}_6^*\left(9^{\alpha+1}n + \frac{33 \cdot 9^{\alpha}-1}{4}\right) \equiv 0 \pmod{3}.$

Proof. Setting $\ell = 6$ in (1.7), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^*(n) q^n = \frac{f_6 f_2}{f_1^2}.$$
(3.14)

Simplifying (3.14) by employing (2.13) with p = 3 and, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*}(n)q^{n} \equiv \frac{f_{2}^{4}}{f_{1}^{2}} \,(\text{mod }3).$$
(3.15)

Employing (2.3) in (3.15), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^*(n) q^n \equiv \psi^2(q) \pmod{3}.$$
(3.16)

Employing Lemma 2.6 in (3.16), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^*(n) q^n \equiv F^2(q^3, q^6) + q^2 \psi^2(q^9) + 2q F(q^3, q^6) \psi(q) \pmod{3}.$$
(3.17)

Extracting the terms involving q^{3n+2} from (3.17), dividing by q^2 and replacing q^3 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*}(3n+2)q^{n} \equiv \psi^{2}(q^{3}) \pmod{3}.$$
(3.18)

Extracting the terms involving q^{3n} from (3.18) and replacing q^3 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*}(9n+2)q^{n} \equiv \psi^{2}(q) \pmod{3}.$$
(3.19)

Employing (3.16) in (3.19), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^* (9n+2) q^n \equiv \sum_{n=0}^{\infty} \overline{R}_6^* (n) q^n \pmod{3}.$$
(3.20)

Iterating (3.20) with n replaced by 9n + 2 and simplifying, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^* \left(9^{\alpha} n + \frac{9^{\alpha} - 1}{2}\right) q^n \equiv \sum_{n=0}^{\infty} \overline{R}_6^*(n) q^n \pmod{3},\tag{3.21}$$

where $\alpha \geq 0$ is any integer. Equating the coefficients of q^n on both sides of (3.21), we arrive at (i).

Combining (3.17) and (3.21), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^* \left(9^{\alpha} n + \frac{9^{\alpha} - 1}{4}\right) q^n \equiv F^2(q^3, q^6) + q^2 \psi^2(q^9) + 2qF(q^3, q^6)\psi(q) \pmod{3}, \quad (3.22)$$

 $\alpha \geq 0$ is any integer.

Extracting the terms involving q^{3n+2} from (3.22), dividing by q^2 and replacing q^3 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^* \left(9^{\alpha} (3n+2) + \frac{9^{\alpha} - 1}{4} \right) q^n \equiv \psi^2(q^3) \pmod{3}, \tag{3.23}$$

Extracting the terms involving q^{3n+1} and q^{3n+2} from (3.23), we complete the proof of (ii) and (iii), respectively.

Theorem 3.4. Let $p \ge 3$ be a prime with $\left(\frac{-1}{p}\right) = -1$ and $1 \le r \le p-1$. Then for any integers $\alpha \ge 0$ and $n \ge 0$, we have

(i)
$$\sum_{n=0}^{\infty} \overline{R}_6^* \left(2 \cdot p^{2\alpha} n + \frac{5 \cdot p^{2\alpha} - 1}{4} \right) \equiv 2\psi(q)\psi(q^4) \pmod{3},$$

(*ii*)
$$\overline{R}_{6}^{*}\left(2 \cdot p^{2\alpha+1}(pn+r) + \frac{5 \cdot p^{2\alpha+2} - 1}{4}\right) \equiv 0 \pmod{3}.$$

Proof. Employing (2.9) in (3.15), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^*(n) q^n \equiv \frac{f_8^5}{f_2 f_{16}^2} + 2q \frac{f_4^2 f_{16}^2}{f_2 f_8} \pmod{3}.$$
(3.24)

Extracting the terms involving q^{2n+1} , dividing by q and replacing q^2 by q from (3.24), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^* (2n+1) q^n \equiv 2 \frac{f_2^2}{f_1} \cdot \frac{f_8^2}{f_4} \pmod{3}.$$
 (3.25)

Employing (2.3) in (3.25), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_6^*(2n+1)q^n \equiv 2\psi(q)\psi(q^4) \pmod{3}.$$
(3.26)

which is $\alpha = 0$ case of (i). Assume that (i) is true for some integer $\alpha \ge 0$. Using (2.6) in (i), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*} \left(2 \cdot p^{2\alpha} n + \frac{5 \cdot p^{2\alpha} - 1}{4} \right)$$

$$\equiv 2 \left[\sum_{j=0}^{(p-3)/2} q^{(j^{2}+j)/2} F\left(q^{(p^{2}+(2j+1)p)/2}, q^{(p^{2}-(2j+1)p)/2}\right) + q^{(p^{2}-1)/8} \psi(q^{p^{2}}) \right]$$

$$\times \left[\sum_{t=0}^{(p-3)/2} q^{4(t^{2}+t)/2} F\left(q^{4(p^{2}+(2t+1)p)/2}, q^{4(p^{2}-(2t+1)p)/2}\right) + q^{4(p^{2}-1)/8} \psi(q^{4p^{2}}) \right] (\text{mod } 3).$$
(3.27)

Consider the congruence

$$\left(\frac{j^2+j}{2}\right) + 4\left(\frac{t^2+t}{2}\right) \equiv \frac{5(p^2-1)}{8} \pmod{p},$$

which is ĕquivalent to

$$(2j+1)^2 + (4t+2)^2 \equiv 0 \pmod{p}.$$

Since $\left(\frac{-1}{p}\right) = -1$, the above congruence has only solution $j = t = (\pm p - 1)/2$. Therefore, extracting the terms involving $q^{pn+5(p^2-1)/8}$ from both sides of (3.27), dividing throughout by $q^{5(p^2-1)/8}$ and then replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*} \left(2 \cdot p^{2\alpha+1} n + \frac{5 \cdot p^{2\alpha+2} - 1}{4} \right) \equiv 2\psi(q^{p})\psi(q^{4p}) \pmod{3}.$$
(3.28)

Extracting the terms involving q^{pn} from (3.28) and replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{6}^{*} \left(2 \cdot p^{2(\alpha+1)} n + \frac{5 \cdot p^{2(\alpha+1)} - 1}{4} \right) \equiv 2\psi(q)\psi(q^{4}) \pmod{3}$$
(3.29)

which is $\alpha + 1$ case of (i). Thus, by induction, we complete the proof of (i). Extracting the terms involving q^{pn+r} , for $1 \leq r \leq p-1$, from both sides (3.28), we complete the proof (ii).

Theorem 3.5. We have

(i)
$$\overline{R}_8^*(4n+\xi) \equiv 0 \pmod{4}; \quad \xi = 2, 3,$$

(*ii*) $\overline{R}_8^*(16n + 4\xi + 1) \equiv 0 \pmod{4}, \quad \xi = 1, 2, 3,$

Proof. Setting $\ell = 8$ in (1.7), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^*(n) q^n = \frac{f_2 f_8}{f_1^2}.$$
(3.30)

Employing (2.9) in (3.30), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^*(n) q^n = \frac{f_8^6}{f_2^4 f_{16}^2} + 2q \frac{f_4^2 f_{16}^2}{f_2^4}.$$
(3.31)

Employing (2.14) with p = 2 in (3.31), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^*(n) q^n \equiv \frac{f_8^2}{f_4^2} + 2q f_{16}^2 \,(\text{mod }4).$$
(3.32)

Extracting the terms involving $q^{4n+\xi}$ for $\xi = 2, 3$ from (3.32), we arrive at (i).

Again, extracting the terms q^{4n+1} from (3.32), dividing by q and replacing q^4 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (4n+1) q^n \equiv 2f_4^2 \pmod{4}.$$
 (3.33)

Extracting the terms involving $q^{4n+\xi}$ for $\xi = 1, 2, 3$ from (3.33), we arrive at (ii).

Theorem 3.6. We have

- (i) $\overline{R}_8^*(4n+3) \equiv 0 \pmod{8},$
- (ii) $\overline{R}_8^*(8n+2\xi+1) \equiv 0 \pmod{8}, \quad \xi = 1, 2, 3.$

Proof. Extracting the terms involving q^{2n+1} from (3.31), dividing by q and replacing q^2 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (2n+1) q^n = 2 \frac{f_2^2 f_8^2}{f_1^4}.$$
(3.34)

Employing (2.10) in (3.34), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (2n+1) q^n = 2 \frac{f_4^{14}}{f_2^{12} f_8^2} + 8q \frac{f_4^2 f_8^6}{f_2^8}.$$
(3.35)

Employing (2.14) with p = 2 in (3.35), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (2n+1) q^n \equiv 2f_8^2 \pmod{8}$$
(3.36)

Extracting the terms involving q^{2n+1} on both sides of (3.36), we arrive at (i).

Similarly, (ii) follows from (3.36) by extracting the terms involving $q^{4n+\xi}$ for $\xi = 1, 2, 3$. \Box

Theorem 3.7. Let $p \ge 5$ be a prime with $\left(\frac{-3}{p}\right) = -1$ and $1 \le r \le p-1$. Then for any integers $\alpha \ge 0$ and $n \ge 0$, we have

(i)
$$\sum_{n=0}^{\infty} \overline{R}_8^* \left(8p^{2\alpha}n + \frac{4 \cdot p^{2\alpha} - 1}{3} \right) q^n \equiv 2f_1 \psi(q) \pmod{8},$$

(*ii*)
$$\overline{R}_{8}^{*}\left(8p^{2\alpha+1}(pn+r) + \frac{4 \cdot p^{2\alpha+2} - 1}{3}\right) \equiv 0 \pmod{8},$$

(*iii*)
$$\frac{1}{2} \overline{R}_8^*(16n+1) \equiv p(n) + \sum_{\nu=1}^\infty p\left(n - \frac{\nu(\nu+1)}{2}\right) \pmod{4}.$$

Proof. Extracting the terms involving q^{4n} from (3.36) and simplifying, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (8n+1) q^n \equiv 2 \frac{f_1 f_2^2}{f_1} \pmod{8}.$$
 (3.37)

Employing (2.3) in (3.37), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^*(8n+1)q^n \equiv 2f_1\psi(q) \pmod{8}.$$
(3.38)

which is the $\alpha = 0$ case of (i). Assume that (i) is true for some integer $\alpha \ge 0$. Using (2.6) in (2.7), we find that

$$\begin{split} &\sum_{n=0}^{\infty} \overline{R}_{8}^{*} \left(8p^{2\alpha}n + \frac{4 \cdot p^{2\alpha} - 1}{3} \right) q^{n} \\ &\equiv 2 \bigg[\sum_{\substack{k=-(p-1)/2\\k\neq(\pm p-1)/6}}^{(p-1)/2} (-1)^{k} q^{\frac{3k^{2}+k}{2}} F\left(-q^{(3p^{2}+(6k+1)p)/2}, -q^{(3p^{2}-(6k+1)p)/2} \right) + (-1)^{(\pm p-1)/6} q^{(p^{2}-1)/24} f_{p^{2}} \bigg] \\ &\times \bigg[\sum_{\substack{j=0\\j=0}}^{(p-3)/2} q^{(j^{2}+j)/2} F\left(q^{(p^{2}+(2j+1)p)/2}, q^{(p^{2}-(2j+1)p)/2} \right) + q^{(p^{2}-1)/8} \psi(q^{p^{2}}) \bigg] (\mod 8). \quad (3.39) \end{split}$$

Consider the congruence

$$\frac{(3k^2+k)}{2} + \frac{(j^2+j)}{2} \equiv \frac{4(p^2-1)}{24} \,(\text{mod}\,p),$$

which is equivalent to

$$(6k+1)^2 + 3(2j+1)^2 \equiv 0 \pmod{p}.$$

Since $\left(\frac{-3}{p}\right) = -1$, the above congruence has only solution $k = (\pm p - 1)/6$ and $j = (\pm p - 1)/2$. Therefore, extracting the terms involving $q^{pn+(p^2-1)/6}$ from both sides of

(3.39), dividing throughout by $q^{(p^2-1)/6}$ and then replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* \left(8p^{2\alpha+1}n + \frac{4p^{2\alpha+2} - 1}{3} \right) q^n \equiv 2f_p \psi(q^p) \pmod{8}.$$
(3.40)

Extracting the terms involving q^{pn} from (3.40) and replacing q^p by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* \left(8p^{2(\alpha+1)}n + \frac{4p^{2\alpha+2} - 1}{3} \right) q^n \equiv 2f_1 \psi(q) \pmod{8}, \tag{3.41}$$

which is $\alpha + 1$ case of (i). Thus, by induction the proof of (i) complete.

Extracting the terms involving q^{pn+r} , for $1 \leq r \leq p-1$, from both sides (3.40), we arrive at (ii).

Extracting the terms involving q^{16n+1} from (3.32), dividing by q and replacing q^4 by q, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_8^* (16n+1) q^n \equiv 2f_1^2 \equiv 2\frac{f_2^2}{f_1^2} \pmod{4}, \tag{3.42}$$

where we used (2.14) with p = 2.

Employing (1.1) and (2.3) in (3.42), we obtain

$$\frac{1}{2}\sum_{n=0}^{\infty}\overline{R}_{8}^{*}(16n+1)q^{n} \equiv \sum_{n=0}^{\infty}p(n)q^{n} + \sum_{\nu=0}^{\infty}p(n-\nu(\nu+1)/2)q^{n} \pmod{4}.$$
 (3.43)

Equating the coefficient of q^n on both sides of (3.43), we arrived at (iii).

Theorem 3.8. We have

(i)
$$\overline{R}^*_{\ell}(n) + \sum_{\nu=1} \overline{R}^*_{\ell}(n-\ell\nu)p(\nu) = \overline{p}(n),$$

(ii) $\overline{R}^*_2(n) = D_2(n).$

where $D_2(n)$ is the number of partitions of n into distinct parts such that each part has two copies.

Proof. From (1.7), we have

$$\sum_{n=0}^{\infty} \overline{R}_{\ell}^{*}(n)q^{n} = \frac{f_{2}f_{\ell}}{f_{1}^{2}}$$
(3.44)

Using (1.5) in (3.44), we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{\ell}^{*}(n)q^{n} \cdot \frac{1}{f_{\ell}} = \sum_{n=0}^{\infty} \overline{p}(n)q^{n}.$$
(3.45)

Employing (1.1) in (3.45)

$$\sum_{n=0}^{\infty} \overline{R}_{\ell}^{*}(n) q^{n} \left(1 + \sum_{\nu=1}^{\infty} p(\nu) q^{\ell\nu} \right) = \sum_{n=0}^{\infty} \overline{p}(n) q^{n}$$
(3.46)

Extracting the coefficient of q^n from both sides of (3.46), we arrive at (i).

Setting $\ell = 2$ in (3.44) and simplifying, we obtain

$$\sum_{n=0}^{\infty} \overline{R}_{\ell}^{*}(n) = \frac{f_{2}^{2}}{f_{1}^{2}} = (-q;q)_{\infty}^{2}.$$
(3.47)

Now (ii) follows immediately from (3.47).
