# A computational transition for detecting multivariate shuffled linear regression by low-degree polynomials

#### Abstract

In this paper, we study the problem of multivariate shuffled linear regression, where the correspondence between predictors and responses in a linear model is obfuscated by a latent permutation. Specifically, we investigate the model  $Y = \frac{1}{\sqrt{1+\sigma^2}}(\prod_* XQ_* + \sigma Z)$ , where X is an n \* d standard Gaussian design matrix, Z is an n \* m Gaussian noise matrix,  $\Pi_*$  is an unknown n \* n permutation matrix, and  $Q_*$  is an unknown d \* m on the Grassmanian manifold satisfying  $Q_*^{\top}Q_* = \mathbb{I}_m$ .

Consider the hypothesis testing problem of distinguishing this model from the case where X and Y are independent Gaussian random matrices of sizes n \* d and n \* m, respectively. Our results reveal a phase transition phenomenon in the performance of low-degree polynomial algorithms for this task. (1) When m = o(d), we show that all degree-D polynomials fail to distinguish these two models even when  $\sigma = 0$ , provided with  $D^4 = o(\frac{d}{m})$ . (2) When m = d and  $\sigma = \omega(1)$ , we show that all degree-D polynomials fail to distinguish these two models provided with  $D = o(\sigma)$ . (3) When m = d and  $\sigma = o(1)$ , we show that there exists a constant-degree polynomial that strongly distinguish these two models. These results establish a smooth transition in the effectiveness of low-degree polynomial algorithms for this problem, highlighting the interplay between the dimensions m and d, the noise level  $\sigma$ , and the computational complexity of the testing task.

## 1 Introduction

In this paper, we study the multivariate shuffled linear regression problem, which is rigorously defined as follows.

**Definition 1.1.** Consider the following linear model

$$Y = \frac{1}{\sqrt{1+\sigma^2}} \left( \Pi_* X Q_* + \sigma Z \right), \tag{1.1}$$

here  $X \in \mathbb{R}^{n*d}$  is the design matrix,  $Q_* \in \mathbb{R}^{d*m}$  is the unknown regression matrix,  $\Pi_*$  is an unknown permutation matrix that shuffles the rows of X, and  $Z \in \mathbb{R}^{n*m}$  is the observation noise. We focus on the Bayesian setting where  $X \in \mathbb{R}^{n*d}, Z \in \mathbb{R}^{n*m}$  are two independent random matrices with *i.i.d.* standard normal entries,  $\Pi_*$  is a uniform n \* n permutation matrix,  $Q_* \in \mathbb{R}^{d*m}$  is sampled from a prior distribution  $\nu$  supported on all d \* m matrices and  $X, Z, \Pi_*, Q_*$  are independent.

Two basic problems regarding this model are as follows: (1) the *detection* problem, i.e., testing this model against two independent Gaussian matrices; (2) the *estimation* problem, i.e., recovering  $\Pi_*$  and  $Q_*$  from the observations (X, Y). If  $\Pi_*$  is known, (1.1) reduces to standard linear regression. Otherwise, this problem is known as shuffled regression [PWC17, APZ17+, LWX24], unlabeled sensing [UHV18, ZSL22, ZL20], or linear regression with permuted/mismatched data [SBD19, MW23, SDL20], as the correspondence between the predictors (the rows of X) and the responses (the rows of Y) is lost. Thus, it is a significantly more challenging problem as one needs to jointly estimate the permutation  $\Pi_*$  and the regression coefficients  $Q_*$ . This problem has attracted considerable theoretical and practical interest due to its applications in areas such as robotics, data integration, and de-anonymization; for further details, we refer the readers to [UHV18, Section 1] and [ZL20, Section 1.1]. In this work we are interested in the algorithmic aspect of the detection problem, where the goal is to solve problem (1) using *efficient algorithms* (i.e., algorithms with polynomial running time). Our results can be informally summarized as follows:

**Theorem 1.2** (Informal). Suppose  $m \leq d$  and  $\nu$  is the Haar measure over the d \* m Grassmanian manifold  $\{Q \in \mathbb{R}^{d*m} : Q^{\top}Q = \mathbb{I}_m\}$ . Then the following results hold:

- (1) when m = o(d), there is evidence suggesting that all algorithms based on degree-D polynomials fails to distinguish (X, Y) with two independent Gaussian matrices even with  $\sigma = 0$ , provided that  $D^4 = o(\frac{d}{m})$ ;
- (2) when m = d and  $\sigma = \omega(1)$ , there is evidence suggesting that all algorithms based on degree-D polynomials fails to distinguish (X, Y) with two independent Gaussian matrices provided that  $D = o(\sigma)$ ;
- (3) when m = d and  $\sigma = o(1)$ , there is an efficient algorithm based on degree-O(1) polynomial that strongly distinguish (X, Y) with two independent Gaussian matrices.

**Remark 1.3.** In view of the widely accepted assumption that the failure of degree- $O(\log n)$  polynomials are evidences for computational hardness and the close connection between detection and estimation, we tend to feel that the estimation problem is computationally hard when  $d/m \ge \text{poly}(\log n)$  or when  $d = m, \sigma \ge \text{poly}(\log n)$ .

In addition, we note that in the in the literature the shuffled linear regression problem (1.1) is usually stated in the non-Bayesian setting, where  $Q_*$  is just an arbitrary unknown d \* m matrix. However, since in the singular value decomposition  $Q_* = U_*\Lambda_*V_*$  where  $V_* \in O(m)$  and  $\Lambda_*$  is an m\*m diagonal matrix, assuming  $V_*$  and  $\Lambda_*$  is known to us will only simplify the problem (note that we can replace the observation Y with  $YV_*^{\top}\Lambda_*^{-}$  where  $\Lambda_*^{-}$  is the pseudo-inverse of  $\Lambda_*$ ). Thus, our hardness result (1) covers the most widely studied non-Bayesian setting and suggests that estimation is hard in this setting in the similar parameter regime.

#### 1.1 Discussions

Information-computation gap and low-degree polynomial framework. A special case in our result is the single-variate setting m = 1, where  $Q_* \in \mathbb{R}^d$  is sampled uniformly from the unit sphere  $\mathbb{S}^{d-1}$ . In this setting, the authors of [LWX24] determined the information threshold for recovering  $\Pi_*$  given (X, Y) when d = o(n), which roughly speaking is  $\sigma = O(n^{-2})$  for exact recovery and  $\sigma = O(n^{-1})$  for almost-exact recovery. In addition, in a recent forthcoming work [GWX25+] the authors determined the information threshold for the detection problem up to a poly(d) factor when  $d = o(\frac{n}{\log n})$ , conjectured to be  $\sigma^2 = O(\frac{1}{d\log d})$ .<sup>1</sup> However, when  $d = \omega(\log n)$

On the other hand, for general  $d = o(\frac{n}{\log n})$ , detection is informationally possible if  $\sigma^2 = O(\frac{1}{(d \log d)^2})$  and informationally impossible if  $\sigma^2 = \omega(\frac{1}{d \log d})$ . They also conjecture that  $\sigma^2 = O(\frac{1}{d \log d})$  is the true information threshold for detection.

currently no known polynomial-time algorithms that solve the detection or estimation problem except in the noiseless case  $\sigma = 0$  [HSS17, AHSS17]. This suggests the presence of an *information*computation gap, a phenomenon commonly observed in high-dimensional statistical inference tasks [ZK16, RSS19, KWB22, Gam21]. Since at this point it seems rather elusive to prove hardness on the detection problem for a typical instance under the assumption of  $P \neq NP$ , we can only hope to prove hardness under even (much) stronger hypothesis.

For this purpose, the *low-degree polynomial framework* emerged as a powerful tool to provide *evidences* for computational lower bounds. Indeed, it has been proved that the class of low-degree polynomial algorithms is a useful proxy for computationally efficient algorithms, in the sense that the best-known polynomial-time algorithms for a wide variety of high-dimensional inference problems are captured by the low-degree class such as spectral methods, approximate message passing and small subgraph counts; see e.g., [Hop18, SW22, KWB22]. Furthermore, it is conjectured in [Hop18] that the failure of degree-D polynomial algorithms implies the failure of all "robust" algorithms with running time  $n^{\tilde{O}(D)}$  (here  $\tilde{O}$  means having at most this order up to a poly(log n) factor). Consequently, the failure of degree- $O(\text{poly}(\log n))$  polynomial algorithms to solve a problem is often interpreted as evidence of its intrinsic average-case hardness, or at least it is expected that breaking such impossibility results would require a major breakthrough in algorithms. Thus, our results provide further evidence supporting the existence of an information-computation gap in this problem when  $d \geq \text{poly}(\log n)$ .

Lattice-based algorithm "beats" low-degree polynomials. Although in the high-dimensional single-variate case  $m = 1, d = \text{poly}(\log n)$  we provide evidence that all algorithms based on low-degree polynomials fail to achieve the detection task even in the noiseless case  $\sigma = 0$ , we note that there is a lattice-based polynomial-time algorithm solving the detection and estimation tasks when  $\sigma = 0$  [HSS17, AHSS17]. Thus, the shuffled regression problem is a rare example where a lattice-based algorithm outperforms the family of low-degree polynomial algorithms. A similar phenomenon has been observed in the problem of clustering a variant of Gaussian mixtures, as discovered in [ZSWB22].

However, as discussed in [ZSWB22], this phenomenon does not necessary contradict the lowdegree conjecture proposed in [Hop18]. Indeed, the lattice-based algorithms in both [ZSWB22] and [HSS17, AHSS17] are highly sensitive to the specifics of the model, and rely on the observations being "noiseless" in some sense. In fact, these algorithms appear to fail as long as the noise level satisfies  $\sigma = \exp(-\operatorname{poly}(n))$ . Thus, we tend to feel that our low-degree hardness result actually suggests that all "robust" algorithms fail to solve the *noisy* detection/estimation problem even when the noise  $\sigma$  is polynomially small.

**Procrustes matching and geometric graph matching.** Another special case in our results which may be of particular interest is the setting where m = d and  $Q_*$  is uniformly sampled from the family of d\*d orthogonal matrices. This problem, known as *Procrustes matching*, has numerous applications in fields such as natural language processing and computer vision [RCB97, MDK+16, DL17, GJB19].

In addition, it was shown in [WWXY22] that this problem is further equivalent to a geometric variant of the random graph matching problems [WWXY22, GL24+, EGMM24]. More precisely, consider the Gaussian model

$$Y = \Pi_* X + \sigma Z$$
, where  $X, Y, Z \in \mathbb{R}^{n*d}$ 

such that  $X_i, Z_i$  being i.i.d.  $\mathcal{N}(0, \mathbb{I}_d)$  vectors. The observation is two correlated Wishart matrices  $A = XX^{\top}$  and  $B = YY^{\top}$ . In the low-dimensional regime where  $d = O(\log n)$ , the information

threshold for estimating  $\Pi_*$  was determined in [WWXY22] and an efficient algorithm approaching the information threshold up to a poly(d) factor was found in [GL24+]. In contrast, the related detection problem was less understood, especially in the high-dimensional regime  $d = \omega(\log n)$ . Our work shows the computation transition phenomenon for this detection problem under the lowdegree polynomial framework, suggesting that (roughly speaking)  $\sigma = O(1)$  is the separation of the computational "easy" and "hard" regime.

**Open problems.** While we have characterized the computation transition for low-degree polynomial algorithms in the detection problem, the information-theoretic threshold for this detection problem in multivariate case remains largely open. In the forthcoming work [GWX25+], inspired by the analysis of the broken sample problem [DCK20, KN22, JWX25+] the authors shows that in the single-variate case, the detection threshold is given by  $\sigma^2 = O(\frac{1}{d \log d})$  when  $d = o(\frac{\log n}{\log \log n})$  and it lies in the range  $O(\frac{1}{d^2(\log d)^2}) \ll \sigma^2 \ll O(\frac{1}{d \log d})$  when  $\frac{\log n}{\log \log n} \ll d \ll \frac{n}{\log n}$ . Extending these results to the multivariate setting presents an intriguing open problem.

Another interesting question left open by our work is whether we could provide stronger evidence on the information-computation gaps emerged in this detection problem when  $d/m \ge \text{poly}(\log n)$ . For instance, it would be interesting if we could establish the sum-of-squares lower bound [GJJ+20, JPRX23] or statistical query (SQ) lower bound [BBH+21, DKPZ23] for this problem. In addition, we note that in the problem of clustering a variant of Gaussian mixtures mentioned above, the hardness of the noisy problem can be shown by reducing to the standard assumption [MR09, Conjecture 1.2] from lattice-based cryptography that certain worst-case lattice problems are hard against quantum algorithms [BRST21]. However, it remains unclear whether similar reductions exist for our problem.

#### 1.2 Notations

We record in this subsection some notation conventions. Denote  $\mu$  to be the uniform distribution over the set of all permutation matrices  $\mathfrak{S}_n$  and denote  $\nu$  to be the Haar distribution over the d \* mGrassmanian manifold. In addition, let  $\mathbb{S}^{d-1}$  be the unit *d*-dimensional sphere. For a matrix or a vector M, we will use  $M^{\top}$  to denote its transpose. Denote O(m) to be the set of all m \* m orthogonal matrices. For a k \* k matrix  $M = (m_{ij})_{k*k}$ , let det(M) and tr(M) be the determinant and trace of M, respectively. Denote  $M \succ 0$  if M is positive definite and  $M \succeq 0$  if M is semi-positive definite. In addition, if M is symmetric we let  $\varsigma_1(M) \ge \varsigma_2(M) \ge \ldots \ge \varsigma_k(M)$  be the eigenvalues of M. Denote by rank(M) the rank of the matrix M. For two k \* l matrices  $M_1$  and  $M_2$ , we define their inner product to be

$$\langle M_1, M_2 \rangle := \sum_{i=1}^k \sum_{j=1}^l M_1(i,j) M_2(i,j).$$

We also define the Frobenius norm, operator norm, and  $\infty$ -norm of M respectively by

$$\|M\|_{\mathbf{F}} = \operatorname{tr}(MM^{\top}) = \langle M, M \rangle^{\frac{1}{2}}, \ \|M\|_{\operatorname{op}} = \varsigma_1(MM^{\top})^{\frac{1}{2}}, \ \|M\|_{\infty} = \max_{\substack{1 \le i \le k \\ 1 \le j \le l}} |M_{i,j}|$$

where  $\operatorname{tr}(\cdot)$  is the trace for a squared matrix. We will use  $\mathbb{I}_k$  to denote the k \* k identity matrix (and we drop the subscript if the dimension is clear from the context). Similarly, we denote  $\mathbb{O}_{k*l}$ the k \* l zero matrix and denote  $\mathbb{J}_{k*l}$  the k \* l matrix with all entries being 1. We will abbreviate  $\mathbb{O}_k = \mathbb{O}_{k*1}$  and  $\mathbb{J}_k = \mathbb{J}_{k*1}$ . The indicator function of sets A is denoted by  $\mathbf{1}_A$ . For any  $\alpha = (\alpha_1, \ldots, \alpha_k) \in \mathbb{N}^k$ , define  $|\alpha| = \sum_{1 \leq i \leq k} \alpha_i$  and  $\alpha! = \alpha_1! \ldots \alpha_k!$ . In addition, for any  $c \in \mathbb{N}$  and  $x \in \mathbb{R}^k$ , define  $c\alpha = (c\alpha_1, \ldots, c\alpha_k)$  and  $x^{\alpha} = x_1^{\alpha_1} \ldots x_k^{\alpha_k}$ . For  $m \in \mathbb{N}$  and  $\alpha \in \mathbb{N}^k$  with  $|\alpha| = m$ , denote  $\binom{m}{\alpha} = \frac{m!}{\alpha_1! \ldots \alpha_d!}$ . We denote  $A \in (\mathbb{N}^k)^{\otimes n}$ , if  $A = (\alpha_i : i \in [n])$  such that  $\alpha_i \in \mathbb{N}^k$ . For two  $A, A' \in (\mathbb{N}^k)^{\otimes n}$  with  $A = (\alpha_i : i \in [n])$  and  $A' = (\alpha'_i : i \in [n])$ , we say  $A \cong A'$  if and only if there exists a bijection  $\pi : [n] \to [n]$  such that  $\alpha_i = \alpha'_{\pi(i)}$  for all  $i \in [n]$ . Denote Aut(A) to be the number of bijections  $\pi : [n] \to [n]$  such that  $\alpha_i = \alpha_{\pi(i)}$  for all  $i \in [n]$ . For a set A, we use both |A| and #A to denote its cardinality.

For any two positive sequences  $\{a_n\}$  and  $\{b_n\}$ , we write equivalently  $a_n = O(b_n)$ ,  $b_n = \Omega(a_n)$ ,  $a_n \leq b_n$  and  $b_n \geq a_n$  if there exists a positive absolute constant c such that  $a_n/b_n \leq c$  holds for all n. We write  $a_n = o(b_n)$ ,  $b_n = \omega(a_n)$ ,  $a_n \ll b_n$ , and  $b_n \gg a_n$  if  $a_n/b_n \to 0$  as  $n \to \infty$ . We write  $a_n = \Theta(b_n)$  if both  $a_n = O(b_n)$  and  $a_b = \Omega(b_n)$  hold.

# 2 The low-degree polynomial framework

In this section we provide the formal statement of Theorem 1.2. More precisely, we will consider the following hypothesis testing problem, where

- under the null hypothesis  $\mathcal{H}_0$ , we let  $X \in \mathbb{R}^{n*d}$  and  $Y \in \mathbb{R}^{n*m}$  be two independent Gaussian matrices with i.i.d. standard normal entries, respectively;
- under the alternative hypothesis  $\mathcal{H}_1$ , we let  $(X, Z, \Pi_*, Q_*)$  be independent random matrices with  $X \in \mathbb{R}^{n*d}, Z \in \mathbb{R}^{n*m}$  having i.i.d. standard normal entries,  $\Pi_*$  an n\*n uniform permutation matrix and  $Q_*$  sampled from  $\nu$ , and let  $Y = \frac{1}{\sqrt{1+\sigma^2}}(\Pi_*XQ_* + \sigma Z)$ .

We establish evidences the computational hardness of this hypothesis testing problem by focusing on a specific class of algorithms known as *low-degree polynomials*. Inspired by the sum-of-squares hierarchy, the low-degree polynomial method offers a promising approach for deriving computational lower bounds in high-dimensional inference problems. At its core, this method analyzes algorithms that rely on evaluating collections of polynomials with moderate degrees. The study of this category of algorithms is motivated by the examination of high-dimensional hypothesis testing problems [BHK+19, Hop18, HKP+17, HS17], with an extensive overview provided in [KWB22]. A key strength of the low-degree polynomial approach is its ability to deliver tight hardness results for a wide range of problems. Notable examples include detection problems such as planted clique, planted dense subgraph, community detection, sparse PCA, correlated random graphs (see [HS17, HKP+17, Hop18, KWB22, SW22, DMW23+, BKW20, DKW+22, MW25, DDL23+, KMW24, CDGL24+]), optimization problems such as maximal independent sets in sparse random graphs [GJW20, Wein22], and constraint satisfaction problems such as random k-SAT [BH22]. In the remaining of this paper, we will focus on applying this framework in the context of hypothesis testing problems.

More precisely, denote  $\mathbb{P} = \mathbb{P}_n$  to be the law of (X, Y) under  $\mathcal{H}_1$  and  $\mathbb{Q} = \mathbb{Q}_n$  to be the law of (X, Y) under  $\mathcal{H}_0$ . In addition, let  $\mathbb{R}[X, Y]_{\leq D}$  denote the set of multivariate polynomials in the entries of (X, Y) with degree at most D. With a slight abuse of notation, we will often say "a polynomial" to mean a sequence of polynomials  $f = f_n \in \mathbb{R}[X, Y]_{\leq D}$ , one for each problem size n; the degree  $D = D_n$  of such a polynomial may scale with n. To probe the computational threshold for testing between two sequences of probability measures  $\mathbb{P}$  and  $\mathbb{Q}$ , we consider the following notions of strong separation and weak separation defined in [BAH+22, Definition 1.6].

**Definition 2.1.** Let  $f \in \mathbb{R}[X, Y]_{\leq D}$  be a polynomial.

• We say f strongly separates  $\mathbb{P}_n$  and  $\mathbb{Q}_n$  if as  $n \to \infty$ 

$$\sqrt{\max\left\{\operatorname{Var}_{\mathbb{P}}(f(A,B)),\operatorname{Var}_{\mathbb{Q}}(f(A,B))\right\}} = o\left(\left|\mathbb{E}_{\mathbb{P}}[f(A,B)] - \mathbb{E}_{\mathbb{Q}}[f(A,B)]\right|\right)$$

• We say f weakly separates  $\mathbb{P}_n$  and  $\mathbb{Q}_n$  if as  $n \to \infty$ 

$$\sqrt{\max\left\{\operatorname{Var}_{\mathbb{P}}(f(A,B)),\operatorname{Var}_{\mathbb{Q}}(f(A,B))\right\}} = O\left(\left|\mathbb{E}_{\mathbb{P}}[f(A,B)] - \mathbb{E}_{\mathbb{Q}}[f(A,B)]\right|\right).$$

See [BAH+22] for a detailed discussion of why these conditions are natural for hypothesis testing. In particular, according to Chebyshev's inequality, strong separation implies that we can threshold f(A, B) to test  $\mathbb{P}$  against  $\mathbb{Q}$  with vanishing type-I and type-II errors. Now we can state our rigorous statement justifying Theorem 1.2.

- **Theorem 2.2.** (1) Suppose  $1 \le m = o(d)$  and  $D^4 = o(\frac{d}{m})$ . Then no degree-*D* polynomial weakly separates  $\mathbb{P}$  and  $\mathbb{Q}$ .
  - (2) Suppose  $m = d, \sigma = \omega(1)$  and  $D = o(\sigma^{-1})$ . Then no degree-D polynomial weakly separates  $\mathbb{P}$  and  $\mathbb{Q}$ .
  - (3) Suppose m = d and  $\sigma = o(1)$ . Then there is a degree-O(1) polynomial that strongly separates  $\mathbb{P}$  and  $\mathbb{Q}$ .

# 3 Proof of Theorem 2.2

In this section we prove Theorem 2.2 formally. In Subsection 3.1 we provide a universal bound for the low-degree advantage between  $\mathbb{P}$  and  $\mathbb{Q}$  for all  $d, m \in \mathbb{N}$ . In Subsections 3.2 we prove Item (1) in the single-variate as preparations. In Subsections 3.3, 3.4 and 3.5 we prove Items (1), (2) and (3) in Theorem 2.2 respectively.

#### 3.1 Universal bound on low-degree advantage

We begin with the classical framework for proving the failure of weak separation of polynomials, as introduced in [HS17].

**Definition 3.1.** For a quadruple (n, d, m, D) with d, m, D possibly depend on n, we define the low-degree advantage by

$$\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q}) := \sup_{f \in \mathbb{R}[X, Y]_{\leq D}} \frac{\mathbb{E}_{\mathbb{P}}[f]}{\sqrt{\mathbb{E}_{\mathbb{Q}}[f^2]}}.$$
(3.1)

It is clear (see [BAH+22, Definition 1.8]) that  $\operatorname{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q}) = 1 + o(1)$  as  $n \to \infty$  implies that no polynomial in  $\mathbb{R}[X,Y]_{\leq D}$  weakly separates  $\mathbb{P}$  and  $\mathbb{Q}$ .

The rest of this section is devoted to proving  $\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q}) = 1 + o(1)$  under various settings. The following polynomials will play a fundamental role in our analysis.

**Definition 3.2.** For all  $m \in \mathbb{N}$ , define the Hermite polynomials by

$$H_0(z) = 1$$
,  $H_1(z) = z$ ,  $H_{m+1}(z) = zH_m(z) - mH_{m-1}(z)$ . (3.2)

In addition, define  $\mathcal{H}_m(z) = \frac{1}{\sqrt{m!}} H_m(z)$ , and for all  $x \in \mathbb{R}^d$  and  $\alpha \in \mathbb{N}^d$  define

$$\mathcal{H}_{\alpha}(x) := \prod_{i=1}^{d} \mathcal{H}_{\alpha_i}(x_i) \,. \tag{3.3}$$

For all  $y \in \mathbb{R}^m$  and  $\beta \in \mathbb{N}^m$ , define  $\mathcal{H}_{\beta}(y)$  in the similar manner. For all  $\mathsf{A} = (\alpha_i : i \in [n]) \Subset (\mathbb{N}^d)^{\otimes n}$ and  $\mathsf{B} = (\beta_j : j \in [n]) \Subset (\mathbb{N}^m)^{\otimes n}$  such that  $\alpha_i \in \mathbb{N}^d, \beta_j \in \mathbb{N}^m$ , define

$$\phi_{\mathsf{A},\mathsf{B}}(X,Y) = \prod_{1 \le i \le n} \mathcal{H}_{\alpha_i}(X_i) \prod_{1 \le j \le n} \mathcal{H}_{\beta_j}(Y_j) \,. \tag{3.4}$$

Define  $|\mathsf{A}| = \sum_{1 \le i \le n} |\alpha_i|$  and  $|\mathsf{B}| = \sum_{1 \le j \le n} |\beta_j|$ . It is well known (see, e.g., [Sze39]) that  $\{\phi_{\mathsf{A},\mathsf{B}} : |\mathsf{A}| + |\mathsf{B}| \le D\}$  forms a standard orthogonal basis of  $\mathbb{R}[X,Y]_{\le D}$  under the measure  $\mathbb{Q}$ , i.e., we have

$$\mathbb{E}_{\mathbb{Q}}\left[\phi_{\mathsf{A},\mathsf{B}}\phi_{\mathsf{A}',\mathsf{B}'}\right] = \mathbf{1}_{\{(\mathsf{A},\mathsf{B})=(\mathsf{A}',\mathsf{B}')\}}.$$
(3.5)

Consequently, we can explicitly express the low-degree advantage  $\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q})$  in terms of this basis, as in the next lemma.

**Lemma 3.3.** Recall (3.1). For any  $n, D \ge 1$ , it holds that

$$\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q}) = \left(\sum_{(\mathsf{A},\mathsf{B}):|\mathsf{A}|+|\mathsf{B}|\leq D} \mathbb{E}_{\mathbb{P}} \left[\phi_{\mathsf{A},\mathsf{B}}(X,Y)\right]^2\right)^{1/2}.$$
(3.6)

*Proof.* For any  $f \in \mathbb{R}[X, Y]_{\leq D}$ , it can be uniquely expressed as

$$f = \sum_{(\mathsf{A},\mathsf{B}):|\mathsf{A}|+|\mathsf{B}| \le D} C_{\mathsf{A},\mathsf{B}} \phi_{\mathsf{A},\mathsf{B}} \,,$$

where  $C_{A,B}$ 's are real constants. Applying Cauchy-Schwartz inequality one gets

$$\frac{\mathbb{E}_{\mathbb{P}}[f]}{\sqrt{\mathbb{E}_{\mathbb{Q}}[f^2]}} = \frac{\sum_{(\mathsf{A},\mathsf{B}):|\mathsf{A}|+|\mathsf{B}| \le D} C_{\mathsf{A},\mathsf{B}} \mathbb{E}_{\mathbb{P}}[\phi_{\mathsf{A},\mathsf{B}}]}{\sqrt{\sum_{(\mathsf{A},\mathsf{B}):|\mathsf{A}|+|\mathsf{B}| \le D} C_{\mathsf{A},\mathsf{B}}^2}} \le \left(\sum_{(\mathsf{A},\mathsf{B}):|\mathsf{A}|+|\mathsf{B}| \le D} \left(\mathbb{E}_{\mathbb{P}}[\phi_{\mathsf{A},\mathsf{B}}]\right)^2\right)^{1/2},$$

with equality holds if and only if  $C_{\mathsf{A},\mathsf{B}} \propto \mathbb{E}_{\mathbb{P}}[\phi_{\mathsf{A},\mathsf{B}}]$ .

The rest part of this section is devoted to bounding the right hand side of (3.6) under various assumptions in Theorem 2.2. For  $\alpha \in \mathbb{N}^d$ ,  $\beta \in \mathbb{N}^m$  and  $Q \in \mathbb{R}^{d*m}$ , denote

$$\Lambda_{\alpha,\beta}(Q) := \mathbb{E}_U \Big[ \mathcal{H}_\alpha(U) \mathcal{H}_\beta(\frac{1}{\sqrt{1+\sigma^2}}(UQ + \sigma V)) \Big], \text{ where } U \perp V \text{ and } U, V \sim \mathcal{N}(0, \mathbb{I}_d).$$
(3.7)

We first bound the right hand side of (3.6) by  $\Lambda_{\alpha,\beta}(Q)$ 's.

Lemma 3.4. We have

$$\sum_{|\mathsf{A}|+|\mathsf{B}|\leq D} \mathbb{E}_{\mathbb{P}} \left[ \phi_{\mathsf{A},\mathsf{B}}(X,Y) \right]^2 \leq \sum_{\substack{0\leq k\leq D}} \sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m\\0<|\alpha_i|,|\beta_j|\leq D}} \mathbb{E}_{Q\sim\nu} \left[ \prod_{1\leq i\leq k} \Lambda_{\alpha_i,\beta_i}(Q) \right]^2.$$
(3.8)

*Proof.* For all  $A \in (\mathbb{N}^m)^{\otimes n}$  and  $B \in (\mathbb{N}^d)^{\otimes n}$ , we can characterize (A, B) with two subsets  $S, K \subset [n]$ and two ordered families of integer vectors  $(\alpha_1, \ldots, \alpha_{|S|}), (\beta_1, \ldots, \beta_{|K|})$  where  $\alpha_i \in \mathbb{N}^d, \beta_j \in \mathbb{N}^m$  and  $\alpha_i \neq \mathbb{O}_d$  and  $\beta_j \neq \mathbb{O}_m$ . Also denote  $\mathbb{P}_{\pi} = \mathbb{P}(\cdot \mid \pi_* = \pi)$ . Note that when  $\pi(S) \neq K$ , suppose that there exists  $j \in S \setminus \pi^{-1}(K)$ , then

$$\mathbb{E}_{\mathbb{P}_{\pi}} \big[ \phi_{\mathsf{A},\mathsf{B}} \big] = \mathbb{E}_{Q \sim \nu, X_{i} \sim \mathcal{N}(0, \mathbb{I}_{d})} \Big[ \prod_{1 \leq i \leq n} \mathcal{H}_{\alpha_{i}}(X_{i}) \mathcal{H}_{\beta_{i}}(X_{i}Q) \Big] \\ = \mathbb{E}_{Q \sim \nu} \bigg[ \mathbb{E}_{X} \Big[ \mathcal{H}_{\alpha_{j}}(X_{j}) \Big] \mathbb{E}_{X} \Big[ \prod_{i \neq j} \mathcal{H}_{\alpha_{i}}(X_{i}) \mathcal{H}_{\beta_{i}}(X_{i}Q) \Big] \bigg] = 0 \,.$$

Similarly, when there exists  $j \in K \setminus \pi(S)$  we can check that  $\mathbb{E}_{\mathbb{P}_{\pi}}[\phi_{\mathsf{A},\mathsf{B}}] = 0$ . If  $\pi(S) = K$ , let  $\sigma$  to be the restriction of  $\pi$  on S, we then have

$$\mathbb{E}_{\mathbb{P}_{\pi}} \big[ \phi_{\mathsf{A},\mathsf{B}} \mid Q \big] = \prod_{1 \leq i \leq |S|} \Lambda_{\alpha_{i},\beta_{\sigma(i)}}(Q) \,.$$

Thus, we have shown that

$$\mathbb{E}_{\mathbb{P}}[\phi_{\mathsf{A},\mathsf{B}}] = \begin{cases} 0, & |S| \neq |K|;\\ \frac{(n-k)!}{n!} \sum_{\sigma \in \mathfrak{S}_k} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i,\beta_{\sigma(i)}}(Q) \Big], & |S| = |K| = k \end{cases}$$

Thus, we have the left hand side of (3.8) is bounded by

$$\sum_{\substack{0 \le k \le D \\ |S| = |K| = k}} \sum_{\substack{\alpha_1, \dots, \alpha_k \in \mathbb{N}^d \\ \beta_1, \dots, \beta_k \in \mathbb{N}^m \\ 0 < |\alpha_i|, |\beta_j| \le D}} \left( \frac{(n-k)!}{n!} \sum_{\sigma \in \mathfrak{S}_k} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i, \beta_{\sigma(i)}}(Q) \Big] \Big)^2$$

$$\leq \sum_{\substack{0 \le k \le D \\ \beta_1, \dots, \beta_k \in \mathbb{N}^m \\ 0 < |\alpha_i|, |\beta_j| \le D}} \left( \frac{1}{k!} \sum_{\sigma \in \mathfrak{S}_k} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i, \beta_{\sigma(i)}}(Q) \Big] \right)^2.$$
(3.9)

2

Using Cauchy-Schwartz inequality, we have (3.9) is bounded by

$$\sum_{\substack{0 \le k \le D \\ \beta_1, \dots, \beta_k \in \mathbb{N}^m \\ 0 < |\alpha_i|, |\beta_j| \le D}} \sum_{\substack{\alpha_1, \dots, \alpha_k \in \mathbb{N}^d \\ 0 < |\alpha_i|, |\beta_j| \le D}} \frac{1}{k!} \sum_{\sigma \in \mathfrak{S}_k} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i, \beta_i(Q)}(Q) \Big]$$
$$= \sum_{\substack{0 \le k \le D \\ \beta_1, \dots, \beta_k \in \mathbb{N}^m \\ 0 < |\alpha_i|, |\beta_i| \le D}} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i, \beta_i}(Q) \Big]^2,$$

where in equality we use that fix any  $\sigma \in \mathfrak{S}_k$  there is a one-to-one correspondence between  $(\beta_1, \ldots, \beta_k)$  and  $(\beta_{\sigma(1)}, \ldots, \beta_{\sigma(k)})$ . This completes our proof.

#### **3.2** Proof of Item (1) in single-variate case

To get a feeling on how we bound the right hand side of (3.8), we first prove Item (1) of Theorem 2.2 in single-variate case (with a milder assumption on D)

$$m = 1, \sigma = 0, D^6 = o(d).$$

Based on Lemma 3.4, we see that

$$\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q})^2 \leq \sum_{\substack{0 \leq k \leq D \\ \beta_1, \dots, \beta_k \in \mathbb{N} \\ 0 < |\alpha_i|, |\beta_j| \leq D}} \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \leq i \leq k} \Lambda_{\alpha_i, \beta_i}(Q) \Big]^2,$$
(3.10)

where

$$\Lambda_{\alpha,\beta}(Q) = \mathbb{E}_{U \sim \mathcal{N}(0,\mathbb{I}_d)} \Big[ \mathcal{H}_{\alpha}(U) \mathcal{H}_{\beta}(\langle U, Q \rangle) \Big] \,.$$

In this case, we can calculate  $\Lambda_{\alpha,\beta}(Q)$  for each  $\alpha \in \mathbb{N}^d$  and  $\beta \in \mathbb{N}$  directly, as incorporated in the next lemma.

Lemma 3.5. We have

$$\Lambda_{\alpha,\beta}(Q) = \mathbf{1}_{\{|\alpha|=\beta\}} \cdot \mathfrak{M}(\alpha;\beta)Q^{\alpha}, \qquad (3.11)$$

where

$$\mathfrak{M}(\alpha;\beta) = \sqrt{\frac{\alpha!}{\beta!}} \cdot \begin{pmatrix} \beta \\ \alpha \end{pmatrix}.$$
(3.12)

*Proof.* By direct calculation, we have that

$$\begin{split} \Lambda_{\alpha,\beta}(Q) &\stackrel{\text{Lemma A.1}}{=} \sum_{\gamma \in \mathbb{N}^d : |\gamma| = \beta} \mathfrak{M}(\gamma;\beta) \mathbb{E}_{U \sim \mathcal{N}(0,\mathbb{I}_d)} \Big[ Q^{\gamma} \cdot \mathcal{H}_{\gamma}(U) \mathcal{H}_{\alpha}(U) \Big] \\ &= \sum_{\gamma \in \mathbb{N}^d : |\gamma| = \beta} \mathbf{1}_{\{\gamma = \alpha\}} \cdot \mathfrak{M}(\gamma;\beta) Q^{\gamma} = \mathbf{1}_{\{|\alpha| = \beta\}} \cdot \mathfrak{M}(\alpha;\beta) Q^{\alpha} \,, \end{split}$$

as desired.

We can now finish the proof of Theorem 2.2, Item (1).

Proof of Theorem 2.2, Item (1). Using Lemma 3.5, we get that

$$\sum_{\substack{\alpha_1,\ldots,\alpha_k\in\mathbb{N}^d;\beta_1,\ldots,\beta_k\in\mathbb{N}}\\0<|\alpha_i|,|\beta_j|\leq D}} \mathbb{E}_{Q\sim\nu} \Big[\prod_{1\leq i\leq k} \Lambda_{\alpha_i,\beta_i}(Q)\Big]^2$$

$$= \sum_{\substack{\alpha_1,\ldots,\alpha_k\in\mathbb{N}^d;\beta_1,\ldots,\beta_k\in\mathbb{N}\\0<|\alpha_i|,|\beta_j|\leq D}} \mathbb{E}_{Q\sim\nu} \Big[\prod_{1\leq i\leq k} \left(\mathbf{1}_{\{|\alpha_i|=\beta_i\}}\cdot\mathfrak{M}(\alpha_i;\beta_i)Q^{\alpha_i}\right)\Big]^2$$

$$= \sum_{\substack{\alpha_1,\ldots,\alpha_k\in\mathbb{N}^d\\\alpha_i\neq\mathbb{O}_d,|\alpha_i|\leq D}} \mathfrak{M}(\alpha_1;|\alpha_1|)^2\ldots\mathfrak{M}(\alpha_k;|\alpha_k|)^2 \mathbb{E}_{Q\sim\nu} \Big[Q^{\alpha_1+\ldots+\alpha_k}\Big]^2$$

$$\stackrel{(\mathbf{3}.12)}{\leq} \sum_{\gamma\neq\mathbb{O}_d,|\gamma|\leq D} \mathbb{E}_{Q\sim\nu} \Big[Q^{\gamma}\Big]^2 \sum_{\substack{\alpha_1+\ldots+\alpha_k=\gamma\\\alpha_i\neq0,|\alpha_i|\leq D}} \binom{|\alpha_1|}{\alpha_1}\ldots\binom{|\alpha_k|}{\alpha_k}.$$
(3.13)

Using Lemma A.4, we see that

$$(3.13) = \sum_{\gamma \neq \mathbb{O}_d, |\gamma| \le D/2} \mathbb{E}_{Q \sim \nu} \left[ Q^{2\gamma} \right]^2 \sum_{\substack{\alpha_1 + \ldots + \alpha_k = 2\gamma \\ \alpha_i \neq \mathbb{O}_d, |\alpha_i| \le D}} \binom{|\alpha_1|}{\alpha_1} \dots \binom{|\alpha_k|}{\alpha_k}$$
$$= \sum_{\gamma \neq \mathbb{O}_d, |\gamma| \le D/2} \left( \frac{\Gamma(\frac{d}{2})(2\gamma_1 - 1)!! \dots (2\gamma_d - 1)!!}{\Gamma(\frac{d}{2} + \gamma_1 + \dots + \gamma_d) 2^{\gamma_1 + \dots + \gamma_d}} \right)^2 \sum_{\substack{\alpha_1 + \ldots + \alpha_k = 2\gamma \\ \alpha_i \neq \mathbb{O}_d, |\alpha_i| \le D}} \binom{|\alpha_1|}{\alpha_1} \dots \binom{|\alpha_k|}{\alpha_k}$$
$$\leq \sum_{\gamma \neq \mathbb{O}_d, |\gamma| \le D/2} d^{-2|\gamma|} D^{2|\gamma|} \sum_{\substack{\alpha_1 + \ldots + \alpha_k = 2\gamma \\ \alpha_i \neq \mathbb{O}_d, |\alpha_i| \le D}} \binom{|\alpha_1|}{\alpha_1} \dots \binom{|\alpha_k|}{\alpha_k}, \qquad (3.14)$$

where the inequality follows from

$$\left((2\gamma_1-1)!!\dots(2\gamma_d-1)!!\right)^2 \le D^{2(\gamma_1+\dots+\gamma_d)} = D^{2|\gamma|}$$

for  $|\gamma| \leq D/2$ . In addition, we have that

$$\sum_{\substack{\alpha_1+\ldots+\alpha_k=2\gamma\\\alpha_i\neq\mathbb{O}_d, |\alpha_i|\leq D}} \binom{|\alpha_1|}{\alpha_1} \dots \binom{|\alpha_k|}{\alpha_k} \leq \sum_{\substack{\alpha_1+\ldots+\alpha_k=2\gamma\\\alpha_i\neq\mathbb{O}_d, |\alpha_i|\leq D}} |\alpha_1|! \dots |\alpha_k|!$$
$$\leq D^{|\alpha_1|+\ldots+|\alpha_k|} \cdot \#\{\alpha_1+\ldots+\alpha_k=2\gamma: \alpha_i\neq\mathbb{O}_d, |\alpha_i|\leq D\}$$
$$\leq D^{2|\gamma|} \cdot k^{2|\gamma|}.$$

Plugging this estimation into (3.14), we get that

$$(3.14) \leq \sum_{\gamma \neq \mathbb{O}_{d}, |\gamma| \leq D/2} d^{-2|\gamma|} (D^{4}k^{2})^{|\gamma|} \leq \sum_{k=1}^{D/2} d^{-2k} (D^{4}k^{2})^{k} \cdot \# \{ \gamma \neq \mathbb{O}_{d} : |\gamma| = k \}$$
  
$$\leq \sum_{k=1}^{D/2} d^{-2k} (D^{4}k^{2})^{k} \cdot {d+k \choose k} \leq \sum_{k=1}^{D/2} d^{-k} (D^{4}k)^{k} = [1+o(1)] \cdot \frac{D^{4}k}{d},$$

where the last transition follows from  $D^4k \leq D^5 = o(d)$ . Thus, we get from (3.10) that

$$\mathsf{Adv}_{\leq D}(\mathbb{P}, \mathbb{Q})^2 \leq 1 + \sum_{1 \leq k \leq D/2} [1 + o(1)] \cdot \frac{D^4 k}{d} = [1 + o(1)] \cdot \frac{D^6}{d} = 1 + o(1) \,,$$

as desired.

## 3.3 Proof of Item (1) for general dimensions

In this subsection we extend our argument to the general case that  $1 \le m = o(d)$  and  $D^4 = o(\frac{d}{m})$ . Still, based on (3.8), it suffices to show that for  $1 \le k \le D$  we have

$$\sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d\setminus\{\mathbb{O}_d\}, |\alpha_i|\leq D\\ (\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m\setminus\{\mathbb{O}_m\}, |\beta_i|\leq D}} \mathbb{E}_{Q\sim\nu} \left[\prod_{1\leq i\leq k} \Lambda_{\alpha_i,\beta_i}(Q)\right]^2 = o(D^{-1}).$$
(3.15)

However, in this case in seems rather complicate to calculate  $\Lambda_{\alpha,\beta}(Q)$  directly. Thus, we will take an alternative approach by first relating the the left hand side of (3.15) to an relatively easier hypothesis testing problems.

**Definition 3.6.** Consider the following hypothesis testing problem, where our observation are two vectors  $X = (X_1, \ldots, X_k)^\top \in \mathbb{R}^{k*d}, Y = (Y_1, \ldots, Y_k)^\top \in \mathbb{R}^{k*m}$  such that:

- under the null hypothesis  $\overline{\mathcal{H}}_0$ , we sample  $X_i \sim \mathcal{N}(0, \mathbb{I}_d)$  and  $Y_i \sim \mathcal{N}(0, \mathbb{I}_m)$  independently.
- under the alternative hypothesis  $\overline{\mathcal{H}}_1$ , we first sample  $X_1, \ldots, X_k \sim \mathcal{N}(0, \mathbb{I}_d)$  and  $Q \sim \nu$  independently, and then define Y = XQ.

In addition, we define P to be the law of (X, Y) under  $\overline{\mathcal{H}}_1$  and let Q to be the law of (X, Y) under  $\overline{\mathcal{H}}_0$ , respectively.

Our next lemma shows that we can bound  $\Lambda(\alpha,\beta)$  by the chi-square norm between P and Q.

Lemma 3.7. We have

$$\sum_{\substack{(\alpha_1,\ldots,\alpha_k):\alpha_i\in\mathbb{N}^d\setminus\{\mathbb{O}_d\}, |\alpha_i|\leq D\\ (\beta_1,\ldots,\beta_k):\beta_i\in\mathbb{N}^m\setminus\{\mathbb{O}_m\}, |\beta_i|\leq D}} \mathbb{E}_{Q\sim\nu}\left[\prod_{1\leq i\leq k}\Lambda_{\alpha_i,\beta_i}(Q)\right]^2 \leq \mathbb{E}_{(X,Y)\sim\mathbb{Q}}\left[\left(\frac{\mathrm{d}\mathbb{P}}{\mathrm{d}\mathbb{Q}}(X,Y)\right)^2\right] - 1.$$

*Proof.* Denote  $L(X,Y) = \frac{dP}{dQ}(X,Y)$ . In addition, for  $\alpha = (\alpha_1, \ldots, \alpha_k)$  and  $\beta = (\beta_1, \ldots, \beta_k)$  we write

$$\kappa(\alpha;\beta) = \mathbb{E}_{Q \sim \nu} \Big[ \prod_{1 \le i \le k} \Lambda_{\alpha_i,\beta_i}(Q) \Big] = \mathbb{E}_{(X,Y) \sim \mathbb{P}} \Big[ \prod_{1 \le i \le k} \mathcal{H}_{\alpha}(X) \mathcal{H}_{\beta}(Y) \Big].$$

Then we have

$$\sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d, |\alpha_i|\leq D\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m, |\beta_i|\leq D}} \kappa(\alpha;\beta)^2 \stackrel{(3.7)}{=} \mathbb{E}_{(X,Y)\sim\mathbb{P}} \left[ \sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d, |\alpha_i|\leq D\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m, |\beta_i|\leq D}} \kappa(\alpha;\beta)\mathcal{H}_{\alpha}(X)\mathcal{H}_{\beta}(Y) \right]$$
$$= \mathbb{E}_{(X,Y)\sim\mathbb{Q}} \left[ \sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d, |\alpha_i|\leq D\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m, |\beta_i|\leq D}} \kappa(\alpha;\beta)\mathcal{L}(X,Y)\mathcal{H}_{\alpha}(X)\mathcal{H}_{\beta}(Y) \right]^{\frac{1}{2}} \right]^{\frac{1}{2}} \mathbb{E}_{(X,Y)\sim\mathbb{Q}} \left[ \left( \sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d, |\alpha_i|\leq D\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m, |\beta_i|\leq D}} \kappa(\alpha;\beta)\mathcal{H}_{\alpha}(X)\mathcal{H}_{\beta}(Y) \right)^2 \right]^{\frac{1}{2}} \right]^{\frac{1}{2}}$$
$$= \mathbb{E}_{(X,Y)\sim\mathbb{Q}} \left[ \mathcal{L}(X,Y)^2 \right]^{\frac{1}{2}} \left( \sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d, |\alpha_i|\leq D\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m, |\beta_i|\leq D}} \kappa(\alpha;\beta)^2 \right)^{\frac{1}{2}},$$

where the last equality follows from (3.5). This yields the desired result since  $\kappa(\mathbb{O}_d, \mathbb{O}_m) = 1$ .

We can now prove (3.15), thus finishing the proof of Theorem 2.2, Item (2).

Proof of (3.15). We will calculate L(X, Y) directly. We divide our proof into two cases. **Case 1**:  $k \leq m$  and  $k^4 = o(d/m)$ . Note that given Y = B and  $XX^{\top} = A$ , the conditional distribution of X under both P and Q is the uniform distribution over

$$\left\{ X \in \mathbb{R}^{k*d} : XX^{\top} = A \right\}.$$

Thus, we have

$$L(X,Y) = L(XX^{\top},Y).$$

Note that  $XX^{\top}$  is a k \* k Wishart matrix with dimension d, it is well-known that the density of  $XX^{\top}$  is given by (see, e.g., [Wis28] and [BDER16])

$$f_{XX^{\top}}(A) = \mathbf{1}_{\{A \succeq 0\}} \cdot \omega(d,k) \det(A)^{\frac{1}{2}(d-k-1)} e^{-\frac{1}{2}\operatorname{tr}(A)}, \qquad (3.16)$$

where  $\omega(\cdot, \cdot)$  is the Wishart constant defined by

$$\frac{1}{\omega(s,t)} = \pi^{t(t-1)/4} 2^{st/2} \prod_{j=1}^{t} \Gamma\left(\frac{s-j+1}{2}\right).$$
(3.17)

In addition, we claim that the conditional distribution of Y given  $\{XX^{\top} = A\}$  is given by

$$Y | \{ X X^{\top} = A \} \stackrel{d}{=} A^{\frac{1}{2}} \cdot \mathbf{Z}_{k*m}, \qquad (3.18)$$

where  $\mathbf{Z}_{k*m}$  is the upper-left k\*m submatrix of a uniform d\*d orthogonal matrix  $\Gamma_d$ . In fact, conditioned on the spectral decomposition of X

$$X = \left(A^{\frac{1}{2}} \quad \mathbb{O}_{k*(d-k)}\right) U \text{ where } U \in O(d) \,,$$

we have

$$Y = XQ = \left(A^{\frac{1}{2}} \quad \mathbb{O}_{k*(d-k)}\right) UQ$$

and thus (3.18) follows from UQ is uniformly distributed over O(d). Applying Lemma A.5, we see that the conditional density of Y given  $\{XX^{\top} = A\}$  is

$$f(Y \mid XX^{\top} = A) = \frac{\omega(d - m, k)}{(2\pi)^{km/2}\omega(d, k)} \det(\mathbb{I}_m - Y^{\top}A^{-1}Y)^{(d - k - m - 1)/2} \det(A)^{-m/2} \cdot \chi(A^{-1/2}Y),$$

where  $\chi(A)$  is the indicator function that all the eigenvalues of  $A^{\top}A$  lies in [0, 1]. In addition, note that under  $\mathbb{Q}$ , the density of Y is independent of x and is given by

$$\frac{1}{(2\pi)^{km/2}}e^{-\operatorname{tr}(Y^{\top}Y)/2}.$$
(3.19)

Thus, we have

$$L(A,Y) = \frac{\omega(d-m,k)}{\omega(d,k)} \cdot e^{\frac{\operatorname{tr}(Y^{\top}Y)}{2}} \det(\mathbb{I}_m - Y^{\top}A^{-1}Y)^{\frac{d-k-m-1}{2}} \det(A)^{-m/2} \cdot \chi(A^{-1/2}Y).$$
(3.20)

Plugging (3.20) into the formula

$$\mathbb{E}_{\mathsf{Q}}\big[\mathsf{L}(XX^{\top},Y)^{2}\big] = \int_{A\succeq 0} \int_{Y} \mathsf{L}(A,Y)^{2} \cdot \frac{e^{-\operatorname{tr}(Y^{\top}Y)/2}}{(2\pi)^{km/2}} \cdot \omega(d,k) \det(A)^{\frac{1}{2}(d-k-1)} e^{-\frac{1}{2}\operatorname{tr}(A)} \mathrm{d}A\mathrm{d}Y, \quad (3.21)$$

we obtain that  $\mathbb{E}_{\mathsf{Q}}[\mathsf{L}(X,Y)^2]$  equals

$$\int_{A \succeq 0} \int_{Y} \frac{\omega(d-m,k)^2 \det(\mathbb{I}_m - Y^{\top} A^{-1} Y)^{d-k-m-1} \det(A)^{\frac{1}{2}(d-k-2m-1)} \chi(A^{-1/2} Y)}{\omega(d,k)(2\pi)^{\frac{km}{2}} e^{\frac{1}{2}(\operatorname{tr}(A) - \operatorname{tr}(Y^{\top} Y))}} \mathrm{d}A\mathrm{d}Y. \quad (3.22)$$

By substituting Y with  $A^{1/2}Z$ , we get that

$$(3.22) = \int_{A \succeq 0} \int_{Z} \frac{\omega(d-m,k)^2 \det(\mathbb{I}_m - Z^{\top}Z)^{d-k-m-1} \det(A)^{\frac{1}{2}(d-k-m-1)}\chi(Z)}{\omega(d,k)(2\pi)^{\frac{km}{2}} e^{\frac{1}{2}(\operatorname{tr}(A) - \operatorname{tr}(Z^{\top}AZ))}} \mathrm{d}A\mathrm{d}Z.$$
(3.23)

Note that

$$\operatorname{tr}(A) - \operatorname{tr}(Z^{\top}AZ) = \operatorname{tr}(A(\mathbb{I}_k - ZZ^{\top})),$$

by substituting A with  $(\mathbb{I}_k - ZZ^{\top})^{-1/2}B(\mathbb{I}_k - ZZ^{\top})^{-1/2}$ , we get that (note that  $\det(\mathbb{I}_m - Z^{\top}Z) = \det(\mathbb{I}_k - ZZ^{\top}))$ 

$$(3.23) = \int_{B \succeq 0} \int_{Z} \frac{\omega(d-m,k)^2 \det(\mathbb{I}_m - Z^{\top}Z)^{\frac{1}{2}(d-3k-m-1)} \det(B)^{\frac{1}{2}(d-k-m-1)}\chi(Z)}{\omega(d,k)(2\pi)^{\frac{km}{2}}e^{\frac{1}{2}\operatorname{tr}(B)}} \mathrm{d}B\mathrm{d}Z. \quad (3.24)$$

Note that

$$\int_{B \succ 0} e^{-\frac{1}{2}\operatorname{tr}(B)} \det(B)^{\frac{1}{2}(d-k-m-1)} dB = \frac{1}{\omega(d-m,k)},$$
$$\int_{Z} \det(\mathbb{I}_{m} - Z^{\top}Z)^{\frac{1}{2}(d-3k-m-1)}\chi(Z) dZ = \frac{(2\pi)^{mk/2}\omega(d-2k,k)}{\omega(d-2k-m,k)}$$

We then get that

$$(3.24) = \frac{(2\pi)^{mk/2}\omega(d-2k,k)}{\omega(d-2k-m,k)} \cdot \frac{1}{\omega(d-m,k)} \cdot \frac{\omega(d-m,k)^2}{\omega(d,k)(2\pi)^{km/2}} = \frac{\omega(d-m,k)}{\omega(d-m-2k,k)} \cdot \frac{\omega(d-2k,k)}{\omega(d,k)}.$$
(3.25)

Applying Lemma A.3, we get that (recall the assumption  $k^4 \leq D^4 = o(d/m)$ )

$$(3.25) = [1 + o(1)] \cdot \left(\frac{d}{d-m}\right)^{k^2} = [1 + o(1)] \cdot \left(1 + \frac{mk^2}{d}\right) = 1 + o(D^{-1})$$

**Case 2**:  $m^4 \le k^4 = o(d/m)$ . In this case, again we have

$$\mathsf{L}(X,Y) = \mathsf{L}(XX^{\top},Y)$$

and the density of  $XX^{\top}$  is given by (3.16). Using Lemma A.5, we see that the conditional density of Y given  $\{XX^{\top} = A\}$  is

$$f(Y \mid XX^{\top} = A) = \frac{\omega(d - k, m)}{(2\pi)^{km/2}\omega(d, m)} \det(\mathbb{I}_k - A^{-\frac{1}{2}}YY^{\top}A^{-\frac{1}{2}})^{\frac{d - k - m - 1}{2}} \det(A)^{-\frac{m}{2}} \cdot \chi(YA^{-1/2}).$$

Since the density of Y under Q is given by (3.19), we get that

$$L(A,Y) = \frac{\omega(d-k,m)}{\omega(d,m)} \cdot e^{\frac{\operatorname{tr}(Y^{\top}Y)}{2}} \det(\mathbb{I}_k - A^{-\frac{1}{2}}YY^{\top}A^{-\frac{1}{2}})^{\frac{d-k-m-1}{2}} \det(A)^{-\frac{m}{2}} \cdot \chi(YA^{-1/2}).$$

Plugging this result into (3.21), we obtain that  $\mathbb{E}_{Q}[L(X,Y)^{2}]$  equals

$$\int_{A \succ 0} \int_{Y} \frac{\omega(d-k,m)^{2} \omega(d,k) \det(\mathbb{I}_{k} - A^{-\frac{1}{2}} Y Y^{\top} A^{-\frac{1}{2}})^{d-k-m-1} \det(A)^{\frac{1}{2}(d-k-2m-1)} \chi(YA^{-1/2})}{\omega(d,m)^{2} (2\pi)^{\frac{km}{2}} e^{\frac{1}{2}(\operatorname{tr}(A) - \operatorname{tr}(Y^{\top}Y))}} \mathrm{d}A\mathrm{d}Y.$$
(3.26)

Substituting  $Y = A^{1/2}Z$ , we get that

$$(3.26) = \int_{A \succeq 0} \int_{Z} \frac{\omega(d-k,m)^2 \omega(d,k) \det(\mathbb{I}_k - ZZ^{\top})^{d-k-m-1} \det(A)^{\frac{1}{2}(d-k-m-1)} \chi(Z)}{\omega(d,m)^2 (2\pi)^{\frac{km}{2}} e^{\frac{1}{2}(\operatorname{tr}(A) - \operatorname{tr}(AZZ^{\top}))}} \mathrm{d}A\mathrm{d}Z.$$
(3.27)

Substituting  $A = (\mathbb{I}_k - ZZ^{\top})^{-1/2} B(\mathbb{I}_k - ZZ^{\top})^{-1/2}$ , we get that

$$(3.27) = \int_{B \succ 0} \int_{Z} \frac{\omega(d-k,m)^2 \omega(d,k) \det(\mathbb{I}_k - ZZ^{\top})^{d-3k-m-1} \det(B)^{\frac{1}{2}(d-k-m-1)} \chi(Z)}{\omega(d,m)^2 (2\pi)^{\frac{km}{2}} e^{\frac{1}{2}\operatorname{tr}(B)}} dB dZ.$$
(3.28)

Note that

$$\int_{B \succeq 0} e^{-\frac{1}{2}\operatorname{tr}(B)} \det(B)^{\frac{1}{2}(d-k-m-1)} dB = \frac{1}{\omega(d-m,k)},$$
$$\int_{Z} \det(\mathbb{I}_{k} - Z^{\top}Z)^{\frac{1}{2}(d-3k-m-1)}\chi(Z) dZ = \frac{(2\pi)^{mk/2}\omega(d-2k,m)}{\omega(d-3k,m)}$$

We then get that

$$(3.28) = \frac{\omega(d-k,m)^2}{\omega(d,m)^2} \cdot \frac{\omega(d,k)}{\omega(d-m,k)} \cdot \frac{\omega(d-2k,m)}{\omega(d-3k,m)}$$
  
=  $[1+o(1)] \cdot d^{mk} \cdot (d-m)^{-mk/2} \cdot (d-3k)^{-mk/2}$   
=  $[1+o(1)] \cdot \left(\frac{d^2}{(d-m)(d-3k)}\right)^{mk/2} = 1 + o(mk^2/d) = 1 + o(D^{-1}),$ 

where in the second equality we use Lemma A.3 and in the last inequality we use the assumption  $m^4 \leq k^4 = o(d/m)$ . Combining the two cases leads to the desired result.

# 3.4 Proof of Item (2)

In this subsection we discuss the case that  $m = d, \sigma = \omega(1)$  and  $D = o(\sigma)$ . Still, based on (3.8), it suffices to show that for  $1 \le k \le D$  we have

$$\sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m\\0<|\alpha_i|,|\beta_j|\leq D}} \mathbb{E}_{Q\sim\nu} \left[\prod_{1\leq i\leq k} \Lambda_{\alpha_i,\beta_i}(Q)\right]^2 = o(D^{-1}).$$
(3.29)

We will adopt the similar approach as in Subsection 3.3 by relating the left hand side of (3.29) to a simpler hypothesis testing problem. Consider the following hypothesis testing problem, where our observation are two vectors  $X = (X_1, \ldots, X_k)^\top \in \mathbb{R}^{k*d}, Y = (Y_1, \ldots, Y_k)^\top \in \mathbb{R}^{k*d}$  such that:

- under the null hypothesis  $\overline{\mathcal{H}}_0$ , we sample  $X_i \sim \mathcal{N}(0, \mathbb{I}_d)$  and  $Y_i \sim \mathcal{N}(0, \mathbb{I}_d)$  independently.
- under the alternative hypothesis  $\overline{\mathcal{H}}_1$ , we first sample  $X_1, \ldots, X_k \sim \mathcal{N}(0, \mathbb{I}_d)$  and  $Q \sim \nu$  independently (recall that now  $\nu$  is the Haar measure over O(d)), and then define

$$Y = \frac{1}{\sqrt{1+\sigma^2}} \left( XQ + \sigma Z \right).$$

In addition, we define P to be the law of (X, Y) under  $\overline{\mathcal{H}}_1$  and let Q to be the law of (X, Y) under  $\overline{\mathcal{H}}_0$ , respectively. Similar as in Lemma 3.7, we get that

$$\sum_{\substack{(\alpha_1,\dots,\alpha_k):\alpha_i\in\mathbb{N}^d\\(\beta_1,\dots,\beta_k):\beta_i\in\mathbb{N}^m\\0<|\alpha_i|,|\beta_j|\leq D}} \mathbb{E}_{Q\sim\nu}\left[\prod_{1\leq i\leq k}\Lambda_{\alpha_i,\beta_i}(Q)\right]^2 \leq \mathbb{E}_{(X,Y)\sim\mathbb{Q}}\left[\left(\frac{\mathrm{d}\mathbb{P}}{\mathrm{d}\mathbb{Q}}(X,Y)\right)^2\right] - 1.$$
(3.30)

The rest part of this subsection is devoted to the direct calculation of the right hand side of (3.30). Clearly, the probability density function of (X, Y) under Q is given by

$$f_{\mathbf{Q}}(X,Y) = \frac{e^{-\|X\|_{\mathrm{F}}^2/2}}{(2\pi)^{kd/2}} \cdot \frac{e^{-\|Y\|_{\mathrm{F}}^2/2}}{(2\pi)^{kd/2}}.$$

In addition, the probability density function of (X, Y) under P is given by

$$f_{\rm P}(X,Y) = \frac{e^{-\|X\|_{\rm F}^2/2}}{(2\pi)^{kd/2}} \cdot \int_{O(d)} \frac{e^{-\frac{\sigma^2}{2(1+\sigma^2)}} \left\|Y - \frac{XQ}{\sqrt{1+\sigma^2}}\right\|_{\rm F}^2}{(2\pi\sigma^2/(1+\sigma^2))^{kd}} \mathrm{d}Q.$$

Thus, we get that

$$\mathbf{L}(X,Y) = \left(\frac{1+\sigma^2}{\sigma^2}\right)^{kd/2} e^{-\left(\|X\|_{\mathbf{F}}^2 + \|Y\|_{\mathbf{F}}^2\right)/2\sigma^2} \cdot \int_{O(d)} e^{\sqrt{1+\sigma^2} \langle X, YQ \rangle/\sigma^2} \mathrm{d}Q \,.$$

Thus, we have

$$\mathbf{L}(X,Y)^{2} = \left(\frac{1+\sigma^{2}}{\sigma^{2}}\right)^{kd} e^{-(\|X\|_{\mathrm{F}}^{2} + \|Y\|_{\mathrm{F}}^{2})/\sigma^{2}} \cdot \int_{O(d) \times O(d)} e^{\sqrt{1+\sigma^{2}} \langle X, Y(Q_{1}+Q_{2}) \rangle/\sigma^{2}} \mathrm{d}Q_{1} \mathrm{d}Q_{2}$$

We then have

$$\mathbb{E}_{(X,Y)\sim \mathbf{Q}} \Big[ \mathbf{L}(X,Y)^2 \Big] \\
= \Big( \frac{1+\sigma^2}{\sigma^2} \Big)^{kd} \int_{O(d)\times O(d)} \mathbb{E}_{(X,Y)\sim \mathbf{Q}} \Big[ e^{-(||X||_{\mathrm{F}}^2 + ||Y||_{\mathrm{F}}^2)/\sigma^2} \cdot e^{\sqrt{1+\sigma^2} \langle X,Y(Q_1+Q_2) \rangle/\sigma^2} \Big] \mathrm{d}Q_1 \mathrm{d}Q_2 \\
= \Big( \frac{1+\sigma^2}{\sigma^2} \Big)^{kd} \Big( \frac{\sigma^2}{2+\sigma^2} \Big)^{kd/2} \int_{O(d)\times O(d)} \mathbb{E}_{Y\sim \mathbf{Q}} \Big[ e^{-||Y||_{\mathrm{F}}^2/\sigma^2} \cdot e^{(1+\sigma^2)||Y(Q_1+Q_2)||_{\mathrm{F}}^2/2\sigma^2(2+\sigma^2)} \Big] \mathrm{d}Q_1 \mathrm{d}Q_2 \\
= \Big( \frac{1+\sigma^2}{\sigma^2} \Big)^{kd} \Big( \frac{\sigma^2}{2+\sigma^2} \Big)^{kd/2} \int_{O(d)} \mathbb{E}_{Y\sim \mathbf{Q}} \Big[ e^{-||Y||_{\mathrm{F}}^2/\sigma^2} \cdot e^{(1+\sigma^2)(||Y||_{\mathrm{F}}^2 + \langle Y,YQ \rangle)/\sigma^2(2+\sigma^2)} \Big] \mathrm{d}Q \\
= \Big( \frac{1+\sigma^2}{\sigma^2} \Big)^{kd} \Big( \frac{\sigma^2}{2+\sigma^2} \Big)^{kd/2} \int_{O(d)} \mathbb{E}_{Y\sim \mathbf{Q}} \Big[ e^{-||Y||_{\mathrm{F}}^2/\sigma^2(\sigma^2+2)} \cdot e^{(1+\sigma^2)\langle Y,YQ \rangle/\sigma^2(2+\sigma^2)} \Big] \mathrm{d}Q,$$
(3.31)

where the second equality follows from Lemma A.6 and the third equality follows from the fact that  $Q_1 Q_2^{\top} \sim \nu$  for  $Q_1 \perp Q_2$  and  $Q_1, Q_2 \sim \nu$ . Using Lemma A.7 with

$$A = A(Q) = \frac{1}{\sigma^2(\sigma^2 + 2)} \mathbb{I}_d - \frac{\sigma^2 + 1}{2\sigma^2(\sigma^2 + 2)} (Q + Q^{\top}),$$

we get that

$$(3.31) = \left(\frac{1+\sigma^2}{\sigma^2}\right)^{kd} \left(\frac{\sigma^2}{2+\sigma^2}\right)^{kd/2} \int_{O(d)} \det\left(\mathbb{I}_d + 2A(Q)\right)^{-k/2} \mathrm{d}Q \,. \tag{3.32}$$

Note that (denote  $\epsilon = \epsilon(\sigma) = (1+\sigma^2)^{-1} = o(1))$ 

$$\det\left(\mathbb{I}_d + 2A(Q)\right) = \det\left(\frac{1+(\sigma^2+1)^2}{\sigma^2(\sigma^2+2)}\mathbb{I}_d - \frac{\sigma^2+1}{\sigma^2(\sigma^2+2)}(Q+Q^{\top})\right)$$
$$= \left(\frac{(\sigma^2+1)^2}{\sigma^2(\sigma^2+2)}\right)^d \cdot \det\left((1+\epsilon^2)\mathbb{I}_d - \epsilon(Q+Q^{\top})\right)$$
$$= \left(\frac{(\sigma^2+1)^2}{\sigma^2(\sigma^2+2)}\right)^d \cdot \det\left((\mathbb{I}_d + \epsilon Q)(\mathbb{I}_d + \epsilon Q^{\top})\right) = \frac{(\sigma^2+1)^2}{\sigma^2(\sigma^2+2)} \cdot \det\left(\mathbb{I}_d + \epsilon Q\right)^2.$$

Thus, we have

$$(3.32) = \int_{O(d)} \det\left(\mathbb{I}_d + \frac{1}{1+\sigma^2}Q\right)^{-k} dQ = 1 + O\left(\frac{k}{1+\sigma^2}\right) = 1 + o(D^{-1}), \qquad (3.33)$$

where the second equality follows from Lemma A.8 and the last equality follows from  $k \leq D$  and  $D = o(\sigma)$ . This leads to (3.29).

## 3.5 Proof of Item (3)

In this subsection we prove Item (3) in Theorem 2.2. Denote

$$f(X,Y) = \left( \|Y\|_{\rm F}^2 - \|X\|_{\rm F}^2 \right)^2.$$
(3.34)

It suffices to show the following estimation.

**Lemma 3.8.** Assuming d = m and  $\sigma = o(1)$ , then we have

- (1)  $\mathbb{E}_{\mathbb{P}}[f] = o(nd)$  and  $\mathbb{E}_{\mathbb{Q}}[f] = \Theta(nd)$ .
- (2)  $\operatorname{Var}_{\mathbb{P}}[f], \operatorname{Var}_{\mathbb{Q}}[f] = o(n^2 d^2).$

*Proof.* Note that under  $\mathbb{P}$  we have  $Y = (XQ + \sigma Z)/\sqrt{1 + \sigma^2}$ , thus

$$\|Y\|_{\rm F}^2 - \|X\|_{\rm F}^2 = \frac{1}{1+\sigma^2} \|XQ + \sigma Z\|_{\rm F}^2 - \|X\|_{\rm F}^2 = \frac{\sigma^2}{1+\sigma^2} \left(\|Z\|_{\rm F}^2 - \|X\|_{\rm F}^2\right) + \frac{2\sigma}{1+\sigma^2} \langle X, Z \rangle.$$

Thus, we have

$$\mathbb{E}_{\mathbb{P}}[f^{2}] = \mathbb{E}_{\mathbb{P}}\Big[ \left( \|Y\|_{\mathrm{F}}^{2} - \|X\|_{\mathrm{F}}^{2} \right)^{4} \Big] \leq 2^{4} \cdot \left( \mathbb{E}_{\mathbb{P}} \Big[ \sigma^{4} \big( \|Z\|_{\mathrm{F}}^{2} - \|X\|_{\mathrm{F}}^{2} \big)^{4} \Big] + \mathbb{E}_{\mathbb{P}} \Big[ \sigma^{2} \langle X, Z \rangle^{4} \Big] \Big) \\ \leq O(1) \cdot \sigma^{2} \cdot n^{2} d^{2} = o(n^{2} d^{2}) , \qquad (3.35)$$

where the second inequality follows from  $||Z||_{\rm F}^2 - ||X||_{\rm F}$  and  $\langle X, Z \rangle$  are sums of *nd* independent random variables with finite fourth moment. In addition, under  $\mathbb{Q}$  we have X, Y are independent n \* d Gaussian random matrices with i.i.d.  $\mathcal{N}(0, 1)$  entries. Thus, we have

$$\mathbb{E}_{\mathbb{Q}}\left[f\right] = \mathbb{E}_{\mathbb{Q}}\left[\left(\sum_{1 \le i \le n} \sum_{1 \le j \le d} (Y_{i,j}^2 - X_{i,j}^2)\right)^2\right] = 4nd, \qquad (3.36)$$

$$\mathbb{E}_{\mathbb{Q}}[f^2] = \mathbb{E}_{\mathbb{Q}}\left[\left(\sum_{1 \le i \le n} \sum_{1 \le j \le d} (Y_{i,j}^2 - X_{i,j}^2)\right)^4\right] = 16n^2d^2 + O(nd).$$
(3.37)

Combining (3.35), (3.36) and (3.37) yields the desired result.

# A Preliminary results

# A.1 Preliminary results on Hermite polynomials

**Lemma A.1.** For  $x, y \in \mathbb{R}^d$  with ||y|| = 1 and  $m \in \mathbb{N}$ , we have

$$\mathcal{H}_m(\langle x, y \rangle) = \sum_{\alpha \in \mathbb{N}^d : |\alpha| = m} \sqrt{\frac{\alpha!}{m!}} \binom{m}{\alpha} y^{\alpha} \mathcal{H}_\alpha(x) \,. \tag{A.1}$$

*Proof.* Recall Definition 3.2. It was shown in [MOS13] that

$$e^{tx-\frac{t^2}{2}} = \sum_{n=0}^{\infty} \frac{H_n(x)}{n!} \cdot t^n$$

Thus, we see that

$$\sum_{n=0}^{\infty} \frac{H_n(\langle x, y \rangle)}{n!} \cdot t^n = e^{\langle x, y \rangle t - \frac{t^2}{2}} = e^{\langle x, y \rangle t - \frac{\|y\|^2 t^2}{2}} = \prod_{i=1}^d e^{x_i y_i t - \frac{y_i^2 t^2}{2}}$$
$$= \prod_{i=1}^d \left( \sum_{n=0}^{\infty} \frac{H_n(x_i)}{n!} \cdot (y_i t)^n \right) = \sum_{n=0}^{\infty} t^n \sum_{\alpha \in \mathbb{N}^d : |\alpha| = n} \frac{y^\alpha H_\alpha(x)}{\alpha!} \,.$$

Thus, we see that

$$H_n(\langle x, y \rangle) = \sum_{\alpha \in \mathbb{N}^d : |\alpha| = n} \binom{n}{\alpha} y^{\alpha} H_\alpha(x)$$

Combined with Definition 3.2, we get the desired result.

#### A.2 Preliminary results on Wishart constant

The following result can be found in [Gau59].

**Lemma A.2** (Gautschi's inequality). for all  $x \in \mathbb{R}_{\geq 0}$  we have  $x^{1-s} \leq \frac{\Gamma(x+1)}{\Gamma(x+s)} \leq (x+1)^{1-s}$ . In particular, we have when  $x \to \infty$ 

$$\frac{\Gamma(x+\frac{1}{2})}{\Gamma(x)} = [1+O(\frac{1}{x})] \cdot \sqrt{x} \,.$$

Based on Lemma A.2, the following result provides a crude bound on  $\omega(s, t)$ .

**Lemma A.3.** Recall the definition of  $\omega(s,t)$  in (3.17). For  $k^3 = o(d)$  we have

$$\frac{\omega(d,k)}{\omega(d-2k,k)} = [1+o(1)] \cdot d^{k^2} \text{ and } \frac{\omega(d-2k,k)}{\omega(d,k)} = [1+o(1)] \cdot d^{-k^2}.$$

In addition, for  $k^3, m^3 = o(d)$  we have

$$\frac{\omega(d,m)}{\omega(d-k,m)} = [1+o(1)] \cdot d^{km/2} \text{ and } \frac{\omega(d-k,m)}{\omega(d,m)} = [1+o(1)] \cdot d^{-km/2}.$$

*Proof.* Using (3.17), we get that

$$\frac{\omega(d,k)}{\omega(d-2k,k)} = 2^{k^2} \prod_{j=1}^k \frac{\Gamma(\frac{d-j+1}{2})}{\Gamma(\frac{d-2k-j+1}{2})} = 2^{k^2} \prod_{j=1}^k \prod_{i=1}^k \left(\frac{d-j+1}{2} - i\right)$$
$$= \prod_{j=1}^k \prod_{i=1}^k \left([1+O(k/d)] \cdot d\right) = [1+o(1)] \cdot d^{k^2},$$

where in the last equality we use  $k^3 = o(d)$ . Similarly we can get that

$$\frac{\omega(d-2k,k)}{\omega(d,k)} = [1+o(1)] \cdot d^{-k^2}.$$

In addition, using (3.17) again we have

$$\begin{split} \frac{\omega(d,m)}{\omega(d-k,m)} &= 2^{km/2} \cdot \prod_{j=1}^m \frac{\Gamma(\frac{d-j+1}{2})}{\Gamma(\frac{d-k-j+1}{2})} = 2^{km/2} \prod_{j=1}^m \prod_{i=1}^k \frac{\Gamma(\frac{d-i-j+2}{2})}{\Gamma(\frac{d-i-j+1}{2})} \\ &= 2^{km/2} \prod_{j=1}^m \prod_{i=1}^k \left( \left(1 + O(\frac{2}{d-i-j+1})\right) \cdot \sqrt{(d-i-j+1)/2} \right) = [1+o(1)] \cdot d^{km/2} \,, \end{split}$$

where in the last equality we use  $k^3, m^3 = o(d)$ . Similarly we can get that

$$\frac{\omega(d-k,m)}{\omega(d,m)} = [1+o(1)] \cdot d^{-km/2}.$$

## A.3 Preliminary results in probability

**Lemma A.4.** For all  $\{\gamma_i \in \mathbb{N} : 1 \leq i \leq d\}$  we have

$$\mathbb{E}_{Q\sim\mathrm{Unif}(\mathbb{S}^{d-1})}\left[Q_1^{\gamma_1}\ldots Q_d^{\gamma_d}\right] = \mathbf{1}_{\{\gamma_1,\ldots,\gamma_d \text{ is even}\}} \cdot \frac{\Gamma(\frac{d}{2})(\gamma_1-1)!!\ldots(\gamma_d-1)!!}{\Gamma(\frac{d+\gamma_1+\ldots+\gamma_d}{2})2^{\frac{\gamma_1+\ldots+\gamma_d}{2}}}.$$

*Proof.* Denote  $X = (X_1, \ldots, X_d) \sim \mathcal{N}(0, \mathbb{I}_d)$ . We the have  $||X|| \perp \frac{X}{||X||}$  and  $\frac{X}{||X||} \sim \text{Unif}(\mathbb{S}^{d-1})$ . Thus, we have

$$\mathbb{E}_{Q \sim \text{Unif}(\mathbb{S}^{d-1})} \left[ Q_1^{\gamma_1} \dots Q_d^{\gamma_d} \right] \cdot \mathbb{E} \left[ \|X\|^{\gamma_1 + \dots + \gamma_d} \right]$$
  
=  $\mathbb{E} \left[ \left( \frac{X_1}{\|X\|} \right)^{\gamma_1} \dots \left( \frac{X_d}{\|X\|} \right)^{\gamma_d} \right] \cdot \mathbb{E} \left[ \|X\|^{\gamma_1 + \dots + \gamma_d} \right]$   
=  $\mathbb{E} \left[ X_1^{\gamma_1} \dots X_d^{\gamma_d} \right] = \mathbf{1}_{\{\gamma_1, \dots, \gamma_d \text{ is even}\}} \cdot \prod_{1 \leq i \leq d} (\gamma_i - 1)!! .$ 

In addition, since the law of  $||X||^2$  is a Gamma distribution with d sample and parameter  $\frac{1}{2}$ , we have

$$\mathbb{E}\Big[\|X\|^{\gamma_1+\ldots+\gamma_d}\Big] = \frac{2^{\frac{\gamma_1+\ldots+\gamma_d}{2}}\Gamma(\frac{d+\gamma_1+\ldots+\gamma_d}{2})}{\Gamma(\frac{d}{2})}.$$

Thus, we see that the desired result holds.

**Lemma A.5** ([JM19], Lemma 2.1). Let  $\Gamma_d$  be an d\*d random matrix which is uniformly distributed on the orthogonal group O(n) and let  $\mathbf{Z}_n$  be the upper-left p\*q submatrix of  $\Gamma_n$ . If  $p+q \leq n$  and  $p \geq q$  then the joint density function of entries of  $\mathbf{Z}_n$  is given by

$$f(Z) = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \chi_0(Z^{\top}Z) + C_{q} = \frac{\omega(d-p,q)}{\omega(d,q)(2\pi)^{pq/2}} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)/2} \cdot \operatorname{Det}(\mathbb{I}_q - Z^{\top}Z)^{(n-p-q-1)$$

where  $\chi_0(Z^{\top}Z)$  is the indicator function of the set that all q eigenvalues of  $Z^{\top}Z$  are in [0,1]. When p < q, the density of  $\mathbf{Z}_n$  is obtained by interchanging p and q in the above Wishart constant.

**Lemma A.6.** Let Z be an d \* m matrix with entries are i.i.d.  $\mathcal{N}(0,1)$  random variables. Then for all  $\lambda > 0$  and  $A \in \mathbb{R}^{d*m}$  we have

$$\mathbb{E}\left[e^{-\lambda \|Z\|_{\mathrm{F}}^{2} + \langle A, Z \rangle}\right] = (1 + 2\lambda)^{-dm/2} \cdot e^{\|A\|_{\mathrm{F}}^{2}/2(1+2\lambda)}$$

*Proof.* Note that

$$\mathbb{E}_{X \sim \mathcal{N}(0,1)} \left[ e^{-\lambda x^2 + ax} \right] = \frac{1}{\sqrt{1+2\lambda}} e^{\frac{a^2}{2(1+2\lambda)}} ,$$

we then have

$$\mathbb{E}\Big[e^{-\lambda \|Z\|_{\mathrm{F}}^{2} + \langle A, Z \rangle}\Big] = \prod_{\substack{1 \le i \le d \\ 1 \le j \le m}} \frac{1}{\sqrt{1+2\lambda}} e^{\frac{a_{i,j}^{2}}{2(1+2\lambda)}} = (1+2\lambda)^{-dm/2} \cdot e^{\|A\|_{\mathrm{F}}^{2}/2(1+2\lambda)} \,.$$

**Lemma A.7.** Let k < d and let Z be an d \* k matrix with entries are i.i.d.  $\mathcal{N}(0,1)$  random variables. Then for any d \* d semidefinite matrix A we have

$$\mathbb{E}\left[e^{-\operatorname{tr}(Z^{\top}AZ)}\right] = \det(\mathbb{I}_d + 2A)^{-k/2}.$$

*Proof.* Note that for all  $U \in O(d)$  we have

$$\mathbb{E}\left[e^{-\operatorname{tr}(Z^{\top}AZ)}\right] = \mathbb{E}\left[e^{-\operatorname{tr}(Z^{\top}U^{\top}AUZ)}\right].$$

Thus, without losing of generality we may assume that  $A = \text{Diag}(a_1, \ldots, a_d)$  is a diagonal matrix. In this case, we get from direct calculation that

$$\mathbb{E}\left[e^{-\operatorname{tr}(Z^{\top}AZ)}\right] = \prod_{1 \le i \le d} \mathbb{E}\left[e^{-a_i \sum_{j=1}^k Z_{i,j}^2}\right] = \prod_{1 \le i \le d} (1+2a_i)^{-k/2} = \det(\mathbb{I}_d + 2A)^{-k/2}.$$

**Lemma A.8.** Denote  $\nu = \nu_d$  to be the Haar measure over O(d). For all  $\epsilon k = O(1)$  and  $0 \le \epsilon \le 1 - \Omega(1)$ , we have as  $d \to \infty$ 

$$\mathbb{E}_{Q \sim \nu} \Big[ \det(\mathbb{I}_d + \epsilon Q)^k \Big] = 1 + O(\epsilon k) \,.$$

Proof. Clearly it suffices to show that when  $\epsilon k = \Theta(1)$  we have  $\mathbb{E}_{Q \sim \nu} \left[ \det(\mathbb{I}_d + \epsilon Q)^k \right] = +O(1)$ , and the general cases follows from the simple inequality  $\mathbb{E}[X] \leq \mathbb{E}[X^m]^{\frac{1}{m}}$  for  $m \geq 1$  and  $X \geq 0$ . Denote  $\{e^{i\theta_1}, \ldots, e^{i\theta_d} : \theta_1, \ldots, \theta_d \in [0, 2\pi]\}$  to be the spectrum of Q. In addition, denote  $\overline{F}_d$  to be the empirical distribution of  $\theta_1, \ldots, \theta_d$ . We then have

$$\det(\mathbb{I}_d + \epsilon Q)^k = \exp\left(k\sum_{\ell=1}^d \log(1 + \epsilon e^{i\theta_\ell})\right) = \exp\left(d \cdot W_d\right),$$

where

$$W_d = \int_0^{2\pi} k \log(1 + \epsilon e^{it}) \mathrm{d}\overline{F}_d(t) \,.$$

Denote  $\varphi(t) = k \log(1 + \epsilon e^{it})$ . Note that when  $\epsilon k = O(1)$  and  $0 \le \epsilon \le 1 - \Omega(1)$  we have  $|\varphi'(t)| \le \frac{\epsilon k}{1-\epsilon} = \Theta(1)$  and thus  $\varphi$  is 1-Lipchitz. It was well known (see, e.g., [AGZ10, Theorem 4.4.27] and [MM13, Theorem 2.1]) that  $\overline{F}_d$  weakly converges to F, the uniform distribution over  $[0, 2\pi]$ . In addition, we have the following bound for the tail probability of  $W_d$ :

$$\mathbb{P}\left(\left|W_{d}\right| \geq t\right) = \mathbb{P}\left(\left|W_{d} - k\int_{0}^{2\pi} \log(1 + \epsilon e^{it}) \mathrm{d}F_{d}(t)\right| \geq t\right) \leq 2e^{-\Theta(1) \cdot d^{2}t^{2}},$$

where the equality follows from

$$\int_0^{2\pi} \log(1 + \epsilon e^{it}) \mathrm{d}F_d(t) = 0 \text{ for all } \epsilon \in [0, 1)$$

and the inequality follows from [MM13, Corollary 2.4]. Thus, we have

$$\mathbb{E}_{Q\sim\nu}\left[\det(\mathbb{I}_d+\epsilon Q)^k\right] \le 2\int_0^\infty de^{dt} \cdot e^{-\Theta(1)\cdot d^2t^2} dt = e^{O(1)} = O(1).$$
