Fractal Von Neumann Entropy

Abstract

We consider the *fractal von Neumann entropy* associated with the *fractal* distribution function and we obtain for some universal classes h of fractons their entropies. We obtain also for each of these classes a fractal-deformed Heisenberg algebra. This one takes into account the braid group structure of these objects which live in two-dimensional multiply connected space. The *fractal von Neumann entropy* associated with the *fractal distribution function* was introduced in Ref. [\[1](#page-8-0)]. We have defined *universal classes h of particles or quasiparticles* which carry rational or irrational spin quantum number s. The fractal parameter or Hausdorff dimension h runs within the interval $1 < h < 2$. Fractons as charge-flux systems are such particles which live in two-dimensional multiply connected space and satisfy specific fractal distribution function. The particles of each class are collected taking into account the *fractal* spectrum

$$
h - 1 = 1 - \nu, \quad 0 < \nu < 1; \qquad h - 1 = \nu - 1, \qquad 1 < \nu < 2; \tag{1}
$$
\netc.

and the spin-statistics relation $\nu = 2s$, which is valid for such fractons. For example, consider the universal classes with distinct values of spin $\left\{\frac{1}{2}\right\}$ $\frac{1}{2}$, $\frac{3}{2}$ $\frac{3}{2}$, $\frac{5}{2}$ $\frac{5}{2}, \cdots \Big\}$ $h=1$ $\{0, 1, 2, \cdots\}$ $h=2$ and $\left\{\frac{1}{4}\right\}$ $\frac{1}{4}$, $\frac{3}{4}$ $\frac{3}{4}$, $\frac{5}{4}$ $\frac{5}{4}, \cdots \Big\}$ $h = \frac{3}{2}$, then we have the Fermi-Dirac distribution

$$
n[1] = \frac{1}{\xi + 1} \tag{2}
$$

the Bose-Einstein distribution

$$
n[2] = \frac{1}{\xi - 1} \tag{3}
$$

and the Fractal distribution

$$
n\left[\frac{3}{2}\right] = \frac{1}{\sqrt{\frac{1}{4} + \xi^2}}\tag{4}
$$

with $\xi = \exp\{(\epsilon - \mu)/KT\}.$

Another result of our approach to fractional spin particles is that the classes h satisfy a duality simmetry defined by $\tilde{h} = 3 - h$, and as a consequence we extract a fractal supersymmetry which defines pairs of particles $(s, s + \frac{1}{2})$ $\frac{1}{2}$. Thus, the fractal distribution function is a quantum-geometrical description of the statistical laws of Nature, since the quantum path is a fractal curve and this reflects the Heisenberg uncertainty principle.

The Fractal von Neumann entropy per state in terms of the average occupation number is given as[[1](#page-8-0)]

$$
\mathcal{S}_G[h] = n K \Big[\big(\mathcal{Y}[\xi] - 1 \big) \ln(\mathcal{Y}[\xi] - 1) - \big(\mathcal{Y}[\xi] - 2 \big) \ln(\mathcal{Y}[\xi] - 2) \Big] \tag{5}
$$

$$
= K \left[[1 + (h-1)n] \ln \left\{ \frac{1 + (h-1)n}{n} \right\} - [1 + (h-2)n] \ln \left\{ \frac{1 + (h-2)n}{n} \right\} \right] \tag{6}
$$

where

$$
n = \frac{1}{\mathcal{Y}[\xi] - h} \tag{7}
$$

is the Fractal distribution function which appears as a simple and elegant generalization of the fermionic and bosonic distributions for particles with braiding properties. The function $\mathcal{Y}[\xi]$ satisfies the equation

$$
\xi = \left\{ \mathcal{Y}[\xi] - 1 \right\}^{h-1} \left\{ \mathcal{Y}[\xi] - 2 \right\}^{2-h}.\tag{8}
$$

We also have

$$
\xi^{-1} = \left\{ \Theta[\mathcal{Y}] \right\}^{h-2} - \left\{ \Theta[\mathcal{Y}] \right\}^{h-1} \tag{9}
$$

where

$$
\Theta[\mathcal{Y}] = \frac{\mathcal{Y}[\xi] - 2}{\mathcal{Y}[\xi] - 1} \tag{10}
$$

is the single-particle partition function. The free energy for the particles in a given quantum state is expressed as

$$
\mathcal{F}[h] = KT \ln \Theta[\mathcal{Y}],\tag{11}
$$

such that for fermions

$$
\mathcal{F}[1] = -KT\ln\left\{1 + \xi^{-1}\right\} \tag{12}
$$

and for bosons

$$
\mathcal{F}[2] = KT \ln \left\{ 1 - \xi^{-1} \right\}.
$$
\n
$$
(13)
$$

Hence, we find the average occupation number

$$
n[h] = \xi \frac{\partial}{\partial \xi} \ln \Theta[\mathcal{Y}] = \frac{1}{KT} \xi \frac{\partial \mathcal{F}}{\partial \xi}.
$$
 (14)

Using the thermodynamic relation $S = -\left(\frac{\partial \mathcal{F}}{\partial T}\right)_{V,N}$, we obtain another general expression for the entropy

$$
S_G[h] = -K \ln \Theta[\mathcal{Y}] - \frac{KT}{\Theta[\mathcal{Y}]} \frac{\partial \Theta[\mathcal{Y}]}{\partial T}
$$
\n(15)

$$
= -K \ln \Theta[\mathcal{Y}] - \frac{KT}{(\mathcal{Y} - 2)(\mathcal{Y} - 1)} \frac{\partial \mathcal{Y}}{\partial T},\tag{16}
$$

where the energy is given by

$$
\mathcal{E} = -\frac{KT^2}{\Theta[\mathcal{Y}]} \frac{\partial \Theta[\mathcal{Y}]}{\partial T} \tag{17}
$$

$$
=-\frac{KT^2}{(\mathcal{Y}-2)(\mathcal{Y}-1)}\frac{\partial\mathcal{Y}}{\partial T},\tag{18}
$$

since we have $\mathcal{E} = \mathcal{F} + T\mathcal{S}$.

Now, if you consider the density matrix ρ , the entropy is found to be [\[2](#page-8-0)]

$$
\frac{S}{K} = -\text{Tr}\,\rho\ln\rho\tag{19}
$$

$$
= -\sum_{n} \mathcal{W}(n)\mathcal{P}(n)\ln \mathcal{P}(n) \tag{20}
$$

where

$$
\mathcal{W}(n) = \frac{[G + (nG - 1)(h - 1)]!}{[nG]! [G + (nG - 1)(h - 1) - nG]!}
$$
\n(21)

is the statistical weight for the classes of fractons and $N = nG$ is the number of particles, G is the number of states, n is the average occupation number [\[1\]](#page-8-0). The microstate probability is given by

$$
\mathcal{P}(n) = p^{nG}q^{[n(h-2)+1]G},\tag{22}
$$

with $p + q = 1$ and the total probability is unity

$$
\sum_{n} \mathcal{W}(n)\mathcal{P}(n) = 1.
$$
\n(23)

Differentiating this last expression with respect to p , we find

$$
n\left[\frac{q}{p} + 2\right] - nh = 1\tag{24}
$$

and defining $\left[\frac{q}{p} + 2\right] \equiv \mathcal{Y}[\xi]$, we obtain again the fractal distribution function. Considering now the Eq.(20) plus the Eqs.([21](#page-3-0)) and (22) we have another derivation of the Eqs.([5](#page-2-0)) and (6) for the fractal von Neumann entropy.

The entropies for fermions $\left\{\frac{1}{2}\right\}$ $\frac{1}{2}$, $\frac{3}{2}$ $\frac{3}{2}, \frac{5}{2}$ $\frac{5}{2}, \cdots \Big\}$ $h=1$ and bosons $\{0, 1, 2, \cdots\}$ $h=2$, can be recovered promptly

$$
S_G[1] = -K\left\{n\ln n + (1-n)\ln(1-n)\right\}
$$
 (25)

and

$$
S_G[2] = K\{(1+n)\ln(1+n) - n\ln n\}.
$$
 (26)

For fractons of the self-dual class $\begin{cases} \frac{1}{4} \end{cases}$ $\frac{1}{4}$, $\frac{3}{4}$ $\frac{3}{4}$, $\frac{5}{4}$ $\frac{5}{4}, \cdots \Big\}$ $h = \frac{3}{2}$, we have

$$
S_G\left[\frac{3}{2}\right] = K\left\{(2+n)\ln\sqrt{\frac{2+n}{2n}} - (2-n)\ln\sqrt{\frac{2-n}{2n}}\right\}
$$
(27)

and for two more examples, the dual classes $\left\{\frac{1}{3}\right\}$ $\frac{1}{3}, \frac{2}{3}$ $\frac{2}{3}, \frac{4}{3}$ $\frac{4}{3}, \cdots \Big\}$ $h=\frac{4}{3}$ and $\left\{\frac{1}{6}\right\}$ $\frac{1}{6}, \frac{5}{6}$ $\frac{5}{6}, \frac{7}{6}$ $\frac{7}{6}, \cdots \}$ $h=\frac{5}{3}$, the entropies read as

$$
\mathcal{S}_G \left[\frac{4}{3} \right] = K \left\{ (3+n) \ln \sqrt[3]{\frac{3+n}{3n}} - (3-2n) \ln \sqrt[3]{\frac{3-2n}{3n}} \right\}
$$
 (28)

and

$$
\mathcal{S}_G\left[\frac{5}{3}\right] = K\left\{(3+2n)\ln\sqrt[3]{\frac{3+2n}{3n}} - (3-n)\ln\sqrt[3]{\frac{3-n}{3n}}\right\}.
$$
 (29)

We have also introduced the topological concept of *fractal index* asssociated with each class (h is a geometrical parameter related to the quantum path of the particles) and defined by[[3\]](#page-8-0)

$$
i_f[h] = \frac{6}{\pi^2} \int_{\infty(T=0)}^{1(T=\infty)} \frac{d\xi}{\xi} \ln \{ \Theta[\mathcal{Y}(\xi)] \}
$$
(30)

so we obtain for the bosonic class $i_f[2] = 1$, for the fermionic class $i_f[1] = 0.5$ and for some classes of fractons we have $i_f[\frac{3}{2}]$ $\frac{3}{2}$] = 0.6, i_f [$\frac{4}{3}$ $\frac{4}{3}$] = 0.56, i_f [$\frac{5}{3}$] $\frac{5}{3}$ = 0.656. Thus for the interval of definition $1 \leq h \leq 2$, there exists the correspondence $0.5 \leq i_f[h] \leq 1$, which signalizes the connection between fractons and quasiparticles of the conformal field theories, in accordance with the unitary $c < 1$ representations of the central charge.

On the other hand, fractons satisfy a fractal-deformed Heisenberg algebra which generalizes the fermionic and bosonic ones. The fractal-deformed Heisenberg algebra is obtained of the relation

$$
\mathbf{a}(x)\mathbf{a}^{\dagger}(y) - f[\pm h]\mathbf{a}^{\dagger}(y)\mathbf{a}(x) = \delta(x - y),\tag{31}
$$

between creation and annihilation operators. The factor of deformation is defined as

$$
f[\pm h] = \exp(\pm ih\pi),\tag{32}
$$

such that for $h = 1$ and $x = y$, we reobtain the fermionic anticommutation relations $\{a(x), a^{\dagger}(x)\} = 1$, and for $h = 2$ and $x = y$, we reobtain the bosonic commutation relations $[\mathbf{a}(x), \mathbf{a}^{\dagger}(x)] = 1$. If $x \neq y$ and $1 < h < 2$, we have nonlocal operators for fractons

$$
\mathbf{a}(x)\mathbf{a}^{\dagger}(y) = f[\pm h]\mathbf{a}^{\dagger}(y)\mathbf{a}(x). \tag{33}
$$

The braiding relations have the hermiticities

$$
\mathbf{a}(x)\mathbf{a}^\dagger(y) = f[+h]\mathbf{a}^\dagger(y)\mathbf{a}(x) \tag{34}
$$

$$
\mathbf{a}^{\dagger}(x)\mathbf{a}(y) = f[+h]\mathbf{a}(y)\mathbf{a}^{\dagger}(x) \tag{35}
$$

$$
\mathbf{a}(x)\mathbf{a}^{\dagger}(y) = f[-h]\mathbf{a}^{\dagger}(y)\mathbf{a}(x) \tag{36}
$$

$$
\mathbf{a}^{\dagger}(x)\mathbf{a}(y) = f[-h]\mathbf{a}(y)\mathbf{a}^{\dagger}(x) \tag{37}
$$

$$
\mathbf{a}(x)\mathbf{a}(y) = f[+h]\mathbf{a}(y)\mathbf{a}(x) \tag{38}
$$

$$
\mathbf{a}^{\dagger}(x)\mathbf{a}^{\dagger}(y) = f[+h]\mathbf{a}^{\dagger}(y)\mathbf{a}^{\dagger}(x)
$$
\n(39)

$$
\mathbf{a}(x)\mathbf{a}(y) = f[-h]\mathbf{a}(y)\mathbf{a}(x) \tag{40}
$$

$$
\mathbf{a}^{\dagger}(x)\mathbf{a}^{\dagger}(y) = f[-h]\mathbf{a}^{\dagger}(y)\mathbf{a}^{\dagger}(x),\tag{41}
$$

where the plus sign of h stands for anticlockwise exchange and the minus sign of h for clockwise exchange.

The statistics parameter ν for the plus sign has the pattern

$$
\{-, +, -, +, \cdots\}_h \tag{42}
$$

and the minus sign, gives us another one

$$
\{+, -, +, -, \cdots\}_h. \tag{43}
$$

For example, consider the class $h = \frac{3}{2}$ $\frac{3}{2}$, then

$$
\left\{\mp\frac{1}{2}, \pm\frac{3}{2}, \mp\frac{5}{2}, \pm\frac{7}{2}, \cdots\right\}_{h=\frac{3}{2}},\tag{44}
$$

i.e.

$$
f[+h] = e^{-i\frac{1}{2}\pi} = e^{+i\frac{3}{2}\pi} = e^{-i\frac{5}{2}\pi} = e^{+i\frac{7}{2}\pi} = \cdots
$$
\n(45)

and

$$
f[-h] = e^{+i\frac{1}{2}\pi} = e^{-i\frac{3}{2}\pi} = e^{+i\frac{5}{2}\pi} = e^{-i\frac{7}{2}\pi} = \cdots.
$$
 (46)

As we can see, in each class, the particles with different values of statistics parameter ($\nu = 2s$) have unambiguously distinct braiding properties to obey the fractal distribution function determined by the parameter h.

The phase of the wave function (consider two-particle system) changes by $+\pi\nu$ (anticlockwise exchange) and $-\pi\nu$ (clockwise exchange) in response to which way we braid in interchanging x and y . On the one hand, the violation of the discrete symmetries of parity and time reversal is verified for such fractons, i.e.

$$
e^{\pm i\pi\nu} \longrightarrow e^{\mp i\pi\nu}.\tag{47}
$$

We have applied these ideas in some systems of the condensed matter such as fractional quantum Hall effect[[1\]](#page-8-0) and Luttinger liquids [\[4](#page-8-0)]. Besides this we have also considered some connection with conformal field theories [\[3\]](#page-8-0) . Another direction of research is the connection between Number Theory and Physics as explicited by our formulation[[1,3\]](#page-8-0). There exists other possibilities of application, for example, we are considering the study of entanglement states for fracton quantum computing [\[5](#page-8-0)].

In conclusion, we have considered in this Letter, the fractal von Neumann entropy associated with the fractal distribution function for some universal classes h of fractons. The derivation of the Eqs.(5) and (6) obtained in Ref. $[1]$ using the Eq.(20) suggested in Ref. $[2]$ and adapted to our formulation is another result of this paper. We have also determined the fractal-deformed Heisenberg algebras for these classes of fractons which obey specific fractal distribution function. A next step is to consider the construction of the nonlocal operators for fractons taking into account an angle function as discussed in $|6|$.
