A new analytical m ethod for self-force regularization I. scalar charged particle in Schwarzschild spacetime

W e form ulate a new analytical m ethod for regularizing the self-force acting on a particle of sm all mass orbiting a black hole of mass M, where M.At rstorder in , the geometry is perturbed and the motion of the particle is a ected by its self-force. The self-force, how ever, diverges at the location of the particle, and hence should be regularized. It is known that the properly regularized self-force is given by the tail part (or the R -part) of the self-eld, obtained by subtracting the direct part (or the S-part) from the full self-eld. The most successful method of regularization proposed so far relies on the spherical harm onic decom position of the self-force, the so-called m odesum regularization or mode decom position regularization. However, except for som e special orbits, no system atic analytical method for computing the regularized self-force has been given. In this paper, utilizing a new decomposition of the retarded G reen function in the frequency domain, we form ulate a system atic m ethod for the com putation of the self-force. O urm ethod relies on the post-Newtonian (PN) expansion but the order of the expansion can be arbitrarily high. To dem onstrate the essence of our method, in this paper, we focus on a scalar charged particle on the Schwarzschild background. The generalization to the gravitational case is straightforward, except for som e subtle issues related with the choice of gauge (which exists irrespective of regularization m ethods).

I. IN TRODUCTION

We are now at the dawn of gravitational wave astronom y/astrophysics. The interferom etric gravitational wave detectors, LIGO [1], TAM A 300 [2] and GEO 600 [3] are currently in the early stage of their operations, and VIRGO [4] is expected to be in operation soon. Furtherm ore, R & D studies of a space-based interferom eter project, LISA [5], are in rapid progress. These interferom eters, after their nal sensitivity goals are achieved, are expected to detect gravitational waves from compact star binaries or compact stars orbiting super-m assive black holes.

To fully utilize the information contained in the observed gravitational wave data, particularly for the purpose of a precision test of general relativity, it is essential to have accurate theoretical predictions of the waveforms [6]. For nearly equal mass binaries, the standard PN approximation is a powerful tool to compute the waveforms [7]. An alternative method of computing the waveforms is the black hole perturbation approach [8{13}]. This approach is very elective, in particular, when the mass ratio of the objects composing a binary is extremely large. In this paper, concerned with the cases of such extrement mass ratios, we propose a new method for calculating the corrections to the force acting on the small mass body (which is treated as a point -particle) that are induced by the eld generated by the particle itself, the so-called self-force corrections.

In the black hole perturbation approach, one m ay appeal to the energy-angular m om entum balance argum ent to evaluate the radiation reaction to the orbit of a particle, namely, by equating the rates of change of the energy and angular m om entum of a particle with those carried away by the gravitationalwaves em itted by the particle. How ever, the balance argum ent will not be su cient. First, the radiation reaction to the Carter constant is not calculable by this m ethod. The Carter constant is the third constant of m otion of a test particle in the K err spacetime. The other two constants of m otion, the energy and angular m om entum with respect to the sym m etry axis, are associated with the K illing vectors of the background spacetime, and their rates of change m ay be evaluated by the gravitational waves em itted to in nity or absorbed to the black hole horizon. In contrast, there is no correspondence to any such K illing vector in the case of the Carter constant. Hence, its rate of change is not directly related to the waves em itted. Second, and m ost im portantly, the balance argum ent can give only the tim e-averaged rates of change of the two constants of m otion, while there are m any situations in which the know ledge of the actual radiation reaction force as well as the so-called conservative part of the self-force at each instant of the orbital m otion becomes necessary.

Consider a particle having either a scalar, electrom agnetic or gravitational charge. The orbital motion of the particle will induce a eld at rst order in its charge, and the motion will be a ected by its self-eld. The self-eld is, how ever, divergent at the location of the particle. Hence, the force due to this self-eld is apparently ill-de ned. It is known that the self-force in the vicinity of the particle may be decom posed into the so-called direct part and the tail part, and that the correctly regularized self-force is given by the tail part. The justi cation of this prescription is given in [14] for the scalar and electro-m agnetic cases, and in [15, 16] for the gravitational case.

In the scalar case, the K lein-G ordon equation is hyperbolic from the very beginning. In the electrom agnetic and gravitational cases, the eld equations can be put in the hyperbolic form by choosing the Lorenz gauge (it is offen called the harm onic gauge in the gravitational case). In general, for a hyperbolic equation, the retarded G reen function $G^{ret}(x;x^0)$ can be split into two distinct pieces (at least locally when the two points, namely, the eld point x, and the source point x^0 , are close enough), which is called the H adam and form . O ne part has support only on the future light-cone of x^0 . The form er gives the direct part and the latter the tail part. Recently an equivalent but m ore elegant decom position of the G reen function was proposed [17], in which the direct part is replaced by the S-part and the tail part by the R-part. The S-part is de ned by adding a piece that has support outside the light-cone in such a way that it does not contribute to the self-force when it is subtracted from the full eld. The rem aining part is called the R-part, which now has support outside the light-cone as well. The advantage of this new decom position is that the S-part is symmetric with respect to x and x^0 , and it satis es the same equation as the retarded G reen function does. This im plies that the R-part now satis es the source-free, hom ogeneous equation.

Thus our task is to evaluate the tail or R-part of the eld and the self-force due to this part. However, we do not have any system atic method to compute the R-part directly. In contrast, there exist several schemes to compute the full retarded eld in Schwarzschild or K err spacetime [8{13, 18{21}}. Therefore, what one can do is to subtract the direct or S-part from the full eld to compute the regularized self-force, and there have been m any discussions on this method [22{28].

Since both the full eld and the S-part diverge at the location of the particle, it is necessary to develop a regularization scheme to compute the di erence between the two. The most successful scheme of regularization that has emerged is the mode decomposition (or mode-sum) regularization [22, 23]. The full eld can be decomposed into partial waves by using the spherical harm onics $Y_{\rm im}$ (). Then, the contribution to the force from each '-m ode does not diverge in the coincidence limit of the eld point with the location of the particle. If we subtract the S-part from the full eld before taking sum mation over ', the divergence disappears. Hence, we can perform sum mation over ' to obtain the expression for the regularized force.

There still remain several problems to be solved in actual computations. Since the S-part can be calculated only in the form of a local expansion, that is, at eld points su ciently close to a point on the orbit, it is necessary to extend it over a sphere containing the orbital point to obtain the spherical harm onic coe cients. On the other hand, the full eld is calculated with either Regge-W heeler-Zerilli or Teukolsky form alism, which heavily relies on the Fourier decomposition of the time-dependence by taking full advantage of the stationarity of the background spacetime, in addition to the spherical (or spheroidal in the Kerr case) harm onic decomposition. Thus, at least in analytic computations, the full eld may be calculated in the frequency dom ain. Therefore, the descriptions of the full eld and the S-part are very di erent, and taking the di erence between the two is not at all straightforward.

As for the S-part, a method of its harm onic decom position was developed in the Schwarzschild case [2{27], and it was recently extended to the case of the Kerr background [28]. But there is still a mism atch: The full eld is given in the frequency domain, while the S-part is in the time domain. If the orbit is specified a priori, it is in principle possible to obtain the full eld in the time domain by explicitly performing the integration (or summation) over the frequency !. But, in practice, the explicit integration over ! is possible only in some special cases such as the case of circular orbits [29, 30], though, as an alternative approach, one may numerially work in the time domain from the begining [31].

In this paper, we propose a new method to perform the integration over !. Though we employ the PN expansion, the order of the expansion can be arbitrarily high as long as it is nite, assuming the convergence of the PN expansion. For simplicity, we also restrict our analysis to the case of a geodesic orbit on the background spacetime, but removing this restriction is straightforward (of course, the equations become much more lengthy). Furthermore, we focus on the case of a scalar charge in order to avoid the gauge problem. There is a subtle problem associated with the choice of gauge in the gravitational case [32, 33], but ourmethod for integration over ! is equally applicable to the gravitational case irrespective of this problem.

The key idea of the new approach developed in this paper is to separate the retarded G reen function in the frequency domain into two distinct pieces, in analogy with the S-R decomposition in the space-time domain. We call them the S-part and the R-part. The former contains all the singular terms to be subtracted, while the latter satis as the source-free, hom ogeneous equation. In particular, once the PN order is specified, contribution from only a nite number of ` is necessary to evaluate the R-part. The most important point of this new decomposition is that the S-part in the frequency domain is given in the form of a simple Taylor series with respect to ! multiplied by exp[i! (t t^0)]. Therefore, the integration over ! can be performed easily for such terms. They just produce (t t^0) and its derivatives. Using this technique we may obtain the S-part in the time domain relatively easily. Then, the regularization is done by subtracting the S-part from thus obtained S-part in the time domain.

This paper is organized as follows. In Sec. II, we describe our new decomposition of the retarded G reen function in the frequency domain and show some of the form ulas explicitly to 3PN order in the scalar eld case. In Sec. III,

focusing on the scalar case, we dem onstrate our regularization method. Namely, we rst integrate the force due to the S-part over ! to obtain the harm onic m odes of the force in the time dom ain, subtract the S-part m ode by m ode, and sum over 'to obtain the force due to the (S S)-part. We will not discuss the R-part since it is nite from the beginning. Final section IV is devoted to conclusion and discussions. Some form ulas to 3PN order and proofs of several propositions used in the text are given in Appendices. For readers' convenience, form ulas for 4PN order calculations are placed at the web page: http://www2.yukawakyoto-uac.p/~misao/BHPC/.

II. NEW DECOMPOSITION OF THE GREEN FUNCTION IN FREQUENCY DOMAIN

W e consider a point scalar charge q m oving in the Schwarzschild background,

where fx g = ft;r; ; g are the Schwarzschild coordinates, and M is the black hole mass. The full scalar eld induced by this charged particle is given, using the retarded G reen function, as

Here Y_m (;) are ordinary spherical harm on ics. Then, Eq. (2.3) reduces to an ordinary di erential equation for the radialG reen function as 0

The radial part of the full G reen function is expressed in terms of hom ogeneous solutions of Eq. (2.5), which can be obtained by a system atic analytic method developed in Ref. [18], as

Here the in-going and up-going hom ogeneous solutions are denoted, respectively, by in and up, and is called the renorm alized angular m om entum [18, 19], which is equal to `in the lim it M !! 0.

W e express the hom ogeneous solutions $_{\rm in}$ and $_{\rm up}$ in term s of the solutions $_{\rm c}$ and $_{\rm c}$ $^{-1}$, which are expressed in term s of a series of the C oulom b wave functions [13, 18], as

The properties and the relations of the coe cients f;;; g have been discussed extensively in Ref. [18, 19] (function _ is denoted by R_ in Ref. [18]). Here we need to stress a rem arkable property of the wave function , which becomes manifest when we consider the PN expansion, i.e., when c is expanded in terms of z = !rand 🗧 2M ! assuming they are small, respectively, of 0 (v) and 0 (v³). In the expression of its PN expansion, \approx (2z) $_{c}$ contains only term s which are in integer powers of z and , and there are no term s like log z. In fact, we nd that this condition, that log z is absent, uniquely speci as a single solution of the radial hom ogeneous equation. As is explained in Appendix A, this fact can be used to compute simultaneously determining the eigenvalue . Furtherm ore, this PN expansion turns out to be a double Taylor series expansion in z^2 and =z. That is, there appears only positive powers of !² in the expansion. W ith the norm alization that ! 1 in the leading order, the result up to 3PN order is

We note, however, that the general expression for the PN expansion of $_{\rm c}$ ¹ with this method (i.e., by requiring absence of the log z term s) becomes invalid at the (` 1)th PN order. For small `, the computation must be done following the original method given in Ref. [18]. The results up to `= 4, which is necessary to keep the term s up to 3PN order, are given in Appendix E.

W e now divide the G reen function into two parts,

Here we have assumed that \notin 0 and \notin 0, and also introduced the coecients f^{\sim} ; $\sim g \coloneqq f = ; = g$. U sing the result obtained in Ref. [18], we not that the coecients f^{\sim} ; $\sim g$ behave under PN expansion as

The functions $_{c}$ and $_{c}$ ¹ are, respectively, of 0 (v') and 0 (v ' ¹) (except for '= 0; see Appendix E). Therefore, the three terms in the K-part of the G reen function become, respectively, of 0 (v⁶), 0 (v^{2'+1}) and 0 (v^{4' 1}) relative to the S-part.

The part that we need to take care in the regularization of the force is just the S-part. There is no divergence associated with the remaining \mathcal{R} -part. The \mathcal{R} -part term inates at nite `as far as a nite PN order is concerned. Moreover, the \mathcal{R} -part satis es the hom ogeneous radial equation. This fact will be an additional advantage of the present method when we consider extension to the case of gravity. Since the \mathcal{R} -part is a hom ogeneous solution, we can apply Chrzanow ski's method [20] to reconstruct the metric perturbations even in the frequency domain. We will discuss this point in more detail in a separate paper.

III. COMPUTATION OF THE S-PART

W e compute now the force due to the S-part for a general orbit. When expanded in terms of the spherical harm onics, the force corresponding to the S-part (the S-force) is known to take the form [23]

where F^{S} , is the 'm ode of the S-force, L = '+ 1=2, and A and B are independent of L. When summed over ', the A-term gives rise to a quadratic divergence and the B-term diverges linearly. For large ', D \cdot is at most of O (L ²), hence contains no divergence. Since the S-part is calculable only locally, its extension to the whole sphere has some am biguity. As a result, the coe cient of each 'm ode, D \cdot , depends on the way of extension, but the result after summation over ', which is determined by the local behavior of the eld near the source location, does not. It is known that

The di erence between the S-force and the S-force should be nite because the R-force is nite. Thus, in general, the S-force must take the same form as the S-force

Below we con m explicitly that both A and B for the S-force coincide with those for the S-force. Then the force due to the S-part m inus the S-part, which is nite, is given by

A. Force in the time domain

To obtain an expression for the S-force in the form of Eq. (3.3), it is necessary to perform the ! integration explicitly. Here the key fact is that there appears no fractional power of ! in the S-part. This is because we have chosen $_{\rm c}$ and $_{\rm c}$ ¹ as the two independent basis functions. As noted before, except for the overall fractional powers z and z ¹, they contain only the term s with positive integer powers of !². When we consider a product of these two functions, ! contained in the overall factors z and z ¹ just produces ! ¹ which is canceled by ! from the inverse of the W ronskian. N am ely, $g_{\rm int}^{\rm S}$ (r;r⁰) is expanded as

Therefore, the integration over ! can be performed easily, as we shall demonstrate below explicitly. The Fourier transform of !²ⁿ simply produces

D i erentiation of the delta function in the expression above can be integrated by parts to act on the source term . Thus, we can express the S-force in the time dom ain as

Here we have inserted a projection tensor P = + u u with u being the four velocity so that the norm alization u u = 1 is maintained. Now that we have the S-force given in the time domain, the meaning of the coincidence limit $r ! z^r(t)$ is transparent.

B. Separation of the A-term

Before performing the operation discussed in the preceding subsection, we separate the A-term from the other contributions. This can be easily done by using the fact that only the A-term has a jump in its values at the coincidence limit, depending on the direction from which one approaches the source point. We divide the S-part G reen function into the symmetric and anti-symmetric parts as

Then the force due to the anti-symmetric part must coincide exactly with the A-term. We know that the A-term for the S-part has a simple form proportional to L, while the expression for the S-force given in terms of the G reen function looks more complicated. The reason why such a simple result for the A-term is recovered is explained in Appendix B.We concentrate now on the symmetric part, which is responsible for the B and D-term s.

C. The (S S)-part of the force

Up to 3PN order, the results of computation of the S part of the force are given explicitly in Appendix D. To obtain the expressions presented there, we used the rst integrals of the geodesic equations

where E and L are, respectively, the energy and the angular momentum of the particle, and we reduced higher derivatives with respect to t by using the equations of motion

As long as we neglect corrections which are higher order in , we can assume that the orbit is momentarily geodesic. Here we nd that the S-part force is solely written in terms of the orbit at the location of the particle (that is, no tails!). Hence, for the correction at the lowest order in , the force coming from the (S S)-part is also written in terms of the position and the velocity of the particle. We do not have any terms with a positive power of ', as is expected. How ever, this cancellation looks rather m iraculous in the present form ulation. In Appendix C, we give a brief explanation why the terms in positive powers of ' are absent. From the asymptotic behavior for large ' we can read o the coe cients B . These coe cients agree with the results obtained previously. As mentioned earlier, a separate treatment is necessary for small '. The radial functions for ' 4 are given in Appendix E. The S-part of the force from these lower 'm odes is also explicitly shown there.

Once we obtain the general expression for the $(S \circ S)$ -part of the force, computation of the remaining R -part is rather easy, since only terms up to a nite `contribute to the force for a given PN order.

Now we discuss a technical but in portant property of the S-part of the G reen function. The two independent radial functions at the leading order in are given by the spherical B essel functions j(z) and n(z). Both c and c ¹ are given by linear combinations of these two independent solutions. Up to O (⁰), we have c / j(z) while ¹ / ¹ j(z) + C(n(z)), where C(z) is a constant of order unity. Here, in passing, we note that the leading term of ^c ¹ in the PN expansion comes not from the term ¹ j(z) but from n(z) for 2. This is because the ratio of the two terms is j(z) = (n(z)) / z²² = O (v²) in the PN expansion. At rst glance, the existence of the term ¹ j(z) seem s problem atic, since it would naively lead to a term in the G reen function that behaves as 1=M. At the lowest order in M , the trajectory of a particle is a straight line in the M inkow skibackground. Since the above expression for the leading part of the G meen function is Lorentz invariant, we can choose the straight line to be a static one without loss of generality. A nother in portant property of the force due to the (S S)-part is that it contains only the conservative part of the force. IV. CONCLUSION AND DISCUSSIONS

The present work is an attempt towards a more realistic (calculation e ective) analytic scheme for constructing orbits, taking into account the radiation reaction e ects. The key idea proposed in this paper is a new decomposition of the G reen function into the S and R parts, given in Eq. (2.10). This new decomposition relies on the system atic analytic approach to the black hole perturbation developed in Refs. [13, 18, 19]. The new decomposition is not identical to the usual S and R decomposition [17], but has common properties. The S part is singular and symmetric, and it satis es the same inhom ogeneous equation as the G reen function. The R part is regular, and it satis es the source free equation. Considering a scalar charged particle, we showed that the S part of the self-force can be evaluated analytically in the time dom ain, and that it yields the same regularization parameters A and B in the m ode-decom position regularization as the usual S -part. This means that the S -part contains all the singular behavior of the original S -part. A lso, we showed that the self-force due to the (S S)-part is conservative. M oreover, we found that the R -part of the force valid up to (`+ 0:5)th Post-N ewtonian (PN) order can be obtained by taking account of only the spherical harm onics modes up to the `-th order.

The analysis here was restricted to the self-force due to a scalar eld for its simplicity. The extension to the electrom agnetic case is straightforward, although the computation of the force from the master variable of perturbations [11] becomes more tedious. The gravitational case, however, is more complicated since the self-force is gauge dependent. In the scalar case, as is manifest from our calculation, the computation of the S-part was in fact unnecessary if we made use of the known fact that the non-singular part of the regularization parameter D \sim for the S-part vanishes after summing over `modes. By virtue of this fact, the simple prescription of subtracting A and B-terms is valid in this case. In the case of gravity, before subtracting the S-part from the S-part of the force, we need to adjust the gauges which are originally di erent. A natural prescription for this is to transform the S-part, originally given in Lorenz gauge, to the gauge in which the S-part is computed. Due to this gauge transform ation, the parameter D \sim will not vanish in general. This needs to be studied in more details.

Related to the gauge dependence of the gravitational self-force, there arises a conceptual question. W hat kind of gauge-independent notions are contained in this, otherw ise gauge-dependent, quantity? There are several constants of m otion for geodesics on the background black hole spacetime. These constants of m otion evolve after we incorporate the self-force. However, the secular change of the constants of m otion" has a gauge-invariant meaning. It may be evaluated by merely taking account of the force due to the R-part, or we can simply use the radiative G reen function [34]. In addition to the information on the constants of motion, the self-force may contain other gauge-invariant information. This question needs to be answered, although it is not a problem speci c to our present

m ethod. We may nd that the physical information contained in the gauge-dependent self-force by itself is very limited. Even if it is the case, calculation of the self-force will be a necessary step to develop a black hole perturbation theory to second order in m ass of the orbiting particle.

O ne of the m ain advantages in our m ethod is the successful in plem entation of a system atic post-N ew tonian expansion technique in the black hole perturbation. A lthough we gave results up to 3PN order (4PN is available at link http://www2.yukawa.kyoto-u.ac.jp/~m isao/BHPC/), the m ethod can be easily extended to any desired PN order, depending upon com putational resources.

There could be a criticism to our approach in regard to the limitation of PN expansion itself. The black hole perturbation is considered to be a method complimentary to the standard post-Newtonian approximation. In this sense, one might think that there is no point in using PN expansion in the black hole perturbation approach. However, we should stress the point that the PN expansion of the perturbation in the black hole spacetime can be system atically extended to an arbitrarily high order without any conceptual di culties. Hence, if we can make use of this advantage, problem s far beyond the validity of the nite order standard post-Newtonian approximation can be investigated.

In an actual computation, the achievable PN order will be limited. Then the question will be the speed of convergence of PN expansion. In this respect, there are a couple of encouraging evidences. First, we mention the issue of the innerm ost stable circular orbit (ISCO). At present, calculation of the orbital frequency at ISCO up to 3PN order is available [35]. The result is in rather good agreement with numerical estimation for an equal-mass binary [36]. Second, we mention the energy bass rate of a particle in a circular orbit in the Schwarzschild black hole evaluated from the asymptotic waveform [12]. A though the convergence of PN expansion gets slower and slower for a smaller orbital radius, there is no evidence of failure of convergence even at ISCO [37]. Hence, if we can develop a systematic method of evaluating the gravitational self-force in PN expansion, its range of validity will be very wide.

The right-hand side is of higher order in the PN expansion. Substituting Taylor expansion of with respect to =z and z^2 to the above equation, the coe cients are determined order by order. However, the z-independent terms in vanish on the left-hand side. Therefore, the terms which becomes zeroth order in z should also vanish on the right-hand side. This condition determines order by order. If, however, 'is not su ciently large, the terms proportional to $z^{2'-1}$ arise. For such terms the left-hand side is suppressed by a factor of (2).
