Supersymmetric penguin contributions to the process $B_d \longrightarrow \Phi K_s$ in SUSY GUT with right-handed neutrino.

Abstra
t

The $B_d \longrightarrow \Phi K_s$ process is without tree level decay amplitude. Then the SUSY ontributions may be signi
ant . We al
ulate the neutralino and gluino penguin contributions to the CP violating phase in $SU(5)$ grand unified theory with righthanded neutrino $SU(5)_{RN}$. We find that the SUSY contributions change the phase in $B_d \longrightarrow \Phi K_s$.

1 Introdu
tion

In the minimal Standard Model(SM) lepton avor is onserved . Then Lepton Flavor Violation (LFV) and flavor changing neutral current (FCNC) is forbidden at tree level. Therefore, the flavor mixing is controlled by the Cabibbo Kobayashi Maskawa (CKM) matrix element . So the phase in the CKM matrix is the only sour
e of the CP violation in the Standard Model (negle
ting the strong CP problem) .

However, in supersymmetri (SUSY) models there is a new sour
e of avor mixing in the mass matri
es of SUSY partners for leptons and quarks . In the ontext of minimal Supergravity $(mSUGRA)$, where SUSY breaking parameters are assumed to be flavor blind ale, the avorage is the avorage is the avorage is the controlled by the CKM matrix elements of the CKM matrix e result, the maximal deviation from the SM in the CP violating parameters is of the order of 10%, while the SUSY contribution to $b \longrightarrow s\gamma$ process can be much more important [1]. In the GUT scenario, there are additional contributions to FCNC/LFV process from GUT interaction[2]. As for LFV processe the $\mu \longrightarrow e\gamma$ branching ratio is closed to the current experimental bound, especially for $SO(10)$ model $[3]$. Experimental evidences of neutrino oscillation indicate the existence of small neutrino mass and large flavor mixing in the lepton sector. A natural explanation for small neutrino masses is the seesaw mechanism^[4] . In this me
hanism, heavy right-handed neutrinos are introdu

tor . In the Supersymmetri Grand Unied theory (GUT) with right-handed neutrino, above the GUT s

tor may be transferred to the right-handed down type squark mass matrix $[5]$, which affects the CP violation in the B decay

The $B_d \longrightarrow \Phi K_s$ process is without tree level decay amplitude. Then the SUSY contributions may be significant. The SUSY contributions, to the CP violation in this process. are gluino, neutralino and chargino. In the $B_d \longrightarrow \Phi K_s$ process, gluino and neutralino interact with down type squark-quark (fig 10,11), whereas the charginos interact with up type squarks. So in our model, $SU(5)_{RN}$, only gluino and neutralino contributions are concerned by flavor violation in the slepton sector.

In this context we calculate the neutralino and gluino penguin contributions to the CP violation in the process $B_d \longrightarrow \Phi K_S$. Then, the SUSY contributions can be large and the phase in the decay amplitude can be as large as $O(0.1)$ which is much larger than the SM . In our calculation we apply the multimass insertion method $[6]$. We take into account the mixing of the squark eigenstates as well as the mixing in the neutralino se
tor and we consider the case of large mixing between second and third generation, suggested by the atmospheric neutrino problem $[10]$. The calculation of the neutralino contribution is new . Previous gluino calculation can be found in the reference $[9]$ equation $(A.16)$, where mass insertion method has been used". In this calculation to obtain the results presented in figure (2) by the author, we must take the derivative of the equation $(A.16)$ of the reference [9] Consequently, we have also calculated the gluino contribution, with multimass insertion method (where the left and right squark masses are taken into account).

This paper is organized as follows . In section 2 the $SU(5)$ grand unified theory with righthanded neutrino $SU(5)_{RN}$ is introduced. In section 3, we give the explicit expressions of the amplitudes associated to the neutralino and gluino contributions to the decay $B_d \longrightarrow \Phi K_s$ $(b \rightarrow s\Phi)$. Finally, in section 4 we find the numerical results on the SUSY contributions to the decay phase for different values on SUSY parameters. In section 5 we conclude. In annex, the analyti expressions for the Feynman integrals, whi
h appear in the evaluation of the amplitudes, are given .

2 $SU(5)$ grand unified theory with right-handed neutrinos $SU(5)_{RN}$

We consider the supersymmetric $SU(5)$ grand unified theory (GUT) with right-handed neutrinos, as an extension of the Minimal Supersymmetri Standard Model with right-handed neutrinos (MSSMRN)[5], $[6]$, $[7]$. Above, the GUT scale the superpotential is:

where Ψ_i (the quark doublet), Φ_i (the charged lepton doublet) and N_i (the right-handed neutrino) are 10, $\overline{5}$ and singlet matter fields of $SU(5)$ in i-th generation, while \overline{H} and H are Higgs fields in 5^* and 5 representations, such that : $H = (H_2, H_c)$ and $H = (H_1, H_c)$. Finally, H_1 , H_2 are the Higgs multiplets of the MSSM and H_c , \overline{H}_c are two different colored Higgs multiplets . Here M_N is the Majorana mass matrix for right-handed neutrinos. For simplicity, we chose degenerate Majorana mass matrix for the right-handed neutrinos :

The Yukawa matrix Y_U is a complex symmetric matrix, while Y_D and Y_N are complex. It is convenient to work in the basis where Y_D is diagonal. Then we have:

Moreover, V_Q and V_L are unitary mixing matrices parametrized by three mixing angles and on CP violating phase .

At GUT scale $(M_{GUT} \approx 1.9 \times 10^{16} \text{GeV})$, the GUT gauge symmetry is spontaneously broken into the SM one : $SU(5)_{GUT} \rightarrow SU(3)_c \times SU(2)_L \times U(1)_Y$. So, at low energy, Ψ^i contains $Q^i(3,2,\frac{1}{6}), \overline{U}^i(\overline{3},1,-\frac{2}{3})$ and $\overline{E}^i = (1,1,1),$ quark and lepton superfields . $\overline{\Phi}^i$ includes $\overline{D}^i(3,1,\frac{1}{3})$ and $L^i = (1,2,-\frac{1}{2})$ quark and lepton superfields . \overline{N}^i is a singlet of $SU(3)_c \times SU(2)_L \times U(1)_Y$. The representations for SU(3), SU(2) groups and $U(1)_Y$ charge are indicated in parenthesis. Then the GUT multiplets in terms of MSSM field are:

In the $SU(5)$ limit, the naive GUT relation is predicted $\hat{Y}_E = \hat{Y}_D$ at the GUT scale. Although this relation gives a reasonable agreement for m_b and m_{τ} , it is well know that the mass ratio of down-type quarks and charged leptons in the first and the second generation can not be explained in this way² . Then, in [\(4\)](#page-2-1), the unitary matrix V_Q becomes the CKM matrix : $V_Q \simeq V_{CKM}$. The left-handed neutrino mass matrix induced by seesaw mechanism is :

For a large M_{ν_R} the equation[\(6\)](#page-2-2) becomes non-perturbative below the Planck scale. In terms of MSSM fields, the third term in the superpotential[\(1\)](#page-1-1) can be written as :

The phases $\phi^{(L)}$ and $\phi^{(Q)}$ remain in the colored vertices . The effect of the colored Higgs is negligible at tree level, but affects the soft SUSY breaking mass parameters through the RG effect and generates off-diagonal elements in the mass matrix of down-type squarks. In this model we assume the universality of the scalar mass (m_0) at the reduced Planck scale $M_* \simeq$ $2.4 \times 10^{18} \text{GeV}$. Thus, we adopt the model so-called mSUGRA. Due to the neutrino Yukawa matrix, non-vanishing off diagonal elements are generated. The off-diagonal elements in the mass matrix of right-handed down-type squarks (D) are approximately :

where a_0 is the universal A parameter and R stands for right component . For the lefthanded down-type squarks, the off-diagonal elements in the mass matrix are generated by the top Yukawa oupling, su
h as:

where L stands for left component. These off-diagonal elements mass matrix $[m²/_{\gamma}]_{i3}$ and $[m_{\tilde{J}}^2]_{i3}$ are coefficients of $\Delta B \neq 0$ operators, they change the standard model predictions to the mixing and the decay of the B-mesons.

In this context we calculate the neutralino and gluino penguin contributions to the CP violation in the process : $B_d \longrightarrow \Phi K_s$.

3 Neutralino and gluino penguin ontributions to $B_d \longrightarrow \Phi K_s$

The operators contributing to $B_d \longrightarrow \Phi K_s$ [8] have a structure like $(\overline{s}b)(\overline{s}s)$, then they are indu
ed at the one-loop level in the standard model . Therefore the SUSY ontributions may be significant. The SUSY contribution to the decay amplitude for $B_d \longrightarrow \Phi K_s$ comes from the penguin and box diagrams. In our analysis, we only take into account the chromodipole contribution because, as is mentioned in reference [9], box and color-charge form factor contributions have the same size but the opposite sign^{[3](#page-3-0)}. Consequently, the $\Delta B = 1$ effective Lagrangian onsidered takes the following form:

where m_b is the bottom quark mass, T_{ab}^A is the $SU(3)_c$ generator, $G_{\mu\nu}^a$ is the gluon field and a and b the olor indi
es.

We have calculated the neutralino and gluino contributions to the coefficient C_R^{DM} . We apply the multimass insertion method . The calculation of the neutralino contribution is new. Previous gluino calculation can be found in the reference [9] equation(A.16), where mass insertion method has been used . The results are very large and to obtain the results presented in figure(2) by the author, we must take the derivative of the equation($A.16$) of the reference $[9]$. Consequently, we have also calculated the gluino contribution, with multimass insertion method, to the hromo-dipole operator .

3.1 Neutralino ontribution

We assume neutrino and quark mass hierarchy and $y_{\nu_3} \gg y_{\nu_2} \gg y_{\nu_1}$. From the atmospheric neutrino observation we take :

neutralino and gluino contributions have the same behaviour. For chargino it is different.

These two terms ontribute to the de

The right-right non-diagonal term $(eq.11)$ $(eq.11)$ depends on the neutrino phase and is dominant compare to the left-left one (eq[.12\)](#page-3-3) because $|[V_{CKM}]_{ts}| \ll |[V_L]_{32}|$. So, we only consider the right-right contribution to the $M_{B_d \to \phi K^0}^{(SUSY)}$ decay amplitude. Feynman rules used for the calculation are summarized in figures(10)-(11). In annex, we have the Feynman integrals. In the following we note: $(\overline{m}^2)_{32} = [m_{\gamma}^2]_{32}$. The three kind of diagrams contributing to the decay are illustrated in figure 1 and figure 2.

The functions $FC_3(X), FC_4(X), FC_5(X)$ and $FC_6(X)$ are written in annex.

Finally, the contributions drawn on figure $2(a-b)$ and $2(c-d)$ are identical with the last ones (fig.1:e-h), but they are proportional to m_s due to the left-right diagonal insertion :

3.2 Gluino ontribution.

Due to gluino-gluon intera
tion and the multimass insertion method, the eight diagrams (four in the mass insertion method ase) ontributing to the hromo-dipole are illustrated in figure 3. Due to the flip of chirality on the strange leg, the amplitudes associated to the diagrams(3c) and (3g) are proportional to m_s . Then, these two contributions are negligible omparatively to the others .

From the diagrams illustrated in figure3 we obtain :

Due to the multimass insertion method, all the amplitudes depend on the squark left and right masses (
ontrary to the mass insertion method ase where an average squark mass contribute). Now, we can build the SUSY contribution to the decay amplitude : $M_{B_d \to \phi K^0}^{(SUSY)}$

4 Numerical results on SUSY contribution to the decay phase

In the decay amplitude, we take into account the chromo-dipole term only. Then, with the factorization approximation[11]-[12], the decay amplitude[\(13\)](#page-4-2) takes the following form :

The equation (36) is very sensitive to the standard model contribution. So we choose to take into account the next leading order QCD corrections, with the renormalization scale $\mu = m_b = 5Gev, \alpha_{em}(m_Z) = 1/128, \alpha_s(m_Z) = 0.118$ and $m_t = 176Gev$. So, the Wilson coefficients have the following values :

For each case and different K_{DM} values, we have calculated the decay phase . From the atmospheric result, we take the tau neutrino mass : $m_{\nu_{\tau}} = 0.07eV$ and $V_{L32} = -\frac{1}{\sqrt{2}}$ 2 \ldots right-handed neutrino mass is constrained by the neutrino Yukawa coupling $eq(6)$ $eq(6)$ and the $Br(\mu \to e\gamma)$ experimental bound [6]. So we choose $M_{\nu_R} = 2 \times 10^{14} GeV$. In our numerical analysis we have used the suspectz $\,$ program by which is possible to obtain the sparticle

mass spectrum for different values on SUSY parameters that is $:m_0, m_{1/2}, \tan \beta, sign(\mu)$. In this program RG evolution of parameters is taken into account. To fix the gluino mass we take $m_{1/2} = 200$ Gev and $sign(\mu)$ positive. These values are given in tables: 1, [2,](#page-8-1) [3](#page-8-2) and are consistent with $Br\left(\mu\to e\gamma\right)$ experimental bound .

and gluino ones $eq(42)$ $eq(42)$ on figures 7-9.

From the results obtained, we remark the following .

(1) Be
ause of our use of multimass insertion method, the results depend on the gluino, wino, higgsino and squark left and right masses (tables [1,](#page-8-0) [2,](#page-8-1) [3](#page-8-2)) .

(2) The gluino and neutralino ontributions have the same behaviour and the upper values are obtained for $m_0 = 500$ Gev (figures 4-9).

(3) As is shown on fig.4 and fig.7, these two contributions are very sensitive to $tan \beta$ and K_{DM} values . They increase with the enhancement of these two parameters .

(4) The dependency on a_0 of the decay phase is presented on fig.6 and fig.9. The phase becomes more important with increasing a_0 parameter.

 (5) In the gluino case, thanks to the gluino mass (500 GeV) , the decay phase is significant for large tan β and moderate K_{DM} values. Indeed, from fig.8, for $a_0 = 0$, tan $\beta = 30$ and $K_{DM} = 1.5$ the upper value of the decay phase is 4.10^{-2} . This value is greater than the uncertainties in the SM calculation $O(10^{-2})$ [8]. Moreover, as is shown on fig.9, for $a_0 = 10$ the gluino contribution is more competitive with the SM one because the upper value is 0.1. Our results are consistent with those of the reference[9] (figure 2). However, our results are much smaller due to multimass insertion method and the value of the $M_{\nu} = 2 \times 10^{14} GeV$ (instead of $M_{\nu_R} = 5 \times 10^{14} \text{GeV}$ in the reference[9]).

(6) For the neutralino case, due to the small values of μ and M_1 (tables [1,](#page-8-0) [2,](#page-8-1) [3](#page-8-2)), the decay phase (fig. 4,5) cannot be competitive with the gluino one for a_0 less than 250 (even for large tan β and K_{DM} values) . The highest value (10^{-3}) is very small in comparison with the uncertainties in the SM model calculation. Nevertheless, for large a_0 ($a_0 \ge 250$) and tan β values, we obtain results (fig.6) greater than 10^{-2} . Then, the neutralino contribution changes the phase in the process $B_d \longrightarrow \Phi K_s$.

5 Con
lusion

In the context of $SU(5)$ grand unified theory with right-handed neutrino, we have calculated the neutralino and gluino penguin contributions to the phase in $B_d \longrightarrow \Phi K_s$. In our calculation, we apply the multimass insertion method . For convenient choices of SUSY parameters, the neutralino contribution to the decay phase is greater than $O(10^{-2})$. For the gluino ontribution the de
ay phase is the order of 0.1 . Then, the SUSY ontributions change the decay phase in the process $B_d \longrightarrow \Phi K_s$.
