Integrability of Supersymmetric Quantum Matrix Models in the Large-N Limit

Abstract

Many physical systems like supersymmetric Yang-Mills theories are formulated as quantum matrix models. We discuss how to apply the Bethe ansatz to exactly solve some supersymmetric quantum matrix models in the large-N limit. Toy models are constructed out of the one-dimensional Hubbard and t-J models as illustrations.

More and more physical systems are formulated as quantum matrix models; notable examples are quantum chromodynamics [1, 2, 3, 4, 5], supersymmetric Yang-Mills theory [6, 7], D-branes [8, 9], M-theory [10, 11] and string theory [12, 13]. The dimensions of these matrices can be interpreted as the numbers of colors or the numbers of D-branes. Taking the limit as the dimensions going to infinity is also of interest; for instance, it is conjectured that the large-N limit captures the essence of quantum chromodynamics like quark confinement [1], and that M-theory in the infinite momentum frame is exactly described by the large-N limit of D0-brane quantum mechanics [10]. Certainly if ways are developed to solve quantum matrix models in the large-N limit, we will understand better the physics of these interesting systems.

In this Letter, we will concentrate ourselves on matrix models whose Hamiltonians preserve the number of partons. These models can be used to describe asymptotic spectra of supersymmetric Yang-Mills theories [6]. It is found that the ubiquitous Bethe ansatz [14] is helpful in solving some of these models, and the Yang-Baxter equation can help us determine if the Bethe ansatz is applicable. In previous papers [15, 16], we provided some examples of bosonic quantum matrix models which can be solved by the Bethe ansatz. Here, we will give first instances of quantum matrix models which contain both fermions and bosons and which are still exactly integrable. Previously, work was done to solve some integrals over finite chains of matrices with both commuting and anti-commuting entries which describe classical integrable systems with supersymmetry (see Ref.[17] and the citations therein). From this perspective, the implication of our discussion here is that certain path integrals over matrices corresponding to quantum integrable systems with supersymmetry can be exactly evaluated, too.

Consider a physical system of bosons with Λ_B degrees of freedom (other than colors or labels for D-branes) and fermions with Λ_F degrees of freedom (again other than colors). (In the context of D-branes, Λ_B is the number of transverse dimensions of the D-branes; in the context of gauge theory, Λ_B gives the number of different values of the longitudinal momentum a gluon can take.) Let the vacuum be trivial. Let $a_{\mu_2}^{\mu_1}(k)$ be an annihilation operator for a boson if $1 \leq k \leq \Lambda_B$, or a fermion if $\Lambda_B + 1 \leq k \leq \Lambda_B + \Lambda_F$. Here μ_1 and μ_2 are row and column indices running from 1 to N (physically they can be color indices or labels for D-branes). The corresponding creation operator is $a_{\mu_2}^{\dagger\mu_1}(k)$. They satisfy typical (anti)-commutation relations, the most important ones being

$$\left[a_{\mu_2}^{\mu_1}(k_1), a_{\mu_4}^{\dagger\mu_3}(k_2)\right] = \delta_{k_1k_2}\delta_{\mu_2}^{\mu_3}\delta_{\mu_4}^{\mu_1}$$

for $1 \leq k_1, k_2 \leq \Lambda_B$; and

$$\left[a_{\mu_2}^{\mu_1}(k_1), a_{\mu_4}^{\dagger\mu_3}(k_2)\right]_+ = \delta_{k_1k_2} \delta_{\mu_2}^{\mu_3} \delta_{\mu_4}^{\mu_1}$$

for $\Lambda_B + 1 \leq k_1, k_2 \leq \Lambda_B + \Lambda_F$.

A typical color-invariant physical state is a linear combination of states of the form

$$\Psi^{K} \equiv N^{-c/2} a_{\nu_{1}}^{\dagger\nu_{2}}(k_{1}) a_{\nu_{2}}^{\dagger\nu_{3}}(k_{2}) \cdots a_{\nu_{c}}^{\dagger\nu_{1}}(k_{c}) |0\rangle.$$

Here we sum over all possible values of the row and column indices. The superscript K is the integer sequence k_1, k_2, \ldots, k_c . The factor of N in this equation serves as a normalization factor in the large-N limit. If we split K into two sequences K_1 and K_2 such that $K_1K_2 = K$, it follows that

$$\Psi^{K} = (-1)^{\epsilon(K_{1})\epsilon(K_{2})}\Psi^{K_{2}K_{1}}$$

where $\epsilon(K_1) = 0$ if the number of integers in K_1 larger than Λ_B is even, and $\epsilon(K_1) = 1$ if it is odd.

A color-invariant observable is a linear combination of operators of the form

$$\gamma_J^I \equiv N^{-(a-1)} a_{\mu_1}^{\dagger \mu_2}(i_1) a_{\mu_2}^{\dagger \mu_3}(i_2) \cdots a_{\mu_a}^{\dagger \nu_a}(i_a) \cdot a_{\nu_a}^{\nu_{a-1}}(j_a) a_{\nu_{a-1}}^{\nu_{a-2}}(j_{a-1}) \cdots a_{\nu_1}^{\mu_1}(j_1).$$

Again we sum over all possible values of the row and column indices. I is the integer sequence i_1, i_2, \ldots, i_a , and J is the sequence j_1, j_2, \ldots, j_a . The factor of N is chosen to ensure that once we act this operator on a state of the form given by Eq.(1), we will get another normalizable state.

It is known that as $N \to \infty$, if there were no fermions, the action of γ_J^I on Ψ^K would be such that a segment of any cyclic permutation of K which is identical to J would be replaced with I [3, 18]. This is the key reason why there is a connection between large-N matrix models and spin chains. With the inclusion of fermions, the situation is similar except that we have to be careful with the signs of the terms:

$$\gamma_{J}^{I}\Psi^{K} = \delta_{J}^{K}\Psi^{I} + \sum_{K_{1}K_{2}=K} (-1)^{\epsilon(K_{1})\epsilon(K_{2})} \delta_{J}^{K_{2}K_{1}}\Psi^{I} + \sum_{K_{1}K_{2}=K} \delta_{J}^{K_{1}}\Psi^{IK_{2}} + \sum_{K_{1}K_{2}K_{3}=K} (-1)^{\epsilon(K_{1})[\epsilon(K_{2})+\epsilon(K_{3})]} \delta_{J}^{K_{2}}\Psi^{IK_{3}K_{1}} + \sum_{K_{1}K_{2}=K} (-1)^{\epsilon(K_{1})\epsilon(K_{2})} \delta_{J}^{K_{2}}\Psi^{IK_{1}} + \sum_{J_{1}J_{2}=J} \sum_{K_{1}K_{2}K_{3}=K} (-1)^{\epsilon(K_{3})[\epsilon(K_{1})+\epsilon(K_{2})]} \delta_{J_{1}}^{K_{3}} \delta_{J_{2}}^{K_{1}}\Psi^{IK_{2}}.$$

In Eq.(3), a summation like $\sum_{K_1K_2=K}$ means that we sum over all possible pairs of K_1 and K_2 such that the concatenated sequence is K. A typical delta function like δ_J^K yields 1 if the sequence K is the same J, and 0 otherwise.

A crucial observation at this point is that Eq.(3), an equation in the context of quantum matrix models in the large-N limit, can be paraphrased in the context of a quantum spin chain containing both bosons and fermions as follows. Consider a spin chain with c sites satisfying the periodic boundary condition. Each site can be occupied either by a boson or a fermion. There are Λ_B possible bosonic states, and Λ_F possible fermionic ones. Let $A_p(1)$, $A_p(2), \ldots, A_p(\Lambda_B)$ be the annihilation operators of these bosonic states, and $A_p(\Lambda_B + 1), A_p(\Lambda_B + 2), \ldots, A_p(\Lambda_B + \Lambda_F)$ be the annihilation operators of the fermionic ones. Attaching daggers as superscripts to these operators turns them to the corresponding creation operators. Then a typical state of a spin chain can be written as

$$\psi^K \equiv A_1^{\dagger}(k_1) A_2^{\dagger}(k_2) \cdots A_c^{\dagger}(k_c) |0\rangle.$$

Define the Hubbard operator [19] as follows:

$$X_p^{ij} \equiv A_p^{\dagger}(i)A_p(j).$$

It is readily seen that the action of a product of Hubbard operators on ψ^K is

$$X_{p}^{i_{1}j_{1}}X_{p+1}^{i_{2}j_{2}}\cdots X_{p+a-1}^{i_{a}j_{a}}\psi^{K} = (-1)^{[\epsilon(k_{1})+\epsilon(k_{2})+\dots+\epsilon(k_{p-1})][\epsilon(I)+\epsilon(J)]} \cdot (-1)^{[\epsilon(i_{a})+\epsilon(j_{a})][\epsilon(k_{p})+\epsilon(k_{p+1})+\dots+\epsilon(k_{p+a-2})]}\delta_{j_{a}}^{k_{p+a-1}} \cdot (-1)^{[\epsilon(i_{a-1})+\epsilon(j_{a-1})][\epsilon(k_{p})+\epsilon(k_{p+1})+\dots+\epsilon(k_{p+a-3})]}\delta_{j_{a-1}}^{k_{p+a-2}}\cdots (-1)^{[\epsilon(i_{2})+\epsilon(j_{2})]\epsilon(k_{p})}\delta_{j_{2}}^{k_{p+1}}\delta_{j_{1}}^{k_{p}}\psi^{k_{1}k_{2}\dots k_{p-1}i_{1}i_{2}\dots i_{a}k_{p+a}k_{p+a+1}\dots k_{c}}$$

for $p + a - 1 \le c$.

We are now ready to identify supersymmetric matrix models with supersymmetric quantum spin chains. Consider the following weighted sum of all cyclic permutations of the states of a quantum spin chain in the following way:

$$\Psi^{K} = \sum_{K_{1}\dot{K}_{2}=K} (-1)^{\epsilon(K_{1})\epsilon(\dot{K}_{2})} \psi^{\dot{K}_{2}K_{1}}$$

where \dot{K}_2 may or may not be empty but K_1 has to be non-empty. This Ψ^K obeys Eq.(2), too. Then after some algebra, it can be shown that

$$\gamma_{J}^{I} = (-1)^{[\epsilon(i_{a})+\epsilon(j_{a})][\epsilon(j_{1})+\epsilon(j_{2})+\dots+\epsilon(j_{a-1})]} \cdot (-1)^{[\epsilon(i_{a-1})+\epsilon(j_{a-1})][\epsilon(j_{1})+\epsilon(j_{2})+\dots+\epsilon(j_{a-2})]} \cdots (-1)^{[\epsilon(i_{2})+\epsilon(j_{2})]\epsilon(j_{1})} \cdot \sum_{p=1}^{c} X_{p}^{i_{1}j_{1}} X_{p+1}^{i_{2}j_{2}} \cdots X_{p+a-1}^{i_{a}j_{a}}$$

because both the left and right hand sides of it satisfies Eq.(3). As the Hamiltonian of a typical matrix model is of the form $\sum_{I,J} h_I^J \gamma_J^I$, where only a finite number of h_I^J 's are non-zero, Eq.(5) provide us a way to transcribe the matrix model into a quantum spin chain with fermions and/or bosons, if for each non-zero h_I^J the numbers of integers in I and J are the same.

Let us give some typical examples to illustrate the idea above. Consider the following supersymmetric matrix model with $\Lambda_B = \Lambda_F = 2$:

$$\begin{aligned} H_{\text{Hubbard}}^{\text{matrix}} &= -\left(\gamma_{12}^{34} + \gamma_{21}^{34} - \gamma_{12}^{43} - \gamma_{21}^{43} + \gamma_{34}^{12} + \gamma_{34}^{21} - \gamma_{43}^{12} - \gamma_{43}^{21}\right) \\ &- \left(\gamma_{31}^{13} + \gamma_{13}^{31} + \gamma_{41}^{14} + \gamma_{14}^{41}\right) + \left(\gamma_{32}^{23} + \gamma_{23}^{32} + \gamma_{42}^{24} + \gamma_{24}^{42}\right) \\ &+ U\gamma_{2}^{2}. \end{aligned}$$

Eq.(5) tells us that the corresponding spin chain model is

$$H_{\text{Hubbard}} = -\sum_{p=1}^{n} \sum_{\sigma=3,4} \left(X_p^{\sigma 1} X_{p+1}^{1\sigma} - X_p^{1\sigma} X_{p+1}^{\sigma 1} \right) -\sum_{p=1}^{n} \left(X_p^{31} X_{p+1}^{42} + X_p^{24} X_{p+1}^{13} + X_p^{14} X_{p+1}^{23} + X_p^{32} X_{p+1}^{41} - X_p^{42} X_{p+1}^{31} - X_p^{13} X_{p+1}^{24} - X_p^{23} X_{p+1}^{14} - X_p^{41} X_{p+1}^{32} \right) -\sum_{p=1}^{n} \sum_{\sigma=3,4} \left(X_p^{2\sigma} X_{p+1}^{\sigma 2} - X_p^{\sigma 2} X_{p+1}^{2\sigma} \right)$$

$$+U\sum_{p=1}^{n}X_{p}^{22}.$$

If we identify the states 1, 2, 3, 4 to be the vacuum state, the state with one spin-up and one spin-down electrons, the state with a spin-up electron only, and the state with a spin-down electron only respectively, we will see that the Hamiltonian in Eq.(6) is nothing but that of the Hubbard model [20]. More specifically, let $c_{p,\uparrow}$ and $c_{p,\downarrow}$ be the annihilation operators of spin-up and spin-down electrons at the *p*-th site respectively. Then we can make the following identifications:

$$c_{p,\uparrow} \leftrightarrow A_p(3); c_{p,\downarrow} \leftrightarrow A_p(4); \text{ and } c_{p,\downarrow}c_{p,\uparrow} \leftrightarrow A_p(2).$$

The Hamiltonian can now be rewritten as

$$H_{\text{Hubbard}} = -\sum_{p=1}^{n} \sum_{\sigma=\uparrow,\downarrow} \left(c_{p\sigma}^{\dagger} c_{p+1,\sigma} + c_{p+1,\sigma}^{\dagger} c_{p\sigma} \right) + U \sum_{p=1}^{n} n_{p\uparrow} n_{p\downarrow}.$$

where $n_{p\uparrow} = c_{p\uparrow}^{\dagger} c_{p\uparrow}$ and $n_{p\downarrow} = c_{p\downarrow}^{\dagger} c_{p\downarrow}$ are the number operators for spin-up and spin-down states at the *i*-th site. This model was shown by Lieb and Wu to be exactly integrable using the Bethe ansatz [21], and is believed to describe many condensed matter phenomena like high- T_c superconductivity, fractional quantum Hall effect, superfluidity, ... etc. [22]

It is not necessary for $\Lambda_B = \Lambda_F$ for a matrix model to be integrable. Consider another celebrated fermionic spin chain model, the t-J model [23, 19]. Its Hamiltonian is given by

$$H_{tJ} = -t \sum_{p=1}^{n} \sum_{\sigma=\uparrow,\downarrow} P\left(c_{p\sigma}^{\dagger} c_{p+1,\sigma} + c_{p+1,\sigma}^{\dagger} c_{p\sigma}\right) P + \frac{J}{2} \sum_{p=1}^{n} \left[\mathbf{S}_{p} \cdot \mathbf{S}_{p+1} - \frac{1}{4} \left(n_{p\uparrow} + n_{p\downarrow}\right) \left(n_{p+1,\uparrow} n_{p+1,\downarrow}\right)\right].$$

In this equation,

$$P = \prod_{p=1}^{n} (1 - n_{p\uparrow} n_{p\downarrow})$$

is the projection operator to the collective state in which no site has 2 electrons. \mathbf{S}_p is the usual spin operator:

$$S_p^x = \frac{1}{2} \left(S_p + S_p^{\dagger} \right);$$

$$S_p^y = \frac{1}{2i} \left(S_p - S_p^{\dagger} \right);$$

$$S_p^z = \frac{1}{2} \left(n_{p\uparrow} - n_{p\downarrow} \right);$$

$$S_p^{\dagger} = c_{p\downarrow}^{\dagger} c_{p\uparrow}; \text{ and}$$

$$S_p = c_{p\uparrow}^{\dagger} c_{p\downarrow}.$$

If $J \ll t$, then this model is equivalent to the Hubbard model in the large-U limit. However, this model is in general different from the Hubbard model. When the values of J and t are such that J = 2t, we say that the model is at the supersymmetric point, and it is integrable. The corresponding integrable matrix model in the large-N limit is

$$H_{\rm tJ}^{\rm matrix} = -t\left(\gamma_{31}^{13} + \gamma_{13}^{31} + \gamma_{41}^{14} + \gamma_{14}^{41}\right) - \frac{J}{4}\left(\gamma_{43}^{34} + \gamma_{34}^{43} - \gamma_{34}^{34} - \gamma_{43}^{43}\right)$$

Note that there are 2 fermionic states (States 3 and 4) but only 1 bosonic state (State 1) in this integrable model.

To date many exactly integrable generalizations of the Hubbard model have been found [24]. We can use the same transcription procedure to write down the corresponding integrable supersymmetric matrix models in the large-N limit.

Besides considering matrix models in which there are only matrix degrees of freedom, we can also consider models, the matrix-vector models, in which there are both matrix and *vector* degrees of freedom. Such models describe, say, mesons in quantum chromodynamics or both quarks and squarks in supersymmetric Yang-Mills theory. For the sake of simplicity, we will confine ourselves to models in which there are only one column vector and one row vector degree of freedom. Let χ^{μ} and $\bar{\chi}_{\mu}$, where again μ runs from 1 to N, be annihilation operators such that typical commutation relations hold. In particular, they obey the following two non-trivial commutators:

$$\left[\chi^{\mu_1}, \chi^{\dagger}_{\mu_2}\right] = \delta^{\mu_1}_{\mu_2}; \text{ and } \left[\bar{\chi}_{\mu_1}, \bar{\chi}^{\dagger \mu_2}\right] = \delta^{\mu_2}_{\mu_1}.$$
 (7)

The following formalism will still hold if we replace the commutators among χ^{μ} 's and $\bar{\chi}_{\mu}$'s with anti-commutators. A typical color-invariant state is a linear combination of the form

$$s^{K} \equiv N^{-(c+1)/2} \bar{\chi}^{\dagger \nu_{1}} a_{\nu_{1}}^{\dagger \nu_{2}}(k_{1}) a_{\nu_{2}}^{\dagger \nu_{3}}(k_{2}) \cdots a_{n_{c}}^{\dagger \nu_{c+1}}(k_{c}) \chi_{\nu_{c+1}}^{\dagger} |0\rangle.$$

An observable is again a linear combination of γ_J^I introduced above. Nevertheless, we find it convenient to introduce the following two kinds of operators:

$$l_J^I \equiv N^{-a} \bar{\chi}^{\dagger \mu_1} a_{\mu_1}^{\dagger \mu_2}(i_1) a_{\mu_2}^{\dagger \mu_3}(i_2) \cdots a_{\mu_a}^{\dagger \mu_{a+1}}(i_a) \cdot a_{\mu_{a+1}}^{\nu_a}(j_a) a_{\nu_a}^{\nu_{a-1}}(j_{a-1}) \cdots a_{\nu_2}^{\nu_1}(j_1) \bar{\chi}_{\nu_1}$$

and

$$r_J^I \equiv N^{-a} \chi_{\mu_{a+1}}^{\dagger} a_{\mu_a}^{\dagger \mu_{a+1}}(i_a) a_{\mu_{a-1}}^{\dagger \mu_a}(i_{a-1}) \cdots a_{\mu_1}^{\dagger \mu_2}(i_1) \cdot a_{\nu_1}^{\mu_1}(j_1) a_{\nu_2}^{\nu_1}(j_2) \cdots a_{\nu_b}^{\nu_{a-1}}(j_a) \chi^{\nu_a}.$$

Actually an l_J^I is a finite linear combination of γ_J^I 's, and so is an r_J^I , though it is no need for us to bother about the details here. (See Ref.[25] for a comprehensive discussion of this.)

Matrix-vector models correspond to spin chain models satisfying *open* boundary conditions. The relation between a γ and Hubbard operators is almost the same as Eq.(5), except that the summation index p runs from 1 to c - a + 1 this time. It can be easily seen that the corresponding Hubbard operators for an l_J^I and an r_J^I are

$$l_{J}^{I} = (-1)^{[\epsilon(i_{a})+\epsilon(j_{a})][\epsilon(j_{1})+\epsilon(j_{2})+\dots+\epsilon(j_{a-1})]} \cdot (-1)^{[\epsilon(i_{a-1})+\epsilon(j_{a-1})][\epsilon(j_{1})+\epsilon(j_{2})+\dots+\epsilon(j_{a-2})]} \cdots (-1)^{[\epsilon(i_{2})+\epsilon(j_{2})]\epsilon(j_{1})} \cdot X_{1}^{i_{1}j_{1}}X_{2}^{i_{2}j_{2}}\cdots X_{a}^{i_{a}j_{a}}$$

and

$$r_J^I = (-1)^{[\epsilon(i_a) + \epsilon(j_a)][\epsilon(j_1) + \epsilon(j_2) + \dots + \epsilon(j_{a-1})]} \cdot \\ (-1)^{[\epsilon(i_{a-1}) + \epsilon(j_{a-1})][\epsilon(j_1) + \epsilon(j_2) + \dots + \epsilon(j_{a-2})]} \cdots (-1)^{[\epsilon(i_2) + \epsilon(j_2)]\epsilon(j_1)} \cdot \\ X_{n-a+1}^{i_1j_1} X_{n-a+2}^{i_2j_2} \cdots X_n^{i_aj_a}$$

respectively.

Let us see how the transcription is put into practice. Consider a matrixvector model with the following Hamiltonian:

$$\begin{aligned} H_{\text{Hubbard}(o)}^{\text{matrix}} &= -\left(\gamma_{12}^{34} + \gamma_{21}^{34} - \gamma_{12}^{43} - \gamma_{21}^{43} + \gamma_{34}^{12} + \gamma_{34}^{21} - \gamma_{43}^{12} - \gamma_{43}^{21}\right) \\ &- \left(\gamma_{31}^{13} + \gamma_{13}^{31} + \gamma_{41}^{14} + \gamma_{14}^{41}\right) + \left(\gamma_{32}^{23} + \gamma_{23}^{32} + \gamma_{42}^{24} + \gamma_{24}^{42}\right) \\ &- U\gamma_{2}^{2} + \mu \left(\gamma_{3}^{3} + \gamma_{4}^{4} + 2\gamma_{2}^{2}\right) \\ &- p_{\uparrow} \left(l_{3}^{3} + r_{3}^{3} + l_{2}^{2} + r_{2}^{2}\right) - p_{\downarrow} \left(l_{4}^{4} + r_{4}^{4} + l_{2}^{2} + r_{2}^{2}\right). \end{aligned}$$

It turns out that the corresponding spin chain model is nothing but a Hubbard model with an open boundary condition [26, 27, 28]:

$$H_{\text{Hubbard}(o)} = -\sum_{i=1}^{n-1} \sum_{\sigma=\uparrow,\downarrow} \left(c_{i\sigma}^{\dagger} c_{i+1,\sigma} + c_{i+1,\sigma}^{\dagger} c_{i\sigma} \right) + U \sum_{i=1}^{n} n_{i\uparrow} n_{i\downarrow} + \mu \sum_{i=1}^{n} \left(n_{i\uparrow} + n_{i\downarrow} \right) - p_{\uparrow} \left(n_{1\uparrow} + n_{n\uparrow} \right) - p_{\downarrow} \left(n_{1\downarrow} + n_{n\downarrow} \right).$$

(We remark that this particular Hubbard model is taken from Ref. [27].)

We have seen in the above discussion how to determine the integrability of a supersymmetric quantum matrix model in the large-N limit — rewrite the Hamiltonian in terms of Hubbard operators, and then test if the Bethe ansatz is applicable by checking if the scattering matrix of the equivalent spin chain model satisfies the Yang-Baxter equation. As for the case of bosonic spin chains, we remark that the operators γ , l and r defined above form a Lie superalgebra [25]. The symmetry of the simplest integrable matrix model, the Ising matrix model, can be described by the Onsager algebra, which is a subalgebra of the cyclix algebra [15]. As a result, all conserved quantities of the Ising model are elements of the cyclix algebra. Likewise, we speculate that the Lie superalgebra describe the symmetry of supersymmetric matrix models, and may even help us determine the integrability of them.
