Hamiltonian and Linear-Space Structure for Damped Oscillators: I. General Theory

The phase space of N damped linear oscillators is endowed with a bilinear map under which the evolution operator is symmetric. This analog of self-adjointness allows properties familiar from conservative systems to be recovered, e.g., eigenvectors are "orthogonal" under the bilinear map and obey sum rules, initial-value problems are readily solved and perturbation theory applies to the *complex* eigenvalues. These concepts are conveniently represented in a biorthogonal basis.

I. INTRODUCTION

Conservative systems are described by self-adjoint time-evolution operators \mathcal{H} on a linear space, with welldeveloped mathematical tools. Eigenvectors are orthogonal and complete, and eigenvector expansions are unique, with coefficients given by projection. Expansion of the initial data solves the dynamics, with each term simply acquiring a phase $e^{-i\omega_j t}$, where ω_j are the eigenvalues.

Indeed much of our very language, e.g., normal modes, energy levels, transition frequencies, photons and phonons, is rooted in eigenvector expansions. These examples already suggest that the present ostensibly classical problems are also relevant in the quantum domain.

However, these concepts are ruined by dissipation, since \mathcal{H} is no longer self-adjoint. This paper shows, for ohmically damped oscillators, that many properties well known from the conservative case can be resurrected, in terms of not the standard inner product, but a bilinear map under which \mathcal{H} turns out to be symmetric. This symmetry is analogous to self-adjointness, and leads to the orthogonality of eigenvectors under the bilinear map, the usual ready solution of initial-value problems and Rayleigh–Schrödinger perturbation theory (RSPT) in the familiar form but applicable to complex eigenvalues.

Serious microscopic discussion of dissipation began with a single linear oscillator coupled to an infinite bath, which is then eliminated from the equations of motion or path integral [1]. A huge body of works generalize this to many nonlinear coupled oscillators [2]. Here, however, we first deal with N coupled *linear*, *classical* oscillators, with coordinates $\phi(\alpha)$, $\alpha = 1, ..., N$, described by

$$d_t^2 \phi(\alpha) + \Gamma(\alpha, \beta) d_t \phi(\beta) + K(\alpha, \beta) \phi(\beta) = 0 \qquad (1.1)$$

(summation convention for Greek indices), with Γ a symmetric non-negative damping matrix and K a symmetric positive matrix of force constants [3]. One can obtain (1.1) by elimination of a bath, giving the dynamics the necessary quantum pedigree; but until Section VI, it can simply be regarded as phenomenological. The non-negativity of Γ may be relaxed, e.g., in continuum models of the electromagnetic field in *gain* media.

Section II sets up the linear-space formalism. However, eigenvector expansions would not be useful unless there

is a convenient projection; for this purpose, the key bilinear map (ψ, ϕ) between state vectors in 2N-dimensional phase space (leading to a biorthogonal basis) is introduced; examples are given in Section III. The application to time-independent perturbation theory (Section IV) for the *complex* eigenvalues and eigenvectors proceeds by mimicking RSPT for conservative systems. Section V briefly discusses the continuum limit $N \to \infty$, recovering results for waves in open systems, which have been studied extensively [4].

Section VI sketches the application to thermal and quantum physics, and to nonlinear oscillators. As a further outlook, Appendix A considers the separation of time scales if one oscillator is light. Adiabatic elimination of its momentum yields effective constrained dynamics, giving an example where the methods still apply also when phase space is *odd*-dimensional. An extensive account can be found in Ref. [5].

The formalism assumes that (a) although \mathcal{H} is not selfadjoint, its eigenvectors f_j are complete, and (b) for all j, $(f_j, f_j) \neq 0$. These are in fact related, and violated only at *critical points* (with measure zero in parameter space) where eigenvectors merge (Section II H and Ref. [6]). A brief treatment focusing on "excess noise" in open systems can be found in Ref. [7].

II. FORMALISM

A. State space and evolution operator

We cast (1.1) in first-order form by introducing the momenta $\hat{\phi}(\alpha)$. Denote the state in phase space as

$$\boldsymbol{\phi} = (\phi, \hat{\phi})^{\mathrm{T}} = (\phi^{1}, \dots, \phi^{2N})^{\mathrm{T}} = \sum_{j=1}^{2N} \phi^{j} \boldsymbol{u}_{j} , \qquad (2.1)$$

where u_j are the basis vectors of this canonical representation, and boldface denotes 2N-vectors. Then

$$d_t \phi = -i\mathcal{H}\phi \,, \tag{2.2}$$

$$\mathcal{H}^{\bullet} = i \begin{pmatrix} 0 & I \\ -K & -\Gamma \end{pmatrix}, \qquad (2.3)$$

with I the $N \times N$ identity. The dots specify whether the indices are contravariant or covariant (cf. Section II D).

Eigenvalues are the roots of

$$J(\omega) \equiv \det(\mathcal{H}^{\cdot} - \omega) , \qquad (2.4)$$

and right eigenvectors f_j are defined by

$$\mathcal{H}\boldsymbol{f}_j = \omega_j \boldsymbol{f}_j \ . \tag{2.5}$$

Left eigenvectors f^{j} will be introduced later. For f_{j} , (2.2) implies the time-dependence $e^{-i\omega_{j}t}$, so

$$\hat{f}_j = -i\omega_j f_j , \qquad (2.6)$$

and one can simply solve (1.1) in the frequency domain for the coordinates, without reference to the momenta:

$$\left[-\omega_j^2\delta(\alpha,\beta) - i\omega_j\Gamma(\alpha,\beta) + K(\alpha,\beta)\right]f_j(\beta) = 0. \quad (2.7)$$

With dissipation, $\operatorname{Im} \omega_j \leq 0$ [8]. Conjugating (2.5), it follows that $\omega_{-j} = -\omega_j^*$ is also an eigenvalue, with $f_{-j} \propto f_j^*$ (see below for normalization and phase). Thus, eigenvalues are paired, except for so-called zero-modes with $\operatorname{Re} \omega_j = 0$ [9]. Indeed, the determinant of $[\cdots]$ in (2.7) has 2N roots ω_j ; if $\Gamma \neq 0$ then typically also all ω_j^2 are different, showing that an eigenvector expansion can only be sought in phase, not coordinate, space.

B. Inner product and bilinear map

In phase space, the standard inner product is [10]

$$\langle \boldsymbol{\psi} | \boldsymbol{\phi} \rangle = \psi(\alpha)^* \phi(\alpha) + \hat{\psi}(\alpha)^* \hat{\phi}(\alpha) , \qquad (2.8)$$

with $\langle \boldsymbol{\phi} | \boldsymbol{\phi} \rangle \geq 0$. Unfortunately, $\langle \boldsymbol{\psi} | \mathcal{H} \boldsymbol{\phi} \rangle \neq \langle \boldsymbol{\phi} | \mathcal{H} \boldsymbol{\psi} \rangle^*$, so $\langle \boldsymbol{f}_k | \boldsymbol{f}_j \rangle \neq 0$ even if $\omega_k \neq \omega_j$.

Our key concept is the bilinear map:

$$(\boldsymbol{\psi}, \boldsymbol{\phi}) \equiv i \big[\psi(\alpha) \hat{\phi}(\alpha) + \hat{\psi}(\alpha) \phi(\alpha) + \psi(\alpha) \Gamma(\alpha, \beta) \phi(\beta) \big]$$

= $(\boldsymbol{\phi}, \boldsymbol{\psi})$. (2.9)

The diagonal entries (ϕ, ϕ) are not positive definite, not even necessarily real [11]. By (2.6), (f_j, f_k) can be expressed in terms of the coordinates alone.

We will justify (2.9) by the ensuing properties, crucially (2.10) below; still, let us motivate it immediately. First consider the conservative case $\Gamma = 0$. A structure $\psi \phi + \hat{\psi} \hat{\phi}$ is not dimensionally correct [10], but $\psi \hat{\phi} + \hat{\psi} \phi$ is. Moreover, with (2.9) an eigenvector pair with coordinates $f_j(\alpha, t) = f_j(\alpha)e^{-i\omega_j t}$ and $f_{-j}(\alpha, t) = f_j(\alpha)^* e^{i\omega_j t}$ will have opposite momenta, hence a zero bilinear map. This would not hold if one vector is conjugated. When there is damping, the last term $\psi \Gamma \phi$ is the only other type with the correct dimension; with a unit coefficient as in (2.9), it ensures

$$(\boldsymbol{\psi}, \mathcal{H}\boldsymbol{\phi}) = (\boldsymbol{\phi}, \mathcal{H}\boldsymbol{\psi})$$
. (2.10)

In the proof, Γ in \mathcal{H} cancels Γ in (2.9). This analog of self-adjointness, as usual, yields "orthogonality"

$$(\mathbf{f}_j, \mathbf{f}_k) = 0$$
 if $\omega_j \neq \omega_k$, (2.11)

including pairs ω_{-j} , ω_j . Taking suitable linear combinations, (2.11) can be extended to level crossings, i.e., multiple independent eigenvectors at one eigenvalue.

C. Normalization and phase

If $(f_j, f_j) \neq 0$ (cf. Section II H), completeness implies

$$\boldsymbol{\phi} = \sum_{j} \frac{(\boldsymbol{f}_{j}, \boldsymbol{\phi})}{(\boldsymbol{f}_{j}, \boldsymbol{f}_{j})} \boldsymbol{f}_{j} . \qquad (2.12)$$

This normalization-independent form is appropriate if small denominators must be handled for $(\mathbf{f}_j, \mathbf{f}_j) \approx 0$. Also, the usual convention for the conservative limit is $f_j(\alpha)f_j(\alpha) = 1$, i.e., $(\mathbf{f}_j, \mathbf{f}_j) = 2\omega_j$ [incidentally explaining the conventional factor i in (2.9)]. Thus, connection with this limit is best expressed via (2.12).

However, in most other circumstances, it is more convenient to adopt the normalization (and phase) convention $(f_i, f_i) = 1$ for all j, in which case

$$(\boldsymbol{f}_j, \boldsymbol{f}_k) = \delta_{jk} \ . \tag{2.13}$$

Unless otherwise specified, expressions that are not manifestly normalization-independent conform to (2.13).

Conjugate eigenvectors have the phase relationship

$$\boldsymbol{f}_{-j} = \pm i \boldsymbol{f}_j^* \tag{2.14}$$

in order to satisfy (2.13) [12].

D. Metric

In the $\pmb{u}\text{-basis}$ [13], $(\pmb{\psi},\pmb{\phi})=\sum_{i,j}\psi^i g_{ij}\phi^j$ in terms of

$$g_{ij} = (\boldsymbol{u}_i, \boldsymbol{u}_j), \qquad g_{\cdot \cdot} = i \begin{pmatrix} \Gamma & I \\ I & 0 \end{pmatrix}.$$
 (2.15)

This, and the inverse metric

$$g^{\prime\prime} = -i \begin{pmatrix} 0 & I\\ I & -\Gamma \end{pmatrix} \tag{2.16}$$

are used to lower/raise indices as usual. This explicit form shows that $g_{\cdot \cdot}$ is non-singular. Moreover, if $(\psi, \phi) = 0$ for every ψ , then $0 = (g^{\cdot \cdot}\phi^*, \phi) = \sum_j |\phi^j|^2$, implying $\phi = 0$. In the eigenbasis, $\bar{g}_{ij} = (f_i, f_j) = \delta_{ij}$.

The crucial symmetry (2.10) translates into the symmetry of $\mathcal{H}_{\cdot \cdot} = g_{\cdot \cdot} \mathcal{H}^{\cdot}_{\cdot}$. Explicitly,

$$\mathcal{H}_{\cdot\cdot} = \begin{pmatrix} K & 0\\ 0 & -I \end{pmatrix}, \qquad (2.17)$$

in the evaluation of which [cf. (2.3) and (2.15)] the cancellation of Γ becomes apparent. Incidentally, $\mathcal{H}_{\cdot\cdot}$ can be expressed directly in terms of the matrix elements $(\psi, \mathcal{H}\phi) = \sum_{i,j} \psi^i \mathcal{H}_{ij} \phi^j$, and using (2.17) gives

$$(\boldsymbol{\phi}, \mathcal{H}\boldsymbol{\phi}) = -\hat{\phi}(\alpha)\hat{\phi}(\alpha) + \phi(\alpha)K(\alpha, \beta)\phi(\beta)$$

= -2L[\vert \vert], (2.18)

where L can be interpreted (at least in the non-dissipative limit) as the Lagrangian.

Although Γ disappears from (2.17), physical quantities of course do depend on the damping. For example, ω_j is the stationary value of $(\phi, \mathcal{H}\phi)/(\phi, \phi)$ attained when $\phi = f_j$. The numerator (2.18) is Γ -independent; but the denominator carries the nontrivial dependence on Γ .

E. Duality

For any basis $\{\boldsymbol{v}_j\}$, there is a dual $\{\boldsymbol{v}^j\}$ such that $\langle \boldsymbol{v}^j | \boldsymbol{v}_k \rangle = \delta^j_k$ [14]. For the canonical basis, $\boldsymbol{u}^n = \boldsymbol{u}_n$, so that the $2N \times 2N$ coefficient matrices (in the \boldsymbol{u} -basis) $(v_j)^n$ and $(v^j)^*_n$ are each other's inverse. However, for the eigenbasis one can bypass this inversion, since (2.13) and (2.15) give $(f^j)_m = \sum_n [g_{mn}(f_j)^n]^*$, that is,

$$\boldsymbol{f}^{j} = \mathcal{D}\boldsymbol{f}_{j} \equiv \left[\boldsymbol{g} \cdot \boldsymbol{f}_{j}\right]^{*}. \qquad (2.19)$$

This is extended to any vector $\boldsymbol{\phi}$, i.e., $\mathcal{D}\boldsymbol{\phi} \equiv [g \cdot \cdot \boldsymbol{\phi}]^*$.

The duals are left eigenvectors $\mathcal{H}^{\dagger} \boldsymbol{f}^{j} = \omega_{j}^{*} \boldsymbol{f}^{j}$. In terms of these, $\boldsymbol{\phi} = \sum_{j} \boldsymbol{f}_{j} \langle \boldsymbol{f}^{j} | \boldsymbol{\phi} \rangle$ and, in an obvious shorthand,

$$\mathcal{I} = \sum_{j} \boldsymbol{f}_{j} \left\langle \boldsymbol{f}^{j} \right| \boldsymbol{\cdot} \right\rangle \,, \qquad (2.20)$$

with \mathcal{I} the $2N \times 2N$ identity. The dual basis leads to a consistent use of contravariant and covariant indices.

F. Sum rules

Writing out (2.20) in components yields four sum rules:

$$0 = \sum_{j} f_j \otimes f_j , \qquad (2.21a)$$

$$I = \sum_{j} \omega_j f_j \otimes f_j , \qquad (2.21b)$$

$$0 = \sum_{j} f_{j} \otimes (\Gamma f_{j}) , \qquad (2.21c)$$

$$0 = \sum_{j} [\omega_j^2 f_j \otimes f_j + i\omega_j f_j \otimes (\Gamma f_j)] . \qquad (2.21d)$$

Here, $a \otimes b$ stands for the matrix with elements $a(\alpha)b(\beta)$. We have verified all these in examples.

For $\Gamma \to 0$, (2.21a), (2.21c) and (2.21d) become vacuous. Namely, all $\operatorname{Re} \omega_j \neq 0$ for small Γ , so the f_j

are paired, obeying (2.14). Thus, e.g., $f_{-j}(\alpha)f_{-j}(\beta) \rightarrow -f_j(\alpha)f_j(\beta)$, making (2.21a) trivial. The remaining (2.21b) reduces to the familiar sum rule for conservative systems (cf. Section II C for the different normalizations).

G. Time evolution

In terms of (2.12), the dynamics is formally solved as

$$\boldsymbol{\phi}(t) = \sum_{j} \phi^{j} e^{-i\omega_{j}t} \boldsymbol{f}_{j}, \qquad \phi^{j} = (\boldsymbol{f}_{j}, \boldsymbol{\phi}(t=0)). \quad (2.22)$$

This familiar construction would *not* be possible with the product (2.8), which would have required inverting the $2N \times 2N$ matrix $\langle \mathbf{f}_j | \mathbf{f}_k \rangle$ —nontrivial if N is large. Of course, to use (2.22), one must know the \mathbf{f}_j , but when only a few \mathbf{f}_j 's dominate the dynamics, the burden of finding those (e.g., iteratively) is comparatively small.

In operator form [cf. (2.20)], the Green's function is $\phi(t)\theta(t) = \mathcal{G}(t)\phi(t=0)$ (θ is the unit step function), or

$$\left(\mathcal{H} - \omega\right)\tilde{\mathcal{G}}(\omega) = -i\mathcal{I}. \qquad (2.23)$$

With the eigenvectors complete, explicitly one has

$$\tilde{\mathcal{G}}(\omega) = \begin{pmatrix} \tilde{G}^{QQ} & \tilde{G}^{QP} \\ \tilde{G}^{PQ} & \tilde{G}^{PP} \end{pmatrix} = \sum_{j} \boldsymbol{f}_{j} \frac{i}{\omega - \omega_{j}} \left(\boldsymbol{f}_{j}, \boldsymbol{\cdot} \right), \quad (2.24)$$

Fourier inversion of which reproduces (2.22).

Using (2.3), in the canonical basis we can also write

$$\tilde{\mathcal{G}}(\omega) = (-\omega^2 - i\omega\Gamma + K)^{-1} \begin{pmatrix} \Gamma - i\omega & I \\ -K & -i\omega \end{pmatrix}, \quad (2.25)$$

involving the inversion of only an $N \times N$ matrix, in contrast to (2.23). The first factor in (2.25) corresponds to the differential operator in (2.7).

H. Exceptions

Our formalism relies on (a) the completeness of eigenvectors, and (b) $(f_j, f_j) \neq 0$ for all j. These assumptions are related. Imagine that system parameters are tuned, and the 2N eigenvectors start off (e.g., for $\Gamma = 0$) complete. Then (a) is violated when two (or more) eigenvectors merge, e.g. $f_k \rightarrow f_j$, so $(f_j, f_j) = \lim (f_j, f_k) = 0$. Conversely, if (b) is violated, f_j is orthogonal to every eigenvector; if these would be complete, then f_j is orthogonal to all ψ , contradicting $f_j \neq 0$, cf. below (2.16) [15].

These conditions are violated only for a zero-measure set of parameters. Section III contains examples; the extension to these critical points will be given separately [6].

III. EXAMPLES

A. Single oscillator

Although the theory is most valuable when $N \gg 1$ (otherwise brute force suffices), it is already nontrivial for N = 1. Let K = k and $\Gamma = 2\gamma$. The eigenvalue equation $J(\omega) = 0$ [cf. (2.4)] leads to $\omega_{\pm} = \pm \Omega - i\gamma$, where $\Omega = \sqrt{k - \gamma^2}$, and

$$\boldsymbol{f}_{\pm} = c_{\pm} \begin{pmatrix} 1\\ -i\omega_{\pm} \end{pmatrix} \,. \tag{3.1}$$

The bilinear maps are $(f_+, f_-) = 0$ and

$$(f_{\pm}, f_{\pm}) = \pm 2c_{\pm}^2 \Omega$$
. (3.2)

At the critical point $k = k_* \equiv \gamma^2$, (a) the eigenvalues merge: $\omega_+ = \omega_- = -i\gamma$; (b) from (3.1) the eigenvectors merge, leaving only one in the 2-d space; and (c) from (3.2) the diagonal bilinear map vanishes. This example also explains why eigenvector merging is called criticality.

B. Two oscillators

Let N = 2 with [3]

$$K = \begin{pmatrix} 4 & -2 \\ -2 & 4 \end{pmatrix}, \qquad \Gamma = \begin{pmatrix} 4\gamma & 0 \\ 0 & 2\gamma \end{pmatrix}.$$
(3.3)

As γ increases, one mode pair becomes overdamped for $\gamma > \gamma_{*1} = 0.8599$, and the other for $\gamma > \gamma_{*2} = 2.1031$. Except at these critical points, the eigenvectors are complete, and all bilinear maps etc. can be found explicitly. A perturbation of (3.3) will be studied in Section IV A.

C. Chain of masses

Next consider a chain of unit masses with displacements $\phi(\alpha)$ from the rest positions $x_{\alpha} = \alpha \Delta$. Mass α is tied to x_{α} and its nearest neighbors by springs of force constant $V(\alpha)$ and k respectively, and is moreover subject to a damping force $-\Gamma(\alpha)\partial_t \phi(\alpha)$. That is,

$$K(\alpha,\beta) = \begin{cases} 2k + V(\alpha) & \text{if } |\alpha - \beta| = 0\\ -k & \text{if } |\alpha - \beta| = 1\\ 0 & \text{if } |\alpha - \beta| > 1 \end{cases},$$

$$\Gamma(\alpha,\beta) = \Gamma(\alpha)\delta(\alpha,\beta). \qquad (3.4)$$

In the obvious continuum limit $\Delta \rightarrow 0$, $k\Delta^2 = 1$, the system obeys the (generalized) Klein–Gordon equation

$$[\partial_t^2 + \Gamma(x)\partial_t - \partial_x^2 + V(x)]\phi(x,t) = 0, \qquad (3.5)$$

discussed in Section VA.

Let $0 \le \alpha \le N+1$, $\phi(0) = \phi(N+1) = 0$. In the special solvable case $\Gamma(\alpha) = 2\gamma$, (2.7) reads $K(\alpha, \beta)f_j(\beta) =$

 $(\omega_j^2 + 2i\gamma\omega_j)f_j(\alpha)$. But K has a complete real eigensystem $\{\Omega_j^2, f_j\}$, with Ω_j the frequencies for $\gamma = 0$. Now

$$\omega_j = -i\gamma \pm \sqrt{\Omega_j^2 - \gamma^2} , \qquad (3.6)$$

while the eigenvectors remain the same. Thus this model is in effect a superposition of many oscillators, each as in Section III A. For any γ , at most one of these can be critical. This example is simple because $[K, \Gamma] = 0$.

Let us comment briefly on the doubling of modes [16]. For $\Gamma = 0$, the Ω_j^2 are real; but each of these splits into two complex ω_j^2 when $\Gamma \neq 0$. Modes are doubled because expansions now refer to ϕ and $\hat{\phi}$ simultaneously.

The f_j -basis for the [un]damped system is orthogonal under (2.9) [(2.8)]. This is consistent, since

$$(\boldsymbol{f}_j, \boldsymbol{f}_j) = \pm 2\sqrt{\Omega_j^2 - \gamma^2} f_j(\alpha) f_j(\alpha)$$
(3.7)

equals the conventional norm for the conservative system except for the prefactor, vanishing at critical damping.

To be even more specific, let $V(\alpha) = 0$, so that the undamped case is essentially the familiar model for acoustical phonons, with $\Omega_j^2 = 2k\{1 - \cos[j\pi/(N+1)]\}$ and $f_j(\alpha) = c_j \sin[j\pi\alpha/(N+1)]$ for $1 \le j \le N$. Setting (3.7) to unity, one finds $c_j = [(\omega_j + i\gamma)(N+1)]^{-1/2}$.

D. Inhomogeneous damping

A non-trivial solvable model with $[K, \Gamma] \neq 0$ can be constructed as follows. Let the masses be $\alpha = 0, \ldots, N$, with again $\phi(0) = 0$ but with $\phi(N)$ free, so there are N dynamical variables, with force constants as in (3.4) except that

$$K(N, N) = k + V(N)$$
. (3.8)

Let only the final mass be damped:

$$\Gamma(\alpha,\beta) = \gamma \delta(\alpha,N) \delta(\beta,N) . \tag{3.9}$$

We only consider V = 0, returning to finite V in Section VB. For $N \to \infty$, it is then straightforward to find

$$\frac{N\omega_j}{\sqrt{k}} = \begin{cases} (j + \frac{1}{2})\pi - i \operatorname{artanh}(\gamma/\sqrt{k}) , & \gamma < \sqrt{k} ;\\ j\pi - i \operatorname{arcoth}(\gamma/\sqrt{k}) , & \gamma > \sqrt{k} . \end{cases}$$
(3.10)

The divergence as $\gamma \to \sqrt{k}$ occurs only for $N \to \infty$. For finite $N \gg 1$, (3.10) fails very near $\gamma = \sqrt{k}$, and the true ω_j are continuous in γ . In particular, for $\gamma = \sqrt{k}$ one has $\omega_j = (\sqrt{k}/N)[(j+\chi)\pi - \frac{1}{2}i\ln N]$, where $\chi = \frac{3}{4}, \frac{1}{2}$, and $\frac{1}{4}$ for $-N \ll j \ll -\ln N, |j| \ll \ln N$, and $\ln N \ll j \ll N$ respectively.

IV. PERTURBATION THEORY

The familiar RSPT can be transcribed, everywhere replacing the usual inner product with the bilinear map (2.9). However, this assumes that the bilinear map itself is unperturbed, so we only consider, for small real ϵ ,

$$\mathcal{H} = \mathcal{H}_0 + \epsilon \Delta \mathcal{H} , \qquad \Delta \mathcal{H} = i \begin{pmatrix} 0 & 0 \\ -\Delta K & 0 \end{pmatrix} .$$
 (4.1)

A. Simple modes

The changes in the eigenvectors up to first order, and in the eigenvalues up to second order, are [17]

$$\Delta \mathbf{f}_j = \epsilon \sum_{k \neq j} \mathbf{f}_k \frac{(\mathbf{f}_k, \Delta \mathcal{H} \mathbf{f}_j)}{\omega_j - \omega_k} , \qquad (4.2)$$

$$\Delta \omega_j = \epsilon \left(\boldsymbol{f}_j, \Delta \mathcal{H} \boldsymbol{f}_j \right) + \epsilon^2 \sum_{k \neq j} \frac{(\boldsymbol{f}_k, \Delta \mathcal{H} \boldsymbol{f}_j)^2}{\omega_j - \omega_k} .$$
(4.3)

In the ϵ^2 -term, the matrix elements are squared *without* taking absolute values. Higher orders are easily written down. Here and below, $\{\omega_j, f_j\}$ is the unperturbed eigensystem. In view of (4.1), one simply has

$$(\mathbf{f}_k, \Delta \mathcal{H} \mathbf{f}_j) = f_k(\alpha) \Delta K(\alpha, \beta) f_j(\beta) \equiv (\Delta K)_{kj}$$
. (4.4)

Consider the example in Section III B with $\gamma = 0.5$ for \mathcal{H}_0 , and set $K(1,1) \mapsto K(1,1) + \epsilon$. Figure 1 shows $\Delta \omega_1(\epsilon)$ for the least damped mode $\omega_1 = 2.267 - 0.699i$. The points are roots of $J(\omega)$; the line is given by (4.3), the intercept (slope) verifying its first (second) term. The remaining error (a quadratic in the plot) reveals an ϵ^3 term in $\Delta \omega$. RSPT now gives Im $\Delta \omega$ correctly as well.

Re-write the first-order shift allowing arbitrary normalization of \mathbf{f}_j , as $\Delta(\omega_j^2)/\epsilon = 2\omega_j(\Delta K)_{jj}/(\mathbf{f}_j, \mathbf{f}_j)$. Agreement with the conservative limit is now apparent. This also shows that the bilinear map is no mathematical artifact, since it relates directly to the frequency shift— $(\Delta K)_{jj}$ being the expected expression. Incidentally, there could be large shifts if $(\mathbf{f}_j, \mathbf{f}_j)$ is small; the interesting consequences in optics [18] are discussed in detail elsewhere [6, 7].

detail elsewhere [6, 7]. Since Im $\Delta \omega_j = \sum_n \delta^{(n)} (\delta^{(n)} \propto \epsilon^n)$ is novel in the generalized RSPT, one further aspect deserves mention. Suppose the state j is weakly damped with quality factor \mathcal{Q} , but other states are strongly damped: $\gamma_j/\omega \sim \mathcal{Q}^{-1} \ll 1$ and $\gamma'/\omega \sim 1$; here $\gamma_j \equiv |\text{Im}\,\omega_j|, \gamma'$ is the typical $|\text{Im}\,\omega_k|$ for other k, and ω is a typical $|\text{Re}\,\omega_l|$. One then has $\delta^{(1)} = \text{Im}[\epsilon(\Delta K)_{jj}] \sim \epsilon \gamma_j$ [because $f_j \in \mathbf{R}$ if $\gamma_j \to 0$], but $\delta^{(2)} \sim \text{Im}[\epsilon^2(\Delta K)_{kj}^2/(\omega_k - \omega_j)] \sim \epsilon^2 \gamma'$. The ratio $\delta^{(2)}/\delta^{(1)}$ between energy loss through transitions to other states and direct change to the damping thus is $\sim \epsilon \mathcal{Q}$, which could be *larger* than one if $\mathcal{Q}^{-1} \ll \epsilon \ll 1$ (very narrow resonance).



FIG. 1: The real (a) and imaginary (b) parts of the eigenvalue shift $\Delta \omega$ for the system in (3.3) (with $\gamma = 0.5$), due to a perturbation adding ϵ to K(1, 1). Straight lines are second-order RSPT; points are roots of the characteristic polynomial.

B. Perturbation around level crossings

Suppose, as parameters are tuned, M eigenvalues merge. Generically, the corresponding eigenvectors also merge (criticality), so the remaining ones are incomplete [6, 19]. Instead, here we consider level crossing, i.e., at an Mth-order zero of $J(\omega)$ there are M independent eigenvectors. Again exactly as in the conservative case, the (typically small) $M \times M$ block is explicitly diagonalized, leaving a perturbation without intra-block elements. Thus zero denominators $\omega_k - \omega_j$ are avoided, and the formulas in Section IV A apply; we omit the details. The same method avoids small denominators near a level crossing, where a group of eigenvalues (but not the eigenvectors) are close.

Near-crossing leads to level repulsion and attraction [20], which can now be stated precisely. Focus on near-degenerate states j = 1, 2 and remove the aver-



age eigenvalue. In the associated subspace, $(\bar{\mathcal{H}}_0)^{\boldsymbol{\cdot}} = \text{diag}(\delta, -\delta)$. Perturb this as in (4.1), with

$$\Delta \bar{\mathcal{H}} \cdot = \begin{pmatrix} 0 & k \\ k & 0 \end{pmatrix} , \qquad (4.5)$$

where $k = (\Delta K)_{12}$ as in (4.4). Then the eigenvalues are

$$\omega = \pm \sqrt{\delta^2 + (\epsilon k)^2} \tag{4.6}$$

 $(|\delta|, |\epsilon| \ll 1$, but ϵ/δ is arbitrary). Note that the physically relevant quantity is k^2 , meshing with the normalization (2.13), which fixes k up to a sign.

If the two modes correspond to two near-identical oscillators (as is always the case for N = 2), then $f_{1,2}^2$ and hence k are real; cf. Section III A. One gets the oftquoted [20] result that frequencies repel but widths attract. This also holds for two modes which are both near crossing and weakly damped, by (2.13) and (4.4) [21].

However, the general case is not as simple, because K and Γ need not commute. For instance, take

$$K = \begin{pmatrix} 2+4\delta & 0 & 0\\ 0 & 2 & 2\\ 0 & 2 & 6 \end{pmatrix} , \qquad \Gamma = \begin{pmatrix} 2 & 0 & 0\\ 0 & 1 & 0\\ 0 & 0 & 4 \end{pmatrix} ; \qquad (4.7)$$

 δ lifts the degeneracy at $\omega = 1 - i$. Perturbation by

$$\Delta K = \begin{pmatrix} 0 & \mu_{12} & \mu_{13} \\ \mu_{12} & 0 & 0 \\ \mu_{13} & 0 & 0 \end{pmatrix}$$
(4.8)

[with μ_{ij} real and O(1)] yields $\Delta \overline{\mathcal{H}}$ as in (4.5), where $k = [\mu_{12}/2 - \mu_{13}(1+i)/4]\sqrt{2}$ can have any phase. Sufficiently near the level crossing—the region of interest—k can be taken constant as ϵ runs through the reals. Simple geometry then shows that the locus of ω in (4.6) is part (by the restriction $\epsilon^2 > 0$) of an orthogonal hyperbola, with (un)stable direction ik (k).

V. CONTINUUM MODELS

The continuum limit $N \to \infty$ is relevant to classical and also quantum (Section VI) *fields*, e.g., electrodynamics in an absorbing medium. Although the examples below are 1-d, the theory also applies to three dimensions.

A. String subject to viscosity

Consider the example in Section III C. In the obvious continuum limit $\Delta \to 0$, $N \to \infty$ with $a = (N+1)\Delta$ fixed, and without loss of generality scaling $k\Delta^2 = 1$, the dynamics obeys (3.5) for $0 \le x \le a$, with $\phi(0) = \phi(a) = 0$. This models a string subject to viscosity. (Generalization to $0 \le x < \infty$ or $-\infty < x < \infty$, in both cases with ϕ vanishing at both ends, is straightforward.) In terms of the momentum $\hat{\phi}(x) \equiv \partial_t \phi(x)$ and the twocomponent field $\phi = (\phi, \hat{\phi})^{\mathrm{T}}$, one has $i\partial_t \phi = \mathcal{H}\phi$, with

$$\mathcal{H}(x) = i \begin{pmatrix} 0 & 1\\ \partial_x^2 - V(x) & -\Gamma(x) \end{pmatrix}.$$
 (5.1)

The bilinear map is (up to an irrelevant overall factor Δ)

$$(\boldsymbol{\psi}, \boldsymbol{\phi}) = i \int_0^a (\psi \hat{\phi} + \hat{\psi} \phi + \psi \Gamma \phi) \, dx \;. \tag{5.2}$$

Again, \mathcal{H} is symmetric under (5.2).

The eigenvalue equation is $\mathcal{H} \boldsymbol{f}_j = \omega_j \boldsymbol{f}_j$, or

$$\left[-\omega_j^2 - i\omega_j\Gamma(x) - \partial_x^2 + V(x)\right]f_j(x) = 0.$$
 (5.3)

This dissipative Sturm-Liouville (DSL) problem could be generalized further by $-\partial_x^2 \mapsto -\partial_x p(x)\partial_x$ for suitable p. In the familiar case $\Gamma = 0$, each V gives a complete set $\{f_j\}_V$, orthogonal under the conventional inner product. Now, each (V, Γ) gives a set $\{f_j\}_{V,\Gamma}$, orthogonal under (5.2) and expected to be complete, with the convergence of infinite two-component sums guaranteed if (V, Γ) are suitably smooth and bounded. Such DSL systems are interesting both for, e.g., functional-analytic aspects such as completeness and convergence, and for the specific orthogonal functions that emerge.

If $\Gamma(x) = 2\gamma$, (5.3) becomes $(V - \partial_x^2)f_j = \Omega_j^2 f_j$, where Ω_j and ω_j are related by (3.6), and $V - \partial_x^2$ has a complete real eigensystem $\{\Omega_j^2, f_j\}$. The norm (f_j, f_j) equals the conventional one $\int_0^a f_j^2 dx$ up to a pre-factor $\pm 2\sqrt{\Omega_j^2 - \gamma^2}$ [cf. (3.7)], which vanishes at critical damping.

All these parallel the discrete version in Section III C.

B. Waves in open systems

Next consider a similar string on $0 \le x < \infty$, segmented into the "system" $x \le a$ and a trivial $[V = \Gamma = 0]$ "bath" x > a, into which the waves are outgoing:

$$(\partial_t + \partial_x)\phi(x > a) = 0, \qquad (5.4)$$

which follows automatically if the bath is at rest initially. So the "system" is to be solved with the same outgoing (rather than nodal) condition at x = a. For simplicity, also take $\Gamma(x \le a) = 0$ so that damping occurs only through the escape of waves, not through the field equation. This models a laser cavity with output coupling.

To see how also this model is a limit of (1.1), set $x = \Delta \alpha$, with $\Delta = a/N$, $0 \le \alpha \le N$, and $\phi(0) = 0$. For $\alpha < N$, the discrete dynamics can be written down immediately. For the last particle, reference to the next one just outside the system can be eliminated by (5.4) as $[\phi(N+1) - \phi(N)]/\Delta = -d_t\phi(N)$, resulting in

$$\left[d_t^2 + \frac{d_t}{\Delta} + V(N)\right]\phi(N) = \frac{\phi(N-1) - \phi(N)}{\Delta^2} .$$
 (5.5)

These exactly correspond to (3.8)–(3.9) for $k = \Delta^{-2}$ and $\gamma = \Delta^{-1}$ —without incoming waves, the outside merely acts as a source of ohmic damping on the right endpoint.

The continuum limit of the bilinear map reads

$$(\boldsymbol{\psi}, \boldsymbol{\phi}) = i \left[\int_0^a (\psi \hat{\phi} + \hat{\psi} \phi) \, dx + \psi(a) \phi(a) \right] \tag{5.6}$$

(again up to a factor Δ), i.e., (5.2) with $\Gamma(x) = \delta(x-a)$. The vital symmetry of \mathcal{H} under (5.6) follows as a limit of (2.10). For a direct proof integrate the $-\partial_x^2$ term by parts; the resulting surface term cancels the one in (5.6) [4, 16]. All results then carry through as before.

Our extensive study of such open wave systems [4] motivates much of the present work (notably the *ansatz* for the bilinear map). One can thus apply eigenexpansions etc. to, say, optical cavities [22]. In particular, the diagonal bilinear map, known to Zeldovich [23] long ago at least for eigenfunctions, has been used for stationary perturbation theory ([4] and references therein).

This previous work points to a remaining subtlety. Namely, while completeness is a simple consequence of linear algebra and counting in the discrete case, the modes of the open cavity are complete only if V(x) or one of its derivatives (depending on the permissible degree of regularization in the field expansion) are discontinuous at x = a—demarcating the cavity. One should thus study how the eigenexpansion behaves as $\Delta \rightarrow 0$, depending on whether or not this discontinuity condition is satisfied in the limit [one can speculate that some modes of (3.8)–(3.9) run off to $-i\infty$ if it is violated]. Ideally, this should yield a completeness proof alternative to the existing one, based on the analyticity of the continuum Green's function for Im $\omega < 0$ but limited to 1-d space.

C. Wronskian

Assuming nearest-neighbor couplings has turned these continuum models into second-order differential equations, for which there is an extra ingredient. One can define, for any ω , two solutions $f(x,\omega)$ and $g(x,\omega)$ satisfying the left and the right boundary condition respectively. For, say, a string fixed at both ends, $f(\omega, 0) = 0$, $g(\omega, a) = 0$. The x-independent Wronskian is $J(\omega) = g(x,\omega)\partial_x f(x,\omega) - f(x,\omega)\partial_x g(x,\omega)$. At a zero ω_j of J, $f \propto g$ satisfy both boundary conditions, hence are eigenfunctions. Thus, the Wronskian plays the role of the characteristic polynomial. Moreover, the (normalization-independent) Green's function can be represented as $\tilde{G}(x < y, \omega) = f(x, \omega)g(y, \omega)/J(\omega) [\tilde{G}(y, x) = \tilde{G}(x, y)]$.

There are however differences from the general finitedimensional case: 1-d second-order differential equations do not admit level crossing, so a multiple zero of J always implies criticality. Also, the one-sided function f (or g) can be studied *near* ω_j , of use for critical points [24].

VI. DISCUSSION

In the conservative case, a classical system's eigenvectors (e.g., electromagnetic *plane* waves) are a starting point for discussing nonlinear phenomena (e.g., secondharmonic generation), quantization (e.g., plane-wave creation and annihilation, Feynman propagators), as well as quantum interactions (e.g., a vertex in a Feynman diagram linking several propagators). Similarly, our eigenexpansion for ohmically damped *linear classical* oscillators is relevant for nonlinear and/or quantum systems as well—especially useful for systems with many degrees of freedom dominated by a few modes (typically at low temperatures or when some masses are large). Here we only provide a sketch; details will be given elsewhere.

A. Nonlinear oscillators

Consider for example a set of oscillators described by

$$\begin{aligned} d_t^2 \phi(\alpha) + [\Gamma(\alpha, \beta) d_t + K(\alpha, \beta) + \lambda(\alpha, \beta, \gamma) \phi(\gamma)] \phi(\beta) &= 0. \\ (6.1) \\ \text{Using the expansion } \phi(t) &= \sum_j a^j(t) \mathbf{f}_j, \text{ one shows that} \end{aligned}$$

$$(d_t + i\omega_j)a^j(t) = -i\lambda_{jkl} a^k(t)a^l(t) , \qquad (6.2)$$

$$\lambda_{jkl} = \lambda(\alpha, \beta, \gamma) f_j(\alpha) f_k(\beta) f_l(\gamma) .$$
 (6.3)

For small λ , these can be solved perturbatively. In particular, (2.12) allows $a^{j}(0)$ to be found by projecting $\phi(0)$.

B. Quantum and thermal correlation functions

To deal with quantum and/or thermal physics (for the moment ignoring nonlinearities), we need to modify two ingredients. First, the equation of motion becomes

$$d_t^2 \phi(\alpha) + \Gamma(\alpha, \beta) d_t \phi(\beta) + K(\alpha, \beta) \phi(\beta) = \eta(\alpha, t) .$$
 (6.4)

The noise η coming from the bath satisfies the fluctuation-dissipation theorem [25]

$$\langle \tilde{\eta}(\alpha,\omega)\eta(\beta)\rangle = \frac{2\omega}{1 - e^{-\omega/T}}\Gamma(\alpha,\beta) , \qquad (6.5)$$

where $\langle \cdots \rangle$ denotes the expectation value at temperature *T*, and $\hbar = k_{\rm B} = 1$. For finite-*T classical* dynamics, the rhs reduces to $2T\Gamma(\alpha, \beta)$. In two-component form,

$$(id_t - \mathcal{H})\boldsymbol{\phi} = i\boldsymbol{S}(t) , \qquad \boldsymbol{S} = \begin{pmatrix} 0\\ \eta \end{pmatrix} .$$
 (6.6)

In the eigenvector basis [26],

$$(d_t + i\omega_j)a^j = S^j(t) \equiv (\boldsymbol{f}_j, \boldsymbol{S}(t)) = \langle \boldsymbol{f}^j | \boldsymbol{S}(t) \rangle$$
. (6.7)

Correlators such as $\langle a^j(t)a^k \rangle$ are then related to $\langle S^j(t)S^k \rangle$, which can be obtained from (6.5) and (6.6).

Classically, (6.4)–(6.7) can already yield nontrivial Langevin dynamics. In quantum mechanics, ϕ and hence its coefficients a^j become operators. Commutators are evaluated by first substituting $a^j = (\mathbf{f}_j, \phi)$ [implying $a^{-j} = \pm i(a^j)^{\dagger}$ when combined with (2.14)], and then imposing the canonical $[\phi(\alpha), \hat{\phi}(\beta)] = i\delta(\alpha, \beta)$. One finds

$$[a^j, (a^k)^{\dagger}] = (\omega_j + \omega_k^*) f_j(\alpha) f_k^*(\alpha) \equiv \Delta^{jk} . \qquad (6.8)$$

For $\Gamma \to 0$, the orthogonality under (2.9) is $(\omega_j + \omega_k) \times f_j(\alpha) f_k(\alpha) = \delta^{jk}$, with all quantities real. Hence, $\Delta^{jk} = \delta^{jk} + O(\Gamma)$ so that a^j and $(a^j)^{\dagger}$ generalize the usual annihilation and creation operators. Crucially, however, their commutators (6.8) are not diagonal—rooted in the very nature of the bilinear map, and implying that the Feynman propagator is likewise non-diagonal. Diagrammatic expansions will thus show interesting features.

In fact, we can calculate the correlation function

$$F(\alpha, \beta, t) = \langle \phi(\alpha, t) \phi(\beta, 0) \rangle \tag{6.9}$$

in a way that by passes some of these technical complications. For $\omega \in \mathbf{R}$, from general considerations [25]

$$\tilde{F}(\alpha,\beta,\omega) = 2(1-e^{-\omega/T})^{-1} \operatorname{Im} \tilde{G}^{QP}(\alpha,\beta,\omega) . \quad (6.10)$$

Using (2.24) for $\tilde{\mathcal{G}}$ then gives

$$\tilde{F}(\alpha,\beta,\omega) = \frac{2i}{1 - e^{-\omega/T}} \sum_{j} \frac{\omega f_j(\alpha) f_j(\beta)}{\omega^2 - \omega_j^2} , \qquad (6.11)$$

with poles at both the ω_j and the Matsubara frequencies $\omega_m = 2m\pi iT$. Substituting the integrated (6.7) into the eigenexpansion of (6.9) also yields (6.11). Again, we omit details, and only stress that the eigenbasis provides a direct correspondence with the frequency singularities.

The Feynman propagator can be evaluated in terms of F and \mathcal{G} . The perturbative treatment of interactions of Section VIA (readily promoted to the operator level) then opens the way to a diagrammatic analysis.

C. Conclusion

We have established an eigenvector expansion for a system of ohmically damped oscillators such that almost all the usual results for conservative systems carry over. In a sense, introducing the bilinear map is equivalent to inverting the (potentially huge) matrix $\langle f_j | f_k \rangle$. Initialvalue problems are readily solved, and RSPT is valid for the *complex* eigenvalues. The possible extension to nonlinear and quantum phenomena has been sketched. The present formalism fails when any mode is critically damped; this is handled in the sequel [6].

These developments should be useful whenever there is (a) dissipation and (b) many degrees of freedom. Examples would include mechanical vibrations, acoustics, electromagnetism in absorbing (as well as gain) media, large Josephson-junction arrays and macromolecule vibrations in a viscous medium.

An extension to non-ohmic damping (which, by the Kramers–Kronig relations, typically would entail dispersion in the force constants as well) would enable modeling the many dispersive systems encountered in applications. Moreover, a closer study of the quantum dynamics requires a high-frequency cutoff on the damping.

APPENDIX A: FAST MODES

1. Equations of motion

If one particle is much heavier than all others, the latter can be treated as "fast modes", the momentum of which is eliminated. In preparation for such a study and for another application in Appendix A 3, here we consider one fast mode $\alpha = N+1$ of mass $\epsilon \ll 1$. Specifically,

$$d_t^2 \phi(\alpha) + [\Gamma(\alpha, \beta)d_t + K(\alpha, \beta)]\phi(\beta) = -A(\alpha)\phi(N+1)$$
(A1)

for $1 \leq \alpha \leq N$ (also the range of the summation convention), while the light particle is coupled to the others only by force constants $A(\alpha)$, not by cross-damping [27]:

$$(\epsilon d_t^2 + \gamma d_t + \kappa)\phi(N+1) = -A(\alpha)\phi(\alpha) .$$
 (A2)

This model (easily extended to more light masses) is contained in (1.1), if one rescales $\phi(N+1) \equiv \sqrt{\epsilon}\phi(N+1)$.

In the adiabatic limit $\epsilon \to 0$, the last particle's momentum follows the other variables:

$$d_t\phi(N+1) = -c\phi(N+1) - B(\alpha)\phi(\alpha) , \qquad (A3)$$

with $c = \kappa / \gamma$ and

$$B(\alpha) = \gamma^{-1} A(\alpha) . \tag{A4}$$

The dynamical system defined by (A1), (A3), and (A4) is dissipative even if $\Gamma = 0$: (A3) breaks invariance under $t \mapsto -t$. The system is stable if the original one is, i.e., if

$$\mathcal{K} \equiv \begin{pmatrix} K & A \\ A^{\mathrm{T}} & c\gamma \end{pmatrix} > 0 . \tag{A5}$$

Assuming K > 0, Sylvester's theorem [14] guarantees stability if det $\mathcal{K} > 0$; in particular, one needs $c\gamma > 0$. Since γ is taken positive in (A2) one finds that c > 0, which is plausible given the form of (A3).

On the Hamiltonian level, (A3) means that $\hat{\phi}(N+1)$ is not dynamical but obeys a constraint instead, hence the phase space has 2N+1 dimensions. Thus, define

$$\boldsymbol{\phi} = (\phi(1), \dots, \phi(N); \hat{\phi}(1), \dots, \hat{\phi}(N); \phi(N+1))^{\mathrm{T}}$$
. (A6)

Then the dynamics takes the standard form (2.2), with

$$\mathcal{H}^{\bullet} = i \begin{pmatrix} 0 & I & 0 \\ -K & -\Gamma & -A \\ -B^{\mathrm{T}} & 0 & -c \end{pmatrix} .$$
 (A7)

2. Bilinear map

Since the above is merely a limiting case of our general model, the bilinear map should be $(\boldsymbol{\phi}, \boldsymbol{\psi}) = i \left[\phi(\alpha) \hat{\psi}(\alpha) + \hat{\phi}(\alpha) \psi(\alpha) \right]$

$$+ \underline{\phi}(N+1)\underline{\hat{\psi}}(N+1) + \underline{\hat{\phi}}(N+1)\underline{\psi}(N+1) \\ + \phi(\alpha)\Gamma(\alpha,\beta)\psi(\beta) + \underline{\phi}(N+1)\epsilon^{-1}\gamma \underline{\psi}(N+1)] \\ = i[\phi(\alpha)\hat{\psi}(\alpha) + \hat{\phi}(\alpha)\psi(\alpha) + \phi(\alpha)\Gamma(\alpha,\beta)\psi(\beta) \\ + \phi(N+1)\gamma\psi(N+1)] + \mathcal{O}(\epsilon)$$
(A8)

in terms of the vectors (A6). By (2.15), this leads to

$$g \dots = i \begin{pmatrix} \Gamma & I & 0 \\ I & 0 & 0 \\ 0 & 0 & \gamma \end{pmatrix}, \quad \mathcal{H} \dots = \begin{pmatrix} K & 0 & A \\ 0 & -I & 0 \\ A^{\mathrm{T}} & 0 & c\gamma \end{pmatrix}.$$

Interestingly, when starting out by *postulating* (A3) in addition to (A1), the proportionality (A4) follows from demanding that (A9) be symmetric. Likewise, requiring the existence of a non-increasing energy function bounded from below then leads to (A5).

The adiabatic limit can similarly be taken in essentially all results of the previous sections, yielding a realization of our framework in an odd-dimensional phase space.

3. Example

Because of (A4), we should demonstrate nontrivial examples. Consider a string of particles $0 \leq \alpha \leq N+1$, spaced by Δ , with $a = (N+1)\Delta$ and $\phi(0) = 0$. Let the force constants be given by (3.4) with $k\Delta^2 = 1$, while for simplicity $\Gamma = 0$. The nearest-neighbor couplings (3.4) also act between particles 0 and 1, and between particles N and N+1. The latter implies $A(\alpha) = -\Delta^{-2}\delta(\alpha, N)$.

The right boundary condition is the discrete version of (5.4), namely $d_t\phi(N+1) = -\Delta^{-1}[\phi(N+1) - \phi(N)]$. Compared to (A3), we have $B(\alpha) = -\Delta^{-1}\delta(\alpha, N)$ and $c = \Delta^{-1}$. Crucially, (A4) is satisfied, with $\gamma = \Delta^{-1}$.

At least formally, for $N \to \infty$ (with *a* fixed) one retrieves the model of Section V B. Indeed, the continuum limit of (A8) agrees (up to an overall factor of Δ) with (5.6). It would be instructive to compare the convergence of the present discrete model with the more physically motivated one from the main text.

At $\omega = -3i$, an eigenbasis of the mentioned type reads $f_1 = \frac{1}{2}\sqrt{2}e^{i\pi/4}(1, 0, -3, 0)^{\mathrm{T}}$, $f_2 = \frac{1}{2}\sqrt{2}e^{-i\pi/4}(0, 1, 0, -3)^{\mathrm{T}}$, while (2.14) maps the orthonormal basis vectors $g_1 = \frac{1}{2}e^{i\pi/4}(1, i, -3, -3i)^{\mathrm{T}}$, $g_2 = \pm ig_1^*$ to each other. Conversely, at $\omega = -3i$ the system K = 3I, $\Gamma = 4I$ of two identical oscillators has an eigenbasis of the first but not of the second type.
