A note on Primes in Short Intervals

Abstract

Instead of a strong quantitative form of the Hardy-Littlewood prime k-tuple conjecture, one can assume an average form of it and still obtains the same distribution result on $\psi(x+h) - \psi(x)$ by Montgomery and Soundararajan [\[1\]](#page-5-0).

1 Introduction

Let $\Lambda(n)$ be von Mangoldt lambda function, $\mu(n)$ be the Möbius function and $\phi(n)$ be the Euler's phi function. Let $e(\theta) = e^{2\pi i \theta}, \epsilon > 0$ and $\psi(x) = \sum_{n \leq x} \Lambda(n)$. In $[1]$, Montgomery and Soundararajan studied the distribution of primes in short intervals

M_K(N;H) := \sum_{n=1}^{N} (\psi(n+H) - \psi(n) - H)^K
$$
 (1)

under a strong quantitative form of the Hardy-Littlewood prime k-tuple conjecture:

Conjecture 1.

$$
\sum_{n \le x} \prod_{i=1}^{k} \Lambda(n + d_i) = \mathfrak{S}(\mathcal{D})x + E_k(x; \mathcal{D})
$$
\n(2)

holds with

$$
E_k(x; \mathcal{D}) \ll_{\epsilon, K} N^{1/2 + \epsilon}
$$

uniformly for $1 \leq k \leq K$, $0 \leq x \leq N$, and distinct d_i satisfying $1 \leq d_i \leq H$. Here $\mathcal{D} = \{d_1, d_2, ..., d_k\}$, and

$$
\mathfrak{S}(\mathcal{D}) = \sum_{\substack{q_1,\ldots,q_k \\ 1 \le q_i < \infty}} \left(\prod_{i=1}^k \frac{\mu(q_i)}{\phi(q_i)} \right) \sum_{\substack{a_1,\ldots,a_k \\ 1 \le a_i \le q_i \\ (a_i,q_i)=1}} e\left(\sum_{i=1}^k \frac{a_i d_i}{q_i} \right)
$$
\n
$$
\sum_{\substack{a_i, a_i \in \mathbb{Z} \\ a_i/q_i \in \mathbb{Z}}} \mathfrak{C}(\mathcal{D}) = \sum_{\substack{a_i, a_i \in \mathbb{Z} \\ a_i \neq a_i \in \mathbb{Z}}} \mathfrak{C}(\mathcal{D})
$$

is the singular series as in equation (2) of $[1]$.

They proved

Theorem 1. Under Conjecture [1,](#page-0-0)

$$
M_K(N;H) = \mu_k H^{K/2} \int_1^N (\log x/H + B)^{K/2} dx
$$

+ $O\left(N(\log N)^{K/2} H^{K/2} \left(\frac{H}{\log N}\right)^{-1/(8K)} + H^K N^{1/2+\epsilon}\right)$

uniformly for $\log N \le H \le N^{1/K}$, where $\mu_k = 1 \cdot 3 \cdots (k-1)$ if k is even, and $\mu_k = 0$ if k is odd; $B = 1 - C_0 - \log 2\pi$ and C_0 denotes Euler's constant.

The first author of [\[1\]](#page-5-0) suggested to the present author that Theorem [1](#page-1-0) is probably true under an average form of the Hardy-Littlewood prime k-tuple conjecture, namely:

Conjecture 2. For $x \geq H$,

$$
\sum_{\substack{d_1,\ldots,d_k\\1\le d_i\le H\\d_i\text{ distinct}}} E_k(x,\mathcal{D})^2 \ll_k x^{1+\epsilon} H^k.
$$

Our goal in this paper is to prove Theorem [1](#page-1-0) under Conjecture [2.](#page-1-1)

2 Proof of Theorem [1](#page-1-0)

Lemma 1. With $\Lambda_0(n) = \Lambda(n) - 1$ and |A| denoting the size of a set A,

$$
\sum_{n\leq x}\prod_{i=1}^{k}\Lambda_0(n+d_i)=\mathfrak{S}_0(\mathcal{D})x+O(\sum_{\mathcal{J}\subset\{1,2,\ldots,k\}}|E_{|\mathcal{J}|}(x;\mathcal{D}_{\mathcal{J}})|)
$$

where

$$
\mathfrak{S}_0(\mathcal{D}) = \sum_{\substack{q_1,\ldots,q_k \\ 1 < q_i < \infty}} \left(\prod_{i=1}^k \frac{\mu(q_i)}{\phi(q_i)} \right) \sum_{\substack{a_1,\ldots,a_k \\ 1 \le a_i \le q_i \\ (a_i,q_i) = 1 \\ \sum a_i/q_i \in \mathbb{Z}}} e \left(\sum_{i=1}^k \frac{a_i d_i}{q_i} \right)
$$

and $\mathcal{D}_{\mathcal{J}} = \{d_j\}_{j \in \mathcal{J}}$.

Proof: The left hand side

$$
= \sum_{n \leq x} \prod_{i=1}^{k} (\Lambda(n + d_i) - 1) = \sum_{n \leq x} \sum_{\mathcal{J} \subset \{1, 2, ..., k\}} (-1)^{k - |\mathcal{J}|} \prod_{i \in \mathcal{J}} \Lambda(n + d_i)
$$

\n
$$
= \sum_{\mathcal{J} \subset \{1, 2, ..., k\}} (-1)^{k - |\mathcal{J}|} \sum_{n \leq x} \prod_{i \in \mathcal{J}} \Lambda(n + d_i)
$$

\n
$$
= \sum_{\mathcal{J} \subset \{1, 2, ..., k\}} (-1)^{k - |\mathcal{J}|} (\mathfrak{S}(\mathcal{D}_{\mathcal{J}}) x + E_{|\mathcal{J}|}(x; \mathcal{D}_{\mathcal{J}}))
$$

\n
$$
= \mathfrak{S}_{0}(\mathcal{D}) x + O(\sum_{\mathcal{J} \subset \{1, 2, ..., k\}} |E_{|\mathcal{J}|}(x; \mathcal{D}_{\mathcal{J}})|)
$$

by [\(2\)](#page-0-1) and the identity $\mathfrak{S}_0(\mathfrak{D}) = \sum_{\mathfrak{I} \subset \mathfrak{D}} (-1)^{|\mathfrak{I}|} \mathfrak{S}(\mathfrak{I})$ (see equation (5) of [\[1\]](#page-5-0)).

Proof of Theorem [1](#page-1-0) under Conjecture [2:](#page-1-1) Following [\[1\]](#page-5-0), we expand [\(1\)](#page-0-2) and have

$$
M_K(N;H) = \sum_{k=1}^K \frac{1}{k!} \sum_{\substack{1 \le M_1, \dots, M_k \\ \sum M_i = K}} \binom{K}{M_1 \cdots M_k} \\ \times \sum_{\substack{m_1, \dots, m_k \\ m_1, \dots, m_k \\ n \le M_i}} \prod_{i=1}^k (-1)^{M_i - 1 - m_i} \binom{M_i - 1}{m_i} L_k(\mathbf{m}), \tag{3}
$$

where

$$
L_k(\mathbf{m}) := \sum_{\substack{d_1,\ldots,d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} \sum_{n=1}^N \prod_{i=1}^k \Lambda_{m_i}(n + d_i) \tag{4}
$$

and $\Lambda_m(n) := \Lambda(n)^m \Lambda_0(n)$. To estimate $L_k(m)$, one needs to distinguish between those *i* for which $m_i = 0$ and those for which $m_i > 0$. Following [\[1\]](#page-5-0), we set $\mathcal{K} = \{1,...,k\}$ and introduce

$$
\mathcal{H} = \{i \in \mathcal{K} : m_i \ge 1\}, \ \mathcal{I} = \{i \in \mathcal{K} : m_i = 0\}, \ \mathcal{J} \subset \mathcal{K}.
$$

Then

$$
\sum_{n \leq x} \prod_{i \in J} \Lambda_0(n + d_i) \prod_{i \in J} \Lambda(n + d_i)
$$
\n
$$
= \sum_{n \leq x} \sum_{\substack{\mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K}}} \prod_{i \in \mathcal{J}} \Lambda_0(n + d_i) = \sum_{\substack{\mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K}}} \sum_{\substack{n \leq x \\ \mathcal{J} \subset \mathcal{J}}} \prod_{i \in \mathcal{J}} \Lambda_0(n + d_i)
$$
\n
$$
= \sum_{\substack{\mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K}}} \left[\mathfrak{S}_0(\mathcal{D}_{\mathcal{J}}) x + O(\sum_{\substack{\mathcal{J}' \subset \mathcal{J} \\ \mathcal{J}' \subset \mathcal{J}}} |E_{|\mathcal{J}'|}(x; \mathcal{D}_{\mathcal{J}'})|) \right]
$$
\n
$$
= x \sum_{\substack{\mathcal{J} \\ \mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K}}} \mathfrak{S}_0(\mathcal{D}_{\mathcal{J}}) + O_k\left(\sum_{\substack{\mathcal{K}' \subset \mathcal{K}}} |E_{|\mathcal{K}'|}(x; \mathcal{D}_{\mathcal{K}'})| \right)
$$

by Lemma [1.](#page-1-2) We write the above as $f(x) = cx + E_{x,\mathcal{K}}$. In general,

$$
\int_{1}^{X} g(x)df(x)
$$

=g(X) f(X) - $\int_{1}^{X} f(x)g'(x)dx$
=g(X)[cX + Ex_xx] - $\int_{1-}^{X} (cx + Ex_{x}x)g'(x)dx$
=c $\int_{1-}^{X} g(x)dx + O(E_{X,X}|g(X)| + \int_{1-}^{X} E_{x,X}|g'(x)|dx).$

Thus, by integration by parts,

$$
\sum_{n=1}^{N} \Biggl(\prod_{i \in \mathcal{I}} \Lambda_0(n + d_i) \Biggr) \Biggl(\prod_{i \in \mathcal{H}} \Lambda(n + d_i) (\log(n + d_i))^{m_i - 1} (\log(n + d_i) - 1) \Biggr)
$$

=
$$
\int_{1 - i \in \mathcal{H}}^{N} \prod_{i \in \mathcal{H}} (\log(x + d_i))^{m_i - 1} (\log(x + d_i) - 1) df(x)
$$

=
$$
c \int_{1}^{N} \prod_{i \in \mathcal{H}} (\log(x + d_i))^{m_i - 1} (\log(x + d_i) - 1) dx + O\Bigl(E_{N, \mathcal{K}} \log^{K} N + \int_{1 -}^{N} E_{x, \mathcal{K}} \frac{\log^{K}(x + H)}{x} dx \Bigl).
$$

This is the analogue of equation (65) in [\[1\]](#page-5-0). Now, note that

$$
\Lambda_m(n) = \Lambda(n)(\log n)^{m-1}(\log n - 1)
$$

when n is prime. We have, by following the argument in $[1]$,

$$
\sum_{n=1}^{N} \prod_{i=1}^{k} \Lambda_{m_i}(n + d_i)
$$
\n
$$
= \left(\sum_{\substack{\mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K}}} \mathfrak{S}_0(\mathcal{D}_{\mathcal{J}}) \right) (I_{\mathbf{m}}(N) + O(H(\log N)^{K-k})) + O(N^{1/2+\epsilon}) \tag{5}
$$
\n
$$
+ O\left(E_{N,\mathcal{K}} \log^K N + \int_{1^-}^N E_{x,\mathcal{K}} \frac{\log^K(x + H)}{x} dx \right).
$$

where

$$
I_{\mathbf{m}}(N) := \int_1^N \prod_{i \in \mathcal{H}} \left((\log x)^{m_i - 1} (\log x - 1) \right) dx.
$$

Putting [\(5\)](#page-4-0) into [\(4\)](#page-2-0),

$$
L_k(\mathbf{m}) = I_{\mathbf{m}}(N) \sum_{\substack{\mathcal{J} \\ \mathcal{J} \subset \mathcal{J} \subset \mathcal{K} \\ d_i \text{ distinct}}} \sum_{\substack{d_1, \dots, d_k \\ d_i \text{ distinct} \\ 1 \le d_i \le H}} \mathfrak{S}_0(\mathcal{D}_{\mathcal{J}}) + O(H^k N^{1/2 + \epsilon})
$$
\n
$$
+ O\Big(\sum_{\substack{d_1, \dots, d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} E_{N, \mathcal{K}} \log^K N + \int_{1^-}^N \sum_{\substack{d_1, \dots, d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} E_{x, \mathcal{K}} \frac{\log^K x}{x} dx\Big).
$$
\n(6)

Now, we use Conjecture [2.](#page-1-1) By Cauchy-Schwarz inequality,

$$
\sum_{\substack{d_1,\ldots,d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} |E_k(x,\mathcal{D})| \ll_k x^{1/2+\epsilon} H^k.
$$

In particular,

$$
\sum_{\substack{d_1,\ldots,d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} E_{x,\mathcal{K}} = \sum_{\substack{d_1,\ldots,d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} \sum_{\substack{\mathcal{K}' \subset \mathcal{K} \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} |E_{|\mathcal{K}'|}(x;\mathcal{D}_{\mathcal{K}'})|
$$
\n
$$
\ll_k \sum_{j=0}^k \sum_{\substack{d_1,\ldots,d_j \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} |E_j(x;\mathcal{D})| \ll_k x^{1/2 + \epsilon} H^k
$$

Applying this to [\(6\)](#page-4-1), the second error term is $\ll N^{1/2+\epsilon}H^k$ while the third error

term is

$$
= \int_{H}^{N} \sum_{\substack{d_1, ..., d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} E_{x, \mathcal{K}} \frac{\log^{K}(x+H)}{x} dx + \int_{1^{-}}^{H} \sum_{\substack{d_1, ..., d_k \\ 1 \le d_i \le H \\ d_i \text{ distinct}}} E_{x, \mathcal{K}} \frac{\log^{K}(x+H)}{x} dx
$$

 $\ll_{k} N^{1/2 + \epsilon} H^{k} + \int_{1}^{H} H^{k+1} \frac{\log^{K}(x+H)}{x} dx \ll_{K} N^{1/2 + \epsilon} H^{k}$

as $H \leq N^{1/2}$. Hence, [\(6\)](#page-4-1) has an error $O(H^k N^{1/2+\epsilon})$ and the rest of the proof in [\[1\]](#page-5-0) follows. Therefore, we have Theorem [1](#page-1-0) under Conjecture [2.](#page-1-1)
