Metastable Behaviour of Small Noise Lévy-Driven Diffusions

Abstract

We consider a dynamical system in \mathbb{R} driven by a vector field -U', where U is a multi-well potential satisfying some regularity conditions. We perturb this dynamical system by a Lévy noise of small intensity and such that the heaviest tail of its Lévy measure is regularly varying. We show that the perturbed dynamical system exhibits metastable behaviour i.e. on a proper time scale it reminds of a Markov jump process taking values in the local minima of the potential U. Due to the heavy-tail nature of the random perturbation, the results differ strongly from the well studied purely Gaussian case.

Keywords: Lévy process, jump diffusion, heavy tail, regular variation, metastability, extreme events, first exit time, large deviations.

1 Introduction

This paper addresses the rigorous mathematical description of the phenomenon of metastability in systems with big jumps. The picture we shall study may be outlined as follows. Let us consider a one-dimensional deterministic dynamical system driven by a vector field $-U'(\cdot)$, where $U(\cdot)$ is a multi-well potential with some smoothness conditions and a certain increase rate at infinity. According to the initial conditions the deterministic trajectories of the dynamical system converge to the local minima of the potential U or stay in its local maxima. Obviously, no transition between different domains of attraction is possible.

The situation becomes different if the dynamical system is perturbed by (small) random noise whose presence allows transitions between the potential wells. However depending on the system's initial conditions and noise's properties, certain potential wells may be reached only on appropriately long time scales or stay unvisited. The phenomenon of metastability means, roughly speaking, that for different time scales and initial conditions the system may reach different local statistical equilibria.

The system's behaviour is determined by the type of random perturbation. Unquestionably, dynamical systems subject to small Gaussian perturbations have been studied most extensively. The main reference on this subject is the book [FW98] where the large deviations theory for the perturbed trajectories is established. The large deviations estimates allow to solve the first exit problem from the domain of attraction of a stable point. It turns out that the mean exit time is exponentially large in the small noise parameter, and its logarithmic rate is proportional to the height of the potential barrier the trajectories have to overcome. Thus for a multi-well dynamical system we obtain a series of exponentially non-equivalent time scales given by the wells' mean exit times. Moreover, one can prove that the normalised exit times are exponentially distributed (see [Wil82, Day83, BEGK04]), and thus have a memoryless property which is referred to in physical literature as unpredictability.

In the simplest situation when the potential U has only two wells of different depths, one can observe two statistically different regimes. First, if the time horizon is shorter than the exit time from the shallow well, the system cannot leave the well where it has started, and therefore stays in the neighbourhood of the well's local minimum. Second, if the time horizon is longer than the exit time from the shallow well, the system has enough time to reach the deepest well from any starting point, and stays in the vicinity of the global minimum. In [KN85] the following metastability result is established. Namely, there is a time scale on which the dynamical system converges to a Markov two-state process with one absorbing state corresponding to the deep well. It is easy to notice that this particular time scale is given by the mean exit time from the shallow well. More general results for multidimensional diffusions can be found in [Mat95] and [GOV87].

There is a very close connection between metastability of a small noise system and spectral properties of its infinitesimal operator. It can be shown that exponentially small eigenvalues of the infinitesimal generator are expressed in terms of mean life times in the domains of attraction, and the corresponding eigenfunctions are close to constants on these domains [KM96]. On the other hand, the generator's eigenvalues can be calculated with the help of variational principles [BM92, BGK05].

However, recently non-Gaussian perturbations with big jumps attract more attention. Instant transitions between remote states are referred to as extreme events and are observed in dynamics of asset prices, climate and telecommunication systems etc. In the physical literature, non-Gaussian symmetric stable Lévy processes are used especially often, under the name of $L\acute{e}vy$ flights. The mathematical study of the gradient dynamical systems subject to small perturbation by a heavy-tail Lévy process was tackled in [IP06] (for symmetric stable processes), where results on the first exit time form the potential well with non-characteristic boundary were established by purely probabilistic methods. It was shown that the exit time increases as a power of the small noise parameter and does not depend on the depth of the potential well but rather on the distance between the local minimum and the domain's boundary.

In the present paper which can be seen as a sequel of [IP06] we deal with more general multi-well potential and arbitrary Lévy processes with regularly varying tails. The presence of big jumps makes the Lévy driven dynamics quite different from the purely Gaussian one. Indeed, the life times in the potential wells belong now to the same time scale which leads to a quite different process in the limit of small parameter.

2 Object of study and main result

Let $(\Omega, \mathcal{F}, (\mathcal{F})_{t\geq 0}, \mathbf{P})$ be a filtered probability space. We assume that the filtration satisfies the usual hypotheses in the sense of [Pro04], i.e. \mathcal{F}_0 contains all the **P**-null sets of \mathcal{F} , and is right continuous.

We consider solutions $X^{\varepsilon} = (X_t^{\varepsilon})_{t \geq 0}$ of the one-dimensional stochastic differential equation

$$X_t^{\varepsilon}(x) = x - \int_0^t U'(X_{s-}^{\varepsilon}(x)) \, ds + \varepsilon L_t, \quad x \in \mathbb{R}, \tag{2.1}$$

where L is a Lévy process and U is a potential function satisfying the following assumptions.

Assumptions on L:

L1 L has a generating triplet (d, ν, μ) with a Gaussian variance $d \ge 0$, an arbitrary drift $\mu \in \mathbb{R}$ and a Lévy measure ν satisfying the usual condition $\int_{\mathbb{R}\setminus\{0\}} \max\{y^2, 1\} \nu(dy) < \infty$. For $u \ge 1$ denote the tails of the Lévy measure ν

$$H_{-}(-u) = \int_{(-\infty, -u)} \nu(dy), \qquad H_{+}(u) = \int_{(u, +\infty)} \nu(dy),$$
 (2.2)

and $H(u) = H_{-}(-u) + H_{+}(u)$.

L2 Assume, $H_{+}(\cdot)$ is regularly varying at infinity, i.e.

$$H_{+}(u) = u^{-r}l(u), \quad u \to +\infty, \tag{2.3}$$

for some r > 0 and a slowly varying function l (for regular variation see Appendix B).

L3 Assume that there exists a finite limit

$$\lim_{u \to +\infty} \frac{H_{-}(-u)}{H_{+}(u)} = \kappa \in (0, +\infty). \tag{2.4}$$

or

$$\lim_{u \to +\infty} \frac{H_{-}(-u)}{H_{+}(u)} = \kappa = 0. \tag{2.5}$$

Assumptions on U:

U1 $U \in \mathcal{C}^1(\mathbb{R}) \cap \mathcal{C}^3([-K, K])$ for some K > 0 large enough.

U2 U has exactly n local minima m_i , $1 \le i \le n$, and n-1 local maxima s_i , $1 \le i \le n-1$, enumerated in increasing order

$$-\infty = s_0 < m_1 < s_1 < m_2 < \dots < s_{n-1} < m_n < s_n = +\infty.$$
 (2.6)

All extrema of U are non-degenerate, i.e. $U''(m_i) > 0$, $1 \le i \le n$, and $U''(s_i) < 0$, $1 \le i \le n - 1$.

U3 $|U'(x)| > c_1|x|^{1+c_2}$ as $x \to \pm \infty$ for some $c_1, c_2 > 0$.

The class of Lévy processes L under consideration covers for example compound Poisson processes with heavy-tail jumps or stable Lévy processes with Lévy measure

$$\nu(dy) = (c_1 \mathbb{I}\{y < 0\} + c_2 \mathbb{I}\{y > 0\}) \frac{dy}{|y|^{1+\alpha}}, \quad \alpha \in (0, 2), \quad c_1 \ge 0, c_2 > 0.$$
(2.7)

We consider X^{ε} for small values of ε , $\varepsilon \downarrow 0$.

Since the Lévy process L is a semimartingale, the stochastic differential equation (2.1) is well defined, see also [Pro04] for the general theory. However, since the drift term U' is not globally Lipschitz we need to show the existence and uniqueness of the strong solution of (2.1) which is done in Appendix A.

Under assumptions on U, the underlying deterministic ($\varepsilon = 0$) equation

$$X_t^0(x) = x - \int_0^t U'(X_s^0(x)) ds$$
 (2.8)

has a unique solution for any initial value $x \in \mathbb{R}$ and all $t \geq 0$. The local minima of U are stable attractors for the dynamical system X^0 , i.e. if $x \in (s_{i-1}, s_i)$, $1 \leq i \leq n$, then $X_t^0(x) \to m_i$ as $t \to \infty$. It is clear that the deterministic solution X^0 does not leave the domain of attraction where it started.

Our goal is to describe the phenomenon of *metastability* which roughly speaking consists in the existence of a time scale for which the system reminds of a jump process taking values in the set stable attractors. We prove the following main Theorem.

Theorem 1 Let $X^{\varepsilon}(x) = (X^{\varepsilon}_t(x))_{t\geq 0}$ be a solution of (2.1). If $x \in (s_{i-1}, s_i)$, for some $i = 1, \ldots, n$, then

$$X_{t/H(1/\varepsilon)}^{\varepsilon}(x) \to Y_t(m_i), \quad \varepsilon \downarrow 0,$$
 (2.9)

in the sense of finite-dimensional distributions, where $Y = (Y_t)_{t\geq 0}$ is a Markov process on a state space $\{m_1, \ldots, m_n\}$ with the infinitesimal generator $Q = (q_{ij})_{i,j=1}^n$,

$$q_{ij} = \frac{\kappa \mathbb{I}\{j < i\} + \mathbb{I}\{j > i\}}{1 + \kappa} \left| |s_{j-1} - m_i|^{-r} - |s_j - m_i|^{-r} \right|, \quad i \neq j,$$

$$-q_{ii} = q_i = \sum_{j \neq i} q_{ij} = \frac{\kappa}{1 + \kappa} |s_{i-1} - m_i|^{-r} + \frac{1}{1 + \kappa} |s_i - m_i|^{-r}.$$
(2.10)

Let us consider a particular example of equation (2.1), namely a symmetric α -stable process L (Lévy flights) in a double-well potential. Let U satisfy Assumptions formulated above and let for definiteness $s_1 = 0$. The process L has a generating triplet $(0, \nu, 0)$ with a Lévy measure $\nu(dy) = |y|^{-1-\alpha}$, $y \neq 0$, $\alpha \in (0, 2)$. Such dynamics is often considered in physical literature. P. Ditlevsen in [Dit99b, Dit99a] studied such a system in his attempt to explain abrupt catastrophic climate changes during the last Ice Age. Further in [CGKM05], the authors addressed the calculation of the mean transition time between the wells if $\alpha \in [1, 2)$. (Their conclusions based on numerical simulations of the process X^{ε} are not fully consistent with our results, and thus should be improved.) One-well dynamics of such processes was firstly studied in [IP06].

Due to Theorem 1, the main features of the process X^{ε} in the small noise limit are retained by a Markov jump process, and on the time scale $\alpha \varepsilon^{-\alpha}$ we obtain the following convergence in the sense of finite dimensional distributions:

$$X_{\alpha t/\varepsilon^{\alpha}}^{\varepsilon}(x) \to Y_t, \quad t > 0, \quad \varepsilon \downarrow 0,$$
 (2.11)

where Y is a Markov process on the state space $\{m_1, m_2\}$ with the following matrix as infinitesimal generator

$$Q = \begin{pmatrix} -m_1^{-\alpha} & m_1^{-\alpha} \\ m_2^{-\alpha} & -m_2^{-\alpha} \end{pmatrix} \quad \text{and} \quad Y_0 = \begin{cases} m_1, & \text{if } x < 0, \\ m_2, & \text{if } x > 0. \end{cases}$$
 (2.12)

To compare the result obtained with its Gaussian counterpart we refer to [KN85], where this problem was first studied.

Let us consider a Gaussian diffusion \hat{X}^{ε} which solves the equation

$$\hat{X}_{t}^{\varepsilon}(x) = x - \int_{0}^{t} U'(\hat{X}_{s}^{\varepsilon}(x)) ds + \varepsilon W_{t}, \qquad (2.13)$$

where W is a standard Brownian motion. Since it is well known that in the Gaussian case the height of the potential barriers plays a crucial role, we assume that the left well is deeper, i.e. $U(0)-U(m_1) > U(0)-U(m_2)$. This leads to the following meta-stable behaviour of \hat{X}^{ε} ([KN85, Theorem 2.1]). These exists a time scale λ^{ε} such that

$$\lim_{\varepsilon \to 0} \varepsilon^2 \ln \lambda^{\varepsilon} = 2(U(0) - U(m_2)) \tag{2.14}$$

and

$$\hat{X}_{t\lambda^{\varepsilon}}^{\varepsilon}(x) \to \hat{Y}_t, \quad \varepsilon \downarrow 0,$$
 (2.15)

in the sense of finite dimensional distributions, where \hat{Y} is a Markov process on $\{m_1, m_2\}$ with the infinitesimal matrix

$$\begin{pmatrix} 0 & 0 \\ 1 & -1 \end{pmatrix} \quad \text{and} \quad \hat{Y}_0 = \begin{cases} m_1, & \text{if } x < 0, \\ m_2, & \text{if } x > 0. \end{cases}$$
 (2.16)

As we see, the main difference between Lévy and Gaussian dynamics consists not only in different intrinsic time scales — polynomial vs. exponential, — but also in a qualitatively different limiting behaviour. In the heavy-tail case, the states of the limiting process are recurrent, whereas in the Gaussian case, the minimum of the deepest well is absorbing.

In general case, we can summarise the differences as follows. First, we see that the characteristic time scale is algebraic in ε . Second, the properties of the limiting process Y depend on sizes of the potential wells and not on their depths. Further, if $\kappa > 0$, the all states of Y are recurrent. The process Y has a unique absorbing state m_n (the local minimum of the right peripheral well) if and only if $\kappa = 0$, i.e. when the positive tail of L dominates.

This material is organised as follows. In Section 3 we decompose the Lévy process L into a small jump part and a compound Poisson part and study the small-jump dynamics of the process X^{ε} . Section 4 is devoted to the asymptotics of the first exit time from a single well. Section 5 provides the asymptotic exponentiality of the transition times between the wells. Theorem 1 is proved in Section 6. Appendices A and B contain the proof of the existence of the strong solution of (2.1) and basic information on regularly varying functions.

3 One-well dynamics of the small jump component

3.1 Exponential estimate for the small-jump component

For $\rho > 0$ and $0 < \varepsilon \le 1$ consider the decomposition $L = \xi^{\varepsilon} + \eta^{\varepsilon}$, where the Lévy processes ξ^{ε} and η^{ε} have generating triplets $(d, \nu_{\xi}^{\varepsilon}, \mu)$ and $(0, \nu_{\eta}^{\varepsilon}, 0)$ respectively with

$$\nu_{\xi}^{\varepsilon}(\cdot) = \nu\left(\cdot \cap \left[-\frac{1}{\varepsilon^{\rho}}, \frac{1}{\varepsilon^{\rho}}\right] \setminus \{0\}\right), \qquad \nu_{\eta}^{\varepsilon}(\cdot) = \nu\left(\cdot \cap \mathbb{R} \setminus \left[-\frac{1}{\varepsilon^{\rho}}, \frac{1}{\varepsilon^{\rho}}\right]\right). \tag{3.1}$$

The absolute value of jumps of the process $\varepsilon \xi^{\varepsilon}$ does not exceed $\varepsilon^{1-\rho}$.

Thus the process ξ^{ε} has a Lévy measure with compact support, and the Lévy measure $\nu_{\eta}^{\varepsilon}(\cdot)$ of η^{ε} is finite. Denote

$$\beta_{\varepsilon} = \nu_{\eta}^{\varepsilon}(\mathbb{R}) = \int_{\mathbb{R}\setminus\left[-\frac{1}{\varepsilon\rho}, \frac{1}{\varepsilon\rho}\right]} \nu(dy) = H\left(\frac{1}{\varepsilon^{\rho}}\right). \tag{3.2}$$

Then, η^{ε} is a compound Poisson process with intensity β_{ε} , and jumps distributed according to the law $\beta_{\varepsilon}^{-1}\nu_{\eta}^{\varepsilon}(\cdot)$.

Denote τ_k^{ε} , $k \geq 0$, the jump times of η^{ε} with $\tau_0^{\varepsilon} = 0$. Let $T_k^{\varepsilon} = \tau_k^{\varepsilon} - \tau_{k-1}^{\varepsilon}$ denote successive inter-jump periods, and $W_k^{\varepsilon} = \eta_{\tau_k^{\varepsilon}}^{\varepsilon} - \eta_{\tau_k^{\varepsilon}}^{\varepsilon}$ the jump heights of η^{ε} . Then, the three processes $(T_k^{\varepsilon})_{k \geq 1}$, $(W_k^{\varepsilon})_{k \geq 1}$, and $(\xi^{\varepsilon})_{t > 0}$ are independent. Moreover,

$$\mathbf{P}(T_k^{\varepsilon} \ge u) = \int_u^{\infty} \beta_{\varepsilon} e^{-\beta_{\varepsilon} s} \, ds = e^{-\beta_{\varepsilon} u}, \quad u \ge 0, \quad \text{and} \quad \mathbf{E} T_k^{\varepsilon} = \frac{1}{\beta_{\varepsilon}}, \tag{3.3}$$

$$\mathbf{P}(W_k^{\varepsilon} < w) = \frac{\nu_{\eta}^{\varepsilon}(-\infty, w)}{\nu_{\eta}^{\varepsilon}(\mathbb{R})} = \frac{1}{\beta_{\varepsilon}} \int_{(-\infty, w)} \mathbb{I}\{|y| > \frac{1}{\varepsilon^{\rho}}\} \nu(dy), \quad w \in \mathbb{R}.$$
 (3.4)

Between the arrival times of η^{ε} the process X^{ε} is driven by $\varepsilon \xi^{\varepsilon}$. The next Lemma shows that on long time intervals $\varepsilon \xi^{\varepsilon}$ does not essentially deviate from zero. Hence the dynamics of the process X^{ε} on the intervals between arrival times of the process η^{ε} can be seen as a small random perturbation of the underlying deterministic trajectory.

Lemma 3.1 For any $\rho \in (0,1)$, any $\gamma \in (0,1-\rho)$ and $\theta \in (0,1-\rho-\gamma)$ there is $p_0 > 0$ and $\varepsilon_0 > 0$ such that the inequality

$$\mathbf{P}(\sup_{t \in [0, 1/\varepsilon^{\theta}]} |\varepsilon \xi_t^{\varepsilon}| \ge \varepsilon^{\gamma}) \le \exp(-1/\varepsilon^p)$$
(3.5)

holds for all $0 < \varepsilon \le \varepsilon_0$ and 0 .

Proof: Let ρ , γ and θ be as in the statement of Lemma. Since

$$\mathbf{P}(\sup_{t\in[0,1/\varepsilon^{\theta}]}|\varepsilon\xi_{t}^{\varepsilon}|\geq\varepsilon^{\gamma})\leq\mathbf{P}(\sup_{t\in[0,1/\varepsilon^{\theta}]}(\varepsilon\xi_{t}^{\varepsilon})\geq\varepsilon^{\gamma})+\mathbf{P}(\inf_{t\in[0,1/\varepsilon^{\theta}]}(\varepsilon\xi_{t}^{\varepsilon})\leq-\varepsilon^{\gamma}). \tag{3.6}$$

we have to estimate two summands. Let us consider the first.

The Lévy measure of $\varepsilon \xi^{\varepsilon}$ has compact support, hence the process $\varepsilon \xi^{\varepsilon}$ has exponential moments. Moreover, $\varepsilon \xi_t^{\varepsilon} - \mathbf{E}(\varepsilon \xi_t^{\varepsilon})$ is a zero-mean martingale, so that

$$\mathbf{E}(\varepsilon \xi_t^{\varepsilon}) = \varepsilon \mu t + \varepsilon t \int_{-1/\varepsilon^{\rho}}^{-1} y \nu(dy) + \varepsilon t \int_{1}^{1/\varepsilon^{\rho}} y \nu(dy),$$

$$|\mathbf{E}(\varepsilon \xi_t^{\varepsilon})| \le \varepsilon t \left[\mu + \int_{|y| \ge 1} y \nu(dy) \right] = \varepsilon t m.$$
(3.7)

Then Kolmogorov's inequality for exponential functions of martingales yields

$$\mathbf{P}\left(\sup_{t\in[0,1/\varepsilon^{\theta}]}(\varepsilon\xi_{t}^{\varepsilon})\geq\varepsilon^{\gamma}\right)\leq\mathbf{P}\left(\sup_{t\in[0,1/\varepsilon^{\theta}]}(\varepsilon\xi_{t}^{\varepsilon}-\mathbf{E}(\varepsilon\xi_{t}^{\varepsilon}))\geq\varepsilon^{\gamma}-\varepsilon^{1-\theta}m\right)$$

$$=\mathbf{P}\left(\sup_{t\in[0,1/\varepsilon^{\theta}]}e^{u(\varepsilon\xi_{t}^{\varepsilon}-\mathbf{E}(\varepsilon\xi_{t}^{\varepsilon}))}\geq e^{u(\varepsilon^{\gamma}-\varepsilon^{1-\theta}m)}\right)$$

$$\leq e^{-u(\varepsilon^{\gamma}-\varepsilon^{1-\theta}m)}\sup_{t\in[0,1/\varepsilon^{\theta}]}\mathbf{E}e^{u(\varepsilon\xi_{t}^{\varepsilon}-\mathbf{E}(\varepsilon\xi_{t}^{\varepsilon}))}$$

$$\leq e^{-u(\varepsilon^{\gamma}-2\varepsilon^{1-\theta}m)}\sup_{t\in[0,1/\varepsilon^{\theta}]}\mathbf{E}e^{u\varepsilon\xi_{t}^{\varepsilon}}.$$
(3.8)

where the latter exponent can be derived from the Lévy-Hinchin representation,

$$\mathbf{E}\exp\left(u\varepsilon\xi_{t}^{\varepsilon}\right) = \exp\left\{dt\frac{\varepsilon^{2}u^{2}}{2} + \mu t\varepsilon u + t\int_{0<|y|\leq 1/\varepsilon^{\rho}} \left(e^{u\varepsilon y} - 1 - u\varepsilon y\mathbb{I}\{|y|\leq 1\}\right)\nu(dy)\right\}. \tag{3.9}$$

Denote

$$\varphi(u, \varepsilon, t) = \ln \mathbf{E} \exp\left(u\varepsilon \xi_t^{\varepsilon}\right) + 2um\varepsilon^{1-\theta} - \varepsilon^{\gamma}u \tag{3.10}$$

and let $u = u(\varepsilon) = 1/\varepsilon^c$ for $c = (1 - \rho + \gamma)/2$. We show that $\sup_{t \in [0, 1/\varepsilon^{\theta}]} \varphi(u(\varepsilon), \varepsilon, t) \to -\infty$ as a power of ε . Indeed, since $0 < c < 1 - \rho$, a straightforward calculation yields

$$\sup_{t \in [0,1/\varepsilon^{\theta}]} \varphi(u(\varepsilon), \varepsilon, t) \leq d \frac{\varepsilon^{2-\theta-2c}}{2} + |\mu|\varepsilon^{1-\theta-c} + \frac{1}{\varepsilon^{\theta}} \int_{|y| \leq 1} (e^{\varepsilon^{1-c}y} - 1 - \varepsilon^{1-c}y)\nu(dy)
+ \frac{1}{\varepsilon^{\theta}} \int_{1}^{1/\varepsilon^{\rho}} (e^{\varepsilon^{1-c}y} - 1)\nu(dy) + \frac{1}{\varepsilon^{\theta}} \int_{-1/\varepsilon^{\rho}}^{-1} (e^{\varepsilon^{1-c}y} - 1)\nu(dy) + 2m\varepsilon^{1-\theta-c} - \varepsilon^{\gamma-c}
\leq \varepsilon^{2-\theta-2c} \left(\frac{d}{2} + \int_{|y| \leq 1} y^{2}\nu(dy)\right) + 2\varepsilon^{1-c-\rho-\theta} \int_{1}^{\infty} \nu(dy) + (2m + |\mu|)\varepsilon^{1-\theta-c} - \varepsilon^{\gamma-c}.$$
(3.11)

Then since $2-\theta-2c, 1-c-\rho-\theta, 1-\theta-c>\gamma-c$ we can take $p_0=(c-\gamma)/2$ to obtain

$$\sup_{t \in [0, 1/\varepsilon^{\theta}]} \varphi(u(\varepsilon), \varepsilon, t) \le -\frac{1}{\varepsilon^{p}}, \quad \varepsilon \downarrow 0, \tag{3.12}$$

for all 0 .

The inequality for inf is proved analogously.

3.2 Dynamics on compact interval, $a > -\infty$

Our goal is to study the one-well dynamics of the small-jump process x^{ε} and its unperturbed conterpart x^{0} ,

$$x_t^{\varepsilon}(x) = x - \int_0^t U'(x_{s-}^{\varepsilon}(x)) ds + \varepsilon \xi_t^{\varepsilon},$$

$$x_t^0(x) = x - \int_0^t U'(x_s^0(x)) ds, \quad t \ge 0.$$
(3.13)

For definiteness we assume that the well's minimum is located at the origin and thus the corresponding domain of attraction for x^0 is (a,b), $-\infty < a < 0 < b < +\infty$, if the well is inner, and $(-\infty,b)$ if it is peripheral. In the first case we also assume that a and b are non-degenerate local maxima of U. In the second case, b is a non-degenerate local maximum and U'(x) increases to infinity faster than linearly as $x \to -\infty$. Denote the critical point curvatures as $U''(0) = M_0 > 0$, $U''(b) = M_b > 0$ and $U''(a) = M_a < 0$ (when defined).

For $\gamma > 0$ and $t \geq 0$ we introduce an event

$$\mathcal{E}_t = \{ \omega : \sup_{s \in [0,t]} |\varepsilon \xi_s^{\varepsilon}| \le \varepsilon^{4\gamma} \}. \tag{3.14}$$

We prove the following estimates.

Proposition 3.1 For any $\gamma > 0$, any c > 0 there is $\varepsilon_0 > 0$ such that for $0 < \varepsilon \le \varepsilon_0$ the inequality

$$\sup_{s \in [0,t]} |x_s^{\varepsilon}(x) - x_s^0(x)| \le c\varepsilon^{2\gamma} \tag{3.15}$$

holds a.s. on the event \mathcal{E}_t uniformly for $t \geq 0$ and $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$.

Consider the representation of the process x^{ε} in powers of ε

$$x_t^{\varepsilon}(x) = x_t^0(x) + \varepsilon Z_t^{\varepsilon}(x) + R_t^{\varepsilon}(x), \quad t \ge 0, \tag{3.16}$$

where Z^{ε} is the first approximation of x^{ε} satisfying the stochastic differential equation

$$Z_t^{\varepsilon}(x) = -\int_0^t U''(x_s^0(x)) Z_{s-}^{\varepsilon}(x) \, ds + \xi_t^{\varepsilon} \tag{3.17}$$

and the remainder $R^{\varepsilon}(x)$ is the absolutly continuous function starting at 0 and satisfying the integral equation

$$R_t^{\varepsilon}(x) = \int_0^t \left[-U'(x_s^0(x) + \varepsilon Z_{s-}^{\varepsilon}(x) + R_s^{\varepsilon}(x)) + U'(x_s^0(x)) + U''(x_s^0(x))\varepsilon Z_{s-}^{\varepsilon}(x) \right] ds. \tag{3.18}$$

We shall prove two Lemmas about the small noise dynamics of these processes.

Lemma 3.2 There is a universal constant $C_Z > 0$ such that for any $\gamma > 0$ there is $\varepsilon_0 > 0$ such that for $0 < \varepsilon \le \varepsilon_0$ the inequality

$$\sup_{s \in [0,t]} |\varepsilon Z_s^{\varepsilon}(x)| \le C_Z \varepsilon^{3\gamma} \tag{3.19}$$

holds a.s. on the event \mathcal{E}_t uniformly for $t \geq 0$ and $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$.

Lemma 3.3 There is a universal constant $C_R > 0$ such that for any $\gamma > 0$ there is $\varepsilon_0 > 0$ such that for $0 < \varepsilon \le \varepsilon_0$ the inequality

$$\sup_{s \in [0,t]} |R_s^{\varepsilon}(x)| \le C_R \varepsilon^{3\gamma} \tag{3.20}$$

holds a.s. on the event \mathcal{E}_t uniformly for $t \geq 0$ and $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$.

The Proof of Proposition 3.1 follows easily from the previous Lemmas.

The proof of Lemmas 3.2 and 3.3 is performed in the sequel. We consider in detail only the neighbourhood of the critical point a. The behaviour of x^{ε} in the neighbourhood of b is obviously similar. The following geometric properties of the potential U will be extensively used:

- 1. The deterministic trajectories $x_t^0(x)$, $x \in [a + \varepsilon^{\gamma}, b \varepsilon^{\gamma}]$ converge to 0 as $t \to \infty$ due to the property xU'(x) > 0 for $x \neq a, b, 0$.
- 2. The curvature of the potential at x = a, b is negative. In a small neighbourhood of a we have $U(x) = U(a) M_a \frac{(x-a)^2}{2} + o((x-a)^2)$. Consequently x^0 behaves there like $a + e^{M_a t}$, and the dynamics of x^{ε} reminds of the dynamics of an inverted process of Ornstein-Uhlenbeck type.
- 3. The curvature of the potential at x = 0 is positive. In small neighbourhoods of 0 we have $U(x) = U(0) + M_0 \frac{x^2}{2} + o(x^2)$. Consequently x^0 decays there like $e^{-M_0 t}$, and the dynamics of x^{ε} reminds of the dynamics of a process of Ornstein-Uhlenbeck type.

From now on, let $\gamma > 0$ be fixed. Using assumptions on U, for technical reasons we fix some small δ , $0 < \delta < \min\{|a|, b\}$, and consider δ -neighbourhoods of the critical points a, 0 and b with the following properties:

- there are some $0 < m_1^a \le M_a \le m_2^a$, $\frac{m_2^a}{m_1^a} < \frac{3}{2}$, such that if $a \le x \le a + \delta$ then $m_1^a(x a) \le -U'(x) \le m_2^a(x a)$;
- $-U'(\cdot)$ is monotone increasing in $x \in [a, a + \delta]$.
- Similar estimates hold in δ -neighbourhood of b.
- There are some $0 < m_1^0 < m_2^0$ such that the inequality $m_1^0 < \inf_{|x| < \delta} U''(x) \le \sup_{|x| < \delta} U''(x) < m_2^0$ holds.

For ε such that $0 < \varepsilon^{\gamma} < \delta$ and for $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$, denote

$$t_{\varepsilon}(x) = \begin{cases} \text{the first time } x_{t}^{0}(x) \text{ reaches the level } a + \delta \text{ if } x \in [a + \varepsilon^{\gamma}, a + \delta], \\ \text{the first time } x_{t}^{0}(x) \text{ reaches the level } b - \delta \text{ if } x \in [b - \delta, b - \varepsilon^{\gamma}], \\ 0, \text{ if } x \in [a + \delta, b - \delta], \end{cases}$$

$$= \begin{cases} \int_{x}^{a+\delta} \frac{dy}{-U'(y)}, & \text{if } x \in [a + \varepsilon^{\gamma}, a + \delta], \\ \int_{b-\delta}^{x} \frac{dy}{U'(y)}, & \text{if } x \in [b - \delta, b - \varepsilon^{\gamma}], \\ 0, & \text{if } x \in [a + \delta, b - \delta]. \end{cases}$$

$$(3.21)$$

Also define the time period

$$\hat{T} = \max\{\int_{a+\delta}^{-\delta} \frac{dy}{-U'(y)}, \int_{\delta}^{b-\delta} \frac{dy}{U'(y)}\}.$$
(3.22)

 \hat{T} has the property that for all $x \in [a + \delta, b - \delta]$ and $t \ge \hat{T}$, $|x_t^0(x)| \le \delta$, i.e. after \hat{T} the trajectory of $x^0(x)$ is within a δ -neighborhood of the stable point 0.

3.2.1 Estimates on Z^{ε}

Proof of Lemma 3.2

The solution to equation (3.17) is explicitly given by

$$Z_t^{\varepsilon}(x) = \int_0^t e^{-\int_s^t U''(x_u^0(x)) du} d\xi_s^{\varepsilon}. \tag{3.23}$$

Integration by parts results in the following representation for Z^{ε} :

$$Z_t^{\varepsilon}(x) = \xi_t^{\varepsilon} - \int_0^t \xi_{s-}^{\varepsilon} U''(x_s^0(x)) e^{-\int_s^t U''(x_u^0(x)) du} ds.$$
 (3.24)

For x = 0, $x_t^0(x) = 0$ for all $t \ge 0$, and $Z^{\varepsilon}(0)$ is a process of the Ornstein-Uhlenbeck type starting at zero and given by the equation

$$Z_t^{\varepsilon}(0) = \xi_t^{\varepsilon} - M_0 \int_0^t \xi_{s-}^{\varepsilon} e^{-M_0(t-s)} ds, \qquad (3.25)$$

and hence for any $t \geq 0$

$$\sup_{s \in [0,t]} |Z_s^{\varepsilon}(0)| \le 2 \sup_{s \in [0,t]} |\xi_s^{\varepsilon}|. \tag{3.26}$$

Further, it follows from (3.24) that for $t \ge 0$ and $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$

$$\sup_{s \in [0,t]} |Z_s^{\varepsilon}(x)| \le \left(1 + \int_0^t |U''(x_s^0(x))| e^{-\int_s^t U''(x_u^0(x)) du} ds\right) \sup_{s \in [0,t]} |\xi_s^{\varepsilon}|. \tag{3.27}$$

In order to prove Lemma 3.2, we distinguish three cases: $x \in [a + \delta, b - \delta], x \in [a + \varepsilon^{\gamma}, a + \delta]$ and $x \in [b - \delta, b - \varepsilon^{\gamma}].$

1. Let $x \in [a + \delta, b - \delta]$. Then we show that for any $t \ge 0$ and for some positive C_1

$$\sup_{s \in [0,t]} |Z_s^{\varepsilon}(x)| \le C_1 \sup_{s \in [0,t]} |\xi_s^{\varepsilon}|. \tag{3.28}$$

Let

$$C_2 = \max_{x \in [a+\delta, b-\delta]} \int_0^{\hat{T}} |U''(x_s^0(x))| e^{-\int_s^{\hat{T}} U''(x_u^0(x)) du} ds.$$
 (3.29)

Consider an arbitrary $t \geq \hat{T}$. Then

$$\int_{0}^{t} |U''(x_{s}^{0}(x))|e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds$$

$$= \int_{0}^{\hat{T}} |U''(x_{s}^{0}(x))|e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds + \int_{\hat{T}}^{t} |U''(x_{s}^{0}(x))|e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds. \tag{3.30}$$

Let us estimate the first summand in (3.30). Since for all $x \in [a+\delta,b-\delta]$ and $t \ge \hat{T}, m_1^0 < U''(x_t^0(x)) < m_2^0$, we have

$$\int_{0}^{\hat{T}} |U''(x_{s}^{0}(x))| e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds = e^{-\int_{\hat{T}}^{t} U''(x_{u}^{0}(x)) du} \int_{0}^{\hat{T}} |U''(x_{s}^{0}(x))| e^{-\int_{s}^{\hat{T}} U''(x_{u}^{0}(x)) du} ds \\
\leq e^{-m_{1}^{0}(t-\hat{T})} C_{2} \leq C_{2}.$$
(3.31)

The second summand in (3.30) is estimated analogously:

$$\int_{\hat{T}}^{t} |U''(x_s^0(x))| e^{-\int_s^t U''(x_u^0(x)) du} ds \le m_2^0 \int_{\hat{T}}^t e^{-m_1^0(t-s)} ds \le \frac{m_2^0}{m_1^0}.$$
 (3.32)

Taking $C_1 = \max\{2, C_2 + \frac{m_2^0}{m_1^0}\}$ completes the proof. 2. Let $x \in [a + \varepsilon^{\gamma}, a + \delta]$. Then we show that

$$\sup_{s \in [0,t]} |Z_s^{\varepsilon}(x)| \le \frac{C_3}{\varepsilon^{\gamma}} \sup_{s \in [0,t]} |\xi_s^{\varepsilon}|. \tag{3.33}$$

Indeed, for $x \in [a + \varepsilon^{\gamma}, a + \delta]$ and $t \le t_{\varepsilon}(x)$ we have,

$$1 + \int_{0}^{t} |U''(x_{s}^{0}(x))| e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds = 1 - \int_{0}^{t} U''(x_{s}^{0}(x)) e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) du} ds$$

$$= 1 - \int_{0}^{t} U''(x_{s}^{0}(x)) e^{\int_{x_{s}^{0}(x)}^{x_{s}^{0}(x)} \frac{U''(v)}{U'(v)} dv} ds \quad (v = x_{u}^{0}(x), dv = -U'(v) du)$$

$$= 1 - \int_{0}^{t} U''(x_{s}^{0}(x)) e^{\ln U'(x_{s}^{0}(x))/U'(x_{s}^{0}(x))} ds$$

$$= 1 - U'(x_{t}^{0}(x)) \int_{0}^{t} \frac{U''(x_{s}^{0}(x))}{U'(x_{s}^{0}(x))} ds$$

$$= 1 + U'(x_{t}^{0}(x)) \int_{x}^{x_{t}^{0}} \frac{U''(v)}{U'(v)^{2}} dv \quad (v = x_{s}^{0}(x), dv = -U'(v) ds)$$

$$= 1 - U'(x_{t}^{0}(x)) \left(\frac{1}{U'(x_{t}^{0}(x))} - \frac{1}{U'(x)}\right) = \frac{U'(x_{t}^{0}(x))}{U'(x)}.$$

$$(3.34)$$

For any $t \ge 0$ we use (3.27) and (3.34) to obtain

$$\begin{split} &1 + \int_{0}^{t} |U''(x_{s}^{0}(x))| e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) \, du} \, ds \\ &= 1 - e^{-\int_{t_{\varepsilon}(x) \wedge t}^{t} U''(x_{u}^{0}(x)) \, du} \int_{0}^{t_{\varepsilon}(x) \wedge t} U''(x_{s}^{0}(x)) e^{-\int_{s}^{t_{\varepsilon}(x) \wedge e} U''(x_{u}^{0}(x)) \, du} \, ds \\ &+ \int_{t_{\varepsilon}(x) \wedge t}^{t} |U''(x_{s}^{0}(x))| e^{-\int_{s}^{t} U''(x_{u}^{0}(x)) \, du} \, ds \\ &= 1 - \frac{U'(x_{t}^{0}(x))}{U'(x_{t_{\varepsilon}(x) \wedge t}^{0}(x))} \left(1 - \frac{U'(x_{t_{\varepsilon}(x) \wedge t}^{0}(x))}{U'(x)}\right) \\ &+ \int_{0}^{t - t_{\varepsilon}(x) \wedge t} |U''(x_{s}^{0}(a + \delta))| e^{-\int_{s}^{t - t_{\varepsilon}(x) \wedge t} U''(x_{u}^{0}(a + \delta)) \, du} \, ds \\ &\leq 1 - \frac{U'(x_{t_{\varepsilon}(x) \wedge t}^{0}(x))}{U'(x_{t_{\varepsilon}(x) \wedge t}^{0}(x))} + \frac{U'(x_{t}^{0}(x))}{U'(x)} + C_{1}. \end{split}$$

Note that for $0 < \varepsilon \le \varepsilon_0$ for some ε_0 small enough and depending on U, a, b, γ and δ

$$1 - \frac{U'(x_t^0(x))}{U'(x_{t_{\varepsilon}(x)\wedge t}^0(x))} + \frac{U'(x_t^0(x))}{U'(x)} \le \begin{cases} \frac{U'(x_t^0(x))}{U'(x)} \le \frac{m_2^a |a+\delta|}{m_1^a(a-x)} \le \frac{C_3}{\varepsilon^{\gamma}}, & 0 \le t \le t_{\varepsilon}(x), \\ 1 + \max_{y \in [a,b]} |U'(y)| (\frac{1}{|U'(a+\delta)|} + \frac{1}{|U'(x)|}) \le \frac{C_4}{\varepsilon^{\gamma}}, & t \ge t_{\varepsilon}(x), \end{cases}$$
(3.36)

3. For $x \in [b - \delta, b - \varepsilon^{\gamma}]$ we obtain an estimate similar to (3.36). Hence, for all $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$, $t \ge 0$ and $0 < \varepsilon \le \varepsilon_0$,

$$\sup_{s \in [0,t]} |\varepsilon Z^{\varepsilon}(x)| \le \frac{C_Z}{\varepsilon^{\gamma}} \sup_{s \in [0,t]} |\varepsilon \xi_s^{\varepsilon}| \le C_Z \varepsilon^{3\gamma}$$
(3.37)

for some positive C_Z on the event \mathcal{E}_t .

3.2.2 Estimates on R^{ε}

To estimate the remainder term R^{ε} we need finer smoothness properties of the potential U. However, the following Lemma shows that this restriction only has to hold locally.

Lemma 3.4 There exists C > 0 and $\varepsilon_0 > 0$ such that for and $0 < \varepsilon \le \varepsilon_0$ the inequality

$$\sup_{s \in [0,t]} |R_s^{\varepsilon}(x)| \le C \tag{3.38}$$

holds a.s. on the event \mathcal{E}_t uniformly for $t \geq 0$ and $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}].$

Proof: By Assumption **U2** we know that for any $t \geq 0$, $x \in [a,b]$ we have $x_t^0(x) \in [a,b]$. Moreover, for $0 < \varepsilon \leq \varepsilon_Z$ and $x \in [a+\varepsilon^\gamma,b-\varepsilon^\gamma]$ we have $\sup_{s \in [0,t]} |\varepsilon Z_s^\varepsilon(x)| < C_Z \varepsilon^{3\gamma}$ on \mathcal{E}_t due to Lemma 3.2. Recall that U' increases at least linearly at infinity (see Assumption **U3**). This guarantees the existence of a constant C > 0 such that for any $x \in [a,b]$, $|z| \leq 1$ we have

$$-U'(x+z+C) + U'(x) + U''(x)z < 0. (3.39)$$

Hence for any $0 \le s \le t$, $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$ the inequality

$$-U'(x_s^0(x) + \varepsilon Z_{s-}^{\varepsilon}(x) + C) + U'(x_s^0(x)) + U''(x_s^0(x))\varepsilon Z_{s-}^{\varepsilon}(x) < 0$$
(3.40)

holds on the event \mathcal{E}_t for $0 < \varepsilon \le \min\{C_Z^{-1/3\gamma}, \varepsilon_Z\}$. Now assume there is some $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$, and some (smallest) $\tau \in [0, t]$ such that $R_{\tau}^{\varepsilon}(x) = C$. Observe that the rest term R^{ε} satisfies the integral equation

$$R_s^{\varepsilon}(x) = \int_0^s f(R_u^{\varepsilon}(x), x_u^0(x), \varepsilon Z_{u-}^{\varepsilon}(x)) du$$
 (3.41)

with the smooth integrand

$$f(R, x^{0}, \varepsilon Z) = -U'(x^{0} + \varepsilon Z + R) + U'(x^{0}) + U''(x^{0})(\varepsilon Z).$$

This implicitly says that R^{ε} is an absolutely continuous function of time. By definition of τ , we have

$$0 \le D^{+} R_{s}^{\varepsilon}(x)|_{s=\tau} = -U'(x_{\tau}^{0}(x) + \varepsilon Z_{\tau-}^{\varepsilon}(x) + C) + U'(x_{\tau}^{0}(x)) + U''(x_{\tau}^{0}(x))\varepsilon Z_{\tau-}^{\varepsilon}(x) < 0, \tag{3.42}$$

a contradiction, with D^+ denoting the right Dini derivative. A similar reasoning applies under the assumption $R^{\varepsilon}_{\tau}(x) = -C$. This completes the proof.

Lemma 3.4 has a very convenient consequence. It states precisely that the solution process $x_s^{\varepsilon}(x)$, $s \in [0, t]$, with initial state confined to $[a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$, stays bounded by a deterministic constant K on the set \mathcal{E}_t , $t \geq 0$. Therefore, in the small noise limit, only local properties of U are relevant to our analysis.

Lemma 3.5 There exists $C_1 > 0$ such that for any $\gamma > 0$ there is $\varepsilon_0 > 0$ such that for $0 \le \varepsilon \le \varepsilon_0$,

$$\sup_{s \in [0, t \wedge t_{\varepsilon}(x)]} |R_s^{\varepsilon}(x)| \le C_1 \varepsilon^{3\gamma} \tag{3.43}$$

on the event \mathcal{E}_t uniformly for $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$ and $t \ge 0$.

Proof: 1. For $x \in [a+\delta, b-\delta]$ the time $t_{\varepsilon}(x) = 0$ and the estimate (3.43) is trivial. Thus it is only necessary to consider x from the neighbourhoods of the boundary points a and b. For definiteness, we consider the case $x \in [a+\varepsilon^{\gamma}, a+\delta]$. Let also Lemmas 3.2 and 3.4 hold for $0 < \varepsilon \le \varepsilon_1$ with constants C_Z and C.

2. The rest term R^{ε} satisfies the integral equation

$$R_t^{\varepsilon}(x) = \int_0^t f(R_s^{\varepsilon}(x), x_s^0(x), \varepsilon Z_{s-}^{\varepsilon}(x)) ds$$
 (3.44)

with

$$f(R, x^{0}, \varepsilon Z) = -U'(x^{0} + \varepsilon Z + R) + U'(x^{0}) + U''(x^{0})(\varepsilon Z).$$
(3.45)

Moreover, R^{ε} is an absolutely continuous function of time. Let the constant K from Assumption **U1** be bigger than C. We write the Taylor expansion for the integrand f with some $|\theta| \leq K$:

$$f(R, x^{0}, \varepsilon Z) = -U'(x^{0} + \varepsilon Z + R) + U'(x^{0}) + U''(x^{0})(\varepsilon Z)$$

$$= -U'(x^{0}) - U''(x^{0})(R + \varepsilon Z) - \frac{U^{(3)}(\theta)}{2}(R + \varepsilon Z)^{2} + U'(x^{0}) + U''(x^{0})(\varepsilon Z)$$

$$= -U''(x^{0})R - \frac{U^{(3)}(\theta)}{2}(R + \varepsilon Z)^{2}$$
(3.46)

Since $U \in \mathcal{C}^3$, $|U^{(3)}|$ is bounded, say by L, on [-K,K]. Using the inequality $(R + \varepsilon Z)^2 \le 2(R^2 + \varepsilon^2 Z^2)$ we obtain that for $t \ge 0$,

$$f(R_t^{\varepsilon}(x), x_t^0(x), \varepsilon Z_{t-}^{\varepsilon}(x)) \leq -U''(x_t^0(x))R_t^{\varepsilon} + L(R_t^{\varepsilon})^2 + L(\varepsilon Z_{t-}^{\varepsilon}(x))^2 < -U''(x_t^0(x))R_t^{\varepsilon} + L(R_t^{\varepsilon})^2 + A^2\varepsilon^{6\gamma},$$

$$f(R_t^{\varepsilon}(x), x_t^0(x), \varepsilon Z_{t-}^{\varepsilon}(x)) \geq -U''(x_t^0(x))R_t^{\varepsilon} - L(R_t^{\varepsilon})^2 - L(\varepsilon Z_{t-}^{\varepsilon}(x))^2 > -U''(x_t^0(x))R_t^{\varepsilon} - L(R_t^{\varepsilon})^2 - A^2\varepsilon^{6\gamma}.$$

$$(3.47)$$

on the event \mathcal{E}_t , with $A^2 = 2C_Z^2 L$.

3. Let us prove the upper bound in (3.43). Together with (3.44) consider the Riccati equation

$$p_t^{\varepsilon}(x) = \int_0^t (m_2^a p_s^{\varepsilon} + L(p_s^{\varepsilon})^2 + A^2 \varepsilon^{6\gamma}) \, ds, \quad 0 \le t \le t_{\varepsilon}(x). \tag{3.48}$$

Under the conditions of the lemma, it is enough to prove two statements:

- a) $R_t^{\varepsilon}(x) \leq p_t^{\varepsilon}$ for $0 \leq t \leq t_{\varepsilon}(x)$.
- **b)** $p_t^{\varepsilon} \leq C_1 \varepsilon^{3\gamma}$ for $0 \leq t \leq t_{\varepsilon}(x)$.

We have the closed form formula for p_t :

$$p_t^{\varepsilon} = A^2 \varepsilon^{6\gamma} \frac{e^{t\lambda^{\varepsilon}} - e^{-t\lambda^{\varepsilon}}}{(m_2^a + \lambda^{\varepsilon})e^{-t\lambda^{\varepsilon}} - (m_2^a - \lambda^{\varepsilon})e^{t\lambda^{\varepsilon}}},$$

$$\lambda^{\varepsilon} = \sqrt{(m_2^a)^2 - 4LA^2 \varepsilon^{6\gamma}}.$$
(3.49)

It is easy to see that p_t^{ε} is a non-negative monotonically increasing function starting at 0. However p_t^{ε} has a singularity at

$$t^*(\varepsilon) = \frac{1}{2\lambda^{\varepsilon}} \ln\left(\frac{m_2^a + \lambda^{\varepsilon}}{m_2^a - \lambda^{\varepsilon}}\right) \ge \frac{3\gamma |\ln \varepsilon|}{m_2^a} (1 + \mathcal{O}(|\ln \varepsilon|^{-1})), \tag{3.50}$$

where the latter inequality holds for $\varepsilon \downarrow 0$. Note that

$$t_{\varepsilon}(x) = \int_{x}^{a+\delta} \frac{dy}{|U'(y)|} \le \frac{1}{m_{1}^{a}} \int_{a+\varepsilon^{\gamma}}^{a+\delta} \frac{dy}{|a-y|} = \frac{1}{m_{1}^{a}} \ln\left(\frac{\delta}{\varepsilon^{\gamma}}\right) = t_{\varepsilon}. \tag{3.51}$$

In the limit of small ε , t_{ε} can be calculated as

$$t_{\varepsilon} = \frac{\gamma |\ln \varepsilon|}{m_1^a} (1 + \mathcal{O}(|\ln \varepsilon|^{-1})), \tag{3.52}$$

Hence $t_{\varepsilon}(x) \leq t_{\varepsilon} < t^*(\varepsilon)$ for $0 < \varepsilon \leq \varepsilon_2$, ε_2 being sufficiently small, and p_t^{ε} is well defined on the time interval under consideration.

To show a) we note that at the starting point t = 0,

consequently it follows from the continuity of R^{ε} and p^{ε} that $p_t^{\varepsilon} > R_t^{\varepsilon}$ for at least positive and small t. Assume there exists $\tau = \inf\{t > 0 : R_{\tau}^{\varepsilon}(x) = p_{\tau}^{\varepsilon}\}$ such that $\tau \leq t_{\varepsilon}(x)$. At the point τ the left derivative of $R^{\varepsilon}(x)$ is necessarily not less than the derivative of p^{ε} which leads to the following contradiction:

$$D^{-}R_{t}^{\varepsilon}(x)\Big|_{t=\tau} = \lim_{h\downarrow 0} \frac{R_{\tau}^{\varepsilon}(x) - R_{\tau-h}^{\varepsilon}(x)}{h} = f(R_{\tau}^{\varepsilon}(x), x_{\tau}^{0}(x), Z_{\tau-}^{\varepsilon}(x))$$

$$\geq \dot{p}_{t}^{\varepsilon}\Big|_{t=\tau} = m_{2}^{a}p_{\tau}^{\varepsilon} + L(p_{\tau}^{\varepsilon})^{2} + A^{2}\varepsilon^{6\gamma},$$

$$f(R_{\tau}^{\varepsilon}(x), x_{\tau}^{0}(x), Z_{\tau-}^{\varepsilon}(x)) = f(p_{\tau}^{\varepsilon}, x_{\tau}^{0}(x), Z_{\tau-}^{\varepsilon}(x)) < m_{2}^{a}p_{\tau}^{\varepsilon} + L(p_{\tau}^{\varepsilon})^{2} + A^{2}\varepsilon^{6\gamma}.$$

$$(3.54)$$

To prove b), we use the inequality

$$\sup_{t \in [0, t_{\varepsilon}(x)]} p_t^{\varepsilon} \le p_{t_{\varepsilon}(x)}^{\varepsilon} \le p_{t_{\varepsilon}}^{\varepsilon}. \tag{3.55}$$

and a formula (3.51) for t_{ε} . Indeed, on \mathcal{E}_t , we have the following estimates

$$e^{t_{\varepsilon}\lambda^{\varepsilon}} - e^{-t_{\varepsilon}\lambda^{\varepsilon}} \leq \left(\frac{\delta}{\varepsilon^{\gamma}}\right)^{\frac{\lambda^{\varepsilon}}{m_{1}^{a}}} \leq \left(\frac{\delta}{\varepsilon^{\gamma}}\right)^{\frac{m_{2}^{a}}{m_{1}^{2}}} = c_{1}\varepsilon^{-\gamma\frac{m_{2}^{a}}{m_{1}^{2}}},$$

$$(m_{2}^{a} + \lambda^{\varepsilon})e^{-t_{\varepsilon}\lambda^{\varepsilon}} \geq m_{2}^{a} \left(\frac{\delta}{\varepsilon^{\gamma}}\right)^{-\frac{\lambda^{\varepsilon}}{m_{1}}} \geq c_{2}\varepsilon^{\gamma\frac{m_{2}^{a}}{m_{1}^{a}}},$$

$$(m_{2}^{a} - \lambda^{\varepsilon})e^{t_{\varepsilon}\lambda^{\varepsilon}} \leq m_{2}^{a} \left(1 - \sqrt{1 - \frac{4LA^{2}\varepsilon^{6\gamma}}{(m_{2}^{a})^{2}}}\right) \left(\frac{\delta}{\varepsilon^{\gamma}}\right)^{\frac{\lambda^{\varepsilon}}{m_{1}^{a}}}$$

$$\leq \frac{4LA^{2}\varepsilon^{6\gamma}}{m_{2}} \left(\frac{\delta}{\varepsilon^{\gamma}}\right)^{\frac{m_{2}^{a}}{m_{1}^{2}}} = c_{3}\varepsilon^{\gamma(6 - \frac{m_{2}^{a}}{m_{1}^{a}})}.$$

$$(3.56)$$

Thus, since $\frac{m_2^a}{m_1^a} < \frac{3}{2}$ and for $\varepsilon \le \varepsilon_0 = \min\{\varepsilon_1, \varepsilon_2\}$ we can estimate

$$p_{t_{\varepsilon}}^{\varepsilon} \leq A^{2} \varepsilon^{6\gamma} \frac{c_{1} \varepsilon^{-\gamma \frac{m_{2}^{\alpha}}{m_{1}^{\alpha}}}}{c_{2} \varepsilon^{\gamma \frac{m_{2}^{\alpha}}{m_{1}^{\alpha}}} - c_{3} \varepsilon^{\gamma (6 - \frac{m_{2}^{\alpha}}{m_{1}^{\alpha}})}} = \varepsilon^{2\gamma (3 - \frac{m_{2}^{\alpha}}{m_{1}^{\alpha}})} \frac{A^{2} c_{1}}{c_{2} - c_{3} \varepsilon^{2\gamma (3 - \frac{m_{2}^{\alpha}}{m_{1}^{\alpha}})}} \leq C_{1} \varepsilon^{3\gamma}.$$

$$(3.57)$$

The proof of the lower bound in (3.43) is analogous.

Lemma 3.6 (Estimate away from critical points) There exists $C_2 > 0$ such that for any $\gamma > 0$ there is $\varepsilon_0 > 0$ such that for $0 \le \varepsilon \le \varepsilon_0$ and any $t_{\varepsilon}(x) \le t \le t_{\varepsilon}(x) + \hat{T}$,

$$\sup_{s \in [t_{\varepsilon}(x), t]} |R_s^{\varepsilon}(x)| \le C_2 \varepsilon^{3\gamma}, \tag{3.58}$$

on the event \mathcal{E}_t uniformly for $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$.

Proof: Using Lemma 3.4, choose K > 0 such that on the event \mathcal{E}_t the processes $x^{\varepsilon}(x), \varepsilon Z^{\varepsilon}(x), R^{\varepsilon}(x)$ take their values in [-K, K] as long as time runs in [0, t]. Let also previous Lemmas hold for $0 < \varepsilon \le \varepsilon_0$. For $t_{\varepsilon}(x) \le t \le t_{\varepsilon}(x) + \hat{T}$, the rest term R^{ε} satisfies the following integral equation:

$$R_{t}^{\varepsilon}(x) = R_{t_{\varepsilon}(x)}^{\varepsilon}(x) + \int_{t_{\varepsilon}(x)}^{t} \left[-U'(x_{s}^{0}(x) + \varepsilon Z_{s-}^{\varepsilon}(x) + R_{s}^{\varepsilon}(x)) + U'(x_{s}^{0}(x)) + U''(x_{s}^{0}(x)) \varepsilon Z_{s-}^{\varepsilon}(x) \right] ds$$

$$= R_{t_{\varepsilon}(x)}^{\varepsilon}(x) - \int_{t_{\varepsilon}(x)}^{t} \left[U'(x_{s}^{0}(x) + \varepsilon Z_{s-}^{\varepsilon}(x) + R_{s}^{\varepsilon}(x)) - U'(x_{s}^{0}(x) + \varepsilon Z_{s-}^{\varepsilon}(x)) \right] ds$$

$$- \int_{t_{\varepsilon}(x)}^{t} \left[U'(x_{s}^{0}(x) + \varepsilon Z_{s-}^{\varepsilon}(x)) - U'(x_{s}^{0}(x)) - U''(x_{s}^{0}(x)) \varepsilon Z_{s-}^{\varepsilon}(x) \right] ds$$

$$= R_{t_{\varepsilon}(x)}^{\varepsilon}(x) - \int_{t_{\varepsilon}(x)}^{t} U''(\theta_{s}^{1}) R_{s}^{\varepsilon}(x) ds - \int_{t_{\varepsilon}(x)}^{t} \frac{1}{2} U^{(3)}(\theta_{s}^{2}) (\varepsilon Z_{s-}^{\varepsilon}(x))^{2} ds$$

$$(3.59)$$

with appropriate θ_s^1 , $\theta_s^2 \in [-K, K]$. Note that $R_{t_{\varepsilon}(x)}^{\varepsilon}(x) = 0$ if $x \in [a + \delta, b - \delta]$. Thus on \mathcal{E}_t , with the help of Lemma 3.5, we obtain

$$|R_t^{\varepsilon}(x)| \leq |R_{t_{\varepsilon}(x)}^{\varepsilon}(x)| + \int_{t_{\varepsilon}(x)}^{t} L|R_s^{\varepsilon}(x)| \, ds + \frac{t - t_{\varepsilon}(x)}{2} L C_Z^2 \varepsilon^{6\gamma} \leq C_1 \varepsilon^{3\gamma} + \int_{t_{\varepsilon}(x)}^{t_{\varepsilon}(x) + \hat{T}} L|R_s^{\varepsilon}(x)| \, ds + \frac{1}{2} \hat{T} L C_Z^2 \varepsilon^{6\gamma}. \tag{3.60}$$

An application of Gronwall's lemma yields the final estimates for $t_{\varepsilon}(x) \leq t \leq t_{\varepsilon}(x) + \hat{T}$:

Lemma 3.7 (Estimate near the stable point) There exist a positive constant C_3 such that for any $\gamma > 0$ there is $\varepsilon_0 > 0$ such that for $0 \le \varepsilon \le \varepsilon_0$ and any $t \ge t_{\varepsilon}(x) + \hat{T}$,

$$\sup_{s \in [t_{\varepsilon}(x) + \hat{T}, t]} |R_s^{\varepsilon}(x)| \le \varepsilon^{3\gamma}, \tag{3.62}$$

on the event \mathcal{E}_t uniformly for $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}].$

Proof: 1. Using Lemma 3.4, choose K > 0 such that on the event \mathcal{E}_t the processes $x^{\varepsilon}(x), \varepsilon Z^{\varepsilon}(x), R^{\varepsilon}(x)$ take their values in [-K, K] as long as time runs in [0, t]. Let previous Lemmas hold for $0 < \varepsilon \le \varepsilon_0$.

For $t \geq t_{\varepsilon}(x) + \hat{T}$ the rest term R^{ε} satisfies the integral equation

$$R_t^{\varepsilon}(x) = R_{t_{\varepsilon}(x) + \hat{T}}^{\varepsilon}(x) + \int_{t_{\varepsilon}(x) + \hat{T}}^{t} f(R_s^{\varepsilon}(x), x_s^{0}(x), \varepsilon Z_{s-}^{\varepsilon}(x)) ds$$
(3.63)

with

$$f(R, x^{0}, \varepsilon Z) = -U'(x^{0} + \varepsilon Z + R) + U'(x^{0}) + U''(x^{0})(\varepsilon Z).$$
(3.64)

Note that for the time instants t under consideration, the deterministic trajectory $x_t^0(x)$ is in the δ -neighbourhood of the stable point 0. Repeating the argument of Lemma 3.5 we obtain the following estimates:

$$\begin{split} f(R_t^{\varepsilon}(x), & x_t^0(x), \varepsilon Z_{t-}^{\varepsilon}(x)) \leq -U''(x_t^0(x)) R_t^{\varepsilon} + L(R_t^{\varepsilon})^2 + L(\varepsilon Z_{t-}^{\varepsilon}(x))^2 \\ & < -U''(x_t^0(x)) R_t^{\varepsilon} + L(R_t^{\varepsilon})^2 + 2C_Z^2 L^2 \varepsilon^{3\gamma} < -U''(x_t^0(x)) R_t^{\varepsilon} + L(R_t^{\varepsilon})^2 + D\varepsilon^{3\gamma}, \\ f(R_t^{\varepsilon}(x), & x_t^0(x), \varepsilon Z_{t-}^{\varepsilon}(x)) \geq -U''(x_t^0(x)) R_t^{\varepsilon} - L(R_t^{\varepsilon})^2 - L(\varepsilon Z_{t-}^{\varepsilon}(x))^2 \\ & > -U''(x_t^0(x)) R_t^{\varepsilon} - L(R_t^{\varepsilon})^2 - 2C_Z^2 L^2 \varepsilon^{3\gamma} > -U''(x_t^0(x)) R_t^{\varepsilon} - L(R_t^{\varepsilon})^2 - D\varepsilon^{3\gamma} \end{split}$$

on the event \mathcal{E}_t , with some $D > 2C_Z^2L$ which will be specified later.

The main difference to Lemma 3.5 consists in the sign of the U'' in the vicinity of zero. Now the curvature is positive what guarantees the boundedness of $R^{\varepsilon}(x)$ on long time intervals.

2. We establish the upper bound for $R^{\varepsilon}(x)$. Consider a Riccati equation

The comparison argument of Lemma 3.5 shows that

$$R_t^{\varepsilon}(x) \le p_t^{\varepsilon}, \quad t \ge t_{\varepsilon}(x) + \hat{T}.$$
 (3.67)

Now we study the Riccati equation (3.66) in detail. It is easy to see that it has two positive stationary solutions at which the integrand of (3.66) vanishes:

$$p^{\pm} = \frac{m_2^0}{2L} \left(1 \pm \sqrt{1 - \frac{4LD^2 \varepsilon^{3\gamma}}{(m_2^0)^2}} \right). \tag{3.68}$$

Applying the elementary inequality $\frac{x}{2} \leq 1 - \sqrt{1-x} \leq x$, $x \in [0,1]$, to the smaller solution p^- and for $\varepsilon \leq \varepsilon_0$ such that $4LD^2\varepsilon^{3\gamma}/(m_2^0)^1 \leq 1$, we find that

$$\frac{D^2}{m_2^0} \varepsilon^{3\gamma} \le p^- \le \frac{2D^2}{m_2^0} \varepsilon^{3\gamma} < \frac{2D^2}{m_1^0} \varepsilon^{3\gamma}. \tag{3.69}$$

This means that if $R_{t_{\varepsilon}(x)+\hat{T}}^{\varepsilon}(x) < \frac{D^2}{m_2^0} \varepsilon^{3\gamma}$, the solution $R_t^{\varepsilon}(x)$ does not exceed $\frac{2D^2}{m_1^0} \varepsilon^{3\gamma}$ on the time interval $[t_{\varepsilon}(x)+\hat{T},t]$ and the event \mathcal{E}_t .

We use Lemma 3.6 to conclude that $R_{t_{\varepsilon}(x)+\hat{T}}^{\varepsilon}(x) < C_2 \varepsilon^{3\gamma}$, and taking $D > \sqrt{C_2 m_2^0}$ and $C_3 > \frac{2D^2}{m_1^0}$ finishes the proof.

3. The lower bound for $R^{\varepsilon}(x)$ is obtained analogously.

Proof of Lemma 3.3 The claim of Lemma 3.3 follows from Lemmas 3.5, 3.6 and 3.7 by taking $C_R = \max\{C_1, C_2, C_3\}$ and ε_0 the minimal value of ε for which these Lemmas hold simultaneously.

3.3 Final estimate for $|x_t^{\varepsilon} - x_t^0|$, $a > -\infty$

In this section we use Lemma 3.1 and Proposition 3.1 to estimate the probability that the small-jump process $x_t^{\varepsilon}(x)$ leaves the $\frac{1}{2}\varepsilon^{2\gamma}$ -dependent tube of the deterministic trajectory $x_t^0(x)$.

Proposition 3.2 Let $a > -\infty$. Let $\rho \in (0,1)$, $x^{\varepsilon}(x)$ and $x^{0}(x)$ satisfy (3.13). Let $T(\varepsilon)$ be an exponentially distributed random variable with mean $1/\beta_{\varepsilon}$ and let ξ^{ε} and let $T(\varepsilon)$ be independent. Then for any $\gamma \in (0, (1-\rho)/4)$ there exist $p_{0} > 0$ and $\varepsilon_{0} > 0$ such that the inequality

$$\sup_{x \in [a+\varepsilon^{\gamma}, b-\varepsilon^{\gamma}]} \mathbf{P}_{x} \left(\sup_{t \in [0, T(\varepsilon)]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) \le \exp\left(-1/\varepsilon^{p}\right)$$
 (3.70)

holds for all $0 \le p \le p_0$ and $0 < \varepsilon \le \varepsilon_0$.

Proof: Let $\theta < \min 1 - \rho - \gamma, r\rho$. Then $\mathbf{E}T_1 = \frac{1}{\beta_e} \gg \frac{1}{\varepsilon^{\theta}}$ as $\varepsilon \downarrow 0$. Consider the number

$$k_{\varepsilon} = \left[\frac{\varepsilon^{\theta/2}}{\beta_{\varepsilon}}\right],\tag{3.71}$$

where [x] denotes the integer part of x. Note that $k_{\varepsilon} \to \infty$ slower than some power of $1/\varepsilon$. For any $x \in [a + \varepsilon^{\gamma}, b - \varepsilon^{\gamma}]$ we have

$$\mathbf{P}_{x} \left(\sup_{t \in [0,T_{1}]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) = \int_{0}^{\infty} \beta_{\varepsilon} e^{-\beta_{\varepsilon}\tau} \mathbf{P}_{x} \left(\sup_{t \in [0,\tau]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) d\tau \\
= \left(\int_{0}^{k_{\varepsilon}/\varepsilon^{\theta}} + \int_{k_{\varepsilon}/\varepsilon^{\theta}}^{\infty} \beta_{\varepsilon} e^{-\beta_{\varepsilon}\tau} \mathbf{P}_{x} \left(\sup_{t \in [0,\tau]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) d\tau.$$
(3.72)

For $0 < \varepsilon \le \varepsilon_1$, ε_1 small enough, the second summand is estimated as

$$\int_{k_{\varepsilon}/\varepsilon^{\theta}}^{\infty} \beta_{\varepsilon} e^{-\beta_{\varepsilon}\tau} \mathbf{P}_{x} \left(\sup_{t \in [0,\tau]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) d\tau \le \exp\left(-\frac{\beta_{\varepsilon}}{\varepsilon^{\theta}} k_{\varepsilon}\right) \le \exp\left(-\frac{1}{\varepsilon^{\theta/2}}\right). \tag{3.73}$$

For the first summand,

$$\int_{0}^{k_{\varepsilon}/\varepsilon^{\theta}} \beta_{\varepsilon} e^{-\beta_{\varepsilon}\tau} \mathbf{P} \left(\sup_{t \in [0,\tau]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) d\tau$$

$$= \sum_{j=0}^{k_{\varepsilon}-1} \int_{j/\varepsilon^{\theta}}^{(j+1)/\varepsilon^{\theta}} \beta_{\varepsilon} e^{-\beta_{\varepsilon}\tau} \mathbf{P} \left(\sup_{t \in [0,\tau]} |x_{t}^{\varepsilon}(x) - x_{t}^{0}(x)| \ge \frac{\varepsilon^{2\gamma}}{2} \right) d\tau$$

5 Transitions between the wells

For $0 < \Delta < \Delta_0 = \min_{1 \le i \le n} \{ |m_i - s_{i-1}|, |m_i - s_i| \}$ and $x \in \mathbb{R}$ denote $B_{\Delta}(x) = \{ y : |x - y| \le \Delta \}$. Consider the following stopping times:

For $x \in \Omega^i_{\varepsilon}$, T^i is the transition time between the wells. For $x \in B_{\Delta}(m_i)$, τ^i is the transition time between Δ -neighbourhoods of wells' minima, and for $x \in B_{2\varepsilon^{\gamma}}(s_i)$, S^i_x is the exit time from a neighbourhood of the saddle point.

(5.12)

Then is easy to see that

$$\lambda^{i}(\varepsilon)\mathbf{E}_{x}T^{i}(\varepsilon) \leq \lambda^{i}(\varepsilon)\mathbf{E}_{x}\sigma^{i}(\varepsilon) + \sum_{k=1}^{\infty} (k+1)(1+\delta) + k\delta)\delta^{k} \leq 1 + \delta \cdot \text{Const}$$
 (5.13)

which proves (5.9).

Proposition 5.2 For any $0 < \Delta < \Delta_0$ the following limits hold

$$\lim_{\varepsilon \downarrow 0} \mathbf{P}_x \left(X_{\tau^i(\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_j) \right) = \frac{q_{ij}}{q_i} \tag{5.14}$$

$$\lambda^{i}(\varepsilon)\tau^{i}(\varepsilon) \xrightarrow{\mathcal{D}} \exp(1),$$
 (5.15)

$$\lim_{\varepsilon \downarrow 0} \lambda^{i}(\varepsilon) \mathbf{E}_{x} \tau^{i}(\varepsilon) = 1. \tag{5.16}$$

uniformly for $x \in B_{\Delta}(m_i)$ and $i = 1, ..., n, j \neq i$.

Proof:

It is obvious that for all $x \in B_{\Delta}(m_i)$

$$\sigma^{i}(\varepsilon) \le T^{i}(\varepsilon) \le \tau^{i}(\varepsilon) \quad \mathbf{P}_{x}\text{-a.s.}$$
 (5.17)

On the other hand, the main contribution to $\tau(\varepsilon)$ is made by the switching time $T(\varepsilon)$, for if the trajectory overcomes the saddle point and is in Ω^j_{ε} for some $j \neq i$, it follows the deterministic trajectory with high probability and reaches the set $B_{\Delta}(m_j)$ in short (logarithmic) time.

First we show that

$$\lim_{\varepsilon \downarrow 0} \mathbf{P}_x \left(\tau^i(\varepsilon) \le T^i(\varepsilon) + c |\ln \varepsilon| \right) = 1, \tag{5.18}$$

where c is defined in (4.10). Let $X_{T^{i}(\varepsilon)}^{\varepsilon}(x) \in \Omega_{\varepsilon}^{j}$ for some $j \neq i$. On the event $A_{\varepsilon} = \{\omega : \sup_{t \in [0,\mu|\ln \varepsilon|]} |\varepsilon L_{t+T^{i}(\varepsilon)} - \varepsilon L_{T^{i}(\varepsilon)}| \leq \varepsilon^{4\gamma}\}$ the trajectory $X_{t}^{\varepsilon}(X_{T^{i}(\varepsilon)}^{\varepsilon}(x))$ follows the deterministic trajectory $x_{t}^{0}(X_{T^{i}(\varepsilon)}^{\varepsilon}(x))$ which reaches the small neighbourhood of the local minimum m_{j} in time $c|\ln \varepsilon|$. The limit (5.18) holds since $\mathbf{P}_{x}(A_{\varepsilon}) \to 1$. Then

$$\mathbf{P}_{x}(X_{\tau^{i}(\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j})) \geq \mathbf{P}_{x}(X_{\tau^{i}(\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}), X_{T^{i}(\varepsilon)}^{\varepsilon} \in \Omega_{\varepsilon}^{j}, A_{\varepsilon})
= \mathbf{P}_{x}(X_{T^{i}(\varepsilon)}^{\varepsilon} \in \Omega_{\varepsilon}^{j}, A_{\varepsilon}) \geq \mathbf{P}_{x}(X_{T^{i}(\varepsilon)}^{\varepsilon} \in \Omega_{\varepsilon}^{j}) - \mathbf{P}_{x}(A_{\varepsilon}^{c}) \rightarrow \frac{q_{ij}}{q_{i}}$$
(5.19)

and (5.14) is proved since $\sum_{j\neq i} \frac{q_{ij}}{q_i} = 1$.

Convergence (5.15) follows easily from inequality (5.17), limits (5.8) and (5.18) and the fact that $\lambda^{i}(\varepsilon)|\ln \varepsilon| \to 0$.

To prove (5.16) we repeat the argument of Proposition 5.1. Indeed, for any $\delta > 0$ there is $\varepsilon_0 > 0$ such that for $0 < \varepsilon \le \varepsilon_0$ the following inequalities hold

$$\max_{x \in \Omega_{\varepsilon}^{i}} \sup_{1 \leq j \leq n-1} \sup_{x \in B_{2\varepsilon\gamma}(s_{j})} \lambda^{i}(\varepsilon) \mathbf{E}_{x} S^{j}(\varepsilon) \leq \delta,$$

$$\max_{1 \leq i \leq n} \lambda^{i}(\varepsilon) c|\ln \varepsilon| \leq \delta.$$
(5.20)

Then it is easy to see that for $0 < \varepsilon \le \varepsilon_0$

$$\lambda^{i}(\varepsilon)\mathbf{E}_{x}\tau^{i}(\varepsilon) \leq \lambda^{i}(\varepsilon)(\mathbf{E}_{x}T^{i}(\varepsilon) + c|\ln \varepsilon|) + \sum_{k=1}^{\infty} \left[(1 + \delta + \lambda^{i}(\varepsilon)c|\ln \varepsilon|)(k+1) + \delta k \right] \delta^{k}$$

$$\leq 1 + \delta \cdot \text{Const}$$
(5.21)

which finishes the proof.

6 Metastable behaviour. Proof of Theorem 1

6.1 Convergence on short time intervals

Proposition 6.1 Let $0 < \delta < r$. Then if $x \in \Omega^i$, i = 1, ..., n, then for t > 0

Proof: For some $1 \le i \le n$, let $x \in \Omega^i$. We shall prove a stronger result: for any A > 0 and $0 < \Delta < \Delta_0$

Indeed, recalling Section 3 we choose $\gamma > 0$ and c > 0 such that $|X_{c|\ln \varepsilon|}^{\varepsilon}(x) - m_i| \leq \Delta/2$ a.s. on the event $E = \mathcal{E}_{c|\ln \varepsilon|} \cap \{T_1 > c|\ln \varepsilon|\}$, where $\mathcal{E}_{c|\ln \varepsilon|} = \{\sup_{[0,c|\ln \varepsilon|]} |\varepsilon \xi_t^{\varepsilon}| \leq \varepsilon^{4\gamma}\}$. This gives

$$\mathbf{P}_{x} \left(\sup_{s \in [c|\ln\varepsilon|, A/\varepsilon^{\delta}]} |X_{s}^{\varepsilon} - m_{i}| > \Delta \right) \leq \sup_{|y - m_{i}| \leq \Delta/2} \mathbf{P}_{y} \left(\sup_{s \in [0, A/\varepsilon^{\delta} - c|\ln\varepsilon|]} |X_{s}^{\varepsilon} - m_{i}| > \Delta \right) + \mathbf{P}(E^{c})
\leq \sup_{|y - m_{i}| \leq \Delta/2} \mathbf{P}_{y} \left(\sigma_{\Delta}(\varepsilon) < A/\varepsilon^{\delta} - c|\ln\varepsilon| \right) + \mathbf{P}(E^{c})
\leq \sup_{|y - m_{i}| < \Delta/2} \mathbf{P}_{y} \left(\sigma_{\Delta}(\varepsilon) < A/\varepsilon^{\delta} \right) + \mathbf{P}(\mathcal{E}_{\mu|\ln\varepsilon|}^{c}) + \mathbf{P}(T_{1} \leq c|\ln\varepsilon|),$$
(6.3)

where $\sigma_{\Delta}(\varepsilon) = \inf\{t > 0 : |X_t^{\varepsilon} - m_i| > \Delta\}$. On the other hand we know that for $\lambda_{\Delta}(\varepsilon) = H_{-}(-\Delta/\varepsilon) + H_{+}(\Delta/\varepsilon)$,

$$\lambda_{\Delta}(\varepsilon)\sigma_{\Delta}(\varepsilon) \xrightarrow{\mathcal{D}} \exp(1).$$
 (6.4)

Since $\lambda_{\Delta}(\varepsilon)/\varepsilon^{\delta} \to 0$ as $\varepsilon \downarrow 0$ we have $\mathbf{P}_y\left(\sigma_{\Delta}(\varepsilon) < A/\varepsilon^{\delta}\right) \to 0$, as well as $\mathbf{P}(\mathcal{E}_{c|\ln \varepsilon|}^c) \to 0$ and $\mathbf{P}(T_1 \le c|\ln \varepsilon|) \to 0$ in the limit of small ε . This finishes the proof of (6.2).

Remark 6.1 It is easy to notice in view of Section 3 that the convergence in Proposition 6.1 is uniform in x for $x \in \Omega^i_{\varepsilon}$.

6.2 Proof of Theorem 1

= \sum_{k=1}^{n}\mathbf{E}_{x}\left[\mathbf{P}_{X_{S^{i}(\varepsilon)}}\left(X_{2/\varepsilon^{r(1-\gamma/2)}-S^{i}(\varepsilon)}^{\varepsilon}\notin\bigcup_{j=1}^{n}B_{\Delta}(m_{j})\right) \cdot \mathbb{I}\left\{S^{i}(\varepsilon) \leq 1/\varepsilon^{r(1-\gamma/2)}\right\} \cdot \mathbb{I}\left\{X_{S^{i}(\varepsilon)}^{\varepsilon}\in\Omega_{\varepsilon}^{k}\right\}\right] \\
+ \mathbf{E}_{x}\left[\mathbf{P}_{X_{S^{i}(\varepsilon)}}\left(X_{2/\varepsilon^{r(1-\gamma/2)}-S^{i}(\varepsilon)}^{\varepsilon}\notin\bigcup_{j=1}^{n}B_{\Delta}(m_{j})\right) \cdot \mathbb{I}\left\{S^{i}(\varepsilon) \leq 1/\varepsilon^{r(1-\gamma/2)}\right\} \cdot \mathbb{I}\left\{X_{S^{i}(\varepsilon)}^{\varepsilon}\notin\bigcup_{j=1}^{n}\Omega_{\varepsilon}^{j}\right\}\right] \\
+ \mathbf{P}\left(J(\varepsilon) > 1/\varepsilon^{r(1-\gamma/2)}\right) \\
\leq \sum_{k=1}^{n}\sup_{y\in\Omega_{\varepsilon}^{k}}\mathbf{P}_{y}\left(\sup_{s\in[c|\ln\varepsilon|,2/\varepsilon^{r(1-\gamma/2)}]}|X_{s}^{\varepsilon} - m_{k}| > \Delta\right) \\
+ \mathbf{P}\left(\sup_{t\in[0,1/\varepsilon^{r(1-\gamma/2)}]}\varepsilon|L_{t} - L_{t-}| > a\right) + \mathbf{P}\left(J(\varepsilon) > 1/\varepsilon^{r(1-\gamma/2)}\right),$$

with $a = \frac{1}{2} \min\{s_2 - s_1, \dots, s_{n-1} - s_{n-2}\}$. The first summand in the latter formula tends to 0 due to Proposition 6.1. The second summand is estimated by $1 - \exp(\varepsilon^{-r(1-\gamma/2)}H(a/\varepsilon)) \to 0$, and the third summand also tends to 0 due to the definition of $J(\varepsilon)$.

2. It is clear from the proof that the limit (6.6) holds also for $x \in \Omega^i_{\varepsilon}$, i = 1, ..., n, and thus for all $x \in \mathbb{R}$. Then, for ε small enough such that $t/H(1/\varepsilon) > 2/\varepsilon^{r(1-\gamma/2)}$ the application of the Markov property

Proof of Theorem 1:

It is clear from the Markov property that it is sufficient to show that for any t > 0 and $x \in \Omega_{\varepsilon}^{i}$, $i = 1, \ldots, n$,

Define a sequence of stopping times $(\tau(k))_{k\geq 0}$ and states $(m(k))_{k\geq 0}$ such that $\tau(0)=0, m(0)=m_i$ and for $k\geq 1$

$$\tau(k) = \inf\{t > \tau(k-1) : X_t^{\varepsilon} \in \bigcup_{i=1}^n B_{\Delta}(m_i) \setminus B_{\Delta}(m(k-1))\},$$

$$m(k) = \sum_{j=1}^n m_j \mathbb{I}\{X_{\tau(k)}^{\varepsilon} \in B_{\Delta}(m_j)\}.$$

$$(6.10)$$

Define also a (non-Markovian) process \hat{X}^{ε} on a state space $\{m_1, \ldots, m_n\}$

$$\hat{X}_t^{\varepsilon} = \sum_{k=0}^{\infty} m(k) \cdot \mathbb{I}\{t \in [H(1/\varepsilon)\tau(k), H(1/\varepsilon)\tau(k+1))\}. \tag{6.11}$$

The strong Markov property of X^{ε} and Proposition 5.2 imply that

$$\operatorname{Law}\left(H(1/\varepsilon)(\tau(k+1)-\tau(k))|\hat{X}_{\tau(k)}^{\varepsilon}=m_{i}\right) \to \exp(1/q_{i}),$$

$$\mathbf{P}_{x}(\hat{X}_{\tau(k+1)}^{\varepsilon}=m_{j}|\hat{X}_{\tau(k)}^{\varepsilon}=m_{i}) \to \frac{q_{ij}}{q_{i}},$$
(6.12)

uniformly for $k \geq 0$.

The process Y defined in the statement of the Theorem is given by the sequence of its jump times and states, $(\theta(k), Y_k)_{k\geq 0}$ with the property that the interjump times are conditionally independent and exponentially distributed. and for $k\geq 0$, $0\leq i,j\leq n,\ i\neq j$,

Law
$$(\theta(k+1) - \theta(k)|Y_k = m_i) = \exp(1/q_i)$$

 $\mathbf{P}(Y_{k+1} = m_j|Y_k = m_i) = \frac{q_{ij}}{q_i}.$ (6.13)

Then

$$\left| \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}) \right) - \mathbf{P}_{m_{i}} \left(Y_{t} = m_{j} \right) \right| \\
\leq \left| \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}) \right) - \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j} \right) \right| + \left| \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j} \right) - \mathbf{P}_{m_{i}} \left(Y_{t} = m_{j} \right) \right|.$$
(6.14)

The second summand in (6.14) vanishes in the limit of small ε due to the weak convergence of the jump process \hat{X}^{ε} to Y. Indeed, in this case the weak convergence is equivalent to the weak convergence of the sequences of jump times and jump sizes (see [Xia92]) $(\tau(k), m(k))_{k\geq 0} \Rightarrow (\theta(k), Y_k)_{k\geq 0}$, which follows from (6.12) and (6.13).

To estimate the first summand in (6.14) we use Lemma 6.1. Indeed,

$$\begin{aligned} & \left| \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}) \right) - \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j} \right) \right| \\ & = \left| \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}), \hat{X}_{t}^{\varepsilon} = m_{j} \right) + \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}), \hat{X}_{t}^{\varepsilon} \neq m_{j} \right) (= 0) \right. \\ & - \left. \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j}, X_{t/H(1/\varepsilon)}^{\varepsilon} \in B_{\Delta}(m_{j}) \right) - \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j}, X_{t/H(1/\varepsilon)}^{\varepsilon} \in \bigcup_{k \neq j} B_{\Delta}(m_{k}) \right) (= 0) \right. \\ & - \left. \mathbf{P}_{x} \left(\hat{X}_{t}^{\varepsilon} = m_{j}, X_{t/H(1/\varepsilon)}^{\varepsilon} \notin \bigcup_{k=1}^{n} B_{\Delta}(m_{k}) \right) \right| \leq \mathbf{P}_{x} \left(X_{t/H(1/\varepsilon)}^{\varepsilon} \notin \bigcup_{k=1}^{n} B_{\Delta}(m_{k}) \right) \to 0, \end{aligned}$$

which finishes the proof of the Theorem.

A Existence of strong solution

Here we refer to [SG03] where the existence of the strong solution was established for potentials with unique stable point.

First, we note that for the existence and uniqueness of solutions of (2.1) it is enough to demand that U' is locally Lipschitz and $U'(x)x \ge 0$ for $|x| \ge N$, with N large enough.

For brevity, we set $\varepsilon = 1$. Then for $n \ge 1$ consider a family of SDEs with truncated drift,

$$X_t^{(n)}(x) = x - \int_0^t U'([X_{s-}^{(n)}(x)]_n) \, ds + L_t, \tag{A.1}$$

where

$$[x]_n = \begin{cases} -n^2, & x < -n^2 \\ x, & -n^2 \le x \le n^2, \\ n^2, & x > n^2. \end{cases}$$
 (A.2)

Since for any $n \ge 1$ the drift $U'([\cdot]_n)$ is globally Lipschitz, (A.1) has a strongly unique solution for any \mathcal{F}_0 -measurable x which is a semimartingale by [Pro04, Theorem V.3.6] and also strongly Markov by [Pro04, Theorem V.6.34].

Define a family of stopping times $T_x^n:\Omega\to\mathbb{R}\cup\{+\infty\}$ in the following way

$$T_x^n = \inf\{t > 0 : |X_t^{(n)}(x)| > n^2\}, \quad n \ge 1,$$
 (A.3)

with the usual convention that if $|X_t^{(n)}(x,\omega)| \leq n^2$ for all $t \geq 0$, then $T_x^n(\omega) = +\infty$. As $(T_x^n)_{n\geq 1}$ is a non-decreasing sequence, we can define for any $\omega \in \Omega$ the *explosion time*

If we show that $T_x = +\infty$ a.s. then using the fact that $X_t^{(n)}(x) = X_t^{(n+1)}(x)$ a.s. for $0 \le t < T_x^n$ we obtain the solution of (2.1) by setting

Let us suppose to the contrary that there is $0 < A < \infty$ such that for some $x \in \mathbb{R}$

and $S_x^n = T_x^{n+1}$ –, if there is $t_0 \in [T_x^n, T_x^{n+1})$ such that for $s \in [t_0, T_x^{n+1})$ we have $\operatorname{sgn} X_s^{n+1}(x) \neq \operatorname{sgn} X_{T_x^{n+1}}^{n+1}(x)$ or $|X_s^{n+1}(x)| < N$ (or both).

Consider different cases separately. First, if $S^n_x=T^{n+1}_x-$, we have necessarily that the jump size $|L_{T^{n+1}_x}-L_{T^{n+1}_x-}|$ must be bigger than $(n+1)^2-N$ which leads to contradiction for n big enough. If $S^n_x\neq T^{n+1}_x$ we have that $|X^{n+1}_{S^n_x}(x)|\leq n^2+2B$ and $|X^{n+1}_{T^{n+1}_x}(x)|\geq (n+1)^2$. We note that due to the inequality $U'(x)x\geq 0$ for $|x|\geq N$, we have

$$\operatorname{sgn}\left(X_{T_x^{n+1}}^{(n+1)}(x) - X_{S_x^n}^{(n+1)}(x)\right) = \operatorname{sgn}\int_{S_x^n}^{T_x^{n+1}} U'([X_{s-}^{(n+1)}(x)]_n) ds \tag{A.9}$$

and

$$|L_{T_x^{n+1}} - L_{S_x^n}| = \left| X_{T_x^{n+1}}^{(n+1)}(x) - X_{S_x^n}^{(n+1)}(x) + \int_{S_x^n}^{T_x^{n+1}} U'([X_{s-}^{(n+1)}(x)]_n) \, ds \right|$$

$$\geq |X_{T_x^{n+1}}^{(n+1)}(x) - X_{S_x^n}^{(n+1)}(x)| \geq (n+1)^2 - n^2 - 2B,$$
(A.10)

which also contradicts the assumptions for n sufficiently big. Thus the existence and uniqueness of the strong solution of (2.1) is established. This solution is also strongly Markov and Feller, see [SG03] and [KP91, Theorem 5.4]

B Regular variation

Definition B.1 a) A positive, Lebesgue measurable function l on $(0, +\infty)$ is slowly varying at $+\infty$ if

$$\lim_{u \to +\infty} \frac{l(\lambda u)}{l(u)} = 1, \quad \lambda > 0.$$
(B.1)

b) A positive, Lebesgue measurable function H on $(0,+\infty)$ is regularly varying at $+\infty$ of index $r \in \mathbb{R}$ if

$$\lim_{u \to +\infty} \frac{H(\lambda u)}{H(u)} = \lambda^r, \quad \lambda > 0.$$
(B.2)

For example, positive constants, logarithms and iterated logarithms are slowly varying functions. Further, one can prove that H is regularly varying of index r if and only if there is a slowly varying function l such that

$$H(u) = u^r l(u), \quad u > 0. \tag{B.3}$$

Another important result is the uniform convergence in (B.1).

Proposition B.1 ([BGT87], Theorem 1.2.1) If l is slowly varying at $+\infty$ then

$$\lim_{u \to +\infty} \frac{l(\lambda u)}{l(u)} = 1,\tag{B.4}$$

uniformly for λ from a compact set in $(0, +\infty)$.
