3D -vortex labyrinths in the near eld of solid-state m icrochip laser.

The usage of vortex labyrinths elds and Talbot lattices as optical dipole traps for neutral atom s is considered for the wavelength of trapping radiation in the range 0.98 $2.79 \, \text{m}$. As a possible realization the spatiotem poral vortex lattices generated in high Fresnel number solid-state m icrochip lasers are studied. The distribution of light eld is obtained via dynam icalm odel based on M axwell-B loch equations for class-B laser, discrete Fox-Lee m ap with relaxation of inversion and static m odel based on superposition of copropagating G aussian beam s. The spatial patterns observed experimentally and obtained numerically are interpreted as nonlinear superposition of vortices with helicoidal phase dislocations. The separable optical trapping potential is proposed as a sum of array of vortex lines and additional parabolic subtrap. The factorization ofm acroscopic w avefunction have led to analytical solution of G ross-P itaevski equation for ensem ble of quantum particles trapped in vortex labyrinth form ed by spatially – periodic array of Laguerre-G aussian beam s.

I. IN TRODUCTION

O ptical dipole traps for neutral atom s [1] are a subject of considerable interest. Recent years there appeared a certain am ount of proposals of increasing complexity of trapping EM - ekd. A part from a relatively sim ple geom etrical patterns like standing plane-wave gratings[2], evanescent wave m inrors[3], toroidal traps which utilize the intensity distribution of Laguerre-G aussian (G L) beam s in beam waist [4] a several proposals were m ade which utilize the arrays of G aussian beam s, both phase-locked [5, 6] and unlocked ones [7]. The interference inherent to phase-locking provides multiply connected con gurations of intensity distribution, phase gradients and electrom agnetic (EM) m om entum density , 9]. The winding EM -m om entum distribution is the cause of the angular m om entum transfer to m acroscopic bodies (e.g. dielectric ball) [10] and to trapped BEC as well [11].

The EM – eld con guration under consideration is based upon properties of self-im aging optical elds, 13]. The di erence between phase-locked array of zero-order G aussian beam s and experimentally obtained phase-locked array of optical vortices (OV) in the near eld of solid-state m icrochip laser [4] is that the latter consists of array of parallel vortex lines with opposite circulations and topological charges ${}^{*}_{EM}$ (TC) (g.1) [5]. In contrast to earlier proposals where individual loading and addressing of trapping sites was considered [7] this OV array have sophisticated con guration of intensity [3] and EM -m om entum density of trapping eld. Due to this con guration the BEC trapped in EM – eld m ight have m acroscopic wavefunction of com plex form com posed of array of super uid vortices (SFV). The cause of SFV form ation is light-induced torque experienced by isolated resonant atom which interacts with Laguerre-G aussian beam having phase singularity. It was show by Allen et al.[8] the value of torque in saturation lim it is proportional to TC: T = ~ ${}^{*}_{EM}$. The origin of T is due to nonzero azym uthal EM -m om entum com ponent. The azim uthal D oppler shift corresponding to such m otion had been onserved [9]. This torque m ight have an appreciable value even in nonresonant case, although it is signi cantly reduced by the multiple of (= $\frac{3}{2}$, where - is detuning,

- is linew idth §]. As a result an azim uthal component of EM -m om entum is transferred to atom in such a way that it will move around phase singularity - the direction of rotation is xed by TC of trapping beam. This is the cause of circular motion of BEC trapped in isolated toroidal trap.

The goal of current communication is to present the maximally transparent and simple analytical description in order to track the transfer of angular momentum from optical vortex array (OVA) to trapped BEC. As a set step the distribution of light intensity and phase in the near eld of solid-state microchip laser computed via split-step FFT technique. The conguration of intensity and phase of EM - eld of OVA has rather complicated, multinode structure. In order to get analytic solution for macroscopic wavefunction trapped by such array, the special optical pancake-like potential (g.1) will be constructed. In this trapping geometry the separation of variables in G ross-P itaevsky equation [2] becomes possible. Next the procedure applied previously to elongated sech²-prole optical trap [5] will

be used. Due to special a justment of potential it is possible to capture an analytic approximation for in the form of superposition of elementary equispaced vortices. The numerical modeling supports this approximate formula: the small but unavoidable EM -torque existing in OV even at large detuning from resonance imposes the correlation between TC of BEC vortices and TC of the optical vortices.

The BEC angularm on entum distribution is form ed via periodic lattice of SFV with alternating topological charges. There is a remarkable contrast with super uid in "rotating bucket" trap: while angularm on enta of SFV in bucket are co-directed [16, 17] the BEC vortices trapped by OVA are counter-directed from site to site.

As a result in the net sum each angular momentum of SFV of positive topological charge is compensated by the angular momentum of SFV with negative charge and total angular momentum tends to zero. Meantime the mutual subtraction of angular momenta (vectorial) of adjaicent vortices in the net sum does not mean the mutual subtraction of rotational energies, which are the positive scalars. The macroscopic quantum state carries rotational kinetic energy of condensate containing N particles of mass m per unite volume, namely $E_{rot} = N_{vortices}N \sim^2 \ln (b=a) = m$, b-diam eter of vortex core, a-interatom ic distance, -length of vortex [17]. This feature of macroscopic wavefunction trapped by vortex array might be useful from the point view of diminishing the decoherence induced by environment and topological quantum computing [18].

II. SQUARE VORTEX LATTICES

Recent advances in controlling the geom etry of solid-state m icrochip lasers [14] of the possibility of reliable control of spatiotem poral optical patterns. C om pared to sem iconductor lasers the host medium composed of dielectric crystal doped by neodim ium N d⁺³ or other rare earth ions (E r⁺³; T m⁺³; H o⁺³; Y b⁺³) have smaller gain and smaller self-phase modulation. Because of smaller nonresonant losses the heating of host crystal by radiation is not dramatic. The changes of the geometry and birefrigence of host crystals, curvature and rectivity of output couplers and spatial distribution of optical pumping give better control over m ode structure. The square vortex lattices (SV L) observed in quasiplane parallel cavity [14] are of special interest. These lattices demonstrate in pressive spatial coherence : the relaxation oscillations of class-B high Fresnel num ber solid-state m icrochip laser [14] with Fresnel num ber in the range N_f 100 1000 are characterized by single peak at frequency about ($\overline{T_1}_c$)¹ (0:3 1:2 M H z). This is the m evidence of single-longitudinal and single transverse m ode behaviour. The form er theoretical analysis was based on Sw iff-H ohenberg equation, resulted from standard set of M axwell-B loch equations, when nite gain linew idth T₂¹ is taken into account [19]:

The alternative model with discrete time step equal to $= 2L_r=c$ (time of bouncing of radiation between m irrors) utilizes the standard rate equations of class-B laser written at n-th step for electric eld⁵, 20]:

where the kernel K for the nearly plane-parallel Fabry-Perot cavity of m icrochip laser with transverse litering via aperture D (\hat{r}^0) has the form [12]:

The similar spatiotem poral picture of transverse modes was obtained for 2D transversal eld distribution. The following parameters were choosen in numerical simulation: $T_1 = 2 \ 10^4 \text{ sec}$, $L_r = 1 \text{ mm}$, for N d⁺³-doped crystals = (1.2 0.6) 10^{20} cm^2 , N₀ = 10^{16} cm^3 , $!T_2 = 0.1$,

In numerical evaluation of eq. (4) via split-step FFT method [22] the mesh size in X Y plane was 512 512 points. The "guard bands ratio" [25] was set equal to 8. The main part of the eld was located inside central part of a mesh of 64 64 size - the "im age area". The tolerance of the energy spillover was kept within $_1 = 0.001$. The "windowing" in wavenum ber space after FFT at each timestep was performed by usage of "Ferm i-D irac" sm oothed step function [22]. The dissipation inherent to "windowing" in split-step FFT method was compensated by nonlinear gain. The initial conditions were taken as multimode random eld 22].

Just near lasing threshold the radiation m ode has a distribution of intensity as rectangular grating of bright and dark spots : the latter are vortex cores. The nonlocal integralm apping proved to be successful in computation of the near eld distribution as well. Q uite unexpectably in the most runs the parallel vortex lines were obtained (g1) [5] rather than periodic array of bright and dark spots, typical to Talbot phenom enon [12]. The origin of parallel vortex lines is interpreted as nonlinear superposition of vortices with helicoidal phase dislocations. In the next sections the possibility of approximation of this nonlinear optical vortex lattice by linear equivalent will be outlined.

III. TALBOT LATTICES

Consider the phase-locked rectangular lattice of zero-order G aussian beam s located at sites $r_{jx;jy}$ [12] separated by period p, where jx; jy - are dicrete indices corresponding x and y coordinate of a given site. Let us assume for simplicity that polarization is linear, thus spin of light is zero. At z = 0 plane the electric eld E is given by expression:

A fler paraxial propagation of distance z the electric eld E(r;z) is transformed into:

The constructive interference between a jaicent beam s produces periodic interference patterns in dimenent z-spaced planes. The initial periodical pattern is reproduced at so-called Talbot-distances $z_t = 2p^2 = .$ In the interm ediate planes $z_t=4m$ the coarser lattices with periods p/m are produced [22, 23]. As a result a 3D lattice of bright spots is form ed (g.2).

Each spot could serve as potential well for neutral atom s [1, 2, 5, 6], because intensity gradient will attract or repulse the atom ic dipoles depending the sign of detuning of radiation frequency from resonance. At low frequencies (reddetuning) atom ic dipole oscillates in-phase with trapping eld and tries to align parallel to electric eld. Thus potential energy of dipole U = p E'(r)=2 is low er in local maxim a of intensity and atom s are collected at bright spots. On the other hand at frequencies above the resonance (blue-detuning) atom ic dipole oscillates out-of-phase and it has tendency to align anti-parallel to electric eld. In this blue-detuned case the potential energy of dipole is higher in local maxim a of intensity and atom s are repelled into dark regions.

Such geom etry of trapping in integer and fractionalTalbot planes based on superposition of co-propagating zerothorder G aussian beam s was considered earlier [5] including possibility of manipulation of optical lattice geom etry via mutual polarization [6] of constituting beam s.

IV . ART IF IC IAL VORTEX LABYR IN TH

Consider now the periodic array of Laguerre-Gaussian vortex beam swith helicoidal phase dislocations (g.3):

The topological charge Y_{EM} is assumed to be unity, the neighbouring beam s (components of the sum (8)) are shifted. The apodization function exp ($jrj^2=D^2$) is added in order to suppress the maximum of interference pattern at the edge of array. The beam s centers are placed in the centers of rectangular grid $r_{jx,jy}$ of period p whose axes are parallel to X,Y. The overlapping beam s produce interference pattern formed by two arrays of bright and dark spots rotated at 45 angle with respect to initial array of LG beams. The dark spots are of two kinds: one lattice of spots coincides with lattice of initial vortices(8), the other one is produced by interference and it is shifted at distance p=2 along diagonal of initial lattice. The resulting interferogram has apparent 45 tilt compared to lattice of initial vortices (g.3).

The topological charges of dark spots (vortices) ip from one site to another. The interesting feature of this interference pattern is the distribution of angular momentum [13]. The initial array of LG beams carries unit circulation and corresponding angular momentum at each site. The interferogram (g.3) contains additional array of vortices with alternative charges. The net angular momentum tends to be close to zero, because at the central part of array each positively directed TC $'_{EM}$ is compensated by four adjaicent negative ones having charge $'_{EM}$. The elementary cell of such a lattice consists of two -shifted initial vortices with co-directed charges $'_{EM}$ becated at diagonal and two counter-directed charges $'_{EM}$ (-shifted too) placed at the other diagonal of cell. The period p of initial pattern was taken being equal to 30 m while width of each initial beam was set $w_{LG} = 22$ m in order to provide signi cant m utual overlapping of vortices .

The longitudinal distribution of intensity of optical vortex array is composed of periodically spaced (with period p) hollow tubes -vortex cores(g.4). Apart from Talbot gratings which are reproduced by diraction at $z = 2p^2 = p$ planes with corresponding period division in between planes the vortex array under consideration keeps its shape within Rayleigh range, i.e. at distances $z < D^2 =$. The diam eter of cores is kept constant along z by interference of adjaicent vortices, whose helical wavefronts are perfectly m atched within elementary cell (g.5).

Consider rst the interaction of individual atom swith single optical beam carrying topological charge. The gradient force will attract the "red"-detuned atom ic dipole to the intensity maximum of an isolated rst order Laguerre-Gaussian beam - "doughnut" beam (g. 5), i.e. to the ring-shaped area around phase singularity. As a result the cloud of cold atom swill be accumulated near the maximum of intensity or "doughnut" as follows from variational solution of G ross-P itaevsky equation (GPE) [2]:

where (!) is polarizability of atom [1], m - m ass of particle, a - scattering length.

The approximate variational solution of GPE for ground state macroscopic wavefunction is Laguerre-Gaussian function [11]:

where ${}_{B E C}$ is the topological charge of this vortex solution. Hence the probability distribution j $(r;t)^2$ of noting atom some where near r = (x;y;z) at the moment t is similar to the intensity distribution of trapping eld as pointed out in [11]. More information could be obtained from the study of phase structure of wavefunction and comparison of topological charges of trapping EM -beam and BEC vortex. Using M adelung transform

it is easy to realize that there exists ow of "probability uid" with velocity v proportional (parallel) to the phase gradient lines:

Such " ow of wavefunction" occurs around the z-axis (beam axis). The " ow " described by 1(1) is potential and conservative as it should be for super uid. This picture is complicated by vorticity of EM -m om entum, inherent to LG-beam s [9]. Strictly speaking the rotation of classical dipole around core is accelerated by nonconservative torque induced by azim uthal force circulating around vortex core For two-level atom the value of torque T is given by following expression obtained by Babiker, Power and A llen [8]:

where I_{sat} - norm alised intestity of saturation, = ! !₀ - detuning of trapping eld frequency ! from resonant frequency !₀ of dipole. In saturation limit T is simply : T = ~ '_{EM} . In nonresonant case this torque reduces as 2 = ². Consequently the loop integral of the azym uthal force over circular trajectory around core (F_t r) d is nonzero (g.5).

Due to this torque in classical picture the dipole (or sm all dielectric ball) placed in the doughnut beam will move "upwards" the helicoidal phase staircase, i.e. it will rotate around LG beam axis. The direction of rotation is determined by topological charge $'_{\rm EM}$ of the trapping beam (g. 5). Qualitatively classical dipole is pushed by azim utally periodic electric eld - it happens because the phase of electric eld oscillations at each point in circle around the center of beam is shifted with respect to neighbouring points. In the same way the sm all macroscopic object like glass ball placed at maximum of intensity of GL-beam will fiel the "plane-wave-like" nonresonant pressure of light eld. The associated azim uthal D oppler shift of the moving atom was observed recently experimentally24]. O utside the resonance the origin of torque T is interpreted in similarily: the Pointing vector has component S (r)_t tangent to helix and local ux of electrom agnetic momentum pushes dipole along phase gradient, i.e. in azim uthal direction. The local density of EM -m om entum $g = S = c^2$ is proportional to components of Pointing vector [9]:

where $S(\mathbf{r})_t$ - is tangential component of Pointing vector, $S(\mathbf{r})_z$ - is axial one, r - is the distance from optical vortex core, ! - is frequency of trapping eld.

A nalogously because of tangential component of EM -m om entum the big dielectric ball with radius larger than LG -beam core and comparable to "doughnut" radius placed in center of LG -beam would rotate with acceleration because of the such torque and corresponding transfer of the angular m om entum [10].

When baded in optical vortex lattice (g.6) the atom ic dipole will move around the adjaicent vortex core with acceleration. The radius of rotation will increase until the dipole will approach the separatrice of the velocity elds N ext after certain am ount of rotations around the vortex core it could jump to another vortex using bright spots between vortices as bridge (g.6). As mentioned earlier the speed of rotation is increased due to light-induced torgue and radius of rotation is increased as well until dipole would come to another attractive core. The migration of a dipole from one vortex to another is assisted by bright regions which serve as channels connecting vortices (g.3). This qualitative picture is complicated by azim uthally inhom ogeneous distribution of intensity around each core.

Our aim now is to show that just described classicalm otion have quantum mechanical counterpart. The transfer of angularm om entum results in the speci c form of macroscopic wavefunction maintaining coherence all over array:

Next section presents the m ethod of solution of G ross-P itaevsky equation with OVA trapping eld E (r) in the form (8).

V. SEPARABLE VORTEX ARRAY POTENTIAL FOR BEC

In order to get closed form solution for macroscopic it is worth to mention that azim uthal accelerating force has very small value, falling as ² under detuning from resonance[8]. Next let us introduce optical potential V_{ext} as a square modulus of trapping eld E (p;z)[1]. The torque T will be taken into account as a "selection" rule for choosing distribution of topological charges l_{EC} in resulting solution.

It was shown recently [15] that G ross-P itaevsky equation [2] in 3D -con guration:

provided the H am iltonian is the sum of two components. First component depends on a longitudinal variable z and a second component depends upon transverse variables r_2 .

Following to [15] in order to separate variables and factorize the wavefunction let us choose trapping potential in the following form, as a sum of components depending on longitudinal coordinate z and transverse coordinates $r_{?}$ separately:

The (!) is assumed to be real due to large negative ("red") detuning from atom ic resonance at frequency $!_0 = 2.4 \ 10^5$ Hz. The imaginary part of denominator under detuning $= ! !_0$ corresponding to 85 Rb atom s trapped by EM - eld at $= 1.06 \ 0.808 \ m$ is 10^6 times smaller than real part, so the permittivity of atom (!) is real with good accuracy [1]. The trapping eld E (p) is assumed to be periodic function of transverse variables $r_2 = (x;y)$, composed of LG beam s placed at the nodes (jx; jy) of rectangular grid of period p :

The additional parabolic well with frequency $!_{?}$ is introduced in (19) in order to get analytical solution for one trapping vortex. In order to avoid the interference between di erent trapping beam s the usage of di erent carrier frequencies is recommended for longitudinal parabolic well $\frac{m !_{z} ^{2} z^{2}}{2}$, vortex array beam E (r) and parabolic subtrap in (19). The characteristic scales of potential in longitudinal z direction and transverse direction are choosen to form "pancake trap": $!_{z} >> !_{?}$ (g.1). The opposite case of elongated trap with $!_{z} << !_{?}$ and "solitonic" longitudinal potential V_{z} sech² (z) was considered earlier using analogous procedure [15].

where $_{\rm B}$ is a width of Feshbach resonance, $B_{\rm R}$ - resonant magnetic eld, $a_{\rm bg}$ -background scattering length [2].

Form ally the separation of variables is applicable each time when H am iltonian is a sum of components depending on di erent groups of variables, but this method have additional physical meaning for asymmetric potentials. The examples are elongated in z-direction trap [15] and "pancake" 2D trap (g.1) as in current case. The dynamics of in 2D traps was considered in large am ount of papers, including the geometries of periodic potentials, B essel lattices etc. In current case the SFV lattice under consideration has some features, qualitatively described above in discussion of classical motion of dipole around phase singularity.

Let us try to seek out the simplest solution of equation (27) which describe the main peculiarity of optical vortex array as a trapping eld. The continuous transfer of angular momentum from OV to BEC wavefunction might induce the vortices in initially nonrotating BEC. Because the direction of rotation of classical particle is determined by distribution of TC of optical vortices $'_{\rm EM}$ of trapping beam the distribution of TC 's in quantum super uid lattice 'BEC will be set identical to those of trapping eld.

The possible solution of equation (27) presumes the identical spatial distributions for elds $_{?}$ (r; ;t) and E (r;). It means that is also a sum of a LG functions with alternating topological charges $_{BEC}$ (see eq.(16)). Unfortunately the elder ective diameter of the core b is much larger than elective size of LG beam bottleneck (4-10 m). But this discrepancy does a lect the basic features of solution.

The correlation K of two complex spatially inhom ogeneous elds 2 (r; ;t) and E (r;) is expected to be unit:

The mutual compensation of these two terms could be achieved via tuned of magnetic eld B near Feshbach resonance. Consider rst the case of single vortex trap collocated with a single parabolic subtrap:

where f_{cavity} is e extive focal length of the laser cavity (g1) induced by them allense collocated with inhom ogeneity of optical pumping.

Because of linearity of equation and superposition principle the solution of (37) will be the sum of free-space m odes including zero-order G aussian functions, G aussian-H em it or Laguerre-G aussian m odes located at sites $r_{jx,jy}$ [12] separated by period p. The axes of such optical array are parallel to X,Y. In order to solve num erically eq. (27) the split-step FFT m ethod [22] was used. The mesh size in X Y plane was 512 512 points, the "guard bands ratio" [25] was chosen equal to 8. So the main part of the eld was located inside central part of a mesh of 64 64 size - the "in age area". The tolerance of the energy spillover was kept within $_1 = 0.0001$. The window ing in wavenum ber space after FFT at each tim estep was performed by usage of "Ferm i-D irac" sm oothed step function [22]. The dissipation inherent to split-step FFT m ethod have led to decrease of total "am ount of particles" j j dxdy within "in age area" at a speed of 10³ per time step. The special initial conditions of "preselected" SFV array in the form (16) superim posed upon hom ogeneous background gave the spatial distribution of "transverse" wavefunction $_2$ well correlated (K 0:7) with the OVA array distribution - the array of phase-locked G aussian-Laquerre wavepackets of the rst order :

The numerical solution for $_{?}$ of GPE proved to be very close to the linear combination of Gaussian-Laquerre functions. Nevertheless this solution takes into account the interference between wavefunctions of "subvortices", because the "doughnut" radius is set to be a bit less than distance between lattice nodes. The arising intereference pattern is well correlated with the interference pattern produced by Laguerre-Gaussian OVA \pm ($r_{?}$) j^{2} (g.3) with the same geometrical parameters and wavelength . Needless to say the stability of such "linear" solution of nonlinear equation is essential and it will be published elsewhere.

Each SFV carries angular momentum ~ per particle and rotational kinetic energy $E_{kin} = N - 2 \ln (\delta = a) = m, b - diam eter of vortex core, a - interatom ic distance, - length of vortex which is roughly equal to thickness of "pancake" [17]. In contrast to super uid in rotating bucket where angular momenta of vortices are co-directed [6], the BEC vortices trapped by optical vortex array are counter-directed from site to site. Consequently in the net sum of angular momenta each vortice of positive topological charge is compensated by the term with negative charge and total angular momentum tends to zero. Nevertheless the mutual subtraction of angular momenta (vectorial) of adjaicent vortices in the net sum does not mean the mutual subtraction of rotational energies, which are the positive scalars. The ground state carry amount of rotational kinetic energy of condensate containing N particles of mass m per unite volume, namely <math>E_{rot} = N_{vortices}N_{vortices}^{2} \ln (\delta = a) = m$.

VI. CONCLUSION

The optical vortex arrays em itted by solid-state m icrochip laser are analysed from the point of view of application to optical dipole traps. The possible equivalent being highly correlated to num erically obtained and experimentally observed EM – eld distributions proved to be an array of G aussian-Laquerre beam s equispaced at the nodes of rectangular lattice. For m acroscopic wavefunction of BEC trapped in such complex optical eld the analytical solutions of G ross-P itaevsky equation were found based on separation of variables and m utual compensation of vortex com – ponent of external trapping eld via nonlinear term of GPE. The obtained wavefunctions have perfect correlation with trapping eld, including distribution of topological charges, which form antiferrom agnetic-like lattice. W ithin fram ework of this particular m odel the "antiferrom agnetic" lattice of BEC vortices carriers total angular m om entum close to zero while net rotational kinetic energy of SFV lattice tends to be equal to the sum of rotational energies of vortices.

The eld of classical velocities, i.e. the eld of phase gradients, obtained via M adelung transform, form s labyrinth structure. In classical picture the trapped particle m oves across the vortex array labyrinth jumping from one whirl to another.

In quantum picture represented via analytic solution of GPE for one trapping vortex and num erical solution for optical vortex array the coherent m acroscopic wavefunction extends allover OV trapping array with transverse spatial dim ension of several hundred m icrons. The com plex eld of velocities, rotational energy and high degree of correlation of SFV wavefunction with OV trapping eld prom ise m ore resistance to decoherence.

The qualitative analytic solution supports the basic feature related to trapping of transparent particles and to BEC trapping: the transfer of OAM from EM - eld to super uid. The proposed OVA trap m ight be interesting from the point of view of studies of quantum -classical correspondence.

The mechanism of imposing the topological charges to BEC vortices by means of manipulating the vorticity of trapping optical array could result in demonstration of macroscopic quantum interference phenomena. Evidently there are 4 possible topologically equivalent combinations of parameters of solution (38) of OV charges ($_{\rm EM} = 1$) and their relative phases (). Thus there exist 4 wavefunctions having the indentical probabability j² distribution and di erent orientation of SFL vortices with respect to physical axes X; Y of trapping setup, characterised by $_{\rm BEC}^{}$ and their relative phases. The transformation of the one into another one having di erent phase structure is equivalent to 90 rotation around z - axis.
