"Hadronthermodynamics, concavity and negative heat capacities"

Abstract.

Problems associated with the nonextensivity of a hadron gas wered is scussed some time ago. Recently the topic has come to light again and here ear rlier results are reexamined in the light of new knowledge and attention is drawn to problem swith the more modern work. Hadronthermodynamicsdealswithagasofindistinguishablepartic leswhosemass spectrum is taken to have the form $Km^a e^{bm}$. Some time ago [1], a long-standing inconsistency was revealed and corrected. That inconsistency amounted t o the nonextensive nature of the expression for the entropy found in some treatmentsbywayof nature found by the microcanonical ensemble contrasting sharply with the extensive way of the canonical ensemble. The former result was shown to be due to an error. After correction of that error, the two ensembles were found to lea d to the same $a \geq -7/2$. However, in the case when expressionsforthethermodynamic quantities if a < -5/2, the microcanonical approach was used to consider the situatio n when one particle was appreciably heavier than the rest. Due to the fact that the resulting entropywasnotfoundtobesuperadditive, it was concluded that this resulting e ntropy expressionwasunphysical. However, since that time, it has eme rged[2]thatitisthe property of concavity of the entropy which embodies the essence of theSecondLaw of Thermodynamics, not the property of superadditivity as used to be f elt to be the n error since the case. Hence, that conclusion of the earlier article [1] must be i discussionfollowedthelinesofnotingthattheentropyexpressionwas notextensive; then noting that it was, in fact, concave; and, by using an earlier result [3] that concavity plus superadditivity implies extensivity, making the deduc tion that the entropymustnotbesuperadditive.Hence,itwasshownquiteclearlyt hatforahadron gas which had one particle appreciably heavier than the rest and f or which a < -5/2. the entropy expression is concave and, therefore, since it is the pr opertyofconcavity which is now known to embody the essence of the second law, this entropy expressionmustbephysicallyacceptable.

It is this property of concavity which excludes the possibility of negative heat capacities inclosed systems. It must be realised that that is all that it excludes. As has been pointed out previously [4], negative heat capacities in open syste ms are quite acceptable because, since the Euler relation is of the form

$$TdS = dU + pdV - \mu dN$$

the expression for the heat capacity in an open system is of the form

$$C_V = T \left(\frac{\partial S}{\partial T} \right)_V = \left(\frac{\partial U}{\partial T} \right)_V - \mu \left(\frac{\partial N}{\partial T} \right)_V,$$

where μ and N represent chemical potential and number of particles respectively. Since the second term on the right-hand side of this as expression has a negative sign associated with it, the sign of the heat capacity is expression has a negative sign the second term indeterminate. Hence, the heat capacity of an open system could be negative. This conclusion does notviolate the Second Law. However, an open system cannot be isolated and, if such a system and its surroundings are in equilibrium an composite system, then that composite system will by each of the system possessing a positive heat capacity.

It is often the case when negative heat capaciti es are discussed that there is a tacit ties are allowable and attention is ption. However, it is clear [4]

that the existence of such heat capacities in close dsystems could lead to violation of the Second Law of Thermodynamics; it is only in ope nsystems that the existence of such heat capacities is permissible.
