Expressions for the Exchange Correlation Potential and Exchange–Correlation Functional of Kohn–Sham Density Functional Theory

Abstract

The State–Specific Kohn–Sham Density Functional Theory [arXiv:physics/0506037] is used to derive the Kohn–Sham exchange-correlation potential $v_{\rm xc}$ and exchange-correlation functional $E_{\rm xc}$ as explicit functionals of v_s and φ_1 , where v_s is the local, one-body potential from the Kohn–Sham equations, and φ_1 is the spinless one-particle density matrix from the Kohn–Sham noninteracting state, say $|\varphi_1\rangle$. In other words, $|\varphi_1\rangle$ is the ground state eigenfunction of the noninteracting Schrödinger equation with the one-body potential v_s . For simplicity, we only consider noninteracting states that are closed-shell states and interacting states that are nondegenerate, singlet ground-states.

I. INTRODUCTION

The Kohn-Sham version of density functional theory plays a major role in both quantum chemistry and condensed matter physics [1, 2, 3, 4, 5, 6, 7]. Unfortunately, the exchangecorrelation functional $E_{\rm xc}$ is an unknown, implicit functional, and there is no systematic method to improve approximations. Recently we have derived a generalization of the Kohn– Sham approach in which the correlation energy $E_{\rm co}$ is assumed to be an explicit functional of v and ρ_1 , where v is the external potential from the interacting target-state, and ρ_1 is the spinless one-particle density matrix from the noninteracting states [8, 9]. In this approach, errors from Coulomb self-interactions do not occur, nor the need to introduce functionals defined by a constraint search. Furthermore, the exchange energy $E_{\rm x}$ is treated as in Hartree– Fock theory, as an explicit functional of ρ_1 . Below, we use this approach to derive the Kohn– Sham exchange-correlation potential $v_{\rm xc}$ and exchange-correlation functional $E_{\rm xc}$ as explicit functionals of v_s and φ_1 , where v_s is the local, one-body potential from the Kohn–Sham equations, and φ_1 is the one-particle density matrix from the Kohn–Sham noninteracting state, say $|\varphi_1\rangle$. In other words, $|\varphi_1\rangle$ is the ground state eigenfunction of the noninteracting Schrödinger equation with the one-body potential v_s .

II. STATE-SPECIFIC KOHN–SHAM DENSITY FUNCTIONAL THEORY

In state-specific Kohn–Sham density functional theory [8, 9], we use an energy functional $E_v[\rho_1]$ that is assumed to be an explicit functional of the external potential v and the spinless one-particle density matrix ρ_1 , where ρ_1 comes from a closed-shell determinantal state, say $|\rho_1\rangle$; this energy functional is given by

$$E_{v}[\rho_{1}] = \frac{\langle \tilde{\Psi}_{v\rho_{1}} | \tilde{H}_{v} | \tilde{\Psi}_{v\rho_{1}} \rangle}{\langle \tilde{\Psi}_{v\rho_{1}} | \tilde{\Psi}_{v\rho_{1}} \rangle},\tag{1}$$

where the trial wave function $\tilde{\Psi}_{v\rho_1}$ generates the exact, or target, wave function, say Ψ_n , under the following conditions:

$$|\Psi_{v\varrho_1}\rangle = |\Psi_n\rangle; \ \varrho_1 \longrightarrow n, \ n \longrightarrow N, v,$$
 (2)

where n is the electron density of Ψ_n , and Ψ_n is the ground state singlet eigenfunction of \hat{H}_v . The right side notation of Eq. (2) indicates that ρ_1 is a spin-less one particle density

matrix that delivers the density n; according to the Hohenberg-Kohn theorem [1, 2, 10], n also determines the external potential v, and n determines the number of electrons N. Using Eqs. (1) and (2), we have

$$E_v[\varrho_1] = \mathcal{E}_n, \ \varrho_1 \longrightarrow n, \ n \longrightarrow N, v.$$
 (3)

Here, \mathcal{E}_n is the exact electronic energy of the target state:

$$\hat{H}_v |\Psi_n\rangle = \mathcal{E}_n |\Psi_n\rangle; \ n \longrightarrow N, v.$$
 (4)

where the Hamiltonian operator is given by

$$\hat{H}_v = \hat{T} + \hat{V}_{\rm ee} + \hat{V}_v, \tag{5}$$

and we have

$$\hat{T} = \sum_{i}^{N} \left(-\frac{1}{2}\nabla_{i}^{2}\right),\tag{6}$$

$$\hat{V}_{\rm ee} = \frac{1}{2} \sum_{i \neq j}^{N} r_{ij}^{-1}, \tag{7}$$

$$\hat{V}_v = \sum_{i}^{N} v(i). \tag{8}$$

The electronic energy functional can also be written as

$$E_{v}[\rho_{1}] = \int d\mathbf{r}_{1} \left[-\frac{1}{2} \nabla_{1}^{2} \rho_{1}(\mathbf{r}_{1}, \mathbf{r}_{2}) \right]_{\mathbf{r}_{2}=\mathbf{r}_{1}} + \int d\mathbf{r} \, v(\mathbf{r}) \rho_{s}(\mathbf{r}) + E_{J}[\rho_{s}] + E_{x}[\rho_{1}] + E_{co}[\rho_{1}, v] + \int d\mathbf{r} \, v(\mathbf{r}) \tilde{\rho}_{c}(\mathbf{r}), \quad (9)$$

where the Coulomb and exchange energies are given by the following:

$$E_J[\rho_s] = \frac{1}{2} \int \int r_{12}^{-1} d\mathbf{r}_1 d\mathbf{r}_2 \rho(\mathbf{r}_1) \,\rho(\mathbf{r}_2), \qquad (10)$$

$$-E_{\mathbf{x}}[\rho_{1}] = \frac{1}{4} \int \int r_{12}^{-1} d\mathbf{r}_{1} d\mathbf{r}_{2} \rho_{1}(\mathbf{r}_{1}, \mathbf{r}_{2}) \rho_{1}(\mathbf{r}_{2}, \mathbf{r}_{1}), \qquad (11)$$

and the correlation-energy functional is

$$E_{\rm co}[\rho_1, v] = \frac{\langle \tilde{\Psi}_{v\rho_1} | \hat{T} | \tilde{\Psi}_{v\rho_1} \rangle}{\langle \tilde{\Psi}_{v\rho_1} | \tilde{\Psi}_{v\rho_1} \rangle} - \langle \rho_1 | \hat{T} | \rho_1 \rangle + \frac{\langle \tilde{\Psi}_{v\rho_1} | \hat{V}_{\rm ee} | \tilde{\Psi}_{v\rho_1} \rangle}{\langle \tilde{\Psi}_{v\rho_1} | \tilde{\Psi}_{v\rho_1} \rangle} - \langle \rho_1 | \hat{V}_{\rm ee} | \rho_1 \rangle.$$
(12)

Furthermore, $\tilde{\rho}_c$ is the correlation density of the trial wave function, i.e, we have

$$\tilde{\rho}_{c}(\mathbf{r}) = \frac{\langle \tilde{\Psi}_{v\rho_{1}} | \hat{\Gamma}(\mathbf{r}) | \tilde{\Psi}_{v\rho_{1}} \rangle}{\langle \tilde{\Psi}_{v\rho_{1}} | \tilde{\Psi}_{v\rho_{1}} \rangle} - \rho_{s}(\mathbf{r}) = \tilde{n} - \rho_{s}(\mathbf{r}), \quad \tilde{\Psi}_{v\rho_{1}} \longrightarrow \tilde{n}, \quad \rho_{1} \longrightarrow \rho_{s}, \quad (13)$$

and $\hat{\Gamma}$ is the density operator; \tilde{n} is the density of $\tilde{\Psi}_{v\rho_1}$; ρ_s is the density of ρ_1 . Since $\tilde{\rho}_c(\mathbf{r})$ is a functional of v and ρ_1 , we can also write $\tilde{\rho}_c[\rho_1, v](\mathbf{r})$.

A determinantal state with the density matrix ρ_1 satisfies the following noninteracting Schrödinger equation:

$$\sum_{i=1}^{N} \hat{\mathcal{F}}_{\varrho_1}(\mathbf{r}_i) |\varrho_1\rangle = 2 \left(\sum_{w} \varepsilon_w\right) |\varrho_1\rangle, \tag{14}$$

where the generalized, or exact, Fock operator $\hat{\mathcal{F}}_{\varrho_1}$ is given by

$$\hat{\mathcal{F}}_{\varrho_1} = -\frac{1}{2}\nabla^2 + v + v_J^n + \hat{v}_x^{\varrho_1} + \hat{v}_{co}^{\varrho_1} + \hat{v}_{ec}^{\varrho_1}.$$
(15)

Here, the Coulomb operator is defined by

$$v_J^{\rho}(\mathbf{r}_1)\chi(\mathbf{r}_1) = \int d\mathbf{r}_2 r_{12}^{-1}\rho(\mathbf{r}_2)\chi(\mathbf{r}_1),$$
(16)

and the exchange operator $\hat{v}_{x}^{\rho_{1}}$, correlation operator $\hat{v}_{co}^{\rho_{1}}$ and external-correlation operator $\hat{v}_{ec}^{\rho_{1}}$ are defined by their kernels:

$$v_{\mathbf{x}}^{\rho_{1}}(\mathbf{r}_{1},\mathbf{r}_{2}) = \frac{\delta E_{\mathbf{x}}[\rho_{1},v]}{\delta\rho_{1}(\mathbf{r}_{2},\mathbf{r}_{1})} = -\frac{1}{2}r_{12}^{-1}\rho_{1}(\mathbf{r}_{1},\mathbf{r}_{2}), \qquad (17)$$

$$v_{\rm co}^{\rho_1}(\mathbf{r}_1, \mathbf{r}_2) = \frac{\delta E_{\rm co}[\rho_1, v]}{\delta \rho_1(\mathbf{r}_2, \mathbf{r}_1)},\tag{18}$$

$$v_{\rm ec}^{\rho_1}(\mathbf{r}_1, \mathbf{r}_2) = \frac{\delta \left(\int d\mathbf{r}_3 \, v(\mathbf{r}_3) \tilde{\rho}_c(\mathbf{r}_3) \right)}{\delta \rho_1(\mathbf{r}_2, \mathbf{r}_1)}.$$
(19)

Our energy functionals E_v are implicit functionals of the noninteracting density ρ_s . Hence, any one-particle density-matrix that yields the interacting density minimizes our energy functional, i.e., we have

$$\mathcal{E}_n = E_v[\varrho_1] = E_v[\varrho_1'] = E_v[\varrho_1''] \cdots, \qquad (20)$$

where

$$n(\mathbf{r}) = \varrho_1(\mathbf{r}, \mathbf{r}) = \varrho'_1(\mathbf{r}, \mathbf{r}) = \varrho''_1(\mathbf{r}, \mathbf{r}) \cdots .$$
(21)

Assuming n is a noninteracting v-representable density, there exist a noninteracting state, say $|\varphi_1\rangle$, that has n as its density:

$$n(\mathbf{r}) = \varphi_1(\mathbf{r}, \mathbf{r}),\tag{22}$$

and this determinant—assuming it is a closed-shell determinant—is the ground-state solution of the following noninteracting Schrödinger equation:

$$\sum_{i=1}^{N} \hat{f}(\mathbf{r}_{i}) |\varphi_{1}\rangle = 2 \left(\sum_{w} \epsilon_{w} \right) |\varphi_{1}\rangle, \qquad (23)$$

where

$$\hat{f} = -\frac{1}{2}\nabla^2 + v_s,\tag{24}$$

and v_s is a local potential. Therefore, the canonical occupied orbitals from $|\varphi_1\rangle$ satisfy the following one-particle Schrödinger equation:

$$\hat{f}\phi_w = \left(-\frac{1}{2}\nabla^2 + v + v_J^n + v_{\rm xc}\right)\phi_w = \epsilon_w\phi_w, \quad \phi_w \in \varphi_1, \tag{25}$$

where, with no loss of generality, we have required v_s to be defined by

$$v_s = v + v_J^n + v_{\rm xc}.\tag{26}$$

Using the approach by Sala and Görling [11], but permitting the orbitals to be complex, it is readily demonstrated that $v_{\rm xc}$ is given by

$$v_{\rm xc}(\mathbf{r}) = \frac{1}{2n(\mathbf{r})} \int d\mathbf{r}_1 \left[2w(\mathbf{r}_1, \mathbf{r})\varphi_1(\mathbf{r}, \mathbf{r}_1) - \varphi_1(\mathbf{r}, \mathbf{r}_1) \int d\mathbf{r}_2 \varphi_1(\mathbf{r}_2, \mathbf{r})w(\mathbf{r}_1, \mathbf{r}_2) + \varphi_1(\mathbf{r}_1, \mathbf{r})\varphi_1(\mathbf{r}, \mathbf{r}_1)v_{\rm xc}(\mathbf{r}_1) \right],$$
(27)

where w is the kernel of the nonlocal potential \hat{w}_{ρ_1} , given by

$$\hat{w}_{\rho_1} = \hat{v}_{\rm x}^{\rho_1} + \hat{v}_{\rm co}^{\rho_1} + \hat{v}_{\rm ec}^{\rho_1},\tag{28}$$

and these operators appear in the exact Fock operator $\hat{\mathcal{F}}_{\varrho_1}$, given by Eq. (15). By substituting $v_{\rm xc}$ repeatedly on the right side, we can obtain an expansion for $v_{\rm xc}$:

$$v_{\rm xc}(\mathbf{r}) = \frac{1}{2n(\mathbf{r})} [2w(\mathbf{r}_1, \mathbf{r})\varphi_1(\mathbf{r}, \mathbf{r}_1) - \varphi_1(\mathbf{r}, \mathbf{r}_1)\varphi_1(\mathbf{r}_2, \mathbf{r})w(\mathbf{r}_1, \mathbf{r}_2) + \varphi_1(\mathbf{r}_1, \mathbf{r})\varphi_1(\mathbf{r}, \mathbf{r}_1)\frac{1}{n(\mathbf{r}_1)} \{w(\mathbf{r}_2, \mathbf{r}_1)\varphi_1(\mathbf{r}_1, \mathbf{r}_2) - \frac{1}{2}\varphi_1(\mathbf{r}_1, \mathbf{r}_2)\varphi_1(\mathbf{r}_3, \mathbf{r}_1)w(\mathbf{r}_2, \mathbf{r}_3)\} + \varphi_1(\mathbf{r}_1, \mathbf{r})\varphi_1(\mathbf{r}, \mathbf{r}_1)\frac{1}{2n(\mathbf{r}_1)}\varphi_1(\mathbf{r}_2, \mathbf{r}_1)\varphi_1(\mathbf{r}_1, \mathbf{r}_2)\frac{1}{n(\mathbf{r}_2)}w(\mathbf{r}_3, \mathbf{r}_2)\varphi_1(\mathbf{r}_2, \mathbf{r}_3) + \cdots], (29)$$

where in this relation it is understood that there are integrations over the dummy variables \mathbf{r}_1 , \mathbf{r}_2 and \mathbf{r}_3 . The leading term of Eq. (29) is the Slater potential [12, 13, 14]; this term

also appears within the Krieger–Li–Iafrate (KLI) approximation of the optimized potential method [14, 15, 16, 17].

The orbitals ϕ_w satisfying Eq. (25) are the Kohn–Sham orbitals [18]; $|\varphi_1\rangle$ is the Kohn– Sham noninteracting state. However, \hat{f} differs from the Kohn–Sham operator, since, in addition to depending explicitly on φ_1 , instead of n, \hat{f} depends explicitly on the external potential v from the interacting Hamiltonian \hat{H}_v . Furthermore, the external-correlation operator $\hat{v}_{ec}^{\rho_1}$ does not appear in Kohn–Sham formalism. And, unlike the original Kohn–Sham approach [18], the *N*-representability problem does not arise, nor the need to introduce a constraint-search definition [19, 20, 21, 22] to avoid this problem.

III. THE KOHN–SHAM EXCHANGE–CORRELATION POTENTIAL

According to Eqs. (28), (18), and (19), \hat{w}_{ρ_1} is a functional of ρ_1 and v, indicating that we can, symbolically speaking, represent Eq. (29) by

$$v_{\rm xc}(\mathbf{r}) = v_{\rm xc}[\varphi_1, v](\mathbf{r}), \quad \varphi_1 \longrightarrow n \longrightarrow v.$$
(30)

In other words, $v_{\rm xc}$ is also a functional of v and φ_1 , where φ_1 determines n, and n determines v.

Note that φ_1 and v from Eq. (30) are not independent. Since, for a given v, the oneparticle density matrix φ_1 which determines $v_{\rm xc}$ from Eq. (30), and then gives v_s from (26), must also be the one-particle density matrix φ_1 from the noninteracting state $|\varphi_1\rangle$ that satisfies Eq. (23). However, for a given φ_1 or v_s , we can also think of v as a dependent variable to be determined. In that case, we choose v_s , construct \hat{f} using Eq. (24), and obtain the one-particle density matrix, say φ_1 , that satisfies Eq. (23). The external potential v is then a simultaneous solution of Eqs. (26) and (30).

Substituting Eq. (30) into Eq. (26), gives

$$v = v_s - v_J^n - v_{\rm xc}[\varphi_1, v], \quad N, v_s \longrightarrow \varphi_1 \longrightarrow n \longrightarrow N, v, v_s, \tag{31}$$

where the notation on the right side indicates that N and v_s determine φ_1 , as indicated by Eqs. (23) and (24); also, φ_1 determines n; n determines N, v, and v_s .

By substituting v on the right side of Eq. (31) repeatedly, as in Eq. (29), we can remove it, giving, symbolically speaking,

$$v = v[\varphi_1, v_s],\tag{32}$$

Hence, this relation gives the external potential v from the interacting system Ψ_n , for $n \rightarrow v$, as a functional of the local potential v_s and the one-particle density matrix φ_1 from the noninteracting state $|\varphi_1\rangle$, where $|\varphi_1\rangle$ is an eigenfunction of the noninteracting Hamiltonian given by Eq. (23), and this noninteracting Hamiltonian is defined by the local potential v_s , as indicated by Eq. (24). Furthermore, the noninteracting state $|\varphi_1\rangle$ shares the same density with Ψ_n ; $|\varphi_1\rangle$ is the Kohn-Sham determinantal state when n is noninteracting v-representable.

Since there is a one-to-one correspondence between local potentials v_s and noninteracting ground states $|\varphi_1\rangle$ [1], Eq. (32) can be written as

$$v = v[\varphi_1, v_s], \quad v_s \longleftrightarrow \varphi_1, \tag{33}$$

where the right side indicates the one-to-one correspondence.

Substituting Eq. (33) into Eq. (30) gives

$$v_{\rm xc} = v_{\rm xc}[\varphi_1, v_s], \quad v_s \longleftrightarrow \varphi_1. \tag{34}$$

Denoting $v_{\rm xc}^{\rm KS}$ the Kohn–Sham exchange-correlation potential [1, 2, 3, 4, 5, 6, 7, 18], at least for non-interacting v-representable densities, we have

$$v_{\rm xc}^{\rm KS}[n] = v_{\rm xc}[\varphi_1, v_s], \quad n \longrightarrow \varphi_1, v_s, \quad v_s \longleftrightarrow \varphi_1. \tag{35}$$

In order to obtain the density functional on the left side of Eq. (35), we need the functionals $\varphi_1[n]$ and $v_s[n]$. According the to Hohenberg-Kohn theorem [1, 2, 10], for noninteracting *v*-representable densities, these functionals exist. For other densities, however, these expressions must be generalized by, for example, using some modified constraint search definition, or, perhaps, by an approach that permits v_s to be nonlocal.

IV. THE KOHN–SHAM CORRELATION–ENERGY FUNCTIONAL AND EX-CHANGE CORRELATION FUNCTIONAL

Using the notation form Eq. (4), the universal functional from the Hohenberg-Kohn theorem [1, 2, 10], can be written as

$$F[n] = \langle \Psi_n | \left(\hat{T} + \hat{V}_{ee} \right) | \Psi_n \rangle; \quad n \longrightarrow N, v.$$
(36)

where Ψ_n is a singlet, ground state wave function. Previously we have shown that the correlation energy from many body perturbation theory [23, 24, 25] can be written as an explicit functional of v and ρ_1 [26]. In a similar manner, but using less restrictive energy denominators, the universal functionals F can be shown to be an explicit functional of v and ρ_1 [27], where this functional does not implicitly depend on ρ_1 , i.e., any $|\rho_1\rangle$ that has considerable overlap with $|\Psi_n\rangle$ can be used as a reference state. So, we can write

$$F[n] = F[v, \rho_1], \quad n \longrightarrow v, \quad n, \rho_1 \longrightarrow N.$$
(37)

For noninteracting v-representable densities n, we can use Eq. (32), giving

$$F[n] = F[\varphi_1, v_s, \rho_1], \quad n \longrightarrow \varphi_1, v_s, \quad v_s \longleftrightarrow \varphi_1, \quad \rho_1 \longrightarrow N.$$
(38)

Setting $\rho_1 = \varphi_1$, we get

$$F[n] = F[\varphi_1, v_s], \quad n \longrightarrow \varphi_1, v_s, \quad v_s \longleftrightarrow \varphi_1.$$
(39)

Hence, assuming the existence of the explicit functional, given by Eq. (37), Eq. (39) gives this functional as an explicit functional of v_s and φ_1 , where v_s is the local, one-body potential from the Kohn–Sham equations, and φ_1 is the spinless one-particle density matrix from the Kohn–Sham noninteracting state $|\varphi_1\rangle$.

Using Eq. (39), the exchange-correlation functional from the Kohn-Sham formalism [18] is

$$E_{\rm xc}^{\rm KS}[n] = F[\varphi_1, v_s] - E_J[n] - \langle \varphi_1 | \hat{T} | \varphi_1 \rangle, \quad n \longrightarrow \varphi_1, v_s.$$

$$\tag{40}$$

It is well know that the Kohn–Sham exchange functional is given by [2, 22]

$$E_{\mathbf{x}}^{\mathrm{KS}}[n] = E_{\mathbf{x}}[\varphi_1], \quad n \longrightarrow \varphi_1.$$
 (41)

Hence, the Kohn–Sham correlation-energy functional is

$$E_{\rm co}[n]^{\rm KS} = F[\varphi_1, v_s] - \langle \varphi_1 | \hat{T} | \varphi_1 \rangle - \langle \varphi_1 | \hat{V}_{\rm ee} | \varphi_1 \rangle, \qquad (42)$$

where

$$\langle \varphi_1 | \hat{V}_{\text{ee}} | \varphi_1 \rangle = E_J[n] + E_x[\varphi_1].$$
(43)

APPENDIX A: THE KOHN–SHAM CORRELATION-ENERGY FUNCTIONAL FROM STATE–SPECIFIC KOHN–SHAM DENSITY FUNCTIONAL THEORY

Consider the energy functional $E_v[\rho_1, v']$ that is obtained by permitting the external potential from the trial wave function, say v', to differ from the one from the Hamiltonian \hat{H}_v ; generalizing Eq. (1) in this way, we have

$$E_v[\rho_1, v'] = \frac{\langle \tilde{\Psi}_{v'\rho_1} | \hat{H}_v | \tilde{\Psi}_{v'\rho_1} \rangle}{\langle \tilde{\Psi}_{v'\rho_1} | \tilde{\Psi}_{v'\rho_1} \rangle}.$$
(A1)

and Eqs. (2), (3), and (9) become

$$|\tilde{\Psi}_{v'\varrho_1}\rangle = |\Psi_n\rangle; \ v' = v, \ \varrho_1 \longrightarrow n, \ n \longrightarrow N, v,$$
 (A2)

$$E_v[\varrho_1, v] = \mathcal{E}_n. \tag{A3}$$

$$E_{v}[\rho_{1}, v'] = \mathcal{E}_{1}[\rho_{1}, v] + E_{co}[\rho_{1}, v'] + \int d\mathbf{r} \, v(\mathbf{r}) \tilde{\rho}_{c}[\rho_{1}, v'](\mathbf{r}), \tag{A4}$$

where we have explicitly mentioned the dependence of $\tilde{\rho}_c$ on ρ_1 and v', and the energy through the first order, \mathcal{E}_1 , is given by

$$\mathcal{E}_{1}[\rho_{1},v] = \langle \rho_{1}|H_{v}|\rho_{1}\rangle = \int d\mathbf{r}_{1} \left[-\frac{1}{2}\nabla_{1}^{2}\rho_{1}(\mathbf{r}_{1},\mathbf{r}_{2})\right]_{\mathbf{r}_{2}=\mathbf{r}_{1}}$$
(A5)
+
$$\int d\mathbf{r}_{1} v(\mathbf{r}_{1})\rho(\mathbf{r}_{1}) + \frac{1}{2} \int \int d\mathbf{r}_{1}d\mathbf{r}_{2}r_{12}^{-1}\rho(\mathbf{r}_{1}) \rho(\mathbf{r}_{2}) - \frac{1}{4} \int \int d\mathbf{r}_{1}d\mathbf{r}_{2}r_{12}^{-1}\rho_{1}(\mathbf{r}_{1},\mathbf{r}_{2}) \rho_{1}(\mathbf{r}_{2},\mathbf{r}_{1}).$$

Using Eq. (32), we have

$$E_{v}[\rho_{1}, v'[\varphi_{1}', v_{s}']] = \mathcal{E}_{1}[\rho_{1}, v] + E_{co}[\rho_{1}, v'[\varphi_{1}', v_{s}']] + \int d\mathbf{r} \, v(\mathbf{r}) \tilde{\rho}_{c}[\rho_{1}, v'[\varphi_{1}', v_{s}']](\mathbf{r}).$$
(A6)

Setting $\rho_1 = \varphi'_1$

$$E_{v}[\varphi_{1}', v_{s}'] = \mathcal{E}_{1}[\varphi_{1}', v] + E_{co}[\varphi_{1}', v_{s}'],$$
(A7)

and suppressing the primes, we have

$$E_v[\varphi_1, v_s] = \mathcal{E}_1[\varphi_1, v] + E_{\rm co}[\varphi_1, v_s], \tag{A8}$$

where we used

$$\tilde{\rho}_c[\varphi_1', v'[\varphi_1', v_s']] = 0. \tag{A9}$$

Comparing Eq. (A8) with the energy functionals from the Kohn-Sham formalism, for noninteracting v-representable densities, we have

$$E_v^{\rm KS}[n] = E_v[\varphi_1, v_s], \tag{A10}$$

$$E_{\rm co}^{\rm KS}[n] = E_{\rm co}[\varphi_1, v_s], \qquad (A11)$$

where $n \longrightarrow \varphi_1, v_s, v_s \longleftrightarrow \varphi_1$. As in $v_{\rm xc}^{\rm KS}$, in order to obtain the above density functionals, we need $\varphi_1[n]$ and $v_s[n]$. Recall that it is well know that the Kohn–Sham exchange functional satisfies Eq. (41) [2, 22].
