Gravity and the Electroweak Theory

Abstract

This work shows that gravity creates inertia for the electron. The Lagrangian directly couples the gravitational field with the electron spinor field. It does so via the covariant spinor derivative. The Lagrangian is invariant with respect to the electroweak gauge group $U(1) \otimes SU(2)_L$.

The field equations are solved for an electron in uniform motion. The solution is the Dirac spinor for a massive electron. In effect, gravitational coupling takes the place of the Dirac mass term.

1. Metrical Gravity.

The formalism of time-dependent, three-dimensional geometry was derived in [1] and reviewed in [2]. A brief summary follows. We introduce a scalar, 3-vector basis $e_{\mu} = (e_0, \mathbf{e}_i)$ and define inner products

The basis e_{μ} changes from point to point in the manifold according to the formula

This separates into scalar and 3-vector parts

$$\nabla_{\nu}e_0 = e_0 Q_{0\nu}^0 \tag{3}$$

By definition $Q^0_{j\nu}=Q^i_{0\nu}\equiv 0$. The 18 coefficients Q^i_{jk} would suffice in the case of ordinary static, three-dimensional geometry. Here, the geometry will be time-dependent, in general, and clock rates may differ from point to point. Hence, the additional coefficients Q^i_{j0} and $Q^0_{0\nu}$, respectively. All 28 independent $Q^\mu_{\nu\lambda}$ are derivable from the metric

where

$$\Gamma^{\mu}_{\nu\lambda} = \frac{1}{2} g^{\mu\rho} \left(\partial_{\lambda} g_{\nu\rho} + \partial_{\nu} g_{\rho\lambda} - \partial_{\rho} g_{\nu\lambda} \right) \tag{8}$$

are the Christofel coefficients. The symbols $\Gamma^{\mu}_{\nu\lambda}$ are symmetric in $\nu\lambda$, while the $Q^{\mu}_{\nu\lambda}$ are not. The following formula holds good

where

The gravitational field is introduced by means of the Einstein-Hilbert action

$$\frac{\kappa}{2} \int R\sqrt{-g} \, d^4x = \frac{\kappa}{2} \int g^{\mu\nu} R_{\mu\nu} \sqrt{-g} \, d^4x \tag{11}$$

where $\kappa = c^4/8\pi G$, and the Ricci tensor is

Variation of the gravitational action gives [3]

The source of gravitation is expressed in terms of a matter Lagrangian \mathcal{L}_m . Variation with respect to $\delta g^{\mu\nu}$ defines the energy tensor

$$\delta \int \mathcal{L}_m d^4 x = \frac{1}{2} \int T_{\mu\nu} \delta g^{\mu\nu} \sqrt{-g} d^4 x \tag{14}$$

Setting the sum of (13) and (14) equal to zero, we obtain the gravitational field equations

$$\kappa \left(R_{\mu\nu} - \frac{1}{2} g_{\mu\nu} R \right) + T_{\mu\nu} = 0 \tag{15}$$

There are seven field equations corresponding to the seven variations δg^{00} and δg^{ij} .

The Lagrangian for gravitation may be derived by partial integration of the action [3]

$$\frac{\kappa}{2} \int g^{\mu\nu} R_{\mu\nu} \sqrt{-g} \, d^4x = \frac{\kappa}{2} \int \left\{ \partial_{\nu} \left(\sqrt{-g} g^{\mu\nu} \Gamma^{\lambda}_{\mu\lambda} \right) - \partial_{\lambda} \left(\sqrt{-g} g^{\mu\nu} \Gamma^{\lambda}_{\mu\nu} \right) + \partial_{\lambda} \left(\sqrt{-g} g^{\mu\nu} \right) \Gamma^{\lambda}_{\mu\nu} - \partial_{\nu} \left(\sqrt{-g} g^{\mu\nu} \right) \Gamma^{\lambda}_{\mu\lambda} + g^{\mu\nu} \left(\Gamma^{\lambda}_{\rho\nu} \Gamma^{\rho}_{\mu\lambda} - \Gamma^{\lambda}_{\lambda\rho} \Gamma^{\rho}_{\mu\nu} \right) \sqrt{-g} \right\} d^4x \quad (16)$$

The first two terms, when converted to boundary integrals, do not contribute to the field equations. With some rearranging, this leaves

The Lagrangian

depends upon the metric $g^{\mu\nu}$ and its first derivatives $\partial_{\lambda}g^{\mu\nu}$. Therefore, variation (13) now takes the form

Variation of the matter action (14) takes a similar form

$$\delta \int \mathcal{L}_m d^4 x = \int \left[\frac{\partial \mathcal{L}_m}{\partial g^{\mu\nu}} - \partial_\lambda \frac{\partial \mathcal{L}_m}{\partial (\partial_\lambda g^{\mu\nu})} \right] \delta g^{\mu\nu} d^4 x \tag{20}$$

Defining the total Lagrangian

and setting the sum of (19) and (20) equal to zero, we obtain the gravitational field equations

The Lagrange equations have a direct bearing upon the question of energy, which is defined in terms of \mathcal{L} (appendix C).

2. Tetrads.

In order to accommodate spinors, the system e_{μ} can be expanded in terms of tetrads on a Pauli basis

leaving seven independent functions $e^{\alpha}_{\ \mu}(x)$. The metric now depends upon the underlying tetrad field

$$g_{\mu\nu} = \eta_{\alpha\beta} \, e^{\alpha}_{\ \mu} e^{\beta}_{\ \nu} \tag{26}$$

As shown in appendix A, the covariant spinor derivative

$$D_{\mu}\psi = \partial_{\mu}\psi + iqA_{\mu}\psi + \Gamma_{\mu}\psi \tag{27}$$

yields the Lagrangian (adding the kinetic term for A_{μ})

 $\hat{\gamma}^{\alpha}$ are the constant Dirac matrices, while $\gamma^{\mu}(x) = e_{\alpha}^{\ \mu}(x)\,\hat{\gamma}^{\alpha}$. The electron field equation is found by varying $\overline{\psi}$

Substitution of

$$\frac{\partial \mathcal{L}_e}{\partial (\partial_\mu \overline{\psi})} = -\frac{i}{2} \hbar c \sqrt{-g} \gamma^\mu \psi \tag{31}$$

gives

A similar calculation with respect to $\delta\psi$ yields the conjugate equation

Multiply the first equation by $\overline{\psi}$ the second by ψ and subtract, to find conservation of charge

In the following sections, we will be concerned with oscillating gravitational fields of very small amplitude. The coordinate system is taken to be nearly rectangular

 $g^{\mu\nu} = \eta^{\mu\nu} - h^{\mu\nu}$ (36)

The indices of $h_{\mu\nu}$ are raised by $\eta^{\mu\nu}$; for example, in lowest order

The tetrads are expressed in a similar fashion

In order to simplify the notation, we mix indices obtaining

In terms of tetrads, the metric is

3. $U(1) \otimes SU(2)_L$ Gauge Invariance. [4, 5, 6]

The gravitational coupling term in L_e (28) contains the factor $\overline{\psi}\gamma_5\hat{\gamma}_\delta\psi$. This factor does not mix right- and left-handed spinor components, ψ_R and ψ_L . In order to prove this, set

$$\psi = \psi_R + \psi_L = \frac{1 + \gamma_5}{2} \psi + \frac{1 - \gamma_5}{2} \psi \tag{44}$$

where $(\gamma_5)^2 = 1$ and $\gamma_5 \gamma_\delta = -\gamma_\delta \gamma_5$. Also, $\overline{\psi}_R = \overline{\psi} \frac{1-\gamma_5}{2}$ and $\overline{\psi}_L = \overline{\psi} \frac{1+\gamma_5}{2}$. In the expansion

the mixed terms are identically zero. For example,

Therefore,

An expression of this type will be invariant under $U(1) \otimes SU(2)_L$ gauge transformations. ¹ Introduce the right-handed singlet $\psi_R = e_R$ and left-handed doublet $\psi_L = \begin{pmatrix} \nu_L \\ e_L \end{pmatrix}$ in order to form the Lagrangian

 L_{int} contains the electroweak interaction terms as well as kinetic terms for A_{μ}, W_{μ}^{\pm} , and Z_{μ}^{0} .

¹The Dirac mass term $m\overline{\psi}\psi=m(\overline{\psi}_R\psi_L+\overline{\psi}_L\psi_R)$ mixes right- and left-handed spinors and cannot appear in the electroweak Lagrangian.

4. An Electron in Uniform Motion.

In the previous article [2], the gravitational field was found for a spin up electron at rest

which took the form

Here, we seek the solution for an electron in uniform motion along x^3

The second term in the electron equation (32) is zero, 2 which leaves

where the tetrad assumes the form (50). The Dirac matrix representation is

The trial solution (51) gives $\partial_{\mu}\psi = -ik_{\mu}\psi$ and $\partial_{\mu}\overline{\psi} = ik_{\mu}\overline{\psi}$. From the conservation law (34), it follows that $\overline{\psi}\,\partial_{\mu}(\sqrt{-g}\,\gamma^{\mu})\psi = 0$.

while $\epsilon^{0123} = -1$. Substitution yields four equations

These equations pair (u_1, u_3) or (u_2, u_4) . Consider the case $u_2 = u_4 = 0$: the equations will be satisfied for all values of u_1 and u_3 , if the coefficients are zero ³

$$-\frac{1}{2}(e_{\alpha\mu}\partial_{\nu}e_{\beta\lambda} + e_{\alpha\nu}\partial_{\mu}e_{\beta\lambda})] \qquad (128)$$

The Lagrange form of the gravitational field equations can now be expressed in terms of tetrads. We first substitute $g^{\mu\nu} = \eta^{\alpha\beta} e_{\alpha}^{\ \mu} e_{\beta}^{\ \nu}$ in \mathcal{L}_g to find [2]

$$\frac{\partial \mathcal{L}_g}{\partial g^{\mu\nu}} - \partial_{\lambda} \frac{\partial \mathcal{L}_g}{\partial (\partial_{\lambda} g^{\mu\nu})} = \frac{1}{2} e_{\alpha\nu} \left[\frac{\partial \mathcal{L}_g}{\partial e_{\alpha}^{\ \mu}} - \partial_{\lambda} \frac{\partial \mathcal{L}_g}{\partial (\partial_{\lambda} e_{\alpha}^{\ \mu})} \right]$$
(129)

This, together with the energy tensor for the electron,

$$T_{\mu\nu} = e_{\alpha\nu} \left[\frac{\partial \mathcal{L}_e}{\partial e_{\alpha}^{\ \mu}} - \partial_{\lambda} \frac{\partial \mathcal{L}_e}{\partial (\partial_{\lambda} e_{\alpha}^{\ \mu})} \right]$$
(130)

give the field equations

$$\frac{\partial \mathcal{L}}{\partial e_{\alpha}^{\ \mu}} - \partial_{\lambda} \frac{\partial \mathcal{L}}{\partial (\partial_{\lambda} e_{\alpha}^{\ \mu})} = 0 \tag{131}$$

Appendix C: Energy Conservation.

The principle of energy conservation derives from the Lagrange equations of motion, by means of the Hamilton function

$$\mathcal{H} = \sum_{\phi} c\pi \,\partial_0 \phi - \mathcal{L} \tag{132}$$

The fields ϕ include $e_{\alpha}^{\ \mu}$, ψ , $\overline{\psi}$, and A_{μ} , while the momenta are defined by

$$c\pi = \frac{\partial \mathcal{L}}{\partial(\partial_0 \phi)} \tag{133}$$

The temporal change of \mathcal{H} is

$$\partial_{0}\mathcal{H} = \sum_{\phi} \partial_{0} \left[\frac{\partial \mathcal{L}}{\partial(\partial_{0}\phi)} \right] \partial_{0}\phi + \frac{\partial \mathcal{L}}{\partial(\partial_{0}\phi)} \partial_{0}\partial_{0}\phi - \frac{\partial \mathcal{L}}{\partial\phi} \partial_{0}\phi - \frac{\partial \mathcal{L}}{\partial(\partial_{\lambda}\phi)} \partial_{0}\partial_{\lambda}\phi$$

$$= \sum_{\phi} \partial_{0} \left[\frac{\partial \mathcal{L}}{\partial(\partial_{0}\phi)} \right] \partial_{0}\phi - \frac{\partial \mathcal{L}}{\partial\phi} \partial_{0}\phi - \frac{\partial \mathcal{L}}{\partial(\partial_{n}\phi)} \partial_{0}\partial_{n}\phi$$
(134)

Making use of

$$\partial_n \left[\frac{\partial \mathcal{L}}{\partial (\partial_n \phi)} \partial_0 \phi \right] = \partial_n \left[\frac{\partial \mathcal{L}}{\partial (\partial_n \phi)} \right] \partial_0 \phi + \frac{\partial \mathcal{L}}{\partial (\partial_n \phi)} \partial_n \partial_0 \phi \tag{135}$$

we find

$$\partial_{0}\mathcal{H} = \sum_{\phi} \left[\partial_{\lambda} \frac{\partial \mathcal{L}}{\partial(\partial_{\lambda}\phi)} - \frac{\partial \mathcal{L}}{\partial\phi} \right] \partial_{0}\phi - \partial_{n} \left[\frac{\partial \mathcal{L}}{\partial(\partial_{n}\phi)} \partial_{0}\phi \right]$$

$$= \sum_{\phi} -\partial_{n} \left[\frac{\partial \mathcal{L}}{\partial(\partial_{n}\phi)} \partial_{0}\phi \right]$$
(136)

The last step is by virtue of the Lagrange equations of motion. Integrate over all 3-dimensional space and discard surface terms, in order to obtain conservation of total energy

$$\frac{d}{dx^0} \int \mathcal{H} \, d^3x = 0 \tag{137}$$

We now derive an explicit expression for the energy density

$$\mathcal{H} = c\pi^{\alpha}_{\ \mu} \partial_0 e_{\alpha}^{\ \mu} + c\overline{\pi} \partial_0 \psi + \partial_0 \overline{\psi} c\pi + c\pi^{\mu} \partial_0 A_{\mu} - \mathcal{L}$$
 (138)

The spinor momenta are

$$c\overline{\pi} = \frac{\partial \mathcal{L}}{\partial(\partial_0 \psi)} = \frac{i}{2}\hbar c\sqrt{-g}\,\overline{\psi}\,\gamma^0$$
 (139)

$$c\pi = \frac{\partial \mathcal{L}}{\partial(\partial_0 \overline{\psi})} = -\frac{i}{2} \hbar c \sqrt{-g} \gamma^0 \psi \tag{140}$$

The electromagnetic momenta follow from

$$L_{e-m} = -\frac{1}{4} \left(2g^{00}g^{ij}F_{i0}F_{j0} + g^{il}g^{jm}F_{ij}F_{lm} \right)$$
 (141)

$$\frac{\partial F_{j0}}{\partial (\partial_0 A_i)} = -\delta_j^i \tag{142}$$

Therefore,

$$c\pi^0 = \frac{\partial \mathcal{L}}{\partial(\partial_0 A_0)} = 0 \tag{143}$$

$$c\pi^i = \frac{\partial \mathcal{L}}{\partial (\partial_0 A_i)} = \sqrt{-g} F^{i0}$$
 (144)

Turning now to the tetrad momenta, the gravitational Lagrangian

$$L_{g} = \frac{\kappa}{2} g^{\mu\nu} \left(\Gamma^{\lambda}_{\mu\nu} \Gamma^{\rho}_{\rho\lambda} - \Gamma^{\lambda}_{\rho\nu} \Gamma^{\rho}_{\mu\lambda} \right)$$

$$= \frac{\kappa}{2} \left\{ g^{00} \left(\Gamma^{l}_{m0} \Gamma^{m}_{l0} - \Gamma^{l}_{l0} \Gamma^{m}_{m0} \right) + g^{lm} \left(\Gamma^{n}_{lm} \Gamma^{0}_{0n} - \Gamma^{0}_{0l} \Gamma^{p}_{pm} \right) + g^{lm} \left(\Gamma^{n}_{lm} \Gamma^{p}_{pn} - \Gamma^{p}_{nl} \Gamma^{n}_{mp} \right) \right\}$$

$$(145)$$

contains time derivatives in the first term

$$\frac{\partial \Gamma_{m0}^{l}}{\partial (\partial_{0} g^{ij})} = -\frac{1}{2} g_{im} \delta_{j}^{l} \qquad \frac{\partial \Gamma_{l0}^{l}}{\partial (\partial_{0} g^{ij})} = -\frac{1}{2} g_{ij}$$
 (146)

Therefore,

$$\frac{\partial \mathcal{L}_g}{\partial (\partial_0 g^{ij})} = -\frac{\kappa}{2} \sqrt{-g} g^{00} \left(g_{il} \Gamma^l_{j0} - g_{ij} \Gamma^l_{l0} \right)$$
 (147)

The electron Lagrangian (28) contains time derivatives in the coupling term

$$\frac{\partial \mathcal{L}_{e}}{\partial (\partial_{0} e_{\beta}^{\mu})} = \frac{\hbar c}{4} \overline{\psi} \gamma_{5} \hat{\gamma}_{\delta} \psi \, \epsilon^{\delta \alpha \beta \gamma} e_{\gamma}^{\ 0} e_{\alpha \mu} \sqrt{-g}$$

$$= \frac{\hbar c}{4} \overline{\psi} \gamma_{5} \hat{\gamma}_{\delta} \psi \, \epsilon^{\delta \alpha \beta 0} e_{0}^{\ 0} e_{\alpha \mu} \sqrt{-g} \qquad (148)$$

which leaves

$$\frac{\partial \mathcal{L}_e}{\partial (\partial_0 e_a{}^i)} = -\frac{\hbar c}{4} \overline{\psi} \gamma_5 \hat{\gamma}_d \psi \, \epsilon^{dab0} e_0{}^0 e_{bi} \sqrt{-g}$$
 (149)

The tetrad momenta are given by

$$c\pi^{\alpha}_{\mu} = \frac{\partial \mathcal{L}}{\partial(\partial_{0}e_{\alpha}^{\mu})}$$

$$= \frac{\partial \mathcal{L}_{g}}{\partial(\partial_{0}g^{\nu\lambda})} \frac{\partial(\partial_{0}g^{\nu\lambda})}{\partial(\partial_{0}e_{\alpha}^{\mu})} + \frac{\partial \mathcal{L}_{e}}{\partial(\partial_{0}e_{\alpha}^{\mu})}$$

$$= \frac{\partial \mathcal{L}_{g}}{\partial(\partial_{0}g^{\nu\lambda})} \left(\delta^{\nu}_{\mu}e^{\alpha\lambda} + \delta^{\lambda}_{\mu}e^{\alpha\nu}\right) + \frac{\partial \mathcal{L}_{e}}{\partial(\partial_{0}e_{\alpha}^{\mu})}$$
(150)

It follows that

$$c\pi^{0}_{0} = \frac{\partial \mathcal{L}}{\partial(\partial_{0}e_{0}^{0})} = 0$$

$$c\pi^{a}_{i} = \frac{\partial \mathcal{L}}{\partial(\partial_{0}e_{a}^{i})}$$

$$= -\kappa\sqrt{-g}g^{00}\left(e_{l}^{a}\Gamma^{l}_{i0} - e^{a}_{i}\Gamma^{l}_{l0}\right) - \frac{\hbar c}{4}\overline{\psi}\gamma_{5}\hat{\gamma}_{d}\psi\,\epsilon^{dab0}e_{0}^{0}e_{bi}\sqrt{-g}$$

$$(152)$$

Substituting the momenta into (138), we find the total energy density to be

$$\mathcal{H} = \frac{\kappa}{2} \sqrt{-g} \left\{ g^{00} \left(\Gamma^{l}_{m0} \Gamma^{m}_{l0} - \Gamma^{l}_{l0} \Gamma^{m}_{m0} \right) - g^{lm} \left(\Gamma^{n}_{lm} \Gamma^{0}_{0n} - \Gamma^{0}_{0l} \Gamma^{p}_{pm} \right) \right.$$

$$\left. - g^{lm} \left(\Gamma^{n}_{lm} \Gamma^{p}_{pn} - \Gamma^{p}_{nl} \Gamma^{n}_{mp} \right) \right\}$$

$$\left. + \frac{1}{2} \sqrt{-g} g^{00} g^{lm} \left(\partial_{l} A_{0} \partial_{m} A_{0} - \partial_{0} A_{l} \partial_{0} A_{m} \right) + \frac{1}{4} \sqrt{-g} g^{il} g^{jm} F_{ij} F_{lm} \right.$$

$$\left. - \frac{i}{2} \hbar c \left[\overline{\psi} \gamma^{l} \partial_{l} \psi - (\partial_{l} \overline{\psi}) \gamma^{l} \psi \right] \sqrt{-g} + \hbar c q \overline{\psi} \gamma^{\mu} \psi A_{\mu} \sqrt{-g} \right.$$

$$\left. - \frac{\hbar c}{4} \overline{\psi} \gamma_{5} \hat{\gamma}_{0} \psi \epsilon^{0abc} e_{c}^{\ l} e_{am} \partial_{l} e_{b}^{\ m} \sqrt{-g} \right.$$
