Shape invariance, raising and lowering operators in hypergeometric type equations

Abstract. The Schrödinger equations which are exactly solvable in terms of associated special functions are directly related to some self-adjoint operators defined in the theory of hypergeometric type equations. The fundamental formulae occurring in a supersymmetric approach to these Hamiltonians are consequences of some formulae concerning the general theory of associated special functions. We use this connection in order to obtain a general theory of Schrödinger equations exactly solvable in terms of associated special functions, and to extend certain results known in the case of some particular potentials.

1. Introduction

It is well-known $[10, 5]$ that, in the case of certain potentials, the Schrödinger equation is exactly solvable and its solutions can be expressed in terms of the socalled associated special functions (ASF). The Hamiltonian of such a system can be factorized as a product of two first order differential operators, and a hierarchy of almost isospectral Hamiltonians (called supersymmetric partners) can be defined by repeated refactorizations.

The hierarchy of Hamiltonians corresponds to a hierarchy of self-adjoint operators having the corresponding ASF as eigenfunctions, and the first order differential operators involved in their factorizations correspond to some first order differential operators relating ASF. The purpose of the present article is to analyse in a unitary way the quantum systems exactly solvable in terms of ASF. In order to do this, we start from the general theory of hypergeometric type equations [\[18](#page-10-0)], and factorize the self-adjoint operators having the ASF as eigenfunctions by using some raising/lowering operators relating these functions.

2. Orthogonal polynomials and ASF

Many problems in quantum mechanics and mathematical physics lead to equations of hypergeometric type

$$
\sigma(s)y''(s) + \tau(s)y'(s) + \lambda y(s) = 0
$$
\n(1)

where $\sigma(s)$ and $\tau(s)$ are polynomials of at most second and first degree, respectively, and λ is a constant. These equations are usually called *equations of hypergeometric* type, and the corresponding solutions functions of hypergeometric type [\[18](#page-10-0)]. The equation (1) can be reduced to the self-adjoint form

$$
[\sigma(s)\varrho(s)y'(s)]' + \lambda\varrho(s)y(s) = 0
$$

by choosing a function ϱ such that $[\sigma(s)\varrho(s)]' = \tau(s)\varrho(s)$. For

$$
\lambda = \lambda_l = -\frac{1}{2}l(l-1)\sigma'' - l\tau' \qquad \text{with } l \in \mathbb{N}
$$
 (3)

there exists a polynomial Φ_l of degree l satisfying (1), that is,

$$
\sigma(s)\Phi_l''(s) + \tau(s)\Phi_l'(s) + \lambda_l \Phi_l(s) = 0.
$$
\n(4)

If there exists a finite or infinite interval (a, b) such that

$$
\sigma(s)\varrho(s)s^k|_{s=a} = 0 \qquad \sigma(s)\varrho(s)s^k|_{s=b} = 0 \qquad \text{for all } k \in \mathbb{N} \tag{5}
$$

and if $\sigma(s) > 0$, $\rho(s) > 0$ for all $s \in (a, b)$, then the polynomials Φ_l are orthogonal with weight function $\rho(s)$ in the interval (a, b)

$$
\int_{a}^{b} \Phi_{l}(s) \Phi_{k}(s) \varrho(s) ds = 0 \quad \text{for } \lambda_{l} \neq \lambda_{k}.
$$
 (6)

In this case Φ_l are known as *classical orthogonal polynomials* [[18\]](#page-10-0). We shall prove that the condition $\lambda_l \neq \lambda_k$ from (6) can be replaced by $l \neq k$. The main particular cases of this general approach are presented in table 1.

The classical orthogonal polynomials Φ_l satisfy a three term recurrence relation

$$
s\Phi_l(s) = \alpha_l \Phi_{l+1}(s) + \beta_l \Phi_l(s) + \gamma_l \Phi_{l-1}(s). \tag{7}
$$

and Rodrigues formula

$$
\Phi_l(s) = \frac{B_l}{\varrho(s)} \left[\sigma^l(s) \varrho(s) \right]^{(l)} \tag{8}
$$

where α_l , β_l , γ_l and B_l are constants [\[18](#page-10-0)].

Let $\kappa(s) = \sqrt{\sigma(s)}$. By differentiating the equation [\(4](#page-1-0)) m times and multiplying it by $\kappa^m(s)$, we get for each $m \in \{0, 1, 2, ..., l\}$ the associated differential equation

$$
-\sigma(s)\Phi_{l,m}'' - \tau(s)\Phi_{l,m}' + \left[\frac{m(m-2)}{4}\frac{\sigma'^2(s)}{\sigma(s)} + \frac{m\tau(s)}{2}\frac{\sigma'(s)}{\sigma(s)} - \frac{1}{2}m(m-2)\sigma''(s) - m\tau'(s)\right]\Phi_{l,m} = \lambda_l\Phi_{l,m}
$$
\n(9)

where

$$
\Phi_{l,m}(s) = \kappa^m(s)\Phi_l^{(m)}(s)
$$
\n(10)

are known as the associated special functions. We have ([\[18](#page-10-0)], p.8)

$$
\int_{a}^{b} \Phi_{l,m}(s)\Phi_{k,m}(s)\varrho(s)ds = \int_{a}^{b} \Phi_{l}^{(m)}(s)\Phi_{k}^{(m)}(s)\sigma^{m}(s)\varrho(s)ds = 0 \quad (11)
$$

for any $m \in \mathbb{N}$ and $l, k \in \{m, m+1, m+2, ...\}$ with $l \neq k$. This means that for each $m \in \mathbb{N}$, the set $\{\Phi_{m,m}, \Phi_{m+1,m}, \Phi_{m+2,m}, ...\}$ (se figure 1) is an orthogonal sequence in the Hilbert space

$$
\mathcal{H} = \left\{ \varphi : (a, b) \longrightarrow \mathbb{R} \middle| \int_a^b |\varphi(s)|^2 \varrho(s) ds < \infty \right\} \tag{12}
$$

with the scalar product given by

$$
\langle \varphi, \psi \rangle = \int_{a}^{b} \varphi(s) \psi(s) \varrho(s) ds. \tag{13}
$$

For each $m \in \mathbb{N}$, let \mathcal{H}_m be the linear span of $\{\Phi_{m,m}, \Phi_{m+1,m}, \Phi_{m+2,m}, ...\}$. In the sequel we shall restrict us to the case when \mathcal{H}_m is dense in H for all $m \in \mathbb{N}$. For this it is sufficient the interval (a, b) to be finite, but not necessary.

The equation (9) can be written as

$$
H_m \Phi_{l,m} = \lambda_l \Phi_{l,m} \tag{14}
$$

Figure 1. The functions $\Phi_{l,m}$ satisfy the relation $H_m \Phi_{l,m} = \lambda_l \Phi_{l,m}$, and are related (up to some multiplicative constants) through the operators A_m , A_m^+ , a_m , a_m^+ , U_m and $U_m^{-1} = U_m^+$.

where $H_m: \mathcal{H}_m \longrightarrow \mathcal{H}_m$ is the differential operator

$$
H_m = -\sigma(s)\frac{d^2}{ds^2} - \tau(s)\frac{d}{ds} + \frac{m(m-2)}{4}\frac{\sigma'^2(s)}{\sigma(s)}
$$

$$
+ \frac{m\tau(s)}{2}\frac{\sigma'(s)}{\sigma(s)} - \frac{1}{2}m(m-2)\sigma''(s) - m\tau'(s).
$$
(15)

The problem of factorization of operators H_m is a very important one since it is directlyrelated to the factorization of some Schrödinger type operators [[10, 5\]](#page-10-0). If we use in (9) a change of variable $s = s(x)$ such that $ds/dx = \kappa(s(x))$ or $ds/dx = -\kappa(s(x))$ and define the new functions

\Psi_{l,m}(x) = \sqrt{\kappa(s(x)) \varrho(s(x))} \Phi_{l,m}(s(x))
$$
\n(16)

then we get an equation of Schrödinger type $% \mathcal{N}$

$$
-\frac{d^2}{dx^2}\Psi_{l,m}(x) + V_m(x)\Psi_{l,m}(x) = \lambda_l \Psi_{l,m}(x).
$$
 (17)

For example, by starting from the equation of Jacobi polynomials with $\alpha = \mu - 1/2$, $\beta = \eta - 1/2$, and using the change of variable $s(x) = \cos x$ we obtain the Schrödinger equation corresponding to the Pöschl-Teller potential

$$
V_0(x) = \frac{1}{4} \left[\frac{\mu(\mu - 1)}{\cos^2(x/2)} + \frac{\eta(\eta - 1)}{\sin^2(x/2)} \right] - \frac{(\mu + \eta)^2}{4}.
$$
 (18)

3. Raising and lowering operators. Shape invariance

Lorente has shown recently [\[15](#page-10-0), [16](#page-10-0)] that a factorization of H_0 can be obtained by using the three term recurrence relation([7\)](#page-2-0) and a consequence of Rodrigues formula. FollowingLorente's idea we obtain a factorization of H_m by using ([10\)](#page-2-0) and a three term recurrence relation.

Theorem 1. For any $l \in \mathbb{N}$ and any $m \in \{0, 1, ..., l-1\}$ we have

$$
\Phi_{l,m+1}(s) = \left(\kappa(s)\frac{d}{ds} - m\kappa'(s)\right)\Phi_{l,m}(s). \tag{19}
$$

Proof. By differentiating [\(10](#page-2-0)) we get

$$
\Phi'_{l,m}(s) = m\kappa^{m-1}(s)\kappa'(s)\Phi_l^{(m)} + \kappa^m(s)\Phi_l^{(m+1)}(s)
$$

that is, the relation

$$
\Phi'_{l,m}(s) = m \frac{\kappa'(s)}{\kappa(s)} \Phi_{l,m}(s) + \frac{1}{\kappa(s)} \Phi_{l,m+1}(s)
$$

equivalent to (19). \Box

Theorem 2. The three term recurrence relation

$$
\Phi_{l,m+1}(s) + \left(\frac{\tau(s)}{\kappa(s)} + 2(m-1)\kappa'(s)\right)\Phi_{l,m}(s) + (\lambda_l - \lambda_{m-1})\Phi_{l,m-1}(s) = 0
$$
\n(20)

is satisfied for any $l \in \mathbb{N}$ and any $m \in \{1, 2, ..., l-1\}$.

Proof. In order to obtain (20), one has to differentiate [\(4](#page-1-0)) $m-1$ times, to multiply the obtained relation by $\kappa^{m-1}(s)$, and then to use (10). \Box theobtained relation by $\kappa^{m-1}(s)$, and then to use ([10\)](#page-2-0). \Box

Theorem 3. For any $l \in \mathbb{N}$ and any $m \in \{1, 2, ..., l-1\}$ we have the relation

$$
(\lambda_l - \lambda_m)\Phi_{l,m}(s) = \left(-\kappa(s)\frac{d}{ds} - \frac{\tau(s)}{\kappa(s)} - (m-1)\kappa'(s)\right)\Phi_{l,m+1}(s). \tag{21}
$$

Proof. This relation follows from (20) and (19) with $m + 1$ instead of m. \Box

Theorem 4. The operators

$$
A_m: \mathcal{H}_m \longrightarrow \mathcal{H}_{m+1} \qquad A_m = \kappa(s) \frac{d}{ds} - m\kappa'(s) \tag{22}
$$

and

$$
A_m^+ : \mathcal{H}_{m+1} \longrightarrow \mathcal{H}_m \qquad A_m^+ = -\kappa(s) \frac{d}{ds} - \frac{\tau(s)}{\kappa(s)} - (m-1)\kappa'(s) \tag{23}
$$

are mutually adjoint [\[19](#page-10-0)].

Proof. Since $\sigma^m(s)\Phi_l^{(m)}(s)\Phi_k^{(m+1)}(s)$ is a polynomial, from [\(5](#page-1-0)) we get

$$
\langle A_m \Phi_{l,m}, \Phi_{k,m+1} \rangle = \int_a^b [\kappa(s)\Phi'_{l,m}(s) - m\kappa'(s)\Phi_{l,m}(s)]\Phi_{k,m+1}(s)\varrho(s)ds
$$

\n
$$
= \kappa(s)\Phi_{l,m}(s)\Phi_{k,m+1}(s)\varrho(s)|_a^b - \int_a^b \Phi_{l,m}(s)[\kappa(s)\Phi'_{k,m+1}(s)\varrho(s)
$$

\n
$$
+ \kappa(s)\Phi_{k,m+1}(s)\varrho'(s) + (m+1)\kappa'(s)\Phi_{k,m+1}(s)\varrho(s)]ds
$$

\n
$$
= \sigma(s)\varrho(s)\sigma^m(s)\Phi_l^{(m)}(s)\Phi_k^{(m+1)}(s)|_a^b + \int_a^b \Phi_{l,m}(s)(A_m^+\Phi_{k,m+1})(s)\varrho(s)ds
$$

$$
= \langle \Phi_{l,m}, A_m^+ \Phi_{k,m+1} \rangle
$$

for any $l\geq m,$ $k\geq m+1$. \Box Since

$$
||\Phi_{l,m+1}||^2 = \langle \Phi_{l,m+1}, \Phi_{l,m+1} \rangle = \langle A_m \Phi_{l,m}, \Phi_{l,m+1} \rangle
$$

= $\langle \Phi_{l,m}, A_m^+ \Phi_{l,m+1} \rangle = (\lambda_l - \lambda_m) ||\Phi_{l,m}||^2$

it follows that $\lambda_l > \lambda_m$ for all $l > m$, and

$$
||\Phi_{l,m+1}|| = \sqrt{\lambda_l - \lambda_m} ||\Phi_{l,m}||. \tag{24}
$$

This is possible only if $\sigma''(s) \leq 0$ and $\tau'(s) < 0$. Particularly, we have $\lambda_l \neq \lambda_k$ if and only if $l \neq k$.

Theorem 5. The operators $H_m: \mathcal{H}_m \longrightarrow \mathcal{H}_m$ are self-adjoint, and

$$
H_m - \lambda_m = A_m^+ A_m \qquad H_{m+1} - \lambda_m = A_m A_m^+.
$$
 (25)

Proof. The relations [\(19](#page-4-0)) and([21\)](#page-4-0) can be written as

$$
A_m \Phi_{l,m} = \Phi_{l,m+1} \qquad A_m^+ \Phi_{l,m+1} = (\lambda_l - \lambda_m) \Phi_{l,m} \qquad (26)
$$

and we get

$$
A_m^+ A_m \Phi_{l,m} = (\lambda_l - \lambda_m) \Phi_{l,m} \qquad A_m A_m^+ \Phi_{l,m+1} = (\lambda_l - \lambda_m) \Phi_{l,m+1} \tag{27}
$$

that is,

$$
(A_m^+ A_m + \lambda_m)\Phi_{l,m} = \lambda_l \Phi_{l,m} \qquad (A_m A_m^+ + \lambda_m)\Phi_{l,m+1} = \lambda_l \Phi_{l,m+1}
$$

whence

$$
H_m = A_m^+ A_m + \lambda_m \qquad H_{m+1} = A_m A_m^+ + \lambda_m. \qquad \Box
$$

From (25) we obtain the relation expressing the shape invariance[[2,](#page-10-0) [8, 7\]](#page-10-0) of operators H_m

$$
A_m A_m^+ = A_{m+1}^+ A_{m+1} + r_{m+1}
$$
\n(28)

where $r_{m+1} = \lambda_{m+1} - \lambda_m = -m\sigma'' - \tau'$. Particularly, we have $\lambda_l = \sum_{k=1}^l r_k$ and

$$
H_0 = A_0^+ A_0
$$

\n
$$
H_1 = A_0 A_0^+ = A_1^+ A_1 + r_1
$$

\n
$$
H_2 = A_1 A_1^+ + r_1 = A_2^+ A_2 + r_1 + r_2
$$

\n...
\n
$$
H_{m+1} = A_m A_m^+ + \sum_{k=1}^m r_k = A_{m+1}^+ A_{m+1} + \sum_{k=1}^{m+1} r_k
$$

\n...

The function $\Phi_{l,l}(s) = \kappa^l(s) \Phi_l^{(l)}(s)$ satisfies the relation $A_l \Phi_{l,l} = 0$, and

$$
\Phi_{l,m} = \frac{A_m^+}{\lambda_l - \lambda_m} \frac{A_{m+1}^+}{\lambda_l - \lambda_{m+1}} \dots \frac{A_{l-2}^+}{\lambda_l - \lambda_{l-2}} \frac{A_{l-1}^+}{\lambda_l - \lambda_{l-1}} \Phi_{l,l}
$$
\n(30)

for all $l \in \mathbb{N}$ and $m \in \{0, 1, 2, ..., l - 1\}.$

The operators A_m and A_m^+ have been previously obtained by Jafarizadeh and Fakhri [\[11](#page-10-0)] after a rather long calculation by using the *ansatz*

$$
A_m = f_1(s)\frac{d}{ds} + g_1(s) \qquad A_m^+ = f_2(s)\frac{d}{ds} + g_2(s). \tag{31}
$$

We use this opportunity to correct a minor error existing in[[11\]](#page-10-0). Since Jafarizadeh and Fakhri[[11\]](#page-10-0) use for ASF the definition $\Phi_{l,m}(s) = (-1)^m \kappa^m(s) \Phi_l^{(m)}(s)$, the proof of our theorem 1 shows that one has to multiply the expressions of $B(m)$ and $A(m)$ from [[11\]](#page-10-0) by (−1) in order to get the correct raising/lowering operators. The expression of A_m in the Legendre case is known for a long time [\[20](#page-10-0)].

4. Creation and annihilation operators

For each $m \in \mathbb{N}$, the sequence $\{|m, m \rangle, |m+1, m \rangle, |m+2, m \rangle, ...\$, where

$$
|l, m \rangle = \Phi_{l,m}/||\Phi_{l,m}|| \tag{32}
$$

is an orthonormal basis of H , and

$$
U_m: \mathcal{H} \longrightarrow \mathcal{H} \qquad U_m |l, m\rangle = |l+1, m+1\rangle \tag{33}
$$

is a unitary operator.

Theorem 6. The operators (see figure 1)

$$
a_m, a_m^+ : \mathcal{H}_m \longrightarrow \mathcal{H}_m \qquad a_m = U_m^+ A_m \qquad a_m^+ = A_m^+ U_m \tag{34}
$$

are mutually adjoint, and

$$
a_m|l,m\rangle = \sqrt{\lambda_l - \lambda_m} \left|l-1,m\right\rangle \quad \text{for all} \quad l \ge m+1
$$

\n
$$
a_m^+|l,m\rangle = \sqrt{\lambda_{l+1} - \lambda_m} \left|l+1,m\right\rangle \quad \text{for all} \quad l \ge m.
$$
\n(35)

Proof.This result follows from ([24\)](#page-5-0) and the fact that A_m and A_m^+ are mutually adjoint. \Box

For each $l > m$ we have

$$
|l,m\rangle = \frac{(a_m^+)^{l-m}}{\sqrt{(\lambda_l - \lambda_m)(\lambda_{l-1} - \lambda_m)...(\lambda_{m+1} - \lambda_m)}} |m,m\rangle.
$$
 (36)

Since

$$
a_m a_m^+ \Phi_{l,m} = (\lambda_{l+1} - \lambda_m) \Phi_{l,m} \qquad a_m^+ a_m \Phi_{l+1,m} = (\lambda_{l+1} - \lambda_m) \Phi_{l+1,m} \tag{37}
$$

we get the factorization

$$
H_m - \lambda_m = a_m^+ a_m \tag{38}
$$

and the relation

$$
[a_m, a_m^+] \Phi_{l,m} = (\lambda_{l+1} - \lambda_l) \Phi_{l,m}.
$$
\n
$$
(39)
$$

By using the operator $R_m = -\sigma'' N_m - \tau'$, where N_m is the number operator

$$
N_m: \mathcal{H}_m \longrightarrow \mathcal{H}_m \qquad N_m \Phi_{l,m} = l \Phi_{l,m} \tag{40}
$$

therelation (39) (39) can be written as $[6, 2]$

$$
[a_m, a_m^+] = R_m. \tag{41}
$$

Since

$$
[a_m^+, R_m] = \sigma'' a_m^+ \qquad [a_m, R_m] = -\sigma'' a_m \tag{42}
$$

it follows that the Lie algebra \mathcal{L}_m generated by $\{a_m^+, a_m\}$ is finite dimensional.

Theorem 7.

$$
\mathcal{L}_m \text{ is isomorphic to } \begin{cases} su(1,1) & \text{if } \sigma'' < 0 \\ Heisenberg - Weyl algebra & \text{if } \sigma'' = 0. \end{cases} \tag{43}
$$

Proof. If $\sigma'' \neq 0$ then $K_+ = \sqrt{2/|\sigma''|} a_m^+$, $K_- = \sqrt{2/|\sigma''|} a_m$ and $K_0 = (-1/\sigma'')R_m$ satisfy

$$
[K_0, K_{\pm}] = \pm K_{\pm} \qquad [K_+, K_-] = -2K_0. \qquad \Box
$$

By using [\(34\)](#page-6-0) the relation (41) can be written as

$$
U_m^+ A_m A_m^+ U_m - A_m^+ U_m U_m^+ A_m = R_m.
$$

and in view of [\(59](#page-8-0)) we get

$$
U_m^+(H_{m+1} - \lambda_m)U_m - (H_m - \lambda_m) = R_m
$$

that is, the relation expressing the shape invariance $[8]$ of H_m

$$
H_{m+1} = U_m (H_m + R_m) U_m^+.
$$
\n(44)

One can also remark that

$$
A_m R_m = R_{m+1} A_m \qquad R_m A_m^+ = A_m^+ R_{m+1} \tag{45}
$$

$$
[H_m, a_m] = -R_m a_m \qquad [H_m, a_m^+] = a_m^+ R_m \tag{46}
$$

and

$$
U_m R_m U_m^+ = R_{m+1} + \sigma''
$$
\n(47)

for all $m \in \mathbb{N}$.

5. Systems of coherent states

Let $m \in \mathbb{N}$ be a fixed natural number, and let

$$
|n\rangle = |m+n, m\rangle \qquad e_n = \lambda_{m+n} - \lambda_m \qquad (48)
$$

for all $n \in \mathbb{N}$. Since

$$
0 = e_0 < e_1 < e_2 < \dots < e_n < \dots \tag{49}
$$

and

$$
a_m|n\rangle = \sqrt{e_n} |n-1\rangle \qquad a_m^+|n\rangle = \sqrt{e_{n+1}} |n+1\rangle \qquad (H_m - \lambda_m)|n\rangle = e_n|n\rangle \qquad (50)
$$

we can define a system of coherent states by using the general setting presented in [\[1](#page-10-0)]. Let

$$
\varepsilon_n = \begin{cases} 1 & \text{if } n = 0\\ e_1 e_2 \dots e_n & \text{if } n > 0 \end{cases} \tag{51}
$$

If

$$
R = \limsup_{n \to \infty} \sqrt[n]{\varepsilon_n} \neq 0 \tag{52}
$$

then we can define

$$
|z\rangle = \frac{1}{N(|z|^2)} \sum_{n\geq 0} \frac{z^n}{\sqrt{\varepsilon_n}} |n\rangle \qquad \text{where} \qquad (N(|z|^2)^2 = \sum_{n=0}^{\infty} \frac{|z|^{2n}}{\varepsilon_n} \tag{53}
$$

for any z in the open disk $C(0, R)$ of center 0 and radius R. We get in this way a continuous family $\{|z\rangle| z \in C(0,R)$ of normalized coherent states, eigenstates of the operator a_m

$$
a_m|z\rangle = z|z\rangle. \tag{54}
$$

6. Application to Schrödinger type operators

We have already seen that the operators H_m are directly related to some Schrödinger type operators. If we use a change of variable $s = s(x)$ such that $ds/dx = \kappa(s(x))$, then the operators corresponding to A_m and A_m^+ are the adjoint conjugate operators

$$
\tilde{A}_m = [\kappa(s)\varrho(s)]^{1/2} A_m[\kappa(s)\varrho(s)]^{-1/2}|_{s=s(x)} = \frac{d}{dx} + W_m(x)
$$
\n
$$
\tilde{A}_m^+ = [\kappa(s)\varrho(s)]^{1/2} A_m^+[\kappa(s)\varrho(s)]^{-1/2}|_{s=s(x)} = -\frac{d}{dx} + W_m(x)
$$
\n(55)

where the *superpotential* $W_m(x)$ is given by the formula

$$
W_m(x) = -\frac{\tau(s(x))}{2\kappa(s(x))} - \frac{2m-1}{2\kappa(s(x))} \frac{d}{dx}\kappa(s(x)).
$$
\n(56)

From (26) (26) (26) and (27) we get

$$
\tilde{A}_m \Psi_{l,m}(x) = \Psi_{l,m+1}(x) \qquad \tilde{A}_m^+ \Psi_{l,m+1}(x) = (\lambda_l - \lambda_m) \Psi_{l,m}(x) \tag{57}
$$

and

$$
(\tilde{A}_{m}^{+}\tilde{A}_{m}+\lambda_{m})\Psi_{l,m}=\lambda_{l}\Psi_{l,m}\qquad(\tilde{A}_{m}\tilde{A}_{m}^{+}+\lambda_{m})\Psi_{l,m+1}=\lambda_{l}\Psi_{l,m+1}
$$
\n(58)

whence

$$
-\frac{d^2}{dx^2} + V_m(x) - \lambda_m = \tilde{A}_m^+ \tilde{A}_m \qquad -\frac{d^2}{dx^2} + V_{m+1}(x) - \lambda_m = \tilde{A}_m \tilde{A}_m^+ \tag{59}
$$

and

$$
V_m(x) - \lambda_m = W_m^2(x) - \dot{W}_m(x) \qquad V_{m+1}(x) - \lambda_m = W_m^2(x) + \dot{W}_m(x) \tag{60}
$$

where the dot sign means derivative with respect to x .

Since $\tilde{A}_m \Psi_{m,m} = 0$, from (55) and (59) we get

$$
\dot{\Psi}_{m,m} + W_m(x)\Psi_{m,m} = 0 \qquad -\ddot{\Psi}_{m,m} + (V_m(x) - \lambda_m)\Psi_{m,m} = 0 \tag{61}
$$

whence

$$
W_m(x) = -\frac{\dot{\Psi}_{m,m}(x)}{\Psi_{m,m}(x)} \qquad V_m(x) = \frac{\ddot{\Psi}_{m,m}(x)}{\Psi_{m,m}(x)} + \lambda_m.
$$
 (62)

For each $m \in \{0, 1, 2, ..., l-1\}$ we have

$$
\Psi_{l,m}(x) = \frac{\tilde{A}_m^+}{\lambda_l - \lambda_m} \frac{\tilde{A}_{m+1}^+}{\lambda_l - \lambda_{m+1}} \dots \frac{\tilde{A}_{l-2}^+}{\lambda_l - \lambda_{l-2}} \frac{\tilde{A}_{l-1}^+}{\lambda_l - \lambda_{l-1}} \Psi_{l,l}(x).
$$
(63)

If we choose the change of variable $s = s(x)$ such that $ds/dx = -\kappa(s(x))$, then the formulae([55\)](#page-8-0),([56\)](#page-8-0), [\(60](#page-8-0)) and (62) become

$$
\tilde{A}_m = -\frac{d}{dx} + W_m(x) \qquad \tilde{A}_m^+ = \frac{d}{dx} + W_m(x) \tag{64}
$$

$$
W_m(x) = -\frac{\tau(s(x))}{2\kappa(s(x))} + \frac{2m - 1}{2\kappa(s(x))} \frac{d}{dx}\kappa(s(x))
$$
\n(65)

$$
V_m(x) - \lambda_m = W_m^2(x) + \dot{W}_m(x) \qquad V_{m+1}(x) - \lambda_m = W_m^2(x) - \dot{W}_m(x) \tag{66}
$$

$$
W_m(x) = \frac{\dot{\Psi}_{m,m}(x)}{\Psi_{m,m}(x)} \qquad V_m(x) = \frac{\ddot{\Psi}_{m,m}(x)}{\Psi_{m,m}(x)} + \lambda_m \qquad (67)
$$

respectively.For example, in the case of Pöschl-Teller potential (18) (18) we obtain

$$
W_0(x) = \frac{1}{2} \left[\mu \cot \frac{x}{2} - \eta \tan \frac{x}{2} \right].
$$
 (68)

7. Concluding remarks

The Schrödinger equations which are exactly solvable in terms of ASF are directly related to the self-adjoint operators H_m defined by (15), and hence, each of them can be described by the interval (a, b) and the corresponding functions $\sigma(s)$, $\tau(s)$, $\rho(s)$, $s(x)$ satisfying the conditions presented in section 2. This infinite class of exactly solvable problems depending on several parameters contains well-known potentials (together with their supersymmetric partners) as well as other physically relevant potentials [[11\]](#page-10-0).

Our results concerning the operators H_m allow to study these quantum systems together in a unitary way, and to extend certain results presented up to now only in case of some particular potentials. Our formulae apply to all the Schrödinger equations solvable in terms of ASF. In order to pass to a particular potential it suffices to replace $\sigma(s)$, $\tau(s)$, $\varrho(s)$, $s(x)$ by the corresponding functions.

In this article we analyse an important class of exactly solvable Schrödinger equations, but the class of known solvable problems is larger [\[3](#page-10-0), [4, 12, 13, 14](#page-10-0)]. Generally, the methods used to enlarge the class of exactly solvable potentials are based on the idea of finding pairs of (essentially) isospectral operators, and the construction of new exactly solvable Hamiltonians starts from a known exactly solvable Hamiltonian. In most of the cases the starting Hamiltonian belongs to the class considered in the present article.

We have already seen that the superpotential W_m which allows to construct the supersymmetric partner V_{m+1} of V_m satisfies the Riccati equation

$$
V_m(x) - \lambda_m = W_m^2(x) - W_m(x).
$$
 (69)

New supersymmetric partners of V_m can be obtained by finding new solutions W of this equation [12, 13] or by solving the more general Riccati equation [3, 17]

$$
V_m(x) - \varepsilon = W^2(x) - \dot{W}(x). \tag{70}
$$

The usual algebraic approach can also be extended to these new exactly solvable potentials by using some non-linear generalizations of Lie algebras [4]. Certain algebraic properties become more transparent if we use the method proposed recently by Gurappa et. al. [9] which allows to connect the space of the solutions of a linear differential equation to the space of monomials, but the advantages obtained in the case of our Hamiltonians are not very significant.
